## **BVI AIRWAYS SUING BVI GOVT. FOR MILLIONS OF DOLLARS**

BVI Airways is suing the Government of the British Virgin Islands for millions of dollars and Premier and Minister for Finance Hon. Andrew Fahie said that he is fighting to save the public purse.

The BVI Airways saga is an unfortunate investment venture that saw the BVI Government investing \$7.2M to have regular flights to Miami and back. Unfortunately, the flights never materialized and the Government is still trying to recoup the money spent.

The last update on the matter was the mention of a lawsuit against Lester Hyman former BVI Government Attorney and BVI Airways Director. While the public has been informed about this case, the BVI Leader is alerting the public that another case is pending.

In bringing the matter to the House of Assembly on 22 April Hon. Fahie said that the Government has been trying to defend itself against the case that was filed in the US. He told legislators: "By the way...I would like the people of the Virgin Islands to know we have been quietly fighting a ten-million-dollar law suit. The same plane turns around and sues us and I am fighting (and) had to pick up taxpayers' money to fight off a lawsuit in New York."

During his disclosure of the lawsuit, Hon. Fahie recalled that at the time of the BVI Airways fiasco he was the Leader of the Opposition and spoke out against certain issues. Hon. Fahie said he was against the government's agreement to pay some \$7.2 M. "Now I who was saying that have to turn around and protect the country from a \$10M suit for the same airplane where (is) the \$7.2 gone. We have no money, no flights and no planes;"the Premier said.

While not mentioning much about the case, and the details surrounding the lawsuit, Premier Fahie confirmed the \$10M lawsuit against the BVI.

One of the telling disclosures made by the Premier is the suggestion that the Governor might not have been in support of the decision to recoup the lost Day the Sportsman Figreen away)

investment. This suggestion was culled from what the Premier said, "When we were doing the case the same last one that start a lot of this mischief, they were fighting us not to go defend the BVI telling us leave it alone. My Ministers there they could tell you

and I said I never thought I could hear that out of somebody here that represents the highest level of the land from up by the mother country. That's amazing!"

The case against the Government and BVI Airways was first mentioned by Premier Fahie

in 2020. At the time Hon. Fahie announced that BVI Airways took legal steps in response to the investigation and launched a claim against the Government of the Virgin Islands in June 2019.

During last year's disclosure Hon. Fahie mentioned that the BVI Airways claim was made before the American Arbitration Association in New York, and sought an unidentified sum for damages. "It is based on allegations which the government strongly refutes," Hon. Fahie suggested.

As a result, the Premier said that further actions are being taken against BVI Airways. "In response, the Government has instructed MKS to file a defence and a counter claim seeking an award of \$7.2 million against BVA. However, the arbitration proceedings have been placed on hold while

the relevant terms of the Framework Agreement... Due to the confidential nature of the mediation process, the BVI government is unable to comment further," Hon. Fahie noted.

In noting what the next move was going to be Hon. Fahie announced: "Following the conclusion of the discovery proceedings in Washington DC, the Government intends to bring an action against Mr. Hyman before the BVI High Court for damages based on his conduct in representing the Government in connection with the events leading up to and following the signing of the Framework Agreement with BVA."

Hon. Fahie mentioned

the parties comply with that in September 2019, the Attorney General of the Virgin Islands, on the back of the findings of the interim report, filed an application for pre-action discovery against attorney Hyman before the US District Court for the District of Colombia. It was noted that Hyman has opposed the application, and the matter now lies before Senior District Court Judge Royce C. Lamberth for a decision.

> In noting the issue with Hyman, the Premier said: "Attorney Hyman had acted as US legal Counsel to the Government of the Virgin Islands from 1987 to July 2017. It was Mr. Hyman who introduced BVA and its promoters to the (BVI) Government in 2014."

While noting that legal proceedings will be conducted here in the Territory Hon. Fahie said: "Following the conclusion of the discovery proceedings in Washington DC, the Government intends to bring an action against Mr. Hyman before the BVI High Court for damages based on his conduct in representing the Government in connection with the events leading up to and following the signing of the Framework Agreement with BVA."

#### More Persons to be Implicated?

While Hyman was getting the heat for the failed airline deal, Premier Fahie had also mentioned that in a 2020 sitting of the House that that attention would be turned to others who had a hand in the saga. The BVI Leader told the House of Assembly

last year: "Mister Speaker, I want to make it clear to the people of the Virgin Islands that this Government will leave no stone unturned in its investigation to uncover the truth behind the failed project."

"We intend to pursue all rights available to the Government to determine who benefited from the use of public funds and to seek recovery of the \$7.2 million lost in this project, which are now needed to assist the many concerns, especially those being named by the opposition who served under the previous administration when the money and planes went missing...anyone legally responsible for the Government's loss will be held to account to the extent that the law permits," Hon. Fahie declared.

# Flexible & Reasonable Financing Rates Needed In BVI: Says Hon. Turnbull

Banks in other countries of the House of Assembly such as the United States are offering flexible financing and assistance to the young generation buying or building a home; additionally various options to help clients cope in these pandemic days are offered. Second District Representative Hon. Mitch Turnbull suggests that BVI financial institutions are making no attempt to fuel recovery and he would like to know why.

The BVI parliamentarian told his colleagues during the Other Business section

on 22 April that he had a series of meetings with his constituents and there were concerns about bank financing.

While recalling what one of his constituents Turnbull said, "I am having difficulty understanding and this is how the question was posed Mr. Speaker that interest rates all across the world for loans, credit cards, mortgages are and have been at an all time low; why is it that here in the BVI everything goes up but nothing seems to marginalize across the board. My community has sent me to put this before this Hon. House."

The Second District Representative explained how the banks in other countries are trying to help their clients by offering certain flexibilities to soothe pandemic financial challenges. Therefore he said that the Premier should query the banks here for similar assistance. "I am putting it to the Premier and Minister for Finance that the conversation be had with the banking industry... Mr. Speaker the percentages in the BVI compared to the region and even the rest of the world even right there with the United States are ridiculously high. It takes persons sometimes six to eight months to be approved for a mortgage. When you go to neighbouring United States Virgin Islands them flinging credit at you," Hon. Turnbull added.

"There is something that needs to be done because how you stimulate your economy Mr. Speaker is you make it easier for persons who are in business..."

"It is possible that these conversations could be had with the (local) banking industry that interest rates be negotiated downwards Mr. Speaker.... I don't believe that we should be having to deal with these high interest rates especially in this time that we are faced with. Everybody is having difficulties, everybody is faced with the different challenges related to COVID...The rates must be addressed for the people of this Territory," Hon. Turnbull added.

# **Premier Elaborates about Displaced Vincentians Assistance**

The government announced more than a week ago that there is an intention to accommodate some of the displaced persons from the volcano zone in St Vincent and the Grenadines. However, Premier and Minister for Finance Hon. Andrew Fahie announced that some persons have approached him to discourage the plan to house the affected Vincentians. The discouraging news was divulged by the BVI Leader during the Other Business segment of the House of

Assembly sitting that was held on Thursday, 22 April.

Hon. Fahie began the disclosure by noting that the situation caused by the La Soufrière volcano in St Vincent and the Grenadines is a sad one. He told the House of Assembly: "When you look and see what our brothers and sisters are going through in St Vincent and the Grenadines; they not only have to contend with COVID 19 but they also have to contend with a volcano. Could you imagine that?"

In further empathizing Hon. Fahie said: "I told a lot of persons ...I can only imagine what our sisters and brothers ...in St Vincent and the Grenadines are going through experiencing a volcano while going through COVID 19." The Premier said that the Caribbean region has to try its best to help St Vincent: "Because today for them, tomorrow it might be us."

As it relates to those discouraging any assistance to the people of St Vincent the Premier

said that he is being approached by persons who are concerned about government's plans to help those affected. He told the House: "You are hearing persons tell you all manner of things. I go home and say God give me the guidance to do whatever you want done and what you would do because I understand the concerns of some persons of the suffering COVID 19 has brought on to the Territory."

Hon. Fahie who insisted that he will not be swayed by the few voices against the plan said: "So I am concerned when I meet persons who tell me about, 'don't help and leave that alone'. How could you? What Bible are you reading and how is your comprehension when you are reading? As a leader if you are asking me not to support a civic organization with their fundraising and not to support all the other organizations, the churches and what their doing...I cannot subscribe to that as a leader," Hon. Fahie declared.

It was designed to facilitate the innovation in the Financial Technology (FinTech) sector, allowing innovative financial solutions being tested in a defined and controlled environment. The approved participants will have 18 months (with a possibility of up to 6 months' extension) to conduct financial services business in the BVI, without the need to apply for a license. This regime creates a more efficient, pro-commerce yet regulated business environment, demonstrating the jurisdiction's commitment to its mission of building the leading digital International Financial Centre.

The first approved participant, a client of Bank of Asia who is affiliated with a well-known major Crypto Exchange, was introduced to this regulatory sandbox by the Bank. The latter also facilitated the whole application process and was instrumental in the successful delivery of this project, which is a strong testimony of Bank

of Asia's capacity in managing projects related to the Sandbox Regulation for its clients.

# **BVI Welcomes Vaccinated Tourists**

The BVI is going to ease travel restrictions effective from 15 May 2021. After officially restoring the ferry services, the Territory is opening its doors to documented vaccinated tourists.

Those who have received both doses of a two dose vaccine (including AstraZeneca, Pfizer-BioNTech, and Moderna) or one shot of a single-dose vaccine (like Johnson & Johnson) will be tested with a PCR test upon arrival and

released from quarantine as soon as it comes back negative.

"These vaccines are shown to be effective in preventing severe COVID-19 symptoms and deaths. They also reduce transmission of the disease in settings where vaccination rates are high. However, these vaccines do not eliminate the risk of transmitting the virus from a vaccinated person to a non-vaccinated person," Carvin Malone, the minister for

health and social development, said in a statement. "This is why we have been encouraging everyone to get vaccinated while the vaccines are freely available, to protect both themselves and the people around them from the increasing risk of severe sickness and death."

When faced with the need to get a COVID-19 test, it's important to know that not every test is created equal, with different levels of accuracy as well as the time it takes to get results back. Some countries will only accept RT-PCR tests — considered the most accurate — while others will accept proof in any form of negative test to enter. All viral tests detect a current infection and are most accurate when "the person is tested when viral load is generally highest," the CDC explains.

A RT-PCR test (or reverse transcription polymerase chain reaction) uses Nucleic Acid

Amplification Tests (NAAT) to detect genetic material. NAAT's can be performed with a nose swab — with something that looks like a long Q-tip — or with saliva.

Unvaccinated people can also visit the British Virgin Islands, but must show a negative PCR test taken within five days of arriving, register to travel on the BVI Gateway App, get tested on arrival, quarantine for four days, and then get tested again on the fourth day.

# BVI to Introduce new travel requirements for **Fully Vaccinated Travellers**

Minister for Health and Social Development Honourable Carvin Malone has announced recent Cabinet decisions to change the border requirements to enter the British Virgin Islands.

Honourable Malone stated that effective May 15, 2021 fully vaccinated persons travelling from overseas would require a PCR test within five (5) days of travel, provide satisfactory evidence of being fully vaccinated, and will be subject to a PCR test upon arrival (day zero). Fully vaccinated persons will be quarantined until a negative test result is received from the BVI Health Services Authority.

Honourable said, "In other words, if the test administered on arrival returns a negative result, the fully vaccinated traveller will immediately released from quarantine unless they have been in close contact with a positive case."

Minister Malone explained that a person is deemed to be fully vaccinated against COVID-19 two weeks after they have received both doses of an approved two-dose vaccine, such as AstraZeneca, Pfizer, or Moderna or one shot of a single-dose vaccine such as Johnson & Johnson.

that effective 15th persons who have been present in the Virgin Islands for a period of more than fourteen (14) consecutive days and travel to the USVI, St. Martin, or Puerto Rico for a period not longer than 24 hours are exempted from quarantine and the COVID-19 test upon reentering the Territory. However, day-trippers

around them from the jurisdictions would be increasing risk of severe required to take a PCR test seven (7) days after Cabinet also decided returning to the Territory.

Honourable Malone May fully vaccinated also outlined the new restrictions on the assembly of persons outlined in the Public Health (COVID-19 Control and Suppression Measures) (No. 3) Order, 2021 comes into effect today, April 23. The restrictions include, gatherings among vulnerable persons are not to exceed five persons, as certified by the Chief Environmental Health to these neighboring Officer. It also states that

all other gatherings are limited to one person per sixty-four (64) square feet and shall not exceed two hundred (100) persons at any given time; except faith-based services; graduation ceremonies; wedding ceremonies; or funerals which should not exceed two hundred and fifty (250) persons.

Honourable Malone said, "In relaxing the travel requirements for persons who have been fully vaccinated, and permitting larger gatherings, there will be an increased risk of exposure to the virus that causes COVID-19 among the resident population. This is why other prevention measures such as maskwearing, hand washing, and physical distancing will remain in effect, and vaccines continue to be widely distributed while they remain in stock."

# Contribution by Premier Andrew A. Fahie on Standing United in the Face of Crime

20th April, 2021

Thank you, Mr. Speaker, for allowing me the opportunity to address this Honourable House.

To all Honourable Members I say

good day and God's Blessings.

And to the wider national community who are following these proceedings virtually, I greet you in BVILOVE.

Mr Speaker, yesterday evening, the people of this Virgin Islands community, were greeted with the tragic news that one of our sisters was snatched from us by the selfish, foolish and senseless actions of someone who lives among us

I am referring here, Mr. Speaker, to the victim of an armed robbery incident, which occurred last Sunday night, 18th April, 2021, in the Paraquita Bay area. The Royal Virgin Islands Police Force has not officially released the name, but, since we started I noticed that the name has been release, which is Mrs. Pickering, so I wouldn't go any further in that because I respect their protocol.

What we do know is that the victim's daughter was exiting her vehicle when the daughter was accosted by an armed bandit who demanded her valuables. The victim, meanwhile, was emerging from her home when the bandit turned and fired his gun, hitting the victim. The victim succumbed to her injuries yesterday afternoon, as I am advised.

Mr. Speaker, I know I speak for this Government and this entire Honourable House when I say on behalf of the Government and people of the Virgin Islands, and on my own behalf and that of my family, and all of us from Districts 1 to 9, I offer condolences to the bereaved family and loved ones. We are a small, close-knit community in the Virgin Islands, and when things like this happen, we all feel it. So, we are all in pain and we are all in grief.

This incident is the latest in a trend that has been slowly developing once again in our community.

But, Mr. Speaker - and I want the wider community to hear me, there is no excuse for engaging in criminal behavior. There is no justification for taking up arms to prey on fellow members of the community. There is no justification for hurting any other human being or, worse yet, taking their life.

If you need food for your family, there are a number of non-governmental organisations and churches that help the needy. All you have to do is ask. Ours is a society of BVILOVE, and members of our society frequently donate food stuff and other necessities to these organisations. In the BVI, we help one another when persons are in need.

Mr. Speaker, a society is a construct in which people live and work together in an agreed structure, with agreed rules and based on respect for one another.

In the BVI, we have prided ourselves in having a society of peace and goodwill towards our fellow men and women.

Persons who willfully and maliciously breach the rules, values and principles of our society; persons who willfully and maliciously endanger the welfare and safety of the wider community; and persons who would live among us and prey on us like wolves in sheep clothing; breach this covenant.

They are not deserving of our trust and our protection, and they are a danger to us all and a danger to all that we hold dear.

Mr. Speaker, your Government condemns in the strongest way possible the lazy, cowardly and despicable actions of the handful of persons among us who refuse to live in BVILOVE and who do not care about the hurt they cause to people or the injury they cause to our Territory's good name, as they betray every good thing that we the Virgin Islands people stand for in their selfish pursuit of materialism.

#### We condemn it.

And I urge all our people in all our communities, regardless of political persuasion, regardless of where you are from – once you call the BVI home, let us unite in BVILOVE to fight this evil that is creeping into our society.

We need, as parents, teachers, churches, civic organisations, as leaders to reinforce it in all our people's minds especially our young people's minds that this is not the way, this is not the BVI.

We need to stand up and protect our society and our peaceful way of life. Proverbs 13:24 states, "He who spares the rod hates his son, but he who loves him is careful to discipline him."

If you see something, if you know something – say something.

Let each one, teach one and reach one. So we can secure the protection and safety of the people of the Virgin Islands.

Today, because of a senseless act, a family is now without a mother, a family is now without a grandmother, a family is now without a wife, a community has lost a good friend.

Mr. Speaker I urge the people of this Territory, if you have any information on this criminal

SANTO DOMINGO - State prosecutors announced the court accepted to incorporate the agreement signed between the Attorney General (under former AG Jean Alain Rodríguez) whereby Odebrecht had accepted to pay the Dominican government US\$184 million in compensation for the US\$92 million in bribes paid to expedite government contracting by the company in the Dominican Republic. Of this amount, Odebrecht had only paid US\$60 million before declaring bankruptcy.

Also accepted by the court were the minutes of the raid on the offices of the Brazilian construction company in Santo Domingo, where reportedly several of the contracts for works that the construction company allegedly obtained in exchange for bribes to former public officials were seized.

Speaking for the prosecution, Mirna Ortiz told journalists that the incorporation of the agreement as evidence against the six accused in the case is "extremely important", because it includes Odebrecht's admission of guilt that it paid bribes in the Dominican Republic.

The defense of the six accused in the case has downplayed the importance of the alleged evidence. [DR1]

**ST. VINCENT** - Lead Scientist of the La Soufrière Monitoring Unit, Professor Richard Robertson announced that the first time the team was able to successfully measure sulphur dioxide (SO2) flux at La Soufrière, occurred on Thursday, 15th April when Gas Specialist Dr. Thomas Christopher (UWI-SRC/MVO), with the assistance of the SVG Coast Guard, conducted the measurements.

These measurements add to a third element to the unit's monitoring tools - seismology and ground deformation being the others. The presence of sulphur indicates that fresh magma from a deeper source is present and could trigger continuing eruptions.

Tons of potentially dangerous ash were deposited here in St. Vincent and the Grenadines and as far east as Barbados and now there is confirmation of emissions of sulphur dioxide (SO2). The UWI SRC noted, "Along with the ash, it (SO2) can be picked up by the planetary winds - in our case the jetstream can be dispersed across the globe." [The Vincentian]

**PHILIPSBURG:**— A young boy is badly injured and currently at the St. Maarten Medical Center taking medical treatment after he was run over by a scooter in St. Peters in the vicinity of the ballpark.

Police Spokesman Joe Josepha said that the young lad is in critical condition.

Police also arrested the scooter rider who is also wanted by police.

The preliminary investigation shows that the minor was attempting to cross the road when he was struck by a motorcyclist who was riding at such a high speed that he could not stop in time to avoid the child. [SMN News]

PUERTO RICO - The Trump administration held up \$20 billion in hurricane relief for Puerto Rico and then obstructed an investigation into the delays, said a federal inspector general's report, according to a story published Thursday by the Washington Post.

Congress requested the investigation into what the Post called "bureaucratic delays" of recovery aid for Puerto Rico after hurricanes Irma and Maria hit the island in September 2017.

"But, the report said, former Housing and Urban Development [HUD] Secretary Ben Carson and another former HUD official declined to be interviewed by investigators during the course of the examination that began in 2019," the Post said. "Access to HUD information was delayed or denied on several occasions. Several former senior administration officials in the Office of Management and Budget [OMB] refused to provide requested information about decision-making related to the Puerto Rico relief funds."

Delays and denials of access and refusals to cooperate negatively affected the ability of the inspector general to conduct the review, according to the report, the Post said.

"The 46-page report presents an incomplete picture of the political influence of the Trump White House on delaying disaster relief for the

struggling island," the newspaper reported.

"Still, Inspector General Rae Oliver Davis, appointed by Trump as top HUD watchdog, found unprecedented procedural hurdles set by the White House budget office -- in addition to an extended partial federal shutdown that also produced delays."

The Post reported that the OMB required HUD's notice of grant funds to go through an interagency review process before approval, preventing HUD from publishing its draft notice of funding by its target date. [San Juan Star].

JAMAICA - A man was fined \$50,000 after pleading guilty to stealing a police officer's phone, which was found hidden in his crotch. Deuton Morris was charged with simple larceny and malicious destruction of property when he appeared in the Kingston and St Andrew Parish Court. Morris has an impending murder case. The court heard that while he was in custody relating to that case, the complainant, who is attached to the court, left her phone on a table. It is reported that Morris took up the phone and when he was returned to police lock-up, the cop's phone was found in his crotch area. However, Morris said he was given the phone by another person who was also in custody. [Jamaica Star]

ROME - Sales of vinyl records surpassed those of CDs in value terms in Italy in the first quarter of this year for time since 1991, according to Deloitte data compiled for Italian music industry federation FIMI.


It said revenues from record sales were up 121% compared to the first quarter of 2020, taking them slightly above earnings from CDs, which were down 6%.

Vinyl records now account for around 11% of revenues on the Italian music market, which is dominated by sales via streaming, which have 80%. (ANSA).

SPAIN - A little more than a year ago, the Spanish labor market suffered an unprecedented blow from the coronavirus pandemic. The number of contributors to the Social Security system - which is considered a measure of job creation - started to fall on March 12, just days before the Spanish government declared a state of alarm to control the spread of the pandemic. Under this emergency measure, public-facing businesses were closed and all Spaniards were ordered to remain at home. By the end of the month, nearly 900,000 people had lost their job as a result of the lockdown.

The number of Social Security affiliations fell even further in February,



when they hit their lowest point. From that moment on, employment figures began to recover but more than one year later have still not returned to pre-pandemic levels. According to new data released by the Labor and Social Security ministries on Tuesday, there are nearly 440,000 fewer contributors to the Social Security system than there were in mid-March, when the 18.9 million were recorded.

Meanwhile, unemployment has also risen during the pandemic. In the last year, 401,328 people have lost their jobs. In March of this year, the number of jobless claims fell by 60,000, pushing the total number of people registered as unemployed below the four-million mark.

However, the job market figures from the pandemic should be considered with caution, given the central government's efforts to mitigate the economic fallout of the coronavirus crisis with public aid, such as the ERTE employment retention scheme and subsidies to self-employed workers. [El Pais].

# POLICE CHARGE THREE --TWO FOR MURDER/ROBBERY, ONE FOR AIDING

Wednesday, April 28 – The RVIPF Major Crime Team today charged two males with murder and robbery, and one female with aiding in the incident that resulted in the fatal wounding of Catherine Pickering on April 18.

Charged with murder are Akeem Hopkinson, 22 and Shameek Grant, 28 both of Zion Hill. Both males were also charged with the possession of a firearm with intent to endanger life and jointly charged with Shermar Richardson for robbery in the same incident.

In addition, one female, Tyann Smith, 20 of Freshwater Pond was charged with aiding offenders in this incident.

Commissioner of Police Mark Collins had noted in a broadcast last week that his detectives were continuing to move meticulously through the inquiry process to ensure no stone is left unturned. He said he was fully confident that the officers in charge were competent, experienced and knowledgeable.

"Early this morning I was able to visit the detectives at the station and congratulated them personally for their diligence in this matter. I am very pleased with the swift actions and work of these detectives. I also made a call to Ms. Pickering's daughter to apprise her of the new developments.," the Commissioner added.

Last week, Shermar Richardson, 24, of Gene Hill was charged with robbery in the same incident.

# Reversing a criminal culture

The Virgin Islands is threatened by a seemingly irreversible criminal culture. Is there hope that it will be reversed?

Rising drug, gun, and gang crime, threatens to destroy Virgin Islands community.

Now at the root of crime, whether here in the Virgin Islands, or elsewhere, is neither poor policing nor poor social leadership. It is materialism, and greed.

If one aspect of Christian Scripture rings true it is the fact that the love of money is at the root of all evil. The preceding is a great statement of what is taking place in the Virgin Islands today.

OK, only a fool will state that cash is not king. That is a simple fact. Wealth is power.

However, when wealth becomes god it tends to become a slave driver and places a society in bondage. That is clear from purely capitalist societies such as the USA, and places where money rules in governance and society such as in Russia, Nigeria, and Colombia. These societies become violent and ruthless. The creed: the survival of the fittest rules. That is never a good place to be, especially for the vast majority of the population.

Greed at the top drives crime down below. When leaders wonder what is happening with our community and delinquent kids, they simply have to look in the mirror.

It is sheer hypocrisy to be alarmed at the violence and death on the street, while the men at the top live like kings on white collar crime, or perpetuate crime through their willful neglect, or even indirect support for crime.

The fact is crime in the Virgin Islands is a systemic issue. It is more than the actual criminal activities: drug busts, gun crime, robbery, murder, sexual assault, public corruption, and fraud. Crime is a problem of culture and social behavior that sits in the social DNA. Crime is about us, not criminals who are caught red handed.

When criminals are glorified, and the youth look to drug barons as their role models, then the country is given over to the devil, literally. Anarchy rules when the respect for the rule of law disappears and we can no longer tell the difference between good and bad.

That is what has happened in the Virgin Islands.

In 2012 this Old Boy wrote an article that foreshadowed the present dilemma.

He wrote that poor parenting, and the lack of a positive male role model and father figure, for thousands of Virgin Islands children and youth, is creating enormous social and educational trauma in this small country.

He further asserted that neglectful parents and missing fathers are at the root of the emergence of a VIRGIN ISLANDS UNDERCLASS.

This he stated was an epiphany that would create a socially divided community in the coming years. This would be a social division based upon education, wealth, and power, with a tiny and privileged minority in tight control of the country, and selfperpetuating.

Social inequality is a driver of crime. Socially equal societies such as those in Northern Europe have far

less crime than societies where there are vast social inequalities. And the effects of poor parenting, negatively affecting thousands of our young people, will actually be the herald for greater social division and new elite in the BVI, as a whole generation of mediocre and dysfunctional underperformers comes of age.

Paradoxically it is the poor and underprivileged who will suffer most in a crime ridden community.

There is coming a ruthless form of social division. The most skilled, brightest, and best educated minds, will sit at the top of the social pyramid.

The upper classes, who,

possess the wealth and power will live in gated homes and mix with their own social class.

Sadly, this coming class division will also spell an increase in crime and violence among the have not's. with the new elite living a privileged life, separated from the rest of the struggling majority, both physically and socially.

The older generation is accepting of social inequality and is willing to accept the social order. The younger generation of residents under 30s is not. They will resort to crime to redress the imbalance.

Homes in the Virgin Islands are becoming increasingly fortified. and this is evidenced by a mini boom in the market for security and surveillance products. It is a pointer

to a socially divided community.

The tendency towards personal preservation and home security will evolve into a new regime of gated communities in specific areas. This will be the physical manifestation of the separated, exclusive, and new elite.

The Virgin Islands upper class be separated from the underclass, as inequality based upon possession of unique and specific educational credentials, skills sets, and family connections, becomes the single entry to wealth and power.

Violent crime will simply be a manifestation of this new social division.

# Keep It Simple in the Kitchen on Mother's Day

My husband's culinary skills begin and end with making a great pot of coffee. With that in mind, I've created a simple Mother's Day dinner recipe that even a non-cook can successfully follow. Preparing a meal is one of the best ways to show someone you love them. After all, the origin of Mother's Day is rooted in a daughter's love and respect for her mother.

In 1905, after her mother's death, Anna M. Jarvis began a campaign to recognize her mother's work as a community activist and peace advocate, and to honor her memory. It took several years, but in 1914, President Woodrow Wilson signed a bill recognizing Mother's Day as a national holiday. The House of Representatives also adopted a resolution recommending that officials of the federal government wear white carnations on Mother's Day.

**Here's a simple recipe for Pasta With Spinach.** The step-by-step directions will ensure a successful result for even the most unskilled cook, and create the perfect meal for the Moms we love.



#### **BEGINNER'S PASTA WITH SPINACH**

- · 8 ounces angel hair pasta · 1 gallon cold water
- 4 teaspoons salt (for water)
   2 tablespoons unsalted butter
- 2 tablespoons olive oil 1 can (14.5-ounce) diced tomatoes
- 1 tablespoon Italian seasoning spice
- 1 package (10-ounce) prewashed baby spinach
- 1/2 cup sour cream or feta cheese 2 tablespoons prepared basil pesto

#### TO COOK THE PASTA:

- 1. Fill a large, tall stockpot with the water, turn heat to high and bring water to a hoil
- When water begins to boil, add the salt. (Adding the salt to the water now is necessary because it's the time when the pasta absorbs it best. Do not add oil of any kind. Oil will coat the pasta, and the sauce will not stick.)
- 3. Hold the pasta vertically over the boiling water and carefully slide it into the pot. Lower the heat to medium so the pasta water doesn't foam up and boil over the sides. As the pasta begins to soften, use a long fork or wooden spoon to push the pasta into the water until it's submerged.
- 4. Turn the heat back up to high. Stir the pasta to keep it from clumping together. Stir every few minutes as needed to keep the pasta separated.
- 5. After 6 to 8 minutes, use the fork or spoon to pull out a piece of pasta. Taste it to see if it is soft, not raw or starchy-tasting. The pasta is done when it is "al dente," which is Italian for "when it is right for the tooth," and refers to the correct cooking point of pasta. If the pasta isn't done, let it continue to cook another 2 or 3 minutes until it's soft but firm -- not mushy or overcooked.
- 6. Fill a coffee cup with some of the pasta water and set it aside to use when making the sauce.
- Place a large colander in the sink. Using potholders to protect your hands, carefully move the pot to the sink. Carefully drain the pasta into the colander.
- 8. Pick up the colander with the potholders and shake it well to remove any excess water from the pasta. Do NOT rinse the pasta.
- 9. Place the drained pasta back into the large pot and start making the sauce.

#### TO MAKE THE SAUCE:

- Using a large saucepan, over medium-high heat, melt the butter and add the olive oil. Add the tomatoes, Italian seasoning and spinach, a few handfuls at a time, and stir to combine.
- When the spinach begins to wilt, stir in the sour cream or feta cheese and the pesto.
- Pour the sauce into the large pot containing the drained pasta. Turn the heat to low.
- 4. Mix the sauce and the pasta together until well-combined.
- 5. Use a 1 or 2 tablespoons of the pasta water to thin out the sauce, as needed.
- Place the finished pasta in a large bowl and serve immediately with garlic bread or rolls. Serves 6.

# 24 Hour quarantine possible with protocol entry update

Fully Vaccinated Visitors Free to Roam The Destination after Negative COVID-19

#### **Arrival Test**

Tortola, British Virgin Islands, 26th March, 2021 Beginning 15th May, 2021, fully vaccinated passengers arriving in the British Virgin Islands will be free to explore the destination after returning a negative Arrival (Day 0) test result. This news was announced by Minister for Health & Social Development, Honourable Carvin Malone on Friday, 23rd April.

The minister confirmed that fully vaccinated persons arriving from overseas, will be required to take a PCR test within five days of travel to the Territory, provide proof of full vaccination, and take a PCR test upon arrival (Day 0). Once they receive a negative test result from that test, they will be free to enjoy their vacation throughout the Territory. This means that they will be able to forgo the four day quarantine still required for arriving passengers that have not been fully vaccinated.

Director of Tourism Clive McCov in reacting to the news said, "This is great news and timely, as more guests are arriving fully vaccinated and many in our industry have stepped forward to take the vaccine in support of economic rejuvenation. The Territory already has an enviable record for health and safety during the pandemic and have continued with its strategy of gradual reopening based on international conditions and the local situation. Any progress in that direction augers well for tourism and for the economy, and this is a very significant step."

Under this updated protocol a person is deemed to be fully vaccinated against COVID-19 two weeks after they have received both doses of an approved two-dose vaccine, such as AstraZeneca, Moderna or Pfizer vaccine or one shot of a single-dose vaccine, such as Johnson & Johnson. Meanwhile the Ministry of Health continues its drive to vaccinate up to 70% of the resident population, so far vaccinating over 9,000 persons.

#### Biden's Initial Steps to Repair Global Ties Receive Praise in Europe, Asia By Jamie Dettmer, Updated April 27, 2021

European leaders and other a switch in the Oval Office can American allies say President Joe Biden has done much in his first 100 days in the White House to start rebuilding confidence in U.S. leadership.

But while agreeing with his key foreign policy goals, including confronting the global rise of authoritarianism, they are still taking the measure of the Biden administration — as are America's foes, say analysts and diplomats.

They say the 78-year-old Biden has already shown how prompt significant political change with a promise of more to come, not only in the United States but across the globe.

Observers in Europe and Asia praise the U.S. leader for his emphasis on multilateral cooperation and the need for a coordinated global effort to tackle climate change. The fresh emphasis on the importance of alliances is a sharp break with Biden's immediate predecessor, Donald Trump, they note.

# **Biden to Address Joint Session of Congress**

U.S. President Joe Biden is expected to discuss his goal of engaging with other nations and taking a leadership role on the world stage as he gives an address Wednesday night to a joint session of Congress.

White House Press Secretary Jen Psaki said ahead of the speech that Biden's comments on foreign policy would include "taking America's seat back in the world, what our values are as a country." She said the president would likely talk about a number of foreign policy priorities, "including our engagement with China."

The Biden administration's push to work more with allies, which this month included coordinating with fellow NATO members on the withdrawal of troops from Afghanistan, is a departure from four years of foreign policy under former President Donald Trump that focused on prioritizing U.S. interests.

House Speaker Nancy Pelosi invited Biden to the House chamber to speak about "vision for addressing the challenges and opportunities of this historic moment," in a speech that comes as the president marks 100 days since taking office.

Psaki said the main policy initiative Biden will highlight is a domestic program for "investment in education and childcare."

The proposal involves \$1.8 trillion in spending over 10 years that includes universal preschool, two years of free community college, subsidized childcare for qualifying families, monthly payments of at least \$250 for parents and expanding availability of free and reducedfee school lunches. Administration officials say Biden is proposing to largely pay for the initiatives with tax increases on the wealthiest Americans.

Psaki said Biden will also discuss the administration's efforts to combat the coronavirus pandemic and unemployment, as well as immigration, police reform and gun safety.

The administration is planning the speech as a launching point to seek support for Biden's initiatives, with the president, Vice President Kamala Harris and members of Biden's Cabinet planning to travel to different parts of the country for events on Thursday and Friday.

Republicans will seek to counter Biden's message with a rebuttal speech Wednesday by South Carolina Senator Tim Scott.

Typically, a presidential speech before a joint session of Congress would include an invited audience of the 535 members of the House and Senate, the vice president, Cabinet members, the Joint Chiefs of Staff, Supreme Court justices, members of the diplomatic corps, and a number of special guests sitting with the first lady, some whom the president notes in the speech as a way of highlighting a certain policy.

Wednesday's audience will be more restricted. Chief Justice John Roberts is expected to be the only justice in attendance. Psaki also said there will not be the traditional box of seating with first lady Jill Biden and guests, and that Cabinet members will be watching the speech from home.

Not having Cabinet members in the House chamber also eliminates another tradition linked to presidential addresses. In order to ensure continuity of government in case of a disaster, one Cabinet member is typically selected to stay away from the Capitol so that high-level officials are not all in the same place.

Wednesday's speech will be conducted under heavy security, with a ring of fencing still standing in the immediate area surrounding the Capitol following the January 6 storming of the site by Trump supporters. Security has eased somewhat in Washington since the attack, with a more extensive perimeter fence on Capitol Hill and another temporary fence extending beyond the White House complex now removed.

# Farrington became fastest 800m youth with BVI's No 7 mark By Dean "The Sportsman" Greenaway

When Jashani "Jahferre" Farrington toed the line in Saturday's Dag Samuels Development Series 800m, coming from a background of participating in different sports unlike his rivals who have been track dominant athletes, he was putting his musculoskeletal development through a stern test.

By time Farrington crossed the line in the 2-lap race and stopped the clock at 1 minute 57.56 seconds, he had run the fastest 800m by a BVI athlete since 2013. In the process, he shattered Tarique "Tweety" Moses' 2011 National Youth Record for U18 athletes of 1:59.00 and landed on the BVI's All Time List as the No 7 performance, since the BVI Athletics Association was formed in 1970.

"An 800 is two laps. For the first lap you pace yourself and on the second one, you put in some more work until you reach the 300m and then you go from there," Farrington told Island Sun Sports, noting that he was surprised to break 2:00.00. "My coach told me if I did what he told me to do, I'd take it"

Farrington who challenged his rivals during the 2020 Elmore Stoutt High School inter-house sports day and was narrowly edged on the line by Jelani Croal, 2:09.61—2:09.64 and relegated Croal to a distant second on Saturday in 2:06.74, said he has been playing basketball, volleyball, baseball and tennis before turning his focus to track now.

"They say, I'm a person that has energy, which is good so just put my effort into it," he said of the 800m, where he easily beat his rivals whose only sport has been track. "They (teammates) said don't worry about them and I can be the fastest of everybody," he said. "The plan is to keep working."

#### Malone's consistency

As she prepares for the delayed 2020 Tokyo Olympic Games qualifying round of the Women's Long Jump on Aug 1, Chantel Malone is showing consistency. The territory's standard bearer had the best series of her career under all conditions, with three jumps over 7.00m on Saturday, at the Chula Vista High Performance Meet #2 in Chula Vista, California. She cut the sand at 7.06m (23'2"), (+4.7) on her second attempt, 7.05m (23'1½"), (+1.6) on her third and 7.10m (23'3½"), (+4.7) on her fourth, as winds robbed of her of a new personal best.

In the process, she relegated 7-time IAAF World champion and Olympic Games gold and silver medalist Brittney Reese of the USA to second, with her 7.05 m (23'1½") (+2.4) effort.

Meanwhile, Olympic hopeful Ashley Kelly had 200 and 400m season's best, competing in the Tru Fit Athletics Series in Miami. Kelly ran 23.72 seconds (+2.0) over the half lap to win her heat and was fourth overall. She lowered her 400m season's best to 54.21 seconds.

#### Collegiate Scene

On the Collegiate scene, 9 of the territory's 13 athletes on collegiate rosters saw weekend action. New Mexico Jr. College Sophomore Djimon Gumbs, became the 5th BVI athlete to throw the Javelin over 50m with his personal heave of 50.53m (165'9) to finish fourth at the Don Kirby Open in Albuquerque, New Mexico. His mark is No 5 All Time. Twin brother Diamante upped his Shot Put personal best form 15.43m (50'7½") to 15.88m (52'1¼") in winning the event, the No 4 All Time BVI mark. Djimon was 7th with a 14.10m (46'3¾") effort. Diamante was2nd in the Discus Throw, extending his personal best from 50.22m (164'9¼") to 50.39m (165'4").

At the same competition, UTEP Freshman Josh Hill, was sixth in the 400m, with a time of 47.69 seconds.

Clemson Sr. Lakeisha "Mimi" Warner, ran a 400m season's best of 58.44 seconds, to finish third at the UCF Knights Invite, in Orlando, Florida. At the same meet, South Florida Sr. Akeem Bradshaw, was 3rd in the Long Jump with a season's best leap of 7.08m (23′2¾″).

Indiana Sophomore Rikkoi Brathwaite, won the Big 10 Relays 100m in 10.46 seconds, in a meet in Champaign, Illinois.

Zara Brown, a Southwest Baptist Freshman, was third in the Pittsburg State University Tune Up 100m.

She had a wind aided 11.70 seconds (+2.3) in the final, after running 11.83 (+3.8) in the prelims.

Last weekend, Utah State Freshman Xiomara "Gia" Malone, made her Collegiate Heptathlon debut, scoring a personal best 4358 points, No 2 on the BVI All Time List. Her mark is 97 points shy of Arianna Hayde's 4455 mark.

# Talbot tops Leroy in Nanny Cay to Belmont race By Dean "The Sportsman" Greenaway

After narrowly finishing second by a point to Mark Stephenson on Chris Haycraft's Ting A Ling during Saturday's Governor's Cup on Barney Cook's Airgasm, Sam Talbot was looking forward to racing Phillippe Leroy in Sunday's BVI Mountain Bike Club's Nanny Cay to Belmont and return race. Leroy missed the season opener on Beef Island, which Talbot easily

Both riders with a developing rivalry, knew what was at stake and played a little cat and mouse. However, in Belmont, there was some confusion on how riders interpreted the course, which became part of a postrace debate.

"It was good fun, actually a little wet," Talbot told Island Sun Sports: "The down hills in the back section (of Belmont) and it was a pretty solid pace set by everyone down and back up. I'm shattered."

Talbot said finally facing Leroy was good fun and they rode the return upwind leg together. "He was tough to keep up with, I'll say that," Talbot said. "Especially on some big nobly tires, but it was a lot of fun. On the way back, we had a discussion on who did what course and he let me go ahead because there was a committee on which course, so we came to an

agreement and I emptied my tank, so he could have passed me if he wanted to."

Leroy who has dominated BVI cycling over the last 25 years, said it was time that someone came along to replace him.

"It's going to take the pressure off me, which would be nice," he noted, saying that the course was great. "There was a bit of confusion on which way to go inside Belmont. I went up the hill and saw someone in front of me and I thought it was Sam, and I was like 'ooh, I'm catching him up—it was someone who took a shortcut by mistake and then Sam caught me on the flat," Leroy recalled following the race. "I was like, 'ooh, that's weird' because he's to be in font. We rode together all the way to the end and he won just at the finish, that was great."

While Talbot is a great sailor, Leroy said he thinks Talbot is more of a cyclist, as he's very strong.

"I did a couple of time trial road races with him and he really beat me well,"Leroy noted. "I was amazed by the time he beat me by. A very, very strong guy."

Leroy said he's surprised by Talbot's power, speed and he has already beaten three of his King of the

Mountains, while he can't beat his previous times nowadays. "He's a big guy and I'm smaller so normally on those hills," Leroy said. "I'm supposed to keep my King of the Mountain, but because he's bigger, he's got more power, but he's strong."

# Less outrage at US caution on travel more action to open economies

In Antigua and Barbuda and Barbados there is outrage in some quarters that the US Embassy, accredited to these countries, has listed them as 'Level 4 – very high' for risk of infection with the coronavirus. Under this categorization, the

US Embassy cautions their citizens and residents not to travel to these countries.

Even though it may be based on misunderstandings of the criteria being applied by the US Embassy, the outrage is understandable for two reasons. First, Antigua and Barbuda and Barbados rank at 26

and 33 respectively of the countries that have inoculated a high percentage of their population with at least one dose of a vaccine. Antigua and Barbuda has vaccinated 29.4 percent of their inhabitants and Barbados 24.75 per cent as of April 22. Second, the numbers of infected persons are declining in both countries.

These factual situations suggest that the two countries should not be on the highest level of caution to US residents who comprise a significant number of the tourists to the Caribbean. However, to be fair to the US Embassy, its travel advisories have been issued in accordance with new measurements issued by the Centres for Disease Control and Prevention (CDC) in the US.

Under those new yardsticks, Antigua and Barbuda and Barbados join eight other Caribbean countries at 'Level -4'. These eight countries are among the main Caribbean competitors for US tourism. They are: The Bahamas, the Dominican Republic, Guyana, Jamaica, St Lucia, St Vincent and the Grenadines, US Virgin Islands and Saint Martin. Furthermore, much larger, and richer countries are also on the current 'Level 4' list, including Canada, the UK, Germany, Switzerland and Sweden. Therefore, the 'Level 4' categorization should not be regarded as an attempt to disadvantage Antigua and Barbuda or Barbados.

Through no fault of the governments or the health authorities of the two countries and, despite the herculean efforts that both have made amid gravely declining revenues, the single event that ran afoul of the new CDC criteria is the spike in the number of infected persons over the 28-day cycle, preceding the These spikes took Antigua travel advisory. and Barbuda and Barbados over the threshold set for infected cases per 100 persons of the population.

Regrettably, what this boils down to is the refusal of some sections of the population to follow the rules set down for masking and physical distancing. Those, who have ignored safety rules, contributed to spikes in the number of infected cases. Those, who now refuse to be vaccinated, are ready hosts for the virus to infect. They, too, are contributing to

the likelihood of increasing cases.

Governments understand both the frustration that people feel from living in the restrictions, caused by COVID-19, over the last year, as well as the fear that has been generated about being inoculated. Therefore, they have been systematically trying to ease restrictions,

> recognising that no country in the world can eliminate them while the pandemic prevails.

> Indeed, until at least 70 to 80 per cent of any country's population is vaccinated, the removal of restrictions, that everyone craves, will not happen. This is why everyone should be willing to endure the restrictions until

inoculation reaches herd immunity.

If the spikes in infection continue because of disregard for safety rules and refusal to be vaccinated, then the US and other countries will be constrained, in their own interest, to recommend that their people do not visit.

What all this says is that people in the Caribbean can influence the level of caution at which their countries are placed by the CDC in the US and by agencies in other countries. Those who choose to ignore the safety rules are endangering their own health and the persons with whom they are in most contact. They are also imperilling the livelihoods of everyone else in their countries by delaying the time when the economies can open, bringing back jobs; generating income and savings; and restoring freedom.

An observation of Dominican-born, Dr Carissa Etienne, the indefatigable Director of the Pan American Health Organization, is worth recalling: "Every person that is hesitant to get the vaccine can become part of the sad statistics – one of the thousands of deaths that occur daily due to COVID-19".

Given the current dire circumstances of most Caribbean economies, particularly the ones highly dependent on tourism, they need to open soon to have any chance of shortening a painful period to recovery.

Conversations will be held with the CDC in the coming days by diplomatic representatives like me and agents of health authorities – as has happened in the past – to review the level at which Caribbean countries are listed. The CDC has no interest in harming Caribbean countries. Once the rate of infection is reduced and testing and inoculations continue, the agency will adjust the level.

How soon Caribbean countries get to levels 2 and 1, removing travel cautions, is dependent on how committed Caribbean people are to making themselves as free as possible of the coronavirus.

This is not a time to be outraged at the efforts of others to protect their own; it is a time for Caribbean people do everything necessary to protect themselves.

## STRONG HURRICANES TO INCREASE IN NUMBER

One of the greatest hits of the early 1960s was Chubby Checker's "Let's Twist Again"; sixty years later the twist song and dance continues compliments of the extreme weather triggered by irresponsible industrial countries who have irreparably disrupted the weather patterns worldwide.

Killer tornadoes in ever-increasing numbers have been tormenting the United States. In case you did not know tornadoes occur in other countries such as Canada, Mexico, Argentina, Australia, China, Japan, and South Africa. European scientists say that up to 300 tornadoes per year touch down across the old continent. The United Kingdom has over 30 tornadoes per year; Germany, while boasting a lower average with just 10 per year, appears to be near the heart of Europe's stronger tornado alley, which generally runs from northeast France toward Poland. Tornado frequency is also relatively high in many areas along the Mediterranean Sea.

Some scientists prefer to be cautious, but most of them have no hesitation in stating that there is evidence that global warming has caused an increase in very heavy precipitation events -- the kind most responsible for major floods. Scientists are also gathering information that irrefutably proves that climate change has caused an increase in tornadoes, hurricanes, and severe thunderstorms.

It has now become clear that there will be a large increase in the frequency of the strongest hurricanes in the Atlantic basin as the climate changes from increasing anthropogenic greenhouse gas emissions.

According to "Science" magazine, the total number of very intense hurricanes (category 4 and 5) will increase in the future by 81% while the frequency of the most intense storms will increase by 250%. Hopefully, history will place the blame for global warming and its catastrophic consequences where it belongs.

Meanwhile, the most recent 2021 hurricane season forecast divulged on 19 April confirms that this year is most likely in for the sixth consecutive above-average year. First predictions have been released, and the message is straightforward: yet another very active hurricane season is expected in 2021. With a quite concerning notice that also an above-average probability of hurricane landfalls along the US coastline and in the Caribbean is likely.

# Lord (Tariq) Ahmad of Wimbledon on Covid-19, vaccines and the post pandemic future.

People in the Overseas Territories are accustomed to the challenges of handling natural disasters and living in relative isolation, but the COVID-19 pandemic unprecedented in the way it has impacted even the remotest communities around the globe. My experience of the Overseas Territories is that they are welcoming and close knit communities, so it was heartbreaking to see the impact of the virus when borders were closed, businesses shut and families separated. I know this has been particularly hard year for many in the British Virgin Islands, just as it has been in

the

United Kingdom where the virus saw a dramatic economic slowdown and sadly many deaths

I am proud of the fact that despite the situation we faced in the UK, we were able to support the Overseas Territories, and in the case of BVI, this included supplying

lifesaving COVID-19 vaccines. Since the outbreak of the virus, experts from the UK's public health organisation have provided remote support to BVI via regular teleconferences to discuss disease management techniques and medical equipment. The UK provided

testing kits, which more than doubled BVI's testing capacity. As of August 2020, the UK had supplied BVI with nearly 400,000 items of equipment, including testing machines, goggles, facemasks and ventilators.

In total the Foreign,
Commonwealth and
Development Office has
delivered over three million
items of medical equipment
to the Overseas Territories
since March last year. We have
recently been organising the
delivery of the vaccines to all
of the Overseas Territories.
Whilst the UK provided
material support, I have been

impressed by the way in which people across the Territories rallied together to keep their communities safe, and how the public servants and other key workers strived tirelessly to keep essential services running in these exceptional circumstances. In these difficult times we have seen the very best of people in our communities.

The pandemic has called into question all of the freedoms and certainties we took for granted, but it has also forced us to innovate and change our ways of working. We all hope that life will return to normal very soon, but we should expect that someaspects of life will have changed permanently as we move forward. Whilst this has

been a shock to many of us, this is actually an opportunity for BVI, especially as the world embraces remote working, placing the Overseas Territories with an opportunity to attract new talent and inward investment.

Likewise, as international tourism restarts and travellers look for destinations that have managed to control community transmission, the supply of vaccines from the UK gives the Overseas Territories a unique advantage to market themselves as safe places to holiday as we learn to live with COVID-19.

We need only look to Gibraltar, which had more than 1,200 active cases when the vaccination campaign began and has managed to reduce this down to zero, or St Helena which managed to vaccinate more than 90% of its adult population within four weeks. However, the supply of vaccines cannot be taken for granted and each batch has a limited shelf life. I implore

everyone who can, to take the vaccine, not only for themselves, but to protect their friends and family, and do their part to ensure we can re-open borders and restart our economies. Whilst the first wave of COVID-19 was a shock, we have seen the spread of more infectious variants in the UK, Gibraltar and

Bermuda, which were much harder to contain and led to more deaths. This is regrettably a phenomenon which many other countries are also experiencing. Now is

not the time to wait and see, the vaccines are safe and effective, by getting vaccinated you will be helping your community.

The pandemic illustrated how fragile global supply chains are and gave us reason to think about the resilience of our communities. As we restart our economies, we need to think carefully about what we can all do to protect the environment and halt global warming, which is disproportionately impacting island communities around the world.

This year the UK will host the 26th UN Climate Change Conference of the Parties (COP26) with the aim of stepping up global cooperation to tackle climate change. The Overseas Territories are an essential part of the British Family and we should use COP26 to showcase the excellent work in some Territories to protect globally important habitats, adapt to the changing climate and lead the shift towards renewable energy.

Working together, in a relationship based upon respect and partnership, the United Kingdom and the Overseas Territories can be a force for good on the world stage.

# The Best Remedy For Back Pain

Back pain exercises are much sought after these days because back pain is a common phenomenon amongst people under the age of 45 and can be rectified effectively only if the true cause behind the pain is identified. Barring a few exceptions, exercises for back pain are effective for all types of back pain, be it the pain in the lower back ore pain in the upper back. Exercises also provide a solution for back pain related to genetically or trauma related deformities and subsequent pain.



This is mainly because exercises to relieve back pain are safe and free from any possible side effects that is a possibility with other treatments for back pain.

However, back pain exercises may not prove to be effective in cases where the pain is not caused by an improper posture or sudden movements, jerks or is accompanied by bowel or bladder control problems. In such cases, it is advisable that the person suffering from backache consults a physician and gets a proper treatment.

The best way to avoid back ache is to maintain a proper posture and keep your muscles well conditioned by undertaking proper back pain exercises. One should never bend at the waist or stoop to pick up an object. Instead, we should lower our body to the level of the object by bending our knees.

The most common back pain exercise is to stand straight or sit on a comfortable chair that provides adequate support to your back. You should avoid sitting or standing in a single posture for a long time. Even while sleeping, you should be careful as to the type of mattress being used. Slouching or leaning forward should be avoided at all times. Yoga and mediation go a long way in relieving back pain and are very good exercises. Prevention, it is said is the best cure for back pain. You can avoid backache by undertaking back pain exercises on a regular basis. These exercises strengthen the muscles in the abdomen and the spinal area and ensure that there is adequate support to the spine. Wall slides, leg raises and leg swings are the best exercises and abdominal strengthening exercises prove to be effective in toning up our back muscles.





#### No Miracle Supplement Can Cure Heart Disease

DEAR DR. ROACH: I ran across a recent article of yours about carotid artery stenosis. In this article you state that "there is no miracle food, drink or supplement that can clear out arteries."

This is actually not true. I'd like to point out Dr. Dean Ornish's work as well as Dr. Caldwell Esselstyn's work on heart disease. Both doctors showed regression in coronary plaques in their patients who followed a whole food plant-based diet. One young patient who suffered a heart attack even saw complete reversal in his coronary artery blockage on a whole food plant-based diet.

I'd encourage you to check out their studies and books if you haven't done so already. Their work is very encouraging and shows that we do not have to succumb to heart disease. — K.G.

ANSWER: I appreciate your writing to give me a chance to make my point a little more clearly.

I do want to emphasize that the patient was asking specifically about YouTube videos for "food, drinks and diet regimens that clear arteries." I have seen some of these, which say, for example, all you need is a cup a day of lemon juice and turmeric to clear your arteries. There are health-care professionals in the media who tout simple cures to reverse heart disease. These are what I refer to when I say there are no miracle cures.

That is not what you are referring to in the work of Drs. Ornish and Esselstyn. Theirs was a significant lifestyle intervention, not a miracle supplement. Dr. Esselstyn did a small, uncontrolled observational study; Dr. Omish did a small controlled study. In the Esselstyn study, the diet was quite restrictive:

"Initially the intervention avoided all added oils and processed foods that contain oils, fish, meat, fowl, dairy products, avocado, nuts and excess salt. Patients were also asked to avoid sugary foods (sucrose, fructose and drinks containing them, refined carbohydrates, fruit juices, syrups, and molasses). Subsequently, we also excluded caffeine and fructose."

The Ornish study had a similar completely vegetarian diet, but 10% of calories from fat was allowed. In addition, there was (as there was not in Esselstyn) mandatory stress reduction time, and all smokers in the study quit. This study's results, proven by angiography, showed reversal in coronary blockages by 3% in five years, compared with 12% worsening in the control group in the same time.

Esselstyn analyzed the study by those judged adherent and nonadherent. For any subject who was judged nonadherent, 62% had coronary events. Less than 1% of adherent subjects experienced an adverse event.

Together, these studies show that in a group of extraordinarily motivated study subjects, coronary lesions can undergo regression with a multi-interventional approach including profound diet changes and sometimes other lifestyle interventions. These aren't miracle diets. It's an entire dramatic change in lifestyle.

Extreme lifestyle changes are not necessary to show benefit. In the PREDIMED study, a Mediterranean-style diet was recommended, with high amounts of fruits, vegetables, legumes, olive oil and nuts, with less red and processed meat, less commercial baked goods and spread fats, and less soft drinks. Those who were recommended this diet had fewer heart attacks, strokes and death than those who were in the control group and were recommended a low-fat diet.


