reluctant to take the COVID 19 vaccine and while Minister for Health and Social Development Hon. Carvin Malone is pleading with people to become vaccinated, he is also stating that this is part of the pandemic is a challenge government has to battle.

After enjoying an extended period of zero COVID 19 cases the situation has changed in the Territory with a reported 18 active positive cases as of 5 April. The increase in cases is being attributed to a funeral held on 27 March at the Sea Cow's Bay Methodist Church. The funeral, which was being referred to by members of the public as a super spreader event was attended by an individual, who health authorities said previously tested positive for the virus.


Following concerns over what was then a slowly growing number of cases, the Health Minister announced that the situation was not significant enough for Government to take any drastic actions. However, it was noted

Some persons in the Territory are that a series of mass testings were scheduled for the 6th through the 8th of April. This the Minister said would avoid any inadvertent spread of the virus.

> In a further update to the Territory on 5 April Hon. Malone announced that Government is viewing the situation as a crossroads of its COVID 19 control efforts. He told the public that the Government has been doing a lot to prevent further COVID 19 deaths but the onus at this time is on the public through vaccina-

> In noting that the BVI is now at a pandemic intersection Hon. Malone declared: "We have exhausted huge sums of money to keep us safe and to allow us to have low numbers of positive cases over the last year. We must now decide that we are going to go the extra mile, follow the science, and be vaccinated. This is the only way that the BVI will have a credible chance to restore livelihoods while saving lives. We are almost there!"

The Health Minister said that from the moment the virus became a pandemic in March last year the Government has been encountering resistance from the public in its effort to keep the population safe. He said, "The COVID-19 virus was declared a GLOBAL PANDEMIC on 11th March 2020. When this Territory recognized and began to battle this pandemic, we also had to battle the feelings of those who professed that: It was a Bill Gates conspiracy! It was a 5G conspiracy! It was a new world order conspiracy! It was a population control conspiracy!"

Hon. Malone said that the pushback to Government's efforts came from all fronts, including from members of the House of Assembly. "Here

at home, you must recall that there were those who scoffed at this Government's decisions "to lockdowns"; "to curfews"; "to quarantine"; "to PCR test"; "to stimulus packages" and indeed to every measure implemented. I will confess that after a year's experience of fighting this virus, and the negativity of some of our leaders, I now have a deeper appreciation for challenges faced by Noah and Moses," he declared.

The Minister said that everyone can now see that Government's actions so far have paid off and that there has been justification for the steps taken. "You must also remember or be reminded that as Minister for Health I proclaimed from the inception of this pandemic, that if this Territory followed the recommendations and observed the protocols, and if it resulted in minimum positive cases and minimum deaths then, at the end we will battle the very same persons – the very same skeptics who loudly voiced that none of what this Government did was required," he stated.

While further lamenting on the negativity the Government continues to face Hon. Malone said that some are waiting for an opportunity to say the government failed. "It was also professed that if the Territory did not follow the protocols, did not follow the recommendations and if it resulted in large numbers of positive cases and numerous deaths then, at the end we will battle the very same persons - the very same hindsight experts who will then

shout that this Government is incompetent and lacks leadership qualities because they drop the ball - if you may," he mentioned.

While Hon. Malone noted that each country and each territory must determine their conditions and vulnerabilities, he noted that there are concerning COVID 19 reports coming from countries in the region. The Health Minister further hinted that there are new strains of the virus in the Caribbean. "While the BVI numbers may not necessarily be alarming to some, based on the realities of the region and the world around us, we must continue to remain vigilant and proactive in our approach with this disease. There exists in our region, new and more aggressive strains; new and more deadly strains of the COVID-19 virus."

In consideration of the negativity and the new strains,

the Minister said that the BVI Government is becoming more aggressive in its efforts to prevent COVID 19 deaths. Towards this end, the Minister said that fines for those contravening pandemic protocols are going to be swift. Hon. Malone said that some persons were already fined. "Since the Social Distancing Taskforce has been activated over 150 tickets or fines have been issued. The message to persons caught violating the provisions of the safety protocols is simple and resolute - we will find you and we will fine you!"

"The Government takes these breaches very seriously because it is costly to lockdown! It is costly to businesses. It is costly to lives. All of our hard work and efforts for the last year will not go down the drain," Hon. Malone added.

Prince Philip Dies aged 99

Longest-serving Royal Consort

LONDON -AP - Prince Philip, the husband of Queen Elizabeth II who mind. Many believe his propensity to speak his mind meant he provided spent more than seven decades supporting his wife in a role that both defined his life, has died, Buckingham Palace said Friday. He was 99.

He fulfilled more than 20,000 royal engagements to boost British his own man, and that was a source of support to the Queen," said royal

interests at home and abroad. He headed hundreds of charities, founded programs that helped British schoolchildren participate in challenging outdoor adventures, and played a prominent part in raising his four children, including his eldest son, Prince Charles, the heir to the throne.

Philip spent a month in hospital earlier this year before being released on March 16 to return to Windsor Castle.

"It is with deep sorrow that Her Majesty The Queen has announced the death of her beloved husband, His Royal Highness The Prince Philip, Duke of Edinburgh," the palace said. "His Royal Highness passed away peacefully this morning at Windsor Castle."

Philip, who was given the title Duke of Edinburgh on his wedding day, saw his sole role as providing support for his wife, who began her reign as Britain retreated from empire and steered the monarchy through decades of declining social deference and U.K. power into a

modern world where people demand intimacy from their icons.

In the 1970s, Michael Parker, an old navy friend and former private secretary of the prince, said of him: "He told me the first day he offered me my job, that his job – first, second and last – was never to let her down."

The Queen, a very private person not given to extravagant displays of affection, once called him "her rock" in public.

In private, Philip called his wife Lilibet; but he referred to her in conversation with others as "The Queen."

In his later years, his image settled into that of droll and philosophical observer of the times.

Philip's position was a challenging one — there is no official role for the husband of a sovereign queen — and his life was marked by extraordinary contradictions between his public and private duties. He always walked three paces behind his wife in public, in a show of deference to the monarch, but he was the head of the family in private. Still, his son Charles, as heir to the throne, had a larger income, as well as access to the high-level government papers Philip was not permitted to see.

But having given up a promising naval career to become consort when Elizabeth became Queen at age 25, Philip was not content to stay on the sidelines and enjoy a life of ease and wealth. He promoted British industry and science, espoused environmental preservation long before it became fashionable, and traveled widely and frequently in support of his many charities.

Many Britons appreciated what they saw as his propensity to speak his

"The way that he survived in the British monarchy system was to be

historian Robert Lacey. "All her life she was surrounded by men who said, 'yes ma'am' and he was one man who always told her how it really was, or at least how he saw it."

Lacey said at the time of the royal family's difficult relations with Princess Diana after her marriage to Charles broke down, Philip spoke for the family with authority, showing that he did not automatically defer to the Queen.

Philip's relationship with Diana became complicated as her separation from Charles and their eventual divorce played out in a series of public battles that damaged the monarchy's standing.

After Diana's death in a car crash in Paris in 1997, Philip had to endure allegations by former Harrods owner Mohamed Al Faved that he had plotted the princess's death. Al Fayed's son, Dodi, also died in the crash.

Born June 10, 1921, on the dining room table at his parents' home on the Greek island of Corfu, Philip was the

fifth child and only son of Prince Andrew, younger brother of the king of Greece. His grandfather had come from Denmark during the 1860s to be adopted by Greece as the country's monarch.


Philip's mother was Princess Alice of Battenberg, a descendent of German princes. Like his future wife, Elizabeth, Philip was also a greatgrandchild of Queen Victoria.

When Philip was 18 months old, his parents fled to France. His father, an army commander, had been tried after a devastating military defeat by the Turks. After British intervention, the Greek junta agreed not to sentence Andrew to death if he left the country.

The family was not exactly poor but, Philip said: "We weren't well off" - and they got by with help from relatives. He later brought only his navy pay to a marriage with one of the world's richest women.

Philip's parents drifted apart when he was a child, and Andrew died in Monte Carlo in 1944. Alice founded a religious order that did not succeed and spent her old age at Buckingham Palace. A reclusive figure, often dressed in a nun's habit, she was little seen by the British public. She died in 1969 and was posthumously honored by Britain and Israel for sheltering a Jewish family in Nazi-occupied Athens during the war.

Philip went to school in Britain and entered Britannia Royal Naval College Dartmouth as a cadet in 1939. He got his first posting in 1940 but was not allowed near the main war zone because he was a foreign prince of a neutral nation. When the Italian invasion of Greece ended that neutrality, he joined the war, serving on battleships in the Indian Ocean, the Mediterranean and the Pacific.



RDA Launches Grievance System To Address Residents Complaints

The Recovery and Development Agency (RDA) has launched its Grievance Redress System (GRS) to provide a platform through which residents can formally lodge complaints on the work of the agency, its projects and its team.

Director of Strategy, Mr. Neil Smith said the RDA is committed to transparency and accountability and a participatory approach to project delivery and that the redress system will ensure that public projects are completed in an efficient and effective manner with community and stakeholder feedback playing a prominent role. This approach he added enables opinions, grievances and complaints to be raised and addressed throughout the project life cycle.

Mr. Smith said, "The RDA firmly believes this level of engagement with the public is essential and lessons learnt will be incorporated in future projects and thus improve the overall

planning and management of projects."

Mr. Smith said grievances or complaints can be lodged on multiple platforms such as RDA WhatsApp, FaceBook and email, through the grievance form on the RDA website, telephone and in person to ensure that the system is accessible to all.

He said persons are encouraged to use the Grievance Redress Online Form if they are submitting a complaint electronically. The public is asked to provide the following information when lodging a complaint or grievance with the RDA.

Full name of complainant (include the name of group or community if a person is registering the complaint on their behalf);

Address of complainant;

Telephone number (if available) for complainant;

Email address (if available) for complainant;

Describe the nature of the complaint;

Location of the project to which the complaint refers; and

Preferred method of communicating with the RDA (e-mail, telephone, WhatsApp etc.). Mr. Smith further stated that redress system's decisions will be based on possibly rectifying any differences or discrepancies between what happened and what should have happened taking into consideration any cost, quality and time implications for the project and the interests of other important stakeholders.

The director said the RDA has dedicated a timely review and decision-making process and complainants will be provided with a unique complaint number and a decision within 30 days from receipt of the grievance.

Residents will also be educated and informed of the full process through an explanatory video led by the GRS Lead and Community Liaison Officer, Patlian Johnson.

The Grievance Redress System is a requirement under the Recovery and Development Agency Act (No. 1/2018) in the establishment of its good governance principles.

Restoration Works Continue At Ralph T. O'Neal **Admin Complex**

Restorative works continue on the Ralph T. O'Neal Administration Complex as the Government of the Virgin Islands works to maintain its public infrastructure.

Minister for Transportation, Works and Utilities, Honourable Kye Rymer said the Government has developed a comprehensive, four pronged approach to the renovation of the Administration Complex. This, he said, includes the demolition and removal of existing building components which includes the removal of all damaged components such as existing walls and floors; removal of all mold ridden items and mold remediation.

Honourable Rymer said demolition works have been temporarily halted to allow for the relocation of the Treasury and Inland



Revenue departments to their temporary location at Fish Bay. He said work will be done to repair the building's cladding and ensure the building is watertight and resilient against high winds.

"The full installation of the waterproofing membrane to the roof of the building was completed by Professional Roofing Company," Honourable Rymer stated. He added, "In addition, Wallan Glass completed the installation of the skylights and DesignBVI Limited will undertake the replacement of all exterior glass windows and doors."

Restorative work on the building will also see the design and installation of new mechanical, electrical, plumbing and ICT (Information Communication Technology) systems, followed by interior outfitting and configuration.

"My ministry in conjunction with OBM Limited is finalising the designs to repair the exterior building cladding, as a close examination revealed numerous gashes and substantial damage throughout," Honourable Rymer said.

Facilities such as the breezeway, conference rooms and the grounds of the Ralph T. O'Neal Administration Complex were closed on March 30 to all events, to facilitate the ongoing works.

COVID-19 Situation and Response Update

Statement by Minister for Health and Social Development Honourable Carvin Malone

April 5th 2021

I extend greetings to everyone in the Virgin Islands and to those joining us by radio, TV and other social media platforms.

I also wish to extend my best wishes as we continue in observance of the Easter Season, GOD has been JUST and MERCIFUL to us and we MUST NOT take this for granted.

As Minister for Health and Social Development I, Carvin Malone, remain committed to keeping you, the people of the Virgin Islands, fully informed as I update you on where we are with the COVID-19 situation in the Territory. I also wish to update

you on recent developments which need to be brought to your attention. I would admit that this has been a very difficult speech to pen, for indeed we stand at the cross-roads.

First I must thank God for His mercies and allowing us to be where we are now in the fight against COVID-19. I must also thank our hard-working Public and Environmental Health teams, our Health Services Authority Teams and all units of Government for their continuous efforts in keeping us safe and GIS and all other mediums for keep us informed. Of course, I must thank you the people of the Virgin Islands for your patience, prayers, and, for the most part, adherence to the health protocols. This is why I said that we are at the crossroads. It was also professed that if the Territory DID NOT follow the protocols, DID NOT follow the recommendations and if it resulted in large numbers of positive cases and numerous deaths then, at the end we will battle the very same persons the very same hindsight experts who will THEN SHOUT that this Government is incompetent and lacks leadership qualities because they drop the ball - if you may.

It was admitted back then that - this Government would rather the minimum positives and minimum deaths! And here we are, more than one year later!

As the world continues to grapple with the realities of COVID-19, we too as a jurisdiction and destination have been experiencing our own set of challenges in this New Regular as we live and work with the realities of COVID-19.

As we continue to navigate the challenges, I call on all of us to remain VIGILANT and RESILIENT as we learn and build from our experiences.

Our early assertion that as a Territory, we will only have all the facilities, equipment and supplies that we need if we need NONE of the very same facilities, equipment and supplies that we have. Our quest can only be to keep our cases at a minimum - for cases will emerge. There MUST be a balance of LIVES

& LIVELIHOODS. We are almost there!

VIGILANCE cannot be just a buzz word. WE FOLLOWED the Science and WE OBSERVED the protocols. We are almost there!

I will now proceed to give an update on:

COVID-19 test results,

The receipt and rollout of the AstraZeneca vaccines,

The recent Decisions of Cabinet. In reports from the Dr. D. Orlando Smith Hospital's certified laboratory, as of today April 5th, of the 178 positive cases diagnosed there was 1 untimely death, 159 cases have recovered and the number of active positive cases in the Territory now stands at 18. This accounts for 14 persons on Tortola, 1 on Anegada, and 3 on marine vessels. Based on the epidemiological summary provided by the Public Health Unit team, 4 of these cases were captured in the arrival Day 0 screening, 7 on their Day 4 screening, and 3 through Travel screening. A concerning reality is that we now have 4 local cases, one of whom is hospitalised, though, for other non-COVID medical conditions.

Though not popular we must take note of the challenges being experienced in each of our regional territories and of countries worldwide as our fate is intrinsically tied to each other.

Do NOT allow the words of the doubters to confuse you! What attains in Canada, America, United Kingdom, Italy, South Africa, Brazil, Germany, Jamaica, Dominican Republic, Antigua, Barbados, Puerto Rico, United States Virgin Islands and each originating port to the Territory of the British Virgin Islands must be of interest to each of us.

Each country and each territory MUST determine their own conditions and vulnerabilities. Review for yourselves the rates of positive cases per 100,000 per capita, the death tolls and the measures now being taken in any of the jurisdictions cited or the jurisdiction of your choice. We wish those countries mentioned well but the fact is, every life and every business matters!

While the BVI numbers may not necessarily be alarming to some, based on the realities of the region and the world around us, we must continue to remain vigilant and Continue on Page 9

proactive in our approach with this disease. There exists in our region, new and more aggressive strains; new and more deadly strains of the COVID-19 virus.

Seven (7) of the 18 active cases in the Territory were either returning tourists or cases within our population. Persons occupying common spaces with positive cases were asked to self-isolate for a period of 10 days. Persons in direct contact with positive cases were asked to quarantine to avoid the risk of spreading the virus to unknown and unassuming persons within the Territory. As a result of these facts, active and aggressive contact tracing exercises and COVID-19 testing have commenced on Tortola and Anegada. I am pleased to report that the Public Health Unit and the Community Health Unit of the Hospital Services Authority have been actively engaged in the contact tracing activities. Persons on Tortola with possible exposure are being notified and are expected to be tested on Tuesday, April 6th and Wednesday, April 7th at the Ebenezer Thomas Primary School in Sea Cow's Bay between the hours of 9:00 a.m. to 12:00 noon. Additional announcements will be made as the contact tracing activities broadens. The numbers to call will be posted. If you were at any of the activities of which are now well known, we ask you to call. We will give you the numbers tomorrow and we will come down to Ebenezer Thomas Primary School.

To assist the contact tracing teams and to lessen the potential risks of community spread, Cabinet at its Wednesday, 28th March meeting resolved that:

Crowd sizes for indoor and outdoor establishments be reduced from 200 to 75 persons;

Crowd sizes for faith-based services; graduations; weddings and funerals be reduced from 200 to 100;

Written application for crowd sizes for outdoor events of more than 75 persons shall be made to the Minister for approval and;

Recommended to the National Security Council that the Curfew Order remains in-force from 2:00 a.m. to 5:00 a.m. This order will expire on the 15th of April.

These measures we approved to allow for the contact tracing to be more effective during the period in question and will be reassessed from time to time.

I wish to remind persons that

Government instituted a number of fines and penalties and expanded the categories of officers designated to administer tickets. The following fines remain in effect in the Territory as a deterrent to persons intent on violating health protocols:

A person who tampers with or damages a geo-fencing device (which we call the bracelet) will pay \$2,000.

A person who visits a quarantined person will pay \$5,000.

A person who contravenes the protocols or guidelines under these regulations will pay \$10,000.

A person who refuses to return a geo-fencing device or approved monitoring device will pay \$500.

A person who provides false information when submitting an application for entry to a designated Public Health Officer enforcing a quarantine order will pay \$5,000. Let me repeat, these fines have been put in place as a deterrent and will be used to ensure compliance. We must each do our part to ensure, not only that we remain law abiding citizens but primarily to keep this Territory as safe as possible.

Since the Social Distancing Taskforce has been activated over 150 tickets or fines have been issued. The message to persons caught violating the provisions of the safety protocols, is simple and resolute – "WE WILL FIND YOU AND WE WILL FINE YOU!"

The Government takes these breaches very seriously because it is costly to lock down! It is costly to businesses. It is costly to lives. All of our hard work and efforts for the last year will not go down the drain.

VACCINE PROGRAMME

Let us be clear! It is more than a year since this GLOBAL PANDEMIC has devastated the lives and the livelihoods of individuals, families, businesses and communities locally and worldwide. NONE has been spared – airlines - ferry operators – hotels – worship centres, entertainment centres, promoters, car rentals – schools – day cares – medical facilities – senior citizen programmes – EVERYONE has been affected by this global pandemic!

It is time that we now open up! It is time for us to further allow our approved protocols to take effect. It is time that our lives and our economy be returned to the pre-COVID-19 era; the pre-Irma-and-Maria era. An era we now refer to as the "NEW REGULAR."

The Government has reallocated millions of dollars to build the infrastructure and increase the human resource capacity required to get everyone to this pivotal moment. We have followed the science to get us here! We must now follow the science to reopen our borders; reopen our schools; return to quarantine-free travel, fill our hotel rooms, sail our yachts, and end all curfews.

We are almost there!

Seventy percent (70%) to eighty percent (80%) of us being vaccinated and attaining herd immunity will make the difference; the Territory will reach our ultimate goals at a quicker pace. Our economy can reopen at a quicker and safer pace. Our schools can reopen at a quicker and safer pace. Our livelihoods can be restored at a quicker and safer pace. We must do this together!

The BVI has been fortunate to receive 32,000 doses of the AstraZeneca Vaccine from the United Kingdom and 2,000 doses from the Government of Dominica. The first shipment of the vaccine has a shelf life of early May; the second shipment's shelf life is early June and the third early July. As at Monday, 5th April, 8,246 first doses have been administered: 6,971 on Tortola; 1118 on Virgin Gorda; 68 on Jost Van Dyke and 89 on Anegada. The monthly statistics reveal that 4,068 units were administered during the month of February; 3,790 during March and so far in April 388

We MUST-NOT let this time pass! While the second doses for all persons shall be reserved, it is our intention to seek to administer the entire 17,730 doses to all qualified persons. The subcommittee formed to work with the community rollout programme has initiated their work and will be seen throughout the community. Memorandum of Understanding with the local medical providers is ready for signature. So those persons who are intent on making sure that they visit their private practitioners; all four of the businesses that have applied would be given the opportunity to sign this Memorandum of Understanding, and we can begin having the extra assistance necessary to get the 17,000 plus persons vaccinated.

Given the global position of availability of vaccines, it is critical to use what we have and not allow for any spoilage as at some point there will be a shortage of vaccines which will impact our efforts, our safety, our economy, our schools, and our livelihood.

In the future, vaccination will allow for changes in the current entry and travel protocols and requirements in the BVI. This is sooner rather than later; it is in your arms. Just yesterday, the CDC announced that fully vaccinated persons can travel in the US without test or quarantine, so long as they remain masked. While we may not be there as yet, as the world turns we must be willing to make the adjustments as long as they are in the best interest of this Territory that we all love.

I must re-emphasise that we are almost there!

The most common or important question for those with concerns about the vaccine is: What benefits will result from taking the COVID-19 Vaccine as far as risk prevention? World experts have determined that:

It allows for persons to increase social engagement;

It limits symptoms and reduce risk to others;

It allows for less scrutiny for public health protocols like other international countries like Gibraltar who have vaccinated a substantial portion, almost 90% of their population and have now done away with even as less as mask-wearing;

It reduces the impact of the different variants as persons who have been vaccinated already, will stand a better chance at responding to a booster if need be to address the variants.

Herd immunity, as mentioned before, is when a large part of the population is immune to a specific disease. We have seen it with meningitis and even polio, where if enough people are resistant to the cause of a disease, it has nowhere else to go.

Adults make up 80 percent of our population and if possible, we need the entire 80 percent to get vaccinated so that we can begin to normalise our everyday activities and begin the process of revitalising our economy.

Vaccinations for persons under 18 (that is) children, will not be available until the fall; so it is really up to the adult population to do their part and get vaccinated now.

The Ministry of Health and Social Development is committed to keeping everyone informed and will bring you regular updates. You can also access information on the Territory's COVID-19 response on Government's website, that is www. bvi.gov.vg

Everyone should also beware of misinformation on the Coronavirus disease circulating on social media platforms. Always double check the facts before sharing by visiting official websites. www.bvi.gov.vg/novel-coronavirus-info/

Ladies and gentlemen, We are not out of the woods!

Improvement Works Begin On Drains At Brewer's Bay

Drainage improvement works are underway at Brewer's Bay as the Government of the Virgin Islands continues to improve the Territory's road infrastructure.

Forecasters Anticipate Above Average Hurricane Season

The Colorado State University Tropical Meteorology Project April forecast for the 2021 Atlantic Hurricane Season warns residents throughout the region that this year will bring above average storm activity.

This early forecast released April 8, anticipates 17 named storms, compared to the average 12. The forecast further calls for eight hurricanes, including four major hurricanes, compared to the average six hurricanes and two major hurricanes. Forecasters cited several factors as contributors to elevated storm activity, including above-average seas surface temperatures in the subtropical Atlantic paired with near-average temperatures in the tropical Atlantic. There also appears to be little to no storminhibiting El Nino this year.

Acting Director at the Department of Disaster Management (DDM) Mr. Jasen Penn said that the forecast should serve as a reminder to residents in the Territory to review emergency plans and begin to make preparations early for the season.

"While the Atlantic Hurricane Season does not officially begin until June 1, it is important for families and businesses to have basic preparations in place all year long as storms can occur before the season begins," he said adding that since 2016, there has been at least one named storm before the season began, and in 2020 two named storms developed during

May.

Mr. Penn went on to encourage some specific preparedness measures such as downloading the DDM app to receive weather and emergency alerts, identifying a safe space to shelter in place, and ensuring that the family has a well-stocked emergency supply kit, including items like face masks and sanitiser to help protect against COVID-19.

"We live in a region that is prone to a variety of different types of hazards, so we cannot afford to take these basic preparedness activities for granted," Mr. Penn said.

Boris Johnson revealed more details earlier this week on the Covid certificates which will allow people to go on holiday and return to sports matches and theatres. But senior government sources have warned the new scheme – which will most likely work over a mobile app – could take "months not weeks" to develop. [The Sun]

CANADA - A gay Palestinian migrant who sought asylum in Canada to escape hate crimes in the United States says he now faces certain death in his home country of Jordan because the Canadian government was set to deport him Monday.

Samer says his family members have promised to kill him if he returns because of his sexuality. His brother and father have told him, verbally and in letters, they would kill him by throwing him off a building or burning him alive. [Montreal Gazette]

SANTO DOMINGO - The director of the National Police, Major General Edward Sanchez Gonzalez, expressed his solidarity with the relatives of the married couple that died in a confusing clash with the Police in Villa Altagracia on Tuesday, 30 March 2021 in the evening.

The Major General said that immediately after learning the

incident, he ordered the Office of Internal Affairs and the Inspector General's Office to investigate and shed the truth of what happened.

As reported, 33-year old Elisa Muñoz and her husband, 37-year old Joel Díaz were returning home from an evangelical activity in the community of Los Ganchos de Pino Herrado in Villa Altagracia. The couple had married two months ago. They were traveling in a white Kia K5.

"Our institution deeply regrets the incident and expresses its solidarity with the family and with the evangelical community..." the Major General said. [DR1]

ST. VINCENT - Director of the National Emergency Management Organisation (NEMO), Michelle Forbes is again urging St Vincent residents to prepare for the possibility of an explosive eruption of La Soufriere. The volcano has been erupting effusively since December and returned to its "normal" dome-building activity last Friday, after three days of elevated seismic activity.

Forbes said on VC3's Round Table Talk on Wednesday that the cessation of the elevated seismic activity is no reason to become complacent. "....We cannot sit and think it is all over because we know we are in it for the long haul," she said. [Caribbean National Weekly]

CUBA - Cuba reported on Friday 1,077 new COVID-19 infections, the

highest number in a day, bringing the total to 77,353 cases, along with another four deaths for a total of 429, the Ministry of Public Health said.

Director of hygiene and epidemiology Francisco Duran at the ministry pointed out that most of these infections corresponded to community transmission at 1,067, "with very high figures in all areas of the country."

Havana continues to be the epicenter of the pandemic on the island, reporting 516 cases in the same period, with an incidence rate of 324.9 per 100,000 inhabitants.

Authorities are maintaining restrictive health measures in the capital that include limiting overnight mobility, as well as severe fines for those who do not wear masks or wear them incorrectly.

Since January, the Caribbean island has been facing a new wave of COVID-19 infections, which has forced the re-application of measures such as the suspension of the school year and the closure of public places throughout the country.[Xinhua]

PHILIPSBURG - The Minister of Public Health, Social Development and Labor (VSA), Richard Panneflek hereby informs the public that effective Monday, April 5, travel restrictions from the ABC islands to St Maarten will go into effect.

Considering the regional epidemiology and consequent likelihood of imported cases from highly concentrated pools of the UK variant (B.1.1.7), together with the absence of systematic nationwide genetic surveillance on Sint Maarten, CPS recommends temporary border

closures to Aruba, Bonaire, and Curacao, effective immediately. CPS would review the situation on each island on a 2-weekly basis.

Returning residents from Bonaire, Curacao, and Aruba will be required to hold a negative 72-hour PCR test. It is advised that these residents be retested 48 hours after the arrival.

Aruba, Bonaire, and Curacao (ABC) are experiencing high COVID-19 transmission. These three islands have strong travel connections with Sint Maarten. While anyone traveling from these islands to Sint Maarten now requires a negative 72hr PCR, CPS remains concerned that the magnitude and exponential growth of cases in these locations result in a higher probability source for imported cases into St Maarten. [SMN News]

ROME - Cruise ships have been stopped from landing in the centre of Venice for good thanks to a decree the government has approved, Culture Minister Dario Franceschini said Thursday. The decree approved on Wednesday says a plan for the berth of the cruise ships outside the Venice lagoon must be drawn up and implemented. In the meantime, big ships will keep docking at the city's industrial port, which has been the landing site for them since last December.

There have long been calls for cruise ships to be banned from Venice because of their impact on the city's delicate historic buildings and on the lagoon's unique ecosystem. The drive to ban them intensified after a cruise ship crashed into a quay in June 2019. [ANSA]


MOSCOW - Russia recorded almost 30,000 excess deaths during February, the country's statistics agency announced Friday — a figure which takes Russia's total excess fatality count since the start of the coronavirus pandemic above 422,000.

Excess deaths are calculated by comparing fatalities during the pandemic with mortality rates in the same months of previous years. It is seen by demographers as the most reliable indicator of the human toll of the coronavirus.

At more than 422,000 between the start of the pandemic and the end of February — the latest such data is available — Russia has recorded one of the highest excess death tolls in the world, including after adjusting for population size.[Moscow Times]

PARIS - Last week France took aim at the failure of some EU countries to rapidly ratify an emergency programme for the bloc's coronavirushit economies, singling out Germany.

The EU's €750-billion virus recovery fund, agreed last summer, requires ratification from all 27 EU states before it can be accessed, but only 16 have so far ratified the plan. Last week, Germany's Constitutional Court halted ratification in a surprise move, after five individuals filed a challenge that resulted in a temporary injunction.

The plaintiffs argued that the EU should not be pooling debt but that it is up to each country to underwrite its own borrowing to pay for the stimulus.

"I promised the French people that the European money would arrive at the start of the summer, at the start of July. I would like to be able to keep that promise and I would like Europe to understand that we shouldn't have to wait before being able to spend that money," French Finance Minister Bruno Le Maire told the CNews TV channel.

He said there were "states like Germany who are imposing additional delays", referring to the decision of the Constitutional Court. [TheLocal.fr]


Dear Readers: Here are some tips to give us some energy throughout the day, that may help us to feel less draggy.

Waking Up: Instead of: Sleeping in..Try: Getting up at the same each day.

This enables your circadian rhythms, which are governed by your body's "master clock" in the hypothalamus gland, to stay in synch with the 24-hour day. In the absence of light, your body's sleep-wake cycle wants to delay by an average of 12 minutes every day and work on a 24.2-hour rhythm. (Scientists don't understand why but think it may relate to the sun's seasonal shifts.) "That means your body wants to keep pushing your bedtime to later," says Mariana Figueiro, PhD, program director of Rensselaer Polytechnic Institute's Lighting Research Center. "But if you let that happen and still have to get up at the same time every day, you're going to be tired."

To keep your circadian rhythms in time with the 24-hour day (when they get out of whack, you feel like you're jet-lagged), aim for 30 minutes of light first thing, even on a Saturday when you've decided to sleep in. An easy way to get it is to go for a half-hour stroll outdoors or have your breakfast by a sunny window.

If your schedule requires you to rise when it's dark outside, crank up the lights indoors—every little bit may help.

Contract Signed For Solar Panels At Jost Van Dyke Clinic

The Recovery and Development Agency (RDA) has awarded a contract to Amandla Engineering to supply and install a Solar Facility at the Jost Van Dyke Clinic as it marches towards a Green Recovery.

Acting RDA Chief Executive Officer, Mr. Anthony McMaster signed the contract with Sean Hartley of Amandla Engineering valued at \$65,500.00 on March 26.

Nations' Climate Change Conference, COP26, later this year, we will actively look to identify more green projects to support."

Premier and Minister of Finance Honourable Andrew A. Fahie thanked the Foreign, Commonwealth and Development Office for its sponsorship and for joining the Government of the Virgin Islands' vision for going green.

Premier Fahie acknowledged

He said there is no better time than now to move forward with the project.

"Whether it is after a storm, or during or after a pandemic the clinic must function, so this is a fitting project for a fitting discipline," the Health Minister stated.

Meanwhile, Second District Representative Honourable Melvin 'Mitch' Turnbull thanked the RDA, and Premier Fahie as the minister with responsibility for recovery, for his commitment to ensuring the clinic in Jost Van Dyke is receiving the necessary attention and will be going Green.

Honourable Turnbull said, "I am grateful for what is going to be done. It is absolutely important to where we are in the Territory and will be a tremendous effort for all that we want to do in the future. As much as we can, we should use solar power and the energy around us to take us off the grid system."

The Second District Representative added that he was grateful on behalf of the people of the Second District, specifically the Jost Van Dyke community, for the project to be taken on and signed.

Contractor, Sean Hartley also expressed gratitude for the opportunity and remarked that it was exciting that Amandla Engineering was getting the opportunity to complete the projects.

The supply and installation of the solar facility at the Jost Van Dyke clinic is the third of three solar energy projects funded by UK Foreign, Commonwealth and Development Office and implemented by the RDA. It will provide 10KWp (DC) solar system at the clinic, which will include the construction of a stainless-steel parking port at the facility with additional solar panels complementing those on the roof of the clinic.

This project will contribute to further promoting renewable energy in the BVI and massively reduce the energy bills for this important community facility. It will also ensure an alternative reliable power source in the event of future disasters.



Works are scheduled to be completed in 17 weeks at the end of July 2021.

The project is funded by the UK Foreign, Commonwealth and Development Office. His Excellency the Governor John James Rankin, CMG in an invited comment said that he was delighted that the UK is funding the solar panelling for Jost Van Dyke clinic.

"This will enable the clinic and wider community to be more resilient in times of natural disaster, as well as help reduce carbon emissions and so tackle climate change, to which these Virgin Islands are so vulnerable," the Governor said.

Governor Rankin added, "This project is a wonderful example of the Governor's Office working in partnership with the Health Service Authority, the Ministry of Health and Social Development, RDA and local contractors. As the UK prepares to host the United

the work of the CEO of the RDA for what he has accomplished with his team including the roll out and execution of a number of majority priority projects. 'Going Green', he said, is a priority of his Government and is important for energy and cost efficiency and in respect and care of the environment.

The Premier shared that Government has amended its legislative policies to allow for the selling back to the grid and in the future a legislative amendment will be introduced to allow for the duty-free importation of renewable energy projects and systems for a specific timeframe. This he added will allow persons to "Go Green" and will drive 'Green Energy'.

THE SMALL BUSINESS ECONOMIC TOOL

Only a strong social democracy: not a trickledown capitalist model, will deliver for the BVI OK. It was small business and the working man that kept the BVI economy alive Post IRMA and will do the same Post COVID 19.

Small business and strong consumer spending drive economic growth and prosperity, when the pandemic finally ends.

That has got to be the key economic lesson from five years of social and economic crisis for the BVI.

Now it is critical the British Virgin Islands Government forges the strongest possible partnership with the small business sector to ensure strong economic growth after the COVID 19 pandemic ends.

This Old Boy is certain that pent up demand for travel and tourism will drive rapid economic growth in both the local market and wider regional economy from late 2022. However, small business resilience and growth must be priority number one for that to happen, and for the average person to benefit.

Government must drive innovation in the economy and fine tune its role as small business facilitator and enabler. That will mean removing

unnecessary regulation and ensuring small business has a seat and strategic presence at the table of governance.

Adopting a culture where small business is placed at the front of the que will drive economic and job growth which is fundamental to the BVI economy.

Economic stimulus is crucial for jump starting an economy under the burden of recession. And it is always better in the social democracy that the Virgin Islands Party espouses, that spending is focused on the poor and vulnerable, and small business sector first and foremost.

The poor and working classes spend on necessities, and that cash goes directly into the areas of the economy that drive economic and job growth. On the other hand stimulus spending that ends up in the pockets of the rich tends to stagnate in bank accounts or is simply used to reduce business debt.

A well - resourced and effectively managed small business sector has the

capability to pull an economy out of the ditch of recession and stagnation by touching and energizing every other component of the economy.

Top down or trickle down economies have failed miserably in driving economic growth. The poor have not benefittedfrom trickledown and the beneficiaries have been the 1%, while the 90% have seen little increase in their wealth since the early 1990s. The narrative from Supply Side Trickle Down has been a massive increase in inequality with the wealthier getting vastly wealthier.

The Post COVID recovery must be driven by the small man and small businesses, government helps small business by investing in a first rate physical and social infrastructure that is the greatest platform for small business growth and economic prosperity.

When governments invest in adequate power supply; resilient road networks; accessible quality healthcare; good public safety, good sanitation; quality basic education; vocational and skills training; and so on and so forth, that is the best way to secure the wider economy by building resilience.

A focus on driving down poverty, empowering youths through trades and vocational skills, and ensuring robust physical and social infrastructure is the way forward Post Covid. And that means small business success, first and foremost.



An Ode to Avocados

I've been preparing, eating, reading and writing about avocados for more than a decade. Never in my wildest dreams did I ever think that avocados would rise to their current heights in the culinary world. Avocados are like the child you have who goes from sitting quietly in the back of the classroom making a "C" at best, to becoming the high-school valedictorian with a full-ride college scholarship to Harvard.

Avocados are considered a fruit. They are one of the few fruits or vegetables that contain fat, but the fat is unsaturated and heart healthy. That healthy fat also is why avocados have such a creamy, delicious mouth-feel.

California avocados are in season from spring to fall, which means they will be easier to find, better quality and more affordable during that time. Avocados are one of the produce items with the least number of pesticides, so there is no reason to buy organic.

Avocados are loaded with nutrients such as dietary fiber, vitamin B6, vitamin C, vitamin E, magnesium, folate and 60% more potassium per ounce than bananas. They're also cholesterol- and sodium-free. Two tablespoons of mashed avocado (about 1 ounce) or one-fifth of a medium avocado provides about 55 calories.



To choose an avocado, squeeze it gently. It should be firm but give to slight pressure. Hard avocados are not yet ripe, but can ripen in a few days. Place the unripe avocado in a brown paper bag for two to five days. Apples or bananas can be added to the bag to shorten the process, because the gas they give off helps ripen the avocados. Ripe avocados can be stored in the refrigerator for two to three days.

Always wash avocados before eating to remove any dirt or bacteria. Cut lengthwise and rotate the halves to separate. Use a spoon to remove the seed and scoop out the meat or peel the skin away from the fruit. Lemon juice, lime juice or white vinegar can help prevent discoloring. You can also press plastic wrap directly on the surface and then wrap to store in the refrigerator for a few days. If the surface turns brown, just cut off the top layer and eat the rest.

Avocados can be enjoyed in a variety of ways, including mashed and spread on a sandwich in place of mayonnaise, or blending it with oil and vinegar to make a salad dressing. This recipe for Avocado Flat-Bread is yet another way to enjoy healthy, delicious avocados.

AVOCADO FLATBREAD

This Avocado Flatbread is soft, delicious and vegan. It is an easy-to-make, simple bread recipe that can be prepared in less than 30 minutes. Sprinkle the finished flatbreads with pre-packaged Everything Bagel seasoning mix for additional flavor and texture, if desired.

- 1 large avocado, or 2 to 3 small avocados, ripe, peeled and pitted
- 1 teaspoon lemon juice 1 teaspoon salt
- 1 teaspoon ground black pepper
- · 1 teaspoon curry powder or garam masala powder
- 1 teaspoon onion powder 1 teaspoon garlic powder
- · 3 tablespoons cilantro or parsley leaves, finely chopped
- 1 1/3 cups all-purpose flour Water, as needed to moisten dough
- · 3 tablespoons vegetable oil (to cook flatbread)
- 1. Using a large bowl and a fork, potato masher or a food processor, mash the avocado until smooth. Add the lemon juice, salt, pepper, curry or garam masala powder, onion powder, garlic powder, cilantro or parsley leaves, and mix well.
- Add 1/3 cup of flour at a time to the avocado mixture and mix or process well after each addition. Lightly dust the counter or cutting board, and a rolling pin with flour. Knead the mixture on the counter or cutting board to form a soft, smooth dough. If the dough is too loose, add another 1/3 cup of flour. If the dough is too dry, add a tablespoon of water.
- Cover the dough with a dish towel or plastic wrap, set aside for 15-30 minutes.
 Divide dough into 8 equal portions. Roll each portion into a circle or oval shape of even thickness (about 2 inches).
- 4. Place a heavy-bottom skillet or a griddle over medium-high heat until hot. Place one of the flatbread pieces in the dry skillet or a griddle. Press flatbread lightly with a spatula. After 5 to 7 seconds, when bubbles form on top of the flatbread and the bottom is light brown, spread a teaspoon of oil on top of the flatbread. Flip it over, cook it for another 5-7 seconds, then apply oil to the top of the flatbread, flip again, cook for the last 5-7 seconds. Transfer to a serving plate, cover to keep warm. Repeat process with remaining flatbread.
- 5. Freeze or store in an airtight container. Serves 8.

Persons in Guyana to be charged, fined, for flouting **COVID** measures

Minister of Health, Hon. Dr. Frank Anthony says citizens will have to feel the brunt of the law if they continue to disregard the COVID-19 measures, putting themselves and others at risk of contracting the disease.

During Thursday's COVID-19 update, the Minister said the National COVID-19 Task Force has discussed its next approach to dealing with this matter.

A lot of people have been charged so far with breaching these orders, and we are going to continue to do that. In fact, from the last Task Force, we are going to step up the enforcement because we are seeing people not paying heed to the warnings that we have put out, and if they don't, then we will see a rise in cases.

If you don't wear a mask and the police arrest you, you will be fined. There is a specific fine that is in the Order that the magistrates can use. They can also impose

wearing is essential. If businesses breach the Covid orders, there are a set of measures there as well that can be used, and I think the magistrates have been doing that," he said.

Minister Anthony also said that as a result of breaches, increased transmissions have been recorded.

"Over the last 24 hours, we have had 126 positive cases. Most of those are coming from Region Four. There's a number of persons who are already in the hospital. We have right, now 52 persons in hospital, this is a serious thing.

So, while we are doing vaccination and that is meant to certainly help, people still have to abide by the rules that we have out there or you're going to get infected and a percentage of persons are going to end up in the hospital, and a percentage of those in the hospital are going to die."

Minister Anthony said COVID-19 is not a joke or a hoax as many

people still believe, but an the vaccine. Dr. Anthony urges the infectious disease. He said people are dying because of this disease and unless everyone takes the outlined precautions - wearing a mask and social distancing - the consequences will be dire.

The Ministry has also noted that several healthcare workers in Upper Demerara-Berbice (Region 10) have been refusing

workers to take every precaution necessary to safeguard their health and that of their patients.

Meanwhile, healthcare workers in Upper Takutu-Upper Essequibo (Region Nine) have completed vaccination of their staff, with the other administrative regions following closely behind.

Police Chief Testifies Ex-Officer Violated Policy

WASHINGTON - Minneapolis Police Chief Medaria Arradondo testified Monday that former police officer Derek Chauvin did not follow his police department's policy when he pinned George Floyd to the street by kneeling on his neck for more than nine minutes.

Kneeling on Floyd's neck after he was handcuffed and subdued is not the department's policy or training, Arradondo said, "and it is certainly not part of our ethics or our values."

The chief said officers are trained to try to deescalate a situation and to minimize or avoid the use of force whenever possible. They also receive first-aid training, he said, adding, "And so, we absolutely have a duty to render that."

Arradondo, the city's first Black police chief, fired Chauvin and three other officers the day after Floyd's death. Arradondo later described Floyd's death last May as "murder."

Chauvin, who is white, was a 19-year police veteran until he was fired. He has pleaded not guilty to murder and manslaughter charges in the case being heard by a racially diverse 12-member jury. Chauvin's lawyer contends that Floyd died from underlying health issues and that Chauvin followed his police training in the way in which Floyd was arrested.

Earlier, the jury also heard testimony from the Minneapolis hospital emergency room doctor who pronounced Floyd dead.

Dr. Bradford Langenfeld testified Monday that Floyd most likely died from oxygen deprivation, supporting the prosecution's murder case.

Langenfeld, who tried to revive Floyd before pronouncing him dead, said he surmised that Floyd, a 46-year-old Black man, most likely died of suffocation.

Langenfeld, testifying at the start of the second week of the trial, said Floyd's heart had stopped by the time he was brought to the hospital. The doctor said paramedics told him they had already tried for about 30 minutes to revive Floyd. But he was not told of any other efforts by police to resuscitate him after he was arrested on suspicion of trying to pass a counterfeit \$20 bill at a convenience store.

Langenfeld said that based on the available information he was given, death by asphyxiation was "more likely than the other possibilities."

The first week of the trial was dominated by emotional testimony from eyewitnesses who watched as Chauvin pinned Floyd to the street with his knee on Floyd's neck even as Floyd repeatedly gasped that he could not breathe.

The May 25 incident last year triggered widespread protests against police treatment of minorities in the U.S. and around the world.

On cross-examination, Eric Nelson, Chauvin's attorney, asked Langenfeld whether some drugs can cause oxygen deprivation. The doctor acknowledged that fentanyl and methamphetamine, both of which were found in Floyd's body, can do so.

In testimony later that day, Arradondo agreed when prosecutor Steve Schleicher said that some people become more vulnerable when under the influence of drugs or alcohol.

"It's recognizing that when we get the call from our communities, it may not often be their best day, and they may be experiencing something that's very traumatic," the chief said.

The Hennepin County medical examiner's office said that Floyd died of "cardiopulmonary arrest, complicating law enforcement subdual, restraint, and neck compression." A summary report listed fentanyl intoxication and recent methamphetamine use

under "other significant conditions" but not under "cause of death."

Shortly before the trial started, the city of Minneapolis paid \$27 million in damages to Floyd's relatives.

Details, Venues Emerge for talks to Revive Iran Nuclear Deal

WASHINGTON - The United States and Iran are due to begin indirect talks Tuesday in Vienna aimed at reviving the 2015 agreement that restricted Iran's nuclear program in exchange for sanctions relief.

U.S. State Department spokesman Ned Price told a press briefing Monday that U.S. Special Envoy for Iran Robert Malley will lead the U.S. delegation to the Vienna talks in which Britain, China, France,

Germany and Russia are seeking to revive the Iran nuclear deal, known as the Joint Comprehensive Plan of Action (JCPOA). The five other world powers are seeking to bring the U.S. back into 2015 agreement and to return Iran to full compliance with it.

Price said Tuesday's talks will be "structured around working groups" that the European Union will form with Iran and the other remaining parties to the JCPOA. He said the agenda would focus on the "nuclear steps" that Iran would need to take to restore its compliance with the JCPOA and the "sanctions relief steps" that the U.S. would need to take to rejoin the deal.

Price said the U.S. would consider lifting nuclear-related sanctions that former President Donald Trump had reimposed on Iran in return for "more permanent and verifiable limits" on the Iranian nuclear program.

Speaking Monday in Tehran, Iranian Foreign Ministry spokesman Saeed Khatibzadeh reiterated that his side wants the talks to focus on the U.S. lifting what he called its cruel Iran sanctions. He said Tehran will not accept the U.S. doing so in a "step-by-step" manner in tandem with Iran taking steps to resume JCPOA compliance.

"We (seek) only one step, which includes lifting of all U.S. sanctions. In return, Iran is ready to suspend its remedial measures and reverse actions," Khatibzadeh said. Iran has referred to its expansions of uranium enrichment and other nuclear activities as remedial measures that it asserts can be reversed. But some Western nuclear experts have said that at least some of Iran's recent advances in sensitive nuclear capabilities cannot be easily undone.

Price tried to downplay expectations for the Vienna talks, saying the U.S. does not anticipate early or immediate breakthroughs.

"These discussions, we fully expect, will be difficult," he said. "But we do believe that these discussions with our partners and, in turn, our partners (discussions) with Iran, are a healthy step forward," he added.

Khatibzadeh also repeated Iran's vow not to meet directly with the U.S. as part of Tuesday's talks. Price said the U.S. does not anticipate direct talks with Iran but remains open to them.

The two likely venues for the talks will be the Austrian capital's Hotel Imperial and Grand Hotel Vienna, according to VOA Persian.

A VOA Persian reporter in the city identified the venues by observing Iranian delegation members moving between the two hotels, which are a few minutes' walk from each other on opposite sides of a major boulevard, and by speaking with several hotel representatives.

The Iranian delegation members seen in video clips and photos exclusively obtained by VOA Persian could not be immediately identified.

It was not clear which of the two Vienna hotels would host Tuesday's meeting of the U.S. and the five other world powers and which would host Iran's meeting with the same five

"Today's game wasn't too bad, but we need to work on the finishing," he said.

One Love's Coach Mark Savage said his team tried its best but told Island Sun Sports that if you want to be victorious, you have to train.

"You can't come one day, two days, nah, you have to come together to win together. That's the basics of football," said the Coach of the 2019 champions who fell apart in the last league. "You got to training and there are five, six guys, you tell them if we're the defending champions, this can't work. You have to lift your head high and people look up to you," he said. "You have to put in the work to get the result, that's all it is. And if you don't train, you can't win games. Simple."

On Virgin Gorda, Lion Heart continued their surge up the table and underlined their desire to qualify for the knockout stage, by finishing in the top 6, with a 3-1 victory over the Panthers, who continued their slide and have now lost three in a row.

Janel Ferdinand put Lion Heart well on the way to victory with two first half strikes, in the 15th and 21st minutes and by the time Nigel Sanderson scored a consolation for the Panthers in the 71st minute from the penalty spot, Dwayne Smith had already made it 3-0 just after half time.

Lion Heart has now won their last three games and are sitting pretty 4th in the standings and look on course to give the usual top three teams a wakeup

In the other game played, One Caribbean and Old Madrid battled to 1-1 when Fitzrov Dalev equalized from the penalty spot in the 67th minute after youngster Gethin Jones had put One Caribbean ahead in the 55th minute, in a match that was 0-0 up to that point.

Meanwhile over at the Virgin Gorda Recreation Ground at 5.45 p.m. on Sunday, Old Madrid will tackle the Wolues, knowing defeat could seriously dent their chances of a top six finish and then at 8 p.m. the clash of the weekend and Virgin Gorda bragging rights, Sugar Boys against VG United in the El Classico.

Currently, VG United is well down the standings, but have games in hand over their rivals. However, they also have to play the Wolues before the season ends, so will be mindful against making any slip ups as they look to advance into the knockout phase.

Collective CARICOM voice for recovery at IMF-World Bank meetings

The response by policy makers of the International Financial Institutions (IFIs) to the depth of COVID-19's effects on Caribbean economies needs to be urgently reviewed, particularly regarding debt.

An unduly optimistic assessment of the extent of damage to economies and an overly confident expectation of how long the effects will last, have resulted in inadequate instruments to help Caribbean countries get out of the hole into which they have been sunk through no fault of their own. Caribbean countries did not create the pandemic and they have been among the most successful in containing it at great cost to their Treasuries.

The staff of the International Monetary Fund (IMF) and World Bank Group (WBG) and the Directors on the Boards, representing CARICOM countries, deserve credit for advancing the region's interests. The inadequacy of the IFIs response is not their fault; it is entirely due to Board directors of some larger countries who remain stuck to mistaken policy positions whose failures have enlarged the harmful effects of the pandemic.

One of these continuing unhelpful policy positions is the application of per capita income as a criterion to deny high income Caribbean countries access to concessionary loans, even though these countries are subject to the same vulnerabilities as lower income countries.

Something of a breakthrough might have occurred. The World Bank Board has approved the preparation of loan documents of \$100 million each for the Bahamas and Barbados - two of the countries with the highest per capita incomes in CARICOM -"due to their heavy reliance on tourism". This is an admission that the Board of the Bank has accepted vulnerability as a criterion, that is superior to high income, as a qualification for concessionary loans. It is to be assumed, therefore, that, if these loans are approved by the Board in the coming weeks, this criterion can now be applied to other high-income CARICOM countries such as Antigua and Barbuda and St Kitts-Nevis. CARICOM Finance Ministers at the Spring Meetings of the Bank and Fund should raise this issue collectively.

Doing so, is especially relevant since countries that might have been "high income", according to IMF/WBG measurements, in 2019, are certainly not so today. High unemployment, resulting from the pandemic, has shaved as much as 30 % from per capita income in some countries and is likely to reduce it even more as unemployment increases and poverty expands. Amid all this, the IFIs response to high and crippling debt in many CARICOM countries that has spiralled because of the COVID-19 pandemic, has increased their debt service burdens. While the Bank and Fund have explicitly stated that debt levels were, for some, more than 100 % of GDP prior to the pandemic, the debt instruments that they have provided are burdensome.

As an example, the IMF's Debt Service Suspension Initiative is only temporary. It is also applicable only to the poorest countries. Therefore only 5 CARICOM countries qualified. The initiative is supposedly to help them cope with the economic and fiscal constraints caused by the COVID-19 crisis. But it gives only a one-year grace with repayment having to be made over 5 years. Clearly, there will be an increase in the debt service burdens

of these countries

The duration of the pandemic's effects on CARICOM economies and its severe impact, will be longer than anticipated. Countries, such as Guyana and Suriname, with their oil and gas resources will be better placed, but Post-COVID, many CARICOM countries will have much reduced economies, high debt, diminished revenues, and little capacity to recover. The UN has already said that the Caribbean will face 'a lost decade' with economies and per capita income declining to 2010 levels.

They will need access to low-cost financing and grants from both IFI's and donor governments. Immediately, they need debt relief in the forms of write-offs and deferral of repayments on easier terms.

If these initiatives are not taken, Caribbean economies will be caught in a poverty trap from which they will not emerge for a generation and, even then, only if they experience no disasters such as hurricanes, prolonged droughts, or flooding – all of which have a high probability of occurring.

The governments of CARICOM countries are struggling to keep their economies afloat with policy initiatives either to revive dormant activities, such as agricultural and fisheries production, or to encourage new technology-based endeavours. These will help with economic diversification over time, but they will not be immediate large contributors to economic growth or replacements for industries such as tourism.

The Spring meetings of the Bank and Fund are an opportunity for robust presentations of the plight of CARICOM countries, always recalling they did not originate or spread COVID-19. They are in their current situation because of their vulnerability to their trading partners which, without exception, enjoy relatively large trade surpluses with the region. Some of these same trading partners are among the most vociferous in the continued application of mistaken criteria that disqualify many CARICOM countries from concessionary financing and debt relief.

At this month's meetings of the IMF/WBG, Caribbean representatives have an opportunity to advance proposals for support. One of the points that should be made is that, since the huge balance of trade surplus that rich countries enjoy with CARICOM states runs into billions of dollars perennially, giving them revenues and employment, they should regard debt forgiveness and rescheduling, as well as concessional financing, as investments in CARICOM countries from which they derive considerable benefits annually.

If the economies of CARICOM countries are not helped to recover, there will be a corresponding contraction in their ability to continue to buy goods and services from the rich. Efforts must be made to create a framework that integrates debt sustainability, growth-investment, and building resilience for CARICOM countries. Such a framework must also take full account of the region's vulnerability to destructive forces they do not create, such as Climate Change.

CARICOM countries should speak with a collective voice in proposing such a framework to the IMF/WBG meetings, omitting no country.

Silent Killers affect over 50 percent of our population

Non-communicable diseases (NCDs) still reign supreme: diabetes, heart disease, cancer, high blood pressure, stroke, are by far the leading causes of mortality in the world, representing over 60% of all deaths.

A World Health Report identified five important risk factors for non-communicable diseases in the top ten leading risks to health. These are high blood pressure, high cholesterol, tobacco use, alcohol consumption, and overweight.

If present growth trends are maintained, NCDs will soon attribute to 7 out of every 10 deaths in developing countries, killing 52 million people annually worldwide by 2030. With statistics such as these, it comes as no surprise that international entities such as the World Health Organization & World Bank Human Development Network have identified the prevention and control of NCDs as an increasingly important discussion item on the global health agenda. Alzheimer's, which is not necessarily an NCD, is projected to affect more people in the next 10 to 20 years. Dementia cases are expected to triple causing an enormous burden on national health services and families. Risk factors for dementia are similar to those listed above for NCDs.

World Health Day was observed last Wednesday on a global scale with a special focus on the silent killer: high blood pressure. High blood pressure - also known as hypertension - increases the risk of heart attacks, strokes, and kidney failure. If left uncontrolled, high blood pressure can also cause blindness, irregularities of the heartbeat, and heart failure. The risk of developing these complications is higher in the presence of other cardiovascular risk factors such as diabetes. One in three adults worldwide has high blood pressure.

The risk of developing high blood pressure can be reduced by reducing salt intake as much as possible; eating a balanced low-fat diet; avoiding canned food; using less processed food; avoiding harmful use of alcohol; taking regular physical exercise; maintaining a healthy body weight, and avoiding tobacco use.

Government, health workers, the entire community, the private sector, families, and individuals must join forces to reduce hypertension and its impact.

BVI Residents To Schedule 2nd COVID-19 Vaccine Dose After April 22

Residents who received their first dose of the AstraZeneca vaccine should prepare to schedule the second dose after April 22.

This date is in line with the newly advised ten to 12 week timeline for the administration of the second dose.

Minister for Health and Social Development, Honourable Carvin Malone during the Sixth Sitting of the Third Session of the Fourth House of Assembly on March 10, explained that the new preferred dosing interval was advised by the medical experts and the Chief Medical Officer in the Ministry of Health and Social Development.

Honourable Malone explained that this guidance takes into account the very clear and published two-fold improvement in the antibody response and 26.2 percent greater efficacy within the 10 to 12 week dose interval over the previously announced six-week regime.

The Health Minister said, "From a legal and ethical standpoint Mister Speaker, it is our hope that persons will follow the new regime, and if they are being advised otherwise or choosing a smaller dosing interval should do so with full information of the disadvantages."

Acting Permanent Secretary in the Ministry of Health and Social Development, Ms. Tasha Bertie explained that persons who received their first dose should refer to their vaccination cards and calculate at least ten weeks from the date the dose was administered. Thereafter, persons should schedule their appointments online by visiting ministry of health.gov.vg/vaccines.

Ms. Bertie stated, "Persons who

show up prior to the April 22 date without their vaccination cards to prove they received their first dose and to verify the date, will be assisted. Hence, residents who received their vaccinations are encouraged to secure their cards to ensure they receive their second dose at the appropriate time."

Meanwhile, Health Minister Malone continues to encourage as many persons as possible to receive their first dose and as quickly as possible. During the Sitting of House of Assembly, he stated that the first dose of vaccine affords very high efficacy against COVID-19 of the order of 76 percent in the short term against symptomatic COVID-19 and

63.9 percent when including both asymptomatic and symptomatic cases.

"We are also aware that the first dose of AstraZeneca vaccine reduces infectiousness by as much as 67 percent and has also led to dramatic reductions of hospitalisation in the United Kingdom of over 80 percent and as high with just under 20 million persons out of an approximately 60 million population having been vaccinated," he said.

Honourable Malone further added that it is important for residents to get vaccinated so that the Territory can reap the benefits through the concept of herd immunity where if a sufficient number of persons are vaccinated, it will interrupt the ability of an infectious disease such as COVID-19 to be transmitted through the population and ultimately allow for review of the current entry protocols.

COVID-19 vaccination centres are open Monday through Friday and are available to all residents age 18 and older. Persons are encouraged to register online at ministryofhealth.gov.vg/vaccines but walk-ins will also be accommodated with inperson registration on site. On leave in Britain, he visited his royal cousins, and, by the end of war, it was clear he was courting Princess Elizabeth, eldest child and heir of King George VI. Their engagement was announced July 10, 1947, and they were married on Nov. 20.

When Elizabeth became gueen on the death of her father, King George VI in 1952, Philip found it very difficult, says Philip Eade, author of the book "Young Prince Philip."

"He had been an extremely successful, extremely highly regarded naval officer in the British navy, and he was tipped from the very top," Eade told VOA. "He was tipped to become head of the navy and so to have to give that all up in order to become second fiddle to his wife. He was a very overtly masculine character and not one who is going to take easily to this sort of life of walking a couple of paces behind the queen."

Over seven decades, Prince Philip navigated the highs and lows of a Royal Family permanently in the public eye. He helped the family cope with difficult times in the 1990s, including the divorces of Prince Charles and Diana, and Prince Andrew and Sarah Ferguson. Diana was killed in a Paris car crash in 1997 alongside her fiancé Dodi Fayed.

Philip was known for his wry sense of humor, which came in handy whenever he had to brush aside any suggestion of his role as a secondary figure. He once said his best speech was in 1956, when he opened the Summer Olympics with eight words: "I declare open the Olympic games of Melbourne."

Prince Philip retired from official royal duties in 2017. A year later, he was involved in a serious car accident while driving near the Royal Family's country estate at Sandringham. His last public appearance was in July 2020 at Windsor Castle.

Prince Philip and Queen Elizabeth II had four children: Prince Charles, Princess Anne, Prince Andrew and Prince Edward. They have eight grandchildren and 10 greatgrandchildren.

Fulfilling his roles as consort and father, Prince Philip had a lasting effect on a 12-hundred-year-old institution, a monarchy that is more visible and relevant to its people as a legacy that he forged, effectively, from his place two steps behind.



St. Vincent on red alert for 'imminent' volcanic eruption By Tatiana Arias, AnneClaire Stapleton and Steve Almasy, CNN

(CNN) - St. Vincent and the Grenadines Prime Minister Ralph Gonsalves on Thursday declared a disaster alert prompted by a change in the eruptive activity at the La Soufrière volcano, according to the country's National Emergency Management Organization.

The island is on red alert, meaning an eruption is "imminent now," NEMO said. Evacuation orders are in place in about a dozen districts of St. Vincent, affecting roughly 6,000 to 7,000 people, a spokesperson for the University of the West Indies Seismic Research Centre, or UWI-SRC, told CNN.



St. Vincent is the largest island of the St. Vincent and the Grenadines chain in the Caribbean.

Scientists at the Belmont Observatory in St. Vincent observed a volcanic tremor on

the island at about 3 a.m. local time, according to UWI-SRC. The first band of tremors was followed by five more throughout the day. This type of seismic signal is usually associated with movement of magma and fluids close to the surface, according to UWI-SRC. "Ash venting was also observed during the most recent tremor episode," the center reported on Facebook.


The volcano has had five explosive eruptions -- in 1718, 1812, 1814, 1902/03 and 1979 -- according to the seismic research center.

Trinidad and Tobago Prime Minister Keith Rowley has spoken to Gonsalves and offered assistance, according to the Ministry of National Security for Trinidad and Tobago.

Venezuela will send humanitarian supplies and risk experts, Venezuelan Foreign Minister Jorge Arreaza said on his Twitter account. Cruise ships are heading to the islands to assist in evacuations, NEMO officials wrote on their Twitter account. Carnival Cruise Lines is sending two ships -- the Carnival Paradise and the Carnival Legend -to evacuate residents, a spokesperson told CNN.

"Each ship will accommodate up to 1,500 residents who will be transported to neighboring islands which have agreed to offer refuge out of harm's way. All precautions will be taken to protect the health and safety of Carnival crew and the passengers who board the ships," the spokesperson said. The ships will arrive Friday, the spokesperson said. Royal Caribbean and Celebrity Cruises are each sending one ship and should arrive Thursday night, according to a statement from Statement from Royal Caribbean International.

Seaports Opening will Benefit the Economy

The increased cases of COVID 19 within the Territory during the last two weeks will not determine the long-awaited reopening of the Territory's seaports Minister for Health and Social Development Hon. Carvin Malone said.

In a statement to the Territory on 1 April, the Health Minister noted the proposed seaport reopening date and mentioned that there is no thought at the moment to defer: "Our sea borders are on schedule to reopen on Thursday 15 April and all efforts are aimed at maintaining as safe a Territory as possible. I am in contact with Health agencies and Health Ministers throughout the region and the common theme is vigilance. Remember do not procrastinate: vaccinate," Hon. Malone said.

Vaccination will Restore Jobs and the Economy

The Minister's announcement that the seaport reopening date will hold came days before Leader of the Opposition Hon. Marlon Penn issued a press release declaring that there should be no further delays concerning the reopening. The Leader of the Opposition said: "We have to be ready to open our seaports. We have to learn to live, work and manage COVID."

Hon. Penn's statement about the delay stems from the fact that there have been at least two changes to the timeline to have the Territory's s reopen. The previous date shifts have also been seen as the reason some of the Territory's sailing business migrated to the US Virgin Islands. Will they return or the USVI will do everything to keep them there: what do you think?

The seaports have been commercially closed since March last year, and with it, an affordable means for tourists to get into the Territory went out of the window. This went on to affect the BVI's tourism sector and caused many companies to operate part-time,

which resulted in a wave of underemployed and unemployed residents and citizens.

The previous reopening push backs Hon. Penn referred to as false starts, and he noted that another such deferment would be unacceptable. "We cannot afford another false start," Hon. Penn said.

Ferries Fares and Limitations

The reopening of the seaport will usher in the resumption of commercial ferry service between the BVI and the USVI. However, reports indicate the resumed ferry service will vary from the way it was before last year's closure. For instance, ferry service operators such as the Native Son will see an increased ticket price. The new cost for Native Son will be adult fare \$60 one way, children and senior citizens \$50, and \$15 for infants.

Where before the closure ferry capacity was 150 persons, now the capacity will be limited to 50 passengers.

Additionally, it was indicated that only one ferry will be operating per day when the seaports open. Initial schedules show that Smith's Ferry is expected to run on Mondays and Thursdays; while Road Town Fast Ferry makes trips on Tuesdays and Saturdays and the Native Son Ferry running on Wednesdays and Fridays. The ferries will alternate service on Sundays. It was also noted that some of the ferry companies will not be selling round-trip tickets.

Ferry Reroutings cause an issue

The Ports Authority previously announced plans to reroute the ferry traffic to the Cyril B Romney Tortola Pier Park, However, the Opposition Leader explained that there are flaws in this plan. He announced in his 5 April Press Release: "Persons living on the Sister Islands may not benefit from this change. Often shipping bulky items to the Sister Islands via ferry, this may prove to be a logistical nightmare for those persons;

adding to the difficulty already experienced in finding parking and a designated on/offloading location at the Pier Park."

While noting that there are potential logistical issues with this plan Hon. Penn further expressed his fears that the lack of an operational jetty at West End along with ferrying persons into Road Town can harm the Jost Van Dyke economy. "Businesses on the Sister Island are virtually on life support and the livelihood of the business owners and their employees would be at stake," he stated.

Further, the Opposition Leader said that precluding the option of taking a ferry to and from West End might deter visitors from traveling to the Sister Island of Jost Van Dyke where many of the businesses depend so heavily on tourism, noting that the current Administration had two years to ensure a fully functioning West End jetty be made a priority.

Commission of Inquiry Preparing for the Next Phase

The Commission of Inquiry (COI) is moving towards the next stage of the investigation – public hearings. This new phase was announced by Steven Chandler the Secretary to the COI. Mr. Chandler disclosed in a release on Tuesday that the Commissioner, Hon Sir Gary Hickinbottom, is preparing for the hearings.

It was announced that Hon. Hickinbottom is currently

considering holding some initial hearings in late April and early May. "The Commissioner will publish rules to regulate the conduct and management of the COI's hearings later this week," the release stated.

Chandler said that the Commissioner who had travelled to the United Kingdom arrived back in the BVI on Thursday 1 April. It was mentioned that the Commissioner was accompanied by Mr. Andrew King (Senior Solicitor to the COI). All of the Commissioner's team were said to be observing 14 days quarantine.

Once out of quarantine the team is expected to continue with the information gathering and production of documents stage of the COI. It was also disclosed that additional members of the COI team are expected to join the Commissioner later this month.

At the commencement of the second stage of the Inquiry Chandler disclosed that the Commissioner was in the process of obtaining further information and documentation in response to the information already provided by members of the public. The Secretary of the COI at that time disclosed that over 100 letters of request for information/documents were sent to public officials, including elected and statutory officials.

The Commission of Inquiry was announced on 18 January by former Governor Augustus Jaspert. The objective of the COI is to look into whether corruption, abuse of office, or other serious dishonesty may have taken place amongst public, elected and statutory officials in recent years.

Commissioner Hickinbottom, was sworn in on 22 January and began his work from that date.

WORKING OUT FOR EXTREME FITNESS

Many people think about building muscles as abandoning life outside the gym and devoting hours in the gym like a monk in a monastery. Perhaps the only way to chisel the body into a hot muscular physique is by toiling hour by hour over the rusty iron day in, day out and year in, year out.

This need not be so. Although hard work is truly required, extreme fitness demands one to be a slave of the iron weights. Full-body work outs can make one progress and it easily fits in one's schedule. This is very convenient if one is looking forward to achieving extreme fitness but finds it hard to hold on to a single work out routine.

Genuine full-body work outs done by athletes with an aim in mind makes for maximum muscle contraction using heavy weights, makes room for full recovery so one can actually grow and continue to train hard plus it also prevents burnout which is inevitable due to excess training.

So if one is ready for extreme fitness, here is all there is to know about full body work out:

Full-body work out is a time saver. The biggest plus about having the whole body trained all at once is probably having to go to the gym less frequently; perhaps around two to three times for every seven days would be enough.

Another advantage of working out the entire body all at once is that one need not spend two or more hours of strenuous exercise in the gym for every session; one only spends one hour in the gym for every session. 
If you decide to shove off going to gym, you will miss out on the benefits mentioned above and much more. 30 minutes to an hour of physical fitness is major health investment.

TB Test Recommended Only for Those at Risk

DEAR DR. ROACH: I am a nursing student in my 30s and originally from the Philippines. As part of my testing, I had a skin test for tuberculosis, which was positive. I had a friend in the hospital recently with tuberculosis. My doctor has recommended that I get treated for latent tuberculosis. What does this mean? -A.C.S.

ANSWER: Most people who are exposed to tuberculosis will not develop the disease. Some people will develop "latent" infection. This means there is active tuberculosis bacteria in their body, but their system is keeping it from becoming a full-blown infection. People in this situation are at risk of the latent tuberculosis escaping the immune system and developing into tuberculosis. Treatment of the latent tuberculosis is intended to reduce the risk of this happening.

Testing is recommended only for people who are likely to be treated. You have two reasons to be tested: First, as a health care worker - congratulations on becoming a nurse, we need you! you are at risk of acquiring tuberculosis infection and should be screened. Second, people born in the Philippines are at risk for having acquired tuberculosis, often in childhood.

People in their 30s are generally at very low risk of serious side effects from the medications used to treat latent tuberculosis infection. Isoniazid (INH) and rifampin are the medicines commonly used. Since the risk of developing disease later in life is much

effect, treatment is recommended in your case.

DEAR DR. ROACH: I'm an 85-year-old woman with no major health problems. I lead an active life and exercise daily. About four years ago, I began being bothered by cold feet at night. At first, I could just wear socks to bed. Now I must put my feet in an electric heated pouch in my bed, which doesn't stay in place. When I travel, I take the heated insoles skiers use to keep their feet warm. Without some device, I'm kept awake by a feeling of icy soles. I am not diabetic. I've described the problem to a neurologist, a rheumatologist and my primary caregiver. No one has explained what causes the icy feet or if there's any cure. Is there one? - J.S.

ANSWER: There are quite a few possible causes for your cold feet, and your doctors need to first identify why they are cold. To do this, they should start by checking the blood flow to the feet. At age 85, the likelihood of blockages to the arteries in your feet are pretty high. A simple test can make the diagnosis. Since blockages in the feet predict blockages in the heart too, it's important to know. Treatment can improve symptoms as well as reduce risk of a heart attack.

Severe anemia and low thyroid levels can cause very cold feet. Nerve damage is common in diabetes and unusual without it, but a neurologist should have found physical findings for neurologic causes.

Raynaud's syndrome, which usually happens in the hands, occasionally affects the feet preferentially to the hands. Medicines, especially beta blockers, can cause cold feet.

Sometimes there isn't a known cause, and physicians are left advising on treatments to relieve symptoms. I wouldn't give up before a circulation test, however.

Noth won't be idle though. His new show "The Equalizer" has already been renewed by CBS for a second season.




