BENEFICIAL OWNERSHIP REGISTRY SIGNING UPSETS OPPOSITION

"What did we commit to," Leader of the Opposition Hon. Marlon Penn asked with concern as he told the House of Assembly that Premier and Minister for Finance Hon. Andrew Fahie quietly signed on to the controversial public registry for beneficial ownership. The Leader of the Opposition reminded that residents of the BVI marched in the streets against this very decision and he noted that he felt that the Premier should have discussed his decision to sign on with the people considering that even the industry had concerns. However, the Premier and Minister for Finance Hon. Andrew Fahie explained that this was a necessary action.

While speaking at the House of Assembly on 29 September Hon. Penn said he was surprised to see a tweet from the UK Government celebrating the BVI's decision to adopt public registers by 2023. As such Hon. Penn said he was forced to read the speech that the Premier had made on the subject and noted that the Premier made no mention of what this signing will mean for the BVI financial services industry.

In noting that he was informed by the UK that the decision was made, Hon. Penn told the House: "To read a tweet from Baroness Sugg, the Minister for Overseas Territories that says –'great news BVI Government has announced it will join all the other Overseas Territories that committed to adopting publicly accessible registers of business owners by 2023. This is a strong signal of the UK family's commitment to tackle the global problem of illicit finance."

"Mr Speaker I saw that tweet that was re-tweeted and I said I am waiting for the fake news stamp to go out - saying this has to be fake news. A decision like this, of this magnitude, will never be made - even though it is the right of the Premier of the day to make that decision without consultation, or discussion with the elected government of the day. Without a public conversation on the issue with the people of this Territory - 1000s of which marched the streets of Road Town to protest this very same issue of beneficial ownership and public registers. I really don't believe that the people actually understand that we have signed on...," the Leader of the Opposition emphasised.

Hon. Penn maintained that the Premier should have had a consultation before taking such an action: "It struck me, I read the statement I didn't understand. I said no – because it is impossible because an issue so important as beneficial ownership – an issue that all of us who were elected at the time marched to ensure whatever position we had was a joint position – an issue where

the then Premier took the then Leader of the Opposition who is the now Premier to the UK to have joint discussions on."

The Leader of the Opposition told the House of Assembly that after he did not see the Government refuting the UK's tweet he concluded that it was true. However, he explained that the Premier's mention of the matter in an earlier statement did not outline what this signing entails, "After I didn't see the fake news stamp coming around I said this has to be true. That we have indeed signed on to beneficial ownership; that the details have to be somewhere inside of the Premier's statement that he read.... I read the statement. It doesn't, to me based on what I read — it doesn't say what we have actually signed on to. It doesn't show or say to the people of this Territory what our commitment to the UK is. I understand that there is a letter that was written to Baroness Suga dated 17 September 2020 it was the day before our House meeting. Idon't know what the content of that letter is, what was agreed to in that letter" Hon, Penn said.

The Leader of the Opposition called on the Premier to give the

Territory a more detailed explanation on what the BVI's commitment consists in the new publicly accessible beneficial ownership arrangement: "What are we committed to... Have these concerns been addressed? Have we had a comprehensive consultation with the industry?"

"For the people to hear about this in a tweet and statement against the backdrop of the economic situation we are having currently: the fact that our tourism is pretty much shut down and has been shut down for the last six months with little to no activities - what is the impact. What impact does this decision have on our economy because it was already in decline? There was a noticeable decline this year over last year in our financial services industry."

Premier Says This Is the Best Option

Premier. Fahie responded to the comments that were made by Hon. Penn and noted that the acceptance is not for public registers but rather publicly accessible registers. The Premier said: "I came to this House and I stated that we are moving towards publicly accessible registers, but they

were subject to certain things."

Hon. Fahie explained that this route is the better option for the BVI as it allows the Territory to sit in the driver's seat of such a vital matter: "The formation of the framework which we are now saying that we have to be the ones to help put this framework in place...We have to now shape the framework of how this will be able to function...Any framework must adhere and protect the rule of law."

The Premier pointed out that the framework will have to provide a mechanism for those seeking information to be able to access the information they are seeking; however, he noted that there must be a plausible cause to permit such access.

While lashing out at Hon. Penn's comments the Premier said: "The Opposition wants to know what would be the fallout, but they also know that the United Kingdom was threatening an order in council for any OT that they felt wasn't moving in the direction that they wanted to move. They would have imposed it on us...The question you have to ask as a leader is —do you want them to impose or do you want

to not do public register but publicly accessible registers?; and we control our framework and send it to them. Which one would you choose? I'm sure you would choose the one that would allow you to have a hand and to direct how the framework would be," Hon. Fahie explained.

As it relates to the consultation the Premier said that although government met with the industry because a decision had to be made and the industry was clear that something was going to be done: "It wasn't nothing done and the industry wasn't aware, but Mr Speaker I see the tweet went out from Baroness Sugg saying the BVI has finally agreed to public registers but they made sure that they put that out but they didn't put out the part."

Although this decision brings a somewhat closure to the looming public register threat, Premier Fahie said that he still seems the entire ordeal was a form of bullying: "I also see it as 21st century bullying that if you don't do it they'll be an order in council," the BVI Leader said.

Cancer Patients Deprived of Specialists' Assistance

Every October the BVI Cancer Society pulls the Territory's attention to the dreaded disease through promotional efforts aimed at awareness. Unfortunately, the organization has been unable to do as much this year as it was reported that the current COVID 19 pandemic caused disruptions. The Society disclosed that this unprecedented interruption has not only affected its operations but it is causing stress to cancer patients who have not been able to get adequate medical attention in months.

President of the BVI Cancer Society Gloria Fahie during a television interview on JTV this week explained that the organisation is committed to the Territory despite the pandemic. However, the President noted that the past long months have been difficult for BVI cancer patients: "Everything was halted when it came to the British Virgin Islands Cancer Society. Unfortunately, visitation by the oncologist to the Territory was also halted. Patients have not been able to see the oncologist for months and now we have a problem but I am working with the Hon. Minister Hon. Carvin Malone to work out the kinks to allow the oncologist to come in unrestricted."

One commentator told The Island Sun that most specialists have not been able to come to the BVI as regularly as in the past: "This may result in deaths of patients and the Government knew and should have intervened post-haste to allow the specialists in."

In further explaining why the oncologist couldn't visit Mrs Fahie said: "Because of COVID 19, because of the social distancing, because of the curfew, because of the borders being closed – the oncologist was not able to come over from St Thomas."

The BVI Cancer Society President further explained that the

inability for the Oncologist to see BVI cancer patients made a bad situation worse: "They (cancer patients) were further compromised because they were unable to get their treatments associated with any of the cancers."

Many cancer patients in the Territory seek treatment in Puerto Rico and despite some flights, it was explained that even this had some challenges: "Persons were able to go out, it was the coming in that was really the problem," Fahie explained.

Even more troubling was the Cancer Society President's mention that this week five persons were diagnosed to be in the late stage of Colon Cancer. She said that these diagnoses trouble her because it is something that the Cancer Society did public service announcement on. She further explained that this particular cancer is preventable and therefore urged residents to do colonoscopies.

It was also mentioned that the Territory had four cases of breast cancer in men and only one survival.

The same difficulties have impacted the traditionally regular visits of other specialists, including urologists, cardiologists, immunologists etc.

Premier Elaborates on Judicial Reviews Against

Government

Finance Hon. Andrew Fahie wants residents of the BVI to feel free to take the government to task if they find that the leaders of the Territory have contravened the rule of law. In fact, the Premier said that he expects citizens to consider filing judicial reviews against the government if they are concerned about the legality of certain actions.

While speaking at the swearing in of newly

Premier and Minister for Appointed Attorney General Hon. Dawn Smith the Premier explained that the Government is expected to uphold the law: "I encourage the public to challenge the Government with judiciary reviews for any action that they feel that the government did not do according to the rule of law and the best interest of the people of the Virgin Islands," the BVI Leader said.

> The Premier explained that by filing a judicial review

BVI citizens will be able to seek recourse for written governmental policies as well as actions: "It is a useful tool to ask the Court to review any decision written or done by the executive of the Territory. It is not a bad thing, it's a good thing for democracy."

"That's why the separation of powers is so important to the rule of law because the Court is there to ensure that any breach or misinterpretation of the law by the executive can be reviewed via judiciary review and I welcome any judiciary review against any decision the executive makes as in the Miller cases in the United Kingdom which I am studying very very thoroughly right now," he pointed out.

The BVI Leader further declared that no man or woman is above the law and all men and women are subject to the law. Therefore he urged the new Attorney General to ensure that she maintains the law.

Further, the Premier stated that the government looks forward to a harmonious relationship with the Office of the Attorney General. He said that the government, Ministries and Departments will work together with the new Attorney General and the Attorney General's Chambers under the newly appointed AG Dawn Smith's leadership.

"I urge the Attorney General Hon. Dawn Smith to always keep the integrity of the rule of law. It is important for this office of the Attorney General to keep the integrity of the rule of law. Once we keep the integrity of the rule of law then even governments can be challenged to ensure that there is democracy," the Premier added.

BVICCHA Disappointed About Shelved Protocol

The British Virgin Islands Chamber of Commerce and Hotel Association's (BVICCHA) President of Hospitality and CEO of the Incline Business Group (IBG), Chaunci Cline announced last weekend that the Chamber is disappointed that the reopening Protocol that was worked on and submitted to the BVI Tourist Board will not be utilized.

In an announcement on 3 October, the organization stated that in collaboration with IBG a small task force from the BVICCHA worked to create the BVI HI 5 Assurance Programme Guidelines which is aimed at promoting visitor confidence.

The organization told the media: "These guidelines included the recommended steps for a soft reopening with a safe haven concept with outer islands on 20 June 2020. This period would allow for the protocols to be thoroughly tested for the requested reopening date of 1 September 2020. The idea of the BVI HI 5 Assurance Programme was to certify that the businesses pass all requirements and have minimum standard operating procedures in place before the full reopening of the borders to visitors."

It was disclosed that the proposal for the guidelines was submitted to the BVI Tourist Board and later submitted to the Government of the Virgin Islands for input and/or decision. According to the BVICCHA: "The protocols and programme were recommended and embraced by the BVI Tourist Board until 21 September 2020 when the BVI Love Campaign was launched. Before the campaign's launch, BVICCHA and IBG were very confident that the programme would be implemented to help build traveller confidence in our national preparedness and protocols while educating and equipping the country to

open safely and responsibly to visitors of the BVI."

The Chamber said that it was disappointed to hear that after giving assurance the BVITB decided not to use the guidelines: "On 30 September 2020, the BVI Tourist Board informed IBG that they decided not to proceed as initially planned with the BVI HI 5 Assurance Programme," the Chamber explained.

It was expressed by the BVICCHA that despite its disappointment it would ensure that the work that went into the Protocol's creation is not wasted. Cline told the members of the

BVICCHA that they will still put the Guidelines to use. "The time put into this project will not be lost as the proposed and recommended BVI HI 5 Assurance Programme Guidelines are now available for all to review."

The Chamber of Commerce further stated that: "Despite this unfortunate and devastating news and many hours of work to get the guidelines and protocols developed, the team remains committed to working on behalf of the industries to influence the role it plays in fighting for the country and everyone's livelihood."

Statement by Premier Fahie at Contract Signing - The BVI is in Transformation Mode

Contract Signing Ceremony for The Ballast Bay Road Rehabilitation & Slope Stabilisation, Great Mountain II Road Rehabilitation & Slope Stabilisation and Repair Work to Road Town Police Station

Monday, 5th October 2020

A pleasant good day and God's blessings to all of you present here today, and to those viewing online, and listening via the radio.

I want to begin first by thanking God for giving us as a Territory the opportunity to rise to every occasion where no job is too small or too large for us to handle.

It is a good feeling to be standing here this morning for the signing of these contracts.

It means that "We are getting there!"

We continue to be pleased as a Government to renegotiate some of the terms in the Caribbean Development Bank's Rehabilitation and Reconstruction Loan when we took office in 2019.

This was important to make sure the people of the Virgin Islands have a stake in the development of their

In the latter part of 2019, the revised Recovery to Development Plan was laid on the table of the House of Assembly without any objections.

The new Revised Plan separates recovery projects from development projects. The recovery matters were assigned to the RDA in order to allow more focus to take place.

The renegotiation was important because it could not be just or fair for this money to pass through the BVI's economy, and the BVI businesses and workers are pushed to the side and disadvantaged from being able to access the benefits of this cashflow. By successfully renegotiating the terms with the CDB, our BVI workers, and businesses, can get a vitamin boost from this

I am pleased that the Recovery and Development Agency, since it has gotten a better focus, with the review of the revised Recovery and Development Plan and renegotiation of the Caribbean Development Bank's Rehabilitation and Reconstruction (RRL) Loan to ensure more local participation in the building of this economy.

I thank the Recovery Development Agency for doing its part and for continuing to move projects forward, and for not allowing the perfect to become the enemy of the greater good.

BVI companies, executing BVI projects, managed by our BVI RDA which is led by BVI talent, and utilising funds sourced and raised by the BVI at this time where we the BVI people are the ones that must repay the loans raised. Hence the people of the BVI must be given every opportunity to benefit from these funds in an accountable and transparent manner while insuring value for money. This is what your Government has insured through the negotiations with the CDB and other agencies on behalf of the people of the Virgin

We continue to welcome foreign investment as we continue our recovery.

I am happy that the RDA is moving forward and is completing many projects across districts-projects that should have at least started by early 2018, as many of the issues we are addressing now were present from 2017 as a result of the destructions caused by Hurricane Irma and we are taking care of them, now allowing our local contractors the opportunity to drive the construction development of this economy.

As everyone should know by now, it is one of my passions to see our Virgin Islands people rising up to their fullest potential thereby taking charge of their destiny. I am pleased to say with today's contract signing we are moving there, and we are getting there!

I have confidence in my people of this Territory.

I believe in their capacities and capabilities, and I am pleased that our people continue to rise to the challenge and create portfolio to access the jobs and earn an income.

Like the speakers before me, I congratulate Mr. Dion Stoutt of STO Enterprises: Ms. Dawn Crabbe-Herbert and team from Autland Heavy Equipment Co; and Mr. Kendol Arthur of K and C Construction for rising to the occasion.

As Premier and Minister of Finance, you know it is one of my mantras that the people of the BVI must benefit from the economic activity that takes place here.

I look forward to the ripple effect where people get to truly participate and benefit from the economic activity that is taking place on our shores, especially in the New Regular of living and working with COVID-19 where we are using what we have in our hands to jump start our economy, create jobs and domino opportunities. I have been saying from Day 1 that we need to get the funds from these projects to circulate more in the economy, we are getting there!

Giving our people a chance - giving them a little push, putting some wind beneath their wings, showing a little bit of confidence in them - is the first step to helping us to correct this situation.

As we have seen, with many of the projects, standards and quality of work are high and done with BVI Pride, and resumes are being strengthened to put our people in positions to even bid externally.

It is a fact that projects can be redesigned to allow local companies to perform within their capabilities while at the same time affording them the chance to learn and to build their resume.

And through monitoring, evaluation, supervision, management, training and learning, we can make sure that we achieve the high standards and deliver value for money to our taxpayers.

We have made this case to the international lending agencies and some of them have given us a hearing.

Lending agencies are now working with us to give this policy shift a chance. We are getting there!

The technical officers in the Ministry of Finance and the Ministry of Works, Transportation and Utilities have put their heads together and they have come up with a framework that will facilitate our local contracting companies in growing so that they will not stay in the same place and at the same level; but on the contrary, they will be able to learn and develop new capabilities so they can qualify for large, more challenging and higher paying projects. The framework will involve training and a continuous improvement programme.

This, will of course, be complementary to other capacity building initiatives that are available and which are taking place.

For instance, I am pleased with the efforts of the RDA in executing its own capacity building mandate. Through various workshops, the RDA provides BVI Contractors with learning opportunities through training, bidder's conferences, site visits and on the job training to deliver projects, strengthen their capability, bid and win projects based on international public procurement procedures.

This, of course, will go a long way in building up BVI contractors to be prepared for the future BVI economy and to be able to bid, win and deliver projects across

And this is very important. Because the BVI is in transformation mode.

If we learnt anything from our experiences in tourism and financial services over the past few years, and now with COVID-19; we cannot carry on using the same models and methods as we did 5, 10, 25 years ago.

The world has changed. The industries we depend on have changed. New industries have emerged. New technology has emerged. And we cannot allow ourselves to live in the mindset of the past.

We need new industries to create new economic streams. Although in the past there was little effort to diversify, we must do so now and do so with haste and precision.

Green energy and Smart technology present us with some opportunities here, but there is a lot more that we can do if we use our innovativeness and our entrepreneurial eye to survey the landscape.

We need to become more competitive - not just among ourselves but within the region and beyond. Becoming more competitive means we have to be able to do the job and deliver quality within a reasonably good price; and we have to look at how we stand in relation to other providers of the same or similar goods and services.

I spoke about this in relation to our tourism product when we launched the BVILOVE rebranding campaign last week. You would have heard me saying that BVILOVE is our brand that must pervade everything we do.

So, here too in construction, we must work with BVILOVE.

When we understand that these projects, the contracts, the training, the negotiations with international lending agencies, and all the other battles that are being fought on your behalf by your Government, are feeding into a bigger picture, which is to awaken our abilities and strap a booster rocket to the backs of our citizens, so that we propel the citizenry as a collective into a new future - then we will see why these things are not to be taken lightly or for granted. It is then you will understand why we will not relent when setbacks come, but that we will press forward with greater determination.

Some persons may say these are minor things, but we are paying special attention to them because this is how we build our nation. This is how we advance our people. This is how we transform this BVI and realize the dreams of our ancestors.

So, your work has to be a labour of love. Put your all into these projects because you have something to prove - and that is that those who put their necks on the block for you, your companies, and your workers, made the right choice.

When you work with BVILOVE, you are clearing the path ahead for your own company, but you are also leaving a path behind for others to also be lifted up. And when all of this comes together, the Territory benefits socially and economically by us being able to handle projects with local talent.

It is a known fact that the future is for the prepared. And as we embark on the journey of transforming the Virgin Islands into a leading regional economy, and as we march towards becoming more self-reliant, self-determined and less dependent on others, we must first prepare.

We can only cross certain hurdles that lie ahead if we are already first prepared by the time we approach those hurdles

So, we must continue to develop ourselves, develop our capabilities and our capacity, and then we can discuss what we can and cannot do, or what further preparation is needed.

But, if we sit down and do nothing, just going through the motions and the routines, then we will never start the preparations.

And just like how many major challenging events hit us suddenly, or just how Irma, Maria and COVID-19 turned our reality upside down in a matter of hours. so too we will continue to face challenges - different challenges with more at stake - and we must be ready.

And the price for being unprepared can end up being very high.

So, once again I say, everything we do, we must do with BVILOVE, because our Territory is depending on positive, successful outcomes.

I want to thank and congratulate the team at the RDA, led by Acting CEO Mr. Anthony McMaster, for continuing to support the Government of the Virgin Islands and the Territory in our recovery following the 2017 catastrophic natural disasters, and now as we continue working to reboot and re-energise the local economy in this New Regular under COVID-19.

I also wish to congratulate our local contractors who will be signing here today. Remember, we want these projects delivered with BVILOVE — this means best quality, on time, in budget and value for money.

Your Government, your Premier and indeed the Virgin Islands people believe in you and also we are proud of you.

I am also very pleased that our Police Station will soon be operating from a better working environment.

Government To Discuss Reopening Protocols With Service Industry

Officials from the BVI Tourist Board will discuss the draft reopening protocols with stakeholders specific to their respective tourism sectors starting this week.

Premier and Minister of Finance, Honourable Andrew A. Fahie said that it is critical that Government meets with stakeholders in the service industry at this juncture as it actions its reopening plans for the Territory.

Premier Fahie said, "As I have said on many occasions, we are in this together, Government officials, Government agencies and private sector in ensuring that our guest are welcomed in the safest manner possible and that our communities remain safe as well."

The Premier, who is also the Minister for Tourism, said that the discussions are expected to be productive as the industry experts get an opportunity to review the plans and give input which will ultimately aid in the finalisation of the COVID-19 protocols for that industry.

Meanwhile, Chairperson of the BVI Tourist Board, Mrs. Kenisha Sprauve said the board is eager to lead the discussions with its industry partners as they finalise the COVID-19 health and safety protocols for the various sectors of the Tourism Industry.

She said, "The frank and impartial discussions will be the perfect opportunity for experts in the various industries to lend their voices to the COVID-19 strategies proposed for the reopening."



Hon. Dawn J. Smith STATEMENT BY THE ATTORNEY GENERAL HONOURABLE DAWN J. SMITH

AT THE FIFTEENTH SITTING of the SECOND SESSION of the FOURTH HOUSE OF ASSEMBLY

1 OCTOBER, 2020

Mr. Speaker, I dedicate my presentation today to expressing my sincere thanks to the Government and people of the Virgin Islands for the confidence that they have placed in me to perform the role, duties and responsibilities of Attorney General. In doing so, I will talk about who I am, how I got here and what I am going to do.

Mr. Speaker, I did not make myself. Nearly 50 years ago, I was born at what was then Peebles Hospital on what I believe was the happiest day of my parents! life. Naturally, they cannot admit to this as they have 3 other children – all of whom have made them very proud. I – on the other hand, decided to become a lawyer!

Under the care and tending of my parents, teachers, community and extended family, I made my way through the public school system – the East End Primary School and the BVI High School.

As the valedictorian of the BVI High School Class of 1988, I was awarded Government-funded scholarships that, together with my parents! contributions supported me over 9 years of tertiary education. I tried my best throughout not to disappoint and on completion of my studies, I was happy to return home. I have no regrets whatsoever that I did.

I was fortunate, Mr. Speaker, to have been welcomed to the Bar even before I was called to the Bar. In 4th Form, my Spanish teacher asked

one of the most senior members of the Bar to take me under his wing for job-training. He agreed and gave me my first real exposure to the practice of law. In his Chambers, a young lawyer took the time to tell me about the honourable profession of law with its traditions as "old as the hills" and she introduced me to legal dress. A couple years later, when I was employed as a legal secretary under the watchful eve of one of my aunts, I was captivated by the sincerity of another lawyer as he talked about, and in his work demonstrated, his love for the law. Then, having just been admitted to Cave Hill, I boldly introduced myself to an up and coming lawyer when I saw him walking on Main Street one day. He was gracious and I was rewarded with a letter of introduction to a friend in Barbados and, as in the case of the other lawyers mentioned, mentorship from then on. 2

After being admitted to practice, I saw the kaleidoscope of life and law through property and bank transactions, wills and probate, admiralty, divorces, adoptions, debt collection, corporate work, litigation and whatever else came my way. My seniors and contemporaries at the Bar would challenge me as an opponent yet remind me to notch every win in my desk, no matter how small. Even court staff would give me tips on presenting my cases. It seems as if everyone pitched in.

Mr. Speaker, I have learnt a lot from many people. I have avoided naming names because truth be told – we would be here for quite some time if I were to individually acknowledge the many people – from everywhere and from all walks of my life – that have brought me here today. From them, I have learnt that all of us contribute to the existence of each other, that we must use what talents we have and not let others define us, not to fear adversity and to cherish my visions, my dreams and my independent spirit.

This is not to say Mr. Speaker that there were no difficult or interesting times or people who were not so nice. In fact, there were many and I expect that there will be many more but I have long resolved in the words of the prayer that some of us know.

"... to do my allotted task with unflagging faithfulness... to be gentle in the face of ingratitude or when slander distorts my noblest motives, ... to come to the end of each day with a feeling that I have used its gifts gratefully and faced its trials bravely...

Mr. Speaker, the office of the Attorney General requires a combination of independence, expertise and seniority.

Our Constitution tells us that:

(i) There shall be an Attorney General whose office shall be a public office and

who shall be appointed in accordance with section 95;

(ii) The Attorney General shall be the principal legal adviser to the Government and, among other things,

(iii) That the Attorney General is an ex officio member of Cabinet, the House of Assembly and the National Security Council and a member the Prerogative of Mercy Committee.

Apart from the Constitution, several laws prescribe responsibilities for the Attorney General and the Attorney General also has to ensure [as the job description puts it] _the smooth and efficient operation of Chambers. I in addition, the Attorney General has to perform as a lawyer with the special professional obligations which attach as a legal practitioner, as an officer of the Court, as the head of the Bar and as the legal representative of her client - the Government.

Mr. Speaker, I started by saying that I did not make myself. Now I go further and say that, given the plethora and variety of responsibilities attached to the role, I alone cannot make a success of my tenure as Attorney General. The Government including the entire public service is an interdependent sum of its many parts and time will tell whether I will be able and allowed to do what I am perfectly capable of doing. I cannot work miracles 3

Mr. Speaker and I will rely on you and all the honourable members and participants in this Honourable House to conduct the subject affairs in an exemplary manner. Politics aside (for that is not my role), may we always be candid and respectful to each other, always mindful of who we are and who and what we represent;

I will depend on decision-makers at all levels of the Public Service to make good decisions – those that are substantively sound, follow a fair process and comply with the law:

- Mr. Speaker - I have every confidence that the Honourable Premier and Minister of Finance will do his part - but I will look to the Governords Group to ensure that the Chambers is, as advertised, "a normal working environment». In 2020, this must mean that it will be equipped and staffed to deliver the quantity and quality of legal representation in the manner befitting the Government of a modern, progressive society – which, you will agree Mr. Speaker – we are.

I expect that every single member of Chambers (attorneys and other professional and support staff) will bring their best selves to work every day, to take pride in our work and in ourselves and to be relentless in delivering the highest quality of service, advice and representation to the Government.

And, I will hold the Bar at large and the BVI Bar Association, in particular, to continue and indeed, to improve its contributions to the practice and rule of law in these Islands and to mentorship, professional development and continuing legal education.

Mr. Speaker, my fundamental responsibility as Attorney General is to act in the public interest. I will do this by speaking law and truth to power and seeking to come up with the best solutions to ensure:

(a) that the operations of the Government are conducted lawfully and constitutionally; and

(b) that the Government is not prevented from lawfully implementing its chosen policies.

Mr. Speaker – I must say a few words about being a Virgin Islander.

On 11 Feb 2004, the then Government appointed a Commission to carry out a review of the 1967 Constitution with a view to ensuring the continued advancement and good governance of the Virgin Islands and, in particular, to review [among other things] the duties of the Attorney General as the chief legal adviser to the Government.

In their 2005 Report, the Constitutional Commissioners, who were drawn from a cross-section of the Virgin Islands community, recommended that the Constitution expressly establish the office of Attorney General and provide for the office to be filled, in the first instance, by a suitably qualified Belonger. Only where such a person cannot be found or is not available [they recommended], ought the position to be filled by someone else and, in such instance, only on contract."

Mr. Speaker, as the then Director of the BVI London Office, I – like the Hon Member for the 3rd District - was in the room when the 2007 constitutional negotiations were concluded. From that moment, the Constitution was destined to provide, as it now does:

No person shall be appointed to the office of Attorney General unless he or she belongs to the Virgin Islands unless, in the opinion of the Judicial and Legal Services Commission, there is no such person who is suitably qualified and able and willing to be so appointed.

Mr. Speaker, it has taken 13 years for this recommendation, which was strongly urged on the Constitutional Commissioners by the public and the Legislative Council (as it was then) and accepted by the framers of the constitution, to come to fruition. Before me, only one such person (21 years ago) has held this position. Of course, I recognise those persons who, not being belongers at the time, have subsequently attained that status but there the cart was before the horse.

Mr. Speaker, the Constitutional commissioners themselves recognized what they called "the practical limitations on finding Virgin Islanders willing to take up the mantle,

even for a short period (para 3.28)." I confess that as a Virgin Islander I did not, for many years, see this particular job or even working in Chambers as a newly qualified lawyer or at any point in my career as even remotely attractive. The strength of support and good wishes following the rumours and announcement of my appointment has been sobering and cause for personal introspection. We have to get our act together Mr. Speaker and I hope that, during my tenure, whatever it is that creates such an unwillingness can be rectified and banished forever.

Finally, Mr. Speaker I come back to expressing my thanks, I cannot end without expressing here my special gratitude:

 to our God for his goodness and mercy;

 to my beloved Daniel, my parents Alphagena & Bennet, my siblings Neil, Tessa and Clive, my beautiful children everywhere and my extended family for their enduring love and acceptance.
 I acknowledge the confidence being placed in me and the efforts and sacrifices that have been made on my behalf or for my betterment.

I have blessed with prayers, warm congratulations and well-wishes from all over these Islands and across the globe. They use words like "hopeful", "happyli and "proudi and it is not lost on me that while being the Attorney General is my responsibility - my being the Attorney General means many things to many people. I know now from the outpouring of support, good wishes and prayers that I represent not just myself but the people who have made me what I am (for the better or worse), those who share my experiences, those who wish me well and those who are depending on me to perform my responsibilities to the highest standard, 5

I am, of course, also very grateful to you Mr. Speaker for organising this special sitting, for the very warm welcome given to me by the members of this Honourable House and to all in attendance today in person or online for their presence.

I am well and truly humbled.

And I thank you, Mr. Speaker.

Property owners in the Virgin Islands are advised that the Magistrate will listen to objections on the 2020 assessment of property at a court sitting on Friday, October 9th at 10:0a.m. Due to restrictions with Covid-19, the court sitting will be conducted via zoom at https://zoom.us/j/93883214076?pwd=MzFvaUdPcXp3am9Ea1hZd3FQR3Z4UT09.

Property owners are encouraged to pay the 2020 Property Tax at this time to avoid interest being charged at twenty percent per annum. Owners should also pay or arrange a payment schedule with the Inland Revenue Department to liquidate any outstanding Property Tax. Legal transactions are not processed for "Stamp Duty" purposes unless the tax relating to the parcel is paid.

The Road to independence is a process

The road to Virgin Islands independence is a game of chess, not dominoes

Now, one reason it appears any talk of independence swiftly dissipates into farce, is the very nature of the beast.

To begin with, the winding, bushy, and thorny path, to independence is further strewn with traps, obstacles, and deep holes. The road to independence has never been an easy road. If one is in any doubt, simply look at history. Hundreds of thousands have died in wars and intrigue leading to national freedom and independence in the Americas, the Caribbean and Africa.

Independence within CARICOM for any Overseas Territory of Great Britain begins with a clear vision of how that independence is to be achieved, the form of that independence, and how independence will benefit citizens and residents.

If there is no vision of independence, and just a cry for independence, the people who truly matter in the debate- Joe and Jane Public- will remain skeptical and wary. That is one reason natives appear not to want independence: the whole

matter of independence has not been explained in a wholesome and effective manner.

The road to independence is a complex process. It is a game of chess where every move must be done with great deliberation and calculation.

Talk shows and online arguments for or against independence are a worthwhile exercise. However, for any movement towards independence to be successful it requires a whole lot more.

First there must be unity of purpose within the country on how the process is to move along and that requires leadership.

Independence frequently begins with a national referendum after public discussion. But even before a referendum is reached, there will be months, if not years of discussion and negotiation between the UK and Overseas territories at the highest levels.

If there is no unity of purpose, then any effort to push the process of greater autonomy and ultimately independence forward, hits the proverbial wall.

For one the UK has all the power in the process. And the UK has always been adept at playing the imperial chess game. So the Foreign and Commonwealth Office and the powerful Mandarins in London know exactly what chess piece goes where on the power board in order to frustrate the process. They have been playing this game since the 1600s.

Consequently the first step is to decide the process: or in other words how the chess game leading to independence is to be played.

It will require patience. It will require diplomacy. The game will have to be played through public education and public acceptance of the process. The game will have to acquire the trust of over 70% of the native and resident population. And the game will have to be played in a disciplined, patient, and intelligent manner.

Independence can be likened to a game of football. One side is very experienced in the game with older players who are adept at both defense and offense. The other side is young and inexperienced, but determined and energetic.

Ultimately experience will win, until the inexperienced side starts to understand how the game is played to win.

That is why any move to independence by the OTs requires a lot more than talk and emotion. It requires a high level of public involvement, collaboration with big players inside and outside the country, understanding where country wants to end up after independence, the costs and benefits of independence, and how a new independence constitution can build resilience, greater national security, and long term social and economic prosperity for the Virgin Islands.

Without a clear and specific vision of an independent Virgin Islands in twenty years, then the effort of fighting for independence will face continual frustration and road block.

It will not get anywhere.

CUBA - (Prensa Latina) The tourist resort of Varadero will be ready as of October 15 to receive international tourists and air operations that are requested to travel to that destination, the Ministry of Tourism of Cuba (Mintur) reported here.

According to this source, the initial stage foresees a partial opening in which clients will be able to enjoy accommodation in four and five-star hotels, engage in maritime excursions, nature tours and other activities, within an approved zone.

This phase includes extrahotel activities associated with the Chapelin and Gaviota marinas, gastronomic, commercial and recreation services, as well as the dolphinarium, among others.

As hygiene measures to avoid the transmission of COVID-19, it was established in the protocols that all services will be paid by customers with the use of their credit cards to avoid the manipulation of cash.

Likewise, there will be a medical team in all the hotels of the resort who will accompany vacationers during their stay, and will carry out frequent health investigations, the Mintur said in a statement.

The Juan Gualberto Gómez international airport, in that resort, is ready to resume all its operations and biosecurity protocols are in place to receive visitors, Mintur reported.

The urgent need to reactivate

Caribbean states to lift restrictions
on entering the country imposed by
the COVID-19 pandemic, although
with some conditions.

The governments of Belize, Guyana and Saint Kitts and Nevis have just announced the reopening of their borders to commercial flights in order to revive the most important economic source.

The first of them did so on October 1, while the others will do so on October 12 and 31, respectively. According to the site Viajes por el Caribe, Belize implemented a so-called Program for Recognition of the Gold Standard for Tourism and a corridor aimed at guaranteeing the health and safety of travelers and residents. The initiative will certify accommodations and tour operators that adopt the new behavior and establish procedures with a minimal impact for guests.

Belizean authorities clarified that the creation of a corridor is a temporary measure to minimize the interaction between tourists and the local community as a way to prevent the spread of COVID-19.

However, provisions such as the mandatory use of face masks, social distancing, improved room cleaning and guest health checks, among others, will remain in force. With similar measures, Guyana will begin to receive tourists on October 12, despite the seven-hour curfew that will last until the end of the month.

With this objective in mind, it was decided to start operations at two airports with specific health security guidelines, among them the mandatory performance of virus detection tests for all people entering the country.

For its part, Saint Kitts and Nevis will lift the closure of the country on October 31 and allow the restart of international commercial flights and the arrival of travelers.

Since the beginning of the pandemic, Belize has registered 2,260 confirmed cases of the disease, of which 1,272 recovered and 27 deaths, while Guyana reports 3,42, 1,907 and 85 deaths and Saint Kitts and Nevis only 19, 17 and zero deaths.

MONTEGO BAY, St James - Noting that Jamaica has become the most COVID-19-resilient destination in the Caribbean, Tourism Minister Edmund Bartlett has announced that Government is fine-tuning the process of introducing a historic health insurance and repatriation programme for all visitors to the destination, to come into effect, hopefully, by November 1.

"By the first of November we hope to inaugurate in the world a complete and comprehensive, end to end health insurance, repatriation and logistics programme for all visitors coming to Jamaica," Bartlett announced.

He explained that visitors will buy the health insurance policy — which will be attached to their flight ticket — to provide them with full health coverage prior to their arrival in Jamaica. "For a small cess on their ticket they will be able to come to the country, ensure that their testing is done...whatever health requirements are needed when they are here on the island will be covered," the tourism minister stated. (Jamaica Observer)

The term comes from the environment the fraudsters traditionally worked in, packed into a small room with a load of telephones and computers, they phone innocent victims and crank up the pressure on them to invest in dodgy or non-existent investment or land banking schemes. These scammers can be highly aggressive as they turn up the pressure to get you to 'invest'.


They often return to the scene of the crime too, so you throw good money after bad to recover your losses.

Efforts aimed at replenishing the Territory's Mangroves

A series of efforts aimed at replenishing the Territory's mangroves were embarked on through a collaboration between the HLSCC Centre for Applied Marine Studies (CAMS) and community conservationist.

Mangroves are vital to territories such as the BVI's ecosystem. Unfortunately a number of the BVI's mangroves were destroyed by the two catastrophic hurricanes of 2017; coupled with natural reductions.

The College's Centre for Applied Marine Studies has a Mangrove Nursery which has raised hundreds of seedlings; which over the last weekend were planted in various locations around the Tortola. The first set of seedlings were planted at Frenchman's Cay. However, before this

planting could have taken place the area had to be cleared of debris. Following the hard work of cleaning the conservationists were able to restore mangroves to that area.

It was disclosed that some 632 mangrove seedlings which were grown at the HLSCC Mangrove Nursery were planted at various identified areas in the Territory. Most impressive was the mention that more than 100 volunteers participated in this project.

At the completion of the series of transplanting it was noted that: 132 seedlings were planted at Gun Creek, Virgin Gorda; 204 at Sea Cows Bay, Tortola; and 296 at West End, Tortola.

















Ladyburd Talks

Dear Readers: How to cultivate a calm state of mind

We know how to become stressed. Most of us are really good at activating our adrenal system and getting wound up. The question becomes, then, how do you wind down? Research suggests several practices that not only feel good but also put us into a calmer, more relaxed state—a state from which we can cope better with whatever life throws at us.

1. Breathing.

Our breathing is a powerful way for us to regulate our emotions, and it is something we take for granted. Through your breath, you can activate your parasympathetic nervous system—the calming response in your body.

Using your breath, you can change how you feel. In another study, researchers observed people feeling different emotions and found that there was a different pattern of breath for each one. Then, they gave other people the different breathing patterns to perform and asked them, "How do you feel?" It turned out that doing those breathing exercises actually evoked the emotions.

One of the most calming breathing exercises you can do is to breathe in (e.g., to a count of four), hold, and then breathe out for up to twice as long (e.g., to a count of six or eight). You can gently constrict your throat, making a sound like the ocean, which is used in deep relaxation breathing. As you're doing this, especially thanks to those long exhales, you're activating the parasympathetic nervous system, reducing your heart rate and blood pressure.

TWO LOADED FIREARMS TAKEN OFF THE STREETS

He was arrested and brought to Road Town Police Station and has since been charged with carrying an unlicensed firearm and will appear before the Magistrate on the next available court date.

RVIPF OPERATIONS UNCOVER DRUG AND TRAFFIC OFFENDERS

Tuesday, October 6 – Several serious traffic-related offences and unlawful drug possession charges were laid by the Royal Virgin Islands Police Force during stop/searches within the last two months.

The Force reported the results of several operations conducted during the months of September and October.

During the month of September, one male was charged with reckless driving and unlawful possession of a controlled drug. Another male was also charged for reckless driving, driving when not covered by insurance, failing to apply for change of ownership of vehicle, driving without a rear license plate, failing to stop at the sound of a siren and driving an unlicensed vehicle.

At the end of September, one male was also charged for reckless driving, possession of a controlled drug, possession with intent to supply a controlled drug and driving when not covered by a policy of insurance. - 3 stalks of celery, cut into matchstick pieces
- 2 tablespoons extra-virgin olive oil
- 3 tablespoons fresh lemon juice
- 2 tablespoons chopped fresh parsley
- 2 cloves garlic, minced
- · 1/2 teaspoon ground cumin
- 1/4 teaspoon ground cinnamon
- · 1 teaspoon sweet paprika
- · 1 teaspoon salt
- 1 teaspoon black pepper
- 4 large Hass avocados, peeled, cut in half and pitted
- 2 teaspoons apple cider vinegar
- In a large bowl, mix together carrots, apples, celery, oil, lemon juice, parsley, garlic, cumin, cinnamon, paprika, and salt and pepper. Cover and let marinate in the refrigerator for at least 2 hours to allow flavors to meld and permeate the ingredients.
- Place 1/2 cup of the salad on each avocado half. Sprinkle with apple cider vinegar. Serve chilled or at room temperature. Serves 4.

American Airlines Planning Pre-Flight Testing for Jamaica, The Bahamas

American Airlines is planning to launch pre-flight COVID-19 testing on certain flights in the Caribbean region.

The plan will begin with preflight COVID-19 testing for customers traveling to Jamaica and The Bahamas.

Jamaica will be the first destination, with American Airlines having reached an agreement with Jamaica to launch an initial testing program at Miami International Airport next month.

The initial phase of that program will be for Jamaican residents traveling home. If a passenger tests negative for COVID-19 ahead of flying with America, the current 14-day quarantine in place for returning Jamaican nationals would be waived.

Following a successful pilot program, American aims to open the testing protocol to all passengers traveling to Jamaica, including U.S. citizens.

"I thank American Airlines for initiating these efforts to ensure safety and confidence for travelers from the United States, and for leading with Jamaica as a pilot for its COVID-19 testing program," said Audrey Marks, Ambassador of Jamaica to the United States. "This is timely, given the government's ongoing review in cooperation with the Global Initiative for Health and Safety group of the current protocols governing travel to the island, and it could be a game-changer, not just for tourism, but also for other key sectors of the economy that have been negatively impacted by the ongoing pandemic."

American Airlines is also working with The Bahamas and CARICOM to launch similar testing programs.

The next program would be with The Bahamas, with similar plans to launch next month.

"We are so pleased that American Airlines has included The Bahamas in their preflight testing program and for their continued commitment to mitigating the spread of coronavirus," said Dionisio D'Aquilar, Minister of Tourism and Aviation for the Bahamas. "Miami is a major gateway to our islands, and we believe predeparture testing will create important efficiencies, while ensuring the health and safety of both our visitors and residents."

American Airlines has not yet revealed what kind of testing would be conducted.

The carrier has revealed similar plans for certain flights to Hawaii. On those flights, one option is on-site airport rapid testing administered by a company called CareNow.

"We are pleased that American Airlines has taken the lead to initiate this exciting COVID-19 predeparture testing program," said Ralph Gonsalves, Prime Minister of Saint Vincent and the Grenadines, and current Chairman of CARICOM, "The Caribbean Community welcomes this important progress to reopen markets with the health and safety of our citizens being of paramount importance, and we'll be monitoring this program very closely as it ramps up in our region."

2020 US Presidential Election Could Be **Like No Other in US History**

WASHINGTON - The U.S. presidential political cycle is nearing its crescendo with some voters already casting their ballots by mail or going to early voting centers ahead of the November 3 election.

And just as the main presidential campaigns for Republican President Donald Trump and his Democratic challenger, former Vice President Joe Biden, are making their final push for support, election security officials are increasingly sounding an alarm - that this election day will be unlike any other in recent history.

Due to the coronavirus pandemic, some experts predict as many as 80 million people in the U.S. will have voted by mail for the November election, compared to about 33 million people (who voted by mail or voted absentee) in the last presidential election in 2016.

"Have a little bit of patience," Christopher Krebs, the director of the Cybersecurity and Infrastructure Security Agency (CISA), said during a discussion at the Billington CyberSecurity in September, "This is probably going to take a little bit longer to do the counting."

The warning from Krebs is being echoed by other officials at the national, state and local levels who are urging U.S. voters and the media to adjust their expectations.

"The reality is it's not about election day anymore. It's about [an] election time period," a senior official with the Department of Homeland Security said in August, while briefing reporters.

President Trump, though, has not voiced the same type of patience.

"I want to have the result of the election. I don't want to be waiting around for weeks and months," Trump told reporters during a briefing this past July (30).

It is not unusual for certified election results to take time. For example, Congress did not certify the results of Trump's victory in the November 2016 presidential election until January 6, 2017.

Still, based on the initial results, Trump declared victory and Democratic candidate, former Secretary of State Hillary Clinton, formally conceded before most Americans woke up the day after the election.

But if the predictions of current election officials play out, and election officials are still counting ballots on November 4, it will be the first time since the 2000 presidential election that Americans will have to wait for some time before knowing who won. That year, President George W. Bush won after a lengthy legal process involving a recount in the state of Florida.

Adding to the potential for election result confusion is the likelihood that the results themselves, even once they and local election officials are already preparing for potential lawsuits.

Data from the Federal Election Commission show both the Trump and Biden campaign are spending hundreds of thousands of dollars on lawyers in preparation for the expected legal fight.

The expected wait for election results is just part of the story.

Here are five other reasons the November 3, 2020 election may be unlike any other in recent memory:

Coronavirus

On March 13, with reports of more than 1,100 COVID-19 cases in 49 of the 50 U.S. states, President Trump declared a national emergency.

Other states, like New York, New Jersey, Ohio, Maryland, Kentucky, and others soon followed with delays of their own.

Despite states reopening to various degrees since then, many are are certified, will be challenged. State still encouraging the use of mail-in ballots for the November presidential election to reduce the risk of COVID-19 transmission.

Mail-in Voting

Even before the coronavirus pandemic, some U.S. states were embracing the idea of conducting elections via mail.

According the National Council of State Legislatures, five U.S states --Colorado, Hawaii, Oregon, Utah and Washington - already conducted "allmail elections," in which every registered voter is allowed to vote by mail.

Another 33 states allow voters to request to cast their votes by mail for any reason.

But in response to the coronavirus pandemic, some of those states have decided to make voting by mail even easier. For example, California announced in May that it would send mail-in ballots to all registered voters for the November presidential election.

We're looking forward to them and reporting to the community on what's happening."

Facebook, Twitter And TikTok Say Wishing Trump's Death From COVID-19 Is Not Allowed

Trump's positive coronavirus test floods social media, Facebook, Twitter and TikTok have a message to users: Wishing for the president to die is not allowed.

All three tech companies confirmed that such posts will be removed for violating each platform's content policies.

As moderators scramble to pull down posts that express hope that Trump succumbs to the virus, wild speculation, conspiracy theories and other falsehoods about the president and first lady's positive COVID-19 tests have been surging on the platforms, with each of them making dicey calls about what is permissible and what crosses a line.

On Trump death wishes, though, the companies fell in line.

A Facebook spokesperson said posts wishing Trump's death - including comments on the president's pages, and posts that tag him — will be taken down from the social network.

Twitter said tweets that "wish or hope for death, serious bodily harm or fatal disease" against anyone, including the president, will be pulled off the platform. Twitter says such "abusive" behavior can lead to an account being suspended.

A spokesperson for TikTok told NPR that cheering on Trump's death would be in violation of the short-form video app's

USA - NPR - As reaction to President community guidelines, saying content longing for Trump's demise "would be a violation of our community guidelines and removed if we find that."

> A federal law, Section 230 of the Communications Decency Act, allows tech companies to set their own rules for what is and is not allowed to be posted to their platforms.

> UCLA professor Sarah Roberts, who studies online content moderation, said abusive behavior should be policed on the platforms, but she said enforcement has long been too lax for those who are not in the public spotlight.

> "There's been an outpouring of regular people saying, 'I've been seeing death threats, rape threats, doxxing for years,' and there's been a complete lack of action," Roberts said. "It's much easier to go and find instances against a major public figure like Trump and erase it than it is with the everyday degradation against everyone else."

> Roberts said she is sympathetic to how difficult decisions about such content can be, since "the social media companies don't have a playbook to go by," adding that, "those deciding what content to remove are often some of the least empowered and lowest on the hierarchy workers who are in real-time dealing with the world's bad behavior."

Lies, Money And Cheating: The Deeper Story Of The College Admissions Scandal

USA (NPR) -- The college admissions process has long been sold as a system of merit: Do well in school, write a killer essay, score well on the SAT, and you'll get in. Yet the recent nationwide scandal, dubbed Operation Varsity Blues, laid bare just how much money, instead of aptitude, often drives admissions at elite colleges.

In March of 2019, federal prosecutors charged 50 people with participating in a scheme to cheat the college admissions system at select colleges nationwide. The investigation into widespread cheating and corruption included Hollywood celebrities, Division I college coaches and wealthy parents who conspired to cheat the process. At its center was a college counselor named Rick Singer, who made millions by bribing coaches at major universities to admit his clients' children as athletes for sports they often didn't play, and by rigging SAT and ACT test scores.

In the new book Unacceptable: Privilege, Deceit, & the Making of the College Admissions Scandal journalists Melissa Korn and Jennifer Levitz, who covered Operation Varsity Blues for the Wall Street Journal, give life to the largest college admissions scandal ever prosecuted by the U.S. Department of Justice.

LESS TV CAN LEAD TO LONGER, HEALTHIER LIFE For decades, research and studies have demonstrated

that heavy television-viewing may lead to serious health consequences. The evidence is here for all of us to see and the effects are devastating.

So much is being said these days about obesity affecting a vast stratum of the population. Television is a major cause in more than one way as it limits the individual's initiative or desire for exercise and for doing chores that will keep him more fit. At the same time the television bombards its viewers with hundreds of commercials about fatty foods or so-called fat-free foods that have other adverse side effects. The end result is overweight to viewers sitting on a couch doing nothing but eating snacks - especially those advertised on tv.

The most perverse effect of television comes in the form of promoting diets, dangerous "sweeteners", so-called "light" foods, diet fads, and books about dieting. People have now been brainwashed to believe that a diet will absolve them from all the fattening sins they have made and they will soon be slim and trim without consequences to their health. Sometimes the problem is not too much weight; it's too little. Eighty-five percent of American women believe they are too fat, an image problem that often leads to bulimia or anorexia.

A study published in recent years proves that obesity is linked to the amount of time we spend watching television and videos. Furthermore, children are brainwashed by ads promoting food and drinks, and one study concluded that 72 percent of all children's ads are for candy, cereal and fast food.

According to an American Journal of Public Health study, an adult who watches three hours of TV a day is far more likely to be obese than an adult who watches less than one hour.

If you find yourself with a few spare tires around your waist you can largely blame the television. Seriously overweight people face an increased risk of developing diabetes, heart disease, stroke, cancer, impotence, back problems, sleeping disorders and depression.

Beware: health problems have a style of showing up when it's TOO LATE!!

There are no quick remedies for the sinister effects of tvinduced obesity but it would be a major step in the right direction if governments would ban television advertising of junk food, diet specialties, diet medications and panacea. Some European countries already have similar bans.

But the most important step has to be taken by you: if you are serious about your health and want to lose weight the first and most important step you should take is to stop watching television or drastically reduce the time you spend watching tv. You will feel better and you will live a longer and healthier life. Tv is just as bad as bad cholesterol!
