OPPOSITION AND BUSINESSES DISTRESSED AS **SEAPORTS OPENING IS POSTPONED**

Leader of the Opposition Hon. via the Road Town Ferry Terminal Marlon Penn has been blasting the Government and Premier Hon. Andrew Fahie for what he said is proof that the Government lacks a clear, comprehensive plan for the reopening of the Territory, and is inconsiderate of the plight of the people on the sister islands.

Hon. Penn's chastisement came in response to the Premier's announcement that the seaports will remain closed until next year. The Premier made that announcement hours before the Territory's seaports were to open on 8 December. At the time he said that it was a decision made by Cabinet during an emergency meeting.

Hon. Fahie in his address to the Territory explained that Cabinet decided to delay the reopening in the interest of keeping the public safe. The Premier said, "Cabinet deferred and is deferring the 8 December opening of the Territory to marine traffic from international visitors

and private charter vessels, unless previously approved, because there were some areas that were previously approved. Those will still be allowed."

"The next thing that Cabinet has decided today is that we have set a target date of 21st January 2021, for the reopening of the Road Town Ferry Terminal only to incoming international visitors until all performance objectives for the reopening are met. So that will give some time for us to make sure that all the measures and all the protocols and all the areas that need to improve in terms of the facility is completed," the BVI Leader added.

However, the Leader of the Opposition blasted the decision calling it a "knee-jerk" response. Hon. Penn said that the new announcement could "erode investor/ business confidence locally and internationally, not to mention the demoralising effects they continue to have on business owners and their employees."

Hon. Penn said that the announcement is devastating news for the businesses on the sister islands that depend on daytrippers and USVI sailors for business: "My support and concern particularly go out to the residents of the Sister Islands of Jost Van Dyke, Anegada and Virgin Gorda whose livelihoods are particularly wrapped up in tourism; some of whom based on this decision would have lost employment for an entire year - that is a year without a paycheck and the ability to provide for themselves and their families," he noted.

Overall the Opposition Leader said that in his opinion the new change in date is an illustration that the Government does not have a reopening plan: "What we are observing right now represents a failure to present a workable plan that finds the right equilibrium to protect the lives of our citizens and the many Virgin Islands businesses and employees that depend so



heavily on tourism, businesses that are virtually on life support right now. The livelihood of these persons are at stake and they can ill-afford these false starts," Hon. Penn noted.

He further stated that all members of the Opposition shared the opinion that the Government's alleged lack of proper planning will cause "further financial strain on already cash strapped businesses (charter companies, ferry operators, etc.) as well as travellers who had already prepared for the 8 December opening only to learn less than 12 hours prior that plans have changed at the very last minute."

Additionally, the Opposition Leader predicted that there will be revenue losses as a result of the extended closure of the seaport: "Naturally, we will experience some negative impact, because the reality is that many of our quests make travel decisions based on cost and convenience, and moreso during this COVID-19 era - coupled with the fact that more than

"We should all be ashamed..." Senior Legislator says

During the 4 December special sitting to mark the 70th anniversary of the Restoration of the Legislature in the Virgin Islands, senior member of the House of Assembly Hon. Julian Fraser told legislators that they ought to be ashamed of themselves.

Hon. Fraser - while noting that the House of Assembly continues to meet in the Save the Seed building - told his colleagues that there is much to be desired as it relates to the BVI's parliamentary operations: "We have to start thinking about those changes that we need to make...We don't have a Parliament. Mr. Speaker. We don't have a Parliament building to speak of."

The Senior Legislator said that the state of things does not compare highly to what members of the BVI House of Assembly see and experience when they travel overseas on Parliamentary visits. "All of you, each one of you have travelled to different countries, for CPA conferences more so than anything else, or you have travelled on an invitation to other countries' parliaments and you can see they go out of their way to ensure that they make a statement with their home as a symbol of democracy in their country. Yet we are here."

Hon. Fraser said that the BVI has been doing well financially for years with impressive budget figures, yet the main lawmaking body is not as well as it should be. "Within the last two years Mr. Speaker: Hurricane Irma and all -2020 the budget \$414M; 2021 the budget \$402M; look at where we are, if you look around in this facility it speaks more to me than it speaks to the House of Assembly; if you look up in the ceiling you will see why. Why are we here."

"We should all be ashamed of ourselves. Shame as a country. We don't have a House of Assembly or Parliament and we invite people here... Colleagues I am telling you those folks that have gone ahead of you, particularly the ones that brought the legislature back here - they will be asking you what have you done? What changes have you made of significance that we can call our home," the Third District Representative declared.

He further called on the Minister for Finance to take the relevant steps

to fix things. He also told legislators to commit to carrying out the changes necessary to further elevate the legislature. "You are going to hear the chatter out on the street, but those same people who are going to be chattering are the same people that are going to bring their friends to see the House of Assembly of the Virgin Islands. They are going to use that as a symbol of our success. We have a financial services industry that is worth a billion dollars. That is only indirect income to the Virgin Islands...How are we making it matter. We have to make it matter by us doing it. We ought to revolutionise this particular body that we sit in. The first thing that needs to be done is to become a statutory body," Hon. Fraser added.

Marijuana Bill delayed assent causes uproar

Both Premier and Minister for Finance Hon. Andrew Fahie and Speaker of the House of Assembly Hon. Julian Willock are peeved that His Excellency Governor Augustus Jaspert has not assented to the Medicinal Marijuana legislation.

According to Marijuana Business Daily, "Wholesale prices of marijuana and hemp oil have fallen from a year ago, according to industry executives, reflecting rising oil production nationwide that has more than offset an uptick in cannabis sales amid the coronavirus pandemic. The drop in wholesale oil prices reflects multiple market factors working simultaneously – and sometimes at odds with one another."

Additionally, just a few days ago, New Cannabis Ventures has announced: "COVID-19 has placed a heavy strain on cannabis-related businesses, which were already struggling due to the highly-regulated nature of the industry, overplanting by farmers and competition from black market suppliers. While bankruptcy would be a useful tool to enable such companies to restructure their financial affairs or to liquidate in an orderly fashion for the benefit of creditors, bankruptcy has generally not been available. However, this may change under a Biden Administration..."

Many developed countries have legalised the cultivation and processing of hemp, which is supposedly leading to an increased demand for hemp extracts for various applications in several sectors, including pharmaceuticals, cosmetics, nutraceuticals, and food & beverage. Many states in the USA are now in the marijuana business determined to take the lion's share of the market. With such competitors is there room for BVI cannabis?

In July this year, the House of Assembly passed the Cannabis Licensing Act which the Government said could result in earning the Territory millions of dollars. The legislation itself earned mixed reviews among the population and has still not being assented to by the Government.

In the meantime the USA is now involved in marijuana production and marketing; the global cannabis market is said to be worth \$340 Billion, but other sources give less optimistic figures. At this pace the production will surpass the demand; the competition will be fierce and investors may go bankrupt.

The complaint about the Governor's snail pace towards the assenting of the Bill has been a complaint from legislators over the recent months. However, multiple mentions about the alleged stalling were made in the House of Assembly on 4 December.

That sitting was specially organised to celebrate the 70th anniversary of the Restoration of the Legislature in the Virgin Islands. The complaint about the Governor's stalled assent commenced from as early as

the Speaker's announcement which opened the proceedings. In his opening remarks Hon. Willock said: "Honourable Members, after 70 years, it is an insult to this House of Assembly when 13 elected Members pass a Bill then an unelected Governor could just refuse to assent to a Bill without a proper explanation. That can never be good governance, transparency or democratic practice, notwithstanding Section 79, 2 of the Constitution."

"Many of my fellow Speakers in the Commonwealth Parliamentary Association (CPA) who I often converse with have labelled this behavior as an abuse of power, dictatorship, and injustice to the people. I trust that by the time we are ready to celebrate our 75th or 80th anniversary of the Restoration of the Legislature, we as free people will not have to face such issues," he added.

While many of the members of the House of Assembly referenced the matter, Premier Fahie was more detailed about his displeasure that the Bill is yet to become law. The Premier told his colleagues: "We have seen the medicinal marijuana legislation being passed and not assented to yet with no logical or legal explanation of why not; except for that the Constitution does not put a mandate on the seat of Governor to assent the Bill within a certain time frame or if not to give the reason so we can deal with it."

Hon. Fahie said that he cannot understand why the BVI's Bill is being held back while the UK is making plans to move forward with its medicinal marijuana venture. "We are seeing that we are here waiting for assent of a Bill Mr. Speaker that was passed in here from and debated all the way up to June and we are seeing now where the very United Kingdom embraces medicinal marijuana and making sure that it is part of their very economy and telling you how many billion dollars it would be able to benefit from in the next ten years, but we were proactive to move in that direction before," the Premier said.

The day before the sitting of the House of Assembly, His Excellency Governor Augustus Jaspert was asked by members of the media why the Bill was not being assented. In response, the Queen's Representative said: "On the marijuana one, that is something that I am considering very carefully as you would expect and would also understand anything that I am discussing, I'll do first to Cabinet prior to here."

His Excellency emphasized that the Cannabis legislation was not the only one outstanding. Further, the Governor explained that he was being careful and thorough before approving the Bill. "On those bills, these are important bills. It's important we consider them properly and it's important that... I consider them fully before giving assent, that's something I'm doing and then you'll respect that any conversations I have will be with the Premier and with Cabinet."

Vaccine will not be imposed: Governor says

Seemingly noting public concerns about COVID 19 vaccines His Excellency Governor Augustus Jaspert gave the assurance that no one would be forced to take the injection.

The fear of taking the COVID 19 vaccine is global as the Wall Street Journal noted in an article on 7 December that in many countries persons are stating reluctance to pandemic inoculation. The article said, "A survey from the University of Hamburg showed the percentage of people hesitant or unwilling to get a Covid-19 vaccine ticking up in November to around 40% of respondents across seven European countries. An October poll by market researcher lpsos found that nearly a third of Japanese and almost half of French respondents said they wouldn't get inoculated for the coronavirus."

The concerns are just the same here in the Territory as persons have communicated in various fora that they are suspicious of vaccines. Noting the comments, Mr. Jaspert during his recent sit-down with the media gave the assurance that no one will be forced to do sbe vaccinated.

The Governor also said that the vaccine distributed in the Territory will not be different than that which UK citizens are receiving." I trust

that many individuals across the Territory will have been closely following work to develop a vaccine. It is great to see the UK pioneering this work and to have assurances from the UK Government that BVI will receive any COVID-19 vaccine procured by the United Kingdom – it will be the same vaccine as that used in the UK and will be distributed on a completely voluntary basis, overseen by the BVI Government."

The Governor's assurance that inoculation will be voluntary gives comfort to residents who the Premier said told him they do not want to be vaccinated.

The Premier made that announcement last month in the House of Assembly. He announced that the residents who have spoken to him about vaccination concerns said that they don't want to be experimented on. "We run from these things, but everyone you meet just about or persons on the side they tell you'um Fahie don't let them experiment on us with these vaccines and then when you are finished you hear this and you hear that our people are quote on quote guinea pigs."

"They are concerned and rightfully so anything new brings concern but then anything new that has to go into your body may bring a lot of concerns..." the Premier added.

Some Pros & Cons of Vaccines

According to the Infectious Diseases Education Organisation: major medical organisations state that vaccines are safe. These organizations include CDC, Food and Drug Administration (FDA), Institute of Medicine (IOM), American Medical Association (AMA), American Academy of Pediatrics (AAP), UNICEF, US Department of Health and Human Services (HHS), World Health Organization (WHO). The US Department of Health and Human Services states, "Vaccines are some of the safest medical products available."

Adverse reactions to vaccines are extremely rare. The most common side effect of vaccines, anaphylaxis (a severe allergic reaction), occurs in one per several hundred thousand to one per million vaccinations.

Herd immunity (or community immunity) means that when a "critical portion" (the percent of people who need to be vaccinated to provide herd immunity) of a population is vaccinated against a contagious disease it is unlikely that an outbreak of the disease will occur so most members of the community will be protected.

Vaccines protect future generations. Vaccinated mothers protect their unborn children from viruses that could potentially cause birth defects, and vaccinated communities can help eradicate diseases for future generations.

Vaccines eradicated smallpox and have nearly eradicated other diseases such as polio. Children are no longer vaccinated against smallpox because the disease no longer exists due to vaccination.

Nevertheless, the same source informs that: Vaccines can cause serious and sometimes fatal side effects. According to the CDC, all vaccines carry a risk of a life-threatening allergic reaction (anaphylaxis) in about one per million children.

Vaccines contain harmful ingredients. Some physicians believe thimerosal, an organic mercury compound found in trace amounts in one flu vaccine for children and other vaccines for adults, is linked to autism.

The government should not intervene in personal medical choices. Medical decisions for children should be left to the parents or caregivers.

Mandatory vaccines infringe upon constitutionally protected religious freedoms. Several religions oppose vaccines and mandatory vaccinations.

Vaccines can contain ingredients some people consider immoral or otherwise objectionable.

Argel Horton Featured For Black In Marine Science Week

Marine Biologist in the Environment and Climate Change Unit Ms. Argel Horton is being featured by the Marine Conservation Society along with two (2) other prominent Caribbean Scientists and marine conservationists as they celebrate Black in Marine Science Week 2020, from November 29 to December 5.

In the Black in Marine Science feature, Ms. Horton expressed that she has had a passion for the sea and the environment from a young age, which was a result of the many adventures that she had with her father Mr. Alvin Horton, who was a captain and fisherman. The knowledge that Captain Horton shared with Ms. Horton about ocean life captivated her and fostered her interest with all the wonders of the sea, which led her to pursue academic studies related to the environment.

Ms. Horton said, "I enjoy the ability to constantly learn. One of my most memorable moments was when I did an ocean exploration mission aboard the Nautilus research vessel. Scientists were conducting research at the sea mounts within the BVI's territorial waters. They collected geological, biological and chemical water samples and mapped the area with multibeam bathymetry. I saw and learned about deep sea corals and the fauna that resides along the summits of the sea mounts."

Ms. Horton added that she loves that her job is not stagnant and that she enjoys sharing knowledge with others and seeing their eyes light up when she tells them about the environment. That is what inspires her to continue to doing her best to preserve the natural resources in the Territory.

When asked what she hopes to achieve with her work in the Territory, Ms. Horton said "I am hoping for a better environment for all. I think we need to have a fair and equitable balance where we can develop with greener technologies and incorporate best practices in the

way we live to reduce our impacts on the environment and species."

Black in Science Week was created to create a virtual space for black marine scientists. The space showcases a diverse and brilliant group of black marine scientists from all over the world. The week features events on planned topics ranging from hair care in the field, to their favourite scientific techniques. Black marine scientists from around the globe take part in conversations about their research, and what got them interested in marine science. During the week, there are also planned events targeted to inspire the next generation of scientists.

The Ministry of Natural Resources, Labour and Immigration congratulates Ms. Horton and is extremely proud of her work. The ministry will also continue to inspire the current and future generation of scientists as it effectively manages and administers the natural resources of the Territory in a manner that ensures.

Illegal Sea Turtle Harvesting Is Strictly Prohibited

Director of Agriculture and Fisheries, Mr. Theodore E. James has said that his department was made aware of a video in circulation regarding the illegal capture of seven Green sea turtles which have since been rescued and released.

Mr. James said investigations into the matter are ongoing and is reminding the public that no person shall remove from the fishery waters, expose for sale, sell, purchase or have in possession any undersized turtle or catch a Leatherback Sea-Turtle (Dermochelys coriacea) or Loggerhead Sea-Turtle (Caretta caretta) on which there is a moratorium.

A moratorium he said means that these sea turtles are strictly prohibited from being caught at any time, even during turtle season, from December 1, 2020 to March 31, 2021. Undersized means a carapace (shell) length less than 24 inches for Green Turtle (Chelonia mydas) and less than 15 inches for Hawksbill (Eretmochelys imbricata).

The Director said, "A person licenced to fish in the Territory by the department must be approved to capture turtles within their licence conditions. Not all licenced fishers possess this approval and buyers are responsible to inquire to ensure that intended purchases are legal."

Attorney General, Honourable Dawn Smith attended her first meeting as Deputy Chairperson of the Virgin Islands General Legal Council last month. The current membership consists of Ms. Anthea Smith, Chairperson;

Honourable Dawn Smith, Deputy Chairperson; exofficio, Mrs. Kimberly Crabbe-Adams; President of the Bar Association, exofficio, Mr. Richard May; Mr. Meade Malone, Mrs. Michelle Frett Mathavious and Mrs. Jude Hodge. "The Commission is committed to fulfilling its mandate under the Legal Profession Act and is moving forward to address matters including the suspended provisions of the Act," Chairperson, Ms. Anthea Smith said. She also

indicated that the council will take steps shortly to bring greater awareness of the provisions of the Act to the general public and members of the legal profession.

The powers and functions of the council include:

to regulate and supervise, generally, the legal profession, and to ensure compliance with the provisions of the Legal Profession Act;

to evaluate, review and set the standards of conduct and proficiency of the legal profession in the Virgin Islands;

to protect the interest of the public with respect to the practice of law in the Virgin Islands;

to promote, maintain and support the administration of justice and the observance of the rule of

The Legal Professions Act was passed in the House of Assembly on March 25, 2015 and came

into force on November 11 of that year. The Chair and other members are appointed to serve for three year terms.

The full complement of members to comprise the current Virgin Islands General Legal Council, pursuant to the Legal Profession Act, 2015, was finalised in December 2019. The council held its first meeting on January 16, 2020.

The powers and functions of the Council are to regulate and supervise the legal profession; and to evaluate, review and set the standards of conduct and proficiency of the legal profession.

BVI Electricity Corporation (BVIEC) made history on December 4, 2020

The BVI Electricity Corporation (BVIEC) is pleased to announce that on December 4, 2020 history the consumer-generator and the units of energy supplied from the consumergenerator to the grid.



was made in the British Virgin Islands when the Bregado Flax Educational Center in Virgin Gorda became the first entity in the Territory with renewable energy generation facility to be "grid-tied" to BVIEC's electrical grid.

The Bregado Flax Educational Center accordance with the BVI Electricity Corporation (Amendment) Act, 2015 is now referred to as a " consumer generator" comprising of a Net Billing Metering System which employs a set of electrical meters one of which is capable of determining units supplied by renewable energy facility generating another one capable of determining both the units supplied from the grid to

In accordance with the BVI Corporation Electricity (Renewable Energy) Regulations, 2018 the Government of the Virgin Islands Electrical Inspection Unit (EIU) carried out an inspection of the system installed by Mr. Sean Hartley of Amandla Engineering to ensure it was constructed utilising industry best practices and issued a certificate of approval for the renewable energy generating facility to be grid-tied.

Mrs. Rosemarie Flax-Chairman of the Board of Director is quoted as saying "this is a proud moment for the BVI. The Board, Management and staff of BVIEC will continue to be relentless in fulling the areas of commitment regarding the Territory's

energy transformation well into the future."


BVIEC is currently in the process of contacting owners of other renewable energy generation facilities within the Territory to request that they regularize these systems and bring them in compliance with the applicable laws and industry codes.

When asked about this significant milestone being achieved Mr. Leroy A.E. Abraham – General Manager/CEO stated that "this is the culmination of many years work by the BVIEC team which started almost two decades ago

with the manifestation of BVIEC now having the capability to grid-tie distributed generation systems and the soon to be constructed Hybrid Renewable Energy and Battery Energy Storage project on Anegada."

The Public is advised to stay tuned for further exciting news updates regarding BVIEC's efforts toward energy diversification within the Territory utilising renewable energy.

As Minister Transportation, Works and Utilities, I too join with the Leaders of ICAO who have stated that the anniversary this year will be remembered as a pivotal point in the history of the global civil aviation sector, given that the COVID-19 Pandemic has resulted in unprecedented loss of jobs and revenue, and of the air connectivity that underpins sustainable development and many humanitarian efforts worldwide. specifically, Dr. Fang Liu, ICAO Secretary General, stated during the recently concluded Aviation Green Recovery Seminar (November 23-24), "Drawing attention to the continued reliance of the world on air transport to move perishable foods, medical supplies, and other urgent goods to where the world needs them most, that the air transport network is still being highly relied upon by countries during the Pandemic, and that its benefits would continue to economies everywhere."

Civil Aviation returns

JAMAICA - The Jamaica government says the 13 nationals deported from the United Kingdom earlier this week "were removed pursuant to having met the criteria for removal as set out in the UK Borders Act of 2007".

In a joint statement, the Deputy Prime Minister and Minister of National Security, Dr. Horace Change and Minister of Foreign Affairs and Foreign Trade, Kamina Johnson-Smith, confirmed that a charter flight with the 13 Jamaican born Involuntarily Returned Migrants (IRMs) arrived at the Normal Manley International Airport from the United Kingdom on Wednesday.

"The return of the IRMs is a routine process that is guided by agreements between Jamaica and our bilateral partner countries. The government is mindful of the heightened sensitivities in respect of IRMs from the UK in particular."For this reason, diplomatic engagements between the Jamaican and UK governments have always sought to ensure that the process is one that takes into account these sensitivities and in particular any remaining legal processes that could provide for exemptions for any of those persons," the joint statement noted.

It said that the information available to the Jamaica government is that the IRMs were allowed to exhaust all legal remedies and recourse available to them prior to their departure.[Caribbean National Weeklv]

BARBADOS - The statue of Lord Nelson, located in National Heroes Square, Bridgetown, is set be removed from that location on November 16, 2020, on the commemoration of the International Day of Tolerance.

Minister in the Prime Minister's Office, with responsibility for Culture, John King, whose office is leading the project, described the decision as "a step towards the healing of the Nation and to remind us all that tolerance is a universal human right".

The Government of Barbados has announced its intentions to officially become an independent republic on November 30, 2021, which is our 55th Anniversary of Independence," Minister King added. "This is indeed an ultimate statement of confidence in who we are as a people and what we are capable of achieving.

"As we amend the Constitution to have a Barbadian Head of State, and as a symbol of the maturity of our democracy, it is imperative that we reexamine notable elements of our colonial past. Cabinet's decision to remove the statue is part of this process as we seek to promote national identity as part of a modern Barbados."

The more than 200-year-old structure is to be removed and transported to a temporary storage

site under the guidance of experts, before being returned to public display on the compound of the Barbados Museum and Historical Society at The Garrison, St. Michael.

The removal of the statue will pave the way for the redevelopment of National Heroes Square as part of the overall renewal of Historic Bridgetown, which forms part of the country's UNESCO-designated World Heritage Site.

The transformation of Golden Square, Fairchild Street Market, the Careenage and Constitution River, the Empire Theatre and Hyatt Hotel are components of the regeneration of the nation's capital.Minister King made it clear though, that the removal of the statue and the transformation of Bridgetown were not just representation of physical development. [Caribbean News Now]

ROME - Italy's already low birth rate is set to plunge further amid the COVID-19 pandemic, the head of national statistics agency ISTAT told a parliamentary hearing on Tuesday."It is legitimate to hypothesize that the climate of fear and uncertainty and the growing difficulties of a material nature (linked to employment and income) generated by recent events will have a negative impact on Italian couple's fertility decisions," ISTAT President Gian Carlo Blangiardo told a joint session of the House's and Senate's budget committees.

The level of 420,000 births registered in Italy in 2019, the lowest in over 150 years of national unity, could fall to around 408,000 this year, with December affected by a drop in conceptions in March, according to

an ISTAT scenario based on the most recent trends. "This could then fall further to 393,000 (births) in 2021". (ANSA).

SWITZERLAND - Switzerland's National Council on Tuesday put in place a range of changes to the Covid-19 regulation. As a result of the changes, police will now be able to issue on-the-spot fines for 'mask refusers', i.e. people who do not comply with the country's strict coronavirus mask requirement.

Groups of people who exceed limits on public meetings and do not comply with social distancing rules can now also be issued with on-the-spot fines by law enforcement officers.

Switzerland's new outdoor mask requirement: Everything you need to know

Previously, police would issue violators with tickets, which would then be forwarded to the responsible governor - who would decide how high the penalty would be and whether it would indeed be imposed. Now, police can issue fines to violators immediately as they come across them.

While the Epidemics Act still has a maximum fine of CHF10,000 for intentional behaviour and CHF5,000 for negligence, these fines are typically issued to businesses and organisations which operate in contravention of the coronavirus measures.

The fines for individual mask violators are capped at a much more reasonable CHF300.


The law changes also gave more discretion to police to refrain from issuing fines where they feel something is unclear, for instance where someone is not wearing a maskin a pedestrian area, as reported by Watson. [thelocal.ch]

SPAIN - Spain's Defense Minister, Margarita Robles, has sent prosecutors at the Madrid regional High Court information about a WhatsApp chat group in which retired military officials appear to show support for military uprisings and mass executions.

Robles is asking prosecutors to determine whether the messages exchanged by members of the 19th graduating class of the Air Force Academy constitute a crime "by individuals who additionally may have posed as members of the military in active duty service without being so," said ministry sources.

The minister's request is backed by information published on Wednesday by the online daily Infolibre, which reported two messages in the private chat group



as stating the following: "There is no other choice but to start executing 26 million sons-of-bitches," and: "What a pity not to be in active duty service in order to reroute a hot flight [carrying real ammunition] from Bárdenas [firing range] to the headquarters of those sons-of-bitches," alluding to the separatist organization Catalan National Assembly (ANC), which played a leading role in the 2017 attempt at the Catalonia region's unilateral secession from Spain. These two quotes have been attributed to Division General Francisco Beca Casanova and to Colonel Andrés González Espinar, respectively.

Although Robles did not mention any specific crime by name, her mention of retired individuals allegedly pretending to be in active duty service could conceivably lead to charges of impersonating an official, which carries prison terms of one to three years.

Prosecutors have replied with a request for further information before making a decision on whether to open an investigation. [El Pais]







PUBLIC APPEAL TO IDENTIFY PERSONS WITH ILLEGAL FIREARMS

Monday, December 7 – The Royal Virgin Islands Police Force continues its appeal to the public for information into the identity of the individuals in possession of illegal firearms as it continues its fight to remove guns from the streets.

Within the past week, several incidents involving firearms were reportedly used and even discharged which is evidence that there are a number of these illegal weapons on the street.

Sunday morning one week ago, two young males were attacked by gunfire while on their scooters near Spring Bay. Fortunately, neither sustained life-threatening injuries.

On Saturday just after midnight, two masked males, carrying firearms. robbed an establishment in Sea Cows Bay resulting in cash and a handbag being taken; no injuries were reported. Later that afternoon, a female reported that her exboyfriend pointed a handgun at her, threatened her and allegedly shot at the vehicle she was driving while in the West End area. On the same day, the sound of a gunshot was heard outside the East End Police Station soon after two persons entered seeking assistance for an

earlier dispute. One shell was recovered at the scene.

Finally, last night, three men were arrested on suspicion of discharging a firearm after six shots were heard in the Brewers Bay area.

In this year alone, the RVIPF seized 21 illegal firearms.

Persons with information about the identity of the individual responsible for Friday's shooting or those in possession of illegal firearms are asked to contact the RVIPF Intelligence Unit at 368-9339. All information will be held in the strictest confidence.

RVIPF CHARGES SECOND OFFICER IN RELATION TO DRUG SEIZURE

Thursday, December 3 - Police today charged a second officer in relation to the recent drug seizure as investigations continue.

Emile Jimenez, 32, is to appear before the Magistrate's Court at the next available court date charged with one count of being concerned in the supply of a controlled drug to another, three counts of unlawful possession of a control drug with intent to supply, one count of keeping a firearm without a licence, and one count of unlawful

possession of a prohibited weapon.

This arrest is as a result of ongoing investigations in the cocaine seized in Balsum Ghut in early November. Inquiries are continuing in the matter.

IS A BIG DEBT CRASH ON THE HORIZON? Part B

The world is over 250 Trillion Dollars in debt: public plus private. Is that vast debt sustainable? Is this debt a bubble about to burst?

Now, there must be a limit to how much debt an economy can manage. There is an analogy: a family earning \$100K per annum can simply not afford a \$2 million mortgage. Why: because all their income will be consumed by interest payments on their loan. Then the family becomes vulnerable to default and home repossession. Countries are different in that they are more resilient to debt. However the analogy is valid as a warning against unsustainable debt.

OK. Investors in times of economic and political crisis view US Government Debt or Government Bonds and Treasury Notes as safe and valuable assets.

As long as these debt instruments are viewed as safe, investors will buy them.

Economically and financially powerful governments: the USA, UK, the European Union; are thus viewed as safe havens, and wealth protectors, by global investors. The preceding is the basis upon which government debt is raised at time of crisis and sustained. In fact wealthy investors are the backers of the global economy in terms of the influences they have on global finance, politics, and economics.

And QE - massive borrowing from global investors by major central banks- has worked wonders in

recent years, keeping the global economy from plunging off the precipice after the 2008 Financial Crisis, and today, keeping the world economy afloat during the COVID 19 pandemic.

But what does this massive debt overhang mean? For one, countries that were under debt strain before the pandemic such as Venezuela, Barbados, Nigeria, Zambia, and even Italy, may default on their debts.

Another problem for the world is that this huge debt may ultimately impact investor confidence in markets, and this in turn could lead to slow economic growth and a longer time for the world to come out of recession. Investor confidence is vital for economic growth as it further impacts consumer confidence, and demand and supply, in world markets.

Then there is the problem of countries spending a higher percentage of national income servicing debt. This lessens the cash governments have to invest directly into the economy and is a further drag on economic growth. Developing countries stand to suffer most as industrialized states have the benefit of powerful central banks that can keep their interest rates low, and inject liquidity into markets, as these countries begin to exit recession and grow economically.

The opposite is the case for poor countries that have to follow the diktats of investor driven institutions such as the IMF and the World Bank.

These countries may well experience prolonged recession. Foreign investors control the finances of developing countries by underwriting debt and balance of payments deficits, and by providing the platform for stock, commodity, and currency trading. Crashes occur when global investors panic because of unsustainable economic factors, such as huge debt levels, stock market bubbles, and runaway government spending.

For now The Federal Reserve

and the world's major central banks appear to be providing the stimulus conditions that is keeping the global economy afloat.

However the big question remains how governments and borrowers pay back the nearly two hundred and fifty trillion dollars in debt owed to investors?

So what does a debt crash mean? In simple terms it is a repeat of the 2008 financial bubble recession, where the financial world collapsed like a pack of cards after the pin prick of banks deluged with unsustainable debt. The problem with 2020 and beyond is that investors may not be too keen to lend central banks

The problem with 2020 and beyond is that investors may not be too keen to lend central banks the trillions required to keep the world economy afloat, especially if there is no hope of that debt ever being repaid in a world economy that is anemic and growing very slowly.

The world may be building an economy on a foundation of debt, which is akin to building a house foundation, on sand.







I call this recipe Christmas Chicken because it's a beautiful holiday dish with lots of colorful red tomatoes, white pasta and green basil or parsley. It's also inexpensive, simple to make, and can be doubled to easily feed a crowd.

I look forward to sharing it with my family and friends for years to come. Merry Christmas, and have a blessed holiday season!

CHRISTMAS CHICKEN

- 1 pound boneless skinless chicken breasts, chicken thighs or a combination of both
- 2 tablespoons poultry seasoning, divided
- 2 teaspoons salt, divided 2 teaspoons ground black pepper, divided
- · 3/4 teaspoon cayenne pepper
- 1 cup all-purpose flour 8 ounces penne pasta
- 1/4 cup olive oil 1/4 stick butter
- 1 large yellow onion, chopped 3 cloves garlic, minced
- 1 (28-ounce) can Cento or San Marzano crushed tomatoes
- 1/8 teaspoon ground cloves or nutmeg
- · 1/4 teaspoon sugar
- 1 cup fresh flat-leaf parsley or basil, cut into ribbons
- · 1/2 cup grated Parmesan or Romano cheese
- Cover chicken breasts with plastic wrap and pound each piece to an even thickness, about 1 inch in the thickest parts. Remove the plastic and sprinkle each piece of chicken on both sides with 1 tablespoon of the poultry season, 1 teaspoon each of the salt and 1 teaspoon freshly ground pepper, and 1/8 teaspoon of the cayenne pepper.
- 2. To the flour, add 1/2 tablespoon of the poultry seasoning, 1/2 teaspoon salt and 1/2 teaspoon of the black pepper, and mix well. Press the chicken into the flour on both sides, shake off the excess and set aside.
- 3. Make the pasta according to package directions. When the pasta is cooked, drain it but reserve 1/2 cup of the pasta water to add to the sauce.
- 4. Meanwhile, heat the olive oil and butter in a large heavy skillet over medium heat until sizzling, about 2 to 3 minutes. Add the seasoned chicken and pan-fry for 4 to 5 minutes on each side until golden brown.
- 5. Place the chicken on a plate and set aside. Add the onions to the pan and cook for 2 minutes. Add in the garlic, tomatoes, the remaining 1/2 tablespoon poultry seasoning, 1/2 teaspoon salt, 1/2 teaspoon pepper and 1/2 tablespoon cayenne, and the cloves or nutmeg and sugar. Turn heat to simmer, and cook to a sauce-like mixture, about 5-7 minutes. Add the reserved pasta cooking water as needed if the sauce is too thick.
- 6. Cut the chicken into strips and add it to the sauce. Stir in half of the parsley or basil. Top the drained pasta with the sauce and stir to combine over medium heat for about 1 to 2 minutes. To serve, sprinkle the pasta with the remaining parsley or basil and the grated cheese. Serves 4 to 6.

Final Declaration of the 7th CARICOM-CUBA Summit Meeting

We, the Heads of State and Government of the Caribbean Community (CARICOM) and the Republic of Cuba, gathered via videoconference on 8 December, 2020, on the occasion of the 7th CARICOM-Cuba Summit held in commemoration of the 48th anniversary of the diplomatic relations between the four CARICOM independent States and Cuba and the 18th anniversary of CARICOM-Cuba Day;

Proud of our shared Caribbean identity and the progress of our political and cooperative relations that have been strengthened by our arrangements, exchanges and coordination at international forums to the benefit of our peoples, and guided by the principles of solidarity and complementarity;

Recalling the Declarations of our Summits of Havana in 2002, Bridgetown in 2005, Santiago de Cuba in 2008, Port of Spain in 2011, Havana in 2014, and Saint Mary's in 2017;

Aware of our need to work together, particularly in the economic and environmental areas, for the sustainable development of our nations in a manner that helps us build more inclusive, just and equitable societies, and address our shared vulnerabilities as Small Island Developing States and countries with low-lying coastal areas;

Deeply grieved by the loss of lives and concerned by the extensive socioeconomic effects of the COVID-19 pandemic and the devastating weather events that have worsened the multiple crises faced by mankind today;

Welcoming the medical assistance provided to the Member States of CARICOM by the Government of Cuba in response to the COVID-19 pandemic

Highlighting the importance of pooling our efforts in order to improve the productivity, infrastructure, and air and sea connectivity in our countries, and expand our economic and trade ties, through the implementation of the Revised CARICOM-Cuba Trade and Economic Cooperation Agreement;

Underlining the significance of consolidating the Community of Latin American and Caribbean States (CELAC) as a mechanism for political consultation, the promotion of our regional unity and integration, and the defence of our regional interests in international affairs and our relations with third-parties; and

Reaffirming the effectiveness of the Proclamation of Latin America and the Caribbean as a Zone of Peace, signed in Havana in January 2014.

HAVE AGREED AS FOLLOWS:

 Reiterate that our regional unity and integration are based on our absolute respect for the Purposes and Principles enshrined in the United Nations Charter

- and International Law; in particular, the principles of sovereignty, self-determination, territorial integrity, non-interference in the internal affairs of States, peaceful settlement of disputes, the prohibition on the use or threat of force; as well as the promotion and protection of human rights for all.
- Underscore the importance of defending our regional unity for the preservation of the peace and stability of our countries.
- Welcome the outcomes of the 6th CARICOM-Cuba Meeting of Ministers of Foreign Affairs held in Georgetown, Guyana, on 14 June, 2019, which agreed on the need for more cooperation, as well as increased trade and investment.
- Reaffirm our will to strengthen South-South cooperation as an expression of solidarity, for the promotion of bilateral and regional programs, as well as triangular cooperation for development, with regard paid to national priorities.
- 5. Express our will to continue to receive Cuban medical cooperation in recognition of its contribution to the wellbeing of the Caribbean people; in particular, its valuable human resources which were added to the fight against the COVID-19 pandemic. We reject any attempt to discredit, distort or disrupt Cuban medical assistance, an important aid to the region and to Caribbean healthcare system.
- Share our best experiences in the management of the COVID-19 pandemic and other epidemiological conditions that are common to the Caribbean, and assess the possible application of innovative Cuban biotech medicines in the prevention and treatment of this pandemic.
- Recognize that the cooperation maintained between Cuba and the CARICOM Member States in the areas of health, humanresource training, construction, sports, education, environmental protection, and natural disaster risk reduction and mitigation, has effectively contributed to the development and wellbeing of our peoples.
- Continue the implementation of the Center for Stimulating the Development of Children and Young People with Special Educational Needs in Guyana.
- Maintain the exchanges so that the Regional School of Arts in Jamaica can start to operate.
- Acknowledge our commitment to finding avenues that promote our economic and commercial relations by identifying our strengths and possible complementarities,

- and by implementing and relying more on the Second Protocol to the CARICOM-Cuba Trade and Economic Cooperation Agreement.
- 11. Note that the Cuban economic model update, the Cuban foreign investment law and the Mariel Special Development Zone offer broad and additional opportunities for the intensification and reinforcement of the economic ties between CARICOM and Cuba.
- 12. Recognize the promotion of sustainable tourism as one of the keys to economic development in the Caribbean region, and agree to strengthen our cooperation in this sector, including the implementation of multi-destination tourism in accordance with the terms of the Memorandum of Understanding between the Government of the Republic of Cuba and CARICOM States signed at the 6th CARICOM-Cuba Summit
- 13. Emphasize that, given the scope of its impact, climate change represents one of the greatest challenges faced by our nations, the repercussions of which are particularly serious in developing countries; especially in Small Island Developing States. For this reason, we commit to expanding our exchanges in the context of CARICOM and at relevant international agencies, in order to mitigate its adverse effects.
- Underline that adaptation to the impact of climate change constitutes an immediate and urgent global priority.
- 15. Strengthen our cooperation in the protection of the environment and the sustainable use of our resources; in particular, those of the Caribbean Sea. In this regard, we support the efforts made by the Association of Caribbean States to designate the Caribbean Sea as a "Special Area in the Context of Sustainable Development," within the UN framework.
- 16. Welcome the actions jointly implemented by our countries in order to reduce the risks of natural disasters and note the agreement signed between the Cuban Civil Defense Authority and the Caribbean Disaster Emergency Management Agency for the purpose of expanding and integrating our regional early warning systems. We recognize the joint efforts made to train a number of Caribbean first-response bodies, as well as Cuban and Caribbean specialists in the management of responses to natural disasters.
- 17. Renew our call for a review and modification of the current "graduation" criteria for the receipt of Official Development Assistance to properly reflect the realities

- and specific needs of the highly indebted middle-income countries; in particular, the Caribbean States, and to integrate the different dimensions of sustainable development included in the 2030 agenda, considering that the current criteria fail to reflect our actual levels of economic and social development or the multidimensional effects of poverty, inequality and vulnerability.
- 18. Express deep concern over the inclusion of certain CARICOM Member States in lists of non-cooperative tax jurisdictions and call for a change in this approach which serves to negatively impact the economies of those countries that have shown their readiness to cooperate and engage in dialogue in order to find mutually advantageous solutions for the parties.
- 19. Express deep concern over and rejection of the progressive decline in correspondent banking relations being experienced by developing nations; in particular, CARICOM Member States, due to the de-risking actions by some of the major international banking corporations, which threatens the financial stability of the affected countries and limits their efforts to achieve development and socioeconomic growth.
- 20. Highlight the importance of reparation and compensation, as an act of justice, for the damages caused by slavery, indentured servitude and native genocide in the Caribbean.
- 21. Reject the imposition of unilateral coercive measures and, in that context, call for an immediate and unconditional end of the economic, commercial and financial blockade implemented by the Government of the United States of America against Cuba, and the termination of the US persecution of Cuban financial transactions, the relentlessness of which has increased. Reiterate our firm rejection of the enforcement of extraterritorial laws and measures, such as the Helms-Burton Act, which grossly violate International Law and undermine the sovereignty and interests of third parties.
- 22. Express our gratitude to the Government of the Republic of Cuba for its arrangements for this 7th Summit of the Heads of State and Government of CARICOM and Cuba held via videoconference.
- 23. Hold the 8th CARICOM-Cuba Summit in 2023, and the 7th CARICOM-Cuba Ministerial Meeting in the Republic of Cuba in June 2022.
- 24. Adopted on this 8th day of December 2020.

US Mayors Paint Troubling Post-Pandemic Picture

America's cities are in crisis as they cope with negative impacts of the pandemic on their most vulnerable residents, struggling local businesses and public schools, according to a new survey of the nation's mayors.

"They're really worried about renters and small-business owners in their communities," says Katherine Levine Einstein, associate professor of political science at Boston University and co-author of the 2020 Menino Survey of Mayors. "They're worried about their residents of color who have been disproportionately impacted by the health and economic effects of the pandemic."

The survey included mayors of U.S. cities with more than 75,000 residents; 130 mayors from 38 states were interviewed throughout summer 2020. It comes at a time when the nation's mayors are taking increasing responsibility for dealing with issues such as climate change, affordable housing and infrastructure including roads, mass transportation, water and wastewater.

"We're in this era of incredible partisan polarization at the federal level and so, as a consequence, a lot of our nation's most important policymaking is happening at the local level," Levine Einstein says. "Local governments are either having to come up with creative solutions or make really challenging cutbacks because they're not receiving the support they need from higher levels of government. They are being tasked with challenging policy issues where they used to ... receive lots of federal support."

The survey included mayors of U.S. cities with more than 75,000 residents; 130 mayors from 38 states were interviewed throughout summer 2020. It comes at a time when the nation's mayors are taking increasing responsibility for dealing with issues such as climate change, affordable housing and infrastructure including roads, mass transportation, water and wastewater.

"We're in this era of incredible partisan polarization at the federal level and so, as a consequence, a lot of our nation's most important policymaking is happening at the local level," Levine Einstein says. They are being tasked with challenging policy issues where they used to ... receive lots of federal support."

Half of the mayors surveyed say that arts and culture in their cities won't return to normal until after 2021. More than 40% think

that's also true for colleges, universities and mass transit.

"I think for the most part, there's this deep concern about what will be left in terms of our economic institutions or public institutions, how much human suffering we're going to see over the next few months," Levine Einstein says.

The mayors are also bracing for the longer-term impacts of COVID-19 — like

what will happen to their downtowns if large numbers of people decide to keep working from home even after the pandemic.

"Their central business districts may change in fundamental ways as the nature of work changes and both businesses and workers realize that they don't necessarily need to be in their offices every day to work productively," Levine Einstein says.

Trump, Biden Vow Quick Coronavirus Immunization for Millions of Americans

WHITE HOUSE - U.S. President Donald Trump and President-elect Joe Biden, separated by 160 kilometers and a much wider political distance, held simultaneous events Tuesday focused on fighting the coronavirus pandemic.

Trump, in the White House South Auditorium, signed an executive order to ensure Americans get "first priority" access to a coronavirus vaccine, although it is unclear how that would be enforced.

"Under this order, the secretary of Health and Human Services is directed to provide priority access to COVID-19 vaccines to Americans," according to the White House, which did not provide further details.

Before signing the document, the president addressed members of the federal government's Operation Warp Speed vaccine distribution team and his coronavirus task force about plans for mass immunization.

"Over the next few months, the numbers should skyrocket downward" of those infected with the virus, said Trump. "This is one of the greatest miracles of modern-day medicine."

In a theater in downtown Wilmington, Delaware, Biden was less optimistic at a time when COVID-19 case numbers and hospitalizations have soared to record levels in the United States.

"As a country, we've been living with this pandemic for so long, we're at risk of becoming numb to its toll on all of us," said the president-elect, while introducing his health leadership team. "We're resigned to feel that there's nothing we can do. We can't trust one another, that we must accept death, pain and sorrow."

Biden, promising 100 million vaccine shots within the first 100 days of his administration, said that will not be enough to eradicate the virus but "we can change the course of the disease."

Biden said that "as a new president I am going to speak directly to the American people. Wear a mask for just 100 days. Help yourself, your family and your community. Mask up for 100 days once we take office."

Trump, responding to a reporter's question about why no members of the president-elect's health team were invited to Tuesday's White House event, continued to insist there is no guarantee Biden will take office on January 20, 2021, the scheduled day of his inauguration.

"We won" the November 3 election, insisted Trump, who decisively lost the popular and Electoral College vote count to Biden. "Hopefully the next administration will be the Trump administration in continuation."

The president also termed it "terrific" that 15 percent of Americans have caught the coronavirus, suggesting that was a positive step toward herd immunity. Most scientists say about 70 percent of any population would have to either have caught COVID-19 or been immunized to break the chain of the pandemic.

More than 15 million people in the United States have been infected by the coronavirus and 285,000 people have died – the highest number of such deaths and illnesses reported by any country.

Guyana and Suriname can underpin CARICOM's sovereignty and prosperity

The presidents of Guyana and Suriname have

announced two major joint venture projects whose implementation will deepen the beneficial relations between the two countries, and could have a positive effect for the 15-nation Caribbean Community (CARICOM) of which they are members.

The projects are a bridge across the Corentyne river to link the two countries, and the construction of a US\$1 billion

offshore base to support huge oil discoveries in the Guyana-Suriname basin of more than 10 billion barrels of oil.

Relations between the two countries have not always been harmonious. Land and sea territorial disputes have caused military skirmishes and tension in the past. Fortunately, successive governments of both territories were sufficiently restrained to stop short of a full-scale war - a marked difference with the other countries on the South American continent.

Peaceful resolution of disputes through negotiation and international arbitration, and active fostering of economic integration, have always been the best way forward for Guyana (formerly British Guiana) and Suriname (formerly Dutch Guiana). Along with French Guiana, they make up what used to be known as 'The Three Guianas', lying next to each other on the north-eastern coast of South America.

In the foreword to the book, "Post-Colonial Trajectories in the Caribbean: The Three Guianas", published by Routledge in 2017, I wrote: "Guyana and Suriname are more similar to each other than they are to any of the member countries of CARICOM, except Trinidad and Tobago. Given the similarity of their resources which includes mining, agriculture, fisheries and oil, they would benefit enormously from the economic integration of their production, freedom of movement of goods and services, joint bargaining with foreign investors and the international community generally"

I added: "If the governments of Guyana and Suriname – together with the private sectors of both countries - were to work diligently toward economic integration, the two countries could easily become a joint economic powerhouse, exporting their products In this connection, it is noteworthy that the Surinamese President, Chandrikapersad Santokhi, said that the US\$1 billion offshore base "will extend also to the private sector so that we can have a public-private partnership approach".

In pursuing joint venture projects that will strengthen their economic integration, governments have sensibly not ignored their one remaining territorial dispute. Having settled their maritime boundary dispute in September 2007 under an arbitration by the United Nations Tribunal on the Law of the Sea, the governments have agreed that their joint Border Commission will continue to examine ways of resolving the land border dispute over an area known as 'the New River Triangle'.

Guyana's President Irfaan Ali, in noting that the "future of (the two) economies is intertwined", also stated that "Guyana and Suriname are also part of

the Caribbean Community". He did not have to do so. His deliberate inclusion of this remark to the Suriname Parliament, is an indication of the

> importance his government places on CARICOM. Even more indicative of Guyana's commitment to CARICOM is President Ali's further remark that "both states (should) take the lead in demonstrating the efficacy of regional integration". "Together", he said, "we can meet and fulfil a great portion of the food needs within the Caribbean community".

President Ali is right, provided that the longstanding problem of sea and air transportation can be resolved to carry food between Suriname-Guyana and other countries in CARICOM. The regional group's bill for the importation of food is now US\$5 billion a year. It would be highly beneficial to the region's food security and its retention of foreign exchange, if its member states could collectively devise at least a break-even financial operation for a shipping line. It is a project which Guyana and Suriname, in collaboration with Trinidad and Tobago, might consider underwriting through a portion of their oil and gas income.

Guyana and Suriname are expected to receive significant revenues in the coming years. Neither country has the absorptive capacity to utilize all the expected annual income, however free spending they might be in building physical infrastructure, increasing the wages of their workforce, and improving health and education. They should be able to dedicate a portion of their revenues to invest in CARICOM projects and member states in ways that would strengthen the region, breaking its dependence on external powers and enhancing its integration.

None of this would be a give-away; it could be targeted investment in projects that provide financial returns for all the parties concerned, while accelerating development in CARICOM. In addition to food and related transportation, Suriname, Guyana and Trinidad and Tobago could consider, in consultation with other CARICOM states, how they could profitably underpin energy security for the region. That profit would be measured not only in financial terms, but also in the benefits of ending reliance on external countries and strengthening the sovereignty of the region in its decision-making.

Security of regional transportation, food and energy would be three important, immediate areas for Guyana and Suriname to "take the lead in demonstrating the efficacy of regional integration" to which President Ali referred.

The "dedicated pathway to deepen economic and social cooperation" between Guyana and Suriname should be applauded by all. Even as they pursue this path, from which both countries and their peoples will undoubtedly benefit, they should take the steps to examine how such cooperation can be extended to CARICOM.

The neighbourhood in which the people of Guyana and Suriname live would be more secure, and in that regard, so would they.

Ignoring Traffic Rules may cause Injuries & Deaths There is a major problem in the BVI — it is called traffic anarchy,

some call it traffic ignorance. One wonders who has given a driver's licence to many of the drivers who use their vehicles as if they were the donkeys of yesteryear but at the speed of light.

Since its inception, the four lane highway fhas been used by many drivers to display their total disrespect and ignorance of basic traffic ethics and regulations. As far as we know nothing has been done to address this problem and quite honestly driving around town it's either for gladiators or those who get a thrill playing chess with death.

Even something as basic as signalling before changing lanes is disregarded by 80 per cent of the drivers. One does not need a scientific survey to come to such a conclusion. Obviously a quota of these drivers does not know that IT IS AN OFFENCE to change lane without signalling first. Many do not know which lane is the basic lane to use and keep zig-zagging from one lane to the next. Most drivers do not know that the fast lane is only for overtaking a vehicle and not as a regular driving lane. Some even say that zig-zagging adds excitement to their driving.

To make things worse we now have an increasing number of IRRESPONSIBLE motor-cycle riders who move around as if they were supermen.

In general most drivers fail to see the importance of using their turn signals, but they do so at their own risk and at the peril of others.

Lane changes are a necessary part of every driver's day. But, how often does that same driver think about the inherent dangers of a lane change? Here are a couple of simple math facts.

The more often you change lanes, the more likely you are to be involved in an accident. The number of times you change lanes in a given day is largely dependent on your speed. Excessive speed leads to excessive lane changes. Thirty percent of all accidents are related to excessive speed.

A properly executed lane change requires planning and execution. Before you begin the maneuver, ask yourself these questions:

Is there anything to gain by passing this vehicle? Is there any approaching traffic? Do I have the right of way to pass? Have I continually monitored traffic following me to ensure that no one is in my blind spots? Have I given adequate warning to vehicles around me that I am preparing to change lanes? Does the traffic around me have sufficient time and space to notice and react to my turn signal?

The sensible driver's goals should be: evaluate the need to pass and then minimize the risk.

Furthermore, pedestrians cross the street or highway at their leisure, many do not even bother to look left and right to ensure no vehicle is in close proximity. Good business for the funeral home!

In conclusion: the path to safety is through education. The BVI should embark on a motorists education campaign for drivers. Furthermore, some of the offenders should not only be fined, but also ordered to attend 30 HOURS traffic education classes or 5 months in jail.

Here's How to Reduce Risk of Heart Disease

DEAR DR. ROACH: I'm a 70-year-old female who had a stress test, echocardiogram and carotid study. I passed all tests. My cholesterol is 173, with my HDL 56, LDL 95.6 and triglycerides 108. My blood pressure is 110/64. The cardiologist put me on 5 mg of Crestor. He feels this will help my numbers. He also has me taking CoQ10 and vitamin D3 in case my legs start aching from the Crestor. I've been taking everything now for two weeks, and my legs are starting to ache. Is it really necessary to stay on Crestor? — J.S.

ANSWER: I put all your numbers into the standard risk calculator at www.cvriskcalculator.com, and your risk for heart disease or stroke in the next 10 years is 6.8%. That is in a range where medication therapy is not usually recommended.

Of course, I can't tell you to stop taking the medication your doctor has recommended. He may know something about you that I don't. It's possible you have a less-common risk factor your cardiologist may not have told you about.

Some people with very good cholesterol and blood pressure numbers have high levels of C-reactive protein, for example, which confers an increased risk for heart disease. That's true even in people with desirable cholesterol levels, and people in that situation would clearly benefit from taking Crestor or a similar medicine. All of these medicines have the risk of muscle aches, although the risk of serious muscle damage is very small.

Nearly everyone can reduce their heart disease risk by having a diet with very little meat but high in vegetables, legumes and nuts, along with whole grains and fruits. Regular moderate exercise is as important as diet. Keeping stress levels low, having good close relationships and sleeping 7-8 hours daily are underappreciated beneficial factors to reduce heart risk as well.

DEAR DR. ROACH: I am 76, female, healthy, do not take any meds and am scheduled for a total knee replacement. During the testing, they made an incidental discovery on the CT scene of the possible yight

on the CT scan of "a possible right sided right Hutch diverticulum of the bladder" and "two prominent right external iliac lymph nodes, measuring up to 15 and 13 mm in short axis."

My surgical team did not respond, and my internist says "do not worry," with no explanation. I would greatly appreciate your opinion.—L.M.

ANSWER: A Hutch diverticulum is a congenital condition, a small pouch in the wall of the bladder. They are seldom diagnosed in adults. They can be associated with infection and stones, but if you have had no problem with either of those conditions, I would certainly advise against doing anything about it.

The external iliac lymph nodes are structures in the hip, and like all lymph nodes, may enlarge in the presence of infection or inflammation. Yours are definitely enlarged, with less than 8-10 mm considered normal. Although we worry about enlarged lymph nodes as a symptom or sign of cancer, it's thought to be cancer only about 1% of the time. After you recover from surgery, it may be worth taking another look to see if they have shrunk. If they are persistently enlarged, especially if they are growing, some physicians would recommend a biopsy to be sure it is nothing to worry about.
