SUPPLEMENTAL INSURANCE FOR PARLIAMENTARIANS GENERATES FIERY RESPONSES

Following a public demonstration and finger-pointing media statements between the Government and the Opposition, the proposal for legislators to get supplemental insurance coverage was halted.

The situation stems from the fact that an RFP (Request For Proposals) was issued to seek insurance coverage to provide supplemental medical coverage for past and present legislators. However, the matter drew public scrutiny and resulted in two private citizens doing a public protest throughout the streets of Tortola during the weekend. This protest, which was aired on social media attracted public interest on the matter and resulted in the Opposition issuing a statement explaining that they were not a party to the decision to put the RFP out.

However, the Opposition's stance has been criticised by the Government who said that it was the opposition members that were pushing the extra insurance matter. Acting Premier Dr. the Hon. Natalio Wheatley in his effort to discredit the statement that was issued by Leader of the Opposition Hon. Marlon Penn took a swipe at the Opposition labelling their position on the matter as opportunistic.

Hon. Wheatley announced that Government has decided to halt the unpopular plan to get supplemental insurance said that he is astonished at the way the Opposition is positioning itself. "Notwithstanding the political pandering and flip-flopping from the Opposition... your Government has taken a decision to halt the tender for the insurance service for current and former HOA Members, so that we can have further deliberations among the Members of the HOA and also to consider the views of the public on the matter."

"It is your Government's position that an important matter such as how we care for our former Legislators in their golden years and

shrouded in discord and controversy. To re-emphasize the assurance given by the Hon. Premier on this matter, whatever is in the best interest of the people of the Virgin Islands will be the only course of action," Hon. Wheatley added. A commentator said that guite a few community members struggle to pay the stiff expenditure for a funeral and bury their dear departed relatives and family members.

In addition to announcing that the supplemental insurance matter is halted, Hon. Wheatley ventured onto giving a detailed account of how the matter came into being. In doing so, he further lashed out at the Opposition accusing them of twisting the facts.

Going further in his attempt to set the record straight, Hon. Wheatley pointed the finger at Second District Representative, Hon. Melvin Mitch Turnbull, who was also one of the Opposition members to cry foul at the RFP in the media. However, Hon. Wheatley announced that Hon. Turnbull who sits on the HOA's Privileges Committee, was lead on this supplemental insurance project.

The Acting Premier said, "... Members of the Opposition have been involved in this matter from its inception - and this includes the Honourable Member for the Second District, who is a part of the Privileges Committee of the House of Assembly, which first raised the matter. Given his background in insurance, he was selected as the lead Member on this matter."

The comments about Hon. Turnbull as the lead of the insurance project was also done in an 8 June statement from Junior Minister for Tourism Hon. Sharie De Castro, who is also Member of the Privileges Committee. Hon. De Castro said, "The Privileges Committee of the House of Assembly (HOA), of which I am a member, was assigned the responsibility of reviewing a proposal on supplemental health insurance for current and former HOA Members. The objective of the committee was to explore the feasibility of the recommendation made. It should also be noted that this recommendation was brought forward by the Member for the 2nd District who was also appointed as the lead on this initiative due to his expertise in the field."

Hon. De Castro mentioned the fact that Hon. Turnbull issued a letter to the House of Assembly which was then made public; the letter expressed his dissatisfaction with the matter being put to tender at this time. However, Hon. De Castro purports that Hon. Turnbull was aware that the matter was going out to tender. "What is extremely disappointing and what took me by surprise, was the blatant disregard for the facts by the Member for the 2nd District when he, seemingly motivated by the public's response, attempted to distort the facts in order to deceptively excuse himself from a collective decision of which he was the architect," Ms. De Castro said.

"In his letter, the Member for the 2nd District stated that he "made it clear" to the Speaker and the team at the Procurement Unit that he would have to write a report based on his findings as an "experienced professional in the insurance field." It should be noted, that in actuality, at no point did the Member express reservations regarding the publication of the tender document. In fact, the said Member met with the Ministry of Finance to make additional recommendations to the tender document after the document was presented to Members and prior to it being made public. Most importantly, the Member was

copied on and in some instances addressed directly in electronic correspondences at every stage during the process. Based on such circumstances, for the Member to assert that the document was finalized without his involvement and subsequently made public is grossly and maliciously mendacious," she

In the statement on behalf of the Opposition on 6 June Hon. Penn said that his side did not agree to the RFP. "Members of her Majesty's Loyal Opposition have expressed their disappointment and concern regarding the Request For Proposals (RFP) for private health insurance coverage for members of the House of Assembly ("HOA"), as advertised in the media, despite there being no consensus by all members of HOA to issue such notice;" the Leader of the Opposition said.

However, this statement was rubbished by Hon. De Castro who said, "It is my belief, that the Leader of the Opposition also saw this as an opportunity to pose as a bystander to the process. However, the Leader of the Opposition in this instance is being disingenuous, as he too was copied on correspondence regarding the RFP and could have indicated his Opposition at any point during the process."

Labour Minister is Very Concerned about **Local Economy**

The dire financial situation caused by the treacherous COVID 19 pandemic has even reduced prominent businesspersons to seek financial assistance from Government to carry on; and Minister for Natural Resources Labour and Immigration Hon. Vincent Wheatley says that this is concerning, The Minister, who once again lamented how bad things are for people says he fears that persons might feel there is no hope and take drastic steps.

The Minister who prefaced his comment by stating that Virgin Islanders are proud people who do not like to beg explained that it is a clear sign that things have gotten to a very critical level when persons who would never

normally seek help are asking for money to pay for basic necessities. In fact, some once upon a time prosperous businesses are said to be an inch from receivership.

In an interview on JTV on 7 June the Minister said "BV Islanders are dignified people, we don't like to beg. Certain persons I have seen here requesting money I have seen it in my lifetime before. It tells me the economy and things are really, really bad. If it was the average person coming and say so and so is the case, but these are some established persons in the community. When they are saying I need help a red flag goes up."

While noting his worry that unspeakable actions might be taken as persons continue to feel hopeless, Hon. Wheatley stated, "My biggest concern is persons buckling under their financial pressure right now. I met with the Minister (clergy) some time back and I told the Minister we have to change the message in church because persons are hurting. The only hope they have left right now, many persons is Jesus Christ and if you take that away, if you don't preach hope in the churches and hope in the House of Assembly, and hope everywhere we are going to start losing persons. Some through stress, and some through suicide, that's my biggest concern that persons might see no end to this and decide to end it."

As he further commented on the fact that persons who would never ask for help are coming forward, the Minister said.

"When you see those persons come forward and have to face the humility, people look up to me as an established persons, and for the public to hear I am losing my property, my light is being cut, my water is shut off; that concerns me."

Hon. Wheatley said that the Government is not in a position financially to help with these areas of hurt. "The Government is not making that kind of money to really carry the country like that for much longer...I have some financial requests; they tell the story of what the state of the economy is in the BVI. A lot of persons are hurting really, really badly. I am from the Ninth District mainly tourism - here it is over a million dollars of request from persons not just to pay bills but to buy food, buy things for their children to go to school and so forth. ... It is a very challenging time. COVID is still wreaking havoc on the entire world...The hurt is real, the story is right in front of me. I see it every day."

"The requests come to my office everyday seeking money to buy food. They are not trying to buy cellphones or jewelry they are trying to buy phones. They are trying to pay rent. They are trying to pay bills. I see it every single day. The requests come in every single day over a million dollars in requests right here now. I don't have the money," he further added.

"We should be preparing for the merciless domino effects," a commentator said.

"Take Vaccination Seriously": UK Health Ambassador Says Cummings who did various media interviews disclosed unfortunately neither of those

As Government continues its drive to get more persons vaccinated, Minister for Health Hon. Carvin Malone has turned to the social media community to determine whether vaccination should be incentivised in the BVI.

As June moves forward and the COVID 19 vaccination effort becomes urgent Hon. Malone gave the teaser on his Facebook page in an effort to get members of the public to weigh in on whether incentivisation might be a way to get more persons to take the vaccine.

The Minister also noted that the USVI has already commenced a similar campaign and he alluded to the fact that there was a previous lunch voucher initiative that received some criticisms. The Minister said, "\$20.00 lunch vouchers in BVI are peanuts compared to USVI'S \$1,000,000 in raffle prices and free land distribution in other jurisdictions."

Hon. Malone explained that some private entities in the Territory have expressed interest in giving an incentive to help to motivate persons to get vaccinated. "A number of BVI businesses are seeking permission to hold private intra company give-aways to

employees being vaccinated during the month of June. What do you think? Should the BVI Government offer monetary incentives to encourage individuals to vaccinate? It is a global challenge," the Health Minister asked.

UK Vaccination Help

Meanwhile Government is getting some visiting help with the vaccination message as UK Health Ambassador to the Overseas Territories, Ian Cummings arrived in the Territory. One of Cummings' main tasks during his visit was to help to dispel vaccine myths and rumors.

while speaking on 284 media on 8 June that the Astra Zeneca vaccine is safe and that persons should not hesitate to become vaccinated.

The Ambassador, while commenting on the Territory's current inoculation drive said, "There is some brilliant work being done here in the Virgin Islands to ensure that as many people take the vaccine but as you know there is more that we can do; there is definitely a degree of vaccine hesitancy. I think that's down to the fact that people have a low perceived risk of COVID, the actual disease and a high Unfortunately neither of those are correct. I have been present in many countries where tragically people have been dying in hospitals and nursing homes from the effects of this."

"There is a tiny risk with the vaccine but there is a much, much greater risk of actually dving if you contract COVID... We don't want there to be an outbreak in the Virgin Islands such as we have recently seen in Anguilla or Bermuda...where tragically people have been in intensive care and lost their lives for people to realize that they need to take this vaccine seriously," he added.

Police To Focus On Organised Crime: Governor Says

issue in our Territory and is it to be blamed for various murders and drug busts the Territory recorded in recent times? His Excellency Governor John Rankin under whose portfolio Territorial security falls is of the opinion that it is. As such the Governor is confident that plans afoot by the Royal Virgin Islands Police Force will be able to combat any organised crime proponents in the BVI.

The Governor made the comment during an interview on 284 Media while noting some recent criminal activities. His Excellency particularly mentioned the fatal shooting of Catherine Pickering and the resulting arrest of multiple persons following allegations of a planned crime.

His Excellency said that he is aware that members of the public are anxious to see crime

Is organised crime a major combatting strides and also justice for past incidents. He said that while actions are being taken to deliver, he as a member of the Security Council has things he would like to see done as well. "My priority first of all is to tackle crime on the island; organised crime in particular and the transshipment of illicit drugs which can be corroding... to the society which we live in."

> The Governor emphasised his belief that some of the incidents that occur are planned criminal activities. "I am particularly aware of the murders which have occurred in recent months, the majority of which may well have been related to that organised crime of which I have spoken. So I welcome the steps that the Police Commissioner has taken. With UK support...we are planning to tackle that organised crime," he said.

Prison Stabbing Incident

Speaking further on the matter of crime the Governor said that he is also concerned about the incident that occurred at Her Majesty's Prison recently. The Queen's Representative said that he has seen photos and heard of situations were prisoners were not acting like persons serving reformative time.

"I saw those pictures on social media like everybody else and it was deeply worrying in terms of what appears to be alcohol, illicit drugs, gang chains being worn what was some form of party being associated at the prison. Tragically the results at the end of that weekend resulted in a number of prisoners being stabbed... loss of life is completely unacceptable," the Queen's Representative declared.

Following the stabbing a few days ago the Governor said that he requested an emergency NSC meeting to discuss the

matter."I called immediately an emergency National Security Council meeting on the Monday following the events on the Sunday evening and we took a number of early decisions. First of all, to have a lock down at the prison, increase the number of prison officers supervising prisoners and secondly to launch an investigation into the events to go along with current police investigations into those events," the Governor said.

Following the incident it was announced that two officers who were in charge when the particular events occurred have been placed on administrative leave. Nonetheless, the Governor said a deeper look into what transpired needs to be taken.

"We need that investigation to continue. The police have already made some arrests in relation to the crime which appears to have occurred, but we also more widely need to have, I believe, an external

review of security at the prison and arrangements at the prison to make sure - not just for these particular set of dreadful incidents but in longer term we can ensure better security and safety at the prison. Safety for prisoners, safety for prison officers and to give the public confidence that the prison is running properly is very high priority for me given the dreadful events of two weeks

Additionally, the Governor mentioned that there are currently 106 prisoners at Her Majesty's Prison and there is a great need for more prison officers."We do need to improve training for Prison Officers. We do need to improve security." He also noted that a UK trainer will be coming to the Territory shortly to assist the Prison Superintendent and staff in that particular area.

The Telecommunications Regulatory Commission (Commission) received two applications for licence renewal from CCT and Flow. The licence renewal process is governed by section 24 of the Telecommunications Act 2006 and Article 3 of the Licence. In deciding whether or not to renew a licence, the Commission must decide whether the Licensee in question has complied with its various obligations under the Act, the Telecommunications Code, the Licence, and any Commission instructions, and on whether the Licensee has been in persistent breach of any of those obligations.

The Commission is presently revising the terms and conditions of the Licence, focusing on the development of the industry and ensuring that the public's interest is protected.

Additionally, the Commission strongly encourages any interested

third party with a legitimate concern to comment on or object to the application as they believe that everyone has the right to have their voice heard. All comments on or objections to the application must be filed with the Commission on or before 30 July 2021.

All responses should be captioned 'Application for Renewal of CCT/Flow's Licence' (specify applicable Licensee) – and sent to the Telecommunications Regulatory Commission, P.O. Box 4401 or 27 Fish Lock Road, 3rd Floor Road Town, Tortola, British Virgin Islands VG1110.

Under Article 3.3(a) of the Licence, the Commission must send to CCT and Flow an Evaluation Report (Report) within ninety (90) working days from the date of receipt of the application, which will be a matter of public record at the Commission. Accordingly, the Commission will send



the Report to CCT and Flow on 30 September 2021.

On 12th and 13th October 2021, a public hearing will be held at Maria's by the Sea for Flow and CCT, respectively, during which the licensee and any third party with a legitimate interest may make comments or objections to the application.

Participation in this hearing will be limited to those persons who submitted a relevant comment or objection to the application by the specified deadline. The Commission will publish a notice with additional details on the public hearing at a later date.

Public Works Increases Road Maintenance And Safety Works

Acting Director of the Public Works Department, Mr. Jeremy Hodge has said that the Public Works Department (PWD) is engaged in heightened road maintenance activities in preparation for the hurricane season and to

ensure continued public safety.

Mr. Hodge said the Atlantic
Hurricane Season began on
June 1, and will officially end
on November 30. He said as
the Territory works to develop
its collective disaster readiness
and security during this time

of increased risk, the Public Works Department plans to ensure the soundness of the Territory's infrastructure as best as possible.

"Prior to and as we officially enter the 2021 Atlantic Hurricane Season, we continue to clear drains and ghuts throughout the Territory," the Acting Director said, adding, "Road asphalt patching and some bush cutting will be more apparent as we continue to experience increased rain showers heading into the season; along with speed bump placements where safety is of concern."

Mr. Hodge indicated that while most remedial road works are initiated by the Public Works Department, the placement of speed bumps are a collaborative effort, as they are only placed in communities throughout the Territory at the request of District Representatives on behalf of the community members in an effort to mitigate concerns for safety.

SANTO DOMINGO - The Ministry of Labor says the department has not ruled on whether businesses can obligate its staff to be vaccinated or if staff can be suspended for not getting the vaccine. The Ministry recently issued a resolution asking companies to give their staff time off to get vaccinated.

As in the rest of the world, in the Dominican Republic legal and academic experts are participating in the debate on whether vaccinating can be made obligatory here. While the Dominican government has secured sufficient vaccines and has in place the logistics to vaccinate upwards of 100,000 a day, hundreds of thousands of locals are reticent to getting the vaccine. The country is vaccinating those who can show a Dominican ID or at least a legal passport.

The most available vaccine in the country is the Sinovac/Coronavac from China that recently received World Health Organization emergency approval. [DR1]

CARIBBEAN - The White House has announced that it will be donating six million doses of COVID-19 vaccines to countries in South and Central America and the Caribbean, including those that have been hit hard by the pandemic, such as Brazil and Haiti.

The doses are part of the 80-million vaccine donations that

U.S. President Joe Biden has pledged to send out worldwide by the end of June.

"This vaccine strategy is a vital component of our overall global strategy to lead the world in the fight to defeat COVID-19, including emergency public health assistance and aid to stop the spread and building global public health capacity and readiness to beat not just this pandemic, but the next one," said the White House in a statement.

The Biden-Harris administration is slated to dispatch its first wave of 25 million doses of Covid-19 vaccines in the coming weeks. As to whether when the vaccines will arrive to their respective countries remain unclear since there is no timeline that has been released by the office.

"Specific vaccines and amounts will be determined and shared as the administration works through the logistical, regulatory and other parameters particular to each region and country," the White House said.

The international aid organization COVAX will receive 19 million vaccines from the U.S. Another 7 million will go to Asian nations, including India, while 5 million will be sent to the African Union.

The U.S. will send another 6 million doses directly to governments that have requested doses, are experiencing surges or are immediate neighbors. These

countries include Canada, Egypt, Georgia, Iraq, Jordan, Korea, Kosovo, Mexico, the West Bank and Gaza, Ukraine, and Yemen. The U.S. will also provide vaccines to United Nations front-line workers. [CaribbeanNewsNow]

PORT OF SPAIN - Trinidad (CMC)

— Trinidad and Tobago registered
19 deaths and 529 new cases linked
to the coronavirus (COVID-19)
pandemic over the last 24 hours.

TRINIDAD - The Ministry of Health said that the 19 deaths, which included nine males and 10 females, all with co-morbidities, bring to 556, the number of people who have succumbed to the virus since the first case was detected in March last year.

The new positive cases were for the period May 28 to June 3.

The figures show that the number of positive cases now stands at 25, 801 with 10,049 being active cases. There are 428 patients in hospitals across the island, 88 in statesanctioned quarantine facilities and 8,947 in home isolation. There have been 217 recovered cases. [nycaribnews]

GERMANY - Armin Laschet boosted his chances of succeeding Angela Merkel as German chancellor by securing a decisive victory in the country's poorest state.

In the final electoral contest before the national vote in September, the 60-year-old party leader showed he can successfully guide the Christian Democrats in a tight campaign. The outcome will help ease doubts about his suitability to lead Germany's conservatives.

The CDU halted its slide in recent elections on Sunday, winning

37% of the ballots in Saxony-Anhalt to improve on its last result, according to projections from public broadcaster ARD. The far-right Alternative for Germany, which was pushing for the lead in recent polls, slumped to a distant second in the former communist region with 22%. [Bloomberg]

BARI - A letter written by an Italian soldier on the Russian Front in World War Two has arrived 78 year after his death there in 1943. The letter ended up by chance in the the possession of a Mantua woman, Olga Rosa Davini, who on Friday delivered it to the granddaughter of the late Lieutenant Vincenzo Fugalli from Barletta in Puglia, Serena Fugalli. Barletta Mayor Cosimo Cannito called Davini's work to bring back solders' bodies and personal effects "a mission charged with humanity, a lesson of sensitivity which I deem a privilege to have heard from the voice of the person responsible".

Davini said "I inherited this work from my family and it has been an honour to hand over the letter to Ms Fugalli". (ANSA).

LONDON - A spokesperson for Prince Harry and Meghan said Sunday the couple welcomed their child Lilibet "Lili" Diana Mountbatten-Windsor. Their daughter weighed in at 7 lbs, 11 oz.


Her first name, Lilibet, is a nod to Her Majesty The Queen's nickname. Her middle name is in honor of her grandmother and Harry's mother. The baby is the eighth in line to the British throne.

"The Queen, The Prince of Wales and The Duchess of Cornwall, and The Duke and Duchess of Cambridge have been informed and are delighted with the news of the birth of a daughter for The Duke and Duchess of Sussex," a Buckhingham Palace spokeswoman said in a statement Sunday. SPAIN - The Spanish job market is steadily recovering from the economic fallout of the coronavirus crisis, according to data presented on Wednesday by the Labor and Social Security ministries. These figures showed that the number of people registered as unemployed in Spain fell to 3,781,250 in May – a drop of 129,378 since April. This is the largest monthly fall ever recorded in the statistical series, which dates back to 1996. The last time a similar drop was seen was in 2017. [El Pais]



Dear Readers: Every third Sunday in June, we honor fathers across the world who work tirelessly to give their families the best life possible. The first recorded Father's Day occurred in 1908 after the Monongah mining disaster in West Virginia. This horrible accident killed 361 men, leaving nearly 1,000 children without a father, so the community gathered at their local church to honor those who were lost. Other early accounts of the first Father's Day celebrations date back to 1910 in Spokane, Wash. The Spokane YMCA took the initiative to recruit clergymen willing to help honor fathers in the city. Harry C. Meek also claimed he was the originator of Father's Day in 1915. Meek, a member of the Lions Club International, claimed the third Sunday in June became the date of celebration because it was his birthday.

Origin aside, it wasn't until 1966 at the first presidential proclamation that honoring fathers became a national talking point in the USA. Half a century after Mother's Day became a national holiday, President Nixon signed a law in 1972 making Father's Day a permanent national holiday, set to be celebrated every third Sunday in June.



THE INFLATION BEAST RETURNS: BUT DON'T PANIC JUST YET

Now the challenge with inflation is that it increases the cost of living. Inflation when uncontrolled can be very damaging. And if economics is primarily about human behavior, then uncontrolled inflation damages consumer and business confidence which are the platforms upon which economics rests.

And inflation- according to the USA Federal Reserve – is back. The reason for the return of inflation has been put down to many years of QE Stimulus: the pumping of cash into the global marketplace by Central Banks in an effort to prevent financial collapse in 2008, to today's pandemic driven stimulus. The present QE is an effort to avoid recession and even depression from a world terrified by COVID

A depression would lead to business shutdowns, bankruptcies, and millions of job losses. Hence policymakers use the instrument of QE-increasing the quantity of cash in the marketplace- through the selling of government bonds

and various treasury instruments to investors, in an effort to drive greater consumer spending and prevent business insolvency.

Government Bonds are the most secure investment in the global marketplace.

In the Virgin Islands, the idea of government stimulus is an analogy of what the US Federal Reserve attempts to achieve in activating the instrument of Quantitative Easing to prevent a US Depression.

Today, there is an imbalance in the cash in the western marketplace: more cash than the goods and services the cash buys; hence rising prices. This is what is driving inflation.

Can consumers protect themselves against inflation? The preceding is not a simple question with a simple answer.

Any income increase that matches the cost of living increases that inflation generates does the job of protecting the consumer. But for those on incomes that cannot be adjusted for inflation which means the majority of consumers, inflations means higher prices and higher costs of living.

For residents on fixed budgets-retirees, employees on fixed wages, and so on- inflation means life gets more expensive. For residents who can push the increase in inflation on others such as their customers, clients, tenants, home buyers, hotel guests, travelers, these people can cushion the effects of

inflation.

Investors have ways they can protect their wealth from inflation; such as moving their wealth into more secure investments: established index funds, government bonds, treasury notes, and such.

Historically land prices rise with inflation and landowners may be protected from inflation.

However interest rate rises frequently accompany the Inflation Beast. Home and business owners with mortgages and commercial loans that are not fixed may get a shock increase in their interest payments. The preceding is negative fallout from inflation for consumers.

Who wins and who loses in the inflationary environment? If the Federal Reserve increases interest rates, then rates worldwide may go up. That means all of us who borrow on car loans, home and commercial mortgages, bank loans, and credit cards, may see life getting more expensive.

Savers on the other hand may see their cash in the bank receive greater returns as rates rise.

There is a catch 22: Savers may see their rate of returns rise only to spend that extra cash on more expensive goods and services.

Inflation is a complex beast.





WHITE POTATOES: Round and long, whites are medium in starch level with a creamy texture. They hold their shape well after cooking. The ultra-versatile round white can be used in most potato preparations.

Tip: Potato Salads -- To create signature potato salads, just toss cooked white potatoes with dressings and ingredients "borrowed" from other salads, e.g., Caesar dressing and grated Parmesan, or Ranch dressing, chopped egg and bacon crumbles.

BLUE/PURPLE POTATOES: Blue/purple potatoes originated in South America and have now become popular in the U.S. They have a subtle, nutty flavor and flesh ranging from dark blue or lavender to white. Microwaving best preserves color, but steaming and baking also are recommended.

Tip: Red, White and Blues -- Combine blue potatoes with whites and reds in salads or roasted medleys to make all three colors "pop."

GRILLED POTATO KABOBS WITH LEMON-HERB DRIZZLE

Red, white and blue potatoes add flavor and eye-appeal to these delicious kabobs. You also might substitute your favorite protein for the chicken sausage or try an all-vegetarian version of this dish.

Lemon-Herb Drizzle:

- 1/4 cup extra virgin olive oil
- 3 cloves garlic, minced
- · 2 tablespoons chopped fresh herbs (such as basil, rosemary, marjoram and sage)
- 1/2 teaspoon sea salt
- · Juice of 1 fresh lemon
- Freshly ground pepper to taste
- · 12 to 16 wooden or metal skewers

Potato Kabobs:

- · 1 pound (total) red, white and blue potatoes, scrubbed
- 1 (12-ounce) package pre-cooked chicken sausage, sliced 1/4-inch thick on the diagonal
- 2 ears fresh corn, cut into 1-inch pieces
- · 1 zucchini, sliced 1/4-inch thick on the diagonal
- If using wooden skewers, soak them in a pan of cold water for 30 minutes to prevent them from burning. Heat olive oil in a small saucepan until very hot; remove from heat and stir in garlic. Let cool, then stir in herbs, salt, lemon juice and pepper; set aside.
- 2. Place potatoes in a medium-size microwave-safe bowl and cover with a lid or plastic wrap. (Note: If using plastic wrap, make sure wrap is not touching any ingredients, and poke one small hole in cover to vent.)
- 3. Microwave on high for 10 to 12 minutes or until the potatoes are tender (cooking time may vary depending on microwave). Use oven mitts to carefully remove the potatoes from the microwave.
- 4. When cool enough to handle, cut the potatoes into large chunks. Thread potatoes, sausage and vegetables onto skewers. Wrap the exposed ends of the skewers with foil to prevent them from burning.
- 5. Grill over medium-high heat for about 10 minutes, turning frequently and brushing with a little of the herb mixture during the last few minutes of cooking. Remove from grill, discard the foil and place the skewers on a platter; drizzle with remaining herb mixture. Serves 6.

Be more strategic, press on urgently with CARICOM Single Market and Economy - Trade Ministers advised

CARICOM Secretariat, Turkeyen, Greater the Community's integration efforts. Under Georgetown, Guyana - Wednesday, 2 June 2021) - The Organs of the Caribbean Community (CARICOM) must move with a greater sense of urgency and clarity of purpose if the Region is to successfully navigate the current difficult circumstances.

Prime Minister of Barbados, the Hon. Mia Mottley made the call Tuesday at the opening of the Fifty-Second Meeting of the COTED.

Prime Minister Mottley, who is Lead Head of Government with responsibility for the CARICOM Single Market and Economy (CSME) in the CARICOM Quasi Cabinet, said that if ever the Region needed to see progress, it was now, and that the Region needed to rely heavily on integration and cooperation.

"If ever there was a time that the Region needs to rely on regional cooperation and regional integration, it is absolutely now within the context of what we are going to face in the post-pandemic period, and we are not yet there but we can begin to see already what it is looking like," she said, as she highlighted the possibility of emerging debt and financial crises "if we are not careful".

She drew to the attention of delegates the "double-digit declines" and pointed out that there was need now for "a greater sense of urgency and greater clarity of purpose by the organs of the Community, in particular, COTED".

VAST MANDATE

Pointing out the vast mandate of the COTED, CARICOM Secretary-General, Ambassador Irwin LaRocque said it was a major driver of the Revised Treaty of Chaquaramas, COTED has responsibility for the CSME which Ambassador LaRocque described as "a massive task" that had produced mixed results.

"These times demand that the full implementation of the CSME should be our pre-eminent task. The COVID-19 pandemic has created havoc in our societies - both in economic and human development terms. Lives and livelihoods have been lost; public finances have been curtailed; our health systems have been challenged; and the education of our children has been interrupted.

"In order to face these challenges, we must devote much more attention to building resilience, including into our production systems. The CSME is the platform for transforming the economic structures of Member States, and building the resilience necessary for dealing with the increasing number of external and internal economic shocks," the Secretary-General told delegates.

In this regard, he highlighted work that was advanced, including the adoption of Protocols on Contingent Rights and on Public Procurement; agreement on Policies on Credit Reporting and on Deposit Insurance; a Food and Nutrition Security Plan; a Strategy for Advancing the CARICOM Agri Foods Agenda is being worked on by a Ministerial Task Force; and a Multilateral Air Services Agreement that was in force. He also spoke of the work of the Region's newest Associate Institution, the Caribbean Private Sector Organisation (CPSO) which had put on the table a plan for reducing the food import bill by 25 percent by 2025, and was actively engaged in the work of the COTED.

"We need now to press on with urgency to complete the full implementation of the CSME. The removal of remaining barriers to intraregional trade, for example, must be among the priorities. The regime of free movement of skills and persons is how our citizens gauge the effectiveness of integration. The implementation of the agreed-on expansion of categories of skilled workers would help to promote a deeper sense of belonging among our citizens," he said.

Ambassador LaRocque added that in order to urgently advance CSME implementation, the COTED had to be "more strategic and senior officials need to meet more often in order to resolve the issues that keep recurring on the agenda among other things."

HEIGHTENED CHALLENGES

Jamaica Minister of Foreign Affairs and Foreign Trade, Senator Kamina Johnson-Smith is chairing the two-day Ministerial. She alluded to the period of heightened challenges in which the COTED was being held. She cited the economic stress occasioned by the COVID-19 pandemic, vaccine inequity, vulnerability to negative impacts of Climate Change and natural disasters and the devastating effects of the eruption of La Soufrière volcano in St. Vincent and the Grenadines.

"In the face of these realities, the imperative of focused recovery is clear. We must ensure that our collective efforts to empower our citizens and continue the process of



transforming our Community through trade and development opportunities. We owe this to future generations," Minister Johnson-Smith

She also referred to the mixed fortunes of the CSME and pointed out that there was room for "much improvement" in the rate of its implementation.

The discussions will include focus on the CSME; matters related to trade in goods; the implementation of the Multilateral Air Services Agreement and developments at the World Trade Organisation (WTO). Minister Johnson Smith announced that new Director-General of the WTO, Ngozi Okonjo-Iweala, will join delegates on Wednesday for discussions on pressing issues on the multilateral trade front. The Director-General will also provide her perspective on access to vaccines" a matter that is clearly a vexed one", the COTED Chair said.

A Meeting of trade officials in early May laid the groundwork for the Ministerial session.

Secretary-General hails CARICOM FIFA MOU

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Tuesday, 1 June 2021) -Secretary-General of the Caribbean Community (CARICOM) Ambassador Irwin LaRocque has hailed the signing of an MOU between CARICOM and FIFA as opening avenues to positively impact the lives of youth within the

Ambassador LaRocque and FIFA's President Mr. Gianni Infantino signed the memorandum in a virtual ceremony, Monday. It creates a framework for further collaboration between football's world government body and CARICOM on the development of football in the Community's Member States.

The Secretary-General said the genesis of the project came with the visit by Mr. Infantino to the CARICOM Secretariat in 2017. He noted that the MOU aligns with CARICOM's endorsement of sport as a development tool to promote positive ideals in individuals, including the inculcation of healthy lifestyles, positive use of leisure time, development of tolerance and the promotion of peace.

"The universal popularity of football gives it a unique position to play its part in assisting in that regard," he noted.

Mr. Infantino noted that FIFA had provided substantial assistance to the Football Associations of Member States of CARICOM to assist with the challenges posed by Covid-19 among other areas. He said he looked forward to working with CARICOM in ensuring that the game in the region was free of discrimination and safe for the children and youth to enjoy.

The President of CONCACAF Mr. Victor Montagliani praised the thrust of the MOU and thanked FIFA for its support.

Regional football legend Russel Latapy endorsed the programmes outlined in the MOU and emphasised that the sport must provide a safe environment for the children and youth who played the game.

The ceremony was witnessed by the Minister of Sport of Guyana, Ambassadors to CARICOM and the Presidents of the National Football Associations of CARICOM Member States.

The MOU will provide institutional support for the strengthening of a football programme for the physical education curricula in primary schools within the CARICOM Region. It will develop and train Physical Education teachers in football coaching and management, through FIFA Member Associations in CARICOM.

It is also expected to build on previous work by CARICOM, including "Reducing Youth on Youth Violence in Schools and Communities" and the "Youth Empowerment through Sports" projects.

Harris Emphasizes Addressing 'Root Causes' of Migration

U.S. Vice President Kamala Harris stressed the importance of fixing the "root causes" of migration in her final remarks during a trip to Mexico and Central America to address the surge of migrants at the southwestern U.S. border.

"I want to be very clear that the problem at the border in large part, if not entirely, stems from the problems in these countries," Harris told reporters Tuesday evening.

"I cannot say it enough: Most people don't want to leave home. And when they do, it is usually for one of two reasons: either they are fleeing harm or to stay home means they cannot satisfy the basic needs of their families."

Harris underscored conversations she had with Guatemalan officials in which agreements were struck for the U.S. to fund projects that root out corruption, strengthen the rights of laborers and farmers, empower young women and more.

Earlier Tuesday, Harris met with Mexican President Andres Manuel Lopez Obrador in Mexico City to discuss bolstering economic conditions in Central America.

When asked by a reporter whether the U.S. made specific commitments to increase legal pathways to migration, including work permits, Harris said there were discussions but "no promises" were made.

Harris and Lopez Obrador watched as aides signed a "memorandum of understanding" to "establish a strategic partnership to cooperate on development programs in the Northern Triangle" countries of Guatemala, El Salvador and Honduras.

Tens of thousands of their citizens have left home to trek through Mexico to try to get into the United States in recent months, with more than 178,000 migrants reaching the U.S. border in April, nearly half from Central America.

Harris had a blunt message Monday for Latin American migrants as she visited Guatemala: "Do not come." She said the U.S. was "not afraid" to enforce its immigration laws and stop people at the border.

However, U.S. President Joe Biden has allowed unaccompanied migrant children to stay in the United States, unlike former President Donald Trump, who expelled them.

López Obrador, responding to a shouted question from a reporter whether Mexico was willing to increase its immigration enforcement, said he and Harris "will be touching on that subject, but always addressing the fundamental root causes" of the surge in migrants.

Harris, according to her spokeswoman, told the Mexican leader in their private talks that the U.S. will make new efforts to increase economic investment in southern Mexico, including loans for affordable housing.

In addition, the U.S. has committed about \$130 million over the next three years to support workers and labor reforms. Harris told Lopez Obrador the U.S. would provide more forensic and law enforcement training in Mexico to help resolve more than 82,000 cases of missing persons and disappearances, a key concern for the Mexican leader.

After meeting with Lopez Obrador, Harris is talking with female entrepreneurs and holding a roundtable with labor workers.

Ricardo Zúñiga, U.S. special envoy for the Northern Triangle, told reporters ahead of Tuesday's meetings that the United States and Mexico "have not had this level of cooperation in Central America before."

"The main thing is that it's very important to show that the United States and Mexico are collaborating and trying to improve conditions on the ground among our neighbors because of the importance that the countries in Central America have for both of us," Zúñiga said. "We're both destination countries for migration from Central America, and we both have some of the same issues trying to ensure that we have legal paths for migration and temporary labor."

Harris' talks in Mexico were similar to those in Guatemala, where she emphasized "the power of hope" along with new efforts to fight corruption.

"I am here because the root causes are my highest priority in terms of addressing the issue, and we need to deal with it, both in terms of the poverty we are seeing, the hunger that we are seeing, the effects of the hurricanes and the extreme climate conditions, what we are seeing in terms of the pandemic," Harris told reporters.

Harris' trip is fraught with U.S.

political implications, though, as Republicans blame Biden and Harris for the surge in migrants trying to cross the country's southwestern border with Mexico

At a news conference in Guatemala City, Harris deflected a question about when she would visit the border, even though she has said she would at some point.

Senate Passes Bill to Boost US Tech Industry, Counter Rivals

The Senate overwhelmingly approved a bill Tuesday that aims to boost U.S. semiconductor production and the development of artificial intelligence and other technology in the face of growing international competition, most notably from China.

The 68-32 vote for the bill demonstrates how confronting China economically is an issue that unites both parties in Congress. That's a rarity in an era of division as pressure grows on Democrats to change Senate rules to push past Republican opposition and gridlock.

The centerpiece of the bill is a \$50 billion emergency allotment to the Commerce Department to stand up semiconductor development and manufacturing through research and incentive programs previously authorized by Congress. The bill's overall cost would increase spending by about \$250 billion with most of the spending occurring in the first five years.

"The premise is simple — if we want American workers and American companies to keep leading the world, the federal government must invest in science, basic research and innovation, just as we did decades after the Second World War," said Senate Majority Leader Chuck Schumer.

"Whoever wins the race to the technologies of the future is going to be

the global economic leader, with profound consequences for foreign policy and national security, as well," he added.

Senate Minority Leader Mitch McConnell said the bill was incomplete because it did not incorporate more Republican-sponsored amendments. He nonetheless supported it.

"Needless to say, final passage of this legislation cannot be the Senate's final word on our competition with China," he said. "It certainly won't be mine."

President Joe Biden applauded the bill's passage in a statement Tuesday evening, saying, "As other countries continue to invest in their own research and development, we cannot risk falling behind. America must maintain its position as the most innovative and productive nation on Earth."

Senators slogged through days of debates and amendments leading up to Tuesday's final vote. Schumer's office said 18 Republican amendments will have received votes as part of passage of the bill. It also said the Senate this year has already held as many roll-call votes on amendments than it did in the last Congress when the Senate was under Republican control.

While the bill enjoys bipartisan support, a core group of Republican senators has reservations about its costs.

One of the bill's provisions would create a new directorate focused on artificial intelligence and quantum science with the National Science Foundation. The bill would authorize up to \$29 billion over five years for the new branch within the foundation, with an additional \$52 billion for its programs.

Senator Rand Paul said Congress should be cutting the foundation's budget, not increasing it. He called the agency "the king of wasteful spending." The agency finances about a quarter of all federally supported research conducted by America's colleges and universities.

"The bill is nothing more than a big government response that will make our country weaker, not stronger," Paul said.

Supporters described it as the biggest investment in scientific research that the country has seen in decades. It comes as the nation's share of semiconductor manufacturing globally has steadily eroded from 37% in 1990 to about 12% now, and as a chip shortage has exposed vulnerabilities in the U.S. supply chain. Cantwell noted that a greater federal investment in the physical sciences had been called for during the administration of President George W. Bush to ensure U.S. economic competitiveness.

"At the time, I'm pretty sure we thought we were in a track meet where our competitor was, oh, I don't know, maybe half a lap behind us. I'm pretty sure now as the decade has moved on, we're looking over our shoulder and realizing that the competition is gaining," said Cantwell, chair of the Senate Commerce, Science and Transportation Committee.

The lead Republican on the committee also weighed in to support the bill.

"This is an opportunity for the United States to strike a blow on behalf of answering the unfair competition that we are seeing from communist China," Senator Roger Wicker said.

Senators have tried to strike a balance when calling attention to China's growing influence. They want to avoid fanning divisive anti-Asian rhetoric when hate crimes against Asian Americans have spiked during the coronavirus pandemic.

Other measures spell out national security concerns and target money-laundering schemes or cyberattacks

by entities on behalf of the Chinese government. There are also "Buy America" provisions for infrastructure projects in the U.S.

Senators added provisions that reflect shifting attitudes toward China's handling of the COVID-19 outbreak. One would prevent federal money for the Wuhan Institute of Virology as fresh investigations proceed into the origins of the virus and possible connections to the lab's research. The city registered some of the first coronavirus cases.

It's unclear whether the measure will find support in the Democratic-led House, where the Science Committee is expected to soon consider that chamber's version. Congressman Ro Khanna, who has been working with Schumer for two years on legislation that's included in the bill, called it the biggest investment in science and technology since the Apollo space flight program a half century ago.

"I'm quite certain we will get a really good product on the president's desk," Schumer said.

Biden said he looked forward to working with the House on the legislation, "and I look forward to signing it into law as soon as possible."

Croal caps national sprint double with 200m personal best By Dean "The Sportsman" Greenaway

Talent Ex's Jaleel Croal capped off a national championships sprint double with a 200m personal best on Saturday, as he pulled Sprint Tech's Wanyaé Bell and Top Notch's Khybah Dawson under the 22.00 second barrier, marking the first time in the 50-year BVI track and field history, that three athletes have run in the 21 seconds range in the same race.

Croal covered the half lap in 21.14 seconds (-1.2 mps), lowering his 2019 best from 21.20. Bell shaved his personal best from 21.85 seconds to 21.81, with Dawson—coming off a lifetime 7.39m (24'3") Long Jump (-3.0) best—placing third in 21.92, after a personal best 21.71 (-0.7) in the semis. Dawson, a 2019 Carifta Games U17 Boys Long Jump silver medalist, improved his mark from 7.36m

"I'm elated right now. I feel like I proved myself, because a few weeks back, I ran that same time and got disqualified because I false started," Croal who won the 100m in 10.64 seconds (-0.6) on Friday night after an 11.24 semi, reflected after the race. "Now that I've run it again, I feel like I proved myself that I can do anything right now." Teammate Mikkel Bassue

followed Croal in the 100m in 10.77, with Bell third in 10.82

While he didn't have external competitions because of Covid, Croal said his competitors—Bell, Dawson, Vadley Sylvester, Mikkel Bassue, Malik John and K'Cei Moses—have been improving which makes him push even harder. He noted that they're stepping up to his level which he really enjoys and would like to travel with them abroad for competition.

"K'Cei has been a good training partner and hasn't been out because of injuries," Croal said. Khybah, he makes me punk out of the 400. He's a very good runner. I just feel he's better than me and I just come out there and show my heart and get the race done."

Bell said he was a bundle of nerves in the 200m final. "It was nerve racking," he said. "I wanted to win the race but I knew I had good athletes in my range.

Dawson said he thought that he would have run faster but he was also thinking that he had to do rehab and therapy as it was his first race back from an injury. "I was ready for the competition and being back with these guys," he said.

Other Highlights

In his first race after establishing an 800m National Youth Record, Jahshani "Jahferre" Farrington, won his specialty in the rain, covering the circuit in 2 minutes, 02.47 seconds. "It was drastic, having to run, wipe your eyes and breathing, it was slowing you down," Farrington, who ran in the rain for the first time said. "It was tiring at the end. I wanted to try the same strategy as the last time, but this was really tiring. I really worked hard for this one."

Virgin Gorda's Kaelyaah "Kae" Liburd, became the 10th BVI female under 55.00 seconds, when she dropped 54.93 on the board in the 400m, landing at No 9 on the All Time List. In the process, she turned back 2019 Carifta Games U17 Girls silver medalist Akrisa Eristee, who was second in 56.54.

Why 84 countries are borrowing from the IMF

In the wake of the economic damage done by the effects of the COVID-19 pandemic, countries in every continent of the world have turned to the International Monetary Fund (IMF) for assistance.

It is right that they have done so. The IMF exists to provide economic and financial support to countries when other options have been extinguished. The pandemic brought countries to that situation in rapid time, particularly tourism dependent countries which were the hardest hit.

In some countries, there is an ideological resentment of the IMF. That resentment is based on past harsh conditionalities that the Fund included in the terms of its loans to countries already in desperate straits. That resentment should be re-evaluated. IMF conditionalities still exist, but they are more geared to recognising the breathing space governments require to get their countries' economies performing at an optimum level. The Fund wants to be repaid, so that, in turn, it can pay back the banks, governments and institutions from which it borrows to supplement its lending resources.

While the main source for IMF loans on nonconcessional terms are provided by member countries, through their quota payments, the Fund also borrows money that it lends. Of the IMF's current total resources for lending, amounting to about US\$1 trillion, a significant portion is money that must be repaid.

If the IMF fails to service its loans, the entire world will lose an extremely important pillar of the global financial architecture, resulting in infectious economic instability and, eventually, political chaos and civil strife.

Consequently, like any lender, the IMF has to make sure that borrowing countries will be able to repay. It sets terms - called conditionalities to ensure that the best use is made by borrowers of the money they are advanced, and that loans can be repaid.

Presently, IMF loans are on more generous terms than they used to be. For instance, financing for approved medium term growth and development strategies could be secured with a repayment period of 14 years, a 4-year moratorium and an interest rate of 1 per cent. Loans of this nature are not available from any other source.

Of course, negotiating the best conditionalities is important. This is not the time to lay-off public sector workers, especially in countries where employment in the private sector has declined disastrously because of the COVID-19 pandemic. The IMF Executive Board and Management are aware of that and have adopted policies that are more open to support for vulnerable groups than they were in the past.

What is more, approval by the IMF to fund a programme opens the door to borrowing from other financial institutions, and to rescheduling debt with agencies such as the Paris Club. These institutions, including the Caribbean Development Bank, regard the imprimatur

of the IMF as crucial in determining a country's creditworthiness.

In the present global economic crisis, 84 countries have already taken advantage of the IMF's lending to the tune of US\$109,594.38 million. Of those countries, eight are CARICOM states, namely: Bahamas, Barbados,

Dominica, Grenada, Haiti, Jamaica, St Lucia and St Vincent and the Grenadines which have borrowed US\$842 million. Eleven Latin American countries, including Honduras, Costa Rica, Panama, Peru, Ecuador and Nicaragua, have borrowed US\$66,677.46 million.

Those, who argue against the IMF on ideological grounds, should have alternative sources of financing to propose. Either they must show a clear path to the capacity of their countries to recover and prosper from renewed and sustainable economic activity, or they must identify cheaper sources of borrowing with less strenuous terms. If they cannot identify such possibilities in a realistic way, then the only alternative to borrowing from the IMF is to leave their economies to languish, running out of money and failing to provide goods and services that their people expect.

The current economic conditions, across the CARICOM states except for Guyana, and possibly St Kitts-Nevis and Trinidad and Tobago, require pragmatism and practicality in recognising that working with the IMF has value.

There is no shame in going to the IMF to borrow in the current climate. It is a necessity, particularly when other options have dried-up. Further, the IMF is fulfilling the role for which it was created – to lend when other options are closed. The anti-IMF ideological argument is one that cuts off your nose to spite your face. It makes little sense.

In the current crisis, political parties and others that try to discredit governments because they opt to borrow from the IMF, ignore two salient points. First, governments are not now constrained to approach the IMF because of any failed policies they pursued; they approach the IMF because the devastating effects of the pandemic forced them there. And, second, the IMF is a lender of last resort. Governments contract with the IMF because the economic circumstances of their countries are such that they must borrow to sustain their populations. and, in those conditions, where better than the institution that provides the cheapest lending.





COVID-19 UPDATE AND ADJUSTING COVID-19 PUBLIC HEALTH MEASURES TO SUPPORT CONTINUED SAFE REOPENING

STATEMENT BY HONOURABLE CARVIN MALONE MINISTER FOR HEALTH AND SOCIAL DEVELOPMENT

JUNE 10TH 2021

I extend greetings to everyone in the Virgin Islands and to those joining us by radio and other social media platforms.

As Minister for Health and Social Development I pledged to continually keep you abreast of new developments as we continue to live and thrive in this COVID-19 era. Yes! I said thrive! We certainly recognise that COVID-19 does not appear to be going anywhere! So the reality is we have to live; we have to work; we have to exist and now we must continue to thrive in spite of this dreadful virus.

As of today, 10th June, 2021 a total of 52,480 tests were conducted on individuals swabbed throughout the Territory and assessed at the Dr. D. Orlando Smith Hospital. The Virgin Islands has recorded a total of 295 cases, with 291 recoveries and 1 death. There are presently 3 active positive cases in the Territory -- one of which was captured on their day 7 screening and the other 2 are contacts of this case. All remaining positive cases are presently located on the island of Tortola. The Public Health Unit Team continues to monitor all positive cases closely and these persons will remain in mandatory quarantine until they are deemed fully recovered.

I continue to say, and I must say here again, "We are not out of the woods yet!" When we listen or read the news accounts of what is happening in our sister nations like Trinidad and Tobago and even Jamaica, we see firsthand that the COVID-19 pandemic is still REAL in several parts of the world, including our own Caribbean region. This pandemic continues to accelerate causing rising death tolls as health systems and economies near and far continue to buckle under the strain of this deadly disease. While we remain grateful for the way God has been gracious to this Territory in allowing us to still be speared the ravages of COVID-19, we must also remain vigilant and mindful that it only takes one unknown carrier to impact from 10 to more than 70 individuals over a short time span. Our own experiences over the last year has shown where one carrier was linked to some 36 cases soon after. Let us take nothing and no one for granted! Remember COVID-19 has no name tag!

As we continue our phased reopening of the BVI to

international travelers, we must remain fully aware of the realities around us. We cannot be paralysed with fear - but at the same time we have to take stock of the real possibilities that can happen when COVID-19 is able to get past the stop gaps put in place for the safety of ourselves, our families and our Territory that we love so dear. Our preventative measures such as washing of hands, wearing of mask and staying an appropriate distance away from persons cannot be forgotten or placed on the back burner. We MUST observe all safety PROTOCOLS if we are to remain safe from the ravages of this virus!

Let me now pivot to the statistics related to the vaccine rollout.

In previous reports, I informed of the 34,000 doses of vaccines which were donated to the British Virgin Islands by the United Kingdom Government. We had anticipated that 17,000 persons would be able to have free access to two doses of vaccines per person.

To date, 12,245 persons have received their first doses, while 7,289 have received their second doses. An analysis of these totals shows that:

On Tortola, 10,217 first doses and 6,217 second doses have been administered to date:

On Virgin Gorda 1,815 first doses and 974 second doses were administered;

On Jost Van Dyke 98 first doses and 50 second doses were administered; and

On Anegada 115 first doses and 48 second doses were administered to date.

I was hoping by now that our first dose numbers would be significantly higher; at least in the 15,000 persons range (a mere 2000 persons away from our 17,000 goal). But we are not there yet! There is still some ways to go, but the reality is time is not on our side! The current stocks of vaccines we have available in the Territory are set to expire by July 31, 2021. That means in order for us to effectively use the vaccines in stock, persons still expected to receive their first dose can do so no later than July 3, 2021. This would give a 4 week time frame between the first and second dose.

Again, I must appeal to all residents and stakeholders in this Territory, who are eagerly anticipating a measured yet unrestricted reopening of all our borders; we MUST take this

vaccine roll out seriously! Despite the growing voices of dissent to the vaccine - not only in the BVI, but throughout the Region and the World, the vaccine is literally the only viable assurance of returning to some level of normalcy. If we as a Territory can achieve the herd immunity we hear so much about, we must have a greater uptake in the vaccine. And the fact is, what we have available will soon expire! Your Government has done all that we can to prepare and prevent this disease from impacting us all. We must each now take personal responsibility for the lives and livelihoods of ourselves, our family members and for us as an entire Territory.

We are pleased to welcome professor Ian Cumming of Public Health England to the Territory as he conduct an assessment of our COVID-19 measures and offer recommendation not only for laboratory improvements but also of his experience as he travels throughout the British Overseas Territories.

Health Emergency The Operations Centre (HEOC) and the Public Health teams continue to monitor the COVID situation as it unfolds and proposes strategies to help mitigate the impact of the pandemic on our Territory. At a Cabinet Meeting held yesterday Wednesday the 9th of May, the HEOC team proposed additional adjustments to our COVID-19 public health measures to support the continued safe reopening of the Territory. Several changes were suggested and approved by Cabinet allowing additional amendments to entry requirements, particularly for vaccinated travellers.

I am pleased to provide this update on the subsequent changes which are expected to take effect by June 15th 2021.

Cabinet has decided that fully vaccinated persons travelling from overseas would be required to provide an RT-PCR test or an approved rapid antigen test within five (5) days of arrival and provide satisfactory evidence of being fully vaccinated.

Cabinet further decided that fully vaccinated travellers would no longer be subject to PCR testing on arrival (day zero) and resultantly NO quarantine time would be required save for that ordered by a Quarantine Officer as a result of their entry screening.

In addition, effective June 15, 2021, Cabinet decided that partially vaccinated persons travelling from overseas would require a PCR test within (5) days of travel; provide satisfactory evidence of being partially vaccinated, and will be subject to a PCR test or rapid antigen test upon arrival in the Territory (day zero) and quarantined for a period of four (4) days.

In light of these decisions, Cabinet further decided that the Gateway administrative fee be reduced from \$105.00 to no more than thirty-five dollars (\$35) for fully vaccinated travellers.

For flight and vessel crews who are fully vaccinated, Cabinet decided that these persons would no longer be required to conduct bi-weekly screening and testing, but should self-monitor and report any symptoms of or recent exposure to COVID-19.

For the record, I think it is important to emphasis that these decisions will take effect from June 15, 2021. All things being equal, we anticipate that the revision of the entry portal to effect these changes will be a work in progress. We therefore ask travellers to be patient with us as we anticipate there will be processing issues in light of these amendments. Safety must remain our first priority for this Territory and we crave your indulgence during this period.

Decisions taken and reported during my last presentation on May 13th still remain in effect. Let me highlight these again for the benefit of everyone:

1. Where fully vaccinated persons are travelling with one or more unvaccinated child:

Children aged 5-17 will be tested on arrival;

Children will remain with their fully vaccinated parents/guardians while awaiting their test results.

Unvaccinated children will be required to return to a testing centre and be subjected to a further test on day four.

2. The quarantine period for unvaccinated travellers has been extended from four (4) days to seven (7) days. This still remains in effect.

3. Where people are traveling with mixed groups with some individuals unvaccinated, the party of unvaccinated individuals will be expected to be quarantined for 7 days upon arrival. The exemptions recently approved will only apply to the vaccinated persons in that party.

The recent decisions taken by Cabinet will also effect some additional changes particularly for 'outgoing day trippers'. Persons who now wish to travel to the US Virgin Islands, St. Maarten, or

Puerto Rico for any period, as long as they are fully vaccinated, would no longer be required to take a PCR test seven days after returning to the Territory. However, children aged 5 to 17 travelling with their parents on the day trip will be required to take a RT-PCR test 7 days from their travel.

As a result of these decisions, the Premier will soon be announcing further measures that will be put in place that will continue to strengthen our tourism industry and by extension our economy, while balancing lives and livelihoods.

As we continue to live, work and thrive in this COVID-era, I will continue to sound the alarm that vaccination is our best defense against this pandemic. And as the decisions announced today would have shown, there will be benefits derived for persons fully vaccinated; even for persons living in and visiting these islands. I will continue to reiterate the fact that new, more aggressive strains continue to emerge, as the virus mutates and spreads rapidly from one region to another, increasing the risk of severe illness and death. The reality is none of us know how the virus will affect us. We simply must be vigilant and do the next best thing, get VACCINATED! Protect yourself, your loved ones and our economy! Remember VIGILANCE now more than ever! We cannot let our guards down! Can we reopen - YES we can! Gradually with all the necessary and precautionary protocols measures!

Will we reopen? – YES we will! With the support and diligence of you the PEOPLE! Must we reopen? – YES we must! Our livelihoods depend on it!

Again, let me remind you – wash your hands! Wear your masks! Cover your coughs and sanitise your surfaces as often as you must! Also, keep your distance! May the grace and mercy of God continue to watch over this little Territory as we continue to traverse these waters! Let us all continue to do our parts! God blessings on the citizens and residents of these Virgin Islands. I thank you for listening!

G-7 Nations Reach Historic Deal to Tax Big Multinationals

LONDON - [VOA - Reuters] - The United States, Britain and other leading nations reached a landmark deal Saturday to pursue higher global taxation on multinational businesses such as Google, Facebook, Apple and Amazon.

In a move that could raise hundreds of billions of dollars to help governments cope with the aftermath of COVID-19, the Group of Seven (G-7) large, advanced economies agreed to back a minimum global corporate tax rate of at least 15%. Companies will also have to pay more tax in the countries where they make sales.

"G-7 finance ministers have reached a historic agreement to reform the global tax system to make it fit for the global digital age," Britain's Chancellor of the Exchequer Rishi Sunak said after chairing a two-day meeting in London.

The meeting, hosted at an ornate 19th-century mansion near Buckingham Palace in central London, was the first time finance ministers have met face to face since the start of the pandemic. U.S. Treasury Secretary Janet Yellen said the "significant, unprecedented commitment" would end what she called a race to the bottom on global taxation.

German Finance Minister Olaf Scholz said the deal was "bad news for tax havens around the world," adding: "Companies will no longer be in a position to dodge their tax obligations by booking their profits in the lowest-tax countries."

Lengthy fight

Rich nations have struggled for years to agree on a way to raise more revenue from large multinationals, which can pay little tax on the billions of dollars of sales they make in countries around the world, draining public finances.

U.S. President Joe Biden's administration gave the stalled talks fresh impetus, however, by proposing a minimum global corporation tax rate of 15% to deter companies from booking profits elsewhere.

The 15% is above the level in countries such as Ireland but below the lowest level in the G-7. Amazon and Google welcomed the agreement, and Facebook said it would likely pay more tax.

Nick Clegg, Facebook's vice president for global affairs and a former British deputy prime minister, said: "We want the international tax reform process to succeed and recognize this could mean Facebook paying more tax, and in different places."

But some campaign groups condemned what they saw as a lack of ambition.

Broader support

The deal, years in the making, also promises to end national digital services taxes levied by Britain and other European countries, which the United States said unfairly targeted U.S. technology giants.

But the measures will first need to find broader support at a meeting of the G-20 which includes a number of emerging economies scheduled for next month in Venice

"It's complicated and this is a first step," Sunak said. Countries still must agree upon which big companies will be covered and how governments will divide up the tax revenue.

Germany, France and Italy welcomed the tax agreement, although French Finance Minister Bruno Le Maire said he would fight for a higher global minimum corporate tax rate than 15%, which he described as a "starting point."

Campaign groups such as international development charity Oxfam also said the minimum tax rate should be much higher.

"They are setting the bar so low that companies can just step over it," Oxfam's head of inequality policy, Max Lawson, said. But Irish Minister for Finance Paschal Donohoe, whose country is potentially affected because of its 12.5% tax rate, said any global deal also needed to take account of smaller nations.

Sunak said the deal was a "huge prize" for taxpayers, but it was too soon to know how much money it would raise for Britain. The agreement does not specify which businesses will be covered by the rules, referring only to "the largest and most profitable multinational enterprises."

Some European countries have feared that a business such as Amazon could slip through the net as it reports lower profit margins than most other well-known technology companies.

Ministers also agreed to move toward making companies declare their environmental impact in a more standard way so investors can decide more easily whether to fund them, a key goal for Britain.

The G-7 includes the United States, Japan, Germany, Britain, France, Italy and Canada.

New US\$50 billion health, trade and finance roadmap to end the pandemic and secure a global recovery

Heads of International Monetary Fund (IMT), World Bank Group (WB), World Health Organization (WHO) and World Trade Organization (WTO) issue extraordinary call for financing actions by government leaders to accelerate end to COVID-19 pandemic.

IMF, WB, WHO and WTO principals call for US\$50 billion investment to generate US\$9 trillion in global economic returns by 2025 and boost manufacturing capacity, supply, trade flows and the equitable distribution of diagnostics, oxygen, treatments, medical supplies and vaccines.

Call to action by this quadrilateral grouping comes at a perilous point in the pandemic and as the historic World Health Assembly concludes, G7 meetings commence, and follows the G20 Global Health Summit.

Doses need to be donated immediately to developing countries, synchronized with national vaccine deployment plans, including through COVAX, which is co-led by CEPI, Gavi and WHO, alongside key delivery partner UNICEF.

The heads of the world's predominant global financing, health and trade agencies have united to urge government leaders to urgently finance a new US\$50 billion roadmap to accelerate the equitable distribution of health tools to help end the pandemic that has devastated lives and livelihoods for 18 months and also set the foundations for a truly global recovery, as well as enhanced health security.

In a statement published by newspapers around the world, the leaders of the International Monetary Fund, World Bank Group, World Health Organization and World Trade Organization [Kristalina Georgieva, Tedros Adhanom Ghebreyesus, David Malpass and Ngozi Okonjo-Iweala] said governments must act without further delay or risk continued waves and explosive outbreaks of COVID-19 as well as more transmissible and deadly virus variants undermining the global recovery.

Leaders of the four agencies said: "By now it has become abundantly clear there will be no broad-based recovery without an end to the health crisis. Access to vaccination is key to both."


The joint statement draws on a recent IMF staff analysis, which stated that US\$50 billion in new investment is needed to increase manufacturing capacity, supply, trade flows, and delivery, which would accelerate the equitable distribution of diagnostics, oxygen, treatments, medical supplies and vaccines. This injection would also give a major boost to economic growth around the world.

"At an estimated US\$50 billion, it will bring the pandemic to an end faster in the developing world, reduce infections and loss of lives, accelerate the economic recovery, and generate some US\$9 trillion in additional global output by 2025, "said the leadership.

Commercial Lab Tests vs Genetic Counseling

DEAR DR. ROACH: I have a daughter (almost 31 years) who is concerned about Charcot-Marie-Tooth syndrome. Her maternal grandmother has been diagnosed with that condition. She is interested in seeking out a genetic test for the condition to learn if she is susceptible. She was referred to a commercial, direct-to-consumer laboratory for the test.

How likely is it that a lab test for this specific condition would be accurate? Should she be doing all of this through either a particular type of genetics counselor or her private physician (internist) rather than an independent effort? — R.C.

ANSWER: Charcot-Marie-Tooth disease is the eponym given to a family of hereditary motor sensory neuropathies: diseases that affect the nerves that carry the impulses necessary for movement and sensation. The initial symptoms are most commonly weakness and atrophy in the feet, followed by similar problems in the hands and sensory changes.

The diagnosis may be made by EMG testing (electromyography, a needle study of the electrical activity of the muscles), but genetic testing is another way of making the diagnosis. If her grandmother has a known mutation, then genetic testing is likely to give her confirmation of her own status.

Commercial genetic testing is certainly available, and probably accurate. However, I would still recommend a visit to a genetic counselor. This may require a referral from her primary-care doctor. The correct test to order, and its interpretation, depends on the exact diagnosis of her grandmother's condition, since there are many genetic variations of Charcot-Marie-Tooth. It is likely that your daughter will have questions after the test results, and the benefit of having an experienced clinician there to answer them would be invaluable.

DEAR DR. ROACH: I'm an 81-year-old man. About two years ago, I began to realize that my testicles were shrinking, and they are now about the size of a marble. I have asked my primary care doctor and urologist about this, and the reply is that nothing can be done about it.

I have read that boxer shorts are recommended to keep the testicles cooler and healthier. I am wondering whether my extensive time sitting at a desk and reading could be related to my shrinking testicles. Or is it related to erectile dysfunction, which is caused by decreased blood flow? I have ED. My last testosterone result was about 500. Is there nothing that can be done, not even any exercises? —L.D.

ANSWER: The medical term for what's happening to you is "testicular atrophy," and it has several possible causes. Age alone is one: At age 81, many men have noticed some shrinkage in testicular size, but yours is beyond the norm. You are right that cooler temperatures are healthier for the testicles, but again, I am a little surprised by the severity of your description.

Among the other common causes are a history of trauma or infection. However, any underlying cause can also affect the ability of the testicles to make testosterone. Your blood testosterone level is surprisingly normal for your age (400-500 is the average for a man in his 80s). A low testosterone is a common cause of erectile dysfunction (poor blood flow is only one cause of ED).

After two years, it is very unlikely that any treatments will affect the testicles now, unfortunately.

WHO supports people quitting tobacco to reduce their risk of severe COVID-19


Geneva, (WHO)— The World Health Organization's 'Commit to Quit' tobacco campaign has made resources from its Quitting Toolkit freely available to more than a billion tobacco users, less than 5 months into the year-long campaign.

WHO launched the campaign to support those millions of tobacco users who are actively taking steps to save their lives, but still need help to succeed.

The campaign is currently working directly with 29 focus countries. Each country agreed with WHO on selected activities, including, running national awareness campaigns, re-

leasing new digital tools, revising policies, engaging youth, training health workers, opening new cessation clinics, supporting nicotine replacement therapies through WHO partners, establishing national toll-free quit lines, making quitting courses available, and more.

"Smokers have up to a 50% higher risk of developing severe disease and death from COVID-19, so quitting is best thing smokers can do to lower their risk from this coronavirus, as well as the risk of developing cancers, heart disease and respiratory illnesses," said Dr Tedros Adhanom Ghebreyesus, WHO Director-General.

The Quit Challenge gives daily notifications of tips and encouragement for up to 6 months to help people remain tobacco free. It is available for free on WhatsApp, Viber, Facebook Messenger and WeChat.

Globally, roughly 39% of men and 9% of women use tobacco. The highest smoking rates are currently found in Europe at 26%, with projections only showing a 2% decrease by 2025 if urgent government action is not taken.




It echoes economic analysis by the International Chamber of Commerce; and the Eurasia Group - both of which make the case for a relatively modest investment by governments in comparison to the trillions spent on national stimulus plans and lost trillions in foregone economic output. But the critical element of this is that it effectively spurs global vaccination and bridges the equity gap.

"Increasing our ambition and vaccinating more people faster: WHO and its COVAX partners have set a goal of vaccinating approximately 30% of the population in all countries by the end of 2021," said the four leaders. "But this can reach even 40% through other agreements and surge investment, and at least 60 percent by the first half of 2022."

Governments are urged to act on the investment opportunity to boost supplies of vaccines, oxygen, tests and treatment. The IMF, WBG, WHO and WTO leaders issued their joint statement as the World Health Assembly drew to a conclusion and a round of G7 meetings were set to start, beginning with a Finance Ministers convening later this week, and following a Global Health Summit co-hosted by the EU and Italy, which chairs the G20.

"To urgently get more shots in arms, doses need to be donated immediately to developing countries synchronized with national vaccine deployment plans, including through COVAX," said the four leaders. "Cooperation on trade is also needed to ensure free cross-border flows and increasing supplies of raw materials and finished vaccines"
