### NEW BILLS OPEN THE DOORS TO REMOTE GOVERNMENT SERVICES

The BVI's longstanding e-government dream that spans two administrations got a major nudge as the House of Assembly passed various pieces of legislation geared at facilitating remote government services, with emphasis on legislation enabling online payments. These new bills facilitate payments without long queues whether you pay from the Virgin Islands or any other location on earth.

During the debate of one of the bills in the suite titled "Electronic Filing Act", Premier Hon. Andrew Fahie explained that the legislation is crucial to helping government move swiftly towards e-government.

As he debated the Electronic Filing Act, the Premier explained that the suite of Bills will not only protect but also create the framework for which business in the Territory will be able to be done electronically: "This Electronic Filing Act Bill seeks to provide use for electronic records and documents during transactions with public authorities. It would provide



flexibility for public authorities to design electronic forms suited for online transactions hence improve the customer's overall e-government experience."

As it specifically relates to the Electronic Filing Act, the Premier said: "This Bill will add value to doing business with the government making the entire Territory, as well as the private sector, more effective, more efficient."

He said that effectiveness and efficiency lead to more revenue, and as a result, the Premier spoke favorably of economic activities that would arise from such legislation: "We are talking about overall transactions here in the Virgin Islands and how do we begin to allow persons to use to pay water bills with the government in terms of the public sector or to pay their Inland revenue taxes. Whether it's to pay Social Security or whether it is to pay any bill that is associated with government... knowing that this now will allow us to be able as a people to have a paradigm shift in the way government does business," the Premier declared.

The BVI Leader spoke about the possibilities that would arise from this legislative undertaking. "This will revolutionize the way government does business. It is long in coming but it is still within its time. Persons don't have to be or have to come to Road Town or Tortola to pay a bill. You can stay whether it is West End, Belle Vue, East End, Carrot Bay, Cane Garden Bay or you can stay even in Jost Van Dyke. You can stay in Anegada, you can stay from Virgin Gorda, you can stay on Camanoe once the signal is up with the internet and any other island or islet in the BVI or the world and

actually do business with the government."

Hon. Fahie explained that the suite of bills enables payment as well as documenting access and filings. "Get documents downloaded and filled out and also have them submitted," the Premier noted.

Data protection is a major factor and consideration to such a service and Premier Fahie said that Government has made efforts to address this matter: "This is quite innovative, even to the point where the old Data Protection that we did ...works (like) hand in glove even with the information system that we are putting in," Hon. Fahie explained.

In noting how many things would change once these bills are enacted, Hon. Fahie said: "At times some persons would come to pay a bill to the government or a statutory body or even privately and what they would end up doing is if the line is too long and they glimpse it in their car they would even drive away or if they are in their car they would leave and say well I'll come back at some other time. That can be dealt with now in a different way. It could not be done before because the legislation was not passed allowing government to receive payments for all its entities through credit cards or debit cards etc. it was difficult. It was done

in certain areas but difficult and persons were immensely concerned about the protection of their information."

While further sharing the doors that these new Bills will open the BVI Leader said: "We have seen that these transactions with public authorities now will be greatly assisted through the passing of these pieces of legislation. The documents also that will be shared will also be given the assurance as much as is humanly possible that the information will be secure and authentic."

Now that these services are fully migrating to the world wide web, the Premier said that care would be taken to prevent malicious activities, particularly forgeries. "Let's not forget about the authenticity of the document because we know that online persons can duplicate just about anything. The authenticity of the document knowing that it is from the government of the Virgin Islands and knowing that when you do return it that you are returning it to the Government of the Virgin Islands, given all the safeguards that are being put in place with these documents as you do your transactions so that it does not go to some other entity that gets your credit card or debit card information."

While referencing the current state of affairs with the pandemic Hon. Fahie noted that should another lockdown be necessary these tools will help businesses remain on track.

# **BVI International Airport to Speed Up Arrival Procedures**

The government is aiming related questions. The to improve the arrival experience at the Terrance B. Lettsome International Airport through the use of Automated Passport Control (APC), which is a system that would allow Virgin Islanders and Belongers to use kiosks to clear immigration upon arrival.

In many countries, these automated systems make the arrival process easy. The service is simple, upon arrival persons would approach the selfservice kiosks to respond to immigration-inspection-

system also allows for the submission of biographic information. This innovation results in shorter wait times, less congestion, and faster processing.

As the system is being prepared for local rollout Premier and Minister for Finance Hon. Andrew Fahie told legislators during the 9 March continuation sitting of the House of Assembly that the system is almost ready.

The Premier while mentioning the soon to

be launched automated airport immigration service told the House: "This is quite innovative, even to the point where the old Data Protection that we did... works for hand in glove with the new information system that we are putting in place."

Hon. Fahie while noting how much this new system will speed up airport clearance announced: "As you know now when you come into the Immigration Department now even through the plane Belongers will be able to get their passports swipe; and I think the time now that it takes to process you ... is or even Jamaica or one or roughly 25 to 30 seconds --if I am not mistaken. Also, it lends itself to where we are going to protect that data. We already passed the law to protect such data."

"With the kiosks that are coming, I think within the next month or two we should have at least one kiosk in the Terrance B Lettsome International airport and another kiosk by the ferry terminal in Road Town and you do not have to wait anymore when you land. You would just go to the kiosk like you've done in most other countries like when we land in Puerto Rico

two areas and you are a resident or a Belonger you just go with your passport and you could check yourself in," Hon. Fahie added.

The BVI Leader further noted that this would be a great improvement to the arrival experience at the airport. Hon. Fahie said, "we are talking about checking yourself in, in just seconds. This system is already set up, and now we have been able to cement more protection for the data that those systems would be produced under the Data Protection

# **Negotiations to end Internet Disservice are underway**

As discussions with the telecoms services providers in the Territory continue, the government is hopeful that soon the Territory would finally have better internet services. In the meantime, consumers have to endure the inconvenience caused by frequent and annoying buffering episodes and sudden black-outs of broadband.

The poor state of internet service in the BVI has been a public outcry for years, and back in November Premier and Minister for Finance Hon. Andrew Fahie promised that in the first quarter of 2021 talks with the service providers were going to resume.

Meanwhile, customers use the word "fraud" more frequently and it is clear that the internet is the next gold with the prices charged by telecoms the situation may catch fire, sooner rather than later. The term "class action suit" is also being used.

In an update on the discussions, Hon. Fahie said that the aim is to get better internet. He explained that the government is motivated to see this vital service improved because it is the "next gold mine" for BVI's economy.

While not mentioning specifics about the conversation with the service providers or what they agreed to the Premier simply disclosed: "Our negotiations are on the way through the process of getting going with our telecom companies - how do we improve the internet because

mine for us with our economy."

Hon. Fahie said that government believes that efficient internet is imperative to the improvement of the Territory's economy and other revenue streams that will come to the BVI: "Most of them will significantly depend on a very effective internet system and also to make sure that we do have laws that would allow business to be done online from the Virgin Islands and also the protection of data and many other areas," Hon. Fahie added.

Last November the situation of the chronically flawed BVI internet was quickly referenced in the Premier's Budgetary address. In that statement Hon. Fahie told the House of Assembly, "Negotiations with telecommunications service providers are expected to begin in 2021, and your Government will be insisting that service providers commit to ensuring quality service and value for money is provided to our residents."

Successive governments have tried to reason with the internet service providers for better service but to no avail. However, the Premier is adamant that change will come, "There will be no compromise on this because reliable telecommunications, particularly the internet, is essential for competitiveness in today's global business environment," Hon. Fahie told Legislators.

In March last year as the Territory was forced to depend

heavily on internet services due to the COVID 19 social distancing requirements Premier Fahie promised that a new entrant to the telecommunications market; additionally even satellite service was being considered. These options he said were on the table as government plans to fix the disastrous internet services that have been plaguing the Territory for decades.

At that time, the Premier announced that he is vesting his confidence in the newly appointed Chairman and Deputy Chairman of the Telecommunications Regulatory Commission (TRC) **Board Vance Lewis and Vincent** Wattley.

### **New COVID Strains Generate Concern**

Although the aim is to have the Territory's population vaccinated, residents are being warned that the BVI is not out of the woods as yet as it relates to COVID 19. Premier and Minister for Finance Hon. Andrew Fahie warned that the arising new strains of the virus are still a major concern.

During the House of Assembly on 9 March, Hon. Fahie explained that COVID 19 might be around for a long time: "Although the efforts of this Territory have been remarkable ... we still have to be vigilant because ... there are seven other versions of that COVID 19 mutating all the time and we have to pay particular attention to these seven new strains. It is very important."

Hon. Fahie said that the new strains demonstrate that the Territory and people are not out of the woods yet: "The truth

be told we have to learn how to live and work with COVID 19 no matter what variation of the strain comes out and we have to stay ahead of the curve and we are trying to make sure that we stay ahead of the curve," the Premier said.

"One of the things we do with staying ahead of the curve is to make sure that we do what is necessary as leaders in this House of Assembly to make sure that the business of government continues. We saw during the lockdown there was difficulty with financial services and we were able to amend certain legislation for financial services to allow it to continue to operate in the middle of a pandemic," the BVI Leader added.

The new strains of COVID 19 are emerging in various countries. Most significant has been reports of the United Kingdom, South Africa, and Brazil. With the initial announcement of the effects of these variants, the Government acted proactively by instituting a travel ban.

For instance earlier this year the government announced a ban in response to news that a new strain of the COVID 19 virus was circulating in the United Kingdom.

However, the fact that the United Kingdom is the Territory's mother country caused the news of the travel ban to sit uneasily among some residents.

Meanwhile, the World Health Organization (WHO) has pointed out that "The COVID-19 vaccines that are currently in development or have been approved are expected to provide at least some protection against new virus variants because these vaccines elicit a broad immune response involving a range of antibodies and cells. Therefore, changes or mutations in the virus should not make vaccines completely ineffective. In the event that any of these vaccines prove to be less effective against one or more variants, it will be possible to change the composition of the vaccines to protect against these variants."

WHO added: "Data continues to be collected and analyzed on new variants of the COVID-19 virus. WHO is working with researchers, health officials and scientists to understand how these variants affect the virus's behaviour, including their impact on the effectiveness of vaccines, if any. See WHO's Disease Outbreak News to get up-to-date information on the impact of COVID-19 virus variants on the effectiveness

of the different vaccines. This is an area where the evidence remains preliminary and is developing quickly. While we are learning more, we need to do everything possible to stop the spread of the virus in order to prevent mutations that may reduce the efficacy of existing vaccines. In addition, manufacturers and the programmes using the vaccines may have to adjust to the evolution of the COVID-19 virus: for example, vaccines may need to incorporate more than one strain when in development, booster shots may be required, and other vaccine changes may be needed. Trials must also be designed and maintained to allow any changes in efficacy to be assessed, and must be of sufficient scale and diversity to enable clear interpretation of results. Studies of the impact of vaccines as they are deployed are also essential in order to understand their impact."

# Statement by the Honourable Vincent O. Wheatley Minister for Natural Resources, Labour & Immigration on Extension of Lay-Off Period Comes to an end

Mister Speaker, I thank you for the opportunity again to address this Honourable House and the people of this Territory. Today, I want to give an update on the lay-off period and severance pay matters for employers and employees of businesses in these Islands.

Mister Speaker, over the last year my Ministry, the Department of Labour & Workforce Development and the Immigration Department have continuously banded together to make the necessary adjustments needed to accommodate legal work in this Territory during the Pandemic. We have made many adjustments to procedures, policies, and even legislation to accommodate the varying needs of our people. Mister Speaker, the issue of lay-offs and payment of severance is one that is burdensome to say the least, as we straddle the thin line of economic sustainability and humane

practices for workers. I want the public to know that we are cognizant of all possibilities surrounding the payment of severance.

Mister Speaker, as you would recall in June 2020 I introduced the Labour Code Amendment Act, 2020 which allowed for the lay-off period to be changed from its usual three (3) months, and announced an extended period from March through 31st October, 2020. That amendment suspended the payment of severance pay due to an employee during that period, thus allowing businesses to get their bearing as the Pandemic had just hit our shores. Once this period had ended and we realised the effects of COVID-19 were still very real and fluid, we again sought to bring aid to employees and employers.

In November 2020 I came before you Mister Speaker again to bring forward the Labour Code (Extension of Severance Pay Period) Order, 2020 which allowed for a further extension to 31st January 2021, giving employees and employers a further three months. Thereafter, the final extension was given in February of this year to cover the period of up to 28th February, 2021. Mr. Speaker, we have done all that we can to make the necessary adjustments to allow for employers to be properly prepared to make the relevant payment in a timely manner to their employees.

Mister Speaker, as the Government continues to push forward with initiatives that will aid in bringing persons to our shores, to revive economic activity, we are cognisant of the climate that persists where work is scarce. However, Mister Speaker, employees are the most important asset of a business and compensation should be delayed no further. Mister Speaker, I ask here today, that employers make the necessary arrangements with employees to bring outstanding payments current. Those who may be unable to honour their full obligation to employees are required to visit the Department of Labour and Workforce Development to gain assistance in developing plans to make these outstanding payments, and make them in line with a mutually agreed plan with their employees. The Department of Labour and Workforce Development is ready and available to assist those who are unsure of the way forward and those needing guidance with closing these outstanding matters. Persons needing assistance can visit the Department of Labour and Workforce Development in person, or contact a Labour Relations Officer at 468-4739 and 468-4713.

The donation to national vaccination programmes is being made by the bank through its charitable arm the FirstCaribbean International ComTrust Foundation, and will support the purchase of vaccines in Antigua, Bahamas, Barbados, Dominica, Grenada, Jamaica, St. Kitts, St. Lucia, St. Vincent and the Grenadines and Trinidad and Tobago.

RIO DE JANEIRO, BRAZIL - For anyone looking to pursue an international career, the good news is that Canada is on the lookout for professionals to move to the country. According to Cebrusa Northgate Canadian immigration agency, the government expects to accept over 1,233,000 new permanent residents in the coming months.

The agency's president Daniel Braun points out that Canada has a serious shortage of skilled labor in several positions and levels.

"Anyone thinking that this is underemployment is wrong, the vacancies are open for several positions and levels. The minimum wage is around CA\$2,000. [RioTimes]

ROME, Italy's privacy watchdog has set up an emergency channel against revenge porn with the help of Facebook.

The channel can be used by people fearing their intimate images may be posted against their will so that the postings can be blocked, sources said.

The flagging-up channel was activated in a pilot project by Facebook in Italy last year.

The channel may also be used by victims of non-consensual pornographic posts of any nature, sources said. "Collaboration is underway to help potential victims," they said. (ANSA). **DOMINICAN REPUBLIC** - Less tax revenues and more social spending during the Covid-19 pandemic have led to an increase in borrowing and consequentially in the national debt. The consolidated public debt closed in 2020 at about US\$53 billion. Yet, the Central Bank is bullish, the Dominican economy is gradually yet firmly recovering.

The Central Bank released on 4 March the report "Public Debt and Financial marks in Times of the Pandemic." The report concludes that as the foreign exchange generating sectors are reactivated, there will be a gradual reduction of the debt.

"Consolidated public debt closed 2020 at about US\$53 billion. If nominal GDP in dollars had simply maintained its 2019 level, some US\$89 billion, instead of falling to some US\$79 billion as estimated in 2020, the consolidated public debt, would have stood at around 59.5% of GDP, some 10 percentage points lower than the figure. [DR1]

JAMAICA - Jamaica recorded its highest number of daily COVID-19 cases with 527 cases reported across the island, according to the Ministry of Health and Wellness.

The new high shatters the previous record of 468 cases reported on February 27.

The newly confirmed COVID-19 cases bring the total number of cases

on the island to 25,303, 10,469 of Pre-Ministerial forum will assess which are active cases.

There were three additional COVID-19 deaths on Friday, bringing the overall coronavirus death toll in Jamaica to 446. The island's positivity rate stands at 24.2%. [CaribbeanNationalNews]

**BERMUDA** - A fall in the island's gross domestic product last year will lead to more job losses, the Leader of the Opposition warned yesterday.

Cole Simons, also the One Bermuda Alliance's shadow finance minister, said that GDP was expected to drop by seven to nine per cent for 2020 and called for a change of direction by the Progressive Labour Party to avoid more damage to the economy.

He added: "What the reduction in GDP means for Bermuda is more job losses for Bermudians, especially small businesses, which play a vital role in Bermuda's economic engine."

Mr Simons was speaking as he delivered the Opposition's Reply to the Budget unveiled by Curtis Dickinson, the Progressive Labour Party finance minister, last Friday.

He said businesses such as beauty salons, gyms and the hospitality sector would "continue to bear the brunt of job losses". [Royal Gazette]

**PHILIPSBURG** - The COVID-19 pandemic has made evident how fragile our different systems are. The school sector has become one of the worst affected sectors all over the world.

From 15 to 26 March, the regional review on school safety in the context of Systemic Risk: the virtual Caribbean Safe School Initiative (CSSI) Pre-Ministerial forum will assess experiences of the education sector's COVID-19 response and recovery prior to and during the 2020 hurricane season. It will also discuss the need for coordinating policies and actions for prevention and mitigation to build education sector resilience.

The Pre-Ministerial Forum will also highlight the fact that ensuring school safety is the starting point for reactivating the economy while discussing the fiscal limitations that might impact the region due to the economic crisis resulting from the pandemic. [smn news]

Ziggy Marley, Rita Marley, and Cedella Marley will produce on behalf of Tuff Gong. Robert Teitel will also produce. The film will focus on the singer's life and career. There is no word just yet regarding cast or the commencement date for production. [nycaribbeannews]


LOS ANGELES, (Xinhua) - An average of 46 bombs have been dropped on other countries per day by the United States and its allies since 2001, recent research by anti-war group CODEPINK revealed.

According to the research by Medea Benjamin and Nicolas J.S. Davies of the U.S.-based group, which was published Thursday on the Common Dream website, the United States and its allies have dropped at least 326,000 bombs and missiles on other countries since 2001, including over 152,000 in Iraq and Syria.

The conclusion was made primarily on official U.S. military releases, as well as data from the Bureau of Investigative Journalism, the Yemen Data Project, and the New America Foundation, the research said, adding since the Trump administration ceased publishing figures of its bombing campaigns in 2020, the total number was underestimated.

Moreover, the data also had not included bombs or missiles used in helicopter strikes, AC-130 gunship attacks, strafing runs from U.S. bombers, or any counter-insurgency or counter-terrorism operations in other parts of the world, the research said.

If you really don't like to eat breakfast, you can split it up into two smaller meals. Eat a hard boiled egg at home, and an hour or two later, take a break from work and snack on an apple and a handful of healthy nuts like pecans or walnuts.



### COUNTRIES THAT PREVAILED EARLY AGAINST THE PANDEMIC

What was the common denominator for countries that kept the pandemic to a minimum?

Unlike in the USA, Brazil, and UK, draconian action and effective governance appeared to be the key components in keeping the COVID 19 virus from spreading in specific countries.

In some places the wearing of a face mask is mandatory and anyone venturing out without a mask is arrested swiftly. In those countries there is no halfway house: wearing a face mask is compulsory.

Even in countries where masks are not compulsory, populations that are actively mindful of the importance of masks in combatting Covid 19 wear their masks when necessary. This has probably stemmed the tide of infections in those countries.

Early in the pandemic there was mixed messaging on masks especially in the USA and UK.

Then countries that took the pandemic seriously in December 2019 were better prepared for action when the worst happened, unlike countries that refused to take the pandemic seriously and that failed to lockdown early.

There may have been a belief that the pandemic was an Asian issue. The pandemic would

not reach the west. However science stated that with global aviation and international shipping, it would only be a matter of time before the pandemic reached western shores.

In Africa, in early January 2020, Kenya, which has a robust manufacturing base, converted that base into a machine for building ventilators and health care equipment. That effort apparently paid off in minimizing the spread of COVID in Kenya.

Countries where populations obeyed government protocols did well. The Caribbean-British Virgin Islands is one examplepossessed residents who did not disobey directives and rules set by health ministers. The result may have been a minimization of infection rates and deaths in most of the Caribbean islands.

West Indians and residents of

the Caribbean stayed indoors, obeyed quarantine rules, and social distancing requirements. The result was a far less spread of the pandemic in the region. Limiting personal contact was a disaster for these economies. However lockdowns and social distancing achieved the desired result of controlling the spread

In Africa, the poster boy for prevailing against the virus is Rwanda.

of the virus.

Rwanda is a highly digitized African state capable of going cashless at very short notice. When lockdown was initiated very early on, Rwanda went cashless and all transactions were done online. The country fully locked down for months. The preceding kept social distancing to a maximum. And that helped keep control of the pandemic in Rwanda.

Effective digitization meant that

over 50% of Rwandans could work from home. Online schooling was empowered, and most businesses were able to operate online.

Rwanda has a population of 12 million with just 2200 cases and 8 deaths.

Compare that with the USA and UK where hundreds

of thousands have died and millions are infected, then there is no doubt Rwanda is an example of early action saving

And it appears that so with countries that obeyed science with early action on COVID, so it will be with countries that bow to science with the vaccine.

The countries that first get the majority of their populations inoculated from COVID 19 achieving herd immunity will be the first to return to normal and see full economic and social recovery.


# St. Patrick's Day the Easy Way

My first love is culinary history. Researching, reading and writing about the history of food and recipes is what fuels my passion to share what I've learned in my cookbooks and the articles that I write for newspapers, blogs and magazines.

When I was asked to write a column about St. Patrick's Day, I discovered the fascinating history of Irish potatoes. The people of Ireland embraced the potato around 1780. The crop rapidly became the primary source of food for most of the population.

**Potatoes are nourishing and filling,** and contain most of the vitamins needed in our daily diet. The crop also is a popular food source around the world because it only requires an acre of land and will grow under almost any conditions.

An Irish potato is covered with an off-white or cream-colored skin. The flesh is creamy white. Black flecks or marks often mottle the flesh of the potato, but have no impact on the flavor. An Irish potato is waxy, which makes it hold its shape when boiled, a common cooking technique in Ireland. The potatoes also are delicious when fried, roasted or broiled. However, the potato's waxy texture makes it gluey and dense when mashed, so select another variety like a Russet or Yukon gold for this purpose.



In the mid-1800s, a disease caused by a fungus infested potato crops throughout Europe, causing a devastating famine in Ireland. This time period is called the Great Famine or Gorta Mor, meaning "the great hunger." Mass emigration coupled with widespread deaths from starvation caused the Irish population to drop by 20% to 25%. Many Irish families immigrated to America to escape the hardships in Ireland and to start a new life. By 1850, the Irish made up a quarter of the population in Boston, New York City, Philadelphia and Baltimore.

After years of suffering in Ireland, in 1883, the French botanist Alexandre Millardet discovered an effective fungicide to combat the potato blight. Today, potatoes are the world's fourth largest food crop, following rice, wheat and maize. My recipe for Irish Sheet Pan Potatoes, Sausage and Cabbage Bake is an easy way to incorporate the flavor components of a traditional, long-simmering Irish stew in half the time. It also provides the perfect showcase for Irish potatoes while creating a warm and comforting family meal for a St. Patrick's Day or any day of the week.

### **IRISH SHEET PAN POTATOES, SAUSAGE AND CABBAGE BAKE**

- 3 tablespoons olive or vegetable oil, divided
- · 2 pounds Irish potatoes, quartered
- · 1/2 head green cabbage, sliced into chunks
- · 1 bulb fennel or 3 stalks celery, thinly sliced
- · 1 yellow onion, peeled and roughly chopped
- 6 cloves garlic, peeled and diced
- 1 1/2 tablespoons poultry seasoning
- 1 1/2 teaspoons salt
- 1 1/2 teaspoons ground black pepper
- 1/2 teaspoon ground allspice
- 6 links (about 3-ounces each) Irish banger sausage links, Kielbasa or Bratwurst links
- 1. Preheat the oven to 400 F.
- 2. Lightly coat a rimmed, 9-by-13 or 18-by-13 baking sheet with 1 tablespoon of the olive oil, or spray until lightly coated with cooking oil spray.
- 3. Place the Irish potatoes, cabbage, fennel or celery, onion and garlic on the sheet pan. Drizzle the olive oil over the vegetable mixture. Sprinkle the poultry seasoning, salt, pepper and allspice over the mixture. Combine the mixture with the seasonings with your clean hands or a spoon or spatula.
- 4. Spread the mixture evenly around the baking sheet and press the ingredients into the bottom of the pan so that everything cooks uniformly. Place the sausages evenly on top of the vegetable mixture.
- 5. Cook for 20 minutes, stir, press the vegetable mixture into the bottom of the pan so that it is evenly distributed, and turn the sausages over to cook on the other side. Then cook for an additional 20 minutes or until the potatoes are tender when pierced with a fork. Serve with thick slices of hot crusty bread and butter. Serves 6.

Caribbean Tourism Leader Lauds effective mobilization to resist the as well as the compassionate Women's Contributions to Fighting COVID-19 MIAMI, Florida (March 6, 2021) - Caribbean women are being celebrated for their tremendous efforts in helping the region's countries and territories combat and recover from the Coronavirus Disease 2019 (COVID-19) crisis.

### **COVID Relief Bill Projected to Slash US Child Poverty**

The \$1.9 trillion pandemic relief bill awaiting final passage in the House of Representatives would bring the United States in line with many other advanced democracies around the world by providing regular, unrestricted federal payments to families with children that would cut the rate of child poverty in half.

In all, 13.1 million children and adults would be lifted out of poverty, including 5.7 million under the age of 18, according to one analysis. It would be an historic byproduct of President Joe Biden's massive economic response to the COVID-19 pandemic and Democrats' pent-up demands for addressing income inequality in the U.S. through direct government action.

What remains to be seen is whether the change is temporary or signals a permanent adjustment to U.S. social policy.

### Almost unprecedented

An analysis by the Urban-Brookings Tax Policy Center found that the bill would increase the after-tax income of the poorest quintile of Americans by 20.1% and the second-lowest quintile by 9.3%. (Those figures include a one-time federal payment of \$1,400 for most Americans as well as elements tailored to benefit families and the poor.)

An analysis by the Center on Poverty and Social Policy at Columbia University found that the bill would cut the overall poverty rate in the United States from 12.3% to 8.2%. The impact on children under 18 would be even more dramatic, dropping their poverty rate from 13.5% to 5.7%.

Supporters of more generous government benefits for low-income Americans struggled to find a parallel in U.S. history.

"It's a huge change," said Sarah Halpern-Meekin, a professor in the LaFollette School of Public Affairs and the Department of Human Development and Family Studies at the University of Wisconsin-Madison. She said the nearest historical comparison in terms of impact on society would be the Social Security Act of 1935, which set up a system of guaranteed income for most retirees in America.

### **Details of legislation**

In addition to direct stimulus payments and enhanced unemployment benefits, the American Rescue Plan Act of 2021 would create a refundable tax credit worth \$3,600 per year for children under 6 years of age, and \$3,000 for children between 6 and 18.

Beginning in July, the funds would be delivered in monthly payments, creating a predictable income stream for families. The bill would also expand existing tax credits to care for children and dependents.

A separate element of the bill, expanding federal benefits to low-income working households through a program known as the Earned Income Tax Credit, would further reduce poverty in the U.S.

Analysts say financial improvements can trigger other positive outcomes for struggling Americans and their families.

"With these kinds of increases in income there are concrete health benefits," said Halpern-Meekin, who is also affiliated with the Institute for Research on Poverty. "The family being less likely to experience material hardship and run short of what they need has a short-term effect on children's or infants' health outcomes, and those spill over into long term effects ... on health, school and employment outcomes."

### Unintended consequences

While progressives celebrate the bill as a major victory, conservatives say they fear that providing regular, no-strings-attached income to parents will have unintended consequences that do more harm than good.

Scott Winship, the director of poverty studies at the American Enterprise Institute, released a research paper titled, "The Conservative Case Against Child Allowances" as lawmakers were debating the bill.

"Child allowances run a very real risk of encouraging more single parenthood and more no-worker families, both of which could worsen entrenched poverty in the long run — an overreliance on government transfers, poverty over longer stretches of childhood, intergenerational poverty, and geographically concentrated poverty," he wrote.

"And the concern is about not only material poverty but also the social poverty that comes from growing up in non-intact families or communities with limited social capital and a dearth of meaningful roles for members to fill." Noting that the United States has already seen a significant decrease in child poverty in recent decades, Winship called on lawmakers to reject the bill and to instead continue with existing policies that, he said, have been proven to work.

"Policymakers should reject child allowances in favor of other policies to reduce child poverty that would build on the lessons of welfare reform, run lower risks of unintended consequences, address stubbornly low rates of intergenerational mobility, and attempt to reverse pervasive declines in family and associational life," he wrote. "They must resist the allure of a family policy that — only apparently — has no downsides."

As currently written, the changes to tax policy in the bill would expire at the end of the year.

However, even if law reverts to its current form next year, taxpayers can expect an additional infusion of cash in 2022, when the benefits for the first six months of this year are refunded to them after they file their 2021 taxes.

# Lettsome claims its 10th ESHS title by ending Flemming's 3-peat quest By Dean "The Sportsman" Greenaway

Lettsome, House 1, prevented defending champions Flemming, House 3, from attaining their historic third 3-peat victory since their first between 2002-2004, during Thursday's Elmore Stoutt High School Inter-house Track and Field Championships, with a resounding 44 points victory at the A. O. Shirley Grounds. It was Lettsome's 10th overall title.

Lettsome amassed 330 points to win the oneday version of the 49th edition of the championships that's traditionally held over two days. Flemming fended off hard charging Carlisle, House 4, by a mere four points—286-282 for second. O'Neal, House 2, rounded out the competition with 226 points.

Carlisle's Jaleel Croal—who shared the Victor Ludorum with teammate Jahshani Farrington and O'Neal's Khybah Dawson with 20 points respectively—became just the second school boy to win three successive Victor Ludorums since Carlisle Scott introduced interhouse competition at the Virgin Islands Secondary School in 1957. Croal joined Al Potter who pulled off the feat 2001-2003 for Lincoln—which was renamed O'Neal. Lettsome's A'Keela McMaster, repeated as Victrix Ludorum.

In an exclusive interview, Lettsome's House Master Kamira Forbes, told Island Sun Sports that she couldn't even put the victory into words.

"Last year we fell down, but decided we were not comfortable in second place. We came all the way from last, last year and said 'no, we don't like second place, we want first place this year," she pointed out. "I have to give a shou-tout to all my athletes. They are always willing to assist, even those who aren't athletes. Once you call, they normally come out and give it their all. They felt that they could do it. They said 'Miss Forbes, we are capable. We can get back to No 1, that's where we need to be. We're House 1, we can get back to being No 1.""

Fobes said it was a special moment for her team, especially the way they dethroned defending champions Flemming. "I was awesome, more than anything else," she said. "We were just thinking House 3 can't beat us, not at all."

Forbes said some of their Senior athletes and others take the lead. She noted that they always get the younger athletes motivated and let them know Lettsome is the best house, no matter what and they're No 1.

Among notable performances, Croal won the 100/200m double in 10.80 seconds and 22.19 to shake off Lettsome's Malik John's, 22.26. Dawson became one of the few school boys to run the 400m under 49.00 seconds in the championships, when he stopped the clock at 48.94 seconds, after settling for 6.86m in the Long Jump.

The 1500m was the day's most exciting individual race. Farrington out-sprinted Lettsome's Jelani Croal in a photo finish, 5:03.96-5:03.97. Farrington had an unchallenged 800m victory in 2:12.20.

# Small states diplomacy pays dividends on 'de-risking'

It was an odd law into which to place it, but new and welcome directives on 'de-risking', which has plagued Caribbean countries, has become law in the United States.

The law in which the helpful directives are embedded is the "William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021" (NDAA). It was vetoed by former President Donald Trump and it should, at that point, have died. But for the first time in Trump's presidency, the Congress mustered the two-thirds majority needed to overturn his veto.

Trump's veto had nothing to do with 'derisking'. It was directed mainly at the bill's removal of the names from military facilities of Confederate officers. A significant number of Trump's supporters come from the former confederate states.

Section 6215 of the NDAA, which deals with Financial Services De-Risking, is the result of painstaking work by the Prime Minister of Antigua and Barbuda, Gaston Browne, and his instructions to me, as Ambassador of Antigua and Barbuda to the United States, to leave no stone unturned in engaging the U.S. Congress and particularly the House Banking Committee, to draw attention to the harmful – if unintended - consequences of de-risking for the Caribbean's banking system. Browne is the lead CARICOM head of government for financial services.

The Chairperson of the Committee is the formidable Maxine Waters, representative in the House for California's 43rd district. Throughout the latter half of 2019, she was bombarded by approaches from Antigua and Barbuda in written and personal presentations, explaining why de-risking by U.S. global banks was depriving Caribbean banks of crucial correspondent banking relations, and threatening to cut-off the region from participation in the global trading and financial system.

In early 2019, banks in some CARICOM countries had lost all their correspondent banks, and institutions in other states were tenuously

holding on to only one. All this had arisen because of U.S. regulatory directives to its banks concerning money laundering, financing of terrorism and the mythical but popular view that Caribbean countries were 'tax -havens' and their banks were awash with dirty money.

The facts told a different story. In the 10 years up to 2019, US\$26 billion has been imposed worldwide as fines for non-compliance with money laundering, but not one bank was located in the Caribbean.

Little attention was paid to the reality that all the banks in CARICOM countries and all their assets and transactions do not total 5 per cent of the assets and transactions in the world. Therefore, in the unlikely event that all 5 per cent of financial transactions are dirty in some form or another, it stands to reason that the countries and banks, responsible for the remaining 95 per cent of assets and transactions were large tax havens and purveyors of illegal financial services.

Changing this image of the Caribbean, laying out the evidence, and making solid arguments were all necessary, particularly for a U.S. Congress confronted with a multitude of domestic and global issues on an hourly basis. In Maxine Waters, the Caribbean region found a tough but decisive person, sceptical but willing to listen and to examine the evidence.

The Caribbean effort that was spearheaded in Washington by Antigua and Barbuda strongly supported by Belize and St Lucia, culminated in a Congressional Round Table in November 2019, chaired by Waters and attended by Gaston Browne, St Lucia Prime Minister Allen Chastenet, and Ministers from Trinidad and Tobago, Barbados, and Jamaica. Waters had invited to the meeting senior representatives of major U.S. banks as well as other members of the House Finance Committee. A full and frank discussion ensued.

At the end of it, Waters and her Congressional colleagues promised action. Deal making in the U.S. Congress is more art than science. It results in matters inserted in a law where it may seem to have no relevance. But that is the trade for support that occurs. In the result, the promised action was delivered in the NDAA.

Among the matters that the law stipulates as guidelines are: providing vital humanitarian

Meeting between Caricom and US Financial Services Commission and development assistance and protecting the integrity of the international financial system are complementary goals; access issues are a concern for other underserved individuals and entities such as those sending remittances from the United States to their families overseas and certain domestic and overseas jurisdictions that have experienced curtailed access to crossborder financial services due, in part, to de-risking; the financial exclusion caused by de-risking can ultimately drive money into less transparent, shadow channels through the carrying of cash or use of unlicensed or unregistered money service remitters, thus reducing transparency and traceability, which are critical for financial integrity, and can increase the risk of money falling into the wrong hands; and anti-money laundering, countering the financing of terrorism, and sanctions policies must ensure that the policies do not unduly hinder or delay legitimate access to the international financial system for underserved individuals, entities, and geographic area.

Those were the very points which were put forward by the representatives of small Caribbean states who can be pleased that one of the law's fundamental directives is that "policies that encourage financial inclusion must remain a priority".

The NDAA is a small but significant step by the U.S. Congress and especially by the House Banking Committee, led by Congresswoman Maxine Waters. It was a big leap for small Caribbean countries and a triumph for their diligence and diplomacy.

Much work remains to be done but an important pathway to rectifying and balancing de-risking has been opened. Amid the ravages of COVID-19, it is welcome good news.

Minister Speaker, the Healthy School Programme is one of the interventions of the Non-Communicable Disease (NCDs) Prevention and Control Programme. physical Inadequate activity and unhealthy eating are two behavioural risk factors that contribute chronic disease, which is identified as significant health problem in the Territory. This programme is a joint venture of the Ministry of Education, Culture, Youth Affairs, Fisheries Agriculture and and the Ministry of Health & Social Development. 



Rather than dodge the question, parents should consider whether their family is ready for a pet, says Sharon Bergen, senior vice president of education and training for Knowledge Learning Corporation, the nation's leading provider of early childhood care and education.

Bergen suggests that parents weigh the pros and cons of adding a pet to the household before agreeing to a child's request. In Biblical City of Ur, Pope Urges
Inter-Religious Tolerance, Fraternity
from terrorism and war. "Hostility, extremism and

AMMAN, JORDAN [VOA] - Pope Francis has addressed an interfaith gathering of Iraq's religious and ethnic groups in Ur, said to be the birthplace of Abraham, the common patriarch for Jews, Christians and Muslims. He drove home the need for respect and unity, and he used the opportunity to condemn violent religious extremism.

Pope Francis traveled to the ruins of the ancient city of Ur, considered the cradle of civilization, to remind people that what binds them is more powerful than what divides. Faithful from the Christian, Muslim, Yazidi and Mandean communities were present Saturday. The pope reinforced his call for inter-religious tolerance and fraternity during the first-ever papal visit to Iraq, where religious and ethnic divisions and conflict have torn apart the social fabric for decades.

The pontiff said that all of Iraq's communities have suffered too long

from terrorism and war. "Hostility, extremism and violence are not born of a religious heart: They are betrayals of religion," he said. His remarks in Italian were translated into English.


"We are believers and as believers mustn't stand silent when we see terrorism, when terrorism takes hold of religion for its own gain. It is up to us as religious men and women to destroy evil. We cannot have the light of God be darkened as it has been in this country, where war, violence and terrorism has brought darkness," the pontiff said.

Pope Francis also drew attention to the genocide perpetrated by Islamic State militants against Iraq's minority Yazidi community and their continuing plight.

"Yazidi men and women, young children were taken from their homes and sold into slavery, subjected to violence. We must remain hopeful for the future. But there are still people to this very day, who are held captive. People who cannot return to their homeland. We pray for freedom of thought, of mind, freedom of religion to be upheld everywhere," the leader of the world's Roman Catholics said.

Pope Francis has sought to support Christians in Iraq, whose numbers have dwindled from 1.5 million in 2003 to less than 300,000 in this majority Shiite Muslim country, by calling on leaders to protect all minority rights. During his speech, the pope praised "the young Muslim volunteers of Mosul, who helped to repair churches and monasteries, building fraternal friendships on the rubble of hatred, and those Christians and Muslims who today are restoring mosques and churches together."

He called "the greatest blasphemy" the act of "hating our brothers and sisters."







### Deep Vein Thrombosis Usually Due to Surgery

DEAR DR. ROACH: I am a 47-year-old woman. Five years ago, I developed a blood clot in my left leg after fracturing my ankle and being immobilized for several months. I was put on a blood thinner, and my ankle healed. Recently that leg started swelling again, and I went for an ultrasound. I was told that I have a chronic DVT, but that I don't need blood thinners. Why do I not need a blood thinner now when I did before? What does "chronic" mean? Why am I getting swelling again five years after the first clot? — L.S.B.

ANSWER: Blood clots can happen in veins or arteries, but the type that happen due to surgery and immobilization are almost always in the vein. That's the "V" in "DVT," which stands for "deep vein thrombosis."

A brand-new blood clot has a high risk of propagating further up the vein, and also of breaking off and traveling through the vein into the heart. Most often, the clot will go on into the lungs, then called a "pulmonary embolus." But in the rare case, the clot can go through a patent foramen ovale, which is sometimes called a hole in the heart, and cause a stroke.

Because of the risk of life-threatening complications, acute DVTs are treated with anticoagulants, such as warfarin (Coumadin) or apixaban (Eliquis). This stabilizes the clot, and after a week or two the risk of propagation or embolization becomes much lower. Most people are treated for at least three months for maximum benefit. Treatment does not dissolve the clot, and a follow-up ultrasound will detail changes that show the clot is no longer acute, hence "chronic." The vein itself

is scarred and damaged, and never returns to normal.

"Chronic DVT" isn't the best term, since it confuses many, both patients and physicians alike. I prefer scarred, and some experts use "chronic luminal changes" to differentiate it from an acute clot. Whatever it is called, it may still be symptomatic.

Most people with a history of a large clot on one leg will notice that leg swells more than the other in heat or with a large salt load. Even so, anticoagulant treatment is neither necessary nor helpful.

Effective treatment for swelling associated with previous DVT includes salt restriction, compression stockings and leg elevation several times during the day. People with more severe symptoms that do not respond to conservative management may benefit from more aggressive therapies, such as placement of a metal stent to let the blood flow better through the damaged area.

DR. ROACH WRITES: I am often asked about screening tests for pancreatic cancer. Despite the promise of new tests, the U.S. Preventive Services Task Force recently re-reviewed the available evidence and continues to recommend against screening in the general population. However, it's important to recognize that these recommendations do not apply to people at increased risk for pancreatic cancer, such as those with familial pancreatic cancer or with some genetic syndromes, such as Peutz-Jeghers syndrome. However, it does apply to people with other risk factors for pancreatic cancer, including smokers and those with new-onset diabetes or chronic pancreatitis.

With better screening tests, or with improved treatments for pancreatic cancer, the balance of benefits (it's currently unlikely to find early pancreatic cancer when it can be treated) to harms (false positive results can lead to unnecessary surgery) may shift.



No one would offer an authentic Fendi Spy Bag for \$249.00.

Who you're purchasing the bag from yourself.

It can be difficult buying a designer is of utmost importance. You can be guaranteed that when purchasing that Prada bag from Nieman Marcus or that Gucci from Bergdorf Goodman you're getting an authentic bag, although perhaps not a deal. Check the e-luxury site.
