## MORE MURDERS AND COLOSSAL DRUG SEIZURE: BVI SHOCKED

A grim picture that shows a network of smuggling and organised crime in the Territory is becoming quite apparent and His Excellency Governor Augustus Jaspert announced on 10 November during a joint press conference with Commissioner of the Royal Virgin Islands Police Force Michael Matthews that actions are being taken to thwart these negative undertakings.

The Governor's announcement that action to wipe out and prevent criminal enterprise or smuggling attempts came on the heels of a busy weekend where a man was shot and killed in broad daylight, there was a chase at sea, and – to top it all – police had one of the largest drug busts in recent history.

In referencing the highly disturbing recent criminal matters the Governor noted that on Friday 6 November Everton McMaster, Jr. was brutally murdered in Baughers Bay where he lived, and on that very day, the Royal Virgin Islands Police Force raided a property in Tortola and seized a colossal quantity of cocaine, as well as multiple loaded firearms. Most disquieting was that one of the

arrested persons is a member of the Royal Virgin Islands Police Force.

In his disclosure about the seizure, His Excellency noted that the quantity of cocaine is the largest in BVI history – 2,353 kilos with an estimated street value of US\$250 million: "The value of the seizure equates to around 75% of our entire national budget in the BVI. It is also one of the largest seizures in the history of any British Overseas Territory or the UK. I share these figures as an illustration of just how large this seizure is. The Police conducted exceptional and high-risk work to enable such a significant seizure. Its size indicates that drug smuggling can potentially have debilitating and deteriorating effects on our Territory, and the level of safety and good governance we expect and deserve," the Governor pointed out.

The Governor noted that the weekend of high crime also included a boat chase. He said that the incident occurred on Sunday 8 November, and featured a fast boat. He said the boat was reported stolen by a known criminal and capsized off the coast of BVI. Further, it was mentioned that \$99,000 in cash

was found on the boat and two individuals were rescued and taken into police custody.

Nonetheless, His Excellency assured that the BVI is still a very peaceful and tranquil place and alluded that there is a correlation between drug smuggling and the

Territory's pervious borders. His Excellency said: "we cannot ignore the fact that the BVI is vulnerable to the smuggling of people and drug and related criminality, in part due to our geography and our location. I have long-held concerns regarding the porous nature of our borders and the increasing number

of seizures in nearby waters. Earlier this year, my concerns led me to invite HMS Medway to BVI waters in order to help protect our Territory and I have long been advocating reforms to increase our police capability and border security."

# More Murders And Colossal Drug Seizure: BVI Shocked

Over the last few months, the Governor has echoed concern about the nature of the BVI borders and even invited the UK Navy to patrol. Now that incidents have occurred that give credence to the border security efforts His Excellency declared that more will be done. The Queen's Representative said: "Following reports over the weekend, my concerns about the security of our borders and our vulnerability to drug smuggling have increased even more. I understand that many are equally concerned about the state of security in the BVI and want to know what is being done to protect the community. I would like to take this opportunity to set out some of the actions being taken to

protect BVI from the scourge of drug-related criminality."

The Governor pointed out that the massive seizure of drugs over the weekend showcases that there is an element of organised criminality in the BVI: "My view and that of law enforcers is that this is not the work of a few criminals sneaking through the cracks or a one-off. A seizure of this scale, especially when combined with other seizures made in recent months, is strong evidence of serious and organised criminality here in the BVI. The investigation is at an early stage, but regrettably, the involvement of a police officer indicates that there may be pockets of corruption facilitating this kind of illicit activity. It is important that we act fast to eliminate and prevent this corruption from growing further.

The investigation is again in early stages and we cannot confirm whether this is connected to Friday's seizure," he said.

Governor Jaspert explained that the seizure was an extraordinary exercise for the officers of the RVIPF. "It was a dangerous and complex operation, which required significant courage and professionalism. The significance of their bust is beyond anything the officers have seen in their lifetimes and will make our streets and others around the world a safer place. It has shown drug smugglers that BVI will not tolerate their illicit activity – we can and will stop trafficking. Our officers who led the investigation and raid should be incredibly proud of their effort and I hope we all feel proud of what they have

achieved. We all owe them a debt of gratitude," His Excellency stated.

While returning to his point about criminality in the Territory Mr. Jaspert said, "We believe these three crimes are unrelated, but put together they present a concerning picture of the state of security in BVI – drug smuggling, gun crime, murder, and potential corruption. The fact that corruption has occurred is a sobering sign that our institutions can be manipulated. If we fail to tackle corruption now, there is a danger that it could spread throughout our institutions, businesses and society. This must be a wake-up call - we cannot allow BVI to become a target for drug trafficking and criminality in the region."

In noting the actions that will be taken to dissuade such operations the Governor disclosed: "Fortunately, we have

taken significant steps to bolster our law enforcement in recent years. We have built back our Police Stations, expanded our footprint in the community, and trained officers in specialist skills - supported by funds from the UK Government. We have also bolstered border security with the establishment of the Joint Task Force. I am currently considering other forms of training and support from the UK, both immediate support that will enable us to conduct more effective border patrols and long-term capability building of our agencies. I cannot go into further details as this is still being discussed with NSC, but I will update as soon as appropriate."

"These actions will help us protect the borders, but they need to be matched by actions to help protect against corruption. I believe that we have not done enough over the years to ensure that no kind of corruption can take place within our institutions in the Territory," he added.

## Government Makes Adjustments To Tourism Protocols

The Government has struck a balance with the reopening Protocols after widespread complaints from residents and businesses about various components. The announcement regarding the new adjustments was made by Premier and Minister for Finance Hon. Andrew Fahie and Minister for Health and Social Development Hon. Carvin Malone on 10 November.

When the government previously announced the Protocols on 26 October residents and in particular tourism stakeholders heavily criticised the proposal claiming that the protocols were going to be costly to travelers, and has already resulted in numerous booking cancellations. There were further questions about what would be the requirement for residents who travel outside of the Territory upon return.

While emphasising that quarantine would be a requirement that is not going to be adjusted for both residents and visitors the Premier noted that some concession has been made. Hon. Fahie explained that Cabinet agreed that for the first three months, from 1 December until 28 February the cost of quarantine in a Government approved property will be met by the Government of the Virgin Islands. However, he noted that this was only for citizens, belongers, permanent residents, and work permit holders. Additionally, the Premier said that such quarantine will not include meals.

### Marine Tourism

When the Premier announced the reopening, protocol stakeholders particularly in the marine tourism sector, were unhappy that provision was not made for their sector. However, the update seemed to have the concerns of the marine sector into consideration.

In noting the change in this regard, Hon. Malone said that Cabinet decided that the Protocol for Vessel Arrivals will require certified RT-PCR testing and provide for quarantine accommodations aboard vessels as well as restricted movement within Territorial waters.

Hon. Malone said that the Cabinet decision requires that boaters quarantine on vessels at mooring sites to be approved by the Minister for Health and Social Development in consultation with the Minister for Natural Resources, Labour and Immigration. It was explained that the vessels will be able to move within territorial waters during the quarantine period but will only be able to moor at sites approved by the Minister for Health and Social Development in consultation with the Minister for Natural Resources, Labour and Immigration.

Similarly, mega yachts will be approved for entry into the

Territory under the established marine protocols, except otherwise as approved by the Minister for Health and Social Development.

While commenting on the update the Premier praised members of the marine industry who he said consulted with the government on the matter: "I want to thank them for coming to the many meetings that we have had. Not just now, since we have announced the protocols but even before. A lot of interest was generated when they heard the first speech about the protocol," Hon. Fahie said.

### Cost Reduction

One of the outcries following the previous announcement was the impression that the many tests and required tracking components were too expensive. These costs have now been reduced.

Both the Minister and the Premier explained that test and tracking are necessary for both residents and tourists: "Cabinet met

and agreed that all travellers for entry to the Territory, inclusive of all citizens, belongers, permanent residents and work permit holders, will be required to pay for the traveller app, monitoring bracelet and the required two tests (entry and four-day) at a total charge of \$175 per person. This is a significant reduction from what was previously mentioned. Cabinet also agreed that travellers or other persons will be charged \$125 for any tampering or damage to the monitoring bracelet," the BVI Leader mentioned.

As it relates to those requiring a test to leave the BVI it was stated that Cabinet also agreed that travelers requiring a test from a government facility to facilitate exit from the Territory will be charged seventy dollars (\$70.00) per test.

# Biden Wins Presidential Race



On Saturday morning (7 November) USA 46th President of the United States posted this message to the world: "I am honored and humbled by the trust the American people have placed in me and in Vice President-elect Harris. In the face of unprecedented obstacles, a record number of Americans voted. Proving once again, that democracy beats deep in the heart of America. With the campaign over, it's time to put the anger and the harsh rhetoric behind us and come together as a nation. It's time for America to unite. And to heal. We are the United States of America. And there's nothing we can't do, if we do it together."

It took several days to count the votes, but finally on Saturday most media confirmed Biden as winner in the 2020 presidential race. A victory in Biden's native Pennsylvania placed the Democrat

over the 270 electoral votes needed to secure the presidency. Across the country, Biden supporters poured into the streets to celebrate his victory and that of the Democratic party.

In Europe, in the Caribbean, Canada and Latin America many governments aired a sigh of relief.

A commentary published the Guardian noted: "Europe has many problems of its own, but set against the record of US regress over the last 20 years, our European story looks like triumphal progress. The same can be said for Australia, New Zealand or Canada. Still more dramatic has been China's rise, facilitated by years of American strategic distraction."

While the votes counting continued day after day, "The yuan-dollar exchange rate swung wildly in the wake of the US presidential election, but ended on a 28-month high for the Chinese currency as Democratic candidate Joe Biden appeared to inch closer to victory."

'USA Today' looked ahead and stated: "Democrat Joe Biden's victory in the presidential race will provide a boost to a U.S. economy battered by the COVID-19 pandemic as his bold spending plans and stauncher support for trade and immigration more than offset the drawbacks of new taxes and regulations, top economists say."

# Good-Bye St. Thomas X-Mas Shopping

This Christmas little to no British Virgin Islands residents will be rushing to St. Thomas for their annual Christmas shopping in the US Virgin Islands thanks to COVID-19 precautions that make the previously common one day trip untenable.

Questions about whether same-day travel to the United States Virgin Islands, which residents have enjoyed for decades can be resumed was put to both Premier and Minister for Finance Hon. Andrew Fahie and Minister for Health and Social Development Hon. Carvin Malone during an update to the Territory on 10 November.

While neither Premier Fahie nor Minister Malone said that a one-day trip will not be allowed; both explained that any one-day trip will be accompanied by quarantine and COVID-19 tests. This response comes weeks before the festive season begins which is usually a time when ferries are filled to capacity with shoppers for Kmart, Pricemart and Cost U Less.

In noting that COVID-19 precautions would be applied to any quick run to the neighbouring Virgin Islands the Premier said: "It is not that these things are being done in a negative tone at all. We have

to understand that travelling is not the same. No one can just get up now and go to St. Thomas today and come back this afternoon with a bucket of Kentucky Fried Chicken, shop by Kmart or whatever the case may be – those days are gone."

"If you are going to shop and you are coming back you better shop for four days worth of Kentucky because you will be in quarantine - or whatever it is you shop for - make sure that it lasts you for four days," the Premier added.

While commenting on the matter Hon. Malone also said that there is going to be a change to the USVI shopping runs. "One day will cost you four and two or three tests."

Further, the Minister said, "We have circumstances around us so if you want to quarantine for four days well you go out for one day...with the appropriate tests. If you want to avoid the tests and only do one, well maybe we can choose to do the fourteen-day quarantine; so that you can just do the one test if you are afraid of the particular three tests that you may have or the two."

Hon. Malone noted that the same goes for persons who have to travel for medical purposes.

# Long Overdue 911 Upgrade At The End Of The Tunnel

The promised 911 Emergency Call system upgrade that has been in the pipeline for almost four years is inching closer to implementation now that the legislation to make the new system operational is heading to the House of Assembly.

The upgrade to how persons in the BVI can call for help was promised more than three years ago but was stalled. Legislative issues were mentioned as one of the reasons for the standstill of the deployment of the new system.

Now the changes in the way the 911 system operates are expected to take effect shortly because the House of Assembly is planning to make the legislative changes during this session of the House.

The announcement of the upcoming legislative amendment was made by His Excellency Governor Augustus Jaspert during the Speech From the Throne delivered on 5 November.

In sharing the news the Governor said: "The Emergency Call Handling Bill is needed at this time. Our Government has established a Next Generation 911 Emergency Call Handling Centre for the Territory of the Virgin Islands, which is designed to enable the sharing of valuable lifesaving emergency response and law enforcement information through the use of smart mobile and fixed communications."

"A critical element to the full functioning of this Centre is the

enactment of supporting legislation. Hence, 911 Emergency Call Handling Bill will be introduced to meet the aims and purposes of the Call Handling Centre," the Governor added.

Last year it was announced that the Territory would have had a state of the art 911 system that allows persons distressed to signal for help via text message and video by the end of 2019. That disclosure about the new upgrades to the current 911 system was made during an interview with Project Manager Russell Jones.

In that interview, Jones disclosed that the modernising of the system was expected to be completed by the end of 2019. Jones noted that the service was not where it ought

to be, and pointed out that the improvements being made will be a major leap for 911 services in the Territory. In commenting on why the new upgrades are necessary the Project Manager said: "We are so far behind as far as 911 legislation."

Since 2017 it was announced that the SMS features were going to be added to the 911 capabilities. Unfortunately, this installation was subjected to various setbacks. "SMS and 911 aren't active yet. The storm held it up. Things that were ready to go off got delayed because we weren't able to activate..." the Project Manager noted.

## 26 More Receive Certificates Of Naturalisation

A second set of twenty-six new British Overseas Territories Citizens (BOTC) received Certificates of Naturalisation at a ceremony held on November 6.

Governor Jaspert reminded those present that this new status entitles them to carry a Virgin Islands Passport and to apply for British Passports.

Premier and Minister of Finance Honourable Andrew A. Fahie was unable to attend the ceremony but sent his regards to the new citizens via Deputy Premier and Minister of Education, Culture,

Youth Affairs Fisheries and Agriculture Dr. the Honourable Natalio Wheatley.

Honourable Wheatley welcomed the new citizens to the British Overseas Territory family, and reminded them that their diverse backgrounds mean they are well placed to promote harmony within the Territory.

"I would urge you to be on the forefront of the fight against dis-unity; the

fight against hatred; the fight against xenophobia," Honourable Wheatley stated. He added, "Despite all our differences, we are all united in love for this Territory and seeking to make it a better place for all of us."

The day's ceremony was the second of three planned ceremonies organised to allow for safe physical distancing.

## Immigration Transformation And Border Security Underway

The Immigration and Passport Act (CAP.130) will be revised and amended to align with international standards and best practice and to ensure that the legislation is in keeping with the transformation plan for the Department of

Immigration.

This announcement was made in the First Sitting of the Third Session of the Fourth House of Assembly (HOA) on Thursday, November 5, where His Excellency the Governor, Augustus J.U. Jaspert delivered the Speech

from the Throne outlining the Government of the Virgin Island's Legislative Agenda.

Changes to the Act will include having a variety of systems online, which will result in the Immigration Department being more

effective and efficient; giving the department the power to charge compound fees on persons who enter the country illegally without having to take them to court, and amending the Immigration policy to allow longer stay for investors in an effort to attract more business to the British Virgin Islands.

Shortly after the Speech from the Throne was delivered, Minister for Natural Resources, Labour and Immigration Honourable Vincent Wheatley give his perspective on the immigration transformation.

Honourable Wheatley said, "What we're going to be doing is bringing our processes online, we're going to make sure that you don't waste a lot of time in line processing stuff."

Minister Wheatley went on to speak about attracting more businesses to the BVI to boost our economy.

Honourable Wheatley said, "Also we're going facilitate more businesses coming to the BVI with persons being able to stay longer and work from the BVI. These things will have a direct benefit to the economy financially."

The Immigration Department continues to contribute to the security and prosperity in building a stronger and better BVI, by operating fair but firm immigration control that regulates and facilitates the movement of people through BVI borders while


exercising sound judgment in the performance of duties. The department also ensures that the needs of their customers are met

in an efficient, effective and courteous manner in accordance with BVI Immigration laws.

The Speech from the Throne is delivered at the beginning of each new session of the House of Assembly. The Speech from the Throne is prepared within the Premier's Office in consultation with Ministries. The Speech is then deliberated and approved by the elected Government of the Virgin Islands. Subsequently, the Speech is delivered to the Governor. During the First Sitting of the HOA, the Premier and Minister of Finance, then moves a motion to invite the Governor to read the Speech from the Throne. The Government's Legislative Agenda is monitored by the Premier's Office to ensure that it moves forward with fortitude and determination.

## Environment And Climate Change Are Legislative Priorities

The Government will introduce Environmental Management and Climate Resilience Act during the Third Session of the Fourth House of Assembly to provide for the sound and sustainable management of natural resources in the Territory.

On Thursday, November 5, His Excellency the Governor Augustus J.U. Jaspert in delivering the Speech from the Throne outlining the Government of the Virgin Island's Legislative Agenda explained that the act focuses on establishing the legal framework for the improved management of the environment and the conservation of biodiversity. He added that it will help to establish the institutional framework to manage the causes of and impacts from climate change.

In an interview with the Department of Information and Public Relations following the speech, the Minister of Natural Resources, Labour and Immigration Honourable Vincent Wheatley spoke about the legislation underway from his Ministry as presented in the Speech from the Throne.

These legislations are going to help us benefit more from our natural resources."

# GLOBAL NEWS BRIEF

**CARIBBEAN** - Regional leaders have extended their congratulatory messages to President-elect Joe Biden and his Vice President-elect Kamala Harris on their victory in the 2020 US presidential election on Saturday.

The statements came after major US media outfits have called the election for Biden.

Barbados' Prime Minister Mia Mottley, in a statement, noted that "America has spoken and the world is inspired."

"The people and Government of Barbados warmly congratulate President-elect Joe Biden and his Vice President-Elect Kamala Harris, the first woman and person of colour to hold that position. I am sure that we in the Caribbean will look forward with optimism to working with the new administration to confront a number of global issues from the awful pandemic to the climate crisis to the pursuit of racial justice. There is much work for the world to do if we are to lift up our people across the globe to fight these issues that know no boundaries but require character and leadership to defeat them."

In a tweet, Prime Minister of Jamaica, Andrew Holness congratulated Kamala Harris, who bears Jamaican heritage, for a monumental accomplishment for women all over the world.

Meanwhile, Antigua and Barbuda Prime Minister Gaston Browne congratulated Biden through a letter.

"As you begin to plan for your assumption of office in January 2021, I know that you will be cognizant the Caribbean is the "third border" of the United States and that our governments have a joint responsibility to cooperate in economic and social development that will keep our collective neighbourhood prosperous."

Saint Lucia's Prime Minister, Allen Chastanet, said that the results indicate that the American people have decided that Joseph Biden and Kamala Harris will be their leaders.

Trinidad and Tobago Prime Minister, Keith Rowley also looks forward to the strengthening of those bonds in the months and years ahead given the close familial ties of both countries and their joint economic and security connections.

**SANTO DOMINGO** - The Tax Agency (DGII) reports a surplus in October 2020. The DGII says that collections in October were RD\$45.48 billion. This is RD\$8.7 billion more than what had been estimated in the National Budget. It is RD\$3.26 billion

more, or 7% more, than what was collected in October 2019.

The DGII reports that from January to October 2020 an amount for RD\$361.82 billion has been collected. This is RD\$15.61 billion more than the estimate, equivalent to a compliance level of 104.5%.

The DGII says that October is the first month this year in which original estimates made for the 2020 National Budget (pre-Covid) has been met. The DGII says that the figure does not include the advance payment made by Barrick mining corporation. [DR1]

**LONDON** - SOTHEBY'S was sued last week, by New York's attorney general, who accused the auction house of defrauding the state by helping a client avoid millions of dollars of sales taxes on art he purchased.

Attorney General Letitia James claims Sotheby's helped the client, a collector of contemporary art, obtain false tax exemption certificates known as resale certificates by letting him portray himself as an art dealer rather than as a collector.

James said this enabled the client, who runs a shipping business and lives mainly outside the country, to avoid sales taxes on more than \$27 million (£21 million) of art he bought for personal use between 2010 and 2015, including for his Manhattan apartment.

The complaint said Sotheby's accepted four resale certificates despite "overwhelming" evidence the purchases were for personal use, including when senior Sotheby's

personnel visited the apartment "to admire his artwork on the walls." [EuroWeeklyNews]

**WASHINGTON** - Some of the mayhem that will follow Donald Trump losing the presidential election is already known. The US exited the Paris climate agreement on Wednesday regardless. The coronavirus pandemic that has already claimed almost a quarter of a million lives in America will worsen. Trump has hinted he will attempt to fire Dr Anthony Fauci, the nation's leading expert in infectious diseases.

But Trump's defeat also sets the clock ticking on 11 weeks that some analysts believe could be the most dangerous period in US history, the time before the 20 January inauguration of Joe Biden during which a vengeful president can wreak havoc if he chooses to do so.

"If Trump loses power he'll spend his last 90 days wrecking the United States like a malicious child with a sledgehammer in a china shop," said Malcolm Nance, a veteran intelligence analyst and political author, speaking before the result of the election was known. [The Guardian]

**PENNSYLVANIA** - A federal judge in Pennsylvania Friday denied a GOP-led effort to toss votes within a county that let voters fix errors on their absentee ballots, The Hill reported.

District Court Judge Timothy Savage, an appointee of former President George W. Bush, rejected the lawsuit — a decision that came two days after he'd been dubious about the GOP arguments.

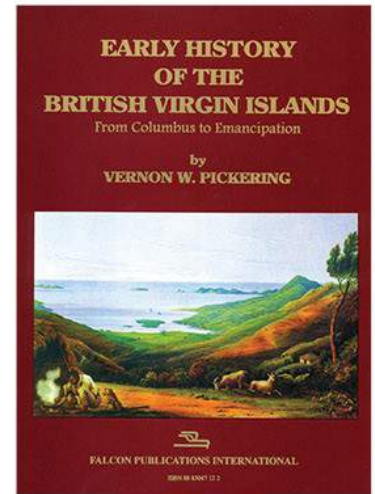
According to Politico, Savage's skepticism came out in an exchange with a lawyer for GOP congressional candidate Kathy Barnette during a Wednesday hearing in Philadelphia.

Lawyer Thomas Breth argued that the Pennsylvania Supreme Court concluded the law prohibits counties from letting voters who made a mistake on their ballot to complete or package their mail-in ballots to correct those errors.

"I'm not sure about that," Savage said, Politico reported. "Is that exactly what was said, or is what was said that there is no mandatory requirement that the election board do that? ... Wasn't the legislative intent of the statute we are talking about to franchise, not disenfranchise, voters?" [Newsmax.com]

**WASHINGTON, (Xinhua)** -- The U.S. Centers for Disease Control and Prevention (CDC) on Sunday reported a record-high average daily increase of COVID-19 cases at nearly 100,000, a new milestone

The seven-day average daily cases and deaths have been on sharp rise recently, and stood at 99,320 and 938, respectively, as of Sunday, CDC data showed.

Daily case count in the country set a new record on Friday at 132,830, which is an all-time high in the United States and around the world, according to the CDC.

Saturday was the fourth day in a row the country broke its case count record, according to The COVID Tracking Project.

A total of 715,000 cases were reported last week, which means that one in every 462 people in the United States tested positive for COVID-19 last week, according to the project.

"Hospitalizations are also spiking in all regions, and are now close to the totals we saw in the spring and summer surges," the project tweeted.

There are about 56,000 Americans currently hospitalized with COVID-19.

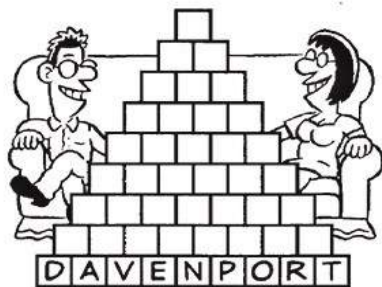

## A Happy (and Healthy) Thanksgiving!

**Most people eat more at Thanksgiving dinner than they consume in a normal day,** and then continue overeating at year-end. So it helps to have a plan in place to avoid any holiday gobbling that you might pay for later.

**Turkey, yams, mashed potatoes,** green beans and cranberry sauce are all nutritious, so long as lots of salt, sugar and butter haven't been added to them, says Kathleen Duran-Thal, director of nutrition at Cooper Healthy Living at the Cooper Clinic in Dallas.

**An earlier study by researchers at the National Institute of Child Health and Human Development and the National Institute of Diabetes and Digestive and Kidney Diseases** found that Americans usually gain only one pound during the winter holidays, but the weight put on then isn't shed in the new year.

**Those findings contradict many people's views that they gain five to 10 pounds between Thanksgiving and New Year's Day.** Researchers said the effects of weight gain at year-end, however, are worth worrying about because they contribute to increased weight over time.

**Keeping weight stable in the fall and winter may help prevent age-related weight gain and associated diseases,** says Dr. Riva Rahl, medical director at Cooper Wellness. In addition to not looking or feeling top-notch, adults with excess weight are at greater risk of heart disease, high blood pressure, diabetes and certain cancers, she says.

**Cooper Wellness experts say to go ahead and enjoy your favorite Thanksgiving foods,** but consider making healthy choices at your turkey dinner. They offer some tips for keeping you from fiddling with your belt at the end of the meal.

1. First of all, don't arrive at a Thanksgiving dinner hungry. Eat a good breakfast, and maybe even lunch that day.

2. Fill half your plate with vegetables, one quarter of it with lean meat, and one quarter with starches like mashed potatoes and turkey dressing.
3. Choose white-meat turkey and avoid eating the skin.
4. Avoid gravy. Turkey doesn't need to be smothered in gravy to taste good. If you want gravy, just drip a little on your meat and potatoes.
5. Limit yourself to small helpings of heavily sweetened yams and cranberry sauces.
6. Use restraint when dinner rolls are passed around. Buttered rolls may melt in your mouth, but they're full of calories, so eat only one.
7. Try sampling in moderation the many foods that you have looked forward to. And consider bringing something healthy to the dinner, like a side dish that's low in fat, sugar and salt.
8. Eat slowly. By eating Thanksgiving dinner slowly, your body has time to register when it is full so that you don't consume too much.
9. At dessert time, try to choose the lightest options. Pick pumpkin over pecan pie, for example, and avoid 200 calories in the process. Or just eat half a piece of pie, and pass on whipped toppings and ice cream. As dinner winds down over coffee, avoid any plates of additional sweets that may be sitting on the table.
10. After Thanksgiving dinner, take a walk with your friends or family. Fifteen minutes of walking will get your blood circulating and can burn off 100 calories, says Susie Kania, exercise physiologist and director at Cooper Wellness. The fresh air will invigorate you after a long stay at the table.

### LIGHT SWEET POTATO PUDDING

Agave syrup is a natural sweetener that doesn't raise your blood glucose levels. This is a great dessert for everyone, but is particular good for diabetics.

- 1 1/3 cups mashed, cooked sweet potato
- 1/2 cup agave syrup
- 2 teaspoons ground cinnamon
- 2 teaspoons grated orange zest
- 1 teaspoon salt
- 1 teaspoon ground ginger
- 1/2 teaspoon ground cloves
- 1/3 cup egg substitute
- 16 ounces evaporated skim milk
- 1/2 cup light whipped topping, optional
- 1/2 cup chopped, toasted walnuts, optional

#### Cooking spray

1. Heat oven to 375 F.
2. In a large bowl, combine sweet potato, syrup, cinnamon, orange zest, salt, ginger, cloves and egg substitute. Beat at medium speed with a mixer until smooth. Add milk; mix well.
3. Pour mixture into a 2-quart casserole coated with cooking spray. Bake at 375 F for 1 hour or until a knife inserted near the center comes out clean. (For individual servings, pour 2/3 cup potato mixture into each of 4 custard cups. Bake at 375 F for 40 minutes or until a knife inserted near the center comes out clean.)
4. Let pudding cool. Cover and chill for 2 hours. Serve with a tablespoon of whipped topping and sprinkle with walnuts, if desired. Makes 4 servings (2/3 cup per serving, 88 calories).

### Tourism Must Get Back On Track, Bartlett

KINGSTON, Jamaica; November 09, 2020: Tourism Minister, Hon. Edmund Bartlett says the industry is a key driver of the Jamaican economy and urges stakeholders to view the unprecedented crisis brought on by the pandemic as a transformational opportunity to help get tourism back on track.

Speaking at the opening of the first-ever virtual staging of the Jamaica Product Exchange (JAPEX), the Minister said, "Tourism must get back on track. Pre-pandemic, there were 1.5 billion international tourist arrivals; travel and tourism accounted for 10.3% of global GDP, and it employed 1 in 10 persons around the world. At home, as we welcomed 4.3 million visitors, the sector earned US\$3.7 billion, contributed 9.5% to the nation's GDP and generated some 170,000 direct jobs."

Bartlett noted that the Government is doing its part to rebuild the economy and tourism will

play a key role. He shared that despite Covid-19, proactive measures were being implemented that will ensure a tourism product that is safe, attractive for visitors, and economically viable for all tourism stakeholders.

Despite the challenges caused by the pandemic, Bartlett remains cautiously optimistic as data from the Jamaica Tourist Board indicate that the industry is slowly rebuilding.

Preliminary JTB figures indicate that since reopening on June 15, the country has recorded a little over 211,000 passengers to the island; June to September earnings amounted to US\$231.9 million, and hotel occupancy rates are slowly inching up. A 40% increase in arrivals over the winter season when compared to the preceding periods of massive downturn, is also projected.

"In terms of airlift, most of the major airlines serving the destination are increasing service as the demand picks up. These include the following airlines in the Americas: American Airlines, Delta, JetBlue, United, Southwest, Air Canada, WestJet, and Copa," he said.

Expedia also reported that searches for Jamaica's Montego Bay rose 15 percent in July, and Jamaica was among the most-searched-for destinations in the Caribbean.

"I have received reports that some of our hotel properties have reported that they are reaching up to 60% occupancy through a combination of international and local guests, with numbers reaching nearly 90% around holiday weekends," he said.

The Jamaica Product Exchange (JAPEX) is the

premier trade event and the single most important business generator for Jamaica's tourism industry. It facilitates pre-scheduled appointments for leading wholesalers and tour operators with hundreds of Jamaica's leading tourism suppliers to conduct business negotiations.

Since its 1990 inception, The Jamaica Product Exchange (JAPEX) has been a joint project of The Jamaica Hotel and Tourist Association (JHTA) and the Jamaica Tourist Board (JTB). It is supported by every Jamaican organization involved in the development, promotion and sale of the Island's tourism product.

According to the organizers, the three-day event, which is being held virtually this year due to the novel coronavirus pandemic, has more than 2,000 buyer and supplier delegates, travel agents and media representatives from countries such as the UK, USA, Canada, China, India, Russia, Spain, Mexico, Brazil, Colombia, and Argentina.

### CARICOM Election Observation Mission To The St. Vincent And The Grenadines Elections, 5 November 2020

#### PRELIMINARY STATEMENT

The Secretary General of the Caribbean Community, his Excellency Irwin LaRocque, was pleased to deploy the CARICOM Election Observation Mission to St. Vincent and the Grenadines to observe the general election of 5 November 2020. This followed the invitation from the Prime Minister, the Honorable Dr. Ralph E. Gonsalves.

On the days prior to the elections the six-person CARICOM Election Observation Mission (CEOM) met with stake holders and other civic groups virtually as part of the precautionary measures. The over twenty groups included two Trade Unions, the leadership of the Police Service, the Police Welfare Service, the Women's Advocacy Group, the National Monitoring

and Consultative Mechanism (NMCM), a body comprising most of the churches and other groups, the National Council of Women, the representatives of the blind and the disabled. They also met with the two main political parties, represented by the Honorable Prime Minister and the Honorable Leader of the opposition, Dr. Godwin Friday.

On Election Day the Mission was divided into four teams (two with 2 members and two with 1 member). The Mission did not have the resources or the time to visit the Grenadines but the member visited every polling station.

The Mission's assessment of the Election Day was that there were no incidents of intimidation of voters inside or outside of the voting precincts. The

agents of the parties also testified that there were no irregularities and that the process was generally peaceful and orderly. At the polling stations, the voters' identification card was collected by the Presiding Officer who called out the name and number of the said voter for the benefit of the agents of the parties. At every polling station the voters were told about the way to vote and how to return the ballot which was inserted in the ballot box by the Presiding Officer. The Mission observed that adequate health measures were in place to protect voters against the COVID-19 pandemic at the polling stations visited. On the day of the election each voter received a mask. Measures were also put in place for more than two hundred voters in quarantine to exercise their franchise.

All members of the CEOM agree that the process was conducted according to law and was done without any intimidation or fear. They also reported that there was adequate security at each location and that the officers displayed a very professional approach to their duties.

I therefore conclude that the Election was free and fair and free from fear and that the outcome presented the will of the people of St. Vincent and the Grenadines.

We congratulate the voters for the discipline displayed on Election Day and we wish to thank all the stake holders, including the leaders of the Political Parties, Civil Society and the Church for the warm welcome and cooperation which contributed to the success of the mission.

## Biden: 'Embarrassment' That Trump Has Not Conceded Election Loss

U.S. President-elect Joe Biden said Tuesday he is not worried about President Donald Trump's refusal to concede after last week's national election, but that he thinks it is an "embarrassment" for Trump and the country.

"I think it will not help the president's legacy," Biden told reporters in Wilmington, Delaware, where he is working on his transition to power and planning his first steps after his expected inauguration on January 20.

Trump, without offering major evidence of voting or vote-count irregularities, has filed more than a dozen lawsuits in several states, trying to overturn Biden's projected election victory.

But Biden said, "We've already begun the transition" and that Trump's refusal to concede "does not change the dynamic." Biden is focusing first on addressing the coronavirus pandemic, which has killed more than 238,000 Americans — the most in any country.

Biden said he might make a couple of key appointments to his administration

before the annual Thanksgiving holiday, which falls on November 26 this year.

"The fact they're not willing to acknowledge our victory is not of much consequence," he said. Trump, in trying to contest the election results, has kept his administration officials from cooperating with Biden's representatives to arrange a transition of power.

The General Services Administration, a U.S. government agency, has refused to certify Biden's presumptive victory. That is keeping Biden officials from taking over office space in federal agencies, being assigned government email addresses and receiving federal money to fund the transition.

But Biden brushed it aside without much concern.

"We can get through without the funding," he said, while also acknowledging he had yet to start receiving the Presidential Daily Brief on U.S. intelligence findings around the world.

"The PDB would be useful," he said, "but I'm not the sitting president."

Biden said there was no need for his team to file litigation to try to force acknowledgment that he had won the election.

"I think it will all come to fruition on January 20," he said.

Asked what he would tell Trump if he were watching the news conference, Biden smiled and said,

"Mr. President, I'll look forward to speaking with you."

## US Supreme Court Appears Ready to Uphold Health Care Law

WASHINGTON - A majority of the U.S. Supreme Court signaled Tuesday it is likely to rebuff a Republican effort to strike down the country's Affordable Care Act health care law that provides medical insurance for millions of Americans.

At a hearing in Washington before the nine-member court, two conservative jurists, Chief Justice John Roberts and Justice Brett Kavanaugh, both indicated they were inclined to join three liberals on the court in keeping the law in effect.

Enacted in 2010 and fiercely opposed by Republicans since its inception, the Affordable Care Act sought to incentivize Americans to purchase private health care insurance while also expanding access to government-funded health care for the poor.

Republican state officials, backed by the administration of President Donald Trump, asserted at the hearing the entire law should be overturned since Congress in 2017 reduced to zero the amount of a tax

penalty Americans would have to pay if they did not buy health insurance.

But Kavanaugh, whom Trump appointed to the court, said, "It does seem fairly clear that the proper remedy would be to sever the mandate provision and leave the rest of the law in place."

Roberts said much the same: "Congress left the rest of the law intact when it lowered the penalty to zero."

Three court liberals — Stephen Breyer, Elena Kagan and Sonia Sotomayor — also have supported the law, popularly known as Obamacare after former President Barack Obama, who championed its passage.

One of the justices hearing the case was Justice Amy Coney Barrett, a recent Trump nominee who gives conservatives a 6-3 ideological majority on the country's top court. Before Trump appointed her to an appellate court judgeship in 2017, Barrett had criticized Roberts in a law journal for his key vote in a 2012 case upholding the constitutionality of Obamacare, with

Roberts viewing the required payment for not buying insurance as a tax.

It is not known how Barrett might vote in the latest challenge to the law, which has risen in popularity over the years and enjoys majority backing, according to opinion polls.

After the court hearing, President-elect Joe Biden told reporters it was essential for the law to remain in effect, saying it has "saved countless families from financial ruin."

He attacked Republican efforts to overturn it as "simply cruel and needlessly divisive."

Tuesday's case was brought by Republican officials who argued the health insurance mandate was critical to the law, and without a penalty, the entire statute should be overturned.

When Congress first passed the law, the rationale for the penalty payments was that requiring people to have coverage would bring healthier people into the system who would pay premiums without using many

services, helping to offset costs of individuals who needed more care, including those with pre-existing conditions who had previously been denied coverage.

Texas and its partner states have argued that eliminating the individual mandate would create a cost imbalance and push health costs unfairly higher for many people.

The Democratic-leaning state of California has supported the law, arguing that Congress, by eliminating the penalty payments in 2017 and keeping the remainder of the law intact, showed it had no intention of abandoning the statute.

When the court heard the 2012 challenge to Obamacare, six current justices participated in the case, with Justices Samuel Alito and Clarence Thomas voting to strike down the entire law. Roberts, Breyer, Kagan and Sotomayor voted to uphold it.

Justices Barrett, Kavanaugh and Neil Gorsuch — all Trump nominees — have since joined the court.

# Democracy not autocracy must prevail

Democracy, including free and fair elections, is under siege in the Western Hemisphere, including now in the United States of America (US). But the country that cries out for immediate vigilance is Bolivia.

Even though elections, held on October 18, gave overwhelming and convincing victory to the Movimiento al Socialismo (MAS) and its leader, Luis Arce, right wing groups have organized protests demanding that the results be annulled by military intervention. These protests are being encouraged by the interim government which remains in office until November 8.

The interim government was installed by the military when the October 2019 elections were overturned with the help of governments in North and South America opposed to former President Evo Morales' socialist stance. These same governments funded and manned the OAS election observation mission and audit team that, questionably, pronounced the elections rigged.

In previous commentaries, I underlined the resentment of MAS by the light-skinned descendants of Europeans who back the Civic Community (CC) party that forms the interim government. MAS is mainly the party of the indigenous people.

The current protesters are being mobilised by the Santa Cruz civic committee (CCPSC), which was in the forefront of demonstrations insisting on the annulment of the October 2019 elections. The protestors might have secured more official support for their current protests were it not for the fact that, in light of the overwhelming victory of MAS and Luis Arce, the OAS and other electoral observation missions were constrained to declare the elections free and fair.

Nonetheless, the demonstrations are gathering steam, fortified by strikes called by the CCPSC on the eve of Arce's swearing-in as President. The President of the CCPSC, Rómulo Calv, has planned "staggered strikes" to block roads and organize crowds of demonstrators.

Far-right groups have also engaged in violence and are openly demanding military intervention to overturn the elections and to abort Arce's swearing-in.

On November 1, Arce called on the interim government to act against protesters demanding military intervention to prevent his inauguration. He was supported by the country's Ombudsman, Nadia Cruz, who called for immediate legal action to be taken. The calls were treated with scant regard, encouraging the organisation of even more protests.

It was indicative of the abuse of power in the OAS that a meeting of the body's Permanent Council was summoned on November 5 to give the interim government's foreign minister and her Ambassador to the OAS an opportunity to make political speeches that did not condemn the violent demonstrations or the calls to overturn the election results.



Even more alarming was the support, expressed by some governments, for the interim regime and their justification for the annulment of last year's elections.

The OAS meeting underscored that some governments in the Americas, including those claiming liberal credentials, remain insistent on undermining other governments that do not bend to their will. At the same time, governments that deserve condemnation for their autocratic actions, have escaped censure.

The silence of the OAS and many governments in the hemisphere about events in Bolivia is contributing to the undermining of democracy and democratic principles that they claim to uphold. The absence of condemnation of the acts of violence by groups demanding that legitimate elections be overturned, is causing the supporters of MAS to take action to protect themselves.

MAS supporters are mounting counter-protests. Violent clashes have so far largely been avoided, but the death of a mining union leader, Orlando Gutiérrez, on 28 October, allegedly from injuries sustained in a beating by far-right protesters, has served to escalate turmoil.

The scene is being set for continuing unrest in Bolivia and for placing Luis Arce's Presidency in jeopardy. The same governments that are now silent while the far-right groups in Bolivia incite and commit violence against the MAS and its indigenous supporters, will undoubtedly condemn him should he take action to stop them.

It remains doubtful where the military stands in all this. In the protests surrounding the 2019 elections, it did nothing to stop violent protests by the far-right. In contrast, when MAS supporters protested the interim government's continuous delay of promised elections, the police and army stood by while "shock groups", organized by fascists, brutally attacked them. It has to be hoped that the military will stand by their constitutional duty.

Bolivia is blighted by the problem that has beset the countries of South America for centuries, and that is the sense by a privileged elitist group that they are entitled to run the country for their own benefit, keeping their booted heel on the backs of the poor indigenous people.

Those elitist groups have traditionally formed lucrative alliances with foreign governments, corporations, and banks – all of which have exploited these countries, enriching, and empowering themselves.

It is time for democracy, the rule of law, and the rights of the majority, freely expressed in general elections, to triumph over autocracy and privileged interests. Bolivia's elected President must not only be sworn-in, but his government should be given the chance to function democratically in the interest of all the people of Bolivia. And governments in the Caribbean, which have emerged from the struggles of slavery and exploitation, should support democracy in Bolivia. History summons such Caribbean support.

## CONGRATULATIONS TO BIDEN AND HARRIS

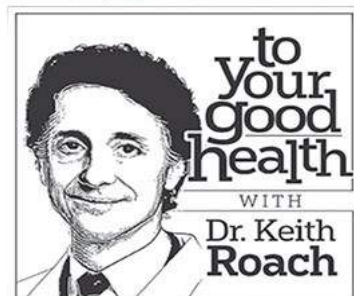

and another quarter contained the psychoactive component THC. For food allergies, I would recommend strongly against using any unproven treatment. Egg allergies have a broad range of severity in children, from mild rash to life-threatening airway swelling and anaphylaxis. Although many children outgrow egg allergies, your friend should listen to her daughter's doctor, not her CBD-supporting friend.

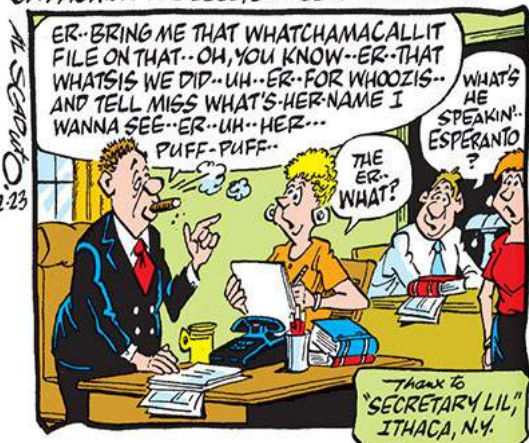

### CBD Recommendation Awaits More Research

DEAR DR. ROACH: I have a friend whose daughter has an egg allergy. She said her daughter will break out in a rash if she eats anything that even has trace amounts of egg in it. Another friend of hers told her to use CBD oil to prevent reactions, but I am skeptical. I cannot find anything credible to support the claim. What are your thoughts? — E.B.P.

DEAR DR. ROACH: I recently changed primary doctors, and I saw the report of my echocardiogram. It said I have "mild left ventricular hypertrophy with some diastolic dysfunction." Could you tell me what this means and if it is serious? — C.B.

ANSWER: An echocardiogram uses sound waves to take precise images of the heart. The cardiologist interprets those images to make statements about the anatomy of the heart, including thickness of the walls of the heart, as well as its function.

ANSWER: Almost every day I hear another claim that cannabidiol, the major nonpsychoactive component of cannabis, is effective for some medical condition. Unfortunately, the evidence of effectiveness of CBD is very limited.

The left ventricle is the chamber of the heart that pumps blood to all of the body, having received oxygenated blood from the lungs. Consequently, it is the thickest of the chambers. "Hypertrophy" means "too much growth" — that the wall is too thick. "Diastole" is the part of the cardiac cycle where the ventricles fill up. This should happen at very low pressures. In diastolic dysfunction, which commonly accompanies left ventricular hypertrophy, the left ventricle requires higher pressure to fill that thickened and stiffer wall.

The sole Food and Drug Administration indication for CBD is for the treatment of two uncommon childhood seizures: Dravet syndrome and Lennox-Gastaut syndrome. There is preliminary evidence that CBD may be useful for anxiety disorders, some types of sleep disorders and chronic pain. There is active research on other conditions, including asthma, multiple sclerosis and contact dermatitis. I believe it is likely that CBD will be proven effective for other conditions, but until there is better evidence of effectiveness, I cannot make a recommendation to use CBD (outside of the two forms of childhood epilepsy for which it is indicated).

LVH and diastolic dysfunction are most commonly results of high blood pressure. Some of the many medicines we use to control high blood pressure are good at helping the heart fill at lower pressure. Not everybody with these findings on an echo needs treatment. The key word in your report is "mild," which generally indicates no need for treatment beyond careful blood pressure monitoring.

Although there are laws in all 50 states legalizing CBD, the federal government's position is still that cannabis extracts are Schedule I controlled substances, although they do not seem to be enforcing action against CBD at present. Unfortunately, independent laboratory analysis of available CBD products show that about a quarter of them have less CBD than advertised,
