HON. MALONE CALMLY ENDURES "LANGUAGE" OF ANTI-VAXXER TALK SHOW HOST

After spending more than a year battling the COVID 19 pandemic, acquiring vaccines, and overseeing a public inoculation campaign, Minister for Health and Social Development Hon. Carvin Malone is now forced to face off against Anti-Vaxxers.

For many years countries like the United States of America have grappled with the views of persons who are not in favor of getting their children vaccinated. This movement was named the Anti-Vaxxer movement, and recently it seems that this philosophy has taken some root here in the BVI. Persons who are against the COVID 19 vaccine are informally joining their voices.

Vaccine hesitancy normally produces a delay in acceptance, or refusal of vaccines despite the availability of vaccine services. Vaccine hesitancy is complex and context-specific, varying across time, place, and vaccines. It is influenced by factors such as complacency, convenience, and confidence.

The BVI situation of anti-vaccination further escalated when it was reported that local companies are allegedly terminating staff who were not vaccinated. This report of layoffs prompted a shocking anti-vaccination face-off on live radio. This confrontation was between Minister for Health Hon. Carvin Malone and Radio Station owner and Host Floyd Burnett. During that exchange, the radio host who champions the Anti-Vaxx views reportedly referred to the Hon. Malone as the Minister of Death and said he hopes the Minister takes a dive and never surfaces.

The Anti-Vaxx minority is proud to declare that they do not intend to take the Astra Zeneca vaccine that is being offered by the government. Some say that they do not care if it means that they would not be able to travel. For this group, the cause became stronger when a prominent resort in Virgin Gorda allegedly gave its employees 90 days to become vaccinated, or

allegedly be placed on a temporary lay-off. According to cms wire companies have the right to require that all employees get vaccinated before they return to work on their premises, although a few states could enact legislation barring discrimination based on vaccination status.

The Radio Exchange

The strong feeling Anti-vaxxers hold against the vaccine was on full display on Monday 10 May when Burnett during his Tola Radio show the 'Da Morning Braff' called the Health Minister and made fiery comments over the government's push for the population to become fully vaccinated.

During his outrage, Burnett accused the Health Minister of trampling on the rights of the citizens and residents of the Territory. As he attempted to make contact with the Minister, Burnett made disrespectful and disparaging comments: "If we don't get him [Hon. Malone], we will leave him one nasty message... nobody elected this dude to be

our doctor. His first health concern should be his weight," he announced.

Once Hon. Malone answered, the Radio the Host commenced his questioning. He queried why even the vaccinated persons are still subjected to COVID 19 precautions. Burnett suggested that the vaccine should have been able to protect the person fully from the virus: "Vaccinated people still have to quarantine from 14 days from high-risk places. Doesn't that clearly highlight the vaccine does not work. Let us just stop at common sense," he said.

While calling for public protest the radio host declared, "It is time for us to push back...Why are we the people implementing the mark of the beast upon ourselves...Certain people have lost their jobs for refusing to take the vaccine...Why are they bullying those innocent workers. Where is the science?"

During his response to the tirade Hon. Malone indicated that he was just coming from the beach. The Minister interjected

the fiery comments stating: "You came off the weekend all excited, what is worrying you? ...You called me coming out the water at Cane Garden Bay, having a relaxing moment, my moment of solitude, my moment of relaxation only to be greeted with hostility. What is worrying you?"

The radio host responded: "You living your life in peace but you messing up other people's life... well I mess it up this morning...I asked you a question Minister of death, I asked you a question."

Hon. Malone calmly and respectably attempted to address the concerns of the staff layoffs as a result of non-vaccination. He said, "As it relates to the staff layoffs the Minister said, You haven't given me the facts as yet, every hotel has a right... everyone has to examine their vulnerability and then decide what level of exposure that they are exposed to."

"That is a subjective thing. ... Are they able to keep the persons in without actually intermingling with the guests," the Minister added.

The response did not seem to sit right with the Radio Owner

who declared, "Hon. Malone we are ready to march against you".

In response the Minister said, "... This doesn't seem like it would be a civil conversation at all...I always answer my phone, I always answer you, I'm coming out the beach and here you are ...Which of the Protocols don't you favor so that I can actually assist...At the end of the day, you have a narrative and you are looking for a few points to support them. You don't intend to be vaccinated, you said you have never taken one in your life. Why do you think it is your job to make sure that nobody takes it? ...Why do you think it is your job and your particular responsibility to go and spew out all this?" the Minister questioned.

"You are taking stuff out of context...I have five more minutes of swim, can I schedule a day that you can call or I can call," the Minister added.

In response, the radio host declared, "Here is what I want, I want you to dive for that five minutes, don't come back up. I tell you we marching...we had it sir we had it."

ECSC Has Difficulties Recruiting Judges

Over the last few years, the Eastern Caribbean Supreme Court had difficulties recruiting judges and had no alternative but to turn to the legislatures of the member states to pass an Act to upgrade the pension package.

During the House of Assembly sitting on 6 May Premier and Minister for Finance Hon. Andrew Fahie explained to the legislators that there is a need to make the position more attractive. Hon. Fahie explained that there is a situation where only certain applicants apply for the post and he said that

the court wants to widen the net of eligible applicants.

The BVI Leader commented during the debate of the Eastern Caribbean Supreme Court Judicial Officer Pensions Act. Mr. Fahie explained the objects and reasons of the new Bill: "We know the importance of our judiciary system...But we have seen as of late throughout all the member states the difficulty to attract judges to come and be part of that profession."

Hon. Fahie mentioned that the inability to source judges has been an ongoing issue. The Premier mentioned that at successive OECS meetings pleads were made for some support from the governments on the matter. The Premier mentioned that the regional court has been begging for assistance in this area from before his tenure and even now.

The BVI Leader recalled, "The Chief Justice, one of our very own has made numerous pleads and begging member states to please fix this problem and the recommendations were many...I listened to the Chief Justice and she was almost to her knees pleading

to adjust this situation... Of course, that was even before COVID"

Hon. Fahie said that the changes will help the court to field the best applicants. In noting how beneficial the changes will be the Premier added: "So that we can attract more judges especially while they are still within young age and worked in the profession for a while and become seasoned. They had to settle a lot of times for persons getting involved but doing so part-time or doing so close to when they are finished with their career and only do so

on certain conditions. One of the areas that came to the table was to see if member states can afford a salary increase."

"The next possible solution given to all member states in the OECS would be to work on a retirement package since the salary would be more of a challenge at that time for member states. This legislation aims to deal with the retirement benefits so to speak, more so to be more attractive to persons from within the Caribbean diaspora to serve as judges knowing that after serving you would be compensated accordingly while in this position," the Premier said.

Gaming & Gambling Legislation Forgotten: Opposition Leader Says

What happened to the gambling urgency, Leader of the Opposition Hon, Marlon Penn questioned as he announced that Government has not been pushing to facilitate the gaming industry as was previously touted.

During the NDP Radio programme on 3 May, the Opposition Leader recalled that Government was touting the gaming and gambling legislation and the resulting industry as a major economic injector. However, Hon. Penn said that now that the Bill has been passed the Government has not said much.

While noting that the Act was assented to and should be ready for implementation Hon. Penn said he is baffled by the silence on the matter. "I am not hearing that the Gambling Commission has been put in place. I am not

hearing anything going forward in terms of setting up anything," he said.

While further commenting on the proposed gambling industry the Leader of the Opposition said that he is not happy with how the Government implemented the gambling legislation.

Hon. Penn further mentioned that in the past he spoke about the potential impact of gambling on the BVI's financial services industry. "I feel it is going to create significant social hardship on our people. Persons are going through a very desperate period right now and when persons are going through these times they feel like going to a casino and try their luck to try to win ...We see it in St Maarten and the implication of the social impact it has on St Maarten and throughout places. It's a

problem," he added.

On 16 June last year, the House of Assembly debated the Gaming and Betting Control Act 2020. The legislation which was subsequently passed was a fulfillment of a promise made in the Speech from the Throne and the 2019 budget.

In presenting the objects and reasons of the Bill the Premier explained that the legislation would legalize gambling, betting and other forms of game of chance in the Territory. Most importantly, he said, the legislation would get rid of illegal lottery and gambling currently taking place in the Territory.

Gambling Legislation Attracts Criticism

Before the legislation having its reading in the House, religious persons announced their unhappiness about the legalization of gambling in the Territory. A statement was even released from the Cane Garden Bay Baptist Church.

The Premier said that the legislation was necessary not only as a revenue earner for the BVI, but to fix an underground gambling sector. "There are persons who are going around saying your government is introducing gambling. Mr. Speaker that is not a true statement, and I'll tell you why -Gambling is already taking place in the Territory; illegal gambling. There are lottery tickets on sale on our streets in the BVI. How much does the BVI make from the sale of these lottery tickets zero. We make nothing from the sales of those lottery tickets," the Premier explained.

"It is money that is pulled out of this economy here and then taken abroad. It is transferred out, most likely by circumventing the banks and

remittance services where we might have been able to collect some measure of taxation," the Premier added.

Hon. Fahie said that for years various betting and gambling activities have been taking place in corners of the BVI and nothing was done about it. "I am advised that there are other forms of gambling taking place where people bet on other kinds of sports. This is also betting on horse racing which we will be seeking to regularize and regulate to organizing to unlock its full potential as a sport that can generate revenue and create jobs," the Premier announced in 2020.

In further response to the complaints Hon. Fahie announced, "Many of the things some people try to create taboos and stigmas around; some of those same persons go abroad to do it also."

Businesses & Consumers Deplore Fees Increases

Business owners in the Territory are concerned about the recent rise in certain government fees which are making the cost of living higher and the cost of doing business unreasonable. The views of the business community was echoed by Chairman of the BVI Chamber of Commerce and Hotel Association Shaina Smith-Archer recently.

Smith-Archer who was a guest on the JTV programme The Big Story explained that several business owners are still facing hardships caused by the pandemic. She said that these hardships are being further exasperated by the increase in the Port Fees.

The Port Fees increase has been publicly criticized since January and the Premier had promised that some of the implementation was going to be stalled. However, the BVICCHA has announced that the promise has not comforted concerned business owners.

The BVICCHA Chair said that as a watchdog organization the Chamber is also still concerned about what seems to be an increase in the cost of doing business in this so-called Tax Haven that taxes anything in sight. "We have a situation where we have to decide, we are collecting less revenue over the last 12 months, and now we have an increase in the cost of doing business through government services fees increases. Where is the balance? We don't have additional revenue to put towards these increases in cost so that we can say ok we'll absorb that and not pass it on to the consumers," Smith-Archer stated.

She explained that despite the government's announcement that the port fees will be delayed in some instances, there has been no visibility of this. "One supermarket was saying to me

it's upwards of a million dollars a year additional across the board in terms of what these fees translate to them. I expect that because the government is not going to increase fees to collect a couple hundred thousand dollars. If you...Businesses make money but we don't print it. We have to look at the social situation," she pointed out.

"We are still seeking clarity since the last press release as it relates to what were the changes that were going to remain and what we are going to be the ones that would be put on hold until next year or whenever such time," Smith-Archer further said.

While noting a disparity between Government's announcement and what is happening on the ground as it relates to charges the BVICCHA Chair said: "We know that it is a Cabinet decision that has been taken; and as far as tracking, we haven't seen a Cabinet decision that says that (fees delayed). So if that (Cabinet decision) is not needed; we still need clarity because as far as we're getting in terms of feedback from businesses they are still being charged based on the rates that were decided on earlier...There is much in terms of anxiety I would say."

School Garden Initiative Continues To Grow

The Department of Agriculture and Fisheries' School Garden Initiative is the recipient of an irrigation system including an irrigation hose, fittings, emitters and seedlings including, okra, kale, lemon basil, season and bell peppers courtesy of the Fort Garden Centre and Plant Wise VI.

The Fort Garden Centre donated the irrigation system while the seedlings were donated by Mr. Jamal and Mrs. Stressa Bradshaw of Plant Wise VI as part of the Farmers' and Fishers' Week 2021 activities.

Deputy Premier and Minister for Education, Culture, Youth Affairs, Fisheries and Agriculture, Dr. the Honourable Natalio D. Wheatley, said the much appreciated donations will benefit the students of Alexandrina Maduro Primary School by allowing them to be exposed to and work in a properly set up garden.

"As a result, these students will have the knowledge and skills to set up their own gardens at their homes or even consider a career in agriculture. They will also develop a greater appreciation of how the food they eat is produced," Honourable Wheatley said.

Director for the Department of Agriculture and Fisheries, Mr. Theodore James said the department's school garden initiative aims to expand the learning experience beyond the traditional classroom setting.

"School gardens are not only about planting, watering and harvesting of fruits and vegetables, but they also provide many opportunities for problem-solving and identifying beneficial and nonbeneficial insects," Mr. James said, adding, "They promote healthy eating by connecting growing food and healthy diets. They also increase environmental awareness.

The Director said, "Obesity and malnutrition affect many children and adults around the world. To curb these behaviours many countries are incorporating health and nutrition curriculum alongside their school garden; they are changing the eating

Director James said the department intends to collaborate with the Ministry of Education, principals, staff, parents and teachers associations, other sponsors as well as the farming and fishing community to develop a programme and an agreement among stakeholders during the next twelve months. He also encouraged all private schools to build or improve on their school gardens and farms.



"We encourage all schools to establish a garden club, create badges and club shirts for students. Before you know it, your school can be featured at the Farmers' and Fishers' Week Exhibition and Market Day event," he said.

New Public Pound To Address Roaming Livestock **Problem** fisheries are going to be a significant

A new public pound created as a response to the growing number of roaming livestock across the Territory was officially opened last week.

Deputy Premier and Minister for Education, Culture, Youth Affairs, Fisheries and Agriculture Dr. the Honourable Natalio D. Wheatley in remarks at the ceremony said that stray animals eating crops is "a big challenge for us here" in the BVI.

Honourable Wheatley said: "We needed to improve our infrastructure to be able to deal with these stray animals. I am glad that we are getting some of these resources today to be able to address these problems. It is very hard when you plant; you put a lot of time, energy and money into planting just to watch some animals eat your whole garden. It is very difficult."

The minister affirmed that the new public pound removes some obstacles from his path to developing the agricultural sector. "I have an unyielding commitment to make sure that agriculture and

part of our economy and a significant part of our society. There are lots of things, obstacles along the way, but I will not be discouraged," he said.

Meanwhile, Director for Agriculture and Fisheries Mr. Theodore James is calling on the persons who are affected by roaming livestock and dogs on their private property to contact and notify the department.

Director James said, "Following notification, the department dispatches the Animal Control Team to investigate or capture animals. Captured animals are processed, publicised and held. Livestock that is not registered becomes the property of the Crown. All animals will be forfeited to the Crown if their owners do not claim them or do not pay the total amount payable for the release of the animal within 21 days from the day the capture was advertised on the pounds notice board."

The Government of Virgin Islands (GOVI) has received financing from the Caribbean Development Bank (CDB) in an amount equivalent to US\$65,291,000 towards the cost of CDB No. 12/

SFR-OR-BVI: Rehabilitation and Reconstruction Loan - Hurricane Irma Project and intends to apply a portion of the proceeds of this financing to eligible payments under a contract for which this invitation is

issued. Payments by CDB will be made only at the request of GOVI and upon approval by CDB and will be subject in all respects

to the terms and conditions of the Financing Agreement. The

Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOVI shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

Landfill Establishment And Waste Rehabilitation Tenders Received

Director of Programme Strategy Department at the RDA and Project Lead Mr. Neil Smith said the Government of the Virgin Islands is developing an ambitious Waste Management Strategy aimed at maximum prevention, re-use and recovery of solid waste.

In support of this, four consultants submitted proposals to the Virgin Islands Recovery and Development Agency (RDA) for consulting services to provide a feasibility assessment and concept design for a sanitary landfill establishment, existing waste site rehabilitation and establishment of an auxiliary service station in the British Virgin Islands.

Mr. Smith said, "Seven companies were shortlisted by the Government of the Virgin Islands to participate in this

opportunity of which four responded by the bid submission 10:00 a.m. deadline to the RDA on Friday, 7 May, 2021. The technical proposals will now be evaluated by a team of evaluators following which the financial proposals will be reviewed."

Feedback from ongoing public consultations being led by the Ministry of Health and Social Development will feed into the development of the successful consultant's methodology. The ministry's policy documents can be found at http://bvi.gov.vg/dwmpolicy-documents and the public has until 30 June, 2021 to submit feedback.

Mr. Smith added that the overarching outcome for waste management is to provide waste diversion and disposal facilities which support the reduction of waste and provide a sustainable means for disposal that embodies accountability and transparency throughout the waste life cycle.

"The successful consultant's outcome must be consistent with the Draft Waste Management Strategy and align with Sustainable Development Goals representing value for money whilst embracing a circular economy," he said.

The Virgin Islands Recovery and Development Agency continues to support the Government of the Virgin Islands with its ambitious recovery plan and provides technical expertise in support of major infrastructure projects.



The Commissioner's Opening Statement for COI Hearings

Tuesday 4 May 2021

As you are all aware, considering that it would be in the public welfare – that is, in the public interest – on 19 January, the then Governor issued a Commission of

Inquiry ("COI") to establish

whether there is information that corruption, abuse of office or other serious dishonesty in relation to officials, whether statutory, elected or public may have taken place in recent years; to consider the conditions which may have allowed any such serious dishonesty to take place and

whether they may still exist; and, if appropriate, to make independent recommendations with a view to improving the standards of governance and the operation of the agencies of law enforcement and justice in the British Virgin Islands.

I was appointed the sole

Commissioner; and, since January, with the COI team, quietly but with purpose and determination, I have been fulfilling those terms of reference. They require me to report to the Governor with my findings and recommendations by July, but, if necessary, the Governor is able to extend that time to October. Whether an extension may be required is a matter I will consider over the next few weeks

To date, many have come forward with information, through the COI website portal or other means, and by face-toface and remote meetings. I am very grateful to all those who have come forward. I should emphasise that, if anyone has information which they have not yet sent to us, which they consider falls within the scope of the COI and may be useful, they should contact the COI through the website portal or by any of the other ways set out on our website page which can be found at www.bvi. public-inquiry.uk. Any such information received by the COI

will remain strictly confidential. As well as information volunteered in that way, the COI team have made requests for voluntary production of information, mainly Ministers and other public officials who have provided substantial number documents. I understand this has involved public servants putting in a considerable amount of work to respond to the requests. Whilst some have asked for additional time, none has suggested that he or she has been unable to comply fully with the COI requests as a result of lack of resources. I sincerely thank them for their efforts, which I much appreciate.

Much information has thus been gathered, and much progress made. However, we have now reached a stage when oral hearings are required to ensure further progress can be made, and at the required rate. One of the focuses of the initial hearings will be production of information. As I have said, in response to COI requests for voluntary production, in most instances, the recipient of the request has provided information and documents, with an indication that he or she has fully complied with the request. It is vital that I do have all information and documents relevant to the Inquiry, and some of these initial hearings will be to give me appropriate comfort that that is indeed the case. However, as I indicated at the outset of the COI, I intend to be flexible with regard to the conduct of the Inquiry, including the hearings, so that we make progress in an efficient way - whilst, of course, always ensuring that all are treated fairly.

In respect of documents which have been produced, various Ministers through the Attorney General have reserved their position on whether information and documents they have produced - and are continuing to produce - may be made available to the public. Consequently, some of the initial hearings will be held in private; so that, if there is reference to information or documents in respect of which privilege or confidentiality is maintained, such issues can be considered before the relevant material is made public. However, at each hearing, having heard any submissions on the point, I will determine

whether the hearing (or part of it) needs to be kept private; or whether it can properly be made public and, if so, how. I have well in mind both the understandable interest that the public has in the COI, and the importance of the principles of transparency and openness.

However, in respect of a private hearing such as this, until I make a declaration that the hearing (or part of it) can be made public in some way, everything that occurs at the hearing will remain strictly confidential. Everyone involved in the hearing is subject to the obligation of confidentiality. Unless and until I declare otherwise, no one is allowed to publicise any part of it, in any way. If there is any such publicity, then I can - and usually will investigate the cause of the leak and take appropriate action against anyone who has caused or facilitated the breach of confidence.

Further, it is important that I emphasise that no recordings can be made of any hearing public or private - save for the authorised recording that I am causing to be made. A transcript will be made of each hearing. If the hearing is private, then

a transcript may be provided to participants on the basis of a confidentiality undertaking. If a hearing is public - or if I direct that a private hearing be made public - then the default position will be that the relevant transcript will be posted on the COI website.

In commencing this next stage of the Inquiry, may I again stress that, although I have many of the powers of a High Court Judge, the COI is not a court of law. I am simply conducting an investigation, as required by my terms of reference; and the hearings are not adversarial, but inquisitorial. I would ask all those who may be involved in the hearings to bear that in mind. Counsel to the Inquiry, Mr Bilal Rawat, is not here to promote any cause: he has been appointed, by the Attorney General on my recommendation, to promote the public interest and to ensure, so far as he can, that the COI complies with its terms of reference for the benefit of all who live in this territory. That too is my overarching and primary consideration. I hope, and expect, all witnesses and those who might represent them to share those aims.

GERMANY - From Sunday, those who are fully immunized against COVID-19 are exempt from many restrictions in Germany. The WHO has warned that a variant spreading in India may be dodging vaccine protection. Follow DW for the latest. German residents who are considered fully immune to the coronavirus will no longer be subject to nightly curfews and restrictions on meeting people starting Sunday.

Anyone who has had both doses of the vaccine or who has recovered after falling ill will be able to meet with others in the same category in private without any restrictions. The fully immune also won't need to show proof they tested negative to enter shops and be in quarantine after travel, except in specific cases - for example, if they enter from an area where a variant of the virus is rampant. However, they will still be required to adhere to social distancing measures, including wearing masks in shops and on public transport.

Berlin's mayor Michael Müller admitted that it was going to be "damn difficult to check" whether people were exempt from the rules or not. [Deutsche Welle]

SWEDEN - A total of 1,002,121 coronavirus infections have been confirmed in Sweden since the start of the pandemic, according to the

Public Health Agency's latest data, presented on Thursday afternoon.

In the early months of the pandemic, Sweden had a relatively low rate of testing, so the real number is likely higher. [thelocal.se]

SWITZERLAND - Parliament's climate strategy appears to enjoy solid support among Swiss citizens ahead of next month's nationwide vote on the CO2 law. Supporters of two anti-pesticide initiatives also have the upper hand in an opinion poll published on Friday. It was commissioned by the Swiss Broadcasting Corporation (SBC), SWI swissinfo.ch's parent company.

A total of five issues are on the ballot sheet on June 13, including the government's economic measures to cope with the Covid-19 pandemic as well as a law to boost police powers to combat terrorism. Supporters of the amended CO2 law currently have a 25-percentage point lead, with the campaign still to get into full swing. [swissinfo.ch]

PUERTO RICO - The transformation and financial restructuring of Puerto Rico's bankrupt electric power authority have generated more than \$440 million in consulting contracts during the last seven years and could cost island residents more than \$1 billion before completion, according to a study released Thursday by the Institute for Energy Economics and Financial Analysis (IEEFA).

In the study IEEFA, whose stated mission is "to accelerate the transition to a diverse, sustainable and profitable energy economy," found the vast majority of consultants hired to retool the commonwealth's electrical system were based on the mainland U.S. Consultants based in Puerto Rico only accounted for \$14 million, or roughly 3 percent of all contracts. A handful of the consultants charged more than \$1,200 per hour for services on the island, where the median household income barely tops \$20,000.

"Puerto Rico agencies and the Financial Oversight and Management Board (FOMB) frequently employ the rhetoric of savings, cost-effectiveness and prudent financial management," said Cathy Kunkel, an IEEFA energy analyst and lead author of the report. "But not when it comes to contracts for professional services." In a press release announcing the report, IEEFA said: "During the seven years, the Puerto Rico Electric Power Authority (PREPA) and other government agencies, including the FOMB, have spent at least \$440 million on consultants, with five U.S. mainland firms receiving 40 percent of the total. More than \$1 of every \$3 spent on contracting has gone to law firms." [caribbeanbusiness]

ANTIGUA - Despite pronouncements a few months ago that Covid-19 vaccinations will remain voluntary, the likelihood of the shots becoming somewhat mandatory in Antigua and Barbuda – specifically within the tourism sector – is increasing with each official announcement.

Just recently, the government said players within the international cruise industry were still very interested in resuming travel to the island, but that interest was said to come with the condition that locals who operate in the sector - such as cab drivers, tour operators and shop workers - would be vaccinated to provide an improved level of safety and protection for the visiting guests. The request was noted to be reciprocal, as the cruises assured that they would only be transporting guests that have similarly taken a full dose of an approved vaccine.


Now, as more people in the country's major tourism source markets get vaccinated and carriers start to increase their airlift, hotels and other such accommodations are being told that guests would prefer that the people they interact with on the ground are fully vaccinated.

Officials from the Antigua and Barbuda Hotels and Tourism Association (ABHTA), met with the Cabinet yesterday and disclosed those increasing requests, as well as the fact that approximately half of the employees within the sector have yet to be vaccinated. [Antigua Observer]

DERBENT, Dagestan — At low tide, the waves on the beach fall back to expose an odd pile of rocks. half buried in the sand. Smooth and grey, some are carved into arched gateways. They are the last traces of a centuries-old tower, long hidden beneath the sea. The walls of Derbent — an ancient Persian fortress city now at the southernmost tip of Russia's North Caucasian Dagestan region — have always been shrouded in mystery. A popular myth has them built by Alexander the Great to seal off his empire from barbarian invasions. The intrigue is heightened by Derbent's evocative location, straddling a narrow pass between the Caucasus mountains and the Caspian Sea. "This is a hugely important discovery," Murtazali Gadjiev, an archaeologist who has been excavating Derbent since the 1970s, said of the ruins, which emerged from under the waves in March. "We're likely to find more such remnants of the city walls in future." "Assuming the Caspian continues to shrink, that is." Increasingly, scientists agree that it will. According to a series of recent studies, the Caspian — the world's largest inland body of water — is rapidly drying up as climate change sends temperatures in the region soaring.

Having already fallen by several meters since its mid-1990s peak, the Caspian's retreat represents a major



threat to fragile ecosystems with hundreds of endemic species, and to huge areas of arid inner Asia where human life has always depended on the sea. [Moscow Times]

USA - Seven people were killed after a man opened fire inside a birthday party at a mobile home in Colorado Springs overnight, police said, according to the Colorado Springs Gazette. The incident happened just after midnight Sunday morning at the Canterbury Mobile Home Park on the east side of the city. Officers, dispatched on report of a shooting, arrived at a trailer to find six dead adults and a man with serious injuries. That man later died at the hospital, Colorado Springs police said in a Sunday news release.

The suspect, the boyfriend of a female victim, drove to a trailer, where a birthday party was being held, with friends, family and children in attendance. He reportedly walked inside and began shooting party attendees before taking his own life, police said, adding that the children present "are now with relatives." [Arutz Sheva]

POLICE WARN AGAINST TAKING INTIMATE VIDEOS/PHOTOS

Monday, May 10 - Royal Virgin Islands Police Force Family and Juvenile Unit is urging persons not to take photos or participate in photos or videos of an intimate nature.

Increasingly, persons, particularly young people, are reporting that their intimate photos or videos are being circulated on social media.

Head of the Family and Juvenile Unit Inspector John Antoine says while the perpetrator of such an act, who is usually a former companion or friend, can be charged for violation of privacy, the offensive images or videos may remain on the internet and in circulation indefinitely.

'We will investigate each case which is reported to us, but the harsh reality is that we may never be able to stop the circulation of these images once they are released. Therefore, recovery from this tragic mistake is difficult. My strong advice is to choose never to record or be a participant in a photo or recording that would likely bring embarrassment or shame if it was to be made public," he said.

Under the Cyber Crime Act 2019, a person charged with violation of privacy by capturing, publishing or transmitting an image of a private area of another person can be fined up to \$200,000 or serve a term of seven years upon conviction.

the preceding is done, that is when economic growth is sustainable long term.

Strong societies are societies that are compassionate, equal and fair. The western idea of survival of the fittest as the ticket to prosperity has actually been a misnomer.

Strong and prosperous societies are those that lift up the whole population and not just the tiny percentage at the top.





Jerusalem Artichokes Are Culinary Treasure

If you're bored with the same vegetable and tuber routine, it's time to try something new -- like Jerusalem artichokes, also known as sunchokes. Think of it as a culinary treasure hunt with a delicious reward for your palate.

Like many tubers, sunchokes look a little strange. But when it comes to food, looks can often be deceiving. The sunchoke is the tasty, knobby, root of a sunflower. Until recent years, this native of North America was more popular in Europe than in the United States.

The sunchoke is a hardy perennial that can grow in a variety of conditions and is not frost tender. With water shortages and the growing cost of agriculture almost everywhere in our country, farmers were looking for ecologically sustainable crops, and the sunchoke fit their needs. Sunchokes are now being grown commercially and by home gardeners in America.

Many small organic farms are also growing sunchokes successfully, so look for them at farm stands and farmers markets. The crop does have its downside. It tends to grow wild, and can be invasive, presenting challengers for farmers and backyard gardeners alike.



Jerusalem artichokes

As a healthy addition to our diet, sunchokes are a low-glycemic food and possess a significant amount of protein, with very little starch. They also are rich in inulin, a natural fructose type of carbohydrate. Inulin is thought to be better tolerated by those diagnosed with Type 2 diabetes.

When shopping for sunchokes, look for firm, brown-colored tubers. If they are beginning to darken, they are not fresh. After you get them home, store in paper towels in a plastic bag in the refrigerator for up to two weeks. Don't wash your sunchokes until you are ready to use them, as moisture can lead to spoiling. Sunchokes have a thin skin and don't need to be peeled.

Sunchokes are extremely versatile. You can use them in the same way you typically use a potato. They have a crunchy texture and are delicious raw. When roasted, their nutty flavor comes out. Steamed sunchokes can stand alone or can be mixed with other vegetables, used in a gratin or to make a delicious soup. If you're using sunchokes in a creamed soup or puree and want to remove the peel for presentation color, pass them through a food mill or a fine mesh strainer.

Try this recipe for Sunchoke Chips With Parmesan and Parsley as a delicious alternative to potato chips. And remember, this is just the first step on your adventure to discover all things Jerusalem artichoke! Enjoy!

SUNCHOKE CHIPS WITH PARMESAN AND PARSLEY

- · 2 pounds unpeeled sunchokes (also called Jerusalem artichokes), scrubbed
- Vegetable oil (for frying) 1 1/2 teaspoons salt 1/2 cup grated Parmesan
- 1 1/2 teaspoons minced fresh parsley
- 1. Fill a large bowl with cold water. Slice sunchokes into thin rounds (about 1/16-inch thick), immediately dropping into bowl of water to prevent browning. Rinse and drain 3 times to remove some of the starch for a crisper chip. Pat dry with paper towels.
- 2. Pour enough oil into a large, deep skillet to reach depth of 1/2 inch. Submerge bulb of deep-fry thermometer into the oil; lean top of thermometer against skillet rim. Heat oil to 375 F. Mix salt, Parmesan and parsley together in small bowl, blending well, and set aside.
- 3. Working in batches, fry sunchoke slices until golden brown, 3 to 4 minutes, stirring occasionally. Using a skimmer, transfer chips to a wire rack placed over a paper-lined baking pan to drain. While the chips are hot, sprinkle them with the Parmesan and salt mixture. The chips won't be crispy immediately out of the fryer. After a few minutes, they will crisp up. Mound chips in bowl and serve. Serves 8.

TO BAKE THE CHIPS:

- 1. Preheat oven to 400 F.
- 2. Line two baking sheets with foil and lightly grease with cooking oil spray. Place the slices in a single layer on the two sheets. Spray each slice with oil, then sprinkle salt on top
- 3. Bake for 10 to 15 minutes. If they aren't golden brown and crisp, bake them in 3 to 5 minute increments until done. Sprinkle with the topping of your choice.

ALTERNATE TOPPINGS:

- For protein boost and cheese flavor: Sprinkle chips with 1/2 cup nutritional yeast.
- For spicy flavor: Sprinkle chips with 1 tablespoon chili powder and 1/4 teaspoon cayenne pepper.

Orange Level Volcanic Alert at La Soufrière following recommendation from UWI Seismic Research Centre

The UWI St. Augustine, Trinidad & Tobago, Thursday, May 6, 2021. — The Government of Saint Vincent and the Grenadines has lowered the volcanic alert level at La Soufrière to ORANGE based on recommendation from The University of the West Indies Seismic Research Centre (UWI-SRC).

UWI-SRC/MVO Volcano-seismologist and current Scientific Team Lead, Roderick Stewart made the recommendation to the cabinet on Tuesday May 4, during his update on the current activity at the volcano. Mr. Stewart indicated that the recommendation was being made given that there have been no explosions at the volcano since April 22, and the number of volcanic earthquakes recorded has also decreased significantly. At alert level ORANGE the volcano may resume explosions with less than twenty-four hours of notice.

Lahars (mudflows) continue to pose a dangerous threat to the river valleys surrounding the volcano including Wallibou and Rabacca. Mudflows observed over the past several days have contained boulders up to 5m (15 feet) in diameter. Scientists also observed steaming flows, which are likely due to contact with and incorporation of hot volcanic deposits. Lahars can cause damage to property and serious injury to persons in their path. Access to the RED volcanic hazard zone should be limited to government approved essential work only. Conditions remain hazardous and the potential for injury also remains.

National Emergency Management Organisation (NEMO) and The UWI-SRC continue to be the authoritative sources of information on the eruption of La Soufrière volcano in Saint Vincent.



New and returning Faculty Deans make history at The UWI

The UWI Regional Headquarters, Jamaica. W.I. Thursday, May 6, 2021. — The appointments of seven new and returning Faculty Deans were approved at the annual business meeting of The University of the West Indies (The UWI) last Friday, April 30, 2021. Among them is the regional University's first ever female Dean of Science and Technology, based at The UWI Cave Hill Campus, Dr. Jeanese Badenock.

Two new female Deans appointed at the Mona Campus, Professor Silvia Kouwenberg in the Faculty of Humanities and Education and Professor Minerva Thame in the Faculty of Medical Sciences also made history as their appointments brought a 50% female representation in deanships at the Campus.

These historic appointments of the female Deans come on the heels of The UWI's recognition by the Times Higher Education Impact Rankings in April, for its pursuit of the UN Sustainable Goal on Gender Equality (SDG:5), among other

The other Deans approved at the April 30 meeting of University Council are: Dr. Mark Wuddivira, newly appointed in the Faculty of Food and Agriculture at the St Augustine Campus; Dr. Brian Cockburn, who was reappointed as Dean of the Faculty of Science and Technology, also at St. Augustine and Dr. Akshai Mansingh, reappointed in the University's Faculty of Sport which serves all campuses. At The UWI Cave Hill Campus, Professor Eddy Ventose was appointed to serve as Interim Dean of the Faculty of Law.

Deans are responsible for the overall academic and administrative management of Faculties including the oversight of their financial affairs. They are also expected to represent their Faculties on all relevant Campus and University Boards and Committees as well as external stakeholder bodies. As is tradition, the new and returning Deans will serve a period of four years, effective August 1, 2021.

The lesson begins at 11.40 am EST/ 9.40 am Belize time and focuses on the opportunities, different interests, the CSME and reasons for having CARICOM.

Ms. Grinage is a Social Studies teacher with 12 years' experience in the profession.

Next Thursday, 20 May 2021, Mr. Inshanally will teach Ms. Grinage's class at the same time doing a second lesson concluding the theme.

This online pilot is a precursor to a proposed activity for teacher exchanges, where they would travel and be attached to classrooms across CARICOM to observe and share experiences in the host Member State.

The original plan to be facilitated with assistance from the European Union was placed on hold because of the Covid19 pandemic.

These activities are part of the CARICOM Secretariat's on-going initiatives of Public Education on the CSME.

In a speech on the party's message to the House floor on Tuesday night, Cheney described Cheney, the lone Trump's continuing efforts to delegitimize the election results as " a threat America has never seen before."

"A former president who provoked a violent attack on this Capitol in an effort to steal the election has resumed his aggressive effort to convince Americans that the election was stolen from him. He risks inciting further violence."

McMaster, Hodge break 400m Hurdles, 200m national records

Kyron McMaster ran his first 400m Hurdles race since the 2019 World Athletics Championships, making his season's debut by shaving his own national record by 0.04, while 15-year old Adaejah Hodge qualified for the Georgia State High School Championships by breaking the 200m Youth and Jr. Records, while also claiming 100m and Long Jump victories.

McMaster finished second in 47.50 seconds at the USTAF Golden Games in Walnut, California, to former Antigua and Barbuda athlete Rai Benjamin who now competes for the USA, and produced a world leading 47.13 seconds time. McMaster shaved his June 30, 2018 personal best and national record from 47.54 seconds and moved up to No 18 on the World Athletics All Time list in the event.

At the same competition, Shot Putter Eldred Henry had an unlooked for 18.65m (62'1¼") heave to place ninth in his first outing since the 2019 World Athletics Championships.

At the high school level, Adaejah Hodge, 15, became the National Youth and National Jr. 200m record holder, when she stopped the clock at 23.64 seconds (0.8) at the Georgia Class 6A Sectional B (Regions 3, 4, 5 and 8) Championships and qualified for the weekend State Championships. With the time, she moved to No 5 on the BVI All Time List and has the fastest performer by a woman, so far this season.

Hodge also advanced to state in the 100m and Long Jump events. She won her 100m heat in 11.73 seconds, after cutting the sand at 5.88m (19'3½").

On the collegiate scene, Southwest Baptist Freshman Zara Brown, won the GLVC Freshman Athlete of the Year Award, after scoring 15 points in the 100, 200 and 400m and helping her school to a 2nd place finish in the conference with 139 points. Brown was second in the 100m with a personal best and school record time of 11.76 seconds (0.8), the No 8 All Time BVI Women's mark. She won her heat in 11.88 seconds (-0.5). Brown followed up with a fourth place finish in the 400m in 57.35 seconds, after finishing second in her prelims with a personal best of 56.98, the No 5 mark on SBU's All Time List.

Brown ended her duties that included a 2nd leg carry on the victorious 4x100m relay that ran 46.00 seconds, with a seventh place

finish in the 200m and a time of 24.99 seconds. She used a personal best of 24.41 seconds (0.3), to win her heat, a mark that places her at No 3 All Time at SBU.

Elsewhere, Utah State Freshman Xiomara "Gia" Malone, tuned up for the weekend Mountain West Conference Championships Heptathlon at the Weber State Invitational, with a 100m Hurdles personal best of 14.63 seconds (1.8) and a 3rd place finish. She equaled her High Jump personal best of 1.63m (5'4¼") to place fifth. Malone ended the Long Jump with a third place leap of 5.55m (-1.2) (18'2½").

Ashley Kelly was fourth in the Tom Tellez Invitational 400m in 54.41 seconds.

Competition in the National Jr. College Championships began earlier in the week for New Mexico Jr. College Sophomore twin brothers Djimon and Diamante Gumbs and Cloud County Freshman Tashira Edwards. This weekend Central Florida Sophomore, Beyonce DeFreitas, Clemson Sr. Lakeisha "Mimi" Warner, UTEP Freshman Josh Hill, Northwestern State Sophomore Akira Phillip, Indiana Sophomore Rikkoi Brathwaite and Xiomara "Gia" Malone, will contest their respective conference championships.



A storm brewing over Haiti at the OAS

Strong disagreement may be brewing at the Organization of American States (OAS) on how to respond to the ongoing, grave political and constitutional crisis in Haiti.

Since January 2020, the Haitian President, Jovenel Moïse, has been ruling the country by decree without any legislative oversight. The

mandates of the members of the Haitian Parliament, except for 10 of them, were terminated because elections were not

The rising tension in the country, including use of lethal force by the police against protestors, widespread kidnappings and killing, rape of women, and an arbitrary decision by

Moïse to hold a controversial referendum on a new constitution, as well as heightened political contention, caused concerned member states at the OAS, including nine CARICOM countries, to sponsor a Resolution at the organization's Permanent Council to address the situation urgently.

Specifically, the Resolution, adopted on March 17, offered "the good offices of the OAS under the authority of the Permanent Council to facilitate a dialogue that would lead to free and fair elections". It requested the Secretary-General, Luis Almagro, "to advise the Government and other major stakeholders in Haiti, of the Permanent Council's offer to undertake a good offices role and to invite the President of Haiti to consider inviting the Permanent Council to do so".

Whether or not Almagro wrote to the Haitian President and "other major stakeholders" is unclear. Certainly, no major political party or human rights group in Haiti has confirmed receipt of any communication from him. There has also been silence from him to two official requests, asking for details of stakeholders to whom he might have written and when. There is no need for this - a straight answer is all that is required.

This matter will be mired in controversy, because while uncertainty prevails over whether or not the Secretary-General did write to the President and other major stakeholders in Haiti, a letter dated April 28 was sent to him by Claude Joseph in the latter's capacity as Minister of Foreign Affairs. The letter is significant.

First, it does not refer to any communication received from Almagro. Instead, it references the Permanent Council's Resolution of March 17 as the basis for writing. Second, it states that "the Government of the Republic of Haiti is willing to receive an OAS mission in support of the ongoing dialogue with all the nation's stakeholders with a view to concluding a political agreement that will facilitate the organization of the constitutional referendum and elections at all levels during the course of 2021".

On the second point, the OAS Resolution of 17 March did not offer its good offices "to facilitate the organization of the constitutional referendum". The proposed referendum is entirely of President Moïse's making and is mired in claims of unconstitutionality.

highly respected U.S. Congresswoman, Maxine Waters, describes it as "Moïse's most audacious and dangerous power grab". Legal experts inside and outside Haiti have opined that the existing Constitution specifically prohibits referenda to decide constitutional changes because a former dictator, Jean Claude 'Baby Doc' Duvalier, had used that artifice to proclaim himself President-

for-Life. Therefore, if the OAS accepts that facilitation of the referendum is a condition of its good offices' role, its purpose and credibility are undermined even before it starts. No stakeholder would participate in any dialogue where organisation of a constitutional referendum is a condition.

It is important to recall that, prompted by the rapidly deteriorating democratic and human rights situation in Haiti, the offer of good offices by the Permanent Council resolution was "to facilitate a dialogue that would lead to free and fair elections". Nowhere did the Resolution venture to suggest that the OAS' role would include facilitating the organisation of a referendum to alter the constitution.

Particularly significant is that on April 26, two days before Joseph sent his letter to Almagro, 68 members of the U.S. Congress wrote to Secretary of State, Antony Blinken, pointing out that Moïse "lacks the credibility and legitimacy to oversee a constitutional referendum scheduled for June 2021, or to administer elections that are free and

This position by such a large number of U.S. Congress persons, led by Gregory W. Meeks, the Chair of the Foreign Affairs Committee of the House, is a remarkable development. It shows that important U.S. lawmakers are deeply concerned about what they describe as, "lack of preparedness of electoral institutions to hold elections, as well as the unconstitutional composition of the prevailing electoral council". Contrary to law, Moïse handpicked the members of the Council.

Of especial note is that the 68 U.S. Congresspersons urged Secretary Blinken to use the U.S. vote within the OAS "to ensure U.S. taxpayer dollars are not spent in support of this referendum".

Last year, the OAS and CARICOM, held all the parties in Guyana to account to deliver a credible result to general elections held on March 2. It took five months of the active attention and diligence of CARICOM, the Commonwealth, the European Union and the OAS to ensure that democracy and the rule of law were upheld in Guyana, and that general and regional elections were not stolen by the incumbent government.

What is happening in Haiti now is no less egregious than what was resisted in Guyana in 2020 and is now being condemned in other member states of the OAS - and even in countries outside of it. The OAS must act in the interest of Haiti and the Haitian people to uphold their rights to democratic governance, human rights, and the opportunity for economic development. The governing Charters of the OAS mandate it.

GET VACCINATED TO SEE THE LIGHT AT THE **END OF THE TUNNEL**

We are told that we will see some light at the end of the Covid tunnel sometime soon. We hope they are correct because so far no one has seen it. The damage done to the world economy, the millions of lives lost, the travel limitations and tribulations, the difficulties encountered even by the big countries in attempting to secure a good supply of vaccines are clear examples of the situation the entire humanity has found itself in. But these are only some of the major aspects, think about the impact on people's jobs, on tourism, on the cost of living at a time when most of us have depleted our savings to survive, and what about our bank loans and mortgages.

Long-lasting consequences are knocking at our doors and the new generation will pay a high price for the disruption of the education system; the elderly on their part have certainly taken note of the shortcomings and inadequacies of social services, health services and infrastructure.

While everyone is trying to go through all of this with some dignity, not all will succeed and our confidence in man's ability to overcome a problem like Covid is being tested to the limit.

So far a lot of hope has been placed on vaccines, but even that remedy has raised questions and confusion, partly due to misinformation circulating at all levels and the "pharma" war that denigrates and belittles the product of the competition giving life to further doubts about vaccination.

Dr. John Whyte, Chief Medical Officer at WebMD has asked the crucial question most of us have been pondering on: Just how long are you protected from COVID after vaccination?

"Both Pfizer and Moderna studied the immune function of people that were vaccinated six months ago. And what they determined was that they still had a strong immune function. The vaccine was effective at over 90%.

Now they only studied for six months because that's what is required by the FDA for full approval, but they are going to continue to study for many months and even years. And the point of this is, there is protection for at least six months, not only six months. And that has been misreported by some news media."

"So what do you do? Well, don't get frustrated. Thinking that this is never going to end, or we are going to need boosters every six months or every year. We don't know that, it depends on what happens with the variant. But what we can do is get vaccinated, protect ourselves, protect our family, and protect our community."







The Number One Work At Home Scam Explained



Working at home is very popular. As with anything that is popular there are people out there who like to try to scam those looking for work at home jobs. Scams can sometimes be hard to recognize, but if a person knows what to look for they can raise their chances of not being caught in a work at home scam. A popular way to get taken by a scam work at home company is when they ask a person to pay them money.

The first key that a work at home opportunity may be a scam is that the company asks for money up front. This is also something that can be confusing because some legitimate companies ask for money, too. The main rule abut paying money is that if the job were not work at home would it be reasonable to pay money up front to work with this company. In these cases the work at home employee usually also finds out the job duties are completely different from what they were originally told. The whole concept is the scam company makes their main income off potential work at home employees, not through a real business.

Almost any good reference on working at home will mention not to ever pay money for a work at home job. It may seem like common sense, but can be confusing for someone who is new to the work at home industry. Many of these scams seem real and also come across as a way to make big money fast. This type of money scam is the biggest of all work at home scams.

There's No Such Thing as 'Cure' for Autism

DEAR DR. ROACH: A friend took her autistic son to a clinic in Mexico where he was fed a bleach solution that was supposed to cure his autism, but instead it made him very sick. He was deeply distressed and regressed in his behavior, and there was nothing my friend could do because in Mexico these kinds of clinics are allowed to operate with impunity. Isn't there some way to stop this kind of thing? - P.P.L.

ANSWER: Before I get into why this story makes me both sad and angry, I want to address autism. Autism is an increasingly diagnosed condition that includes difficulty with social interactions, stereotyped repetitive movements and delayed language skills, although there is a subset of people with autism with no language delay. It's absolutely critical to recognize that autism is a spectrum condition, ranging from people with profound disabilities to those who are so mildly affected that the diagnosis is very subtle. Correct diagnosis is complicated, even for an expert. Intellectual abilities in autism range from severe cognitive impairment to far above-normal intelligence. As such, the proper medical care of a person with autism depends on his or her unique situation.

Although most people on the autism spectrum need some extra empathy and understanding in order to have the best possible life, people with autism do not need to be "cured." There is no "cure"

for autism, so when you hear a professed "cure," you should be deeply suspicious.

In the case of the bleach solution, it is sadly not just in Mexico where this happens. The Food and Drug Administration had to warn consumers against the use of a product called "miracle mineral solution," "chlorine dioxide" and other names. It is hard for me to believe the FDA has to warn people not to drink (or make your child drink) a powerful bleaching agent, but there are increasing reports of its use. It causes damage to the intestines, as you correctly note, but may also cause liver failure, nausea and vomiting, and dehydration. There is no evidence that this "treatment" is effective for any condition, even though it is marketed for cancer and HIV as well as autism. This is what makes me angry: I cannot imagine a crime much worse than profiting off of a treatment known to be both dangerous and ineffective.

What makes me sad is that I can empathize with parents who have a child with autism who want their child to be more like other children, more "normal." It takes time to come to grips with the fact that your child is not like others, but that he or she is a unique person who should be loved and accepted for who he or she is. That means finding creative ways to really help your child. There is a wide range of appropriate treatments for people with autism, preferably considered as early as possible, which is why it is so important to make the correct diagnosis quickly in a child with autism.

DR. ROACH WRITES: After my recent column on mercury, a toxicologist wrote to remind me that metallic mercury can be absorbed through the skin and thus mercury, such as from a broken thermometer, should never be played with and should be properly disposed of.

10 SETUP SECRETS FOR YOUR HOME BASED BUSINESS

Setting up a home based business doesn't have to be intimidating, expensive or time consuming. When you decide to make your living working from home, you simply need to go through a basic set up process to ensure you are ready.

Here are the steps for setting up your home business for success:

1. Attitude

- The key to your business success is your attitude.
- Treat your business like a business. This is critical whether you are working part-time or full-time. For example, the mom who works from home around her family. She always puts her family first, at the same time developing her business. She says, "I may work part-time, but I have a full-time attitude." To put another way, "Have a hobby attitude, get a hobby income, have a business attitude get a business income."

You can be successful working parttime and you can be successful working full-time but it is unlikely that you will be successful just working in your "spare time".

2. Describe Your Business

Be able to describe your business concisely; a powerful one or two sentence description that someone can repeat in describing your business to others.

A unique and memorable tag line can also be invaluable for promoting your business. This is often referred to as your "elevator pitch" or "audio logo". Think about it, if you ask someone about their business and they describe it as "a errr, well, I kind of take care of, you know, well in as much as..." would you be impressed? Would you think that you should really hire that person? It's much better to be able to speak briefly, confidently and memorably about your business and what makes it unique.

3. Know Your Product or Service

Once you have chosen the product or service to sell you need to know your product intimately. If you are selling e-books for example, then know the content and its value. If you are selling software then use it and know it "inside out".

You will develop a reputation of providing quality information and because of your product knowledge, you can become the preferred supplier.

If it is not practical to use certain products (for example a woman may choose to sell man's shoes or vice versa) then you won't be using the product, however you can still know the benefits and features of the product intimately.

4. Get a Domain Name

Welcome to the twenty first century, you need a domain name for your business! You'll need an account with a reputable hosting company who will provide a "space" on the web for your domain name and site. The fees can be as low as \$4.95 per month and go up from there. If you do not have any knowledge of HTML there are hosting companies that provide "site builder" software via the web. This can be a great option but be sure you like the application before you plunk down your money as you will probably be using it a lot!

5. Email

Once you have your own domain you will have one or more email accounts for that domain. This can assist in the promotion of your business and promotes a more professional business image.

Using email smartly can help you in the task of organizing your business communications. For example, sales can arrive via sales@your-company.com, support and help requests via support@your-company.com and so on.

By setting up some basic rules in Outlook or other email program you can have the mail conveniently sorted into folders for you as soon as it arrives.

6. Payment Processing

You will probably need a way to process credit cards. You could use services such as:

- Checkout http://www.2checkout.com
- Clickbank http://www.clickbank.

Paypal now has a Pro level of service that includes a virtual terminal, helping to keep the costs low. Once your business picks up you may need to look into your own merchant account for credit card transactions but any of the sites listed will certainly get you started and may be all you need for the life of your business.

7. Computer Protection

Your computer is the lifeline to your business dealings and must be protected including the data that is stored. You will need a virus scanner, personal firewall, anti-spyware and anti-adware and preferably an email scanner with the ability to delete suspect or spam email from the server before it is downloaded to your computer.

8. Working Environment

Getting organized is highly important, to ensure that you complete projects on time but also pay your bills on time and even bill your clients on time!

Having a working environment that help rather than hinders you work is also highly important. It can be tough but you need to establish a definite workspace for both yourself and any other people that are around.

- A space that you can call your own, free from distractions for your scheduled time.
- A comfortable chair and organized desk.
- Stationery supplies as required.
- Ensure you have a good computer monitor if you will be staring at it for long periods of time.
- Consider the value of a broadband connection. Your time is valuable and a broadband connection can allow you to get more done in a given time frame.

9. Administration

Use good record keeping practices... please! You may need to consult a tax advisor who can let you know about the best way to set up your financial records and what records need to be kept. Your advisor can recommend record keeping systems and software may simplify this aspect of your business.

Additionally you can obtain advice on the best arrangement for your bank accounts. You will most likely be advised to have a separate account. Many banks now offer free checking for small business so do your research in to the options available to you.

Keep track of your various logins, usernames and passwords. This can be quite a big deal once your have a number of business resources online.

There are other useful tools for this also from a simple paper notebook to free and commercial password keepers. One popular solution is PasswordSafe. com. They provide a free web based service for storing username / passwords so you can access them from anywhere with an internet connection. They've been around since 1998 so the service is both trustworthy and reliable.

10. Schedule

Develop a schedule that works for you, your family and your business. When you mark off a block of time for work, then use that time for work. Equally important is to schedule time for your other commitments – family time, self-education (reading, listening and viewing), "health time" (exercise, cooking and eating), and leisure time. During these other times don't work. Remember, one of the reasons to work from home is to spend more time with your family and you don't want your working at home time to consume your family time.

You are working for yourself and your schedule (by your choice) is your "boss". When you have people calling you or dropping around unexpectedly or maybe out-of-town visitors may want to catch up with you then you need to make a choice. Are you committed to your own business success? What will be your choice in these situations? Only you can decide what is important to you.

In a family environment you may need to negotiate with your family and have your business time agreed upon, during which you will not be interrupted. Put this schedule prominently somewhere so all family members are aware of your work schedule.

These are the ten basics of working at home. Some of these items may change a little depending on the type of business you choose but in essence, this is it. A home based business can be the most fun, most rewarding experience of your adult life as long as you realize there are a few simple rules to keeping everything on track along the way.
