COVID VACCINATIONS: OFF TO A SMOOTH START

A week has passed since the group that made up the first ten to be vaccinated publicly received their Astra Zeneca vaccine shot and curiosity as to whether there have been any side effects from the jab was answered. Minister for Health and Social Development Hon. Carvin Malone who was the first person to get a dose announced that he has not experienced any side effects. He did however mention that there were few reports of side effects but did not state if it was amongst the first ten or the frontline workers that followed.

The grand vaccination rollout commenced last Thursday 11 February at the Dr. D. Orlando Smith hospital and saw the inoculation of the group that included: His Excellency Governor John Rankin, Hon. Malone, Minister for Natural Resources, Labour and Immigration, Hon. Vincent Wheatley, Speaker of the House, Hon. Julian Willock, Leader of the

Opposition Hon. Marlon Penn, Fourth District Representative Hon. Mark Vanterpool, Chief Medical Officer Dr. Irad Potter, Acting Chief Medical Officer, Dr. Ronald Georges, Media personality Cathy Richards; and the spouse of the Minister of Health Mrs. Pernis A. Malone.

The media questioned why Premier and Minister for Finance

Hon. Andrew Fahie was not one of the first ten and he announced that he was going to be vaccinated this week. The Premier said, "I have made a decision to allow our front line to as many as possible, especially in the healthcare section to get ahead and next week I will be taking the vaccine. It's as simple as that."

"Next week I'm going to be vaccinated, allowing with due respect the Governor who has worked hard with the United Kingdom to bring the 8,000 dosages and the Minister of Health and the rest of the front line, and some other members said they want to go ahead," the Premier added.

Soon it will be mandatory to be vaccinated if you travel

Days after being vaccinated on camera the Health Minister reported that he was still feeling fine. While speaking on the VIP Let's Talk programme on 16 February Hon. Malone said, "While a few persons have reportedly had side effects from taking the COVID 19 vaccine myself and members of my household that have been vaccinated are doing well."

The Minister in response to a question about side effects from a caller on the programme that was aired on ZBVI and Facebook stated that he did not experience any. "What we have is that there are a few persons who did have slight fevers, chills, they have... and this is why they give you some paracetamol."

Nonetheless, the Minister noted that he is grateful that there is nothing unpleasant about the vaccine. "I have been fortunate, me and my household have been fortunate that we didn't have any of the side effects of this, but there are those is not unlike every other vaccine that you take. With the...team that we have, they have all of the eventualities. They were calling me every day to make sure that I was not experiencing any of these symptoms...I was able to tell them I am fine," he stated.

Meanwhile, the government's vaccine rollout plan is moving along and the Minister explained that frontline workers are getting their shots. "Most of the Healthcare workers

persons. Just very few. It vaccinated, those who indicated," Hon. Malone mentioned.

> The Health Minister said that the inoculation campaign is continuing across the Territory and he made another appeal for persons to get vaccinated. "We are asking everyone to come and be vaccinated. When we do this we look in terms of preserving lives preserving livelihood and it is the way in which we will be able to reopen our borders even faster."

As it relates to persons on Tortola have been who remain skeptical

about the vaccine or its side effects the Minister alluded to the fact that vaccination is voluntary. However, he noted that not being vaccinated might soon hinder travel. Hon. Malone said, "We know we have a series of persons who are hesitant in terms of taking the vaccine. So all those who wish to take it we will go ahead and administer first. Those persons who don't take it if you want to travel soon it will be a requirement for travel so at the end of the day."

Unfortunately, it seems that business in these COVID 19 days has not

The continued closure of property and as such the owners announced that they have no choice but to close the door. In a Facebook announcement, the management of the trattoria said that they were sad to make the decision.

> While noting that the decline in tourists and visitors was the cause, the management wrote, "It is with a very heavy heart and tremendous concern for each and everyone that we regrettably have to make the following decision. A decision which comes out of the factual reality of COVID-19, resulting in a negative market for our tourism industry."

"The negative result been the best for the has manifested itself in a manner which makes it financially impossible for us to continue to be open at this time. Therefore, we are giving notice that Top of The Baths Restaurant and coffee bar will be temporarily closed until such time as the economical conditions return to a point where the business can meet its daily obligations. We truly hope that this period of business interruption will be shortlived," they added.

Prior to the decision to close the management of Top of The Baths Bar and Restaurant had tried to salvage things by changing their hours. In early February the hours of the restaurant were altered, and the management noted that they were hoping to see

more persons patronising the property for break and lunch.

The restaurant has earned impressive reviews on Tripadvisor, and according to travel platforms on the internet, the restaurant was opened in 1994, and has maintained the premises in tip-top shape to this day. Since then, they have welcomed thousands upon thousands

of visitors. "The menu is surprisingly diverse with everything from chocolate chip pancakes to chicken roti, jerk pork chops, grilled lobster tail, stewed oxtail, or pasta primavera. I guess the menu could be described as North American & Caribbean fusion with a little Italian and Japanese thrown in for good measure."

Contract Signing RDA Projects

REMARKS BY PREMIER AND MINISTER OF FINANCE HONOURABLE ANDREW A FAHIE, 16th February, 2021

God's blessings to each and every one - whether present with us physically or joining in virtually.

The recovery of our Territory from the ravages of Hurricanes Irma and Maria in 2017 continues, and so does our mission of transformation and development.

On behalf of the Government of the Virgin Islands, I am very pleased to see that the schedule of projects in the revised Recovery and Development Plan continues to move forward.

As stated before Irma and Maria were real because we continue to live with reality of their destruction.

Upon taking office, it was clear that many recovery projects had to be started. We made it a priority to get the ball moving to start the recovery projects, especially in a time where there are limited resources, but high demands.

Today, we continue to move forward with four of those recovery projects.

- 1. We have the repairs to the Anegada Administration Building which will be a six-month project starting on March 1, 2021 to No Limit Construction in the amount of \$209,653.86. This building was severely damaged in the hurricanes of 2017. There were some repairs and I am glad the major repairs will be done. Clearly our public officers deserve to be in a better working condition. Through this Government making this project a high priority, it shows our commitment to the wellbeing and safety of our public officers and the public who are customers of our facility. We thank the Deputy Governor's Office for the work that they have done for joining in partnering with us to get things done. And for sure shows that this is a Government that cares.
- 2.Then we have the Rubberised Resurfacing of the Multipurpose Court at the Jeffery A. Caines Sports Arena, Virgin Gorda, a three-month contract that is being awarded to Alternative Concrete Solutions Ltd with works to begin on 25th February 2021 in the amount of \$72,308.00. This facility was also destroyed during the hurricanes of 2017. Our athletes, especially our young people, deserve proper sporting facilities. Since taking office this Government continue to improve the sporting facilities throughout the Virgin Islands in places such as Carrot Bay, Cappoon's Bay, Belle Vue, Diamond Estate, West End, just to name a few. So it is clear that is a Government that cares.
- 3.And, we have the Rubberised Resurfacing of the Anegada Recreation Ground also a threemonth contract to Alternative

Concrete Solutions Ltd in the amount of \$94,423.00 to begin February 2021 very shortly. This court and grounds have also been in need of repairs since the passage of the 2017 hurricanes and I must say that it devastated all our islands, yes.

- 4.But basketball overall on Virgin Gorda is immensely important especially to the economy of the Territory but mainly in Virgin Gorda. The basketball season in Virgin Gorda is also a great economic boost during the off season of tourism when the summer jam happens. Many persons come from the other islands stay in hotels, support the restaurants, and car rentals. But, here we are today with hope as works will now begin to fix the recreational areas so that families in Anegada and Virgin Gorda, especially our young people can enjoy. Clearly, this is a Government that cares.
- 5. Additionally, we have a contract being awarded to ATEC BVI Ltd. in the amount of \$53,380 for Ivan Dawson Primary School. This is important as Government has been stressing renewable energy. In short order in a few weeks, we will be carrying legislation to the House of Assembly in order to amend the Customs Act to allow all renewable energy materials and hybrid cars to be duty-free for a certain period so that we can encourage the transition of renewable energy in this Territory. Because it's not just about talking the talk but about walking the walk so this continues to fall in line with the mandate that we have already placed as a Government on the need for renewable energy, so we welcome this.

And it is important to ensure that our children are learning in a quality environment, and that our teachers are sharing with our students and working in a quality environment. So, we really welcome this because projects like these do a lot for our teachers, students and the electricity bill. But it does a lot for the environment and that is key especially in this error of Climate Change.

So, let me pause here and say that I congratulate the contractors for being proactive in all of these ventures, even those that were not successful because it takes a lot to tender and a lot of funds, but they will continue to persevere and be successful.

I also know that the RDA, Mr. Macmaster and myself are planning a renewed sense of energy and purpose in making sure that we get to each and every single district so that each and every single contractor can have an opportunity to come and listen

and join the workshops and also we have the online session that we are going to do with the RDA so that more contractors can come and register through the RDA and also register with the programme for central Government because it is important that we continue to point them in this direction to sharpen their skills.

And also, in central Government with the Ministry of Finance, we have through the Acting Financial Secretary, Mr. Frett and Dr. Drexel Glasgow who are working feverishly on getting the new procurement legislation to be brought forward so that we can continue to further strengthen our areas of accountability and strengthen our resolve to do even more as a people of the Territory.

So I want to congratulate them all and congratulate the contractors, especially Mr. Smith who has hired Anegadians on his project without being prompted; that is very important that when we as the people of the Virgin Islands get an opportunity that we bring our people along because it would not be right to be working in an environment especially where they have suffered so much with COVID-19 and the economy and see people come and work among them and not participate and benefit from the economic spin off. So, let's give the contractor a round of applause.

I am pleased that the Recovery and Development Agency, which is an extension of the Premier's Office continues to play its role in the execution of projects under the loan from the Caribbean Development Bank (CDB); projects which will contribute to supporting and simulating the Territory's economy in these crucial times of COVID-19. Sometimes when we look at our success through COVID-19 we take for granted that we are still in the middle of COVID-19. But the challenges are real, and every Territory is facing them.

Since the week of 7th May 2020, following a mandatory curfew for the Territory, your Government has signed several construction contracts through the Recovery and Development Agency and the Ministry of Finance to boost the economy. So, the construction industry in the BVI is doing extremely well because of the conscious decision made by this Government to ensure that we focused on that area and get it going and I know because I heard that from both of the main concrete plant suppliers and they have concluded that it is indeed going pretty well with both of them and this is a testament to show that your Government cares.

We saw this as a way to reboot and reawaken our economy following a

pause that was precipitated by the COVID-19

For example, contracts were signed by the RDA for work to rehabilitate and reconstruct public buildings like the Bregado Flax School in Virgin Gorda, the Flax Building in Virgin Gorda, the Vanterpool Administration Building in Virgin Gorda, and the North Sound Administration Building now officially renamed the John E. George Senior, MBE Administration Building.

As you can clearly see, Virgin Gorda is getting some T-L-C, and your Government will continue to ensure that this T-L-C is shared and felt throughout each district in the Virgin Islands.

We have also signed contracts for the start of works to get water to different reservoirs and to repair them in order to solve the some of the many long outstanding water woes. This

truly is a Government that cares.

I must say to my team at the Recovery and Development Agency, led by Virgin Islander Mr. Anthony McMaster congratulations for pushing the projects forward and not allowing the perfect to become the enemy of the greater good.

Today continues more TLC for Virgin Gorda and Anegada, and Ivan Dawson Primary School in Cane Garden Bay so that the entire BVI can move forward together.

I want to remind all of us about something important.

When your Government took office in 2019, we were faced with a compromised situation where the people of the Virgin Islands were paying a hefty interest on a CDB loan that was not being used.

That loan, based on how its mechanisms were designed, could not ensure that Virgin Islanders would meaningfully access opportunities to hold a stake in the development of their own economy, nor could they fully benefit from the economic activity this funding would create on our shores.

This meant that the vast majority of this money would not have passed through the BVI's economy, and the BVI businesses and workers would have been pushed to the side and disadvantaged from being able to access the benefits of this cash flow.

Your Government felt that this was unfair and a disservice to the people of the Virgin Islands, especially given that these were loan funds that the BVI taxpayers would be obligated to pay back.

Your Government felt that there were ways to be explored that would allow the BVI and the BVI people to gain a greater benefit from these loans.

You see, development is not just about building infrastructure. Development is also about people, and developing their skills and their capabilities. It is about building the

human capital of the Virgin Islands. It is about giving local sectors the opportunity to grow and develop when this is possible.

Your Government also saw this as an opportunity to allow for more persons to participate in this economic spin off than usual than was accustom to. Your Government saw the recovery and development agenda as an opportunity for of the people of the Virgin Islands, the local economy and local sectors, to develop and to grow.

We also saw these projects as having opportunities that could benefit the local private sector. As you have heard also that it allows for great partnerships to be forged especially with Unite BVI, and I single them out because there have been many projects that they have partnered with the Government of the Virgin Islands that we are immensely grateful to Unite BVI. So, your Government sat down with CDB upon taking office and we renegotiated some of the terms of the loan in the best interest of the people and the Virgin Islands, and we agreed on a clear plan forward with the help of Dr. Drexel Glasgow and the Ministry of Finance that will allow for priority areas to now be addressed in a transparent and accountable manner.

Your Government is happy to see that the CDB Loan Funding is actively being used to assist with jumpstarting the construction industry at this time.

As a leader, and as a Government, we have to have faith in our Virgin Islands people, especially as we mature in our journey towards self-determination.

We maintain - our people can do the work.

Our people can build this economy. Our fore-parents did it before, and we can do it again.

We just have to make sure that we prepare our people, because the future belongs to the prepared. Nothing is more important than having your own Virgin Islands people, Belongers, driving the prosperity of this Territory, for their heart must be in it. And we welcome the help of others

I thank the RDA for implementing the projects on behalf of the Government of the Virgin Islands and our team at the RDA. When I look at this Territory and I see what our people are doing with the assistance of others of course with those who continue to help us. When I look and I see how our people have handled COVID-19. I'm indeed proud. When I look and see how our people continue to handle disasters through Disaster Management I am indeed proud. When I look and I see the increased ratio of our people that continue to better themselves through technical fields, Master's, Bachelor's, Associates

and even Doctorates, I'm indeed proud and it shows that the Territory is continuing to mature. And I'm indeed proud if anytime such as now I am proud to be a Virgin Islander.

And I thank the RDA again for implementing the projects on behalf of the Government of the Virgin Islands.

I cannot underscore enough how pleased your Government is to see the RDA pushing forward so that our infrastructure can be built and re-engineered with the appropriate technology, reliable procurement systems, operational capacity, inbound and outbound logistics, marketing and sales, and supporting services.

We can build our Territory; we have built our Territory; and we continue to do so even with the help that we receive whether it be from United BVI, the FCO, private partners, we welcome it. Commission of Inquiry Seeking Information from Public Sector Employees. from Commission. They have expended to the commission.

The public has been giving information to the Commissioner of the Inquiry that is currently underway in the Territory. The COI which is to determine whether corruption, abuse of office or other serious dishonest activities may have taken place amongst the public, elected and statutory officials in recent years is said to be moving along well and the Commission said that it is ready to hear confidentially from persons in the public service.

Secretary to the Commission, Steven Chandler, in an update to the media on 15 February mentioned that the Inquiry is proceeding well. The Secretary stated: "The Commissioner is extremely grateful for the information that has been shared to date, and for the constructive engagement he received during his visit to the Islands in January/February; and for the information which continues to flow in."

Mr. Chandler said that at this point of the Inquiry the Commissioner Sir Gary Hickinbottom is ready to gather information from public sector workers. "The next stage of the Inquiry, expected to last several months, will involve seeking further information and documentation predominantly from public officials, including elected and statutory officials," Chandler said.

It was pointed out that the Government has put together a special policy to deal with information gathering from the public sector. In disclosing this the Commissions Secretary said: "The Commissioner has been informed and welcomes that it is BVI Government policy that all ministries, departments, statutory bodies, and Government-owned entities provide appropriate and timely cooperation with the Inquiry. He also understands that the Attorney

General, assisted by Withers Solicitors, will coordinate the implementation of that policy."

However, the Secretary of the Commission announced that public officers on their own can choose to share information with the Commission and that such information would be confidential. "The Commissioner wants to reassure the population of the BVI, and its public officers in particular, that whatever mechanisms government adopts to assist the Commission there is nothing to prevent those in public office who have concerns

from coming forward directly to the Commission. They have every right to do so, and if they do their information and input into the Inquiry will be kept strictly confidential."

"The Commission encourages anyone who would like to submit information relating to the Inquiry to do so as soon as possible via the secure website portal (www.bvi. public-inquiry.uk). As well as the website portal, the Commission has provided a number of different and secure ways for individuals to share information with the Inquiry Team... all information will be received and held in strict confidence," Mr. Chandler








CONTRACTS SIGNING GENERATES WHISPERS

As the various announcements of contracts being issued and persons being successful in bids on government projects are announced there are whispers in the Territory. The whispers have been coming from contractors who have not been able to get such contracts. Such whispers seemed to have caught the Premier's ears and on Monday he rebuked the complaining contractors.

Hon. Andrew Fahie while speaking at groundbreaking ceremony for the new NEOC building said that contractors on sidelines who are complaining should prepare themselves to take advantage of project opportunities.

The Premier who is also the Minister for Finance said: "I challenge the rest of the people in our community, especially the contractors and all those people on the sideline to get in the game. Go to the courses in the Ministry of Finance, register to be able to get a job with the government's registry to make sure that you are registered."

The Premier said that there are training opportunities and invited the contractors to take advantage: "You can get the training from the RDA. The game has changed and you cannot use the same rules, but if you want to be in the game you have to get on the field."

While hinting that he has heard the complaints the BVI Leader said: "I am encouraging our people that

are on the side grumbling like mumbling to stop grumbling and get on the field; so that you get your fair chance. I played softball and basketball for years and I am still the champion in many of those areas although retired. One of the things I have learned is that while the game is going only the members of the team can be subbed in; so if you do not get on the field and be part of the team that is developing skills you cannot be called in when the time comes and they need someone to go in do a specialised job."

While further rebuking the complainers Hon. Fahie noted that those who are successful in their bids should be congratulated. "I encourage my people to

develop. I encourage people to stop looking to see who got two contracts when they bid. It takes a lot to bid, it takes a lot of money. A lot of sacrifices there's a lot of things you need to put up homes different things; so you

cannot sit back and watch those who are taking a chance to develop themselves and then you sit on the side and complain. I want you to get in the game. The more you get in this life of construction the Premier can help you," he added.



BARBADOS - The COVID-19 pandemic is causing a deep recession in Barbados, but implementation of the Barbados Economic Recovery and Transformation (BERT) program remains strong and targets are still being met, an International Monetary Fund (IMF) staff mission reported last week.

The comments came at the end of an IMF staff visit, via videoconferencing, between February 2 and 5, to discuss the implementation of the BERT plan, supported by the IMF under the Extended Fund Facility (EFF).

"The prolonged COVID-19 pandemic continues to have a major impact on Barbados. The economy is estimated to have contracted by about 18 percent in 2020, with a gradual recovery projected to start in 2021," said team leader Bert van Selm in a statement.

"Tourism arrivals remain at a fraction of normal levels, and recent increases in COVID-19 cases in key source markets, including the US and the UK, will likely delay the recovery. In addition, a recent outbreak of COVID-19 in Barbados led to an ongoing lockdown that will reduce economic activity in the first quarter of this year." [Caribbean News Weekly]

SANTO DOMINGO - The secretary of organization of the Social

Christian Reformist Party (PRSC), José Balaquer, said on Thursday, 11 February 2021 that the party disassociates itself from the disorders that have been staged in front of the National Congress. PRSC deputy Pedro Botello led a crowd of protesters who resorted to vandalism to press for the passing of a bill by the Senate to allow workers to access 30% of their savings in pension funds. The bill had already passed in the Chamber of Deputies. The spokesperson for the PRSC party says it disapproves of the violent actions. "The PRSC disapproves of the vandalism that the claims of 30% of the AFP have turned into, even going so far as to destroy windows of offices of several senators," the secretary of organization of the party wrote in his Twitter account. Balaguer said that these unacceptable actions have been condemned by all of society.[DR1]

BERMUDA - Hurricane wind speeds around Bermuda have more than doubled because of a rise in sea temperatures, new research has revealed.

The study by the University of Southampton and the UK National Oceanic Centre found the average wind speed of storms near Bermuda increased from 35 to 73mph - an increase of more than 6mph every decade - between 1955 and 2019.

The sea surface and sub-surface

water temperature in the region increased by up to 1.1°C over the same time - which could add strength to storms.

Mark Guishard, the director of the Bermuda Weather Service and a co-author of the paper, said the research highlighted the major role that "upper ocean heat" - the temperature of the water in the top 50m - played.

He added: "Near-surface ocean heat provides the fuel for hurricane strength and the potential for storms near Bermuda to be more intense has accordingly been gradually increasing, as our study demonstrates."

Dr Guishard emphasised: "This research does not represent a prediction of the likelihood of storm impacts in any given year, but it reveals a trend in the intensity of those storms that do come through our area."

He said that there were "peaks and troughs" that explained variability in hurricane numbers year-to-year, but rising water temperatures had been a longerterm trend. [Royal Gazette]

USA - Federal health officials Wednesday urged Americans to keep their masks on and take steps to make them fit more snugly — or even to layer a cloth covering over a surgical mask — saying that new research had shown that masks greatly reduce the spread of the coronavirus.

Recent laboratory experiments found that viral transmission could be reduced by 96.5% if Americans wore snug surgical masks or a clothand-surgical-mask combination.

In announcing the findings, Dr. Rochelle P. Walensky, director of the Centers for Disease Control and Prevention, pleaded with Americans to wear a "well-fitting mask."

"With cases, hospitalizations and deaths still very high, now is not the time to roll back mask requirements," she said. "The bottom line is this: Masks work, and they work when they have a good fit and are worn correctly."

Masking is now mandatory on federal property and on domestic and international transportation. Studies conducted in households in Beijing, hair salons in Missouri and aboard an aircraft carrier in Guam have proved that "any mask is better than none," said Dr. John T. Brooks, the chief medical officer for COVID response at the CDC and lead author of the agency's new research on masking.

"Wearing a mask reduces spread, and in communities that adopt mask-wearing, new infections go down," Brooks said.

But while masks reduce the respiratory droplets and aerosols exhaled by infected wearers, and protect uninfected wearers, air leaking around the edges of a mask can reduce its effectiveness. The agency's new laboratory experiments showed how to fix the problem.


One option is to wear a cloth mask over a surgical mask, the agency said. The alternative is to fit the surgical mask more tightly on the face by "knotting and tucking" — that is, knotting the two strands of the ear loops together where they attach to the edge of the mask, then folding and flattening the extra fabric at the mask's edge and tucking it in for a tighter seal. [San Juan Star]

ROME - The new, more contagious British variant of COVID-19 currently accounts for almost one in five of the new cases of the coronavirus in Italy, 17.8%, according to the preliminary results of a 'flash survey' by the health ministry and the Higher Health Institute (ISS) along with regional laboratories.

That compares to a prevalence of 20-25% in France and 30% in Germany. It said the variant is likely to become the prevalent form of COVID in the coming months. It stressed that the COVID vaccines "remain effective against the mutated virus". (ANSA).

SPAIN - The fall in rent prices is no longer a big-city phenomenon in Spain. For the first time in years, the average cost of rent in the country is either on a downward trend or stagnating. This January,

the coronavirus pandemic ended a growth streak that had been uninterrupted since July 2015, according to real estate website Fotocasa, and since June 2014, according to property website Idealista. This makes it the first drop recorded since the 2008-2014 financial crisis in Spain. Meanwhile, in the big cities, rental prices continue to fall.

The real estate portals Fotocasa, Idealista and Pisos.com began to record a drop in the cost of rent in Spain's main cities in the early stages of the pandemic. Each month, rent became cheaper, and this began to be reflected in the national average. But in year-on-year terms, the cost of rent in any given month was still higher than it was in the same month of the previous year. Now, in 2021, this no longer holds true: the Spanish average of €11 per square meter that Idealista recorded as the asking price last January is 0.1% less than 12 months earlier. It is not a big drop, but it is significant as it is the first time this has happened since June, 2014, according to Idealista.[El Pais]



VACCINE ADMINISTERED TO LAW ENFORCEMENT

Thursday, February 18 – Commissioner of Police Michael Matthews says the vaccine 'jab' was quick, virtually painless and has provided for him a sense of protection and confidence moving forward.

The Commissioner sat this morning next to Head of Customs Mr. Wade Smith downstairs of the Police Headquarters as they both received the first of two shots of the COVID-19 vaccine. Outside headquarters was a line of other officers from the law enforcement sector waiting to receive the vaccine.

"I happily took the vaccine this morning. We are on the

frontline and just as we put on our protective vests and gear before dealing with potentially deadly situations, we must also readily put on our immunisation arsenal. It is that simple. The COVID outbreaks in the Force place several shifts out of commission. We were scrambling to maintain sufficient coverage during those days. While it is absolutely optional, I am happy there is an option for keeping continuity of service. "For the wider community, there is reluctance by many to take the vaccine. Truth is if the COVID deaths were higher here, we would see a lot more coming forward

for vaccinations. Government worked tremendously to keep the community safe, but the price is we essentially are isolated from the experiences of the world. Those I found in the line this morning were family members of individuals overseas who either died or almost died from the virus.

"Make no mistake - this virus is not selective. In the absence of any alternatives for keeping us safe and restoring our economies, I am happy there is an option," the Commissioner said.

Vaccinations are now being delivered today and tomorrow at Police Headquarters strictly for law enforcement officers.

Lions Club of Tortola Donates School Bus to Special Needs School

9 February 2021, Tortola, BVI: The Lions Club of Tortola, in partnership with the West Indian Association of Bermuda, the Ministry of Education, Culture, Youth Affairs, Fisheries and Agriculture (MECYFA) and the Ministry of Health and Social Development (MHSD) donated a brand new 13 seater 2020 Toyota Hiace School Bus to the Eslyn Henley Richiez Learning Centre (EHRLC), the Territory's school catering to children with special needs.

Speaking at the Handover Ceremony this morning, President of the Lions Club of Tortola, Kedrick Malone, said "the handover of this School Bus shows what is possible when voluntary organisations, the private sector, Government and the community work together to address needs". EHRLC lost its home to Hurricane Irma in September 2017 and it is yet to be reconstructed. The school was relocated to a room at the Althea Scatliffe Primary School where they remain to this day.

The donation was initiated by Lions Club of Tortola member Nichola Dunkley who reached out to the principal of EHRLC in September 2019 to see how she could assist one of the school's students. She discovered that the school had many needs and got the Lions Club to assist. By March 2020, the Club and corporate sponsors Infinite Solutions and Mourants had donated three Ipads and a 65 inch Smart TV to the EHRLC. The Club then turned its attention to the School Bus.

Bus came in the form of a grant from the West Indian Association of Bermuda who had previously raised funds for hurricane relief and were desirous of partnering with a local organization to put the funds towards a project. Through its representative Anil Chatergoon, the Association agreed to work with the Lions Club of Tortola and contributed \$20,000 towards the purchase of the School Bus for EHRLC. The funds were later supplemented by donations of \$9,000 and \$5,000 from the Ministry of Education, Culture, Youth Affairs, Fisheries and Agriculture and the Ministry of Health and Social Development, respectively.

In a statement from the Association read by Lion Nichola Dunkley, the Association expressed its pleasure in partnering with the Lions Club of Tortola in procuring the bus for EHRLC and said, "WIA (Bermuda) is especially grateful for the warmth and generosity of the Bermudian public that made our Give from the Heart Telethon in 2017 a success. We at the WIA believe that rebuilding the minds and hearts of children represents the indomitable spirit of the future".

Speaking at the Ceremony, Minister of MECYFA Dr. the Hon. Natalio Wheatley thanked the Club, the West Indian Association of Bermuda and all who played a part in the donation. He said he was "glad to be a part of the donation

serving the needs of children with special needs". He confirmed that plans for the new school are being completed and it will be relocated next to its current temporary home, the Alther Scatliffe Primary School, to allow the newly formed bond between the two schools to continue.

In a statement read by his Ministry, Minister for Health and Social Development Hon. Carvin Malone extended apologies for not being present due to a conflicting commitment and thanked the Lions Club, West Indian Association of Bermuda and all others the MECYFA and MHSD. responsible for making the bus a reality. He said, "we thank you for being team players. We are grateful for your ability to make a difference while positively changing the livelihood of others".

Accepting the keys to the new school bus, the Principal, Mrs. Vansittart Huggins thanked the donors for the new School Bus and pointed out that a bus has always been a part of the school since 1972 and it has been difficult not having one. She said that "most learning takes place outside the walls of the school and the bus will help the students to explore and have more meaningful learning".

Representative for the district and Minister for Transportation, Works and Utilities, Hon. Kye Rymer, was also on hand to welcome the donation. He said

The majority funding for the School as the MECYFA is a strong supporter of it was "a good enhancement to the school, particularly for field trips" and commended the partners for coming together to help the community.







Casseroles are One-Dish Wonders

I was looking for a baking pan in the back of a cupboard and inadvertently discovered I have quite a collection of casserole dishes. I started thinking about all the casserole recipes I've collected over the years. When I was a newlywed and novice cook almost 46 years ago, preparing a casserole was my "go-to" dinner recipe.

I decided to do some research on the origin of the casserole, and I discovered a photo of an ancient casserole dish in a museum in Athens, Greece. Casseroles, both the dish and various recipes, have had a long and interesting culinary history.

There's some debate about the origin of the term "casserole" but most culinary historians think it's from the French word for "saucepan." Casseroles come in a variety of styles, but what they all have in common is that they are typically a large, deep dish used both in the oven and as a serving vessel. The word casserole also is used for the food cooked and served in the dish. The Oxford Encyclopedia of Food and Drink in America provides detailed information about casseroles:

"Casserole cookery has been around since prehistoric times, when it was discovered that cooking food slowly in a tightly covered clay vessel softened fibrous meats and blended succulent juices. With the addition or subtractions of leftovers or inexpensive cuts of meat, the casserole is flexible and economical in terms of both



ingredients and effort. The classic casserole, a French dish, was originally made with a mound of cooked rice. Fannie Meritt Farmer's Boston Cooking School Cook Book (1896) had one casserole recipe, for Casserole of Rice and Meat, to be steamed for 45 minutes and served with tomato sauce.

"In the 20th century, casseroles took on a distinctive American identity. During the depression of the 1890s, the economic casserole provided a welcome way to stretch meat, fish and poultry. Certain items also were scarce during World War I, and leftovers were turned into casserole meals. The same was true during the Great Depression of the 1930s."

The casseroles we know today became popular in the 1930s during the Great Depression. Typically, casseroles are composed of a meat, starch, creamy sauce (after 1934, it was usually a creamed soup from a can) and a vegetable. - 1 pound smoked sausage, cut into 1/4-inch-thick slices
- 3 tablespoons vegetable oil
- · 1 medium-size green bell pepper, chopped
- · 1 small onion, chopped
- 1/4 cup instant roux mix, like Tony Chachere's Creole Instant Roux Mix
- 1 (10-ounce) can diced tomatoes and green chiles, like Rotel's
- · 1 (32-ounce) container chicken broth
- 1 (16-ounce) package frozen okra
- · 1 cup quick-cooking rice, uncooked
- 1/2 teaspoon Cajun seasoning
- · 1/2 teaspoon dried thyme
- 3 tablespoons butter, melted
- 2 garlic cloves, minced
- 1 (12-ounce) French baguette, cut into 1/2-inch-thick slices

Fresh parsley, finely chopped for garnish

- Heat the oil in a Dutch oven over high heat, 1-2 minutes. Add the sausage, green bell
 pepper and onion. Saute the sausage mixture for 8 minutes or until browned; stir in
 roux mix. Cook, stirring constantly, 2 minutes.
- 2. Stir in tomatoes, chicken broth, okra, rice, Cajun seasoning and thyme. Bring mixture to a boil. Remove from heat. Pour into a 13- by 9-inch baking dish.
- 3. Stir together butter and garlic; brush on one side of bread slices. Top sausage mixture evenly with bread slices, buttered side up.

The Guyana Tourism Authority (Gta) rolls out "Safe for Travel" plan to open up Tourism and ensure communities and travellers remain protected

Georgetown, Guyana (February 4, 2021): The Guyana Tourism Authority (GTA) has launched a new marketing messaging tied to its revamped inspection process due to COVID-19 titled "Safe for Travel" that sees the tourism body, given the authority by the National COVID-19 Task Force, to assess tourism businesses to ensure they are operating within the National COVID-19 Gazetted Safety Measures and in a position to welcome the return of domestic and international travel. The objective of the scheme is to protect the areas most affected and vulnerable to the COVID-19 pandemic as well as ensure that the health and safety of the traveller is always front-of-mind as the destination reopens to tourism.

In response to coronavirus, the Government of Guyana cancelled all international passenger flights beginning 18 March 2020, however the Guyana Civil Aviation Authority has since launched a phased re-opening approach. Details of which are as follows:

Phase 1 - 18 March - 11 October 2020: Repatriation flights.

Phase 2 - 12 October 2020: Limited incoming commercial flights for Guyanese citizens, permanent residents, international travellers, international workers and diplomats.

Phase 3 - November 2020 (in place as of January 2021): Expansion of incoming commercial flights that allow foreign nationals and international travellers to enter Guyana.

Phase 4 - TBC: Expansion of inbound and outbound flights to provide more service for inbound and outbound tourists.

As of January 2021, this reopening is currently in phase three which has seen the expansion of commercial flights that now allow foreign nationals and international travellers to enter Guyana. With this comes risk that the virus could spread from visitors to some of Guvana's most vulnerable communities in a country that has seen relatively low case rates throughout the pandemic.

To protect these communities and the general population, travellers to Guyana are required to present a negative PCR test from an accredited lab. Negative tests from within 72 hours of arrival will be allowed to pass through the airport. However, if the PCR test is done within four to seven days of travel, the passenger will be required to do another PCR test upon arrival in Guyana and present a negative test. It should be noted that if a passenger is required to take a test in Guyana, it will come at their expense at a cost of GY\$16,000 (approx. £56). More information on travelling to Guyana is available at www. guyanatravel.gy.


The 'Safe For Travel' scheme has been put in place as a further measure to protect the Guyanese population, including vulnerable communities, and travellers alike. Tourism businesses are assessed in a two-step procedure. First, they must submit their Standard Operating Procedure (SOP) detailing how the business has adjusted its practices and adopted new measures to prevent the spread of COVID-19. Once the SOP has been submitted, the GTA will carry out an inspection on the business to ensure they are meeting the criteria as follows:

- 1. Signage (hand wash, mask wearing and social distancing)
- 2. Temperature Monitoring (calibrated thermometer temperature checks)
- 3. Sanitisation practices and products in use
- 4. Staff Safety
- 5. Guest Safety
- 6. Monitoring how the business plans to monitor the effectiveness of its SOP

Once a tourism business has been assessed and deemed to be COVID-19 compliant by the GTA and National COVID-19 Task Force, approval is granted for the business to begin operating once again

In addition to these newer measures, the GTA was able to provide COVID-19 Support Packages to indigenous communities tied to the tourism value chain earlier in the pandemic. Communities that are actively in the tourism licensing process and working with the GTA benefited from a package that included recommended Ecolab cleaning and sanitation products, infrared thermometers, cloth and sewing supplies for creating masks, knapsack sprayers to disinfect buildings and luggage etc, and signage on COVID-19. For communities not actively involved in tourism, the packages included sanitation products, cloth and sewing supplies for creating masks and signage on COVID-19. The support packages were delivered with a training session done by Ecolab and Ministry of Health representatives as well as the

Independent Commission to Examine Capitol Riot, Pelosi Says

House Speaker Nancy Pelosi said Monday that Congress will establish an independent, September 11-style commission to look into the deadly insurrection that took place at the U.S. Capitol.

Pelosi said the commission will "investigate and report on the facts and causes relating to the January 6, 2021, domestic terrorist attack upon the United States Capitol Complex ... and relating to the interference with the peaceful transfer of power."

In a letter to Democratic colleagues, Pelosi said the House will also put forth supplemental spending to boost security at the Capitol.

After former President Donald Trump's acquittal at his second Senate impeachment trial, bipartisan support appeared to be growing for an independent commission to examine the deadly insurrection.

Investigations into the riot were already planned, with Senate hearings scheduled later this month in the Senate Rules Committee. Pelosi of California asked retired Army Lt. Gen. Russel Honoré to lead an immediate review of the Capitol's security process.

In her letter Monday, Pelosi said, "It is clear from his findings and from the impeachment trial that we must get to the truth of how this happened."

She added, "As we prepare for the Commission, it is also clear from General Honoré's interim reporting that we must put forth a supplemental appropriation to provide for the safety of Members and the security of the Capitol."

Lawmakers from both parties, speaking on Sunday's news shows, signaled that even more inquiries were likely. The Senate

verdict Saturday, with its 57-43 majority falling 10 votes short of the two-thirds needed to convict Trump, hardly put to rest the debate about the Republican former president's culpability for the January 6 assault.

"There should be a complete investigation about what happened," said Louisiana Sen. Bill Cassidy, one of seven Republicans who voted to convict Trump. "What was known, who knew it and when they knew, all that, because that builds the basis so this never happens again."

Cassidy said he was "attempting to hold President Trump accountable," and added that as Americans hear all the facts, "more folks will move to where I was." He was censured by his state's party after the vote.

An independent commission along the lines of the one that investigated the September 11 attacks would probably require legislation to create. That would elevate the investigation a step higher, offering a definitive government-backed accounting of events. Still, such a panel would pose risks of sharpening partisan divisions or overshadowing President Joe Biden's legislative agenda.

"There's still more evidence that the American people need and deserve to hear, and a 9/11 commission is a way to make sure that we secure the Capitol going forward," said Democratic Sen. Chris Coons of Delaware, a Biden ally. "And that we lay bare the record of just how responsible and how abjectly violating of his constitutional oath President Trump really was."

House prosecutors who argued for Trump's conviction of inciting the riot said Sunday they had proved their case. They also railed against the Senate's Republican leader, Mitch McConnell, and others who they said were "trying to have it both ways" in finding the former president not guilty but criticizing him at the same time.

Republican Sen. Lindsey Graham of South Carolina, a close Trump ally, voted for acquittal but acknowledged that Trump had some culpability for the siege at the Capitol that killed five people, including a police officer, and disrupted lawmakers' certification of Biden's White House victory.

Graham said he looked forward to campaigning with Trump in the 2022 election, when Republicans hope to regain the congressional majority.

"His behavior after the election was over the top," Graham said. "We need a 9/11 commission to find out what happened and make sure it never happens again."

The Senate acquitted Trump of a charge of "incitement of insurrection" after House prosecutors laid out a case that he was an "inciter in chief" who unleashed a mob by stoking a monthslong campaign of spreading debunked conspiracy theories and false violent rhetoric that the 2020 election was stolen from him.

Trump's lawyers countered that Trump's words were not intended to incite the violence and that impeachment was nothing but a "witch hunt" designed to prevent him from serving in office again.

The conviction tally was the most bipartisan in American history but left Trump to declare victory and signal a political revival while a bitterly divided Republican party bickered over its direction and his place in the party.

The Republicans who joined Cassidy in voting to convict were Sens. Richard Burr of North Carolina, Susan Collins of Maine, Lisa Murkowski of Alaska, Mitt Romney of Utah, Ben Sasse of Nebraska and Pat Toomey of Pennsylvania.

"It's frustrating, but the founders knew what they were doing, and so we live with the system that we have," Democratic Delegate Stacey Plaskett, a House prosecutor who represents the Virgin Islands, said of the verdict, describing it as "heartbreaking." She added: "But listen, we didn't need more witnesses. We needed more senators with spines."

McConnell told Republican senators shortly before the vote that he would vote to acquit Trump. In a blistering speech after the vote, the Kentucky Republican said the president was "practically and morally responsible for provoking the events of that day" but that the Senate's hands were tied to do anything about it because Trump was out of office. The Senate, in an earlier vote, had deemed the trial constitutional.

"It was powerful to hear the 57 guilties. And then it was puzzling to hear and see Mitch McConnell stand and say, 'Not guilty' and then minutes later, stand again and say (Trump) was guilty of everything," said Democratic Congresswoman Madeleine Dean of Pennsylvania. "History will remember that statement of speaking out of two sides of his mouth."

Dean also backed the idea of an impartial investigative commission "not guided by politics but filled with people who would stand up to the courage of their conviction."

Cassidy and Dean spoke on ABC's "This Week," Graham appeared on "Fox News Sunday," and Plaskett appeared on CNN's "State of the Union."

Brewley told Island Sun Sports that the game was very competitive and she fell apart in the second set and wondered what was happening.

"Nevertheless, I kept fighting, I kept motivating myself, because I learned that from my husband to motivate yourself during the match, in order to keep yourself up, keep focused and a positive vibe flowing," she said. "I kept fighting, didn't drop my shoulders and came back and won the third set."

Against Glenn, she said she had him on his toes despite the loss.

Competing in the Safe Group, Pat Lettesome overcame Keziah "Jade" Bolton, 3-4, 4-3, 4-3.

Lettsome said she played a little timid because of a knee problem.

she said, noting that after the 4-1 second set to Brewley, she was hoping to carry the momentum and stay in the game. "In the third set she came back and ultimately won the game."


Coach and tournament director Carol Matthew, told Island Sun Sports that it was a good tournament and she's proud of all the players.

Five new members elected to BVI Volleyball Association Executive

Rockel Woods, Kiah Walters, Valissa Brathwaite, Caldon "Reno" Morton and Canis Marquis, were elected as five new Virgin Island Volleyball Association Executive Committee members on Monday night, during the body's quadrennial elections at the Multipurpose Sports Complex, which also saw Stephen Payne as the new president taking the helm. He was nominated unopposed as well as Vice President, Marquis.

Woods garnered 13 votes to Henrietta Alexander's 5, for the post of Assistant Secretary. Kisheba Sprauve-Callwood was returned as General Secretary unopposed. Walters amassed 11 votes to Curtis Davis'7, to become the Public Relations Officer. Brathwaite tallied 15 votes and Morton 13, for the posts of Player Representatives. Tylia "Tweety" Nibbs received 6 votes and Arianna Forbes, 2. Anabelle Skelton-Malone—the former Assistant Secretary—was unopposed as Treasurer. Maria Drigo retained her post as Assistant Treasurer.

"My vision is to put volleyball back where it was when I came here," Payne told Island Sun Sports. "Volleyball was a vibrant sport. There was youth involvement in it from the schools and that's where I want to see it go. The motto for volleyball is keep the ball flying. We want the ball to be flying in the near future."

In order for youth development to take place, Payne said coaches need to be developed and given the knowledge and transfer it through the schools. While there are PE Teachers with certain core knowledge, youth development goes beyond knowing the basics.

"It's a whole program that you have to incorporate, after school programs, making sure volleyball is played on a consistent basis," he pointed out. "Youth development is something that caters to senior development. If you don't have a youth segment, there's no future for the sport. I've realized we don't have a senior national team because we don't have any youth programs to develop the senior national team. We must invest first and foremost and that's one of the things I'll be trying to implement, to ensure we get the requisite training for coaches, the officiating side of things. Even if we have to bring in persons to work along with the association, to make sure focus can be given to youth development."

Payne said there are naturally gifted persons within the schools. They might have the height or be able to jump. However, he said the game must be introduced in the Primary Schools.

"Introducing certain skills in the game—it might not be volleyball per say—but it might be motor skills, skills that are necessary for the development of the sport," he said. "Lateral movement, jumping, all of those kinds of things, then bringing them up introducing balls at tennis net height level, make the game interesting. And if you can develop a love for the game, then you'll stick with it."

Payne, who's almost 60, began playing volleyball with a ball made from goat skin in primary school in Barbados at 11 and said his love for the sport hasn't waned because of his early exposure. He envisages the same here, once youngsters are exposed early.

"Inorder for you to get that kind of advancement, you must have persons in the trenches to coach; you must have the support of the government; you must have the support of the schools," he explained. "From primary school, we need to do a better job with the PE Teachers working alongside of the Volleyball Association and sport disciplined coaches, for instance Volleyball coaches will go in a work alongside the normal PE Teachers, develop a curriculum, develop a program and we can make it happen."



Haiti – on the edge of disaster again

Haiti – a country to which all other countries that suffered slavery are deeply indebted - is once again in turmoil. Therefore, no Caribbean Community (CARICOM) country should stand aside, silently, while Haiti is sliding into further

catastrophe, retarding its already impoverished economy and depriving the Haitian people of hope for an improved future.

Of course, no country should interfere in the internal affairs of any other state. CARICOM has never done that. In the times, when the organization has played a role in resolving political, electoral, and

constitutional issues in a CARICOM member-state, it has done so at the invitation of the Government and other political parties. This occurred most recently in Guyana, where CARICOM played a pivotal role in upholding democracy and ensuring the credible result of elections.

Non-interference in the internal affairs of a state should not be construed as approval. And, when conditions reach the point of loss of lives, the least that friendly states should do is to offer to help to bring about peace and to assist in resolving the issues that are causing violence and destruction. While the Haitian government might not agree, the present circumstances of the country are crying out for remedial action.

Hence, CARICOM was right, on February 11, to issue a public statement "encouraging all parties to engage in meaningful dialogue in the interest of peace and stability" and "strongly urging that action be taken to foster a safe environment, a return to normal life and the building of sustainable democratic institutions".

Since October 2019, when President Jovenel Moïse postponed parliamentary and local elections, there has been no legislature in Haiti. The President has ruled the country by decree, contrary to its Constitution. Even at the municipal level, when the terms of elected Mayors end, Moïse has appointed persons of his own choosing.

Further, in the absence of a legislature which, under the Constitution, is required to approve appointments to independent institutions and law enforcement agencies, including the Police, President Moïse has unilaterally installed favoured persons. For over a year, these circumstances have infuriated opposition parties as would be expected, but they also caused alarm among human rights groups within the country and internationally.

More recent events in Haiti, however, have attracted strong criticism of Moïse. The most compelling condemnation has come from seven members of the House of Representatives of the United States of America (U.S.). In early February, they wrote to the Secretary of State, Anthony Blinken, demanding the departure of Moïse "in accordance with the Haitian Constitution".

For several months, the contention has been made by political and civil rights groups in Haiti, that in conformity with the Constitution, the President's term ended on February 7 – five years after the last elections in November 2016. He has contended that, notwithstanding the position stated in the Constitution about the life of the President's term, he is entitled to remain in office for another year, since he did not assume office until February

In a situation in which a President's stewardship has brought peace, economic development and social progress, the Haitian society may have gone along with Moïse's view. Unfortunately, the situation on the ground in Haiti has been very

> different. Moïse was not a popularly elected President. The 2016 elections had a low turnout of voters. His actions, since then, especially his ruling by decree, weakened his approval still further.

> In this amosphere, the country slipped into lawlessness - some of it allegedly engendered by Moïse's ruling party. Kidnappings and killings haunted rich

and poor alike, and marauding gangs ruled districts driving fear into communities. Massacres occurred in neighbourhoods where opposition to Moïse is strong.

All this led to street protests which the government met with an iron fist. In recent weeks, Police have fired live ammunition into crowds, killing and wounding people including two journalists, one of whom is in a critical condition.

During this, on February 7, Moïse alleged that there was a plot to overthrow him. Police arrested and detained 23 persons, including a former presidential candidate, a high-ranking police inspector and a judge on the country's highest court. Additionally, Mosie, arbitrarily sent three judges of the Court of Justice on retirement. One of these judges was named jointly by the Opposition parties as the "Interim President" of Haiti – much as happened with Venezuela's Juan Guaidó. The U.S. Embassy in Haiti issued a statement questioning the merits of the action to unseat the judges.

Several non-CARICOM countries, looking for a solution to the current problem, are doing what they usually do - focussing on Presidential elections to end the conflict.

The problem is that there is no credible election machinery in Haiti, including no up-to-date and verifiable electoral list. What is more, Moïse appointed a Committee of his associates to make recommendations on institutional and political reform, including of the provisional electoral council (CEP) which administers elections.

The much greater problem is that he plans to hold a referendum on April 25 on a draft constitution that his Committee has drafted. Amongst other things, the draft constitution, will set the stage for Presidential and other elections. The process has no credibility and no support from opposition political parties and civil rights groups and, therefore, will continue to rouse protests and crowd demonstrations.

Haiti, including President Moïse, and all the other actors - political and civil - need the help of honest brokers and mediators to help create agreed conditions to remedy the institutional issues, including the election machinery. Without it, the situation is Haiti will worsen.

No country or organisation can impose itself to assist Haiti. The Haitian players must invite such help. Until they do so, all organisations, including CARICOM and the Organisation of American States should express their concerns and stand ready to be helpful to the people of Haiti who deserve the chance for a better life.

Climate change is here to stay causing wars, starvation, disease, migration and misery on an unprecedented global scale. In fact patterns keep changing all the time and what was unthinkable two years ago is now becoming a new and disquieting norm, just look at the extreme winds affecting Europe, Ireland, the British Virgin Islands and the United Kingdom, look at the late summer heathwave in the BVI, and tropical storms and hurricanes moving in new directions.

If this madness were not enough, climate change comes with many problems and complications attached. We live on a planet whose population is growing beyond control and beyond nutritional viability, all in the name of religions or philosophies sermonising the populace to continue to happily multiply their specie: after all it's good for all types of business - including funeral homes. Caveat, though: mass graves as we are seeing have become the norm!

In recent years some countries freed themselves from hunger or at least curbed it, but in 2018 analysts saw this pattern reverse and return to the dramatic levels of malnutrition and starvation that killed and kill million after million: we have reached a breaking point beyond which people will turn to methods of survival whereby the Latin motto "Mors tua Vita mea" [the law of the jungle: your death is my life will be on flags and coat of arms of many nations engaged in the battle for survival. The remedy is no remedy: putting the prices of staple food higher and higher. Beware, when people face death they will not hesitate to kill for their own survival.

Why did we get to this point? GREED, yes, greed of that 1% who keeps getting richer and gets tax cuts all the time while the others pay 24% VAT and face fiscal pressure of unprecedented proportions as well as salary deductions and pensions cut-back.

Mike Rowse says that mass migration, driven by war and politics, has already fuelled social discontent in Europe and America. But things may get much worse if climate change continues unchecked.

The USA is no example: the decision by Trump to rescind the Paris agreement is the most irresponsible thing perpetrated by a head of state at this point in history. The damage has been done, but it will be difficult to patch it over and forget, even with all of President Biden's goodwill. Corrupt leaders, money grabbing politicians and greedy zillionaires are taking us to an Apocalyptic end of the world FULL SPEED.


"Justice Ramdhani comes to


Government Seeks New Registrar Of Interests



In the COVID-19 vaccine race, we either win together or lose together

Joint statement by UNICEF Executive Director Henrietta Fore and WHO Director-General Dr. Tedros Adhanom Ghebreyesus

Of the 128 million vaccine doses administered so far, more than three quarters of those vaccinations are in just 10 countries that account for 60% of global GDP.

As of today, almost 130 countries, with 2.5 billion people, are yet to administer a single dose. This self-defeating strategy will cost lives and livelihoods, give the virus further opportunity to mutate and evade vaccines and will undermine a global economic recovery.

Today, UNICEF and WHO - partners for more than 70 years - call on leaders to look beyond their borders and employ a vaccine strategy that can actually end the pandemic and limit variants.

Health workers have been on the frontlines of the pandemic in lowerand middle-income settings and should be protected first so they can protect us.

COVAX participating countries are preparing to receive and use vaccines. Health workers have been trained, cold chain systems primed. What's missing is the equitable supply of vaccines.

To ensure that vaccine rollouts begin in all countries in the first 100 days of 2021, it is imperative that:


Governments that have vaccinated their own health workers and populations at highest risk of severe disease share vaccines through COVAX so other countries can do the same.

The Access to COVID-19 Tools (ACT) Accelerator, and its vaccines pillar COVAX, is fully funded so that financing and technical support is available to lower- and middle-income countries for deploying and administering vaccines. If fully funded, the ACT Accelerator could return up to US\$ 166 for every dollar invested.

Vaccine manufacturers allocate the limited vaccine supply equitably; share safety, efficacy and manufacturing data as a priority with WHO for regulatory and policy review; step up and maximize production; and transfer technology to other manufacturers who can help scale the global supply.

We need global leadership to scale up vaccine production and achieve vaccine equity.

COVID-19 has shown that our fates are inextricably linked. Whether we win or lose, we will do so together."



Post-COVID Symptoms Will Have Profound Impact on Global Health

The World Health Organization says debilitating post-COVID-19 symptoms in patients will have an impact on global health because of the magnitude of the pandemic.

The World Health Organization is conducting research into why many people who are infected with COVID-19 continue to suffer from various disabling conditions for up to six months after they have had the illness.

The team lead of WHO's Health Care Readiness Division, Janet Diaz, says some people with post-COVID-19 conditions, also known as "long COVID" have not been able to go back to work. She says their incapacitating symptoms prolong their recovery period.

"Some of the more common symptoms of the post-COVID-19 condition can be fatigue, exertional malaise, and cognitive dysfunction. Sometimes you may be hearing patients describing that as 'brain fog.' These are real," she said.

Other complications include shortness of breath, cough, and mental health and neurological complications. Diaz says it is not clear which patients are most at risk of long COVID. She says they range from patients who have been hospitalized and required intensive care treatment to those with mild illnesses who were treated in ambulatory outpatient settings.

She says researchers do not know why this is happening and are working hard to get the answers to the many questions surrounding this disease, caused by the SARS-CoV-2 virus.

"We are concerned, obviously, with the numbers of patients infected with SARS-CoV-2 virus. ... We do not know how common it is or how uncommon it is. But the numbers, just by the magnitude of the pandemic will impact health systems. Again, the main message from us is prevent infection with SARS-CoV-2. So, the public health measures are the No. 1 intervention right now that we know will prevent this," she said.

These measures include observing physical distancing, wearing a mask and handwashing.

WHO is calling for a coordinated global research response and the collection of as much standardized clinical data as possible to better understand the condition and learn how to better treat those afflicted with this complication. [VOA]





Childhood Vaccinations Still Mostly Effective

DEAR DR. ROACH: I am in my mid-50s and in good health (I don't take any medications). I rarely get sick with colds or flu. I have been vaccinated with all the common vaccinations for our childhood. With all the immigrants coming into our country, I am wondering if any have been given childhood vaccinations in their countries. I fear that chickenpox, measles, etc., could re-enter this country. If so, do our childhood vaccinations still protect us from these diseases? Should seniors be re-vaccinated or is that harmful at our age? - C.S.

ANSWER: Legal immigrants into the U.S. are required to have all vaccinations as recommended by the Advisory Committee for Immunization Practices.

Undocumented immigrants are more difficult to study, but what data there is suggests that vaccination rates are roughly the same in the countries of origin of many undocumented immi-grants as in the United States. In fact, several Central American countries have higher vaccination rates than the

U.S. currently.
Analysis of outbreaks of vaccine-preventable diseases have suggested that most of these outbreaks have come from visitors (Americans or foreign visitors) from countries with high levels of ongoing transmission who spread the disease to others during their infectious period. Because there are some communities where there are enough unvaccinated people due to medical reasons, personal choice or ineffective vaccination to allow spread of the disease, there continues to be ongoing infection in the U.S. This is especially true of measles.

People born before 1957 are generally considered to be immune to measles, and the vast majority have had chick-enpox. People born between 1963 and 1967 (that might be you) are at risk for having had ineffective measles vaccination, and those at risk should check their immunization status and may need revaccination, especially those in an area near an outbreak.

DEAR DR. ROACH: I read your recent column on vaginal estrogen. Based on plants such as soy, bioidentical hormones are a safe solution for older people that provide sexual rejuvenation. You should spread the word! — P.F.

ANSWER: I appreciate your passion, but there are several problems with your statement.

First, the bioidentical female hormone in humans is estradiol, which is available only by a prescription. It remains my choice for women who need hormone replacement, such as women with severe symptoms of menopause (replacement is given by mouth or patch), or for women with atrophic vaginitis (given vaginally, by cream, tablets or ring). It is certainly the most natural option.

Second, phytoestrogens (the soybased hormones, such as isoflavones and lignans) have chemical structures similar to estradiol, but absolutely are not bioidentical. They have both estrogen and anti-estrogen properties. They may slightly reduce breast cancer risk, probably have no effect on endometrial cancer risk and probably do not increase clotting risk. However, for women with a history of breast cancer, many oncologists recommend against soy protein due to its estrogen activity. Some hematologists warn against these in people with history of abnormal blood clots.

The effect of phytoestrogens on sexual function has been studied, and a 2018 review showed that soy "had no promising effect" on sexual function. Of course, some women will have better effects than others.


