# WATER PROBLEMS GET HON. RYMER'S ATTENTION

Water problems continue to affect residents of the Territory and Minister for Transportation Works and Utilities Hon. Kye Rymer said that the complaints have been plenty and the Water and Sewerage Department is feverishly working to resolve the issues – some of which have been longstanding.

In a statement to the House of Assembly on 10 March, Hon. Rymer said that several remedial efforts are being taken and are in the pipeline to ensure that the BVI has a reliable supply of water. However, he said that the old troubles are causing issues: "Mister Speaker, over the past few months the Ministry and the department have been bombarded with calls from customers who have been experiencing a myriad of water issues pertaining to but not limited to their water bill."

The Minister told Legislators, "This and other



issues are of real concern to me and my Ministry and we are working feverishly to solve them. In an effort to effectively and efficiently address all customers concerns in a timely manner, the department has optimized its Customer Service team that

will focus on receiving queries, investigating situations, and providing options to remedy these issues."

The situation is so serious that Hon. Rymer said that a temporary halt on disconnections of

water supply had to be implemented. The Minister explained: "In recognition of the heightened challenges the customers are experiencing, the Government of the Virgin Islands has placed a three-month grace period on water disconnections Territory-wide.

This grace period took effect on 18 January and is slated to expire on 30 April. This period is to allow customers the opportunity to settle outstanding balances."

# Water Problems Get Hon. Rymer's Attention

"This Government understands the challenges that the residents have experienced as a result of the impact of the COVID-19 pandemic. Therefore, we decided to add some leniency in the regularly scheduled disconnections. During this period, we continue to encourage customers of the Water and Sewerage Department including those with bill discrepancies to make arrangements to bring their accounts current," he further noted.

To deal with complaints from residents about their bills, the Minister said that the Ministry has plans to replace the water meters that are currently in use. Hon. Rymer disclosed: "To curb the margin of loss, in the first instance, five thousand three hundred and twenty-five (5325) ultrasonic digital water meters with the capability to be read remotely were purchased and are being installed throughout the Territory, thereby replacing the existing analog meters. This will lead to a much more

efficient and effective water accountability and billing system."

Meanwhile, the Minister is asking residents to exercise patience about the various water issues and pointed out that the situation did not develop recently. "The water infrastructure in the Territory has been under stress for decades. The infrastructure is aged and dilapidated and as a result, frequent repairs of leaks and water line breakages have become the modus operandi of the Water & Department on a daily basis."

In further explaining the prevailing issues with water, Hon. Rymer mentioned that the hilly landscape of the Territory makes the situation even more difficult. However, he noted that a solution on how to make the most of the topography has already been found. "Water distribution is further complicated by the topography of the Territory, with the exception of Anegada which suffers from other water quality issues. The mountainous terrain on the remaining islands makes pressure management challenging. We cannot

continue to have residents living without a reliable potable water supply. For this reason, with the support of the Ministry, the Water & Sewerage Department has placed much emphasis on improving and enhancing the water distribution networks. The plan for an island with our topography is to reduce the pressures with Pressure Reducing Valves, leak detection exercises, leak repairs with resilient materials, installation of air release valves and meterization."

# Agriculture & Fisheries to get better attention

Deputy Premier and Minister for Agriculture and Fisheries Dr. the Hon. Natalio Wheatley is confident that the agriculture and fisheries sectors are about to be reborn. The Minister in a statement in the House of Assembly on 10 March touched on the myriad of issues that have plagued the sectors for decades and announced that several plans are in the pipeline to breathe new life into agriculture in the Territory.

For decades water woes have been the main complaint from farmers, especially those at Paraquita Bay which was described as the agriculture central in the BVI. The situation

has been laid at the feet of successive Ministers and Hon. Wheatley said that he has also heard the cries. In noting that plans are afoot to bring aid to agricultural enthusiasts the Minister said: "Farmers continue to face frustrating water woes on the Paraquita Bay estate. Leaking pipes and indiscriminate water use when it is available are some major issues we are facing in this area," Hon. Wheatley said.

The Deputy Premier also mentioned that the Minister of Works and Utilities Hon. Kye Rymer assured him that the pipes and other water systems in Paraquita Bay will be tended to ensure that

water is effectively delivered to the farms. "We are working on upgrading the aging infrastructure on the estate," he said.

"Major work will include carrying out comprehensive repairs to the water distribution system and installing hillside tanks that can supply water on the estate when the main supply is unavailable," Hon. Wheatley further explained.

Another great issue for farmers throughout the Territory is the matter of roaming animals. For years many persons have announced that their efforts to plant in their yards are

thwarted by roaming cows and goats that feed on their cultivations. The Minister noted that the Ministry is aware of the situation and has also made plans to tackle the problem of wandering animals.

In mentioning this Hon. Wheatley said: "Other major works in Paraquita include the reconstruction of the animal pounds to alleviate some issues we face with free-roaming animals from the damage they can cause to properties throughout the Territory. That is nearly finished."

Dr. Wheatley said that plans are also afoot to host

a farmers and fishermen exhibition market day on the 24 April under the theme Restore, Increase Sustain And Educate. Hon. Wheatley said that the Ministry is cognizant that these are COVID sensitive times, but he said that the cause for the event is great.

"We will all appreciate that resources are limited. We were mindful that precautions to reduce the risk of COVID 19 are very much in place. We do however think that it is important to highlight the work of the agriculture and fisheries sectors and look forward to public participation as much as possible," he explained.

# Deputy Speaker Criticizes the Law & Order Situation

Deputy Speaker of the House of Assembly, Hon. Neville Smith is not pleased that bloggers have been hurling blame at the Government regarding the recent criminal activities in the Territory. Hon. Smith in an announcement in the House of Assembly on 10 March said that the violent crime issue should be on the Royal Virgin Islands Police Force high priorities. Further, the legislator issued a challenge for the Commissioner of Police Michael Matthew to present a plan for tackling the issue. This challenge, however, did not seem to sit right with the Commissioner who took to the radio to announce that he was disappointed.

Hon. Smith made his comments during the Private Members section of the 10 March sitting of the House of Assembly. The Legislator lashed out at the bloggers for comments that he said were irresponsible: "We are talking about freedom of speech, there's a difference between freedom of speech and defamation of character. You can go and you can call me a fool if you want, that's okay; but when you being a criminal or thief that is wrong...and there are laws in place that this should not happen. But here again we do not do what we're supposed to do. Enforcement Mr. Speaker. We are passing a heap of laws here and there's no

enforcement," the Deputy Speaker said.

In taking umbrage to the blaming of government for the recent spate of robberies and murders the Deputy Speaker declared: "The crime and the drugs that are taking place and everybody is blaming the government. How can you blame the government for this, there are laws in place. Mr. Speaker let me ask you a question – the drugs are made here – no. The drugs staying here – no. they coming from somewhere and going somewhere but they have to pass more than one stop before they reach here – they don't have security as well.:

"I am trying to figure out why are we getting the blame for this and it has to pass through all sort of different areas before it comes here but when it reaches the BVI is the biggest drug place in the world. Can anyone give me the ratio of a list of how many drug addicts we have in the BVI. Do we have any. Do we have a rehab center that has people who are addicted to drugs – seldom," he further added.

Hon. Smith also explained that the situation in the Territory as it relates to drug matters is not as dire as the bloggers make it seem: "We have one or two people who drink alcohol – that's there. We have to stop furnishing and putting ourselves in a situation where we calling down

each other. You calling down the government about stuff that we are not responsible for. Yes, we are responsible because we are government but we are not the ones who are supposed to turn around and enforce the law."

He then turned his attention to the Commissioner of Police and issued the challenge to see a plan geared at dealing with the recent spike in criminal activities from the RVIPIF. Hon. Smith said: "I am going to call out the Commissioner of Police today, I am going to call him out and I am going to tell him he needs to come to the public and give us a plan he has to fight crime right now. I'll give him two weeks but he needs to come with a plan to the people to say how he is going to fight this crime. We had five or more deaths, murders just the other day, what are we hearing. What people are going to say?... What government could do? We already put things in place.

Once again I am going to ask the question. What is succession planning?"

## Commissioner Responds

On Monday this week Commissioner of Police Matthews during a ZBVI interview responded to the comments made by the Deputy Speaker. The Commissioner minimized the Legislator's request for a plan by announcing that such a plan is already with the National Security Council.

"The plan was actually submitted towards the end of last year but it was finally heard in the National Security Council on the 10th of February. So we've had the plan and we've actually been working on that plan since last October. It was a composite plan. Indeed, the Deputy Premier asked for more time to study the plan because he wanted to go into depth on it. So that's the first thing — there has been a plan presented and agreed," the Commissioner announced.

Matthews further added that his officers have been working hard to deliver on the Force's mandate and he declared that recent figures are testimony that things in the Territory are not so bad. "Recorded crime [went] down five percent last year, serious violence down nine percent last year, detection rate up 55 percent. And for the naysayers that say, 'well, that's all well and good but you are not doing anything about these noisy scooters,'

we seized 12 scooters in the last 14 days. Now, that doesn't sound to me like we haven't got a plan and we're not fighting crime," the Commissioner announced.

He said that that like Hon. Smith he has also heard the chatter that crime is rampant in the Territory, but he said that this is not true. "I keep hearing these negative noises about 'crime is out of control' ... Let's talk some real figures rather than [spew] noises," Matthews said.

Zooming in on what Hon. Smith said the Commissioner rubbished the Deputy Speaker comment that the Government should not be blamed. "Whilst I got the responsibility of the commissioner to deliver on plans that are agreed, I do think it is somewhat naive to keep referring to this being the police's responsibility. There is a very big government responsibility there, too. There is a public responsibility, too, around supporting your local police and cooperating with police, and giving information to police. So this should be a joined-up effort and if individuals want to call me out — single me out as a commissioner — and say 'you're not doing enough, that just sounds like an excuse to me,' the Commissioner said.



# "Searcher" To Enhance BVI'S Border Protection



Her Majesty's Customs' is the recipient of a new vessel to strengthen its capabilities in protecting the borders of the Virgin Islands.

The vessel 'Searcher' is said to be a well-outfitted 39 foot grey and black high-speed interceptor Midnight Express and is the fourth of its kind purchased by the Government of the Virgin Islands.



Premier and Minister of Finance, Honourable Andrew A. Fahie, gave God thanks at the vessel's official dedication and ribbon cutting ceremony on March 5, for giving the Government the will to be able to purchase a vessel that would allow the members of Her Majesty's Customs to provide continued exceptional service to the people of the Virgin Islands.

The Premier stated that the Government continues "to build the capacity of the Virgin Islands and continuously strengthen local resources; adding to the physical resources as well as training of staff."

Premier Fahie also noted the importance of His Excellency, Governor John J. Rankin being a part of the occasion, as they intend to work together in their respective roles in keeping the borders safe. Subsequently, in his remarks, His Excellency expressed his hopes for the new vessel.

"Searcher, I wish you well in your searching," the Governor said. "I wish that this will be

successful for the betterment of every one of us on these islands."

Acting Financial Secretary, Jeremiah Frett in his remarks said the sacrifices of Customs Officers and all law enforcement officers "enables the Territory to maintain a comfortable standard of living.

Mr. Frett said: "As these brave officers perform their duties effectively, we must ensure that they are equipped with the necessary resources to succeed. M.V. Searcher is one of those resources, and we celebrate the launching of this fine vessel. She will be an essential tool as we continue to make strides towards building the BVI that we aspire it to be."

Commissioner of Customs, Wade N. Smith spoke about the growth of the BVI's maritime operations over the past two decades and highlighted the humble beginnings of the maritime operations. He also acknowledged the hard work that was done to achieve the standard of the department today.

Mr. Smith said, "With the dedication of this vessel, the Territory should be proud knowing the commitment, dedication and sacrifices made by the Customs team. National Security begins and ends at the borders."

The commissioner also extended greetings and

gratitude to U.S. Customs & Border Protection officers who were present at the ceremony. He said the officers have worked alongside their BVI counterparts in the fight to keep the borders of the greater Virgin Islands safe.

"I welcome our colleagues from the United States Coast Guard and U.S. Customs and Border Protection Agency who are part of the High Intensity Drug Trafficking Area Task-Force, and who provide marine and air support during our operations" Mr. Smith said.

Following the ceremony, the Premier had the honour of taking "Searcher" out on the water for its first sail.

# Premier's International Leadership Hailed At UN

Premier and Minister of Finance, Honourable Andrew A. Fahie has been hailed by the United Nations Economic Commission for Latin America and the Caribbean (UN ECLAC) and regional partners for the British Virgin Islands' steadfast international leadership and for spearheading the first ever High-

Level Meeting of the Associate Member Countries of ECLAC on sustainable development.

Premier Fahie chaired the virtual meeting in his capacity as Vice Chair of the Caribbean Development and Cooperation Committee (CDCC).

In his opening statement, Premier Fahie said, "The Associate

Members of ECLAC as a special group of primarily Small Island Developing States in the Caribbean are making genuine efforts to achieve sustainable development. However, they share common challenges that require attention and support in order to achieve the

sustainable development goals. Critical factors in the sustainable development process such as administrative capacity, policy expertise, technology transfer and financial resources are all areas in which Associate Members would benefit from more support. These challenges are now compounded by the pressure on Governments to respond to the COVID-19 pandemic and climate emergency."

He went on to say, "We cannot deny that COVID-19 has been a setback to the 2030 Agenda. However, I firmly believe that this is the time to strengthen our resolve and to work even harder to defeat the pandemic and promote sustainable development and green growth."

The Executive Secretary of ECLAC, Ms. Alicia Barcena, in her opening statement commended Premier Fahie for spearheading the high-level meeting to discuss Associate Members' challenges in the implementation of the 2030 Agenda for Sustainable Development. She also highlighted the British Virgin Islands' consistent participation in ECLAC and strong leadership as a Vice Chair of CDCC.

The Chair of ECLAC, represented by Mr. Christian Guillemet-Fernández, Deputy Minister for Multilateral Affairs in the Ministry of Foreign Affairs and Worship of Costa Rica, lauded the British Virgin Islands for its advocacy on behalf of the Associate Members as a group within ECLAC who require more overall support as a part of Latin America and the Caribbean.

Official statements were made by Prime Ministers, Premiers, Deputy Premiers, Ministers and Senior Officials from among the represented Associate Members that included Anguilla, Aruba, Bermuda, British Virgin Islands, Cayman Islands, Curaçao, Guadeloupe, Martinique, Montserrat, Puerto Rico, Turks & Caicos Islands and the United States Virgin Islands.

Representatives of the Caribbean's three premier regional organisations also made statements on support to ECLAC's Associate Members, including statements by Secretary-General of the Association of Caribbean States (ACS) Mr. Rodolfo Sabonge, CARICOM Assistant Secretary-General for

Human and Social Development Dr. Douglas Slater, and H.E. Ambassador Stephen Fevrier, Head of the Permanent Delegation of the OECS to the UN in Geneva. Ministers of Government from Belize and Antigua and Barbuda were also present.

Additionally, participants also heard presentations on the circumstances of the Associate Members and support from the UN system that were delivered respectively by the Director of the ECLAC Sub-regional Headquarters for the Caribbean Mrs. Diane Quarless and UN Resident Coordinator for the Eastern Caribbean Mr. Didier Trebuc.

In highlighting the importance of the meeting in his remarks, Premier Fahie said,

This meeting is a decisive milestone marking ECLAC's renewed engagement with its Associate Members and the tremendous efforts of Costa Rica as the current Chair of ECLAC to deepen the inclusion and participation of the Associate Members in the sustainable development of Latin America and the Caribbean."

The High-Level Meeting of the Associate Members of ECLAC took place on March 15 in the frame of the Fourth Meeting of the Forum of Latin America and the Caribbean on Sustainable Development, but ahead of the official meeting of the Forum from March 16 to 18. The meeting's objective was to accelerate the mainstreaming of the Associate Members of ECLAC into the sustainable development framework of the region. The participants agreed to meet again in 2021 to discuss the Associate Members' progress on achieving the Sustainable Development goals.

Honourable Andrew A. Fahie is currently participating in the Fourth Meeting of the Forum of the Countries of Latin America and the Caribbean on Sustainable Development. His primary delegation includes Deputy Premier, Dr. the Honourable Natalio D. Wheatley, Permanent Secretary in the Premier's Office, Dr. Carolyn O'Neal-Morton, Deputy Secretary in the Premier's Office, Mrs. Elvia Smith-Maduro, Director of the International Affairs Secretariat, Ms. Najan Christopher, Assistant Secretary for External Affairs, Ms. Dwynel Davis, Programme Officer, Ms. Xyrah Wheatley and Special Envoy of the Premier, Mr. Benito Wheatley.

# BVI Joins Regional Earthquake And Tsunami Exercise

The Virgin Islands joined nearly 400,000 residents of the Caribbean and Latin America on March 11 to participate in Caribe Wave, the annual tsunami preparedness exercise.

Schools, businesses, families

and Government agencies from around the Territory practiced earthquake and tsunami safety responses of drop, cover and hold and evacuating to higher ground.

Department of Disaster

## CONSTITUTIONAL REVIEW “IS NECESSARY”: PREMIER SAYS

Cabinet recently approved the framework that will guide the structure of the Constitutional Review. This means that the Review which is almost four years overdue will be finally moving forward.

The announcement that the framework was approved was made by Premier and Minister for Finance Hon. Andrew Fahie during the House of Assembly on 10 March. During that Sitting Hon. Fahie announced that the Review is necessary and that the time has come for the BVI to examine its Constitution closer.

The BVI Leader told the House of Assembly: “Mr. Speaker, our development and indeed the modern world of globalisation have outgrown many of the restrictions contained in our Constitution, and therefore the Constitutional Review exercise is as urgent as it is necessary.”

Hon. Fahie said that the Review process would be better if the people of the BVI prepare for the exercise by reading the current 2007 Constitution. “I continue to urge members of the public to prepare themselves for this exercise. Read and discuss the Constitution among yourselves and with your families. Be critical in your reflections. Look at what works for the Virgin Islands and what does not work for the Virgin Islands,” he said.

“Our new Constitution must be informed by the vision that our people hold for themselves, so we need the people of the Virgin Islands to tell us what they want in the Constitution and what they do not want. And we must bear in mind that the Constitution will be our guiding document for at least the next 10 years and that this exercise transcends political parties and personalities,” the Premier added.

The movement to commence the Constitution Review Process has been slowly gaining momentum. In addition to the framework Cabinet also approved the budget for the process. This was done at a meeting held on 17 February.

During that Cabinet meeting, Government agreed to the matrix of activities for the establishment of the Constitutional Review Commission, which is the body that would be driving the process. Cabinet’s approval included the communication budget which is expected to fund the urgent implementation of a public education campaign.

According to the Cabinet report, the overall budget for the Review is not to exceed \$300,000 for the establishment of the Constitution Review Commission and implementation of associated activities; and agreed that the funding be provided to the Premier’s Office in the next available Supplementary Appropriation Provision.

# GLOBAL NEWS BRIEF

STORIES SELECTED BY GIORGIO MIGLIAVACCA

**BRIDGETOWN, Barbados (CMC)** — The COVAX Facility has announced its final allocation of COVID-19 vaccines for Barbados and countries in the Eastern Caribbean that will see them receiving a proportion of 16 to 20 percent of their population coverage by the end of March.

According to PAHO, following the approval for the AstraZeneca COVID-19 vaccine for Emergency Use List (EUL) by World Health Organization (WHO), 100,800 doses of the vaccine will be delivered to Barbados; 74,400 doses to St Lucia; 40,800 doses to Antigua and Barbuda; 21,600 doses to Saint Kitts and Nevis; 45,600 doses to Grenada; 28,800 doses to Dominica; and 45,600 doses to Saint Vincent and the Grenadines.

In a statement on Saturday, PAHO said that its Revolving Fund for Vaccines (RFV) will procure and deliver the COVAX vaccines to the countries in the Eastern Caribbean and Barbados.

"PAHO is working with its Member Countries to close the purchase orders and to expedite administrative, regulatory, and logistics procedures to scale up vaccinations in the region. The countries will start receiving their first vaccines through COVAX in March if all the conditions are met. Countries received the letters from COVAX informing about the volumes they will receive until May

from the first producer that met the EUL authorization from WHO and finalized the commercial agreement with COVAX."

The PAHO/WHO Representative for Barbados and Eastern Caribbean countries, Dr. Yitades Gebre, stated that "the priority of the first phase of vaccination is to save lives. We will achieve this by vaccinating the most exposed groups — like the health professionals, and the most vulnerable groups to developing severe COVID-19 illness."

COVAX is financially supporting access to vaccines for the four Eastern Caribbean countries of Dominica, Grenada, St Lucia, and Saint Vincent and the Grenadines, which probably would have to wait many months to get vaccines if the facility did not exist.

**ANTIGUA** - As of last week Saturday the prison administration has confirmation of 32 asymptomatic inmates testing positive and 3 corrections officers testing positive. All necessary protocols to isolate and quarantine the affected individuals have been implemented. [Daily Observer]

**ANGUILLA** - There has been a peak in tourist arrivals in Anguilla for President's Week, giving a number of hotels a well-needed increase in bookings and accommodation.

The arrivals were facilitated by executive jets which have been flying in and out of the Clayton

J. Lloyd International Airport, in arrangement with Lloyd's Aviation Services, the ground-handlers for the flights.

The Presidents'Week celebration, which began on Monday, February 15, is a holiday-time in the United States — which spills over from there with increased travels to such Caribbean holiday destinations like Anguilla. In the past several years this has been a big event in Anguilla, with various hotels reporting large numbers of guests. [The Anguillian]

**SANTO DOMINGO** - Low-fare carrier Frontier Airlines is now a new option to fly from the Miami to the vacation destination of Punta Cana. The non-stop flights between Miami International Airport (MIA) and Punta Cana International Airport (PUJ) are twice a week — on Mondays and Fridays. The flights began on 8 March 2021. The flights cost a low US\$80 fare valid through 26 May 2021. [DR1]

**NEW YORK** - New York City's jails were under such threat from the coronavirus last spring that city officials moved swiftly to let hundreds of people out of the crowded, airless, old buildings. The effort shrank the jail population to its lowest point in more than half a century.

But it did not last. A year later, jails are more crowded than they were when the pandemic began. And there has been an increase in infections in recent months that could pose a public health risk even beyond the jail walls.

There are now more than 5,500 people in the city's jails, slightly more than were detained last March. About three quarters of the people being

held have not been convicted. Many are awaiting trial much longer than usual, as the court system continues to operate at a near standstill during the pandemic. In lawsuits, prisoners and guards alike have called the living conditions inside unsanitary and dangerous. Incarcerated people who were recently held at Rikers Island say social distancing has again become impossible in some jail units and that soap, sanitation wipes and disinfectants are scarce or unavailable. Many correctional officers, they say, still do not regularly wear face coverings. [San Juan Star]

**ROME**, Italy saw a record loss in employment last year with some 456,000 jobs disappearing, an unprecedented annual fall of 2.0%, ISTAT said Friday.

Employment, which had risen to a record high in 2018 and 2019, fell one percentage point to 58.1%, while unemployment also fell, by 0.8%, to 9.2%.

Payrolled workers were down 1.7%, the statistics agency said.

The amount of hours worked was down 13.6%.

The recourse to the CIG lay-off fund was up 139.4% in terms of hours.. (ANSA).

**UNITED KINGDOM** - UK exports to EU drop by 40%. The Office for National Statistics said that in January exports of goods from the UK to the EU dropped by a staggering 40 per cent. The government said lockdowns, stockpiling and businesses adjusting to new trading relationships make reductions inevitable. [CH4]

**VATICAN** - The Vatican warned that it has nearly depleted its financial reserves from past donations to cover budget deficits over recent years, as it urged continued giving from the faithful to keep the Holy See afloat and Pope Francis' ministry going.

The Vatican published its 2021 budget in its latest effort at greater financial transparency amid a predicted 50 million euro budget deficit this year.

The aim is to reassure donors that their money is being well spent, following years of mismanagement that is currently the focus of a Vatican corruption investigation. [Daily Mail]

**MOSCOW** - Lyubov, a 59-year-old pensioner doing her weekly shop, doesn't know why her Russian state pension isn't going as far as it used to, but is sure the government needs to do something about it.

"All the prices for food are going up," she told The Moscow Times on her way out of a branch of Billa, a mid-range supermarket in the capital's Profsoyuznaya district. "Everyday products like sugar, bread, eggs and chicken have become too expensive."

Higher prices have forced Lyubov to think twice about what goes into her basket and shop more frequently in discount supermarket chain Dixy.

"The government's role is to ensure people don't go hungry. But hunger is already here. I see lots of nonprofit organizations and churches helping to feed people ... That should be the state's responsibility," she said.

Food prices have long been a hot-button issue in Russian society. Now, rising prices for staple goods — the result of climbing global prices, a weaker ruble and other specific factors, like a bird flu outbreak that caused a dearth of chicken and eggs — are hitting hard on the back of the economic crisis and years of falling living standards.

Official data shows food prices rose 7.7% over the last year — the fastest rate in five years — while Russians' disposable incomes climbed by less than 1.5% in cash terms. After adjusting for inflation, Russians' disposable incomes have fallen by more than a tenth since 2013. [Moscow Times]

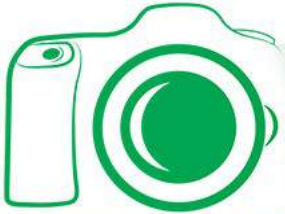

The send off which was held over the weekend was attended by legislators, calypsonians, members of the Festival and Fairs Committee and members of the Virgin Gorda community.

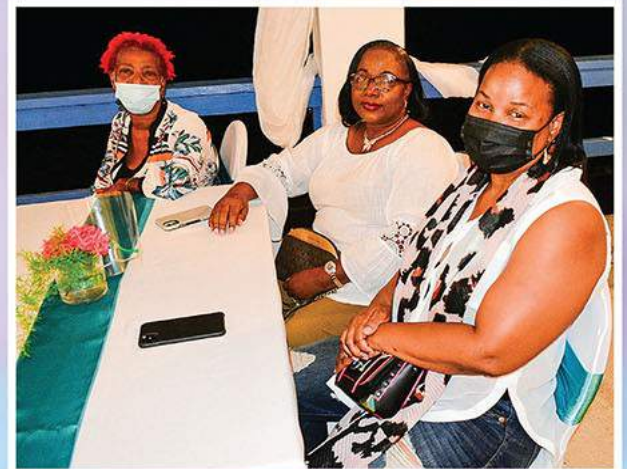

## IDENTITY OF MURDER VICTIM RELEASED

Wednesday, March 17 – Officers of the Royal Virgin Islands Police Force Major Crime Team are now in a position to release the name of the victim in yesterday’s shooting.

Deverson Williams, 38, native of St. Vincent, who resided in Long Trench, was pronounced dead at the scene after sustaining several gunshot wounds while in his vehicle in the Fish Bay area around 3:45 pm yesterday. The victim’s vehicle, nearby vehicles and the International Motors building also sustained damage. Evidence indicates that a high-powered weapon was used in this incident. Following the incident, a search warrant was carried out on a property on Tortola which resulted in the seizure of a loaded firearm and ammunition. Two persons were arrested as a result.

## CHARGE OF DEATH BY DANGEROUS DRIVING AGAINST TRUCK DRIVER

Tuesday, March 16 – Police arrested and charged Erick Rabsatt, 19, of Purcell Estate with death by dangerous driving and attempting to pervert the course of justice in relation to the October 2019 accident at Duff Bottom that took the life of Ryan Adams, 20.

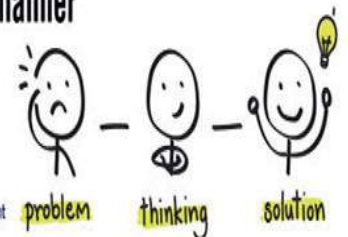
Rabsatt, who was 17-year-old at the time of the accident, was the driver of the Freightliner truck that collided with Adams’ scooter on the evening of October 23. Adams was taken to hospital for treatment that night and expired early the next morning.

The Director of Public Prosecution returned their advice yesterday on the file submitted by the Road Policing Unit in January 2020 following a thorough investigation in the collision. Other charges laid against Rabsatt such as driving without a driver’s licence and driving when not covered by insurance passed the stature of limitations and therefore were dropped.

Erick Rabsatt will appear before the Magistrate’s Court on the next available sitting.

## BILLIONAIRE BANK

*The most powerful institution on earth is the Federal Reserve: here is why.*

Now, global financial stability from 2008 is owed to the power of Central Banks intervening at times of crises.

Then independent central banks are the one institution in the economy that have the power to bail out besieged markets, failing banks, and battered global corporations, when the worst happens.

When markets crash, when financial meltdown threatens economies, at the horror of natural disaster, pandemic, or war, it is to the central banker the world turns for refuge.

Where does that huge power come from? The answer is complex.

The power of the central bank is a mix: a combination. Central bank power comes from the backing of powerful governments such as the USA and the European Union; the recognition of its supreme ability to steward the economy by global institutions from the World Trade Organization to the UN; and wealthy international investors.

The power of the central bank is also the result of business and consumer confidence in the power of these banks to underwrite the global economy and marketplace. The preceding allows the central bank to print currency, even without limit.

Central banks prop up the global economic order. And the rule of the super wealthy – the 1% - is backed by the FED that will

always intervene to safeguard the global financial order.

Some pundit referred to the central bank as the billionaire's bank. Why? Billionaires and wealthy investors view the central bank as the bank of last resort and the safe place to migrate when there is economic, political, and natural disaster. Investors prefer the safety of government issued debt- bonds and associated instruments- in times of crisis.

Central banks are arguably more powerful than ruling politicians as history shows that central bankers are listened to by the establishment and society over and above any politician in time of crisis. This is a result of the confidence placed in central banking by ruling elites and society in general.

One great ally of the central bank in recent decades is low inflation.

Low inflation is one key reason why central banks have been able to pump stimulus cash into ailing economies without any fear of repercussion such as ruinous high inflation.

The reasons for low global inflation are not clear cut: frugal and cautious consumers post the 2008 financial meltdown; globalization and economies of scale; and the rise of China- the world's factory.

Digitization has lowered business costs and that is also a lid on inflation, add greater competitiveness in economies.

The evidence shows that in spite of printing over \$30 trillion since 2009, inflation remains subdued.

Consequently, there is no reason to pull back from Quantitative Easing- QE and bond buying- as the economic wrecking ball termed inflation is far from being a problem, especially in a deflationary environment.

If anything, a small rise in inflation is pointer to economic recovery. A rise in inflation may well herald the much desired Post Covid economic recovery.

It is indeed a paradox central banks are hoping for some inflation as a tool to stimulate economies.

Inflationary concerns remain, and a massive sell off in global markets at the very end of February 2021 was a signal investors are worried about inflation and the sustainability

of ongoing stimulus spending. Investors are fearful of a bond market meltdown and inflation, but not central bankers. Central banks have near unlimited power to print cash.

And in a low inflation environment that power will not diminish any time soon.

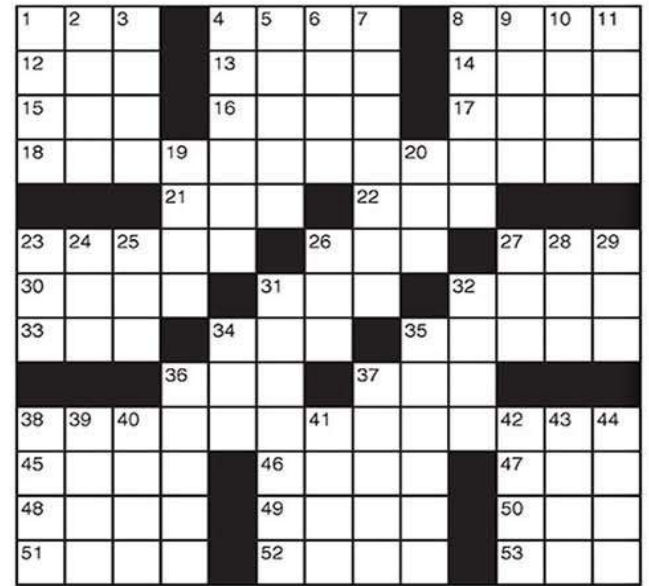

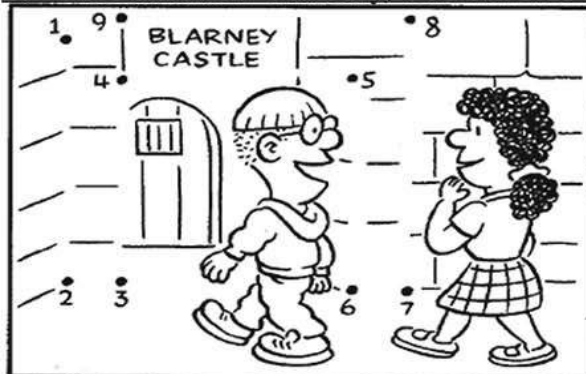

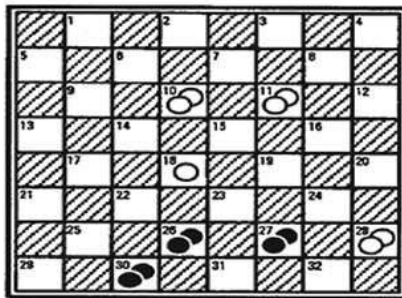

## Spring Mix Greens Herald a New Season

Years ago, when bags and bins of spring mix lettuce greens first appeared in the grocery stores in early March, I must admit, I was skeptical. To me, spring mix looked like small leaves of multicolored lettuce mixed with lawn clippings. The variety of colors and flavors, textures and varieties were radically different from my traditional (and quite frankly boring) salad consisting of iceberg and romaine leaves, and maybe a tomato or two.

After trying spring mix, I've become a fan of the interesting combination of flavors and textures. Now one of my favorite spring pastimes is visiting my local farmers market and looking at all the varieties of lettuce greens at their colorful best.

Spring mix, also known as "mesclun," is a name used for a salad mixture of leaves of various species. The name comes from the Spanish word "mezclar," which translates as "to mix." Traditional mesclun usually consisted of chervil, arugula, lettuce and endive.

Now, spring mix is typically made up of 16 fresh greens and lettuces of varying tastes and textures, including red romaine, baby spinach, radicchio, green romaine, red oak leaf, mizuna, red leaf, lollo rosso, arugula, red mustard, green mustard, red chard, frisee and tatsoi. About half of the greens and lettuces are sweet and mild, while others provide a complementary, slightly bitter edge.

Spring mix is available year-round with a peak season in spring and summer. These delicate greens contain a punch of flavor and are packed with vitamins A, C and E, calcium and potassium.

Here's an overview of the many types of spring mix lettuce greens.

**Arugula or Rocket** -- Typically has long, spiked, dark green leaves and a strong, peppery flavor, especially when the leaves are larger and wild-harvested. Cultivated arugula varies in intensity of flavor, so taste before using. Arugula adds a bold punch to salads or an intense note as an ingredient in hearty dishes.

**Little Gem lettuce** -- A mixture of soft leaves with a slight crunch, similar to butter lettuce in texture.

**Mesclun** -- A combination of tender, wild-harvested or cultivated young greens. Most mesclun varieties include greens with texture and peppery flavor such as curly endive, mezzaluna, mustard leaves, watercress, arugula, purslane, cress, Asian greens like mizuna, red kale and chicory, and a few herbs such as cilantro, basil or parsley.

**Mache, Corn Salad or Lamb's Lettuce** -- Grows in a tight bunch of 4 or 5 leaves attached to a root. It has more flavor and texture than most salad greens, but requires more care when cleaning because grit and dirt tend to settle in the rosette-shaped leaves near the roots.

**Dandelion** -- Greens are a dark emerald color and are bitter. They add a distinctive flavor component when added raw, but lose some of their sharpness when cooked low and slow.

**Escarole** -- Has a subtle bite, hearty texture and a longer growing season. During the spring months, escarole is sweeter and at its tender best. Add it raw to provide complexity to a salad or as an interesting addition to cooked dishes in place of spinach.

**Pea Greens** -- These are the giant, tangled vines on which peas grow. Pea greens are typically available at farmers markets in spring and early summers.

Break out the salad bowl and try a variety of spring mix lettuce greens in nontraditional ways. This recipe showcases spring mix salad topped with crunchy cucumber slices, seeds or nuts, tart cherries, creamy goat cheese and a drizzle of Maple Balsamic Dressing. It's a delicious way to welcome spring!

### SPRING GREENS WITH GOAT CHEESE AND CHERRIES

- 1 (12-ounce) bag spring mix greens
- 12 cherry or grape tomatoes or 2 small/medium tomatoes, cut into wedges
- 1/2 large cucumber, sliced • 1/3 cup dried cherries or cranberries
- 3 tablespoons roasted, salted sunflower seeds or roasted almonds
- 1 teaspoon salt • 1 teaspoon ground black pepper
- 1/2 cup crumbled goat cheese

Add the greens, tomatoes, cucumbers, dried cherries or cranberries, and sunflower seeds into a large bowl or platter. Sprinkle with the salt and pepper, and toss lightly with desired amount of dressing (recipe follows), then top with crumbled goat cheese. Serves 4.

### MAPLE BALSAMIC DRESSING

- 4 tablespoons balsamic vinegar • 1 1/2 teaspoons Dijon mustard
- 2 teaspoons pure maple syrup or maple-flavored agave syrup
- 1/2 teaspoon salt • 1/4 cup olive or vegetable oil
- 2 tablespoons lemon juice • 1/8 teaspoon cayenne pepper

Whisk everything together in a medium bowl until emulsified, or place all the ingredients into a jar with a tight-fitting top and shake until everything is well-combined. Store remaining dressing in the fridge for up to 1 week. Shake to recombine the ingredients before using. Makes about 1/2 cup.

# Regional Public Health Practitioners To Benefit From Clinical Management Of HIV Course

(PANCAP Coordinating Unit, CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Friday, 12 March 2021) - The Pan-Caribbean Partnership against HIV and AIDS (PANCAP), the mechanism that provides a structured and unified approach to the Caribbean's response to the HIV epidemic, is facilitating an exciting educational and capacity building opportunity for Public Health practitioners working in the Region's HIV response.

PANCAP is providing financial support for twenty (20) Public Health practitioners to attend the Clinical Management of HIV course at the University of Washington Global Health E-Learning Program. The course provides a global perspective on the diagnoses and clinical management of HIV. Participants will learn from experts in the field, who offer real-world examples of diagnosing and treating HIV and STIs

in both resource-rich and resource-constrained settings, with a focus on using US-based guidelines. The course will commence in April 2021.

During a virtual orientation, Dr. Rosmond Adams, Director, PANCAP, highlighted that the course is happening at a critical time when Public Health Practitioners are challenged with maintaining the HIV response while tackling COVID-19.

"Our public health practitioners have mounted an extraordinary response to COVID-19", stated Dr. Adams, "Within a few months, the Region reacted with COVID-19 testing, appropriate safety measures and public health education. Now we're witnessing the rollout of effective COVID-19 vaccines within a year after the start of the pandemic. Our healthcare workers were responding to COVID-19 while maintaining the gains made in the HIV response. PANCAP is pleased to enhance their

ability to test, treat and provide care for HIV by facilitating access to the course".

Dr. Shanti Singh-Anthony, Coordinator, Knowledge Management, PANCAP, explained that the online graduate-level course consists of video lectures, readings, discussion forums, and quizzes. She emphasized that group participation is encouraged as it provides a platform for discussing course concepts and applying them to the Caribbean.

Dr. Singh-Anthony further highlighted that the course is part of PANCAP's overarching Knowledge Management strategy to empower regional public health practitioners to achieve the 2030 goal of ending AIDS through providing the requisite capacity building, training and knowledge.

The course is funded by the United States Agency for International Development (USAID) through support to the PANCAP Coordinating

Unit. Mr. Jason Fraser, USAID Country Representative, noted that they are indeed glad to support this initiative to build capacity as the Region advances action towards ending AIDS.

Permanent Secretary in the Ministry of Health, Guyana, Mr. Malcolm Watkins, thanked PANCAP for spearheading this initiative and stated that it would build capacity for practitioners working in HIV to advance national and international targets.

Participants include Medical Doctors, Nurses, Physician assistants/ Medexes, National AIDS Programme Managers, and Civil Society Organisation (CSO) representatives with clinical backgrounds.

The course is only the first phase of a planned capacity building initiative by PANCAP, encompassing more training opportunities and virtual courses for Public Health practitioners working in the Region's HIV response.

## Antigua PM writes UK PM for recompense for damage

St John's, Antigua and Barbuda's Prime Minister, Gaston Browne, has written to Britain's Prime Minister, Boris Johnson, saying that "an appropriate response is necessary" for the damage done to his country's small economy by a Public Health England (PHE) website posting that wrongly claimed "an Antigua variant" of the coronavirus had been discovered in the UK.

Browne proposed that the British Government urgently consider recompensing Antigua and Barbuda by a donation of 100,000 doses of the AstraZeneca vaccines.

In his letter, Browne told Johnson that "Antigua and Barbuda is highly

dependent on tourism and has long been a favoured holiday destination for British tourists but the PHE notice, that went viral after it was picked up by international media, has caused hotel bookings to be cancelled".

The Antigua leader said his country was already "reeling from the almost complete shutdown of tourism caused by the pandemic" and asserted that the PHE posting has "eroded confidence in the gains Antigua and Barbuda made in its management of the virus". "We now have to redouble our efforts at great expense", he said.

The Antigua and Barbuda Prime Minister drew Johnson's attention

to the fact that "no British visitor to Antigua had contracted COVID-19" in his country. He affirmed that his government has enforced strict protocols for managing the pandemic and has a comparatively low level of infections and a high level of recoveries. Mr. Brown also stressed that the British High Commission to Antigua and Barbuda explicitly stated on March 13 that "there is no scientific evidence to determine where this variant first emerged" and that it regretted "any misunderstanding that may have arisen from the matter".

However, Mr Browne said that "the damage was done from the moment that PHE erroneously published the claim on its website. He has suggested

to Prime Minister Johnson that "consideration should be given to recompensing Antigua and Barbuda with a donation of 100,000 doses of the AstraZeneca vaccines". Antigua and Barbuda is one of over 150 nations that are struggling to secure vaccines at a time when the costs are high and more than 80 per cent of them have bought by rich countries, including the UK.

Prime Minister Browne remarked to Mr Johnson that "Antigua and Barbuda has always cherished its close relationship with Britain" and he "looked forward to a favourable response to his proposal".

## Asian American Group Receives Nearly 3,800 Reports of Hate and Bias

WASHINGTON - In Brooklyn, New York, a white man catcalled an Asian American woman and aggressively followed her down the block, yelling a racial obscenity and a sexually derogatory term.

In Washington, D.C., a man punched an Asian woman in the back in a Metro subway station, repeatedly shouting racial expletives and physically threatening her and her boyfriend.

In Las Vegas, a ride-sharing service driver told his Asian passenger, "Damn, another Asian riding with me today. I hope you don't have any COVID."

The three incidents are among nearly 3,800 firsthand accounts of anti-Asian hate and abuse an advocacy coalition has recorded since the start of the COVID-19 pandemic a year ago. The disease originated in China.

In a new report released Tuesday, Stop AAPI Hate said it recorded 3,795 anti-Asian hate incidents between March 19, 2020 – shortly after COVID-19

was declared a pandemic – and February 28, 2021. More than 500 of the incidents were recorded in 2021.

"The number of hate incidents reported to our center represent only a fraction of the number of hate incidents that actually occur, but it does show how vulnerable Asian Americans are to discrimination," the group said in a statement.

Verbal harassment and shunning made up 68.1% and 20.5% of the incidents, respectively. Physical assaults constituted 11.1% of the total incidents.

Stop AAPI Hate was launched a year ago by a coalition of two Asian American advocacy groups and a university department to help Asian Americans report hate incidents during the pandemic.

Asian Americans started reporting an increase in discrimination as early as January 2020. But the number surged as former President Donald Trump began using xenophobic language such as "kung flu" to refer to the coronavirus and

blaming China for the pandemic, Stop AAPI Hate co-founder Cynthia Choi said.

The majority of the incidents recorded by Stop AAPI Hate

are not hate crimes, which the FBI defines as criminal offenses motivated by race, religion, sexual orientation and other factors, Choi said.

However, as VOA previously reported, anti-Asian hate crimes last year soared by 150% in major U.S. cities, and the violence has continued into this year.

## 6 Asian Women Among Victims in Atlanta Area Shooting

Authorities in the U.S. state of Georgia arrested a man late Tuesday after a series of shootings that left eight people dead, six of them Asian women.

South Korea's foreign ministry said four of the victims were of Korean descent.

The first attack took place at a massage parlor in the town of Acworth, about 50 kilometers north of Atlanta. Authorities there said a shooter killed two

Asian women, a white woman and a white man, and also wounded another man.

About an hour later, police in Atlanta found three Asian women dead from apparent gunshot wounds at a beauty spa. They then found another Asian woman dead of a gunshot at a spa a short distance away.

Police said surveillance video showed the suspect's vehicle at all three locations, and that they

were very confident the same shooter was responsible for the attacks.

### Suspect arrested

After a highway pursuit, police later stopped a vehicle about 240 kilometers south of Atlanta and arrested 21-year-old Robert Aaron Long.

The shootings come amid other attacks against people of Asian descent in the United States.

The group Stop AAPI Hate called the shootings "an unspeakable tragedy" for the Asian American community.

"There has been a documented pattern of recent attacks against our community, as we have received nearly 3,800 reports of hate incidents across the country since March 2020," the group said in a statement. "Not enough has been done to protect Asian

Americans from heightened levels of hate, discrimination and violence."

Congresswoman Pramila Jayapal, a member of the Congressional Asian Pacific American Caucus, tweeted, "My heart breaks to see this tragic news."

"AAPI Americans are once again being targeted, harassed, attacked, and killed in Georgia and communities across America," she wrote. "We must do everything we can to end this violence while organizing together against hate, gun violence, and bigotry."

### JSPS' Crabbe: 'We made history unseating Althea Scatliffe'

Joyce Samuel Primary School Stingers' meteoric rise to a jaw-dropping 8-point dethroning victory over perennial Inter Primary Schools champions Althea Scatliffe Primary School Striders Friday, sent seismic shockwaves across the territory's sporting community.

How could that have happened to the Mighty Scatliffe who have never lost since their 1983 formation?

When former Althea Scatliffe Assistant Principal Olandette Crabbe was appointed Joyce Samuel Principal, she took paragraph one of the play book with her, creating the pathway to the stunning victory, demonstrating that leadership indeed matters.

At ASP, the short opening paragraph in the playbook formula created for victories by architect and former Principal Curlin Lettsome, was a simple one.

"If you don't want your child involved in sports, take them somewhere else," Lettsome, a former softball player, told parents in 1998. "All my teachers understand that your child will be active in sports. If your child isn't strong academically, we'll work with him through sports. My teachers know not to keep a child in class if they're selected for a team. She won't reach him anyway, when he's thinking about what his teammates are doing on the field."

It then understood why they had been perennial champions. It was a culture and it started with the leader.

Samuel, a former B Division powerhouse moved to the A Division and was second before the format changed to a true championship format with no divisions. They finished 2nd last year behind Scatliffe. This year's one day modified version, saw each school fielding eight athletes.

Joyce Samuel seized the lead in the Under 9 Girls Division 60m with a victory while Scatliffe was sixth and got another advantage in the U11 Girls 80m with a third place to Scatliffe's seventh, en route to amassing 144 points to Scatliffe's 136.

"Sweet victory. I'm super proud of my eight athletes, my coaches, my PE Teacher who has been consistently preparing our students for today, I couldn't ask for anything more," Crabbe told Island Sun Sports. "We made history today, unseating my school, the Althea Scatliffe Primary School, the Mighty Scatliffe, so it's a sweet victory for me. I congratulate all the teams, all the principals, coaches, teachers, the students and parents for coming out today and doing their best, we plan to enjoy this victory."

In her analysis, Crabbe said the fact that the relays were limited, it put Althea Scatliffe at a disadvantage. Whereas Scatliffe could find four strong, that's an area in which they faltered. She said last year it was the same in the individual races where her athletes were getting first, seconds and thirds—something they came to do.

"We medaled in every race and the relays," Crabbe noted. "And the relays."

In her program's journey to the top, Crabbe explained that when they identify athletes with potential, they try to get them into a track program and they have partnerships with practically every Track Club.

"When we see our students have certain talent, we get them on to the track even if it means we have to transport them there which is something we have been doing, we try to get them there," she pointed out. "So every athlete you see here today with the exception of the Under 9s, train daily and that made a difference today."

Eustace "Boss" Freeman, Program Officer at the Department of Youth Affairs and Sports, told Island Sun Sports: "Today was very exciting and you heard, we had a major upset after a lot of years we have a new champion which is Joyce Samuel and that's just an indication of how the day went," he stated. "It was up and down as it pertained to different races, we had some ups and downs and there were races we knew the results before they happened. I expected the meet to be close because of the new structure due to Covid, but I had no idea we would have a new champion right now. Congratulations to all the schools but special congratulations to Joyce Samuel from the Zone6 area."

### NCAA 60m medalist Brathwaite: 'I made history for my country, school'

Indiana Jr. Rikkoi Brathwaite sprinted into history on Saturday, becoming his school and the Territory's 1st NCAA Division I Indoor Championships male sprint medalist, when he stopped the clock at 6.56 seconds--.001 off his personal best—to claim 60m bronze.

In the process, Brathwaite joined Minnesota's Tahesia Harrigan who bagged 60m silver in 2002 and Chantel Malone who earned Triple Jump bronze in 2011 for Texas, as the three BVI athletes who have won NCAA Indoor Championships medals. Brathwaite who equaled his 6.55 seconds personal best to win his semifinal and advanced to the final, became the Territory's seventh All American of 10 athletes who have qualified for an NCAA Division I Indoor or Outdoor Championship, since 1979.

"It was somewhat emotional for me, because for two years now, I've been trying to get to those championships," Brathwaite, who won last month's Big 10 Conference 60m title, told Island Sun Sports. "It took a lot of work of course and a lot of prayer."

All along, Brathwaite, the BVI's first Carifta Games U20 Boys 100m medalist in 2018, had been telling his friends he's going to qualify the championships and said it was a really positive environment. After placing third in the final, he said he was hanging his head a bit low, because he wanted to run faster than his 6.55 personal best which he has run twice this season and it took a couple hours for what he had done to really sink in, that he was the third best sprinter on the collegiate level.

"I made history for my country. I made history for my school and now they know who I am, I'm on watch," he pointed out. "I can't be anything else but grateful."

With improved 60m speed, he said it's definitely a confidence booster for the outdoor season, which keeps him driving, working and chugging. He said now it's easier to tell his coach to drop him in some 400s to help his conditioning, for when he's ready to run fast.

"I'll have the training, I'll have the speed and

hopefully by then, speed endurance, to hopefully run a nine," he pointed out. "So it has been a big confidence booster."

He will now turn his focus to the outdoor season.

At the same meet, Florida Sr. Kala Penn, ended her collegiate career with a 16th place Triple Jump finish in 12.53m. Penn and Brathwaite became the first female and male athletes to compete in the same NCAA Division I Championships, joining Malone and Illinois' Ashley Kelly, who were the first athletes in the same championships in 2011.

Elsewhere, Southwest Baptist Freshman Zara Brown, helped her team's Distance Medley Relay to an NCAA Division II Indoor Championships bronze medal. Brown split 57.84 seconds on the 400m leg, as her team edged Augustana by .001, 11:35.54-11:35.55, to earn All American honors.

Meanwhile, Deya Erickson chopped her 3-year 100m Hurdles personal best and national record from 13.80 seconds to 13.61, after finishing 2nd in the South Florida Challenge 3 meet on Saturday.

# Will regional unity be forever lost to the Caribbean?

Several editorials in respected newspapers as well as blogs by influential persons in the region are, once again, expressing deep concern about CARICOM, particularly over its lack of unity in international affairs and the failure of its leaders to implement their own decisions regarding the single market.

This has led a Minister of the St Vincent and the Grenadines government to reproduce on his blog, a strong view that “CARICOM is dead”, depicted by a headstone in a burial ground.

Against the background of these recent pronouncements, my commentary this week draws on an article I wrote in 2013.

Ian McDonald’s, “A Cloud of Witnesses”, published by The Caribbean Press, is a collection of thoughtful reflections on the Caribbean condition; visionary and inspirational addresses to diplomats and graduating University students; and moving accounts of experiences that are shaping the Caribbean in which we live.

The topics in the book are varied reflecting a long life in the Caribbean; the interests of a man who is poet and writer; lover of cricket; executive in the sugar industry and a consummate West Indian – born in Trinidad of Antigua and St Kitts ancestry, grew up in Trinidad and Antigua, earned a degree from Cambridge University, Captained the West Indies Davis Cup tennis team, and worked most of his adult life in Guyana. He is also among a rare breed – a white and proud West Indian as comfortable in the company of other West Indians of all races as he is content in his own skin.

After he retired as an Executive of the Sugar Industry in Guyana, and by then an accomplished and well-recognised writer and Poet, McDonald worked with the West Indian Commission – that body of distinguished West Indian men and women who produced in 1992 the seminal study, *Time for Action*, that laid out a blueprint for the Caribbean’s future. McDonald recalls the testimony of “experts” who pointed to the models that were being developed elsewhere – the Asian Tigers, the Singapore model, the new Europe. He also remembers with satisfaction that the Commission felt that, while these models were useful reference points, the West Indian model had its own intrinsic value. “West Indians”, the report said, “offer a rare creation – a people of many nationalities, many races, many faiths, and different cultural heritages” who have stayed together in a single community.

McDonald asserts his own belief in the value of the West Indian model. Nonetheless, he is practical enough to “pray because I think we will need some heavenly blessing in a hard task... but in the end I profoundly believe because I think we already hold enough in common to secure an undivided future together”.

His profound belief does not prevent him



from being “disillusioned with the pettifogging gradualism that the word CARICOM is rapidly coming to stand for”. “All of our small countries”, he says, “simply have to make ourselves bigger very soon – enlarge our domestic market, broaden our technological base, combine our financial resources, increase the scale of opportunity for our ambitious young people, bring together behind one frontier the marvellous common cultural strains that exist in the West Indies side by side but apart – apart and therefore more vulnerable to outside cultural impact”.

As for the grand communiques, speeches and often touted plans of CARICOM meetings, he despairs – “every country in the region is littered with the burnt-out corpses of plans not implemented and reports unread”. Of the high-sounding declarations, he laments that they are “Declarations of futility”.

The book conjoins cricket with poetry not only in capturing the superlative stroke play of Rohan Kanhai and Vivian Richards; the genius of Frank Worrell; and the artistry of Garfield Sobers and Brian Lara, but the essence of what cricket means to every West Indian – “truly cricket is supremely an imaginative possession which binds our Caribbean Community together... If it is no longer to be so we have lost something of infinite value”.

McDonald’s book celebrates the nobility and importance of West Indian-ness and the necessity to consolidate its value. However, it does not ignore the warts so obvious on our Caribbean face, nor does it avoid confronting our obsession with our sovereignty that is constantly invoked to pursue narrow political interests. Clinging to sovereignty, which in any event we only exercise against ourselves is an obstacle to the unity we all need to survive in a world that cares little about small states. As the rest of the world sees the English-Speaking Caribbean, our entire populations are collectively no more than a small city in the US, Europe or Asia. What is more, many of our countries frequently yield their sovereignty to larger countries when they are either lured or pressured to do so – even at the expense of the CARICOM Treaty obligations.

In truth, as was evidenced in their testimony to the 1992 West Indian Commission, Caribbean people would prefer a Caribbean with one currency, one passport, free to travel between them, to invest in them, to benefit from its abundant collective wealth, to hail their joint heroes in sport, in literature and in other areas of achievement. And, more than anything else, to command respect in the world.

McDonald’s book describes the things that give pleasure and cause the soul to soar and want to accomplish what looks impossible like “painting the wind” or creating a West Indian nation – the former only God can accomplish; the latter is within the capacity of Caribbean people inspired by their leaders, when we all get to it.

## Telephone Manners & Security leave Much to be Desired

The telephone rings, the caller utters “Hello, is this Shake & Spares?” “Who is calling?” “Is this Shake & Spares?”. This can go on indefinitely but the caller is so rude that he/she does not know some basic telephone etiquette such as: when you make a phone call you introduce yourself first. No way; under the circumstances we do not engage in any further conversation and hang the receiver.

At the opposite pole, we have a caller saying: “I am calling about the bomb threat...” At the other end, someone may ask “Who are you calling sir? We are not the police station”, or the caller is allowed to spill all the beans only to discover that he called the wrong number. Awful, but it does happen. Figure out in which predicament you will be if the caller is a drug dealer who is telling you where they drop the next ton of substance. You may become “statistics” in due course.

Basic telephone etiquette, rule number 1: Always identify yourself at the beginning of all calls; number 2: Especially when leaving messages, speak clearly and slowly.; number 3: Build the habit of always turning off your cell phone ringer when entering a meeting, restaurant, theater, training class, or other places: number 4: Do not call before 9 am or after 9 pm unless it is a real emergency.

Now, enter the “informant” who gathers rumors and real information by calling you, and then throwing the proverbial sprat catches a whale of a melee, tapes it all and passes it on to interested parties. Of course, this brings us to the widespread suspicion that telephone calls are monitored, even though there is no court order. If so, who is doing the monitoring and why?

Equally annoying is the \*69 device. Someone calls you but no matter how you rush to the phone or to the cell the ringing stops. You then dial \*69 and quite often you are told the number that called cannot be given out. Why? Was that the CIA or NSA, or a potential criminal who called? Why some numbers are given and why others are not? What’s going on? As you see many questions remain unanswered.

Long before Wikileaks appeared on the international horizon, we, here in the BVI, had politicians retrieving leaked email messages with private, and therefore sensitive, information which could, as it did, damage the victim. There were many questions as to how the leaked messages were obtained, nobody bothered to answer, which seems to translate into “anything goes”.

# World Health Organisation Endorses AstraZeneca's COVID-19 Vaccine



[VOA] - The World Health Organization (WHO) on Friday approved Johnson & Johnson's COVID-19 vaccine for emergency use, while also firmly endorsing AstraZeneca's COVID-19 vaccine as some countries continued to suspend its use.

WHO spokeswoman Margaret Harris described AstraZeneca's vaccine at a virtual briefing hosted in Geneva as "excellent" and said that "we should continue" to use the vaccine.

The WHO endorsement came as Thailand followed an increasing number of European countries in suspending AstraZeneca's use because of periodic blood clots among recipients. Bulgaria and the Democratic Republic of the Congo also suspended AstraZeneca use Friday. However, AstraZeneca said in response to the claims that there was "no evidence of an increased risk."

The European Medicines Agency, a European Union body that supervises

medical products, said in a statement that the AstraZeneca vaccine's "benefits continue to outweigh its risks and the vaccine can continue to be administered while investigation of cases of thromboembolic events is ongoing." Thromboembolic events occur when a blood clot breaks loose and travels through the body, causing harm.

The WHO had already approved the AstraZeneca vaccine for global emergency use and on Friday broadened global access to inoculations by approving Johnson & Johnson's vaccine, the first to be administered in a single injection instead of two. The WHO also previously backed the vaccine by Pfizer-BioNTech, making for a total of three vaccine approvals.

"Every new, safe and effective tool against COVID-19 is another step closer to controlling the pandemic," WHO Director-General Tedros Adhanom Ghebreyesus said in a statement.

In another development Friday, Brazil reported 2,216 COVID-19 deaths in the last 24 hours, the third day in a row that fatalities in the country exceeded 2,000. The stretch of deaths is the worst in Brazil since the pandemic began last year.

Brazil also reported 85,663 new cases of the coronavirus infection Friday, the second-highest number for a day.

Tedros described the situation in Brazil as "deeply concerning" and said that "unless serious measures are taken, the upward trend now flooding the health system and becoming more than its capacity will result in more deaths."

Also Friday, the United States, Australia, India and Japan agreed to a partnership to make 1 billion vaccines available across Asia by the end of 2022, India's foreign secretary said at a news conference in New Delhi after a virtual meeting with U.S. President Joe Biden and the leaders of the other countries.

At the virtual summit held by the four countries, the Quadrilateral Security Dialogue, commonly known as the "Quad," the countries agreed to finance, manufacture and distribute the vaccine across Asia.

## Can Mushroom Microdose Help With Depression?

**DEAR DR. ROACH:** I am battling depression and have a question about psilocybin. I stopped taking Effexor for my depression because I did not like the side effects. I also tried SAM-e, which had only a small effect. So, for the past three months I have been trying cognitive behavioral therapy, using certain tactics.

I've cut back my days of work and avoid all news when not on the job. I stringently avoid social media. I don't put myself into situations that I know will upset me. I am also limiting my alcohol consumption. Lately I've been reading about how microdosing the psilocybe mushroom can elevate or change moods for the better.

I would like to know your opinion on the use of psilocybin for depression. It seems to be gaining traction, but my fear is that it can bring on degrees of psychosis. — S.M.

**ANSWER:** I found two studies on psilocybin, a naturally occurring chemical in 200 or so species of mushrooms, especially those of the genus psilocybe. One study from 2016 was in 29 people with cancer, and anxiety and depression: 60%-80% had "clinically significant reductions in depression or anxiety." Another study (also from 2016) treated 12 patients with treatment-resistant depression with two doses of psilocybin, and their depression scores were reduced by more than half at five weeks. All 12 patients had adverse effects, usually mild, such as headache, nausea or confusion. Two patients had paranoia. All adverse effects lasted less than a day.

While I am optimistic that this might lead to an additional option for therapy, these are very small studies. Further, the authors of the second study note "patients have taken pharmaceutical grade compounds of known strength and purity, under the supervision of trained therapists." The authors and research institution "cannot advise on the procurement of illegal psychoactive substances, nor can we recommend self-medication." I can't emphasize that enough.

**DEAR DR. ROACH:** Someone I know, who is a nurse, mentioned to me that she had Lyme disease about 15 years ago. She said her doctor at the time told her that if she gets it again, she will die. Is this true? I would have thought some immunity would be gained once you have it. She is completely healed and said she has no health issues associated with it. — D.S.

**ANSWER:** Lyme disease is caused by the bacteria *Borrelia burgdorferi*, and is spread by the deer tick. There are many manifestations of Lyme disease, including rash, many nonspecific symptoms, and late symptoms such as arthritis.

Death from Lyme disease is rare, and is usually a result of carditis, which is heart inflammation. This happens in about 1% of cases of Lyme disease. There were nine cases of fatal Lyme carditis reported between 1985 and 2018.

People who are treated early for Lyme disease, such as those get the classic bull's-eye rash, do not get immunity to Lyme. However, people who have had Lyme long enough to develop arthritis do develop some resistance to future episodes. Unfortunately, we are still at least several years away from a Lyme vaccine.

I could find nothing to support a significant risk of death from people who get Lyme disease a second (or subsequent) time, so I think you can reassure your friend.

# What Smart Shoppers Know About Telephone, Mail Order, and Internet Sales

Buying by telephone and mail is a convenient way of shopping for most consumers. As more people have access to a computer, and as more companies sell their products and services online, the Internet is also becoming a convenient way of shopping for most people.

Consumers face more choices than ever before, not only when selecting merchandise, but in determining whether to shop through the mail, via the Internet, over the phone, at their local store, or the new mall outside of town. The following tips are what smart shoppers should know about purchasing merchandise through the mail, by telephone, or via the Internet.

return purchased merchandise within a reasonable time for a full cash refund, store credit, or an equal exchange. Find out the seller's return policy. Many sellers have a very limited return policy. Some do not allow returns. Can you return the item if the item is too large, or the color is not exactly right? Who pays for return postage? If the seller does not allow returns for full cash refunds, store credit or equal exchanges for at least seven days, the seller's refund policy must be conspicuously posted.

Find out if the quality and performance of the merchandise are guaranteed. Is there a warranty? If so, check the terms of the warranty. Are repair parts available? Can

notify you of the delay and give you the opportunity and a cost-free method to cancel the order and receive a refund.

It is safest to order from reputable merchants who are known to you, your family, or trusted friends. If you have not done business with the merchant before, and the purchase is especially large or important to you, check the business' reputation. If you have any doubt, call a local consumer protection agency or the Better Business Bureau to find out if they have received any complaints about the company. However, if the Better Business Bureau has not received complaints about a business, which does not necessarily mean there have not been any complaints. Unless you already know the company by its reputation, it is best not to start out with a big order. Instead, find out how the business handles one that is smaller or less important to you.

## If you decide to order

Your name, address, and product information (e.g., stock number, color, size) must be communicated clearly. If you want the item sent to someone else as a gift, it is especially important to give the correct name and address of the person you are sending it to. Most sellers also ask you to provide a means of quick and inexpensive communication, such as a telephone number or e-mail address. Since doing this will involve giving up some of your privacy, give it some thought before you do so.

Keep a copy of your order form and any letters you send to the business. If you order by telephone, make a note of the date, time, type of payment, and confirmation number. If you order over the Internet, print out a copy of your order. If the transaction does not pan out, this information may be of help.

Never send cash. Pay by check, money order, or credit card so that you have a record of payment. If you do not know the company or its reputation for integrity and competency, it is best to pay only by credit card, since you ordinarily can cancel the payment if the promised merchandise is not delivered.

Examine the merchandise immediately when you receive it. Make sure it is what you wanted and ordered. If it is not, telephone or e-mail the business right away. All reputable mail, telephone, and Internet sellers maintain an easy-to-use method of returning such merchandise and either returning your payment or sending the merchandise you ordered. If things do not seem to be going right, notify the business in writing and keep a copy of your letter. Return any merchandise promptly for a refund or exchange.

## Before buying over the Internet

Internet shopping can be as safe and advantageous for consumers as shopping by telephone or mail. You have many more options, including purchase of air transportation, music, books, and almost anything else, but there are also some risks, which you can reduce by acting carefully and cautiously.



## Shop carefully before buying

First, do some comparison shopping. If the product you want is available locally, how does the local price compare with the telephone or Internet price? (Remember to add the price of handling and delivery for orders that are shipped.) Also consider the advantage of receiving the product right away from a local merchant, and of having the merchant nearby if problems develop. (But also remember the cost and time involved in getting to and from the mall.)

Watch out for offers that seem unbelievably cheap. The merchandise will most likely be of poor quality, or you may never receive it.

Most retail sellers allow a customer to

the item be repaired locally if it needs repair? Who pays for shipping if it needs to be returned to the seller for repair? How long will it take the seller to repair the product and return it to you?

Ask the seller for a more detailed description of the merchandise, and ask for a copy of the warranty, if one is offered, if you have any doubts about either.

Find out how long it will take the business to ship your order. If the business does not state a delivery time, the maximum time you must wait for shipment is 30 days, according to a Federal Trade Commission (FTC) rule, and a similar rule in effect in California. If the business does not ship the item within the proper time frame, it must
