TRAGIC PLIGHT: 23 CONFIRMED COVID DEATHS

With 23 confirmed COVID deaths as of 21 July and 151 new infections reported on average each day with the highest daily average reported on 15 July, the BVI's COVID situation is at an all-time high. This worrying trend has caused the Government to consider all options relevant to curbing the situation.

Speaking on the 20 July broadcast of VIP radio Minister for Health Hon. Carvin Malone explained that he sees the effects of the coronavirus on the Territory. He said the Ministry of Health is keeping an eye on the numbers and the statistics: "What we will never be able to measure is where we are mentally in this fight. We as a people cannot go without hope, but since July we have had some remarkable changes in terms of what we had to do. Some of them positive and some of them very disheartening."

While noting that the current COVID numbers are very high, the Health Minister stated: "In

July [so far] we have had 13,541 tests that were run. For our adult situation was under control from population...that is half of the adult population that has been tested in the Territory at this particular time. We have 1,604 positive cases that exist at this time."

Hon. Malone said that the the time the pandemic started in March 2020. However, things seem to have taken a sudden drastic turn, and the community feels the effects.

"We had one death that occurred early in the pandemic, and it was not until July 2021 that we started to... have a total of 23 deaths.

These are persons that we know, persons that we love...I have had to speak to crying mothers, dads, and sisters and brothers... The sad part of this is that whatever we feel as to who did, who did not it doesn't count anymore. What is [important] is that you have a lost son, daughter, mother, uncle, aunt; so our condolences go out to all of these families."

The rise in cases and the increase in COVID deaths has ignited calls within the community to explore all options. The Minister noted that all reasonable and safe options were on the table: "You can rest assured that your government is doing all that is required in order to see us through this period."

This conversation is coupled with the debate among pro-vaxxers and anti-vaxxers that continues to rage on social media. One of the common complaints in this line of conversation is the opinion that the Government has not been open to alternative medicine. While the Minister did not reference this concern directly, his comment did touch on the areas of complaints. Hon. Malone said: "There are persons who have herbal remedies, persons who have new medicine that they would like to see introduced,

There are emerging technologies, emerging drugs that we would seek to get...This is not a magic pill but it is something that if it can save one life we would make sure that it is here."

Hon. Malone further said that as persons become concerned about the current tragic juncture, they should also consider that the treatment options currently being used are working. "We have looked in terms of the persons who have had to use our particular facilities and the Special Care Unit. You will hear of the stories of the deaths but you will not hear much about the recoveries."

"Everything is being done to keep everyone off of the ventilators that we have. Ventilators are not the best remedy, when it comes to saving a life we have to try everything and we try our very best to keep everyone away from ventilators. We have the 12 facilities that are fulltime in terms of all of the pieces necessary because a ventilator by itself is not a full system so the unit that we have built have additional ventilators We have the 12, we are currently using two. Four persons in ICU about 13 in the special ward. We have a number of people that have been checked into emergency wards," Hon. Malone further stated.

The Minister said that

some of the extreme situations are avoidable as persons should get medical help once they notice COVID like symptoms. Hon. Malone said that there are instances where persons seem to ignore the signs of the virus: "Of critical importance is the number of persons who are feeling ill, but simply refuse to get help for whatever the reason. The fact is that there are some who have been introduced to natural remedies, herbal remedies and it has worked. We have asked that you do not wait until you are in an advanced stage of illness before you present yourself. You may have your herbal remedies, it is best to call the hotline and speak with the qualifying physician who can then help you to assess."

With the numbers being at an all time high, the Health Minister said that the Government is seeking medical assistance to help curb the situation. "I have been in meetings all day with agencies around the world. We have had conversations

Virgin Islands, with FEMA and a number of voluntary health organizations who have put forward a number of ideas and concepts and ready to deploy the help that we need. We have been in consultation with doctors that have been referred to us by religious institutions. They have looked in terms of providing the respiratory therapist that we need, the lab technicians that we need, the emergency techs that we need, the EMS," he mentioned.

Hon. Malone said that a shipment of additional PPEs is due to arrive in the Territory next week, Monday. He also spoke about the concerns of residents who wish to take the other types of vaccines. Hon. Malone disclosed that the plans to facilitate the Pfizer and Moderna vaccines are at an advance stage: "We would be making announcements as to how you can get access to the Pfizer and Moderna [vaccines]. This could only be accessed in St Thomas but the agencies are working with us here in the Virgin Islands. We are putting a team together so that you can call a central desk and we are trying to get the rapid test so that when you enter the portal for the United States Virgin Islands you can have it entered there. You will

and we have the particular buses. Once you get down, transportation would be there arranged...to take you to the R Schneider Hospital second floor and you are administered either the Pfizer or the Moderna."

"You will be brought directly back to the ferry. Return, take a rapid test and then we will announce what protocol we will follow. The Chief Medical Officer is finishing his write up of protocols for this. We know that some of you will be concerned about whether or not you will have to be guarantined for an additional four days. We will be guided by the Acting Chief Medical Officer as it relates to that," he added.



Medicure Lab Responds to Ministry of Health **Press Releases**

provider Medicure Laboratory, which is an extension of the Eureka Medical Clinic, has lashed out at the Ministry of Health for what it claims were indirect efforts to discredit Medicure Lab PCR testing capabilities and an attempt to make the public think that by offering PCR testing Medicure Laboratory was

acting irresponsibly.

In the press release issued on 18 July, Dr. Heskith Vanterpool, the Medical Director of both Medicure Lab and Eureka Medical Clinic said that he felt compelled to respond to two press releases from the Ministry of Health. He explained that the press releases in question were issued on 15 and 16 July and related to the status of PCR and Rapid antigen testing in BVI.

The first of the press releases issued by the Ministry of Health aimed at advising the public that the Dr. D. Orlando Smith Hospital is the only facility authorized and recognized by the Ministry of Health and Social Development to conduct PCR testing and antigen testing in the Virgin Islands at this time. While the second stated that the Ministry was working with the Management of Eureka Medical Clinic to bring their

Private medical service PCR testing capacity online in a safe and effective manner. In fact, Acting Chief Medical Office (CMO) Dr. Ronald Georges said the Ministry had an initial discussion with Eureka Medical Clinic to have additional PCR capability available in the Territory. "We have reached out to the Pan-American Health Organization to provide the necessary support to ensure that the necessary biosafety and quality aspects are independently verified and are in place prior to start of testing," Dr. Georges explained.

> However, Dr. Vanterpool criticized the announcement stating, "Medicure Lab now has PCR and Rapid antigen capabilities and contrary to the suggestion in the press release, we are acting very responsibly in the rollout of these services."

> While rubbishing the Ministry of Health's mention of authorization, Dr. Vanterpool stated: "The Ministry of Health (MOH) has never been known to approve or disapprove any laboratory test in BVI and has no publicly known mechanism in place for authorizing or recognizing any lab for doing PCR or any other form of test. Prior to Medicure starting PCR testing, only the hospital lab did this test. It did not need

approval or authorization from Government. We respect the responsibility that the MOH has to ensure the health of the public and recognize that in a pandemic could act to control irresponsible and dangerous behaviour, if necessary. Not the case here! While there is a need to ensure accuracy of PCR test results there is no need to undergo the prolonged and complex process that was said to be necessary in the press release. Medicure lab already has the essential requirements in place to qualify at level 2 biosafety standards (same as hospital) and has in the past been advised by a representative from PAHO on this matter. There is no need for PAHOs involvement at this time."

Dr. Vanterpool said that the Ministry rushed to issue its press release after noting that Medicure Laboratory has been carrying out stateof-the-art COVID 19 testing. "Within the last two weeks Medicure laboratory started doing PCR testing for the Covid 19 virus and two days ago we added Rapid Antigen (Lateral Flow) testing as well. Eureka Medical Clinic built a Specimen collection center in the parking lot area, to ensure safe and efficient sample collection for patients. These developments apparently prompted the two press releases by the Ministry of Health claiming in the first one that "Dr. D Orlando Smith Hospital is the only facility authorized and recognized by the Ministry of Health and Social Development to conduct PCR testing and antigen testing in the Virgin Islands at this time."

The Director of Medicure Laboratory further added: "These press releases made a number of statements that put the Medicure Laboratory and Eureka Medical Clinic in a bad light and strongly suggested that both institutions are acting in a cavalier and irresponsible manner as they both try to improve the public's access to PCR and Rapid antigen testing during this deadly surge of Covid virus infection in the Territory. Thus, the management of both institutions have thought carefully about how to respond to these indirect allegations, with a view to defending the hard earned good reputation of both institutions, at the same time educating the public on the reality of Covid testing in BVI and importantly to respect the authority and oversight that the Ministry of Health has for healthcare in the Territory. I, Dr. Heskith Vanterpool, am the medical director of both Medicure Lab and of Eureka Medical Clinic, I have provided medical services through Eureka Medical Clinic for the last 36 years and Medicure Laboratory has provided



Dr. Heskith Vanterpool excellent state of the art laboratory services for 31 years."

The Director further stated: "The owners and directors (Dr. Hubert and Mrs. Jennifer O'Neal and Dr. Heskith and Mrs. Jean Vanterpool) have invested heavily in this Lab, continuously advancing the testing capability that can be offered to the public. Medicure lab has undoubtedly performed as well as the hospital lab has over the years. Our laboratory technologists are as well trained and exercise as much care in the performance of their work as those at the public hospital. Our lab is not cavalier in doing its work, and the establishment of PCR testing at Medicure is not being done without attention to factors that affect accuracy of our results. Covid 19 is a serious illness, and we take the necessary steps to ensure that the results are accurate."

BVI Ministers Criticize Commission of Inquiry

In a joint statement issued on Extension of Commission of Monday, 20 July, Ministers of Government have reprimanded the Commission of Inquiry (COI) for overworking public servants by making overwhelming requests for information. In the statement, which allegedly represented the views of all portfolio holding members of Government the COI team were criticized for being unreasonable in their information quest.

In the statement the Ministers said that they had to speak out against the many requests that were made by the Commission of Inquiry team in their probe on corruption reports. The Government members alluded to the current pandemic and opined that the constant requests were distracting from important public service tasks.

This complaint from the Government seemed to have been triggered by the 14 July

Inquiry announcement by His Excellency Governor John Rankin. While noting this announcement the Government members said: "Ministers have been increasingly concerned by the large and growing diversion of the resources of the Government to the Commission of Inquiry, and more so after the six-month extension announced by His Excellency the Governor."

Now that the COI hearings have been extended, the Ministers said that they would like to see a clear structure and timetable for the hearings. The Ministers said that they would also like to see notice of the subject matter for those hearings set out well in advance, so that the Government can plan its resources and the time of public servants accordingly.

In disapproving the current format of the Inquiry the Government members said that although the Inquiry, thus far, pages of documentary exhibits, has indicated six general areas of interest, it has generally given only a week's notice to the witnesses it would call. The Ministers cited this process as burdensome for public servants: "The accumulated strains on the public service of dealing with the COI's requests for evidence and further demands for documents, often at very short notice, is untenable at a time when the Government is grappling with the most dangerous COVID-19 outbreak since the beginning of the pandemic. It is for these reasons, Ministers believe, that the COI has been extended," the statement explained.

It was mentioned that since February 2021, the Government has provided over 100,000 documents to the COI. The Ministers said that the COI has also requested that Ministers and public servants make over 30 lengthy affidavits, each with many

explaining in detail matters such as procurement systems, legislation in the British Virgin Islands, the working of statutory bodies, the system of granting Crown lands and the financing of the public service, going back many years.

"Ministers believe it to be essential to recognize that the limited human resources of the public service are supposed to serve the people of the Virgin Islands and have many other vital priorities with which they have to deal daily. For the Inquiry to continue with legitimacy and to manage both the limited capacity and time of public officers, it is hoped the COI will provide both a schedule for the hearings and details on the subjects and areas for investigation," the Ministers stated.

PRO-VAXXERS Vs ANTI-VAXXERS: Opposition Leader is Concerned

Leader of the Opposition Hon. current COVID outbreak is the clash Marlon Penn is concerned over what seems to be a constant clash between vaccinated and unvaccinated members of the community. In an address to the Territory on 12 July Hon. Penn said that this division is thwarting COVID response which is dangerous at this time.

The Opposition Leader bemoaned the current increase of COVID 19 Cases in the Territory and said that the pointing of fingers is not making the dramatic situation better. "Fellow Virgin Islanders, friends and family, one of the unintended consequences of the

between business expectations and the burden placed on unvaccinated workers. We need not be totally divided on this issue, because in all of this we all desire the same outcome - the preservation of lives and livelihoods."

The rift between those who took the vaccine and the others who have not is being compounded by the decision of some companies to send home their unvaccinated workers. This decision which is being adopted by major European countries resulted in calls for boycott of such local businesses by other antivaxxer residents; which resulted in an escalation of the Government should also be part debate.

Hon. Penn called on employers to use reason. He said, "To the employer with unvaccinated staff, we ask you to change the conversation and help your staff navigate through the difficult issues that are preventing them from vaccinating."

The position of whether to vaccinate or not has erupted in a massive public debate and Hon. Penn said that the time has come for a brainstorming on the matter in order to find a reasonable solution. He also noted that the of the conversation.

"We must also expand our education campaign, and with a strong focus on the individual, if we are to make greater progress in defeating COVID-19. Every citizen needs to be engaged so that we can express, learn and understand each other's views, fears and concerns, reservations, and truths. We must answer each other truthfully, clearly and fully, supported by credible information and the best actions to halt the spread of the virus," the Opposition Leader added.



Department of Labour and Workforce Development Logo (Photo credit: GIS) Deputy Labour Commissioner at the Department of Labour and Workforce Development Mrs. Michelle McLean said that it is important that persons get acquainted with the user manual for the system to submit their applications via the portal as the department is no longer accepting hard copy applications for any type of work permits.

Mrs. McLean said, "We are working on processing the hard copy applications that were previously submitted before the

launching of the system with the aim of going fully digital. Therefore, to avoid negating this process, it is particularly important that no further hard copies be submitted to the department."

BVI Reports Six More COVID Fatalities

The Ministry of Health and Social Development is confirming six more COVID related fatalities over the last two days bringing the total number of deaths in the Virgin Islands to 23.

The deceased are a 50-year-old female who died on July 18, a 71-year-old male, a 66-year-old female a 41-year-old female and a 74-year-female who died on July 19, and a 67-year-old male who died today. Five persons died at the Dr. D. Orlando Smith Hospital and one person died at home.

Minister for Health and Social Development Honourable Carvin Malone expressed condolences to the families and friends of those who are hurting and mourning the loss of their loved ones on behalf of the Government of the Virgin Islands. "This is a difficult time for all of us here in the Territory. We have never seen a situation like this unfold. I pray that God continues to grant us favour and mercy to see us through this very troubling time," he said.

Honourable Malone further stated, "We met with a team of over 45 doctors, who have pledged their support and we are calling on the nurses active, retired, at home or abroad to lend their services and support at this very important moment."

As of July 18, confirmed active cases had fallen to 1,604 in the Territory with a reduction in daily increase in new cases.

Acting Chief Medical Officer Dr. Ronald Georges said, "Persons who test positive for COVID-19 need to disclose their positive status especially if they live in a household with other people. We are seeing a number of occurrences of persons not disclosing and therefore endangering persons around them."

Operation Protect Each Other Vaccination Drive-Thru which was launched last weekend remains in effect. Persons seeking their first or second jab of the AstraZeneca vaccine can do so from July 20 to 24 on the Festival Grounds between 9:00 a.m. and 4:00 p.m.



BRITISH VIRGIN ISLANDS COMMISSION OF INQUIRY PRESS NOTICE COMMISSION OF INQUIRY: UPDATE

The Commission of Inquiry ("the COI") was issued on 19 January 2021 to look into whether corruption, abuse of office or other serious dishonesty may have taken place amongst public, elected and statutory officials in recent years; and to make appropriate recommendations as to governance and the operation of the law enforcement and justice systems in the BVI. The Rt Hon Sir Gary Hickinbottom is the sole Commissioner.

As the Commissioner has confirmed, the COI will not hold hearings in August; and, as it is not possible to arrange hearings in respect of Statutory Boards and Crown Land prior to the August break as the Commissioner had hoped, the hearings earlier this week will be the last this month.

nIn his statement on 2 June 2021, the Commissioner explained that, given the history of inadequate and incomplete disclosure of documents and to ensure properly focused hearings, he was making requests for corporate witness statements in relation to these topics. These requests were largely addressed to Ministers, but the Commissioner was content for a Minister to decide if a public officer should provide the statement in his or her stead. The Commissioner expected the Inquiry Response Unit (IRU) to assist in the preparation of these statements. Despite requests having been made weeks before the recent rise in Covid 19 cases and multiple extensions of deadlines, in substantial part these statements are still awaited. Whilst the Commissioner is sensitive to the fact that the current Covid 19 situation in the BVI now makes it more difficult for some Government departments, it is vital that the material outstanding be provided as soon as possible to enable focused hearings to resume.

The Commissioner and his team will be returning to the UK to continue the task of preparing for the forthcoming hearings. They will return to the BVI in late August to complete the hearings. It is hoped that it will be possible by then for witnesses to appear in person at our hearing room at the International Arbitration Centre. The COI however has arrangements in place to allow for remote hearings should these become necessary. The COI will continue to keep the BVI public informed through its website.

The Commissioner reiterates his gratitude to the people of the BVI for their continuing help and support, and to the public officers upon whom the main burden has fallen to provide the documentation and evidence that is vital to enable the COI to carry out its work and fulfil its Terms of Reference.

ONEMART SUPERMARKET WILL NOT RELEASE UNVACCINATED WORKERS

President and CEO of the One Mart Supermarket group, Mark Vanterpool, says unvaccinated staff will keep their jobs respecting their decisions not to accept the COVID-19 vaccine at this time. Vanterpool commented:

"Several weeks ago, our Supermarket group adopted a policy of not scheduling unvaccinated employees to work physically at any of our company's properties. We did so in the interest of our customers, our employees, and our business; however, we have no plans to release those workers on account of non-vaccinations at this time. Instead, our executive team is exploring options for those persons to be assigned other duties or to work remotely within the company." He further added:

"Our staff members have always been devoted to our company and customers, and we too are devoted to them. Thankfully over 90% (125 persons) of

One Mart's staff is already fully vaccinated or partially vaccinated. Approximately 10% (15 persons) remain for unvaccinated various reasons. I strongly believe that COVID-19 vaccines are the only option to give our business, our people, and our community a fighting chance at defeating this deadly pandemic. However, we fully intend to treat all staff with respect and dignity. We respect their positions, but we still strongly encourage them to be vaccinated unless they have extenuating medical or religious reasons. In the meantime, we will pivot our operations slightly and deploy available technology to allow them to work remotely."

On June 28th, 2021, after having two staff members test positive for COVID-19, One Mart Supermarket instructed the affected workers to remain quarantined at home until advised otherwise by the British Virgin Islands Public Health Unit. Then, on June 30th,

2021, One Mart supermarket further advised all employees that persons who did not take their first COVID-19 shots by July 3rd and their second shots by July 31st, would not be scheduled to work until further notice. Since that

time, all such employees have continued to receive full pay and a weekly \$100 food voucher for a two-week period with home-delivery grocery service.

One Mart values all its team members and respects the personal decisions of unvaccinated staff.

The supermarket continues to operate with enhanced safety measures in place and vaccinated workers only at this time

TRINIDAD - Prime Minister of Trinidad and Tobago, Dr. Keith Rowley has raised the possibility of the COVID-19 vaccine becoming mandatory should the virus mutate to the point of posing a serious threat to the country.

"This is an international conversation which is very much a local conversation. What the government has done is to respect that right to choose what you do with your body. That is reasonable, under the circumstances," Rowley said on a television program here hosted by a former government minister Dr. Bhoe Tewarie.

"But suppose it becomes a situation where there is a variant of this virus that becomes even more virulent, is more deadly and spreads more rapidly and we know, through scientific information, that there's a vaccine that could prevent that from happening, then the Government will have to take a decision on behalf of those persons who have the right to protect themselves from this virus. So a decision will have to be made," he added.

Rowley told television viewers that if the voluntary situation gives Trinidad and Tobago the result that it can live with, "then we live with being voluntary. [CNW]

JAMAICA - In a move to seek "justice from injustices", Jamaica is readying

to demand reparations from Great Britain for the centuries-old slave trade in the former British colony.

The island was seized by the British, from the Spanish, in 1655 and profited off the labour of African slaves who worked on plantations of sugar cane, bananas and other crops. An estimated 600,000 Africans were shipped to toil in Jamaica, according to the National Library of Jamaica.

Although Britain prohibited trade in slaves in its empire in 1807, slavery wasn't abolished in the Caribbean until 1834. And Jamaica remained a British colony until its independence in 1962.

Leading the push for reparations in Minister of Culture, Gender, Entertainment and Sports, Olivia "Babsy" Grange, who said it is time that Jamaica get justice from injustices. [CNW]

CARIBBEAN - Mastercard has released its report Recovery Insights: Ready for Takeoff? , a global look at key trends in air and land travel. Although the global travel recovery remains uneven in pace, one-fifth of the countries surveyed have returned to at least 90% of pre-pandemic levels in domestic flight bookings.

PUERTO RICO - The Centers for Disease Control and Prevention (CDC) reduced the risk of contracting COVID-19 in Puerto Rico to Level 2, or "moderate"

Therefore, fully vaccinated people can travel to the Island without restrictions.

According to Discover Puerto Rico, the Destination Marketing Organization (DMO) of Puerto Rico, "the news is a positive sign for the tourism industry in Puerto Rico, which is already experiencing a solid recovery from the effects of of the pandemic. As reported in the July Industry Update, the island's recovery is advancing at a pace that exceeds that of other states and territories in the United States - the number of visitors so far this year continues to increase, the rates occupancy reaches unprecedented levels and income and taxes derived from visitor consumption have reached historical levels compared to 2019, the best year in the history of the Island."

Brad Dean, Chief Executive Officer (CEO) of Discover Puerto Rico, the Island's Destination Marketing Organization (DMO), noted that "the organization's marketing efforts to keeping Puerto Rico on the minds of

consumers and travel agents - even during the most difficult point of the pandemic - are paying off."

ROME - A Rome court on Friday released the explanation of its May decision to give two young American men, Finnegan Lee Elder and Christian Gabriel Natale Hjorth, life in prison for the homicide of Carabinieri police officer Mario Cerciello Rega in July 2019.

Elder killed Cerciello Rega with 11 stab wounds inflicted by a combat knife he had brought over from the US while Natale Hjorth assaulted the slain officer's partner at the end of a chain of events sparked by a drugs deal that went wrong.

Cerciello Rega, 35, had recently returned from his honeymoon when he was killed.

The judges said the personality of the defendants was "alarming, despite their young age".

The explanation talked of the "disconcerting perpetration of serious criminal acts in an disturbing escalation of illegality".


It said they upheld "deviant models of behaviour" with the "glorification of drugs, the ostentation of weapons and money as symbols of success, as documented by the photos found on mobile telephones" and said this highlighted "the clear criminal capacity of both". [ANSA]

MALTA - The new controversial Hungarian law, according to MEP Alfred Sant, is purposely vague and will create a context in which LGBTIQ people will feel threatened, unprotected and where homophobic attacks could be allowed. 'This way,' Sant warns, 'fascism beckons'

MEP Alfred Sant has taken a harsh stance against Hungary's new and controversial anti-LGBTIQ legislation, insisting that, "One cannot tolerate public discrimination and hate speech in the EU against LGBTIQ citizens and other minorities and it is even more unacceptable that such discrimination and injustice is being set into a national law, as in Hungary."

While voting in favour of a European Parliament resolution on 'Breaches of EU law and of the rights of LGBTIQ citizens in Hungary as a result of the adopted legal changes in



the Hungarian Parliament, Sant told the EP's plenary session this that the new law blatantly restricts the rights and freedoms of LGBTIQ persons, as well as children's rights.

"The issues at stake go beyond considerations and legal procedures related to Article 7, which have in the past been subject to partisan manipulation. They relate to human rights values as enshrined in Article 2 of the Treaty of the EU. About these, there can be no compromise."

On 15 June, the Hungarian Parliament adopted a law originally intended to fight paedophilia, which, following amendments proposed by members of Victor Orban's ruling Fidesz party, contains clauses prohibiting the portrayal of homosexuality and gender-reassignment to minors.

The law also prohibits homosexuality and gender reassignment from being featured in sex education classes and stipulates that such classes can now only be taught by registered organisations. [Maltatoday]

Gibraltar is a tiny place and densely populated. Had there been no vaccine effort, the death rate would have been astronomical.

When Gibraltar was in a bard place like the BVI is today vaccines, a receptive attitude to vaccine, and a ramped up vaccination effort saved the Territory from disaster.

Gibraltar is back to normal. Its hospital is free of Covid patients,

POLICE NEWS

RVIPF WARNS AGAINST OUTDOOR GATHERINGS

Tuesday, July 20 – The Royal Virgin Islands Police Force continues to see persons within the community violating the COVID Suppression Orders.

Acting Deputy Commissioner Jacqueline Vanterpool notes that gatherings of any kind, tables, at their favorite watering holes and outdoor spots. The present COVID Suppression Orders prohibits these types of gatherings since it does not allow enough social distance between persons to prevent transmission. It is very difficult



even outdoors, are still in breach of the Public Health Orders and must cease if the Territory is to reduce the rapid transmission of the COVID virus.

"Despite the present public health warnings, persons around the Territory are still gathering around domino not to take part in these daily practices, but we must in order to save lives," she noted.

The Acting Deputy noted, one officer had to discharge pepper spray in the vicinity to disperse well over a dozen individuals that had gathered around a domino game in East End after his direct order was not obeyed.

The individuals disbanded temporarily but returned an hour later to continue their game. Establishments are also being penalised.

"We are also seeing persons travelling by boat during the curfew hours of 7pm to 5am. The restrictions of movement around the Territory applies to both vehicle and boat traffic. If you are out and about after 7pm without a new July 2021 police-issued pass, you will be arrested for violation of the Curfew Order. Those who possess the new passes must have them in hand along with identification. One person's failure to act according to the law affects all of us," she noted.

RVIPF is ensuring that persons do not contravene any of the other COVID suppression measures as laid out in Public Health Order, 2021 and the COVID Control and Suppression Regulations that establish prescribe social distancing requirements

RVIPF RETURNING TO FULL COMPLEMENT

Friday, July 16 – The Royal Virgin Islands Police Force continues to do its part to aid in the Territory's return to a place of relative safety after close to four dozen of its officers had been on self-isolation.

Commissioner of Police Mark Collins says he is happy to note that of 45 officers on self-isolation since the recent outbreak, 26 have tested negative and have returned to work. With the curfew passes now in place, he says the Force can now adequately ensure that persons are abiding by the Curfew Order in force since July 6th.

"We are returning to the

complement we had prior to this recent COVID outbreak so we are able to play a full part in restoring the Territory to relative safety. We are prayerfully monitoring the condition of the nine that tested positive and the additional ten on isolation for COVID in hopes that they make a speedy recovery.

Commissioner Collins noted that while the community is largely abiding by the curfew, there are still a small number of individuals who are resistant. To those who choose for violate the orders he says, "If you are on the roadways after 7pm without a new July 2021 police-issued pass, you will be arrested for violation of the Curfew Order. Those who possess the new passes must have them in hand along with identification."

Officers are also ensuring that persons do not contravene any the other COVID suppression measures as laid out in Public Health Order, 2021 and the COVID Control and Suppression Regulations that establish prescribe social distancing requirements.

The Public Health Order requires persons to continually wear face masks when in public establishments and on public transportation.

NEW RVIPF ADMINISTRATION OFFICE SERVICE ARRANGEMENTS

In keeping with heightened COVID restrictions, the Administration Office within Royal Virgin Islands Police Force will change the process for accepting police certificates, police reports and visa waivers.

Persons requiring a police certificate can place a completed application along with supporting documents,

i.e., two passport-size photos for one single application and copy of passport profile page, in a sealed envelope and place that envelope in the drop box provided in the reception area of the Road Town Police Station. The name and email address or contact number of the applicant must be placed on the front of the envelope. Similarly, persons requiring a Police Report can place a completed application in a sealed envelope with the name and contact information of the applicant.

Payment for these services will be on collection of the requested document at an appointed date and time.

Cash is NOT to be placed in the envelope of any applications.

Applications for visa waivers will be accepted from 9am to 1pm daily by appointment only.

Contact for appointments is 468-5331. For medical emergencies for visa waivers, contacts can be made to 468-5305 or 368-9451.

RVIPF CHARGED SECOND MAN IN JANUARY'S COCAINE FIND

Thursday, July 22 – The Royal Virgin Islands Police Force charged a second male in relation to an operation in January that resulted in the seizure of over 200 kilos of cocaine.

Shaun Massicott, 28, of East End was charged for possession of a controlled drug with intent to supply and being concerned with the supply of a controlled drug. He appeared before the Magistrate's Court on Friday and was offered bail. Devon Bedford had been previously charged in the matter.

During an operation on January 19 in the Brandywine area, officers of the Force intercepted a rental vehicle. A search of that vehicle uncovered a large quantity of cocaine. A subsequent search of a second vehicle uncovered a smaller quantity of cocaine. A boat was seized as part of that operation.

Recipes for Life

Dear Readers:

Over a decade ago, I was given the wonderful opportunity to work King Features Weekly Service to create The Kitchen Diva! food and lifestyle column. Editor Jim Clarke helped me to craft 800 words, including a recipe, into a user-friendly and, hopefully, entertaining format each week, year in and year out. This is my last column for King Features, and I'd like to take this opportunity to thank Jim for being such an extraordinary editor, the King Features Weekly Service staff and all of you for your interest and support of my work.

I've enjoyed reading your emails, searching for recipes that you loved and lost, and answering questions about your cooking dilemmas. I feel like I've made thousands of new friends over the years. I can't thank you all enough for the privilege of doing what I love, and the honor of being able to share my thoughts and new discoveries with you each week.

When I started The Kitchen Diva column, I was transitioning into the culinary world after writing more than 100 children's books and visiting schools and presenting speeches at literacy conferences all over the U.S. and Europe. My love affair with studying culinary history, writing about food, creating recipes, publishing cookbooks and doing

cooking demos as The Kitchen Diva! is an odd turn of events considering I was never a great cook.

My mother, Angeline, is a wonderful cook, among her many other artistic talents, so I never felt the need to try to cook anything when I was growing up. My mother's decision to supplement her income by baking and selling her fabulous pies was the impetus of my career change. But instead of baking and selling pies, my sister Sandra suggested that I write a cookbook containing her recipes.

I taught myself how to cook and to write a recipe as part of the educational process of creating my first cookbook, "The African American Kitchen," with lots of help from my mother and my sister Marcia. I had no idea how labor-intensive, expensive (we bought all of the ingredients and tested over 150 recipes) and challenging this cookbook would be. I spent two years studying culinary history and heritage recipes from Africa, South America, the Caribbean, old Southern "receipts and scripts" and the African-influenced melting pot of cuisines that make up the foundation of the way that we eat in America today.

Over the past two decades, I've also observed the impact of recipes, handed down from generation to generation and prepared for the people you love, to bond together a family or to welcome new friends. It's those recipes for life that have held me in good stead through the horrible and heartbreaking national and personal events during the pandemic last year. Jim, my editor at King Features, took over my column in order to allow me to take the time that I needed to run The Kitchen Diva's Health Outreach, a division of Book Boosters, our families' non-profit education, health and social-service agency.

We were able to distribute hundreds of prepared meals, and to purchase canned and packaged foods to establish onsite pantries for families living in apartments in underserved communities here in Austin, Texas, during the pandemic and the horrible winter storm last year. I want to devote more time to operating our non-profit health outreach division and focus on educating and empowering people all over the world about ways to combat diabetes and diet-related illnesses using every form of media.

So, dear readers, as a tribute to my mother, Angeline, who LOVES collard greens, I'm sharing one of her favorite recipes with you. Enjoy, and "see" you soon!

ANGELINE'S EASY COLLARD GREENS

- · 1 large bunch (about 10 ounces) collard greens
- · 3 tablespoons olive or vegetable oil
- 1 red bell pepper, seeded, ribs removed and thinly sliced
- 1 yellow onion, peeled and thinly sliced
- 1 tablespoon garlic powder
- 1 teaspoon salt
- · 1 teaspoon sugar
- 1/2 teaspoon cayenne pepper
- · 2 tablespoons balsamic or red wine vinegar
- Wash the greens in cool water to remove any dirt. Cut the thick central ribs out of the collard greens. Stack the leaves on top of one another. Starting at one end, roll them up into a cigar-liked shape, then slice across the roll to make the greens into thin strips about 1/8-inch wide, and cut again lengthwise.
- Place a large, heavy bottomed skillet over medium-high heat. Add the olive oil and heat for a minute. Then add the greens and all of the rest of the ingredients except for the vinegar. Cook the greens, stirring every 30-seconds to combine the ingredients and cook them through, about 8 to 10 minutes.
- Transfer the collards to a serving bowl, sprinkle them with the vinegar, stir and serve immediately. Serves 4.

On Assassination Of Haitian President Jovenel Moise By Heads Of Government Of The Caribbean Community

The Heads of Government of the Caribbean Community (CARICOM) met in a Special Emergency Session on Wednesday, 7 July, in the wake of the assassination of the President of Haiti.

The Heads of Government are shocked and saddened by the assassination of a member of the CARICOM family, His Excellency Jovenel Moise, during the early hours of 7 July 2021.

They are concerned by the condition of his wife, the First Lady, Her Excellency Martine Moise, who

was gravely wounded in the attack, and wish her a full and speedy recovery.

Heads of Government strongly condemn this abhorrent and reprehensible act that comes at a time of deep turmoil and institutional weakness in the country. They called for the perpetrators to be apprehended and brought to justice, and for law and order to prevail.

In accordance with its values, as expressed in its Charter of Civil Society, the Caribbean Community does not settle its differences by violence which undermines democracy and the rule of law, but peacefully through dialogue and recourse to democratic institutions.

In light of Haiti's Membership of CARICOM and the family ties that bind the people of Haiti and CARICOM together, CARICOM expresses its willingness to play a lead role in facilitating a process of national dialogue and negotiation to help the Haitian people and their institutions to craft an indigenous solution to the crisis.

They call on the people of Haiti to remain calm, and to overcome their differences and unite at this moment of national peril.

Heads of Government extend condolences to the family of President Moise, and the Government and People of Haiti.

As a mark of respect, the Member States of the Community and the CARICOM Secretariat will fly their national flags and the CARICOM Standard at half-mast for three days beginning immediately, as well as on the day of the funeral.

US Considering Ways to Aid Cubans

The United States is examining potential ways to aid the people of Cuba following antigovernment protests this month that were the biggest on the island nation in decades.

Senior administration officials who spoke to news agencies on the condition of anonymity said the steps under consideration include changes to remittances that would allow people in the United States to send money to their family in Cuba without the Cuban government taking a portion.

Other potential actions include ways to make it easier to access the internet, working with international organizations to provide more humanitarian aid, and increasing U.S. Embassy staff in Havana.

The State Department reduced the number of staff at the embassy by more than half in 2017 after more than 40 American diplomats serving in Cuba said they suffered persistent ear pain, headaches, and problems with memory, concentration, balance and sleeping in 2016. The Trump administration said the injuries resulted from what it termed a "sonic attack."

The Biden administration has not publicly announced any intended actions, but it has been conducting an ongoing review of U.S.-Cuba policies. The White House said Monday several officials met with a group of Cuban American leaders "to listen to their policy recommendations and concern."

A White House statement stressed that addressing the current situation in Cuba "is a top priority."

State Department spokesman Ned Price told reporters Monday that the administration is concerned about human rights, democracy and civil rights.

"That's precisely what you're seeing and what we have said in the mechanisms of support over the years that the United States has provided to the Cuban people, and it is precisely what we mean when we say that we will consider additional forms of support, including any humanitarian support for the Cuban people," Price said.

Storm Threat Prompts Calls for Outside Help Fighting Oregon Fires By Associated Press, July 20, 2021

PORTLAND, ORE - The threat of thunderstorms and lightning has prompted officials in fire-ravaged Oregon to ask for help from outside the Pacific Northwest to prepare for additional blazes as many resources are already devoted to a massive fire in the state that has grown to a third the size of Rhode Island.

The 1,391-square-kilometer (537-square-mile) Bootleg Fire is burning 483 kilometers (300 miles) southeast of Portland in and around the Fremont-Winema National Forest, a vast expanse of old-growth forest, lakes and wildlife refuges. Evacuations and property losses have been minimal compared with much smaller blazes in densely populated areas of California.

But given how the Bootleg Fire — fueled by extreme weather — keeps growing by miles each day, officials with the Rogue River-Siskiyou National Forest in southwest Oregon are asking for more outside crews to be ready should there be a surge in fire activity there.

"Although the lightning activity predicted for early this week is expected to occur east of us, we are prepared for the worst, and hoping for the best," Mike McCann, an assistant fire staff, said Monday in a statement released by the national forest.

The worry is that dry conditions, a drought and the recent record-breaking heat wave in the region have created tinderbox conditions, so resources like fire engines are

being recruited from places like Arkansas, Nevada and Alaska.

A rural state

Meanwhile, the Bootleg Fire's jaw-dropping size contrasted with its relatively small impact on people underscores the vastness of the American West and offers a reminder that Oregon, which is larger than Britain, is still a largely rural state, despite being known mostly for its largest city, Portland.

If the fire were in densely populated parts of California, "it would have destroyed thousands of homes by now," said James Johnston, a researcher with Oregon State University's College of Forestry who studies historical wildfires. "But it is burning in one of the more remote areas of the lower 48 states. It's not the Bay Area out there."

At least 2,000 homes have been evacuated at some point during the fire and another 5,000 threatened. At least 70 homes and more than 100 outbuildings have gone up in flames. Thick smoke chokes the area where residents and wildlife alike have been dealing with months of drought and extreme heat. No one has died.

Pushed by strong winds from the southwest, the fire is spreading rapidly to the north and east, advancing toward an area that's increasingly remote.

Evacuation orders on the fire's southern edge, closer to more populous areas like Klamath Falls and Bly, have been lifted or relaxed as crews gain control. Now it's small, unincorporated communities like Paisley and Long Creek — both

with fewer than 250 people — and scattered homesteads that are in the crosshairs.

But as big as the Bootleg Fire is, it's not the biggest Oregon has seen. The fire's size so far puts it fourth on the list of the state's largest blazes in modern times, including rangeland fires, and second on the list of infernos specifically burning in forest.

These mega fires usually burn until the late fall or even early winter, when rain finally puts them out.

The largest forest fire in modern history was the Biscuit Fire, which torched nearly 2,000 square kilometers (780 square miles) in 2002 in the Rogue River-Siskiyou National Forest in southern Oregon and northern California.

Road to Tokyo Olympics began at Youth Olympics for Phillip, McMaster By Dean Greenaway

When 50m Free Swimmer Elinah Phillip and 400m Hurdler Kyron McMaster walk into the Tokyo Olympic Games stadium as flag bearers on Friday, they will make history as the territory's first Youth Olympic Games participants making it to the Olympic Games.

Seven years ago, McMaster participated in the 2014 Youth Olympic Games in Nanjing, China. Phillip was there to see her sister Amarah swim. She went on to compete in the Youth Olympic Games in Buenos Aires in 2018, after debuting in the 2016 Rio Olympic Games

Now, both will simultaneously walk into the Tokyo Olympic Games Stadium on Friday—Phillip as a 2-times Olympian at the tender age of 21—McMaster as an Olympic Games debutant.

"I think it's incredible to reflect on, really," Philip told Island Sun Sports before departing for Tokyo. "I don't think very often you get an opportunity to reflect on something like that so I think it's incredible, because it might seem like the paths have been similar but they haven't and both of us definitely overcame a lot between 2014-2018 and then now. We've both done a lot and to get to this point, it is something that we should definitely be proud of."

Phillip added: "It takes a lot of growth and determination and recognition for how difficult it is to be an athlete and the mental and physical strength it takes to persevere,"

McMaster did not respond to a July 11 request to provide reflections for this article as he promised he would.

Already with an Olympic Games experience under her belt, Phillip who at 16 became the territory's youngest Olympian since the territory debuted in Los Angeles in 1984, said competing in Rio 2016 has definitely prepared her for Tokyo.

"One thing I'm grateful for is my background going to different international competitions, so I'm used to the caliber of athletes that are going to be there," she pointed out. "But, it definitely doesn't take away the nerves, because it's going to be the Olympics at the end of the day."

The idea of an Olympic dream began at 12, while watching the 2012 London Olympic Games when she saw the swimming. Phillip, whose father Elsworth taught her to swim at Long Bay Beach, Beef Island, remembers turning to her uncle Ozzie Bradsha: "I'm going to be there in 2016 and I'm going to swim."

"He said okay and I remember seeing him just before I left for the Olympics and he told me how proud he was, that I actually made it happen for myself," she fondly reflected.

When asked about her 2016 Olympic Games debut and being in surroundings where it's not just her sport but a multiple of sports in the same place and seeing people she saw on television and read about, Phillip said being in such an environment with athletes you idolize, is definitely a surreal feeling.

"I remember seeing Venus and Serena (Williams) in the dining hall in 2016 in Rio and I just thought to myself, they're really here like that—that's them," she noted. "It feels great because you know everybody

there, including you, have worked very, very hard for their spot to be there."

The two times Olympian said she's looking forward to having fun in Tokyo—something she forgot to do in past competitions when she gets nervous. She said she's looking forward to that and really enjoying herself, especially when she swims.

"That's something I've noticed over the past few months, I swim my fastest when I'm having fun and I'm happy," she noted. "I'm most relaxed and when you look back, you realize it wasn't too bad actually."

While she's preparing to face the starters gun in the 50m Free on July 30, the Florida International Student who did a six weeks course at her school, is also taking a six weeks summer course in dentistry at Columbia University, that ends the same day she competes.

"I'm making everything work. Luckily my coaches and everyone at the summer program are working with me, to make things easier to manage," she said. "There's a lot happening in the background, but I'm in a position where my coaches have been working with me—whether it means I swim at slightly different times and the people at FIU academics and also at Columbia are working with me, especially in traveling when it comes to the time difference (Japan is 13 hrs ahead of Eastern time), they're very, very supportive which makes me happy."

Phillip said it makes things easier to manage and with their support. "They do things like recording lectures so I can watch it at a reasonable time while

I'm in Tokyo, and instead of staying late or waking up early to watch it at the same time it's happening, it makes it easier for me to manage and helps with my competition overall."

Dawson to play with British team in European U23 Baseball Tournament By Dean "The Sportsman" Greenaway

When East Georgia State University Catcher Kennard Dawson got correspondence from a British Coach about making the team to play in the European U23 Baseball Tournament in Italy in August, he was first skeptical and thought it was a scam.

"The letterhead in the initial email said "Mets Organization," Dawson told Island Sun Sports. "I was like wait, hold on. Then my coach started talking to me and said it was legit. When Shadow (Nateshon Thomas) messaged me and I actually got on the phone with the guy, I was like wow, this is actually what could really help me out in my career and it could boost me. Then I called my parents."

As the excitement built, he was told to take it easy because he needed to have all the proper documentation. He said it was a driving point for him because after his collegiate season, it was something else to focus on in preparation for next season. This was something to look forward to, to try and reach another level with his game.

"I felt like this was the perfect opportunity for me" he said

The chain of events began in May, during his team's baseball playoffs, when his head coach received

a message from the British pitching coach saying he was going through a list of players eligible to play for the British team, who were playing collegiate baseball.

"He said he liked my stats and what I brought to the table," Dawson said of the conversation with his coach. "He contacted me, then he contacted Shadow, who messaged me to get in contact with the coaches so I did and we spoke for a little while and they expressed interest in me playing."

Dawson is in the process of obtaining his British passport.

"I was granted a sport on the team, so I'll be heading to Italy to play in the preliminaries of the U23 European Baseball Tournament," he said. "If we win that tournament, we'll be in New York the following year."

Demoi "Ben Up" Hodge and Molique Malone were working with Dawson on Friday at the E. Walwyn Brewley Softball Park, as he's preparing for this journey. Other baseball players Reyondre Mercer and KJ Thompson have also been part of the group working out with Dawson.

"That's my brother for a long time, so I'm happy for him," Hodge told Island Sun Sports. "I feel I had a shot on the team but seeing that school and I weren't getting along, I didn't get the exposure this season, but in the future, he and I will be representing the BVI well. We have the talent to do it and we're going to work hard."

Hodge said they're motivated by family and friends and it's not a hard sport but it takes dedication to learn the sport.

Malone said Dawson deserves the opportunity because from day one, he has been working hard, working out, practicing, doing school work—everything.

"He really deserves it," Malone stated.

Despite the absence of a facility, Malone encourages youngsters to get out and 'try to make things happen." Come out and do something," he said. "Workout, go gym. If you have to run to keep your stamina, run. We have a softball field here. You can try a little something—run, hit and throw."

Malone said his mother has been his motivator and encourages him to practice. Friends also play a part with their support. "We motivate each other to try harder and do better, instead of being out on the streets doing nothing."



Cuba could help US normalize relations

All may not be lost in the efforts to improve relations between the government of Cuba and the Biden Administration in the US, despite the rhetoric - most of it emanating from the Cuban government in the wake of protests by thousands across the island.

The protests were occasioned by grievances over high prices, food shortages and power outages - due in part to the US trade embargo whose impact has been worsened by the COVID-19 pandemic that crippled Cuba's tourism industry, its biggest foreign exchange earner.

Unlike the former Trump administration, President Biden has not taken a hard line on Cuba. If anything, his administration has been seeking ways to revitalize the eased relationship that the Barack Obama administration promoted in 2015 and 2016.

Finding those ways has not been easy due to internal politics in the US and to insufficient movement by the Cuban government to manage dissent peacefully, rather than clamp down on it by military force. The Cuban government's harsh response to protestors on 11 and 12 July, fed the desire by influential members from both parties in the US Congress to continue Donald Trump's tough measures against Cuba, including its designation as a sponsor of terrorism that triggered additional financial and other sanctions.

The Biden administration has been navigating a thin line between wanting to improve relations with Cuba and not dismissing political and human rights concerns.

The most notable advocate of maintaining the Trump Administration's hardline policy on Cuba is the Republican Senator from Florida, Marco Rubio, who wrote to Biden on July 12, saying: "The

current protests in Cuba are not just about current economic shortages. They are about the longstanding and deliberate

> actions taken by the dictatorship to stymy the economic prosperity and political freedom of the Cuban people".

> The Biden administration could be better helped by the Cuban government to resist Rubio and others, and to return to the easing

of strained relations between the US and Cuba of which he was a part as Vice President in the Obama administration. It has always been well-known, including by the Cubans, that Biden is deeply committed to political and human rights, including the right to protest and dissent. Had the Cuban government responded in a spirit of tolerance and willingness to listen to the protesting voices of 11 and 12 July, it would have aided Biden in being stronger in his efforts to combat hardliners such as Rubio.

The US government regards freedom of expression of artists and freedom of speech by media to be fundamental rights everywhere, including in Cuba. US support for these freedoms are not efforts to subvert Cuba.

Most Caribbean governments also uphold these rights in their own countries. In the almost 60 years of experience of the 13 English-Speaking Caribbean countries as sovereign states, governments have learned to manage dissent and protests and to encourage media freedom as part of their democracies. Had they not done so, the economic progress of these countries, with considerable foreign investment, would not have been accomplished.

The experience in Cuba has been different. Over the last 61 years, trapped by a trade embargo, which causes economic hardship and deprivation, and threatened by repeated attempts to overthrow the government, the Cuban authorities have employed harsh measures to stop dissent and protests. They have not had the room to nurture a culture of tolerance and persuasion.

Ending the trade embargo against Cuba has always been the right thing to do. As Barack Obama famously said in December

2014, "an outdated approach has failed for over 50 years to advance our interests". In announcing efforts to normalize the relations between the two countries, he stated, "Today, America chooses to cut loose the shackles of the past so as to reach for a better future -- for the Cuban people, for the American people, for our entire hemisphere, and for the world". Those shackles were quickly fastened again by Trump.

Yet, a Cuba, that is released from the chains of the trade embargo and the threats to its security, could quickly become an economic powerhouse, attracting foreign investment, and unleashing the creativity and entrepreneurship of its people that comes from greater freedoms.

There is clearly a need for the US and Cuban administrations to return to the sensible negotiations about their future that started under the Obama-Biden administration. The Cuban government can help that process by changing from a culture of repression to one of tolerance and constructive management of dissent. Such a change would help empower Biden to continue what he helped to start with Obama.

Eyes are already on the US midterm Senate elections to be held in November 2022. Marco Rubio won his Senate seat in 2016 by less than 10 per cent of the vote. He relies heavily on the Cuban-exile vote to return to the Senate. Both he and the Republican Party will be heightening the anti-Cuba rhetoric to maintain that seat in a Senate now equally divided between the Republicans and Democrats.

Cuba should be mindful of that reality and ease up on the rhetoric that blames America for all Cuban discontent. The Cuban President Miguel Díaz-Canel, may have started that process. On July 14 in a televised address, he offered some self-criticism, for the first time, by saying that the government's shortcomings in handling shortages and other problems played a role in the recent protests.

That's an important step. It should be followed by a more open dialogue with those who have ideas about how the country should be governed. Thus, Biden would be emboldened to normalise relations, including ending the repressive trade embargo.



Paraplegic Battles UTIs

DEAR DR. ROACH: I am a paraplegic due to a spinal cord injury back in 1979. I battle one UTI after another, and I am becoming immune to most antibiotics. Why the constant infections? My urologist just ordered a CT scan, but seems uninterested in me as a patient. I am sick of being sick. I straight catheterize four times a day usually. It's getting very hard for them to match the antibiotic to the culture. At times the infections are so bad I get "foggy headed." These times I am in misery. The last time I went to the ER hoping it wasn't sepsis. They gave me antibiotics. I can't keep running to the ER. My copays are too much. Maybe I need a doctor who specializes in working with people who have a spinal cord injury. - Anon.

ANSWER: Regular drainage of the bladder with a "straight catheter" is the most effective way to reduce the risk of urine infections in a person with a spinal cord injury, but it is not perfect. People may still get bacteria in the bladder. Although it may be worthwhile to review your catheterization technique with an expert, it's possible to get infections even with perfect technique.

You haven't become immune to antibiotics, but the frequent use of powerful antibiotics will make you colonized with resistant bacteria, so that if you do get an infection, it's likely to be with a difficult-to-treat organism.

The CT scan is a good idea to see whether there is an anatomic reason for recurrent (or persistent) infections. I am disappointed to hear your urologist does not seem to be doing his or her best for you.

Recurrent infections are dangerous. Becoming foggy headed is a sign of serious systemic infection, and sepsis (a dysfunctional body response to infection) is life-threatening. Some people take antibiotics to prevent infection. Often, these are rotated to reduce resistance.

A urologist experienced in spinal cord injury, perhaps in consultation with an infectious disease doctor, would be ideal.

DEAR DR. ROACH: When is the best time of day to take things like fish oil, vitamin D3 and calcium supplements? — M.W.R.

ANSWER: There is moderately strong evidence that fish, or fish oils, may reduce the risk of cardiovascular disease. One or two servings a week of oily fish provides about as much benefit as more. For people who don't want to eat fish but want the benefit, a fish oil supplement daily (of about 1 gram) provides some of the benefit. I recommend taking it with meals to minimize the side effect of "fish burp" and to maximize absorption.

Vitamin D, given to people at risk for deficiency or with proven deficiency, also should be given with meals to improve absorption. Vitamin D is also needed for some people with inability to absorb vitamins properly. I recommend once-daily dosing with the largest meal of the day.

I seldom prescribe calcium supplements anymore. Recent data suggest that vitamin D and calcium together actually increased stroke risk. While vitamin D is important for bone health and is very difficult to get through food, calcium should be consumed as food, not as supplements. In addition to dairy products, many seeds, legumes, almonds and sardines are excellent calcium sources.
