# "BVI LOVE" TOURISM CAMPAIGN LAUNCHED

On its new reset focus, the British Virgin Islands is gunning to be the crème de la crème of luxury tourism in the Caribbean. The grand plan and mission were disclosed by recently appointed Director of the BVI Tourist Board Clive McCoy during the launch of the "BVI Love" Tourism Campaign on 21 September.

McCoy while lauding the BVI Love campaign announced that the Tourist Board is focused and ready for the global industry in a post COVID era. He said that much thought is being placed on the way forward and the luxury market is the main target.

"As we move forward with this campaign, you will be seeing many of our BVI LOVE promotional ads as we seek to be the best we can be as a luxury tourism destination," he announced during the social media campaign launch.

As part of the luxury market appeal, McCoy said that the BVI will continue to focus on its mainstay markets of Sailing, Diving, Fishing, and Watersports. The Director said, "We are pushing forward to maintain our market share where we are already strong while embracing the challenges brought on by the global pandemic. We are launching BVI LOVE International catering to the tastes and culture of

potential visitors, through the BVI lens. We are already engaging the mega yacht agents and private jet representatives to increase and organise their flow to and stays in the BVI."

Tourism in the BVI was interrupted and remains now on life support following the March border closure. Since then no tourist has been able to enter the BVI and many tourism businesses announced that they were suffering financially. The each geographical pool of Tourist Board responded

with heavy promotion of its annual staycation initiative.

This year, the initiative is said to have been a success - even against the COVID 19 backdrop and social distancing requirements. In reporting that the staycation campaign met its aim McCoy said, "We are so proud of our staycation programme. So many of us, fell in love with BVI all over again this year. We have been forced to come to grips with the fact that you just got to embrace BVI LOVE," he said.

Going forward - he said - the Board is looking for stakeholder involvement: "Our people will be invited to participate in training, surveys, and town hall meetings. We will harness all our BVI LOVE to continue to help our partners to remain in operation. We are all in this together with BVI LOVE!"

As the Territory prepares for its December reopening the Director expressed optimism: "As we reopen our borders, we will work to ensure that everyone is aware of the protocols for reopening our industry, for our visitors, for our industry partners and for us as a destination. We have done our homework. We have observed what has worked for other destinations: the technology, the practices, the regulations, the financial requisites, etc. and tailor-made our protocols to our unique product and circumstances; with BVI LOVE, we are ready," McCoy said.

Hon. Wheatley nonetheless explained that This situation was despite this snag the ICT Unit of the Ministry has been able to commence the distribution of Virgin Islands Digital Education (VIDE) ahead of the start of a new school year. He also mentioned that the Ministry is working feverishly to get more computers for students who need them.

"I wish to assure parents, however, that the Unit is working tirelessly to make additional VIDES available and to create alternative solutions to the existing challenges. For those parents who have already collected their devices, please note that the ICT Unit is in the process of emailing the credentials to allow students to access the application on the VIDES. Emails are being sent to the students' VI schools accounts. The ICT Unit will continue this exercise over the weekend so that students who have already collected their VIDES can access the textbooks."

While emphasizing that the need to acquire new VIDES has caused many students to be left waiting, Hon. Wheatley stated that soon this will be sorted: "I know that some parents in Grades 7 to 9 are becoming anxious because they have not yet received their VIDES. However, I wish to assure them that during these first two weeks, no new material will be taught. Emphasis will be on various orientations, providing psychosocial support, coping strategies, COVID-19 health and safety tips, classroom etiquette, classroom expectations, including online etiquette, an overview of the course material for the term, submission of assignments, academic

ethics. During week two, emphasis will be on building basic subject readiness skills. By the end of this period, we expect to have solved the existing challenges," he said.



# Premier Urges Banks To Do Better: "It Must Happen"

Premier and Minister for Finance Hon. Andrew Fahie is urging the community to come together and demand more from local banks as he explained that in this COVID emergency the banks are not very facilitating when it comes to assisting in expediting the BVI recovery. The BVI Leader made this comment while speaking in the House of Assembly on 22 September as he declared that he is not satisfied with the way these financial institutions chose to respond to the COVID 19 pandemic.

While encouraging residents to join together and respond to the less than empathetic bank behaviour the Premier said: "The only time people get up to deal with a system is when they don't like what a politician does. Other than that they just think that the system has the power over them. Banks make their money and I am the Minister of Finance when you say these things it goes longer than when I was just a regular member."

"Banks make their businesses through us going in to give them business; and if we band together and tell the banks we need better rates, we need better initiatives, they must help us," the Hon. Fahie pointed out.

While declaring that the banks were being insensitive to the current economic situation of the residents of the Territory, Hon. Fahie alluded to conversations he has had with bank management. The BVI Leader noted that these officials seemed most concerned about outstanding payments.

The BVI Leader also explained that he wrote the banks twice since the pandemic commenced and in other communication with bank management constantly heard about delinquent payment; as opposed to assistance and courtesies. "Whenever you challenge a bank, the first thing they tell you is that 'a lot of people delinquent, they ain't paying'. Let me speak the Queen's English - they are not paying. I ask them well 'how are they going to pay? Irma knocks the people down they were barely limping. Irma and Maria came, people ain't catch themselves yet owe. It is because they cannot do and here comes COVID-19'. So you have to come up with systems in the banks to adjust."

Hon. Fahie said that there was some concession from the bank but it was not sufficient for such a fluid situation,"I have written to the banks twice since COVID-19. Some of them have responded well, but some of them, their moratoriums are short and their systems don't go past six months...but they have to go past six months now because it is the need of the people."

Further, the Premier said that he intends to write again in an attempt to get some assistance for persons going through hardship. However, he commented that it would be good if the banks moved to assist by their social assessment: "I am writing them a third time because the government should not have to push the banks to come up with better rates to help the people. You cannot just focus on who owes alone, what about all these other persons. The reason some of them owe is not because they want to

any better. What systems can we come up with to help the people?"

Hon. Fahie said that he has always been concerned about the manner the banks in the Territory behaved and even while he was a member of the Opposition, he spoke out against it. This outspokenness about the banks, the Premier said, even resulted in his wife, who is a banker being threatened. In recalling the incident, Hon. Fahie told the House: "One time when I spoke about the banks because I sleep next to a banker - when I look somebody went and threatened my other half, telling her - let your husband be careful what he saying. Well, I Premier now go back and threaten her outta order people."

Nonetheless, the Premier stated that he was not going to deter from his mission to get more from the people. "I come to represent the people, I did not come to represent any bank. They have some people who think they could frighten you off when you are representing

the people ... I facing so many obstacles in this seat as Premier trying to get the people to help in this time, but guess what I am not getting daunted. I am not getting down spirited, but I have to let the people of the Virgin Islands know... The banks have to come together to do better and it can happen, it must happen," he added.

## **Government Pays Vendors & Service Providers some** of the 10-year-old overdue Bills The Minister also offered an

For ten years the government was owing to some vendors for goods and services. This announcement was made on 22 September by Minister for Transportation, Works and Utilities Hon. Kye Rymer as he mentioned that his Ministry has paid some of the outstanding debt, with others remaining.

This payment announcement is a follow-up from a statement that the Minister made in the House of Assembly on 21 July. At that time Hon. Rymer mentioned that he had met a number of unpaid invoices in the Ministry and instructed his team to get to the bottom of these invoices, intending to finally compensate vendors for the products and services which they have provided.

To date the Minister said that the majority of the invoices have been paid with others in the queue for payment soon: "Mister Speaker, before the end of this year, we hope to process more unsettled invoices that are over Two Million Dollars (\$2,000,000.00).

In noting how much the Ministry had to expend on their outstanding bills Hon. Rymer told the House, "So far, the Ministry has processed a total in the amount of Six Hundred Forty-Five Thousand One Hundred and Seventy-Three Dollars and Thirty-Eight Cents (\$645,173.38) of outstanding invoices for services rendered more than ten years ago."

The settled debts include the payment of invoices from multiple vendors for products or services such as concrete, construction materials, hiring of heavy equipment, barge services for transportation of equipment and materials to the sister islands.

Hon. Rymer expressed criticism: "It is an injustice to anyone who, having provided goods or services to any consumer - especially to the Government - and having met the required standards of quality for the goods or services to be accepted, for payment to be delayed for such an inordinately long period. Such delays affect the cash flow of these companies. It impedes their ability to meet their commitments and to pay their bills. It hampers their growth. It affects their employees. It can cause them to go out of business," he said.

"It is critical that the Government of the Virgin Islands regains a good rapport with the business community. Therefore, we continue to work feverishly to rebuild and maintain a professional and trustworthy relationship with the vendors within the Territory...The Government of the Virgin Islands is very committed to our local businesses and our local business community. We want them to do more than survive - we want them to thrive. As a Government, we are firmly committed to ensuring that local businesses and our Virgin Islands people benefit from the economic activities that take place on our shores."

The Minister further lashed out at the past government for acquiring goods and services and being reluctant to pay and said that this administration is not about that: "I wish to reassure our goods and services providers, that they will be treated with the courtesy, respect, and professionalism they deserve... Governments have a responsibility to the business community to ensure that there is a fair and even exchange of goods, services, and compensation for what was received. We cannot continue to acquire goods or services and not settle our debt on time. This is a gross disservice to our vendors and, as a Government, we must do better than this. This Government intends to lift the bar in how we conduct the affairs of the people," he added.

# Launch of "BVILOVE" Tourism Campaign

Good afternoon to each and every one. I recognize the protocol as established.

This is a very exciting day for us, as we stand on the verge of what will be one of the defining moments in the story of the British Virgin Islands, and I am proud to be here joining hands in the spirit of teamwork, as we seek to move the tourism industry another step forward.

I wish to start by thanking the hard-working management and staff of the BVI Tourist Board for always rising to the occasion, whenever our Territory needs you.

This is one of the reasons why we are a resilient people and why nothing keeps us down for long.

Hurricanes Irma and Maria, in 2017, caused a devastating blow to our tourism industry. But within months, we pulled together and swiftly revived our products and started receiving visitors.

We will implement an appointment based system for installations, equipment collections and phone sales, through our Virtual Store which will continue to be managed by our Senior Retail Associate, Alicia Modeste."

He added, "We first introduced the Virtual/Online Store in March at the onset of the COVID-19 pandemic in the BVI, as part of our efforts to be more responsive to the community's needs during the 24-hour curfew. Feedback from our customers indicated that it was an easier and more convenient way for them to contact us and access our products and services."

Maywahlall added, "We are deploying a new online payment system that will be easier and more user friendly, and which will complement our already large e-Payment options. 
# Labour Department Appointments Can Be Rescheduled

### COVID 19 AND FEARFUL TIMES FOR VIRGIN ISLANDS BUSINESSES

There is light at the end of the tunnel on the COVID 19 Pandemic with an approved vaccine expected shortly, and new super swift testing and tracing capabilities.

businesses However remain desperate and fearful, and that is to be expected

Ok. This Virgin Islands swimming instructor met his key sponsor on another breezy day in paradise, at a marina and resort on Tortola.

The marina and resort manager a charismatic man with a relaxed bonhomie- was unusually melancholic. He was clearly burdened with the horrific impact that the pandemic was having on his business.

" We need a national plan for reopening Mr. Igwe," he asserted. My revenues are down over 50%, and that is having dire repercussions for my customers and employees. "There is only so much we can bear before we may have to close down, even if that means for one season he added."

Now this writer has supported the government's posture that it will be directed by the science - and only by the science- in its plans for reopening the country and economy. However, he fully appreciates the concerns of business that relies on an open and free market, and stress free trading environment, to survive.

Closed borders, lock downs, and curfews are excellent for containing and controlling the spread of the Corona Virus. However, the preceding are also a "death knell" for any economy.

And it has been a miserable year so far The Coronavirus has killed hundreds of thousands around the world. And it has also confined the rest of us to our homes for much longer than usual, and on a daily basis, as the virus has ravaged the BVI economy. especially travel and tourism

And in the colder countries to the north, especially North America and Europe, as autumn days get colder and shorter, and Covid-19 cases surge, a dismal time looms ahead. COVID 19 appears to be a nightmare that will ever end?

The cries of the tourism and maritime industry in a country like the BVI are understandable. In the USA, Canada, and Europe, businesses have been supported by trillions of dollars of government stimulus. A country like the Virgin Islands simply cannot afford that type of overt and generous support to keep the population in jobs and out of poverty.

Consequently, the end to this horrible time is the hope that a vaccine will be forthcoming soon. Scientists around the globe are racing to develop a vaccine.

Regulators everywhere are fasttracking approval processes.

While it is not yet clear whether any particular vaccine will prove to be safe and effective, pharmaceutical companies are preparing to crank up production of many promising candidates.

Governments are even creating a market for vaccines by placing big orders in advance.

If at least one of these bets pays off, 2021 will be a much happier year.

A vaccine offers renewed confidence. That is the main economic benefit in a vaccine short term. When investors - who run the global economy-feel confident, there is frequently a rising confidence of consumers and businesses. That is usually the path out of recession. Economics is first and foremost about confidence.

The hope is that once a vaccine is approved and widely distributed, that humanity will finally be free to hug elderly relatives, socialize with both friends and strangers, move around as we please, and get back to work more or less normally.

In the meanwhile, governments like the Virgin Islands ,that do not have the power to create trillions of dollars of stimulus, out of the creation of debt instruments that investors are willing and happy to "lap up," must use every effort to ensure their economies survive, by listening to the cries of their business people.

One option for the Virgin Islands is creating a regime of pandemic worker who will test, trace, and isolate residents and aliens, as a means of driving normality in the economy. That regime should be supported by a COVID19 tax and levy on travelers who should rightly cover the costs of such a program.

New technologies, like trackers

on bands around the wrist, and cell phone applications, should enable COVID tracers keep an eve on travelers who enter the territory and who prior to entry test negative for COVID 19.

A look around the world will reveal the BVI is not unique in having locked borders and severe travel restrictions. And until a vaccine is approved and widely distributed this is going to be the norm everywhere.

In Europe, a second surge has appeared and is forcing another round of restrictions and local lock downs. The USA - the world's worst affected country- is already seeing a second surge that is worrying scientists.

Yes, government must listen to business. And government must provide businesses with its plan to reopen the country and economy: a plan that is transparent and widely available.

But businesses too must understand the limits of government to "pull a hare out the hat" and return

to pre pandemic normality in the time of COVID.

#### UPDATE ON THE REOPENING OF SCHOOLS

Good day and God's blessings to the people of the Virgin Islands. During my statement on the reopening of schools on Tuesday, 25th August, 2020, I announced that our phased plan to reopen schools was derailed due to a spike in COVID-19 cases in the Territory. I also stated that this decision would be reviewed in the weeks that followed. Since then we have had dozens of active cases. Through the leadership of the Minister of Health and the HEOC team and the cooperation of the public, we have been able to contain this latest outbreak of the Corona Virus, and for this we give all thanks to God! But

we are not out of the woods yet, and I encourage everyone to remain vigilant and adhere to the various health and social distancing guidelines as we continue in our efforts to combat the virus.

As a result of the continued progress that the Territory has experienced with the identification and isolation of positive cases, with the widespread testing reduction of new positive cases, and with the many recoveries of infected persons, I am pleased to announce that we are now poised to resume our phased reopening of schools.

During vesterday's Cabinet meeting, Cabinet received the

HEOC COVID-19 Situation Report #28 and made various decisions in regards to the Territory's schools.

One such decision was to instruct the Attorney General's Chambers to amend the Suppression Order No. 6 to allow private schools, daycare centres, pre-schools colleges to open for in-school instruction where approved, following inspection by the Social Monitoring Task Force and the Ministry of Education, and in compliance with the Social Distancing Protocols of six feet and Sanitisation Measures.

It is of paramount importance that everyone understands that all educational institutions must have measures in place to safeguard the health and wellbeing of our children and our teachers, as stipulated in our "Framework for the reopening of Schools", or they will not be allowed to open. This is a serious responsibility that we must all work together

Our public school system will also open, but in a phased manner. We recognize that all students are not able to access online education in the same way, and, therefore, Cabinet further decided to allow the following groups back into our public school classrooms: technical education students;

(No. 7) Order, 2020 has now been gazetted to give effect to Cabinet's decision. As was done during the Trinity term, all institutions are asked to make the necessary preparations and contact the Chief Education Officer, who will make the arrangements for inspection with the Environmental Health Division.

All schools will be expected to comply with the requirements outlined in the Ministry's Framework for the Reopening of Schools which include some of the following provisions:

All persons on school campuses must wear a mask or face shield. Visitors to school campuses will be restricted. Each school will decide how visitors will be accommodated with the restricted guidelines. School schedules will be outlining lunch and break periods and having them occur in a staggered manner to ensure a

control of students gathering in groups.

I wish to emphasize that schools should continue to engage students through a series of online interactive sessions utilising Cisco Webex, Zoom online platform, Class Dojo, WhatsApp, Facebook, Instagram, Google Teams, Google Hangout, combined with the Google Classroom, emails, PowerSchool for sending and receiving assignments, even for those who are attending classes on the campus.

You would have already heard me outline the plans of the Ministry for this academic year to ensure that we work with every child to get the best academic results. I am calling on all parents to be diligent in ensuring that your child has a structured place in which to engage in

school.

Over the next few weeks, I will engage in further discussions as I seek to have another phase of the reopening framework implemented. The schools will be prepared appropriately accommodate students. Clear demarcations must be placed separating the spaces for each student. Wash basins must be visible for hand washing; sanitizers must be in all classrooms for on-going sanitisation throughout the day. Before I close, I am pleased that the ICT Unit of the Ministry has been able to commence the distribution of Virgin Islands Digital Education (VIDE) ahead of the start of a new school year. I am aware that there have been some challenges which have resulted in the interruption to the distribution schedule. I was disappointed to learn about the extensive damages to the loaned devices. This lack of due care and attention to protecting these loaned devices has contributed to the current challenges. I wish

to give parents the assurance, however, that the Unit is working tirelessly to make additional VIDES available and to create alternative solutions to the existing challenges. For those parents who have already collected their devices, please note that the ICT Unit is in the process of emailing the credentials to allow students to access the application on the VIDES. Emails are being sent to the students' VI schools accounts. The ICT Unit will continue this exercise over the weekend so that students who have already collected their VIDES can access the textbooks.

I know that some parents in Grades 7 to 9 are becoming anxious because they have not yet received their VIDES. However, I wish to assure them that during these first two weeks, no new material will be taught. Emphasis will be on various orientations, providing psychosocial support, coping strategies, COVID-19 health

etiquette, classroom expectations, including online etiquette, overview of the course material for the term, submission of assignments, academic ethics. During week two, emphasis will be on building basic subject readiness skills. By the end of this period, we expect to have solved the existing challenges. We are indeed grateful to God for this breakthrough to allow some of our students to return to the classroom. This decision is timely as we will be joining on Sunday, 20th September, 2020 to commit the 2020/2021 school year into God's hands in our Annual Back to School Church Service. I invite you to join us on Facebook Live at 3:00 p.m. as we give God thanks and commit our new school year into His hands.



Opinion polls in Scotland now consistently show a majority in favour of secession from the rest of the UK, a trend that shows little sign of being just a flash in the pan. So, why the sudden sea change in the fortunes of the independence movement in such a short period?

In the six years since the Scottish independence referendum took place on September 18, 2014, the UK has gone to the polls in two constitutional referenda, three general elections and devolved parliament elections. In this midst of this political tumult, one event in particular has had more impact than the rest: the EU referendum.

While the political and economic union that had persevered for 300 years held (just) in 2014, faultlines over Brexit could cause the final, fatal tremor that sees the UK collapse in on itself entirely. (Euro News)

UNITED KINGDOM - BREXIT risked sparking a domino effect in Europe, with Sweden appearing influenced by Britain's vote, after a poll found the country to be in favour of ditching Brussels for independence. Prime Minister Boris Johnson had been handed a flurry of resignations amid his controversial Internal Market Bill, which the government admitted risks breaching international law. The UK's envoy on press freedom, Amal Clooney, quit her role "in dismay" at the government's willingness to break international law over Brexit. The human rights lawyer said it was "lamentable" for Boris Johnson to be contemplating overriding the Brexit agreement he signed last year. Across the Atlantic, US presidential nominee Joe Biden similarly denounced the move, warning Mr. Johnson



LONDON - The Bank of England left policy unchanged but warned the UK economy was in a precarious position as COVID-19 cases rise and the government's furlough scheme draws to a close. Policy setters kept interest rates at record low levels and maintained the Bank's programme of bond buying at £745bn (\$966.6bn), as had been widely expected. The central bank said the UK economy was performing better than had been expected at its last meeting. However, rising COVID-19 cases, uncertainty around the end of the furlough scheme, and Brexit risks meant it was still unusually difficult to forecast and risks remain high. "The outlook for the economy remains unusually uncertain," the Monetary Policy Committee (MPC) said in a summary of its meeting. The pound sank against the euro and dollar in response to the policy statement. (Yahoo News)

#### Avoid multitasking and micro-tasking

Try not to perform more than one task or activity at a time. Many people think they can do multiple things at once but there are downsides to it. When you multitask or micro-task, assignments take longer to get done because each time you come back to an assignment, you have to get familiar with it, find your spot and remember what you were going to do next. You are also more likely to make mistakes and remember less because switching between tasks tires out the brain and you're less able to commit what you're learning to long-term memory.

#### Trade your strategies for new ones

Look for ways to adapt your usual habits or form new ones. For example, if you usually study in the library, ask yourself what kind of environment helps you study. See if you can recreate that at home. Maybe it's studying in a chair, rather than on your bed or couch, or moving to a new spot when you change tasks. If you feel you need background noise, consider a white noise app.

In your best interest, avoid obsessing over endless coronavirus coverage. Choose only certain credible websites like cdc.gov for a limited amount of time each day.

With all the uncertainly happening outside your home, keep the inside organized, predictable and clean.

Setting up mental zones for daily activities can be helpful to organize your day. For example, try not to eat in bed or work on the sofa – just as before, eat at the kitchen table and work at your desk.

Loosening these boundaries just muddles your routine and can make the day feel very long.





# OPERATION OF UNLICENSED MONEY SERVICES BUSINESS IN THE BVI



BVI Financial Services Commission (the "Commission") reminds members of the public that operating a Money Service Business ("MSB") is a regulated activity that requires a licence.

#### CONSIDER THE FOLLOWING SCENARIO:





a fee to send money to the U.S.A.



Manuel's family can then pick up the funds in the U.S.A. from Shane's associate. In this example, Shane is conducting a money services business that requires licensing.

The Financing and Money Services Act, 2009 provides for the regulation, licensing and supervision for persons carrying on financing and money services businesses.

#### PENALTY

If **NOT** licensed, and Shane is carrying on an unlicensed money services business, he has committed an offence. Shane may be liable to the following penalties:



- 1. A fine of \$75,000 USD;
- 2. 3 years imprisonment; or
- 3. Both

#### **Money Services operation includes:**



Money transmission services (the business of moving money between bank accounts or from one person or organisation to another)



Cheque cashing services;



Currency exchange services;



The issuance, sale or redemption of money orders or traveller's cheques; or



An agent or franchise holder of a person carrying on any business specified above. If you or anyone you know is aware of persons carrying out unlicensed money services business, you should report it to any of the following:

I'm the director of a non-profit health outreach organization and a certified health worker tasked with sourcing and distributing food and essential supplies to underserved neighborhoods impacted by COVID-19. I'm also a chef, healthy food product developer, food writer and cookbook author with a passion for using unique ingredients -- produce, meats, herbs and spices -- to create recipes as the focus of my work to use food as medicine.

**Sometimes, all those hours concentrating on food become a problem** when it comes to figuring out what I want to eat. When that happens, I turn to a simple, satisfying solution -- I make myself a sandwich. It's the perfect, versatile, hand-held meal for any time of the day!

**Sandwiches range from slices of beef, turkey, chicken or seafood** on wholewheat bread to roasted vegetables stuffed in a pita. Dressings, spreads and sauces can add a delicious depth and complexity to a typical sandwich and completely change its flavor profile.



A mealtime sandwich suddenly becomes more interesting with the addition of a beautifully flavored mayonnaise. Adding herbs, spices or fruit to homemade or a good-quality store-bought mayonnaise changes the flavor and can be made to complement a wide range of meats, seafood and vegetables.

**Mayonnaise is made by creating an emulsion,** in this case oil and egg yolks, two ingredients that normally don't combine. Egg yolks provide a rich, creamy base, while adding lemon juice or vinegar to the mayonnaise emulsion also helps deter any bacteria growth. Using the highest quality eggs ensures that safety concerns are reduced to a minimum.

**All the ingredients for making mayonnaise,** especially the eggs, need to be at room temperature. Take everything out at least 30 minutes before you begin. The lecithin in the egg yolks also helps to stabilize the emulsion ingredients, and lutein adds an important antioxidant that helps to maintain healthy vision.

The key to making an emulsion is adding the oil in a slow, steady stream. The type of oil used in the emulsion changes the flavor of the mayonnaise. Do not use unrefined oils containing monoglycerides or extra-virgin olive oil, as the flavor is too strong, and the emulsion will separate. For best results, use regular olive oil, or combine it with vegetable oil.

Use this basic recipe for mayonnaise, and then add your favorite combination of herbs, spices and other ingredients to create a spread that will add a special zip to your sandwiches.

For best results, avoid making mayonnaise during wet or humid weather, as it will affect the emulsion and the mayonnaise will have a greasy texture. For a richer mayo, use only the egg yolks.

- 1 egg yolk 1/4 teaspoon salt 1/4 teaspoon dry mustard
- 1/4 teaspoon sugar 1/2 cup vegetable oil 1/2 cup olive oil
- 3 teaspoons lemon juice or white-wine vinegar 2 teaspoons hot water
- Using a food processor, blender or mixer set on medium speed, combine the egg yolk, salt, dry mustard and sugar until well-blended and a pale yellow.
- 2. With the motor running, slowly drizzle the oils (1/4 cup at a time) into the yolk mixture in a slow, steady stream. Drizzle in 1 tablespoon of the lemon juice and a teaspoon of the hot water. Continue to alternate mixing in the oil and the lemon juice until all the ingredients have been combined. The finished mayonnaise will be thick. If a thinner consistency is desired, whisk in 1 or 2 teaspoons of hot water.
- 3. Cover and refrigerate for at least an hour before using to let the flavors blend. The mayonnaise will keep about 4 to 5 days. Yield: 1 1/4 cups.

The following additions add a unique flavor to this basic mayonnaise recipe: Spices: saffron, paprika, cumin, mustard, coriander, chilies, horseradish/wasabi, ground ginger, curry powder and nutmeg.

Herbal Flavors: dill, parsley, basil, oregano, sage, cilantro, chives, chervil.

Other Flavors: grated lemon or orange zest, chutney, sun-dried tomatoes, capers, anchovy paste, pureed avocado, roasted red peppers, lime juice, ground dried wild mushrooms, pesto sauce, barbeque sauce, hot sauce, pureed mango or crushed pineapple, soy or Worcestershire sauce, honey mustard, minced garlic, purple or green onions, olives, diced sweet or dill pickles.

Oil Substitutions: Infused olive oils, sweet almond oil, canola oil, safflower oil, avocado oil.

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana) Secretary-General of the Caribbean Community (CARICOM) Ambassador Irwin LaRocque had fruitful discussions with United States Secretary of State Mr Michael Pompeo at the CARICOM Secretariat Headquarters, Turkeyen, Guyana on Friday 18 September.

The discussions included exchanges on the Covid-19 Pandemic and the severe economic fall-out being experienced by CARICOM Member States, the renewal of the Caribbean Basin Trade and Partnership Act (CBPTA), the de-risking of regional banks by US financial institutions and co-operation under the Caribbean Basin Security Initiative (CBSI).

The Secretary-General took the opportunity to thank Mr Pompeo for the response by him and US Treasury Secretary Mr Steve Mnuchin to the issues raised in a letter to them by the then Chair of the Community, the Honourable Mia Mottley, Prime Minister of Barbados earlier this year. The Community sought US support for initiatives to assist in combatting among other things, the economic fall-out from the pandemic.

Ambassador LaRocque emphasised the need for CARICOM Member States to have access to concessional development financing which is denied to them due to the criteria applied of GDP per capita and the classification of Member States as middle income in that context. This access, he noted, was critical as the Region sought to emerge from the grave economic crisis brought on by Covid-19 as well as to build resilience to natural disasters.

# Antigua and Barbuda Tourism Arrivals

**Begin Gradual Rise** 

(ST. JOHN'S, ANTIGUA) September 23, 2020 – As Antigua and Barbuda Tourism Industry stakeholders prepare for peak season, tourism officials are cautiously optimistic that with arrivals steadily increasing each month since the destination's re-opening, that the moderate upward trend will continue into the traditionally busy tourism period.

For the year to August 2020, tourism stayover arrivals show that the destination received 94,810 visitors. Though arrivals dipped drastically in March due to reduced airlift brought on by the global pandemic, as the V.C Bird International Airport re-opened to international flights in June, monthly visitor arrivals have more than doubled from then until the end of August.

For the month of August, the destination received 4761 visitors, with 67% of these visitors travelling from the United States, followed by 21% from the United Kingdom & Europe, 7% from the Caribbean and 3% from Canada.

Minister of Tourism, Charles Fernandez noted that: "The Ministry of Tourism and the Antigua and Barbuda Tourism Authority continue to carefully monitor the Covid-19 landscape within our main source markets. We remain committed to working with the Ministry of Health and the entire Antigua and Barbuda Tourism sector to ensure that as the destination opens up further, we keep those protective measures in place that have been designed to safeguard our residents and those who visit our shores."

The Tourism Minister explained that it would not be business as normal, as with the pandemic ongoing, Covid-19 protocols would still require visitors to travel with their

negative PCR test, wear facial masks when social distancing was not possible and adhere to other protocols stipulated by the Ministry of Health. For tourism businesses, he noted that protocols would also affect operations, and in some instances would mean reduced occupancy levels.

Presently American Airlines, Delta, JetBlue, British Airways, Caribbean Airlines, interCaribbean Airlines and Winair are operating flights into the destination. In the next few months, Antigua and Barbuda will welcome, Virgin Atlantic, Air Canada, and Sunwing.

In October, additional hotel re-openings have also been planned. These include Antigua and Barbuda Hotels and Tourism Association member hotels: Blue Waters Resort, Tamarind Hills, Hermitage Bay, Antigua Village, Galley Bay, Carlisle Bay Resort, St. James's Club, The Great House, Antigua Yacht Club Marina, Ocean Point Resort, Curtain Bluff Resort, and Hawksbill.

"Each hotel or accommodation offering that has opened has been inspected by the Ministry of Tourism and the Ministry of Health, to ensure that they are adhering to the covid-19 protocols set for tourism accommodation. Over two hundred properties have been inspected to date ranging from small bed & breakfast styled properties, to the larger all-inclusives," said the Tourism Minister. # Political Brawl Erupts Over US Supreme Court Vacancy Battle lines were drawn across Merrick Garland, arguing that on a lifetime appointment to the on a lifetime appointment to the

Battle lines were drawn across America's political landscape Saturday over the replacement of U.S. Supreme Court Justice Ruth Bader Ginsburg, whose death Friday silenced the court's best-known liberal voice and raised the possibility of a 6-3 conservative majority on the bench.

The vacancy came weeks before the November 3 general election that will decide whether President Donald Trump gets a second term in office as well as which party will control the chambers of Congress. How and when the vacancy is filled will have immediate political impact and could leave a permanent imprint on how the Senate functions and America is governed.

Conservatives, eager at the prospect of a third Trump-nominated high court justice, cheered Republican Senate Majority Leader Mitch McConnell's pledge late Friday that Trump's eventual pick "will receive a vote on the floor of the United States Senate." He did not offer a timetable.

#### 'They should not falter'

"President Trump and Senate Republicans have worked hard to overturn decades of liberal activism in our court system and they should not falter now," Washington-based Heritage Foundation's political arm, Heritage Action, said in a statement. "Republicans must exercise the power of confirmation that voters have entrusted in them[.]"

Liberal groups and Democrats, meanwhile, girded for battle.

"I've never seen political hypocrisy at this level [magnitude]," veteran Vermont Democratic Senator Patrick Leahy said on NPR, noting that in 2016 McConnell refused to allow consideration of former President Barack Obama's final Supreme Court nominee, Merrick Garland, arguing that high court vacancies should be left unfilled during an election year so the American people can weigh in on the choice.

"This is a flip-flop, it's pure politics," Leahy, a member of the Senate Judiciary Committee said. "It is going to stain the Supreme Court."

Leahy and other Democrats wrote a letter to the committee's chairman, South Carolina Republican Lindsey Graham, saying, "There cannot be one set of rules for a Republican president and one set for a Democratic president, and considering a nominee before the next inauguration would be wholly inappropriate."

For his part, Graham, rejected such calls, noting that in 2013, Democrats changed Senate rules to hasten the confirmation of Obama's judicial nominees and unsuccessfully sought to block Trump's second Supreme Court nominee, Brett Kavanaugh, whose 2018 confirmation was roiled by an allegation of sexual misconduct.

"In light of these two events I will support @realDonaldTrump in any effort to move forward regarding the recent [Supreme Court] vacancy," Graham tweeted.

Republicans have a 53-47 Senate majority and can afford three defections from their ranks and still confirm a nominee with a simple majority, with Vice President Mike Pence breaking a potential 50-50 tie.

Susan Collins, a Republican senator from Maine, is opposed to the Senate's vote for Trump's nominee. Collins posted a statement on her Twitter account Saturday, saying "we must act fairly and consistently - no matter which political party is in power . . . I do not believe that the Senate should vote on the nominee prior to the election . . . the decision

on a lifetime appointment to the Supreme Court should be made by the President who is elected on November 3rd." Alaska Republican Senator Lisa Murkowski has said she would not vote for a Supreme Court pick before the election. Others may or may not follow suit.

The looming fight added uncertainty and suspense to an election season already brimming with both. Political observers mulled how a high court vacancy may energize voter turnout to the benefit of either political party. Some argued against jumping to conclusions.

#### 'Not clear'

"In a world of slim majorities & few persuadable voters, it's not clear that we know how a controversial SCOTUS confirmation battle before November would affect Senate elections and control of the chamber," Brookings Institution political analyst Sarah Binder wrote on Twitter.

Whether Trump succeeds in filling the high court vacancy, the mere effort appears to be strengthening Democrats' resolve to change how Washington works should they win control of the Senate next year.

For months, many Democrats have signaled a desire to eliminate the filibuster that requires three-fifths consent for most legislation to advance in the chamber.

Tweeting shortly after McConnell's statement backing an eventual Trump Supreme Court nominee, Hawaii Democratic Senator Brian Schatz said, "It is going to be very hard after the procedural violence that Mitch McConnell has inflicted on the Senate and the country for anyone to justify us playing it soft next year just to satisfy pundits. We must use the power that voters give us to deliver the change we are promising."

In addition, some Democrats have suggested expanding the number of seats on the Supreme Court from nine to 11 if they win control of the chamber.

Republicans contend the Democrats' fury is unjustified and that 2020 is nothing like 2016, when Garland was blocked from consideration. The Senate and White House were controlled by different political parties at that time.

"By contrast, Americans reelected our [Republican] majority in 2016 and expanded it in 2018 because we pledged to work with President Trump and support his agenda, particularly his outstanding appointments to the federal judiciary," McConnell said in Friday's statement.

The finger-pointing and recriminations since Ginsburg's death are the latest examples of escalating partisan tactics that have transformed the judicial confirmation process from what was once a mostly bipartisan endeavor into a near-constant brawl.

#### Bork hearings, Obama nominees

Republicans were incensed

when Democrats banded together in opposition to former President Ronald Reagan's ultraconservative Supreme Court nominee, Robert Bork, in 1987. Democrats cried foul from 2009 to 2013 when Republicans drastically slowed the consideration of Obama's judicial nominees, prompting Democrats to change the Senate rules and eliminate the filibuster for all but high court nominees. Republicans went one step further and eliminated the filibuster for all nominees in 2017.

Today, analysts say, America is in uncharted territory as the nation grapples with a Supreme Court vacancy weeks ahead of a general election.

"We rarely have these situations where someone passes away and leaves the court, right before an election," said University of Virginia presidential studies director Barbara Perry, who described the situation as unprecedented in modern times.

"So, we'll have to stay tuned to see what happens," she added.

# Third member of BVI's 1st track and field team passed away

Just three days before the BVI Athletics Association which was founded on September 19, 1970, celebrated its 50th anniversary, a third member of the very first team to compete off island, passed

Eric Matthias Sr., 65, died at his home on Sept 16. BVIAA founding member, its second president and its longest serving president Rey O'Neal, told Island Sun Sports about Matthias Sr. and that first team that competed in St. Croix in November, 1970.

"He was someone who would come out and not really trained doing laps around the track, but he was the only one we had who was going to run a 'long race' so we entered him in the 1500m with Dale Abrahamson and he also ran the 5000m," O'Neal recalled. "He got third in the 5000m and after that, he didn't really compete very much if at all and he sort of turned his attention to Softball shortly thereafter. He was a catcher with the Jets and was a pretty good catcher."

Velma Warner and Cecil Dawson preceded their teammate Matthias.

"Velma was the fastest girl in the territory at the time, she ran the 100/200m and I think she came second in each of those races in St. Croix," O'Neal noted, "Cecil Dawson-I considered him one of the best all round athletes if not the best that have come out of the BVI-he was the fastest guy we had. He was second in the 100m in St. Croix. I'm not sure if he ran the 200m but Mario "Sonny" Todman did. Abrahamson (800/1500m and who also played Softball and Cricket) and Gene Hodge (Shot Put/ Discus Throw) were double winners. Hodge also led off the 4x100m Relay.

"Cecil was one of the four athletes in 1971 (including Abrahamson, Warner and Hodge) competing in Trinidad and did pretty well. Abrahamson got a bronze in the 800m in a pretty decent international field, so that was our first major achievement outside the Virgin Islands."

Also on that first team to St. Croix, and is now the Supervisor of Elections, was Juliette Penn, who ran the 4x100m Relay along with Marva Mercer, Elva Jeffers and Warner.

Dr. Robert Mathavious, Managing Director and Chief Executive Officer of the BVI Financial Services Commission competed in the High and Long Jump

"Robert was the best High Jumper we had in High School for a few years and he also broke the Long Jump record that stood for quite a while, which was held by Heraldo Todman," O'Neal said. Todman was the 1957 and 1958 Virgin Islands Secondary School Victor Ludorum, competing for Bronte House. "Heraldo was the first athlete that I recalled who I think if circumstances had been different, could have been, certainly a regional and possibly an international class athlete. Robert played some Softball and competed in inter-house matches, but he was good."

O'Neal pointed out another athlete on that team to St. Croix who many might not associate with track and field as he became a dominant pitcher with the Astros Softball team, was Elmore "The Equalizer" Connor, who won the

Edwin "Boss" Hodge who played centerfield for the Jets and the BVI National team, O'Neal noted that he was a "useful Long Jumper, High Jumper and sprinter."

Errol Blackman from Dominica who worked at Barclays Bank, was a good allround athlete (400m, Shot Put, 4x400m Relay), so was Gerald Rose, (400m, Long Jump, 4x400m Relay) a BVI High School mathematics and chemistry teacher.

Most of the girls on that first team were quite young, O'Neal said. Marva Mercer "could do a bit of everything" (100/200m, Long Jump and 4x100m Relay). Jackie Richardson (400/800m). High Jumping sisters Urmin "Mucho" Richardson and Ramona Richardson— Urmin won the High Jump and Ramona

O'Neal said Elva Jeffers (Long Jump/4x100m Relay) was an "unorthodox looking runner but somehow got from point A to point B, faster than most girls in the high

That first team also included Shot Putter, Monica Martin.

# Has the time come for Caribbean Republics? By Sir Ronald Sanders Elizabeth II as Head of State. Post Origin Arthur and Freundel St.

1994, shortly after Antigua and Barbuda and Cuba established diplomatic relations, Fidel Castro and Antigua and Barbuda's Prime Minister, Lester Bird, had a memorable conversation in Havana.

The conversation is worth recalling in the context of the third announcement by a Government of Barbados that by November 2021, it intends that Barbados should be a Republic, shedding monarchical status and Queen Elizabeth II as Head of State.

The conversation between Lester and Fidel, at which I was present as a member of the Antigua and Barbuda delegation, started with the revolutionary Cuban leader asking Lester (now Sir Lester) what big plans he had in mind for Antigua and Barbuda. Lester told Fidel that he was contemplating moving to make Antigua and Barbuda a Republic, relinquishing the monarch as the country's Head of

Fidel's response stopped Sir Lester and the entire Antigua and Barbuda delegation in our tracks. "Why?", asked the legendary revolutionary. "Does she interfere with your government?". Sir Lester explained that she did not and that, in a real sense, while Antigua and Barbuda like many other Caribbean countries was one of the Queen's realms, her role in the government of the country was performed by a local representative and, apart from assenting to legislation which could not be withheld, was only ceremonial, having no executive authority.

"In which case", Fidel responded, "you might consider remaining as you are. The Queen doesn't interfere with your government and she provides to foreign investors and others a level of confidence in the constitutional arrangements of your state".

The surprising conversation did not go much beyond that. It was staggering to the Antigua and Barbuda delegation, but it demonstrated the practical sense of Fidel Castro, which might account, in part, for the survival of Cuba despite the punishing embargo by the United States.

That 1994 conversation between Fidel and Sir Lester took place at least nine years before Owen Arthur, as Prime Minister of Barbados, first proposed Republican status for Barbados in 2003; eighteen years before Jamaican Prime Minister, Portia Simpson suggested it in 2012; twenty-one years prior to Prime Minister Freundel Stuart echoed the proposition in 2015 for Barbados; twenty-two years before Andrew Holness as Prime Minister repeated it in 2016 for Jamaica; and twenty-six years before the latest announcement by the Barbados government of Prime Minister Mia Mottley on September 15.

So far, none of the countries in which this proposal has been made, has gone through with it.

While the Throne Speech, in which the most recent Barbados announcement was made, referenced Barbados' first Prime Minister, Errol Barrow, cautioning against "loitering on colonial premises", there would be many who would draw a distinction between seeking independence from the colonial authority of the British (which was the context of Barrow's remarks) and retaining Queen

Both Owen Arthur and Freundel Stuart might have retreated from the idea not because they did not believe it to be right, but because within the Barbados society, including the business community, a great value is placed on the Queen as a symbol, if nothing else, of stability and maybe even of unity above the fray of politics.

This is probably true, too, in the case of the Bahamas, Belize, Jamaica, Antigua and Barbuda, and the five other independent countries of the Eastern Caribbean where the Queen is still head of state.

In the event, the present government of Barbados has the greatest chance of success in achieving the objective of becoming a Republic by next year. Unlike the remaining independent countries of the Caribbean of which the Queen is head of state, the Barbados constitution allows for this significant change in constitutional status by "votes of not less than two-thirds of all the members of the House". No referendum of the electorate is required. Given that the present Mottley Government controls twenty-nine of the thirty seats in the House of Assembly, achieving the vote should be easy.

The one obstacle would be how intense, if at all, will be resistance by elements of the Barbados society and the business community against the idea, and how much it threatens to divide the country. This was a matter that clearly influenced both Arthur and Stuart, during their premierships, not to press ahead with the idea.

Antigua and Barbuda, the Bahamas, Jamaica and the other six independent Caribbean countries require not only a two-thirds majority in the House of Representatives, but also a majority vote by the electorate in a referendum.

Winning referenda in the Caribbean has proven to be as difficult as pushing a boulder up a mountain. In 2009, a referendum in St Vincent and the Grenadines rejected the proposal to oust the monarchy and substitute it with a republic. And, several referenda have failed in other Caribbean countries to alter the Constitution to allow the Privy Council to be replaced by the Caribbean Court of Justice, signifying a reluctance by the majority of the electorate for radical change.

While becoming a Republic is regarded by Caribbean intellectuals as "rounding the circle of independence", the argument is not as much about the head of state not being a white woman living in a distant former colonial power; it is more about confidence in good governance when institutions perceived as beneficial are changed.

That argument can only be won by political parties in every Caribbean country, demonstrating that they will maintain the rule of law, civil and political rights, and democratic principles, including non-discrimination particularly in race and religion.

However much ruling political parties might wish to join the Barbados government in pursuing republican status, "the matter is really in the hands of the Caribbean people" as the Queen said in 2012 when Portia Simpson declared: "I love the Queen, she is a beautiful lady, and apart from being a beautiful lady she is a wise lady and a wonderful lady. But I think time come".

# **CANCER AWARENESS CAN SAVE MILLIONS OF LIVES**

- Cancer is the second leading cause of death globally, and is responsible for an estimated 9.6 million deaths in 2018. Globally, about 1 in 6 deaths is due to cancer.
- Approximately 70% of deaths from cancer occur in low- and middle-income countries.
- Around one third of deaths from cancer are due to the 5 leading behavioral and dietary risks: high body mass index, low fruit and vegetable intake, lack of physical activity, tobacco use, and alcohol use.
- Tobacco use is the most important risk factor for cancer and is responsible for approximately 22% of cancer deaths
- Cancer causing infections, such as hepatitis and human papilloma virus (HPV), are responsible for up to 25% of cancer cases in low- and middle-income countries
- Late-stage presentation and inaccessible diagnosis and treatment are common. In 2017, only 26% of lowincome countries reported having pathology services generally available in the public sector. More than 90% of high-income countries reported treatment services are available compared to less than 30% of low-income countries.
- The economic impact of cancer is significant and is increasing. The total annual economic cost of cancer in 2010 was estimated at approximately US\$ 1.16 trillion
- Only 1 in 5 low and middle-income countries have the necessary data to drive cancer policy.

Between 30-50% of cancers can currently be prevented by avoiding risk factors and implementing existing evidencebased prevention strategies.

The cancer burden can also be reduced through early detection of cancer and management of patients who develop cancer. Many cancers have a high chance of cure if diagnosed early and treated adequately.

Tobacco use is the single most important risk factor for cancer and is responsible for approximately 22% of cancer-related

Risk factors include: obesity, diet poor in vegetables and fruit, lack of phisical activity, alcohol, air pollution, illegal drugs, sexually transmitted diseases.

Cancer mortality can be reduced if cases are detected and treated early. Most of all: pressure politicianst o increase political commitment for cancer prevention and control.
