BVI IS READY FOR TOURISTS' ARRIVALS

Tourism officials are enthused about the reopening of the Territory's seaports on 15 April and announced that activities are in motion to supplement and boost the Territory's tourism offerings going forward.


In an interview with JTV tourism officials spoke optimistically about the upcoming tourism season and the reopening of the seaports. The panel included Minister for Natural Resources and Labour Hon. Vincent Wheatley, Junior Minister of Tourism Hon. Sharie De Castro, Junior Minister of Trade Hon. Shereen Flax-Charles, Chair of the BVI Tourist Board Kenisha Sprauve, and Director of the BVI Tourist Board Clive McCoy.

The Tourist Board Director said that his team is looking forward to the reopening of the seaports and have been doing light repairs to make the visitor experience worthwhile. Such repairs

included the refurbishing and, in some instances, rebuilding of visitor lookout points.

Similarly, the Chairperson of the BVI Tourist Board also spoke of her excitement to see more tourists on the streets of the Territory. Sprauve said, "We are looking forward to those days because as we all know the seaports are one of our busiest ports, and once those open you will see the rise in the number of tourists coming to the BVI."

The Chairperson noted that preparatory work was particularly done in the sister island of Virgin Gorda, as it is at the top of the list of many visitors. She said, "Many of the tourists travel to Virgin Gorda which is the Territory's biggest destination; so, we know with that coming it is going to have a lot of traffic. That is why at the Tourist Board we are doing what we can in the downtime to



ensure things are ready for when the seaports open."

Sprauve mentioned that over the past months, persons have been complaining about the current state of tourism in the Territory, and she noted that some of the criticisms have been unfair. "What I want persons to remember, it is not only the BVI that is going through this pandemic...While we are going through low numbers at this time, we just want to encourage persons to continue to work, to continue

to get their businesses ready...because when the seaports open and when things shift a little bit you will see the demand of persons coming back. You will see the amount of people coming to the BVI."

Meanwhile the Junior Minister of Tourism Hon. De Castro mentioned that a holistic approach to the development of the Tourism industry is being mulled, and she has been tasked to spearhead this effort: "The Premier has commissioned methis year to work alongside the BVI Tourist Board and the industry to ensure that we have by year-end a National Tourism Plan."

As it relates to the plan the Junior Minister said: "We have set up a Special Select Committee...We ensure that we hear the voice of the industry, the people who are on the ground day in and day out and who have the expertise necessary to create this plan and make it work for the BVI...It will be a National Strategic Plan that would project what tourism is expected to look like for the next 10 to 15 years."

The Junior Minister further explained that since the objective is to create a National Plan, the expertise from the industry is being depended on for the strategy that would shore up our tourism sector. She said the aim is also to see how the Territory's tourism sector can

be diversified. "This plan will project not what we used to be, but what we plan to be and how we can future proof our destination to ensure that we increase our arrivals," she added.

Hon. De Castro said that she has been seeing a lot of interest in tourism during the pandemic and she lauded the fact that young persons are leading the charge. "I have seen a lot of adventure tourism that's happening especially as it relates to hiking; I have seen a lot of young persons get involved in that part of it. Of course, they are young, energetic, and dynamic."

It was noted that the hikes are just one example of how young persons are seizing opportunities to get involved with the industry and how they are trying their best to add their little touch to it. This youthful touch - Hon. De Castro said - is ensuring that the BVI tourism experience is good for locals as well as visitors. "One of the most amazing things for me has been how we have been able to as BV Islanders and residents to just enjoy the BVI", she added.

The point about youthful interest in the tourism industry and explosion of business was also touched on by Hon. Flax-Charles. She noted: "We have been able

to see so many businesses created during the pandemic and a lot of persons have been able to say to themselves: you know what, let me try something new. Let me do something different and our government's agenda is just that and we want to put persons in a position where they are able to be flexible."

"I am going to be doing some walks through Main Street in the next couple of weeks just to showcase the businesses there especially those that are very young. Moving forward our focus is going to be on our young entrepreneurs and we have some as young as nine and ten and we want them too," she added.

Territory-Wide Agri-Fisheries Complexes To Be Created

Before the 2017 hurricanes, the BVI Fishing Complex was a place to go and purchase locally caught fish. However, following the devastation of the calamitous storms and eventual demolition of the building the Complex is no more. Nonetheless, there have been plans to rebuild the Complex. Meanwhile, the Deputy Premier and Minister for Agriculture and Fisheries Hon. Natalio Wheatley announced this month that the new Complex will have some changes and will no longer be dedicated to fish only.

The disclosure was made by Dr. Wheatley during the 10 March sitting of the House of Assembly. During an update on the agriculture and fisheries sectors of the Territory. In that update, the Deputy Premier outlined the plans for the BVI Fishing Complex. He told Legislators that there are plans to re-establish what was once the BVI Fishing Complex. "The intention is to repurpose this Complex to include agricultural products and other value-added goods from local farmers and fishers. Mr. Speaker, we are excited about this vision and see this as a necessary step to support our fishing and farming community and other industries connected to these sectors such as tourism."

Hon. Wheatley noted that the plan is essential to the development of the BVI's agriculture sector. "Fisheries, Mr. Speaker, is a priority in the Territory's blue economy, and we recognize the importance of this sector's sustainability. The Department of Agriculture and Fisheries has received support in collaboration with

regional and international bodies to strengthen the Department's capacity for data capture, research, and monitoring," Hon. Wheatley said.

Last year it was announced that instead of one, the Territory is about to have multiple fishing complexes. This disclosure was made by Hon. Wheatley during the questions and answers segment of the 27 February 2020 sitting of the House of Assembly.

Hon. Wheatley in response to a question from Leader of the Opposition Hon. Marlon Penn repeated a previous announcement that the current fisheries location was ceded to the BVI Ports Authority. "The Ministry does not have plans to reopen the Fishing Complex at the Baughers Bay location."

The Minister explained that following Cabinet's approval at its meeting on 9 December 2019 the land that formerly housed the BVI Fishing Complex was transferred to the BVI Ports Authority to assist with the expansion of its main cargo handling and passenger terminal.

However, the Minister noted that the plans that Government previously had for the BVI Fishing Complex have changed and the Ministry is pursuing a new plan that involves complexes at various locations.

Hon. Wheatley told the House, "Initially my ministry was only seeking an alternative site for the Fishing Complex, However with the merger of Agriculture and Fisheries as a single department and our desire to expand this sector of our economy we are now using a more holistic approach in our search of land that can accommodate the local fishing and farming industries."

In stating how the plan has evolved the Minister stated: "We now envision an agriculture and fisheries complex that would be equipped to inspect, grade, process, and market both agriculture and fish products which may also serve as a cultural and tourism facility to maximize its marketing capacity and exposure for our local fishermen and farmers."

Meanwhile, Hon. Wheatley noted that the fishermen agree with the plans. "Preliminary discussions with fishermen and farmers have been supportive of this new vision. We are actively considering multiple locations for fisheries complexes. I must also take this opportunity to emphasize that it is the vision of this government to establish fisheries facilities where fisherfolks can land their catch, collect ice, and process among other services in the eastern, western and central area of Tortola, in Virgin Gorda, Anegada, and Jost Van Dyke," the Minister stated.

Drugs Business Negative And "Corrosive" Impact On

The BVI Highlighted

The BVI's drug issue is reportedly being contributed to by young persons who were seduced by the supposed wealth and flashy lifestyle this illegal business may bring. It was noted that these young persons pay no heed to the horrible repercussions. The dangers resulting and the casualty associated with such poor decisions need to stop, Commission of Police Michael Matthews declared last week.

The Commissioner of the Royal Virgin Islands Police Force commented during the Joint Press Conference Addressing Matters Relating to Crime and Public Safety. The 18 March press conference featured His Excellency Governor John Rankin, the RVIPF Commissioner, and Premier Andrew Fahie.

Noting that there have been recent cases of murders and massive drug seizures the Commissioner announced: "What must change is mindsets." The Commissioner explained how some persons are being caught up in such criminal activities.

The Commissioner said: "We have a unique opportunity to

change course here. There is something exceptional about the way of life in the Territory. You enjoy the luxury of the comfort that living in a safe place can only bring. Many relocate to these shores because of that. It cannot be taken for granted. The drug culture will take that from you. If you turn a blind-eye to transshipments of drugs, the Territory, as a whole, will suffer."

In noting the short-lived allure and criminal trappings Matthews explained: "It promises considerable, immediate wealth in the short-term but there will be nowhere on earth to enjoy it -- much less a small Territory like this one. There is always someone

trying to eliminate you to get the upper hand. I have only a few more weeks here in this Territory, but we will all need to think carefully about the future. If you are involved in the drug trade, reflect on where it will take you, and your family, your community, and the future of this Territory."

The Governor also lent his voice to dissuading young persons from the drug trade: "I ask this in particular for our young people who are perhaps most at risk of the drugs culture and of being exploited by those who control the drugs trade. Drugs, and the organized crime which surrounds the transshipment and importation of drugs, are deeply

corrosive and deeply harmful. The young people are the future of these Islands and we must protect them from those who seek to exploit them."

"The deaths we have witnessed over recent months have deep repercussions for everyone in the community. So please join me, the Premier, and the Police Commissioner in a firm resolve to end the unacceptable violence we have witnessed. I ask that the community stand shoulder to shoulder with us in these efforts and refuse to tolerate criminal activity on these islands," Governor Rankin added.

Schools To Adopt 3-Feet Distancing Between Students

Special permission is being sought for the social distancing protocols of six feet to be relaxed in classrooms of public schools in the Territory. Now students will be required to sit three feet apart. This altering of the protocol is to accommodate more students in the classrooms and was announced by Deputy Premier and Minister for Education Hon. Natalio Wheatley at the Sixth Sitting of the Third Session of the Fourth House of Assembly.

Hon. Wheatley told Legislators during the sitting this month that the relaxing of the protocol will help to solve one of many issues the Education Ministry is facing during this COVID 19 pandemic. He told the House: "I will be

requesting through Cabinet very shortly that consideration be given for a reduction in the social distancing in classrooms from sixfeet to three feet. This reduction will allow for more classrooms to accommodate more students, eliminating in most instances, the double sessions for teachers."

The Education Minister gave assurance that this step was a necessary compromise. "Mister Speaker, we are seeking ways to address the challenges that our children and the education system are facing while ensuring we remain vigilant in keeping our children safe."

The Minister said that there is a push to have school return to normalcy, but he noted that

such normalcy would require vaccination: "Mister Speaker, I have engaged the Ministry of Health on what would be required to further normalize our education system, and their refrain has been consistent. The vaccination of the population is how our travel, our churches, our entertainment, our businesses, and, yes, our education system return to normalcy. Therefore, I engaged the Ministry of Health to make vaccinations of teachers and parents a priority."

Nonetheless, Dr. Wheatley assured that the Education Ministry is not going to force vaccination, and he noted that this is a fear that many have: "Mister Speaker, there is some

fear that the vaccine will be forced on teachers and parents. I wish to assure the public that the vaccinations remain voluntary. I understand the concerns of those who are hesitant to take the vaccine."

"To help allay the concerns of those who are skeptical, we have arranged with our health professionals special sessions for our educators. Some schools have held discussion sessions with staff on the vaccine, and, by the end of this week, we would have confirmed sessions for the other schools. We must thank Dr. Ronald Georges and members of his medical team along with community-minded private doctors who have been making the presentations and engaging discussions about the vaccine," he added.

The need for more space in the classrooms and vaccination fears are just some of the issues facing the Ministry at this time. Hon. Wheatley said, "I am well aware of the challenges that parents, teachers, and students have in coping with the impact of COVID-19."

One such issue is internet coverage. In that regard, Dr. Wheatley said: "The struggle for adequate internet coverage in schools continues, but I am pleased to say that some progress was made over the last months in the build-out of the internet infrastructure that should address the coverage on campus. During the course of this term, the mounting of Promethean boards in schools was completed. This will help with the delivery of the lessons, accommodating students in class as well as those online. Partnering with the Department of Information Systems (Dolt), plans are on stream to further equip schools to improve internet coverage on campus."



DISCONTINUATION OF PASSBOOK SAVINGS ACCOUNTS

On behalf of the National Bank of the Virgin Islands ("NBVI" or the "Bank"), you are hereby advised of the following update for your information and guidance:

PASSBOOK SAVINGS ACCOUNTS

Effective 1st July 2021, the Bank will discontinue its Passbook Savings account type to ensure that we are able to maintain our customer service standards and to afford our customers better access to technological advances within the banking industry. Despite best efforts over the years, the Bank is no longer able to adequately service this account type, due to highly specialized equipment and related requirements.

Charters Receive 50 Percent Reduction In Licensing Fees

The Commissioner of Customs, Mr. Wade N. Smith, is notifying all Charter boat owners, charter companies, and charter management companies of a 50% reduction of licensing fees outlined in the Commercial Recreational

Vessel Licensing Act, 1992.

In accordance with Section 4 of the Act, Recreational Commercial Vessel licensing fees are due on November 1 each year. As such, fees were to be paid by November 1 2020. However, given the

circumstances created by the COVID-19 pandemic which prevented the marine industry from operating at full capacity, licensing fees outstanding since November 1, 2020 are now due to be paid at a 50% reduction by April 15 2021. Thereafter fines

and penalties may apply in accordance with Section 11 of the Act for non-compliance.

Premier and Minister of Finance, Honourable Andrew A. Fahie, affirmed that this reduction in licensing fees is a part of the Government's commitment to alleviating the impacts of COVID-19 on the public in the form of stimulus packages.

The Premier said "In the form of a stimulus to the marine industry, I am pleased to announce that your Government has extended a reduction of fees for the 2020 to 2021 season, for the licensing year 1st November, 2020 to 31st October, 2021. This is a stimulus for our

BARBADOS - Almost 40 per cent of the structures scheduled for demolition this year are in the urban communities of St. Michael.

This statistic was revealed in a recent publication of the demolition of derelict buildings by the Director of Environmental Protection Department late last month. In total, 234 buildings are on the list. In addition to St. Michael, they are also structures to be demolished in St. Lucy, Christ Church, St. Peter, St. James, St. Philip, St. George, St. Joseph, St. Thomas, and St. John.

One house located in Wavell Avenue, Black Rock, St. Michael, and scheduled for demolition, was owned by Geraldine Hood. A resident of Black Rock told the Barbados Advocate that she knew Ms. Hood and even spent some of her early childhood living in the area. She said that Ms. Hood, who is now deceased, had several properties in the area. [Barbados Advocate]

SANTO DOMINGO - The Abinader administration announced that the Winston Churchill and Charles de Gaulle bus routes have been assigned to the Central Nacional Movimiento Choferil del Transporte (Mochotran) and the 129 routes affiliated to this transportation association.

The president of Mochotran, Alfredo Pulinario "Cambita", said 94 new electric bus units will circulate on the Charles de Gaulle Avenue in Santo Domingo and 41 on the Winston Churchill Avenue in the National District.

The busses will have capacity for 90 passengers and payment will be via cell phones. The busses will be air-conditioned and offer Wifi. On board, security cameras will offer enhanced safety. The cameras will be connected in a closed circuit to the 911 Emergency System.

Pulinario said the busses will feed the Santo Domingo Metro. [DR1]

ANTIGUA - The Government of Antigua and Barbuda has signed a contract with Russian regulators to acquire the SputnikV vaccine.

Other prominent variants include B.1.1.7, which was first discovered in Britain, and has been identified in 5,567 cases in 50 states and territories and B.1.351 — first discovered in South Africa — with 180 cases in 26 jurisdictions. TRIESTE - Over the past five years, Italy has gone from 50th place to 25th in the World Happiness rankings, the president of the Ernesto Illy Foundation Andrea Illy told ANSA, noting that "thus I think something is changing".

"I think that there is a new sort of awareness," he added, "in part because of the crisis, since Italians express a great deal of solidarity among themselves in moments of difficulty." The latest World Happiness Report shows that, despite the severe consequences of the pandemic, in a single year the country rose three places in the rankings, from 28th to

25th place, and over the past five it halved the distance between it and first place.

The Ernesto Illy Foundation and IllyCaffe are among the supporters of the report, which is the result of an annual survey by the United Nations Sustainable Development Solutions Network, chaired by the US economist and essayist Jeffrey Sachs. [ANSA]

MADRID - A year ago, at the beginning of March, EL PAÍS had zero digital subscribers. At the newspaper's headquarters, work was ongoing to prepare one of the biggest transformations in the history of the company, a change upon which the foundations would be laid for a stable future that would guarantee the profitability of the daily, and as such a boost for independent journalism with a global reach.

It was at that point that the coronavirus pandemic was declared, one of those news stories that will leave a mark on generations. The plans to launch a digital subscription model at EL PAÍS were put on hold until May. Efforts were redirected instead to public service work and to adapting to the circumstances, given that we were forced to work from home like so many other people were. In the case of many journalists, however, that still meant working on the street or from hospitals.

Today, less than 11 months later, EL PAÍS has built a community of more than 100,000 new digital subscribers.. [El Pais]

VATICAN - In a rare display of open disagreement with the Vatican, a number of bishops have publicly denounced a statement issued by the Congregation for Doctrine of the Faith. Numerous Catholic bishops from around the world have publicly denounced the Vatican's recent statement forbidding Church blessings for same-sex couples, calling the move "unacceptable," hurtful and clumsy.


The Congregation for the Doctrine of the Faith (CDF) on March 15 published something called a responsum, along with explanatory note, that reiterated the Vatican's longstanding position that it is "illicit" for Catholic priests to bless same-sex unions.

But in a rare display of open disagreement with the Vatican, bishops from several different countries immediately criticized the CDF intervention.

"I feel ashamed for my Church. I mainly feel intellectual and moral incomprehension," said Bishop Johan Bonny, 65, of Antwerp (Belgium).


and incomprehensible. The pain the Church has caused them is today my pain," said Bonny, a Rometrained theologian who worked at the Pontifical Council for Promoting Christian Unity from 1997 until his episcopal appointment in 2008.

"Controlling who can or cannot receive God's blessing — this is inadequate and wrong," said Franz Kreissl, director of pastoral services for the Diocese of St. Gallen in Switzerland.

"It is not permissible to exclude a certain group from the outset as a 'sinner,' without taking into account each individual concerned," Kreisel continued in a statement published March 16 on the diocesan website.

On the other side of the Rhine, Bishop Georg Bätzing of Limburg said he was "unhappy" with the new note published by the Vatican.

In France, the publication of the CDF text has aroused a sense of anger and incomprehension in LGBTQ+ Christian movements and associations. [National Catholic Reporter]

RVIPF MARKS ONE-WEEK OBSERVANCE IN WILLIAMS' MURDER WITNESSES BEING SOUGHT

Tuesday, March 23 – The Royal Virgin Islands Police Force Major Crime Team (MCT) continues to seek witnesses in their pursuit of those responsible for Deverson Williams death, exactly one week after he was brutally gunned down.

Williams, 38, native of St. Vincent, who resided in Long Trench, was pronounced dead at the scene after sustaining several gunshot wounds while in his vehicle in the Fish Bay area. The victim's vehicle, nearby vehicles and the International Motors building also sustained damage.

Commissioner of Police Michael Matthews says that his detectives have interviewed several witnesses to this daylight shooting, but more witnesses are still needed. "We are still seeking witnesses because the identity of the perpetrator or perpetrators are still unknown. Each eyewitness account helps us to put together the overall picture. In this case, no one single witness account will be enough.

"The incident took place in the streets, in a populated area, where many saw this dreadful event unfold. Drivers and shoppers in the vicinity are being invited to just give their account. We simply want as many accounts as possible. We have not or will never publicly identify persons who may have assisted the Force with confidential information. I must stress that all information received is treated in confidence, the Commissioner noted.

Police are presently working on several leads however, witnesses into the yesterday's incident or anyone with information are encouraged to contact the Major Crime Team directly at 368-5682 or Inspector Vernon Larocque at 368-9809.

Persons with information can share this with other trusted individuals such as their district representative, pastor or church leader or any persons who could pass it on their behalf if they do not wish to speak to the police directly. This information can be forwarded to the RVIPF Intelligence Unit at 368-9339 or via the confidential Whatsapp messenger number of 368-9112.

Working together with the RVIPF to challenge violent crime in the Territory is the only way to keep our communities safe.

MOTORBIKES/CARS SEIZED IN OPERATION CLEAN THE STREETS

Thursday, March 18 – Officers of the Royal Virgin Islands Police Force removed six scooters, six vehicles, arrested four persons and reported seven over the weekend as Operation Clean the Streets continues.

In the weekend operation, a dozen scooters and vehicles were confiscated for being unlicenced and uninsured and for defective mufflers.

Persons were ticketed for various traffic offences – ten for not wearing seatbelts, three for not wearing helmets, and two for not having licence plates. Four persons were taken into custody.

The same Clean the Streets operation at the end of February resulted in another six scooters seized and 18 persons ticketed for various traffic offences.

Acting Superintendent Dariel Robinson noted that while Operation Clean the Streets should be considered a success, the number of violators who deliberately disregard the laws is disturbing.

"It is troubling that there are so many people from all walks of life who blatantly ignore the traffic laws --

laws intended to protect drivers, riders and other road users and allow for safer environment to travel.

"In civil societies, Police should not have force these laws on citizens; people should want it. While enforcement and penalties can be a deterrent, the greatest incentive to following the law is the realisation that without rules, boundaries and guidelines to operate, this will be a very miserable place to live. We are slowly drifting towards this place," Robinson said.



The lethal weapon that is tact

The weapons of diplomacy, tact and negotiation, are better options in moving towards selfdetermination than banging an anti- colonial drum. Tact and diplomacy will achieve more for Overseas Territories than confrontation.

Now, there is a reason for diplomacy: diplomacy is better than war. And in a world where men are swift to draw the sword from the scabbard, diplomacy is one reason why millions of souls are alive today, and not lost to war and conflict.

War Time Leader Winston Churchill once described a diplomat as someone who will tell you to go to hell, and you actually enjoy the journey along the way.

In the Virgin Islands today, with the Commission of Inquiry, and a feeling the land has lost control of its narratives to external forces, one reason for the general feeling of being besieged has been the lack of diplomacy, and the consequent negotiations that derive from diplomacy, towards the UK.

And yes, these islands have been under a microscope for nearly three decades, ever since financial services became the main economic pillar. But that should have been more the reason to adopt greater diplomacy and its sibling tact, and the consequent negotiations that derive from diplomacy, when dealing with outside powers, mainly the UK. This Old Boy once warned a friend and senior public official to adopt diplomacy as a weapon when dealing with a UK that has greater tools at its disposal to drive its own agenda and interests. Woe betide the great man ignored that advice and suffered accordingly.

The simple fact is that the UK as former colonial power and now Overseas Power with controlling stakes over OTs can bring much to bear down on any Overseas Territory if it so wishes, or when in the view of Westminster and Whitehall, a heavier hand is required.

The power local and native governments possess Overseas Territories derives from the UK Common law, Conventions, Customs, the UK national interest in maintaining Overseas territories as strategic appendages of the UK mainland.

That power can only be diminished if a substantial bloc of OT residents and citizens desire a change in the status quo. It is far from certain that residents want less of UK oversight.

Consequently, the one realistic option for constitutional change is not force of rhetoric but diplomacy. And then add the accompanying negotiations and diplomatic skills that serve a desired outcome.

Tact and diplomacy can only be ignored if the mass of an OT population is behind a native government in a drive for full independence.

From observation, this Old Boy is willing to state that in the Virgin Islands specifically, that the majority of residents are happy with the status quo and UK oversight. Without the overt and clear backing of the people for radical constitutional change, it will not happen.

And all the rhetoric against UK oversight by politicians will hit the proverbial ceiling.

It is much better then, if you

are on the weaker side, to adopt tact and diplomacy, in driving constitutional change. When dealing with the UK in

matters of self-determination, it is unwise playing a game of dominoes, when the UK is expert at playing chess.

A Love Affair With Lamb

I seldom prepared or served lamb until I tasted Australian lamb. The tenderness and variety of cuts of Australian lamb opens up the opportunity to serve lamb all year long, not just in the spring. I love slowly braising lamb shanks, marinading and flash-frying lamb chops, and using ground lamb in stews, sauces and forming them into patties.

Lamb is the meat from young sheep that are less than a year old. Americans eat far less of this delicious meat than people in other countries. It's often a case of not knowing how to select the best cuts of lamb or misinformation about the meat having a strong "gamey" flavor.

Current labeling laws often allow a confusing number of packaging terms as it pertains to lamb, including "natural," "pasture-raised" or "grass-fed." These terms are allowed even though the animal may not spend any time in a natural setting, in a pasture or grazing on grass. The label to look for to purchase the best-quality lamb meat is either "100% grass-fed," "organic-100% grass-fed lamb" or "100% grass-fed." This type of lamb has a buttery, tender quality.

Australian lamb can be found in most American markets and is generally available in five different cuts: the shoulder, rack, shank/breast, loin and leg. "Rack of lamb" usually refers to a rib cut that includes nine ribs and can be split into rib roasts. Lamb "chops" can come from several different cuts.



For example, "rib chops" come from the rib, and "loin chops" come from the loin. You might also see "blade" and "arm" chops in the meat section of the grocery; these chops come from the shoulder. Sirloin chops come from the leg. Additionally, many stores sell lamb that has already been ground and can be used to make burgers, meat loaf or sauces.

100% grass-fed lamb is a significant source of B vitamins and niacin. It also is an excellent source of omega-3 fats, dependent upon the diet of the mother and the lamb. Grass-fed lamb has been shown to average at least 25% more omega-3 fats than conventionally fed lamb. Consumption of omega-3 fats has been associated with decreased risk of inflammation and heart disease.

In Australia, where lamb is raised in abundance and eaten regularly, recent studies show it as the top omega-3 food in the daily diet. In regions of some countries without easy access to fish, lamb has sometimes been shown to provide the most omega-3s of any other food in the diet.

AUSTRIALIAN-STYLE LAMB SAUCE WITH PASTA

- 2 pounds Australian ground lamb 10 ounces dried macaroni
- · 3 tablespoons olive oil · 1 medium white onion, peeled and finely diced
- · 2 cloves garlic, peeled and crushed 1 1/2 teaspoons salt
- 1 1/2 teaspoons ground black pepper
- 1 teaspoon ground cinnamon 1/2 teaspoon ground cloves
- 1/8 teaspoon crushed red peppers or cayenne pepper
- · 2 bay leaves · 1 cup chicken broth
- 1 (16-ounce) can chopped tomatoes
- 2 cups crumbled feta cheese or Parmesan cheese
- 1. Cook the pasta according to packet directions. Add salt to the boiling water, cook until al dente and then drain.
- 2. Heat olive oil in a large frying pan on medium heat. Add the onion, garlic, 1 teaspoon each salt and black pepper, cinnamon, cloves and red pepper or cayenne pepper. Saute for 2 to 3 minutes, without browning the garlic. Add the ground lamb, crushing any lumps with the back of a spoon. Cook until lamb is browned, stirring occasionally, about 5 to 6 minutes.
- 3. Add the bay leaves and chicken broth. Reduce heat to a simmer, add tomatoes and stir to combine. Cook 25 minutes; stirring occasionally and season with the remaining 1/2 teaspoon of the salt and pepper.
- 4. Remove and discard the bay leaves. Add the pasta to the pan and combine with the meat sauce. Sprinkle with the cheese, and serve immediately. Serves 4 to 6.

Celac Supports Caricom Call For Gobal Vaccine Summit

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Friday, 19 March 2021) - The Caribbean Community (CARICOM) welcomes the support of the Community of Latin American and Caribbean States (CELAC) for its call for a global summit to address urgently the issue of equitable access and distribution of vaccines to combat the COVID-19 pandemic.

CARICOM Chairman, Dr. the Honourable Keith Rowley, Prime Minister of Trinidad and Tobago had written in January, on behalf of the Community, to the Director-General of the WHO Dr. Tedros Ghebreyesus urging him to convene at the earliest possible opportunity, a Global Summit to address urgently equitable access to COVID-19 vaccines, particularly for developing countries. The Summit, Dr. Rowley proposed, would be held in the context of the Organisation's ACT-A Facilitation Council. The call was repeated by CARICOM Heads of Government following the Intersessional Meeting which they held late last month.

The CELAC statement issued by Mexico as the President Pro Tempore of the group, expressed concern over the lack of delivery of vaccines to the Small Island Developing States (SIDS) of the Region. The statement said that while CELAC supported the COVAX mechanism, it called for the Caribbean to "receive the vaccines as quickly and equitably as possible."

"We are convinced that the COVID-19 pandemic has highlighted the importance of maintaining a strong, united and caring Latin American and Caribbean region, where no country is excluded from universal, fair, equitable and timely access to medicines, vaccines and medical supplies.

Therefore, Mexico joins the call made by the Caribbean Community (CARICOM) to hold a Global Summit within the framework of the World Health Organization to address the urgent equitable access to said vaccines," the statement said.

The full statement reads:

CELAC PPT expresses concern over the lack of delivery of COVID-19 vaccines at the island States of the region

It calls on the COVAX mechanism to expedite the delivery of COVID-19 vaccines to countries in the region, particularly those participating in the Advanced Market Commitment modality.

Mexico, in its capacity as President Pro Tempore (PPT) of the Community of Latin American and Caribbean States (CELAC), expresses its concern over the lack of delivery of COVID-19 vaccines to the region's Small Island Developing States (SIDS). While expressing its support for the COVAX mechanism, it calls for the Wider Caribbean to receive these vaccines as quickly and equitably as possible.

This Pro Tempore Presidency endorses the statement of the meeting of Finance Ministers and Central Bank Governors of the G20 countries, held on February 26th, 2021, which reaffirms the support to the most vulnerable countries, especially those facing an unsustainable debt burden. Therefore, a call is made to the COVAX mechanism to expedite the delivery of vaccine doses to the countries of the region, particularly to those participating in the Advanced Market Commitment modality, a financial mechanism within the COVAX initiative that allows

the poorest countries in the world to have access to the vaccine against COVID-19 through donations.

It is essential to strengthen technical assistance to the least favored countries and facilitate the affordability of financial instruments so that they can access vaccines against COVID-19 as quickly as possible. Likewise, multilateral initiatives must be implemented to enable these countries, including SIDS, to cope with the current situation and achieve rapid economic recovery.

We are convinced that the pandemic caused by COVID-19 has highlighted the importance of maintaining a strong, united and supportive region, where no country is excluded from universal, fair, equitable and timely access to medicines, vaccines and medical supplies. Therefore, Mexico joins the call made by the Caribbean Community (CARICOM) to hold a Global Summit, within the framework of the World Health Organization, to address the urgency of having equitable access to this vaccine.

Early childhood educators access training in distance learning through CARICOM, UNESCO, UWI – Open Campus collaboration Dr. Khan said UNESCO has been supporting

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Friday, 19 March 2021) - Teachers and educators in early childhood education from across the Caribbean Community (CARICOM) are involved in a four-week training workshop to improve their capacity to deliver high quality distance learning experiences for young children.

The workshop commenced on Wednesday March 17, through a partnership among the United Nations Educational, Scientific and Cultural Organization (UNESCO), the CARICOM Secretariat and the Caribbean Child Development Centre (CCDC) of The University of the West Indies (UWI) Open Campus.

Concluding on April 7, the free online workshop explores topics including how to help parents to support their children during home-based learning, expectations for teachers and children, the appropriate timeframe for children's attention span, and how to keep children engaged during online learning.

Speaking during the virtual launch event on Wednesday evening (March 17), Dr. Laurette Bristol, Programme Manager for the Human Development at the CARICOM Secretariat, underscored the importance of high quality early childhood education in individuals' growth and development.

She acknowledged that the education sector's response to the COVID-19 pandemic has placed greater emphasis on the upper levels of basic education, understandably so, because of the need for those students to transition to higher levels of learning.

With this training, she urged the participants to "buy-in to the responsibility to share" the knowledge they will obtain with their colleagues, and to exchange best practices among themselves to "build a strong foundation for quality early childhood education in the Region."

Noting the severe challenges teachers and parents encounter with the technologically enabled learning environment, she said the CARICOM Secretariat is pleased to collaborate with UNESCO and the UWI Open Campus to offer the capacity building opportunity.

In her remarks, Dr. Faryal Khan, Programme Specialist for Education at UNESCO's Cluster Office for the Caribbean, applauded the courage teachers have demonstrated in ensuring continuous leaning for young children, despite the challenges posed by the COVID-19 pandemic. Outlining the widely known impacts of the pandemic on education, she also acknowledged the tests teachers and parents face with applying technology to distance learning.

Dr. Khan said UNESCO has been supporting regional education stakeholders' responses on the principle of Sustainable Development Goal 4, which seeks to ensure inclusive and equitable quality education for all. Part of those efforts included a series of webinars coordinated by UNESCO and the CARICOM Secretariat on COVID-19 Education Response in April 2020. That collaboration saw six webinar sessions discussing safe reopening of schools, gender inclusion, social and emotional skills, and technical and vocational skills and training.

The UNESCO Education Specialist said that Early Childhood Education and Care is a priority area, but attention to it has been inadequate. Fully aware of that fact, she said UNESCO recently organized high level and technical dialogues with advocates to prioritise the sector in the COVID-19 response, and to work towards a global strategy on Early Childhood Education and Care.

Encouraging the participants to immerse themselves in the training, she noted that the facilitators and the materials are "state of the art and high quality."

Speaking at the opening, Head of the Caribbean Child Development Centre and Director of the Consortium for Social Development and Research of The University of the West Indies, Ms. Ceceile Minott said the University is pleased to be associated with the "incredible partnership" with the CARICOM Secretariat and UNESCO.



She said the registration for the workshop was overwhelming and expressed regret that the coordinators had to limit the number to 40 practitioners. In this vein, she stressed the need for the participants to share the knowledge they will gain during the course of the workshop.

Ms. Minott noted that the activity is not a seminar, but a workshop that will be "very participatory."

She assured the participants that they were "in very capable hands" with facilitators who were Early Childhood Development coordinators and teachers. Ms. Minott added that the UWI-Open Campus has developed expertise in distance learning methodologies, which it is pleased to share.

US Senate Confirms Former Union Leader as Next Labor Secretary By Reuters, March 22, 2021

WASHINGTON - The U.S. Senate on Monday confirmed former union leader Marty Walsh, a son of Irish immigrants, as the next labor secretary, boosting U.S. President Joe Biden's efforts to expand workers' protection and delivering a win for the country's organized labor movement.

Walsh's confirmation, by a 68-29 margin on Monday evening, is likely to have a major impact on U.S. workplace laws and regulations, including vigorous enforcement of occupational safety and health rules, overtime payments and proper administration of employee benefit plans.

Walsh, 53, led Boston's Building and Construction Trades Council for

two years before winning the 2013 race for mayor with strong backing from large labor groups. He has also served in the Massachusetts House of Representatives.

Walsh has supported key proposals affecting workers, including a \$15 minimum wage, paid family leave and the PRO Act, a proposal to update labor laws and give workers more ability to organize at work that the House of Representatives passed last year.

Despite the far-reaching impact on employers and businesses, Walsh's nomination has not attracted much controversy.

During his nomination hearing, Walsh spoke about being collaborative, a trait that has won him support from large business groups.

"Throughout my career, I've led by listening, collaborating and building partnerships. That's how, if confirmed, I will lead the Department of Labor," he said.

In a letter to the Senate last week, the U.S. Chamber of Commerce said it supported Walsh's nomination, noting that he "has a reputation as a consensus builder and has displayed a willingness to work with a wide array of constituencies."

Walsh would be the last of Biden's Cabinet secretaries to be confirmed by the Senate, though two other Cabinet-level positions remain to be confirmed.

Donations Pour In for Families of Atlanta Shooting Victims

Shortly after his mother was killed in the Atlanta-area shootings, Randy Park launched a GoFundMe page asking for \$20,000 to pay for funeral expenses. By Sunday, the donations were approaching \$3 million.

With many people seeking a way to support the families of the dead, Park's page and others have offered an outlet for tens of thousands of donors, and the accounts have surpassed their goals only days after they were opened.

"I've never had a good understanding how much money was worth, but every cent of it will be used only in pure necessity," wrote Park, son of Hyun Jung Grant, 51, who was one of the eight people killed in the attacks on massage businesses.

Rani Ban contributed to Park just to show kindness.

"It's important that he knows there are still good people. That's simply it," said Ban, who is from the San Francisco Bay Area.

To date, no central fund been created to aid families of the victims

— a contrast with some other mass shootings where groups were set up to collect and distribute money to those directly affected.

For example, following the 2017 attack on the Las Vegas Strip that killed 58 people that night and at least two others who died later, a nonprofit corporation was formed to pay \$275,000 to the families. The nonprofit stemmed from a GoFundMe account that received more than 90,000 donations.

In 2019, a group of nonprofits organized a relief effort after a gunman opened fire in El Paso, Texas, killing 22 people in an attack that police said targeted Mexicans.

For now, donors to victims of the Atlanta shootings must scour individual GoFundMe accounts.

"We all have to stand up for all the innocent lives that fall victim to such reckless hate," Mallory Spalding wrote on a GoFundMe page set up for Suncha Kim, 69, who was fatally shot in the chest. The page has seen more than \$125,000 in donations in a single day.

"It brings tears to our eyes that you are all standing with us and our beloved halmoni, mother, and wife. Suncha was such a strong, loving presence in all of our lives, and we miss her so much," the family said in a statement posted on the page.

A page for Delaina Yaun has collected more than \$102,000, and one for survivors of Paul Michels has raised more than \$57,000. A page for Yong Yue's family drew more than \$94,000.

The donations will help pay for travel for family members who would otherwise be unable to attend funerals.

Yong Yue's family issued a statement less than 24 hours after creating the GoFundMe page that the money would be used to fly her six grandchildren to the funeral, as well to take care of Yue's "business and home affairs."

The suspect, 21-year-old Robert Aaron Long, is charged with killing

four women at the Atlanta spas and four other people at a massage business about 30 miles (50 kilometers) away in Cherokee County. Seven of the slain were women, and six of them were of Asian descent.

Park's family was the first to launch a GoFundMe page. He explained that he had "no time to grieve" because financial obligations were quickly mounting.

After his page began taking off, others soon followed to raise money for more families.

"To put it bluntly, I can't believe you guys exist. People I will probably never meet, hear nor express my thanks to. This is simply a change in my life," Park wrote to the 70,000 people who had contributed as of Sunday afternoon.

BVI facing Guatemala, St. Vincent in FIFA World Cup qualifier

A Men's national Football squad will become the Territory's first home based international representatives in any sport since the Covid-19 pandemic began, when they face Guatemala on Saturday and St. Vincent and the Grenadines on Tuesday, in the CONCACAF qualifying rounds of the FIFA World Cup, Qatar 2022.

The Territory's 67th and 68th matches since 2000, originally scheduled for the A. O. Shirley Grounds, were rescheduled to Curacao, because of the Covid-19 protocols and quarantine Guatemala would have to face. Home based players departed the territory last Thursday and were joined by nine overseas players to complete the squad.

Assistant Coach Clinton "Tinny" Percival, told Island Sun Sports that based on the Covid situation, they have done fairly well in preparing since January with two weekly training sessions. He said physically, the players are in good shape and they were spending the time leading up to Saturday in camp fine tuning, getting home based players to gel with overseas players, as they have been separated for a while. The focus was on finalizing the unit and finalizing the tactical and technical aspects of the game. The players he noted are in good spirits and looking forward to the games.

"Guatemala is a very good team first and foremost, they are very tactical, but at the end of the day, everybody has strengths and everybody has weaknesses," he noted. "Our thing is to watch as much as possible what they do best and what they do not so good and try to capitalize on what we see we can capitalize on."

Percival said while St. Vincent has more experience than the BVI's young squad, when they go into the square, it's 11 vs 11 and they're asking players to concentrate on their performances.

"As long as their performances are positive and good, we think we have an opportunity of actually doing our best," he said, noting they're a young team going through a process. "We're just hoping they continue to build and get stronger each time we play. The hopes are high and at the end of the day, this is a learning process for us. We are making sure the experience that they gain, will be put to good use going forward."

The BVI, currently ranked 208 of 211 FIFA teams, has never won a FIFA World Cup qualifying match since they began participating in the qualifications in 2000. Their best showing was in the 2010 qualifier, when they drew with the Bahamas 3-3 on aggregate, where both games were played. They lost the away leg 2-1 and drew the home leg 2-2.

Percival said they're playing some very good teams and it's about making sure they have a very positive attitude and that positive attitude can only transcend into positive results.

"Yes, we're looking for positive results and that positive result can only come playing as a unit," he noted. "And whatever we do, we can increase on, as we go on game after game because it's a process. It's a young team, and I do believe years to come, we're going to have a very positive and

upcoming team. We're hoping that these guys can turn out to be the role models for the younger players that are coming. We're not trying to put pressure on them about winning right now, it's about progressing and trying to improve on their skills and having the experience to play against teams at this level on a constant basis."

Percival added: "The foundation we're trying to build now, is what's needed to be done right, continue to be done right, for the standard that they set now, will be the foundation for the youths coming."

BVI 66 match record since 2000 World Cup qualifier

Over the last three years, the team has been on the verge of victory late in games, but have been unable to finish. In their last 28 games since 2008, the BVI has posted a 2-25-1 mark. They beat Anguilla 2-1 in a 2010 friendly, for their first victory since beating Bermuda, 2-0 in 2004. They posted their last victory during a 2018 friendly with St. Maarten, whom they beat 3-2. Their worst defeat over the stretch has been a 17-0 demolition at the hands of the Dominican Republic in 2010 and Montserrat ended a 17-year losing streak by shutting down the BVI, 7-0, in 2012.

The BVI has been outscored 129-14 in their 28 matches and have been unable to penetrate their opponent's defense for a score, in 19 of those 28 games. Overall, the BVI has played in 66 matches since 2000 and posted 11 wins, 44 losses and 11 draws including friendlies. Minus friendlies, they're 2-32-7.

With 10 U20 players on this squad however, they have been assembled with hopes of changing the territory's future fortunes.

The BVI will face St. Vincent and the Grenadines on Tuesday, in their first matchup since 2014 when they lost 6-0.



Haiti needs vigilance by the **International Community**

Organization of American States (OAS) on March

17, I said that "no resolution is perfect, and no resolution satisfies every country, but we cannot sacrifice achieving good on the altar of desiring perfection".

The resolution concerned the current constitutional, political and humanitarian situation in Haiti which is very grave and shows every sign of worsening. The delegation of Antigua and Barbuda was

the architect of the original resolution which sought to cause the member states of the OAS to express concern about Haiti and to offer to facilitate a meaningful dialogue between President Jovenel Moïse and all other stakeholders.

It was a matter of regret that, despite the strong statement of CARICOM Heads of Government, concerning Haiti, on February 11, CARICOM delegations at the OAS were again divided. CARICOM Heads were clear that they wanted "all parties in Haiti to engage in meaningful dialogue in the interest of peace and stability". The Heads also said that they looked forward "to the conduct of free and fair Presidential elections in accordance with the Constitution of Haiti". Eight CARICOM countries - Barbados, Belize, Grenada, Guyana, St Kitts-Nevis, St Lucia, Suriname and Trinidad and Tobago backed Antigua and Barbuda's draft resolution.

In the end, through a process of two weeks of negotiations, countries with important concerns about Haiti - Brazil, Canada, Chile, the Dominican Republic, and the United States joined the nine Caribbean countries in settling a draft resolution that was then negotiated with the Haitian delegation.

By the nature of negotiations, concessions had to be made. Hence, it was not a perfect resolution and not every paragraph of it satisfied everyone. But it was enough to allow the Permanent Council of the OAS to adopt it by consensus.

Essentially, it offered "good offices of the OAS, under the authority of the Permanent Council, to facilitate a dialogue that would lead to free and fair elections" and asked the President of Haiti "to consider inviting the Permanent Council to do so".

This was done against a background that since January 2020, there has been no legislature and no government in Haiti, and President Moïse has been ruling by decree. Further, marauding gangs have been raping women, including young girls, kidnapping people (rich and poor) and demanding huge ransoms. Violence has exploded in the country, particularly as hundreds of thousands of people have been protesting against President Moïse and deadly force has been used against them by a police force that is allegedly highly politicised.

The UN High Commission for Human Rights has stated its "concerns about judicial independence" which it says "has further eroded the separation of powers" in Haiti.

Time is fast running out to avoid further worsening of the situation in Haiti. The OAS resolution, offering to facilitate dialogue, has come only after deep polarization and distrust in the

country. The OAS should have acted much earlier. If President Moïse does not respond positively At a meeting of the Permanent Council of the and swiftly to the offer by the OAS, no dialogue between the stakeholders might be possible. A

> stand-off between them will occur with further confrontations. Many Haitians have already stated publicly that "no dialogue is possible with Moïse", and he has not sought a meaningful dialogue either.

> Instead, he is persisting with plans to hold a referendum in June on altering the Constitution. But there has been no

consultation with major Haitian players who say he has no authority to hold such a referendum. What is clear is that, in 2015, Haiti had more than 6.5 million people registered to vote. Moïse has now issued new identity cards which his OAS Ambassador says has been distributed to 4 million people. Human rights groups in Haiti dispute that figure, putting it closer to 2 million. Either way more than 2.5 million persons are currently disenfranchised. No referendum or election held in these conditions would be credible or acceptable.

Still worse, the current Provisional Electoral Council, to manage a referendum and elections, comprises persons appointed solely by Moïse. They are known to have close links to him. Similarly, the draft Constitution has been written by persons he has hand-picked. None of this is "in accordance with the Constitution of Haiti", and, for the opposition parties, are red rags to a bull.

On March 29, Haiti will mark the anniversary of its 1987 Constitution the very thing that the President is seeking to alter. Stakeholders are pledging to put more than 2 million people on the streets in its defence on March 28 and 29.

The Charter of the OAS strictly forbids interference in the internal affairs of States. And, while there have been various artifices by some OAS member states to circumvent that prohibition, the majority of countries adhere to that principle generally. Consequently, the OAS cannot insist that President Moïse accepts its offer to play a good offices role. It must await an invitation from him to do so.

In this context, member states of the Organization should work behind the scenes with Moïse and other stakeholders to urge them to talk and, in so doing, to take the idea of a referendum on the Constitution off anyone's agenda; to ensure that independent election machinery is established by agreement of all parties and that Presidential, legislative and local elections are held at the earliest possible date, and until then Presidential decrees should be suspended on anything except that on which major players decide.

While this diplomatic work takes place - and CARICOM should be a part of it - the OAS should continue to be vigilant about developments in Haiti and ready to speak out against any further deterioration in the constitutional, political and humanitarian situation.

The people of Haiti need and deserve objective and constructive support in their collective interest, and not for the benefit of any political elite.

Why learn a
Foreign Language?
During the last twenty years, the British Virgin Islands has

strengthened its rapport with regional organisations such as Caricom and OECS, and our business relations with large islands such as Puerto Rico and the Dominican Republic have reached new heights.

Our economy is heavily dependent on tourism and the offshore financial sector. Both of these sectors are bringing to our shores an ever-increasing number of non-English-speaking people who come here as tourists, investors, employees, and employers.

BVI veterans who have been in business for many decades have become convinced that our new generations will be put at a great disadvantage if they do not learn a second and possibly a third language. The BVI needs more language teachers who will not just teach basic rudiments but will bring our students to conversational and business fluency levels.

Our trade and business relations with two very large Spanishspeaking islands such as Puerto Rico and the Dominican Republic as well as the increasing presence of Panamanian companies in the BVI financial offshore sector are clear indicators that our school system must place greater emphasis on teaching Spanish to our students. We would be tempted to say that even at the College level, Spanish should be mandatory in the BVI, irrespective of the course one plans to follow.

The political barriers that circumvent free exchange with Cuba will be shattered in the not too distant future and we can already see that at a regional level Spanish will become as essential as English. Additionally, the growing hemispheric prominence of Brazil is something we cannot overlook. We can attract tourism, investors, and business from Brazil.

Learning a foreign language draws one's focus to grammar, conjugations, and sentence structure. This makes the learner more aware of language, and the ways it can be structured and manipulated. These skills will translate into effective communication. And there are many personal benefits at all levels. A foreign language gives us access to other cultures, and our lives take on a new dimension. In today's global village we are aware of the basic advantages of learning a foreign language for college students and young job seekers.

Among the less obvious benefits of learning a foreign language is the change in perspective bilingual persons will gain from seeing the world through new eyes. As a result, a bilingual person is more dynamic and his/her problem-solving abilities are enhanced through the benefits of learning a foreign language.

The BVI Government, local education authorities, and schools must give language learning a firm place in school life and enable as many students as possible to benefit from the opportunities it creates.

Register Of Interests Act Amended To Support Transparency

The Government of the Virgin Islands continues to bring forward and support major change to legislation in the spirit of cooperation, good governance, and transparency and in the best interest of the Territory.

New legislation was passed on Friday, March 12 which amends the Register of Interests Act 2006 that now allows the Commission of Inquiry (COI) to review the Register directly. This amendment brought forward by the Government, passed by the House of Assembly and having received Assent from the Governor, means that the Register of Members' interests can now be directly shared with the COI.

Following the launch of the COI on January 19, 2021, the Government of the Virgin Islands recognised the importance of granting access to the Commissioner in order to share information legally and quickly.

Until now, the Register of

Interests of Members of the House of Assembly could only be shared in certain circumstances, namely in criminal investigations, legal proceedings or on written request by a Member.

Under this framework, the COI could not access the Register. It is in the spirit of cooperation and transparency that the Government of the Virgin Islands has acted decisively to amend the legislation, while maintaining the laws and interests of the Virgin Islands.

Commenting on the change in legislation, Premier and Minister of Finance, Honourable Andrew A. Fahie, said, "The Government of the Virgin Islands has acted decisively to change the legislation and provide access for the COI to the Members' Register Interests. Through this action, alongside the creation of the IRU, we have put in place a structure to foster cooperation and

transparency with the COI and we will continue to act collaboratively in order to facilitate the Inquiry."

This change in legislation is an important step in providing the Commission with the relevant information and follows on from the creation of the Inquiry Response Unit (IRU), announced on February 5, 2021.

The IRU has been set up to facilitate and co-ordinate the Government's engagement with the Commission of Inquiry. The IRU is independently led by Sir Geoffrey Cox QC and is administered by law firm Withers.

The IRU reports to the Honourable Attorney General, supporting the Attorney General's Chambers ensuring that information is provided to the Inquiry in a systematic, efficient and wellorganised way, which is both auditable and accountable. The IRU will also assist ministers and public officers to understand their duties in relation to the inquiry.

Silicon Valley's Eon Reality gives US\$25 mil to The UWI Open Campus for global online strategy



Adeline Elizabeth Leonard Departed this life

A celebration of life service for the late Adeline Elizabeth Leonard who died on 11 February was held at the Road Town Methodist Church on 12 March.

The late Adeline Elizabeth Leonard was born on 26 December, 1929. She was the first of what would be nine children to come from the union of Cynthelia Thomas and Henrique Creque, on the island of Tortola. The family lived on Main Street in a house that was just up the street from where her mother ran a guesthouse called the Social Inn. As a child Adeline was looked up to and admired by her siblings who affectionately called her 'Tikka'.

After completing her primary education, Adeline entered the then Virgin Islands Senior School -- the first high school in the BVI. In fact, she was in the class of the first attendees and graduates of the school. Thomas Green, the first Principal and Supervisor of Education in the BVI, opened the school in 1943 and was instrumental in advancing Adeline's teaching aspirations. Upon completing the Senior School, she immediately started teaching, and so excelled in the profession that she was selected to attend Spring Gardens College in Antigua from 1948-1950, a prestigious teaching institution at the time. She returned and continued teaching several years. Her many, many pupils today still respect and recall her fondly as 'Teacher Adeline'.

During those years as a teacher, Adeline directed and staged several English plays that would be the highlight of that social year. She would persuade members of the community to act as characters in the play including McWelling Todman and her sister Cinty and even play a part herself. One production she often recalled with delight was the staging of HMS Pinafore.

Adeline eventually met her husband, Edwin Leonard, who was a pupil teacher at the time. They were married on December 18, 1953, and later moved to St. Thomas. In the St Thomas Edwin worked at Bluebeard's Castle Hotel, and Adeline taught for a short time at the St. Peter and Paul Catholic School.

The couple decided to continue moving onward to New York where Edwin worked as a carpenter/ builder, and Adeline worked as an office administer at Roosevelt Hospital. It was there that her two children were born, Robert and Diane. Having the children grow up and be schooled in the big city did not appeal to her, so in 1965, she moved back to St. Thomas. Edwin stayed in New York to finish a contract, and then followed her.

Upon her return, Adeline sought employment with the U.S. Virgin Islands Government at the Department of Commerce as an accountant where she became known for her accounting meticulous practices. She and her husband bought their first home in Tutu Estate and joined the Wesley Methodist Church where they were loyal and dedicated members. Along with teaching Sunday school, she became one of the founding members of an all-female singing group, The United Sisters. The United Sisters and the Wesley Brothers, of which her husband was a member, combined to host concerts with plays she directed that were taken to Tortola during Easter and August celebrations and as far down the island chain as St. Kitts.

After her retirement in 1990, Adeline moved back to Tortola with Edwin to live on the hills of Todman's Estate where he grew up. She continued to live there after her husband's passing in 2002, and did not leave until her home was destroyed in the hurricanes of Irma and Maria in 2017.

To all her friends, family, pretty much anyone who met her, Adeline was gracious, warm and kind to all with a smile that was infectious and welcoming. She was small

in stature, but with a heart of gold.

The Late Adeline Elizabeth Leonard is survived by her: Son - Robert Leonard. Daughter - Diane Leonard-Drayton; Grandchildren Tishan Solomon, Chelsea Solomon, and Terrence Leonard; Great Grandson - Micah Kendall; Brothers -Egbert Creque, Milton Creque and Gene Creque; Sisters - Audrey Todman, Hyacinth Amaro, Ivy Vessup, Annetta Amaro, and the late Lillian Romney; as well as many other relatives and friends too numerous to mention.

I believe that this is important because it can be the most good for your body and contain more nutrients and vitamins than most supermarket produce. I like to source food from my fortnightly farmers market in town, which sells amazing meat and dairy produce and fresh in season fruit and vegetables. This is another important thing to remember, that eating fruit and vegetables in their season means that they will taste better as well as doing you good. I have a lot of influence from Western European cuisine (mainly France and Italy) as you will tell, but I do not profess to be a chef and everything is easy to make and very convenient. 1. Cut back or snacks and ther change the type o snacks you eat.

great diabetes care. The types of snacks to be eating are unsalted nuts dried unsweetened fruit, fresh fruit, fresh vegetables (I love fresh red pep per and cucumber), dark chocolate (richer and nicer and you only want a squares usually).

2. Cut back on white flour and embrace wholemeal carbs.

This is the most essential part of your diet, and the thing that can show the biggest increase in loss of weight. Some diets in fact jsut focus or this point, and are very successful. Wholemeal (especially stoneground wholemeal) is so good for you and has so much more flavour in it that switching is much easier than you think. Most people are really surprised at the ranges you can get in you supermarket, again remember that the bread that is best for you is the one that is freshest with least perservative or added ingredients. Also, brown or basmati rice is great with a lovely nutty texture. Wholemeal pasta is great and for your potatoes I would totally recommend the smaller new potatoes.

3. Stop drinking cocktails, start drinking wine.

Cocktails are full of sugar, colourants and preservatives. As a studen I have had loads of practice at going out and not drinking cocktails, so my drink of choice is Malibu and Diet Coke if I feel I have to drinl something and I make it last all night. I can then top up with Diet Coke (which has almost no sugar in it) and it looks as though I am drinking Malibu, who is to know. If you are out at a restaurant, red wine is much better than anything else you can order, (except water of course!) and i has been proven that the anti-oxidants in red wine are great for keeping a healthy heart. The recommended amount is one glass a day with you evening meal.

4. Start cooking more fruit and vegetables.

Fresh fruit and vegetables are a great way to get all the vitamins and minerals you need. And there are so many different ways in which to cool vegetables, but I find that raw is the best followed closely by steamed Both of these ways preserve all their natural goodness as well. 5. Drink more water.

A few tips on how to ge more water into your day are firstly to put bottles of water at all the place you go in the house or work. So keep one in your desk, on your desk, a glass in the kitchen, the bedroom, the sitting room, etc. Try and drink al these glasses up and you will be well on your way to 8 glasses a day. 



Why Such Frequent Bathroom Visits?

DEAR DR. ROACH: I'm a 91-year-old male who makes frequent visits to the bathroom to urinate. I am in good health and I wonder what causes this. Where does all that liquid come from? -A.R.N.

ANSWER: What goes in must come out. All the liquid you urinate came from fluid you consumed when drinking and eating food.

But it may be more about perception than volume. Frequent urination is extremely common in both men and women, and although some causes are the same, such as an overactive bladder, men have an additional anatomical structure that can lead to urinary problems as they get older: the prostate, a normally walnut-sized gland that may increase in size as men age. It is through the prostate that the urethra, and thus all the urine, has to flow. If the prostate is enlarged, the urinary flow slows down.

As the prostate obstruction becomes worse, men may have trouble emptying the bladder completely. This has the effect of making men go to bathroom more frequently, since the bladder has less functional size. In this case, you aren't urinating any more volume than before, just more often in smaller amounts.

Treatment needs to be directed at the underlying cause. Overactive bladder and enlarged prostate have similar symptoms and different treatments.

It is possible that you really are having excess volume, however. Diabetes is the biggest concern here, and you should be tested if you have truly large volumes of urine.

DEAR DR. ROACH: I read an article about a study the Mayo Clinic did using 20 mg tablets of sildenafil for pulmonary arterial hypertension and that it improved walking distance by 75%. Is there an upper age limit for a person using this medication for pulmonary hypertension? - D.L.

ANSWER: Pulmonary hypertension is different from regular or systemic high blood pressure. It's not the kind that is measured with a blood pressure cuff.

In pulmonary hypertension, the elevated pressures are inside the lungs. There are five general classes of pulmonary hypertension, and people must undergo extensive diagnostic testing to determine which subclass they have. The goal is to find a cause that has a specific treatment. For example, subclass 2 is pulmonary hypertension due to heart disease of the left side of the heart, such as heart failure or valvular heart disease. Treating those can make the pulmonary hypertension better.

However, many people do not have a treatable underlying cause that can be identified, so doctors rely on general treatments to improve symptoms. One such is sildenafil, which is called Revatio when used for pulmonary hypertension, but it is the same drug as Viagra. It prolongs the effect of nitric oxide, a chemical in the blood that relaxes blood vessels in the lungs and reduces pressure. Sildenafil, like other drugs in the same class, significantly improved the distance a person could walk in six minutes. The 75% increase you noted is higher than most studies showed however.

The study included subjects up to 81 years old. I do not think age alone would be a reason not to use these kinds of medications. These medicines should not be used in people taking nitrates (such as nitroglycerine) or those with very low systemic blood pressure.





With the same level as the sous chef, the pastry chef is in-charge of the pastry section of the restaurant. Under these chefs would be the line cooks who are the ones who actually cook the food. The line cooks are divided according to certain cooking specialty. Another key member of the kitchen is the Chef de Garde Manger who manages the cold food section that includes the salads and desserts.

If you have watched an episode of the t.v. cooking show, Iron chef, you would probably know how stressful it is to work as a chef or a line cook. In that show, the cameras usually show the stress and anxiety in the chef's faces as they try to prepare a certain number of meals under time pressure.

Anxiety is also seen on the chef's faces when the judges are tasting their dishes. In another popular reality-base television show called Hell's Kitchen, several people enter as contestants in a game that is supposed to select the next "big chef" in town. Being a reality show, Hell's Kitchen often shows the stress and anxiety on the faces of the contestants while the host shouts and gets mad at them for not doing certain things right in the kitchen.

Anxiety grips each contestant as they try to battle out to win the throne of being the next best chef.
