UNEMPLOYED WORKERS DILEMMA CONTINUES

While employees who have been unemployed since March are disappointed that the government has extended the layoff period to early next year, Minister for Natural Resources, Labour and Immigration Hon. Vincent Wheatley is certain that it was the best decision Government could have made at this time.

Following the Coronavirusspurred shutdown, many businesses were forced to send their staff home and close their doors. Some of these businesses remained closed even after the curfew and lockdown thereby causing their staff to be unemployed. The situation compounded because under the Labour Code these businesses had three months to decide to either sever or rehire. Unfortunately, Tourism businesses were unable to make a decision and called to the government for assistance with the dilemma. In response, Government intervened by extending the three months to 31 October and later reextending to 31 January.

In an update on the situation, Minister for Natural Resources Labour and Immigration Hon. Vincent Wheatley in a JTV interview on 16 November explained that he is aware of how the extension would affect some employees but noted that it was a decision government had to make: "We found that many businesses had not made a penny since March. The guestion then became where would these businesses get the money from to sever their employees who have been there 15, 16, 17 years. This could amount to hundreds of thousands of dollars that the companies or businesses simply do not have."

"If we had insisted on that 31 October cut off period we were guaranteeing certain businesses would never survive in the BVI His Excellency the Governor, Mr. Augustus J. U. again. It was a guaranteed death sentence for too many businesses. So the concern then became how do you keep an employee holding

on so long without work," the Minister further explained.

Hon. Wheatley said that the Government relied on the figures to determine a suitable solution and made a choice after noting that there was not an overwhelming number of laid-off employees. "Our research shows that there weren't too many employees who actually didn't work, very few employees did not find alternative work: I will admit that some were illegal. It's a give and take and we kind of turned a blind eye temporarily and give the businesses a fighting chance until they get their stimulus checks, until they can begin to make some money."

Despite the rationale, some employees who are laid off are saving that government doomed them to a dreary Christmas with no employment and no money. Nonetheless, the Minister assured that the decision to extend was the right move. "I met with the businesses, I met with their employees, I heard both sides. I understand the plight of both sides but we have to make a decision. It was a very difficult decision to make, but we had to make a decision".

The weeks before the extension was provided many of the affected businesses hurried to act to save themselves from large severance payout. It was explained that out of fear of having to pay large severances some businesses rushed to rehire their staff even though they had no business coming in. These companies were lauded by the Minister who said, "I really want to thank those businesses who are good

business who try their best to package, you don't have investment of that person's do good by their employees."

On the other hand, the Hon. Wheatley pointed out that some employers opted to make a bad situation worst. "There are some bad businesses who just don't intend to do good by their employees. I've seen some businesses when they heard 31 October they employed their employees for one day a week. What are you going to do with one day a week. If you have the money to sever them then sever them, but don't play with the employees. These are people with families and bills to pay."

"If companies can afford to sever the employees, please do so; don't be dragging them along. I know some companies genuinely cannot pay, but I am asking those who can pay - just pay. Work out a payment

to pay them all the money one time...pay something so that the employees can move on with their lives...To have persons in limbo for six months seven months I think it is unfair. Those companies who can do better please I am asking you - do better," the Minister added.

It was explained that some employers are giving their laid-off workers false hope that they are ready to reopen and have been avoiding providing severance letters. It was opined that the businesses are doing this as a frustration tactic: "Some persons want them to just resign and leave the benefits behind. That's very difficult to do. If you invested 20 years of your life to a business and you are due a certain severance you don't want to walk away from it. It is an

life... To ask them to just walk away and go I think it is very unfair," Hon. Wheatley explained.

"Some of those persons who were laid off and are waiting...they have their bills to pay. Have their children to send to school. They have their light bills, they have mortgages and rent. Life still goes on for those persons. To have them just there dragging along is challenging them," the Labour Minister further explained.

According to the most recent figures, of the 14013 businesses registered in the Territory, 12018 are operational at the moment. It was mentioned that 195 businesses are still not operating and 1,354 employees have been laid off.

Renewable Energy Plans Are On Track

Actions and works to start the from dependence on fossil Territory's touted transition to renewable energy are expected to take place in 2021. According to Premier and Minister for Finance Hon. Andrew Fahie the BVI Electricity Corporation is currently looking at several projects that will support this transition in various areas of the Territory.

The proposals and projects were mentioned during the presentation of the 2021 budget estimates on 12 November, During that presentation Hon. Fahie reminded of the Territory's pledge to make the transition

fuel to renewable energy and also mentioned some of the work that has already started.

While noting that BVIEC has been working diligently towards the Territory's transition to diversify energy production by utilizing renewable energy Hon. Fahie mentioned that the most significant of this occurred in June this year. "On 4 June 2020, BVIEC awarded the Anegada Hybrid Renewable **Energy and Battery Energy** Storage System Project to Power52 Clean Energy Access, LLC."

The Premier noted that the proposal to explore the project is expected to be completed during the third guarter of 2021, and is projected to reduce the current volume of fossil fuel used to produce electricity on that Sister Island by 95 per cent. "This would surpass the Government's target of reducing fossil-fuel based generation by 80 per cent in Anegada by 2021. The system will comprise of one (1) MegaWatt of solar PV panels and 4,078 kilowatthours of Battery Energy Storage," the Premier noted.

Among the plans

three potential solar plant locations. In fact, it was disclosed that exploration along this line recently started. In sharing the news the BVI Leader said: "The BVIEC is similarly in the infancy of conducting feasibility assessments with respect to exploring the renewable energy potential for utility-scale solar PV generation and penetration on the national transmission grid infrastructure in Paraquita Bay, Tortola, and Virgin Gorda."

It was also divulged Hon. Fahie mentioned is that BVIEC is assessing the viability and feasibility of two proposals submitted by private developers wishing to construct solar PV farms in the Cox Heath area. The Premier further noted that one of these developers is awaiting a revised Green Energy Licence to be issued by the Government to progress the development of their project.

Overall Hon. Fahie pointed out that the completion of all these projects will ensure the Government's target of having 30 per cent of electricity production from renewable energy sources by 2023.

Christmas In The City To Cheer BVI Community

The annual Road Town holiday street event originally known as Christmas on Main Street is once again getting a name change. The grand event is changing its name from Christmas on de Castro Street to Christmas in the City and residents are assured that the 4 to 6 December event will be exciting.

The major change was announced by City Manager Janice Brathwaite-Edwards who explained that the move was caused mainly by the new traffic turnaround that occurred some months ago.

The City Manager said that the move was necessary because it did not seem feasible considering how the traffic currently flows to shut down de Castro Street for three days. It was noted that the shutdown would have

required traffic to be redirected to Main Street and officials observed that this would have been difficult to manage logistically.

Therefore, Brathwaite-Edwards said that an alternative location was found. "We have kindly asked the Minister of Transportation Works and Utilities to grant us permission to use the Central Administration Parking Lot to have what was titled Christmas in the City 2020 this year. We are actually going to be utilising the two front lots."

In addition to the name and location change, Braithwaite-Edwards said that the event will also undergo some tweaking. The event will be allotting more space to vendors in an attempt to try to help more local businesses. "It's going to take on the view that

we have the Christmas in the City participants on one side and we are trying to encourage the corporate side of the business community to come out and show their wares because we know that during COVID people lost a lot of business and we are encouraging them to do and have more business opportunities during the holiday season," Braithwaite-Edwards explained during a television interview.

This year young entrepreneurs will be promoted at the event as part of the City Manager's attempt to promote enterprises that belong to children and young adults. "This year we are extending to what we call young entrepreneurs, young people who are doing business of all sorts. We are going to try to showcase them this year so we are asking people who have their lemonade stands,

their bows stands to come out and showcase their wares because Christmas is coming, we cannot go off-island like we would like to so we are asking you to buy locally," the City Manager explained.

Sadly children who annually look forward to Santa's visit to the event would be disappointed to hear that there won't be such a visit this year. However, the City Manager said that fun activities are scheduled instead.

For this year's event the City Manager also mentioned that there is going to be a special tribute to the late Hon. Delores Christopher, who was a founding member of the annual festive event. This tribute will take the form of a lantern release activity. "We are going to let some biodegradable lanterns fly in her honour because we cannot leave her behind even though she's gone on because her legacy will still live on," the City Manager said.

Honourable de Castro Leads Delegation To Ministerial Conference

Junior Minister for Tourism Honourable Sharie B. de Castro is leading a delegation at the Seventh Ministerial Conference on the Information Society in Latin America and the Caribbean from November 23 to 26.

Honourable De Castro is leading the delegation to the three-day virtual conference on behalf of Premier and Minister of Finance Honourable Andrew A. Fahie.

In an address at yesterday's opening ceremony, Honourable de Castro explained that in March 2020, when the Territory, confirmed its first cases of COVID-19, the Government had to develop an immediate response to prevent community spread. She said further consideration was given to the economic impact of the measures taken to prevent the disease from spreading.

The Junior Minister said that it became evident that a post-COVID-19 environment would necessitate the digital transformation of Government and the Territory, a top priority on the Government's agenda.

"For the Virgin Islands, we recognise that digital transformation must go farther, than e-services; it must enable the collection of relevant and timely data that can be used for management and policy decisions. It must be people-centred in order to genuinely impact the lives of the people of the Virgin Islands for the better," Honourable de Castro stated.

She further added, "Therefore, the transition into e-Government will be accelerated so that we can enhance

the services available online: e-billing, online payment and online bookings and eCommerce."

The Junior Minister said looking at digital transformation of Government means going beyond the initial work undertaken to consolidate public-facing websites and developing some online service delivery. She said for the Virgin Islands, it means focusing on:

Enabling automation of our operations, yielding operational efficiencies, such as reduction of transaction costs, with an impact on productivity.

Enhancing the delivery of public services and the experience by ensuring they are customer-focused

Improving the way our citizens, residents, businesses and tourists interact with Government, and, access to information whilst promoting transparency, accountability and giving our people a voice

Impacting human relationships and behaviour by facilitating social inclusion and communication and

Ensuring the digital space is accessible, safe and secure for everyone.

Honourable de Castro said the areas of focus will support the Territory's economic and social development even in the absence of the National Sustainable Development Plan (NSDP), which is currently being developed under the leadership of the Premier's Office.

She said as the Government of the Virgin Islands continues to move forward in this New Regular living and working with COVID-19, its vision is to transform the Territory into a leading regional economy through innovation, entrepreneurship and local and foreign investment by 2025.

The Junior Minister further explained that the vision for the Digital Transformation of the Territory is being led by the Premier's Office. She said and that the digital transformation of Government aligns with the vision for the transformation of the Territory and mirrors the wider Public Service Transformation Programme vision of delivering the digitalisation of Government ensuring it is respected, trusted, and efficient, and, puts people at the centre.

The virtual conference was organised by the United Nations Economic Commission for Latin America and the Caribbean (ECLAC) and the Government of Ecuador. Countries represented include Colombia, Ecuador, Brazil, Costa Rica, Paraguay, Trinidad and Tobago, Chile, Peru, Barbados, Uruguay, among others.

The leaders are analysing the role of digital technologies in light of the COVID-19 pandemic and are debating the policy priorities on digital matters and defining a new digital agenda.

The high-level discussions include digital technologies in recovery; universalisation of digital technologies for social inclusion; policy coherence and digital integration in

Latin America and the Caribbean; productive transformation and skills in the digital age.

Other areas to be discussed include the potential of digital technologies for changing the dynamics of production in SMEs; data innovation for measuring the digital economy; the rise of e-commerce amid the pandemic and future challenges; Latin American Economic Outlook 2020: digital transformation for building back better; and, women's autonomy in the digital economy.

The other members of the local delegation include Senior Policy Analyst Lizette George, Director of Information Technology Mrs. Annabelle Skelton-Malone and Director of Communications Arliene T. Penn.

Graduates Urged To Start Businesses With Skills From Vocational

Programme

Minister for Education, Culture, Youth Affairs, Fisheries and Agriculture, Dr. the Honourable Natalio D. Wheatley has encouraged graduates of the Caribbean Vocational Qualification (CVQ) programme to start their own businesses with the skills they have acquired.

In his address to the graduates of the second and third cohort of students from the Virgin Islands School of Technical Studies (VISTS), Honourable Wheatley said technical vocational studies is at the forefront of the future of the Territory's economy.

"In the past, it would be common place for persons such as yourselves just to go to the Government and say 'I want a job' and sometimes persons got jobs regardless of qualifications. That is not the situation today. The Premier and Minister of Finance is telling you that we cannot employ more persons at this time. That's why I am here to encourage the young people to start thinking about opening their own businesses."

Principal, Mr. Andrew Francis told the students that the stigma of technical vocational studies should have no merit today and that they are the change makers that will be going into the work force because they will be competent to do so.

"This certificate states that you qualified, you are competent and you will be able to fit right into the world of work," he said, adding, "It is a global certificate, so once you leave the shores of the BVI you will be able to present this certificate to say that I am competent as an Automotive Technician, I am competent as a Cosmetologist, I am competent as a Commercial Food Chef or Bartender."

Mr. Francis said students have moved on from the institution into tertiary institutions in the United States because of the foundation they received from the school, "No matter where you go, Technical Vocational Studies is the drive of the economic growth," he said.

The Caribbean Vocational Qualification (CVQ) is administered by the Caribbean Examination Council and the Virgin Islands School of Technical

Deed Of Contribtution Signed To Enhance RVIPF Marine Base

The Marine Base of the Royal Virgin Islands Police Force is expected to be transformed to a 24/7 operation that is bigger, better and able to weather any storm on the completion of the \$2,010,000 million-dollar project.

ADeed of Contribution from the United Kingdom Government

to the Virgin Islands Recovery and Development Agency was signed on November 19 in the amount of \$450,000 to commence works on the project. These funds will complement the Government of the Virgin Islands contribution towards by \$0.4M.

His Excellency the Governor Augustus J. U. Jaspert signed the grant on behalf of the United Kingdom Government stating that, "we must protect those who protect us, particularly the brave men and women of the Police Force, Immigration and Customs."

He shared that the funds will strengthen their legacy and build capacity for a stronger BVI and that security must be strengthened as a bedrock for its success.

Governor Jaspert said, "This project will transform the

Works to be undertaken include site clearance, removal of derelict boats and vehicles, securing of the perimeter, renovation of the main building with adequate office and dormitory space for staff and safe storage of weapons, workshop, dockage and boat storage.



Peter Haycraft Honoured With Order Of The British Empire

Businessman and Philanthropist Mr. Peter Haycraft was awarded the Order of the British Empire from Her Majesty the Queen for his services to the British Virgin Islands at an Investiture Ceremony today.

Mr. Haycraft migrated to the British Virgin Islands in 1959 to run a ferry service between Tortola and St. Thomas, and has since made significant contributions to the BVI community. He has served as Commodore of the Royal BVI Yacht Club on thirteen occasions and was one of the original organisers of the BVI

Spring Regatta – now recognised today as one of the Caribbean's leading sailing events. He has grown and developed the business environment in the BVI.

Following the 2017 hurricanes, Mr. Haycraft contributed substantial funds to rebuild Enis Adams Primary School (where his wife Mrs. Penny Haycraft has worked as a teacher) into a state-of-the-art educational facility. He continues to make contributions to many worthy causes in the Territory.

His Excellency the Governor Augustus J. U. Jaspert said, "For the past 60 years the name Peter Haycraft has become synonymous with entrepreneurship, innovation and community support. I am very pleased to see Mr. Haycraft honoured with an OBE for his philanthropic work."

The Governor also spoke about Mr. Haycraft's personal resilience in the face of challenge and added that, "with every great opportunity comes great responsibility."

In his response, Mr. Haycraft extended gratitude to supporters near and far, especially his wife Penny, son Chris, and daughters living overseas Susan and Julie. He also extended particular thanks to





WEST END TERMINAL **PROJECT TO TAKE OFF IN 2021**

The West End Ferry terminal project will be moving forward in 2021, Premier, Minister for Finance and First District Representative Hon. Andrew Fahie announced during the 12 November budget presentation.


The project which is located in the First District has been a source of complaints for many years and was a campaign promise of the Premier. Therefore, it was expected that the Premier would provide an update on the subject.

In fact, the Premier said: "We will continue work on the West End Ferry Terminal to develop a modern, technologically driven entry port facility to accommodate over 200,000 passengers per year and to provide an entry port that is resilient and which follows international safety and smart standards while providing opportunities for the people of the Territory."

The situation of the West End Ferry Dock has been lingering for many years with plans for many budgets of the past. Unfortunately, the situation was exasperated when two category five hurricanes struck the Territory in 2017. The damages sustained as a result of the passage of hurricanes Irma and Maria caused the essential infrastructure to be closed for two years. It was finally reopened on 1 August 2019.

During the two year closure, the First District suffered a major drawback. He further noted that the ferry dock is a major infrastructure of the West End district because many residents depend on the facility for their livelihood.

Just after taking office, the Premier bemoaned that the port was losing revenue and people in the First District were being affected by the closure. At that meeting Hon. Fahie noted the significance of the Port and the inconvenience the closure caused stating: "To have the major port some 19 months after Irma still not open to traffic of ferries coming from either abroad, St Thomas etc is not good and some of the working environment I have seen the Treasury staff, the Customs and Immigration over the last few months and years it concerns me. Now I know that you are coming out of a storm, so I was patient for a few months and I tolerated it but now it's time to get it looked at," Hon. Fahie declared.

PHILADELPHIA (AP) - As they frantically searched for ways to salvage President Donald Trump's failed reelection bid, his campaign pursued a dizzying game of legal hopscotch across six states that centered on the biggest prize of all: Pennsylvania.

The strategy may have played well in front of television cameras and on talk radio. But it has proved a disaster in court, where judges uniformly rejected their claims of vote fraud and found the campaign's legal work amateurish.

It was led by Rudy Giuliani, Trump's personal lawyer, who descended on the state the Saturday after the Nov. 3 election as the count dragged on and the president played golf. Summoning reporters to a scruffy, far-flung corner of Philadelphia on Nov. 7, he held forth at a site that would soon become legendary: Four Seasons Total Landscaping.

LONDON - U.K. Chancellor of the Exchequer Rishi Sunak signaled he is optimistic that a Brexit trade agreement with the European Union will be reached.

Speaking to the BBC's Andrew Marr show on Sunday, he said "hopefully" negotiations will end in a "constructive" place.

He was clear that in the "short term," failure to get a trade agreement with the bloc would be a problem. A deal that comes into force when the Brexit transition period ends on Dec. 31 would be "preferable," he said, but added: "We should not be going for a deal at any price." [Bloomberg]

DOMINICAN REPUBLIC-The Centers for Disease Control and Prevention (CDC) of the United States has issued a Level 3 Travel Health Notice for the Dominican Republic due to Covid-19. The US State Department upgraded the Dominican Republic from the red-colored level 4 travel advisory to the orange-colored level 3. The United States issues a travel advisory per country. While level four travel advisory is a recommendation to "don't travel", level three tells US travelers to "reconsider travel."

The 4-week positivity rate in the Dominican Republic is at 10.57% and as of the data for the 18 November Covid-19 bulletin, the 7-day reported positive PCR test average is 556 cases. The rate of deaths per 1M in the country is 211 that favorably compares to 773 in the United States. [DR1]

TRINIDAD - The Trinidad and Tobago government on Saturday announced a total ban on Christmas parties within the public sector, while also urging the private sector to do the same.

Prime Minister Dr. Keith Rowley and Health Minister Terrence

Deyalsingh told a news conference that instructions will be given to the appropriate public sector officials to ensure that government funding for Christmas parties over the coming weeks will not be entertained.

Prime Minister Rowley said he is aware that many villas in Tobago have been fully booked for the Christmas Season and that while the government will not prevent persons residing in Trinidad travelling to the sister isle for the Season, he is reiterating the need to follow all protocols and measures put in place to prevent the spread of the virus that has killed 113 and infected more than 5,000 people in Trinidad and Tobago. HAVANA, Cuba, (ACN) - Italy's Unione Sindacale di Base (USB) urged to support the candidacy of Cuba's Henry Reeve Medical Brigade for 2021 Nobel Peace Prize.

'Let's support the Nobel Peace Prize for the Cuban Medical Brigade' and 'Defeating COVID-19 is possible with Socialism' were the central slogans of a virtual conference held by USB, which will be followed by other similar actions across the country.

The Nobel Peace Prize to these men and women who in the face of every situation are ready to leave their country and relatives to risk their lives in favor of unknown people, is a prize for the conception of the world.


In this regard, the text highlighted the value of this example 'at a time when the human life is in danger due to the irrationality of an economic system that is still dominating a large part of the planet. During the conference, Cinzia della Porta, USB's head of International Affairs, highlighted the help provided by Cuban doctors and nurses to fight the Covid-19 epidemic in Italy's Lombardy and Piedmont regions.

PHILIPSBURG - The Ministers of TEATT Ludmila de Weever and VSA Richard Panneflek have updated the entry requirements to include antigen testing with an effective date of November 25th. Travelers to St. Maarten are required to complete a mandatory health authorization application via the Electronic Health Authorization System (EHAS) available on www.stmaartenentry. com and upload their negative RT-PCR test within 5 days or their negative antigen test result within 48 hours. Currently, the following antigen tests have been approved: Abbott (CGIA Panbio COVID-19 Ag rapid test), Becton Dickinson (CGIA BD Veritor COVID-19 test), and Roche (SD Biosensor F test). The list of acceptable tests is constantly being reviewed as government continues to seek the most accurate alternatives to the PCR test. [SMN News]

IRELAND - Ireland and Lithuania have much in common. Both are small, Catholic, Europhile, enjoy a tricky relationship with a larger neighbour and have cuisines heavy on potatoes. Both also left it late when it came to gay rights. Homosexual acts were decriminalised only in 1993 in both countries. But since then, things have diverged. In the space of a generation, Ireland went from considering homosexuality a crime to allowing gay marriage and electing a gay taoiseach with little fuss. Life for gay Lithuanians has been less happy. Laws banning gay "propaganda" are still on the books. Civil partnerships, let alone same-sex marriage, remain a pipe-dream. Merely living without fear would be an improvement: 84% of lgbt people in Lithuania are not comfortable revealing their identity.

Where an iron curtain once split Europe, a rainbow curtain now divides the continent. In western Europe, gay people enjoy a quality of life better than anywhere on the planet. They are free to marry and adopt children, and are protected from discrimination in all walks of life. Things in eastern Europe are not so good. In seven eu countries, including Poland, Hungary and Romania, less than half the population agree that gay people should have the same rights as straight ones. Civil partnerships are not offered in six eu countries, all in central and eastern



A cup of lemongrass tea is a go-to alternative remedy for upset stomach, stomach cramping, and other digestive problems. A 2012 study on rodents published by the National Institutes of HealthTrusted Source showed that lemongrass may also be effective against gastric ulcers.

The study found that the essential oil of lemongrass leaves can help protect the stomach lining against damage from aspirin and ethanol. Regular aspirin use is a common cause of gastric ulcers.

6. It may act as a diuretic

In the world of natural health, lemongrass is a known diuretic. A diuretic makes you urinate more often, ridding your body of excess fluid and sodium. Diuretics are often prescribed if you have heart failure, liver failure, or edema.

A 2001 study evaluating the effects of lemongrass tea in rats showed diuretic activity similar to green tea without causing organ damage or other side effects. For the study, lemongrass tea was given to rats over a six-week period.

7. It may help reduce high systolic blood pressure

In a 2012 observational study, 72 male volunteers were given either lemongrass tea or green tea to drink. Those who drank the lemongrass tea experienced a moderate drop in systolic blood pressure and a mild increase in diastolic blood pressure. They also had a significantly lower heart rate.

Although these findings are exciting if you have high systolic blood pressure, researchers caution that men with heart problems should use lemongrass in moderation. This can help you avoid dangerous drops in heart rate or increased diastolic pressure.

8. to 10 it may help regulate your cholesterol

High cholesterol may increase your risk of heart attack or stroke. A study published in the Journal of Advanced Pharmaceutical Technology & Research Trusted Source showed that lemongrass oil extract helped to lower cholesterol in animals. The reduction in cholesterol was dependent on the dose.

Lemongrass tea is used as a detox tea to kick-start your metabolism and help you lose weight. Even so, most research on lemongrass and weight loss is anecdotal, not scientific. Since lemongrass is a natural diuretic, if you drink enough of it, you're likely to drop some pounds.

POLICE APPEAL FOR CALM/ HALT TO ALL RETALIATORY BEHAVIOUR

Thursday, November 26 – Police are appealing to the public to discontinue the spread of misinformation through voice notes or another forms of communication as investigations continue into the murder of Everton McMaster.

Several voice notes are being circulated within the Territory implicating three local men as the persons responsible for the murder. Police believe that as a result of these erroneous voice notes, an attempt was made on the life of Cliff Williams in Long Look last night around 6:15pm.

Detectives believe these claims are not only false but are intended to interfere with and divert attention from the investigation since there is no evidence to support these reckless accusations. Police are appealing to the persons not to take matters in their own hands and to desist from all retaliatory behavior as it is hampering efforts to bring justice in this investigation.

Detectives from the Major Crime Team are continuing investigations into the murder of Everton McMaster which took place around 3pm on 6 November 2020 in Baughers Bay. Detectives arrested one person yesterday for questioning in relation to that murder.

The Feast Doesn't End With Thanksgiving


Ah, Thanksgiving -- cleaning, shopping, cooking and entertaining guests for hours! While Thanksgiving is one of my favorite holidays, I've embraced the day after the holiday as my time to feast in peace.

My traditional after-Thanksgiving breakfast consists of a cereal bowl full of warm leftover turkey, ham, corn and dressing with cranberry sauce. One of my favorite after-feast lunches is a turkey and ham sandwich with cranberry sauce and any other leftovers I can fit between two slices of toasted bread!

In my opinion, Thanksgiving leftovers are a national treasure. If you store your leftovers safely and properly, you can enjoy them in a variety of ways for several days.

During mealtime, do not let the turkey sit out for more than two hours after it has been cooked. For safe storage, remove the stuffing and de-bone the turkey. Store the turkey in shallow containers in the refrigerator, because shallow containers allow the turkey to cool faster, preventing the growth of harmful bacteria.

Unless you freeze the leftovers, be sure to use the turkey and stuffing within 3-4 days. Leftover gravy should be used within 1-2 days. Other cooked dishes can be stored up to 4 days.



Frozen leftovers should be stored at 0 degrees Fahrenheit or below and used within 3-4 months. Turkey in gravy or broth, or other cooked turkey dishes can be frozen for 4-6 months. Stuffing and gravy can keep up to one month in the freezer. Marking your leftovers with the date and name of the item will help you keep better track of them.

Here are a few ideas for using the leftovers from your Turkey Day feast:

TURKEY WRAP

- 4 pieces of turkey (about 3-4 ounces) 1 tablespoon light mayonnaise
- 4 slices cooked bacon 2 flour tortillas (whole wheat, flour or flavored)
- 1/2 cup shredded lettuce 2 to 4 slices of tomato
- 2 to 4 slices avocado 1/2 red onion, sliced thinly, vertically
- 1/2 teaspoon salt 1/2 teaspoon pepper

Spread each tortilla lightly with mayonnaise. Divide turkey and put half on each tortilla. Add two slices of bacon, and evenly divide the lettuce, tomato and/or avocado slices and onion to each tortilla. Sprinkle each wrap with salt and pepper. Wrap tightly and serve. Serves 2.

THANKSGIVING POTATOES AU GRATIN

This retro casserole is a great way to use leftover turkey, ham and cooked vegetables.

- 1 cup cooked turkey or ham (or a mixture of both)
- 1 cup cooked white or sweet potatoes, chopped, or 1/2 pound frozen hash brown potatoes
- 1 cup cooked vegetables
- 1 (10 ounce) can cream of broccoli, chicken or mushroom soup. or 1 1/2 cups leftover gravy
- 1/2 cup sour cream or plain Greek yogurt
- 1 small onion, chopped 2 stalks celery, chopped
- 1 1/2 cups grated cheddar cheese, divided
- 1 teaspoon salt 1 teaspoon black pepper
- 1/8 teaspoon cayenne pepper Cooking oil spray

Heat oven to 350 F. In a bowl, combine all ingredients, leaving out 1/2 cup of cheddar cheese. Pour into an 8 by 8 pan sprayed with oil. Sprinkle with the remaining 1/2 cup of cheese. Cover and bake 40 minutes. Uncover and bake another 20 minutes until the cheese on top is browned and bubbly. Serves 4 to 6.

TURKEY CHILI

This is a great dish for a cold day. If you prefer to prepare this in a slow cooker, omit the cooking oil and the recipe step where you cook the spices and vegetables in a pan on the stovetop. You can place everything except for the cooking oil in a slow cooker, mix well, and then cook on low for 4 hours if desired.

- 2 teaspoons cooking oil 1/4 cup chopped onion
- 2 tablespoons chili powder 1/2 tablespoon ground cumin
- 2 tablespoons tomato paste 1/3 cup chopped celery
- 2 cloves garlic, chopped 2 (15-ounce) cans pinto beans, drained and rinsed
- 12 ounces fat-free, low-sodium chicken broth
- 1 (15-ounce) can fire-roasted tomatoes, chopped
- 1 (11-ounce) can white corn, drained •1 (4-ounce) can chopped green chilies
- · 2 cups cubed, cooked turkey · 1 teaspoon salt
- 1 teaspoon black pepper 1/2 teaspoon cayenne pepper

Heat the oil in a heavy, deep pot over medium heat. Add the onions, chili powder, cumin, tomato paste, celery and garlic. Cook until onions are clear. Pour 1 can of the drained and rinsed beans into the pot. Using a large spoon or a potato masher, mash the beans to break them down and thicken the chili. Add the remaining can of beans and the rest of the ingredients to the pot and stir well. Cover and simmer, stirring after 10 minutes, cook 15-20 minutes. Serves 4 to 6.

St Lucia to Introduce Tourism Levy December 15: **CARICOM Business**

The Government of St Lucia apply to guests who are 12 to 17 will introduce a tourism levy effective December 15, 2020 to aid in the financing of the industry marketing and development.

In a two-tier system, guests will be charged either US\$3 or US\$6 per person per night depending on a room rate below or above US\$120. A rate of 50% of the tourism levy will years at the end of their stay.

The fee will not apply to children under 12 years. Additionally, the government will from December 1, reduce the VAT from 10% to 7% for tourism accommodation service providers. Other countries such as Antigua, Barbados, Belize, Jamaica, St Kitts, and St Vincent have similar levies on accommodation for visitors. (JG)

New Company Registrations Soar In Jamaica: **CARICOM Business**

Jamaica has recorded 3,586 new company registrations for the period January 1 to November 11, 2020.

That's according to data produced by the Companies Office of Jamaica and released on social media by Finance Minister Dr Nigel Clarke who noted that "in the middle of the pandemic and record economic contraction, Jamaicans are forming new companies at a rate not seen before."

Though below the record 3,822 new start-ups in 2019, the performance to date in 2020 has outstripped new registrations for 2013 to 2018, with 1,948 new registrations recorded for 2013; 1,775 in 2014; 2,227 in 2015; 2,544 in 2016; and 3,160 in 2018. (CB)

Haiti Receives Us \$7.45-M Pay-Out From CCRIF: **CARICOM Business**

CCRIF SPC on September 7, disbursed approximately US\$7.2m to the Government of Haiti on its Excess Rainfall (XSR) parametric insurance policy following the passage of Tropical Cyclone Laura.

According to CCRIF SPC, Haiti also received a pay-out of US\$290,925 under the Aggregate Deductible Cover (ADC). The total insurance pay-outs to Haiti as a result of Laura fell within the 14-day stipulation for post catastrophe payments.

This is Haiti's fourth pay-out from CCRIF, as previously the country received pay-outs of US\$7.8m following the 2010 earthquake, US\$20.4 million on the country's TC policy following the passage of Hurricane

Matthew in 2016, and US\$3.0 m on the country's XSR policy for that same event. The CDB has been paying Haiti's insurance premiums "either fully or in part since 2010, in support of that country's overall disaster risk management strategy & resilience-building agenda" (CBR)

Biden to Discuss 'Shared Sacrifices' as Coronavirus **Looms Over Thanksgiving** By Ken Bredemeier, Updated November 25, 2020

is set to discuss the coronavirus pandemic Wednesday and the "shared sacrifices" Americans are making ahead of Thursday's annual Thanksgiving holiday.

Millions of Americans typically gather with family and friends, many traveling long distances to do so. But this year, with COVID-19 infections spiking across the country, the federal government has urged people to stay home for Thanksgiving, and many are. Even so, millions of people are ignoring the advice and crowding airports to head to destinations across the country.

Biden's transition office said he would tell Americans "that we can crisis together."

Ahead of the speech, his transition team said it was receiving "extraordinary receptions" from officials in the outgoing administration of President Donald Trump to help Biden take control of the U.S. government after his January 20 inauguration.

Trump, a Republican, acquiesced in the official start of Biden's transition to power this week but has not conceded his defeat. However, election officials in key battleground states have declared the Democrat the winner, giving a Biden an unofficial 306-232 edge in the Electoral College that determines the outcome of U.S. presidential contests.

Biden adviser Kate Bedingfield told reporters, "The election is over. Everyone has accepted

U.S. President-elect Joe Biden the outcome except President Trump and [Trump lawyer] Rudy Giuliani."

> Bedingfield said Biden transition officials were getting information from Trump officials about national security issues the country faces, along with plans for approval and distribution of prospective vaccines to inoculate millions of people against the coronavirus.


> Biden and Trump have not spoken since the November 3 election, with Biden aide Jen Psaki saying, "We do not feel it is essential to talk with President Trump," although Biden has said he would be willing to meet with the outgoing president.

On Tuesday, Biden declared and will get through the current that the United States was "ready to lead the world, not retreat from it," signaling a sharp pivot from Trump's "America First" credo over the last four years.

> Biden said the country was "ready to confront our adversaries, not reject our allies. And ready to stand up for our values."

> From his transition center in his hometown of Wilmington, Delaware, the president-elect introduced his top foreign policy and national security officials, including Secretary of Statedesignate Antony Blinken, a longtime Biden foreign affairs adviser.

> Biden said his foreign policy team embodied "my core belief that America is strongest when it works with its allies. That's how we truly keep America safe without engaging in needless military

check and terrorists at bay."

Under Trump, the United States often found itself at odds with longtime Western allies while the U.S. leader appeared at ease with such autocrats as Russian President Vladimir Putin, Turkish President Recep Tayyip Erdogan and North Korean leader Kim Jong Un.

Biden said, "America leads not only by the example of our power, but by the power of our example."

Aside from Blinken, Biden named former Secretary of State John Kerry to a new position as special presidential envoy for climate, while giving him a seat on the National Security Council. It was a reflection, the Biden transition said, of the incoming president's commitment to addressing climate change as an urgent national security priority.

Biden selected Alejandro Mayorkas to become head of the Department of Homeland Security. A Cuban American lawyer, he is a

Members of the BVI Rugby Football Union and CrossFit, turned Brandywine Bay Beach into a Rugby Festival and fitness center on Sunday, as they held one in a series of fundraising events, as part of their goal to raise \$20,000, to assist national Rugby player Kenrick Thomas, who will have heart surgery on January 20.

The event attracted school, corporate and national Rugby players and included coed teams.

Thomas, 23, who has been playing Rugby since he was 14, last represented the BVI in Santo Domingo in 2019 and has played throughout the Caribbean and Central America, in various competitions.

Thomas told Island Sun Sports it brought him so much joy seeing the number of people who were on the beach playing Rugby, from school children through adults doing sports and cross fit activities. He said it has always been his dream to have as many people playing the sport he loves. It was in March just before the lockdown, that he said that he discovered the problem with his heart.

"I broke my ribs at the beginning of the year and while I was recovering and giving my body a rest, I felt a pain in my heart," he said, thinking it was an overused injury. "Then my wife said I should go to the hospital and better be safe than sorry, so when I did, they doctor said you really have a big problem."

It was discovered that the 23-year old has Ventricular or Atrial Septal Defect (VSD/ASD), which needs surgery to correct. He said when he revealed it to his teammates, they were saddened, but then spurned into action to assist him. He's now looking to have the problem resolved during January 20, 2021 surgery in Puerto Rico and getting back on the pitch after recovery and rehabilitation and continue the sport he loves the most.

"I do want to play, but it give me so much joy seeing all these people coming together, because it's something you want to see since BVI doesn't have many things to keep you occupied and busy," Thomas who was score keeping before joining a kids game said. "Seeing them enjoying this, doing this—I didn't want it being for me, but at least it's happening—so much

people coming together from CrossFit and Rugby, and boxing who's also doing something, it's tremendous."

Having represented the BVI in Rugby Americas North on several occasions, in St. Lucia, St. Vincent and the Grenadines, Puerto Rico and Mexico among others, Thomas said it would mean the world to him to recover and play again.

"Especially because I have all this support. All the people here know me and believe in me, so once I get the problem fixed, I'm going to come back and give my best as I always do, more than 110%," he said. "So, I'm going to bring the win home. That's all I want to do, go and bring a victory."

Thomas joined kids in a short game of Rugby and afterwards commended them on their play.

Niiall Brooks, BVI Rugby Football Union President, said the funds they are raising will supplement National Health Insurance coverage. He said the beach pitch they used for the function was a courtesy of their corporate sponsors. Based on the success of Sunday's

A Caribbean-Central America alliance for Climate

Governments in Central America are calling for "Climate Justice" after the devastation of their countries by Eta and Iota as both tropical

storms and hurricanes.

The Central American countries are echoing a call previously made by Caribbean governments whose countries are repeatedly ravaged by hurricanes.

The response of the international community to the plight of Central America has, so far, not been different to the way they

respond to the Caribbean. Typically, that response is much public handwringing, miniscule immediate contributions, and then tough negotiations over conditions on which any meaningful concessionary loans would be made to help affected countries recover.

If any of the countries are regarded as 'high-income' like Antigua and Barbuda, Bahamas, Barbados, and St Kitts-Nevis, they will get no concessional financing unless they are already in an IMF balance of payments support programme.

Yet, the situation in Central America and neighbouring Colombia is catastrophic. Thousands of people face a lack of drinking water, food and basic supplies after Eta and Iota slammed the region, destroying homes, hospitals and other critical infrastructure and piling one disaster on top of another. Many have died, many are missing, tens of thousands are homeless. On top of the dreadful human suffering, the infrastructural wreckage runs into hundreds of millions of dollars.

The demand for 'climate justice' by Caribbean governments, and now Central American leaders, is for compensation for massive damage caused to their countries by Climate Change in whose creation and ballooning they are least to blame. The Economic Commission for Latin America and the Caribbean notes that Central America's total CO2 emissions represents only 0.2% of the global total; the Caribbean's is even less.

International help, so far, for Central America indicates a slow response. The US Agency for International Development announced \$120,000 each to Honduras and Guatemala, and \$100,000 to Nicaragua. The European Union (EU) did better, pledging \$1.83 m to all Central American countries. But the sums are small given that the US and EU countries are amongst the largest contributors to Climate Change. The silence of other big polluting nations is also alarming.

The Central American Bank for Economic Integration authorised \$1 m in non-reimbursable funds for Honduras and Nicaragua, but its resources are relatively small. It is to International Financial Institutions (IFIs), such as the IMF, World Bank and the Inter-American Development Bank, that these countries will look for significant resources.

Like the Caribbean, the Central American countries are facing extraordinary costs to fight the effects of the COVID-19 pandemic in circumstances where their revenues are dwindling. The havoc wreaked by Eta and Iota adds to their burden of human suffering.

This is why 13 CARICOM countries, (Haiti was the exception) joined the nations of Central America, Mexico and Colombia in sponsoring a Declaration at the Organization of American States (OAS), on November 18, calling for urgent support to the affected countries, "through hemispheric and

global cooperation to address the most pressing needs for recovery and reconstruction".

The sponsoring countries sought a 'declaration'

rather than a 'resolution' which would have been a much stronger instrument, binding on the organization. But Central American and Caribbean countries knew well that some powerful states in the OAS would have pushed against such a binding resolution.

The governments of these same powerful countries are among those who

make policies for the IFIs that disqualify small and vulnerable states, such as Antigua and Barbuda, Bahamas, Barbados and St Kitts-Nevis, from access to concessional financing because of the false criterion of 'high per capita income'.

Making my contribution to the OAS' meeting, I said the following:

"Those who make policy for the international financial institutions and multilateral development banks have to stop pretending that the economic and financial circumstances that existed in January 2020 are still the same in November 2020. They are not. The world has altered, and significantly.

The reality is that while many countries – including my own - are denied access to concessional financing and debt relief on the basis of the wrongful measurement of high per capita income, that per capita income has been reduced by as much as 40% because unemployment has more than tripled. The time has long come for policy makers to admit the reality of the changed situation and to amend the policies of financial institutions to address it.

Similarly, while Paris Club members continue to demand debt repayment without debt restructuring, they too should face the reality that countries cannot pay what they do not have. Debt default is what will occur with little prospect of repayment unless a balance is struck now.

If these circumstances continue to be ignored, or the usual placebos are administered rather than the financing vaccines that exist and can be applied, this pandemic of economic disaster and human suffering will plague our hemisphere irreparably and irreversibly for decades to come".

Given the Caribbean's increasing exposure to external shocks (hurricanes, pandemics and recession in North America and Europe) the region must increase the volume and heighten the intensity of its advocacy on debt which is a tightening noose around its neck.

In the present circumstances, the nations of Central America are the Caribbean's natural allies to make common cause on this issue in the international community. CARICOM countries should initiate a strong diplomatic effort with Central America to build such an alliance.

As a first step, Central American and Caribbean countries should agree to follow the pattern of Barbados and Grenada to include a "hurricane clause" in their bonds, stipulating an immediate, if temporary, debt moratorium if the country is struck by another natural disaster. Such a clause should also be part of all external debt. If Central American and Caribbean counties insist on it collectively and strongly, they have a chance to succeed.

The two sub-regions, representing 20 nations, can turn the crises of this season of hurricanes, tropical storms, and COVID-19 to advantage. But they must act together.

A Time to stand up to Hungary and Poland

"We did it! This is an historic day for Europe," proclaimed weary leaders back in July. After 90 hours of talks, they had finally, unanimously agreed on a coronavirus recovery package and budget worth over €1.8 billion. This was historic because, for the first time, it would involve the European Union effectively sharing debt – a new precedent in desperate times as the continent's economies were ravaged by lockdowns. European Commission President Ursula von der Leyen tweeted at the time: "Today we've taken a historic step, we all can be proud of. But other important steps remain. First and most important: to gain the support of the European Parliament. Nobody should take our European Union for granted." She was right to be cautious.

Last week, both Poland and Hungary called a halt to the process. Not because they didn't want the money - hard hit by the second wave of the coronavirus they needed it more than ever - but they objected to the issue on the rule of law. Back in July, leaders agreed on a mechanism linking future budget payments to judgements about whether countries were adhering to fundamental European principles, such as media plurality and judicial independence. Everyone signed up but, crucially, the details were missing. When earlier this month negotiators for the European Parliament and the Council of the EU reached an agreement to fill in the blanks,

Hungary and Poland did not like the result, insisting this part must be removed from the deal or the entire process would remain in limbo. Hungarian government spokesperson Zoltán Kovács told Euronews that the new rule of law mechanism lacked "objective criteria" and amounted to "political blackmailing". If there is no deal, the EU will fall back on a barebones, emergency spending programme for next year.

So in many ways, both countries are shooting themselves in the foot, as they are among the main beneficiaries of the current agreement. Cohesion payments for new projects would be stopped and there would be no recovery money, which was due to be around 3 per cent of their economies' GDPs. There is hope that a possible solution might come via the Commission, with Budget Commissioner Johannes Hahn talking about a "guarantee" of objectivity in how the mechanism is implemented. But for others, the mechanism itself is a red line. Dutch Prime Minister Mark Rutte told his parliament: "For the Netherlands, the agreed compromise on the rule of law is the bare minimum. We cannot accept anything less." This issue should be a red line.

For years, Orban has been dismantling some of the fundamental components not just of European norms but of democratic societies themselves in Hungary. Last month, the European Court of Justice declared that by throwing the Central European University out of Budapest the government had violated European human rights laws on academic freedom and university autonomy.

Eighty per cent of the country's media is controlled by owners sympathetic to Orban. Several media have also reported on allegations that members of his family are personally profiting from EU fund money. While most EU leaders, parliamentarians and commissioners know something needs to be done, they simply don't have the means to do it. Darren McCaffrey - Euronews Political Editor



False Positives Plague Lung Cancer Screening

DEAR DR. ROACH: I'm a 74-year-old female who smoked a pack a day for 40-plus years, having quit smoking about 18 years ago. As a precaution, I asked my primary doctor to order a screening CT scan, knowing that I'm a candidate for lung cancer. The results showed a 3-mm nodule in one lung, and I was advised not to worry and that my doctor would order another CT scan in six months. I can't help but wonder if this is cancer and if an oncologist, after six months, will ask me why I waited so long to see him. — T.W.

ANSWER: Medical professionals have been attempting to screen for lung cancer for decades. Chest X-rays proved insensitive: By the time cancer could be seen on X-ray, it was usually too late to do anything about it. CT scans are much more sensitive (maybe too sensitive; see below), and studies have shown that some lives will be saved with a screening program. However, the number of people who would benefit is relatively small; 256 moderate-to-heavy smokers would need yearly screening for three years in order to prevent one lung cancer death.

There are two other significant concerns about lung cancer screening. The first is the issue you have now: an abnormal result and what to do about it. It's extremely common. Almost 25% of scans will be abnormal, and 96% of the abnormal results will be false positives. But it will require multiple scans and sometimes an invasive

procedure to prove it. This means a great deal of anxiety among people who get the type of result you did.

The small size of your nodule means your risk that this nodule is cancer is much lower than 1%. A follow-up scan is the usual recommendation, and if the nodule is the same size or smaller, the chance of it being cancer is very close to zero. You should have had a careful explanation of the likelihood of false positive results before getting the scan. You should also have been warned of the possible need for a biopsy and the possible financial costs associated with follow-up testing.

The second concern is that current smokers who consider screening should receive intensive advice and help in quitting smoking. A negative CT scan is not a "clean bill of health" for a smoker and quitting remains the single most important thing most smokers can do for their overall health.

DEAR DR. ROACH: How often does a healthy person with perfect vision and no eye concerns need to see an eye doctor? — D.S.

ANSWER: A periodic eye exam in someone with no symptoms involves a screening test for vision changes related to aging and other eye diseases, including glaucoma, age-related macular degeneration and cataracts. There are several commonsense reasons for screening, but there has not been good evidence to support its use. The U.S. Preventive Services Task Force does not make a recommendation for or against screening. The Canadian Task Force recommends against it.

By contrast, the American Academy of Ophthalmologists recommends a baseline exam at age 40; visits every two to four years from age 40-54; every year to three years from age 55-64; and annual exams for people 65 and over.

'Gracias Diego': Maradona's Fans Mourn Legendary Player's Death

With tears, songs and prayers, a multitude of Argentines flooded into the heart of Buenos Aires to pay their final respects to Diego Maradona, one of the world's greatest soccer players.

Thousands of fans lined up from the early hours on Thursday to file past Maradona's wooden casket as he lay in the Casa Rosada, the presidential palace, beneath his nation's sky-blue-and-white flag and his signature No. 10 shirt.

The facade of the pink-tinged palace was decorated with a huge black ribbon in honor of the audaciously skillful player who rose from poverty to stardom at a young age, and became a national hero by leading Argentina to World Cup victory in 1986.

Occasional clashes with police broke out as some of the crowd grew frustrated with waiting and broke through the security barriers.

As the morning grew longer, a pile of red roses, banners, scarves and shirts formed alongside Maradona's coffin, thrown there by mourners. Some grieving fans carried banners simply saying "Gracias Diego."

"Maradona for me is the greatest thing that happened to me in life. I love him as much as my father and it's like my old man died," Cristian Montelli, a 22-year-old supporter with a Maradona tattoo, told Reuter

Maradona, 60, died of a heart attack on Wednesday at his home on the outskirts of Buenos Aires, where he was recovering from recent brain surgery. After his playing career ended, his life was marred by much-publicized battles with cocaine, alcohol and ill health.

Yet the tributes pouring in from supporters, sports celebrities and politicians around the world have focused on his sporting triumphs,

Maradona's burial is expected to be held on Thursday evening at the Bella Vista cemetery on the outskirts of Buenos Aires where his parents are also buried. Argentina's President Alberto Fernández has declared three

days of national mourning, saying Maradona had made Argentines "intensely happy" and describing him as "the greatest of them all."

Although that claim is disputed by many in Argentina's neighboring Brazil - a fierce soccer rival, where Pelé is widely seen as the world's best-ever player - the Brazilian media marked Maradona's passing with numerous pieces extolling his exceptional talents.
