PEOPLE SMUGGLING & BORDER BREACHES RAISE QUESTIONS

The current urgency of border protection following reports of people smuggling and border breaches has caused rumors that the authorities quickly rushed to deny, and a disclosure that resulted in Premier Hon. Andrew Fahie criticizing His Excellency Governor Augustus Jaspert's decision to make certain things public.

The criticism the Premier heaped on the Governor came following a public announcement the Her Majesty's Representative made on 25 August. During his announcement, His Excellency alluded to the breaching situation. He stated, "people have rightly expressed concern about the small number of individuals who are not following the rules and concerns about our border security."

"As we impose restrictions internally and have strict measures in place for people travelling through the legitimate routes into the Territory, we must ensure that our borders are secure and that people comply with the required measures."

The comment that later caused the Premier to retort sternly was the Governor's mention of discussions that were held by The National Security Council. The Governor during his speech said, "The National Security Council is meeting later today; there was a previous offer from the UK to help to bolster the Territory's border security in the early days of Covid-19. That offer was not supported at the time. I will be discussing with the National Security Council what support might now be needed and will update in due course."

Hours later during a press conference Hon. Andrew Fahie rebuked the decision to make such a revelation. The BVI Leader said, "First of all I am disappointed to know that it reached the public domain in the manner that it reached because this is not a time for persons to be pulling aside, it is a time for unity."

"It is a breach of confidence to say who said what and who disagreed with what... Because of the implications of what has been put in the public's domain, I am now forced to voice the deliberations of the NSC, but I will do my best not to compound the damage that has already been done by the statements that were made."

Further, the Premier complained that there seemed to be an agenda to inject UK military personnel into the Territory, "There was some discussion about military support, and I must say here that the UK and its agencies seem to be itching to put military personnel in the jurisdiction whether on the sea or on the land. That was the one offer on the table."

Additionally Hon. Fahie said that it was felt that this was an opportunity for the Territory's security personnel to get a valuable experience: "It is on this basis and the confidence in our personnel here in the VI it was felt that military was not the way to go and we decided on many measures that we would exercise first, and we have exercised our options, and we have done pretty well," Hon. Fahie added.

Border Breach Conspiracy

In recent days there were rumors that border security officers allegedly participated

in the reported smuggling. responded and this announcement was labelled as 'fake news'. Moreover, during his press conference on 25 August, Premier Fahie sternly refuted the rumor and stated, "We have to run the country on facts! What I can tell persons is that there is a new protocol in place to make sure that officers are not comfortable in one environment for too long."

Meanwhile, Commissioner of Customs Wade Smith during the same press conference said, "the matter is under investigation."

On another note, the Premier announced that the 24-hour border security that is being carried out by Her Majesty's Customs and the Royal Virgin Islands Police Force successfully foiled an attempt to breach the Territory's borders.

Further, the BVI Leader said However, the government that there is an arrangement with the US Virgin Islands for border patrol on both sides.



Ponzi Schemes Target BVI Faith-Based Community

Allegations of Ponzi and to convincingly sound faithpyramid schemes operating here in the British Virgin Islands sent BVI Finance into heightened public education mode to rid the BVI of such schemes. The most prominent of the efforts materialised in the form of a BVI Finance -Money Matters E-Forum held on 23 August on the internet.

The panel included various financial experts and in her explanation of why such schemes are given momentum CEO of BVI Finance, Elise Donovan used the example of schemers that target religious persons and craft their pitch based.

This scam message -Donovan explained - is, unfortunately, appealing to many persons, "I think we are very much a faith-based community and we believe in receiving our blessings... and blessing by definition is receiving favour and a gift from God...It's not the same as for example, if you are in the church and sowing a seed... that if you sow a seed you are going to reap blessings, multiply... it's not the same, but because we are using the same terminology that we are using in church, whether it is a blessing loom or a blessing circle, things are very familiar to us," the BVI Finance CEO said.

During the panel discussion Broderick Penn, the Director of Enforcement at the BVI Financial Services Commission, debunked the belief that some may have that by participating in these quick money offerings they are investing. He explained, "You are not an investor if you are putting your money into a pyramid scheme."

Clarence Faulkner Founder and Managing Director of Pension Management

Interactive, INC pointed out that ordinary hard-working individuals are usually targeted for these schemes: "With these types of structures individuals are using their salaries any form of income to put into something hoping to receive something," Faulkner explained.

The same point on the types of people targeted by such schemes was elaborated on by Dwayne Thomas the Deputy Director of BVI Financial Investigation Agency as he stated that many of the investors never receive anything in return. "These types of persons who

are putting their money into these types of schemes I would have to consider them overly risky; because there is nothing being given showing that they have invested anything. Your money is held by the scheme perpetrator and that person then passes that money to persons at the top level of the scheme."

"Monies come in but it trickles up, as more persons come in below those persons, those persons are more likely to lose their funds unless they can get more persons to come in under themselves." Thomas added.

Fried Chicken Smuggling Criticised

There are many Kentucky Fried Chicken (KFC) lovers n the Territory and over :he years these persons have been known to travel to the US Virgin Islands ust to buy that particular ast food item. The closure of the border from March created a craving and a ew enterprising seafarers decided to offer a service providing KFC. However, :his chicken trade is being lagged as a breach of the Territory's effort to keep :he BVI COVID-19 free.

by Commissioner of Police Michael Matthews during his interview with JTV news on 25 August. In chiding the KFC entrepreneurs Matthews said, "When you see adverts by our ferry companies, for example, saying hey, we'll get you Kentucky Fried Chicken whilst we are in St Thomas, what does that tell you about social responsibility. Why would you be offering to add a service that might risk somebody going on to land and collecting an

The concern was shared additional item, that really Commissioner of Police isn't an essential here?"

The Top Cop described these ventures as daring not because they venture freely into an area with known COVID cases, but because their entrepreneurs boldly advertise their service on social media. In condemning this alleged boldness the Commissioner said, "these people are blatant, they put it out on social media with numbers saying call us and we'll go shopping for

you in St. Thomas... when it is not authorised to do that, and frankly, some of those people are going to find themselves facing the magistrate as a result of those actions," he said.

The Commissioner has been frequently addressing the public about COVID-19 matters. Previously he made a plea in the form of a public service announcement that was released on 21 August. That announcement became timely and by Monday it

was announced that the Territory had gone into a situation where there were actual COVID-19 clusters.

Noting that the borders and the alleged smuggling is a threat to the BVI's efforts to stem the corona virus the Police Commissioner declared: "It has become obvious, that a very small minority of people are still intent on trying to smuggle goods or persons backwards or forward into the Territory from locations outside, particularly the US.

COVID Emergency Causes Return To Online Learning

n normal times students across the Territory would have been preparing for the new school year, but because of the COVID 19 global pandemic Minister for Education, Culture, Dr. The Hon. Natalio D. Wheatley announced that another unconventional year of learning is ahead for BVI students.

During his Territorial address on 25 August Hon. Wheatley reported that although many parents were hoping traditional schooling would recommence the Ministry has decided not

to allow this. The Minister in explaining the reason for the decision noted that the fluidity of this COVID 19 situation is a problem.

Hon. Wheatley explained that following Cabinet's previous decision, he intended to deliver a statement last week on the opening of schools. "However, soon after, I received news from the Minister for Health that we had an additional case. Since that time, we have had several positive COVID-19 cases with a total of 17 presently active."

Hon. Wheatley explained that the need for safety as it relates to BVI students is supported by facts and findings as he stated that alarmingly some of the recently discovered cases of COVID 19 in the Territory included school aged children. Based on such dramatic findings the Minister of Education said that non-traditional schooling is being mulled: "In light of this extremely serious reality, I cannot in good conscience proceed with the plan to reopen schools to face instruction. This will place

administrators, teachers, support staff, and, our most precious resource, and our children all at risk."

The majority of the last school year featured online learning and Hon. Wheatley said that he knows that because of more regular traditional methods of instruction is being craved and many have criticized the Ministry for not making this possible: "I am aware of the fact that many are yearning for the return to the classroom, and I have received criticism from many who are advocating the opening of the Territory,

but we must prioritize the health of our children and our people above all other considerations."

Therefore, the Minister said that the schools will return to online learning for the rest of the year. "This includes all public schools and private schools, and our primary, secondary, and tertiary learning institutions. Cabinet will reevaluate the situation in the coming weeks and months to determine when it will be safe to return to the classroom. Until then we will continue to rely on the use of technology."

Bvi Supports Regional Cooperation Across Wider Caribbean

The British Virgin on implementation Islands continues to support regional cooperation in the wider Caribbean, despite the challenges posed by Covid-19.

On 14th August, Special Envoy of the Premier Mr. Benito Wheatley, attended virtual meetings of the standing committees of the Association of Caribbean States (ACS) where participants discussed progress

of the regional body's Triennial Plan of Action (2019-2021), against the backdrop of the coronavirus pandemic.

The Special Envoy participated in the meeting of the Caribbean Sea Commission whose primary objectives are to ensure the sustainability of the Caribbean Sea and achieve its recognition as a special zone for Sustainable Development recognised

by the United Nations (UN). He also participated in the Special Committee on Sustainable Tourism that is working to establish a Sustainable Tourism Zone of the Greater Caribbean (STZC).

Commenting on the ACS meetings, Mr. Wheatley said, "Premier Hon. Andrew A. Fahie made a commitment to regional cooperation at the ACS Heads of Government Summit in 2019 in Nicaragua. BVI Government has followed up on this commitment through engagement participation in the ACS, among other things. The BVI and our ACS partners have a shared interest in ensuring the economic and environmental sustainability of the Caribbean, particularly in the face of Covid-19 and climate change. We will continue to engage on the regional agenda via ACS and contribute

in any way we can to the implementation of the Triennial Plan of Action."

The BVI joined the Association of Caribbean States in 2018 as an Associate Member. The membership of the regional body includes the countries of Latin America and the Caribbean connected to the Caribbean Basin, as well as several Observer Countries and institutions.

US Virgin Islands "Puts Brakes" on Tourism for At Least One Month

The US Virgin Islands is "putting the brakes" on tourism, closing its doors to leisure visitors beginning Aug. 19 for a period of at least one month.

US Virgin Islands Governor Albert Bryan Jr announced the move, reverting the territory to a "Stay-at-Home" phase of its COVID-19 response for the next two weeks.

"The recent infiltration of the virus into our residential institutions that house vulnerable members of our population creates an alarming level of risk," the Governor said. "This adds to the stress of the ongoing pandemic response that seemingly has no end in sight and is wearing out our health care and public nightclubs and cabarets safety infrastructure."

Effective immediately, all hotels, villas, Airbnb accommodations and quest houses, charter vessels and similar businesses have been ordered not to accept or book any new reservations for a month.

Reservations are only being accepted for business travelers, flight crews, emergency personnel and government workers with written authorization from the government agency they are visiting.

Beginning Aug. 17 through Aug. 31, all restaurants can only offer takeout, delivery or drivethrough, with all bars,

closed.

"We appreciate the concerns of our tourism partners and stakeholders, however, with the recent spike in cases we are seeing, especially in the St. Thomas-St. John district, we must reset, take stock, safeguard human life, and prepare for restarting our tourism economy at a later date," said Commissioner of Tourism Joseph Boschulte, as he spoke about the "difficult but necessary decision."

The UWI Open Campus and CCRIF SPC Successfully Delivered Disaster

Risk Financing Train-the-Trainer Workshop

Continuing and Professional Education Centre. Tuesday, August 25, 2020 — The UWI Open Campus and CCRIF SPC (formerly the Caribbean Catastrophe Risk Insurance Facility) successfully delivered a train-the-trainer workshop on a new course

to be offered at the University, "Disaster Risk Financing for the Sustainable Development of Small Island Developing States (SIDS)."

Eighteen lecturers from four of the five UWI campuses across the region with expertise in disaster risk management, finance, education, insurance and other related fields participated in this five-day training workshop conducted over five weeks, which totalled 25 hours of instruction. Each participant will be awarded a UWI Open Campus Certificate of Participation with two Continuing Education Units or CEUs.

CEUs are an internationally recognized system of merit for persons pursuing Continuing and Professional Education.

CCRIF CEO, Mr. Isaac Anthony, who provided the welcome and opening remarks to participants, outlined the context in which the workshop was being offered. The workshop was an initiative birthed out of the long-standing collaborative arrangement between The UWI and CCRIF SPC, dating back to 2010. This partnership expanded through a new memorandum of understanding signed in March 2020 which formalized collaboration between the two organizations in the areas of disaster risk management, including modelling and disaster risk financing, climate change adaptation and importantly research capacity building towards creating a cadre of individuals who can effectively support the development priorities of countries in the region.

The workshop sessions were facilitated by subject matter experts from the CCRIF SPC team led by Dr. Michael Spranger, CCRIF's Chief Risk Management Officer and Ms. Elizabeth Emanuel, Head of the Technical Assistance and Corporate Communications Team.

Participants engaged in lectures and discussions centred on topics including, among others, the impact of natural hazards in the Caribbean; disaster risk financing; disaster risk financing instruments such as CCRIF SPC's parametric insurance, Cat

DDOs, and contingent credit facilities; an in-depth analysis of CCRIF's models and policies, as well as country risk profiles; and an introduction to CCRIF's WeMAp hazard monitoring and forecasting tools.

Participants expressed their appreciation of the new content that was shared. One participant indicated: "The technical content was explained in an understandable manner. The products and underlying inputs and considerations are very clear. Managers in the public sector should have a proper understanding of what the products provide, the underlying factors and the benefits re management of public sector risks. I highly recommend course for students in public policy/public sector management."

The training of these academic professionals was conducted to facilitate the upcoming collaboration between The UWI Open Campus and CCRIF SPC to offer a Continuing and Professional Education (CPE) Certificate course in Disaster Risk Financing the Sustainable for Development of Small Island Developing States (SIDS). Participants of this course will have the unique opportunity to apply for a scholarship to cover the costs of the course as CCRIF has contributed US\$11,000 to cover enrolment costs.

Special Category To Submit Applications Before Entry To The BVI

The Cabinet of the Virgin Islands has given the approval for a special category of persons to enter the Territory from August 15 providing that applications are submitted to the ministers for Immigration and Health for approval.

The special category includes dependents such as spouses and children of Belongers, Permanent Residents, work permit holders and work permit exemption holders.

Premier and Minister of Finance said in his COVID-19 Update Phase 2 that the special category also include

persons employed by the Government of the Virgin Islands and its Statutory Agencies Bodies, Boards; teachers (public and private) and persons who departed the Territory for medical purposes and those who accompanied those persons.

The Premier said applications are to be submitted by these persons to both ministers before they are allowed to enter the Territory. All other category of persons must apply from September 1.

Meanwhile, Acting Chief

Immigration Officer Mr. Ian Penn said the department has been getting an increased amount of applications that are not accompanied by the approval letters from the ministers of Labour and Health.

Mr. Penn said, "I would like to inform the persons seeking to enter Territory before September 1 that their applications will not be processed unless they get the required approval from both ministers. Those persons that applied to the Immigration Department without the approval will be processed on Sept 1 when that prerequisite approval from the ministers is no longer needed."

The Immigration Department continues to contribute to the security and prosperity in building a stronger and better BVI, by operating a fair but firm immigration control that regulates and facilitates the movement of people through BVI borders while exercising sound judgment in the performance of its duties and ensuring that it responds to the needs of its customers in an efficient, effective and courteous manner in accordance with B.V.I. immigration laws.

Statement By The Director Of The National Parks Trust Dr. Cassander Titley-O'Neal On The National Parks Trust Of The Virgin Islands

Good day to you the people of these beautiful Virgin Islands.

There has been misinformation circulating about the National Parks Trust of the Virgin Islands that sends the wrong message. As the Director, I wish to clarify and give some context on the situation.

As a Territory, we have all been in the fight against COVID-19 together from late March to date, and we will continue to do so for the foreseeable future. The Trust and the Board recognises the value of its employees and their invaluable contributions to the operations of the Trust, especially in this time of

uncertainty and constant change.

I will give some clarification on the recent stories in the media about the National Parks Trust of the Virgin Islands. The imposition of Curfew (No.28) Order 2020 that went into effect on Wednesday August 26, there is a list of approved businesses and essential services that are allowed to operate. Moreover, that list is going to be reviewed and revised over the 14 day curfew period in the first instance.

The National Parks Trust of the Virgin Islands is a Statutory Body with a Board of Directors that generates its own finances and is heavily

dependent on tourism and the marine industry. Unfortunately, both sectors, like many areas of our economy, are and continue to be affected by COVID-19. As such, the Trust like many other entities, will have to find creative ways to adjust moving forward.

As the Trust was not on the approved list to operate during the first 7 days of the curfew and the majority of our employees work outdoors.

One of the creative ways in which the Trust suggested to the staff, that would not be able to report physically to our offices or parks was to use their vacation or paid time off to compensate for the fact the Trust could not afford to pay them to stay at home.

In this time of uncertainty, that decision was made by the Trust as a way to keep all the staff employed. The Trust and the Board are, and will

continue, to be committed to the people of this Territory as we aim to keep all employees employed for as long as possible, while we try to find new streams of revenue.

In conclusion, I want to assure the public that the Trust and the Board are doing everything in their power to safeguard the lives and livelihoods of its employees and our 22 parks for the people of this country now and for future generations.

BVI Adjusts Curfew As Active COVID-19 Cases Increase To 17

Minister for Health and Social Development Honourable Carvin Malone announced Cabinet's decision implement new curfew order after reporting five (5) new positive COVID-19 cases in the British Virgin Islands.

The total number of active cases now stand at 17 Honourable Malone accounted in a statement on August 24 that the Cabinet of the Virgin Islands will impose a new curfew for a fourteen (14) day period from August 26 from 5:01p.m. to 4:59 a.m. He stated that the first seven (7) days of the Curfew period will allow limited categories of businesses to operate which will be subjected to review. Those allowed to operate include supermarkets/ minimarts (limited to two persons per vehicle to shop); approved delivery services; pharmacies/drug stores; bakeries; banks (with limited internal operations, such as, but not limited to clearing of overnight deposits services); farmers and fisheries; fuel and LPG Stations; private health care providers, subject to approval of their client list by the Minister of Health; burials, subject to approval by the Minister of

Health; essential workers as defined in Section 3 of the Labour Code; and exempted persons as listed in the current Curfew Order, except item (n).

Honourbale Malone also announced visitation restrictions Her to Majesty's Prison, the Adina Donovan Home for the Elderly, Virgin Gorda Elderly Home, Rainbow Children's Home, Safe Haven Transition and other private residential facilities in an effort to suppress the spread of the COVID-19 virus.

Health Minister Honourable Malone explained that the decisions made by Cabinet were done after intensive review of the Health Operations Emergency Centre COVID-19 Situation Report taking into account the challenges that have arisen from activities seemingly spurred by greed; the measures required effectively contact trace, swab and test all suspected persons; and the desire to limit the movement of all residents without complete and total

lockdown of the Territory to allow medical teams the ability to complete their work without hindrance.

He closed his statement saying, "The Government of the Virgin Islands take continues to comprehensive approach in our efforts to protect public health by investing millions of dollars and the best available expertise across various disciplines. As the situation evolves, we must be prepared to change quickly based scientific evidence. Governments and health professionals cannot do this alone. It is also important to have active participation by every member of society."

A vocationally skilled youth for a stronger Virgin Islands

The training of Virgin Islands youth for the critical hands on, and vocational skills, required by the economy and community, is not an option

There has been a lot in the news recently on the anomalies of a workforce culture that keeps on importing migrant labor to the detriment of Virgin Islands Society.

Recently, a minister and politician warned of the unsustainability of a workforce that is 70% alien. When there

is this type of imbalance, it spills over into the wider community and impacts the wider culture, mostly negatively.

When migrant labor comes from places where the culture is similar to the VI culture – Guyana, Grenada, Antigua, Anguilla Trinidad, for example- then economic migration is sustainable, albeit numbers must be strictly controlled.

However, culture sets that are vastly different from the VI type can drive division and xenophobia, especially in a tiny community. Though politically incorrect, the culture of migrants is a factor when deciding what type of migrant to welcome into a society.

Now, The fact is that 70% of Virgin Islands youth migrate to the USA and elsewhere after leaving school, to seek 'better opportunities." And, most of these youth remain in the USA permanently.

Caribbean migrants to the US are caught up in the culture type and values set of the USA. This is a culture of an endless credit and debt cycle; consume and spend

orientation; and higher taxes. After a lifetime in the USA most migrants remain "struggling," and one paycheck removed from the debt collector.

In the USA our kids may earn vastly higher wages, but they frequently face discrimination and worse.

Feedback from a number of African migrants in the USA reveals a high level of unhappiness and dissatisfaction with life in the USA, in spite of the economic benefits. The saying is valid: money is not everything.

We all know that in the end those kids who remain in their own land for work and life will ultimately be better off. The geography and local culture is a natural cocoon, a shield and fortress, against a cold world, across the channel.

The migration of a significant percentage of the native population means the economy requires migrant labor to function as replacement labor.

The problem with this is that the learning skills in various areas of the economy, from construction and building maintenance, to auto and culinary, maritime and landscaping, and much more are lost to VI youth for good, and the economy has to depend on migrant labor for these critical disciplines permanently. And these migrants are the beneficiaries of this precious learning in technical and vocational skills, not our own children.

The solution is obvious. It is culture change. This Writer frequently emphasizes that the most successful people economically in the islands are vocationally trained, hands on, men and women. The vast majority of jobs, careers, and businesses are in the vocations. This is a cultural and economic reality in the Virgin Islands and wider Caribbean that is not going to change anytime soon.

Consequently, it is time to reorient the learning culture. The country must build a trade school linked with a national apprenticeship program. On the board of the trade school will sit the men and women who run the local economy: the multi-millionaire

plumber and super store owner, the powerful quarry owners, the boat yard manager, the car dealers, the building contractors, the heavy equipment operators, the oil and gas company, the electricity corporation, and so on and so forth.

This is a call for the business community to collectively mentor Virgin Islands youth to build a future where our young people become the businessmen and women of tomorrow, owning and driving the economy, and job growth, for the benefit of their own country.

If the Virgin Islands as a community fails to do this most critical task in ensuring the future of our youth, through apprenticeship and commercial mentoring, and look only to the bottom line, when we all inevitably pass on, the country will be taken over by alien cultures, and our kids will becomes slaves in their own land.

To be forewarned is to be forearmed.

Statement by Dr. The Honourable Natalio D. Wheatley on the Reopening Of Schools

TUESDAY, AUGUST 25, 2020 Good day and God's blessings to the people of the Virgin Islands. I come before you as Minister for Education to give you an update on the 2020-21 academic school year. The Chief Education Officer assembled a task force to come up with a plan for how teaching and learning would take place in this COVID-19 era of schooling, and I thank them for their commendable efforts in putting forward a solid plan. That plan was brought to Cabinet last week and was passed.

Following Cabinet's decision, I was scheduled to deliver a statement last week on the opening of schools. However, soon after, I received news from the Minister for Health that we had an additional case. Since that time, we have had several positive COVID-19 with a total of 17 presently active. Alarmingly, some of these cases are school aged children. Equally concerning is the fact that these positive cases were socially active and frequented crowded, festive social gatherings.

In light of this extremely serious reality, I cannot in good conscience proceed with the plan to reopen schools to face to face instruction. This will place administrators, teachers, support staff, and, our most precious resource, our children all at risk. I am aware of the fact that many are yearning for the return to the classroom, and I have received criticism from many who are advocating for opening the Territory up, but we must prioritize the health of our children and our people above all other considerations.

Therefore, we will return to

online learning for the rest of the year. This includes all public schools and private schools, and our primary, secondary, and tertiary learning institutions. Cabinet will reevaluate in the coming weeks and months to determine when it will be safe to return to the classroom. Until then we will continue to rely on the use of technology.

For private schools, classes begin as early as next Monday, 31st August 2020, and we will be providing orientation and training specifically for the educators, parents, students and support staff members of these institutions. The sessions begin on 1st September, 2020 with a focus on the online platforms, specifically, in the areas of Power School, the VIDE textbooks full usage, and Google classroom for assessment, evaluations and lesson planning.

On 7th September, as Minister, I will speak to all educators as I outline my strategic direction for the school year and declare the official school year opened. This will be followed by a Professional Day for Educators. The rest of that week will be used for Professional Development Planning and Preparation for the new school year. During the week of the 14th - 18th September, we will be conducting our Kindergarten Readiness Assessment and our Student Orientation, and on 21st September classes will begin for all public

The training and preparation for the upcoming term will have a very heavy emphasis on COVID-19 protocols and online pedagogy. We will partner with the Ministry of Health, specifically the Environmental Health Unit to run training sessions for staff and students. We wish to ensure that all educators and students understand the COVID-19 protocol and the role they must play in keeping our Territory safe. We must also provide psychosocial support

for educators and children

going through tough times as well as tackle stigma and discrimination as it pertains to COVID cases.

Certainly, I am aware of the challenges associated with online schooling, but given the threats to our health, it is the best alternative for educating our children. I continue to ask for employers to understand the plight of parents with schoolaged children; I continue to ask families and trusted individuals to make arrangements for these students' supervision. We continue to dialogue with

internet service providers for solutions to our connectivity problems, and we continue to thank donors who have provided laptops as we await our shipment of 500 devices.

More information on the reopening of schools will be forthcoming from the Ministry.

Now is the time to dig deep as a community. COVID-19 is big and bad, but our GOD is bigger! Let's tap into the divine source to find the resilience and endurance needed to conquer this monstrous pandemic. May God bless this beautiful Virgin Islands and keep us safe!

WASHINGTON - The president's son Eric Trump has refused to comply with a subpoena in a New York state prosecutor's investigation of the Trump Organization, court documents revealed Monday.

President Donald Trump's entire private business entity has yet to comply with subpoenas from New York Attorney General Letitia James, James said in court documents.

New filings showed that James' civil investigation is based, in part, on former Trump lawyer Michael Cohen's testimony to Congress and seeks to learn whether the financial filings for the president's business were inflated or deflated to obtain loans or reduce potential taxes. (NBC News)

VENICE - A 'typhoon' has swept the northeastern Veneto region with flash-flooding across the region. Gale-force winds, downpours and hailstorms have battered Verona, Vicenza, Padua and other cities. Social media have been flooded with images of people wading through chest-high water to save themselves.

There have also been pictures of many trees that have been blown down. Veneto Governor Luca Zaia signed a state of crisis decree for Verona and other comuni in the province. Venice was also affected by the wave of bad weather. Verona

was picking up the pieces and totting up the damage on Monday. (ANSA).

The massive explosion which devastated a large swathe of the Lebanese capital Beirut sent shock waves through the world.

UNITED KINGDOM - But could such a tragedy ever happen here? The SS Richard Montgomery ran aground and sank just off Sheerness back in 1944. And as our chief correspondent Alex Thomson has been finding out – the ship's wreck still contains thousands of tons of explosive ordinance. (ch4 News)

BRAZIL - Brazil's social mediasavvy leader is facing perhaps the most severe online backlash of his presidency after unsuccessfully trying to snuff out questions about his family's financial dealings by warning a journalist he wanted to "smash his face in".

Jair Bolsonaro issued the threat on Sunday, after a reporter from one of Brazil's leading newspapers asked him to explain why a former policeman with alleged links to Rio's mafia had paid thousands of pounds into the bank account of his wife, Michelle Bolsonaro.

Bolsonaro tells journalist he would 'like to smash your face in' over financial questions; but the menacing remark quickly backfired as Brazilian journalists flooded social media with the very same question. "President Jair Bolsonaro, why did your wife Michelle receive 89,000 reais from Fabrício Queiroz?" they tweeted in unison at Brazil's farright leader. Fabio Malini, a social media researcher who is tracking the backlash, said hundreds of thousands of internet users quickly joined the counter-attack against Bolsonaro. (The Guardian)

BEIJING, (Xinhua) -- U.S. Secretary of State Mike Pompeo, in his recent speech at the Richard Nixon Presidential Library, negated every aspect of China-U.S. relations, maliciously attacked the leadership of the Communist Party of China (CPC) and China's political system, and attempted to drive a wedge between the CPC and the Chinese people. He also wantonly criticized China's domestic and foreign policies, spread the so-called "China threat", and called for an anti-China alliance to contain China's development.

Pompeo's baseless, fact-distorting speech misrepresents history and the reality. It is full of ideological prejudice and driven by a Cold-War mentality. His remarks have not only been condemned by the Chinese people, but also criticized and opposed by sensible people in the United States as well as the international community.

HUNGARY - Hungary's six largest opposition parties pledged Thursday (13 August) to form an unprecedented wide-ranging alliance to challenge Prime Minister Viktor Orbán at the next general election in 2022.

Opposition parties accuse the nationalist Orbán of steering Hungary toward authoritarianism and away from mainstream democratic and European Union values.

The self-styled "illiberal" premier has regularly clashed with the EU over alleged backsliding on rule-of-law, migration, and human rights issues.

Orbán has won three consecutive landslides since 2010, partly due to election rule changes he oversaw.

But with around half of the electorate voting for opposition parties Orbán would be vulnerable to a unified front. (euractiv)

CAYMAN ISLANDS - Before the coronavirus crisis, Chris McLaughlin was making a decent living doing landscaping and handyman jobs. He didn't have formal qualifications but he was good with his hands and had a word-of-mouth reputation that allowed him to keep a trickle of cash coming in. But when the pandemic struck, his work came to a standstill. Now as Cayman comes back to life, many of his customers have left the island. The contracts have dried up and there is no certainty over where the next dollar is coming from. (Cayman Compass)


BARBADOS - Minister of Tourism and International Transport, Kerrie Symmonds, has encouraged small hotels and villas to maintain a hopeful and cheerful outlook, regarding the recovery of the tourism sector.



Limited Businesses Approved To Operate In The BVI's New Curfew Order

A limited listing of approved businesses and establishments are allowed to operate under the Curfew Act, 2017, Imposition of a Curfew (No.28) Order, 2020 in the British Virgin Islands.

They are as follows:

Supermarkets/minimarts;

Approved delivery services;

Pharmacies/drug stores;

Bakeries;

Banks;

Commercial farming and fishing;

Fuel and LPG Stations;

Private healthcare providers; and

Burial services subject to approval by the Minister of Health

All other businesses and establishments not listed are ordered to close effective today, August 26 to September 2. This comes after Minister for Health and Social Development Honurable Carvin Malone reported on August 24 of the 17 active cases of COVID-19. The purpose of the curfew order remains to control, suppress and prevent the spread of COVID-19 in the Territory.

Businesses approved to operate must ensure that operating times allow for staff to report to and leave work within the imposed curfew hours of 5:00 a.m. and 5:00 p.m.



R V I P F R E A C T I V A T E S INITIATIVE "IF YOU SEE SOMETHING, SAY SOMETHING!"

Tuesday, August 25 – The Royal Virgin Islands Police Force has reactivated the "see something, say something" initiative that was recently launched.

The phone number 368-9112, is once again, to be used to send texts or photographs via whatsapp of person/(s) Breaching the Curfew. It is also now to be used for information on persons entering the Territory illegally or persons aiding those entering the Territory illegally.

The initiative, which was officially rolled out in April 2020, is mainly to free up the main access numbers so that other offences may be immediately reported.

Any information given through this medium is confidential and would be given the confidence of discretion.

Freeze the Best of Summer

t's August, and that means I'm busily trying to figure out a way to preserve the smells and flavors of my favorite vegetables. I enjoy stocking my freezer with vegetables 've grown or bought in large quantities from local farmers. Your freezer is one of the pest ways to preserve the color and flavor of summer produce all year long. Here's some great tips for freezing the best of your favorite summer vegetables and herbs:

Can I Freeze Bell and Sweet Peppers Raw?

f you've picked a peck of peppers and have too many to eat, try freezing them. Peppers are one of those foods that can be quickly frozen raw without first blanching them. Here are some guidelines on freezing bell and sweet peppers raw:

Select crisp, tender, green or bright-red pods. Wash, cut out stems, cut in half and remove seeds. If desired, cut into 1/2-inch strips or rings. Good for use in uncooked roods because they have a crisper texture, or in cooked foods. Package raw, leaving no neadspace. Seal and freeze.

NOTE: To make it easier to remove only the amount of frozen bell or sweet peppers needed at one time, freeze sliced or diced peppers in a single layer on a cookie sheet with sides. Transfer to a "freezer" bag when frozen, excluding as much air as possible from the bag.



Can Tomatoes be Frozen Raw?

Like peppers, tomatoes can be frozen raw. Frozen tomatoes are best used in cooked foods such as soups, sauces and stews as they become mushy when they're thawed.

Select firm, ripe tomatoes with deep red color. Wash and dip in boiling water for 30 seconds to loosen skins. Core and peel. Freeze whole or in pieces. Pack into containers, leaving I-inch headspace. Seal and freeze.

TIP: Dip just a few tomatoes at a time into the boiling water or the water temperature may be lowered too much to remove the skins without overheating the tomatoes. Place hot tomatoes in a colander and rinse under cold water to make them easier to handle. A knife with a serrated edge works best for cutting tomatoes.

How About Freezing Fresh Herbs?

Wash, drain and pat the herbs dry with paper towels. Wrap a few sprigs or leaves in freezer wrap and place in a freezer bag, then seal and freeze. The frozen herbs can be chopped and used in cooked dishes. After freezing, the herbs usually are not suitable for garnish, as they become limp when thawed.

TIP: To extend the time frozen fruits and vegetables maintain good quality, package foods in material intended for freezing and keep the temperature of the freezer at 0 F or below. It is generally recommended that frozen vegetables and fruits be eaten within eight months for best quality.

GAZPACHO

This wonderful recipe for gazpacho is a great way to use a variety of your favorite herbs and summer vegetables.

- 6 large tomatoes
- 1 large cucumber, peeled, seeded and finely diced
- 1 large green bell pepper, finely chopped
- · 1 medium-sized red onion, minced
- 3 tablespoons red wine vinegar 2 tablespoons olive oil
- Juice and zest of 1/2 lemon 2 tablespoons fresh parsley, chopped
- · 2 tablespoons fresh basil, chopped
- 1/2 teaspoon hot sauce 1 teaspoon salt
- 1 teaspoon fresh ground pepper
- 1/2 teaspoon sugar 1/4 teaspoon nutmeg
- · 1 medium avocado, peeled and diced, for garnish
- · 1 cup herbed croutons, for garnish
- To peel the tomatoes, submerge them a few tomatoes at a time in boiling water for 15 seconds. Place in a colander and rinse under cold water. The skins should slip right off. Core the tomatoes and gently squeeze out the seeds. Chop half of the tomatoes coarsely and puree the other half in a food processor. Combine the puree and chopped tomatoes in a large mixing bowl.
- 2. Add the cucumber, bell pepper, onion, vinegar, olive oil, lemon juice and zest, parsley, basil, hot sauce, salt, pepper, sugar and nutmeg to the tomatoes. Mix gently to blend the ingredients. Cover and refrigerate for several hours before serving.
- Serve chilled. Garnish with the avocado and herbed croutons, if desired. Makes 6 servings.

CDC Reduces Saint Lucia's COVID-19 Rating To Level 1, **As One Of Only Eight Countries Globally** period of July to August 2020 to date, Saint

CASTRIES, August 24, 2020 - Saint Lucia's response to the COVID-19 pandemic in ensuring a safe and strategic approach to the reopening of the economy, is receiving rave reviews the world over. The Center for Disease Control (CDC) has now reduced Saint Lucia's COVID-19 rating to the lowest, Level 1, as one of only eight countries globally, noting that "over the last 28 days, new cases of COVID-19 in Saint Lucia decreased or stabilized."

An August 21, highlight by AOL captioned, "How much it costs to live in 15 COVID-free countries" has rated Saint Lucia as the #2 country in the world that could provide you with a gorgeous and safe place to wait out the

Saint Lucia welcomed its first commercial flight on July 9, with a measure of strictly

enforced protocols in place which include pretesting within seven days of arrival in the destination, mandatory screening on arrival, use of certified taxis and hotels, a 14-day quarantine period for non-bubble countries, the wearing of masks in public and observing physical distancing.

"This is even more validation of our country's success in the management of COVID-19," said Prime Minister Honourable Allen Chastanet. "We have to keep following our protocols and ensuring that pre-testing is done before visitors arrive in Saint Lucia. This takes the support and cooperation of all the stakeholders in the travel industry."

The Saint Lucia Tourism Authority and the Ministry of Tourism has praised the endorsement as timely as it encourages visitors

to enjoy an extended stay on a relatively affordable budget.

Chairman of the National COVID-19 Response Committee and Minister for Tourism, Honourable Dominic Fedee said, "It is an honour to see that the Strategic approach to responsible reopening the tourism sector, dedication and sacrifice of the Government, frontline workers and the cooperation of the public is topical in international jurisdictions. All measures by the government are geared are ensuring that livelihoods are restored while keeping local communities protected from the

US Cyber Forces Go Hunting for Election Trouble

U.S. forces are taking an election now less than three aggressive approach in cyberspace ahead of November's presidential election, aiming to wipe out threats from foreign countries and other actors before they have a chance to disrupt voting or other critical, election-related systems.

"Cyber Command needs to do more than prepare for a crisis in the future; it must compete with adversaries today," Gen. Paul Nakasone, head of U.S. Central Command, and senior adviser Michael Sulmeyer said in a piece published Tuesday in Foreign Affairs magazine.

The strategy, described by top officials at U.S. Cyber Command as "hunt forward," reflects the military's increased desire to move away from what they describe as a "reactive and defensive posture," and confront evolving threats head-on.

"U.S. forces must compete with adversaries on a recurring basis, making it far more difficult for them to advance their goals over time," the officials wrote, outlining the strategy for the public with the presidential

months away. "Additionally, cyber effects operations allow Cyber Command to disrupt and degrade the capabilities our adversaries use to conduct attacks."

Nakasone and Sulmeyer say the more proactive approach to protecting the upcoming U.S. election began, in part, in October 2019, after a team from Cyber Command traveled to Podgorica, Montenegro, to investigate attempts, possibly by Russia, to infiltrate that country's networks.

In the process, the Cyber Command team "saw an opportunity to improve American cyber defenses ahead of the 2020 election," they said in the article.

Nakasone and Sulmeyer also say they are building on efforts from 2018, when Cyber Command joined with the National Security Agency to form the Russia Small Group (RSG) to help protect the congressional mid-term elections, shoring up vulnerabilities within the U.S. election infrastructure, sounding alarms about Russian disinformation campaigns, and hunting for malware.

"Thanks to these and other efforts, the United States disrupted a concerted effort to undermine the midterm elections," they wrote. "Together with its partners, Cyber Command is doing all of this and more for the 2020 elections."

Managing risk

Critics point out that the more aggressive approach to cyber defense carries risks. Namely, they worry that whether due to a miscalculation or an accident, a confrontation in cyberspace could escalate and lead to all-out war.

But U.S. Cyber Command officials argue the risk is manageable and that the "hunt forward" strategy allows them to impose necessary costs on adversaries like Russia, China, Iran and North Korea.

"Inaction poses its own risks: that Chinese espionage, Russian intimidation, Iranian coercion, North Korean burglary, and terrorist propaganda will continue unabated," Nakasone and Sulmeyer wrote in the magazine. "So, the question is how, not whether, to act."

Determining whether Cyber Command's "hunt forward" approach is paying off may be difficult.

U.S. officials charged with protecting key voting-related systems said at least so far, there are no signs of any country-directed attacks on the United States.

"We are not and have not seen specific targeting of those election systems that has been attributable to nation-state actors at this time," Matthew Masterson, senior cybersecurity adviser for the Cybersecurity and Infrastructure Security Agency (CISA), told the Atlantic Council on Tuesday.

"(We) aren't seeing a broad campaign in that way," he said, adding, "We're cognizant that's in the playbook."

Evidence of meddling

Earlier this month, U.S. counterintelligence officials warned they have evidence that Russia, China and Iran are trying to meddle with the November election.

"We assess that Russia is using a range of measures to primarily denigrate former Vice President (Joe) Biden and what it sees as an anti-Russia 'establishment," National Counterintelligence and Security Center Director William Evanina said in a statement.

"Some Kremlin-linked actors are also seeking to boost President (Donald) Trump's candidacy on social media and Russian television," he added.

China and Iran, according to Evanina, appear to prefer a Biden presidency.

Covid-19 and its consequences for Caribbean diplomacy By Sir Ronald Sanders Covid-19 and its consequences for diplomacy name, but its quality will be gravely undermined.

The COVID-19 pandemic is severely limiting the work of diplomacy. It could have a lasting adverse effect on international relations if finding a vaccine continues to elude global researchers for much longer.

Critical to the work of diplomacy, at every level, is interpersonal contacts at which relationships are forged, attempts are made to iron-out differences, or, at least, some deal is struck - even if it is to defer divisive decisions.

But the protocols of managing the coronavirus has halted such contacts. Physical meetings and conferences have been replaced by constrained, strait-jacketed, virtual meetings. Restaurants, famous as venues for deal-making, are firmly shut. The result is that off the record discussions are simply not possible. There would be few in the diplomatic world who do not assume that telephone calls, and discussions on virtual digital platforms are not recorded - therefore as little as possible is said, constraining the possibility of compromise.

Since March, it has been impossible for diplomats in international organisations, such as the United Nations bodies and the Organization of American States (OAS), to conduct face to face meetings either in Councils or in one-on-one discussions.

In Washington, for instance, US government buildings, offices of members of the US Congress, and Embassies have been closed to the public with most officials and diplomats forced to work from home. Meetings, conferences, and bilateral discussions have had to be held on virtual digital platforms like Zoom and Kudo. But while these meetings are better than nothing, they are inadequate to the task of diplomacy much of which relies on interpersonal contacts.

The OAS now holds all meetings of its Permanent Council and Committees through a virtual platform. Subsequently, representatives make speeches at each other. Lost is the opportunity for dialogue that could help to bridge the divide between governments. Meetings lack spontaneity and flexibility. Often, they are interrupted by failures in technology.

The most significant injury to multilateral diplomacy is that diplomats cannot negotiate effectively by disembodied virtual means. example, negotiating resolutions and declarations is a painstaking process in which every word matters. One word could change both meaning and intent. Therefore, great care is placed on the consequences of the use of a word to a country.

As an example, the words "Climate Change" and "Global Warming", much as they represent existence and survival to small states, conjure a different importance for industrialized countries, particularly those that deny the existence of both phenomena. The intense negotiations, required to reach an understanding, if not an agreement, on the use of these terms, are undercut by the restricted nature of online meetings.

One of the big challenges that the OAS will face in October is how to persuade Foreign Ministers from 33 countries to sit in front of their computers at home over two days to participate in the Organization's General Assembly, its highest decision-making body. The meeting will be held in

General Assemblies are more effective for the opportunity they provide for Ministers to talk with each other outside the formal Council. It is in the corridors and in the lounges that problems are overcome, new relationships are forged, and old ones strengthened. There will be no such opportunity this year. Indeed, a raft of new Foreign Ministers, including three new ones from Guyana, Suriname and Trinidad and Tobago, will not have the chance to meet their counterparts from the US, Canada, and Latin America.

The problem is also acute at the United Nations both at the levels of the Security Council and the General Assembly. Up to July, the Security Council could not vote on important issues because its rules do not allow for such voting at informal meetings which is how virtual meetings are characterized.

Recently, representatives have gathered physically once a week to vote on some important issues, but, even so, the work of the Security Council is greatly delayed and impaired. Significantly, this has suited the bigger powers that have taken advantage of Security Council paralysis to advance their national positions, and even their rivalry.

Similarly, in the UN General Assembly, no formal electronic voting system has been established because some members still resist it. Consequently, resolutions can only pass by consensus of all member states. Since such consensus cannot be negotiated, only minimal compromises are made. That, too, suits the few giant nations, long intolerant of the many dwarf countries.

All of this makes the world a less safe place. It provides the opportunity for powerful countries, which have the capacity for non-commercial travel, to make arrangements with other countries, outside of the multilateral system. Invariably, these arrangements serve the interests of the more powerful government.

There is no question that meetings held on virtual platforms have proven that they are beneficial for some purposes. If they continue, they will save governments and businesses a great deal of money that, hitherto, had been spent on travel and accommodation.

They should be retained for routine meetings on non-controversial issues.

But for hard-bargaining and on matters that require careful negotiation, virtual meetings are unhelpful to diplomacy whose effectiveness depends on interpersonal contacts, building relationships and the ability to explore possibilities that are not formally on the table.

Small states, like those in the Caribbean Community (CARICOM) are being left out - and left behind. Unlike powerful states, they need a functioning multilateral system in which to represent their interests - right now that system is fractured even more than it was prior to COVID-19.

The effects of the pandemic have limited the diplomacy of Caribbean state, including their capacity to negotiate with the nations whose policies most greatly affect them.

This situation calls for more cohesive policies by CARICOM governments and collective action by all of them in every international organisation.

ision is Key to Success

American billionaire, mega financier Warren Buffett a few years ago told The Economist that anything good that happened to him "could be traced back to the fact that he was born in the right country...at the right time (1930)".

We are confident that there are many successful BV Islanders who feel that anything good that happened to them had a lot to do with the fact that they were born here (or they belong here) and that they came on the scene at a time when business was growing to levels beyond the wildest imagination.

Many years ago we published an editorial that stated that real leaders are tested in troubled times, not in good times. This remains true, now more than ever. In Buffett's case, being in the right place at the right time played a decisive role in his life. To varying degrees this can be true for most of us.

Up to not too long ago BVI leaders had been born before or during World War II. They knew first hand what hardship was, they knew their roots, and they had vision. No wonder that the late H. Lavity Stoutt' most successful motto was "Where there is no vision the people perish" (Proverbs 29:18).

As time went by, the post-war generation gradually replaced the pioneer leaders, and as we entered the new millennium the next generation born in the 1960s and 1970s began securing solid positions in the political arena.

We seem to come full circle: from the leaders who went through rough times, to those who saw and learnt what it took to be successful, to the generation raised in the age of plenty in whose hands the collective destiny of the BVI now lies.

Times have changed and the global economic crisis is here to stay for quite a while. The 2017 hurricanes recovery is still underway, but COVID has set in to complicate everything. That does not mean that there will be little or no opportunity for growth, quite the contrary -- there might be more than we expect, but our leaders must be focused, honest, and must have a clear and sharp vision and be in the right place at the right time.

Every new generation is labeled with incompetence, arrogance and lack of vision; yet experience has shown us that the leaders we had misgivings about were instrumental in piloting developments that changed our destiny for the better. Two simple examples come to mind: do you remember the vitriolic opposition H. Lavity Stoutt had to endure when he launched the Community College? And has everyone really understood the importance of the International Business Companies legislation introduced by the Cyril B. Romney government in the mid-1980s? Those two examples are real milestones that will consign to posterity true leaders like Stoutt and Romney.

The new generation has largely benefitted from these historic developments, but now they are also confronted with new, unprecedented and gigantic challenges.
