PRESENCE OF ROYAL NAVY CRITICISED BY PREMIER


The invitation to have HMS Medway - a UK Naval vessel - patrol the waters of the Territory has resulted in a major political issue that resulted in Premier and Minister for Finance Hon. Andrew Fahie penning a letter to Baroness Sugg CBE, the United Kingdom's Minister for Overseas Territories and Sustainable Development at the Foreign, Commonwealth & Development Office (FCDO), with further threats to report the matter to the United Nations.

The Premier's response was prompted by His Excellency Governor Augustus Jaspert decision to invite the vessel to patrol the Territory's waters following recent reports of correlation between illegal smuggling and a COVID 19 spike.

Nonetheless this move by the Governor was viewed by the Government as undermining of its authority considering Hon. Fahie's previous announcement that he was against the UK Navy intervening to help keep the borders protected. In fact, last month the Premier admitted that his government turned down the offer for UK border patrol. The Premier during a press conference stated that he was satisfied that the joint task force currently securing the borders was sufficient.

However, the Governor did not seem to agree and since border security falls under his portfolio Mr. Jaspert announced on 25 September that the UK Navy will be here to watch the borders at no charge to the BVI.

The Governor, while announcing that the UK vessel HMS Medway will be here, spoke highly of the work that the currently in place Joint Task Force has been doing to man the borders. "A great deal of hard work has already gone into tackling this challenge. In March, we took decisive action to close the borders in response to COVID-19 and set up the Joint Task Force - made up of officers from the Royal Virgin Islands Police Force, the Immigration Department, and Her Majesty's Customs. Officers have worked 24 hours a day, 7 days a week, with limited resources and under intense pressure. Their work has been commendable and has resulted in a number of illegal entries detected and countless more deterred."

Her Majesty' Representative in this Territory said that his decision was pushed by the fact that over recent weeks the BVI recorded its highest number of COVID-19 cases yet. He said that although it is unknown how the recent spike of cases started, the risks and consequences of just one or two illegal entries to the Territory is well known. Therefore, the Governor said that as the BVI begins to relax internal restrictions, work needs to be done to ensure there is no hampering of the progress being made to prevent individuals from other islands and migrants slipping in illegally through the back door.

"As your Governor, it is my constitutional responsibility to protect the people of the BVI and ensure the security of these islands. That is why I made an offer of UK security support earlier in the year, alongside the medical, technical and other support being provided by the UK. I was disappointed that the offer of security support was not accepted at the time, as I felt it was a missed opportunity to enhance our local capability and protect our community from external risks. I have continually pressed this as a priority with colleagues. Now, in light of recent events and subsequent consequences, I feel I must do all in my power to protect the people of the British Virgin Islands and to support our dedicated law enforcement teams," he explained.

A BV Islander told The Island Sun that if the UK offer would have been accepted from day one we would not have had infiltrations of drug smugglers, people smugglers and other criminals – as a result we had to "endure" repeated lockdowns which were described as "calamitous for the private sector and BVI citizens".

Premier Peeved

In a letter sent to Baroness Sugg on 25 September by the Premier, which was allegedly leaked to the media and partially published revealed Hon. Fahie was peeved by the Governor's statement on the matter.

The Premier is quoted stating,"I am writing to express my dissatisfaction and outrage with the hijacking of the Territory's sea border protection by your Governor on the basis of a grossly inaccurate and exaggerated misrepresentation of the true state and extent of the capabilities of the BVI's resources and the threat that the Territory faces during COVID-19."

The BVI Leader accused the Governor of attempting to sow discord between the people and government. Further the Premier said that the decision was one that was spoken to before and was turned down. Hon. Fahie wrote: "Governor Jaspert's intention to deliberately bulldoze the elected Government is pellucidly clear as he has issued a public statement at 6 pm local time today, 25 September 2020, informing the public that the UK Government would be providing various things which my Government and I have not asked for and which we advised him of our objection to in the format in which he is proceeding to act. He has further, and yet again, made statements aimed at injuring the relationship between the people of the Virgin Islands and their democratically elected Government, and conducted himself in a manner that jeopardises the relationship between the BVI Government and the UK Government."

The Premier then proceeded to accuse the UK government of imperialistic behavior. He stated, "Your Governor's imperialistic, rough-shod behaviour in this matter is offensive and insulting to my Government and I, as well as to the aspirations of the people of the Virgin Islands who are struggling to realize the centuries-old dream of their enslaved ancestors to one day be fully free of the grip of the British, as encapsulated in Article 73 of the United Nations Charter."

The BVI commentator said that "the Governor had the authority to do what he did, and the move was in the best interest of this Territory".

Strained Relationship and UN Complaint

Over the last few months there have been rumors that the Governor and the Government were not seeing eye-to-eye. However, despite various tongue in cheek comments both entities have been sure to avoid the appearance of conflict. However, this downplaying seemed to have been through out the door as the Premier in his letter to the Baroness spoke of a tense National Security Council meeting where the Governor reportedly became 'adamant' and 'aggressive'.

Hon. Fahie said that the government's contention is that Governor Jaspert exaggerated the reason for the UK's intervention by making the situation appear more serious and dire that it was. "To describe the BVI" situation as exasperated and our resources as stretched, as Governor Jaspert has done in his NSC paper, is an exaggeration and grossly misrepresents the state of affairs on the ground. To use this fabricated case to create justification for UK interventions is dishonest. To suggest that the UK Military and Government must swoop in and rescue the BVI people is highly insulting, considering that neither the BVI'border protection nor our public health situations are out of control. The evidence is that these are being well managed by the Government of the Virgin Islands and our people," Hon. Fahie explained.

The Premier said that noting the mentioned exaggeration he requested that the Governor amend his report but the Governor refused. "When asked to amend his NSC paper to more accurately reflect the state of the Territory's affairs and needs, and to keep the UK involvement within the scope of what was requested, Governor Jaspert was adamant that

he would not. The meeting ended with the NSC not agreeing to the structure of Governor's paper following an extended session in which Governor Jaspert' demeanour became quite aggressive."

Further the Premier said that he was not informed of the Governor decision prior to the public announcement as was actually made aware by facebook notification, "Around 6pm this evening, I was advised via a facebook post of a public statement issued by the Governor in which he announced that the HMS Medway would be in the vicinity of the BVI for the month of October and that he is working to put in place a package for permanent border surveillance in spite of the wishes of the BVI people that they would like to do this on their own. The Governor, yet again, went on to state to the public that my Government has declined and resisted the UK's offer to assist in border protection, even though the records show that I have consistently stated that there is a role for the UK and that I have been asking Governor Jaspert for months to provide me with the details of the UK' offer, which request he has consistently ignored."

Additionally, Hon. Fahie also threatened to report the matter to the United Nations.

Public opinion is divided but a segment of the population and business sector has expressed in various forms that "there is a lot the Royal Navy can do to clean our waters, it is needed at this point in time and... other times".

Minister Reviews CXC CSEC Results

Despite the school and education disruptions caused by the COVID-19 Pandemic the Territory's did well and scored high grades at this year's CXC CSEC sittings.

Sharing the results in the House of Assembly on 28 September Minister for Education Dr. the Hon. Natalio Wheatley said that he was pleased with the students performance. While lauding the results the Education Minister declared, "Given the fluid nature of the COVID-19 pandemic and its implications, our students persevered through many psychological, social and emotional challenges. This pandemic forced our students to deal with great uncertainty, adapt to new

learning conditions and adopt new studying practices."

The presence of COVID-19 was visible in the 2020 result statistics as the Minister noted that the BVI recorded ungraded and absenteeism as a result. He noted, "The Ministry of Education recognises this high number of absenteeism and ungraded results and aims to put further measures in place for students, parents and examination centres to reduce these occurrences and significantly improve in these areas for the next sitting."

However, this absenteeism and ungraded notation was not listed as a major block dot when compared to 2019. In bringing this point across Hon. Wheatley pointed out, "The rate of absenteeism or ungraded results was similar to that of 2019. Of the 1,489 examinations registered for the July/August sitting, only 1,325 grades were awarded. This means that 164 exam entries were not sat or graded. The modification in the SBA moderation processes due to the COVID-19 pandemic affected the ungraded results."

It was noted that this year saw changes in the administration of the exams. For instance, there was a change in the format and scheduling of the CXC exams components. Students received grades reflecting School Based Assessment scores and the Paper 1 (Multiple Choice) examination in the majority of subjects. The delayed scheduling of exams to July/August meant that students sat exams well beyond the usual end of the school year, deeper into our hurricane season and even as the students engaged in the annual emancipation holiday activities. Usually, the Territory would have had CXC exams administered for CPEA, CSEC and CAPE, but this year, due to COVID-19, the Ministry made a decision to cancel CPEA examinations.

For 2020 a total of 358 candidates registered for one or more subjects for the CSEC examinations, as compared with 375 candidates in 2019. Of this total, 280 were students attending public secondary schools, 71 were from private secondary schools and seven were private independent candidates.

A total of 27 CSEC subjects were written by candidates, as compared with 28 CSEC subjects in 2019. The subjects with the highest number of entries were English A (232), Mathematics (226), Electronic Document Preparation and Management (175), Human and Social Biology (142) and Principles of Business (117).

Of the 358 students who wrote the examinations, 15 students passed a total of 8 subjects, 20 students passed a total of 7 subjects and 22 students passed a total of 6 subjects.

NHI Anomalies "Cannot Continue": Hon Fraser

It has been described as a Russian roulette situation for residents who need to go abroad for treatment using NHI; and Opposition Member and Third District Representative Hon. Julian Fraser has called on the government and Minister for Natural Resources and Labour Hon. Vincent Wheatley to fix the problem because a number of persons who need overseas treatment are denied by NHI.

Hon. Fraser while speaking in the House of Assembly on 29 September decried the fact that many of the private health insurance policies that existed prior to NHI coming on stream were cancelled because the National Health Insurance was made mandatory.

According to Hon. Fraser even the Government of the Virgin Islands got rid of its private health coverage to facilitate NHI offers and now Hon. Fraser stated that NHI has become a 'monster': "Anybody in this Territory who wants to pretend that we don't have issues with NHI is a hypocrite; either a hypocrite, Mr.

Speaker, or they are living in la la land. Before NHI we had private health care; as a government we had Atlantic Southern. One time we had Lloyds of London," the Opposition Member declared.

While noting that some persons were forced to give up good insurance for the mandated NHI Hon. Fraser questions the benefits of the trade. He told the House: "You can get care anywhere in the world with the private healthcare that you had, anywhere in the world. Government came up with a plan where it made it mandatory. NHI is mandatory so those companies that were offering this private healthcare, some were copays; some were free - it made no sense to have both because on the one hand one was mandatory and the other one it is voluntary..."

The seasoned Representative openly wondered if things got better with NHI coverage as opposed to private coverage: "Majority of companies got rid of their private insurance and so did government; government got

rid of theirs and moved to NHI. If you want to go overseas for treatment – it is almost a no no. what you have to go through... The majority of Virgin Islanders if they want to go overseas for treatment it is almost a no no. Many times you get rejected from the NHI itself and when you do get acceptance to go abroad you are going there on a wing and a prayer...This thing is a monster and it has problems – has to be addressed."

In noting that some areas of NHI were left undone, the Opposition Member recalled the early days of the NHI and suggestions that were expected to be used to solve problems. "When NHI was about to be born we had discussions, questions were asked. Some answers were given ...others were to be looked at and considered. You would have thought that you would have heard what the outcome was."

Unemployed Persons Burdened

Hon. Fraser, in further lamenting that there were areas within the NHI that were supposed to be tweaked, noted that one such area was the accommodating of unemployed persons. Unfortunately the legislator said that this was never done and now persons who are without work are forced to pay their contributions and the employers contribution even though they have no income coming in.

"If you don't pay contribution to NHI you end up being delinquent; and if you are delinquent, Mr. Speaker, it means that you don't get any coverage and if you were to take ill during that period of delinquency you're on your own. These anomalies cannot continue because what they are doing they continue robbing the poor guy. You got a number of people out there that are delinquent, a number of them for a lot of money."

Meanwhile, Hon. Fraser emphasized that he was not against the NHI. In fact, he stated that he was one of the biggest supporters: "Don't get me wrong, I am a proponent of NHI,

I believe it is necessary because I remember what happened before NHI when a number of people didn't have any insurance at all, none whatsoever and the only recourse that they had was to resort to government for some assistance; so I am a proponent of NHI but it must work properly in order for me to support it. These are kinks that need to be straightened out."

"We have a Lot to Consider": Deputy Premier

Deputy Premier and Minister for Education Culture, Youth Affairs, Agriculture and Fisheries Hon. Natalio Wheatley has downplayed the requests made for the government to present its plan for the Territory's recovery from COVID 19 and its alleged decision not to meet with stakeholders in the tourism sector. As it relates to both claims Hon. Wheatley said that those criticizing have ulterior motives and that government has done both things.

The Deputy Premier's comment comes as at least two members of the Opposition criticized the government for moving forward with the naming of a reopening date without meeting with tourism stakeholders to apprise them of what would be required for their incoming tourists.

One of the persons complaining that the stakeholders

were not involved was Leader of the Opposition Hon. Marlon Penn who spoke in various occasions that he believed that the government should have consulted with the business community about the plans for the next tourism season.

The other person raising concern is Second District Hon. Melvin Mitch Turnbull who during the 29 September sitting of the House of Assembly told legislators that his District is dependent on tourism and stakeholders in his areas are clueless about the reopening plans because of limited information.

The Opposition Member said, "My question is, what is the plan?" What is the plan for the businesses as we prepare to reopen this border? The industry meeting needs to happen, so everybody can understand what goal they are working towards to get themselves back into business because it would be a shame for us to reopen this territory looking the way it is."

However, Hon. Wheatley in later comments in that sitting of the House suggested that there are some insincere requests for a plan and stakeholder consultation. He told the House, "One of the things the political opportunists say is that the government doesn't have a plan: that's one of the things that is popular, and Mr. Speaker, I wish I would have said something earlier because when you don't respond to these things sometimes they become gospel."

Hon. Wheatley said that the comments that are being made about the Government not having a plan is a swipe at the senior civil servants who have presented plans to the Government: "Mr.

Speaker, in government one thing that you can always find is a plan, but sometimes we don't have the will to execute the plan but you go on the shelves in any of these ministries, you go find a bunch of plans, because, Mr. Speaker, we have technical persons. They are professionals, you think that they would come to Cabinet and advise Cabinet and they have not put a plan together? It is almost an insult to their intelligence. The persons who out there are saying we don't have a plan they might be thinking that they making the government look bad but it is actually like a condemnation on our senior civil servants who are the ones who put these plans together," Hon. Wheatley announced.

The Minister said that the comments are disingenuous and that the persons asking for the plans are just looking for areas to criticize.

As it relates to the Opposition's concern that there was no consultation with the private sector in relations to the reopening, Hon. Wheatley said, "Mr. Speaker, we speak about consultation. I don't know (if) there is a government in history that has consulted more than this particular administration; and now that we have Zoom it is even worse. We have the videoconferencing. There was a time when this government was jumping from one Zoom call to another with different stakeholders. Don't say that we haven't consulted the various groups because we have. Now, it doesn't mean that we will take every little bit of advice because we have a lot to consider."

2020 CXC CSEC and Cape Results

Today, I am pleased to present to you a synopsis of the Territory's performance in the 2020 CXC Caribbean Secondary Education Certificate (CSEC) examinations and CXC Caribbean Advanced Proficiency Examinations (CAPE). Given the fluid nature of the COVID-19 pandemic and its implications, our students persevered through many psychological, social and emotional challenges. This pandemic forced our students to deal with great uncertainty, adapt to new learning conditions and adopt new studying practices.

This year saw the change in the format and scheduling of the CXC exams components. Students received grades based on School Based Assessment scores and the Paper 1 (Multiple Choice) examination in the majority of subjects. The delayed scheduling of exams to July/August meant that students sat exams well beyond the usual end of the school year, deeper into our hurricane season and even as we engaged in our emancipation holiday activities. Usually, the Territory would have had CXC exams administered for CPEA, CSEC and CAPE, but this year, due to COVID-19 again, we made a difficult, but necessary decision, to cancel CPEA examinations.

As your Minister for Education, I offer sincere congratulations to all our students who have been successful and commend those who have contributed to their success.

Exam Registration & Passes

This year, a total of 358 candidates registered for one or more subjects for the CSEC examinations, as compared with 375 candidates in 2019. Of this total, 280 were students attending public secondary schools, 71 were from private secondary schools and 7 were private independent candidates.

A total of 27 CSEC subjects were written by candidates, as compared with 28 CSEC subjects in 2019. The subjects with the highest number of entries were English A (232), Mathematics (226), Electronic Document Preparation and

Management (175), Human and Social Biology (142) and Principles of Business (117).

We were able to accommodate one transfer student from Guyana and one student from the Cayman Islands, who had to sit exams locally due to the COVID-19 pandemic.

All centres continued to employ the E-testing modality, which allowed for a more efficient administration of the exams, especially under COVID-19 conditions. Grades I, II and III were earned in 78% of the subjects entered. There were a total of 9 subjects with 100% passes; these are:

- Agricultural Science (Double Award);
- Agricultural Science (Single Award);
 Visual Arts;
- Physical Education and Sport; this shows an increase of 1.1% in 2019
- · Food, Nutrition and Health;
- · Family and Resource Management;
- Technical Drawing;
- Industrial Technology (Mechanical);
- · Information Technology.

Subjects with passes from 90% to 99.99% are:

- Electronic Document Preparation and Management (98.8%) – 0.7% higher than 2019
- Integrated Science (94.7%)
- English A (91.4%)
- Overall, 15.6 % of all subject entries were Grade I passes, 30% were Grade II passes and 32.6% were Grade III passes.
- Mathematics and English A (English Language)

Two hundred and seventeen (217) students sat the Mathematics exam, with 113 or 52% receiving Grades I, II or III passes; this 52% has been identified as the regional average in CSEC Mathematics by the CXC Registrar General and Chief Executive Officer, Dr. Wayne Wesley, in his remarks at the launching ceremony of the 2020 results. Thirteen students or 6% of the students received Grade I passes in Mathematics, territory-wide.

One hundred and ninety-eight students sat the English A exam, with 181 or 91.4% receiving Grades I, II or II passes with 45 students or 23% of the students receiving Grade I passes in English A.

Decrease In Active Covid-19 Cases As BVI Reports 66 Recoveries

Minister for Health and Social Development Honourable Carvin Malone has reported a significant drop in active cases of COVID-19 with 66 recoveries now confirmed.

Minister Malone further reported that as of September 28, of the 71 total positive COVID-19 cases recorded, the active cases now stand at 4 and one death. The total number of persons tested for COVID-19 virus stands at 4,841.

Members of the public are urged to continue to report any suspicious activity by dialing 311 and to adhere to all safety measures such as hand hygiene, cough etiquette, wearing face masks in public, physical distancing and minimising social gatherings.

Persons who are experiencing any symptoms related to COVID-19 are reminded not to visit any healthcare facility but are encouraged to contact the Medical Hotline at 852-7650 for an assessment and an appointment for COVID-19 testing. Common symptoms include fever, cough, headache, fatigue, loss of taste or smell, sore throat, muscle aches, or difficulty

breathing.



Chair Of Joint Taskforce Corrects Inaccurate Report

Chair of the Joint Taskforce, Acting Commissioner of Customs, Mr. Wade Smith clarified an inaccuracy reported by BVI Platinum News article tilted, Twin-Engine Fast Boat In High Sea Pursuit With Joint Patrol Team Reportedly Released.

Mr. Smith said that the vessel was detained by Her Majesty's Customs and the matter is still under investigation. The vessel may be in breach of a number of legislations including Customs, Immigration and Curfew order.

The Joint Task Force is a collaboration between officers of Her Majesty's Customs, the Immigration Department, and the Royal Virgin Islands Police Force. The Task Force was established to increase surveillance and enforcement on sea and land during this COVID-19 era. This multi-agency approach to law enforcement has taken a zero-tolerance stance to crime on land and sea and seeks to foster safer communities for legal residents.

The officers involved have expressed their commitment to remaining focused on playing their respective roles in keeping the BVI safe during this pandemic and beyond.

Statement by His Excellency the Governor Augustus J.U. Jaspert On Strengthening Our Security

25 September, 2020



His Excellency the Governor Augustus J.U. Jaspert

I would like to provide an update on plans for further UK support that will strengthen the integrity of our borders and improve the security of the people of the British Virgin Islands.

There has been a great deal of discussion on this topic in recent months—not only private discussions in the National Security Council, but also public debate in communities across BVI. We all recognise the challenge at hand, which is to protect and secure our wide sea borders from illegal entries, the smuggling of narcotics and money, and the ongoing threat of COVID-19. We have long

faced vulnerabilities of our waters being abused by a very small minority and the risks of COVID-19 have heightened these vulnerabilities.

A great deal of hard work has already gone into tackling this challenge. In March, we took decisive action to close the borders in response to COVID-19 and set up the Joint Task Force - made up of officers from the Royal Virgin Islands Police Force, the Immigration Department, and Her Majesty's Customs. Officers have worked 24 hours a day, 7 days a week, with limited resources and under intense pressure. Their work has been commendable and has resulted in a number of illegal entries detected and countless more deterred. On behalf of the people of BVI, I would like to say thank you to our law enforcement officers for their work. I am also grateful for the National Security Council's support to the Joint Task Force.

It is now almost six months since those border restrictions were introduced and it is important that we take stock. During this time, the National Security Council, my team

and I have stayed in close contact with the Joint Task Force to understand the evolving challenge and their needs. This has heightened over recent weeks, as BVI has recorded its highest number of COVID-19 cases yet. We cannot know for certain how the recent spike of cases started, but we are well aware of the risks and consequences of just one or two illegal entries to the Territory. Our health teams continue to do excellent work to tackle the virus and I am thankful to the entire community for playing their part by complying with the restrictions and curfews in place. As we start to relax internal restrictions, we need to ensure we are not hampering the progress we make by letting COVID-19 slip in illegally through the back door.

As your Governor, it is my constitutional responsibility to protect the people of BVI and ensure the security of these islands. That is why I made an offer of UK security support earlier in the year, alongside the medical, technical and other support being provided by the UK. I was disappointed that the offer of security support was not

accepted at the time, as I felt it was a missed opportunity to enhance our local capability and protect our community from external risks. I have continually pressed this as a priority with colleagues. Now, in light of recent events and subsequent consequences, I feel I must do all in my power to protect the people of the British Virgin Islands and to support our dedicated law enforcement teams.

To tackle the immediate threats to our border security, I am pleased to announce that HMS Medway will shortly return to our waters to offer additional support with surveillance and act as a deterrent. HMS Medway is a British Royal Navy patrol ship, designed for counterpiracy, anti-smuggling, fishery protection and border patrol. She will stay in our vicinity until the end of October and work alongside the RVI Police Force and other members of the Joint Task Force to support patrols and temporary radar arrangements in place. This support will be fully funded by the UK Government, and contributes to ongoing efforts by our regional and international partners to tackle smuggling in this region. The crew will not come on to land and will not meet Joint Task Force officers face-to-face in order to avoid any risks of transmitting the virus.

In addition to this, I am currently preparing a further offer of UK support designed to further build local skills and capability here in BVI. My Office and I have listened to voices not only in the Joint Task Force, but also to those in the community too. I know that people want BVI to be able to take care of its own affairs as much as possible. I understand and fully support this. Therefore, I am working to develop a package of support that will enhance our local

capabilities and put in place more permanent surveillance systems to improve security and curb illegal smuggling. I will withhold from disclosing the full details, out of respect for National Security Council members, until plans are discussed and agreed.

What I will say for now, is that we need to send a clear message to those involved in illegal activities and smuggling across our borders that it will not be tolerated. For every illegal landing on our shore, the risk of COVID-19 re-infecting our community returns. As long as our borders are porous, lives are in danger. I am not prepared to take that risk. Only those who benefit from illegal entries and illegal activities stand to gain from porous borders.

I also believe that the return of HMS Medway and offers of further security support from the UK sends a clear message of the UK's unwavering commitment to the people of BVI and to building capability of these islands for the future.

I hope that, by working in

partnership, we can get things right this time around and secure our borders for the long term. As I have stated in many discussions, security is crucial to our COVID-19 response. If we can stop new cases from entering BVI illegally, we can control this virus and keep case numbers down. That means internal restrictions can continue to be eased and further lockdowns avoided, as I am fully aware of the huge impact this has on individuals and businesses. It is vital we learn from our mistakes and give the Joint Task Force the support and investment it needs. I look forward to further discussions with the National Security Council and will endeavour to keep the people of BVI informed on this important matter.

The Great Capitalist Hypocrisy

Capitalism has always sat on the shoulder of the poor and underprivileged. That is nothing new.

Now do not be deceived by the idea of pure capitalism. It does not exist. It is the old cock and bull tale, that capitalism is solely market driven; that free capitalist societies survive without the help of big government, and public spending.

Globally, government support for the private sector is ubiquitous. There would be no private sector without government. The pandemic is a great example. Without government intervention societies would have fallen apart in the light of COVID 19.

Tax holidays, subsidies to producers, grants to pioneer and infant industries, and a whole plethora of "pork" given to businesses and industries in wealthy developed societies are the reason why businesses appear to thrive and prosper. Without this government support, most business in the west would cease to exist.

In August 2020, American Airlines stated to Congress, Senate, and Executive that if the corporation was not granted \$25 billion it would have to furlough 33 000 employees. That cash was given in the form of stimulus money.

Make no mistake, without the trillions of dollars in cash offered to hundreds of thousands of businesses in the west over the period of the COVID 19 pandemic, the western economy would have collapsed.

Citizens of western developed countries received help from their governments to a great extent, with governments paying most of their salaries, and offering businesses grants and cheap loans to remain solvent.

British Economist John Maynard Keynes stated that a clever way, in which government could offer help in an economic depression, was to pay a set of jobless workers to dig a hole, and then another set to refill that hole.

Keynes reasoned this was an excellent way to revive a sagging economy that was approaching the proverbial abyss.

Keynes's brilliant theory was this. As long as a worker in the market performs a task, and gets remuneration, and the conditions of a transaction are met, then that will generate activity and economic growth, as long as the worker gets paid. For example a Red Cross worker may volunteer and get no pay, and that will mean good is done, but it will not impact the economy in terms of stats and metrics that are everything. However, if that Red Cross worker gets paid, then that becomes an economic transaction. and the economy grows as the pay adds to GDP. Economics is a mystery.

Barack Obama's bail out of companies that employed large numbers of people that were too big to fail was Keynes's idea, but exponentially greater. Between 2008 and 2009 Obama shelled out over \$700 billion to keep the western capitalist system standing in the storm of the Great Financial Collapse and Recession driven by bad debt, mortgages under water, and Sub Prime Mortgages.

These US Presidents saved the US economy from collapse, saved millions of jobs, and drove economic recovery.

Then the USA and the European Union provide billions in subsidy to their agricultural sectors. A 2018 report described how the US government granted \$20 billion as direct subsidy to over 2 million farms producing com, soybean, wheat, cotton, and rice for the USA.

Simply put, these subsidies are offered to farmers to supplement their incomes. In effect, this manages the supply of agricultural products to ensure profitability to farm owners, and influence demand and supply for rich countries.

On the other side of the coin, this is blatant trade protection that drives down the true price of food and agricultural products in poor countries of the south, forcing these countries to become net importers of food.

This is a key reason agriculture in the south is on crutches, and why developing countries are net importers of food. Cheap western farm products are subsidized by western governments who in turn dump their excess produce on poor countries keeping those countries in food dependency on richer countries in the north.

The entire capitalist system of the west is dependent upon government spending and subsidy. If there was no CIA, MI5, Military, Police, spending on works and infrastructure, and national research and development, then Facebook, Google, Boeing, Air Bus, and Rolls Royce, could not exist.

So the next time some finance official from a rich northern country appears on the doorstep pontificating on our corrupt ways, and how irresponsibly we manage our scarce resources, give the middle finger, and put them back on the private jet back to where they came from.

Nearly 10, 000 Persons Receiving Treatment For Hypertension

Senior Medical Officer Dr. Shaun Ramroop has said that according to statistics from the National Health Insurance, there are between 5,000 and 10,000 people being treated locally for hypertension which is a major risk factor for cardiovascular disease.

Dr. Ramroop while commenting on the Territory's observance of World Heart Day today is encouraging residents to love their heart by making lifestyle changes that would lower their vulnerability to cardiovascular diseases.

Dr. Ramroop explained that cardiovascular disease occurs when blood vessels leading to the heart and brain are affected by high blood pressure, diabetes and high cholesterol.

"The disease process occurs

when those blood vessels get blocked. When they get blocked, blood supply maybe cut off to the heart or brain which can result in a heart attack or stroke," he said.

The Senior Medical Officer also noted that persons should be especially vigilant for high blood pressure and hypertension because it is the root cause of most cardiovascular issues and can go virtually undetected.

"Anyone who is over the age of 40 should have their blood pressure checked once a year. If you are at risk or have a family history you should start in your 30s. If you have any history of having problems with your kidney, chest pain, shortness of breath, or weakness or numbness of the body seek medical intervention immediately," Dr.

Ramroop advised.

He added that care is available at all of the health centres associated with the BVI Health Services Authority. "We provide screening for high blood pressure, treatment, follow up and dietician services," He said.

World Heart Day is being observed under the theme "Use Heart to Beat Cardiovascular Disease". The day is observed to remind persons, communities, countries and the world at large about the risk of cardiovascular disease.

Dr. Ramroop further added that despite the seriousness of cardiovascular diseases, the community needs to know that they are preventable. Simple lifestyle changes he said including diet and exercise, consuming at least one pound of fruits and vegetables daily, drinking plenty of water, avoiding tobacco use and limiting alcohol use can reduce or prevent the effects of cardiovascular diseases.

Persons can learn more about cardiovascular diseases and what they can do to lower their risk by tuning into the BVIHSA report featuring Dr. Ramroop on ZBVI on October 6 and 8 at 9:00 a.m.

USA - Bruce Tomlin, a 63-year-old truck driver from New Mexico, said he was never really a "gun person." Then he saw a video of three white men following and fatally shooting Ahmaud Arbery while he was jogging.

"The man is trying to get away and they're just gunning him down in the street like he was a dog," Tomlin said about watching the video of Arbery." It's made me hypervigilant. It has made me nervous. I'll even admit to being a little bit scared sometimes."

So he bought a gun. And he's planning on buying more.

"I just feel like in my viewpoint, every Black person in America, especially Black males, needs to have some type of protection with them as often as [they] can, because I think the political climate [is] getting to the point where it's just going to be a lot of violence coming our way," Tomlin said. "I just feel safer now having a gun. And I didn't always feel that way. I've never been the world's biggest fan of guns, but I just don't feel safe without one."

In early June, NPR reached out to Black Americans to ask about their personal experiences in this country. Nearly 500 people responded, some of whom described wanting to buy — or decidedly not wanting to buy — firearms for self-defense in response to the recent fight for racial justice. [NPR]

USA - This week, President Trump expanded a ban on exploratory drilling off the coasts of North Carolina and Virginia, his latest extension of an existing offshore drilling moratorium in the Gulf of Mexico.

The memorandum, which Trump signed Friday, "prevents consideration of this area for any leasing for purposes of exploration, development, or production during the 10-year period beginning on July 1, 2022, and ending on June 30, 2032."

The memo makes clear that the ban on leasing does not apply if it's for "environmental conservation purposes, including the purposes of shore protection, beach nourishment and restoration, wetlands restoration, and habitat protection."

It stands in contrast to the Trump administration's record of supporting oil and gas production and rolling back rules on greenhouse gas emissions.

Trump announced the move at a campaign event in Virginia. But even as he announced the action, Trump immediately indicated a willingness to walk things back. "If you want to have oil rigs out there, just let me know — we'll take it off," he told the crowd. "I can understand that, too." INPRI

ISRAEL - The Jewish holiday Yom Kippur began on Sunday among tightened rules over social gatherings.

During the holiday, which lasts until Monday evening, hundreds of thousands of people usually go to synagogues to pray.

Netanyahu has urged people to pray outdoors instead due to infection risks, a call that has been echoed by rabbis, the Jerusalem Post reported.

In a message to the nation, Israel's figurehead president, Reuven Rivlin, called on people to light a candle in memory of the more than 1,400 Israelis who have died from COVID-19.

Meanwhile, hundreds of ultra-Orthodox Jews have been ordered to be quarantined in their religious schools during the holiday after they got infected with the virus recently while praying together, the Haaretz newspaper reported.

Israel, with a population of just 9 million, is reporting more than 7,000 new cases a day.

The border crossing between Gaza and Egypt reopened on Sunday, for just three days. The Palestinian enclave has been under lockdown for over one month in order to curb the spread of the novel coronavirus. All those entering Egypt are required to provide evidence that they had tested negative for the virus. (Deutsche Welle)

SWITZERLAND - Swiss voters on Sunday overwhelmingly rejected a proposal to limit the free movement of people and immigration from the European Union.

Final results showed that 61.7% voted against the motion, versus 38.3% who turned out in support.

Sunday's referendum had been initiated by the populist right-wing Swiss People's Party (SVP), which said that current regulations allow for an average of 75,000 EU citizens per year to enter, leading to overpopulation, rising housing costs and a strained welfare system. The government had opposed the initiative.

The head of the EU's executive branch, European Commission President Ursula von der Leyen, welcomed the outcome of the vote, calling it "a positive signal to continue to consolidate and deepen our relationship."

The result "upholds one of the core pillars of our relationship: the mutual freedom to move, to live and to work in Switzerland and the EU." (Deutsche Welle)


SAN JUAN - Gov. Wanda Vázquez Garced announced Thursday an amendment to the Puerto Rico Ports Authority's (PA) Maritime Rates Regulation (M-1-8) to offer a discount on the docking fee to cruise lines that dock their ships in Puerto Rico under commercially non-operational conditions.

"Given the impact that world tourism has suffered due to Covid-19, many cruise companies have chosen to suspend their commercial operations and safeguard their ships in different ports until it is commercially viable to restart passenger trips, in what is known as lay-up," the governor explained. "For our ports to become a competitive option for the prolonged docking of cruise ships temporarily out of commercial operations, it was necessary to amend this regulation" and offer "attractive special rates for medium and long-term docking."

The amendment to the M-1-8 regulation was approved by the Ports Authority board, which may make changes, effective immediately, to the general fee structure if necessary in case of a temporary increase or an emergency. Originally, the regulation did not take into account the possibility of a fee reduction to encourage cruise ships to lay up at the island's ports. (CaribbeanBusiness)

SANTO DOMINGO - Foreign Minister Roberto Alvarez was the keynote speaker for the first of a series of online talks on relations between the Dominican Republic and Italy organized by the Dominican-Italian Chamber of Commerce and the Embassy of Italy in the Dominican Republic. The name of the talk was: "Foreign and Commercial Policy of the Dominican Republic, in the Current Economic Context Conditioned by Covid-19."





The victim received life threatening injuries and was then transported by ambulance to the then Peebles hospital where he was treated for gunshot wounds. He remained at the said hospital on life support until the 22nd of September 2005 where he succumbed to his injuries.
- 3. On the 10th of September 2017, around 2:30pm the victim, Julio Pineda Ceasor, was at his Greenland home with his family when mask men entered his residence making certain demands. The gun men then shot the victim and left the residence. He was subsequently taken to Dr D Orlando Smith hospital where he later succumbed to his injuries.
- 4.On the 12th of September 2014, around 11:15pm the victim, Nyron Olliverre, arrived at his Horse Path residence driving his vehicle when an unknown person fired several shots at him. The victim immediately succumbed to his injuries.

September 2020 marks the 16th, 15th, 3rd, and 6th, year anniversary respectively, of these currently undetected attacks. Detectives of the said unit are still hopeful that members of the community may have crucial information, to assist in identifying those responsible for this senseless murder, to bring some closure to the grieving families.

PORTUGAL, ARMENIA, AND CROATIA WIN 50TH ANNIVERSARY OF ASIAGO'S PHILATELIC ART AWARDS



Portugal won the Gio Pomodoro Trophy at the 50th Anniversary of the International Asiago Philatelic Art Award.

Jorge Macedo's masterly blend of traditional and contemporary design of the €3.50 Christmas miniature sheet earned Portugal – represented in Asiago by Isabel Fonseca - the Gio Pomodoro Trophy at the 50th Anniversary of the International Asiago Philatelic Art Award. The miniature sheet depicts a star that shines above the little stable when activated by a built-in luminous diode via a mobile phone connection.

The Jury (Raúl Berzosa, Franco Filanci, Gian Antonio Stella, Maurizio Stella, Gaetano Thiene, Luca Vangelli, and Marco Ventura) appreciated "the unusually original creative graphic and technical way the classic Christmas iconography is presented. The outline of the stable occupies the center of the miniature sheet, functioning as a backdrop for a Nativity scene with the ox and donkey in the fore, and a star shining high above and yet shining light on the Holy Family".

The best tourism promoting

stamps was the Croatian one depicting the Plitvice lakes of the National Park. Extremely inspiring was the decision to pair the close-up views of the majestic waterfalls with their smaller companions. As the Croatian Ambassador to Italy, Jasen Mesić, received the award, he mentioned another stamp bolstering tourism issued in years past by the Croatian Post and featuring a view of Rovinj. In the first version, the name of the city was in Croatian, but this generated legitimate protests from both the Italian Association of Venezia Giulia and Dalmatia and Senator Carlo Giovanardi. The Ambassador thanked the Senator for his documented elucidation, which resulted in the re-issuing of the same stamp with both the Croatian and Italian name: Rovini and Rovigno. After the end of World War II, the name of an Istria place on a stamp was bilingual. "Stamps, too," Ambassador concluded become symbols of peace."

The "intelligent, simple por-

trayal of a barn swallow in the style of ancient Armenian miniatures, on a background depicting the typical flora of this Caucasian region in an equally terse and artistic style", expressed a celebration of the environment. Hence, the awarding to the Armenian stamp designed by Ashkhen (Mila) Khandzratsyan, winner of the Asiago Environment Prize, for which Armenian Consul Gagik Saruacanian expressed his delight.

This year, too, the awards bestowed by two prestigious Academies were included. Founded in 1555 by a group of 21 citizens

of Vicenza and currently chaired by Gaetano Thiene, who is also President of the Asiago International Philatelic Art Prize, the Accademia Olimpica's choice fell on the Vatican' stamp celebrating the 350th anniversary of the death of Rembrandt van Rijn. Marina Richterová's unusual design was highly appreciated. "Not one of his many self-portraits or one of his famous works, but rather an original drawing - almost an engraving - portraying the artist in his composure as he practices his fine art." "Five stamps representing Bosnia Herzegovina, Hungary, the Vatican, Serbia and France" - as Gaetano Thiene revealed - 'made it to the finals but, in the end, the Accademia Olimpica chose the Vatican's stamp depicting Rembrandt, the son of a Calvinist father and a Catholic mother, who broached religious subjects in a new way for his time and scope of action."

The Italian Academy of Philately and Postal History, chaired by Franco Filanci and represented in Asiago by the



Accademia's deputy chairman Lorenzo Carra, chose an Austrian stamp as the most creative. 





Brussels Sprouts Shed Their Bad Reputation

Long before Brussels sprouts became a trendy vegetable, my family, especially, my daughter, Deanna, were huge fans. My mother was raised on a farm and loved to grow all types of green vegetables. She was especially skilled with properly preparing Brussels sprouts and other typically stinky and slimy vegetables -- I'm talking about you, cabbage and okra!

While Brussels sprouts have only recently become popular in America, sprouts have been a culinary mainstay in the southern Netherlands and Northern Europe since the 1600s. They may have been grown in Belgium as early as 1200, and are named for Brussels, its capital.

These tiny members of the cabbage and mustard family also have cancer-fighting phytochemicals, are high in vitamin C and are a reliable source of folate, vitamin A and potassium. Since Brussels sprouts are so good for you, why do so many people despise them?



In a web poll taken several years ago, more than 78,000 adults weighed in on the foods they hate. Brussels sprouts finished No. 8 on the list of most hated foods. The comments section overflowed with horror stories about being forced to eat the vegetable as a child.

One thing I noticed about the readers' comments was that the Brussels sprouts they were served were muddy colored, overcooked and smelled bad. When Brussels sprouts are carefully selected, stored and cooked properly, they have a bright color, a crisp texture and a delicious flavor. When selecting the vegetable, look for small, young, vibrant green, tightly compacted sprouts.

Brussels sprouts are delicious boiled or steamed until tender, but still slightly crisp or roasted to bring out their natural sugars. Use sprouts that are all about the same size to ensure they will cook quickly and evenly. As a rule, Brussels sprouts cook in about 6 to 7 minutes. Be careful not to overcook Brussels sprouts because they will release sinigrin, a natural gas with a sulfur-like smell.

This recipe for Hashed Brussels Sprouts is flavorful and delicious. The quick cooking time and the addition of the garlic, onion and mustard complement the sprouts and showcase its flavors in a unique way. Try it, and you're sure to become a Brussels sprouts lover, too!

HASHED BRUSSELS SPROUTS

- 1 tablespoon freshly squeezed lemon juice, plus
 1 tablespoon grated lemon zest
- 1 pound Brussels sprouts
- 1 tablespoon olive oil
- · 2 tablespoons butter
- 1/2 medium purple onion, minced
- · 1 garlic clove, minced
- 1 tablespoon Italian seasoning
- 1 teaspoon salt
- 1 teaspoon pepper
- 2 tablespoons vegetable broth or low-sodium chicken broth
- 1 teaspoon Dijon mustard
- 1/2 teaspoon honey or sugar
- Using a large bowl, pour in the lemon juice. Cut bottoms off the sprouts, and discard. Halve sprouts lengthwise. Thinly slice sprouts, cutting around and discarding the firm core. Immediately toss sprout slices with lemon juice to separate leaves and retain color.
- Heat oil and butter over high heat in a skillet large enough to hold all the sprouts. When oil mixture is hot, but not smoking, add the sprouts, onion, garlic, Italian seasoning, and salt and pepper. Cook until sprouts begin to wilt, but leaves are still green and crisp, about 3 to 4 minutes. Some of the leaves might brown slightly.
- 3. Move the sprouts to one side of the pan and mix broth, mustard and honey or sugar together in the pan. Combine mixture with the sprouts and cook, stirring, 2 minutes more. Turn off heat, and stir in lemon zest, reserving a little to sprinkle on top of the dish. Transfer to serving bowl, sprinkle with remaining zest and serve. Serves 4.



World Tourism Day 2020 Message

This year's international day of observation comes at a time when the global tourism industry is facing a crisis of historic proportion due to the COVID-19 pandemic. Indeed, the true impact of the pandemic may not be known for some time. However, the immediate impact on our region is very evident. Having begun 2020 on course for a new record in tourist arrivals, the closure of airports in March was followed by virtually no travel to the Caribbean in April and May. The result was a 57 per cent decline in arrivals between January and June. This translates into an estimated 50 per cent to 60 per cent fall in visitor spend, which can be seen directly in the form of closed tourism businesses, and across the economic spectrum in the form of significantly reduced revenues in both the public and private sectors. In addition, the International Labour Organization (ILO) estimates that almost half a million Caribbean tourism workers

face the prospect of job losses, reductions in working hours, and loss of incomes as a result of the pandemic.

Several Caribbean countries are considered among the most vulnerable by the World Tourism Organization (UNWTO) as international tourism revenues account for the majority of total exports in these states. It also goes without saying that women, youth, and workers in the informal economy have been, and will be, among the hardest hit.

The CTO has recognised that the COVID-19 pandemic forces us to rethink our approach to tourism and to forge closer alignment of tourism and health functions. We also recognised that we need to ensure that on the restart of the sector, the benefits of tourism activity accrue as quickly as possible to all facets of our societies. This means that while the traditional players in tourism restart, we also need to help those businesses which are often away from the coast and beaches, in our rural areas.

To this end, the organisation has forged ahead in its collaboration with the Compete Caribbean Partnership Facility (CCPF) which will be funding community-based tourism projects in some rural areas in Caribbean countries. The lessons learnt can be used

as a blueprint to encourage similar projects across the region and be a catalyst for income generation and development in our rural communities.

Some of the characteristics of rural communities such as population demographics, lower income levels and relatively limited access to technology and infrastructure lead to an increased vulnerability in such areas, to the impacts of crises like the COVID-19 pandemic. Tourism can work hand in hand with other economic sectors in the Caribbean such as agriculture, transportation and culture to empower rural communities.

Bringing people together in such an environment of solidarity and trust, advances the cooperation and collaboration needed to help us move beyond the pandemic. By providing a lifeline to the vulnerable in our societies, we reduce the tug on social services and further enhance the capacity of Caribbean people to play a leading role in their own development. Since the greatest resource in the Caribbean is our people, any investment will result in benefits for generations to come.

While we continue to work diligently on ensuring a safe and healthy environment for our visitors and locals alike, let us

contemplate the opportunity that this pandemic affords us to tweak our tourism sector, and indeed all other sectors of our economies, to reach a level of sustainability that is resistant to crisis.

We urge our Caribbean people to join the world tourism community in rebuilding this sector and ensuring that starting now, the benefits of tourism consistently spread beyond the traditional coastal and urban bailiwick to areas of our countries often overlooked, but which can be positioned to sustainably diversify the already rich treasures awaiting visitors to our shores.

U.K. Moves to high risk, Cummins outlines new protocols

On Friday, the Ministry of Health and Wellness in conjunction with the Barbados Tourism Marketing Inc. (BTMI) released the country's updated travel protocols which will see the U.K. moving to the High-Risk category effective October 1, 2020.

Minister of Tourism and International Transport, Senator the Hon. Lisa Cummins, spoke to the reason for the change. "We have been closely following the developments in the U.K., particularly the surge in their COVID-19 numbers within the past week which Prime Minister Boris Johnson referred to as a second wave. These large increases are of concern to our public health officials, who have recommended the new classification of the U.K. to the High-Risk category," she said.

Visitors travelling from the U.K.—in addition to the mandatory COVID-19 PCR

test taken at least 72-hours prior to arrival in Barbados—will now also be required to undergo a second COVID-19 PCR test in Barbados, five days after the date of their first accepted test.

Until the second test is taken, visitors from the U.K. will remain in hotels designated by the Ministry of Health and Wellness and their movements will be restricted within that property. They will also be monitored for seven days after arriving in Barbados, including daily temperature checks and reports to their assigned health officer.

"Travel has changed. In light of COVID-19, we all understand that it will not be business as usual and we have to prioritize the health of all parties involved. We welcome all visitors to our shores, however we must ensure that we do

so safely and responsibly. Many of our visitors are traveling to have that mental health break from the challenges of going through this pandemic. We need to ensure that we can welcome them to a Barbados that is able to keep them safe and healthy. I am confident that our protocols, as we continue to revise them in keeping with the fluidity of the situation, accomplish this goal."

Public health gatekeepers

Cummins lauded the work of the Ministry of Health and Wellness, adding that "Since we resumed commercial flights in July, our public health officials have been our gatekeepers, proactively managing the flow of passengers through our airport. And if you examine our track record, you'll see that thanks to our protocols and the round the clock work of our professionals,

we have been able to capture almost all of the COVID-19 cases at the point of entry. This has allowed us to manage our risk and to ensure that anyone impacted by the virus has been isolated from the wider community.

At the same time, our hoteliers have done an exceptional job of ensuring that their properties are able to welcome guests safely. I have toured several properties in the past few weeks and it has been impressive to see how much attention they are paying to sanistisation and keeping people safe while they are enjoying the facilities. It's peace of mind that many people want to have in this environment.

A U.S. federal judge on Tuesday blocked an increase in immigration fees that was due to go into effect this week

The fees were set to go up Friday by an average of about 20% depending on the type of entry being sought.

The halted hikes include a \$50 fee for asylum applications, the first time the United States would have charged such a fee. The cost for applying to be a naturalized citizen was due to increase from \$640 to \$1,170.

Applicants from lowerincome households have been able to ask that their fees be waived, but the new rules that were due to go into effect eliminated certain categories of waiver eligibility, such as showing extreme financial hardship. Some applicants would no longer have been eligible under tighter household income thresholds.

U.S. Citizenship and Immigration Services, the agency that processes visas, asylum requests, naturalizations and other applications, reported a sharp decline in revenues earlier this year due to the coronavirus pandemic and at one point considered furloughing more than half its staff. Unlike most federal agencies, a significant portion of USCIS's funding comes from fees collected.

U.S. District Judge Jeffrey White wrote he based his injunction on several factors. He said the Trump administration did not adequately follow procedures for making new rules, including failing to consider the

impact of the higher fees on lowincome applicants.

White also agreed with arguments presented by the plaintiffs, a group of eight non-profit groups that work with low-income immigration applicants, who said the acting heads of the Department of Homeland Security had been improperly elevated to their roles at the time the new rules were issued.

Plaintiffs in other federal immigration cases have made the same argument about Kevin McAleenan, who was named acting head of the Department of Homeland Security last year before resigning in November, and Chad Wolf, who succeeded him as acting chief.

The defendants argued the appointments were valid. But Judge White ruled the plaintiffs are "likely to succeed" on the claim that neither McAleenan nor Wolf were validly serving as acting Homeland Security secretary.

It was 90 minutes of chaos in a year of upheaval.

together for the first time on 90 percent of v

R. Biden Jr. appeared onstage together for the first time on Tuesday. It was not exactly a debate. Shouting, interruptions and

often incoherent cross talk filled the air as Mr. Trump purposefully and repeatedly heckled and blurted over his rival and the moderator alike in a 90-minute melee that showcased the president's sense of urgency to upend a race in which polls show him trailing.

Mr. Biden labored to get his points in over Mr. Trump's stream of interjections, turning directly to the camera for refuge from a scrum that hardly represented a contest of ideas. But Mr. Biden did not stumble, contradicting months of questions from the Trump campaign about his mental fitness, and Mr. Trump seemed to do little to bring over voters who were not already part of his base.

The impact on the race of the messy affair — given that 90 percent of voters say they are already decided — is an open question.

From the opening bell, Mr. Trump came out as an aggressor, speaking over Mr. Biden in what seemed to be almost din-by-design: Pull the former vice president, who has run as a statesman promising to restore the soul of America, into a mud-slinging contest.

He bulldozed Mr. Biden and the moderator, Chris Wallace, throughout the evening. But his goal, other than making for a convoluted contest, was less clear. Mr. Trump seemed principally focused on undercutting and disorienting Mr. Biden, rather than on presenting an agenda or a vision for a second term in the White House.

"I've seen better-organized food fights at summer camp," said Michael Steel, a Republican strategist. "But Trump needed a clear 'W,' and he didn't get it."

Mr. Biden's own performance was mostly adequate. He swallowed some of his own lines, and Mr. Trump talked over others.

Before the debate, Mr. Wallace had said that, if successful, his job was to be "as invisible as possible." He sometimes managed to recede, though at other times he was caught up in the shout-fest. Rarely did he exert control over the chaos. "If you want to switch seats?" he offered gamely at one point to Mr. Trump.

The performance kept the focus squarely on Mr. Trump — often where he seems to like it — but also where the Biden campaign wants all the attention in a 2020 election the Democrat has cast as a referendum on the current president.

Biden, at his strongest, pivoted to the camera — and away from Trump.

Mr. Biden's visceral dislike of Mr. Trump practically burst through the screen. He told Mr. Trump to shut up. He called him a clown and a liar. He tagged him as a racist. "You're the worst president America has ever had," he said at one point. "Keep yapping, man," he said at another.

But for the most part, Mr. Biden succeeded in avoiding the chum that Mr. Trump was tossing into the debate water. Instead, he kept turning — physically—to face the cameras and address the American people instead of his chattering rival.

"This is not about my family or his family," Mr. Biden said at one point, after Mr. Trump tried to bait him with an attack on his son Hunter. "It's about your family. The American people. He doesn't want to talk about what you need."

The former vice president was strongest and most comfortable on the issues that he has focused on overwhelmingly in the last six months: the coronavirus pandemic and the resulting economic downturn.

"How well are you doing?"
Mr. Biden asked the television audience about the economy, casting Mr. Trump as the candidate of the well-to-do, seizing on the recent report from The New York Times that Mr. Trump had paid only \$750 in federal income taxes in both 2016 and 2017.

Turning to the cameras gave Mr. Biden refuge from the constant stream of words coming from across the stage, and it helped him land some of his more effective and empathetic lines — an area that his advisers see as crucial to his appeal.

When Mr. Trump bragged about his large rallies that are being held against the guidance of many public health officials, Mr. Biden said, "He's not worried about you."

Cyclists burst out the gates following recent COVID-19 lockdown By Dean "The Sportsman" Greenaway

Phillippe Leroy led senior and junior cyclists out the gate in Sunday's BVI Mountain Bike Prison Break Race, in the first sporting action on Tortola, since sports were paused for a month from mid August, because of a COVID-19 spike and spread within the territory.

Leroy covered the course from Trellis Bay, through Little Mountain, out past the Prison, over to Little Dix Hill and down to HLSCC and return in 46 minutes in 33 seconds.

"The race was fun. I waited for people in Little Mountain because I didn't want to cycle all on my own," Leroy told Island Sun Sports. "On the Prison Hill, I didn't go too hard but harder than the others. I didn't want to kill myself on the hill and then went hard on the flat instead. It was fun. It was quick. It was easy."

As the course was being used for the first time, Leroy said he had no idea how long it would take him to complete the 22.5 km circuit and thought it might probably take 55 mins to an hour.

"I felt fine. I didn't go too hard on the prison hill, but you have to go hard on the part by the prison itself because it's very steep, otherwise I went medium hard because I didn't want to go in the red, so that I couldn't push myself on the flat," Leroy explained. "But it was a lot of fun."

During the lockdown, Leroy planned a 24 hrs virtual ride but missed it and did 17 and did over 10,000m of climbing as well.

"I'm training less now. The most I'm going now is 5, 5½ hrs,"he said after his 46 minutes ride. "Itry to do that almost every Sunday. I'm going home when I finish here. I'm supposed to do five hours today."

Second place finisher Gareth Thomas, said it was the club's third race since Hurricane Irma in 2017 and it was a tough race with about 15 participants including juniors who did a shorter course. Typically, the race would have two circuits up to the Balsam Ghut Prison.

"We felt that it was too early in the season, considering that people had not been racing aggressively so we decided to put Little Mountain in and then the prison as opposed to two prison circuits,"Thomas noted, "The thing is, you go hard. Little Mountain is no joke. You walk around there is hard, you ride around there is tough. I think it surprises people how steep it can be and there's a few fast turns you have to be careful on, so those juniors, they wouldn't be calling it little today, I'm

The race marked the first time Chris Graham was riding hills.

"And they were horrible," Graham who was sixth told Island Sun Sports. "It's worse than I thought but I was ok on the flat, so I caught up there."

Graham said he liked the course, though windy on the ride back to Trellis Bay.

"The first time I ever raced with these guys as well—though I wasn't racing," he said. "It shows how good these guys at the front are. They're elite."

Shicorey Bertie led the Yeppies from the Youth Empowerment Project (YEP), on the junior course.

Bertie, who lives in the Sage Mountain area and had been practicing and playing basketball ahead of the race, said Little Mountain was tougher than many hills he ever drove on.

"I used a different bike and it felt different," he said. "I learned that you have to try and keep your

Injuries behind, Virgin Gorda sprinter Caul eyeing a breakout year By Dean "The Sportsman" Greenaway

Sprinter Shaniyah Caul of Virgin Gorda, a Fairleigh Dickerson University senior, is looking for a breakout season after being hampered by a string of injuries.

Caul, a sports administration major, was injured during the 2020 indoor season but was looking for a good year, before COVID-19 wiped out the outdoor season. She told Island Sun Sports that her collegiate career has been a good one and a great learning experience.

"I got injured a lot but you have to have a strong mindset when you get knocked down to get back up and keep trying," Caul said. "I really liked college but didn't like the cold though. I think the adjustment is what got me hurt a lot. I would start running faster later down in February, but since I had to run indoors, I had to be running fast in December for the season that began in January, so I think that change there, is what got me hurt a lot. I just have to keep adjusting and getting my body prepared for where it needs to be for the season."

Since she was hurt indoors, Caul, a 400m specialist, said that she wanted to come back outdoors and show what she could do, but COVID-19 messed that up. She said that she was looking forward to a great season after doing well in 2019. Since she returned to Virgin Gorda, she had been running on the road and on the beach is bit to keep her fitness, since the Valley Recreation Grounds had been closed.

"I did what I could to keep me in shape till the grounds were reopened," said Caul who will return to school in January and is currently taking online classes. While fall training has begun for students at Fairleigh Dickerson and some of her teammates commute, but the training is in sections because of the pandemic. They'll take a break in November then return to school in January, but will be training on their own during the period, to ensure that they keep in shape.

"I like the hot weather and I can get quality training in," she said of being home. "I don't like the cold. At school, sometimes we're outdoors training, depending on how cold it is because the cold can be a disadvantage to athletes. Training here for me is good because I can train every day."

In 2017, Caul anchored the 4x400m meter relay quartet of Ashley Kelly, Tarika "Tinkerbell" Moses and Beyonce DeFretias to victory in the OECS Championships, beating host Grenada with a time of 3 minutes 34.76 seconds, to help the BVI win the title. The time broke the 2009 mark of 3:37.62, established by Samantha John, Chantel Malone, Kelly and Dominique Maloney, in Cuba. She said representing the BVI at that level was a good experience for her.

"When that meet came about, I had prom and had to choose between the two and I didn't want to miss my prom," she reflected. "I was like, let me just go. If I didn't go, I wouldn't have been a part of that record setting team. That is one race that I wasn't scared to run as I normally do. I remember going out really hard and I wasn't struggling coming home, which was very good. When they said we broke the record, I was so happy."

Should there be a 2021 season, Caul said she's hoping for a breakout, after injuries slowed her development.

"I'm hoping to show what I can really do," she said. "I'm getting my mind together, getting my body together, in order to prepare to run fast for the upcoming season."

Caribbean wouldn't tolerate external interference on Republics money on competitive terms and by refusing to

Of all the fanciful reasons imputed to the decision of the government to make Barbados a Republic, shedding its monarchical status with Queen Elizabeth II as Head of State.

the most surprising has come from the Chair of the Foreign Affairs Committee of the British House of Commons, Tom Tugendhat.

The Foreign Affairs Committee, comprised of parliamentarians from all political parties in the House, is a serious body. It has produced important and influential reports in the past. Therefore, when its Chairman makes a statement, it would be imprudent just to dismiss it.

The Times' newspaper quoted him as saying on September 23, eight days after the Barbados Government's decision was declared: "China has been using infrastructure investment and debt diplomacy as a means of control for a while and it's coming closer to home for us. British partners have long faced challenges from rivals seeking to undermine our alliance. Today we're seeing it in the Caribbean. Some islands seem to be close to swapping a symbolic Queen in Windsor for a real and demanding emperor in Beijing.

As head of the Foreign Affairs Committee, Mr. Tugendhat should have been better informed. The Barbados government was no more influenced by China to change its status to a Republic, than it was under pressure by the British government to continue to share Queen Elizabeth as the Head of the two separate realms.

It is unfortunate that some in the international community regard small states as inexpert, seeing them as ready objects of manipulation by big powers through either coercion or enticements. Thus, the presence of China in the Caribbean, where it has made investments that have aided economic development, is characterised as "a means of control", as Mr. Tugendhat puts it.

Discounted altogether is that, in many Caribbean countries, China has given much needed loans and grants when others have been significant by their absence, or where, by their presence, they institute unhelpful policies of 'black listing' countries without consultation, or blocking much needed loans from international financial institutions on criteria that takes no account of the vulnerability of small states.

Do loans translate into coercive influence over small Caribbean states? The answer is unreservedly no. Loans must be repaid, including Chinese ones whose main attraction is their longer repayment periods and lower interest rates. If their rivals met their terms, competition would win out.

In any event, amid the COVID-19 crisis, China has shown no desire to forgive debt or to defer interest payments to give developing countries more breathing space. However, unlike the members of the Paris Club of official creditors (mostly G7 countries). China has deferred principal payments

If anything, it is other powerful states that provide space for China in the Caribbean by not offering support issues that are vitally important to Caribbean States. Among those issues are curbing Climate Change, promoting debt forgiveness in the epoch of COVID-19, and removing the skewed criteria of per capita income that prohibits many Caribbean countries from access to concessionary loans.

Whether large and powerful nations accept it or not, governments of small states are not vassals; in making foreign policy and domestic decisions, they make them in the context of what is in their best interest. That choice may result in upsetting one or other of powerful rival states, but it would be wrong for them to believe that Caribbean governments are incapable of making reasoned decisions in their country's interests.

On other comments made about the Barbados' wish to proceed to Republican status, should it do so it will not cease to be member of the Commonwealth of Nations which stopped being "British" in 1949 on the independence of India and Pakistan and their becoming Republics.

At that time, it was accepted that the British Crown would be the "Head of the Commonwealth" and, as such, "the symbol of the voluntary association" of its members. Of the 54 member states of the Commonwealth, 31 are Republics.

There also appears to be a perception that, in swearing allegiance to Queen Elizabeth II in Barbados and other Caribbean countries, fealty is being sworn to the Queen of the United Kingdom. This is not so. The Queen is head of state of each of her realms separately. So, in each country when the oath of allegiance is made, it is to the sovereign as head of that state only.

Another point worth making is that if, in becoming a Republic, the choice is made for a non-Executive President (as was recommended by a Constitutional Commission headed by Sir Henry Forde in 1998), no change in the system of government will occur in Barbados or any other county that follows that

The decision of the Barbados government, which has been in contemplation for 17 years, resides in one overarching consideration. It is this: the people of Barbados have a right to decide that their Head of State should be a symbol of their nation - someone who is from, and of the country, who lives within it, who shares its challenges and its benefits and who encompasses their common identity. That decision has not one jot to do with external influences. It is simply a national conclusion whose time has come, logically, emotionally, and intellectually.

Will other Caribbean monarchical states do the same? Highly likely they will, for the same important reason that motivates Barbados. But because their constitutions, unlike Barbados', requires them to hold a referendum in which the majority of the electorate vote in favour (and they have to obtain a two-thirds majority vote in the elected House), the political parties - in government and opposition - have to agree to proceed

More importantly, they will have to jointly explain the implications to the people, or political rivalry and distrust of politicians will defer the change. Unless they do so, "God Save the Queen/King" may still be sung alongside the national anthems of remaining Caribbean realms for another decade.

ANTI-COVID VACCINE: HOPEFUL OR HOPELESS?

Many countries are beginning to resent the continuous · and often sudden - extensions of lockdowns. Last weekend there were huge demonstrations in London and Jerusalem. As expected most of the politically biased, far-right-owned media described the protesters as conspiracy theorists, lawbreakers, trouble-makers, anti-vaccine, and COVID deniers. Other sources said that many protesters were fascists. No wonder more people don't trust the media.

What we have now is a world falling apart under consistent threats of all kinds and descriptions. The hard-earned freedom and democracy are at stake; they were often earned as a result of calamitous wars, uprisings, and revolutions resulting in the death of millions of human beings. Nowadays even the kindest of governments cannot find a reasonable solution to save both the lives of people and the economy of their countries. So far we have lost salaries, jobs and amassed bankruptcies, and foreclosures; to make it worse, we have accumulated poorly devised carbon-copied policies.

Much is expected of the hurried vaccines. Let us remember that apart from flu vaccines and other vaccines, so far there is no vaccine for AIDS, Malaria, Chagas, Dengue, Chikungunia, Cytomegalovirus, Hookworm infection, and Leishmaniasis, Schistosomiasis - to name a few.

"But while vaccination has prevented hundreds of millions of deaths since 1796 when Edward Jenner inoculated a boy with cowpox to prevent smallpox, there's room for improvement: Vaccines are risky or ineffective in people with compromised immune systems, they don't even exist for several viral diseases, and flu vaccines, in particular, often fail in the elderly," STATnews commented in February 2019.

The same source points out that: "Despite decades of trying, there are still no vaccines against viruses that kill tens of millions of people and cause untold suffering every year: HIV, respiratory syncytial virus, and the cancer-causing Epstein-Barr virus. There are many reasons why, including how hard it is to identify the exact piece of an antigen that will trigger the production of an effective antibody. And even when vaccines exist, they fail when B cells don't rearrange their DNA segments in a way necessary to manufacture the needed antibodies."

This leads us to comment that while we spend fortunes and wait for decades for a vaccine we would be better off finding a cure. Now some medications go a long way in combatting AIDS, but for forty years we have been hopelessly waiting for

Presently we are told that it is just a matter of months before we get an anti-COVID vaccine. Can you believe that?
