70% OF THE BVI POPULATION IS FULLY VACCINATED SUPPLY OF MORE VACCINES UNCERTAIN

The British Virgin Islands' COVID vaccine supplies will run out at the end of June, and to date, the Territory has not received confirmation regarding future shipments. This means that when the current batch finishes there might be a lull between the next supply.

In a disclosure during the VIP Let's Talk radio programme on 1 June Minister for Health and Social Development Hon. Carvin Malone said that the Ministry is comforted that the current vaccination drive is close to covering a large percentage of the Territory's population. He said, "If we get enough of our people 15000 – 16000 immunized, then we will be safe knowing that we have done all that we could."

Meanwhile Hon. Malone mentioned that the government is still trying to get more vaccines. Unfortunately, he said that government has not had any positive news in that regard. "We are heavily negotiating with the United Kingdom as to whether or not those persons who wish to take it after June ends; whether or not they would be prepared to send anymore. The responses have not been forthcoming as yet. We cannot guarantee so I am not going to be left wanting in terms of not doing all that we could to make sure that it happens."

Business Pioneer, Philanthropist Peter Haycraft Dies at 88

On Saturday, 29 May, the Territory was rocked by the sad news of the passing of well-regarded businessman and philanthropist Peter Haycraft OBE. Mr. Haycraft, whose most lauded accomplishments included the founding of supermarket giant Road Town Wholesale (Riteway). He is also well remembered for his kindness after the 2017 hurricanes, including a school construction project.

Among the many tributes extended to Haycraft was a message from the management and staff of Roadtown Wholesale. The RTW team said, "Mr Haycraft was an inspiration to us all and will be dearly missed by all the employees, customers, and partners of the business. A business which he courageously built over a period of 60 years. The story of RTW and Riteway is truly an inspiration, and the success of the business 60 years later is a testament to the great vision, leadership, generosity, business acumen and hard work of its founder. Peter started the business importing and selling PET milk in

1961. Some years later the business had grown to become the leading wholesaler and retailer in the British Virgin Islands, an incredible achievement.".

"RTW proudly serves many of the great businesses here as a wholesaler with partnerships that have lasted decades. Such longstanding business partnerships are a true representation of the integrity and conduct of Peter. The team at our Riteway stores don't view their work as running supermarkets, but rather feeding the BVI, a generous spirit fostered by Peter from the outset. Peter's passing will personally impact so many of our team, whom he gave so much to their education and development. He will be sadly missed but remembered fondly," they added.

Premier Hon. Andrew Fahie was among the first to express condolences to the Haycraft family. The BVI Leader said, "I am indeed deeply saddened to learn of the passing of Mr. Peter Haycraft, OBE, a businessman and philanthropist who became a household name in the Virgin Islands with the introduction of Riteway Food Markets and Cash and Carry."

Hon. Fahie said that Haycraft came to the British Virgin Islands in 1959 to run a ferry service between Tortola and St. Thomas. "He was one of the original organizers of the BVI Spring Regatta – now recognized today as one of the Caribbean's leading sailing events. He served as the Commodore of the Royal BVI Yacht Club on 13 occasions," the Premier noted.


Hon. Fahie spoke fondly of the support that Haycraft delivered to the Territory after the 2017 hurricanes. The BVI Leader said, "Following the 2017 hurricanes, Mr. Haycraft contributed substantial funds to rebuild Enis Adams Primary School into a modern educational facility, where his wife Mrs. Penny Haycraft has worked as a teacher. We were able to celebrate the completion and handing over of this project with him. Mr. Haycraft has indeed made contributions to

many worthy causes in the Territory. His passion for business development can be seen in Island Shipping and Tropical Shipping."

"On behalf of the Government and people of the Virgin Islands and my family, I express our condolences to his family, his wife Penny, his daughters Julie and Susan and his son Chris. May God continue to be with them during this difficult time. We thank Mr. Haycraft for his unwavering commitment to the development of the Virgin Islands. May his legacy and memories continue to be with us all," Hon. Fahie added.

In his tribute Leader of the Opposition Hon. Marlon Penn said that Haycraft was a caring member of the BVI community who often supported worthy causes, "Mr. Haycraft was a prominent businessman and philanthropist who often gave of himself and his enterprise to very worthy causes in and around the Virgin Islands."

"Most notably, the contribution made by him and his family after

Hon. Malone said that despite all that government has done to ensure that everyone becomes vaccinated, when June ends and the BVI's upply runs out many will still blame government. "I know what's going to happen. When July hits, August hits if anything happens, they are going to turn to the same Carvin..."

Testing Boost

In June the Territory is also expected to see commercial calls from cruise ships and Hon. Malone said that as more persons are expected to visit the government will be introducing rapid testing. The Health Minister said: "We are now in the process of buying the rapid test where if you are fully vaccinated, and you enter then we are looking in terms of a 15 minutes test ... We are trying to move away from the nasal test into one that can use saliva. That is an emerging technology that is tried and proven in some places but we are guided in terms of the recommendations that we receive from a number of the regional and international body."

"We are closer there than ever before and we surely will be moving to the 15 minutes rapid test. Hon. Malone noted that there are also nasal swab rapid tests available so he did not state definitively what types the BVI intends to purchase. He said that for persons travelling to other destinations they will need to note that some places require a PCR test," Hon. Malone added.

Regarding future vaccine availability, the Minister said: "We have those persons who have not taken it and we are not assured of anymore (vaccine) coming." On the other hand Hon. Malone said that those hesitant to be vaccinated are saying that they are interested in taking other vaccine brands instead of the Astra Zeneca brand currently offered. In response the Minister said that it is improbable that the BVI will get the Pfizer vaccine. According to Hon. Malone the

onerous storage requirement for that vaccine is a deterrent to the procurement of that brand.

Nonetheless, Hon. Malone noted that he is aware that some members of the community have no intention of becoming vaccinated.

Hon. Malone did promise to see if other vaccine brands can be procured: "One of the concerns we have and we want to make sure it does not happen is that folks will say well if you get this one we will take it and when you get it they still refuse to take it... We will try our very best for any one of the particular through the COVAX facility but we have issues in terms of getting this defined at this time," he added.

People Have Covid but No Symptoms

While the Minister explained that the securing of more vaccines is unknown at the moment Chief Epidemiologist Harmony Brewley- Massiah announced during a COVID-19 Update and Press Conference on 27 May that many of the persons who tested positive for the virus had no symptoms.

The Chief Epidemiologist said, "When we look at symptomatology, we are seeing that 72.3 percent cases were actually asymptomatic...The high prevalence of the asymptomatic cases is particularly concerning for us. It reinforces the value of the community wide mitigation efforts that we the BVI have put in place to reduce transmission in the Territory such as the handwashing, the mask-wearing the physical distancing."

Brewley-Massiah explained that data shows that male COVID patients were likely to have three or more symptoms compared to women who only reported one symptom. Most concerning, she said, is that the symptoms women had: "Women would mostly report a slight fever which lasted about 24 hours and then abated or a headache. Those were the two most prevalent symptoms

that the females reported," she noted.

On the other hand, the epidemiologist pointed out that persons who did not have any underlying symptoms and were deemed as healthy were the ones who reported more symptoms..."75 percent of our hospitalized cases were persons who had underlying health conditions; which we know from the studies can predispose you to having a severe event or even premature death," she pointed out.

"As of 23 May, 16,759 doses of the Astra Zeneca vaccine administered in the Territory..." 70 percent of the population is fully vaccinated. "These numbers are likely to be underestimated because we have had persons in the Territory that went abroad and got Pfizer, Moderna, and Johnson & Johnson vaccines." She said the percentage might also be off because the current population number is unknown.

Government Confiscates Unpaid Crown Land

Some of the Crown land allocated to persons to build their homes has been taken back by the Government. Minister for Natural Resources Hon. Vincent Wheatley explained that the lands were confiscated after persons who were given the properties failed to make payments on them.

While speaking in the House of Assembly on 13 May the Minister, during the Questions and Answers segment, explained that the decision was made to reclaim the lands that were unpaid for. According to Hon. Wheatley several hundred persons applied for government properties particular areas. Unfortunately, he noted that some persons who were able to get allocations did not utilize the land.

In explaining the decision to take the land back Hon.

Wheatley said: "Persons were granted Crown lands and were given payment plans. Some ran 10 to 15 years payment plans and did not pay off their loans. I sent out a notice...last year giving those persons who are already behind...When you purchase the land you are given a time to pay off let's say three or four or five years. These persons went way beyond the five or ten years; we are now into 15 or 20 years. I have seen one case 29 years this person was given land and didn't pay for it".

The Minister explained that the lands were given to persons who expressed a readiness for use and had the money to purchase. "I gave those persons an extra month so ten years and one month to find that money, those that did not find that money, their names were

removed from the list but to the community if we take they were put back onto the waiting area until they are ready. So that persons who are ready to build and who had the funding got the preference over those persons who didn't have the money to pay off for those lands. I think that it is only fair, if somebody cannot even afford to buy the land, how are you going to build a house. Persons who show more potential to do that was given the preference."

The persons whose land was taken were said to have been added to a waiting list for future allocations. "Those persons who were put back on the list whenever there is more land available they are given first preference in that second around. Nobody will be denied a proper chance of holding property in the BVI. I think that would be a disservice that approach, but persons must get themselves ready. You must prepare yourself financially or otherwise to own the opportunity when it comes."

The Minister said that persons who are desirous of acquiring government land to build their homes should know that the land has a cost. "I have been saying so for two years that persons need to get themselves ready the land is not free. It is going to cost something depending on the location. The best thing you can do if you know you want to own a piece of land start saving some money...I am willing to work with persons. If you cannot pay all at one time I would give you a payment plan within a reasonable time frame."

Hon. Wheatley said that it was a matter of budgeting

for some persons to be able to make their land payment. "The same way you can find \$30,000 to buy a car is the same way you can find \$15,000 to pay off for a piece of land ... While persons who have been preparing themselves have the savings and are ready to move ahead..."

When asked if the persons whose land was confiscated were given refund Hon. Wheatley explained that in some instances no payment was ever made on the land over the years. "In most cases no money was paid at all. Those who had made partial payment they either got a refund or they haven't been removed. They were given a further extension to pay. I cannot think of any person who was removed that was owed money. If they were they would have been refunded."

Employers Exhorted to Grant Paternity Leave

Employers are being fathers getting time off - he encouraged to provide paternity leave to men working within their organization. This suggestion was made by Minister for Education Dr. the Hon. Natalio Wheatley in his 25 May message in observance of Early Childhood Awareness Week.

The Minister exhorted companies to be more understanding of the needs and circumstances of their employees with young children by providing flexible work schedules and spaces for children. As it relates to

explained - that employers should consider "the feasibility of paternity leave to allow fathers to be more involved in the process of caring for mother and child."

Hon. Wheatley alluded to the fact that boosting of early childhood wellbeing requires an all hands on deck approach and he especially called on the corporate citizens of the BVI to play a part. "We are urging our business community to consider developing policies and procedures to support employees with young children. These policies supportive to employees."

In noting what such support from employers should entail the Education Minister opined, "They should provide maternity and vacation leaves, flexible work schedules and child-friendly spaces to allow workers with childcare constraints to bring their child/children to work as needed. COVID-19 has revealed the possibility of working remotely when necessary. This brings to mind a number of considerations for employers such as adjusting your policies to

should be family-friendly and include the aforementioned areas."

> Hon. Wheatley similarly called on religious organizations within the Territory to also play a part in the molding of young minds. He also mentioned that a campaign to educate the community on early education will commence shortly. "I am pleased to announce the launch of a six-months campaign with a focus on raising the level of awareness within the society about early childhood and particularly the need for all of us to

come together to support the holistic development of our Territory's youngest citizens. This campaign will commence in July and run through to December of 2021. Each month a different area of nurturing care will be highlighted. By the end of the campaign, it is anticipated that more children will be the recipients of greater collaborative efforts to support their physical, social, emotional, cognitive, language, and spiritual development," Hon. Wheatley noted.

Message From Acting Premier On The 2021 Atlantic Hurricane Season

"WORKING TOGETHER TO BE READY AND STAY READY"

Good day to you the people of the Virgin Islands.

The Atlantic Hurricane Season is once again upon the region, bringing with it a heightened risk of tropical storms. This year, as has become common in recent years, the first named storm formed before the June 1 beginning of the designated season.

As the people of the Virgin Islands understand very well, the best way for us to BE READY for the hazards we face – from earthquakes

and tsunamis to the pandemic and yes, storms and hurricanes, is for us to work together to STAY READY.

I am pleased to report that 2021 has seen significant accomplishments on the long road to recovery from the devastating impacts of Hurricanes Irma and Maria. Firstly, and I know of great interest to our people, key Government assets such as the West End Community Centre, which serves as an emergency shelter, have been repaired to a high standard.

Many more recovery projects are in progress, including the Valarie O. Thomas Community Centre in Sea Cow's Bay, East End Community Centre, the National Emergency Operations Centre, the renovations at the Road Town Police Station and BVI Fire and Rescue Services headquarters.

BVI families continue to benefit from the Housing Recovery Assistance Programme either through grants or low-interest loan assistance for repairs to their homes; through the construction of social homes; or through financial support to make their homes more resilient with hurricane shutters.

The road network in the Virgin Islands is also seeing significant improvements, with major projects underway at Bob's Gas Station, Great Mountain, Little Dix Hill, and Windy Hill. These projects will bring more stable hillsides and improved drainage and will strengthen our capacity to withstand the storms that may come our way this season and in the years to come.

On the economic side, despite major setbacks presented to us by the COVID-19 pandemic, our tourism sector, particularly in the yachting and marine community, is showing signs of a strong recovery. I thank our tourism workers for their patience as the BVI balances welcoming visitors while protecting us from the very real threat of COVID-19. I look forward to even greater recovery as we continue to vaccinate our local population.

We would not like to see a loss of all the gains we have made since 2017 in the event of another hazard impact.

We have endeavoured to protect our public assets by continuing to be a part of the Caribbean Catastrophe Risk Insurance Facility or CCRIF regional insurance programme. By providing insured nations' payouts in the event of major damages cause by earthquakes, tropical cyclones and excess rainfall, CCRIF coverage means that if we should face another disaster, we will have the financial means to begin the rebuilding process right away.

I would like to call your attention to the fact that these efforts are not being done on the strength of Government alone. We are proud to work together in BVI LOVE with contractors in the private sector, with the Recovery and Development Agency, and with international partners like the Caribbean Development Bank.

The time is now for all of our BVI people to do your part to BE READY and STAY READY for what is forecast to be an active hurricane season. We pray that we would not see any storms on our shores, but we should also BE READY and STAY READY to work together and lend

our strength to our friends and neighbours. King Solomon's sage advice speaks to us in these times: "Though one may be overpowered, two can defend themselves; And a cord of three strands is not quickly broken."

With that in mind, please do what you can to be a strong support to your family and community Review and update your emergency plans and emergency supply kits as necessary; take steps to protect your property by ensuring that you have adequate structural protection and that there are no unnecessary hazards around your home or business. For those who are able, I would also encourage you to reach out to the vulnerable members of your extended family or village to see what assistance may be needed.

We cannot know exactly what storms this season may bring, but we can work together to help each other and the entire Virgin Islands to BE READY and STAY READY.

Thank you and May God continue to bless and watch over these beautiful Virgin Islands.



TRC To Renew Operators' Licences

The four unitary licences issued to CCT, Flow, Digicel and BVI Cable TV by the Telecommunications Regulatory Commission in 2007 are due to expire over an 8-month period in 2022.

The licence renewal process is governed by section 24 of the

Telecommunications Act 2006 and Article 3 of the Licence. In deciding whether to renew a licence, the Commission must decide whether the Licensee in question has complied with its various obligations under the Act, the Telecommunications Code, the Licence, and any

Commission instructions, and on whether the Licensee has been in persistent breach of any of those obligations.

All operators seeking renewal must apply to the Commission no less than 12 months before their Licence expiration. Where an operator seeks

renewal, once the Commission receives an Application Form, it will follow the steps outlined in Article 3.3 of the Licence. Specifically, it will:

Issue a public notice within ten working days of receiving the application indicating, amongst other things, that an operator has applied for renewal of its Licence. Within this notice, the time within which a person can make comments or objections to the respective application will be specified.

Evaluate the operator's compliance with, among other things, Licence obligations and the extent to which the licenced services were provided, and business conducted in accordance with BVI Laws. An evaluation report will be produced based on the Commission's findings and published within 90 working days of receipt of the application. Conduct a public hearing within ten working days of publishing the evaluation report to allow

persons with a legitimate interest to comment on or object to the requested renewal. This will be limited to those persons who have filed comments or objections in response to the notice.

Issue a decision within 120

working days of receiving the application. The Commission will notify the operator of its decision or if the decision will be delayed, in which case it will be issued no later than one year after receiving the application. In addition to the foregoing, the Commission is presently revising the terms and conditions of the Licence, with a focus on the development of the industry and ensuring that the public's interest is protected. BVI Residents To Receive 2nd Covid-19 Vaccine **Dose After 4 Weeks**

Officials at the Ministry of Health and Social Development are advising the public that the interval between COVID-19 vaccine doses is being shortened to 4 to 8 weeks.

The adjustment is to ensure that as many residents as possible can be fully vaccinated before its stock of AstraZeneca vaccine expires at the end of July.

Persons who have not yet received their first dose are encouraged to do so between today and Friday July 2.

Chief Medical Officer, Dr. Irad Potter has explained that although the AstraZeneca vaccine produces a greater antibody response within a 10 to 12 week dose interval, a 4 to 8 week regime will still meet the threshold for full vaccination status.



Arrangements for the shipment of additional doses have not been confirmed due to various constraints affecting the global supply of AstraZeneca vaccines. Cold chain and logistics requirements that limit the Territory's access other approved COVID-19 vaccines add to the uncertainty of future supply.

"Discussions

however, ongoing with Public Health England and the COVAX Facility regarding vaccine supply to the Territory, and further information will be provided to the public once agreements have been finalised," Dr. Potter said.

He added that in light of stringent manufacturer requirements, the onward transportation of vaccines from the BVI to a receiving country may not be feasible, and is encouraging residents to take advantage of the opportunity now while supplies last.

The BVI Health Services Authority is offering COVID-19 vaccination to residents over the age of 18 from Monday to Friday, 10:00 a.m. to 3:00 p.m. at the following locations:

BERMUDA - A cruise ship home porting in Bermuda has sold most of its cabins for a series of summer voyages from the island.

Although operating at half capacity, the Viking Cruises website showed that the eight trips by the Viking Orion have sold the majority of the suites.

A spokeswoman for the Ministry of Transport and Tourism said the ministry was pleased with the high demand for the cruises. She added: "We are hopeful that the success of this summer's home porting initiative will encourage Viking to schedule regular cruise calls and return for home porting from Bermuda next year." The Bermuda Escape cruises, part of the Viking Cruise's "Welcome Back" collection, will run from the island between June 15 and August 3. The cruise line's website showed that its July 13 and July 20 voyages have one available cabin each. The Viking Orion, which offers suites of up to 1,448 square feet, will spend the first two days in Hamilton before putting out to sea on day three. [Royal Gazette]

CAYMAN ISLANDS - The Cayman Islands Tourism Association (CITA) has offered the population a chance to win US\$10,000, as well as 280 other prizes worth a total of US\$15,000, as part of an initiative to encourage persons to get vaccinated for COVID-19.

The CITA along with the charity R3 Cayman Foundation announced the prizes during a recent meeting of its members.

CITA president Marc Langevin said it was vital for the territory to reach its target of vaccinating 70 percent or more of its population, so that the borders can reopen safely to tourists, and the tourism sector had a part to play in that by encouraging its employees to get inoculated as soon as possible.

Langevin said CITA has been asking its members to provide weekly updates on how many of their staff have been vaccinated, and that "right now, as an industry, we are at 75 percent". [Caribbean National Weekly]

SANTO DOMINGO - The National Confederation of Transport Organizations (Conatra), a leading public transport private company, says that as of 1 June 2021, drivers need to show a vaccination card to be authorized to work.

The measure is adopted due to the surge in Covid-19 infections in recent days.

Mario Diaz, spokesperson for the transport company, said that Conatra as of the second week of June, will be asking passengers using the interurban transport routes of Conatra to present a vaccination card. "We adopt these measures with great responsibility and against our will, because we have to respect the norms, we have to help the government with this serious problem and we have to protect the Dominican population, especially the users of the passenger transportation service in our country", exclaimed Diaz. [DR1]

ANTIGUA - The most recent reports received by the Ministry of Health, Wellness and the Environment from the Mount St. John's Medical Centre (MSJMC) and the Caribbean Public Health Agency (CARPHA) have revealed sixteen (16) new laboratory confirmed COVID-19 cases in Antiqua and Barbuda as of Tuesday 16th March 2021 at 6pm. These new cases were as a result of ninety-eight (98) samples processed by MSJMC and eighty-seven (87) processed by CARPHA. Consequently, the total number of persons with laboratory confirmed COVID-19 cases in Antiqua and Barbuda is one thousand and eight (1008); which is inclusive of three hundred and eighty-three (383) active cases. Meanwhile, three hundred and ninety-one (391) Covid-19 vaccines were administered since the last publication bringing the total number of individuals vaccinated to twenty four thousand nine hundred and four (24,904). [Antigua Observer]

ST. MAARTEN - State Secretary Raymond Knops has informed the government of Sylveria Jacobs that St. Maarten will not receive further liquidity support until it tackles the restoration of Philipsburg airport energetically. Because of old style government dysfunction, St. Maarten's airport cannot be repaired, an allocated \$120 million cannot be spent, and St. Maarten now has to wait for its 39 million guilder fifth tranche.

Hurricane Irma destroyed the St. Maarten airport in 2017. Little restoration work has been accomplished, even though the general director and the Supervisory Board have more than \$120 million available. The money includes \$51 million that was set aside for the recovery, a further \$50 million loan from the European Investment Bank, and \$21 in liquidity support intended to keep the airport operational during the corona crisis.

The \$120 million is subject to a number of conditions that are intended to restore confidence in the management of the airport.

One condition is that, in line with international standards, security surveys be carried out on members of the airport management and supervisory board, both now and in the future. Profile sketches for the board members should also be drawn up. [Bonaire Reporter]


ROME - Italy's brain drain has risen 41.8% in the last years, the Audit Court said Wednesday. "Limited job prospects and low pay are pushing ever more graduates to leave the country, with a rise of 41.8% over 2013." said the court. Italy like other countries is seeing more and more young people graduating, but is losing more and more of them unlike other countries, the court said. "The phenomenon is due to the persistent difficulties in entering the labour market and the fact that the degrees does not offer, unlike in the OECD area, greater chances of employment with respect to lower levels of education", it said. Successive governments have tried to reverse the brain drain. Premier Mario Draghi has vowed to make Italy "a country for young people" with the help of the EU-funded COVID Recovery Plan. (ANSA).

MOSCOW - The state-backed Russian group behind a massive hacking campaign revealed last year has reemerged with a series of attacks on government agencies, think tanks, consultants and other organizations, according to officials and researchers.

A security update from Microsoft late Thursday said the group known as Nobelium has stepped up attacks, notably targeting government agencies involved in foreign policy as part of intelligence gathering efforts.

The U.S. government's Cybersecurity and Infrastructure Security Agency posted a link to the Microsoft update and urged computer network administrators to "apply the necessary mitigations." Microsoft said it detected a



"sophisticated" and large-scale campaign that delivered phishing emails delivering malicious software and enabling the hackers to get protected data from victims. "This wave of attacks targeted approximately 3,000 email accounts at more than 150 different organizations," Microsoft vice president Tom Burt said in a blog post.

The news comes a month after Washington imposed sanctions and expelled Russian diplomats in response to Moscow's involvement in the massive attacks last year on SolarWinds, a security software firm, as well as for election interference and other hostile activity.

"When coupled with the attack on SolarWinds, it's clear that part of Nobelium's playbook is to gain access to trusted technology providers and infect their customers," wrote Burt.

"By piggybacking on software updates and now mass email providers, Nobelium increases the chances of collateral damage in espionage operations and undermines trust in the technology ecosystem." [Moscow Times]

Levericks Bay is one of the most recent hospitality businesses to become fully Gold Seal Certified. In celebration of the timely accomplishment the excited staff posed for a photo opportunity that the Island Sun newspaper is happy to feature.

The Gold Seal certification programme was introduced as part of the British Virgin Islands' Tourism Reopening Guide. This guide was first released on 6 November; and outlines the requirements, training and protocols that hospitality establishment were required to adhere to in order to be "Gold Seal Certified".

A number of the BVI's restaurant and hotels have since received Gold Seal certification which has two main completion requirements. The first component requires that the staff take a two-hour training. This training is

conducted by the BVI Tourist Board in conjunction with Aquila Center for Cruise Excellence, which is the exclusive training partner of the Florida Caribbean Cruise Association (FCCA).

Also, in order to be certified the establishments had to ensure the compliance of health and safety protocols. Therefore, inspections were carried out. These inspections were scheduled through the BVI Tourist Board and conducted by a team headed by the Environmental Health Division.

The Gold Seal programme is required for persons working in the Tourism sector who interact with guests, including: the entire marine sector, those who host land activities, Taxi Operators, Tour Guides, Vendors, and Retail Workers.

Northern Europe is home to a number of social democracies or countries with a high social democracy component: Denmark, Finland, Germany, Norway, Northern Ireland, Austria, and France. The drive to create greater social equality in these countries has led to the highest quality of life indices anywhere on earth. Social democracy or democratic socialism leads to greater longevity, lower crime rates, and the highest standards of living and quality of life matrices.

If increasing social inequality is a ticking time bomb driving public anger and human suffering, then greater social equality promises "peace on earth."

Cupcake-Making Tips from Betty Crocker

While Betty Crocker is often associated with 1950s happy homemaking, she originally belonged to a different generation. Created in 1921 as a "friend to homemakers" for the Washburn Crosby Company (a forerunner to General Mills) in Minneapolis, her purpose was to answer consumer mail. "She" was actually the women of the Home Service Department who signed Betty's name.

Eventually, Betty Crocker's local radio show on WCCO expanded, and audiences around the nation tuned her in, tried her money-saving recipes and wrote Betty nearly 5,000 fan letters per day. "Your talks ... have given me hope," wrote one listener to the Betty Crocker radio program during the Depression.

A fascinating book, "Finding Betty Crocker" (Minnesota Heritage, 2007), by author and documentary producer Susan Marks, offers a unique look at the culinary and marketing history of America's First Lady of Food. According to Marks' largely

chronological "biography" (there was no real Betty Crocker), it was human connections like this one that made Crocker one of the most successful marketing tools ever. Filled with treasures from the General Mills archive -- including letters sent to Crocker during World War II, reprints of famous recipes and advertisements, and portraits updated through the years -- Marks' book introduces readers to the people who breathed life into Crocker's image as the happiest of homemakers.

With these basic items and tips courtesy of the Betty Crocker website (www. bettycrocker.com), you can bake and decorate a batch of beautiful cupcakes in a snap.

CUPCAKE MAKING TIPS

Staples:

- Betty Crocker boxed cake mixes in a variety of flavors
- · Ready-to-spread frostings · Decorating icing, assorted colors
- Decorating gels, assorted colors
- · Food colors (liquid, gel or paste). Try paste food color for more vivid color frosting
- Assorted colored sugars and edible glitters Assorted candy sprinkles

Equipment:

- Cupcake pans (mini and regular)
- Paper baking cups, available in a variety of colors and prints. Find them in supermarkets, party, craft or specialty cake decorating stores.
- Resealable food-storage plastic bags for piping icings and glazes.

Tip: Baking Pans

A box of cake mix makes 24 to 30 cupcakes in regular-size cupcake pan. There also are pans that have mini, large and jumbo cups. If you have only one pan and a recipe calls for more cupcakes than your pan will make, just cover and refrigerate the rest of the batter while baking the first batch. Cool the pan about 15 minutes, then bake the rest of the batter, adding 1 to 2 minutes to the bake time.

An easy way to fill baking cups is to use an ice cream scoop. Use one that measures out 1/3 cup batter when filling regular-size cups. Use one that measures out 2 tablespoons batter when filling mini cups.

Frosting Tips:

- Carefully dip tops of cupcake into the frosting, give a slight twist and remove.
 Finish off with a swirl of a knife if needed.
- Dip frosted cupcakes into bowls of nuts, colored sugar, sprinkles or other decors for easy decorating.

Storing Cupcakes:

- Cool cupcakes completely before covering to keep tops from becoming sticky (about 30 minutes).
- Loosely cover cupcakes that will be frosted later so the tops stay dry. If covered tightly, they become sticky and difficult to frost.
- 3. Store cupcakes with a creamy-type frosting loosely covered with foil, plastic wrap or waxed paper, or under a cake safe or inverted bowl
- 4. Refrigerate cupcakes with whipped-cream toppings or cream fillings.
- Frost cupcakes with fluffy frosting on the day they are to be served.
- 6. Freeze cupcakes two to three months, tightly wrapped.
- 7. To keep frosting on frosted cupcakes from sticking, freeze cupcakes uncovered 1 hour, then insert a toothpick in the top of the cupcake, and tightly wrap.
- Thaw cupcakes in the refrigerator or on the countertop.
- When thawing on the countertop, loosen or remove wrapping to prevent condensation.
- Decorating gel, hard candies and colored sugars do not freeze well because they tend to run during thawing.

St. Kitts & Nevis Open Only to Fully Vaccinated Travelers Effective May 29

Basseterre, St. Kitts (May 26, 2021) – The Prime Minister of St. Kitts and Nevis, Dr. the Honourable Timothy Harris announced last evening that based on the cluster of 16 new cases of COVID-19, the first of which was reported on May 19, 2019, involving a national with no travel history, the Government would immediately enact a series of initiatives an effort to contain the spread of the COVID-19 virus. Currently, the Federation has a total number of 61 confirmed COVID -19 cases with 45 cases fully recovered and zero deaths. The 16 new patients are stable and are being monitored. While the extensive contact tracing proceeds, new travel requirements for International Travelers were announced:

Effective May 29, 2021, only fully vaccinated travelers will be allowed entry into St. Kitts & Nevis. Exemptions for Citizens and Residents.

With the summer family travel season beginning considerations have been made for families traveling

with children. The following will apply to non-vaccinated children under 18:

Non-vaccinated children under 18 traveling with fully vaccinated parents are welcome.

If the family is staying 9 days or less, the current Vacation in Place guidelines apply.

If the family is staying 10 days or more, the parents and the child will have to Vacation in Place until day 14 when the child will be tested.

Vaccinated parents traveling with a non-vaccinated child will not be allowed to integrate into the Federation until after the child is tested on day 14 and the test results come back negative.

A curfew was imposed from 11p.m. to 5a.m. daily, starting May 25 for 14-days.

Below are the travel requirements for fully vaccinated travelers. The previously announced travel requirements for non-vaccinated travelers are null and void.

A traveler is considered fully vaccinated when two weeks have passed since receiving their second dose of a two dose vaccine series (Pfizer/BioNTech, Moderna or AstraZeneca/Oxford) or two weeks after they have received a single dose vaccine (Johnson + Johnson). The traveler's official COVID-19 Vaccination Record Card will be accepted as proof.

Traveler must complete the Travel Authorization Form on the national website (www.knatravelform. kn). Once the Travel Authorization Form is completed, the traveler must submit a copy of their official Vaccination Card (back and front scan). The vaccination card must be sent for verification via email or WhatsApp. The date of arrival and the KN number generated on their completed KNA travel form must be included.

Vaccination Record cards may be submitted via one of two methods: WhatsApp Phone Numbers - 869-762-0238 or 869-765-4880

Email - officeofcmo@gov.kn, Subject line: Vaccination Card

Upon review, the Chef Medical Officer will email the acceptance status of the traveler's vaccination card.

Upon submission of a completed KNA travel form and approval of their vaccination card, the traveler must upload their official COVID-19 RT-PCR negative test result from a CLIA/CDC/UKAS approved lab accredited with ISO/IEC 17025 standard taken 72 hours prior to travel. There are no exceptions to the 72-hour timeframe.

Upon receipt of the copy of the COVID -19 RT-PCR test negative result and their official vaccination card, the traveler's information will be reviewed, and they will receive the approval letter to enter the Federation (letter as pictured below).

Democracy Imperiled, Biden Warns, As He Pays **Tribute To Nation's War Dead**

ARLINGTON, VIRGINIA -

"Democracy itself is in peril here at home and around the world," U.S. President Joe Biden warned Monday in remarks to commemorate the Memorial Day holiday.

Biden made the comment after he, along with Vice President Kamala Harris and the nation's top military officials, took part in a wreath-laying ceremony at Arlington National Cemetery.

"What we do now, how we honor the memory of the fallen, will determine whether or not democracy will long endure," the president said, in a veiled reference to the January 6 siege of the U.S. Capitol by those seeking to overturn the results of last November's election in which Biden. a Democrat defeated incumbent Republican President Donald Trump.

Senate Republicans on Friday blocked a Houseapproved bill to create a bipartisan commission to investigate the rioting.

Biden, as he has done numerous times, spoke of a struggle for the "soul of America" that "is animated by the perennial battle between our worst instincts — which we've seen of late — and our better angels."

As the country observed the annual holiday honoring its war dead, Biden, at the cemetery located just south of Washington, also referenced "the right to vote freely and fairly and conveniently."

Hours prior to the president's speech, Democrats walked out of the Texas House chamber to prevent Republicans from passing a bill that would create new limitations to voting in the second mostpopulous U.S. state.

"The right to vote, the right to rise in the world as far as your talent can take you, unlimited by unfair barriers of privilege and power such are the principles of democracy," the president said.

In his 22-minute speech honoring the fallen, Biden also called for the media to pursue "the truth, founded on facts, not propaganda."

Defense Secretary Lloyd Austin and General Mark Milley, chairman of the Joint Chiefs of Staff, preceded Biden in remarks at the cemetery's memorial amphitheater.\

The previous day, in his home state of Delaware, Biden addressed a crowd of veterans and families of fallen service members.

"We must remember the price that was paid for our liberties. We must remember the debt we owe those who have paid it, and the families left behind. My heart is torn in half by the grief," he said.

Biden's Sunday remarks came on the sixth anniversary of the death of his son Beau, who served as a major in the Delaware Army National Guard, including a tour of duty with U.S. forces in Iraq, before dying of cancer in 2015.

"I know how much the loss hurts," Biden said. "I know the black hole it leaves in the middle of your chest. It feels like you may get sucked into it and not come out."

The United States has commemorated Memorial Day to honor its war dead at the end of May since 1868 after the Civil War. The national holiday is now held each year on the last Monday in May.

To coincide with the holiday, flags are placed by the headstones at Arlington National Cemetery and at many of the other national cemeteries across the country, where many who served in the U.S. military are buried.

It listed higher prices over prepandemic rates for cookout fare such as hamburgers and hotdogs, as well as higher prices for dinner and drinks out, amusement parks, concerts and car rentals. Prices are below prepandemic levels for airfare and hotels.

Prices for many goods have been rising because of surging consumer demand, as well as supply issues for both materials and labor.

"It's not just three or four teams and the younger guys don't have the opportunity, so I really love this aspect of the district league," said Richards who had 16 points and 13 boards for the team, behind Azim Beazer's 17 points, seven rebounds, four steals and

four assists night. "It brings out the development of young players and we get to see more of the talent from certain districts."

Knowing that the gym would be hot because of no air conditioning, Coach Derwin Scatliffe said he tried introducing a new level of basketball—trying to move the ball, create easy shots and try to help players save energy.

I'm in the Second (District) and I'm trying to build the Second. They say everybody in the town has the best coaches, so I live in the Second and I'm repping the Second and I'm going to make sure build it strong. When everybody gets together and knows what they have to do, they're going to have a lot of problems with this team."





GET ILLEGAL MIGRANTS VACCINATED

GUEST EDITORIAL By Sir Ronald Sanders

Not vaccinating illegal migrants against the coronavirus would be a fatal mistake in every country. Unvaccinated persons pose a real threat to subduing COVID-19 and will delay the opening-up and recovery of economies.

There are two issues related to this matter. First, governments may be reluctant to inoculate illegal persons for fear that, by doing so, they will create attractive circumstances for more people to enter and remain illegally on their shores. Second, illegal immigrants may be reluctant to be inoculated because of concerns about exposing themselves to arrest and deportation by police.

This matter is an issue for all Caribbean Community (CARICOM) states from Belize in the north to Suriname in the south, including the Caribbean islands. It is well known that the Bahamas is home to illegal Haitians, Trinidad and Tobago now accommodates Venezuelan refugees as does Guyana which also has a share of Haitians and Dominican Republicans. In truth, every CARICOM country has a population of illegal immigrants to some extent. The problem, therefore, is region wide.

The COVID-19 pandemic demands national plans to deal with inoculating illegal immigrants for the safety of the citizens and legitimate residents of each country, and as part of the process of economic recovery. The Economic Commission for Latin America and the Caribbean has recently reported that the decline in Gross Domestic Product in Latin America and the Caribbean in 2020 "represents the greatest decline in 120 years".

On May 27, the government of Canada partly opened the way for CARICOM countries to implement programmes to vaccinate illegals, as part of a wider programme to reach vulnerable people. In a new collaboration with the Pan American Health Organization (PAHO), Canada has provided CAN\$50 million (close to US\$40

> million) to support PAHO's work to vaccine at-risk women, migrants, refugees, and transient persons.

> But, this money is for use in more than 30 countries in Latin America and the Caribbean, although I have been informed that there is a carve-out of CAN\$6 million for the Caribbean

Public Health Agency (CARPHA) which has done remarkably well in providing testing and other COVID-19 related services.

All CARICOM countries, in thanking Canada for this generous donation to Latin America and the Caribbean, should ensure that they establish with PAHO their interest in implementing a programme to inoculate illegal migrants.

Dr. Carissa Etienne, the Director-General of PAHO, has explained why it is in the interest of Caribbean countries to ensure that illegal migrants are vaccinated. She said: "By offering vaccines to transient populations, countries in the Caribbean and Latin America can deter additional burdens to their national health systems due to infections while mitigating further transmission of the virus. This alliance (between PAHO and Canada) is pivotal to offer much-needed technical cooperation for a comprehensive response against COVID-19, to save lives and leave no one behind." To emphasise Dr. Etienne's point: countries that fail to inoculate illegal migrants could incur huge medical costs, treating citizens and residents who get infected. Wider infection will also mean a longer period for economic rebuilding.

Even if every Caribbean country inoculates all its citizens and legal residents, the entire society remains in real danger of infection while unvaccinated illegals move around in their country. Illegal migrants tend to live in heavily populated areas with poor sanitation facilities, where transmission of communicable diseases, such as COVID-19, is more likely. They also work on construction sites, in farming communities or in the homes of people as domestic help. Their nearness to their employers and fellow workers puts everyone at risk.

The onus is on governments to tackle this problem directly in several ways. Here are

four steps that might be considered. First, make it clear that illegal migrants who seek inoculation will not be rounded-up by the police and deported. Such a programme of information could be disseminated in communities where illegal migrants are believed to live, and on social media platforms.

Second, the health authorities should consider organising mobile facilities to go into the areas where illegals live and work, offering them inoculations in an environment in which they feel relatively safe. If mobile facilities are not available, setting up special clinics in the locations where migrants congregate might also be an option.

Third, the government should provide an undertaking that the gathered information would not be provided to the police or immigration departments for the purpose of deportation. The information should be used only for the purpose of issuing a vaccination certificate and providing a date on which a second dose of the vaccine would occur.

Fourth, recognizing that many, if not all, of the illegal migrants would have no official identity cards, a requirement could be that they provide two passport photographs, one of which could be attached to their certificate and the other kept in the records of health authorities to verify identities at the time of the second vaccine.

Munya Radzi, the head of Regularise, a UK based campaign to obtain rights for undocumented migrants, points out: "In my experience people do want to get the vaccine, people do want to be part of the solution to control the spread of the virus but it's the fear of what happens to me if I go to get this vaccine". He adds: "Unless they get a strong assurance that their data won't be shared, they will not go".

The adverse consequences of not vaccinating illegal migrants are great, both for curbing the spread of infections and for delaying the ability of countries to open their economies and get recovery going. The UN says that "the decline in GDP and the expected increase in unemployment rates will raise the number of people living in poverty and extreme poverty in Latin America and the Caribbean by 45 and 28.5 million, respectively".

Not vaccinating illegals as part of the population is not an option in these circumstances. Every country in the world will have to face the problem, however reluctantly.

The Caribbean could lead the way globally.

New Registrar Of Interests Appointed



50TH ANNIVERSARY OF APPOINTMENT OF DR. HON WILLARD WHEATLEY AS CHIEF MINISTER OF BVIBy Family of former Chief Minister, the late Dr. Hon. Willard Wheatley, MBE, LLB

2nd June 2021

June 2nd marks 50 years since the late Dr. Hon. Willard Wheatley, MBE, LLD was appointed the second Chief Minister of the British Virgin Islands after he was first elected to the Legislative Council (i.e. House of Assembly) in 1971. His political legacy is the financial autonomy of the Territory that remains the cornerstone of self-government and the furthest advance in self-determination achieved thus far.

Dr. Wheatley's accomplishments as Chief Minister between 1971-1975 and 1975-1979 include his Administrations' success in guiding the British Virgin Islands through a deep recession inherited by his Government, which was effectively managed through prudent public financial management and sound economic policies. This resulted in the resumption of economic growth and a balanced budget by the local Government for the very first time in 1977, which eliminated the need for financial assistance from the United Kingdom (i.e. grant-in-aid) that ended in 1978.

The Wheatley Administration consolidated the financial autonomy of the Territory through successful negotiations with the United Kingdom on a new constitution (Virgin Islands Constitution Order 1976) that transferred responsibility for Finance from the Governor to the elected Government under the portfolio of the Chief Minister. Dr. Wheatley became the British Virgin Islands first Minister of Finance on 1st June 1977 when the new constitution came into force. The contribution of Dr. Wheatley and his Administrations to the financial autonomy and political advancement of the British Virgin Islands remains highly relevant today, particularly as the society continues to recover from Hurricanes Irma and Maria and prepares for Constitutional Review.

The Wheatley Family salutes the distinguished former Chief Minister, the late Dr. Honourable Willard Wheatley MBE, LLB on the 50th anniversary of his appointment as the second Chief Minister of the British Virgin Islands and his first election to the Legislative Council.







Ten Ways Fathers Model Healthy Relationships for Their Children



Your children learn how men should behave in relationships by watching you. Even if you do not live with their mother, they are keenly aware of the way you interact with her. Most divorce and domestic violence happens to men and women who grew up without a father modeling healthy relationship behavior. Here are 10 tips to help you model the way you want your daughter to be treated in her adult relationships, and the way you want your son to treat the woman he loves.

- 1. Value their mother: Children value themselves and others more when they feel that their mother and father value one another.
- 2. Perspective-taking (seeing things through someone else's eyes): Show your children the importance of respecting the perspectives of people they love, even when they disagree with them.
- 3. Cooperation: Show how to participate willingly in work, problem-solving, or task-accomplishment.
- 4. Negotiation: Show your children how to work out solutions to problems that respect one another's perspectives.
 - 5. Resourcefulness: Never stop trying to make things better.
- 6. Motivation to improve: Approach disagreements with the attitude of making them better, not worse.
- 7. Compassion: This gut-level reaction to your wife's pain, discomfort, or anxiety includes sympathy, protectiveness, and willingness to help but not control. It recognizes that your wife is different from you, with her own temperament, set of experiences, beliefs, values, and preferences.
- 8. Good will: Learning a positive attitude toward the people they love will greatly improve your children's chances of having good relationships. Think good thoughts about your wife, and always give her the benefit of a doubt.
- Affection: Showing affection toward their mother makes children feel more secure.
- 10. Relationship investment: Successful relationships require that people care about and occasionally do nice things for one another.

Teach Your Children About Money

I firmly believe that if we'd been taught more about investing and basic money management in high school (and younger!) my generation wouldn't have some of the financial troubles that they do. I was lucky enough to have parents who taught me those lessons at home, but many of my friends weren't so lucky. I don't think much has changed for our own children. The schools just don't have the time or resources to focus on basic money skills so it's up to us as parents to educate our children.

We have to teach by example. If our children see us spending money on credit cards they think that the little plastic card is all you need to get your heart's desire. We need to show them that the little plastic card produces a bill each month that must be paid. Pay it in full so they can learn the habit early.

Some people are hesitant (or refuse) to involve their children in their financial affairs. Up to a certain age I would agree. But at some point you need to involve your children at least a little bit so they can learn the process of money management and it will help keep you accountable for your actions. Having to explain your frivolous purchases to your children can quickly alter your own habits.

Your ultimate goal is for your children to be better off than you are. If you don't teach them about how to manage money they could easily become worse off in their adult years. Don't burden them with ignorance. If you don't feel qualified to show them proper money handling skills then enlist the help of qualified professionals or family members who are skilled with money. The goal is not perfection. It's basic education and hopefully preventing the already catastrophic credit card debt from spilling over into the next generation.

My favorite example of teaching money management within the home was setup by the Dilley family. They had sextuplets several years ago and learned a way to teach their children good behavior and money management at the same time. The kids earn Dilley Dollars for doing their chores and good behavior. The dollars are redeemable for video game time or can be converted to real money (50 cents real money for every Dilley Dollar) which can be spent on real things. The kids are taught to save some of it and they learn to appreciate what it takes to make money in this world.

Whatever system you come up with, stick with it. Make your children accountable for their own spending habits and be accountable to them for your decisions. Admit your mistakes and do your best to lead them down the right financial path. Stick with the consequences of poor judgment. Of course you are the parent and make the final decisions, but the more you can involve them in the money processes of your household the better off they'll be when they step into the real world on their own.





Patient History More Than Just Medical Facts

DEAR DR. ROACH: I am 77 years old. When I go to a new doctor, there is always that past history form to fill out. I know to include current medications, including OTC and allergies, but how far back should I go?

Should I include the tonsillectomy when I was in grade school (I don't recall how old I was)? Or the surgery to remove a benign tumor from my right femur in 1955? The miscarriage in 1961? Or that the last of my five children was born over 40 years ago?

I would include the surgery because my right leg is about 3/4 inch shorter than my left. After all these years, it causes a backache after standing too long.—S.B.

ANSWER: In general, doctors want all the information you can give. However, past medical history tends to become less important as people get older. I agree with you that the surgery on your femur is important: Even now, a leg-length discrepancy may still benefit from being addressed. A small (half the discrepancy or less) adjustment to the shoe of your shorter right leg may help reduce your backache.

If I were your new doctor, it would be important to me to know you had a 40-year-old son (and about the rest of your children), but that would be more to know who you are as a person. I also ask my patients to identify someone in their family who can help make decisions if you are unable to. That should be done formally, through a health care proxy designation, which is com-

plementary to the advance directive that all adults should have.

It's a privilege for me as a primary care doctor to get to know my patients and follow them over years, sometimes many years.

DEAR DR. ROACH: I've read about a new drug for depression that is supposed to work quickly. Is it safe? — N.F.

ANSWER: Ketamine, like many biological molecules, has two forms that are mirror images of each other. Esketamine, the more active of the two, has recently been approved by the Food and Drug Administration for treatment of depression, and is the first new class of approved depression medication in years.


It is striking how quickly it works. With the intravenous drug, test subjects found their mood improving within hours, as opposed to the weeks it takes most current drugs to work. With the nasal spray form, the kind just approved by the FDA, benefit began within two hours and persisted throughout eight weeks of follow-up. It is not yet clear how long the effect will last and whether (or more likely, how often) additional doses will be necessary in long-term use. It is approved to be given only in a doctor's office, and only for people who have been resistant to other medications.

There are significant potential harms. Blood pressure goes up after the dose, and people can have sedation and disorganized thinking after treatment. For now, the drug is given only through a restricted distribution system.

I am cautiously optimistic. Depression is a serious disease with treatments that are not as effective as we would like. Any new type of treatment is a source of hope; however, I have seen potential "miracle drugs" turn out to be only moderately useful.
