MORE RECOVERY STIMULUS NEEDED: HON. WHEATLEY SAYS

As the government struggles to get the tourism sector back on solid footing Minister for Natural Resources Labour and Immigration Hon. Vincent Wheatley announced that the government might need to consider providing another round of stimulus for the Ninth District which is dependent on tourism and may still be impacted.

While speaking on the 3 November broadcast of the Honestly Speaking radio programme Minister Wheatley commented on the concerns of tourism stakeholders as it relates to the 1 December reopening plan and admitted that the situation with the hospitality businesses is currently dire.

The Minister predicted that the reopening, which is much anticipated, will not greatly improve the current situation because of ongoing global COVID 19 pandemic. While Hon. Wheatley said that it is exciting to see BVI resorts prepare to welcome guests, he pointed out that many tourists may not come to the BVI.

In fact, he explained that the tourism rebound is going to be slow. "There is a combination of what I see happening...Tourism

is going to be a bit soft after opening; not because people don't want to come here, but because of what is happening in the UK and what is happening in the Americas, where the cases are spiralling, they are going up every day; those persons will not want to travel or leave their businesses behind...I think tourism is going to be soft in the beginning, but pick up a bit later on."

The world economy is not doing well, despite all the assertions of Donald Trump and other leaders in Europe and all over the world. There will be repeated domino effects starting from bankruptcies of small businesses on which the big businesses and manufacturers depend.

Nonetheless, Minister Wheatley expressed confidence that the Territory will be ready for the full rebound in the future, and he explained that many of the outer islands prime resorts are in preparation mode for this period. These properties he said includes Bitter End, Saba Rock, Biras Creek, Moskito Island, and Necker Island.

Most noted among the mentioned reopening resorts

disclosed by Hon. Wheatley is the iconic and signature resort Little Dix Bay which is scheduled to open when the Territory's doors swing open in December. In mentioning that the long-awaited Little Dix Bay Hotel reopening will coincide with the grand Territorial reopening Hon. Wheatley said,

"they are going to be open as far as I know on December 31. Quite a bit of their staff start back tomorrow (3 November)".

However, the Minister noted that even though the best BVI resorts will be ready to greet guests and all of the prime boutique properties are waiting,

he stressed that the industry needs to brace for a not so bright restart. He commented: "Tourism might not be as robust in the beginning as people might be thinking. We have to start being creative about how we are going to manoeuvre in the age of COVID."

More Stimulus?? "In the Mail??"

Given the already dire situation caused by COVID and the fact that some tourism businesses can barely make it beyond December, Hon. Wheatley disclosed that he asked Premier and Minister for Finance Hon. Andrew Fahie to consider offering another round of stimulus for tourism businesses who were down since March.

Yet, the business stimulus promised by Government in September has not been received by quite several businesses. If it is not substantial and expedited it will not generate recovery of the economy and will hardly be a patch: this is according to many

businessmen who commented on the situation.

The Minister said: "I told the Premier on Sunday, Premier we have to figure out another round of stimulus in case tourism is really weaker than anticipated. We have to do an intervention in the Ninth District. We are going to need an intervention if tourism continues in the way we expect. We can't continue down this road here for very long."

While advocating for more stimulus the Minister apologised that there presently is a backlog for the various available stimulus programmes. "Some people have not received their stimulus check... it has to do with the number of

programmes that the government has and the number of checks being printed. Thousands and thousands of checks that are in the system along with the thousands that are there before for the normal payroll, the normal thing that government do... There is only so much printing that Treasury can do, you can't work there for 24/7."

"It's simply a backlog of so many checks – there is fishing, there is the stimulus, there are the business grants, there are the farming grants, there is the 13 members COVID grants and there is the 13 members monthly check and there's all the business government does with all of the businesses in the Territory. So

you are looking at thousands upon thousands of checks that must be printed; some are going to fall through the cracks so to speak. There are going to get lost in the mix, unfortunately," Hon. Wheatley explained.

He also explained that this backlog situation is not only affecting the businesses and individuals but the legislators as well. "We have gotten to the point in a pandemic where we have the accountability of normal times and I respect the accountability, but when it paralyses you, when you have to, and every member could tell you this – when you are in a District and you have to wait six seven or eight weeks for a check to buy food we have to go into our pockets. Every one of us could tell you sometimes our entire paycheck for that month has

to be given out to people who are waiting on some kind of stimulus check somewhere. The system is just slow," the Minister stated.

"We are trying our very best to get your stimulus check to you, to get your COVID check to you. I am not the Minister for Finance but I suggest or recommend that we look seriously now at the second wave of stimulus. I don't know what it is going to be, how it is going to be or where it is going to come from, but from where I sit, the way I see things the possibilities of things going wrong, some businesses will not be able to survive without further stimulus," he added.

In fact, after 8 months of Covid, banks are not helping, supermarkets want cash, creditors are restless, filling the car tank is a problem: once large numbers of businesses collapse, the whole economy will collapse. Promises do not help either.

Opposition Leader Refutes Allegations Of Inciting Unrest

While standing behind his support for a peaceful protest against the government for the handling of the reopening of the hospitality industry Leader of the Opposition Hon. Marlon Penn refuted allegations that he was inciting civil unrest in the Territory.

The Leader of the Opposition during the NDP Radio programme on 2 November accused Minister of Health Hon. Carvin Malone of sharing untruths. Hon. Penn stated that it was brought to his attention that Hon. Malone was allegedly spreading false information by accusing the Opposition of inciting riots. These allegations, the Leader of the Opposition said, were being circulated to residents via Whatsapp.

In elaborating on his assertions Hon. Penn said: "I saw a Whatsapp going around from the same Minister suggesting that my colleagues and I are

suggesting that persons should riot the streets and tear down the government building. Suggesting that we are in some way insinuating, inciting violence in any way in terms of protesting the government's decision."

Hon. Penn vehemently denied the claims and explained that his disclosure on the subject of protest was in response to a question from the media during the Opposition's press conference on 27 October.

The Leader of the Opposition commented: "A question was asked specifically in terms of people are suggesting that they want to protest the government's protocols and the decisions that are being made in terms of the reopening and the economy and we were very clear. We support any peaceful protest... We had that recently with the beneficial ownership we had a peaceful protest to the

Governor's house expressing our displeasure with the approach of the UK administration to impose public registers on us as a territory and we all were there," Hon. Penn said.

The Opposition Leader also referenced the historical Faulkner march and the iconic Noel Lloyd protest and said that Virgin Islanders have been known to demonstrate peacefully. "It is a right of our people for peaceful assembly ... The people have a right to peacefully protest if they choose to and we will never suggest any civil unrest anything of that sort where persons would damage the country."

While lashing out at the alleged Whatsapp from the Minister for Health, Hon. Penn declared that such actions are belittling: "For the Minister to send that around and make that suggestion is very disingenuous and unbecoming of someone that holds his position."

"The people have a right to protest, you are talking about

the livelihood of people, you are talking about tourism ... Tourism has fed our country for decades. It is the main industry... it brings more to government coffers.... So if persons are not satisfied with certain decisions they have a right to express their dissatisfaction," he added.

During last week's Opposition press conference Hon. Penn told the media that he supported a protest. "The business community went through a process where they had a petition, they were responsible in their approach, they wrote to the government and expressed their concerns in terms of what is happening in the business community and they were able to have a meeting with the government, even though the government did not listen to them. But the fact that they had an opportunity to have a meeting with the government, it is the right of the people."

At that press conference Opposition member and Second District Representative Hon.

Melvin 'Mitch' Turnbull also echoed support for a protest. Hon. Turnbull told the media, "The people are the government so if that is the feeling of the people, they have the power. The power is not to be relinquished after they vote for persons on election day. The powers still lie with the people. The people have a right to demand from government and their elected representatives of what they want to see happen for their best interest."

Unemployment Insurance In The Pipeline: Minister Says

By summer next year the Territory will have unemployment insurance in place as Minister for Natural Resources Labour and Immigration Hon. Vincent Wheatley announced that the proposed insurance will be on the government's legislative agenda for this session of the House of Assembly. Hon. Wheatley said that the legislation for the insurance will be operative by Summer 2021.

While a guest on the Honestly Speaking radio programme on 3 November,

the Minister disclosed that the unemployment insurance legislation will pave the way for the Territory to soon have unemployment benefits for residents who for one reason or another are unable to work.

Unemployment benefit or unemployment insurance is offered in many countries and since the COVID lock-downs, it has become a feature that was called for in the Territory. Now the Minister said that Government is responding

and is aiming to have the insurance at no additional cost to residents.

While explaining that the plan is to get the insurance available in the coming months, Hon. Wheatley said: "What we will have in place by next year is a proper unemployment benefit. So that when a pandemic or hurricane comes and persons can't work there is funding there for that specifically. It is not in place now, it has been spoken about for the last 20, 26 years. It will be in place by next year. We have no choice..."

"We have to ensure we put things in place, a proper unemployment benefit," Hon. Wheatley added. He also mentioned that the government is striving to have the new insurance cost absorbed into the current social security deduction.

"The thinking will be not to increase the current [contribution percentage]. Use the existing, reconfigure and redistribute it. I think its eight and a half per cent now, it probably remains there ...we don't want to add a burden on to anybody," the Minister explained.

As it relates to the proposed time-frame the Minister said: "January might be too early I might say by Summer next year. It needs time to get seed monies in place.... It needs time for the money to accumulate. It needs to have some money there before you kick it off... It is critical...I am going to make it happen."

As it relates to funding the unemployment benefits Hon. Wheatley explained that the government will not take money from another source to fund the unemployment insurance, "the money has to be generated."

BVICCHA Urges Extension Of Deadline On Furloughed Workers

What will become of furloughed workers! That is the concern of the BVI Chamber of Commerce and Hotel Association (BVICCHA) now that the deadline that was put forward by Minister for Natural Resources Labour and Immigration Hon. Vincent Wheatley has passed, plunging affected workers in limbo.

Globally, furlough became the go-to option for businesses that were forced to close their doors as countries locked down in the early days of the international response to the COVID-19 pandemic. By furloughing, companies were able to retain staff with a reduction

in payroll obligation. As their income shrank and business languished the entrepreneurs had little choice. Some businesses are also looking at receivership as a way to a fresh start, in which case creditors may never be paid or receive a fraction of their receivables.

Under the BVI Labour Code, there are stipulations to how businesses must deal with employees and there arose a situation where severance was required to be paid if the companies had to get rid of staff that they could no longer afford to keep because of the pandemic. As a means of assisting these companies that could

not afford the severance or to keep their staff, the government presented a temporary solution.

This short term solution was presented in a statement that was made by the Minister on 3 May. At that time, Hon. Wheatley stated that the Labour Code 2010 is not equipped with the necessary language to protect employees and employers during times of disasters and pandemics such as this COVID-19 situation. As such the Minister extended the three months Lay-off period that is provided for. This extended lay-off period gave a total of four additional months

to employers. This meant that at the end they were expected to either let the staff go with severance or rehire. Most specifically this period was not to exceed 31 October.

At the time the Minister said that the extension was going to alleviate the burden on employees to seek alternative employment, and on businesses to identify the necessary funding for severance, where applicable.

However, 31 October came and went and some employers have not decided and the Chamber of Commerce is concerned about what will happen next. This concern was put forward by the BVICCHA in a press release on 30 October.

The BVI Chamber of Commerce and Hotel Association in its public query on the matter demanded urgent communication from the Ministry of Natural Resources, Labour and Immigration regarding the Government's decision on the workforce furlough extension. The organization pointed out that "If this deadline is not extended, requiring severance payments will likely bankrupt many businesses. Further, it will become unduly costly to restart the hiring process. With no announcement from Government at this time, the Chamber now respectfully urges that the date be extended to 30 November 2020 in the first instance."

Chris Juredin Voted BVI'S CIBC FirstCaribbean Unsung Frontline Hero

Tortola, British Virgin Islands, October 30, 2020 – Mr. Chris Juredin is the BVI's recipient of the CIBC FirstCaribbean Unsung Frontline Hero award initiative for his extraordinary service to the community during the first wave of the COVID-19 pandemic back in March of this year.

The programme, designed by CIBC FirstCaribbean through its ComTrust Foundation to highlight the work of persons across the region at the forefront of the COVID-19 fight, has brought to the fore the stories of many of those whose deeds have gone virtually untold. Over 100 persons were nominated for awards in the 16 countries where the bank operates.

Mr. Juredin's name was submitted by Ms. Natasha Ruscheinski as a BVI nominee for the public campaign that the bank ran during the August/September period. The campaign, which was promoted via social and broadcast media including the ZBVI community bulletin board, sought to identify an individual who had gone above and beyond to serve the community and to publicly acknowledge and thank that person for the deeds that helped people pull through the initial desperate days when the pandemic

was first announced. Public nominations were sought from the following categories of frontline workers: Medical personnel, The Protective Services and Community Heroes.

Ms. Ruscheinski, who runs PAW BVI, an animal non-profit in the BVI, documented Mr. Juredin's acts. She explained that, in responding to her public plea on social media to consider buying extra dog/cat food for those who couldn't afford to stock up for their pets, Mr. Juredin reacted swiftly by personally buying and delivering thousands of dollars' worth of pet food, enabling PAW to do a big distribution prior to lockdown.

As the lockdown extended, Mr. Juredin reached out and asked if PAW needed more food. "By this stage, countless desperate pet owners had reached out to PAW to see if we had food for them, which we didn't. Mr. Juredin stepped up yet again and purchased another huge amount of pet food and then helped distribute it door-to-door to those who were unable to afford to buy it themselves."

"Although the food was for animals and not humans, so many families benefitted from it and were able to keep their pets fed during these difficult times, all thanks to Mr. Juredin. He purchased all the food

himself and asked for nothing in return- when families did make donations, he gave it straight to PAW BVI for their vet bill," said Ms. Ruscheinski.

Mr. Juredin was one of seven people nominated by the public and one of three semi-finalists submitted by the committee panel comprising external and internal judges for further voting by the public to help determine the ultimate Unsung Frontline Hero. The other two semi-finalists were Mr. Trevon Penn for his commitment to the public's health and safety in his role in the Protective Services and Nurse Yahmega John for her dedication and exceptional care in the Medical Personnel category.

At a presentation in the banking hall after hours on Thursday, October 29, Mrs. Vernecia Holder, Head of International Corporate Banking, awarded Mr. Juredin with a gift of a \$2,000 e-cheque to be spent on a staycation of his choice and thanked him for his service. "Mr. Juredin - BVI's CIBC FirstCaribbean Unsung Frontline Hero – on behalf of the bank and the Unsung Frontline Heroes committee, thank you for going above and beyond during those tumultuous and disruptive and disrupted times and for your selfless support of those in need and despair," said Mrs. Holder.



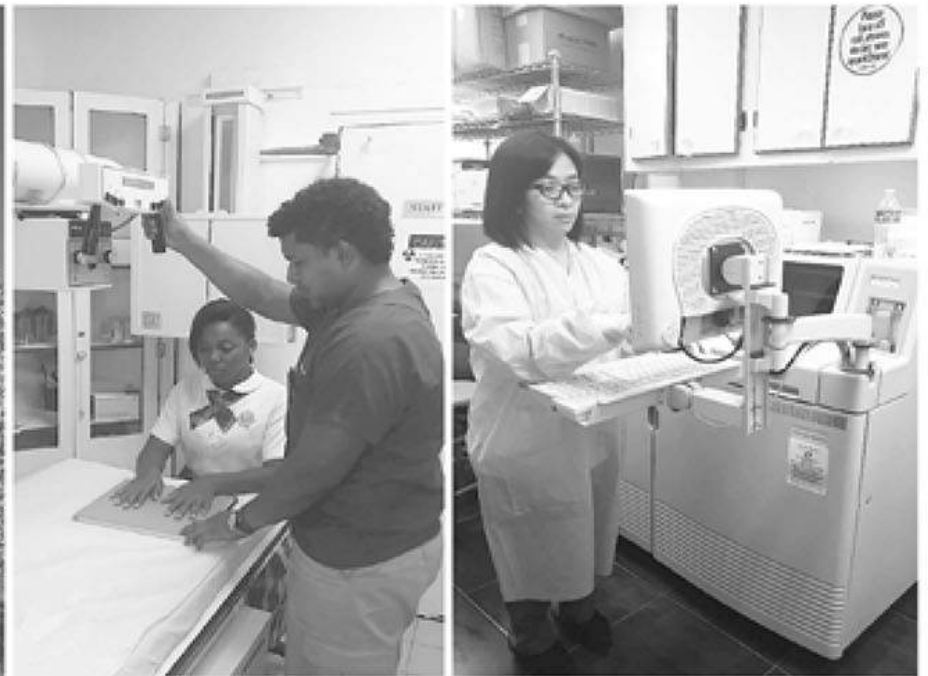

BVI Premier Leads UN ECLAC Discussions On COVID-19 Recovery

Premier and Minister of Finance of the Virgin Islands, Honourable Andrew A. Fahie, chaired a High-Level Panel on 'Challenges for Caribbean to Building Back Better from COVID-19' at the virtually held 38th Session of the United Nations (UN) Economic Commission for Latin America

and the Caribbean (ECLAC), October 26-28, 2020.

Premier Fahie chaired the meeting in his capacity as Vice Chair of the Caribbean Development and Cooperation Committee (CDCC) and stated that the COVID-19 pandemic has generated a new sense of urgency to address holistically

the challenges faced by the heavily indebted middle-income countries of the sub-region already suffering from high exposure to natural disasters and climate change.

The Premier said, "Rarely do we get an opportunity such as these urgent circumstances present to demonstrate the


complex, multidimensional nature of Caribbean challenges and vulnerabilities and to advocate for a uniquely blended response to ensure the survival of the countries of the sub-region during these very challenging times."

The high-level meeting on October 27 began with the official launch of the new ECLAC publication, 'The Caribbean Outlook 2020,' which was presented by the

CARICOM Mr. Joseph Cox and Vice Chancellor of the University of the West Indies Sir Hillary Beckles.

In response to the views expressed by the panel, official statements at Ministerial and official levels were made on the floor of the meeting by Aruba, Barbados, Canada, Cuba, Mexico and Suriname.

Speaking on the outcome of the meeting, Premier Fahie said, "We had very fruitful

As part of the Government of The Virgin Islands' plans to achieve its vision to be a leading economy through entrepreneurship, innovation, foreign and local investment by 2025, Premier and Minister of Finance Honourable Andrew A. Fahie, in consultation with members of his Cabinet, has made a decision to establish an ad hoc Economic Advisory Council to the Premier (EAC).

Premier Fahie explained, "At this stage in the Territory's constitutional and economic development, it is in the best interest of the Government and the people that the EAC, a non-constitutional and independent body be established to provide economic advice specifically to the Premier."

The EAC is expected to highlight key economic issues facing the Territory to the Government of the Virgin Islands from an objective viewpoint.

It will advise the Premier on economic issues including industries, diversification/development of industries, regional and local business opportunities, inflation (e.g. cost of doing business and cost of living), finance and foreign investment, in an effort to ensure that the economy of the Virgin Islands continues in an upward mobility and that the Virgin Islands keeps its competitive advantage regionally and globally.

The Terms of reference as defined by the EAC are as follows:

1. Analysing any issue, economic or otherwise,

referred to it by the Premier and advising him thereon;

2. Addressing issues of macroeconomic importance (whether on its own cognisance or on a reference from the Premier) and presenting views thereon to the Premier;

3. Creating sub-committees of the EAC to look at specific economic categories of the economy including but not limited to foreign investment, national strategic planning, social restructuring, digital transformation/innovation and the environment. Each sub-committee of the EAC shall include representation from the sister islands in the various industries as such representation is determined and approved from time to time;

4. Submitting periodic reports to the Premier on macroeconomic developments and issues with implications for economic policy; and

5. Attending to any other task as may be directed by the Premier from time to time.

Hence, the EAC will closely monitor national and international economic developments and trends and will develop appropriate policy responses and points of action for the Premier. It may also publish annual reports on the economic standing and outlook of the Virgin Islands as well as general reviews on the economy of the Virgin Islands.

Erica Smith-Penn Appointed Complaints Commissioner

Mrs. Smith-Penn will lead the Office of the Complaints Commissioner as well as the investigations carried out by that office.

Governor Jaspert said the role of the Complaints Commissioner is one aspect of ensuring good governance in the Territory.

"Government strives to deliver excellent service to all who live here. The Complaints Commissioner, by hearing out those persons who have a grievance and by working to resolve such grievances, ensures that where maladministration exists, it can be rectified in a fair and transparent manner," Governor Jaspert said.

He added that Mrs. Smith-Penn's experience and qualifications make her an excellent fit for the Complaints Commissioner post.

Premier and Minister of Finance Honourable Andrew A. Fahie said, "The Government of the Virgin Islands knows that our people are our greatest asset. As such, I am always pleased when Virgin Islanders can rise to the occasion and do their part in strengthening our administrative structures further as we move towards self-determination."

He said, "I have had the opportunity to work with Mrs. Smith-Penn in various capacities. She is diligent and is committed to tenets of good governance. I know that her legal expertise and experience working in various arms of the Public Service will be of great benefit as she serves in her new role as Complaints Commissioner. I wish her all the best on this new journey of great potential and the advancement of our people."

Deputy Governor, David D. Archer, Jr. also welcomed Mrs. Smith-Penn's appointment, noting that the Complaints Commissioner's work can help the Public Service continually improve its services.

Mr. Archer, Jr. said, "Since it was established, the Office of the Complaints Commissioner has shared valuable information about how Government entities can improve operations. Mrs. Smith-Penn will be an able Complaints Commissioner and help guide all of us to continue our commitment to excellence in the Public Service."

Mrs. Smith-Penn will succeed Mrs. Sheila Brathwaite, who took up the post in 2015 after the retirement of founding Complaints Commissioner Mr. Elton Georges, CMG, OBE.

Mrs. Smith-Penn holds a Graduate Diploma in Law from the College of Law in Birmingham, United Kingdom; a Bachelor of Laws Degree from the University of Birmingham (Upper Second Class Honours); and a Bachelor of Arts Degree in Management from the University of the Virgin Islands (Summa Cum Laude) in the United States Virgin Islands. Mrs. Smith-Penn was admitted as a Barrister of England and Wales at Lincoln's Inn in the United Kingdom, and as a Barrister of the Eastern Caribbean Supreme Court. She was inducted into the Golden Key Honour Society, she is a trained mediator and was ordained as a Minister of the Gospel in 2005.

Mrs. Smith-Penn has served as Supreme Court Registrar since 2014. Previously, she served as Chief Registrar of Lands. Mrs. Smith-Penn has also served as Deputy Permanent Secretary in the then-Ministry of Education and Culture; and Private Secretary to the Governor and Clerk to the then-Executive Council.

STORIES SELECTED BY GIORGIO MIGLIAVACCA

SANTO DOMINGO - President Luis Abinader and Tourism Minister David Collado were in Punta Cana on Thursday, 29 October for the announcement of the Latitud 18° Santo Domingo at the Hard Rock Punta Cana. Rodrigo Chapur, voice for the Mexican hotel group, Grupo RCD, announced two high rises of 20 floors each are part of the project set to go up on the corner of Av. Abraham Lincoln and Andres Julio Aybar street in Santo Domingo.

A 208 room Marriott Hotel would be built in one 20 floor building. The other would be an Aloft Hotel, another Marriott International brand and would have 192 rooms. The Aloft brand is most notable for its modern architectural design style.

The promoters say there will be four levels of underground parking. There will be a modern gym, three restaurants with terraces and a 2,000 m² meetings and events hall. The promoters announced an investment of US\$70 million. [DR1]

NEW YORK - Long Island, health officials scrambled to contain a coronavirus outbreak in Suffolk County when dozens of people tested positive for the virus after attending a high-end Sweet 16 party in September that violated state restrictions on gatherings. On Wednesday, county officials said they were coping with the fallout from two more so-called

superspreader events that left 56 people with the virus and nearly 300 in quarantine: a wedding that exceeded the state's 50-person limit and a birthday party that did not.

"This kind of blatant disregard for the well-being of others is not only extremely disappointing, it will not be tolerated," Steven Bellone, the Suffolk County executive, said at a news conference, referring specifically to the wedding. "If you violate the rules, you'll be caught and held responsible."

Bellone said the venue where the wedding was held, the North Fork Country Club in Cutchogue, would be fined \$17,000. Ninety-one people attended the wedding, on Oct. 17, officials said. Thirty people, including 27 guests, two employees and an outside vendor, later tested positive for the virus, and 156 people wound up under quarantine, officials said.

A spokesman for the State Liquor Authority said it had opened an investigation into the matter "upon learning of this allegedly illegal and dangerous event." [San Juan Star]

JAMAICA - The Jamaican government has paid tribute to Sean Connery, the Scottish actor who is best known for playing fictional spy James Bond in seven films from 1962 to 1983.

Connery died on October 31 at the age of 90. Through his portrayal

of the character written by famous Jamaican resident, Ian Flemming, Connery brought the beauty of Jamaica to Hollywood. His first appearance as James Bond came in Dr No in 1962. Some scenes from the movie were shot on some grounds of Goldeneye, Fleming's home which was later turned into a resort. Other scenes were shot in Oracabessa, Port Royal and the Palisades strip in St Andrew. Several scenes from Live and Let Die (1973) were also shot in Jamaica.

Jamaica's Prime Minister, Andrew Holness sent his condolences to the family, friends and fans on Connery, saying: He will always be remembered as the original James Bond with the phrase: 'The name's Bond... James Bond.'

The island's Minister of Culture, Gender, Entertainment and Sport, Olivia Grange also praised the actor for his work which she says brought both him and Jamaica to world attention. In a post on Twitter, Grange said, "Jamaica remembers Sean Connery, the first James Bond, whose role in the blockbuster film 'Doctor No' brought both him and beautiful Jamaica to world attention."

"His career in films included many stellar roles, but Jamaica will always remember him for his role in the classic adaptation of Ian Fleming's novel. Sending tribute and commendations from Jamaica. #RIP," she added. [Caribbean National Weekly]

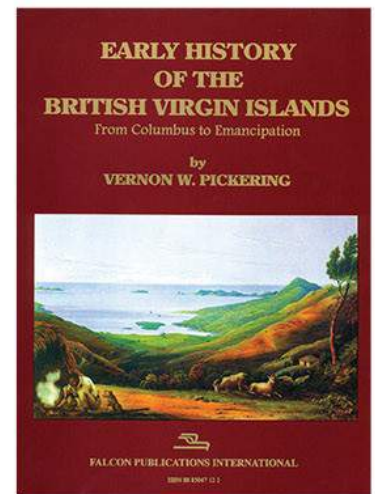

Turmeric tea's strong anti-inflammatory properties can help ease inflammation and swelling in people with arthritis. This reduces painful symptoms. One study Trusted Source found that an active compound in turmeric, called curcumin, was effective in reducing pain in patients with osteoarthritis.

2. Helps prevent Alzheimer's disease

While research is still searching for what exactly causes Alzheimer's disease, it seems as though the curcumin found in turmeric may help prevent it. Turmeric's antioxidants prevent damage that can lead to Alzheimer's. Even more importantly, some research shows that turmeric can reduce the synaptic marker loss and the accumulation of amyloids linked to Alzheimer's development.

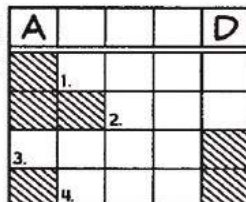

Cactus Is a Prickly Treat

I was shopping in an ethnic grocery store when I saw a huge pile of fresh Prickly Pear cactus pads in the produce section. Prickly Pear cactus is thought to be native to Mexico and is eaten as a vegetable. The cactus is called “nopal” in Spanish, and the pads or stems are called “nopales.” Mexico exports 40,000 pounds of nopales pads to Texas every day. They’re also grown as an export crop in Central America and Israel.

The pear-shaped fruit on the ends of the nopal pads are called “tunas,” and range in color from a greenish-white to purple. If the tuna fruit are sweet, they’re eaten raw or used to make wine or as a sweet syrup. If sour, they’re cooked and incorporated into a variety of recipes. I’ve always wondered about the first adventurous cook to take this prickly crop and turn it into a delightful dish!

Preparing the fresh cactus pads takes time and care, as all of the prickly spines and thorns must be carefully removed. After the pads have been prepped, they’re grilled or boiled until tender. When sliced thinly, the

nopales are called “nopalitos.” They look like French-cut green beans and have a similar texture.

You can buy nopalitos in a can or jar, and both the fresh nopales and the canned variety are widely available in ethnic supermarkets. I prefer the ease and convenience of using the canned nopalitos because it’s difficult to prepare them properly the first few times. Be sure to rinse the canned nopales well before using them.

Nopalitos are a popular ingredient in Mexican dishes. They’re scrambled with eggs and served during the Mexican celebration of Lent, used as a taco filling, as a vegetable in soups, or breaded and eaten like French fries.

I used breaded nopalitos as a crunchy topping for this unusual Fried Cactus Salad. Enjoy this taste of Mexico, and try nopalitos in your recipes to give your dinner a South-of-the-Border flair!

FRIED CACTUS SALAD

- 1 cup fresh nopalitos, rinsed, drained and patted dry
 - 1/3 cup all-purpose flour • 2/3 cup cornmeal
 - 1 teaspoon chili powder • 1 1/2 teaspoon salt
 - 1 teaspoon ground black pepper
 - 1/8 teaspoon cayenne • 1 cup vegetable oil
1. To make the fried cactus, place flour, cornmeal, 1 teaspoon salt, black pepper and cayenne pepper in a small bag. Shake the bag to mix the ingredients. Drop the rinsed and drained nopalitos into the bag. Shake until the strips are well-coated.
 2. Heat oil in a medium-sized skillet, about 2 to 3 minutes. Fry the strips until they are golden brown. Place strips on a paper towel to drain, sprinkle with the remaining salt, and set aside.

Salad:

- 3 tablespoons chopped white or sweet onion
- 1/2 cup chopped fresh cilantro
- 1/2 teaspoon dried oregano or 2 teaspoons fresh
- Romaine Lettuce, torn into bite-sized pieces
- 1/4 cup prepared Italian Dressing

Topping:

- 3 tomatoes, sliced
- 1/3 cup chopped fresh cilantro
- 1/3 cup crumbled queso fresco or anejo or Monterey jack cheese
- 1/3 cup purple onion rings
- 1 avocado, peeled and sliced (optional)

Place the onion, cilantro, oregano and lettuce into a large bowl. Drizzle with the salad dressing. Toss to combine. Top with the tomato slices, cilantro, cheese, onion rings and avocado. Sprinkle the fried nopalitos over and around the salad. Makes about 4 servings.

This year's theme is, The Caribbean Awaits.

This theme compliments the region's success in generally containing the spread of COVID-19 which has taken a major toll on tourism along with other sectors of our economies. EU: Brexit Trade Talks Still Face 'Too Many Difficulties'

BRUSSELS - With a deadline looming ever more menacingly, the European Union's chief negotiator on the post-Brexit trade deal with Britain on Wednesday publicly blamed London for a lack of progress in the two sides' belated attempt to reach an even rudimentary agreement.

"At this stage, there are still too many difficulties remaining on important topics," Michel Barnier said on his way to brief the envoys of the 27 member states.

In a Twitter comment later, Barnier said, "Despite EU efforts to find solutions, very serious divergences remain."

Britain's chief negotiator, David Frost, said he agreed that "wide divergences remain on some key issues."

"We continue to work to find solutions that fully respect U.K. sovereignty," Frost tweeted.

Barnier's comments threw a dampener on optimistic reports that progress was being made at a rapid pace on issues such as fisheries rights, one of three remaining major topics that need a compromise solution if a deal is to be found before Jan. 1, when a transition period in the Brexit divorce proceedings ends.

Barnier's stern words were in complete contradiction to the olive branch he offered London only two weeks ago after British Prime Minister Boris Johnson insisted that the EU and Barnier fundamentally had to change tack to continue the negotiations.

Both sides have been intensely negotiating since, but, as Barnier pointed out, to little effect.

The lack of progress on fisheries and on the need to have common regulatory standards and fair competition to make

sure Britain won't undercut EU businesses has befuddled the negotiating teams for months, as both sides have been trying to strike a trade deal since the U.K. left the EU on Jan. 31.

Without a deal, trade between both sides would fundamentally change, and hundreds of thousands of jobs would be threatened on both sides, especially in nations close to Britain such as Ireland, France, Belgium and the Netherlands. Barnier insisted again Wednesday that the EU "is prepared for all scenarios."

In the trade negotiations, Britain wants to retain as many of the advantages of EU membership as possible without having to live by the bloc's rules. The EU is insisting on stringent trade regulations to avoid having a giant buccaneering trade partner on its doorstep that could freely undercut the bloc's state aid, social and environmental standards.

After negotiating in Brussels this week, the talks are set to move to London again in the coming days.

Coaching dilemma: VG United Coach teams play in different venues

When Virgin Gorda Men and Women's Football teams played on Tortola on Saturday, Coach Thomas "Manly" Albert found himself with a dilemma. One team would suffer, as both his VG United Men's team of which he's Captain and VG United Women's team which he coaches, were scheduled to play at different venues, with games starting 15 minutes apart—4:15 and 4:30 respectively.

The Men were Greenland, the Women—in the 5-A-Side League debut—were at Cedar School in Kingston.

The Men's game against league leaders Islanders—which has been interrupted by COVID-19 and had its latest restart last month—had long been on the BVI Football Association schedule.

"The Manager was trying to let them know—the Football Association—not to do something like that," Albert told Island Sun Sports. "Both VG teams cannot go and play

on the same day, but I think they sent the information late. I'm the Head Coach of the Women's team and had to send my assistant Anna French, but she had to play on the team."

Albert said it was difficult for his Women's team that lost to the Wolues 6-2, to play without him, while his men's side was losing 3- to Islanders. During Monday's practice, Albert said the first thing he asked was about the game.

"They said 'Coach, you weren't there. We didn't play how we were to play because the assistant coach was on the field. If I were there, it would have been different," he noted. "The first thing I did was apologize and I told them, remember, I'm the Captain of the VG United Men's team and the team really needed me, but I still had an assistant to do the job."

Albert said he spoke to his Men's team manager and told him if it happens again, he's be going with the Women's team and someone will be in charge of the Men's game.

"It was a rough spot," Albert noted. "I'm

on the field and I'm not feeling well. I tried to play against Islanders, but my mind was on the women's game."

When asked about the conflict, Lorrelle Abrams told Island Sun Sports there wasn't a particular reason but it was the only time the game could be played.

"A lot of things were taken into consideration and in order to get anything done, we just had to make a decision to start now and not to delay it further," said Abrams noting the 2017 Hurricane displaced a lot of players. "It's only a temporary decision. Hopefully come January, things will be better."

Abrams said they did look at the BVIFA schedule in planning the league.

"There will be conflicts," she said. "It's because of the situation that was handed to us and we wanted to get the Women's program off and running, this is the decision we had to make."

Women's Committee Chair Mary Phillips

told Island Sun Sports the decision was made over her head.

"In fact, I would have preferred that we play and have all the guys come out and support the ladies," she said. "Personally, I wouldn't schedule a game for the men and have the ladies playing, especially for the opening. That was a decision of the others."

2020. That pledge was also given to the member states of the OAS at a subsequent meeting of the Permanent Council. But the February date became May, and then September and finally October, amid growing violence in the country, including atrocities against the indigenous people

who are the main supporters of Morales party, Movement Towards Socialism (MAS).

No effort was made in the OAS to hold Añez's government to account because, hypocritically, it had become an ally of powerful governments in their campaigns to target selected countries, particularly Venezuela and Nicaragua. Only increasing agitation by the Bolivian people eventually led to elections on October 18, 2020.

88.42 percent of Bolivia's seven million voters turned out at the election, giving Morales' successor as the leader of MAS, Luis Arce, 55.18 percent of the vote in the first round. There was no room for the OAS, or any elections observation mission, to claim fraud. For many, this overwhelming number served to reinforce the view that Morales had also won the 2019 elections and had been wrongfully denied it.

Despite MAS' convincing win, all is not well in Bolivia. Luis Arce, the President-elect, will not be sworn-in until November 8. In the meantime, much mischief can be made, and there are those who are agitating it.

On October 27, crowds were organized outside military barracks in four areas of Bolivia, calling for the armed forces to intervene to overturn the result of the October 18 general election. The ethnic group, who had ruled the country for decades prior to Morales, and who grabbed power for a year under Añez, is angry at having to relinquish control. Among the organized crowds were far-right militia groups, threatening violence if the result is not overturned.

However, the military is keenly aware that the large number of MAS supporters would not tolerate another installation of a government they did not elect. These supporters are already demanding action against the military for killing protesters opposed to the removal of Morales last year. They want Arce to punish those

A bizarre moment at the 50th session of the general assembly of the Organization of American States (OAS), on October 20 and 21, was a claim by the outgoing Foreign Minister, Karen Longaric, that her government had brought democracy to Bolivia.

It was the people of Bolivia who had brought democracy to Bolivia - and everybody knew it. Ms Longaric was one of those who had helped to deny it.

Most Bolivians, resentful of Ms Longaric and her party that had assumed government one year ago with the help of the military, turfed them out through the power of the ballot. On November 11, 2019, the commander of the armed forces, Williams Kaliman, announced that “we ask(ed) the president of the state (Evo Morales) to renounce his presidential mandate”. It was hardly a request that Morales could refuse with the armed forces arrayed against him.

The military instruction to Morales to renounce his Presidency and leave Bolivia came after Presidential elections were declared fraudulent by an audit team from the OAS. The team's findings were hotly disputed, including by the New York Times which, on June 7, 2020 said that, “a study by independent researchers, using data obtained by The New York Times from the Bolivian electoral authorities, has found that the Organization of American States' statistical analysis was itself flawed”.

Recalling this event at the OAS 50th general assembly, Maximiliano Reyes Zúñiga, the Mexican representative, placed responsibility for the “flawed” analysis directly in the hands of Luis Almagro, the OAS Secretary-General. He stated, “Mexico suggests to Mr. Luis Almagro that he submit himself to a process of self-criticism of his actions against the OAS Charter and for hurting Bolivia's democracy, to determine if he still has the necessary moral authority to lead this organization”.

In any event, in November 2019, the Bolivian military installed Jeanine Añez, a member of the Civic Community party, as President. She pledged to hold fresh elections within three months in February

responsible, something he is unlikely to do, given the impracticality of it. Therefore, an uneasy truce is more likely with the troops staying in their barracks, and the commanders maintaining their constitutional role. At least for now.

Bolivian society is riven by deep ethnic divisions. Racist discourse, religious bigotry and regional rivalry have long been a feature of the country's politics. The hostility has re-emerged in a nation divided between a wealthier, more European-descended lowland east and a more indigenous, poorer, highland west.

This situation will call for careful handling by the new Arce government. While those opposed to his government on grounds of ethnic superiority are a minority, they

comprise the far-right which is given to violence, and have links to other far-right, ideological groups in the hemisphere.

In seeking reparations for slavery, CARICOM countries have made it clear that they also want reparation for genocide against indigenous people. That is why shortly after Añez's government took office, Ambassadors representing the 14 independent CARICOM nations at the OAS, produced a resolution, taking a strong position against discrimination and violence toward the indigenous people in Bolivia. It was adopted by a majority vote of only one vote to the vexation of governments at the OAS, allied to the Añez government.

Fortunately, on October 21, with no shred of doubt surrounding the will of the majority of the Bolivian people in the 2020 elections, the US government declared that it “looks forward to working with the new, democratically elected government on matters of mutual interest”.


Nonetheless, unease remains among some hemispheric nations ruled by a particular ethnic and rightist elite. Consequently, the situation in Bolivia will now have to be watched carefully for attempts to undermine Arce's government by forces inside and outside the country.
