## REFORM PROGRESS SATISFACTORY, BUT **MORE NEEDS TO BE DONE**

While Governor John James Rankin CMG praised the Government for the progress that has been made in some areas to date, His Excellency announced that there are areas that are of concern such as the continuous issuing of contracts without tender.

In his first quarterly review of the "Framework for Implementation of the Recommendations of the Commission of Inquiry Report and Other Reforms" on 4 October, the Governor noted that while he has some concerns, he is pleased with the reform with the Premier and progress.

He is pleased with the overall constructive engagement and partnership he has had

Cabinet, and noted that by far most of the deadlines in the framework have been met on time. He also stated that he is satisfied

that those that have been delayed were for legitimate reasons.

The areas of delayed reform flagged by the Governor include amendments to the Register of Interests Bill which, he said, restricts access to the Register and would only make it publicly available in the most limited way. He also noted the resistance encountered to some of the nominations for the Constitutional Review Commission which ran contrary to the importance of the Commission being representative of the BVI as a whole.

His Excellency also raised concern about the continued tender waivers which are being put forward to Cabinet with insufficient justification.

While explaining his issue with these matters the Governor pointed out that: "The overarching aim of the COI and this reform programme is to improve governance, accountability and transparency for the benefit of all of the people in the British Virgin Islands. It is essential that the areas of concern I have outlined

are addressed and that new governance issues do not arise."

He also explained that while a lot has been accomplished since the reform began there was still "much hard work" to be done.

The Governor announced: "Over the next few months we will start to see the outcomes from the various reviews, audits and investigations that are under way. The next stage will include consideration of those outcomes and

the actions required as a result. Some are likely to involve difficult discussions and further much needed change to previous practices."

The reform process is a result of the Commission of Inquiry conducted recently. The current process is being carried out by the Government of National Unity. This was the first of the quarterly reviews that are part of the United Kingdom Government required accountability and good governance checks and

balances. The Governor's review is a key part of the Framework document that was agreed upon between the UK and the Government of National Unity as it is a method of monitoring the implementation of the COI recommendations.

This review which was read to the public by the Governor has already been sent to Ministers in the UK for consideration. His Excellency has since promised to hold a press conference once he has received a response to the report.

## DOMESTIC VIOLENCE IS ON ENDLESS RISE

Domestic Violence is just cohabiting." increasing in the Territory, and in an interview on 1 October in observance of Domestic Violence Awareness month, Gender Affairs Coordinator Tara Sue Morgan announced that there is a misconception that domestic violence only relates to persons in intimate or sexual relationships. She said that this is not true and can also include biological family members.

The Gender Affairs Coordinator announced: "It could be violence against your grandmother, a child in the household, or among parents in the household. They don't have to be married; they don't have to be in a relationship because it could be persons who are

"Domestic violence is any act of intimidation that's brought against somebody or violent act that is brought against somebody which is normally related to somebody trying to achieve power over the other person. Specifically, to the BVI when we speak about domestic violence, we refer to persons who are intimate partners. So, a lot of times, people will interchange domestic violence for intimate partner violence but it's more than that," she added.

She noted that this is one of the messages that will be harped out during this year's observance of October as Domestic Violence Awareness month. "The mission is to get the word

out to as many persons as we can around the Territory and even if persons want to listen in from outside of the Territory... for persons to know what it is, how you can deal with it and what is there for you - what can be there to help you."

As it relates to the increasing cases, Morgan explained that all cases are not being reported and that even though the ones that are being disclosed have increased: "It's increasing - the reported cases, and if the reported cases are increasing you can imagine."

"From 2016 theren is a constant increase... over the years you can see the trend and it always so happened that based on the reports from police that women [are] always double in reports. It's always double or triple," the Gender Affairs Coordinator added.

While noting why some of the cases are not reported Morgan suggested that shame and embarrassment might be the main reasons. "It's a small community and a lot of people are fearful that once one person knows it is quite likely several people are going to know and then, especially in this era of social media where people can just catch a little tape, a little conversation, you can just say something privately to your friend and next thing you know it's on blast... A lot of people are trying their best to protect their sanity," she noted.



## **ELECTRICITY PRICE REVIVES ANCIENT CALL FOR ALTERNATIVE ENERGY**

The price of electricity does not show any signs of getting cheaper soon, and Premier Dr. the Hon. Natalio Wheatley made it clear during a 23 September press conference that government might not be able to offer more subsidies on high bills across the BVI. This is a global problem that will cause "turbulence" of all kinds.

During the 12 September subsidy announcement by Ministerfor Communications and Works Hon. Kye Rymer it was announced that Government was sympathetic to the plight

of rising fuel cost in the Territory and was going to subsidize the electricity bills of residents for three months.

Hon. Rymer, while illustrating that the Government is very much aware of what is being reflected on electricity bills across the BVI explained that Government allocated some funds to help to lower residential electricity bills by half. The Deputy Premier stated that Government will be subsidizing 50 percent of the fuel oil surcharge on residential electricity bills for the months of October and

November 2022, and for the month of December 2022 the subsidy will be 100% of the fuel oil surcharge for residential electricity bills.

The Minister also said that the Government hoped that this measure will ease the burden of residents; and he explained that the Government remains committed to doing everything possible to provide the support needed to help you through these scary and challenging times.

However, during his recent press conference, the Premier announced: "I know that people all over the world are experiencing high prices, but certainly I would love to see the price of the electricity be lowered because, of course, it's only so much subsidization Government will be able to do."

While stating that subsidies will not be totally off the table, the BVI Leader said, "We'll have to examine (whether to continue the electricity subsidy) moving forward based on the resources that we have available, but certainly I think we have to get very aggressive about going into alternative energy because,

of course, we couldn't afford to subsidize throughout the whole year."

Nonetheless, he commented that alternative energy might be the only solution to this electricity high cost that is being caused by a global fuel situation. The Premier in noting the need to go alternative said, "We'd be able to provide a little bit more resilience into our energy sector, we provide a little bit more stability, a little bit more predictability, and I think this is the way that we all have to go."

## "MY REPUTATION SPEAKS FOR ITSELF": NDP LEADER SAYS

Leader of the National Democratic Party Hon. Marlon Penn has announced that the Party already has a slate of persons ready to contest the upcoming 2023 general elections. He indicated that most of the persons will be first-timers in the political arena.

The NDP Head made this disclosure during his guest appearance on the Tola Radio Morning Braff programme on 4 October. When asked about the readiness for upcoming elections Hon. Penn said: "I think we have assembled a group of young men and women who have the capacity to do this, to move this country forward and I think the reality is that we have to focus on the people. We need a people-centric approach to lead in this country."

During that appearance the NDP third-termer was asked to address comments that were made by political activist Claude Skelton-Cline recently on his radio programme. The comments related to Skelton-Cline's question of Penn's leadership ability and stating that he might lose the next election.

In response Hon. Penn explained: "I am not going to entertain that rhetoric [of] some boys." He further responded to the comments by stating that the public should compare the track records of himself and those speaking about him. Penn declared: "I'm wary of these persons who come and say

they are speaking on behalf of the public. All you have to do is check their own personal track record and you will see who they are speaking on behalf of."

"At the end of the day, my reputation is going to speak for itself. Wherever I've been, I've left where I was better than it was. I'm a man that is focused on the empowerment of people, empowerment of my Territory... To move this country forward I think the reality is that we have to

focus on people. We need a people-centric approach to leading this country", he added.

Nonetheless, the legislator said that he understands that the comment was someone's personal opinion which they are entitled to. "We are in a level of democracy and persons have a right to express their democratic view and I'll never try to infringe on anyone's democratic view, on their perspective in terms of what they bring forward."

## Statement From Governor John Rankin CMG - 4 October, 2022

Today I am pleased to share with you my first quarterly review of the "Framework for Implementation of the Recommendations of the Commission of Inquiry Report and Other Reforms" ("the Framework document"), being led by the Government of National Unity. The quarterly review is a key part of the Framework document that was

agreed between the UK and Government of National Unity to monitor the implementation of the COI recommendations.

This review has been sent to Ministers in the UK for consideration and I will hold a press conference once I have received their response to it.

The quarterly review includes a summary of progress against deadlines for implementation

of the COI recommendations. It highlights a number of key areas, including: investigations and audits; policy and reviews of appointments governance; to statutory boards; reform assistance grants; tendering of contracts; and law enforcement reform. As required by the Framework document it also includes an assessment of the political

culture exhibited in the day-today running of government.

I hope you will take time to read the review in full. There has been good progress in some areas to date, and I am pleased with the overall constructive engagement and partnership I have had with the Premier and Cabinet. So far most of the deadlines in the Framework have been met on time and I am satisfied that those that have been delayed were for legitimate reasons. I am pleased that UNICEF has agreed to support the review of assistance grants which is now underway, and that His Majesty's Inspectorate of Constabulary from the UK has agreed to lead the review of the law enforcement and justice system. These are examples of where the delay in starting the reviews was justified to ensure we found the right reviewers through the right processes.

However, in the quarterly review I note a number of areas of concern where there has been less progress than expected, and where I have been disappointed with the level of commitment to reform. These include amendments to the Register of Interests Bill which restrict access to the Register and would only make it publicly available in the most limited way; the resistance encountered to some of the nominations for the Constitutional Review Commission which contrary to the importance of the Commission being representative of the BVI as a whole; and the continued tender waivers being put forward to Cabinet with insufficient justification.

The overarching aim of the COI and this reform programme is to improve governance, accountability and transparency for the benefit of all of the people

## Community Meetings on Long Bay Beach Management Plan Upcoming

The Ministry of Natural Resources and Labour has continued work on The Long Bay, Beef Island Beach Management Plan since it was initially introduced to the public for feedback earlier this year.

The development of the Long Bay, Beef Island Beach Management Plan is being done in a phased manner. The process began with a Conceptual Plan which was discussed and open for feedback via community meetings held March 29 and March 31. Additional input to the planning process was received via an online public survey. Comments and inputs were taken into consideration

and amendments to the Conceptual Plan made as the basis for moving forward. The Long Bay, Beef Island Beach Management Plan is now in its draft detailed stage, which will be open to more feedback from the public before the Plan is finalised in the coming weeks.

Minister for Natural Resources and Labour Honourable Melvin Turnbull stated that he was pleased that the Plan is progressing and spoke on its importance. He said, "The progression and implementation of the Beach Management Plan for Long Bay, Beef Island is crucial to the overall sustainability of that beach. It is a beach that you can visit year round without

having to worry about riptides or undertows. Long Bay, Beef Island has become a popular location on Tortola for tourists, sharing in the footprint of cruise passengers that is customary in Cane Garden Bay and Brewers Bay, especially after the 2017 hurricanes. My Ministry remains committed to ensuring that the proper balance is struck between economic growth and natural sustainability at all beaches in the Territory."

Environmental Officer in the Ministry of Natural Resources and Labour Ms. Angela Burnett Penn highlighted how much progress has been made since the Conceptual Plan was presented for feedback. She 

said, "The conceptual plan focused on a spatial plan for the beach to determine the best placement of facilities and amenities and designation of use zones to support the vision for the beach."

She added, "Now that we have gotten feedback on the Conceptional Plan from the public, additional input through the survey and gathered field data, the Ministry has developed comprehensive Draft Detailed Plan with input from various agencies and experts. The Draft Detailed Plan includes several layers: the Spatial Plan, Facilities Plan, Environmental Restoration Protection Plan. Management Measures & Rules, and an Implementation Plan. We are again seeking feedback from the community to ensure that all stakeholders are as satisfied as possible with the proposed Plan."

There will be a virtual community meeting on Tuesday 11 October on WebEx at 6:30 p.m that will be streamed on Facebook live. The link to join that meeting to give feedback on the Plan is tinyurl.com/3a58fcs4.

The in-person community meeting will take place at the East End Methodist Church Hall at 6:30 p.m on Thursday 13 October. The final Plan will be presented to the Cabinet of the Virgin Islands for approval following any revisions based on public comment.

## Contract Inked For Demolition Of Temporary Classrooms At Old CTL Building

As the Recovery and Development Agency (RDA) remains steadfast in its quest to deliver four new buildings on the main Elmore

Islands has signed the contract for demolition works of the temporary Elmore Stoutt High School project, located in the old CTL Building.

The contract was awarded to Construction and Engineering Systems (BVI) Limited on 3rd October, 2022 in the amount of US\$97,359.00.

This project will return the Old Clarence Thomas Building to its original configuration and remove existing equipment and infrastructure.

The Scope of Works include the removal of lights, power outlets, doors, frames, acoustic ceilings, emergency by constructing temporary classrooms that would facilitate a shift system for students and teachers by utilizing a space that was once a business structure.

Thirty-five (35) classrooms were constructed using readily available lumber to separate each room. There is also a teacher's lounge, administrative area, a conference room, a radio station and the Principal's Office inclusive of a waiting area and kitchenette.

This temporary school was upgraded by the RDA in 2020 improving the facility by installing improved AC,

lighting, and sound proofing.

This temporary facility is now due to be demolished as the building is to be returned to

its original configuration. Meanwhile, works are steadily advancing towards the completion of the main campus of the Elmore Stoutt High School, a project being executed by the Recovery and Development Agency.

ITALY - In Italy, an old video has been making the rounds. It shows a beautiful young woman saying things that are not so beautiful. Donning 1990s fashion, her body turned to the back from the front seat of a car, she answers questions for a French television reporter in good if accented French. "For me, Mussolini was a good politician," she says. "Everything he did, he did for Italy, and that is something that is not found in the politicians we have had in the last fifty years."

She will most likely be elected Italy's prime minister next Sunday.

Georgia Meloni is no longer 19 years old, and she no longer speaks so openly of her admiration for Italian dictator Benito Mussolini, but she has never forgotten which political tradition she belongs to. Because fascism was never formally expelled from Italian public life after the second world war. In Germany, the allies imposed a rigorous program that permanently excluded ex-Nazis from power. In Italy, however, fascists were allowed to regroup under a new party, the "Italian Social Movement."

That's what it was still called in 1992, when Giorgia Meloni, then only 15 years old, joined its youth wing. Since then, the party has changed names several times. But let's be clear: Fratelli d'Italia, the party Giorgia Meloni leads, is the successor party to the successor

party to the party founded by Benito Mussolini. It has never renounced il Duce's legacy.

Does this mean that Italy is returning to fascism?

#### Not necessarily.

The fact that Giorgia Meloni is on the brink of power has less to do with her neo-fascism and more to do with how easily Italian voters are seduced by anti-establishment candidates. Meloni is just the latest in a long string of radical and populist outsiders that have been growing in popularity in Italy since the 1990s. In fact, Meloni's junior coalition partners include the leaders of two of the last three antipolitics waves in Italy: the now elderly Silvio Berlusconi and Matteo Salvini, leader of Lega (the League), yet another far-right anti-establishment party. [El Pais]

**ROME** - The new Italian government has "difficult decisions" in store due to the country's high public debt and the expected onset of recession in Europe, S&P Global Ratings has said.

The ratings agency highlighted the "limited" room for budget manoeuvre, with the debt set to be around 138% at the end of the year and the deficit coming in at around 6.3%.

"Despite this, we do not expect imminent budget risks in the transition to the new government," it said. S&P forecasted negative growth of 0.1% for Italy in 2023, with GDP expected to rise by 1.5% in 2024.

Giorgia Meloni is expected to become Italy's first woman premier as her right-wing Brothers of Italy (FdI) party was the driving force of the right coalition's victory in Sunday's general election. (ANSA)

**UKRAINE** - As the war in Ukraine enters its eighth month, Americans are growing tired of the Biden administration's approach to punishing Russia for the invasion, a new poll suggests.

According to the poll conducted by Data for Progress and commissioned by the Quincy Institute for Responsible Statecraft, 57 percent of likely voters strongly or somewhat support the U.S. pursuing diplomatic negotiations, even if it means Ukraine would have to make compromises with Russia. Comparably, 32 percent of respondents were strongly or somewhat opposed to the idea.

The poll also found that 49 percent of Americans believe that Congress and the Biden administration need to do more diplomatically to help end the war. However, Washington has largely written off wading into negotiations and stuck to just providing military assistance to Ukraine. (Newsweek)

**BERMUDA** - The Government has tabled legislation to make a number of essential goods duty free in an effort to address the cost of living.

David Burt, the Premier, said the Customs Tariff Amendment (No 3) Act 2022, tabled in the House of Assembly, would drop duty rates on 21 essential items, including a variety of food and sanitary products.

Mr Burt said: "Since the House rose just before Cup Match, we have been working on concrete measures to address the cost of living. [Royal Gazette]

**TRINIDAD** - The worldwide Hindu community says it is aghast at reports of continuous vandalizing of Hindu temples in Trinidad and Tobago in recent months.






# BVI Cancer Society kicked off its month of activities

# October Brings Pumpkin Bisque With a Twist

**Oh, October! It's officially pumpkin-flavored everything month!** If you want to see the face of bliss, offer your loved ones this easy-to-prepare scrumptious Pumpkin Apple Cider Soup lovingly paired with adorable grilled cheese croutons.

**Although incredibly nutritious,** pumpkin on its own is a little bland. We're infusing complexity into it by adding onion, garlic, lots of seasonal spices, apple and apple cider. The cider and the apple bring the perfect balance of sweetness and acidity to this soup. However, this is a savory soup; don't expect a pool of pumpkin pie!

**If your budget allows,** this is the time to splurge on some good unfiltered cider. You only need one cup for the soup; the rest you get to sip when evenings get chilly.

You can choose to make this soup as chunky or as smooth as you like. The outcome depends on how small you chop the ingredients and if you decide to puree the finished soup. I chose the middle ground with finely diced onion and apple and was very pleased with the results. My family loved the little bursts of apple spiking the rich and savory soup.

## PUMPKIN APPLE CIDER SOUP

#### **Total Time: 40 minutes**

### Yield: 8 cups

- 1 tablespoon each of olive oil and butter
- 1 cup onion, diced
- · 1 cup apple (any variety), peeled, cored, and diced
- · 1 teaspoon garlic, minced
- 1 (large 29-ounce) can pure pumpkin
- · 4 cups (32-ounce box) chicken or vegetable broth
- 1 cup apple cider
- · 1 teaspoon thyme
- · 1/2 teaspoon each of cinnamon and ground ginger
- 1/2 teaspoon kosher salt
- 1/4 teaspoon pepper

## Optional for bisque: half and half or heavy cream

## Garnish: sour cream, pepitas, roasted pumpkin seeds

In a heavy bottomed soup pot or large saucepan over medium heat, bring the oil and butter up to a sizzle and saute the onion for about 3 minutes. Next, add the apple and continue to saute until both are quite soft. Add the garlic and stir to combine and take a moment to appreciate that amazing aroma. Don't you love a great savory and sweet combo? Now, let's make soup! Add the pumpkin, chicken or veggie broth, apple cider and stir. Now add the spices, thyme, cinnamon, ginger, salt and pepper. Stir to combine and let this simmer for 20 minutes. Remove from heat. Adjust seasoning to taste.

At this point, for a creamier, totally smooth soup, you can use an immersion blender or transfer soup to a blender to puree until it reaches your desired consistency. You also can choose to add half and half or heavy cream to make pumpkin bisque. I'd start at half a cup and add from there.

To serve, ladle into bowls and serve with grilled cheese croutons -- instructions below. For extra Diva flair, you can garnish with little dollops of sour cream (it doesn't dissolve into the soup like heavy cream would) and a sprinkle of bright green pepitas (shelled pumpkin seeds) and/or roasted whole pumpkin seeds.

## **GRILLED CHEESE CROUTONS**

## Total Time: 10 minutes Yield: 12 croutons

- 1 baguette (day old is perfect!)
- · 1 (8 ounce) block sharp cheddar cheese, room temperature
- 1/4 cup butter, room temperature

Preheat a skillet on medium-high heat. Slice a baguette into 24 (1/4 inch) slices. Slice cheese into 12 slices. Place a slice of room temperature sharp cheddar cheese between two slices of bread and butter the outsides, like little sandwiches. Grill the croutons in the skillet until golden brown.

Make extra, because these are simply addictive! I kid you not. This is a dish destined to become a fall family favorite.

After years of debate, public pressure and tireless campaigning by activists - including our chapter in Australia - the country is finally set to create a federal watchdog agency with broad powers to investigate serious or systemic circumstances'. They also flagged corruption.

Transparency International Australia first made the call for such a body more than fifteen years ago, and this Wednesday, Attorney General Mark Dreyfus introduced National landmark Anti-Corruption Commission (NACC) bill in the parliament.

According to early reviews by experts, while not perfect, the bill is promising.

The new commission will be independent and able to investigate not just politicians and public officials, but also third parties property developers, such as lobbyists, political donors and unions. Essentially, anyone who could seek to corrupt or adversely affect government decision-making is covered. Moreover, the agency's

powers will be retrospective - so it of establishing a national antican investigate corruption that took corruption watchdog to pick up its place before its establishment.



## Cardiac Stent, While Helpful, Can Bring Risks

DEAR DR. ROACH: I am a 71-year-old woman diagnosed with coronary artery disease. My latest calcium score was 801. My right coronary artery was 80% blocked, and the left artery was 25%. My cardiologist asked me to decide if I want to do angioplasty or not. I don't have any symptoms, only shortness of breath on exertion. I can't decide what to do. My cardiologist seemed against getting a stent, not that he said that exactly, but he stressed the risk of getting one. — M.C.

ANSWER: A cardiac stent is a device placed into an artery of the heart after it is re-opened, usually by a balloon in a procedure called an angioplasty. Stents help reduce the risk of the artery closing off after the procedure. In people with stable coronary artery disease, opening up a blood vessel can reduce symptoms, but has not been shown, despite many studies, to reduce risk of heart attack or death.

You said you were asymptomatic, but shortness of breath is one of the major symptoms of blocked coronary arteries, which are the blood vessels that provide oxygen-rich blood to the heart muscle. It can be very difficult at times to judge whether a person's shortness of breath is coming from blockages in the artery or not, and stress testing can help answer whether this is likely. People can have shortness of breath on exertion for many reasons, including lung problems, anemia, lack of exercise or persistent symptoms after a COVID infection.

While the decision is ultimately up to you — it's your body — it's best if

the cardiologist gives you a definite recommendation and the reasoning behind it. You can't make an informed decision without being informed. A stent might improve your shortness of breath, but there are risks of bleeding, infection and even heart damage from a stent placement. It's not to be undertaken lightly.

If your cardiologist doesn't feel that your shortness of breath stems from the blockages, then a stent is not likely to be helpful. Revisit with your cardiologist to get a clear idea of the potential benefit and harm specific for your case, and bring a friend or family member to assist you.

# DEAR DR. ROACH: I take Antabuse to help me quit drinking. Do I need to worry about the alcohol in hand sanitizers? — L.W.

ANSWER: Antabuse is a medication that makes people feel very sick even if they drink small amounts of alcohol. It is not frequently used anymore, but it is still an effective and time-tested option for medication treatment in people with problem drinking.

Hand sanitizers are made from either ethyl alcohol, which is the alcohol in alcoholic beverages, or from isopropyl or rubbing alcohol. There have been case reports of people developing a reaction to the alcohol from practicing hand hygiene, from aftershave, and even from inhaling fumes after practicing hand hygiene. According to a study during the pandemic, of 42 people on Antabuse who routinely used hand sanitizers, 20% had a reaction to the ethyl-alcohol-based sanitizer, and 10% had a reaction to the isopropyl-based sanitizer. Seven percent of people had severe reactions, but the rest were mild and self-limited.

There clearly is a risk for developing symptoms after even the smallest amount of alcohol that can be absorbed through the skin or inhaled through fumes. People on Antabuse with a reaction to skin sanitizers should wash their hands rather than use sanitizers.

## Hurricane Ian Rescue, Recovery Efforts Continue in Florida

More than 500,000 homes and businesses in Florida remain without power nearly a week after Hurricane Ian struck the southeastern U.S. state and left a trail of destruction and devastation.

Ian struck Florida September 28 as a dangerous Category 4 storm with maximum sustained winds of 240 kilometers an hour, and left more than two million customers across the state without power. Officials with utility companies say it will likely be Friday or Saturday before electricity is restored to at least 95% of its customers.

More than 1,500 people have been rescued as search and rescue crews engage in a painstaking door-to-door search for victims among destroyed homes and buildings. The U.S. death toll from lan has risen to more than 100 people from Florida to the state of North Carolina, with the majority of the fatalities in Florida. More than 50 deaths were reported in Florida's Lee County, which bore the brunt of Hurricane lan when it came ashore. Reuters says another 21 deaths have been reported by state officials from nine other counties.

Four deaths were reported in North Carolina.

Lee County includes the hard-hit areas of Fort Myers and Sanibel and Pine Islands. The two barrier islands are cut off from the mainland after lan destroyed the only bridges that connected them, prompting rescue crews to drop supplies by helicopter on Pine Island. Governor Ron DeSantis told reporters Monday that temporary bridges will be built to reconnect Sanibel and Pine Islands to the mainland.

DeSantis on Monday defended officials who

have come under increasing scrutiny over the timing of their evacuation orders.

U.S. President Joe Biden and first lady Jill Biden will travel to Florida Wednesday.

The Bidens visited Puerto Rico Monday to get a first-hand look at the devastation from Hurricane Fiona, which struck the island just days before the emergence of Hurricane lan.

# Hurricane Ian Evacuees Return to Devastated Homes, Communities in Florida have pivoted to relief and

## **NEW ORLEANS** —

Brandie Rae Chapman was at home in Fort Myers Beach – a tiny island town – when she learned a rapidly strengthening Hurricane lan would hit southwest Florida last week as a Category 4 storm.

Grabbing her dog and cat, Chapman opted to abandon her late father's house and evacuate, a decision that may have saved her life.

When she returned days later, Chapman was in shock.

"Water reached the roof on the outside, and was four

feet high on the inside," she told VOA. "Everything I own was in that home, including a lifetime of family memories. It's heartbreaking. My dad's house, our neighborhood – our entire island, really – is just gone."

Days after lan made landfall in the United States with sustained winds of more than 240 kilometers an hour, the death toll from the storm continues to rise, as do damage estimates running in the tens of billions of dollars. Hundreds of thousands of Floridians remain without electricity and internet as search and rescue operations

have pivoted to relief and recovery efforts.

## Americans mobilize to help

Nina Phelps is volunteering with the United Cajun Navy, a Louisiana-based relief group that formed during Hurricane Katrina in 2005 and responds to disasters by helping with search and rescue efforts, getting essential supplies to victims and assisting with recovery efforts. She sees a long and painful road ahead for hurricanebattered areas, especially the island communities lan pummeled.

"People in this area are finding parts of their home

a mile away from where it should be," she told VOA. "Boats are in the middle of the road, and on stretches of the coast I'd say 85% of homes are destroyed. Even the 15% that aren't still have roof damage, which means the homes probably need to be gutted. This recovery will

definitely take a year if not longer."

The American Red Cross says more than 1,300 workers are supporting disaster relief efforts in Florida and elsewhere. Phelps said the need for assistance is overwhelming.

# McMaster: 'A Therapist Is Essential' Not Just In Track And Field By Dean "The Sportsman"

Kyron McMaster closed his season by repeating as NACAC 400m Hurdles champion, when he ran the second fastest time of his career in Freeport, Bahamas and improved his own meet record of 48.18 seconds, after stopping the clock at 47.34. That came after becoming only the second repeat Commonwealth Games titlist in the event since 1930, joining Australia's Ken Roche who pulled off the feat in 1962 and 1966.

In Track Town USA, Eugene Oregon in July, McMaster was unable to go after a coveted World Athletics Championships prize, when he pulled out of the semis with a hamstring injury. Unlike his rivals, he didn't have a dedicated therapist-massage or physio-to work with, but had to rely on someone else, whenever they finished their duties with another country, a position the eight fastest 400m Hurdler in the history of the event All Time with his 47.08 seconds best, should not be in.

McMaster compares the stress he puts his body through with someone doing construction work for the first time, working long hours lifting blocks, sifting sand, mixing sand and when you go home you're mashed up and tired. Imagine feeling like that every day he added, noting day in day, out, you're beating your body up like that. If you don't have somebody there to maintain your body, either you're gonna burst or drop dead, he said.

"That's been happening to me for quite some time now but I don't really complain. I do what I have to do, put the legs up and let the blood run," he told Island Sun Sports during an exclusive interview on his recent home visit. "But, a therapist is one of the most essential persons—not just in track and field—in sports in general. Personally, I would pay my therapist more money than I'm making because that person is making sure that my body is in the position to win. You have to take care of the people around you and put them in a position where they can solely deal with you. I'm a firm believer in that-putting them in a position where it benefits you."

McMaster added: "You can't have a therapist on your team but he's not legit where you pay him a little change, he's not going to take his job seriously. You need somebody who doesn't look at you just as the next athlete-you need somebody who looks at you as the next world record holder-so for me, having a therapist is like having a parent. You need that structure in your life."

On the Sports Beat Magazine program on CBN 90.9 FM, Massage Therapist Levi James who has worked with BVI athletes in different sports, said persons in charge must buy in to having the requisite athlete services.

"We're left to wonder how greatness can be expected without the support for greatness to be achieved," he said. "You expect Kyron to run 46.5. You expect Chantel (Malone) to jump 7.16m (23'6"), but then they need that help," James explained. "It's almost like you're sending your car to the track without a mechanic, to make sure everything is always in tip top shape. Until the people who are responsible to put people like us in those places,

realizing the importance, we'll continue to suffer, and in some cases, waste supreme talent, because of a lack of support."

Also a Sports Beat Magazine guest, Kinesiologist and athletic therapy trainer Shaun Williams-who has also worked with BVI athletes-explained that between rounds of competition, besides a recovery massage, the time is used to do a mental and physical assessment of the athlete.

"As therapists, we have to be able to give them a recovery massage and a pre-race massage—which are two totally different massages," he pointed out. "And also take them through a range of motion, depending on the event they're doing."

Courtney Bascombe, another program guest and physio who has worked with Trinidad and Tobago athletes, said when athletes compete, they're competing at their best and when they run as hard as they can, there might be muscle discomfort and a lactic acid build up.

"If that stays there, you cannot go and run another round and expect the same high performance all the time, so it's important to get that therapy," he said. "These things are very technical and are key on that day, in terms of performance. It's key to performance."

## VI Fends Off Jamaica For 28 Run Victory In **Haycraft Cup** By Dean "The Sportsman" Greenaway

Despite the heroics of Jamaica's 16-year old Ameri Hinds, who for the third straight game was their leader with the bat and taking out the BVI's first two batsmen for ducks on successive balls, seventh man Monty Butler's 39 from 23 balls, guided them to a 28 run victory in their first match after two rainouts.

With a supporting 30 from Wicketkeeper Sylvester Mitchel before he was removed by Hinds, 19 from Ricky Singh and a contributing 17 off the bat of Sheldon John before he was caught by Hinds laid the foundation for the BVI's 150, before restricting Jamaica to 122.

Hinds, who bagged 3 for 27, narrowly missed a half century before he was bowled by John for 48, the third straight game he has led all scorers. Courtney Smiley had a knock of 14 not out with another 10 from Kelvin Lewis.

"It was an important victory for us because we had two games washed out, hopefully, we'll get them played back, we're still waiting for that decision," BVI Captain Vishaldev Bharat told Island Sun Sports. "It was important to start off on a winning note, have a large group of players to choose from and we have a decent team. We expect to win a few games and

show the BVI and the public that we're not an easy walk over team. Monty had 39 and he was the one who pulled us up to 150 and it was a defendable

Jamaica's Richard Francis said the batting failed his team. "I think we could have made some smarter choices in terms of the lineup and in terms of some of the decision making and in terms of when the batsman went out to bat," he explained. "I think we could have played a bit more responsible out there on the crease."

### Guyana over Vincy by 5 Wickets

Guyana bowlers Reno Mitteholzer and Jagnarine "Sugar" Persaud ripped through the St. Vincent and the Grenadines order as they slumped to 40 for 6, before Morray Olliverre's 20 pulled them to 88 as he

Mitteholzer bagged 3 for 18 and Persaud 3 for 25 and Dhanpaul Chrisnanand 2 for 25, anchored Guyana's bowling before they responded with 94 for the victory, tying the game at 88-88, then ended it with a six. Royston Duggin stroked 24 as Guyana's top batsman, with Keon DeJesus dropping 21. Vincy's Ronniel Jeffrey snatched 2 for 35.

"We know they're a strong team—one of the bigger teams in the tournament—so our main aim was to go out, stick to the game plan our bowlers went out and did the job," Guyana's manager Colin Campbell said. "A little too many wickets fell for us, but we got the job done."

Vincy's Cameron Williams said he was 'happy with the team's performance. "To be honest, there are some areas we need to improve in, we just didn't come out and bat the way we were supposed to bat," he noted. "But I know the guys, they can do better than that in the batting because 20 more runs on that total, would have put Guyana in a more difficult position. We do have batting up to number 11, so I was pretty confident that we could have scored at least a 120."

## JOIN THE INTERNATIONAL FIGHT FOR CLIMATE JUSTICE

## By Sir Ronald Sanders

(The writer is Antigua and Barbuda's Ambassador to the United States of America and the Organization of American States. He is also a Senior Fellow at the Institute of Commonwealth Studies, University of London and Massey College in the University of Toronto)

On September 23, at the 77th Session of the United Nations General Assembly, the Prime Minister of Antigua and Barbuda, Gaston Browne, made a clear and unequivocal

Climate Change.

He said: "Mr. President, the effects of global warming are universal; they reach every country. But it is vital that we all understand that, in as much as global warming is universal, its damaging effects are not the same; the burden falls mostly on the poor in small developing nations, such as mine. That is why, as the representative of the people of Antigua and Barbuda, I must stand up for their rights; including their right to livelihoods and to life.

Prime Minister Browne continued: "My voice cannot be stilled while danger gathers in the skies above my small and vulnerable country. I have no choice but to fight unrelentingly for climate justice".

The statement by the Antigua and Barbuda leader resonates with all leaders of small island states across the world who are frustrated with the failure of the world's worst polluting nations to honour their pledges to provide funds for adjustment and for building resilience to the extreme weather conditions, which their actions are causing.

More particularly, the leaders of small island states are demonstrating their readiness to fight back in the face of disregard for the persistent loss and damage they are experiencing without any effort to compensate them.

Vanuatu is seeking the approval of the UN General Assembly, during this current session, for an opinion by the International Court of Justice on the rights of present and future generations to be protected

from the impacts of climate change. Similarly, Antigua and Barbuda along with Tuvalu, Palau, and Niue have established the Commission of Small

Island States on Climate Change and International Law (COSIS), which is registered with the UN.

objective The of the Commission is to seek an advisory opinion directly from the International Tribunal for the Law of the Sea (ITLOS) on compensation for persistent loss and damage caused by Climate Change.

The Vanuatu initiative, and statement, concerning the impact of the Commission established by Antigua and Barbuda and three other small islands, reflect their joint frustration with the failures of the COP process to address the damage being done to small countries.

> The efforts of these small countries are winning active support from international legal experts. A team of 17 highly regarded international lawyers has joined COSIS to provide legal advice on the approach to ITLOS.

> There is also wider support from organizations such as the Commonwealth Foundation and "The Stop Ecocide Foundation", a charitable fundraising and commissioning body, which was founded with the intention getting Ecocide recognized as an international crime at the International Criminal Court (ICC). The Ecocide Foundation is partnering with "Stop Ecocide International" - a panel of expert lawyers who want to see ecocide outlawed internationally.

> "Ecocide" is defined as "unlawful or wanton acts committed with knowledge that there is a substantial likelihood of severe and either widespread or long-term damage to the environment being caused by those acts". Given the wide body of evidence, gathered by international environmental experts, there can be no government of any country that can claim, with any credibility, that they do not know that pollution is causing "widespread or long-term damage to the environment being caused by those acts".

> But there is still a long road ahead before the Ecocide definition could be adopted by the court. One of the court's 123 member countries would

need to submit the definition to the United Nations Secretary-General, triggering a formal process that could lead to an amendment of the Rome Statute, which sets the court's rules.

There would, of course, be great opposition to this by the world's greatest polluters. Consequently, enormous pressure would be put on small states not to pursue any of the legal initiatives now being contemplated by Vanuatu, by Antigua and Barbuda, Tuvalu, Palau and Niue, and by The Ecocide Foundation.

However, as I told a "Virtual Islands Summit 2022 Symposium", organized by the Stop Ecocide Foundation on September 29: "Something has to give in this unlevel playing field in which small island states and low-lying coastal states are made to suffer. The peoples and governments of small island states cannot sit back while their countries are destroyed and they, themselves, are dislocated from their homelands"

A global alliance of small island states and states with low lying coastlands can be a powerful global force for the protection of each other, and of all life on Earth.

It calls for Caribbean countries, especially the most vulnerable such as The Bahamas, and the smaller islands of the Eastern Caribbean, to join the COSIS and Stop Ecocide initiatives. countries have the most to lose; therefore, they must fight the hardest.

The destruction wreaked by Hurricane Fiona in the Eastern Provinces of Canada, and the decimation and loss of lives in Florida and South Carolina in the United States, over the last two weeks, should, at last, persuade the remaining doubters in governments and industry, in these two countries, that their present circumstances are bad, and their future will be worse unless they also take immediate action.

Prime Minister Browne spoke for the peoples of all small states when he told the UN general assembly: "My voice cannot be stilled while danger gathers in the skies above my small and vulnerable country"

There is a global train for climate justice that is now running on an international railroad; all small countries should board it.



# Residents Encouraged To Practise Earthquake Safety

The Department of Disaster Management (DDM) invites all Virgin Islands residents and visitors to improve their earthquake readiness by joining the global ShakeOut earthquake exercise on October 20, 2022 at 10:20 a.m.

DDM Training Manager Carishma Hicks said that the exercise is an important opportunity for persons to gain experience before an earthquake occurs.

"Since earthquakes happen without warning, it's important to be ready to respond safely and calmly. The more times persons practise safer earthquake response, the better prepared they will be in case of an actual earthquake," Ms. Hicks said.

During the self-led exercise, participants will practise the "Drop, Cover, and Hold On" safety method endorsed by emergency officials and first responders worldwide.

DROP where you are, onto your hands and knees. This position protects you from being knocked down and allows you to stay low to crawl to shelter if nearby.

### COVER your head and neck with one arm and hand

- If a sturdy table or desk is nearby, crawl underneath it for shelter
- If no shelter is nearby, crawl toward an interior wall (away from windows)
- Stay low; bend over to protect vital organs

#### **HOLD ON until shaking stops**

- Under shelter: hold it with one hand; move with your shelter if it shifts
- No shelter: hold on to your head and neck with both arms and hands.

Participants are also encouraged to create or review earthquake response plans and practise them together as a family or organisation. After the exercise, DDM encourages participants to share photos or video on social media with the #BVIShakeOut hashtag.
