FORMER BVI PREMIER OFFICIALLY RETIRES FROM POLITICS

were the closing words from former Premier Hon. Andrew Fahie in his official letter of resignation and announcement of retirement from politics in the Territory.

The letter which was noted by Speaker of the House Hon. Corrine Massicote officially brought a close to the more than two decades of legislative service of Hon. Fahie. It also brought a close to the matter of representation for the First District as Hon. Fahie has now resigned from that post as well.

The unfortunate closure of the career of a legislator that entered the political space as one of the youngest leaders of the Territory is marred by the current legal and criminal matters looming. These matters were cast by the 28 April arrest of Hon. Fahie in Miami and the multiple criminal charges he is currently facing.

In his letter, the former Premier commenced his

"Our best days are yet ahead," farewell by recalling the modern-day Virgin Islands, growth and development the Territory has made thus far. He said, "Our foreparents have built our Virgin Islands through prayers to God, and like Moses, used the little that was in their hands en route to the promised land. They accomplished plenty. They built the prosperous and beautiful Virgin Islands as it is known today."

> He also alluded to what can be interpreted as the current constitutional review and the matter of the COI noting, "The way forward at times may result in debates on which is the most effective methodology. However, as long as everyone in the Virgin Islands stays connected to the common thread, which is love for God, love for the Virgin Islands and thereby striving for what is best for the Virgin Islands, then and only then - in spite of any delays or shortcomings or minute differences, the bright and prosperous future of the

filled with opportunities for the people of the Virgin Islands and all who call the Virgin Islands home, can never be denied."

He also gave some advice to the men and women that he served with in the House of Assembly; the majority of which served under his VIP leadership. In his advice the former leader urged his colleagues to learn from what has happened before in the Territory. "As the journey continues today, our Virgin Islands - especially through the House of Assembly must continue to do like our foreparents — learn from the mistakes of the past while embracing the challenges of the present and thereby turning them into opportunities for the present and future generations. Also, learn to pause at times and celebrate the victories along the way."

He also called for unity by admonishing persons "to remain laser-focused on the areas that unite rather than those that divide and allow God through time to do what only he does best with time - which is to be the only true and fair judge while healing all wounds."

RESIGNATION AND RETIREMENT

In what was his final

Fahie announced: "I, Andrew Alturo Fahie, now respectfully take this time to officially inform you Madam Speaker, through this written notice with effect from 24 November 2022, of my retirement from serving in the capacity as a member

"I also take this time to acknowledge receipt of your 2nd September 2022 correspondence in response to my 18 July 2022 correspondence. Madam Speaker, I humbly and respectfully request of you to please officially convey my retirement that comes into effect from the 24th November 2022, to all the requisite authorities especially to all members of the House of Assembly, as well as to the people of the

Virgin Islands - especially my beloved people of the First District on the floor of the House of Assembly via this letter, among other means you may deem appropriate. My deepest appreciation and love I express to all. May God forever bless our Virgin Islands and the people of the Virgin Islands as our best days are yet ahead," he added.

VIRGIN GORDA PEOPLE STILL NOT GETTING THE BANKING SERVICES

THEY NEED

Despite the previous promise that Virgin Gorda's banking woes would be a thing of the past, Ninth District Representative Hon. Vincent Wheatley explained that his constituents are still not getting the financial services that they need.

The Legislator - who was the fact that only three days during the week the lone bank on that island is opened - told his colleagues that something needs to be done. In his complain to the member of the House of Assembly Hon. Wheatley stated that for five years the people of Virgin Gorda have had less

than standard banking offering.

"We went from no banks in 2017 to one bank about three days a week. Now, we have to push that up. It's been too long now that we're here still limping on one bank for three days. In Anegada, [there is] no banking at all," the Ninth District Representative stated.

The complaint of Hon. Wheatley is of note, considering that Virgin Gorda's banking situation was seemingly solved in November 2019 when Banco Popular opened a branch on that sister island. At the time of the opening, it was declared that the service would make things better for residents because it brought an end to the need to travel to Tortola for banking services.

It was during the opening ceremony that Bank officials announced that the Virgin Gorda Banco Popular branch was not going to operate daily. Instead, it was explained that the branch will operate lobby operations on Monday, Wednesdays and Friday from 9:00 to 4:00. In addition to the lobby services the Bank officials said that the Branch was also going to offer 24 hours ATM with easy deposit feature, and a night deposit service.

While lauding the service President/CEO at Popular Inc. Ignacio Alvarez described the Bank's opening as taking a 'chance,' that led to the solving of a major problem: "We solved the problem because there was a partnership between government and the private sector," he stated.

In explaining why the decision was referred to as a chance Alvarez said: "When we do the numbers it looks very difficult. We would talk to the Premier and we would share with him what our concerns were. Our concerns was the difficulty of bringing money back and forth the cost. He said isn't there a way we can work it out, and I would go back to our team and say ...Isn't there a way we can work it out because I really wanted to be here, I didn't want to see another Bank's sign there."

In further noting that the venture was somewhat of a leap of faith the Banco Popular CEO said: "With some creativity the Premier and his government, following the steps of prior governments were creative and came up with a solution. We were creative, we took a chance. We took a chance because we do see the future in Virgin Gorda. I'm personally bias, but I think all of us view it. We see the future not only of Virgin Gorda, but we see the future of the Territory as a whole. We're very committed," he said.

said: "2023 will also see the return of a VI Music Festival to help develop and bolster our tourism sector through the development of entertainment tourism. Again, this is an effort to provide more value to our product and improve the experience of our visitors while attracting new ones."

The news about the reactivation of the famous May weekend activity is of interest to many because there was never a formal farewell. The event was being planned in 2014 and

Back in 2014 many pushed for the event to be held. However, it was noted at the time that allegedly funding issues were causing the event's stall. Up to March that year the community was given hope that the show would go on when the organizing Committee announced that the plans were on.

In a Facebook post the organizers wrote on 25 March, 2014: "We are finalizing our sponsors and adding some new twists to the event! Look out for our

"All Inclusive" options! More delight for your dollar! We hope to launch one week from tomorrow! All will be revealed."

Prior to announcement, the Committee stated: "Fans it won't be much longer before we make the Grand Announcement regarding this year's BVI Music Festival. The theme this year is 'The Reunion'! We are looking at some of your favourite artistes from the past 14 years! Who were your favourite two artistes of all time?"

The Committee also mentioned that some minor

changes were also being considered for the 2014 event. "We are going back to the drawing board to bring you the most enjoyable that BVI Music Festival. Stay tuned, get your friends and relatives to like the page and be prepared to win special prizes and enjoy a great event."

PATHETICALLY LANGUISHING PROSPECT REEF TO **GET SOME ATTENTION**

After many promises by to Prospect Reef as a various governments, Premier and Minister for Finance Dr. the Hon. Natalio Wheatley said that his administration intends to advance the development of the Prospect Reef pathetically languishing property early next year.

The Prospect Reef Hotel, which is a governmentowned hospitality operation was destroyed by the 2017 hurricanes and remains in an unjustifiably deplorable state. However, it is being noted that changes are coming in months. This announcement was made by the Leader of Government Business during his 2023 Budget address on 29 November.

Some have referred

preposterous eyesore and absurd waste of prime real estate; however, the Premier is noting that things are about to change. He further noted that government has intentions to move ahead with the property's improvement.

While noting that his administration has plans for tourism development, Hon. Wheatley told the House of Assembly, "One such area for development is Prospect Reef. I have discussed the matter with the Chairman of the Prospect Reef Board and we intend to have a request for proposal in early 2023 if not sooner."

However, this budgetary announcement improvement to Prospect

Reef is not new. In fact at the start of this year reporters insistently questioned former Premier Andrew Fahie about the ongoing neglect of the prime property.

Members of the media noted at a press conference on 28 January that 2022 ushered in another year that the Prospect Reef resort remains in a dilapidated state and were informed that the condition was not an indication that government had turned a blind eye.

In fact, the previous VIP Premier explained that efforts to improve the current state of the facility continue to be a hurdle. He explained, "Prospect Reef seems to be an entangled weave; every time you straighten out one

thing with Prospect Reef, something else comes in."

"I say it in that parable because there are some legal concerns that have been raised lately, so I wouldn't want to say anything more about that until we pass that hurdle, which will hopefully be the last hurdle with Prospect Reef," Hon. Fahie further explained.

Nonetheless it was stated that work to improve the lot of Prospect Reef has been occurring behind the scenes. "We have made great progress although it doesn't look that way in terms of physical movement, but there was a lot of legal entanglement and measures that we had to get past with Prospect Reef; hopefully this is the last one."

He further noted that there are details that cannot be explained at this time. "It was more of a legal nature with the legal issues that were involved in some areas. so based on the nature we cannot make that public as yet. But we will get there," Fahie further stated.

COI Implementation Unit Reports On Progress For The Month Of October

The Commission of Inquiry Implementation Unit is advising the public that it has reported to the Governor and Premier on the status of work completed up to the end of October 2022.

Based on the timelines agreed in the Framework for Implementation of the Recommendations of the Commission of Inquiry Report and Other Reforms, the Director of the Unit Ms. Hadassah Ward has advised that work on 48 of the 50 Framework recommendations has begun. The remaining two are scheduled to begin in 2023.

Ms. Ward said, "One Recommendation that was originally scheduled to begin in 2023 was begun early. The number of Recommendations completed remains at 13. Of the 35 recommendations being actioned now, 73.1 percent are in progress and on track and 26.9 percent are in progress with challenges to meet deadlines."

She said that the Dashboard gives a pictorial summary of the status of the fulfilment of the COI recommendations as agreed in the Framework. The Key shares each of the 50 Framework Recommendations, now being worked on as the main focus of Government of the Virgin Islands to raise our standards of governance in our beautiful Territory, so you can track the status of work on each recommendation.

The COI Implementation Unit assists in coordinating the overall delivery of the COI recommendations, which includes providing support to ministries in developing work plans for the delivery of recommendations, assist in drafting policy directions, and the development of new programmes and systems.

The unit is also responsible for preparing monthly progress reports, reports on specific work programmes, and reports to identify key issues associated with implementation and suggest remedies. Premier Wheatley Announces \$399.33 Million Budget For 2023

Premier of the Virgin Islands, Dr. the Honourable Natalio D. Wheatley, delivered his maiden Budget Address in the Virgin Islands House of Assembly earlier today, with a fiscal package totaling \$399.33 million, of which \$335.08 million is allocated for recurrent expenditure and \$41.59 million for capital expenditure.

The theme of the 2023 Budget "Resilience, Revenue, Reform, and Recovery: the Virgin Islands in Transition",

which, according to the Premier, represents "a simple but largely comprehensive matrix of what we have accomplished this year and what the priorities and parameters of our mission in the upcoming year and beyond should be, given the international geopolitical and economic climate, and the situation closer to home."

Major allocations in the 2023 Budget include: \$73.07 million to the Ministry of Health and

Social Development; \$62.51 million to the Ministry of Communications and Works; \$55.7 million to the Ministry of Education, Culture, Youth Affairs and Sports; \$52.3 million to the Governor's Group; \$43.3 million to the Premier's Office; \$7.77 million to the Ministry of Natural Resources and Labour; \$54.23 million for pensions, public debt and contributions to various funds; and \$8.67

million to constitutionally established departments. Some \$24.9 million in development projects that will be managed by Central Government, and \$12.17 million will be for development projects that will be managed by the Recovery and Development Agency.

According to Premier Wheatley, based on the economic strategy and in consideration of the state of the global economy, the Virgin Islands economy is projected to experience 2.9% growth in the upcoming year, "all things being equal". Total recurrent revenue of \$373.03 million is being projected with a recurrent surplus of approximately \$36.7 million. The Virgin Islands' tourism industry continues on the path of recovery and growth with around 703,000 visitors expected in 2023, of which about 292,000, would be overnight visitors. The financial services industry is expected to continue its strong performance and yield about \$222 million in revenues in 2023.

Based on this definition, and the way the Virgin Islands economy and people have stood up to recent challenges, the economy and people of the Virgin Islands have demonstrated great resilience.

THE COMMEMORATION OF THE 1949 GREAT MARCH AND THE RESTORATION OF THE LEGISTLATIVE COUNCIL

MESSAGE BY PREMIER AND MINISTER OF FINANCEDR. THE HON.NATALIO D. WHEATLEY ON

MONDAY, NOVEMBER 28, 2022

Greetings people of the Virgin Islands.

Today we celebrate the Great March of 1949 which led to the restoration of the Legislative Council in 1950. This march was incredibly significant to us as a Virgin Islands people because it was an overwhelming pronouncement of the people's desire for democracy, for the right to have a voice in their society, to play a leading role in their governance, to become a more autonomous and self-determined people. 1500 people marched on the 24th of November 1949 at a time when the population was under 7000 persons. This means between 20 and 25 percent of the population marched at a time when we had no social media, no ferries, none of the modern conveniences that we have today. They marched because the right to rule their destiny was important to them. Their actions helped us take a giant leap forward for the restoration of the Legislative Council, eventually allowed the people to vote and select representatives who worked on behalf of the people and jump started the development of the modern Virgin Islands. They worked to help develop our economy; they partnered with pioneers in the private sector to build a tourism and financial services industry. They made laws; they passed policies; they designed systems that would improve our healthcare, our education, our environmental protections, our labour practices, and so much more. They became the architects of the Virgin Islands we have today, which remains one of the most successful societies in the world despite what you may have been told. We have highly educated people; we have low crime; we are polite and hospitable; we are hardworking and innovative; we are entrepreneurial with a high degree of land and home ownership. No we are not perfect. Yes we have our faults, but we have done a good job of building our society, which attracts people from all over the world. We can be proud of what we have achieved.

This government administration was successful in staving off the threat of direct rule following the release of the Commission of Inquiry report. We believe very firmly that democracy is the key to improving our systems of governance. The hopes, dreams, and aspirations of the people must be at the heart of the reform process. They must participate in the conversation about what must be improved and how it will be improved. This must not be imposed by local or foreign officials. We must respect the intelligence, the morality, and the good intentions of the Virgin Islands people, and we must trust them to make choices in their own best interest.

Let us not take our democracy for granted. Theodolph Faulkner, Isaac Fonseca, Carlton deCastro and the 1500 worked too hard to claim it. We must not allow our House of Assembly to be taken away. Hope Stevens and the Civic League worked too hard. We must not allow our Cabinet to be taken away. Those who ushered in ministerial government toiled too hard. We must raise up a new generation of leaders who will reform and strengthen our institutions and lead us to our ultimate destination on the road to self-determination.

I do hope that everyone has a restful, safe, and enjoyable holiday and please take some time to view the documentary, titled "March On Virgin Islanders", produced by the House of Assembly, the Virgin Islands Communal Association, and the Virgin Islands Studies Institute of H. Lavity Stoutt Community College in commemoration of the 1949 Great March and Restoration Day.

May God pour his richest blessings upon the people of the Virgin Islands.

2022 Hurricane Season Closes With Minimal Impacts To VI The Department of Disaster Management (DDM) is thanking the Territory

The Department of Disaster Management (DDM) is thanking the Territory for its diligence in staying prepared throughout the 2022 Atlantic Hurricane Season, which ends today, November 30.

DDM Director Jasen Penn said, "We are very grateful that the Virgin Islands did not experience major impacts this hurricane season, but even more grateful that the community was able to work together to #BeReady." The director said that the 2022 hurricane season was an unusual one.

"Forecasters initially observed several factors that would typically point toward a more active season. However, with the lingering Sahara Dust in the area, we actually saw lower than average activity in the early part of the season," Mr. Penn said.

No tropical systems formed during the month of August, which has only been observed during two prior season since 1950. Also unexpected was the rare formation of two storms during November, a month that would usually see only one system form.

According to the National Hurricane Centre, this season produced 14 named storms, including eight hurricanes. Two systems – Fiona and Ian – strengthened to major hurricanes before dissipating.

Mr. Penn said such surprises are likely to be the norm as global climate change impacts continue, which should remind all residents to stay vigilant when it comes to being prepared for hazards like tropical storms. "Even though the hurricane season has concluded, we know that storms can continue to form outside of the season. We also know that we are vulnerable to other hazards like earthquakes, so it continues to be very important for individuals and businesses to stay prepared," he said.

ROME-Right-wing extremists, some direct or indirect descendants of fascist parties, are coming to power in Europe—most recently in Italy, where Giorgia Meloni has made it to the summit of government. The black thread of her Fratelli d'Italia goes back through the 'post-fascist' Alleanza Nationale and the 'neofascist' Movimento Sociale Italiano to the real thing. In Austria, the Freiheitliche Partei Österreichs (FPÖ), whose predecessor emerged in the 1940s as a sort of ex-Nazi rallying point, has already tasted power more than once.

But even freshly minted ultraright parties, such as the Sweden Democrats on whom the new government of the right in that country depends, are not simply 'populist'. To put it schematically, they have more in common with Benito Mussolini than Juan Perón and the eponymous 'ism' to which his authoritarian-populist rule in Argentina gave rise.

Avoiding the f-word

We nevertheless abjure the f-word. The new ultra-right would indignantly reject the label 'fascism': they would insist, after all, that under their rule there would be no suppression of dissent, no lawlessness or street violence—never mind concentration camps. Opponents of the far right avoid the term too, intuitively knowing this

would only be presented as further evidence that 'the establishment' wanted to undermine its legitimacy and second-guess its abused voters. (Social Europe)

ARGENTINA - Cristina Fernández de Kirchner, who claims to be a victim of political persecution, is facing 12 years in prison and a lifetime ban on holding office if she is found guilty on December 6 of leading a scheme that diverted \$1 billion in state funds

"Last words..." said Cristina Fernández de Kirchner from her office in the Senate, staring at the camera. She paused for a second, smiled and delivered the line she had already envisaged as a headline. "Never has a judicial term been so appropriate to define what this court is: it is a firing squad."

Her words were aimed at three federal judges who on December 6 will decide whether she is guilty of leading an alleged scheme to divert state funds through public works contracts. The prosecution wants Fernández de Kirchner to spend 12 years behind bars and be permanently barred from holding public office.

Fernández de Kirchner, 69, has been charged with "illicit association" and "aggravated fraudulent administration" in connection with a corruption case involving 12 other defendants and known in Argentina as the Vialidad Case. The 51 contracts under scrutiny were awarded in the province of Santa Cruz, the political cradle of Kirchnerism, to companies owned by a friend of the Kirchners, Lázaro Baez, over a 12-year period (Baez has since been sentenced to 12 years in prison for money laundering). Prosecutors said many contracts were inflated and some were never carried out. They have estimated that the scheme cost the state around \$1 billion. The defendants include officials accused of collecting bribes and businesspeople suspected of paying them. [El Pais]

RUSSIA - Russia's Kartsev Institute of Computing has announced it will begin production of a new drone designed to disperse crowds next year, state news agency TASS reported on Tuesday.

The Shershen, or hornet, is a hexacopter drone that functions in much the same way as a more typical quadcopter drone, though it uses both ultrasound and infrasound to disperse crowds, and is designed for use in a domestic security context.

The move could signal increasing concern among the country's elite that civil unrest might break out as frustration grows over Russia's international isolation and punishing Western sanctions over the war in Ukraine.

"We are planning to enter serial production of the Shershen after the New Year. From mid-December to January, we will already be able to show the hexacopter in action," Vitaly Dolgov, the head of the Research Institute's research laboratory for unmanned vehicles, told TASS. [The Moscow Times]

BERMUDA - Police said yesterday that they are working on the island and with organisations overseas to address and remove social media posts accusing people of providing information that may have led to criminals being jailed.

Darrin Simons, the Commissioner of Police, feared that spreading the material put lives at risk and assured the public that there were measures in place to protect residents who supplied intelligence.

He said: "The Bermuda Police Service is aware of a number of social media posts accusing individuals of providing information which may have led to criminals being incarcerated.

"In the strongest possible terms, I condemn this activity. It is dangerous and has the propensity to put the lives of individuals at risk, all the more if the information is wrong.

"An individual has been identified that we believe is responsible for these posts and steps are being taken at various levels both locally and internationally to address the situation and have the posts withdrawn."


He added: "Rest assured, the BPS has systems in place to protect the identity of members of the public who do the right thing in assisting us to provide closure to families whose loved ones have become the victims of violent crime.

"This system is so strict that not even I, as the Commissioner of Police, is normally privy to information regarding the identity of individuals who co-operate with police investigations." [Royal Gazette]

PUERTO RICO - More than a dozen municipalities in Puerto Rico have filed a class action lawsuit against fossil fuel companies for their alleged role in the 2017 hurricane season that devastated the island, causing billions in damages and leaving thousands dead, according to a statement from Milberg Coleman Bryson Phillips Grossman LLC on Monday.

The first-of-its-kind lawsuit seeks financial compensation from oil and coal companies for marketing and selling carbon-based products that they intentionally misrepresented to the public, according to the suit. It describes how companies that include Exxon Mobil, Royal Dutch Shell, Chevron, BP, ConocoPhillips, and Arch Coal worked together to publicly conceal the climate risk changes from their products while



internally acting on climate science to safeguard their own assets. The municipalities are represented by the aforementioned law firm.

"Puerto Rico was hit by the perfect storm and is the ultimate victim of global warming," Milberg partner Marc Grossman said. "This is an opportunity to finally get justice for all that Puerto Rico sacrificed in 2017."

The municipalities of Bayamón, Caguas, Loíza, Lares, Barranquitas, Comerío, Cayey, Las Marías, Trujillo Alto, Vega Baja, Añasco, Cidra, Aguadilla, Aibonito, Morovis and Moca seek to recover damages from the defendant oil and coal companies for 2017 storm losses, including social, educational and economic losses.

Decide what you can do ahead of time:

What prep work can you do ahead of time? Chopping vegetables, baking pies, etc. The turkey needs to go into the oven that morning, but most desserts can be done ahead of time. Similarly, vegetables should be cooked the day of, but you can chop and wash them a few days ahead and store them in your fridge.

Schedule your shopping and prep work.

When will you do that prep work? How far ahead can you begin preparations? Make sure to block ample time off on your calendar, like the Sunday afternoon and Tuesday night ahead of the big day. Try to leave Wednesday open for anything you might

have forgotten, and then get to work that evening and organized for Christmas: again: Create a Game Plan:, so that you can enjoy your holidays without too much stress.

These boards can be as simple or as elaborate as you choose. While it's easy to drop a serious chunk of change on upscale cookies and candies, these boards don't have to be expensive to be festive. You can pick up cocoa mix, a bag of marshmallows and a package of assorted cookies for under \$10. Then arrange a lovely board. You also can make a board with only marshmallows and whipped cream.

The dollar store is a treasure trove for goodies to make these boards. You'll find seasonal platters, mugs and plates -- even cocoa, marshmallows and other fun holiday treats to brighten up your board.

To assemble your abundant board, start with the largest items first, spaced evenly around the board. Odd numbers tend to look best. Be sure you have

something to add height and visual interest, like candy canes. Next, arrange the medium-size items, like cookies, looking for contrast in shape, color and texture. Avoid straight lines and go for curves instead. Lastly, fill in any empty space with small items like candies, leaving no bare board.

To add interest, add elements like ribbons, ornaments and mini lights. But don't include anything that's not edible that might look edible to the kiddies (poinsettias and holly berries!). That's a recipe for disaster.

Yield: Just shy of 3 cups of mix or approximately 24 servings of hot cocoa

What You'll Need:

- 1 cup plus 2 tablespoons unsweetened cocoa powder
- · 13/4 cups granulated sugar
- 1 teaspoon table salt
- · Whole milk to serve

Here's How:

Sift the cocoa powder (to remove any lumps), sugar and salt into a large bowl. Whisk all ingredients until fully combined. Store in an airtight container.

To serve: Warm 1 cup of your choice of milk (or non-dairy alternative), add 2 tablespoons hot cocoa mix and give it a good stir. To make 8 servings, add 1 cup mix to 8 cups hot milk.

IDENTITY OF TWO MISSING BOATER RELEASED

Tuesday, November 29 – The Royal Virgin Islands Police Force is now able to release the identity of the two men reported missing at sea following boat mishap.

The lone survivor identified Lucien Roy Gabriel and Gabriel Bryan, both residents of St. Maarten, as the two men that were onboard of the 16.5' Wahoo with one 70hp Yamaha outboard engine.

The survivor said that on Tuesday, last week, the three boarded the vessel from Baie De Grand Case on the French side of St. Maarten and headed toward Baie Du Marigot. He said that along the journey, a wave struck the vessel causing it to overturn and all safety equipment was lost. He stated that all three persons drifted for four days until Saturday when local boaters spotted the overturned vessel.

The lone survivor stated that within 24 hours of being rescued both Gabriel and Bryan released their hold on the boat and disappear below the water.

Officers of the Police Marine Branch continue their search for the missing boaters.

MAN CHARGED IN MAY'S DEATH OF PEDESTRIAN

Tuesday, November 29 – The Royal Virgin Islands Police Force on Friday formally charged Alixson Auguiste of Sea Cows Bay with causing death by dangerous driving in the traffic fatality on Waterfront Drive that claimed the life of a woman in May of this year.

The deceased, Sophia Wilson, a native of Jamaica, was struck by the vehicle driven by Auguiste while she walked east on the sidewalk near the Dr. D.O. Smith Hospital. She was taken to hospital and later transferred overseas for medical care but later succumbed to her injuries.

Auguiste was granted bail in the sum of \$25,000 with one surety to appear before Magistrate's Count on 23 February 2023.

This March, we celebrated the revision of the global standard on company ownership, which now requires that all countries collect information in centralised registers. But years before that, an important victory was scored in the EU where public registers of beneficial ownership became a requirement. Some countries did this better than others, and during the last couple of years we've focused on pushing governments to make their registers truly public.

Justice (CJEU) Tuesday on ruled that the individuals real behind anonymous companies should be shielded from public scrutiny effectively reversing progress of recent years.

It all started with a law firm representing man - whom court documents refer

for denying his request to exclude his ownership of 35 companies and an investment firm from public records. WM argued that by disclosing his identity, the Luxembourg register would be exposing him to risks of fraud, kidnapping and even death.

Instead of scrutinising these claims, the Luxembourg district court asked the CJEU - also situated in Luxembourg - to weigh in. But they posed a much bigger question: does public disclosure of information on companies' true owners infringe on their rights to privacy and data protection?

Corporate transparency opponents have long claimed that public disclosure comes with unacceptable security risks for the owners of secret companies. And while this accountable.

requires attention, they are yet to demonstrate that it is specifically public beneficial ownership registers that create such risks.

On the other hand, no one can refute the overwhelming evidence that anonymous companies are used to channel bribes, launder money and evade taxes. While EU public registers haven't been around for long, we already have many examples showing how they make investigations - that would have previously hit a dead-end - possible in the EU and beyond.

And yet, CJEU judges have ruled that they do not see Yet now, in a disappointing twist, the EU Court of an added value to opening up registers to all of the

public.

Kleptocrats and their accomplices probably are rejoicing especially those out there trying to keep their wealth out of reach of authorities that have sanctioned them. Nosy activists, journalists and even government investigators already have been locked out

to as "WM" - suing the Luxembourg Business Registers of registers set up by Austria, Luxembourg and the Netherlands.

The law firm representing WM, that appears to be on a mission against corporate transparency, is publicly celebrating. They have hailed the court's decision as proof that "single-minded transparency campaigners" were wrong to have pushed for public access. But it's not just us: there's a much bigger coalition calling for an end of the corporate secrecy era.

The judges did agree, however, that civil society and media play a role in the fight against money laundering, and that they have grounds for accessing such data. We'll use this to make sure that no unscrupulous actor can dispute our right to unmask and hold them





Decade-Long High Lymphocyte Count Isn't a Cause for Concern

DEAR DR. ROACH: I am a female and almost 75 years old. My vital signs are always normal, and I am active, but slightly overweight. I get quarterly blood draws, and every reading is in the normal range except for the lymphocytes. That count is higher, just outside the normal range (the lab's range is 850 to 3,900 cells/ uL, and my absolute lymphocytes are 4,377 cells/uL).

This has occurred in the blood draws from the last two or three years, with the exception of one that was back in the normal range. About 12 years ago, after several abnormal results, I saw a hematologist, who reported nothing wrong after doing more extensive blood work. No reason could be given for it. I am concerned, but not obsessing over it. Is there any reason you can give for the slightly high lymphocyte count? - S.M.

ANSWER: Lymphocytes are one of the two major types of white blood cells found in the blood (the other are the granulocytes, the most common of which are the neutrophils). High levels of lymphocytes raise suspicion for serious blood disorders such as some leukemias, lymphomas and related blood diseases, but there are other causes. Acute stress can do it, but you have been living with this for many years. Not having a spleen causes high levels of lymphocytes, whether you are born without one or have it surgically removed. Chronic infection is another reason.

I suspect your hematologist did a more sophisticated set of tests looking for blood disorders, and the fact that your level is the same after 12 years also supports my suspicion that this level is normal for you. Normal levels are generally defined as what is found in people without evidence of disease 95% of the time. So, by definition, 5% of normal people will have their result on any given lab fall outside of the normal range. Since yours is just outside of the normal range and, as I said, unchanged for years, I think you can relax your level of anxiety. Periodic blood tests do seem prudent, however, and further testing would be recommended in the event that the count starts getting higher or you develop any new symptoms.

DEAR DR. ROACH: I am a 67-year-old male in relatively good health. I exercise regularly (four times a week). I have been taking medication for hypertension, which is getting much better since I started a plant-based diet three months ago.

About every three months or so for the last five years, there are two half-dollar-sized blood stains on my pillow coming from my right ear. I have no headaches, and my hearing is what it is for my age. My wife is concerned, but I am not. What do you think? - J.G.

ANSWER: I think your wife is wise to be concerned. This is not something I commonly encounter, and the answer is very likely to be found inside your ear through a clinical exam. I do sometimes see small infections in the ear that may bleed, and there are benign tumors of the ear canal and eardrum that may sometimes bleed as well. I have read about a very rare condition of an aneurysm bleeding from the ear. This has been going on a long time, so it's definitely worth an evaluation.



CARICOM SECRETARIAT GOES "ORANGE" TO HIGHLIGHT ENDING VIOLENCE AGAINST WOMEN AND GIRLS

INITIATIVE PART OF "16 DAYS OF ACTIVISM" IN COLLABORATION WITH UNDP SPOTLIGHT INITIATIVE

Wednesday, 30 November 2022 (CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana): The CARICOM Secretariat illuminated its Headquarters in Georgetown, Guyana, with orange spotlights on Tuesday, 29 November, in recognition of "16 Days of Activism" which is being observed internationally. The awareness activities aim to bring attention to ending violence against women and girls.

The observance was held in collaboration with the United Nations Development Programme (UNDP) Regional Spotlight Initiative and formed part of the Secretariat's awareness activities for the 16 Days of Activism, which commenced Friday, 25 November.

In her feature address, Dr. Carla Barnett, CARICOM Secretary-General, illustrated the significance of the building illumination and emphasised that the "16 Days of Activism" campaign is intended to galvanise action to end violence against women and girls. "Its focus is to challenge harmful gender norms and end the impunity, silence, and stigma that have allowed violence against women and girls to escalate and/or remain normalised in far too many countries", stated the Secretary-General. She also highlighted that the colour orange was particularly significant as it symbolises a brighter future "in which all women and girls can live free of violence".

Dr. Barnett highlighted that the Lighting Ceremony was occurring on Women Human Rights Defenders Day, the second of four signature observances which anchor the "16 Days" campaign. She underscored that Human Rights Defenders worldwide are under threat, even as more formal state commitments are implemented to respect, protect and fulfil legal human rights obligations without discrimination. "Data from Front Line Defenders demonstrate that the killings of women human rights defenders are on the rise, as women are routinely targeted with violence, harassment, hate speech, discrimination, dissemination of personal or intimate information, defamation, and other forms of online violence to silence or punish their activism," stated Dr. Barnett.

The Secretary-General shared the sentiments of the UN Resident Coordinator,



who spoke earlier, by highlighting "unsettling" data from prevalence surveys conducted globally and in the Caribbean; "violence against women and girls remains the most widespread and pervasive human rights violation affecting more than an estimated one (1) in three (3) women globally, a figure that has remained relatively unchanged over the last decade," stated Dr. Barnett, "As my colleagues from the UN highlighted, the Caribbean may surpass the global average with unacceptably high rates of intimate partner violence," she said.

Dr. Barnett further stated that the COVID-19 pandemic had exposed existing systematic inequalities supported by gender norms which threaten to reverse decades of progress in women's equality. She praised the work of international and regional agencies which have raised awareness, mobilised advocacy, and inspired individual and collective action to combat gender-based violence. The Secretary-General challenged stakeholders to work towards creating comprehensive and inclusive approaches that create the space for all to become activists for the prevention of violence against women, including civil society actors, human rights defenders, academia, artists, the private sector, governments, and men and boys. "This is not a struggle for feminist women alone," Dr Barnett pointed out.

As she turned on the switch to illuminate the Secretariat, Dr. Barnett reiterated the Secretariat's commitment to ending violence against women and girls.

"The Secretariat is pleased to light up our building as a beacon of our promise to stand by women and girls and advocate for their protection," she said.

Ms. Yeşim Oruç, UN Resident Coordinator, Guyana, commended the CARICOM Secretariat for highlighting the significance of the "16 Days of Activism" and expressed appreciation for the "Spotlight Initiative" collaboration. She shared that the investments in gender equality and ending violence against women and girls by development partners, notably the European Union (EU) and the United Nations at large, along with Member States, is a pathway to achieving the Sustainable Development Goals (SDGs) in the Region.

The UN Resident Coordinator referred to gender-based violence (GBV) as a scourge and emphasised that the rates of

violence against women in the Caribbean are above global averages. Referring to recent data, she highlighted that one (1) in every two (2) women in CARICOM Member States experienced intimate partner violence or domestic violence in their lifetime; however, Ms. Oruç expressed pride in the fact that Member States are implementing programmes to combat violence against women.

"Belize, Grenada, Guyana, Haiti, Jamaica, Trinidad and Tobago are implementing very successful Spotlight initiatives", stated Ms. Oruç, "what we are recognising with this observance is that addressing issues of GBV, gender equality and women's empowerment require a regional approach, and it is a testimony to the commitment of our international development partners, including the EU, to regional solutions for regionally shared problems and working through regional institutions, such as CARICOM, with whom we are very proud to be collaborating on the regional programme for Spotlight".

The Secretariat will remain illuminated in orange un l 10 December, which is observed interna onally as Human Rights Day.

EU Seeks Special Court for Russian Crimes Against Ukraine

European Commission President Ursula von der Leyen called Wednesday for a special court to prosecute Russian crimes against Ukraine.

Von der Leyen proposed a court backed by the United Nations "to investigate and prosecute Russia's crime of aggression."

She also said Russia and Russian oligarchs need to pay for costs to rebuild Ukraine from the damage done by Russian forces since they invaded Ukraine in February.

"Russia's horrific crimes will not go unpunished," von der Leyen said. She spoke as NATO foreign ministers met in Romania on the final day of meetings that include discussing the conflict and support for Ukraine.

NATO chief Jens Stoltenberg said Tuesday Ukraine would one day join the Western military alliance in direct defiance of Russian President Vladimir Putin.

"NATO's door is open," Stoltenberg said, renewing a commitment for Ukraine membership first made in 2008 but stalled since then. He noted that North Macedonia and Montenegro recently joined the West's chief post-World War II military alliance,

and that Sweden and Finland also will do so soon.

"Russia does not have a veto" on countries joining, Stoltenberg said. "We stand by that, too, on membership for Ukraine."

"President Putin cannot deny sovereign nations to make their own sovereign decisions that are not a threat to Russia," the former Norwegian prime minister said. "I think what he's afraid of is democracy and freedom, and that's the main challenge for him."

But Ukraine will not soon join NATO, which under terms

of the alliance's charter, would likely push the armed forces of the 30-member nations directly onto the battlefield fighting Russian troops. It would be a commitment far beyond the billions of dollars in military and humanitarian assistance the United States and its allies have already sent to the Kyiv government to help Ukrainian fighters defend their country.

U.S. Secretary of State Antony Blinken announced that the United States is sending Kyiv another \$53 million to support the purchase of critical electricity grid equipment in the face of weeks-long Russian airstrikes targeting Ukrainian infrastructure to knock out power and water systems as winter weather takes hold in the country.

The top U.S. diplomat said the equipment would be sent to Ukraine on an emergency basis and include distribution transformers, circuit breakers, surge arresters, disconnectors, vehicles and other key equipment.

Struiken fends off Farley for 28 seconds Half **Marathon victory**

After hearing his footsteps, Clif Struiken fended off fast charging Julius Farley by 28 seconds, to win Saturday's 17th Deloitte-Ogier BVI Sunrise Half Marathon destination race from Road Town to Smugglers Cove, in 1 hour 27 minutes and 28 seconds, to Farley's to 1:27.57.

"It was my first race in the BVI in a long time. I took off and actually tried to stay relaxed but Julius took off relatively fast and he basically sling-shotted me into a pace that I wasn't planning on running," Struiken explained. "I kept up that pace for a while, but one thing for a long while, but then I think one thing I underestimated was that ridiculous hill (Steel Point) at the end which was a nice equalizer. I think I built up a nice gap up until that point but in the last few hundred meters, I had to speed up because I heard Julius coming behind me. He managed to get over the hill a bit faster than me. Luckily, I had something in my reserves to

Farley said that he started off trying to put himself in a good position and did that for the first three miles before Clif opened a 400m

gap, until toward the end in Steel Point. "I was surprised while coming off the hill, I saw him about five meters ahead of me, so I tried to speed up and he heard my footsteps, took off and that was it," Farley said. "He took the win as usual. It's Clif you're racing against. With Clif, you're always second best."

Like Struiken, Farley said while the first part in Steel Point was good, he forgot about the middle part. "That was the killer," he said. "When you've used up your energy in the first part of the hill, then you have the next part of the hill still to go before the decline—that was the challenge. I had to walk for a few meters and had to stop, because my legs were killing me."

Rown Victor was third among the men and fourth overall in 1:44.49, hanging on to beat Mark Stephenson by .02 with his 1:44.51 time. Asked about his debut Victor said: "It was torture," he said. "Like anybody's first long race, not knowing what to expect but coming out and doing it, the rest of the guys pushed me, I'm grateful to finish. That's all I can say right now."

Steel Point Victor said it was the hardest part

of the race. "I started to walk from there and said my race is done," said Victor, who was passed by Katrina "Kat" Lindsay and she placed third overall in 1:37.35. "But then I saw Mr. Stephenson said 'let me finish before he catches me."

He said after Lindsay passed him, he said to himself: "You go girl. You go. Do your thing," he reflected. "This is my first time running this distance, so I'm very proud of myself. Great job to the other guys though."

Stephenson said he missed the start by five minutes and did a lot of catching up. "I was a tough first half really, because I was doing 4 minutes 15 (miles) catching up to most people except for the front five," he noted. "At the hill, I couldn't take this young gentleman (Victor). He kept it up so it was a good race, but it will teach me to set my alarm clock a little earlier."

Lindsay said the race was 'hard' and 'tough coming over those hills." I was glad that I didn't have someone right on my shoulder because I would have really struggled," she said. "I've been running about 1:36 and was on a good pace, but when I hit the hills, I knew that wasn't going to

happen. So getting under 1:40, I'm really pleased with that."

Her father Gordon was eight overall in 1:59.09 and said it was 'so nice' competing with him.

One thing runners can't say is that the Deloitte-Ogier BVI Sunrise Half Marathon courses are boring.

Saturday's 17th edition was a destination race from the A.O. Shirley Grounds to Smugglers Cove. "We ran a couple of years on a looped course and that was really nice," she stated. "It was great to see everyone in the race, everyone was cheering each other on. Some people said loops are boring but it turned into an absolutely fantastic social run. And the road closure was absolutely awesome so we enjoyed that course. Post Irma, we did the loops again just because the roads were a little beaten up and then we thought well let's try a destination course."

Reddy said last year was the first and they

ended in West In in the Ferry Terminal car park. "A car park is not the best place to end a race," she pointed out. "You just want to have a beer, enjoy the sun, enjoy the glory, so this year we switched it up to finish at Smugglers and I think this is the nicest place to finish we've ever had in the 17 years. The 17th edition is one of the best."

Reddy said finishing at Smugglers Cove is 'one of the best things we've ever done,' an 'absolutely stunning course.' "We live on Tortola, we have the most beautiful beaches in the world, it's probably one of the best things we've ever done, an absolutely stunning finish at Smugglers Cove. I'm looking out here right now at the white sand, the blue sea, the blue skies, you can't get better than that. How many races in the world can you do a Half Marathon, go through the finish line and into the gorgeous Caribbean 82 degree sea? It was a stunning race today. The guy at the front was fast, 1 hr 27 despite a few hills that we threw in, and everybody after him went

Call me a cynic, but years of participation in negotiations between developed and developing countries have

schooled me to be cautious about grand announcements and promises. The devil is usually in the detail. Experience has taught me to remain hopeful, but to be vigilant in ensuring the commitments, pledges and promises are kept.

That experience has been garnered in negotiations in the Commonwealth, the World Trade Organization, the United Nations Educational, Scientific and Cultural Organization, the Organization of American States, the Organization for Economic Cooperation and Development, the Financial Action Task Force and in direct bargaining between European Union countries and the Caribbean. In each of these fora, the countries of the developed North have sought advantage over the underdeveloped countries of the South. By various stratagems, the developed countries have got their way, including by making commitments at major occasions such as COP27 which concluded on November 20.

In the words of Barbados' Prime Minister, Mia Mottley, at the opening of COP27, "This world looks, still, too much like when it was part of an imperialistic empire".

Therefore, while the leaders of small island states, including Antigua and Barbuda's Prime Minister, Gaston Browne, who, for years, as the Chair of the Association of Small Island States (AOSIS) has been advancing the argument for a fund to pay for loss and damage caused by Climate Change, are to be applauded for gaining acceptance by developed nations that such a fund should be created, the game is not yet over. The negotiated text has recognized the need for financial support from a variety of sources, but no decisions have been reached on who should pay into the fund, where the money will come from, and which countries will benefit.

When COP27 had to be extended into the weekend of 19 and 20 November to address the loss and damage issue,

> Ministerial negotiators for many small island states had already departed Egypt. It was left to Antigua and Barbuda's Environment Minister, Sir Molwyn Joseph, and the Environment Minister of the Maldives, Shauna Aminath, with their technical teams, to ensure that the concerns of small island

states were adequately met.

Much work remains to ensure that the loss and damage fund is established and adequately resourced. Further, it has to be clear that new money will finance the Fund, and not a shifting of monies already pledged for other purposes which, regrettably, happens far too often.

It should be recalled that wealthy nations still have not fulfilled an outstanding pledge to provide \$100 billion to help vulnerable countries adapt to the impact of Climate Change that they have been suffering for decades.

It is critically important for small island states and other developing countries to monitor, and participate actively in, the work of the 'transitional committee' which was established at COP27. That committee is tasked with "making recommendations" on how to operationalize the loss and damage Fund, including new funding arrangements to resource it. That committee is expected to meet before the end of March 2023, but its "recommendations" won't be considered until COP28 in Dubai in November-December 2023. Note the committee will make "recommendations".

We can be quite certain that the bargaining within the 'transitional committee' will be intense and that many developed nations will seek to avoid or minimize their obligations.

So, while praise must be given to the leaders of small island and other developing states for finally getting 'loss and damage' on the COP agenda, there are still hurdles to be jumped before they can realistically say that the problem has been functionally and effectively addressed.

A credible Fund will require sufficient money. Adapting to the impact of Climate Change will require a comprehensive approach, including building sea walls and creating drought-resistant crops.

This could cost developing countries

anywhere from US\$160-US\$340 billion annually by 2030. The number could rise to US\$565 billion by 2050 if Climate Change accelerates. That's the estimate of the United Nations Environment Programme (UNEP) in its 2022 Adaptation Gap Report.

These numbers have been made convincing by the fact that not enough was done at COP27, or by any of the previous COPs, to reduce the greenhouse gas emissions responsible for the climate crisis. The final agreement mentioned "the urgent need for deep, rapid and sustained reductions in global greenhouse gas emissions" to limit global warming to 1.5°C above pre-industrial levels.

However, a UNEP report, released just before COP27, painted a worrying picture for small island states and low-lying countries, such as Bangladesh. The report was clear "there is no credible pathway to a 1.5°C future". What is more, the report points out that "for each fraction of a degree that temperatures rise, storms, droughts and other extreme weather events become more severe".

This is why, as Prime Minister Gaston Browne, pointed out at COP27, the worst emitters, including China and India, must begin to act beyond their own interest to include the interests of the world. The development of a few countries should not happen at the expense of many others.

It is more than likely that both the initiative by Vanuatu to seek an advisory opinion by the International Court of Justice on the rights to be protected from climate change, and the establishment by Antigua and Barbuda, Tuvalu, Palau and Niue of a Commission of Small Island States (COSIS), backed by 17 international legal experts, to seek a similar opinion from the International Tribunal on the Law of the Sea, sufficiently worried major developed countries to encourage them to consider a loss and damage fund at COP27. They can influence the latter, while cases before international courts are beyond their control. It was a case of better the devil you know.

In the fight against the present damage and clear danger to their existence, all Caribbean Island States should join in using the international legal system to preserve their rights against the world's major emitters of greenhouse gases. All small island states should actively back the Vanuatu initiative and join COSIS.

The United Nations Intergovernmental Panel on Climate Change says that emissions must decline by 45% to limit global warming to 1.5°C if the already ravaged world is to be saved. There isn't a moment to waste.



China Softens Tone on COVID Severity After Protests

China is softening its tone on the severity of COVID-19 and easing some coronavirus restrictions even as its daily case toll hovers near record highs, after anger over the world's toughest curbs fueled protests across the country.

Several cities in the world's second-largest economy, while still reporting new infections, are breaking with practice by lifting district lockdowns and allowing businesses to reopen. Health authorities announcing the relaxation of measures did not mention the protests, which ranged from candle-lit vigils in Beijing to clashes with the police on the streets of Guangzhou on Tuesday and at an iPhone factory in Zhengzhou last week.

The demonstrations marked the biggest show of civil disobedience in mainland China since President Xi Jinping took power a decade ago and come as the economy is set to enter a new era of much slower growth than seen in decades. Despite near-record case numbers, Vice Premier Sun Chunlan, who oversees CO-VID efforts, said the virus's ability to cause disease was weakening, state media reported.

"The country is facing a new situation and new tasks in epidemic prevention and control as the pathogenicity of the Omicron virus weakens, more people are vaccinated and experience in containing the virus is accumulated," Sun said in comments reported in state media.

Sun also urged further "optimization" of testing, treatment and quarantine policies.

The mention of a weakening pathogenicity contrasts with earlier messages from authorities about the deadliness of the virus.

Changing rules

Less than 24 hours after violent protests in Guangzhou, authorities in at least seven districts of the sprawling manufacturing hub north of Hong Kong, said they were lifting temporary lockdowns. One district said it would allow in-person classes in schools to resume and would reopen restaurants and other businesses including cinemas.

Some changes are being implemented with little fanfare. A community of thousands in east Beijing is allowing infected people with mild symptoms to isolate at home, according to new rules issued by the neighborhood committee and seen by Reuters.

Neighbors on the same floor and three stories above and below the home of a positive case should also quarantine at home, a committee member said.

That is a far cry from quaran-

tine protocols earlier in the year when entire communities were locked down, sometimes for weeks, after even just one positive case was found.

Another community nearby is holding an online poll this week on the possibility of positive cases isolating at home, residents said. "I certainly welcome the decision by our residential community to run this vote regardless of the outcome," said resident Tom Simpson, managing director for China at the China-Britain Business Council. He said his main concern was being forced to go into a quarantine facility, where "conditions can be grim to say the least".

Prominent nationalist commentator Hu Xijin said in a social media post on Wednesday that many asymptomatic carriers of coronavirus in Beijing were already quarantining at home.

The southwestern city of Chongqing will allow close contacts of people with COVID, who meet certain conditions, to quarantine at home, while Zhengzhou in central China announced the "orderly" resumption of businesses, including supermarkets, gyms and restaurants

National health officials said this week authorities would respond to "urgent concerns" raised by the public and that COVID rules should be implemented more flexibly, according to a region's conditions.

Re-opening next year?

Expectations have grown around the world that China, while still trying to contain infections, could look to re-open at some point next year once it achieves better vaccination rates among its elderly.

Health experts warn of widespread illness and death if CO-VID is let loose before vaccination is ramped up.

Chinese stocks and markets around the world dipped initially after the weekend protests in Shanghai, Beijing and other cities, but later recovered on hopes that public pressure could lead to a new approach by authorities.

More COVID outbreaks could weigh on China's economic activity in the near term, the International Monetary Fund said on Wednesday, adding it saw scope for a safe recalibration of policies that could allow economic growth to pick up in 2023.

China's strict containment measures have dampened domestic economic activity this year and spilled over to other countries through supply chain interruptions.

Following downbeat data in an official survey on Wednesday, the Caixin/S&P Global manufacturing purchasing managers' index showed factory activity shrank in November for a fourth consecutive month.

While the change in tone on COVID appears a response to the public discontent with strict measures, authorities are also seeking out for questioning those present at the demonstrations.

China Dissent Monitor, run by U.S. government-funded Freedom House, estimated at least 27 demonstrations took place across China from Saturday to Monday. Australia's ASPI think tank estimated 43 protests in 22 cities.
