Some of the sewerage Opposition Hon. Julian Fraser, who at the time expressed concern that sewerage was leaking in the streets because of poor planning. To this effect, constructing properties Hon. Fraser asked Adams how much responsibility should the Town and Country Planning take for the sewerage that is running on the streets from buildings that he said are obviously "ill-planned."

> In response, the Chief Planner explained that he believed that a great part of the responsibility lies with the Planning Department. He further stated that from a planning standpoint when applications are received, they need to ensure that the applications are reviewed as far as the output for black water from the sewerage side of the waste.

quality has a lot to do with this sewerage situation and noted that the Town and Country Planning Department has to do more technical work in terms of the soil quality that projects are being built on.

The Chief Planner explained the building soil quality will have to be tested to ensure that the soil allows for percolation rather than runoff. Towards this end, Adams told

the Standing Finance Committee of an ongoing study with the Department of Disaster Management (DDM).

Adams explained that the issue of soil quality was one of the areas that the Department of Town and Country Planning recommended for the study. As it relates to ensuring that soil testing continues in the Territory the Chief Planner suggested to the Standing

Finacne Committee that consideration be given to the creation of a soil lab at the H. Lavity Stoutt Community College.

This lab - he said - will facilitate continuous soil testing. In furtherance of the idea of the lab the Chief Planner also suggested that someone be trained to determine the quality of the soil where development is happening especially from a standpoint of percolation.

BVI AIRPORTS AUTHORITY AIMS AT BECOMING WORLD-CLASS

situation is expected to make a dramatic change for the better in June this year when American Airlines commences direct flights to Miami. In preparation Premier and Minister of Finance Dr. the Hon. Natalio Wheatley said that the BVI Airports Authority (BVIAA) is on a mission to transform its organization.

During a press briefing on 6 January Hon. Wheatley said that the management of the BVI Airports Authority intends to elevate itself to world-class despite certain limitations. In alluding to the previous calls for the airport to be expanded, Hon. Wheatley pointed out that the BVIAA is on a

> "The BVIAA is engaged in a spatial planning exercise to accommodate additional businesses to increase and diversify the offerings to match the needs of the range of airport users," Hon. Wheatley pointed out.

The Premier said that the Managing Director of BVIAA Kurt Menal and his team have a number of new initiatives in-store to enhance the experience for travelers - both visitors and residents, and to make our airports a preferred and convenient choice for traveling into and out of the British Virgin Islands.

Hon. Wheatley disclosed that the plans include both security and logistical airport matters. He divulged that "Plans are afoot to enhance the facilities at the Terrance B. Lettsome International Airport, such as the arrival and departure halls by expanding these spaces to make them more comfortable and relaxing. Work has begun to upgrade the Hand Baggage Search machines. This upgrade will allow passengers' bags to be processed more efficiently and reduce the time spent at the security checkpoint."

While noting that even the customer service will be given an upgrade Hon. Wheatley noted that the changes will regard three aspects. The BVI Leader said, "The Customer Care Unit aims to launch its BVIAA **Customer Care Programme** soon. This programme entails focus on Guest Love, Facility Love, and Staff Love. Guest Love aims to elevate service delivery. Through the Airport Council International's (ACI) Airport Service Quality (ASQ) Programme, the Customer Service Team's strategy will be data-driven and constantly benchmarking against other airports of similar size regionally and internationally. Facility Love aims at delighting guests with a clean environment and Staff Love aims to train, educate, reward and recognize current and new staff."



JOST VAN DYKE SCHOOL CONSTRUCTION **MAKES PROGRESS**

The Jost Van Dyke school Jost Van Dyke school which was highlighted on social media as being in a deplorable state and also causing parents protests is moving into another stage of its construction. The new information on the project was provided by Minister for Education Hon. Sharie de Castro during her 9 January update on current educational matters.

The Jost Van Dyke educational facility became a subject of public discussion in September 2021 after parents of the

threatened to protest if action was not taken to fix the building. The matter incensed the community after a television reporter used footage exposing the deplorable conditions of the school.

In her New Year education announcement Minister de Castro announced that the school remains on the Education Agenda: "The Jost Van Dyke Multipurpose Educational Facility is currently four

months into construction."

While giving an account on how far the project has advanced the Education Minister said: "The milestones that have been accomplished thus far are as follows: the construction site has been fully cleared and prepared for the new building's footprint to be located. The Lower-level Foundations had been constructed. The basement level floor slab has been poured in place, as well as a portion of the Ground Floor slab. Strip footings for the remainder of the ground floor slab have now been completed. A portion of the main retaining wall has been constructed."

Following the public outrage over the state of the school former Minister of Education and current Premier Natalio Wheatley had pledged to have the school fixed, and to present short-term solutions for the education of the students. This shortterm plan involved the retrofitting of some trailers for school use.

At that time Hon. Wheatley announced the plans for a new school. He said: "We have been designing a new school for Jost Van Dyke and we had the designs which were recently approved by Town and Country Planning and we have now gone to the building authority for the approval of the mechanical, electrical and construction drawings. We are looking towards beginning procurement for the building of the school in Jost Van Dyke."

HEALTH SERVICES BURDENED BY 20 HOSPITAL "RESIDENTS"

Members of the House the Standing Finance is acute care beds for Committee. Smith who was at the time speaking about the expenses of the BVI Health Services Authority explained that having to provide year-round care to these 20 persons was a factor.

> The BVIHSA Chair stated: "The hospital is currently housing 20 boarders that really should be in nursing care. We are housing persons at the highest expense, which

individuals that should be in a lower level type of facility. So these are things that we all have to come together comprehensively and look at. We cannot fix it by ourselves."

This was not the first time that the BVIHSA Board Chair spoke about the 20 hospital Boarders. He previously mentioned the situation during a 24 November press conference.

During that conference Smith told the media: "Many don't know that there are about 20 boarders here at the hospital. The hospital is not a nursing home. But we now have to carry 24-hour around-theclock care for individuals who should have been discharged."

While noting that this situation was contributing to the financial issues faced by the Authority the Chair said: "If we talk about the financial strain on the Health Services Authority, it has been at a crisis level for some time - from its beginning. So I wouldn't draw an alarm like services won't be delivered or people will be fired or anything like that. But we as a board won't kick the can down the road or abdicate our fiduciary responsibility to do those things that are within our remit to do."

May God continue to bless our beautiful Virgin Islands and her people.





extremely common, but the majority of the time they are not felt by persons," Mr. Penn said, adding "Together with partners like the Puerto Rico Seismic Network (PRSN), Pacific Tsunami Warning Centre, the University of Puerto Rico at Mayaguez Strong Motion Programme, and the United States Geological Survey, even minor earthquakes are monitored closely."

From December 1, 2022 through January 9, 2023, PRSN recorded 76 earthquakes ranging from barely detectable magnitude 0, to a magnitude 4.35 event on Christmas Day.

The Director went on to say earthquakes that rise to the level of being significant are widely reported to the public to ensure that persons can be aware if they are at risk.

"If there is a threat of a secondary hazard, such as a tsunami, we notify the public via radio, press announcements, social media, the DDM Alert App, and if necessary, the early warning sirens," Mr. Penn said. Residents can always view the latest significant earthquakes for the PR/VI area on the Puerto Rico Seismic Network website https://redsismica.uprm.edu/index.php.

Agreements with international partners such as the Pacific Tsunami Warning Centre enable the department to rapidly receive and disseminate any safety information regarding threats that originate from distant earthquakes.


Mr. Penn, who is also

Vice Chairman of the Intergovernment all Coordination Group for the Tsunami and other Coastal Hazards Warning System for the Caribbean and Adjacent Regions (ICG/CARIBE EWS), added that redundancies are built into emergency alerting protocols.

"If there is a need for a tsunami evacuation, for instance, the local population can be alerted by DDM, or by the Royal Virgin Islands Police, or as a failsafe, directly by our partners at the PTWC," he explained.

The Department of Disaster Management takes this time to remind the community that earthquakes can occur at any time. During an earthquake, it is important to stay calm. If you are inside, stay there; move away from ceiling fans, glass windows and doors, or anything that may fall. Get under a desk or sturdy piece of furniture cover your head and hold on. If outdoors, move into an open area away from trees, building, or utility wires and poles. During an earthquake, the more you move, the more likely you are to be hurt, so refrain from entering or exiting a building during shaking.

Residents can access resources to help them plan and prepare for possible disasters, such as the emergency shelter list, emergency plan templates for families, and continuity planning templates for businesses, on the DDM website http://www.bviddm.com.

Job Placements Made Under Employment Relief Programme Premier and Minister of Finance of the Virgin Islands Dr.

Premier and Minister of Finance of the Virgin Islands Dr. the Honourable Natalio D. Wheatley said placements have been made for several applicants under the Government of the Virgin Islands Registration Apprenticeship Training Employment and Development (RATED) Programme.

The programme, launched in November of last year, is a new temporary employment relief and skills development initiative that provides three pathways for people between the age of 16 to 65 who are unemployed or under-employed. The programme seeks to obtain opportunities through short-term employment, apprenticeship and/or training, education and development, thereby, empowering them through work and training opportunities.

Speaking at his recent One-on-One press conference, Premier Wheatley stated that several persons have applied for the programme and placements have already been made for several applicants.

"We have already been able to put persons to work in areas such as the much-needed beautification of our roadsides. So, some persons have been able to obtain short-term employment, and the public has been able to get some benefit in return," Premier Wheatley said.

The Premier sought to remind the public why the bush on the roadsides has become overgrown in the last few months; noting the procurement process has come under scrutiny with concerns raised on the issuance of the bush-cutting contracts.

"We had to halt the issue of those contracts which supplemented the labour force for roadside maintenance. We were left with a gap while a new system was developed and implemented to get this work done. The RATED Programme is a lot more transparent and will allow more persons to benefit from these kinds of opportunities than under the previous system," Premier Wheatley explained.

He further added that in the upcoming months, the government will press ahead with implementing the other aspects of the programme such as training and apprenticeship.

The Premier encouraged more people to register their interest for the RATED Programme to be added to the database for consideration when other components come on stream.

"I want persons to bear in mind that the RATED Programme is not just for roadside maintenance and beautification. It is for other types of opportunities as well, so please register your interests – and registration will help us to identify what types of jobs and skills development are in higher need than others," the Premier said.

HUNGARY - Hungarian Prime Minister Viktor Orban has already survived several domestic, international, economic and social crises that have threatened to loosen his grip on power. But now he faces the greatest challenge of his 13-year rule. This is why 2023 could become a decisive — perhaps even fateful — year for the politician, whose name is inextricably linked to the rise of illiberalism in Europe.

Hungary is currently in the midst of its most serious economic crisis since the country almost went bankrupt during the international financial meltdown of 2008-09. Its currency, the forint, has plummeted in value in recent months, and inflation now exceeds 20%, plunging a rising number of people into hardship. Price caps for food and petrol have not been much help so far and have resulted in shortages for the first time since the collapse of socialism in eastern Europe in 1989.

In the middle of this difficult socioeconomic situation, the European Union decided in December to withhold billions of euros in funds because of concerns about corruption and the rule of law in Hungary. Brussels is now threatening to make even more cuts or to completely halt all EU payments to Budapest. [Deutsche Welle]

MEXICO - In 2019, Ovidio Guzmán - the son of drug trafficker Joaquin

"El Chapo" Guzmán – was detained and released in Culiacán, the capital of the northwestern Mexican state of Sinaloa. It took more than three years to have a second shot at catching him. He was finally taken into custody by authorities on January 5, 2023.

On Friday, the Mexican government revealed that Guzmán and his gang – Los Chapitos, a faction of the Sinaloa Cartel – had been under surveillance for the past six months. To avoid violent scenes like those from 2019 – when hundreds of his henchmen opened fire and threatened mass civilian deaths to secure their boss's release – authorities waited patiently for the perfect time to strike.

The cost of human life has still been high: 29 people were killed during the operation, including 10 soldiers. However, Mexican President Andrés Manuel López Obrador and Defense Secretary Luis Crescencio Sandoval made it clear that the effort by investigators and officers had been a resounding success.

The fall of Guzmán – a top priority for the United States – put the 2019 fiasco to rest. López Obrador has explained that extradition to the US will be completed as soon as possible, although he eventually backtracked regarding how fast this could be done. The Mexican Prosecutor's Office has also opened

an investigation against El Chapo's son, for the crimes committed on Friday: murder and illegal possession of weapons. [El Pais]

ROME - Italian Professional Footballers Association AIC on Thursday "firmly condemned" the racist abuse Lecce players Samuel Umtiti and Lameck Banda were subjected to by Lazio fans during the Serie A match between the teams on Wednesday - an incident that led Serie A's sporting judge to close the Olimpico Lazio ultras stand for one game.

The Rome club also released a statement condemning the racism during the match, which hosts Lecce won 2-1. "We express our support and unconditional solidarity for the two players in the name of all of us," said AIC President Umberto Calcagno in a statement.

He called for the sporting authorities to get to the bottom of what had happened as soon as possible and for the application of "the appropriate penalities for the subjects guilty of this serious behaviour. "These so-called fans have nothing to do with the millions of enthusiasts who follow our sport faithfully," he added. Lazio, like many Italian teams, has a significant number of far-right supporters among its fans.

They have been behind a series of shameful acts of racism and anti-Semitism in the past.

There are also groups of Lazio fans that are against racism, such as the Lazio e Liberta' group, and are trying to combat the stereotype that depicts all the team's supporters as neo-fascists. In condemning the abuse, Lazio said that the club had "always combatted every form of racism and discrimination with every means at its disposal, staging initiatives to repress such phenomena, raise the awareness of its fans about these issues and protect its image at the appropriate

"Once again today, SS Lazio condemns those who were the protagonists of this vile, shameful and anachronistic gesture and, as always, will offer total collaboration with the authorities to identify those responsible," it said.

"Lazio's fans are not racist and they must not be associated with the handful of individuals who seriously damage the club's image". [ANSA]

BERMUDA - The former main branch of Clarien Bank in Hamilton has been permanently closed.

The bank said that its office at 19 Reid Street had been an "emblem" of Clarien for nearly 20 years at that location.

But with the move to digital banking in 2022, all primary client services moved online or became automated.

Service continues at Clarien's new flagship location at Point House on Front Street.

Remaining client services, including preordered cash and chequebook pick-up and draft collection, are to relocate from 19 Reid Street to Clarien's 25 Reid Street facility.

Clients should enter the new facility through the Reid Street entrance and take the elevator to the second floor for assistance.

Clarien said it had added "significant enhancements" at 25 Reid Street, as with Point House, to work in tandem with its digital-first facilities. [Royal Gazette]

ANTIGUA - The Police and Customs Department seized a sizeable amount of Cannabis at one of the main ports of entry on Friday.


Both law enforcement agencies conducted a joint drug operation at the Deep Water Harbour and discovered 52 vacuum-sealed packages of Cannabis weighed 52 pounds.

The substance is valued at EC \$312,000 and is recorded as the first major drug seizure for the year.

In 2022, millions of dollars worth of Cannabis were seized between the two main ports of entry by both law enforcement agencies.

This includes 7 ½ pounds of Hashish that were found washed ashore in Barbuda in December.



USA - The New York Immigration Coalition (NYIC) has strongly denounced plans by the Joe Biden administration to limit migrants from the Caribbean into the United States.On Thursday, the Biden administration announced it was limiting migrants from Cuba, Nicaragua, Venezuela and Haiti who enter the US to 30,0000 each month under humanitarian parole, while expelling those who attempt to cross the south western border. NYIC, an umbrella policy and advocacy organization that represents over 200 immigrant and refugee rights groups throughout New York State said these plans will "cruelly favor" asylum seekers with family connections and financial privilege, demanding the expansion of additional protections for Caribbean and other asylum seekers.

"President Biden's plan to expel those who attempt to cross the border, announced earlier today, is an attack on the humanitarian values and obligations of the United States," NYIC Executive Director, Murad Awawdeh, told the Caribbean Media Corporation (CMC). [CNW]





Soup Swap Offers Fun by the Spoonful

What do you get when you mix a few friends, a few soups and a chilly afternoon? You get one fantastic get-together! It even has its own holiday. Saturday, Jan. 21 is National Soup Swap Day.

Here's how to throw the easiest, least expensive, most appreciated party of the season: a soup swap. Invite a small number of friends, asking each to bring several quarts of their favorite homemade soup. One quart of each soup will be heated and sampled during the party, along with breads, snacks and beverages. Before going home, everyone exchanges soups. The best part is everyone goes home with a variety of soups to keep them cozy in the cold days ahead.

Soup swaps work best when you invite four to six people. Everyone brings the same number of quarts of soup as there will be people attending the party. For example, if four people will attend, each should bring four quarts.



Host a soup swap with this inexpensive yet delicious recipe.

This makes one quart to sample during the party and three quarts to give to friends. You won't bring home your own soup. The host will decide if they will provide soup garnishes like sour cream, crackers and breads, along with beverages, snacks and dessert. Or the guests can bring those items, potluck style.

Send invitations two weeks in advance, and be sure to communicate clearly how the swap party works and what each guest should bring on your invitations. Ask about food allergies and share that information. It's fun to share recipes, so ask guests to provide printed recipes or to send them to you before the party, then you can print them as a party favor. Guests will label their soups with the name of soup, reheating instructions and any additional comments or ingredients if

As the host, decide how your guests should bring their soups to swap. Guests might bring their soup in containers that they don't mind giving away. You could consider getting inexpensive quart-size to-go soup containers at a restaurant supply store and sending them to guests before the party. Alternatively, see if everyone has quart-size canning jars they don't mind swapping.

During the party, you will need to heat one quart of each soup. Alternatively, ask guests to bring soup for sharing in their own slow cookers. The remaining quarts of soups should arrive frozen or refrigerated. I recommend either emptying a shelf of your refrigerator or preparing a cooler to keep the soups cold during the party.

Here's a recipe for the easiest soup ever. It's fresh and light, with only three ingredients, and it's cooked in the time it takes to boil the liquid.

TOMATO TORTELLINI SOUP

- · Yield: 4 quarts (8 to 12 servings)
- · Time: 15 minutes
- 8 cups (64 ounces) chicken or vegetable broth
- 2 (28 ounce) cans diced tomatoes, Italian style (with liquid)
- · 1 (19 ounce) bag of frozen cheese tortellini

In a soup pot, heat the stock and tomatoes to a boil over medium-high heat. When at a rolling boil, add the tortellini and cook according to the package directions. Turn off heat and serve hot.

Here are some variations to try:

Chicken Tomato Tortellini Soup -- Add 4 cups shredded cooked chicken.

Cream of Tomato Tortellini Soup -- Add 1 cup heavy cream after cooking the tortellini.

Fiesta Tomato Tortellini Soup -- Add 1/4 cup fresh cilantro and use tomatoes with green chilies. Squeeze the juice of one lime into the soup.

Want to make winter feel warm and cozy? Enjoy homemade soups and a casual gathering with friends or family. It's a great excuse for a party that's mmm, mmm good!

Benedict XVI: Apostolic trips, his love and hopes for Africa

Pope Emeritus Benedict with "dear friend" Cardinal

During his nearly 8-year-pontificate, Benedict XVI made two bond between Africa and Christianity. He said the continent was apostolic trips to Africa, visiting Cameroon, Angola and the Republic blessed by Our Lord Jesus himself. of Benin.

Pope Emeritus Benedict XVI called on Catholics in Africa to strengthen their faith and hope in God and to be artisans of unity and reconciliation during his apostolic trips to Africa.

EMBRACING ALL AFRICAN PEOPLE

Benedict, in his address, remembered the many people in Africa who suffer from diseases such as Aids, Malaria and Tuberculosis. He encouraged the Church's efforts to comfort those suffering, reiterating the total respect for life from conception to its natural end.

The Pope offered the example of Simon of Cyrene, an African who helped Jesus carry his cross, as a model of how we can be close to the world of suffering.

He told his audience they were not alone in their pain, for Christ is close to all who suffer. "He reveals to the sick and infirm their place in the heart of God and in society", Benedict XVI said.

GOD CHOSE AFRICA AS A PLACE OF REFUGE

The first visit in 2009, the 11th international trip of his pontificate, took Benedict to Yaoundé, the capital of Cameroon, from the 17 - 20 March and then to the Angolan capital Luanda from the 20 - 23 March 2009. Benedict would later say that his visit was limited to the two countries but "intended to embrace in spirit all the African peoples and to bless them in the Lord's name" (Gen. Audience 1 April 2009).

Speaking about Cameroon, Pope Benedict said he chose to go there first because the "country sums up many features of the vast continent of Africa and first and foremost its profoundly religious spirit which all the very numerous ethnic groups that populate it have in common" (Welcome address, 17 March 2009). Benedict XVI then spoke about some of the continent's challenges and what Africa needs going forward.

High on the agenda of the visit to Cameroon was the promulgation of the Instrumentum Laboris or working document of the Second African Synod during Holy Mass celebrated on the feast of St Joseph, 19 March. Before presenting the document to the bishops of Africa, he offered the example of St. Joseph and the Holy Family of Nazareth as a model for African families.

THE HUMANIZING ACTION OF CHRIST'S MESSAGE

Another high moment of the Apostolic voyage in Cameroon was the Pope's meeting with the sick at the Cardinal Paul-Émile Léger Centre for disabled and disadvantaged youngsters in Yaoundé. He referred to it as "a powerful sign of the humanizing action of Christ's message."

In a meeting with the Special Council for Africa of the Synod of Bishops (19 March 2009), Pope Benedict XVI recalled the intimate

"At the dawn of his earthly life, sad circumstances led him to set foot on African soil. God chose your continent to become the dwelling place of his Son. In Jesus, God drew near to all men and women, of course, but also, in a particular way, to the men and women of Africa", Benedict XVI said. "Africa has received a particular vocation to know Christ. Let Africans be proud of this!" he added.

UNITY AND RECONCILIATION

Benedict XVI expressed the hope that "Africa will be able to find the strength needed to face its (sometimes) difficult daily existence, and thus it will be able

to discover immense spaces of faith and hope which will help it to grow in God."

He reiterated this at his first General Audience after he visited Cameroon, saying: "In the midst of the unfortunately numerous and tragic conflicts which still afflict various regions of that continent, the Church knows she must be a sign and an instrument of unity and reconciliation so that the whole of Africa may build together a future of justice, solidarity and peace, putting into practice the teachings of the Gospel."

POPE BENEDICT XVI IN ANGOLA

From Cameroon, Pope Benedict flew to Angola's capital, Luanda, for the second leg of his apostolic trip in the first quarter of 2009. On 22 March, in a meeting with the Southern African Bishops under the association of the Inter-Regional Bishops of Southern Africa (IMBISA), he revisited and reiterated his message of peace regarding the violent conflict that had marked the history of Angola. Later, Pope Benedict re-echoed his message of forgiveness, reconciliation, hope and new life in Christ during Mass.

"Look to the future with hope: trust in God; reconciliation is the fruit of inner change," Benedict XVI said while speaking in Portuguese, Angola's official language. The Pope called on all the faithful to realize that the Church, in Angola and throughout Africa, is meant to be a sign before the world of that unity to which the whole human family is called through faith in Christ the Redeemer.

BENEDICT XVI IN BENIN

Two years after the Second African Synod in Rome, Benedict XVI returned to Africa. This time, he visited the West African nation of Benin. The main purpose of the 18 - 20 Nov. 2011 visit was to present the Post-Synodal Apostolic Exhortation or final document, which was the fruit of the Second African Synod.

Among other reasons, Benedict chose to go to Benin to pay homage to Cardinal Bernardin Gantin, a native of Benin and former Dean of the College of Cardinals with whom he worked for many years in the Vatican.

Ackie's first screen credit was in a 2015 episode of "Doctor Who," but her big break came by playing Jannah in "Star Wars: The Rise of Skywalker."

According to Yahoo UK, Ackie, who is British, says that 97.9% of the vocals in the film are Houston's, but that she herself did sing the first song in the movie when the character was a bit younger and "needed to be refined." Even though she lip-synced, Ackie did a fantastic job recreating iconic moments in Houston's life, such as singing the "Star Spangled Banner" at Super Bowl XXV and starring in the hit film "The Bodyguard" with Kevin Costner. Whether or not Ackie's hard work will pay off with an Oscar nomination on March 12 remains to be seen, as the film itself has received mixed reviews that might hurt her chances, despite her solid performance.

. For those who didn't hear, for-A . ror those who didn't have host of "The Tonight Show" and lover of cars old and new - Jay Leno suffered second-degree burns while working in his garage recently. According to "People" magazine, on Nov. 12, while working underneath one of his vintage vehicles (he owns 204 cars and 168 motorcycles), "a freak fire erupted, spraying him with flaming gasoline." He's undergone several skin grafts at a burn center, but despite developing some scars, he has fully recovered. Fortunately, Leno's friend Dave Killackey was nearby and pulled him out before any more severe damage occurred, which could have resulted in Leno losing an eye.

As for his career, after leaving latenight shows in 2014, the comedian launched his CNBC TV series "Jay Leno's Garage," where he and his celebrity friends celebrate everything from

• Whatever happened to "Good • Morning America's" Joan Lunden? I haven't seen her on television in years. She was always one of my favorites.— I.S.



Immunological Therapy Reasonable for Case of Lymphoma

DEAR DR. ROACH: I am an 86-year-old woman who was recently diagnosed with stage 3A follicular lymphoma. It was discovered on a CAT scan when I went to the ER for diverticulitis. I have no symptoms. The doctor did a biopsy to confirm, and I had a PET scan as well. I feel good otherwise. I am only on blood pressure and cholesterol medications. My oncologist is recommending low-dose chemotherapy. I am conflicted. At my age, what should I do? — L.H.

ANSWER: There are many types of lymphomas (which are a type of cancer of blood cells), but lymphomas are predominantly in the lymph nodes. Follicular lymphoma is an "indolent" type of lymphoma, meaning it is very slow-growing, but unfortunately often uncurable. People with no symptoms from follicular lymphoma and who are stage 1, 2 or 3A tend to have a long time before they have progression of the disease to the point of having symptoms. Depending on other characteristics, that time ranges from three to seven years. Choosing to hold off on treatment is definitely a reasonable option for a person in your situation.

However, your oncologist knows much more about your disease than I do, such as the extent of tumor in the abdomen, the molecular markers of the tumor, and additional blood results. When an oncologist suggests treatment, I would listen carefully.

One treatment that your oncologist might be considering is immunological therapy such as rituximab. Unlike traditional chemotherapy, rituximab alone is pretty nontoxic and can delay the progression of the disease. A large study suggested improvement in the quality of life with rituximab. Usually, rituximab is given once a week for four doses, but some oncologists repeat the four doses every two months.

If I had a patient in your situation, I would say holding off on treatment would be reasonable given your age and lack of symptoms, but a trial of the rituximab (if that is what the oncologist is contemplating) would also be a reasonable choice. If you had serious side effects to the treatment, I would recommend against further doses.

DEAR DR. ROACH: I recently read your column on astaxanthin. The article contained a statement that flabbergasted me. Can you explain the details behind it? You state, "Most astaxanthin sold commercially is synthesized from petroleum products." What gives? — K.O.K.

ANSWER: Any drug, supplement or chemical you buy is either extracted and purified from a natural source or synthesized in chemical reactions (or some combination of the two).


For example, if you buy curcumin from the health food store, the supplement might start off as the roots of the shrub Curcuma longa in the ginger family. These are then boiled in water and baking soda and also powdered, making turmeric. Curcumin is purified from turmeric through the use of a solvent like acetone and becomes crystalized to make pure curcumin.

However, curcumin from the health food store might also be synthesized directly from vanillin, which, in turn, is derived from wood pulp or from crude oil. No matter whether the curcumin starts — as turmeric roots from India, as wood pulp, or as oil — the chemical you take is exactly the same, and your body doesn't know where it's coming from.

Keep in mind that the manufacturer chooses the least expensive way of getting you what you want.

Pineapple Green Beans

A taste of Hawaii!

- 1/2 cup chopped onion
 - 1 (8-ounce) can pineapple tidbits, packed in fruit juice, drained and 1/4 cup liquid reserved
- 1/4 cup water
 - tablespoon cornstarch
- 11/2 teaspoons reduced-sodium sov sauce
- 2 cups frozen cut green beans, cooked, rinsed and drained
- 1. In a large skillet sprayed with butter-flavored cooking spray, saute onion for 5 minutes.
- 2. In a covered jar, combine reserved pineapple liquid, water and cornstarch. Shake well to blend. Pour mixture into skillet with onion. Stir in soy sauce. Add green beans and pineapple tidbits. Mix gently to combine.
- 3. Continue to cook over medium heat for 6-8 minutes or until mixture thickens and is heated through, stirring constantly. Divide into 4 servings.

TIP: If you can't find tidbits, purchase pineapple chunks and coarsely chop.

2023 NEW YEAR'S MESSAGE FROM THE CARIBBEAN TOURISM ORGANIZATION

Bridgetown, BARBADOS (January 9, 2023): In 2022, the Caribbean was among the fastest-recovering regions globally and would have reclaimed between 85.0% and 90.0% of total arrivals in Some individual destinations surpassed their 2019 levels with recordbreaking performances, while others are approaching the benchmark levels of 2019, and are expected to equal or exceed these levels in 2023. Nevertheless, a few destinations will require a longer period to reach pre-pandemic levels. We have seen unprecedented levels of airlift into the region from our source markets and the aforementioned recovery has been very evident in both land based and cruise tourism. This speaks to the resilience of the sector and the positive perception of the region in our source markets, based on our hospitality, stability, connectivity and our perennial well-earned status as a region for wellness.

"The year 2022 and especially the second half of the year has been a very encouraging one for Caribbean tourism. While we are still seeing elements of the effect of the pandemic on international travel, here in the Caribbean, we have noted a much more consistent pattern of travel which is a good indicator of a return to normalcy and a path to 2019 levels." said Mr. Neil Walters, CTO's acting Secretary General.

Of course, the gains we have recorded have not been achieved without

challenge. Our ability to learn from and recover from the significant challenges of the 27 months up to June 2022 are a testament to the resilience of Caribbean tourism and Caribbean people in general. Many of those challenges continue today, compounding the latent effects of the pandemic and evolving into new challenges for the tourism sector and Caribbean economies in general. Thus far, we have been able to ride out the supply chain issues, the political unrest existing in some regions of the world and the economic unrest which seems to be forever looming in our key source markets. Of immediate concern is the lack of intraregional connectivity especially in the

Central, Southern and Eastern Caribbean. The effect of this is particularly acute in these sub-regions where several of our member countries depended on intra-regional travel in the pre-pandemic era as one of their key source markets.

Our aim in 2023 is to create mechanisms to ensure that the Caribbean remains in the top 5 of the fastest growing tourism regions in the world. To date, the majority of our efforts have been focused on traditional markets, resulting in the significant recovery outlined above. But we do recognize that even within and abounding our traditional source markets there are untapped markets which are ripe for growth including the non-

traditional markets outside of the USA, UK and Europe.

The Caribbean tourism sector's key assets - our people and diverse cultural and natural resources - remain critical to the development of regional tourism. Sufficient and sustainable funding including foreign direct investment are other critical factors. Market growth, development of the sector's key assets and sustainable funding are examples of some of the actions needed for sustained recovery and rebuilding of Caribbean tourism. By focusing on the key pillars of the CTO's work - research, product development including human resource development at all levels of the Caribbean and marketing - the aim is to ensure the CTO's continued leadership in the development of regional tourism and to overcome some of the challenges outlined above.

In affirming this action, Hon. Kenneth Bryan, Chairman of the CTO Council of Ministers and Commissioners of Tourism and Minister of Tourism and Transport for the Cayman Islands noted, "The CTO is the region's tourism development agency and in recognizing this, the CTO Council of Ministers and Commissioners of Tourism has started a process to reshape the organization to reposition it to be more relevant in the post-pandemic era. In this way, the CTO can best lead the region in developing tourism into a more resilient and robust sector, confirming its significant contribution to positive regional economic growth."

Antigua and Barbuda Prime Minister condemns assault on Democracy in Brazil

St. John's, January 8... The Government of Antigua and Barbuda has condemned the storming of the Congress in Brazil by supporters of the country's former, leader, Jair Bolsonaro.

Prime Minister Gaston Browne also denounced the actions of right-wing groups who surrounded the Supreme Court and the Presidential Palace.

The Antigua and Barbuda Prime Minister said, "Mr. Bolsonaro lost the Presidential election, found to be free and fair by Observers from international organizations, including the Organization of American States, and the will of the electorate must be fully respected".

"These attacks on institutions of government by groups, seeking to overturn the results are assaults on democracy, which will not be tolerated by the governments and peoples of the Hemisphere", Prime Minister Browne stressed.

"The Government of Antigua and Barbuda stands in support of democratically-elected President Luiz Inácio Lula da Silva and his government, and we will make this position clear at the OAS and at the UN, in the coming days," the Prime Minister added.

NATO, EU Back More Military Aid for Ukraine

NATO and European Union leaders have reinforced their commitment to providing Ukraine with military support to counter Russia's nearly year-old invasion, including providing advanced air defenses and other equipment.

European Commission President Ursula von der Leyen told reporters Tuesday she thinks Ukraine should get all the military equipment it needs to defend itself, "because they also defend the basic principles of the U.N. Charter, of the fundamental rights and of the international law.

'Speaking alongside von der Leyen and European Council President Charles Michel after a meeting in Brussels, NATO Secretary General Jens Stoltenberg welcomed the announcements in recent days by the United States, Germany and

France of plans to provide Ukraine with new types of armor and armored vehicles. He stressed the need to also keep a focus on training, maintenance and ammunition for the existing systems that allies have already sent to Ukraine's forces.

"NATO allies and EU members have depleted their stocks to provide support to Ukraine, and that has been the right thing to do because this is also about our security and of course we need to use our capabilities, our stocks, our ammunition, to support

Stoltenberg added that while Ukrainian forces have been able to inflict losses on Russia's military, Russia should not be underestimated and President Vladimir Putin has shown no indication of changing "the overall aim of his brutal war against Ukraine."

"The regime in Moscow wants a different Europe. It wants to control its neighbors and it sees democracy and freedom as a threat," Stoltenberg said. "This will have long-lasting consequences for our security, so we must continue to strengthen the vital transatlantic bond in NATO, we must continue to strengthen the partnership between NATO and the European Union, and we must further strengthen our support to Ukraine." Bakhmut battle

Britain's defense ministry said Tuesday Russian forces and those from the mercenary Wagner group were "probably now in control" of most of Soledar, a small salt mining town in eastern Ukraine located in one of the areas of fiercest fighting

The fighting for Soledar has resulted in heavy losses for both sides.

Ukrainian President Volodymyr Zelenskyy, in his nightly address Monday, described the destruction in Soledar by saying, "There are almost no whole

"Due to the resilience of our warriors there, in Soledar, we have gained additional time and additional power for Ukraine," Zelenskyv said.

About 10 kilometers from Soledar is Bakhmut, which the British defense ministry said in its latest daily assessment is likely Russia's main target in

"Despite the increased pressure on Bakhmut, Russia is unlikely to envelop the town imminently because Ukrainian forces maintain stable defensive lines in depth and control over supply routes," the

A senior U.S. military official, who spoke to reporters Monday on the condition of anonymity, called the fight in Bakhmut "really savage."

"And what I mean by savage is you're talking about thousands upon thousands of artillery rounds that have been delivered between both sides," the official said, adding that Russian mercenary forces sacrifice their weaker soldiers by putting them in

The weaker soldiers "essentially take the brunt," the official said, adding that better trained forces then "move behind them to claim the ground."

Flood, Mudslide Threats Prompt Evacuations Along **California Coast**

MONTECITO, CALIFORNIA — The latest in a string of Pacific storms blamed for at least 12 deaths soaked California on Monday, prompting evacuations of some 25,000 people, including the entire town of Montecito and nearby areas of the Santa Barbara coast, due to heightened flood and mudslide risks.

The Montecito evacuation zone was among 17 California regions where authorities worry a series of torrential downpours since late December could unleash lethal cascades of mud, boulders and other debris in hillsides stripped bare of vegetation by past wildfires.

The mandatory evacuations came five years after mudslides from heavy rains struck newly fire-scarred slopes and canyons around Montecito, an affluent coastal enclave 90 miles northwest of Los Angeles, causing widespread damage and killing more than 20 people in January

Sheriff's deputies were out plying flooded roads in armored high-clearance BearCat SWAT vehicles to rescue residents trapped by high water, said Raquel Zick, a Santa Barbara County sheriff's spokesperson told Reuters.

Among the nearly 9,000 residents of Montecito, many with opulent homes in the picturesque town, are such celebrities as media mogul Oprah Winfrey, and Britain's Prince Harry and his wife Meghan.

It was not immediately clear whether they were among those forced to flee the area. Winfrey was known to have been in Hawaii over the New Year's

Another famous Montecito resident, actresscomedian Ellen DeGeneres, posted a video selfie on Twitter of herself standing in the rain beside a flooded torrent flowing through what she described as a normally dry creek bed near her property.

'Mother nature is not happy'

The performer, garbed in a hooded jacket, tweeted that she had been advised to "shelter in place" rather than evacuate since her home was on higher ground.

"We need to be nicer to Mother Nature, because Mother Nature is not happy with us," she said in the video. "Let's all do our part. Stay safe, everybody. Yikes," DeGeneres said.

All 15 districts of Montecito were ordered to immediately evacuate along with portions of the city of Santa Barbara and adjacent areas of Carpinteria and Summerland where "burn scars" posed a threat of mudslides, the Montecito Fire Department said.

Social media video posted online by TMZ.com showed a man paddling his kayak in the middle of a flooded street in Santa Barbara. The Los Angeles Times reported numerous road closures from flooding and debris flows, including sections of U.S. highway route 101 in Santa Barbara and Ventura

Along the central California coast, some 14,000 people were ordered evacuated early on Monday from four Santa Cruz County communities inundated with flash floods, extreme tides and heavy runoff from local mountains, said Brian Ferguson, a spokesperson for the state Office of **Emergency Services.**

Nearly 4,000 more people in the town of Wilton remained under evacuation orders due to flood threats from breached levees along the Cosumnes River south of Sacramento, the state capital, Another 42,000 residents of roughly a dozen counties were under evacuation warnings, Ferguson said.

The torrential rains, along with heavy snow in mountain areas, were the product of yet another "atmospheric river" of dense moisture funneled into California from the tropical Pacific, powered by sprawling low-pressure systems churning offshore.

At least a dozen fatalities have been attributed to several back-to-back storms that have lashed California since December 26, including a toddler killed when a redwood tree was blown over his family's trailer home last week.

Experts say the growing frequency and intensity of such storms, interspersed with extreme dry spells, are symptoms of climate change, posing greater challenges to managing California's precious water supplies while minimizing risks of floods, mudslides and wildfires.

The six storms since just after Christmas have been accompanied by pounding surf that has battered seaside communities, as well as fierce, gale-force winds that have uprooted thousands of trees weakened by prolonged drought.

The National Weather Service (NWS) has warned the latest onslaught would impact most of California's 39 million residents, with up to 5 inches of additional rain expected to fall near the coast and more than a foot of snow on the Sierra Nevada mountains over the next few days.

The high winds have wreaked havoc on the state's power grid, knocking out electricity to tens of thousands of Californians. As many as 120,000 homes and businesses were without electricity on Monday morning, according to data from Poweroutage.us.

Athletes kick off season in Dag Samuels Development Series By Dean "The Sportsman" Greenaway

Athletes used Saturday's Dag Samuels Development Series meet as a measuring stick to see how their off season program has helped their development for the new season. A nervous Talent Ex Track Club's Ashleigh Penn, opened her season in the 300m Hurdles.

"When I went in the race, I didn't want to use my blocks either, but I just set them up and tried my best not to trip, but to attack every approach and felt like I did well," Penn, in the second year of hurdling told Island Sun Sports, adding that she has learned a lot. "I feel like I really came a really long way, from not having correct form, not knowing what to do properly. Not using my arms and today I felt like I executed, that's all thanks to coach (Burt) Dorsette."

Penn, the daughter of Athletics Association General Secretary, Stephanie Russ Penn who likes the hurdles, didn't have a background in track like her mother who ran the 400 and 800m. While completing community service hours with the association, something clicked.

"I was like, I should try this, maybe I'll be good at this," she reflected. "So I came and here I am."

Teammate S'Ryiah Mitcham, who prefers the shorter hurdles, said she felt like the wind was holding her back. "I thought I wasn't going to get over it," she said of running into a headwind.

"Other than that it was alright. I was working on getting through the race as I'm accustomed to the shorter hurdles, so this is something new to me so I was just trying to get a feel of it."

Jelani Croal set the early pace in the Open 600m, but it was Tyreese James overhauling Coral Jonathan Lynch and Top Notch teammate M'Kori Crabbe, to win in 1 minute 23.28.

"In the beginning of the race was a little challenging for me because that's not the strongest part of my race, but I was told not to be too far behind, stay close to the pack until the end, which I know is usually the strongest part of my race," James explained. "I gave it all I had. Coming home, I was lining up with Jelani and Jonathan and Mook (Crabbe) was ahead of us, so my goal was just to catch him and at least pass him."

Lynch who was third in 1:24.46 later won the U20 Boys 300m in 36.84, said he rant the 600 the way he planned to.

"I hit the time the coach wanted me to hit," he said. "On the home stretch, I just tried to relax and held on."

Croal, who faded to 1:28.07 for fourth said that he went out too hard. "I didn't have enough endurance to take me home," said Coral, just 43 points shy of a bronze medal in last year's Carifta Games Octathlon. "I tried to get out in front, stay ahead of the pack and tried to not let them catch me."

After winning the 300m, Kenyatta Grate said her aim was to get out over the first 30m, work on her form and push herself over the last 100. "Then it was making my way home, working on my form, my legs and staying tall," she said. "Right now, Coach (Willis Todman) is teaching me to swing from my shoulders and making sure I can see my thumb and when my hand's going back, making sure it's going by my pocket."

Wanyae Belle won the 300m in 34.24 second before taking the 150m in 16.10 and was pushed by Malik John in 34.70 and 16.35 in both races, then said it was like a training session and test day. "I came out trying to run a personal best," he said, noting that John kept him pushing. "That motivated me to run even faster, because I really wanted it."

Belle—just the 2nd U20 Boys Carifta Games 100m finalist and 3rd 200m finalist during the 2022 Carifta Games, then went on to the World Athletics Championships, said he's looking forward to "some big personal bests and staying healthy."

Carifta High Jump bronze medalist Jah'Kyla Morton won the U17 Girls 60m in 9.12 seconds

and was second in the 600m in 1:56.31."The first 200 was very well executed," Morton noted of the 600. "Coming around the back stretch, my whole body started to tighten up, so I couldn't go any faster, but I told myself I cannot stop, I have to finish the race, even though I'm feeling the lactic acid building up."

Morton said her preparation for Carifta is going well. She has dropped the Long Jump and added the hurdles as her second event.



The fallacy of "President" Juan Guaidó is over

The pretender, Juan Guaidó, is now finally gone. The myth that he was the President of

Venezuela and had the capacity to act and speak for the country, has now evaporated.

The myth of Guaido's presidency and authority was possible only because Donald Trump, as President of the United States, endorsed him on 23 January 2019, for personal political

reasons. Trump needed the exile votes in South Florida for his run for a second term as President. Several countries were "persuaded", in defiance of customary international law to support Trump's position. But many of the then governments of those supporting states knew that the position they took was not rooted in international law or practice, and it was unsustainable unless the de facto government of Nicolás Maduro crumbled. Four years later, Maduro is still there.

Further, sanctions applied against the Maduro government, designed to hasten its collapse, did not succeed. The only thing that the sanctions accomplished was hurting the populace of the country, particularly the poor, creating the second largest flow of refugees in the world today.

Many countries, which followed the Trump lead in recognising Guaidó as President of Venezuela, had begun to abandon that farce. In Latin America and the Caribbean, change of governments in Mexico, Argentina, Bolivia, Chile, St Lucia, and Guyana, which had formed themselves with Canada into the "Lima Group", departed from the patently obvious uselessness of supporting a charade. Jamaican government, while not formally a member of the Lima Group, continued its pro-Guaidó position.

The purpose of the "Lima Group" was to try to give international legitimacy to Juan Guaidó, particularly in hemispheric organisations, such as the Organization of American States (OAS) and the Inter-American Development Bank, where, along with the U.S. government, they used their slender majority to impose Guaido's nominees as the representatives of Venezuela.

Several Caribbean governments resisted this imposition, which was also a violation of the rules of the OAS and of customary international law. Among the Caribbean countries, which steadfastly adopted this principled stance from the outset, were Antigua

> and Barbuda, Dominica, St. Vincent and the Grenadines, and Trinidad and Tobago. These countries, recorded in the resolutions of the OAS, that they did not accept the violation of the OAS rules and would not be bound by any decision, which required the vote of Guaidó's representative to pass.

On 6 October 2022 - just three months ago at the General Conference of the OAS in Peru, as Ambassador of Antigua and Barbuda, I introduced a resolution to overturn the decision to seat Guaido's representative at the OAS. The resolution received majority support of 19 of the supposedly 35 member states (neither Cuba nor Venezuela are members despite the unenforceable 1948 rules of the organisation, really making membership 33). Only 4 countries voted against, namely Canada, Guatemala, Paraguay and the U.S.

However, even though Guaidó's nominee was seated at a General Conference in 2019 by 19 votes, which, wrongly, included the nominee voting for himself, the archaic rules of the OAS required a favourable vote of 22 Abstentions by three CARICOM countries deprived the OAS of correcting the blemish of illegality and immorality of seating a pretender as a legitimate government. How any government could expect to maintain the credibility of the OAS in such circumstances is deeply troubling.

As matters turned out, it was the Venezuelan opposition parties that put an end to this international conspiracy to accord Guaidó the status of President. The opposition shadow "National Assembly" voted on Friday, 30 December 2022, to remove Juan Guaidó. Guaidó's own party did not oppose removing him; they wanted to replace him.

But the three major opposition groups recognised that, realistically, a farce was never sustainable in the beginning, and continuing it was self-destructive. Instead, they have created a five-member commission to manage

Venezuela's foreign assets, especially the U.S. based, CITGO, a subsidiary of the state-owned oil company, PDVSA. However, this scheme is entirely dependent on the support of foreign governments, including the U.S. and the United Kingdom.

Almost \$2 billion worth of Venezuela's gold reserves are held in the Bank of England. A London High Court had ruled last August that Guaidó should control these assets, but the Maduro government appealed the decision. Now that Guaidó has been deposed by the Opposition parties and the farce of his Presidency has evaporated, the Court will be constrained to review its ruling.

Meanwhile, Gustave Tarre, Guaidó's nominee representative to the OAS, has announced the termination of his own appointment in the wake of Guaido's removal. Since it was Guaidó who, himself, made this appointment as "President of the National Assembly", and he has been removed by the same opposition National Assembly, the entire scheme at the OAS now falls away. Unless, of course, 19 governments are brazen enough to try to once again bulldoze and bully the other members of the Organization to accept another mockery of customary international law and practice.

It is most unlikely that 19 member states will support such an initiative. The vote at the OAS General Conference on 6 October, 2022 was self-evident. Only 4 countries voted against the Resolution by Antigua and Barbuda, whose objective was to restore respect for law and rules at the OAS by removing Guaidó's representative. Spain has shown the way to all those who initially recognized Guaidó. On 28 December 2022, Spain formally appointed an Ambassador to Venezuela, dealing directly with the Maduro administration.

The reality is that on 27 April 2017, the Government of Venezuela denounced the OAS Charter and announced its withdrawal from membership of the Organization with effect two years later on April 27, 2019, as required by the Charter. Since then, a pretender has wrongly occupied the Venezuelan seat, not paying any part of the \$10 million, ascribed as dues payable by Venezuela over the last 4 years.

The consequence was false accounting that has contributed to the inability of the Organisation to fulfil its mandate to the peoples of the member states.

This additional fallacy must also now end.
