## NHI BLUES: EXPENSIVE STUDY "DID NOT YIELD VALUE FOR MONEY"

National Health Insurance (NHI) that has been promised for almost four years has been completed. However, the Director of the Social Security Board (SSB) Jeanette Scatliffe-Boynes told members of the House of Assembly during the 2023 Standing Finance Committee (SFC) Deliberations that the outcome of the study is disappointing.

SFC hearings that the Director of SSB disclosed that a request for expression of interest was issued to conduct a comprehensive review of the NHI system. At that time she stated that there were also recommendations for the relevant regulations to be amended to maintain the

The review and study of the scheme's solvency while, at the same time, maintaining and improving the level of benefits currently offered.

> Scatliffe-Boynes announced that the SSB contracted Redbridge Solutions on 1 December, 2021, to conduct this operational review of the NHI and to also provide technical assistance. That approximate contract amounted \$423,000.

The update on the review It was during the 2022 was raised following a question about the status of the study from the Premier and Minister of Finance Dr. the Hon. Natalio Wheatley. The BVI Leader asked if the Social Security Board "determined that the study that was commissioned did not yield value for money or the results for which the study was commissioned."



In response to the Premier's question, Scatliffe-Boynes stated that the Social Security Board was disappointed in the outcome of the study.

While providing further the completed study, the Deputy Director of the

Social Security Board with responsibility for NHI, Roy Barry told legislators that recommendations were submitted but to date, there has been no implementation.

Mr. Barry explained clarity on the matter of that: "the management team at NHI have prepared and submitted several recommendations and they await a final decision on such recommendations." However, as it relates to the current state of NHI the Deputy Director noted that: "there would be no change in direction at this time."

it also provides medical coverage at select regional and international health facilities. One such location is the neighbouring United States Virgin Islands; where for years a number of residents have been known to seek treatment. However, the Leader of the Opposition Hon. Julian Fraser questioned whether the USVI was still a wellutilized medical option.

The Leader of the Opposition and Third District Representative suggested that there might be an issue with some of NHI's USVI service providers. Hon. Fraser told the SFC that "service providers in St. Thomas who were once providers no longer provide service." He noted these service providers complained that it was too onerous to do business with NHI. Therefore Hon. Fraser queried why NHI does not have more providers in St. Thomas.

In response, the Deputy Social Security Director stated that to his recollection NHI has not lost any of its providers in the USVI. Barry also indicated that NHI has not added any new providers in St Thomas because the USVI healthcare costs are way too expensive.

## "GREEDY BILL" IS UNPOPULAR WITH ELECTORATE

Minister for Health and Social Development and National Democratic Party Leader Hon. Marlon Penn is already in campaign mode. In fact, he has announced that if his NDP government is elected he will make changes the public has asked for in the Retiring Allowances Act, better known as the Greedy Bill.

The Act was a major concern to residents who were not in agreement with the fact that under the Bill members of the House of Assembly will continue to receive their full salary for leave office. This proposal resulted in the legislation being nicknamed the 'Greedy Bill'.

The idea that some legislators will still be well taken care of if they were to lose the upcoming election was especially unpopular with Community activists including Kishma Penn and Cindy Rosan; who were instrumental in alerting the public of the content of the Bill. In fact, Penn and Rosan organized a motorcade on 5 June, 2021 to rile up the public concern in the matter.

at least two years after they However, despite their efforts, the Bill was passed in the House of Assembly and later assented to by the Governor.

> The matter was never laid to rest, with some activists currently calling on members of the public to only vote for politicians in the upcoming elections who have promised to repeal the Retiring Allowances Act.

> Therefore, it is no surprise that Hon. Penn who announced that he was never in favor of all aspects of the Act is promising to

make the recommended changes. Hon. Penn who appeared on Monday's Talking Points radio programme announced: "I would remove the Act. I have said this publicly before it was passed. My concern at the time we were discussing and negotiating the Retirement Act was the way that the pension was being calculated."

"For instance, you had [House of Assembly] members. The average salary of a member was \$36,000 base — that's the member's salary.

So members were getting pensions based on that \$36,000, not based on all the other allowances and things they were getting [in] their package. But they were being taxed on it," Hon. Penn explained.

Hon. Penn who at the time the legislation was passed was the Leader of the Opposition, was criticized for his decision to vote for the Bill. Now that he is announcing that he will bring an amendment the Legislator said that he still endorses aspects of the Retirement Act which was the reason he voted.

## **INCREASE IN CANCER CASES IS BECOMING A**

## **GRAVE CONCERN**

Talk show host Edju Enka aka Cromwell Smith is lending his voice to the cancer concern that has been echoed in various sections of the community. The Talk Show host on the 17 January edition of his Umoja radio programme has called for research on what seems to be an increase of cancer cases in the Territory.

Edju Enka who speculated that Territory's environment might be a contributing factor announced, "We need investigation funding to look at the environment to see where in the environment and what environment is causing the increase in cancer patients."

While stating that he is alarmed by what appears to be an increase in cancer cases the Talk Show host said "Over the last several months, we have had a lot of passings and we continue over the years actually and it seems to be like, let me just say persons are beginning to think that we have an environmental problem that's contributing to the development of cancer," he stated.

This point of view that there has been a dramatic increase in cancer cases in the Territory has been expressed Leader of the Opposition Hon. Julian Fraser. The most recent announcement of this concern was made in November last year.

Hon. Fraser who was at the time speaking on the Morning Braff radio show on Tola Radio on 1 November complained that too many people are discovering cancer in their bodies. He said, "You know how many people are contracting cancer on a

regular basis and dying in this territory? Far too much. It's endemic, and nobody's talking about this thing."

This was not the first time that Hon. Fraser raised this concern. In fact, he mentioned this matter in the House of Assembly last year during the 16 June sitting. At that time Hon. Fraser drew a line connecting the rise in cancer-related deaths in the Territory and problems with running sewerage as well as the open burning incinerator issues.

However, science is of the view that a diet high in whole foods like fruits, vegetables, whole grains, healthy fats and lean protein may prevent cancer. Conversely, processed meats, refined carbs, salt and alcohol may increase your risk. Though no diet has been proven to cure cancer, plant-based and keto diets may lower your risk or benefit treatment. in a country that imports most of its food from foreign countries where Genetically Modified Organisms (GMOs) are produced.

According to the World Health Organization (WHO), GMOs, i.e., genetically modified organisms can be defined as organisms (i.e. plants, animals or microorganisms) in which the genetic material (DNA) has been altered in a way that does not occur naturally by mating and/or natural recombination.

Ty Bollinger" writes that "The rapidly growing industry of genetically modified crops are infiltrating our food supply at an alarming rate. More than 90% of our corn and soy are now genetically modified. This fairly new practice is the source of many debates. Experts agree that adequate testing was not

## **KEVON LETTSOME SAYS HE HAS REAL REMEDIES** FOR 7TH DISTRICT

With elections constitutionally due in coming months Kevon "Shack" Lettsome the contender for the Seventh District seat is amping up his campaign.

Lettsome launched his candidacy on 25 April last year and has since been constantly sharing his views and vision for the Seventh District which is currently being represented by Premier. Natalio Wheatley.

Although the Premier has announced that he intends to go the unorthodox way in his bid for reelection, Lettsome has maintained his campaign mode by consistently highlighting issues affecting the District. In a recent interview on the Umoja talk show on 9 January Lettsome pleaded with the people of the District to give him a chance.

The Seventh District Candidate suggested that the issue with the previous

stemmed from the fact that the elected Representatives were more concerned with ministerial portfolios. "In the past, we have tried doctors, we have tried the most educated, we have tried the best speakers... persons who can look the part and dress the part and I have viewed those persons before me and even the now premier as persons who have national ambitions and a portfolio person."

In what some have noted to be a jab against the

representation of the District incumbent representative, Lettsome stated: "I believe that District 7 needs someone who will focus on the district, has time for the district, and who is actually from the district and understand the district's pain."

> While noting that he takes his decision to run seriously, Lettsome announced that he joined the race to give the people of the Seventh District an option. "I just want to give my peers, my family, my friends, a valuable option to vote for someone who understands their

problems... because they have gone through and even gone through some of the same issues and problems that are still there presently."

As he mentioned some of the issues plaquing the community the Seventh District candidate called for solutions and remedies. "Those things need to be addressed urgently and they need urgent attention and I personally and strongly believe right now District Seven doesn't need anyone who is portfolio driven," Lettsome announced.

## REVISED: 19 Illegal Immigrants Found On Virgin Gorda

Chief Immigration Officer, Mr. Ian Penn has said that 19 illegal immigrants are now in the custody of the Department of Immigration following an exercise by the officers of the Royal Virgin Islands Police Force and Immigration Department carried out on Virgin Gorda on January 16.

According to Mr. Penn, the illegal immigrants who were

found on Virgin Gorda are of Haitian nationality and include 12 males, four females and four children.

The Chief Immigration Officer said all persons will be safely detained following intake interviews and COVID-19 testing administered by the BVI Health Service Authority.

Mr. Penn urged persons residing in the Territory to

remain vigilant and report any suspicious activities at sea. Additionally, anyone with information related to these immigrants should also contact the Immigration Department at 468-4717, 468-4715 or 468-4753 or the Royal Virgin Islands Police Force hotline at 311.

The Joint Task Force, which comprises officers from the

Department of Immigration, Her Majesty's Customs and the Royal Virgin Islands Police Force, will continue to increase their capabilities by ensuring that cohesive plans are executed in a manner that will ensure the safety of residents as the security of the Territory's borders is paramount.



## **Energy Project Moves Forward On Anegada**

Deputy Premier and Minister for Communications and Works, Honourable Kye M. Rymer, has said that the Battery Energy Storage System (BESS) project is long overdue as the Virgin Islands continues to move towards energy resiliency and energy security.

Honourable Rymer while addressing the Ground Breaking Ceremony on Anegada said had it not been for the COVID-19 pandemic which struck in 2020, the renewable energy project

would have been completed about a year ago. He added, "It is overdue in the first sense, that with everything we know about the damaging effects of fossil fuels; the world is playing catch-up with the climate crisis – and some people and some countries have still not yet gotten the message that time is running out to save our planet."

The British Virgin Islands Electricity Cooperation (BVIEC) and Power52 executed the contract for the Anegada Hybrid Renewable Energy & Battery Storage System (BESS) Project in November 2021 in the sum of \$4,687,944.72.

"The long-term goal is for us to get to around 70 to 80 percent renewable energy across the Virgin Islands. This project will reduce diesel-produced electricity on Anegada by 90 to 95 percent," Honourable Rymer said.

The BVIEC subsidises the cost of electricity for residents on Anegada, who are not connected to the main electrical grid. This is significantly higher than the fuel used to produce electricity on the main grid. The completed project is expected to reduce the overall cost and reduce the financial burden on the BVIEC.

The project has a substantial completion and commissioning date of November 2023.

## VI Benefits From Executive-Level Oil Spill Training



Twenty high level public officers participated in Level 3 Oil Spill Response Training designed to improve the coordination, management and planning of responses to these events.

Acting Permanent Secretary in the Ministry of Natural Resources and Labour Joseph Smith Abbott said the training was valuable for leaders in the public service who have the responsibility to ensure that oil spills within the Territory receive a well-balanced response.

Mr. Smith Abbott said, "Oil spills are unique in that they require us to plan

responses that swiftly protect the Territory's natural resources, safeguard our first responders, and investigate the scene in case there is a need for criminal prosecution, all at the same time."

Director of Disaster Management Jasen Penn said the executive-level training is for decision makers who must ensure effective and harmonious responses among responders from other Government agencies, as well as international partners, nongovernmental organisations, and the private sector. He

said it also helps the Territory achieve compliance with the International Maritime Organisation's International Convention on Oil Pollution Preparedness, Response and Co-operation (OPRC).

Mr. Penn added that the training complements the 2021 revision of the National Oil Spill Contingency Plan.

"As technology and best practises change, it's imperative for us as a Territory to improve our capacity to respond to incidents as well," the Director said.

Officers from the Ministry of Natural Resources and Labour, Royal Virgin Islands Police, Virgin Islands Shipping Registry, BVI Ports Authority, Virgin Islands Fire and Rescue Service, and the Department of Disaster Management participated in the four-day virtual training.

The session was organised by the Department of Management Disaster (DDM) as part of its annual training programme with financial support from United Kingdom Maritime and Coastguard Agency (UKMCA) through Conflict, Stability and Security Fund (CSSF). It was provided by Ambipar Response, and conforms to the requirements of the International Maritime Organisation (IMO). Level 1 and Level 2 training sessions for persons who respond directly to oil spill incidents are scheduled to follow in February.

Residents who suspect an oil spill has occurred or is occurring should report it to the Virgin Islands Fire and Rescue Service by calling 911 or 999.

## COI Implementation Unit Reports On Progress For December

The Commission of Inquiry Implementation Unit is advising the public that it has reported to the Governor and Premier on the status of work completed up to the end of December 2022.

Based on the timelines agreed in the Framework for Implementation of the Recommendations of the Commission of Inquiry Report and Other Reforms, the Director of the Unit Ms. Hadassah Ward has advised that work on 48 of the 50 Framework recommendations has begun.

Ms. Ward said, "15 of the Recommendations have been completed and 33 Recommendations are in progress. The Recommendations are currently split into 132 Actions. Of these, 52 (39%) are completed, 31 (23%) are in progress and on track, 26 (20%) are in progress but experiencing challenges and 22 (17%) have not been started as yet." She noted that during the month of December:

Two Independent Reviewers completed and submitted their reports: B25 – The Establishment and Maintenance of Statutory Bodies and B29 - Review of the Membership of Statutory Boards. These will be submitted to Cabinet as Information Papers and laid before the House of Assembly before the relevant Ministries begin public consultation and continuing to change the relevant policies and procedures and requesting legislative amendments.

The Auditor General completed and submitted three Reports: B12 – HOA Assistance Grants, B22 - Claude Skelton-Cline Government contracts since 2019 and B23 EZ Shipping – Government Contracts for radar barges since 2019.

She said that the Dashboard gives a pictorial summary of the status of the fulfilment of the COI recommendations as agreed in the Framework. The Key shares each of the 50 Framework Recommendations, now being worked on as the main focus of Government of the Virgin Islands to raise our standards of governance in our beautiful Territory, so you can track the status of work on each recommendation.

The COI Implementation Unit assists in coordinating the overall delivery of the COI recommendations, which includes providing support to ministries in developing work plans for the delivery of recommendations, assist in drafting policy directions, and the development of new programmes and systems. The unit is also responsible for preparing monthly progress reports, reports on specific work programmes, and reports to identify key issues associated with implementation and suggest remedies. The unit reports directly to the Permanent Secretary Mrs. Carolyn Stoutt Igwe in the Premier's Office, who chairs the COI Implementation Steering Committee. The Governor and Premier receive the monthly report on the 15th of each month.





USA - The United States is about to reach the debt limit that it can have in circulation, as Treasury Secretary Janet Yellen warned this Friday in a letter sent to Congress. There was debate about when that milestone would be reached, but it was not expected to be so imminent. Raising the debt limit is the responsibility of Congress and with the House of Representatives in Republican hands it will not be easy to achieve. In an unlikely extreme case, the federal government's inability to borrow could lead to an unprecedented debt default that would rock markets and send the country into recession.

"I am writing to inform you that beginning on Thursday, January 19, 2023, the outstanding debt of the United States is projected to reach the statutory limit. Once the limit is reached, Treasury will need to start taking certain extraordinary measures to prevent the United States from defaulting on its obligations," Yellen said in her letter.

The debt limit is the total amount of money that the United States government is authorized to borrow to meet its existing legal obligations, including Social Security and Medicare benefits, military salaries, interest on the national debt, tax refunds, and other payments. It is currently set at \$31,381 trillion.

Yellen has announced to Congress the implementation of extraordinary

measures, but warns that they will serve to weather the situation and "enables the government to meet its obligations for only a limited amount of time." "It is therefore critical that Congress act in a timely manner to increase or suspend the debt limit. Failure to meet the government's obligations would cause irreparable harm to the US economy, the livelihoods of all Americans, and global financial stability," says the Treasury Secretary. [El Pais]

GERMANY - It would be premature to talk about Russian military defeat in Ukraine. But Vladimir Putin has lost the gas war against Germany — that much can already be said for certain. Germany has the largest natural gas storage capacities in the whole of the EU. And if these are still more than 90% full in mid-January, at the height of the heating season, it means the loss of Russian gas supplies no longer constitutes a threat.

When Russia invaded Ukraine almost 11 months ago, Germany was importing more than half its natural gas from Russia. Blackmailing Germany was therefore the centerpiece of the economic pressure Moscow piled on the European Union, aiming to undermine European support for the Ukrainian people and their army.

The plan has failed. Germans are not freezing in their homes; they

have not been forced to shut down their factories. Politicians in Berlin are no longer afraid that Moscow could take revenge on Germany and bring the country to a standstill. No — Germany itself renounced coal and crude oil from Russia as part of the EU sanctions, and since the end of August it has not received any natural gas from Gazprom, either. [Deutsche Welle]

ROME - The first real wintry conditions of the season are set to hit Italy on Sunday and last for some time, weathermen said Thursday. "January 15 will be the date of the first meteorological inversion towards a marked change in the weather," said Lorenzo Tedici of the www.iLMeteo.it website.

After the recent balmy spell gave way to rain and high winds, but still far from average high temperatures, Tedici said colder and more unstable air will move in from northern Europe starting Sunday. There will be a bright side to the cold front as it will bring much-needed snow to both northern and central mountains, amid a snow crisis in the central Apennines that is threatening winter tourism along the spine of Italy and has already cost over 50 millon euros. "Conditions will be more typical of the time of year," said Tedici, adding that snow ill fall on low ground in the Po Valley and the Apennines.

Ahead of the brisk change in the weather, however, "we will still have three days of very mild conditions, with temperatures as high as 15 degrees celsius." (ANSA).

**BAHAMAS** - AN American cruise visitor was fined in court on Friday after admitting to bringing

recreational marijuana into the country.

Idris Aliyu, 25, of New York, stood before Magistrate Samuel McKinney on a charge of possession of dangerous drugs.

After entering New Providence aboard the Carnival Conquest, Aliyu was arrested after being found with 1 ¼ oz of Indian hemp in four blue packages.

In a subsequent police interview he admitted to buying the drugs in the US for his recreational use and further said that he was unaware that weed was illegal here.

As such he pleaded guilty to the offence in court resulting in him receiving a fine of \$350 or one month in prison.

After requesting to have the fine lowered over concerns of the cost to return home, the magistrate told the defendant that the US Embassy should assist with his repatriation. [The Tribune]

DOMINICAN REPUBLIC - Santo Domingo.- Former Vice President Margarita Cedeño responded this Wednesday to the request of the director of the Supérate (food coupon) program, Gloria Reyes, in the sense that the efforts of that social assistance institution be investigated from when the former president directed it until now.

"Not her, eagle doesn't hunt flies," said Cedeño when asked what she has to say to Gloria Reyes, after the official requested the aforementioned audit from the Accounts Chamber.


Cedeño stated that President Luis Abinader wants to do a circus with her, arguing that "there is a plot from the National Palace."



Benn said while the police are working on information regarding the fire, he hinted that the blaze may have been deliberately set.

"It would appear passing strange and it would test probability that within two or three weeks, we can have a fire at the same building at a prominent location in Georgetown where hundreds of children are working on their SBAs (School-Based Assessments) and other things," he said;

He urged everyone to stand in support of the education system and that the destruction of the Christ Church Secondary School was a "tremendous blow."

Benn said the spike in the number of fires at schools "has to tell us something" with the authorities noting that a large section of the North Ruimveldt Multilateral School was destroyed in June, 2021, the St George's Secondary School was ravaged by a blaze in July, 2022, and arsonists destroyed the Mabaruma Secondary School in September 2021. 

# Celebrate Fortune, Happiness and Health in the Chinese New Year

**This year, Chinese New Year begins on Sunday, Jan. 22** and will culminate with the Lantern Festival on Feb. 5 as we welcome the year of the Rabbit.

**You know me,** if festivities are happening, I'm on board! In the Chinese culture, eggs symbolize birth or a new start, so this week I'm sharing the Chinese American classic Egg Fu Yung. This Chinese restaurant favorite is like an omelet filled with crisp vegetables served with a sweet and savory sauce.

It's surprisingly easy to prepare, very inexpensive, and it's delicious.

The only thing you probably don't have on hand would be mung bean sprouts. They're usually under \$2, commonly found packaged in the produce department near the tofu or canned in the ethnic food aisle of your grocery store. Bean sprouts make this dish fresh and crispy, but if you absolutely can't find them, substitute thinly sliced celery, bok choy or napa cabbage instead. They have the same crunch and a similar taste.



Celebrate the Chinese New Year with Egg Fu Yung

## **EGG FU YUNG**

- Yield: 4 to 6 servings
- · Time: 1 hour

This makes 6 to 8 egg foo yung and is a satisfying dinner served with ramen or rice and stir fry vegetables on the side. The recipe yields enough sauce to serve over rice and veggies, too.

## What You'll Need:

## For the Sauce:

- 1 (14.5 ounces) can chicken broth, divided
- · 3 tablespoons soy sauce
- 1 1/2 tablespoons apple cider vinegar
- · 1 tablespoon sugar
- · 1/2 teaspoon garlic, minced
- 1/4 teaspoon fresh ginger, grated
- · 3 tablespoons cornstarch

#### Here's How:

In a small saucepan, combine 1 cup of the chicken broth with the soy sauce, vinegar, sugar, ginger and garlic, and bring this mixture to a boil. Take the remaining cold chicken broth and mix it with the corn starch until completely blended, no lumps! Slowly, add this to the boiling liquid while whisking to combine. Bring to a boil, stirring until thickened. Hold this on very low heat, stirring occasionally, until ready to serve.

## For the Egg Fu Yung:

- · 12 eggs, well beaten
- 1/2 teaspoon salt
- 1/4 teaspoon pepper
- · 1/4 teaspoon garlic powder
- 1 teaspoon sesame oil
- 12 to 14 ounces (about 3 cups) mung bean sprouts
- · 1/2 cup green onions, thinly sliced, plus more for garnish
- Vegetable oil or olive oil for cooking

## Here's How:

Preheat the oven to 180 F. Combine the well-beaten eggs with salt, pepper, garlic powder and sesame oil. Add the bean sprouts and green onion, stirring to incorporate. In a preheated 8-inch skillet, heat about a teaspoon of oil adding additional oil as needed. Using a 1/2 cup measure for each, place a scoop of the mixture in the hot pan and fry as you would a pancake, turning once, until cooked through and golden brown. Keep warm on a platter in the oven while cooking the remaining mixture.

Repeat with remaining egg mixture to make 6 to 8 pieces. Stir the egg mixture each time you scoop to be sure each one gets an equal share of the sprouts and onion, or the last few will be just egg. Serve topped with the Egg Fu Yung sauce, garnished with green onion.

This inexpensive recipe is a great addition to your Meatless Monday rotation. However, you could also add cooked chicken, shrimp, pork, beef or tofu. Other optional ingredients would be sauteed mushrooms, peas, julienned carrot, thinly sliced cabbage and/or cilantro.

While not traditionally Chinese, it's fun to have this easy and versatile recipe to help celebrate the "other" New Year. Happy cooking and xin nian kuai le! Happy New Year!

## FOUR DOGS EUTHANISED FOLLOWING VICIOUS ATTACKS

Monday, January 16 – The Royal Virgin Islands Police Force ordered four dogs euthanised over the weekend following incidents of each either injuring persons, or maining or killing livestock.

The latest in a series of dog attacks was on Saturday in Pleasant Valley where a neighbour's dog entered an adjacent property and bit the foot of a guest of the property owner. The property owner reported that the dog, which is unregistered, had been seen off-leashed in the neighbourhood and had been on his property in the past.

The owner of the dog was subsequently reported for having an unregistered dog and warned of prosecution in relation to injuries sustained to the victim.

The three other dogs owned by a Sea Cows Bay resident were also unregistered and had, on several occasions, attacked and injured tenants residing on his property in addition killing livestock in the area.

The RVIPF is reminding dog owners of this undesirable outcome should dangerous animals be allowed to roam the neighbourhood freely and without restraint.

The Pounds and Livestock Brands Act, 2004 makes provision for any animal found straying in a public place or trespassing on any private land to be captured and impounded. The Dogs (Prevention of Injury to Person, Livestock and Poultry) Act, 2001 further states that officers are in right to destroy, either by shooting or put down in some other manner which will cause as little pain as possible, any dangerous dog.

Dog owners are reminded of their responsibility to secure these animals, so they are not a danger to the public or to livestock. Owners must also register their dogs with the Department of Agriculture and place the ID registration tags on the collar of the dog.

## Actor Alec Baldwin to Be Charged With Manslaughter in Shooting

SANTA FE, NEW MEXICO

Prosecutors announced that actor Alec Baldwin will be charged with involuntary manslaughter in the fatal shooting of a cinematographer who was killed on a New Mexico movie set.

Halyna Hutchins died shortly after being shot during rehearsals at a ranch on the outskirts of Santa Fe on Oct. 21, 2021. Baldwin was pointing a pistol at Hutchins when the gun went off, killing her and wounding the director, Joel Souza.

Santa Fe County Sheriff Adan Mendoza, who led the initial investigation into Hutchins' death, described "a degree of neglect" on the film set. But he left decisions about potential criminal charges to prosecutors after delivering the results of a yearlong investigation in October. That report did not specify how live ammunition wound up on the film set.

Taking control of the investigation, Carmack-Altwies was granted an emergency \$300,000 request for the state to pay for a special prosecutor, special investigator and other experts and personnel.

Baldwin — known for his roles in "30 Rock" and "The Hunt for Red October" and his impression of former President Donald Trump on "Saturday Night Live" — has described the killing as a "tragic accident."

He sought to clear his name by suing people involved in handling and supplying the loaded gun that was handed to him on the set. Baldwin, also a co-producer on "Rust," said he was told the gun was safe.

In his lawsuit, Baldwin said that while working on camera angles with Hutchins during rehearsal for a scene, he pointed the gun in her direction and pulled back and released the hammer of the weapon, which discharged.

New Mexico's Office of the Medical Investigator determined the shooting was an accident following the completion of an autopsy and a review of law enforcement reports.

New Mexico's Occupational Health and Safety Bureau has levied the maximum fine against Rust Movie Productions, based on a scathing narrative of safety failures, including testimony that production managers took limited or no action to address two misfires of blank ammunition on the set prior to the fatal shooting.

Rust Movie Productions continues to challenge the basis of a \$137,000 fine by regulators who say production managers on the set failed to follow standard industry protocols for firearms safety.

The armorer who oversaw firearms on the set, Hannah Gutierrez Reed, has been the subject of much of the scrutiny in the case, along with an independent ammunition supplier. An attorney for Gutierrez Reed has said she did not put a live round in the gun that killed Hutchins, and she believes she was the victim of sabotage. Authorities said they have found no evidence of that.

Investigators initially found

500 rounds of ammunition at the movie set on the outskirts of Santa Fe — a mix of blanks, dummy rounds and what appeared to be live rounds. Industry experts have said live rounds should never be on set.

In April 2022, the Santa Fe Sheriff's Department released a trove of files, including lapel camera video of the mortally wounded Hutchins slipping in and out of consciousness as a medical helicopter arrived. Witness interrogations, email threads, text conversations, inventories of ammunition and hundreds of photographs rounded out that collection of evidence.

State workplace safety regulators said that immediate gun-safety concerns were addressed when "Rust" ceased filming, and that a return to filming in New Mexico would be accompanied by new safety inspections.

The family of Hutchins — widower Matthew Hutchins and son Andros — settled a lawsuit against producers under an agreement that aims to restart filming with Matthew Hutchin's involvement as executive producer.

"Rust" was beset by disputes from the start in early October 2021. Seven crew members walked off the set just hours before the fatal shooting amid discord over working conditions.

Hutchins' death has influenced negotiations over safety provisions in film crew union contracts with Hollywood producers and spurred other filmmakers to choose computergenerated imagery of gunfire rather than real weapons with blank ammunition to minimize risks.

# Pope Francis: Africa 'a continent to be valued, not plundered'

VATICAN NEWS: We publish an excerpt of Pope Francis' interview published online on Friday by Comboni missionaries in Spain in Republic of Congo and South Sudan ...

'Mundo Negro' magazine. The 30-minute interview took place on 15 December at the Vatican with the magazine's director, Fr. Jaume Calvera, Editorin-Chief ,Fr.Javier Fariñas Martín, and Cardinal Miguel Angel Ayuso Guixot, Prefect of the Dicastery for Interreligious Dialogue.

Q: Holy Father, you became a Jesuit, among other reasons, to go to Japan as a missionary...

Yes, that is true.

Q: What has stayed with you since that time?

I think I have always been interested in the peripheries. I look at the peripheries from the inside, not only because they interest me intellectually. And that is what stays with me, to go beyond the frontiers.

Q: You have said that "Africa never ceases to surprise." How much of this surprise do you think can be attributed conflict, that is why I am not going to Goma, since it is not possible to the missionaries you have met?

What surprises me most about missionaries is their ability to put themselves on the ground, respect cultures and contribute to their development. They do not uproot the people, on the contrary. When I see missionaries, and there are always some who do not succeed, I note that Catholic missionary outreach does not proselytise, but proclaims the Gospel according to the culture of each place. This is Catholicism, respect for cultures. There is no Catholic culture as such; yes, there is Catholic thought, but every culture is rooted in what is Catholic, and this is already experienced in the very action of the Holy Spirit on the morning of Pentecost. This is very clear. Catholicism is not uniformity, it is harmony, a harmony of differences. And this harmony is created by the Holy Spirit. A missionary goes forth, respects what is found in each place, and helps to create harmony, but (he or she) does not proselytise ideologically or religiously, much less with a colonialistic mindset. Some aberrations have occurred on other continents, for example the serious problem of the schools in Canada that I visited and spoke about. Missionary work must respect the culture of the people, living within that context and doing this


Q: The Second Vatican Council sixty years ago offered extraordinary missionary momentum. Has the understanding of mission changed much since then?

Thank God, yes. Historians say that it takes 100 years for a Council to be fully implemented, so it is only half way through. Many things have changed in the Church, many things for the better ... There are two interesting signs: the initial imprudent enthusiasm of the Council has already disappeared, I am thinking of the liturgical effervescence, which is almost non-existent. And anti-conciliar resistance is emerging that had never been seen before, something that is typical of any process of maturation. But so much has changed... On the missionary side, respect for cultures and inculturation of the Gospel are values that blossomed as an indirect consequence of the Council. Faith is inculturated and the Gospel takes on the culture of its people, allowing for an evangelization of culture.

Q: Are we still very focused on the number of Catholics?

Statistics are useful, but we should not put our hopes in them. I ask myself: in whom do I place my hope? And I ask everyone: in whom do you place your hope, in your organization, in your sociological ability to bring people together, or in the power of the Gospel?

Q: From 31 January to 5 February you will travel to the Democratic



due to the fighting. It's not that I'm not going because I'm afraid, but with this (volatile) atmosphere and seeing what is happening...we have to take care of people.

Q: You mentioning human and existential peripheries brings to mind the African continent. Are these two peripheries inseparable?

Africa is unique... (but) there is something we must denounce: there is a collective unconscious idea...that says Africa is to be exploited. History tells us this, with independence halfway: they give them economic independence from the ground up, but they keep the subsoil to exploit, we see the exploitation of other countries taking their resources.

O: What are the riches of the continent that we do not see?

We only see material wealth, which is why historically it has only been sought and exploited. Today we see that many world powers are going there for plunder, it is true, and they do not see the intelligence, the greatness, the art of the people.

Q: While insisting on the war in Ukraine, you reiterate that we must not forget other conflicts that remain hidden, some of them in Africa ...This is obvious. I said that we now realize that this is a world war because it is right next door ... One of the biggest problems is the production of weapons. Someone once told me that if we stopped producing weapons for a year, world hunger would end. An industry that kills...

Q: When we talk about the exploitation of the African continent, we are talking about natural resources and people. What are we missing when we build fences and put up obstacles to stop or impede their arrival?

And when we put up barbed wires to prevent them from escaping ... It is a crime. It is a crime. And those countries that have a demographic index at its lowest, that need people, that have empty cities and don't know how to manage the integration of migrants. Migrants must be welcomed, accompanied, promoted and integrated. If they are not integrated, that is bad ... But there's a great European injustice, isn't there? Greece, Cyprus, Italy, Spain, and even Malta are the countries that are receiving most migrants. And what is happening in Italy where despite the current government's migration policy being, let's say in a nice way, restrictive, the country has always opened its doors to save the people that Europe does not welcome. These countries have to deal with everything and are faced with the dilemma of whether to send them back where they risk being killed or dying, or to do what they can... This is a serious problem. The European Union does not accompany them.

## Family History of Breast Cancer Prompts Man to Get Examined

DEAR DR. ROACH: My mother and both of her sisters had breast cancer in their 30s, with my mother eventually passing after her third bout at age 43. They all grew up in the same house that I grew up in. I'm now a 34-year-old father of three small children. I don't want to die early because I need to be around for them, but the generalized advice I'm seeing is that I don't need a cancer screening until my 40s.

Am I overly sensitive, or am I missing something that I should potentially screen for? — M.M.

ANSWER: With your mother and two aunts having breast cancer at such a young age, I would be concerned about an inheritable cancer gene such as BRCA1 and BRCA2. This gene may not have been identifiable at the time they had their cancers, as the first test became available in 1996. It is worth a discussion with a genetic counselor to consider testing for you.

Men with the BRCA1/2 genetic mutations are at risk to develop breast cancer themselves and are recommended to do monthly breast self-examinations starting at age 35, with a clinician exam yearly. A PSA test is also recommended for men who are positive for BRCA2 (and maybe for men with BRCA1), as men with these mutations are more at risk for prostate cancer at a younger age than average-risk men.

Although BRCA increases the risk of colon cancer, all men should get colorectal cancer screenings at age 45, regardless of BRCA status. Those with a strong family history of colon cancer

should speak with an expert about the right time to begin screening.

I honor you for considering your family and expect you are doing as much as you can with your lifestyle to keep yourself healthy. A diet including plenty of fresh fruits and vegetables, with little to no processed meat, has been shown to reduce cancer risk as well as heart disease risk, which is still the major cause of death in industrial societies.

The most likely causes of death in men your age include motor vehicle accidents and suicide. These are not completely preventable, but driving safely, not texting while driving, never driving while intoxicated and seeking help with symptoms of depression go a long way at reducing your immediate risk so that you can continue to be there for your children.

## DEAR DR. ROACH: I first tested positive for COVID eight days ago. Should I start Paxlovid now?—P.M.

ANSWER: This medicine has made a huge reduction in the number of people who get so sick from COVID that they need to be hospitalized, but only when used properly. This means it has to be used at the right time — ideally within 24 hours of getting sick and certainly within five days. It's not likely to be of any help to you eight days after symptom onset.

The medicine is of most value to people who are at high risk of severe COVID. This includes people who are unvaccinated, people over 65 and people with high-risk conditions such as advanced HIV, organ transplantation or other severe problems with the immune system (including cancer chemotherapy and similar powerful drugs used for autoimmune diseases). Healthy, younger, vaccinated people with initial mild to moderate symptoms are at low risk for severe COVID (as of the time of this writing, with the omicron strains currently circulating) and do not benefit much from Paxlovid.

# White House Gives Few Details About Additional Classified Documents Found at Biden's Home WHITE HOUSE Department failed to p

The White House faced a new barrage of criticism Tuesday about the weekend announcement that lawyers found a third tranche of classified documents at the president's private home.

Administration officials emphasized they are being cooperative with investigators and transparent with the public and are drawing a contrast between their behavior and that of former President Donald Trump.

However, in a half-hour call with reporters, White House spokesperson lan Sams declined to offer any details beyond the few the administration already has reported about the unknown number of documents found in private offices and homes used by President Joe Biden.

And while White House press secretary Karine Jean-Pierre fielded multiple questions on the issue, she stressed repeatedly that the White House would not provide too many details while an investigation was underway. Last week, Attorney General Merrick Garland appointed a special counsel to investigate the potential mishandling of classified documents by Biden.

"While we may be constrained from being able to provide a ton of facts as this investigation is ongoing, we're being very forthright that we're being cooperative with the Justice Department," said Sams, special assistant to the president and senior adviser to the White House counsel's office. "And that's such a stark contrast. I mean, you listen to these House Republicans ... they're faking outrage about disclosure and transparency."

On Saturday, White House lawyer Richard Sauber said in a statement that officials found six pages' worth of

classified documents in Biden's private library at his home in Wilmington, Delaware. He said those documents were immediately turned over to the Justice Department.

The latest discovery adds to a trove found in December in the garage of Biden's Wilmington home, and another set found in November in an office in Washington that he used.

Biden said after the first discovery was announced last week that he was "surprised to learn that there were any government records that were taken there to that office."

"But I don't know what's in the documents," he added.

Previously, the Justice Department retrieved about 300 documents at various levels of classification from Trump's Florida home.

## **Unanswered questions**

In Tuesday's call with reporters, the White House did not give comprehensive responses to questions about why they delayed by days or weeks in announcing the document discoveries, what the parameters were for the searches, whether they are done searching, what's in the documents themselves and how many there are, and whether Biden would sit for an interview with the special counsel if he is asked.

Trump, on his social media network, sought to contrast his case with Biden's, saying that he "did NOTHING wrong [and] have the right as President to "declassify."

Trump added that he kept the documents securely and that "Mar-a-Lago is a highly secured facility, with Security Cameras all over the place, and watched over by staff & our great Secret Service. I have INFO on everyone!"

Biden's Republican critics have promised swift action.

"President Biden's three strikes against transparency will be met with swift congressional oversight," James Comer, chairman of the House Committee on Oversight and Accountability, said in a statement on Saturday. "The White House, the National Archives, and the Justice

Department failed to promptly inform Congress and the American people about mishandled classified documents from Joe Biden's time as vice president."

When asked if the White House would cooperate with Congress, Sams said, "We're reviewing those letters. We'll make a determination about our response in due course. But of course, we're going to call it out when we see rampant hypocrisy that shows a total lack of credibility when it comes to these requests."

Walter Shaub, a senior ethics fellow at the Project on Government Oversight, told VOA via email that while the administration was right to promptly inform Justice Department officials after they found the documents, "things might have come out better for the Biden White House if they had done a better job [of]] communicating with the public. At a minimum, they should have been forthcoming with all relevant details when the media first asked about President Biden's retention of the records."

"It may be understandable that the administration didn't alert the public immediately" when they first discovered the documents, he said, but "at some point, they owed the public information. It would have been nice if the administration made an announcement before the media learned that President Biden had discovered classified records in his possession. ... That was a breach of trust with the public."

Jean-Pierre questioned whether the public was preoccupied with what is turning out to be a political headache for the Biden administration, which faces stiff opposition in the new Congress.

"That's for the American people to decide, right?" she said.

# Hodge blasts season opener while Collegians break out By Dean "The Sportsman" Greenaway

Adaejah Hodge opened her season by chopping .24 seconds off her 60m by climbing to No 2 All Time Indoors, while nine collegians saw action, four of whom were debutantes.

Hodge, now at Montverde Academy in Bradenton, Florida, won her 55 meter heat in 6.90 seconds at the Virginia Showcase on Saturday. The soon to be 17 year old then finished 2nd in the 60m dash in 7.24 seconds to teammate Micayah Holland's 7.21. Hodge chopped her personal best from 7.51, and became the territory's No 2 performer behind Tahesia Harrigan-Scott's 7.09 from 2008.

Hodge told Island Sun Sports that her coach wanted her to execute what they had been working on in practice, including being aggressive out the blocks, not rushing the drive phase and making sure they didn't have excessive air time.

"Going into the 55, I was super excited as it was my first 55," she said. "When I saw 6.90, I was super excited because it was a US No 2 (mark) so it really boosted my confidence going into the 60m."

Hodge said since it was the first time she and Holland were running together, her coach told them to focus on their own lane, have tunnel vision and not rush the drive phase.

"Crossing the line to see a 7.24, had to be the most shocking thing I had ever experienced in my life, because my PR was 7.51," she said. "It's really relieving to see that the training is going well and to open the season rewriting history and in the BVI and the US, I know there's more work to be done. This boosts my confidence for the rest of my season."

### Collegiate debutants

South Florida Freshmen Jaleel Croal, won the 60m at the Jimmy Carnes Invitational in 6.74 seconds, after a 6.79 prelim. Croal, who admitted being nervous, said he didn't know what a good indoor time was. "I kinda stumbled (out the blocks" then caught myself and then had to work," Croal noted of his prelim. "For the final, I executed better. All I've been working on since I came to the school was the start of my race."

UCF's Beyonce DeFreitas won the 400m in 56.92 seconds.

New Mexico Jr. College's Khybah Dawson, was among four BVI athletes at the Texas Tech Corky Classic. In his first meet since injuring himself at last year's Carifta Games, Dawson opened his season with a Long Jump leap of 7.44m (24'5") to place second. He won his 200m heat in 21.84 seconds for the meet's 13 best mark, then had a 49 second split on his team's 3 minutes 28.49 seconds 4x4 Relay.

"It was a good debut. I've never run indoors before, never jumped indoors and it was a different feeling," Dawson said. "It feels good to jump at a College level. Returning to the Long Jump was good. It felt different because I didn't foul the first jump and my second jump is always the greatest jump. It feels good to jump after I got injured the last time I jumped. It feels humbling to jump again."

After injury derailed his 2022 season, UTEP's Josh Hill returned to action with a 47.70 seconds 400m and placed seventh. "I feel like my season opener was good. I'm satisfied with it, due to the circumstances of being out a whole year with injuries," Hill said. "There's always room for improvement—especially in this sport. So it's back to the drawing board and getting ready for the rest of the season."

Northwestern State's Djimon Gumbs won the Shot Put with a heave of 17.44m (57'2³¾") while twin brother Diamante was 8th with 16.08m (52'9¾"). "It was a good opener for me," Gumbs said. "I was 31 cms short of my opener last year and to see that I could do that on a fatigued body, it says that I have gotten stronger and I've gotten technically better, so I'm just excited to see how this season is going to play out."

Diamante was 9th in the Weight Throw with a 16.82m (55'2'4") inch heave and thanked God for getting through the meet healthy. "I feel like I had a good start, it's something I can definitely build from," he said of the Shot. "The Weight, it was a bit shaky technically. I have some stuff to fix but that's minor."

Northern Iowa Area Community College's

Bruce Huggins ran 7.33 seconds in the 60m and 23.91 in his 200m debut. "For my first indoor meet, I know I could do better in the next meet" he said.

South Dakota State Heptathlete A'Keela McMaster, ran 9.45 seconds in the Bison Cup 60m Hurdles; leapt 5.28m in the Long Jump for eight place and ran 26.13, for fourth in the 200m.

Eastern New Mexico's Alisha Hayde, contributed a second leg carry on her team's 4x4 Relay, that was 3rd in 4:25.66, in the Friday Night Kick Axe Open, in Arizona

# ABOLITION OF WORK PERMITS: AN EXAMPLE FOR REGIONAL INTEGRATION

It has been interesting to read the responses in Editorials and Opinions in some regional

media, concerning the decision by the two main political parties in Antigua and Barbuda to abolish work permits for nationals of Caribbean Community (CARICOM) countries and the Dominican Republic.

The significant thing in the Editorials and Opinions, is that while they have

freely expressed opinions on the decision made by the two main political parties in Antigua and Barbuda to deal with this long contentious issue in CARICOM, they have been silent on the attitude of governments and opposition political parties in other CARICOM countries. The exception to this has been the Editorials in the Jamaica Gleaner.

There is no question that the two political parties in Antigua and Barbuda have now put the cat among the pigeons in CARICOM. The decision of the Antigua and Barbuda Labour Party (ABLP) and the United Progressive Party (UPP) to liberalise the system by which CARICOM nationals migrate to, and work in, Antigua and Barbuda, raises questions about how far other members of the Caribbean Community are prepared to go to realise the purposes of the CARCOM Treaty.

The Constitution of Antigua and Barbuda allows its nationals to bestow citizenship on their grandchildren wherever they are born. Many of those grandchildren from the Dominican Republic took advantage of this Constitutional right to migrate to Antigua and Barbuda. This situation - unique to Antigua and Barbuda – is not relevant to CARICOM. Therefore, it is not discussed here.

When the Revised CARICOM Treaty was signed in 2001, it committed all the Governments who were its ultimate signatories "to the goal of free movement of their nationals within the Community". The governments raised the expectation that their people would be able to travel to each country freely; that they would have a single currency; and that there would be no duties and tariffs on goods moving

from one country to the other. That was why the notion of a CARICOM Single Market and Economy (CSME) was born – the nations of CARICOM would become one community and one market. The exception was The Bahamas, which does not participate in the group's single market and economy arrangements.

Throughout the existence of CARICOM, preceding the signing of the Revised Treaty

in 2001, it member states have had a chequered history regarding the acceptance of the movement of people between them. The exemplary country, during its previous economic heyday up to 1973, was Guyana, which welcomed Caribbean migrants from the region – a welcome that was taken

up by many from Dominica, St. Lucia and St. Vincent who, among other things, became farmers in Guyana's productive agricultural hinterland.

Now with its wealth in oil and gas, Guyana has once again become a magnet for Caribbean migrants and businessmen. This time it is nationals of Jamaica, Barbados and Trinidad and Tobago who are flocking to Guyana - not only ordinary people, looking for work but businessmen seeking to profit from selling goods and services.

But in the lean economic times of Guyana, when imports had to be restricted to preserve scarce foreign exchange, and the value of its currency slumped dramatically, Guyanese had a forbidding experience when they migrated to other CARICOM countries to find work. There were special benches for Guyanese immigrants at the Airports in Barbados and Trinidad and Tobago on which they endured confined circumstances before being deported.

Let it be said that the Prime Minister of St. Vincent and the Grenadines, Ralph Gonsalves, the late Barbados Prime Minister, Owen Arthur and the present Prime Minister, Mia Mottley were the three leaders who constantly stood up for the principles of movement of nationals within the Caribbean community.

However, Antigua and Barbuda was one of the few countries in CARICOM where Caribbean migration, while not without its restrictions, was far more tolerant. The reason was consistent commitment to Caribbean integration by its leadership, particularly Sir Vere Cornwall Bird, Sir Lester Bird and now

Sir Vere was one of the founders of the West Indian labour movement for independence from Britain, dating back to 1947. He conceived of West Indian independence from Britain in the context of a West Indian Federation with all the freedoms and rights for the people that such a federation offered. He saw the West Indian people as one, and was deeply disappointed at its collapse, triggered by a referendum in Jamaica. In the referendum campaign, ironically, one of the arguments used against the Federation was that "Jamaica would be overrun by the small islanders". Today, it is Jamaicans that are heading to the small islands.

For his part, Sir Lester, while upholding the objectives of CARICOM, was a founder of the Organization of Eastern Caribbean States (OECS) and was a strong and influential voice for the maintenance by its 6 independent member states of one currency, one central bank, one judiciary, one civil aviation authority and one economic space. The complete freedom of movement of nationals within the OECS today is due, in large part, to the leadership given by Antigua and Barbuda. Sir Lester saw the OECS as a successful model of regional integration that CARICOM should emulate.

For all these reasons, Antigua and Barbuda, opened its doors to migration from CARICOM countries. Today it hosts people in relatively large numbers from Dominica, Guyana, Jamaica, Montserrat, and St. Vincent and the Grenadines. Many of those people have become nationals of Antigua and Barbuda and their children are born Antiguan and Barbudan.

One of the lessons for the rest of CARICOM, is that migrants have brought value to development. Caribbean migrants in Antigua and Barbuda have contributed towards the transfer of skills and knowledge, and they endeavoured alongside native Antiguans and Barbudans to achieve development from which all benefitted. This is reflected in Antigua and Barbuda's steady economic growth which reached 8.3% in 2022, second only to Guyana with its new wealth in oil and gas

The decision by the political parties in Antigua and Barbuda gives testimony to the part that freedom of movement of CARICOM nationals can and does play in attaining regional and national development objectives. It is a big leap forward, and an example to the region.

## US Starts 'Extraordinary Measures' to Avert Debt Ceiling Breach

WASHINGTON —

The U.S. has begun taking "extraordinary measures" to avoid spending that would breach the country's \$31.4 trillion debt ceiling, Treasury Secretary Janet Yellen told lawmakers Thursday, touching off a Washington debate on how to avoid a default on the government's financial obligations and calamity for the global economy.

The Treasury chief said she has started to suspend investments in the Civil Service retirement fund for government workers and a retiree health plan for postal workers that weren't immediately needed to pay beneficiaries but warned those measures were only a stopgap until June 5.

Yellen told key congressional leaders they need to increase the government's debt ceiling, which has been done 78 times since 1960 — or, less likely — do away with any spending limit, which is the practice in most countries throughout the world.

The U.S. government routinely fails to balance its annual budget, often spending \$1 trillion or more than it collects in taxes, and then reaches its debt ceiling set by Congress and agreed to by sitting presidents.

The U.S. has never defaulted on its worldwide financial commitments, such as to China, Japan and other countries that have bought its debt, or on obligations to some taxpayers, such as pension and health care payments to older Americans. But the political debate in the U.S. over increasing the debt limit to make payments on spending already approved by Congress and a succession of presidents has often intertwined with heated discussions over future spending, leading to a standoff as spending approaches the debt ceiling.

Once such stalemate occurred in 2011, when Democratic President Barack Obama eventually reached agreement with Republican congressional opponents to increase the debt ceiling while also curbing spending for much of the past decade.

Now, the newly empowered but narrow Republican majority in the House of Representatives is similarly calling for future spending cuts to keep 2024 discretionary federal spending for government agencies at 2022 levels.

House Speaker Kevin McCarthy told reporters this week, "I don't see why you would continue the past behavior."

But the White House is balking and instead demanding a "clean vote" on increasing the federal debt ceiling that is not linked to new spending totals. President Joe Biden said he will not curb pension and health care assistance for older Americans.

"Americans have every right to expect that Congress will come together as they have dozens and dozens and dozens of times before in a bipartisan fashion to make sure we keep the American economy on this stable path," White House spokeswoman Olivia Dalton told reporters aboard Air Force One as they accompanied Biden to California to view storm damage in the state.

No negotiations have been held with congressional leaders.



# CARICOM ELECTION OBSERVATION MISSION TO THE ANTIGUA AND BARBUDA GENERAL ELECTIONS

18 JANUARY 2023

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana -Thursday, January 2023): The seven (7) CARICOM member Election Observation Mission (CEOM) which was mounted by the Caribbean Community, at the invitation of the Government of Antigua and Barbuda, observed the General Election on 18 January 2023. The CEOM visited 184 of 188 polling stations across 16 constituencies in Antigua. Due to logistical challenges polling stations in Barbuda were not visited. The Mission monitored the Election Day activities by observing the opening of the poll, the voting process,

In all stations observed, indications are that polling stations opened on time and voting started promptly at 6:00 a.m. It was observed that all polling stations were fully staffed, and that the two (2) major political parties each had political agents present at all locations. Most polling stations were conveniently located and generally accessible to the electorate including the disabled.

the closing of the poll, the

transporting of ballot boxes

and the counting of ballots.

The CEOM observed that all materials and supplies needed were present in quantities. the required Adequate security was in place at locations observed. The officers displayed professionalism in the maintenance of law and order which contributed to the level of calm that accompanied the day's activities. The Mission observed that prior to the opening of polls, many voters were eagerly waiting to cast their vote. Throughout the day, the polling staff remained focused as they steadily carried out the required procedures, ensuring that eligible voters who turned out were able to cast their vote.

The CEOM also observed that transportation of ballot boxes from the polling stations to the counting stations was done with adequate security, in the presence of party agents. In all stations observed, Returning Officers commenced counting of ballots promptly, arrival of the ballot boxes. The count of ballots was done transparently and professionally the in presence of party agents.

While the conduct of the election is highly commendable, stakeholders, including the main opposition party, with whom the Mission met, raised concerns about the delay in the publication of the register of elections, therefore they had no opportunity to put forward claims and objections. The Electoral Commission informed the CEOM that the date for the publication of the register was calculated based on the advice of legal counsel and, in its view, the calculation is correct.

The CEOM was made aware that in 2021, persons were appointed to the Constituencies Boundaries Commission to address the disparity in the number of electors in the constituencies.

PRELIMINARY STATEMENT

While the Mission applauds the effort to address this disparity, there is urgent need to ensure that this exercise is not delayed any further, as completion is extremely necessary prior to the next general election.

Stakeholders raised concerns about the lack of accountability and transparency regarding campaign financing regulations. This is indicative of the need for a framework to be put in place to deal with the issue of campaign financing.

The Mission's assessment of the Election Day's activities is that the voters were able to cast their ballots without intimidation and that the General Election was free and fair, and the outcome reflects the will of the people of Antigua and Barbuda.

The Mission will prepare a detailed report for submission to Her Excellency, Dr. Carla Barnett, Secretary-General of the Caribbean Community (CARICOM). This report will include recommunity include recommunity for strengthening the electoral process in Antigua and Barbuda.

The Mission wishes to congratulate the staff of the Electoral Commission, the Poll Workers, the Candidates and the Security Forces for the mature way in which the elections were conducted.

The level of discipline displayed throughout the entire process is highly commendable.

The CARICOM Election Observation Mission wishes to thank the Leaders of the Political Parties, Independent Candidates, Civil Society Groups, Media and the wonderful people of Antigua and Barbuda for their warm hospitality and cooperation which no doubt contributed to the success of the Mission.
