SKELTON-CLINE GOVT CONTRACTS EXAMINED BY AUDITOR GENERAL

The investigation into government contracts and dealings with political consultant Claude Skelton-Cline, which is one of the most anticipated Audit reports following the Commission of Inquiry (COI) has been completed. This announcement was made by the Director of the Commission of Inquiry Implementation Unit, Hadassah Ward on 19 January.

In that recent update, Ward advised the public that the Commission of Inquiry Implementation Unit reported to the Governor and Premier on the status of work completed up to the end of December 2022. Among the listed completed tasks was the mention of the "Claude Skelton-Cline Government contracts "Auditor General report which was submitted.

The announcement of the report suggests that the document is in the process of the prescribed delivery as stipulated in Section 20 of the Audit Act No 13 of 2003. This Act states that the report must be first submitted to the Governor before being sent to the House of Assembly. According to Section 20 (2) of the Audit Act, "the Governor shall, within three months of receipt of a Special Report from the Auditor General, cause the report to be laid before the Legislative Council (House of Assembly)."

The matter of the Claude Skelton-Cline government contracts was a very sensitive topic; and the wait is now on -- for the report to make its way to the House of Assembly and be made public. An insight into some of the allegations against Skelton Cline who over the years has received multiple government contracts was gleaned during the 2021 COI hearings. The disclosures during the COI interview of Skelton-Cline on 4 October 2021 caused a public outcry as it was emphasized that there was scanty sign of results regarding the contracts that he was awarded.

COI COMMISSIONER CALLED FOR SKELTON-CLINE INVESTIGATION

Under Recommendation B22, Commissioner of Inquiry Sir



Gary Hickinbottom requested an audit and possible criminal investigations into Skelton-Cline contracts in order to determine if he delivered value for money.

The Commissioner said: "In respect of the government contracts with Claude Skelton Cline since 2019, I recommend that, as soon as practical, a full audit of these contracts be performed by the Auditor General

or some other independent person or body instructed by her, and a report on that audit be presented to the Governor."

Sir Gary Hickinbottom pointed out that the terms of that exercise should include consideration of the evidenced work done by Skelton-Cline under these contracts, the contractual obligations of Skelton-Cline under these contracts, and any mismatch between those obligations and the work done, to the extent that he was not performing his contractual obligations. Sir Hickinbottom said that the investigation should consider the circumstances in which Skelton-Cline was paid out of the public purse, and whether the contracts provided value for money.

"Unless in the meantime the relevant BVI authorities consider otherwise, further steps including any criminal investigation and steps to recover public money (including recovery from any public official who has acted improperly) can await the outcome of that audit," the Commissioner added.

From the onset of the hearing, Skelton-Cline objected to being part of the Inquiry. He announced that the COI was to investigate governance and matters of government and not private citizens. Skelton-Cline who received the contracts as a government Consultant also rejected the Auditor General's report on which the COI relied.

Skelton-Cline told Commissioner of Inquiry Sir Gary Hickinbottom: "I am the only private citizen in a private capacity that you have summoned to this COI. I question that because it is too glaring to ignore, which leads me to a conclusion because it feels like targeting and victimization to me in my private capacity as a private citizen."

However, there was not sympathy from Sir Hickinbottom who responded to the concern stating: "You are not the only private citizen;

and secondly, the evidence that I need to take properly to investigate governance and serious dishonesty in public office is a matter for me. The focus is on governance... It will remain on governance. But at the moment there are serious suggestions in the evidence of really, really poor governance, and some of those suggestions relate to matters in which you have become--in which you have been involved, and I need to drill into those matters, and you can help me do that."

Skelton-Cline also questioned the veracity of the COI and Public Accounts Committee reports which were relied upon heavily by the COI team. In noting his disapproval of these two documents Skelton-Cline said: "the Auditor General's Report and the Public Accounts Committee's Report, are wrong on so many -- and in so many ways with some of the things that have been said because it's a conflating, a confusion of this whole process and what took place."

ISSUES FLAGGED DURING **COI HEARING**

The concerns surrounding the Skelton-Cline contracts sandwiched three administrations. The VIP 2008-2011 administrations Neighbourhood Partnership contracts; the NDP 2011-2015 Tortola Pier Park Consultation, and the VIP 2019 to present multiple Advisory contracts.

As it relates to the first VIP arrangement it was noted the first contract was received in 2008. It was noted that the Auditor General's Report on the Virgin Islands Neighborhood Partnership Project shows that "Claude Ottley Consulting Limited received \$696,800 through four consultancy contracts between October 2008 and December 2010. It was explained that the purpose of the Neighbourhood Partnership programme was to "establish a Neighborhood Partnership between key stakeholders of the communities such as churches, schools, parents and organisations, to work for the common good of the youth and to guide them in a holistic wholesome approach to life".

It was noted that the Project operated centers. During the COI it was noted that the Auditor General's team received feedback from the various centers. In relation to Virgin Gorda, the feedback received from church leaders indicated that financial and other support needed to make the programme viable

was not received. Further the COI report indicated instances of the programme funds being used for unspecified purposes.

As it relates to the Tortola Pier Park project the COI questioned why Skelton-Cline was selected for the job; and what made him the most qualified person for the task. In response the government Consultant said: "My experience is in leadership, and that was the reason for me being engaged. My leadership skills to mobilise, marshal people, manage things to make it happen. That's where my skill set is, and that's why I was engaged."

The final concern related to the contracts Skelton-Cline's company Grace Consulting received from the Andrew Fahie administration. The first of those contracts -, it was disclosed - was intended to be for a six-month period running from 14 March 2019 to 17 of September 2019. With additional contract extensions.

Public perception of those contracts was that it was repayment for Skelton-Cline's assistance in getting the government elected. However, this notion was disputed by Skelton-Cline when he appeared before the COI. In his denial of such a suggestion the Consultation said: "If the suggestion is, Mr Commissioner, that somehow the contract was a political favor, then I would have to say very quickly again, you know, there is a certain skill that Claude Skelton-Cline has that God has gifted me with. One reason or another, it is sought out and has been particularly by governments for the purposes of which we speak because Grace and I do other things."

The series of contracts were given specific areas of focus which included climate change, renewable energy; jobs programme; youth empowerment; telecommunications; and Prospect Reef. The Agreement with Skelton-Cline asked that he devote sufficient time and attention to the performance of service under this Agreement; and to ensure that all milestones and deliverables are met in the manner and by the dates

During COI hearing the deliverables and milestones of the focus areas were examined and among other things it was noted that a number of projects Skelton-Cline submitted documents and reports were completed by third parties as part of his deliverability.

CANNABIS LICENSING MAKES SOME PROGRESS

Premier and Minister for Finance Dr. the Hon. Natalio Wheatley is pleased that the United Kingdom government has shown interest in moving the Cannabis Licensing Act forward.

In July 2020 the House of Assembly passed the Cannabis Licensing Act which the Government said could result in earning the Territory millions of dollars. However, former Governor Augustus Jaspert made a decision to forward the Bill to the FCO for review rather than assent to it.

This has resulted in the document being in a sort of limbo and attracted repeated requests for its assent from various members of the House of Assembly.

While delivering the first substantive update on the Cannabis Licensing matter, the Premier who recently returned from a United Kingdom visit announced during his press briefing on 23 January that conversation on the matter took place during his visit to the UK.

Hon. Wheatley disclosed that he "was also very pleased that the UK Foreign, Commonwealth and Development Office and UK Home Office had very good discussions with my delegation on medicinal cannabis."

While it was not stated that the Bill would be assented in the near future by His Excellency Governor John Rankin, the Premier pointed out that advancement of Cannabis Licensing will result in patients being able to use medicinal cannabis for

said: "We have found a way forward on this aspect of medicinal cannabis, and are proceeding to put the necessary regime in place for approval. I am grateful to the UK Government for their support in this area."

The UK support in putting the necessary regime in place seems to be a follow up on the arrangement that was announced by His Excellency Governor John Rankin in April 2021. At that time the King's Representative said that his office is interested

their healing. The Premier in working with the government to promote what is best for the Territory and he mentioned that this is an area that requires collaboration. "I am keen to encourage effective conversation between development agencies here and their opposite numbers in the UK so we can make sure those regulations and licensing arrangements are in place. I certainly hope we can make progress in that area," the Governor noted.

PARAQUITA FARMLANDS SQUATTERS TO BE REMOVED

removed, absolutely," Premier Natalio Wheatley declared during a press conference on 23 January in response to disclosures that expatriates were living on the farmlands at Paraquita.

The Premier said that the matter of the squatters came to his attention and steps are being taken to remove them from the land and have the land remain for farming only. Hon. Wheatley told reporters that in a recent conversation with persons from the Ministry and Department of Agriculture he asked that the matter be dealt with.

Hon. Wheatley said: "One of the tasks I gave them was being able to

"They have to be come up with standard leases. For everybody who on Paraquita Bay, and everybody who has a standard lease for the land they have to adhere to the conditions of that lease. One of those conditions is that it has to be used for agricultural purposes. No squatting, whatsoever, will be tolerated."

> The Premier who said that he would have wanted the situation rectified urgently noted that there was a lag in fixing the matter. He noted: "The PS (Permanent Secretary) is here and she can tell you oftentimes I am pulling out air, air ... wondering why it can't go more guickly. We had a meeting, I think it was about two weeks ago, and they updated me on their

progress and I made it clear under no uncertain terms that I need that standard lease and I need everybody who is on Paraguita Bay to be on a lease."

"We have to be accountable how we use the precious resource of land, especially given the fact that we have a scarcity of flatland in the Virgin Islands and food security is a priority for us," the Premier added.

During the Standing Finance Committee sitting Leader of the Opposition and Representative for the Third District, Hon, Julian Fraser disclosed that the land at Paraquita Bay was subdivided to allow farmers to get plots of land to farm. However, he said that to his understanding

the plots of land have been transformed into living quarters in some instances.

Hon. Fraser stated that he does not know what course of action needed to be taken but something ought to be done.

While commenting on the matter Director of Agriculture and Fisheries, Theodore James stated that from his perspective, there were buildings that were approved to be built and were later destroyed. He stated that persons have sheds on the lots.

Hon. Fraser told the Committee: "The notion is that there are a lot of nonlocal persons who took up residence. However, locals are allowing persons to occupy the land."



STATEMENT BY PREMIER AND MINISTER OF FINANCE DR. THE HONOURABLE NATALIO D. WHEATLEY ONE-ON-ONE PRESS BRIEFING WITH UPDATES ON HIS RECENT OFFICIAL VISIT TO THE UNITED KINGDOM

JANUARY 23, 2023 Members of the Press Corps Ladies and gentlemen People of the Virgin Islands

A pleasant good morning. I am pleased to have another press conference to keep the public informed. My update today is on my official visit to the United Kingdom which concluded yesterday.

First, however, I would like to extend my deepest condolences to the families of the two men, Vincent Huggins and Seddy Callwood, who lost their lives, as well as the wider Jost Van Dyke community.

I know that you are hurting right now, and I pray that God will ease your pain in time. I want to encourage everyone to be as vigilant as possible when driving on our roads. Let us pray that we do not see more car accidents and loss of life in our beloved Virgin Islands.

Turning to my official visit to the UK, I am pleased to report that my delegation and I had a successful week of meetings and engagements to advance the economic, political and environmental interests of the Territory.

Let me say at the outset that I initiated this visit. I was not asked to come to London by the new Overseas Territories Minister Lord Goldsmith. In fact, I requested the meeting with Lord Goldsmith, because it is important that the Virgin Island and United Kingdom remain politically engaged on various issues of interest and concern to us. That is what is means to be in a mature partnership. You talk and engage.

I was very pleased to have a bilateral meeting with Lord Goldsmith. Our discussion was constructive, warm and frank. I very much appreciated his great interest in the sustainable development of the BVI. He was very keen on tapping UK support to assist the BVI's efforts to both conserve and sustainably use the marine environment. He also pledged to provide as much UK technical assistance as possible to assist us with continuing the work of reform.

I did raise the concern about the Order in Council currently being held in reserve.

The Minister agreed that we would have a dedicated discussion on this in the very near future. While that issue needs to be resolved, I felt Lord Goldsmith was genuine about wanting a stronger partnership between the UK and BVI that fairly considers the interests of both sides. I am aware that he will travel to the Territory in a few weeks' time and I look forward to seeing him again.

I was also very pleased that the UK Foreign, Commonwealth and Development Office and UK Home Office had very good discussions with my delegation on medicinal cannabis, particularly with respect to the licencing of medical practitioners in the Virgin Islands to administer medicinal cannabis to patients. We have found a way forward on this aspect of medicinal cannabis, and are proceeding to put the necessary regime in place for approvals. I am grateful to the UK Government for their support in this area.

In terms of the UK Parliament, we had very successful engagement with UK Parliamentarians. A reception at parliament was graciously hosted by Mr. James Sunderland MP, who serves as the Chair of the BVI All Party Parliamentary Group. My delegation and I interacted with many parliamentarians who have a very keen interest in the BVI. Many of them genuinely want to see the UK be as supportive as possible to the Overseas Territories. I got very good insight and advice on issues of interest to us, and I believe we are making progress in improving the view of the Virgin Islands in that political institution.

I also had a very good bilateral meeting with the Shadow Overseas Territories Minister Mr. Stephen Doughty. He explained the views of the Labour Party on the Overseas Territories. I gave him a clear understanding of the Virgin Islands' economic, political and environmental priorities. He pledged to take these into account in future debates in the House of Commons and in discussions within the Labour Party.

Of course, I was very pleased to have a bilateral meeting with the Speaker of the House of Commons The Honourable Lindsay Hoyle. The Speaker is a champion of the Virgin Islands and Overseas Territories and was very gracious with his time. We had an excellent discussion on how the Register of Interests works in the UK Parliament. He also provided other very helpful insights that I will discuss with my colleagues in the House of Assembly.

On the economic front, my delegation and I had a very productive roundtable discussion with the financial services industry in the UK. The industry was represented by those firms who also operate out of the Virgin Islands. We were able to update them on legislative developments and plans for the year ahead. The feedback was very good, and together we are committed to ensuring the jurisdiction remains competitive.

I also attended a business roundtable with the Caribbean Council to gauge interests in investment in the Virgin Islands in the tourism sector and our airport expansion. I was also able to talk with some of our existing suppliers of certain goods and services. There is keen interest in the Virgin Islands economy and an appetite to invest. My team will be following up with our business partners and those with an interest in investing to help my move our economy forward.

In terms of environmental partnerships, I had an excellent visit to Southampton where I signed a Memorandum of Understanding between the University of Southampton and the Virgin Islands. This is an excellent partnership that will assist the Virgin Islands in researching and documenting our environment and finding solutions to problems such as climate change. The blue economy will also be a major focus.

I also attended a meeting with one of our existing partners: the National Oceanographic Center. They presented to me the progress being made on their work in mapping our marine environment. We will soon better know what these assets are, and how they can be leveraged to help address the climate problem, particularly using carbon markets that will be beneficial to us in the Virgin Islands.

In terms of our educational and cultural cooperation, my delegation and I also visited Hertfordshire County Council, with

whom we also have an MOU. We discussed cultural and academic exchange, and cooperation in relation to tourism. We will be following up on this very soon.

Regarding engagement with Virgin Islanders in the UK, I was very happy to virtually engage with our students and citizens who attended a townhall and luncheon at BVI House. Fortunately, Permanent Secretary Mrs. Carolyn Stoutt-Igwe and I were able to participate once our hotel in Antigua and Barbuda was available. We were unable to travel to London due to technical difficulties with our flight that grounded the plane. I listened to the students concerns and responded to them, and also updated them on matters at home. I was very pleased that by the end of the townhall, three students had been paired with Government agencies for summer internships.

Finally, it was my pleasure to celebrate the 20th anniversary of the BVI London Office at the annual Premier's reception. Many of our friends and supporters were present for the occasion, as well as members of the diplomatic corps in London.

I would like to thank my entire delegation and BVI London Office for their support in making my official visit a success.

Premier's Meetings And Engagements With UK Officials A Success

Premier and Minister of Finance, Dr. the Honourable Natalio D. Wheatley has stated that the past week of meetings and engagements in the United Kingdom were successful in the advancement of the economic, political and environmental interests of the Territory.

Premier Wheatley led a delegation to London, United Kingdom to promote the socio-economic and political interests of the Virgin Islands between January 14 and 22.

During his official visit, the Premier and his delegation engaged in bilateral political meetings with Overseas Territories Minister Lord Zac Goldsmith which he said generated productive and constructive results.

"I very much appreciated his great interest in the sustainable development of the BVI. He was very keen on tapping UK support to assist the BVI's efforts to both conserve and sustainably use the marine environment. He also pledged to provide as much UK technical assistance as possible to assist us with continuing the work of reform," Premier Wheatley reported.

Lord Goldsmith is scheduled to travel to the Virgin Islands in

a few weeks to further discuss the Order in Council, which is currently held in reserve.

Wheatley Premier stated that progress in relation to the use of medicinal cannabis was achieved through positive discussions with United Kingdom Foreign, Commonwealth and Development and United Kingdom Home. These discussions specifically underscored the licencing of medical practitioners in the Virgin Islands to administer medicinal cannabis to patients.

Tax-Payers At The Heart Of New System

The Inland Revenue Department is seeking to improve its database to allow taxpayers greater access and flexibility.

The department in collaboration with the Department of Information Technology is preparing the Standard Integrated Government Tax Administration System – SIGTAS 3.0 to go live in March 2023, to facilitate the submission of online payments via the Government e-payment gateway. The new system will also automate the administration of all taxes and licenses.

Commissioner of the Inland Revenue Department Mrs. Karen Smith-Aaron recently revealed that taxpayers will be able to submit registration forms online, print registration certificates, make queries about accounts, check unfiled tax periods, follow the status of pending requests, and communicate easily with the tax administration through an embedded messaging centre.

Mrs. Smith-Aaron said, "Taxpayers are at the heart of the new system. They are now empowered to view their tax information."

The commissioner said in order to facilitate this upgrade, all residents of employable age are required to be registered. She said members of the public must provide either a valid passport or driver's license along with their Social Security Card, and an email address to ensure that registration is successful.

Mrs. Smith-Aaron said the Inland Revenue Department is "committed to assessing the taxes, licences and fees due to the Government of the Virgin Islands while applying the tax laws with fairness and integrity, and in an atmosphere of mutual respect."

The Inland Revenue Department strives to maintain compliance according to local and international standards, while fostering the economic and social well-being of the Virgin Islands.





Only 16 per cent of Caribbean countries and territories have made progress in developing Dementia National Plan, most of which have inadequate funding. Montserrat, Puerto Rico, Saint Kitts and Nevis, Saint Martin, Saint Barthelemy, Saint Lucia, Saint Vincent and the Grenadines, Sint Maarten, Suriname, Trinidad and Tobago, Turks and Caicos Islands, and United States Virgin Islands.

"Access to support and a care plan, including care at home and in community settings, athome adaptations, and respite for carers, alongside medical treatments, are vital for people living with dementia, as well as their carers and family."

"By denying the British Virgin Islands and those across the region this support, governments are doing a disservice to their communities," says Barbarino. "All people living with dementia in the Caribbean deserve access to the kinds of support and services a National Dementia

Plan makes available. It's their human right." As the world's population gets older, the prevalence of Alzheimer's disease and dementia is rapidly increasing, threatening to overwhelm health services in many countries. In 2019, dementia was ranked the 3rd leading cause of death in the Americas, accounting for over

390,000 deaths. ADI is calling on people living in Caribbean countries participating in the #WhatsYourPlan campaign to urge their governments to develop a National Dementia Plan that features, improvements in care for those living with dementia, support for carers and to implement key policies to help delay or reduce up to 40 per cent of the possible number of cases of dementia in the future.

"We're talking with the various Ministries of Health, Age & Social Support in many Caribbean countries, and while in some cases it can lead to progress it is often too slow. For a condition like dementia, time is of the absolute essence. People cannot wait," says Paola Barbarino.

"We need people from all over the Caribbean to speak up for people with dementia so that their governments might actually listen and act."

Empty promises and blunt tools: Lack of funding stalling progress in the CaribbeanWhile some progress has been made in developing National Dementia Plans in the Caribbean, Paola Barbarino, ADI Chief Executive Officer, says that a lack of funding for these plans means many communities are missing out.

"A National Dementia Plan is a government's best tool for preparing for this looming global health crisis," says Barbarino. "Despite some progress to develop plans in a few Caribbean nations, without adequate funding to implement them, these plans are laying unused on the desks of bureaucracy across the region - more empty promises, and blunt tools." "Continued inaction now will lead to much greater health, care and societal challenges in

managing dementia later," continues Barbarino. "Governments must have robust dementia strategies funded and in place, to save healthcare systems from being overwhelmed as dementia cases rise in the future."

Over 740,000 people: While progress stalls, the number of people in the Caribbean living with dementia continues to soar

The latest estimates show that there will be over 740,000 people living with dementia in the Caribbean by 2050. However, it's not possible to obtain the true number of people living with dementia in the British Virgin Islands currently, as it is not measured by the government; an issue which would be ameliorated by a National Dementia Plan.

Research has found that the greatest risk factors for dementia in the Caribbean include Cardiovascular health, diabetes, family history, older age, education. Further, women with lower levels of education in rural areas are overrepresented in dementia statistics in the

Caribbean.Risk reduction should be designed with a life-course approach in mind, targeting both older and younger populations, with a focus on the modifiable 12 risk factors estimated to contribute to 40 per cent of the cases of those living with dementia.

LONDON - On February 1st Britain will experience something close to a 21st-century general strike. Hundreds of thousands of teachers, university lecturers and civil servants will stop work, together with the railway workers whose industrial action has already paralysed the network for weeks. Five days later, nurses will begin a two-day shutdown, while the strike calendar for ambulance workers stretches well into March.

This is not a French-style, politicised mass movement. Union leaders are forbidden by law from co-ordinating action, while the Conservative government's new anti-strike law will force public-service workers to guarantee minimum service levels. But to borrow from Galileo, eppur si muove (and yet it moves).

This sudden upsurge of union militancy is partly down to double-digit inflation. Real-terms pay for junior doctors, for example, is 26 per cent below its 2009 level. Nurses' real wages are 8 per cent below where they were in 2010. The Universities and Colleges Union calculates that lecturers' pay is down 20 per cent since 2009.

But that is combined with a strategic skills shortage: everything from the railways to accident-andemergency units relies on voluntary overtime or agency staff. And staff shortages are acute not just because of 'Brexit'—which has choked off the supply of skilled and unskilled workers from mainland Europe—but because public- and private-sector pay have rapidly diverged. [Social Europe]

ROME- Several Italian regions have been put on alert due to a wave of extreme weather in Italy, with many part of the country hit by freezing cold, torrential rain or snow and powerful winds.

Marche and parts of Emilia Romagna have been put on orange alert by the civil protection department, which is one notch down from the maximum red alert and means the weather poses a danger to people and property.

Abruzzo, Basilicata, Campania, Umbria and other parts of Emilia Romagna were on yellow alert.

Schools were closed on Monday due to the weather in the southern city of Potenza and in areas of the northern provinces of Rimini and Modena.

A homeless man who was found dead in Milan at the weekend is thought to have been killed by the cold. (ANSA).

BRAZIL - Brazil and Argentina aim for greater economic integration, including the development of a common currency, Brazilian President Luiz Inácio Lula da Silva and Argentine leader Alberto Fernandez said in a joint article they penned.

"We intend to overcome the barriers to our exchanges, simplify and modernize the rules and encourage the use of local currencies," says the text published on the Argentine website Perfil.

"We also decided to advance discussions on a common South American currency that can be used for both financial and commercial flows, reducing costs operations and our external vulnerability," the article said.

Earlier in the day, the Financial Times reported the neighboring nations will announce this week that they are starting preparatory work on a common currency. The plan, set to be discussed at a summit in Buenos Aires this week, will focus on how a new currency which Brazil suggests calling the "sur" (south) could boost regional trade and reduce reliance on the US dollar, FT reported citing officials. [El Pais]

BRAZIL - The highest authorities of the Republic of Brazil were summoned by the newly-inaugurated president, Luiz Inácio Lula da Silva – popularly known as "Lula" – this past Monday. The subsequent high-level meeting took place only 24 hours after a mob of rioters assaulted the government institutions in Brasilia. The violent protestors were supporters of Jair Bolsonaro, 67, who narrowly lost his re-election bid to Lula in October 2022.

The 77-year-old president – who previously governed Brazil from

2003 until 2010 – convened the session at the Planalto Palace, the official workplace of the presidency. Attendees included Supreme Court President Rosa Weber, President of the Chamber of Deputies Arthur Lira and Senate President Rodrigo Pacheco. Defense Minister José Múcio and the recently-appointed heads of the Armed Forces were also summoned.

Lira – despite being a supporter of Bolsonaro – joined the unanimous condemnation of the assault by the highest representatives of the country's democratic institutions.

After the meeting, the leaders of the three branches of government released a joint statement, condemning the "terrorism, vandalism and criminal acts" committed on Sunday. The storming of key government buildings was described as an "attempted coup."

Ibaneis Rocha – the governor of the Federal District – has been suspended from office for three months by the Supreme Court, for not having done enough to stop the extremists from storming the headquarters of the country's democratic institutions.

On Monday afternoon, Lula also met with the governors of Brazil's 26 states, after speaking by phone with the prime minister of Portugal, António Costa, and with US president Joe Biden, who invited him to visit the White House at the beginning of February. The Brazilian president has accepted, according to a note from his team.

President Biden has expressed the "unconditional support of the United States to Brazilian democracy and to the will expressed by the people in the last elections, which Lula won."

On the ninth day of his new term, Lula is facing the most serious threat to Brazilian democracy since the end of the military dictatorship in 1985. [El Pais]


BERMUDA - Customs officers will be recognised for their crucial work as border organisations around the world prepare for International Customs Day.

Events started yesterday with a virtual church service to honour fallen customs officers in Bermuda.


Tomorrow will see several customs officers attend Port Royal Primary School in Southampton to entertain and educate pupils and staff about the role that they play.

Top Uses for Pasta Sauce Besides Pasta

You know those inexpensive pasta sauces? While they're indispensable for making quick spaghetti dinners, these sauces are useful for so much more than pasta. Here are several ideas that think outside the pasta box. Not a noodle in sight.

Easy Creamy Tomato Soup -- In a saucepan, lightly saute 1/2 cup fresh basil (minced) in 1 tablespoon butter or olive oil. Add one (24-ounce) can of pasta sauce, 2 cups water and heat through. Remove from heat and stir in 1/2 cup heavy cream. Yields 4 servings. This soup told me it's lonely without its best friend. So please make a grilled cheese sandwich, too.

Sloppy Joes -- Brown 1 1/2 pounds ground beef with one (16-ounce) bag frozen pepper and onion blend. Add 2 cups pasta sauce, 2 tablespoons cider vinegar, 1 1/2 tablespoons Worcestershire sauce and 1 tablespoon brown sugar. Divide the mixture between 4 to 6 hamburger buns.

Tomato Butter -- In a food processor or mixing bowl with a hand mixer, blend 1 stick (1/2 cup) softened butter, 1/4 cup pasta sauce and 1/4 cup

chopped parsley or basil. Use plastic wrap to roll the compound butter into a log; refrigerate. Slather on fresh baked breads, fish, chicken, cooked vegetables or rice.

ITALIAN POT ROAST

Yield: 4 to 8 servings

Total Time: 2 to 3 hours, 15 minutes

Here's a great recipe for those times when you can linger in the kitchen and enjoy your home leisurely filling with the aroma of a slow-cooked roast.

What You'll Need:

- · 3 to 5 pounds chuck roast
- 1/4 cup flour
- 1 teaspoon each: salt, pepper, garlic powder
- · 2 tablespoons olive oil
- 1 onion, sliced (about 1 1/2 cups)
- 3 carrots, peeled and chopped (about 1 cup)
- 3 celery ribs, chopped (about 1 cup)
- · 4 6 cloves of garlic, minced
- 1 cup red wine
- 1 (24 ounce) can pasta sauce
- 1 (14.5 ounce) can Italian style diced tomatoes
- Mashed potatoes or polenta for serving, optional
- · Chopped parsley, optional garnish

Here's How:

In a small bowl, mix flour, salt, pepper and garlic powder. Sprinkle the flour mixture evenly over the roast. In a Dutch oven, heat the olive oil over medium-high heat. Add the meat and brown well on all sides. Remove to a plate and set aside.

Reduce heat to medium-low. Add the onions, carrots and celery and cook until softened, about 5 minutes. Add the garlic and continue cooking for another 2 minutes. Then add the wine, scraping all the lovely, browned bits off the bottom of the pan, and cook until it reduces a little, about 5 minutes. Add the pasta sauce and canned tomato and stir to combine. Then return the roast to the pot and cover. Turn the heat down to low and let it simmer gently for 2 to 3 hours, until fork tender.

When finished cooking, transfer the meat to a chopping board and let rest for about 10 minutes before slicing. If the sauce isn't thick enough for your liking, you can continue boiling over medium-high heat, uncovered, until it reduces enough to reach your desired thickness. Taste and adjust seasoning. Cut the roast into gorgeous big chunks and return to the sauce to serve.

Some of these recipes don't use the entire can of sauce. You can easily freeze extra sauce for future fun recipes by placing the sauce in ice cube trays or muffin tins, then freeze and store in plastic freezer bags.

So next time you're feeling a little saucy, remember life is about exploring all the pasta-bilities, even those beyond pasta.

POPE DECRIES VIOLENCE IN MYANMAR, PERU AND UKRAINE

Pope Francis has made an impassioned appeal for an end to the violence in Myanmar, also known as Burma, where a Catholic Church was destroyed.

Following his Sunday Angelus address to the faithful gathered in a frigid St. Peter's Square, the Pope expressed his sorrow for the tragic events taking place in Myanmar, recalling specifically the attacks on places of worship, including the recent arson and destruction

of the Catholic Church of Our Lady of the Assumption in Chan Thar, one of the oldest and most important places of worship in the country. The Pope said he is close to the civilian population, suffering greatly in many cities, and he prayed that the conflict may end soon and a new time may open up marked

by forgiveness, love and peace. He then invited all present in the Square to join him in praying a Hail Mary for Myanmar.

VIOLENCE IN MYANMAR

In the wake of the recent destruction of the church by the Burmese army, and other violence, the religious leaders in Myanmar, including Cardinal Charles Maung Bo of Yangon, launched a "passionate appeal for peace," urging that "all of us need to undertake the pilgrimage of peace." Since the 2021 military coup that overthrew the democratically elected government, the southeast Asian nation has suffered a series of political, social, and economic crises, and has descended into a spiral of violence since the 2021 military coup that overthrew the democratically elected government.

Thousands of people have subsequently been arrested

or killed without cause.

APPEALS FOR PERU, UKRAINE AND CAMEROON

The Pope also decried violence in Ukraine and Peru, while expressing his hope that steps toward peace can continue to come out of Cameroon.

Pope Francis said he was concerned about the critical situation in Peru, and called for dialogue and peaceful solutions to the crisis. The Pope united his voice with that of the Peruvian Bishops in saying,

"no to violence from wherever it comes!, no to death!"

In Peru, demonstrations continue to intensify in the South American nation's capital of Lima, as more protesters arrive from the Andean region demanding the resignation of the President and calling for immediate elections.

The Holy Father said to pray for the Latin

American country. The Pope also made another heartfelt appeal for peace in Ukraine, recalling the great pain suffered by the Ukrainian people, as the war continues to rage on, for almost an entire year. He prayed that the Lord may give them comfort and support. Lastly, the Pope turned his attention to Cameroon, where he noted positive developments that bring hopes for a resolution of the conflict in the anglophone regions.

He offered his encouragement to all involved in implementation of peace-seeking agreements to persevere in the way of dialogue and mutual understanding, as only in encountering one another can the future be built together.

Chalazions Continue to Develop in Both Eyelids

DEAR DR. ROACH: Are oral antibiotics ever prescribed to treat chalazions, in addition to eye drops and ointment? I have had two this year for seemingly no reason. They were treated with tobramycin eye drops, ointment and warm compresses. The first one didn't resolve with those meds and was excised surgically. That eyelid then became infected without a chalazion and was treated with a second round of antibiotic drops. It remains a bit puffy and pinkish in color, which I chalked up to the new normal appearance.

Now, a chalazion has developed in the other eyelid. I don't wear eye makeup and use an eyelid cleanser recommended by my ophthalmologist. I am an otherwise healthy 76-year-old woman. Could there be a systemic bacterial or viral infection causing chalazions to keep developing? — M.W.

ANSWER: The terms for different types of eyelid lesions can be a bit confusing. Most people are familiar with a stye, which is a localized inflammation of the upper or lower eyelid, most commonly caused by an infection of one of the glands of the external eye, usually by the bacteria Staphylococcus aureus. A stye is also called a hordeolum. An external hordeolum is in the eyelash follicle or the lid margin, whereas an internal hordeolum is inflammation in the meibomian glands, the ones that secrete mucous to help keep the eyes lubricated.

Makeup can block these glands and predispose someone to hordeola. Hordeola are treated with warm compresses and sometimes by an eye specialist, with thalmologist is necessary if it doesn't get better within one to two weeks. If the infection gets into the skin around the eye, it may need oral antibiotics.

A chalazion is not an infection. It's a usually painless rubbery mass in the eyelid. A chalazion can be a complication of a hordeolum, since the glands are blocked by inflammation, leading to thickened secretions from the gland. Since it's not an infection, neither oral nor topical eye antibiotics are useful. These also usually get better with warm compresses over weeks to months. People with recurrent chalazia should be considered for biopsy, since they can turn out to be tumors in rare circumstances.

DEAR DR. ROACH: I am a 72-year-old female with numerous health issues, including three types of epilepsy. About two years ago, I experienced watching my pillow turn into bubbles and ants marching across my bedroom ceiling. They remained there and did not join me in bed, thankfully. After some time, they went away — until this week. I am awake and alert when I see them, and it always happens at night. Due to a staphyloma, I only have vision in one eye. I was also born with cataracts and had those, along with

age-related ones, removed at age

69 and 70. I am wondering if these

visions I am experiencing could be

yet another form of epilepsy. - S.G. ANSWER: Although epilepsy can certainly cause visual hallucinations, they usually last only seconds and are not normally as complex as what you describe. Rather, I think this is more likely to be Charles Bonnet syndrome, which is associated with visual loss (that does not have to be complete). These visions are usually colored and may stay still or move, and hallucinations of animals and people are well-described. Moving the eyes toward and away from the hallucinations rapidly may suppress them. There are available medications to make them go away, which some people want and others do not.


conspiracies, subterfuge, and bad intentions, that in this observer's opinion is simply absurd.

Germany Confirms Plans to Ship Powerful Leopard 2 Tanks to Ukraine

WASHINGTON —

The United States and Germany are moving ahead with plans to supply Ukraine with highly advanced battle tanks to bolster its fight against the nearly one-year old Russian invasion.

A spokesman for German Prime Minister Olaf Scholz issued a statement Wednesday saying Berlin will provide 14 of its Leopard 2 tanks to Kyiv, the first step in establishing two battalions with the powerful tanks in Ukraine.

The statement said the tanks will come directly from Germany's military stocks. It also said that Ukrainian troops will soon begin training in Germany, and that Germany will also provide logistics and ammunition.

Prime Minister Scholz is expected to formally announce the decision during a parliamentary session later Wednesday.

Germany's decision comes hours before the administration of U.S. President Joe Biden is expected to announce that it will send M1 Abrams tanks to Ukraine. The decision, first reported Tuesday by The Wall Street Journal, is part of a diplomatic understanding with Germany over its donation of Leopard 2 tanks.

U.S. news outlets say the administration is considering sending a little more than 30 of the sophisticated tanks to the Ukrainian battlefield.

A U.S. official familiar with the deliberations told VOA on Tuesday the White House is working to finalize a plan to get Ukraine the coveted tanks, though it could be some time before Kyiv would be able

to take delivery and use them on the battlefield.

The official, who spoke on condition of anonymity because of the sensitive nature of the plans, said the tanks would likely be provided through the Pentagon's Ukraine Security Assistance Initiative (USAI). The fund allows the Defense Department to purchase weapons and systems either from defense manufacturers or from other sources, rather than draw them directly from U.S. stocks.

In this case, the official said the United States might seek to purchase the M1 Abrams tanks from other countries and refurbish them, before sending them to Ukraine.

British Prime Minister Rishi Sunak, who has pledged 14 of his country's Challenger 2 tanks to Ukraine, welcomed the news from the U.S. and Germany in a post on his official Twitter account Wednesday, calling it "the right decision by NATO allies and friends" which will "strengthen Ukraine's defensive firepower."

"Together, we are accelerating our efforts to ensure Ukraine wins this war and secures a lasting peace," Sunak wrote.

Russia: tanks will be 'destroyed'

But Anatoly Antonov, Russia's envoy to the United States, described the pending U.S. decision as "another blatant provocation against Russia" in remarks posted on the embassy's Facebook page.

"It is obvious that Washington is purposefully trying to inflict a strategic defeat on us," Antonov said, while vowing the American tanks "without any doubt will be destroyed as all other samples of NATO military equipment."

Russian government spokesman Dmitry Peskov dismissed the news as "a failed plan" during a telephone press briefing Wednesday. Peskov said the deployments of the U.S. and Germany tanks as an "overestimation" of its potential to help the Ukrainian army, and predicted the machines "will burn like all the rest."

US changes mind on M1

The move to provide Kyiv with the tanks would represent an about-face for U.S. officials, many of whom have dismissed the idea of sending Abrams tanks to Ukraine, warning that while Abrams tanks are very capable, they are difficult to maintain and require more fuel than Kyiv can spare.

"We should not be providing the Ukrainians systems they can't repair, they can't sustain, and that they, over the long term, can't afford, because it's not helpful," Under Secretary of Defense for Policy Colin Kahl told reporters last week.

Pentagon press secretary Brigadier General Patrick Ryder echoed those concerns Tuesday.

"Our focus has been on providing Ukraine with capabilities it can employ right now on the battlefield," he said. "The M1 [Abrams tank] is a complex weapon system that is challenging to maintain. ... That was true yesterday. It is true today. It will be true in the future."

The shift in the U.S. position on sending Ukraine the M1 Abrams tanks came as multiple German news outlets reported that Germany had decided to send some of its Leopard 2 tanks to Ukraine in addition to clearing the way for other countries to send their German-made Leopard tanks to Kyiv.

Earlier, following a meeting in Berlin, NATO Secretary-General Jens Stoltenberg welcomed Germany's decision to allow allies, led by Poland, to send Ukraine the coveted German-made tanks.

"At this pivotal moment in the war, we must provide heavier and more advanced systems to Ukraine, and we must do it faster," Stoltenberg said.

He added that providing battle tanks to Ukrainian forces is important in order to both repel Russian advances and to help Ukraine retake its territory.

Ukrainian officials have said Western battle tanks, like the Leopard and the Abrams, will allow their forces to maneuver more effectively, with greater firepower and protection, as they seek to push back Russian forces occupying their country.

"A few hundred tanks for our tank crews — the best tank crews in the world. This is what is going to become a real punching fist of democracy against the autocracy from the bog," Ukrainian President Volodymyr Zelenskyy's chief of staff, Andriy Yermak, wrote on Telegram Tuesday.

In the meantime, the U.S. signaled that despite an initial reluctance to provide Ukraine with some weapon systems, it remains willing to shift gears as conditions on the ground change.

"We have not taken capabilities off the table," State Department spokesman Ned Price told reporters Tuesday. "This is a conversation based on what our Ukrainian partners need, where they need it, when they need it."

Morton punches Carifta Games ticket in two events on 'amazing day' By Dean "The Sportsman" Greenaway

Jah'Kyla Morton, a 2022 Carifta Games U17 Girls High Jump bronze medalist, punched her ticket to the 50th edition of the championships in Nassau, Bahamas, April 8-10, in two events on Saturday, during the 2nd Dag Samuels Development Series meet.

"Today has been an amazing day. I qualified two times in both events I'm training for on the same day," Morton told Island Sun Sports. "It was not expected, but I'm glad it happened. I was very surprised. I was not expecting to run 15.09 (seconds) in the (100m) Hurdles. I thought I would have run at least 15.20 or something."

Morton said that leading up to the meet, training has been a 'real struggle' trying to get the technique for each event spot on. During the morning session, she cleared 1.59m (5'2½") to qualify in her pet event, the High Jump and said she didn't feel pressured when she became the first to qualify for the Carifta Games. "My best is actually 1.60 (5'3") which I did in Carifta, but I'm passing that this year," she said. "I'm aiming for first place this year. My goals have gotten bigger. If I don't get first it's okay, I'll deal with second. I'm not dealing with third, not this year."

Morton's goal is to become an Olympic High Jumper and said the event is 'peaceful in

a way."It's the most technical event, but I like it," she said. "Love that event actually."

Malik John opened his season with a 49.15 seconds run in the open 400m.

"It was really windy today so the homestretch was kind of hard, I did my best to come off the turn and try to come home; 49.15 wasn't really the target for today," he noted. "But, for the season opener, we'll settle with it, hope for the future and see where it takes us."

Collegiate Scene

UCF's Beyonce DeFretias eclipsed Ashely Kelly's 7-year old 23.69 seconds 200m Indoors National Record, when she stopped the clock at 23.54 to finish 3rd in the Texas Tech Red Raiders Open, after running a personal best, 7.50 seconds in the 60m.

Northern Iowa Area Community College's Bruce Huggins, lowered his 200m indoors best to 23.61 seconds in the Jack Jannett Invitational and was eight overall. He was 4th in his 60m Heat in 7.40, a mark good for 10th overall.

Washburn's Kimberly Smith won the Washburn Rust Buster Long Jump with a 5.66m (18'7") leap to qualify for the NCAA Division 2 Indoor Championships and ran 8.26 seconds in the 60m.

"I didn't get the mark I wanted to jump or the time I wanted to run, but I got the job done," Smith said.

It was a 7.14 seconds 60m debut performance for Miles Creque of Iowa Central at the Jim Emmerich Alumni Invitational. "I really enjoyed my first college race," he said. "It wasn't the time I wanted to run, but there's room for improvement and there are more meets coming up so I can improve on those things."

It was a 'new experience' for Northern Michigan's Jahtivya Williams, who won her 400m Heat at the Lake Michigan Open in 1:02.68, then without full recovery, ran the 55m finals in 7.52 seconds for second place after winning her heat in 7.41. It was Williams's first 400m indoor race and she learnt where she had to make the break. "Five minutes after I did the four, I had to run the 55 meters finals. That was crazy because I was exhausted," she reflected. "My head was still spinning and the lactic acid was crazy, but I did what I had to do and got second in the finals. It was an experience I will never forget."

North Dakota State Heptathlete A'Keela McMaster, made her 400m debut in 58.92 seconds. "I was happy with my time because I

Montverde Academy's sprint sensation Adaejah Hodge, ran 55.70 for second in the RADD Sunshine Girls Showcase 400m, finishing second behind teammate, Michelle Smith of St. Croix, who ran 55.38.

Between them, they won five Carifta Game U17 Girls Division gold medals in Jamaica last year.







ECONOMIC INEQUALITY AT THE ROOT OF PROTESTS: POLICE **BRUTALITY NOT THE ANSWER**

Many countries in South America are now in a state of troubling unease. Recent events in Peru have catapulted it to the forefront of security concerns in all its dimensions. But worry also exists about other countries which are tiptoeing through political minefields that could explode overnight.

Although the causes of these conditions of dysphoria are ascribed to hostilities between political parties in their constant battles to control power, the root of the problem lies in inequality, injustice and racial and ethnic discrimination.

The dispossessed, throughout Latin America, found a voice and a champion among left-leaning parties which demand change. The elite and the privileged, including the military, maintain their economic and social advantage through right wing political parties and alliances with powerful multinational companies from North America and Western Europe. The two sides are persistently in conflict.

These conditions have been portrayed in the poetry of Pablo Neruda, the novels of Isabelle Allende, Gabriel García Márquez, and Mario Vargas Llosa among others; and in the painstaking research and raw descriptions in the works of Marie Arana and Eduardo Galeano.

In his seminal work, Open Veins of Latin America, in one sentence, Galeano poignantly describes the structural divide in many Latin American societies - "The system has multiplied hunger and fear; wealth has become more and more concentrated, poverty more and more widespread. That is recognized by the documents of specialized international organizations in whose aseptic vocabulary our oppressed territories are 'countries in the process of development' and the pitiless impoverishment of the working class is 'regressive income distribution'."

And, inasmuch as the judgement may seem harsh, there is a sobering truth

in Marie Arana's assertion in, Silver, Stone and Sword, that "... extractive societies such as Latin America's are built on social injustice. They are designed and maintained by a ruling class whose primary goal is to enrich themselves and perpetuate their power. They thrive when absolute

privilege reigns over absolute poverty".

None of this is to say that, over the years, progressive elements in Latin America have not succeeded in pushing for institutional change. They have been aided in the work of the United Nations Human Rights bodies, and in the efforts of the Inter-American Commission and Court on Human Rights. Authoritative external organizations have been hugely instrumental in pushing governments to adopt international treaties on human rights and non-discrimination.

But adherence to treaties and laws is only as good as effective implementation of their values. In this connection, not all law enforcement agencies and governments have been as dutiful as they could have been. Thus, inequality has continued and the desire by the disadvantaged to overturn it has escalated.

The role of the military has also not been neutral or respectful of their constitutional requirement to be apolitical servants of the executive branch and subordinate to their civilian commander-in-chief, the President. As social unrest escalated throughout Latin America in the decades between 1964 and 1985, military dictatorships took control in several countries including Brazil, (1964), Chile (1973), Uruguay (1973), and Argentina (1976).

It was the military that pressured Evo Morales in November 2019 to abandon his disputed Presidency in Bolivia. The same military acted heavy-handedly to subdue street protests over the controversial installation into the Presidency of the right-wing, opposition representative Jeanine Añez.

While in Argentina and Chile, the return to democratic regimes was "accompanied by transitional justice, a reckoning with the past and a recognition that the armed forces had strayed from their constitutional mission", as one political commentator put it, the role of the military in Brazil and

Peru remains questionable.

Brazil's President Lula da Silva dismissed the country's army chief, General Julio Cesar de Arruda, in the aftermath of the storming of several government buildings by the supporters of former President Jair Bolsonaro on January 8. Lula said he suspected collusion by "people in the armed forces".

In Peru, where elected President, Pedro Castillo, was ousted on December 8, after an ill-advised and clumsy attempt to suspend the Congress, which was seeking to impeach him, his vice-president, Dina Boluarte, was sworn in to replace him. He was carted off to prison at a police base that triggered protests in the rural areas and poorer neighbourhoods in the capital.

In response, police raided San Marcos University, detaining hundreds of protestors. This was part of a violent crackdown on the protestors which has left many dead or seriously injured. The UN Office of the High Commissioner for Human Rights (OHCHR) in Peru condemned the Peruvian administration over the violence used to curb the protests.

But the fundamental problems, driving the unrest remains ignored - a huge gap between rich and the poor, particularly the people in the South of the country who feel neglected by its institutions and, most of all, its hugely unpopular congress, which is largely viewed as a tool of the rich and powerful.

Hemispheric institutions, such as the Organization of American States (OAS), should seek a constructive role in Peru, and they must keep a watchful eye on the military and right-wing forces in Brazil which may yet turn on President Lula.

It is difficult to see what practical role the OAS can play in resolving the political issues in Peru, but, at the very least, the member states must let the Peruvian government know that further brutality against protestors will receive the strongest condemnation; and, instead, they should seek meaningful dialogue to address the deep-rooted issues in the country.

In the meantime, Caribbean governments and political parties should ensure that, in their own countries, economic inequalities must be discouraged. Dissatisfaction is fuelling the fire of unrest in Peru and other Latin American countries; it must not spread to the Caribbean.


