## HOUSE OF ASSEMBLY DISCUSSES SKELTON-CLINE **CONSULTANCY CONTRACTS**

for the members of the Cabinet of the Andrew Fahie Virgin Islands Party (VIP) administration as the Auditor General's report on Claude Skelton-Cline contracts was laid on the Table of the House of Assembly. The debate in the House of Assembly on 21 February saw Premier Dr. the Hon. Natalio Wheatley, who was the Deputy Premier in the Fahie-led government blasting Claude Skelton-Cline who previously served as that Administration's consultant. Unfortunately, the Premier's attempt to step away from the matter was unsuccessful as the current Minister of Health and Former Leader of the Opposition Hon. Marlon Penn announced that the should be laid at the feet of the former Cabinet which included the current Premier.

When the report was made public on Tuesday members of

It was an evening of reckoning the public openly expressed their disgust at the findings that Skelton-Cline was paid \$16,000 per month to carry out projects that had no clear deliverables. Further that Skelton-Cline did not deliver or complete any of the projects which saw various contract renewals and the complete payment of some total \$365,000 to the consultant.

> While the matter sent tongues wagging throughout the community, legislators sat in the House of Assembly. During the sitting Premier Wheatley called for the report to be debated, and in his presentation of the document he announced that the contracts were a mistake.

> While declaring that it was an error on his part Hon. Wheatley said: "Certainly, I have to say that these contracts that we speak about, these contracts for Claude Skelton-Cline

did come to Cabinet, and I did support them. I am here to say to you Madame Speaker that I believe that my support for these contracts was a mistake, and I believe that the former Premier made a mistake in engaging Claude Skelton-Cline with these contracts. It is okay to acknowledge a mistake. There is nothing wrong with acknowledging a mistake."

The Premier while doubling down on his apology said that he expects that persons will use the admission of a mistake against him: "Some persons will say oh you have acknowledged a mistake. There you go, you have admitted how horrible you are. We all make mistakes sometimes, but it takes a man or in some cases a woman to be able to admit when you have made a mistake. No doubt about it this series of contracts was a mistake."

The Leader of Government Business also sought to



distance his Party from the Skelton-Cline contract saga by declaring: "In this audit, it is pretty straightforward. We have Mr. Claude Skelton-Cline who received I believe a total of three contracts, he was paid exorbitantly for those contracts and his contribution to the success of the initiatives that he was tasked to complete was marginal at best. Let's just speak about the fact that

Mr. Claude Cline has been associated with political parties including the Virgin Islands Party; of which I am the Chairman. I don't think he supports Virgin Islands Party anymore, which has been his pattern if I might say that. He has been jumping left, jumping right."

#### HON. PENN LAYS BLAME PREMIER ON AND **CURRENT VIP MEMBERS**

In a stinging debate contribution Hon. Penn took swipes at the Premier and his attempts to distance himself from the contract issue. The former Leader of the Opposition said that the entire VIP Cabinet was complicit in the matter, and he recalled how in the very House of Assembly he raised alarm about the contracts and even sought to get information for the public but none was provided.

Hon. Penn said: "Madame Speaker it was about a very simple principle if you are going to expend \$365,000 of taxpayers' money to deliver on particular items we need to get and ensure that we have value for the money that is being expended. I remember at one point the attacks against me were so vehement."

"When I was asking those questions as Leader of the Opposition I didn't hear anyone get up and say how unjust they were, we should have done this differently, we should have done that differently. We cannot just whitewash these under the table... We also have to atone and account for our actions as well Madame Speaker," Hon. Penn stated.

In heaping further fire on the Premier and other members of the VIP Cabinet Hon. Penn blasted: "We all cannot act like Naaman take seven dips in the ocean and come up clean, like we have no responsibility to play in this process...We cannot abscond ourselves from our role in this process and act as if we weren't there when this happened...The members here are part of the Cabinet and part of the team that approved these contracts. Then want to throw Claude Skelton-Cline under the bus and then run him over back and forth... He didn't just get here \$365,000 later with nothing to show

for it ... The Cabinet went silent, no one spoke out."

In taking another jab at the Premier who debated before him Hon. Penn said: "Madame Speaker I listened earlier, and we cannot whitewash these things as if they appeared out of thin air. The Report is very clear. This was approved by Cabinet...all three contracts were approved by Cabinet with no clear deliverables... If you are going to engage a consultant it has to be performance-based. You cannot have an open-ended consultancy without a performance measure, and then you expend \$365,000 of taxpayers hard earned money in a time when you are going through

significant social challenges within the population...Do you know what \$365,000 could have done to help alleviate some of those challenges?"

"We have a report before us where more than 90 percent of the things in this report are neither delivered or not achieved, or not accomplished Madame Speaker. The former Cabinet has to take responsibility for this; not whitewash it and shove it under the rug, because Mr. Skelton-Cline did not just come off the street and attained these contracts, as the report clearly states they were approved by Cabinet. The directions were given by the Cabinet," Hon. Penn added.

## **HEALTH MINISTER TALKS ABOUT "LIVABLE WAGE"**

livable wage - Minister of Health and Social Development Hon. Marlon Penn announced in response to complaints that the price of goods and servicesare escalating while household incomes struggle to keep up.

Hon. Penn who was a guest on the Umoja Show on 13 February the Minister stated that he believes that instead of a revised minimum wage which some are calling for, there should be consideration for a livable wage.

The Minister explained, "It's not a discussion that I have had with this Unity Government but I think it is a discussion that we need

We need to look at a living wage. One of the things that we have discussed with this new transformation of the grant programme at Social Development is - what is a living wage in the BVI?."

Hon. Penn explained that this recommended livable wage would not only apply to persons who are employed; but persons who are currently in situations where they require public assistance. The Minister explained that even the monetary assistance that the government provides to persons will have to reflect the livable wage.

"Right now we are offering persons some assistance, but

Not a minimum wage, a to have going forward. it's based on some thinking ten-plus years ago. Someone decided okay we'll just give something a month. This is what we are giving for rent, this is what we are giving for so, but we haven't really looked at what it costs to live in the BVI," the Minister noted.

> "For instance, you may have someone who is making \$24,000 a year - say \$2000 a month you would say this should be all right, this should be okay; they should be able to survive. But in the BVI rent is \$1200 a month, if they have kids they have to pay for daycare, they have to pay for food; so you're looking at a situation where persons might seem to be gainfully employed but

they fall under the category of working poor. Those persons will still need to get some type of support, some type of assistance if they're going to live a decent life in the country," Hon. Penn pointed out.

The Minister of Health however noted that it was not just a matter of implementing such a wage, but rather ensuring that the BVI's economy can sustain the rise. He said that these are the type of considerations that the Government envisaged that the Trade Commission was going to address.

While making this point, Hon. Penn said: "This is a whole economic issue that we are speaking about as

well. One of the areas that we looked at was to put an engine that will help drive economic development, economic regulations, economic administration."

He further explained that the Trade Commission the supporting new Trade Licensing Act and Proposed Consumer Protection are part of the mechanisms that are being put in place.

The Minister with responsibility for Social Development said that this suite of legislation is expected to propel the BVI economy and make the lives of the people better.

# AUDITOR GENERAL BLAMES GOVERNMENT FOR TASKING SKELTON-CLINE WITH CONSULTANCY who might be more properly qualified and more able to

In the bombshell report by the Auditor General Sonia Webster on the Claude Skelton-Cline contracts it was announced that in an effort to continue being paid the consultant submitted reports to the Government with information that he copied wholesale from independent individuals and projects; as well as falsely claiming to have meetings with persons when he did not.

The 23 pages long report was laid on the table of the House of Assembly recently and subjected to debate on 21 February. Even before the report made light on the Skelton-Cline contracts it was expected that the findings were going to be shocking based on information that was revealed by the Opposition at the start of the VIP administration, and later the Commission of Inquiry hearings.

During both publicized outcries there were mentions

in various sections that they were false and that some work was done. Unfortunately, this mystery was solved by the report which outlined a list of valuable projects that are of Territorial importance that were placed as part of Skelton-Cline's contractual responsibility. However, the Auditor General stated that almost all of the projects were incomplete and never delivered despite payment being made to the consultant.

In her conclusion, Webster stated: "The records do not show any demonstrated effort by the Consultant to actually satisfy the deliverables stipulated in the contracts. The audit confirmation exercises performed indicate that much of the work reported or claimed by the Consultant Skelton-Cline was undertaken by persons and programmes independent of the consultancy. In a number of cases, his association with the

programmes was either fleeting or non-existent. The information in the Consultant's periodic reports was largely duplicated without demonstrating any advancement or effort to achieve progress. As a result, very little was gained from this arrangement and the Government failed to receive value for money on these contracts."

She further added that: "After a period of two and a half years, none of the initiatives stipulated in the three contracts have been delivered. Similarly, none of the ad-hoc "noncontractual" assignments have been realized. This is with the exception of the COVID-19related initiatives that were self-determining. Substantial reports and information were received only where the Consultant was assigned as a part of a committee or working group. These documents were usually prepared by other

members of those bodies as was the case with the supporting documents for the Seafarers programme and the report issued by the Economic Advisory Council."

The tasks assigned to Skelton-Cline were of serious importance to the Territory and included matters such as economic diversification, climate change, youth empowerment, unemployment, and Prospect Reef development. Unfortunately, these projects suffered, and the Auditor General blamed the Government for tasking Skelton-Cline with such important subjects.

She said, "The failure of the Premier's Office to adhere to the procurement regulations for competitive submissions resulted in substantial costs incurred on this (and other similar no bid consultancy contracts). It also created a disservice to other citizens

who might be more properly qualified and more able to deliver the specific initiatives contained in the contracts. The Government would have been better served by establishing different thinktanks or other mechanisms to address the areas identified under the three contracts. This would have availed the process to expert input and presented actionable results."

Further the Auditor General said that the time has come for such consultant hires to stop, "The practice of using public funds to engage consultants with misleading or unrealistic contractual objectives should cease. If a genuine need exists, the service should be advertised and candidates properly vetted and engaged on qualifications, experience and ability to deliver. Permanent Secretaries or the engaging agency should ensure that remuneration is commensurate rather than extortionate."

## **BVI & JVD PAY LAST RESPECTS TO SEDDY CALLWOOD**

Restaurant Philisianno Callwood also known as Seddy or Zeddy was held on 18 February. Seddy - the son of the famous Philisianno "Foxy" Callwood - was in his own right a renowned public figure on the island of Jost Van Dyke.

Seddy was born on 2 February 1963 and departed this life on 20 January, 2023. He was born on the island of St. John USVI to Lestelle Callwood and Philisianno Ohanio "Foxy" Callwood.

Seddy resided on the island of Jost Van Dyke, however, at the tender age of 6 he relocated to the island of St. Thomas to reside with his paternal grandmother, the late Romalia Callwood. He attended the Lockhart Elementary School and then the Wayne Aspinall Jr.

High School. As a teenager, he was relocated back to Jost Van Dyke when his grandmother moved back there.

As a youth, he remained with his grandmother and his grandfather, the late Christian Callwood, where he would travel to the hills early in the morning to assist his grandfather with rounding his cattle. Over the years, Seddy worked on his grandfather's farm and became very skilled at cultivation and land management, which proved fruitful in producing crops. He also worked with his dad Foxy for several years bartending before venturing off.

He tried his hand at marriage at a young age, and from the union Lorraine and Jacob were born. His two other children Lilliana and Isaac would follow some years later in another relationship. Seddy later met Laura and after a few years of friendship, he decided to take another shot at marriage.

For some time Seddy lived between the islands of St. John and St Thomas working as a landscaper in hope of one day becoming an entrepreneur. He also lived on the mainland and dabbled in the restaurant industry for the little while he was there.

Seddy was blessed, when his maternal grandmother the late Olivia Callwood provided the land to create what is now known as the "One Love Bar & Restaurant". He did backbreaking work to construct his landmark on White Bay Beach where many

tourists would come to partake in the beverages or delight in the delicacies from the kitchen.

His fame came from his ability to mesmerize the people who visited his establishment. Many visited his business to have an encounter with the self-thought magician who was famous for his card tricks and who left everyone in a state of disbelief from his famous "spit knot" trick.

When Seddy was not in his bar he was making fish pots or out pulling his pots for the catch of the day. He was known for his generosity and would share the fish and lobster he caught with families on Jost Van Dyke.

Seddy's death is recorded as a shocking and sad

## FIRE RESPONSE TRAINING HELD AT HIS MAJESTY'S PRISON

His Majesty's Prison hosted a training session for emergency first responders to develop a plan of action for dealing with fires on the prison grounds.

The training session, held on Tuesday, February 21, was presided over by Deputy Superintendent Joe Wilcox. The session featured a representative from the Virgin Islands Fire and Rescue Service, the Royal Virgin Islands Police Force, the Emergency Medical Service, the Department of Disaster Management and His Majesty's Prison.

Deputy Superintendent John Wilcox said the first responders decided to come together to formulate a plan to best tackle an incident that may require emergency services on the prison grounds. He noted that during emergencies, the safety and security of the staff and prisoners along with protecting the prison's infrastructure are of paramount importance; hence developing a plan of action is desperately needed.

The plan of action, according to Mr. Wilcox, is to provide guidance to allow the safe and secure operations at the prison in the event of a fire or any other large scale disaster. The plan focuses on strategies to reduce damage to infrastructure while fulfilling the prison's role in keeping in custody people committed by the courts while minimising possible injuries or loss of life to staff and inmate.

Mr. Wilcox said, "We need to understand what the fire brigade needs from the prison to ensure they feel safe in cases of emergency. We also need to know what the medical staff wants because we understand that not everybody feels safe rushing into the prisons. That is what this training is about; how to deal with major incidents that could potentially lead to mass casualty."

During the session, the first responders looked at security challenges that might arise from any major disasters during and after contact is made with prisoners. They also focused on risk assessment strategies that can guide how to proceed in unique situations.

The Deputy Superintendent said he hopes that within two months, a simulation drill can be held at the prison in Balsam Ghut so first responders, prison staff and prisoners can get a full understanding of the response process.

Mr. Wilcox added, "From this, it is good to work together with everybody. We can understand the needs of each department and system and work together as a team to bring any incident under control. We also can understand each other's challenges and what we need and ensure we provide the safety and security to those emergency personnel coming in to help."

The Ministry of Health and Social Development remains committed to providing the resources to ensure the safety and security of all staff and occupancy at His Majesty's Prison.





## OIL SPILL RESPONDERS UPGRADE THEIR SKILLS

Thirty-five persons have received training from Ambipar Response in best practices for managing oil spill events.

The sessions were held on February 8 to 10 and February 13 to 16 and covered essentials of managing oil spill response including contingency planning, responder safety, spilt oil behaviour, oil containment and removal, and shoreline management.

Director of Disaster Management Jasen Penn said that a sound knowledge of these essentials help the Virgin Islands meet its obligations under the International Maritime Organisation's International Convention on Oil Pollution Preparedness, Response and Cooperation (OPRC).

"In keeping with the Territorial Oil Spill Response Plan, participants

included representatives of all the agencies that may need to respond to an oil spill," Mr. Penn said. This includes the Ministry of Natural Resources and Labour, BVI Fire & Rescue Service, Department of Disaster Management, BVI Ports Authority, Royal Virgin Islands Police, and Virgin Islands Shipping Registry, as well as staff from the major fuel providers such as Sol.

Harrison Jolly, Senior Response Consultant and Trainer with Ambipar Response, congratulated participants on their successful completion of the operational and tactical sessions.

"It was clear to our trainers during the preparation for and delivery of the courses that BVI is demonstrating a commitment to enhancing their understanding of marine oil spill response, developing new skills and ensuring resilience amongst key stakeholders and agencies at all levels," Mr. Jolly said.

Participants included Virgin Islands public officers plus officers from Anguilla, Cayman Islands, Montserrat, and Turks and Caicos, as well as partners from the private sector.

The February sessions followed Level 3 oil spill response training for executive officers in January. The series was organised by the Department of Disaster Management (DDM) as part of its annual training programme with financial support from United Kingdom Maritime and Coastguard Agency through the Conflict, Stability and Security Fund.

Residents who suspect an oil spill has occurred or is occurring should report it to the Virgin Islands Fire and Rescue Service by calling 911 or 999.





## Public Officers To Provide Feedback On Compensation Review

The Government of the Virgin Islands is continuing its Public Service Compensation Review and is inviting Public Officers to submit feedback through a survey.

A survey link has been emailed to public officers directly, and should take individuals no more than 10 to 15 minutes to complete. The deadline for completion of the survey is Tuesday, February 28.

The consultancy firm PricewaterhouseCoopers Advisory Services Limited (PwC) is conducting the nine-month long review which aims to support modernising employment terms and conditions to enhance performance across the Public Service.

The project is currently in the current state assessment phase and focus group discussions are ongoing with officers throughout the Public Service. In order to get a greater holistic view of the issues at hand, a survey was developed to allow every individual public officer the opportunity to express their opinions anonymously.

The contract for the Compensation Review was signed with PwC in October of 2022 and is valued at Three Hundred and Two Thousand, One Hundred and Three Dollars (\$302,103.00). The project is scheduled to conclude in August.



## Cabinet Decides Increments Are To Be Paid To Public Officers

On Wednesday, February 15, Cabinet made the decision to begin issuing outstanding increments to public officers.

Cabinet has decided pay eligible public officers performance year increments, with arrears, for 2018 and 2019 to commence immediately and be substantially completed by end of the Second Quarter of 2023.

Additionally, the decision was made to pay eligible officers performance year increments for 2020, 2021 and 2022, without arrears initially, to be substantially completed by the end of the Third Quarter of 2023. In cases where officers are on the top of their scales, they will be paid a one-off payment the equivalent of the incremental value.

Therefore, eligible public officers at the end of the entire processing period, will receive the payment of two (2) full increments (2018 & 2019) and see a change in their salary levels by five (5) incremental steps.

The Office of the Deputy Governor in partnership with the Ministry of Finance and the Department of Human Resources, made presentations to Cabinet earlier this week regarding the payment of outstanding increments to public officers. The presentation to Cabinet highlighted the impact of the delayed increment payments on the Public Service, and the effect on the engagement and morale of public officers. Prior to 2013, the payment of performance increments was in accordance with General Orders, and perfectly

married to the Performance Management Programme. Due to the fluctuating fiscal challenges since 2012, which were further compounded by the disasters of 2017 and the COVID-19 pandemic, the payment of increments was subsequently delayed.

Acting Premier Honourable Kye M. Rymer said that he is pleased with the outcome of this Cabinet decision.

"On behalf of the Premier. Dr. the Honourable Natalio D. Wheatley, I would like to underscore that this decision is of monumental importance, and I am pleased to see it is being prioritised for the sake of so many hard working public officers who are owed these increments. This is a symbol of the Government's commitment to driving public service excellence," the Acting Premier said.

Similarly, Deputy Governor Mr. David Archer, Jr. also expressed his excitement.

"So many public officers will benefit from these long overdue payments of increments. These payments are an acknowledgement of their individual work and continued commitment to the Public Service. I am proud to have been able to be a part of this process and remain dedicated to ensuring that every officer is both recongised and valued for their work."

The decision to commence the payment of increments comes as the Office of the Deputy Governor wraps up several Compensation Review stakeholder meetings. These focus-group sessions have taken place with various stakeholder groups within and external to the Public Service and is led by consultancy firm PricewaterhouseCoopers Advisory Services Limited (PwC).

The Compensation Review and Job Classification Project, which is an initiative under the Public Service Transformation plan, seeks to address remuneration disparity; further support the retention, engagement and motivation of skilled and competent officers

## Concept & Detailed Designs To Be Finalized For New West End Ferry Terminal

Climate response and energy savings measures in a functional layout were on the agenda during stakeholder discussions on the new West End Ferry Terminal (WEFT) held on February 15 and 16.

The meetings were held to finalise the new terminal's conceptual designs, facilitated by RDA Contract Supervisor and Project Manager Sergio Dantas and Community Liaison

Officer April Glasgow, who were joined by the WEFT design consultants, Project Lead Dr. Karsten Galipp and Principal Architect Torsten Illgen of Inros Lackner S.E.

The two-day stakeholder sessions were attended by the Acting Premier and Minister for Communications a

Works Honourable Kye Rymer, with representatives from the Ministry of Communications and Works, the BVIAuthority, H. M. Customs and

Immigration Departments, the Royal Virgin Islands Police Force, the B.V.I. Tourist Board, the Town and Country Planning Department, Virgin Islands Ferry and Rescues Service,

Ferry Operators and the West End Taxi Association among others.

The two-storey ferry terminal features measures to promote efficient flow and processing of passengers for both domestic and international travels.

In sharing expectations for the visit, Dr. Galipp said, "is important that we receive feedback on the design from the stakeholders. We have listened to their concerns, some of which we can integrate to bring relief."

Dr. Galipp shared that following the consultations, they are a step closer and are

eaded in the right direction. Principal Architect Mr. Illgen said, "We hope that the direction of climate response will have a positive impact," adding, "Regarding the functional layout, we are on the right track."

Following an analysis and integration of the stakeholder consultations, public consultations will be scheduled.

The design team will now incorporate the end user feedback and finalize the conceptual designs and proceed with the detailed final designs and tender documents.

The ferry terminal at West End was the busiest seaport in the Virgin Islands prior to the 2017 hurricanes with 40% of all arrivals into the Territory cleared in through West End.

Under the direction of the Ministry of Communications Works, the RDA manage the design will construction of a and new, expanded terminal, in partnership with key stakeholders. The proposed 12,000 square foot facility will double the size of the previous facility, and have the capacity to process more passengers, provide berthing for multiple ferries and private yachts, and parking for vehicles.

The facility will be built from sustainable materials and will incorporate technologies to offer greater efficiency for businesses and passengers.

In July 2022, the Virgin Islands community was engaged in a poll on the design for the new West End Ferry Terminal which focused on the aesthetics of the building. Taking into consideration the efficacy

of the three designs, the resiliency of the building and the availability of materials, the Classic Modern design emerged the winner following a tie with the Organic, Futuristic design.

This round of stakeholder consultations on the West End Ferry Terminal consistently supports the

Virgin Islands Recovery and Development Agency's overarching goal, to deliver on its mandate to execute recovery projects, build capacity and philanthropy.

## COI IMPLEMENTATION UNIT REPORTS ON PROGRESS FOR JANUARY 2023

The Commission of Inquiry Implementation Unit is advising the public that it has reported to the Governor and Premier on the status of work completed up to the end of January 2023.

Based on the timelines agreed in the Framework for Implementation of the Recommendations of the Commission of Inquiry Report and Other Reforms, the Director of the Unit Ms. Hadassah Ward has advised that work on 49 of the 50 Framework recommendations has begun.

Ms. Ward said, "19 of the Recommendations have been completed and 30 Recommendations are in progress. The Recommendations are currently split into 132 Actions. Of these, 65 (49%) are completed, 24 (18%) are in progress and on track, 22 (17%) are in progress but experiencing challenges and 19 (14%) have not been started as yet." She noted that during the month of January:


The completion of actions under Recommendations B02 and B03 which covered making the Registration of Interests for the House of Assembly public.

The completion of B35 which brought the revised Public Service Transformation Programme completely on stream.

B37 was also completed which streamlined Public Service Training and resulted with an agreement between the Government of the Virgin Islands and HLSCC to prepare a Memorandum of Understanding to support the implementation of the Public Service Learning Institute. She said that the Dashboard gives a pictorial summary of the status of the fulfilment of the COI recommendations as agreed in the Framework. The Key shares each of the 50 Framework Recommendations, now being worked on as the main focus of Government of the Virgin Islands to raise our standards of governance in our beautiful Territory, so you can track the status of work on each recommendation.

LONDON — Boris Johnson is "being Boris," a senior U.K. Cabinet minister quipped, after the ex-prime minister waded into the Tory debate over the contentious Northern Ireland protocol ahead of a crucial few days for his successor Rishi Sunak.

Sunak heads into the week hoping he can keep Conservative Eurosceptics and Northern Ireland's unionist politicians onside as the U.K. nears an agreement on the post-Brexit trading set-up after months of talks between London and Brussels.

Following a meeting with European Commission President Ursula von der Leyen on Saturday, Downing Street said "very good progress" was being made, but insisted "intensive work" is still needed "in the coming days."

Other politicians were less diplomatic. Labour peer Peter Mandelson told the same show: "There's nothing that Boris is doing now, or indeed throughout our recent history with the European Union, that could possibly be described as helpful." And he suggested Johnson was trying to "wreck" Sunak's attempts at a deal as part of the ongoing "fratricidal war" in the Conservative Party. [Politico]

**ROME** - European People's Party (EPP) President Manfred Weber said Friday that the centre-right group

has cancelled an event scheduled to take place in Naples this year in protest at comments by ex-premier and Forza Italia (FI) leader Silvio Berlusconi criticizing Ukrainian President Volodymyr Zelensky.

The decision sparked an angry reaction from FI. "Following the remarks by Silvio Berlusconi on Ukraine we decided to cancel our study days in Naples," Weber said via Twitter. "Support for Ukraine is not optional".

Speaking Sunday, Berlusconi said he would "never" have met with Zelensky as Italian Premier Giorgia Meloni did on the sidelines of an EU summit in Brussels last week, adding that he had a "very, very negative" view of Zelensky's conduct and suggesting Moscow had been provoked into invading its neighbour. [ANSA]

**USA** - The 39th president, who at 98 is the longest-lived American leader, has entered home hospice care "to spend his remaining time with his family"

Former president Jimmy Carter, who at 98 years old is the longest-lived American president, has entered home hospice care in Plains, Georgia, a statement from The Carter Center confirmed Saturday. After a series of short hospital stays, the statement said, Carter "decided to spend his remaining time at

home with his family and receive hospice care instead of additional medical intervention."

The statement said the 39th president has the full support of his medical team and family, which "asks for privacy at this time and is grateful for the concern shown by his many admirers."

Carter was a little-known Georgia governor when he began his bid for the presidency ahead of the 1976 election. He went on to defeat then-President Gerald R. Ford, capitalizing as a Washington outsider in the wake of the Vietnam War and the Watergate scandal that drove Richard Nixon from office in 1974. [El Pais]

**USA** - US Secretary of State Antony Blinken has warned that any attempt by China to supply Russia with "lethal support" for use in Ukraine would have serious implications.

In an interview with US network CBS News, Blinken said that, to date, Chinese companies had been providing non-lethal support to Bussia

Blinken pointed out that Washington had been watching developments between China and Russia very closely.

"Just weeks before the aggression, you will remember that President Xi and President Putin had a meeting in which they talked about a partnership with no limits, and we were concerned that among the lack of limits would be Chinese support for Russia in the war." Blinken said.

"The concern that we have now is, based on information we have, that they're considering providing lethal support," Blinken told CBS news anchor Margaret Brennan. "We've made it very clear to them that would cause a very serious problem for us and in our relationship."

The top US diplomat said, "There's a whole gambit of things that fit in that category, everything from ammunition to the weapons themselves." [Deutsche Welle]

SAN FRANCISCO - (AFP) – Facebook and Instagram owner Meta will launch a paid subscription service starting at \$11.99 a month allowing users to verify their accounts, CEO Mark Zuckerberg announced Sunday, following a similar move by Elon Musk at Twitter.

Meta Verified, which will roll out first in Australia and New Zealand this week, will let users verify an "account with a government ID, get a blue badge, get extra impersonation protection against accounts claiming to be you, and get direct access to customer support," Zuckerberg said.

"This new feature is about increasing authenticity and security across our services," he wrote in a statement posted to his Facebook account.

There would be no changes to accounts on Facebook and Instagram that are already verified, the company said, adding that only users who are over the age of 18 will be allowed to subscribe. The service is not yet available to businesses.





The Bermuda Tourism Authority (BTA) report said the majority of visitors - 402,657 or 73 percent arrived by cruise ship, with 145,865 visitors travelling by air. A further 4,595 visitors called arrived in Bermuda by yacht. But air arrivals pumped far more money into the economy, spending US\$270 million during the year. Cruise ship passengers spent US\$102 million. In 2019, visitors spent a total of US\$520 million. The figures also showed the United States remained Bermuda's key market, with 73 percent of air visitors flying in from America. Visitors flying out of the United Kingdom made up a further 11 percent of air arrivals while Canada accounted for another nine percent of visitors.

"While there is more work to do to reach our pre-pandemic visitation levels, the data show strong forward momentum," said BTA's chief operations officer, Erin Smith.



## **HOMEMADE AUSSIE BITES**

#### Yield: 24 pieces

#### **Total Time: 22 minutes**

- 1 3/4 cups rolled oats, divided
- 1/4 cup granulated sugar
- · 1/4 cup dried apricots, roughly chopped
- 1/4 cup raisins
- · 1/4 cup ground flaxseed
- 1/4 cup sunflower seeds
- · 1/4 cup unsweetened shredded coconut
- 1/4 cup quinoa, cooked or uncooked
- · 2 tablespoons chia seeds
- 1/2 teaspoon baking soda
- 1/4 cup honey or pure maple syrup
- 1/4 cup butter or coconut oil, melted
- 1/4 cup canola oil or other vegetable oil
- 1/2 teaspoon vanilla extract
- 1/2 teaspoon kosher salt, optional

Preheat the oven to 350 F. Lightly grease a 24-count mini muffin pan.

Place 1 cup of the rolled oats in a food processor and process for about 1 minute, until the oats are ground into oat flour. Add the remaining 3/4 cup rolled oats, sugar, apricots, raisins, flaxseed, sunflower seeds, coconut, quinoa, chia seeds and baking soda to the food processor. Pulse until the apricots and raisins are in small pieces.

Add the honey, melted butter, canola oil and vanilla extract. Pulse until just combined. The batter will be like a stiff oatmeal cookie batter.

Using rounded tablespoons, divide the batter among the prepared muffin cups. Bake in the preheated oven for 10-12 minutes, until golden brown. Cool in the pan on a wire cooling rack. When completely cooled, remove the muffins from the pan and store in an airtight container for four to five days or freeze for up to six months.



# ONE CHARGED IN RELATION TO MURDER/ONE FOR FIREARMS

Wednesday, February 22

— Officers of the Major Incident Team today charged one male in relation to last December's murder of Kadeem Jimenez and charged another for firearm, ammunition, and drug offences.

Nyall George, 26, of Old Plantation was charged with conspiracy to murder Jimenez while both George and John Burgos, 24, of St. Croix, USVI were charged with unlawful possession of firearms, unlawful possession of ammunition and unlawful possession of a controlled drug.

A search warrant conducted

on George's Hodges Creek residence uncovered three illegal handguns, a large quantity of ammunition and a quantity of illegal drugs. Both men were arrested at Hodges Creek.

The two men will appear in Magistrate's Court at the next available sitting.

Kadeem Jimenez was fatally wounded in the early afternoon of December 12 after shots were fired in Major Bay, East End. He was pronounced dead at the scene.

With the escalation in gun violence on the island of Tortola, Commissioner Mark Collins reiterated his commitment and that of the RVIPF in identifying offenders. He noted, however, that officers cannot do so alone.

"We need to present a united front against those who want to put us and our loved ones in danger and in fear. I urge anyone who has any information into the recent murders and the attempted murder on Saturday to come forward," he said.

# CPI SHOWS THAT MOST COUNTRIES ARE FAILING TO STOP CORRUPTION

## THE 2022 CORRUPTION PERCEPTIONS INDEX (CPI) SHOWS THAT MOST COUNTRIES ARE FAILING TO STOP CORRUPTION.

The CPI ranks 180 countries and territories around the world by their perceived levels of public sector corruption, scoring on a scale of 0 (highly corrupt) to 100 (very clean).

The global average remains unchanged for over a decade at just 43 out of 100. More than two-thirds of countries score below 50, while 26 countries have fallen to their lowest scores yet. Despite concerted efforts and hard-won gains by some, 155 countries have made no significant progress against corruption or have declined since 2012.

Global peace has been deteriorating for 15 years. Corruption has been both a key cause and result of this.

Corruption undermines governments' ability to protect people and erodes public trust, provoking more and harder to control security threats. On the other hand, conflict creates opportunities for corruption and subverts governments' efforts to stop it.

Even countries with high CPI scores play a role in the threats that corruption poses to global security. For decades, they have welcomed dirty money from abroad, allowing kleptocrats to increase their wealth, power and destructive geopolitical ambitions.

WHAT'S HAPPENING AROUND THE WORLD?

While every country faces different corruption challenges, this year's index reveals ongoing stagnation around the world.

Countries in the top-scoring region, Western Europe and the European Union, have been at a standstill for over a decade or have declined over the past five years. Undue influence over decision-making, poor enforcement of integrity safeguards and threats to the rule of law continue to undermine governments' effectiveness.

On the other end of the index, countries with low scores are also unable to make significant progress. In

many parts of the Americas, Eastern Europe and Central Asia, and Sub-Saharan Africa, restrictions and attacks on civic space and basic freedoms continue as multiple crises threaten security and stability, democracy and human rights. Similarly, in various Asia Pacific countries, rising authoritarianism dilutes civil society's function as a watchdog, while many leaders are prioritising economic recovery over anti-corruption efforts. In the Middle East and North Africa, where unequal political and economic power is deeply intertwined with conflict, corruption is undermining democratic processes, causing pervasive civil unrest and fuelling violence.

Check out the latest corruption wins, scandals and predictions for each region of the world.

For the fourth consecutive year, the Americas scores an average of 43 out of 100 in the Corruption Perceptions Index (CPI). A lack of bold, decisive action to fight corruption and strengthen public institutions is fuelling organised criminal activities, undermining democracy and human rights, and threatening the achievement of the Sustainable Development Goals (SDGs). This is, in turn, sparking violence, environmental damage and migration across the hemisphere.

Since 2016, 27 out of 32 countries have stagnant corruption levels.

Leading the regional rankings are Uruguay and Canada, each with a score of 74, followed by the United States with 69. In Venezuela (14), Haiti (17) and Nicaragua (19), the countries with the lowest scores, it is difficult to draw a line between public institutions and criminal activities.

Weak and unaccountable public institutions in Latin America have created fertile ground for organised criminal networks to flourish, fuelling violence and insecurity. These are among the main concerns for Latin Americans, along with corruption and the economy. In many countries, law enforcement and corrupt officials collaborate with criminal gangs or accept bribes in exchange for turning a blind eye to their illicit activities. In Honduras (23), Guatemala (24) and Peru (36), evidence suggests that organised criminals wield a strong influence over candidates and politicians, financing electoral campaigns or even running for public office themselves.

The impacts of these intertwined criminal and political interests are felt particularly by the most marginalised groups in society, and witnessed in the destruction of natural resources. Across the region, women, girls and migrants are victims of human trafficking and sextortion, which usually involves public officials demanding sexual acts in exchange for services like awarding passports or granting passage through border controls.

Corrupt networks also fuel wildlife trafficking, illegal glogging, illicit gold mining, and slash-and-burn land gclearance.

In the Amazon, the drug trade has brought violence to the ancestral territories of indigenous and Afrodescendent peoples, which coincide with critical areas of high biodiversity. Moreover, in 2021, Latin American countries recorded the highest number of killings of human rights defenders. Colombia (39) had the highest numbers of killings of human rights defenders with 138, followed by 42 in Mexico (31) and 27 in Brazil (38). Too often, murders of environmental and anti-corruption defenders go unpunished due to corrupt and criminal networks' infiltration of local governments and the justice system.

Meanwhile, to tackle organised crime and gang violence some governments have taken extreme measures that concentrate power in the executive branch, reducing transparency and accountability, and posing serious threats to human rights and basic freedoms. For instance, the declaration of states of exception during 2022 in countries like El Salvador (33), Ecuador (36) and Honduras (23) - whilst constitutional and officially temporary - granted

extraordinary powers to the executive branch to suspend constitutional guarantees. They impacted people's rights to assembly, access to information, transit and basic procedures during an arrest. In the name of security, these governments closed down civic space, shrinking its oversight capabilities and considerably increasing democratic backsliding and risks of corruption.

In the Caribbean, the Dominican Republic (32) has gained four points in the CPI in the last two years by strengthening the independence of its justice and oversight bodies, enhancing transparency in public procurement, and enacting an asset forfeiture law a key legal instrument to combat corruption and organised crime. However, the slow pace of the judicial processes has hampered progress with convictions for corruption. There is concern in Dominican society that the courts are not living up to the strong national demand to advance in the fight against corruption and crime.

Guyana (40) has significantly risen in the CPI over the last 12 years, however recently the country has stagnated. The oil-rich nation must still place stronger emphasis on building a well-functioning democratic system and implement greater levels of transparency and oversight, especially in the extractive industry. #### High Doses of Vitamins Lead to Vitamin Toxicity

DEAR DR. ROACH: I have been diagnosed with vitamin D toxicity, according to the blood work from a month ago - my result was 122 ng/mL. I was taking high doses of vitamin D3 in pill form (15,000 IU a day for three years) bought from a drugstore. I have stopped taking it, but I need to know how long it will take to have a normal amount in my body. (Weeks, months?) Can you shed any light on this question? I would like to take it again when my level comes down, but in a lower amount. Also, by any chance, would the high amount of D3 in my system have any correlation to a diagnosis of stenosis of the aortic valve? - C.I.

ANSWER: Vitamin D toxicity is not common. I have seen one case in my career requiring hospitalization, due to a very high elevation of the blood calcium level. Vitamin D increases absorption of calcium from food through the intestines.

In addition, calcium can come out of bones in people with very high levels of vitamin D. With high vitamin D levels, calcium levels can also become dangerously high. Common symptoms of very high calcium levels include constipation, nausea and vomiting, muscle weakness, kidney stones, and neurological symptoms, including poor concentration and fatigue. These symptoms tend to happen at levels higher than yours, above 150 ng/mL. Years of high calcium levels can absolutely cause existing heart valve disease to worsen quickly.

In cases of acute intoxication from vitamin D, available treatments include steroids and pamidronate (an injectable medicine similar to alendronate and other drugs used to treat osteoporosis), which can quickly bring the calcium levels back down to normal.

Without this kind of intervention, a vitamin D level will still come down on its own, only more gradually. Vitamin D3 is removed slowly from the body, because it can go into fat tissue. It takes about two months for half the excess to be removed from the body. but because the active forms are removed more quickly, toxicity from excess vitamin D3 usually only lasts for weeks, not months. Still, you are likely not to need any vitamin D for many months, and if you do take it again, do not exceed the safe dose of 5,000 IU a day. I recommend you also get your blood levels tested. Recent studies have questioned the benefit of supplemental vitamin D for most people, although some people, such as those with osteoporosis and low vitamin D levels, probably still benefit.

I'm very glad you wrote. Many people still don't know that excess of some vitamins can occasionally be dangerous. Vitamin A is the other vitamin where high levels can be very dangerous.

DEAR DR. ROACH: I am a 67-year-old female who has been unable to tolerate both liquid and pill forms of colonoscopy preparations. Therefore, my gastroenterologist has been unable to complete a colonoscopy on me. What are my other options? — F.K.

ANSWER: I would consider an alternate form of colon cancer screening. Home stool tests look for blood and DNA for colon cancer, or both. The data on Cologuard (a commonly available brand) show that it isn't quite as good as a colonoscopy, but much better than not receiving a screening. However, if the result is positive, you will certainly need additional testing, which calls for preparation, possibly requiring you to get the preparation done under supervision.

This is a waste of taxpayer cash, and the marginalized frequently outlasts politician in office, in any event.

The vindictive politician is the classic "Jekyll and Hyde." He or she possesses two faces and is adept at presenting a pleasant face to friend, and an ugly face to foe. It is easy to read these people. Eventually that ugly

side over-rides the friendlier side, and his enemies become as cantankerous as the bad acting politician is. Victimization is bad politics. In a small community especially. Word gets around. In four to five years, the politician needs to return to Jack and Jill Voter if he or

she wants to return to office. An angry Jack or Jill will view the polling booth as the place of "payback." Angry Jack is also the source of discontent that mushrooms into a mob against Julius Caesar at an election.

A pool of enemies makes that proposition of return after an

election for the politician harder, much harder. The maxim is wholly appropriate for Julius Caesar if he is wise: "keep your friends close, but your enemies closer."

# Strong CARICOM-Canada solidarity on Haiti



(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Friday, 17 February 2023): Solidarity is strong between Caribbean Community (CARICOM) and Canada to help foster solutions to the crisis in Haiti.

Addressing the 44th CARICOM Summit as a special guest on Thursday 16 February in Nassau, The Bahamas, Prime Minister of Canada, Rt. Hon. Justin Trudeau, announced that Canada plans to deploy Royal Canadian Navy vessels to conduct surveillance, gather intelligence and maintain a maritime presence off the Haitian coast, in the coming weeks.

This assistance comes as "Canada continues to reinforce the capacities of the Haitian police to overpower armed gangs and hold those who support them accountable," Prime Minister Trudeau said.

"The toll of human suffering in Haiti weighs heavily on me," he told the Conference adding that the situation in Haiti hits not only in the Region but also in Canada where there is a large Haitian diaspora.

Chairman of CARICOM, the Hon. Philip Davis, Prime Minister of The Bahamas, told the opening ceremony of the Conference on 15 February that the Community "is in vigorous agreement" that the crisis in Haiti requires urgent attention.

"We will all benefit if Haiti is again a fully-functioning state," the Chairman said. He urged his colleagues to "learn from the failures of past efforts to help, rather than use those disappointments as an excuse for inaction."

Prime Minister Davis expressed optimism about an agreement on "a series of concrete steps to help move towards a solution for the Haitian people, and the Region as a whole."

These sentiments were echoed by outgoing Chairman of CARICOM, His Excellency Chandrikapersad Santokhi, President of Suriname, as well as the Secretary-General of CARICOM, Dr. Carla Barnett.

"Our sister nation, Haiti, is in need of our concrete, and feasible assistance. We must support the Haitian people," President Santokhi stated in his address to the Conference.

He said that democracy, free and fair elections, rule of law and the protection of fundamental human rights are core values in the Region, and these must be fostered and protected in Haiti.

"We will have to show the resilience and fortitude of the Haitian people as we strive to overcome challenges and advance the initiatives to improve the lives of all citizens of our Caribbean Community," the Secretary-General stated in her remarks at the opening.

Prime Minister Trudeau told CARICOM Heads that Canada's "fundamental objective" in supporting Haiti was to ease the suffering and empower the people to chart their own future.

"Now is the moment to come together to confront the severity of this situation," he said urging solutions that would restore order and security, allow essential aid to flow to those in urgent need of it, and create the conditions for free and fair elections.

The Canadian Prime Minister informed that he had a "constructive conversation" with interim Prime Minister of Haiti, Hon. Ariel Henry, as Canada continued to support Haiti to address the political, security and humanitarian crises.

In that vein, he said Canada has deployed a surveillance aircraft, and vital strategic security equipment and vehicles to assist the Haitian National Police with tools and support to solve the security situation.

Over the coming days, it will also deliver Mine-Resistant Ambush Protected (MRAP) vehicles, Prime Minister Trudeau informed.

He also announced a sixth round of autonomous sanctions against two more individuals, in addition to 15 others Canada sanctioned for using their "influence and resources to support criminal gangs and fuel instability in Haiti."

## Biden, Stoltenberg Meet Bucharest Nine Leaders in Warsaw

WARSAW, POLAND — U.S. President Joe Biden and NATO Secretary General Jens Stoltenberg are in Warsaw Wednesday, to attend the summit of the Bucharest Nine, countries on NATO's easternmost flank; Bulgaria, the Czech Republic, Estonia, Hungary, Lithuania, Latvia, Poland, Romania, and Slovakia.

This little-known grouping is an initiative launched in 2015 by Romanian President Klaus Iohannis and Polish President Andrzej Duda. It is aimed at enhancing cooperation among NATO's newest members to support the alliance's objectives of improving security and stability between the Baltic and Black Seas.

Biden is set to reaffirm U.S. commitment for B-9 security, whose members joined the military alliance after being under Russia's sphere of influence during the Cold War and are now looking at Moscow's expansionist ambitions with concern.

"The president looks forward to talking about NATO's shared commitment to

freedom and democracy, which Ukraine is fighting to defend, and the critical leadership many of our allies on the eastern flank have provided as together we have strengthened NATO to meet any threat we may face," a National Security Council spokesperson told VOA.

Except for Bulgaria and Hungary, B-9 members are now among the strongest supporters of military aid to Ukraine and pushing back against Russia.

Hungarian Prime Minister Viktor Orban, who has vowed to maintain relations with Moscow, is not attending the meeting, sending President Katalin Novák in his place. Meanwhile, caretaker Bulgarian President Rumen Radev has been hardening his government's antiwar position, opposing the West's efforts to fortify Ukraine with weapons.

Despite some divergence on Ukraine, B-9 leaders are expected to pave the way for hashing out a common stance for a NATO summit in Vilnius, Lithuania July 11

Biden Tuesday used a speech in Poland's capital, Warsaw, to defend NATO's year-long effort to help Ukraine fend off Russia's invasion and vowed it would not stop.

"One year ago, the world was bracing for the fall of Kyiv," Biden told the over ten thousand Poles gathered outdoors at Poland's Royal Castle complex. "Well, I've just come from a visit to Kyiv, and I can report Kyiv stands strong. It stands tall. And most important, it stands free."

Fresh off his dramatic visit to the Ukrainian capital, Kyiv, on Monday, Biden assailed Russian President Vladimir Putin for the invasion he launched a year ago this Friday and said the Russian leader could just as easily end the warfare.

## Pope Francis Highlights 'Sad Anniversary' of Russia's **Ukraine Invasion**

Pope Francis Wednesday noted what he had brought "great pain in my heart." called the "sad anniversary" of Russia's fullscale invasion of Ukraine.

Speaking during his weekly general audience, the pope called the conflict an "absurd and cruel war."

"Let us remain close to the martyred Ukrainian people and ask ourselves: has everything possible been done to stop the war?" the pope said. "I appeal to those in authority over nations to make concrete efforts to end the conflict, to reach a ceasefire and to start peace negotiations."

Pope Francis has repeatedly called for peace since Russia sent its troops into Ukraine on February 24 last year. The day before the invasion, he urged all parties to avoid any actions that would cause people more suffering and said the threat of war

Ukrainian President Volodymyr Zelenskyy Tuesday accused Russia of "mercilessly killing" civilians in the southern city of Kherson following a missile strike that left five people dead and 16 others injured.

"A vehicle park, residential areas, a highrise building, and a public transport stop were hit," Zelenskyy said on the Telegram social messaging app. "The Russian army is heavily shelling Kherson. Again, mercilessly killing the civilian population."

"The world has no right to forget for a single moment that Russian cruelty and aggression know no bounds," the Ukrainian leader said. He posted photographs online showing corpses lying in the street.

Russia has denied targeting civilians.

don't differentiate my pace between long and short races."

Returning from sickness, Victor said the race was a challenge. "I'm trying to get back there and hopefully, the next one will be much better," he said. "Going up through Lower Estate (incline) was pretty challenging, but, as I said, next time will be better. No excuses. We'll be back."

James Ramprashad, a BVI Football Association referee, placed fourth and told Island Sun Sports that it was 'pretty amazing' as he's currently recovering from an injury. "It wasn't the fastest race I've done, but I had a really nice finish. James kept me going for most of the run and pulled me along and we finished really strong, so I'm really happy with the time."

# END SEXUAL VIOLENCE AGAINST WOMEN IN THE INTEREST OF MANKIND

Rape, and other forms of sexual violence against women in war and conflict, represent one of the great silences and suppressed issues in modern-day history.

Yet, women remain the greatest victims of war and other forms of conflict in many parts of the world. Recently, in Haiti, rape has become a weapon for members of the 200 gangs which now control 60 per cent of the Capital, Port-au-Prince. Women and girls are deliberately targeted for rapes, torture, kidnappings and killings. Tragic stories have emerged of schoolgirls being captured, gang raped and becoming pregnant; their lives stripped of dignity or choice.

In the war in Ukraine, rape is also used as a deliberate weapon of terror, or by soldiers taking advantage of their position to rape women in the absence of any deterrent. U.N. findings suggest thar the incidents of rape are underreported in Ukraine. Similarly, the number of rapes, reported in Haiti, are far less than accounts given by victims, who either have no means of making an official report or are too frightened to do so.

Women have been a target of war wherever it has occurred. U.N. statistics show that, in Rwanda, up to 500,000 women were raped during the 1994 genocide, in acts known as 'genocidal rape'; in Sierra Leone 60,000 women were raped during the civil war (1991-2002); in Liberia, 40,000 women were raped and mutilated (1989-2003); in Bosnia in Europe, 60,000 women were raped (1992-1995); in Democratic Republic of the Congo, more than 200,000 women were raped in a decade of conflict. None of this takes account of rapes that certainly occurred during conflicts in Central and South America.

Rape is prohibited, under the Rules of War, particularly the "Geneva Convention Relative to the Protection of Civilian Persons in Time of War (1949)", and its 1977 protocol. However, this prohibition is not a deterrent, since the governments, that send their soldiers into war, have not made rape, committed during conflicts, a criminal offence. Indeed, as has happened in the war against Ukraine, Russia has described reports of rape as lies.

Wars and conflicts create refugees who are forced into camps with little protection from predators — in some cases, officials who manage the camps. In such vulnerable situations, women again become victims.

Unacceptable and wrongful as is rape of women in wars and their aftermath, it is in daily life that violence against women, including rape, is most despicable and inexcusable. The situation cries out for action to end it. U.N. figures paint a grim picture.

Globally, an estimated 736 million women—almost one in three—have been subjected to physical and/or sexual intimate partner violence, or both at least once in their life. More than 640 million women aged 15 and older have been subjected to intimate partner violence. During the COVID-19 pandemic, violence against women increased dramatically.

It is significant that, globally, violence against women disproportionately affects low- and lower-middle-income countries and regions. Thirty-seven per cent of women aged 15 to 49, living in "least developed" countries, have been subject to physical and/or sexual intimate partner violence in their lives. Globally 81,000 women and girls were killed in 2020, around 47,000 of them (58 per cent) died at the hands of an intimate partner or a family member. This latter figure equates to a woman or girl being killed every 11 minutes in their home. In 58 per cent of all killings, perpetrated by intimate partners or other family members, the victim was a woman or girl.

While these figures are deeply disturbing, the silent acceptance of the situation is worse, condemning all societies in which such tolerance prevails.

Against this background, an international coalition of 2,100 women's rights advocates in 128 nations called "Every Woman", is proposing the adoption of a global treaty to

eradicate violence against women and girls. It is a treaty whose creation and adoption should be fully supported.

The treaty will not cause violence against women to end overnight, but it will be a potent international instrument that would bind governments to take the necessary legislative, preventative and protective measures to save millions of women from the killings and violence that now exist. The urgency for a global treaty is driven by the fact that, although several conventions have been adopted globally, and legal frameworks have been established nationally, violence against women has persisted. The existing frameworks have failed to deliver the strong measures that are clearly required.

In truth, many of the existing Conventions have serious gaps that have allowed governments to sidestep their responsibilities. And, even where Conventions have not been strong, some governments have not agreed to them. The global treaty seeks to remedy the obvious weaknesses and gaps in existing Conventions.

The government of Costa Rica, which has an outstanding record in advocating for human rights, has already endorsed the concept of a Global Treaty, recognizing that much more has to be done to protect women from violence. Caribbean governments and civil society should not hesitate to join in the treaty's promotion.

Even with the best will in the world, a global treaty cannot be negotiated, agreed and ratified with the swiftness it deserves. It could take years, by which time many more millions of women — mothers, daughters, sisters — will die or be seriously injured as victim of violence.

As the advocates of the treaty argue, "It's time to come together to outpace the violence with a concrete, clear and actionable solution. Women and girls are waiting. They are asking that we do better".

Women are restricted to contributing only 37 percent of global production even though they are 50 per cent of the world's population. Yet, a McKinsey Global Institute report finds that, by advancing women's equality, US\$12 trillion could be added to global output by 2025. The global circulation of that money would make a huge difference to the economic wellbeing of all countries.

Ending violence against women is in the interest of all mankind.

## Airbnb awards US\$250,000 sustainability grant to UWIhosted Global Tourism **Resilience Centre**

The UWI Regional Headquarters. Jamaica, W.I. Thursday, February 16, 2023—The Global Tourism Resilience and Crisis Management Centre (GTRCMC), hosted by The University of the West Indies (The UWI) was recently announced as a recipient of a sustainability grant from Airbnb, the online marketplace for short-term homestays and experiences.

The Centre was awarded US\$250,000 as part of Airbnb's Community Fund to support sustainability and conservation programs. Launched in 2020, the Fund aims to distribute US\$100 million through 2030 to help strengthen communities around the world.

The US\$250,000 grant will be used to support the Building Climate Knowledge, Attitudes and Awareness across the Caribbean (Project: C-KAP) led by the Centre, to help raise awareness among Caribbean Micro, Small and Medium Sized Tourism Entrepreneurs (MSMEs) about the importance of climate-responsible practices in their operations, as well as encourage them to take urgent action to combat climate

Project C-KAP's overall goal is to assess research/monitor, plan for, forecast, mitigate, and manage risks related to tourism resilience and crisis management. This will be achieved through four objectives which include research and development; policy advocacy and communication management; programme/project design and management as well as training and capacity building.

A statement on behalf of the Centre's Board of Governors noted, "We are excited to partner with Airbnb whose climate action corporate sustainability framework (which is committed to making Airbnb a Net Zero company by 2030), is in sync with one of the GTRCMC's mandates; that is, building tourism resilience capacities for climate action and for global sustainability."

Professor Sir Hilary Beckles, Vice-Chancellor of The UWI is among the Centre's Board of Governors, together with Professor Lloyd Waller from The UWI who also serves as Executive Director and the Honourable Edmund Bartlett, Jamaica's Minister of Tourism.

Within the Centre's workplan is the hosting its inaugural conference, the Global Tourism Resilience Conference-from February 15 to 17, 2023 at The UWI's Regional Headquarters in Mona, Jamaica. The conference is a first of its kind, a threeday event, designed to bring the global tourism community together to discuss investment opportunities, discuss and debate solutions to today's most pressing challenges, and increase cooperation for greater global resilience across the industry.

On the opening day of the conference, the Centre officially launched Global Tourism Resilience Day, which was initiated by Professor Lloyd Waller and designated by The United Nations General Assembly as an annual observance on February 17.
