#### VIP CANDIDATE ALLEGEDLY SPEAKS TO FORMER PREMIER

Marieta Flax-Headley, the Virgin Islands Party (VIP) Second District candidate, has addressed recent claims that she had to speak to former Premier Andrew Fahie before deciding to run for office. The allegation of the conversation were raised in early March incumbent Second District-Representative Progressive Virgin Islands Movement (PVIM) candidate Hon. Melvin Turnbull. While making the comment Hon. Turnbull alleged that even while facing criminal charges in the United States Fahie was still directing the VIP.

This allegation became a public sensation and as a result Flax-Headley sought to address the allegation during her launch. While noting the rumor the VIP Second District Candidate denied the allegations but acknowledged that Fahie is still her friend despite the criticism faced on the campaign trail.

"Let me make it clear, crystal clear, Hon. Andrew Fahie was and still is my friend. If you are my friend, you can rest assured that you have a friend, I am a friend for you in good times and in bad times. You won't have to worry about me kicking you to the curb when you are down but rest assured, I will lend a hand to help you out if you fall," she said.

Flax-Headley also extended her prayers to Fahie as he prepares to go before the judge, stating that she waits in anticipation for him to have his day in court.

#### WHO ENCOURAGED FLAX-HEADLEY TO RUN?

In-his-allegations incumbent Second District Representative-Hon. Turnbull alleged that Fahie had instructed Flax-Headley to run with the VIP. However, At-Large candidate Hon. Carvin Malone sought to discredit those claims during a subsequent VIP radio

program.

While referring to Hon. Turnbull's comments Hon. Malone said: "It looks as if you have made some people mad. They are talking all kind of mess about who instructed you and who did this and so forth and I know it was a family decision that you were making and you had to make sure that the people who are closest to you were comfortable with what you are doing. That is what it was and we will have to straighten that out."

During Flax-Headley's launch Premier and Minister of Finance Dr the Hon. Natalio Wheatley also addressed the comments that were made by Hon. Turnbull. He however did not explicitly deny consulting with Fahie over selection Flax-Headley's as the Second District candidate.

Nonetheless, the Premier

roundly rebuked the incumbent District Representative and Minister of Labour Hon. Turnbull, for making 'disrespectful' remarks about the matter.

The VIP Chairman stressed the importance of holding leaders accountable, even when it is uncomfortable, and credited Flax-Headley, his former teacher, with teaching him this important lesson. While also highlighting his friendship with Hon. Turnbull, the

Premier condemned what he said on the matter. Hon. Wheatley particularly called Hon. Turnbull out for referring to Fahie as 'Head Coach'.

While announcing that the name Hon. Turnbull used to refer to Fahie is derogatory, Hon. Wheatley said: "That 'who' he's calling the 'head coach' — which in my view is unnecessary. It's unnecessary regardless of what has taken place; still be respectful," Wheatley said.

The Premier also rebuked Turnbull's suggestion that the

VIP is still being controlled by Fahie, arguing that it was insulting to the intelligence of their supporters. He accused Turnbull of using the former Premier's misfortune against him and urged politicians not to use somebody's misfortune as a platform to prop themselves up. "You don't have to pull down a soul. You don't have to talk anything about a head coach," Wheatley stated. "You don't have to try to connect Marieta Flax-Headley, a distinguished woman, a woman of class, a woman of integrity and suggest that she cannot make up her own mind," Hon. Wheatley said.



### NDP HAS LEARNED FROM PAST MISTAKES: DR. PICKERING SAYS

Former Deputy Premier Dr. Kedrick Pickering has cleared the air about the split that led to the downfall of the National Democratic Party (NDP) in 2019. Speaking at the launch of Myron Walwyn's Sixth District Candidacy Dr. Pickering claimed that the National Democratic Party had voted themselves out of office by not staying united.

"There is nothing like people who can admit that you have made a mistake, and you are prepared to do what is right and move beyond. We are ready to take this country forward where we left off and take it in a direction," he said. Dr. Pickering acknowledged that the NDP was on a great

NDP was on a great trajectory, but they got carried away and made mistakes that cost them their position of power.He admitted that the split was the main reason why they lost the election, adding that they would have still been in office had they stayed together as a team.

"Listen to this, the NDP

voted themselves out of office, all of us know that if we had stayed together as a team, we would still be in office. All of us know that. I challenge anybody to tell you that under the National Democratic Party this country wasn't going places. Because we know this country was doing very well, but we were the ones who created the problems for ourselves but we realized that we made a mistake," he said. Despite their past mistakes, Dr. Pickering believes that the NDP has

learnt from them and is ready to take the country forward. He spoke of the many achievements made under the NDP, such as the negotiation of a \$65M loan with the Caribbean Development Bank after the 2017 hurricanes.


"Our country would have been well on the way if we had stuck to our plans, and moved ahead along the pathway," he said.

Dr. Pickering also emphasized the importance of unity and putting the country first. He spoke of his

#### THIRD DISTRICT WATER WOES GENERATE FIRM FINGER POINTING

The-Third-District Representative, Hon. Julian Fraser has placed the blame for his District's water crisis on his political opponents, and he is not mincing his words.

Speaking at the launch of his Progressives United (PU) campaign, the Third District Representative slammed the Virgin Islands Party (VIP) and the National Democratic Party (NDP), calling them out for their failures.

According to Hon. Fraser, District has been struggling with water shortages for decades, and he refuses to take the blame for it. He claimed that a plant commissioned during his tenure as Minister for Natural Resources & Labour with a previous VIP government produced more than enough water for the people of the Third District. However, the plant was closed by the NDP government in 2013, and no replacement was put in place.

Hon. Fraser went on to accuse his opponent, Kevin 'OJ' Smith, of being "right there" with the NDP at the time, and rebuked him for criticizing the state of the District's water distribution program now that he's running for office. "Now he's got the gumption to come talk about water shortage in Sea Cows Bay... Yeah, the people who you associate yourself with are responsible for it. I'm not taking blame for that." the District Representative said. Hon. Fraser also accused the NDP of installing a water line that was never connected to a water source, calling it a waste of money and a prime example of political nonsense.

#### WATER WOES MORE THAN 10 YEARS OLD

For years Hon. Fraser has faced his constituents

to lament the ongoing water situation. One such complaint was made at a 22 September 2016 community meeting. At that public meeting in 2016 Hon Fraser expressed his frustration, saying that the lack of water was an unconscionable act of discriminatory water shortage in the Third District. He also alleged that it was

part of a purposeful plan by the National Democratic Party (NDP) Government to punish the people of Sea Cows Bay for voting for him instead of their candidate in the last two general elections.

Hon Fraser called out the former government for its failure to complete the Meyers to Chalwell pipeline project and install the more important pipeline from Sabbath Hill to Meyers. He recounted how visitors had to bathe at Nanny Cay during the August holidays, as they were unable to get water in Sea Cows Bay. The lack of water was just one element in a purposeful plan by the NDP Government to punish the people of the Third District, he said.

Hon Fraser noted his disappointment in the then government's lack of progress in fixing the water shortage issue, saying: "There is no way that I can believe that this government actually cares about the people of the district and their water woes."

#### VIP POLITICIANS DISMISS RUMORS ABOUT BVI – UK RELATIONSHIP

Premier and Minister of Finance, Dr the Hon Natalio Wheatley has come forward to dispel rumors of a strained relationship between the United Kingdom (UK) and the BVI. During a recent broadcast of VIP's Let Talk radio program on 28 March, Hon. Wheatley joined Deputy Premier and Minister for Communications and

Work Hon Kye Rymer in stating that governance issues in the Territory were not as grim as opposing political candidates are claiming them to be.

Hon Rymer spoke first, dismissing rumors of a sour relationship with the United Kingdom and affirming that the BVI has had good dialogues with the UK in the spirit of a modern partnership.

The Deputy Premier revealed that he had just returned from the UK,

where he had been able to have a conversation with the Foreign Commonwealth and Development-Office (FCDO) on the progress of the Territory's reforms. Premier Wheatley echoed Hon Rymer's sentiments, stating that the BVI and UK have a good relationship without the need for a 'great negotiator' to save the Territory. He highlighted the negotiations that took place to prevent the suspension of the VI constitution, adding that the level of comfort with the BVI government is currently at an all-time high.

"The United Kingdom is happy to partner with us in our journey," Dr Wheatley declared.

## **BVI Ports Authority Attends Seatrade Cruise Global 2023**

Tortola, British Virgin Islands, 04 April 2023 – A delegation from the British Virgin Islands attended Seatrade Cruise Global 2023 on 27th- 30th March 2023 in Fort Lauderdale, Florida, USA. The delegation was comprised of individuals from the British Virgin Islands Ports Authority (BVIPA), Cyril B. Romney Tortola Pier Park (CBRTPP), British Virgin Islands Tourist Board (BVITB) and local cruise industry partners.

This year, the goal of the delegation was to be better together by

building and expanding on the relationships and partnerships with regional and international partners while charting the way forward for the cruise tourism industry in the Territory. ### **Operating Hours On Good Friday For Premises That Sell Liquor**

Businesses and premises on which intoxicating liquors are sold, exposed or kept for sale by retail are to be closed until 6:00 p.m. on Good Friday, April 7.

The Premier's Office is notifying the public that these establishments shall remain closed during this time acting in accordance

with Schedule 9 of the Liquor Licences Act, 2022, as referenced in Section 45(1).

Further, Section 45(5) further states, "A person who fails to comply with the provisions of this section and section 46 commits an offense and is liable on summary conviction

a fine not exceeding two thousand dollars and for any subsequent offence to a fine not exceeding five thousand dollars."

Section 46 of the Act prohibits a person from consuming liquor in and taking liquor from the licensed premises during the hours of closing.


Additionally, Section 47 stipulates that a person found on licenced premises during closing hours commits an offence and is liable on summary conviction a fine not exceeding one thousand dollars unless he or she can satisfy the court that his or her presence on such premises was not in contravention of the

provisions of the Act.

The particular hours of opening and closing for premises on which liquor is sold are dependent on the type of licence granted to the establishment. Businesses and the public are asked to note and comply with the operating hours designated for Good Friday.

### 20 Years Of Child Abuse Prevention And Awareness



## A Tiny New Caribbean Adults-Only Hotel

Virgin Gorda has its share of traditional hotels, luxury resorts, beachside villas, and sailor's havens, but an adults-only French country inn is definitely a first for the island — and the British Virgin Islands as a whole.

The British and French are centuries-long rivals, so perhaps it's appropriate that this international matchmaking was pulled off by a pair of Americans, albeit both longtime BVI residents. Memphis-born Rose Giacinto and New Yorker Inge Judd are the co-innkeepers of the Inn at Cornucopia, a new five-suite luxury inn near the Baths, by far the top visitor attraction in the BVI.

Giacinto is best known as the founder and manager of the Chez Bamboo and Bath & Turtle, a combination bar/restaurant/coffee house that's one of the culinary and entertainment hot spots of Spanish Town. Judd is a longtime executive search professional who has been a BVI "belonger" for more than half a century.

"The best thing I can say about coming to Cornucopia is you get both Rose and Inge," says Judd. "Both of us have been in the 'people business' forever and we both love it. With Rose having years of restaurant hospitality and my being a seven-continent, high-end traveler plus my years of business experience, running an inn is an extension of our love and expertise. And our bonus is having created this beautiful place to work in and care for."



The BVI has other small inns and B&Bs, of course, but the Inn at Cornucopia is unique in its level of service and European flair, which includes a gourmet breakfast included daily, concierge and local transfer services, and custom furnishings brought together by Judd. Breakfast opens with a Bloody Mary or an islandinspired passionfruit Bellini, and continues with egg dishes, specials like French toast and Quiche, charcuterie and homemade vogurt. Afternoon drink service is provided, too. "Historically the territory has had hotels, resorts and villas," says Judd. "All offer different types of accommodations. Hotels are just that, rooms for rent. Resorts like Little Dix Bay or Long Bay have services, amenities, are usually large, and usually quite costly. Necker Island, Mosquito and Oil Nut Bay are out of the financial range of most people. And villas, well, you need to book the entire property and there is usually a minimum of 7 days."

"Cornucopia is an inn: just 5 visually beautifully en-suite rooms full of antiques, ironed and starched linen, and all rooms with either balcony or terraces," explains Judd. "We are an option for sailors wanting to spend a few days on land, we are available for villa guests who just need a few extra nights on island." And, of course, the inn is a standalone option for travelers looking for a different kind of BVI vacation experience.

If you've stayed at an upscale small inn in the U.S., picture that level of dining, service, and accommodation, but in the Caribbean. Rooms have vaulted ceilings and private patios looking out over the boulder-strewn landscape of the Baths, some with water views. And it's one of the rare resorts in the BVI that welcomes pets — at least, cats and dog under 20 pounds (there's also a special menu for furry travel companions).

Children, however, are invited to stay home: this inn is adults-only. The inn at Cornucopia is not on the beach, but it's a short walk to the Baths and even closer to Little Trunk Bay and Spring Bay, the latter a public park. Dining and nightlife options in walking distance include the Top of the Baths restaurant (which also has a pool) and the Mad Dog and Poor Man's bars. A three-night minimum stay is required.

"We are now open receiving and

welcoming guests," said Judd, "and I am loving getting up every morning, staying challenged and making things happen."

HILLSDALE, Mich. (AP) -A Michigan college has ended its partnership with a Florida charter school whose principal was forced to resign after a parent complained sixth graders were exposed to pornography during a lesson on Renaissance art that included Michelangelo's David sculpture.



Hillsdale spokesperson said Tallahassee Classical School no longer is affiliated with the small, Christian classical liberal arts college in southern Michigan, MLive.com reported Thursday.

"This drama around teaching Michelangelo's 'David' sculpture, one of the most important works of art in existence, has become a distraction from, and a parody of, the actual aims of classical education,"spokesperson Emily Stack Davis wrote in a statement. "Of course, Hillsdale's K-12 art curriculum includes Michelangelo's 'David' and other works of art that depict the human form."

Tallahassee Classical School was licensed to use Hillsdale's classical education curriculum, but its license was "revoked and will expire at the end of the school year," Davis said.



PARIS -For or against electric scooters for rent? This is the question that Parisians of legal age who registered on the electoral rolls of the French capital will be able to answer. The popular consultation, which will take place this Sunday, will determine the future of these electric vehicles in the city, one of the first to open up to this personal mobility market. The mayor, Anne Hidalgo, has said loud and clear that she wants to ban them because she considers them dangerous, environmentally

unfriendly and a source of conflict in the public space.

The scooter craze has not waned since they arrived in the French capital in 2018, when more than 12 operators offered their services. The devices have proliferated across the city's wide boulevards, but also on its narrower streets and on the hundreds of kilometers of bike lanes that authorities have built in recent years. Their growing use, however, has been accompanied by criticism and controversy due to their difficulty in coexisting with pedestrians, motorists and cyclists, and the fact that they obstruct some sidewalks. [El

ROME - Italy's Association of Rainbow Families rallied in Bologna Sunday to def end the rights of same-sex couples to have their children recognised by the state, which the rightwing government has stopped.



"A clearer law is needed," said Bologna's centre-left Mayor Matteo Lepore, referring to the supreme court ruling that the government has used to stop mayors registering the children

of gay couples, but which appears to be open to interpretation.

Several hundred people defied steady rain to attend the Bologna rally, held in the iconic central Piazza Maggiore.

The mayor of the northwestern port city of Savona, Marco Russo, on Saturday became the latest local official to flouted the government ban and register the son of two women.

Thechild, conceived in Barcelona with the assisted fertility of one of the women, was born in Savona earlier this week.

It was the first case of registration of the child of a samesex couple in Liguria since the government stopped the practice.

Russo explained his decision to prosecutors and the prefect saying that he had signed the act personally without involving any other functionaries."I challenge the ban, the government is far away from reality", he said. [ANSA] ROME - CNN -Italians who


use English and other foreign words in official communications could face fines of up to €100,000 (\$108,705) under new legislation introduced by Prime Minister Giorgia Meloni's Brothers of Italy party. (pictured here)



Fabio Rampelli, a member of the lower chamber of deputies, introduced the legislation, which is supported by the prime minister.

While legislation the encompasses all foreign languages, it is particularly geared at "Anglomania" or use of English words, which the draft states "demeans and mortifies" the Italian language, adding that it is even worse because the UK is no longer part of the EU.

The bill, which has yet to go up for parliamentary debate, requires anyone who holds an office in public administration to have "written and oral knowledge and mastery of the Italian language." It also prohibits use of English in official documentation, including "acronyms and names" of job roles in companies operating in the country.

### Ladyburd Talks...

Dear Readers: Kite flying is a popular tradition in the Caribbean, especially on Easter Monday, when families and enthusiasts take to open spaces to display various kites of shapes and sizes either for leisure or in competition.

Like any other aerial sport, there are safety rules which should be followed to ensure no one is hurt during kite flying as well as property is not damaged.

#### Here are five rules for safe kite flying:

#### 1.Do not fly kites near power lines

Kites should not be flown in yards or spaces that are close to overhead power lines. Your kite flying line can be used as a path for electrical current. If your kite become stuck on a power line, do not try to remove it yourself. Contact your local utility company if the kite poses a danger to others and needs to be taken down.

#### 2. Do not fly kites near airports :

Most airport authorities will issue warnings about the dangers of flying kites in the vicinity of a space with air traffic. Playing with a kite near these areas could distract pilots as well as be ingested into aircraft engines. This could place persons' lives at risk on the ground as well as those within an aircraft.

#### 3. Do not fly kites during stormy weather:

It is never a good idea to fly a kite when it is raining or when the weather is stormy. A wet kite string can become a conductor of electricity if there is lightning when there is inclement weather. also, do not use a metallic flying line on your kite.

#### 4. Be aware of your surroundings :

When choosing a spot to fly your kite, make sure you are not too close to other kite flyers as everyone is trying to enjoy the space. Also make sure you are not flying your kite over or near other people as a kite falling on someone depending on the size, as well as someone becoming entangled in the flying line, could result in injury. And, to avoid injury to yourself always be aware of any objects, holes on the ground in front or behind you to prevent falling over.

#### 5. Choose your kite size wisely:

Think about your strength and the size of the kite you could manage when the wind begins to pick up. You might have to consider wearing gloves to prevent injury to your hands if flying a giant kite.

Keep in mind that you should not fly a kite that you cannot control. Have fun!!

## These show-stopper cookies are perfect for Easter

Springtime Perfection: Easy and Colorful Meringue Cookies With a Secret Twist!

Could these cookies be any more perfect for springtime? I think not. They're sweet, pastel and light as a feather. The technique of making meringue has been used in European baking since the 17th century and is a staple ingredient in classic desserts like pavlova and lemon meringue pie.

While they look impressive, they're astonishingly easy to make. And if I can make these, you can make these. Let everyone think you moonlight as a pastry chef in a French patisserie. It'll be our secret.

Speaking of secret, there's an unexpected ingredient in these meringue-based cookies. We use gelatin dessert powder (such as Jell-O brand). Besides giving these cookies their beautiful colors and fun fruity flavors, the gelatin makes the meringue exceptionally stable and very easy to work with. The stable texture makes using a piping bag with a tip to create beautiful flower shapes easy and fun.

I imagine my dear readers rolling their eyes thinking, "She's lost her mind. Not only is she expecting us to make meringue, but she wants us to use a piping bag." Believe me, I used to be scared of both things, too. But as I said, if I can do this, anybody can. If you can use a mixer, you can make

meringue. You simply whip the egg whites, adding sugar and gelatin powder. If you choose not to pipe them, just plop by the spoonful and bake. Using a piping bag is great fun. I have no piping skills whatsoever! The internet is filled with easy instructional videos. You can invest in some reusable bags and a few tips for under \$5. Any mistakes you make you can scoop back into the bag and try again. Or just eat them. I won't tell.

#### PASTEL MERINGUE COOKIES

Yield: approximately 36 cookies
Total Time: 2 1/2 hours
4 egg whites
1/4 teaspoon cream of tartar
1/2 cup sugar

1 (3 ounce) box gelatin, any flavor

25 F. Carefully separate egg yolks from the whites, taking care that absolutely no yolks get in the whites. Reserve yolks for another purpose.

In a completely clean and dry mixing bowl, beat egg whites and cream of tartar on high speed. When whites reach soft peak stage, gradually add the sugar one tablespoon at a time. Continue to beat until stiff peaks form. Turn mixer to low and gradually add gelatin powderuntilincorporated.

On a parchment lined baking sheet, drop mixture by tablespoonfuls or use your piping bag fitted with a decorative tip to pipe meringue mixture



into shapes as desired. Bake for 1 hour, then turn off heat. Without opening the oven door, leave them in the oven for another hour to further dry.

Once dried, these cookies can be stored in an airtight container at room temperature for up to a week, or in the freezer for up to a month.

I made these cookies using five flavors of gelatin. Pineapple was the family favorite, but each flavor was enjoyable.

## Monday, May 8 and Friday, June 16 have been declared public holidays.





## VOA NEWS VOA NEWS VOA NEWS Finland Joins NATO in Major Blow to Russia Over Ukraine War

BRUSSELS -

Finland joined the NATO military alliance Tuesday, dealing a major blow to Russian President Vladimir Putin with a historic realignment of Europe's post-Cold War security landscape triggered by Moscow's invasion of Ukraine.

The Nordic country's membership doubles Russia's border with the world's biggest security alliance. Finland had adopted neutrality after its defeat by the Soviets in World War II, but its leaders signaled they wanted to join NATO just months after Moscow's invasion of Ukraine sent a shiver of fear through its neighbors.

The move is a strategic and political setback for Putin, who has long complained about NATO's expansion toward Russia and partly used that as a justification for the invasion.

"I'm tempted to say this is maybe the one thing that we can thank Mr. Putin for because he once again here precipitated something he claims to want to prevent by Russia's aggression, causing many countries to believe that they have to do more to look out for their own defense and to make sure that they can deter possible Russian aggression going forward,"

U.S. Secretary of State Antony Blinken said before accepting the documents that made Finland's membership official.

The U.S. State Department is the repository of NATO texts concerning membership.

Russia warned it would be forced to take "retaliatory measures" to address what it called security threats created by Finland's membership. It had also warned it would bolster forces near Finland if NATO sends any additional troops or equipment to what is its 31st member country.

The alliance says it poses no threat to Moscow.

Alarmed by Moscow's invasion of Ukraine last year, Finland, which shares a 1,340 kilometer (832 mile) border with Russia, applied to join in May, setting aside years of military nonalignment to seek protection under the organization's security umbrella.

"It's a great day for Finland and an important day for NATO, too," said Finnish President Sauli Niinisto. "Russia tried to create a sphere around them and, well, we are not a sphere. I'm sure that Finns themselves feel more secure, that we are living in a more stable

Neighboring Sweden, which has avoided military alliances for more than 200 years, has also applied. But objections from NATO members Turkey and Hungary have delayed the process.

Niinisto said Finland's membership "is not complete without that of Sweden. The persistent efforts for a rapid Swedish membership continue."

Earlier, Russia's Foreign Ministry said Moscow "will be forced to take military-technical and other retaliatory measures to counter the threats to our national security arising from Finland's accession to NATO."

It said Finland's move marks "a fundamental change in the situation in Northern Europe, which had previously been one of the most stable regions in the world."

Kremlin spokesman Dmitry Peskov said Finland's membership reflects the alliance's anti-Russian course and warned that Moscow will respond depending on what weapons NATO allies place there. But he also sought to play down the impact, noting that Russia has no territorial disputes with Finland.

It's not clear what additional military resources Russia could send to the Finnish border. Moscow has deployed the bulk of its most capable military units to Ukraine.

NATO Secretary-General Jens Stoltenberg said no more troops would be sent to Finland unless it asked for help.

The country is now protected by what Stoltenberg called NATO's "iron-clad security guarantee," under which all member countries vow to come to the defense of any ally that comes under attack.

But Stoltenberg refused to rule out the possibility of holding

more military exercises there and said that NATO would not allow Russia's demands to dictate the organization's decisions.

"We are constantly assessing our posture, our presence. We have more exercises, we have more presence, also in the Nordic area," he said.

Finland's Parliament, meanwhile, said its website was hit with a socalled denial-of-service attack, which made the site hard to use, with many pages not loading and some functions not available.

A pro-Russian hacker group known as NoName057 (16) claimed responsibility, saying the attack was retaliation for Finland joining NATO. The claim could not be immediately verified.

The hacker group, which has reportedly acted on Moscow's orders, has taken party in a slew of cyberattacks on the U.S. and its allies in the past. Finnish public broadcaster YLE said the same group hit the Parliament's site last year.

Finland's entry, marked with flag-raising ceremony at NATO headquarters, falls on the organization's very own birthday, the 74th anniversary of the signing of its founding Washington Treaty on April 4, 1949. It also coincides with a meeting of the alliance's foreign ministers.

#### **Trump Pleads Not Guilty on 34 Counts Related to Hush Money Indictment**

Former U.S. President Donald Trump pleaded not guilty Tuesday in a state court in Manhattan to 34 charges linked to a \$130,000 hush money payment to porn actress Stormy Daniels just ahead of his 2016 presidential election victory to silence her about her claim of an alleged tryst with him a decade earlier.

It is the first indictment ever filed against a current or former U.S.

Trump has long denied her claim of a one-night encounter but not that his one-time lawyer and political fixer, Michael Cohen, made the payment to Daniels and that reimbursement payments to Cohen were recorded on a Trump Organization business ledger as legal expenses. Trump disputes the payment was related to his presidential campaign seven years

The 76-year-old Trump oversaw his real estate business empire and was a fixture in the city's glitzy, tabloid social world for decades before becoming president. But now for the first time, he was appearing in his home city as a defendant, even as early national polls show him leading the race for the 2024 Republican presidential nomination as he tries to reclaim the White House.

Americans are sharply divided politically about Trump and long accustomed to watching his every move on television. But in an age of mass media and constant videos of his life throughout the country, they won't be able to watch Trump in court. New York State Supreme Court Justice Juan Merchan rejected media requests to televise the proceedings but said he would allow a pool of photographers to take pictures of Trump and others just before starting his arraignment.

The indictment against Trump remained sealed, so the exact charges and any supporting evidence could remain secret until it is publicly disclosed during the arraignment.

Shortly before, Trump was booked and fingerprinted like any criminal defendant. But authorities say in deference to his standing as a former president, he was unlikely to be handcuffed or paraded before photographers in a so-called "perp walk." It was not immediately known whether a mug shot was

Dozens of police assembled at the

courthouse and at Trump Tower six kilometers away, where Trump spent the night at his residence and had last-minute strategy talks with his lawyers. Trump's Secret Service detail mapped out his passage into the courthouse and his walk to Merchan's courtroom. The White House declined to discuss security arrangements but said the government is "always prepared" for whatever might unfold if protests erupt for or against Trump and District Attorney Alvin Bragg, the prosecutor in the case. Before the court hearing, pro-Trump demonstrators scuffled with some of his detractors in a park across

the street from the courthouse.

New York City Mayor Eric Adams warned that "rabble rousers" coming to the city to protest had better behave.

"Our message is clear and simple: Control yourselves. New York City is our home, not a playground for your misplaced anger," he said.

When asked if he thought there would be unrest in the city, President Joe Biden, who was touring a factory in Minnesota on Monday, replied, "No. I have faith in the New York Police Department."

50th BVI Spring Regatta ends with 'closest finishes we ever had'

It was fitting that the competitive 50th BVI Spring Regatta would have the offspring of co-founder and longtime chairman Peter Haycraft battling in the event he dedicated his life to.

And officials could not have asked for a better final day than having one race in 20 knots breeze to determine three of the 10 classes with a tie breaker, while settling final podium finishes in five classes, to wrap up three days of competitive racing.

In the Sport Multihull Division, the BVI's Chris Haycraft on "Ting a Ling 2", a Corsair F31, entered Sunday tied on 14-14 points, with his son Nathan on his Corsair F27, "Ting a Ling." Nathan placed fourth in his penultimate race on Saturday, after leading from day one, while Chris won the day's last two races, setting up the father son showdown, in the event their respective father and grandfather helped found in 1972. Chris won Sunday's decider to finish with 17 points to claim the division with Nathan third in the final race, to place second on 19. Barney Cook's

Corsair Sprint 760R was third with 26.

"We tried really hard but it came down to seconds," Nathan told Island Sun Sports. "It was really fun. I'm really honored to race against my pop. It's a shame he beat us but at the same time, I'm happy with the result."

Chris said it was a tough weekend. "We finally won. It was down to the last race, 10 seconds," he noted. "We had to rethink our strategy. He got the boat moving faster than when I sailed it, because he was closer that we expected. It was great to have him out there."

St. Thomas' Peter Corr put up six picket fences and finished no less than second in nine races on his Summit 40 "Blitz" to win the CSA 2 division comfortably with 11 points. Great Britain's Tony Mack's J-122 "McFly on El Ocaso" was second with 17 and the BVI's Sam Talbot's J-111 Spike, in third on 29.

"I think we've gotten better and better," Corr said. "All the prerace stuff makes you a winner. I can win or lose. It's fine because I enjoy it so much. But the fact of the matter is, it's better to win than lose."

"Lady M" opened the door for a 9-9 tie with Puerto Rico's Luis Balzac's Salona 44 "Paroma" in CSA Performance A, after finishing fifth in race four, while Balzac won Saturday's last race. Then Balzac slipped to fourth in Sunday's finale, while Christian Cabral won and leap frogged him into second with 13 points-one behind division winner, Rodriguez. "I was very tough this year. We had to work very, very hard to win it," Rodriguez said. "Sometimes we didn't think we'd make it, but at the end, we put out the effort as a team and we came through. We're very happy.'

Woody Cullen of the USA Swan 58 "Wavemaker" was nursing a one point 8-9 edge in the CSA 1 division after a third place penultimate race finish Saturday, while Great Britain's Dr. Laura Schlessinger Lombard 46 "Pata Negra" made a move with a victory in race four and France's Sjoerd Bos' First 53 "Yagiza" finishing second, tying both at 9-9 for second. Dr. Schlessinger dropped bullets in the final two races to win the division with 11 points. Bos, who had tied Cullen on 11 in the penultimate race, was second to finish with 13 points while Cullen's By Dean "The Sportsman" Greenaway





## CORPORATE TRANSPARENCY WAS HIGH ON THE AGENDA DURING THE SUMMIT FOR DEMOCRACY MEETINGS

#### By Transparency International

This week, the European Parliament made a full suite of progressive amendments to draft legislation to increase EU's defences against dirty money. From bolstering the powers of the forthcoming anti-money laundering authority to fixing risky investment migration schemes, the Parliament is tightening the screws on the corrupt – much like we have been suggesting for years.

We are particularly happy – and relieved – to see proposals for reforming EU's corporate transparency framework. The Parliament has fully considered our concerns and included strong measures for

ensuring that civil society, media and academia are able to find out who's behind anonymous companies created across the EU.

This may not seem like a big deal considering that EU rules previously required governments to disclose information about companies' real or beneficial owners to the wider public. Late last year, however, the EU's highest court struck down the anti-money laundering provision which guaranteed that.

Right now, EU policymakers are in damage-control mode, and understandably so. Going forward, they will need to find a solution outside the anti-money laundering framework to bring back public access to the registers. After all, as the new paper from Transparency International's Anti-Corruption Helpdesk outlines, beneficial ownership information helps ensure transparency in business-government relationships, combat tax abuse, eliminate dark money in politics and defend against foreign interference.

For all these reasons, corporate transparency

was high on the agenda during the Summit for Democracy meetings happening this week. Convened by the US government, the summit brought together country leaders to discuss how they can rescue democracy from its many threats, including corruption. The regional meeting hosted by South Korea, which we helped design, was specifically dedicated to anti-corruption.

One of the summit outcomes announced by the US government is a commitment from 20 countries to enhance corporate transparency in line with the new global standard, which was adopted following our campaign. While an unequivocal pledge is welcome, it's hardly ambitious: along with 180 other countries, they have to follow the standard. In the US itself, the federal government has been working to develop rules to operationalise the register following the passage of the historic Corporate Transparency Act in 2021.

Clamping down on corporate secrecy in a major financial centre like the US can really advance the fight against illicit financial flows, to which African countries are particularly vulnerable. That's why our vice chair Rueben Lifuka – who joined the summit meetings in Zambia – has penned an opinion piece urging the US government to

finalise its rulemaking quickly and flawlessly.

In recent weeks, there has been some justified anxiety over the proposed reporting form that companies would have to fill out. In a self-defeating manner, it contains fields which would allow entities to claim that they are unable to obtain information on their true owners. Our colleagues in the US, other civil society groups and even lawmakers have expressed serious concerns, and now the government is reportedly reconsidering its approach.

Another pending issue relates to the regulation on who will be able to obtain the information and how. As currently drafted, the rule envisions unnecessary access barriers for foreign authorities investigating

schemes where anonymous companies formed or registered in the US pop up. So together with Transparency International US and 30 of our chapters we are asking the US government to address this.

More positively, in neighbouring Canada, our colleagues are applauding the government for proposing strong legislation to implement the long-awaited register. As previously announced, it will be public and free to use. This means that investigators, civil society and media around the world will be able to see who's behind dodgy Canada-registered companies.

We'll take all these wins. But as with all good things in life, progress takes hard work and vigilance. Together with our movement, we'll be watching closely to see all these reforms through to the end.

Meanwhile the European Parliament has agreed its position on the draft EU legislation to increase the bloc's defences against dirty money. The joint committees on economic

affairs (ECON) and home affairs and civil liberties (LIBE) – who co-lead on this legislation on the side of the European Parliament – have adopted a series of ambitious amendments to the anti-money laundering package proposed by the European Commission in July 2021.

Now the EU Council, Commission and Parliament will begin negotiations to reach an agreement on the final legislation for implementation by member states. Transparency International welcomes the strong measures included in the European Parliament's amendments, particularly revisions to the proposed 6th Anti-Money Laundering Directive, and encourages the Council to accept them.

Maíra Martini, corrupt money flows expert at Transparency International, said: "The need to enhance the EU anti-money laundering package gained new importance after the EU's highest court struck down public access to company beneficial ownership registers late last year. We commend the European Parliament for responding to the current challenges and proposing provisions which, if adopted, will prevent the EU from sliding back into the corporate secrecy era."







## UN CLIMATE JUSTICE SUCCESS SHOULD ENCOURAGE SMALL STATES TO ACT TOGETHER

Efforts by small states to seek justice for damage and existential threats to their countries, caused by the world's major environmental polluters, moved a step further at the United Nations General Assembly (UNGA) on March 29.

By consensus, the UNGA adopted a resolution seeking an International Court of Justice (ICJ) advisory opinion on climate change.

The resolution asks the ICJ to clarify states' obligations regarding climate change, including their human rights obligations to reduce greenhouse gas emissions. It also asks the court for guidance on questions of accountability for "states that have caused significant harm to the climate," and to small island states.

The adoption of the resolution demonstrates the soft power of developing states when they act collectively in international fora. While the resolution was proposed by the Pacific Island of Vanuatu which did remarkable diplomatic work to build the consensus that eventually led to UN GA adoption, 18 other countries formed a core group in advancing it. Antigua and Barbuda was the only Caribbean country in the core group.

By the time of the UNGA'S adoption of the Resolution the core group had secured co-sponsorship by more than 130 states. Antigua and Barbuda is also a co-founder of another UN-registered Commission which is utilizing the international legal system and its institutions to seek climate justice. This body is the Commission of Small Island States on Climate Change and International Law (COSIS) which is seeking an advisory opinion from the International Tribunal of the Law of the Sea (ITLOS).

Unlike the Vanuatu initiative, which will now have to await formalities from

the ICJ about the procedures for the submission of memoranda and a date

for hearings, COSIS has already received confirmation from ITLOS for a first hearing on September 12 in Hamburg, Germany. Vanuatu is one of the six core members of COSIS which is co-chaired by the Prime Ministers of Antigua and Barbuda and Tuvalu, Gaston

Browne and Kausea Natano, both of whom will attend the ITLOS hearing in Hamburg.

These efforts by small island states to use the international legal system for climate justice arise from the failure of meetings of the UN Conference of the Parties (COP), which have produced little or no benefits for them.

Small Island states are the greatest victims of climate change and global warming, although they collectively contribute less than 0.1 per cent of Global Green House Gas emissions - CO2.

The latest UN report is clear that human activity is responsible for virtually all global heating over the last 200 years; the rate of temperature rise in the last half century is the highest in 2,000 years; and concentrations of carbon dioxide are at their highest in at least 2 million years.

Thirteen countries are currently responsible for 68 per cent of the world's CO2 emissions. Of the 13 countries, 4 of them - China, the United States of America, India and Russia - account for 55 per cent.

Much irreversible damage has already been done to many countries and to millions of people. The planet Earth - our one homeland - has also been wounded with consequences for all. Communities in many countries have been displaced by extreme weather In Antigua and Barbuda. all the inhabitants of Barbuda were dislocated in 2017 by Hurricane Irma. Similarly, in 2019, Hurricane Dorian decimated the Abacos Islands, in The Bahamas, dislodging the entire community. Effectively, these persons were "Climate refugees" - a classification which has not yet been accepted in international law or in international provisions. Economies of Island Sun

developing states, especially small island states, are repeatedly set back by extreme weather events. All of these small economies have incurred burdensome debt to rebuild destroyed countries and to try to build resiliently for the future.

Current global financial flows for adaptation, including from public and private finance sources, are insufficient and constrain implementation of adaptation options in developing countries.

A World Bank report recently revealed that "richer countries, which significantly expanded their economies over the last decades, were the largest contributors of CO2 emissions, while small states are the most affected and face the most significant costs of adaptation." While the polluting nations get richer, the suffering nations get poorer. The injustice cannot be more blatantly obvious.

The plea for compensation for loss and damage by small countries was only reluctantly considered at COP27 and appears to have been pushed off into a committee to make recommendations to COP28 that might amount to little. The sense of hopelessness in small states is rising even as temperatures and the level of the sea rise.

In nine months, world leaders will gather at COP28 in Dubai. The leaders of the most powerful nations - and the biggest polluters - should go to Dubai to deliver climate justice to those countries caught in the vortex of crises none of them caused; they should be prepared to compensate those, that they have harmed most, for loss and damage They should also deliver on the financial commitments made at COP meetings in Copenhagen, Paris and Glasgow. But there is no sign that this will happen. Hence the resort by small island states to seek redress in the international legal system.

The arbitrations and the judgements of ITLOS and the ICJ are not binding on states, but they carry legal authority and moral weight that cannot be ignored. Favourable opinions from each or either of them, showing that international law is not on the side of the polluters, would be a boost to the negotiating strength of small states at COP28.

Hopefully, the consensus resolution by the UNGA, that resulted from developing states working together, will embolden them to do more to advance their joint interests.

## Asthmatics Urged To Wear Masks During School Demolition



Asthmatics and persons with respiratory conditions in the vicinity of the demolition of the Althea Scatliffe Primary School are being urged to take the necessary precautions including the wearing of masks.

Chief of Drugs and Pharmaceutical Services, Mrs. Gracia Wheatley-Smith said the demolition, which has started, is expected to be completed in an estimated two-week period and that she is encouraging asthmatics and persons with respiratory conditions living and working in the area to take precautions.

Mrs. Wheatley-Smith said vulnerable persons should wear a form-fitting mask to reduce inhalation of the dust that will be generated during the demolition and which will linger in the air even after the demolition period is over. Asthmatics should also ensure that they have their rescue inhaler on hand to administer in the event of an attack.

The Chief of Drugs said persons should also use alternative routes where possible to reduce exposure. "These air borne particles are small and may not be visible to the eyes but they can trigger an asthma attack, make it difficult to breathe and also irritate the eyes," she said.

Persons are also advised to keep windows closed during the demolition period to reduce dust entering their homes, keep pets indoors, avoid hanging laundry outside and place floor mats inside all entryways. Shoes should not be worn beyond entry door and should be cleaned on a daily basis during this time.

"We also want to take this time to encourage persons to hose down any outside furniture and surfaces every day around the house to reduce the pile up of dust," Wheatley-Smith cautioned. She added, "If asthmatic, do not hesitate to go to the Emergency Room if experiencing prolonged difficulty in breathing especially after using the rescue inhaler(salbutamol)." also alerted community to look out for cockroaches and other rodents that will be looking for a place to live as a result of the demolition.

Notwithstanding the denial of approval outlined above, the ECCB remains fully engaged with FCIB Barbados as it continues to assess its operational footprint in the Eastern Caribbean Currency Union.

This means that FirstCaribbean International Bank (Barbados) Limited will retain its presence in St. Kitts and has announced plans to transform the way it does business in St. Kitts.

Chief Executive Officer of CIBC FirstCaribbean, Mark St. Hill, noted that while the ending of the sale process is disappointing for the bank, CIBC FirstCaribbean will take advantage of this opportunity to refine its business in St. Kitts. ### Press Statement From Governor Of The British Virgin Islands Mr John Rankin Cmg

On 13 February I published my second Quarterly Review of progress made under the Framework for Implementation of the Commission of Inquiry Recommendations. This was published here in the BVI and also sent to Lord Goldsmith, the UK Minister for the Overseas Territories. I've now received his response to my Quarterly Review and I am publishing it today for everyone to see.

My report noted that 19 of the 48 Recommendations in the COI Report had been completed and I welcomed such progress as had been made.

But I also noted that much more still needs to be done. The BVI Government's count now is that 20 of the 48 recommendations have been completed. But that is still less than half and behind where we agreed as part of the initial deadlines.

A number of the specific reviews which were commissioned have now been received, for example in relation to Statutory Boards and distribution of Crown Land. The Statutory Boards Review carried out by Jamal Smith was received on 31 December. The Review on Crown Land by David Abednego was received on 13 January. But neither of these reviews have yet been made public, allowing people to read for themselves the direction that it is proposed the reforms will take.

Similarly the Review on Social

Assistance conducted by the Social Policy Research Institute in support of UNICEF is yet to be published despite having been received on 18 January. Given the sensitivity of the issues arising from the Assistance Grants Audit, I expect that members of the public will be interested to see what solutions the experts recommend.

So I believe the reviews need to start being made public now, and unless they are otherwise published shortly, I will take steps to do so. Moreover the reviews are only the start of a process on which further action is required. It is imperative that the Government considers the recommendations in the reviews, consults on them as necessary, and then gets on with delivering the necessary changes.

Other areas of delay include reforms required to curb the unfettered discretion of Ministers. I welcome the fact that there has now been agreement on adopting the Protocol on Appointments to Statutory Boards. But in my view it should have been adopted sooner and again it has not yet been published. I also expressed concern in my Quarterly Review about delays in the processing of applications for Residency and Belongership. There is a huge backlog of old applications, and since 1 June 2022, over one thousand new applications have been made but little if any progress has been made in dealing with them. I am working with the Premier, his office, and the Deputy Governor's Office to find a solution. This will require a significant commitment of time and resources, but this should have happened already. Under the Framework Document the Government made a commitment to prioritise and allocate resources to the agreed reforms.

I should note that I am pleased to have now received the Audit on the 2019 Residency and Belongership Fast Track Programme and I am working through it in consultation with others as appropriate. I look forward to its publication in due

Let me now turn to Lord Goldsmith's response to my Quarterly Review. In his letter he notes that during his visit to the Territory in February he was reassured by the Premier and Ministers of the Government of National Unity's commitment to promoting good governance and carrying out reforms. But he also notes that progress on implementing the recommendations in the Framework document has been too slow. He is concerned that there have been signs of insufficient commitment in some specific areas, that too many areas lag substantially behind, and that much of what has been delivered so far doesn't yet represent sufficient reform to prevent future abuse.

Overall the Minister agrees with my conclusion that serious efforts and clear prioritisation of time and resources are required to pick up the pace to deliver the reform that the people of the BVI want and deserve.

Some adjustments to the deadlines in the Framework Document will be required. The Premier has asked

Indeed as the Minister makes clear in his letter, the Order can be lifted sooner if implementation can be achieved more quickly. The staff in my Office and I will do all we can to support the implementation Let me conclude by reiterating that I welcome the progress that has been made to date. The current Premier has assured me of his commitment to implementing the

COI Recommendations and to

achieving the deep reforms that

are required. But we have to get on

with it and we need to accelerate

the reform programme so that the

people of the BVI start seeing

more real, positive changes.

Once the General Election is over I will sit down with whichever Government is in place to work out a refreshed plan for implementing the commitments in the Framework Document. I remain fully determined to ensuring that such implementation takes place, just as the UK Government remains committed to taking the necessary actions to ensure that the people of the BVI get the reforms they deserve.
