SURPRISE CROSSOVER HEAVILY CRITICISED BY OPPOSITION MEMBERS

Days after Hon. Lorna Smith was sworn in as Deputy Premier in the new Virgin Islands Party (VIP) administration persons in the community have been expressing their concerns about her decision. The members of the Opposition were among the most vocal about the actions of their former colleague.

In a joint press conference on 27 April, the leaders and elected members of the three opposition parties criticised Smith's decision to join the VIP. Leader of the Opposition and PVIM leader Hon. Ronnie Skelton said, "We had negotiations between the three leaders... while we were negotiating, the rug was pulled from under us, that's the reason we are not in government." Similar sentiments were expressed by NDP Chairman Hon Marlon A. Penn, who added that the decision to form an alliance with the VIP was made by Smith without any discussion

with the opposition parties. "While those discussions were being had, a decision was made, as we learned during that discussion, was made by Hon Lorna Smith to form an alliance with the Virgin Islands Party," he said.

Penn dismissed the notion that Smith's move to the VIP camp was made for the good of the Territory, claiming instead that it was purely self-interest. "Her decisions were solely self-interest and for power, and we focused on doing what is in the best interest of the country, and that's why we are still here standing unified as an opposition," he said.

Penn agreed that Smith's actions demonstrated a betrayal of the voters and contended that the evidence of this was clear from their expressions. "The voters were betrayed because persons voted on the basis of our [NDP's] vision, on the basis of our campaign that we espoused to the voters

that, 'Look, we are running anti-corruption, anti-maladministration campaign. We are not in any way running to support what has happened to this

country over the last four years," he said.

The NDP Chairman went on to say that the debacle resulted in first-time voters now insisting that they were

misled about the NDP vision and promising never to vote again at future general elections. "We all have our responsibility. We have a

civic duty to vote, and those young persons who I know, who've expressed to me the sense of betrayal in the way that they feel, [I want to say] that there's hope. There's hope on the way forward. Do not allow this to deter you from participating in the democratic process," he urged.

WALWYN SAYS VOTERS WANTED COALITION

During the press conference Sixth District Representative Hon. Myron Walwyn stated that the lack of an outright majority victory at the polls for the incumbent Virgin Islands Party was a clear indication that the people voted against them. Walwyn stated: "I personally believe that when you look at the results — even though you don't have the statistics yet from the election office the people voted against the Virgin Islands Party."

According to the Sixth District Representative, the Opposition Parties had an obligation to ensure that voters got the government they wanted by fully working through the machinations and resolving any issues that arose during negotiations between the three parties.

The Representative said that he fears how the failure to form the government in the manner the people wanted would affect already frustrated voters. Hon. Walwyn noted that during the election campaign people told him that they were unwilling to vote due to an apparent mistrust of politicians. He said: "Because the psyche of the public has been damaged by politicians. And when things like this (Lorna Smith's crossing of the floor) happen, you further erode and further damage the psyche."

Hon. Walwyn acknowledged that if the negotiations between the Opposition Party broke down and someone had to make a move, he understood. However, he felt that all members had an obligation, and the people of the BVI expected them to do so. Walwyn apologized to the electorate

for not being able to deliver the results he felt they voted for but added that he believed a formidable opposition was now in place in the House of Assembly (HOA), and he urged the Territory to move forward.

FORMIDABLE OPPOSITION

Third District Representative Julian Fraser announced that the current strength of the Opposition will be a blessing to the Territory going forward; as they will work hard to hold the Government's feet to the fire.

According to Fraser, the last time the opposition had this many members in the HOA was in 1999.

Going forward, he said debates on bills brought before the House of Assembly will be robust. He predicted that not just one, but multiple motions of no confidence would be tabled in the Fifth House of Assembly. "The debate is going to be vigorous, [and] embarrassing. It's going to be everything," Fraser added.

"I can tell you, whatever the issue is that we are debating, it's going to be very difficult for the government to move it forward with the kind of opposition you will see," Fraser told members of the media. He further stated, "I would not like to be in the government right now — unless, of course, I was the Premier."

OUTSTANDING INCREMENT PAYMENTS: PREMIER EXPLAINS THE SITUATION

Public service workers in the British Virgin Islands (BVI) who are awaiting long outstanding increment payments have been told that the responsibility for those payments is no longer within the remit of Premier Dr Natalio Wheatley.

The government had previously announced that the payments, some of which cover a five-year period extending as far back as 2018, would be paid out, with several payments expected to be completed by

the end of June 2023.

In an interview with JTV News on Wednesday, 26 April, Dr Wheatley explained that while the money had been made available and Cabinet had given instructions for the increments to be paid, the Human Resources Department, which falls under the Deputy Governor's Office, was responsible for processing the payments. He said: "That's out of my hands as a Minister of Finance and an elected representative."

Dr Wheatley also emphasized that government ministers are often blamed for issues that fall outside their remit. "What you have to realise in a government, different actors have different responsibilities," he explained.

"The governor under our Constitution is responsible for the public service, responsible for the terms and conditions of employment for public officers. That doesn't fall under the responsibilities of the Minister of Finance. [The] Minister of Finance must make sure money is available, and we made the monies available."

He added that while different actors have different responsibilities, it is a partnership, and he has a good working relationship with both the Governor and Deputy Governor. His government will continue to work together with them to ensure public officers get what they are entitled to under the law.

The issue of outstanding public service increment payments has been a contentious one in the BVI, with public service workers calling for their payments to be made. Dr Wheatley's announcement that the responsibility for those payments is no longer within his remit may further raise concerns among those who have been waiting for their payments.

Water Distribution Network Power Restored

The Water and Sewerage Department's water distribution network's power service has been restored following disruptions over the weekend that left many residents without water.

Acting Director Mr. Brian Davis said the disruption to the water supply was caused by power outages at the distribution plant from April 29 to May 1. The disruption affected areas within and surrounding Road Town.

Mr. Davis said, "The plant is back online, however water levels were completely depleted. To restore levels, a hard distribution shutdown was done to restore tanks equalising storage levels. A leak detection exercise was also done to pinpoint the major leak that impacted Road Town and the surrounding areas."

The Acting Director thanked customers and residents for their patience and understanding during the disruptions, adding that the department remains committed to providing potable and reliable water service to the Virgin Islands.

"GRAVY TRAIN" SECTIONS OF "GREEDY BILL" TO BE REPEALED

Premier and Minister of Finance, Dr. Natalio Wheatley has confirmed that the Retiring Allowances Legislative Service Amendment Act 2021, commonly referred to as the 'Greedy Bill', will have its offending sections repealed upon his return from a scheduled trip to London. The Premier made this announcement during a press conference and General Update on 2 May, discussing various issues in the Territory.

"Soon at the cabinet meeting, perhaps after I return from London, we will have a Cabinet paper which will put forward a decision to have the offending sections of that act repealed," the Premier stated.

He also highlighted the importance of going through the legislative process and not skipping steps, as advised by Attorney General Dawn J. Smith. Nevertheless, he promised that a decision would be made as soon as possible to repeal the problematic sections of the legislation, as pledged during the 2023 election campaign trail in the BVI.

During the recalled House

of Assembly in April 2023, a decision was taken not to repeal the bill on the Attorney General's advice. According to critics. some of the problematic parts of the bill included sections specifying that a legislator who had served three terms in the House of Assembly would receive a gratuity of \$250,000-300,000 immediately upon retirement if they were 50 years or older. Additionally, the same legislators would receive their current salary per month for a fixed number of years as if they were still working. Such a "gravy

train" had infuriated large segments of the population. The Premier acknowledged that legal advice would be required for persons already entitled to benefits, as such individuals cannot be disenfranchised. "That is something that we are going to need legal advice on, persons who have already become entitled to benefits. We certainly don't want to disenfranchise anyone from a legal perspective and taking away rights, which they have already earned," he stated.

He further added that an independent body like

Pricewaterhouse Coopers is currently reviewing salaries and would recommend salaries for legislators that consider roles and responsibilities, as well as other professions.

"For me, the ideal situation is to come up with salaries from an independent body. Pricewaterhouse Coopers currently conducting a review of salaries and we would want for them recommend salaries for legislators, which is commensurate with the roles and responsibilities and also takes into consideration all other professions," he explained.

REFERENDUM ON SAME SEX MARRIAGE TO BE HELD SOON

Premier and Minister of Finance, Dr. Natalio D. Wheatley, has announced that the British Virgin Islands (BVI) will hold its first-ever referendum on the issue of same-sex marriage ahead of a June 2023 court case.

Speaking at a press conference on 2 May, Premier Wheatley confirmed that the referendum will likely be held before a legal case involving a same-sex couple, who were married abroad and are suing BVI the government have their union to

legally recognised in the Territory. "We want to do that, actually very soon...I think there's a case which is slated for June, so we wanted to be able to have the referendum ahead of that," he said.

The Premier had previously stated that the BVI government would vigorously defend its local laws that clearly define marriage as being between a man and a woman.

The proposed referendum will also consider whether the state should introduce new legislation to provide any person in a domestic partnership with certain legal rights, such as the ability to pass on one's estate to their partner regardless of sex.

This announcement comes after Kinisha Forbes and Kirsten Lettsome, a samesex married couple who are both Virgin Islanders, sued the VI government in June 2022 after being denied a marriage license the Registrar General. If the couple is successful, Section 13(1) (c) of the Matrimonial Proceedings and Property defines Act, which

marriage as between a man and a woman, would be declared unconstitutional and null and void, leading to same-sex marriage becoming legal in the VI. The referendum will be an opportunity for the people of the BVI to have their say on the issue of same-sex marriage. The Premier hopes that it will be held ahead of the June court case, although no official

date has been set yet.

"Ostracizing minorities and ignoring their human rights is totally anti-democratic and unconstitutional, to say the least, also beware that such a referendum might well fire back and become the starting point of endless referenda in the Territory," a commentator told this newspaper.



Post-Election Update on Government Administration and Other Matters

Good morning to the Press Corps and people of the Virgin Islands.

I am very pleased to hold this press conference, which is the first by the new Government Administration that I lead. Today kicks off our plans for bi-monthly press conferences to ensure regular communication with the press. We are fully committed to transparency and keeping the public informed on what is taking place in government.

Before going any further, I want to extend my heartfelt and deepest condolences to the family and friends of my cousin Mr. Kemo Lettsome, another young man lost to gun violence. His murder has deeply hurt his loved ones and the wider District 7 community. The murders we are experiencing are a very worrying development for us as a Territory.

Yesterday, His Excellency the Governor Mr. John J. Rankin, CMG convened a meeting of the National Security Council which I attended, along with the Minister for Communication and Works Hon. Kye Rymer and other members of the Council, to discuss the situation.

We are resolved that more must be done to arrest crime and solve murder cases. I have requested of the National Security Council an action plan to confront the

challenge of violent crime in our community, so it can be rooted out from these Virgin Islands. Later today, the Governor and I will be making a joint statement making a firm commitment tackling crime and preserving our security. These senseless deaths must stop! It is imperative that we remove illegal guns from our Virgin Islands now. It is time for action, and your Government will make this a priority.

I call on everyone to do their part, including providing information to the Royal Virgin Islands Police Force, which can be done anonymously. I also urge you to report any suspicious activity that you see taking place in your neighbourhood. The fight against violent crime cannot be won without the support of the community.

Ladies and gentleman, I would now like to provide post-election update on where things stand following the incident-free General Election held on 24th April 2023. I again want to thank everyone who exercised their right to vote and will do everything in my power to restore the confidence of those persons who did not in the general elections. The only way to accomplish this is to ensure the political system delivers for everyone, which I am committed to achieving.

Following the General Election, the new Government was sworn into office on 25th April. Subsequently, Ministerial appointments were confirmed on 28th April.

I remain the Premier and Minister of Finance, and I am also the Minister with responsibility for Natural Resources that now sits within the Premier's Office.

I will be supported in my Ministerial responsibilities by Dr. the Honourable Karl Dawson, Junior Minister for Agriculture and Fisheries, and the Honourable Luce Hodge-Smith, Junior Minister for Tourism and Culture.

The Honourable Lorna Smith, OBE is Deputy Premier and Minister for Financial Services, Labour and Trade. This a new and necessary Ministerial portfolio that places these three interrelated subjects others under one Ministry, which will allow for greater policy coherence their administration. had discussed establishment of a Ministry for a long time. Hon. Smith is highly qualified and competent to successfully lead and oversee the new Ministry.

The Honourable Kye Rymer remains Minister for Communication and Works and is a member of the National Security Council. He will lead on our much needed infrastructure development and improvement.

The Honourable Sharie de Castro remains Minister of Education, Youth Affairs and Sports. Her competency will deliver better outcomes in education, youth development and athletics, among other sports.

Finally, The Honourable Vincent Wheatley is Minister of Health and Social Development. He will lead our efforts to fix the National Health Insurance.

to deliver better medical care in the Territory including the Sister Islands, and fix the incinerator problem once and for all.

Our Ministerial team is ready to serve the people of the Virgin Islands. Yesterday, an orientation session for Members of Cabinet was conducted to ensure everyone has a clear understanding of what is required and what is expected of them.

At the level of the Public Service. Permanent Secretaries are in the process of being briefed on their assignments and their respective Ministries, as well ongoing initiatives which are taking place within the Ministries. They will soon initiate the process of converting the Virgin Islands Party (VIP) manifesto, which has been mapped to the National Sustainable Development plan into a Government policy agenda, which the Public Service will be tasked with delivering over the course of our term.

The Government's overarching policy framework is the National Sustainable Development Plan (NSDP). Implementation of the Plan will begin later this year, supported by the United Nations (UN) system in the Eastern Caribbean.

I look forward to detailing our comprehensive policy agenda in a statement in the near future.

Ladies and gentleman, in terms of the legislative branch of government, I am very pleased that on 18th May, all District and At-Large Representatives will be sworn in at the First

Sitting of the First Session of the Fifth House of Assembly.

The wheels of democracy are turning as we continue the new era of democratic governance.

More immediately, I will travel to London on Wednesday to attend the coronation of King Charles III. I will then attend the Joint Ministerial Council (JMC) between the United Kingdom (UK) and the Overseas **Territories** Ministers. I will be joined at the JMC by Deputy Premier Lorna Smith, whose wealth of experience as a former Director of the BVI London and Executive Office Director of BVI Finance, will add great value to my delegation.

Honourable Smith and I will also resume engagement with our United Kingdom partners to continue the process of building a new modern partnership that is stable and supports the aspirations of the people of the Virgin Islands. Among other things, we will meet UK OT Minister Lord Goldsmith, other UK Ministers and the BVI All Party Parliamentary Group (APPG) in the United Kingdom Parliament to discuss how the UK Government can support my Administration's agenda on reform, economic resilience, infrastructure, sustainable development, climate change. environment, education, health and security.

Customs Officials Engage In Endangered Species Workshop

Representatives from His Majesty's Customs were engaged in a two- day workshop on the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).

The participants were trained in areas covering legislation, science and enforcement aspects of the convention.

Environmental Officer Argel Horton said CITES is an international agreement between governments with the aim of ensuring that international trade in specimens of wild animals and plants does not threaten the survival of the species.

Ms. Horton added, "The importance of the CITES permitting system is to ensure that international trade of listed species in the convention are sustainable, the process is legal and all specimens can be traced."

Ms. Horton reminded the public that CITES permits are required to enter into other countries with animals, plants or their by-products that are listed under CITES. Products and pets that fall under this list can be confiscated; fines can be issued and/or even arrest.

Marine Biologist Mr. Mervin Hastings said the Virgin Islands has been a party of the CITES international agreement since 1976 and has upheld the agreements with the 1987 Endangered Animals and Plants Ordinance.

Mr. Hastings said, "Now, we have updated this legislation and we now have the 2020 Virgin Islands Trade in Endangered Species (CITES) Act. The Environment Unit continues to do its part as the CITES authority within the Territory to ensure that agencies such as His Majesty's Customs are well versed in the subject.

"We encourage all persons that are considering leaving or entering the Territory to familiarise themselves with the CITES website to verify if the item they are travelling with is or is not considered an endangered species," Mr. Hastings said, adding, "If they are part of the endangered species list, persons are asked to apply to the ministry for a CITES permit."

Participants were also engaged in interactive learning sessions during the workshop, and also enhanced their knowledge about the purpose of the convention, its rules, and the legislations that aim to protect endangered species as well as the enforcement aspects concerning the wildlife trade which is governed according to the convention.

Discussions also focused on identifying species, how they are listed in the CITES appendices, rules around the issuances of permits, species that regularly enter and leave the VI that require CITES permits include by are not limited to; Conch Meat, Conch Shells, Conch Products (jewellery, pearls etc.), Corals and Coral Products, Pet Snakes, Pet Parrots and Wild Orchids. 


Trike and Libertas Win 2023 Governor's Cup

Deputy Governor Archer, Jr.'s appointment is in accordance with section 37 (1) (a) of the Virgin Islands Constitution Order 2007 which states, "During any period when the office of Governor is vacant, or the Governor is absent from the Virgin Islands or is for any other reason unable to perform the functions of his or her office, the Deputy Governor shall during Her Majesty's pleasure, act in the office of Governor and shall perform the functions of that office accordingly."

SOUTHAFRICA-The slayings and other cases have fueled outrage over widespread graft linked to government contracts, which has plagued Africa's most developed economy for years. An accountant working on a highprofile corruption case was killed along with his son by unknown gunmen while traveling on one of South Africa's main highways. A government health department employee who warned of illegal dealings worth nearly \$50 million was shot 12 times in the driveway of her home.

The slayings and other cases have anti-corruption groups urging South African authorities to provide far better protection for whistleblowers. They also have fueled outrage over widespread graft linked to government contracts, which has plagued Africa's most developed economy for years but appears to continue unabated.

The Global Initiative Against TransnationalOrganised Crime counted a total of 1,971 assassination cases in South Africa between 2000 and 2021, with whistleblowers accounting for many of the targeted individuals.

The specialist accountant and liquidator, 57-year-old Cloete Murray, was working on the financial accounts of a company that was heavily implicated in allegedly bribing government

ministers and others to win huge state contracts.

The company, previously known as Bosasa and now named African Global Holdings, was one of the most prominent subjects of the Zondo Commission a judicial inquiry into government and other high-level corruption during the 2008-2019 presidency of Jacob Zuma, who is on trial on separate corruption allegations.

Murray was shot in the head while driving with his son in an SUV on the N1 highway just outside Johannesburg in March. He died in the hospital. His son, Thomas Murray, who worked with his father, was declared dead at the scene. No one has been arrested in the killings, which police said had the hallmarks of a professional hit. [El Pais]

SWITZERLAND - Michelinstarred restaurants are synonymous with high cost. However, there is a wide price range and some offer meals for 30 Euros or less.

Prices for a three-course meal at Michelin-starred restaurants in Europe go as high as 595 Euros at the Ciel Bleu in Amsterdam while descending as low as 20 Euros at the L'Antic Molí in Ulldecona in Spain.

This week, Ioana Neamt put together a list of the most expensive and least expensive Michelin-starred restaurants in Europe and set them out on the two maps below.

Affordable ones closest to Switzerland are Le France (1 star) near Le Doubs river in the Jura region of France - a threecourse lunch here costs 26 Euros - and Le Bon Accueil (1 star) nearby in Malbuisson, France. A lunch here (Wednesday and Friday) costs only 28 Euros. These are the closest two most Michelin-starred affordable restaurants to Switzerland. After this Drusenheim in France and Turin in Italy are the next closest destinations. In Drusenheim you'll find the Au Gourmet (1 star) hotel and restaurant, where you can dine for 29 Euros. And in Turin, there is the restaurant Vintage 1997 (1 star) in the middle of the city where a set menu is 30 Euros. [LE News]

RUSSIA - On 31 March, Russia released its latest foreign-policy concept setting out its official view of the world, its major interests and goals, and how it will pursue them. It is Russia's sixth, and darkest, such statement, following those published in 1993, 2000, 2008, 2013, and 2016.

The 9,000-word document might invite skepticism. It is a committee product in a personalistic autocracy. It espouses principles of international law, human rights, and peace that Russia has violated outrageously. It was drafted with its propaganda value in mind. Indeed, for the first time, propagandistic terms such as "Russophobia," "neo-Nazism" and "the collective West" are mentioned in this version of the

concept. But the concept matters. It is Russia's first systematic foreign policy statement since it invaded Ukraine in February 2022. It codifies Russia's evolving response to the adverse changes in its international position that the invasion triggered. [Moscow Times]

PHILIPPINES - The United States called on China to stop intimidating Philippine ships in the South China Sea, pledging to stand with its ally. Beijing claims sovereignty over almost the entire South China Sea. The United States on Saturday called on China to stop its "provocative and unsafe conduct" in the South China Sea. It followed a tense encounter between a Chinese coast guard ship and a Philippine patrol vessel last weekend.

In a statement, the State Department criticized China's "harassment and intimidation" of Philippine vessels in the contested waterway.

It added any attack on Philippine armed forces would trigger a US response.


The State Department said the US "stands with our Philippine allies in upholding the rulesbased international maritime order."

"We call upon Beijing to desist from its provocative and unsafe conduct," State Department spokesman Mathew Miller said.

The Philippines on Friday accused China's coast guard of "dangerous maneuvers" during the incident in the contested waterway. [Deutsche Welle]

CARIBBEAN - MEXICO CITY (Reuters) - High rates of gun violence in the Caribbean are being fueled by small-scale trafficking, largely from the United States, via shipping firms, commercial airlines and by post, according to a new report by the Geneva-based Small Arms Survey.Caribbean countries suffer three times more violent deaths than the global average, often caused by firearms, despite tight regulations on gun ownership and little domestic manufacturing, the report found.

Last week, Caribbean heads of state vowed to ban civilian assault weapons across the region and stand with a lawsuit launched by the Mexican government seeking to hold U.S. gun-makers accountable for arms trafficking out of the country. Matt Schroeder, a senior researcher for the Small Arms Survey, told Reuters that shipments to the Caribbean often consist of up to

a couple dozen guns or several hundred rounds of ammunition, hidden among food or clothing by small-scale traffickers. [Caribbean News Weekly]

REPUBLIC DOMINICAN - Bavaro.- In response to alerts issued by Canada and the United States to their citizens regarding crime in the Dominican Republic, the Minister of Tourism, David Collado, stated that there have been no reported incidents involving Canadian tourists. In fact, he noted that the Canadian market is growing significantly, with a higher number of Canadian tourists arriving in the first three months of 2023 compared to 2019. Collado believes that if analyzed by the number of inhabitants, Canada could become the number one country in terms of tourist arrivals to the Dominican Republic. He further stated that they are taking steps to improve safety by strengthening the Tourist Police and recovering the boardwalks. Collado emphasized that they are working with transparency and honesty to ensure that the Dominican Republic is a much safer destination. During the interview at DATE 2023, he stated that it is important to understand that Canada's warning to the Dominican Republic is the same as what the country had in 2019, and it has not been increased. RVIPF TO BE REPRESENTED AT CORONATION

Tuesday, May 2 – Acting Chief Inspector Dean Robin and Acting Inspector Jacqueline Tom will represent the Royal Virgin Islands Police Force at events to mark the coronation of Majesties King Charles III and Queen Camilla to take place in London on Saturday, May 6.

The two police officers, selected by the Senior Management Team in recognition of their work within the ccommunity, will join officers representing other police forces within the U.K. Overseas Territories as well as within the United Kingdom.

Highlighting the events of the day will be a coronation service at Westminster Abbey in Central London just after midday on Saturday. A ceremonial procession will precede and follow the coronation service.

The coronation is expected to draw thousands of persons from overseas and tens of thousands from around the United Kingdom to view the events.

MURDER VICTIM IDENTIFIED

Tuesday, May 2 – Officers of the Major Incident Team are confirming the identity of the male victim in Sunday night's shooting at a residence near to the Stickett in Long Look as Kemo Lettsome, 37, of Long Look

Lettsome was fatally wounded and pronounced dead at the scene.

Initial inquiries indicate that the shooter drove by the residence in a vehicle around 6:30pm, discharged several bullets and left in the same vehicle. Much more information is needed to help with investigations into this incident.

His Excellency the Governor John Rankin and Premier Dr. the Hon. Natalio Wheatley joined the RVIPF in making an appeal for information into the murder of Kemo Lettsome, and the first two murder victims of 2023.

Both the Governor and the Premier condemned the vile and senseless actions of the perpetrators and encouraged those who saw something or heard something, to say something. They also both pledged their support the RVIPF in bringing to account those responsible for these murders and other acts of gun violence.

Detectives are asking for witnesses to this shooting or persons with information about the perpetrator(s) of this murder contact the Major Incident Team at 368-9410. Alternatively, persons can give this information anonymously through the Crimestoppers hotline number 800-8744.

A: "UnREAL" originally aired on the Lifetime network for three seasons before concluding with a short fourth and final season on Hulu. It starred Shiri Appleby ("Roswell") as a young producer of a "Bachelor"-style reality show titled "Everlasting." She was directed by an even more unscrupulous executive producer behind the monitors, played by Constance Zimmer.

"UnREAL" was based on the short film "Sequin Raze," which was directed by Sarah Gertrude Shapiro, who once was a field producer on ABC's "The Bachelor." "UnREAL" ended up winning a Peabody Award "for illustrating how masterfully parody can work when it shines its light fearlessly and for smartly blending the dichotomy between high and low culture."

Hulu didn't order any new episodes after the fourth season in 2018, and a return doesn't seem to be in the works. Appleby recently had a role in the Reese Witherspoon rom-com "Your Place Or Mine," but has been more busy directing than acting, having recently directed several episodes of the sitcoms "Young Sheldon" and "Grown-ish." Zimmer, too, had found herself drawn to leadership positions behind the lens. She's returning to Lifetime to direct her first feature-length film, "Boy in the Walls." She also was a regular on the ABC series "Big Sky," a show that remains in limbo as it hasn't been canceled or renewed.

Exercise Builds Strength and Improves Limits in Those With Arthritis

DEAR DR. ROACH: I so appreciated your recent column on arthritis, specifically osteoarthritis. I'm a big exerciser; however, I have always heard that this arthritis is caused or exacerbated by wear and tear. I was surprised to hear otherwise!

I have modified or given up a handful of exercises that seem to cause my joints more pain, specifically full-body weight-bearing on my wrists. Are these exercises I can incorporate back into my routine? I have found that certain activities, i.e. card shuffling, buttoning, etc., hurt my thumbs, so I have made adaptations. Should I work through the pain, assuming that I am not causing any more damage to my joints? — L.D.

ANSWER: Most exercise is not damaging to joints, but high-impact or high-frequency activities can certainly worsen arthritis pain.

For arthritis of the knees and hips, I recommend walking as the best exercise, starting slow and building up based on what a person can tolerate. It's the movement, not the resistance, that's most important, so swimming (or just walking in a pool) is a great option for people who feel too much pain from walking.

For the smaller joints of the hands and wrists, I would recommend activities that don't hurt you as much. Stretching the joints and movements like squeezing are a good place to start. You might consider a "stress ball" or a hand therapy ball to provide some resistance and build up hand strength.

Adapting your activities to your limitations is a good idea, but you also want to work on improving those lim-

want to work on improving those limitations. A physical or occupational therapist is your best partner in designing a program.

Don't forget that over-the-counter topical anti-inflammatory medicines, like diclofenac, are pretty effective with small joints and are very safe.

DEAR DR. ROACH: Would you discuss the difference between rheumatoid arthritis and the ankylosing spondylitis? — S.Y.

ANSWER: Both rheumatoid arthritis and ankylosing spondylitis are uncommon (each affecting about 1% of the population), inflammatory, multisystem diseases. RA affects the synovium (the lining of the joint) and tends to affect the hands first, but it can affect nearly any joint. The major area of activity of AS occurs where bones connect to ligaments, cartilage and tendons.

There is an auto-immune component to both diseases. Without treatment, RA leads to joint deformities, whereas AS causes new bone formation, leading to pain and reduced movement of the joints. The back and neck are most often affected in AS, but the hips and other joints may also be affected.

RA is treated early and aggressively with disease-modifying agents, such as methotrexate and hydroxychloroquine, or with biological agents.

Physical therapy is useful in RA, but is a mainstay of therapy with AS. Medications are often needed in AS, usually starting with anti-inflammatory drugs and progressing to more potent agents if needed. About 30% will need biological agents, whereas 94% of people with RA need a disease-modifying drug.

A rheumatologist is the expert for both conditions, and a person with either condition should be referred to an expert as soon as the diagnosis is made.

Low Voter Morale in the Virgin Islands

The fragmentation of the two party system has left the Virgin Islands Party the undisputed powerhouse of Virgin Islands politics. The opposing three parties are a work in progress. However, of the three, the Progressive Virgin Islands Movement and National democratic Parties are the more permanent fixtures. Will they survive in their present form? Time will tell.

OK. What can be learned from the April 24, 2023 Virgin Islands Election?

For this eternal observer, the much earlier Commission of Inquiry had spurned a culture of lack of trust in government in the Virgin Islands. That lack of trust may have been there well before the start of the very public inquiry. The inquiry simply exacerbated that trust deficiency: it revealed the underbelly of the beast.

Subsequent events including the arrest of the previous leader of the country on drug conspiracy charges did not help. The low voter turnout is clear evidence of the preceding assertions. A deficit in engagement with the political process especially from young

voters is never a good thing.

appropriate that politicians campaign in poetry but govern in prose. In other words, they campaign as painters but rule as bureaucrats.

I described politics as linear in that it looks back at past narratives of political power: and how the present play affects the future. Politics was asymmetrical in that it observed the sideways and peripheral factors that affected public opinion, power and governance: the holistic.

The habit of religious societies of Africa and the Caribbean using prophecy to predict political outcome, instead of polling and statistics was flawed. The Virgin Islands Election of April 24 2023 had its prophets and soothsayers, they were mainly wrong in their predictions, as usual

Then the strength of the district game, especially of the Virgin Islands party district campaign, left the VIP as the party with the most seats: six. District decided outcome over At Large. Albeit the VIP was short of one seat to form a government. Three remaining parties got between one and three seats.

There is a caveat: the three opposition parties got more votes than the VIP did signaling the people may have wanted change.

The rumor mill is a key component of the Virgin Islands political system. The Virgin Islands is a large village. The public knew the outcome of negotiations to form a new government, and the crossing over of an opposition party member to the incumbents, well before it was news on the national media.

In the past four elections, the At Large vote decided the success of a political party and the outcome of an election in the Virgin Islands. This time it would appear this factor in Virgin Islands elections was less a decider. The strength of the district candidates was paramount in delivering a victory for the VIP, in addition to its one At Large Representative. The At Large vote remains crucial to the process however, and the April 24 2023 election may have been a one off in the lesser effect of the At Large votes on the trajectory of the election.

The Virgin Islands Party Government will continue to manage the affairs of the country under the Damocles Sword of the Order in Council and a much more vigilant UK, for the next four years, hopefully. Thankfully, the key players in the present government appear not to be under the cloud of Commission of Inquiry driven investigations.

Public frustration remains at a high level as revealed in lower turnout numbers, than previous elections. Anger remains, as the outcry at a politician crossing the floor and enabling the Virgin Islands Party form the government showed.

The lesson going forward, assuming the constitution remains the same is that parties must compete in all districts with candidates on the ground. The better the ground game – boots on the ground going door to door-the greater the likelihood of success at an election. The VIP has a sustainable grassroots game, possesses structure and

organization, and is the more unified organization. The party understands that it is better to compete at local level and lose, than not compete at all, for success.

Going forward, politicians cannot take low voter turnout of 50% as a new norm. Low morale of a country's citizens is never a good thing for democracy. The political party is wise that takes every effort to address this matter. The party and politician that causes low morale to improve will increase turnout in their favor. That will be a trump card in four years.

That means engaging with voters at grassroots level daily over four years, and not just at election season. The party that has the best ground game over the next four years will have the better chance of success at the next General Election.

US, Mexico Agree on New Policy on Border Crossings

The United States and Mexico have reached agreement on a new plan to control the flow of illegal border crossings while also allowing migrants to enter the U.S. on humanitarian grounds.

The plan was announced

Tuesday after a meeting b e t w e e n - M e x i c a n President Andres Manuel Lopez Obrador and U.S. Homeland Security adviser Liz Sherwood-Randall in Mexico City.

Under the plan, the United States will accept migrants from Cuba, Haiti, Nicaragua and Venezuela as part of a humanitarian parole program, while Mexico has agreed to accept migrants from those four nations who entered the United States illegally.

Biden Sends 1,500 Troops to Southern Border, Expects Migrant Surge

WASHINGTON —

The Biden administration will send 1,500 troops to the U.S.-Mexico border ahead of an expected migrant surge following the end of coronavirus pandemic-era restrictions, Pentagon press secretary Brigadier General Pat Ryder said in a statement Tuesday.

Military personnel will do data entry, warehouse support and other administrative tasks so that U.S. Customs and Border Protection can focus on fieldwork, the officials said. The troops will not do law enforcement work and will be there for roughly 90 days, though their presence can be extended if necessary.

The COVID-19 restrictions allowed U.S. officials to turn away tens of thousands of migrants crossing the southern border, but those restrictions will lift May 11, and border officials are bracing for an expected surge of migrants. Even amid the restrictions, the administration has seen record numbers of people crossing the border, and President Joe Biden has responded by cracking down on those who cross illegally and by creating new pathways meant to offer alternatives to a dangerous and often deadly journey.

Biden's actions follow similar moves by then-President Donald Trump, who deployed active-duty troops to the border to assist border patrol personnel in processing large migrant caravans, on top of National Guard forces that were working in that capacity. There are roughly 2,700 National Guard members at the border.

The Pentagon on Tuesday approved the request for troops by the Department of Homeland Security, which manages the border, one of the officials said.

But the deployments have a catch: As a condition for Defense Secretary Lloyd Austin's previous approval of National Guard troops to support the border mission throughout fiscal 2023, which ends October 1, DHS had to agree to work with the White House and Congress "to develop a plan and implement solutions to staffing and shortfalls funding maintain border security and the safe, orderly, and humane processing of migrants that do not involve the continued use of DOD personnel and resources after FY2023," said Pentagon spokesman

Air Force Lt. Col. Devin Robinson.

As part of the agreement, DOD requested quarterly updates from DHS on how it would staff its border mission without service members throughout this fiscal year; it was not immediately clear if those updates have happened or if DHS will be able to meet its terms of the agreement — particularly under the strain of another migrant surge.

For Biden, who announced his Democratic reelection campaign a week ago, the decision signals his administration is taking seriously an effort to tamp down the number of illegal crossings, a potent source of Republican attacks, and sends a message to potential border crossers attempt not to journey. But it also draws potentially unwelcome comparisons to Biden's Republican predecessor, whose policies Biden frequently criticized. Congress, meanwhile, has refused to take any substantial immigrationrelated actions.

It's another line of defense in an effort to

manage overcrowding and other possible issues that might arise as border officials move away from the COVID-19 restrictions. Last week, administration officials announced they would work to swiftly screen migrants seeking asylum at the border, quickly deport those deemed as not being qualified, and penalize people who cross illegally into the U.S. or illegally through another country on their way to the U.S. border.

They will also open centers outside the United States for people fleeing violence and poverty to apply to fly in legally and settle in the United States, Spain or Canada. The first processing centers will open in Guatemala and Colombia, with others expected to follow.

Hodge lowers 100m record, climbs to No 5 All Time U18

Adaejah Hodge returned to competition after missing last month's Carifta Games action and continued to lower the 100m record she claimed from Tahesa Harrigan-Scott on April 23 and climbed the World U18 All Time list in the process.

Hodge, who came into 2023 with an 11.29 seconds best, went into the Pure Athletics meet after a season opening with 11.18 seconds. She then lowered her 100m best to 11.16 in the semis. Hodge won the final in 11.12 seconds to break Tahesia Harrigan-Scott's 17-year old mark of 11.13 established in 2006.

On Saturday, Hodge shaved the time to 11.11 seconds to finish second at the Texas Tech Corky Shootout, in Lubbock, Texas. Her time is =No 4 All Time mark in the U.S. High School list and No 5 on the All Time World U18 List. It's also =No 24 on the World U20 List. She followed up by riding a 5.0 meters per second tail wind to victory in the 200m, stopping the clock at 22.31 seconds, avenging a 100m loss to Oklahoma's Kennedy Blackmon, who ran 22.56 after taking the century in 11.06.

Hodge is scheduled to compete against Jamaican high school stars who she did not face at the Carifta Games, at the Puma East Coast International Showcase in Maryland this weekend. At the same meet, New Mexico Jr. College's Khybah Dawson returned to action with a sixth place finish in the Long Jump, after cutting the sand at 7.14m (23'51/4").

University of Texas El Paso's Josh Hill, became just the fourth BVI male athlete to break 47.00 seconds in the 400m. Competing at the Desert Heat Classic in Tucson, Arizona, Hill chopped his best from 47.31 seconds to 46.66 in winning his heat. His time moved him to No 3 the BVI All Time List.

Coming off a 10.76 seconds for second in the Scotts Invite 100m after a 10.79 prelim, Tennessee Wesleyan's K'Andre Campbell, was fifth in the Appalachian Athletics Conference century in 10.74 seconds. Campbell settled for third in the 200m, after stopping the clock at 21.65 seconds.

"My aim basically all the time is not to stop, but at some point when I reached up (the hill) at the Marine College, I actually had to stop when I reached the top," he told Island Sun Sports. "I walked a little then tried to overtake one of the persons who passed me on the way up. It was challenging, but I did it and I'm proud."

Human was the women's winner in 25:08, with Vicki Francis placing second in 25:49. Rosmond Johnson was third in 26:10.

"I'd never run this course before so I had no idea what to expect," Human said. "I found it really hilly and on the last hill, I almost went the wrong way so I lost about 15 meters, but the hills are quite hectic."

Human, who ran the first leg of

a 2-man team from the Tortola Sports Club to Sage Mountain in the 33.74 miles Tortola Torture and won the Queen of the Mountain segment from Stoutt's Look Out to Sage, said Saturday's race was much harder. "That's because I ran much faster,

she said. "The longer races are a bit easier I think because I'm not running this fast. But in this one, I was on max all the way from start to finish."

New comer Priya Mattu, fifth overall in 26:31, found the course to be a challenge. "That was a really hard route. Who came up with it?" she asked. "It feels okay now that we've done it, but it's the hardest one I've done so far of the series—harder than Carrot Bay. It's hotter now because in Carrot Bay, we weren't running in the sun, which I think made this one even worse. It's too hot."

Race Director Kay Reddy, said the race was fast at the front, lots of By Dean "The Sportsman" Greenaway

battles going on in the middle and some people really pushing around the course in the end. "This course is called the Paraquita Beast and it's a beast," she noted. "Today didn't disappoint. As well as the course, we had some big heat reminding us that summer is underway. So it was a push up three or four hills."

The Trident Trust 5K Series will

conclude on May 13 with the City Circuit race, starting and ending at the A. O. Shirley Grounds. The race will loop out to the Port Purcell Roundabout, then down the James Walter Francis Dual Carriageway, by the banks and return to the grounds. Awards will be doled out following the race

HUNGARY'S YOUNG PEOPLE APPRECIATE POPE'S "CLEAR VOICE TO GUIDE THEM"

Pope Francis meets with young people at the Papp László Sport Arena in Budapest and encourages them to "aim high in life", reminding them that no one can take their place in the history of the Church and the world.

"Invest in the great goals of life! Then, train through dialogue with Jesus, who is the best of coaches". In the last public event of the second day of his Apostolic Journey to Hungary, Pope Francis encouraged youths to "aim high" in their lives, overcoming their fears and stepping forward, always dialoguing with Jesus, their best friend and brother.

The event, attended by some 12,000 people, was introduced by the greeting speech of the Hungarian lead bishop for Youth Ministry, Bishop Ferenc Palánki, and the testimonies of four youths: Bertalan, Dóra, two high-school students, Tódor, a young Greek-Catholic, and Krisztina, a university student.

WHO DARES WINS

Taking his cue from the first testimony, Pope Francis reminded those gathered that "Jesus wants us to accomplish great things" in life and "never disparages our expectations".

"Jesus doesn't want us to be lazy "couch potatoes"; he doesn't want us to be quiet and timid; instead, he wants us to be alive, active, ready to take charge. Jesus would agree with a proverb of yours, which I hope I pronounce well: Aki mer az nyer [Those who dare, win the prize]."

But how do we win in life?", the Pope asked. "Just as in sports, there are two basic steps". The first step, he said, is "to aim high", putting our talents "to good use", investing them "in the great goals of life".

"WE DON'T ACHIEVE GREATNESS BY TREADING UPON OTHERS, BUT BY SERVING OTHERS!"

Dialoguing with Jesus

The second step is to train through dialogue with Jesus, "who is the best of coaches". Indeed, said the Pope, "Jesus encourages you, believes in you" and "constantly invites you to be a team player, never alone but with others: in the Church, in the community, sharing your experiences with others".

Another important element of this training, the Pope further remarked, is silence which was recalled in the testimony of Krisztina. In a world "bombarded with the message that we have to be fast, efficient and practically perfect, like machines", said the Pope, "we have to learn how to stop and fill our tanks, to recharge our batteries", without however, indulging "in moodiness or brood" over our troubles.

Silence, he remarked, "is not sitting glued to your cell phone, or on social media", but rather "the soil on which we cultivate good relationships". It "allows us to entrust to Jesus whatever we are feeling, (...), to share our difficulties, to remember our friends and to say a prayer for them".

Silence is therefore, "the door to prayer", which is a "dialogue with Jesus", with whom we freely share our vulnerability "without hiding or disguising anything".

"Prayer is not boring, it is an encounter with Christ" The Lord wants authentic people

Indeed, "the Gospel tells us that the Lord does not do great things with exceptional people, but with ordinary people. Those who count on their own abilities and are anxious always to look good before others", the Pope noted," keep God away from their hearts".

"JESUS LOVES YOU THE WAY YOU ARE"

Helping the world to live in peace by serving others

Pope Francis then reflected on the words of Tódor, a young Greek-Catholic, who in his testimony noted that the zeal for the mission "can be blunted by living in security and comfort", while not far from us "war and suffering are daily realities".

"This - the Pope commented - is the real challenge: to take control of our lives in order to help our world to live in peace", by generously and selflessly serving others, "as Jesus taught us".

FAITH STARTS WITH GIVING

Faith, "starts with giving freely, with enthusiasm and generosity, overcoming our fears and stepping forward!", insisted Pope Francis at the end of his discourse, recalling the miracle of the Multiplication of the five Loaves and two Fish recounted in John's Gospel in which a young man shares the little bread and fish he has with Jesus to feed the multitude.

"WE HAVE TO LEARN TO LEAVE THINGS IN THE HANDS OF JESUS."

"Each of you is precious to Jesus, and also to me!", the Pope concluded. "Remember that no one can take your place in the history of the Church and the world: no one can do what only you can do".

The President of Colombia, Gustavo Petro, hosted a Conference on Venezuela in his nation's capital, Bogota, on April 25. The European Union (EU) and 19 countries from the Americas, including the Caribbean, attended, but it is doubtful that they all had the same goals in mind.

For several years, under Colombia's former President Iván Duque, relations between the governments of Colombia and Venezuela were openly hostile. Immediately after his inauguration as President, Petro began to engage with Venezuela's President Nicolás Maduro. Since then, relations between the two countries have significantly improved.

Despite thawing the earlier icy relations between the governments of Colombia and Venezuela, Petro remains concerned about democracy and respect for human, political and civil rights in Venezuela and other Latin American countries. Addressing a meeting of the Permanent Council of the Organization of American States (OAS) on April 19, just 6 days before hosting the Conference on Venezuela, Petro said that now could be "Latin America's time in the world", but not "through authoritarianism [or] through dictatorships." And he restated his interest "in seeing Venezuela re-join the Inter-American Human Rights system".

In a meeting with US President, Joe Biden, on April 20, the day after his OAS address, Petro pressed an argument for removing US sanctions against the Maduro government in exchange for a return to democracy in Venezuela.

It was with that unofficial theme that Petro appeared to approach his bold initiative to gather representatives of the EU and 19 nations with diverse and - in some cases divergent interests to discuss Venezuela. At the end of the conference, there appeared to be consensus - though no unanimity - on trying to promote two objectives. According to statements by Colombia's Foreign Minister, Alvaro Leyva, the first aim is to persuade Venezuela's governing and opposition political parties to set an electoral calendar for free and fair elections, which, presumably, would include the release of political prisoners, so that they could fully participate in the process. The second is that there should be gradual lifting of sanctions

directly linked to progress of negotiations between the Venezuelan political parties to reach an agreement on elections and the restoration of democratic processes.

Leyva is reported to have said, after the Conference, that countries, which attended the meeting, "will inform President Maduro

> and opposition parties and civil society of the results of the summit". The only official response from the Maduro government was a statement from Foreign Minister, Yvan Gill, on Twitter in which he assured that "note" had been taken "of the deliberations carried out" at the

Conference and reiterated "the prevailing need to lift sanctions".

Representatives of some of the Latin American and Caribbean countries, which were invited to attend the Colombia Conference. unrealistically focussed only on lifting the sanctions and ignored the issue of free and fair elections and the restoration of democracy through a negotiated agreement on these goals by all the Venezuelan parties. That position was obviously untenable. There is clear need for compromise, concessions and flexibility in any negotiations between the political parties in Venezuela. There must also be agreement on absolute tolerance for political dissent; the development of constitutional guarantees for the independence of the judiciary and the media; and provision for power-sharing in the National Assembly.

Importantly, at the Colombia Conference, the US representatives said that the Biden Administration has "no desire to maintain US sanctions in perpetuity". They argued that sanctions "are only a tool" to urge the government to take the steps necessary for free and fair elections and the restoration of democracy. Furthermore, they undertook to the Conference that "if, and as, Venezuelan leaders take these steps, we are more than ready to reduce and ultimately end our sanctions pressure".

Therefore, the Colombia Conference can take credit for a frank exchange of views leading to consensus on the two symbiotic paths that have emerged: the Venezuelan parties must get back to the negotiating table to agree on a process for free and fair elections, and a gradual but progressive lifting of sanctions as steps are implemented.

Significantly, the US representatives told the other nations at the Conference that all of them should encourage that "any agreement include some guarantees that the loser will not face persecution". US will accept the outcome and work with the government they produce".

Against this background, there is cause for cautious optimism that there could be renewed efforts by the Venezuelan

parties to achieve an agreement at revived negotiations, which, so far, have failed. However, there were some key players - at least on the Maduro side - that were not at the Colombia Conference. They Russia, include China and Iran, Turkey which have helped the Maduro

government to weather the storm of sanctions. Another is Cuba which has played a key advisory role to Maduro.

It is more than likely that, for other geopolitical considerations, particularly the conflict over Ukraine embodied by Russia and the US, at least Russia and Iran might continue to embolden the Maduro government to continue the same hard-line that it has taken so far in the negotiations with the opposition parties. If that happens, the political impasse in Venezuela could persist with all its unfortunate consequences, including an increase in the 7.2 million Venezuelan migrants and refugees of which 2.5 million are in Colombia alone; and a growth beyond the 2.3 million people who are "severely food insecure and in need of immediate humanitarian assistance", according to the UN World Food Programme.

Countries, such as the US, Canada and the members of the EU, should also make it clear to the Venezuelan opposition parties that they do not enjoy unqualified support, and they, too, are expected to work diligently toward a resolution of the political deadlock.

The countries of CARICOM have a vested interest in a politically stable region where economic progress can thrive. Consequently, CARICOM governments should urge all Venezuelan parties to negotiate their future between them and present the world with a plan, free of retribution, which would rebuild Venezuela in a democratic mould with guaranteed constitutional freedoms, based on free and fair elections.

Government Of the VI Seeks Solutions to Waste Management



The Government of the Virgin Islands continues to look at possible solutions and directions to manage waste in the Territory.

To this end, Minister for Health and Social Development Honourable Vincent O. Wheatley has met with the staff at the incinerator at Pockwood Pond and the Department of Waste Management surrounding the management and security of the dumpsite.

Honourable Wheatley met with Manager for the Department of Waste Management Mr. Neville Allen, Assistant Manager for the Department of Waste Management Mr. Anselm Myers, and the First District Representative Honourable Dr. Karl Dawson.

Discussions were held on the best strategy for ensuring that persons do not have access to the area after it is closed as it was disclosed that most of the fires started at the site are intentional.

Additionally, the group explored different pathways to getting the incinerator repaired and back on stream to assist with the Territory's waste management challenges and the removal of derelict vehicles and equipment from the Territory which is currently an ongoing process.

Honourable Wheatley stated that waste management, in general, in the Virgin Islands has been a longstanding issue across successive administrations. He said as a new government, a message must be sent that the voice of the people, especially those in the First and Third Districts, must be heard.

The Minister said, "We want to be seen early on giving the incinerator and dumpsite their due attention. I want to come and get a fresh look at what the current reality is, and this here is not sustainable going forward. So, we must look at the possible solution and the possible direction that we want to take waste management into."

Honourable Wheatley highlighted that the needs of the people are at the epicentre of his goals, and as Minister, he wants to be visible on the ground which he hopes will reflect in the Government's action plan.

While the Minister acknowledged that waste management across the world has been a cause for concern, he said because the Virgin Islands relies heavily on tourism, safeguarding the environment is paramount.

"It is important as the Minister for Health to ensure we can do what we can to get the waste management issue under control in as short a time as we can. So, from day one I want to be on the ground working with my colleagues to support what we are trying to do here," Honourable Wheatley said.

Meanwhile, Dr. the Honourable Karl Dawson noted that the degradation of the incinerator along with the recent fire has become a cause of concern for residents of the First District.

He said, "The impact is great for us, and we intend to do our part in the district. This includes leading the way in recycling efforts and certain efforts to ensure there is less waste coming to any landfill that we create because we realise the solution is not simply to build better incinerators but to have less waste. It calls for a mind shift and we want to lead that shift in the VI."

The Ministry of Health and Social Development through the Department of Waste Management is committed to transforming and implementing innovative ideas and strategies to manage waste in the Virgin Islands.







Premier Wheatley to Attend Coronation of King Charles The III

Premier and Minister of Finance Dr. Honourable Natalio D. Wheatley will be absent from the Territory from today Wednesday, May 3 until Saturday, May 13, for the purpose of attending the Coronation of His Majesty King Charles III alongside The Queen Consort in the United Kingdom.

Premier Wheatley will also attend a series of meetings namely the Overseas Territories Political Conference and the meetings of the Joint Ministerial Council.

The objective of this official visit is to continue to advance the socioeconomic and political interests of the Virgin Islands.

Premier Wheatley during his recent Press Conference said, "My Government will resume engagement with our United Kingdom partners and continue the process of building a new modern partnership that is stable and supportive of the aspirations of the people of the Virgin Islands."

The Premier also indicated that he anticipates engaging in strategic discussions with Lord Zac Goldsmith and other United Kingdom Ministers at the Joint Ministerial Council meetings, the Overseas Territories Political Conference, and the BVI All Party Parliamentary Group.

Premier Wheatley stated, "I will be seeking the United Kingdom Government's support on my administration's agenda on reform in the areas of economic resilience, infrastructure, sustainable development, climate change, the environment, and health. I believe the United Kingdom's partnership with the Virgin Islands must add value to the relationship and support the work being undertaken by the local Government to improve the lives of the people in the Territory."

According to the Premier, Deputy Premier Honourable Lorna G. Smith, OBE is also scheduled to be away from the Territory commencing May 5 and Minister for Communication and Works Honourable Kye Rymer is scheduled to be away from the Territory during the same period May 3 to 13 for both personal and duty travel accordingly.

In light of the foregoing, Honourable Lorna G. Smith will be appointed to carry out the duties of Premier and Minister of Finance for the period May 3 to 4 and then Honourable Vincent Wheatley be appointed to carry out the duties of Premier and Minister of Finance for the period May 5 to 13.

Honourable Smith's appointment is in accordance with Section 55 (1) of the Virgin Islands Constitution Order, 2007 which states, "If the Premier is expected to be absent from the Virgin Islands for more than forty-eight hours, the Governor shall authorise the Deputy Premier to perform the functions of the office of Premier; and the Governor shall revoke this authority on the return to the Virgin Islands of the Premier."

Honourable Vincent Wheatley's appointment is in accordance with the Virgin Islands Constitution Order, 2007 Section 55 (2) which states, "If both the Premier and the Deputy Premier are expected to be absent from the Virgin Islands for more than forty-eight hours, the Governor shall authorise another Minister designated by the Premier to perform the functions of the office of Premier; and the Governor shall revoke this authority on the return to the Virgin Islands of either the Premier or the Deputy Premier."

The Government of the Virgin Islands remains committed to the overall development of the Territory through the strengthening of its relationship with the United Kingdom.

VI Government Moves To Promote Turtle Conservation



The Government of the Virgin Islands facilitated a series of workshops and public consultation meetings to promote and improve turtle conservation in the Territory.

The workshops were facilitated to advance and improve turtle conservation, and is a collaborative effort with the local non-profit Association of Reef Keepers (ARK) and the United Kingdombased Marine Conservation Society (MCS).


Director of Agriculture and Fisheries, Mr. Theodore James indicated that the workshops have been instructive, useful, and deeply engaging. He stated that the sessions have provided an opportunity for interested persons to be involved in a two-way flow of information that will help the department in its data-gathering process.

Mr. James added, "The viewing of a film on turtle conservation also addressed the challenges that are being faced with the responsible fishing of sea turtles in the Virgin Islands, and the feedback that was provided was informative and will aid in the department's efforts to better manage this issue."

Head of Ocean Recovery at the Marine Conservation Society, Dr. Peter Richardson stated that the level of involvement by persons in the community is indicative of the commitment that people in the Virgin Islands have towards the preservation of local culture while simultaneously engaging in responsible turtle fishing.

Dr. Richardson said, "The feedback from participants shows that a lot is being learned at the workshops, not only from scientists about our turtle populations, but also from the wisdom of those attending. The attendees include fishermen, tourism business representatives, visitors, and other key decision-makers."

He also noted that one participant said the project provides the perfect bridge between community



The final workshop was held on May 2, at 6:00 p.m. at Foxy's Bar in Jost Van Dyke. This project is funded by the Darwin Plus United Kingdom Government fund. The University of Exeter has also provided technical support and research resources for this project.
