### **GOVERNMENTANDHOUSE OF ASSEMBLY NEED TO PAY MORE ATTENTION** TO THE TOURISM SECTOR

Following a successful threeday events that encompassed a broad cross-section of the Territory's tourism sector Sharon Flax-Brutus, the Acting Executive Director

of the BVI Yachting, Hotel Tourism Association (BVIYHTA) indicated that the organization is in the process of consolidating key insights and conclusions

from a recent symposium they hosted. The resulting document, she said will then be submitted to the government, in the hope that the suggested measures will be considered and implemented.

Ms. Flax-Brutus voiced her desire for a meeting not just with the Cabinet, but also with the entire House of Assembly, which represents all the Territory's elected officials. She mentioned, "If we fail to engage in a constructive dialogue, or if they aren't sufficiently open to listen, our industry and the BVI will continue to face difficulties."


She elaborated: "We aren't expecting all our suggestions to be implemented, but the reality is that the people making tourism decisions lack the necessary understanding. I am not mentioning this to cause discomfort, it is just the way it is."

She appealed to the government to surround itself with individuals knowledgeable in the local tourism sector if it intends to stick with its current course. Ms. Flax-Brutus also clarified that organization,

BVIYHTA, should not be perceived as an antagonist by either the government or the BVI Tourist Board (BVITB). Rather, she called for a synergistic relationship and expressed a desire for her association to play a supportive role. She stated, "We are dedicated to integration and finding solutions. Yes, we have our issues, but it's all about delivering these solutions." Addressing the discrepancy between the respect accorded to tourism and financial services sectors, Flax-Brutus lamented the lack of appreciation for the tourism industry. She noted: "The majority of people in the financial sector do not have voting rights in the BVI, that's the key difference I see between the two sectors."

She continued: "Tourism often suffers from meddling or neglect as it is where the votes lie. Consequently, tourism becomes a political football, to the detriment of

our country."

Flax-Brutus pointed out that while the government is accommodating the needs of the financial services industry and supporting it with legislation, large players in the tourism industry often face negative portrayals. "The big players in tourism are predominantly foreign-based. This seems to give rise to the perception of these large corporations as 'big bad wolves' reaping everything."

She raised another issue that some tourism companies do not often communicate their contributions to the Territory and their initiatives for the BVI. "Tourism is a political football, and the influence on voters is greater when efforts are focused on a particular district over another."

Finally, she highlighted the need for an overarching plan concerning tourism and gave instances of roads being dug up and left incomplete, with no consideration for the inconvenience caused to locals or tourists.

### "WE HAVE SUFFERED FROM RUMORS, INSINUATIONS, AND REPUTATIONAL DAMAGE" EZ SHIPPING SAYS

EZ Shipping, a company previously mentioned in an Auditor General's (AG) report, has issued a statement criticizing Second District Representative Melvin 'Mitch' Turnbull. They claim Turnbull is vehemently criticizing the AG's COVID Grants Audit Report.

Since early last week tongues have been wagging in the Territory as the AG's COVID Grants Audit Report, which was recommended by the Commission of Inquiry and was circulated. The document revealed that many persons received grants aimed at COVID 19 relief for matters such as phone bill payment, car repairs and house renovations. The document also showed how these grants were given out by House of Assembly members to persons related or connected government members.

Following the territory-wide chatter about the report, EZ Shipping sought to add their voice to the public's outcry and also attempt to clear their name. The company said: "The Auditor General's report on the House of Assembly's COVID-19-Assistance Grants was debated in the

House of Assembly last week. Members of the House of Assembly, including the Honorable Melvin 'Mitch' Turnbull, cited in the report, criticized it. Mr. Turnbull asserted to the Assembly that the Auditor General's procedures fell short of international-industry standards and were severely deficient."

They further noted: "Yet in March this year, Mr. Turnbull praised the flawed Auditor General's Static Marine Platform Report and censured other Assembly members who had questioned parts of the report. However, Mr. Turnbull's position has shifted since he became a subject of the Assistance Grants report. He has criticized the Auditor General and dismissed her work, saying: 'I will not allow certain things to be reported that create a public narrative when the submitted details suggest otherwise.'

While further alluding to their own Auditor General report which claimed the company did not deliver value for the large amount of money that was paid by Government for a barge to perform static platform services as a border security tool EZ Shipping noted that the report was flawed.

The company stated that it has since engaged an independent forensic accountant to assess the Auditor General's Static Marine Platform Report. "The forensic accountant's report found that Auditor General's work was defective, failed to meet international standards and was inadequate," the company stated.

A representative for EZ Shipping further added, "We have suffered from rumors,-insinuations, and reputational damage resulting from a flawed report process where we were not asked to contribute evidence prior to its publication. We were subsequently attacked in the House of Assembly by members, specifically one who now changes his stance on the Auditor General's work when he is under scrutiny. Our only request is for the facts to be assessed fairly, objectively, and independently. We are confident this will show that we met all our contractual obligations."

### Normal Operations Resume At All VI Airports

The BVI Airports Authority (the Authority) is notifying the travelling public that the airports on Virgin Gorda and Anegada respectively have resumed normal operations.

Officer-in-Charge, Mr. Ronnie Lettsome stated that the temporary closure of the airports was necessary as a result of operational issues within the Fire Service at the main airport, Terrance B. Lettsome International Airport (TBLIA).

Mr. Lettsome said the authority failed to satisfy the minimum staffing levels required by OTAR 140, which prevented the airport from operating in compliance with established safety regulations.

He said, "In order to rectify the situation and ensure the restart of operations at our main airport, the Authority made the difficult decision to temporarily suspend services at the Virgin Gorda and Anegada Airports and reallocate manpower to address the staffing shortage at the T.B. Lettsome International Airport.

Chairman of the Board, Mr. Theodore E. Burke apologised to the travelling public, and stakeholders affected by the closure of the airports. Mr Burke said that his Board fully understands the impact the closure had on travellers and the local community, and wishes to assure the public that both the Board and the Ministry are committed to ensuring that such disruptions are avoided in the future.

Mr. Burke added that the Authority took swift action and launched a full investigation into the situation which resulted in the closure of the airports.

"A thorough review of our processes primarily as it relates to staffing levels and operational disruptions is under review," the chairman said. He added, "We are confident that these proactive steps will strengthen our operations and prevent any future disruptions."

Permanent Secretary in the Ministry of Communications & Works Mrs. Elvia Smith-Maduro reminded travellers that the Government of Virgin Islands is working acidulously to improve the system of airports within the Territory.

Mrs. Smith-Maduro stated that these improvements will not only enhance the travel experience but also have a positive trickle-down effect on the local economy.

"As we strive for excellence in our aviation services, the Ministry will provide unwavering support to the Authority in their efforts to improve their systems and eradicate any potential issues that may be faced, whether in the operation of the airport or by its staff members," the PS said.

The Authority will update its operational contingency organisation wide in the immediate short term and will continue to deliver exemplary service to all its customers and stakeholders while it strives to uphold its motto of "Safety is our #1 Priority".

### DEMAND FOR INCREASED SECURITY PRESENCE HAS ESCALATED

S e c o n d - D i s t r i c t Representative Melvin 'Mitch' Hon. Turnbull has expressed concern over the insufficient police presence in his district amid a surge of serious crimes.

Hon. Turnbull, speaking at a recent House of Assembly meeting, reported that the police station in Cane Garden Bay only operates from 8:30 am to 4:30 pm every day. Beyond these hours, residents have been

instructed to contact the West End Police Station.

Hon. Turnbull contended that these restricted operating hours not only harm the residents but are also illogical given the tourist hotspots in his district.

"We have transitioned from having an open police station to one that operates limited hours, a move justified repeatedly by several Commissioners as a philosophical decision. If anyone in our community requires help, they're directed to the West End, which I understand also functions only from 8:30 am to 4:30 pm. What is expected of our residents when these police stations close?" questioned Hon. Turnbull.

He added, "We have witnessed a rise in burglaries and potentially fatal threats that we cannot ignore. Premier, if we are the ones funding the Royal Virgin Islands Police, we can't permit them to dictate how policing should be done. We must work towards ensuring the safety and security of all our people — residents, belongers, and tourists alike."

The issue of inadequate policing services is a chronic problem in the Virgin Islands, with the police force, akin to numerous other public bodies, consistently facing staffing challenges.

## DEPUTY PREMIER PLEDGES NOT TO DISAPPOINT LOCAL BUSINESS OWNERS

During a recent House of Assembly (HOA) sitting, Hon. Lorna Smith, the Deputy Premier and Minister for Financial Services, Labour & Trade, drew criticism for her approach in a set of outreach meetings with local business owners.

Hon. Smith recently held a series of Business Round Table discussions throughout the Territory with the goal of strengthening ties with the business community. She expected fruitful outcomes from these discussions.

However, Sixth District Representative Myron Walwyn criticized Deputy Premier Smith for not offering financial solutions to businesses during these round table discussions. Hon. Walwyn argued this was something Smith should have considered given her interactions with residents during the recent election campaign.

Attorney Walwyn acknowledged Smith's initiative to understand businesses' challenges but suggested that the businesses did not receive what they anticipated from the meetings.

"The most significant hurdle businesses in this country face is capital, gaining access to capital," Walwyn stated. "People are short of money. Hence, minister, I anticipated that you would bring some financial solution to that meeting."

He continued: "You approached the people of District Six empty-handed."

Hon. Walwyn also claimed that the government's recently approved Schedule of Additional Provisions (SAP) offers nothing to the suffering businesses in the Territory.

In response, Hon. Smith shared that her aim was to listen to the businesses' concerns and potential solutions they might offer. She also mentioned that the business owners did not shy away from voicing the

government's shortcomings.

"I didn't carry a stash of money, but I have only been in this role for three months, and the primary goal was to genuinely listen to the people," the first-term lawmaker declared.

Hon. Smith also expressed her intention to engage in

further discussions with banks to explore ways they could better assist the Territory's residents. She affirmed her delight at the opportunity to serve the people of the Territory and pledged not to disappoint them.



### C&W Communications officially launches 'JUMP'

- private-public initiative aims to help bridge the digital divide across Caribbean

Bridgetown, BARBADOS (July 10, 2023) -- A plan to deliver all-important internet connections to low-income-Caribbean-households has-been-unveiledas part of a privatepublic partnership between leading telecoms operator C&W Communications and some Caribbean countries.

Aptly called JUMP, the initiative aims to help bridge the digital divide and foster greater

digital inclusion in a region that today still has less than 65% broadband penetration with 27 million users from a total combined population of 44 million.

In partnership with local governments, C&W Communications, the operators of Flow,

Flow Business, C&W Business and BTC, will provide qualifying households with a subsidised high-speed internet connection, a free laptop computer and relevant training for individuals and families.

So far, the governments of Barbados, Grenada, Jamaica, St Lucia, and The Bahamas have committed to JUMP and more than 2,700 households have already been connected.

life while reducing costs and improving health care. We are very excited for the possibilities of this programme," Dr. Georges stated.

The project will commence with the launch of the guidelines, but it will also be re-enforced with continuous education in the form of CME (Continuing Medical Education) sessions which will address standardised assessment, care and treatment for persons with diabetes.

"We want these guidelines to be seamlessly implemented within our healthcare system. To do this, our focus will be on offering continuous education sessions, building collaborations with the Diabetes Association and clinicians as well as empowering patients to be more proactive and vested in their own care, Dr. Georges said.

The CMO added that the aim is to get to the point where clinical audits will be conducted to ensure that the guidelines are being implemented and further education and training will be provided where necessary to ensure sustainability.

The Launch of the CARPHA Guidelines for the Management of Diabetes in Primary Care in the Caribbean will be held at the Dr. D. Orlando Smith Hospital on Thursday, July 20 at 5:30 p.m.

Clinicians, persons with diabetes, caregivers and persons who have a vested interest in the topic are welcome to attend. Two CME hours will be available.

The Ministry of Health and Social Development is committed to protecting and promoting the health of the people of the Virgin Islands.

### PRESS STATEMENT FROM GOVERNOR OF THE BRITISH VIRGIN ISLANDS MR JOHN RANKIN CMG



His Excellency John James Rankin CMG

The Audit of Covid-19 Assistance Grants made by Members of the House of Assembly was laid in the House on 13 July. The report can be accessed below.

A total of \$3,885,074 was awarded in 2,276 grants. The Audit notes that the grants enjoyed some measure of success, as they were able to assist persons in financial hardship brought on by the pandemic. However, at the same time it finds that there were applicants who took advantage of the programme to obtain public funds in order to accommodate their lifestyle or otherwise obtain grants in the absence of genuine need.

The Audit concludes that: Grants were approved where applications were not supported by documentary evidence.

There were no tracking mechanisms to prevent multiple awards to the same person.

The requirement for the Financial Secretary to review and approve applications for awards in excess of \$5000 wasn't adhered to.

The transparency of many payments was lost, particularly for some large sums paid directly to some applicants.

Public The Finance Management Regulations were not applied in procurement of services for District/community works.

The Report provides further details about grants awarded which I would encourage people to examine for themselves, including the sections that address:

### Grant awards in excess of \$5000

Business reduction grants

Grants awarded by certain Members of the House of Assembly to family members or other Members of the House of Assembly (many of whom also received grants from other public assistance programmes).

The Report finds that the absence of controls in the programme led to multiple

abuses and the award of public funds to ungenuine applications.

The-primary recommendation-from Audit is that "the management of all Assistance Grants should remain within the remit of Social Development the This Department. will ensure that the needs of the most vulnerable persons are addressed and protected against abuses and unscrupulous activities".

I fully support conclusion and I once again thank the Auditor General and her team for their work. The methodology used in carrying out the Audit is set out in the report and I continue to have full confidence in the Auditor General in carrying out her independent functions under the Constitution.

What is most important is that lessons are learned from this Audit, that public funds go to those in genuine need and that mechanisms are in place to prevent abuses. It is positive to see that the Ministry of Health and Social Development is currently consulting on a social assistance programme, and I encourage people to participate. the community as we work together to enhance security at the Cyril B. Romney Tortola Pier Park."

The review meeting broughttogether participants,-including representatives from the British Virgin Islands Ports Authority (BVIPA), Tortola Pier Park Ltd (TPPL), and the Ministry of Communication and Works.

The-Ministry-of Communications and Works, in close coordination with the

BVIPA, TPPL, British Virgin Islands Tourist Board (BVITB), and Royal Virgin Islands Police Force (RVIPF), remain committed to prioritising the safety of all individuals within the Cyril B. Romney Tortola Pier Park. The implementation of these recommendations and additional security measures demonstrates the dedication addressing the recent incident and ensuring a secure environment for park visitors.









Minister Communications and Works Honourable Kye Rymer has announced that the Cyril B. Romney Tortola Pier Park (CBRTPP) is already in the process of implementing significant security measures from 22 recommendations following the submission of the security audit report.

Honourable Rymer, minister responsible for ports, held a review meeting on 12th July with key stakeholders. The

purpose of the meeting was to discuss the recommendations provided in the report and effective collaborate on strategies to enhance security measures.

Minister Rymer stated that he is pleased to announce that out of the 22 recommendations presented in the security audit report, the Cyril B. Romney Tortola Pier Park was already in the process of implementing significant measures. Specifically, a new electronic

being gating system is installed to enable the park to be adequately secured during closure periods. Furthermore, upgrades will be made to the existing CCTV system at the park to further enhance surveillance capabilities and increased security personnel within the park premises to enhance security presence and deter criminal activities.

### **CDB Meeting Addresses Specific Needs Of Overseas Territories**

Premier and Minister of Finance Honourable Dr. Natalio Wheatley has stated that the historic consultation meeting with the Caribbean Development Bank (CDB) last month has brought attention to the specific circumstances and needs of Overseas Territories.

Premier Wheatley attended the Inaugural Consultation with Overseas Countries and Territories and the Caribbean Development Bank hosted by the Honourable Premier and Minister of Finance and Health of Anguilla. This meeting operated under the theme, "Biennial inaugural High-Level Meeting for Transformative Action in the British Overseas Territories (OTs)".

Premier Wheatley explained that because of its categorisation as having "high GDP per capita", the Virgin Islands is precluded from accessing official development assistance and concessionary financing, notwithstanding its heavy dependence on tourism and financial services, and susceptibility to external threats.

Honourable Wheatley stated, "The historic consultation meeting has highlighted the specific circumstances and needs of OTs, while promoting the benefits of further engagement and involvement

with the bank."

The Premier said the framework that was formulated by OT Heads of Governments in conjunction with the Caribbean Development Bank, will ensure that the Virgin Islands is more resilient to the development challenges confronting the Territory through accessing more avenues for financing.

Premier Wheatley added, "The Virgin Islands, like other OTs are disproportionately susceptible to socio-economic and environmental challenges. Therefore, one of the primary objectives of the consultation was to explore viable options for obtaining funding towards achieving our development goals."

The forum also allowed for high-level dialogue on advancing stronger representation for Overseas Territories within the structure of the bank. The CDB is optimistic that solution-based bilateral discussions would ensure that developmental strategies are employed to allow Overseas Territories to fully capitalise on the advantages of regional cooperation.

Premier of Anguilla, the Deputy Premier of Turks and Caicos Islands, the Premier of the Virgin Islands, along with senior managers from the respective countries, attended the inaugural consultation with the Caribbean Development Bank.

The Government of the Virgin Islands will host the next meeting, where discussions will be held on enhanced cooperation and improvement of the bank's capacity to further support the development agenda of OTs Borrowing Member Countries (BMCs).

Meanwhile, - Premier Wheatley attended Caribbean Development Bank's Annual Heads of Government Meeting in June where the bank's highest decisionmaking body discussed climate change, and mitigation corresponding and adaption strategies to engender resilience

Significantly, the Virgin Islands has also assumed its rotation as Governor on the Bank's Board.

The Government of the Virgin Islands remains resolute in the promotion of the overall development of the Territory, through deepening and strengthening its relationship with the regional stakeholders.

## GLOBAL STORIES SELECTED BY GIORGIO MIGLIAVACCA

**EUROPEAN** HEATWAVE Countries across the Mediterranean are in the grip of a record-breaking heatwave as they are hit by the second 'heat storm' in a week.

Much of southern Europe including holiday spots like Spain, Italy, Croatia and Greece has seen extremely high temperatures that are expected to last for at least another week.

Some parts of southern Italy and Greece are expecting highs over 40C as the weather continues to get hotter.

Forecasters have warned that the European temperature record of 48.8C - recorded close to Siracusa in Sicily in 2021 - could be broken. So what does this mean for holidaymakers heading to southern Europe this summer? [EuroNews]

USA - Alabama's Republicanled legislature is holding a special session to approve a new map of congressional voting districts, after the U.S. Supreme Court said the current map, approved after the 2020 census, weakens the power of its Black voters. It only has one majority Black district (out of seven), in a state where more than one in four people are Black. [NPR]

SAN FRANCISCO Jack Mogannam, manager of Sam's Cable Car Lounge in downtown San Francisco, relishes the days when his bar

stayed open past midnight every night, welcoming crowds that jostled on the streets, bar hopped, window browsed or just took in the night air.

He's had to drastically curtail those hours because of diminished foot traffic, and business is down 30%. A sign outside the lounge pleads: "We need your support!"

"I'd stand outside my bar at 10 p.m. and look, it would be like a party on the street," Mogannam said. "Now you see, like, six people on the street up and down the block. It's a ghost town."

SEX APPETITE - Experts talk about how the weather and its variations affect our sex life, from both a physical and a psychological perspective.

They say that spring is the season of love. The summer, however, does not have a saying that relates sexual arousal to seasonality. Still, the notion that when temperatures soar, the libido follows suit, is very widespread. The study Seasonality in human reproduction, published by the University of Oxford, concludes that in countries with high temperatures — not scorching hot — births increase ten months after the summer. In this way, it establishes that the heat is responsible for the higher number of sexual relations.

The study emphasizes that arousal occurs in warm, not extreme, temperatures. "Extreme

heat can cause increased sweating and fluid loss, which can lead to dehydration, which can affect the body's hormonal balance and have a negative impact on libido. In addition, high temperatures can increase the levels of stress and trigger a higher production of cortisol, a hormone that can interfere with the sexual response," explains sexologist Andrés Suro from the MYHIXEL male sexual health company. [El Pais]

RUSSIA - Russia has resorted to sending aging, Soviet-made tanks to the battlefield in Ukraine in a desperate bid to compensate for its staggering artillery losses, experts and analysts have said to mixed effectiveness.

According to the Dutch OSINT project Oryx, Russia had by May 31 lost over 2,000 tanks out of the 3,000 combat-ready vehicles of its original complement when it invaded Ukraine 17 months

As these losses have piled up - and as it lacks the capacity to refurbish more modern tanks at the rates needed - Moscow has increasingly brought outdated Soviet-era T-54, T-55 and T-62 tanks out of storage and to the frontline, even as Ukraine receives increasingly advanced artillery from its Western allies. [Moscow Times]

GREECE FIRES - A wildfire raging near Athens, Greece, has prompted authorities to evacuate a nearby residential community with thousands of seaside homes.

The fire broke out in Kouvaras, roughly 27 kilometers (17 miles) southeast of the capital, damaging several homes.

A spokesman for the regional fire department said, "It's a difficult fire, the winds are really strong."

High winds with gusts of up to 70 kph (45 mph) have fanned the flames as it devours vegetation and threatens nearby buildings.

Greek authorities say as many as 150 firefighters are on the scene, using 40 fire engines and 11 extinguishing aircraft to get the blaze under control. Greece's Hellenic Fire Service also reported that a second blaze had broken out in woods near the resort town of Loutraki, about 90 kilometers west of Athens. On Monday evening, authorities said police arrested a "foreigner" for allegedly causing the fire near Kouvaras. [Deutsche Welle]

Areas bracing for widespread record highs



The main objective of the guidelines is to ensure that individuals with diabetes receive the same level of care, regardless of the healthcare facility they choose for treatment.

The potential impact of diabetes care guidelines

He shared that the program has the potential to significantly improve patient outcomes, reduce complications, and enhance their quality of life.

He further said that it will lead to cost reduction and overall healthcare improvement in services.

According to Georges, the guidelines will be reinforced through ongoing education in the form of Continuing Medical Education (CME) sessions. These sessions will focus on standardized assessment, care, and treatment for individuals with diabetes.

"We want these guidelines to be seamlessly implemented within our healthcare system. To do this, our focus will be on offering continuous education sessions, building collaborations with the Diabetes Association and clinicians as well as empowering patients to be more proactive and vested in their own care," Georges said. The CMO added that clinical audits will eventually be conducted to ensure the effective implementation of the guidelines. [CNW]

How to Stay Hydrated

The key to staying safe and healthy this summer is staying hydrated. And the key to staying hydrated? Follow these 10 easy tips:??

 Drink water—and plenty of it!

According to the Centers for Disease Control and Prevention, daily fluid intake recommendations vary by age, sex, pregnancy, and breastfeeding. Start by drinking a cup of water each morning when you wake up or a glass before bed. Have another glass with every meal. Drink one or two cups after working out. To ward off dehydration, drink fluids gradually throughout the day.

2. Know the signs of dehydration. Does your skin feel dry, irritated, inflamed, itchy, or sensitive? That's a sign of dehydration. Experiencing a headache or feeling dizzy or fatigued? These are signs, too. Muscle cramps, rapid breathing, fainting, and not urinating (or having very dark yellow urine) are others. If you're experiencing any of these symptoms, the simple solution is to get out of the heat and drink plenty of liquids. There are small over-the-counter options like Pedialyte and Hydralyte that balance out electrolytes and sodium with dehydration as well. If your dehydration is severe, call 911.

3. Check your urine.

A good measurement of hydration is the color of your urine. Pale urine, similar to the color of straw, indicates proper hydration while darker urine is a sign that you need more water. A dark yellow or amber color means you may have mild to severe dehydration. Of course, other medications and health conditions could affect this. If you're concerned about the color of your urine, consult with your health provider.

4. Avoid alcohol, sugary drinks, and/or caffeine.

Tricky fact—some liquids work against hydration! Drinks like coffee, sugary sodas, beer, wine and hard liquor, lemonade, sweet tea, energy drinks, smoothies, and flavored milk are all culprits. They are loaded with sugar, sodium, and other ingredients that remove water from your tissues. Consider swapping some of these out daily or rehydrating with more water for each dehydrating drink you consume.



## Sweet Pepper Poppers: The Adorable and Delicious Bite-sized Delights

Have you seen the bags of those cute little mini red, yellow and orange sweet peppers in the produce section? They are adorable! Perhaps choosing produce according to level of cuteness isn't the best way, but in this case, it totally works!

These peppers are so versatile and so sweet, you can eat them right out of the bag. They're delicious grilled; just rub them with oil and pop them on the grill. Word to the wise -- grill the whole bag, because they're scrumptious hot or cold and make a simple side dish, or a lovely addition to salads, or anytime snack.

Bell peppers are highly nutritious, packed with essential vitamins like vitamins C, K1, E and A and

potassium, making them a healthy addition to any diet.

The recipe below is light and summery tasting, even though it's creamy and cheesy. The flavor is fresh and herbaceous with the mild green chilis and cilantro. If you're not a cilantro fan, substitute it with your favorite herb. I used cotija cheese because the mild, salty flavor pairs perfectly with the sweet peppers. Cotija cheese is typically found in the refrigerated cheese section of the grocery store, often alongside other Mexican or Hispanic cheeses. If you can't find any, you could substitute feta cheese.

## EASY CHEESY SWEET PEPPER POPPERS

This recipe can be made under the broiler if you prefer not to barbecue.


- 1 1/2 pounds mini sweet peppers, about 20 peppers
- 8 ounces Neufchatel or cream cheese, at room temperature
- · 10 ounces cotija or feta cheese
- 1 (4 ounce) can mild green chili peppers
- · 2 tablespoons cilantro, minced
- · 2 tablespoons green onion, minced
- Preheat the grill to 400 degrees.

Oil the grates or prepare a grill pan. I recommend using a grill pan, because you don't have to transfer the stuffed peppers on and off the grill or worry about them falling though the grates and all the cheese oozing into

the fire.

Prepare the peppers. Set each pepper on a flat surface and see how it wants to sit without tipping over. Then use a small knife to cut a slit in the top side of the pepper. Use a small spoon or your fingertips to remove any seeds. Set them aside while you make the filling.

In a medium bowl, using a hand mixer or stand mixer, whip the cream cheese with the cotija cheese until fluffy and well combined. Dump the can of chili peppers into the cheese, juice and all. Add the cilantro and green onion, then mix it



Place peppers cut side up on the grill for 4 to 6 minutes until they have softened and have nice grill marks. As the peppers blister, the cheese mixture inside turns warm and gooey. Divine!

Remove from grill and serve with typical Diva flourish.

The eascheesy poppers pepper wonderful served as an appetizer or a side dish. Here are a few suggestions dishes for to serve alongside the poppers: Serve with a fresh green salad, use to accompany grilled meat or seafood, serve with salsa and guacamole, or add them to a charcuterie board or crudite platter. ## GOVERNOR COMMENDS MARINE OFFICERS IN PERSON

Friday, July 14 – His Excellency the Governor John Rankin added his personal voice to the local and overseas commendations expressed to the six RVIPF Marine Branch officers whose bravery and tactical skills was showcased during the high sea chase and interception of two boats carrying illegal drugs off Anguilla last Friday.

The Governor spoke to the officers while onboard the St. Ursula at the Police Marine Base.

"I warmly congratulate you, the members of the RVIPF marine unit, for your work in this operation. The successful seizure demonstrates the increased capacity that the marine unit has developed, including with UK support, and the importance of cooperation between Overseas Territories and international partners in tackling the illicit trade in drugs," the Governor noted.

Two RVIPF vessels with two teams, a sergeant and 5 constables, responded to a call to assist in a joint international anti-narcotic smuggling operation led by U.S. law enforcement authorities and the UK National Crime Agency.

In the end, the two vessels intercepted the two boats within Anguillan territorial waters, arrested the six persons onboard and confiscated 60 bales of what is suspected to be cocaine, one of the largest waterbased cocaine seizures in recent history.

This success characterizes

the ongoing international collaboration of law enforcement entities throughout the Caribbean which continues to disrupt and dismantle organised criminality.







### RVIPF OFFICERS COMPLETED ARV TRAINING AND BECAME D.A.R.E OFFICERS

Tuesday, July 18 – Officers of the Royal Virgin Islands Police Force recently completed an Armed Response Training & D.A.R.E Program, which ran simultaneously at the Road Town Police Station over the last four to six weeks.

exhibition (even overseas), for having acted as a liaison and keeping me updated. Best regards - Elisabetta Carnielli".

Among the highlights of the Conference was a visit to the Mercantile Palace which hosts, among other things, a large "surprise" for visitors interested in postal history: the Menz Archive of 250,000 letters. Already in the 18th century the Menz family was divided into three branches of descent, among which the best known is the Sarnthein-Menz line with the so-called "French bride" Annette von Menz and the commercial house "G. Menz". The collateral line founded by Dominicus Maria von Menz in the second half of the 18th century was equally successful, though less well-known. In the 19th century Peter Paul von Menz and Adolph von Menz, Dominicus's

son and grandson respectively, ran a lucrative business in Bolzano. The Mercantile Museum of Bolzano, housed in the Mercantile Palace, is located in the heart of the ancient commercial settlement, between Via Argentieri and Via dei Portici. The eighteenth-century building, designed by the Veronese Francesco Perotti. architect hosted for more than a century the Mercantile Magistrate, a special commercial court established in 1635 by the Archduchess of Austria Claudia de' Medici, called to settle the disputes that arose among merchants during the international fairs the nineteenth century, the tasks and competences of the Mercantile Magistrate passed to the newly constituted Chamber Commerce of Bolzano, which, aware of the historical and architectural value of the building, undertook constant maintenance and renovation work until 1997 when the doors were officially opened to the public.



### How to Avoid Calcium While Taking Thyroid Medication

DEAR DR. ROACH: I had a thyroidectomy, and I take levothyroxine. Instructions for the medication state not to take it within four hours of consuming calcium. No discussion of the drug has clearly stated whether this only refers to calcium supplements or whether this also includes high-calcium foods.

I usually take levothyroxine when I wake up, between 2 a.m. and 3:30 a.m., to avoid breakfast dairy products (i.e. yogurt, cheese and soy milk) and dinner foods (broccoli, leafy greens, dairy and soy). I go to bed fairly early. I eat mainly plantbased, plus dairy.

I have asked some doctors and pharmacists, only to have them answer with the question: "Doesn't that only apply to supplements?" I don't know! That's why I'm asking. I want my thyroid prescription to work as it's supposed to. Can you shed light on this issue? - E.G.

ANSWER: Large amounts of elemental calcium do decrease the absorption of the thyroid hormone, thyroxine. If you were to take thyroxine (Synthroid and others) at the same time as you would a large calcium pill, you could expect the thyroid medicine to be about 7% to 8% less absorbed. (Iron and caffeine also decrease thyroid hormone absorption.)

A glass of cow's milk taken at the same time will decrease thyroid hormone absorption. Soy milk has not been studied, but I would expect calcium-fortified soy milk to be similar to milk, vogurt and some high-calcium cheeses in their ability to reduce thyroxine absorption.

However, I think you may be taking things too far. One hour is probably adequate enough to separate calcium from thyroxine. Furthermore, if you are consistent in taking your medication, your dose will get adjusted to the correct level. I doubt that vegetables have any effect on absorption.

Finally, in a study of people who took thyroxine sometimes with and sometimes without their calcium, the change was not enough to get them out of the desirable range, although the levels were definitely affected. The dose of thyroid hormone has a little bit of leeway in most people, although some people (such as those with a history of thyroid cancer who are now on replacement therapy after surgery) need to have a very exact dosage. So, avoiding calcium, iron and caffeine in those cases is more critical.

DEAR DR. ROACH: I am a 72-year-old woman who, over my adult years, has developed allergies to Tylenol and all NSAIDs. Just this week, I developed a rash after taking aspirin, which was my last resort for pain. I was given a prescription for tramadol, but I really don't want to take a narcotic for aches and pains I only have periodically. Instead, I use ice, heat, stretching and exercise, which keep me pain-free most of the time. — T.W.

ANSWER: I have rarely seen a person allergic to so many classes of medicines, but it can occasionally happen. It's unfortunate, but I certainly agree with you that an opioid (the term narcotic isn't used any more) is too powerful a medication to use lightly.

There are serious side effects that can happen with tramadol, like any other opioid, and even appropriate use of opioids can lead to opioid use disorder. Misuse of prescription drugs is a huge problem in North America, and not prescribing them in the first place is a good way to prevent problems. (People who misuse opioids commonly get them from a friend or relative.)

Nonprescription ways of treating pain seem like a very good way to treat the occasional pains we all get. Topical treatments, like menthol, camphor-based creams or even topical NSAIDs like diclofenac, may not cause allergic reactions, so you might have success by trying those.

### ALLEGED STRIKE BY CUSTOMS OFFICERS

STATEMENT BY DEPUTY GOVERNOR OF THE VIRGIN ISLANDS MR. DAVID D. ARCHER JR.



Earlier today, I was invited to a meeting by the Financial Secretary to meet with members of His Majesty's Customs Department and the members of the Customs Welfare Association, the Honourable Premier and representatives from the Ministry of Finance were present. The Association made it clear that their goal was to discuss their purpose, address matters impacting Customs Officers and to ascertain a detailed update on outstanding increment payments. They further shared that they did not plan to strike as a result of increments not being paid but wanted to get an update and offer their support in the processing of increments.

A bountiful discussion on the importance of Customs Officers to matters of national security and economic stability culminated in solutions to address a number of organisational matters outside of increment payments. As such, I would like to unequivocally dispel any rumors of Customs Officers striking as a result of increments not being paid.

To date, 1420 of 2261 eligible public officers have been paid their outstanding performance year increments, with arrears, for 2018 and 2019. It is important to note that the processing of increments for eligible customs officers has begun with over 40% of eligible customs officers paid. Following my circular shared on Friday, 14th July, we have now received 98% of the needed documentation to begin processing increment payments for the balance of customs officers. While initial payments were made to officers with no changes to their employment during those years, the remaining payments require a more complex calculation per officer and thus requires more time.

Regarding the overall public service, we have processed an additional increment payroll for this month on 18th July. The Ministry of Finance has assured that officers who were paid increments during this payroll should expect to see funds by tomorrow. This is due to processing time required by the banks to complete the transaction.

Additionally, Payroll officers are working overtime to ensure all outstanding increment payments for 2018 and 2019 continue to be paid as soon as possible provided that all outstanding increment reports and letters are submitted by Heads of Departments by Wednesday, 19th July. I have seen good progress following my last circular.

The public should be aware that we understand the importance of government services and the impact created by closures, through industrial actions. All efforts will be extended to address any concerns made by officers which could impact the delivery of government services.

We thank public officers for their continued hard work and dedication to the Public Service and for being a part of the process to ensure each eligible public officer's increment is paid.

### **Dengue – the Region of the Americas**

19 July 2023

### Situation at a glance

Since the beginning of 2023, dengue outbreaks of significant magnitude have been recorded in the WHO Region of the Americas, with close to three million suspected and confirmed cases of dengue reported so far this year, surpassing the 2.8 million cases of dengue registered for the entire year of 2022. Of the total number of dengue cases reported until 1 July 2023 (2 997 097 cases), 45% were laboratory confirmed, and 0.13% were classified as severe dengue. The highest number of dengue cases to date in 2023 are in Brazil, Peru, and Bolivia. Additionally, 1302 deaths were reported in the Region with a Case Fatality Rate (CFR) of 0.04%, in the same period.

As part of the implementation of the Integrated Management Strategy for the Prevention and Control of Arboviral Diseases (IMS-Arbovirus), WHO is actively working with the Member States to strengthen healthcare and surveillance capacity.

WHO has assessed the risk of dengue as high at the regional level due to the wide spread distribution of the Aedes spp. mosquitoes (especially Aedes aegypti), the continued risk of severe disease and death, and the expansion out of historical areas of transmission, where all the population, including risk groups and healthcare workers, may not be aware of warning signs.

WHO does not recommend any travel and/or trade restrictions for countries in the Americas experiencing the current dengue epidemics based on the currently available information.

## US, China Relations on 'Surer Footing,' Treasury Secretary Says

Relations between the United States and China are on a "surer footing," U.S. Treasury Secretary Janet Yellen said Sunday in Beijing as she wrapped up a four-day visit there, saying "no one visit will solve our challenges overnight."

The world's two largest economies – the United States and China – have a duty to themselves and other nations to communicate more closely when it comes to their economic decisions and climate change, Yellen said at a press conference at the U.S. Embassy.

During her visit, Yellen met with Chinese officials for 10 hours of talks. Five of them were with Chinese Vice Premier He Lifeng on Saturday. The U.S. Treasury Department described the meetings as "candid, constructive and comprehensive," while

Chinese state media termed them "in-depth, candid and pragmatic."

Yellen defended Biden administration restrictions on technology exports that Beijing disagrees with and said such disagreements should not prevent the two countries from finding ways to address "important global challenges, such as debt distress in emerging markets and developing countries and climate change."

The Chinese side expressed concern about U.S. sanctions and restrictive measures against China, the Xinhua state news agency said. The vice premier said the two governments should return to an agreement reached last November by Biden and Xi to improve relations.

"The two countries should act with a sense of responsibility for history, for the people and for the world," he said.

On climate, Yellen pointed out that the U.S. and China are the world's two largest emitters of greenhouse gases and the largest investors in renewable energy.

She said that "climate finance should be targeted efficiently and effectively" to support already established institutions like the Green Climate Fund, a U.N. entity that is endeavoring to support a paradigm shift in the global response to climate change.

Yellen's three-day visit to China wraps up Sunday with an early morning news conference.

On Friday, Yellen held "candid and constructive" talks with China's prime minister, Li Qiang, in Beijing.

### US Treasury Secretary: US, China Must Work Together to Fight Global Warming The world's two largest economies – the United States and China –

The world's two largest economies – the United States and China – must work together to fight the "existential threat" of global warming, U.S. Treasury Secretary Janet Yellen said Saturday in Beijing at meeting with Chinese government officials and climate experts.

"As the world's two largest emitters of greenhouse gases and the largest investors in renewable energy, we have both a joint responsibility and ability to lead the way," Yellen said.

Yellen said "climate finance should be targeted efficiently and effectively" to support already established institutions like the Green Climate Fund, a U.N. entity that is endeavoring to support a paradigm shift in the global response to climate change.

On Friday, Yellen held "candid and constructive" talks with China's prime minister, Li Qiang, in Beijing.

A Treasury Department statement said Yellen "discussed the administration's desire to seek healthy economic competition with China that benefits both economies, including American workers and businesses."

She also emphasized close communication on "global macroeconomic and financial issues and working together on global challenges, including debt distress in low-income and emerging economies and climate finance."

China's foreign ministry released a statement saying the prime minister noted that U.S. and Chinese economic interests are closely intertwined, and that China's development is an opportunity rather than a challenge to the United States. Beijing said that Yellen stated during the talks the U.S. "does not seek 'decoupling and disconnection' and has no intention of hindering China's modernization process."

The foreign ministry said, "China and the United States should strengthen coordination and cooperation, join hands to tackle global challenges and promote common development."

While both sides described Yellen's visit in positive terms, no new plans for more high-level meetings were announced.

"China's going to continue to be around and be a major player on the world stage," White House press secretary Karin Jean Pierre said Friday, adding that an intense competition requires intense diplomacy.

"So it is important to have an intense competition requires intense diplomacy," she said. "That's what you see Secretary Yellen do, that's what you saw Secretary Blinken do. These are the type of conversations that the president has had with President Xi in meetings that he's had with him as well," she said. The U.S. Treasury secretary began a four-day visit to China Friday by calling for market reforms in the world's second-largest economy, and warning that the United States and its allies will fight back against what she called China's "unfair economic practices." Speaking Friday in Beijing to the American Chamber of Commerce in China, Yellen said, "The United States does not seek a wholesale separation of our economies. ... The decoupling of the world's two largest economies would be destabilizing for the global economy, and it would be virtually impossible to undertake."

And while she noted the importance of trade and investment with China, Yellen also "raised concerns, including barriers to market access, China's use of non-market tools, and punitive actions that have been taken against U.S. firms in recent months," during a roundtable with more than 10 U.S. businesses operating in Beijing. "She also reaffirmed the U.S. economic approach to China, which remains focused on three primary objectives: securing vital interests pertaining to national security and human rights; pursuing healthy and mutually beneficial economic competition, in which China plays by international rules; and seeking mutual cooperation on urgent global challenges, including on the macroeconomy, climate, and global debt," according to a Treasury Department statement Friday.

China's foreign ministry said in its statement, "the two sides should strengthen communication and seek consensus on important issues in the bilateral economic field through candid, in-depth, and pragmatic exchanges, so as to inject stability and positive energy into Chinese-U.S. economic relations."

### Two silver medals ends 14-year Jr. Caribbean Squash finals drought



Delilah Pease and Ethan Mohamed, ended the BVI's 14-year Caribbean Junior Squash Championships finals drought with silver medals on Monday in St. Vincent and The Grenadines, marking the first time in its competition history the territory had earned two medals in the same competition. Their medals in the U11 Girls and U13 Boys Divisions, were the first finals hardware since Joe Chapman won U19 silver in 2009. Oliver Henderson was an U13 bronze medalist in 2022.

Gia Ghuran of Trinidad and Tobago, the No 1 seed, beat Pease 11-5, 11-7 and 11-5 to claim the gold.

Both girls had navigated their way throuh the draw without dropping a game. Today something had to give," Coach Adam Murills told Island Sun Sports. "Both girls have fantastic serves and apply huge pressure especially when serving from the forehand side. Gia immediately found her rhythm making things exceedingly

difficult for Delilah. She opened up a lead and managed to maintain it throughout the first game to take it 11-5"

Pease, he noted, coped slightly better with Ghuran's serve in the second game and played and had some fantastic volley returns. "She was closer but Gia still managed to take the game 11-7. Delilah gave her absolutely every point, chased everything down, hit some great winners of her own, but ultimately Gia was slightly too good on the day and prevailed 3-0. An incredible debut performance representing the BVI from Delilah. She's only 8 years old and will have two more years to try and go one better and get her hands on the trophy. I certainly wouldn't back against her."

Pease stopped St. Vincent and the Grenadines' Amiyah Bascombe, 11-3, 11-1 and 11-2 in her opener, then overpowered Guyana's Zoey McDonald, 11-3, 11-7 and 11-3. She advanced to the final after a 12 minute 11-3, 11-4 and 11-2 win over Barbados' Peyton Marshall-Branc.

Like Pease, Mohamed was up against the No 1 seed in the form of Ben Shepherd from Barbados, who prevailed 11-1, 11-5, 11-3.

"Ben is quite small in stature but

is known for being a very skillful player. Ethan's game plan was to try and be solid around the middle and get the ball past Ben before then looking to use his own skills to take the ball in short," Murills explained. "Ethan managed in patches to play some high-quality squash, but he couldn't quite match Ben's consistency. Ben was able to keep a cushion in all three games and ran out a 3-0 winner."

Murills said that something Mohamed can take away from the match is that he needs to remain positive at all times. "He's a great young player and he needs to fully believe that when he's on court and not be disheartened if things aren't quite going his way," Murills said. "I fully believe he has the potential to overturn this result down the road."

Mohamed, the No 2 seed, opened with an 11-2, 11-4 and 11-7 win over Berhan Jackson of Trinidad and Tobago. He needed five sets to overcome the Cayman Islands' Levi Jack 11-5, 11-6, 4-11, 6-9 and 11-6 and advanced to the final.

"Both Ethan and Delilah have succeeded in making history for the BVI by claiming the BVI's first silver medals at the Junior Caribbean Champs since 2009. This is something they can both be immensely proud of," Murills said. "I have no doubt that they'll

Jakob Noblett bested the Cayman Islands' Dualtach Lynch, 11-7, 11-0 and 11-9, before turning back Barbados' Ethan Cyrus, 11-7, 11-4 and 11-0. He also beat Barbados' Elian Hamati, 11-9, 11-9 and 116, then needed five sets to get past stubborn Ross D'Juran of Trinidad and Tobago, 7-11, 11-4, 11-8, 8-11 and 12-10.

Zevieh Abraham fell to the Cayman Islands' Charlie Makin, 8-11, 9-11 and 8-11, then overcame Dru Samuel of hosts St. Vincent and the Grenadines, 4-11, 11-8, 11-2, 7-11 and 11-4, before falling to Bermuda's William Frith, 7-11, 7-11, 11-6 and 7-11. Zane Peltlove went under to Benjamin Sherratt of Bermuda, 11-3, 11-3 and 11-3, before turning back St. Vincent and the Grenadines' Za'mar Hannaway, 11-2, 11-2 and 11-3. Darci Reich lost to Jamaica's Catherine Risden, 3-11, 2-11 and 3-11.

### Walters win NACAC 11-12 Age Group, Gillings misses 13-14 by 2-points

Bryson Walters won the NACAC Age Group Championships 11-12 Boys overall division and Othniel Gillings who won the 11-12 Boys crown 2-years ago, narrowly missed the 13-14 Boys title by just two points, during the event held in Santiago, Dominican Republic.

Walters, who won Long Jump silver and 60m bronze, amassed 3080 points for the title from a field of 30 participants, in the five events Pentathlon. Kerjahni Prevost finished with 2242 and 29th overall. Shakoya Richards was 14th of 37 among the Girls with 2388 points while Tiffany

Herbert placed 29th with 1959.

Gillings, who led the seven event Heptathlon competition from the start and earned High Jump Gold, 80m bronze and 80m Hurdles bronze, needed to finish in the top 10 of the 1200m, but was 13th and missed the overall 13-14 Boys Division crown by merely two points. He amassed 4796 points behind the Bahamas' Jahcario Wilson who was seventh in the 1200 and edged him with 4798. Ty'Rique "TyTy" Charles finished fifth with 4682 including a Ball Throw bronze. His points combined with that of Gillings, gave them the 13-14 Boys Division title.

In 2021, Jah'Kyla Morton and A'Sia McMaster were the 13-14 Girls Division champs.

Counterparts Jamelia Chambers was 10th of 34 participants with 3555 while Deneil Clark was 16th with 3342.

"The athletes came out and all did

their best despite the long hours of travel and short hours of rest before competition started," Coach Ericca Frederick told Island Sun Sports. "Some had personal bests in different events. I'm also super proud of Ty'Rique "TyTy" Charles and Othniel Gillings, who came back two years later and once again won the 13-14 Boys Heptathlon Division after winning the 11-12 Division in Nicaragua in 2021"

Both Walters and Gillings—who finished among the top overall sport—are coached by Frederick. "Right now, I'm feeling extremely proud and happy for Bryson Walters and Othniel Gillings. They have put in the hard work in training for the competition over the past one and a half years," Frederick noted. "Othniel already had the experience from two years ago when he came first in the 11-12 Boys Division. He's very competitive and

loves competition which I know pushes him to do better."

As for Walters in his first international competition, she said he did the same thing Gillings did two years ago. "Many times in training, I

told him I had confidence in him and I knew he could do the same thing that Othniel did. As I watched him in training, I saw that he was at the same level that Othniel was two years ago."

## A missed Golden Opportunity

Gold should be sold to those who know its value, as an African proverb goes. Meanwhile, in Ghana, the government - which is responsible for protecting the country's natural

resources - is alleged to be undervaluing the country's gold itself.

Back in December 2020, together with the Ghana Integrity Initiative and the Ghana Anti-Corruption Coalition, asked we regional West Africa's court to weigh in on the Agyapa deal, in which the government of Ghana has been considering selling off the country's future gold royalties in perpetuity under highly suspicious circumstances.

After more than two years of deliberation, the judges announced their decision on Monday. Disappointingly, the court rejected our plea to intervene.

Based on the arguments we've heard so far, the court appears to be refusing to act mainly because harm has not yet occurred. This is unfortunate: We should not have to wait for the damage to happen to correct the course.

The court also considers that we failed to present substantial evidence to demonstrate corruption risks under the government's proposed deal. Never mind the 64-page report from the special prosecutor, which

documented numerous irregularities fighting corruption. and warned of risks of illicit financial flows.

## HAITI URGENTLY NEEDS A GENUINE AND REPRESENTATIVE TRANSITIONAL GOVERNMENT

Haiti's non-elected President, Dr. Ariel Henry has been identified as a significant part of the current crisis in Haiti. Henry and a small clique, who surround him,

are hardly running the affairs of the state. Indeed, as armed gangs control more than 60 per cent of Port-au-Prince and the main corridors throughout Haiti, the disappearance of the state is obvious.

However, Henry and his appointed government have been dismantling what remained of Haiti's democratic institutions. As a coalition of U.S. based law school clinics describe it, "As of January 2023, there is no longer a single elected official at any level of government in Haiti."

In the meantime, Henry has been accused by the U.S. law school clinics, including Harvard Law School, and others of taking illegal actions, which are designed to prolong his non-elected role as President. In March, Henry illegally named eight justices to Haiti's highest court, the Cour de Cassation, undermining the court's legitimacy to check executive power. Additionally, in December 2022, he organized a "National Consensus Document for an Inclusive Transition and Fair Elections".

The document hardly reflected a "national consensus" in which key human rights organizations and political actors were excluded – a serious flaw which has been ignored by hemispheric and regional organizations.

This unpopular document would help to consolidate Henry's power by allowing him to pack the Cour de Cassation, Haiti's Supreme Court, with his handpicked persons, and putting in place an unconstitutional Provisional Electoral Council to organize and superintend Presidential and other elections. Haitian civil society, in many public statements, and presentations to members of the U.S. executive and legislative branches and to diplomats in the U.S., Canada and France have made it clear that they object to the December 2022 document.

According to a statement made by the Heads of Government of the Caribbean Community (CARICOM) at their 50th anniversary meeting in Trinidad from July 3 to 5, Henry told them "that he will not seek election but will head a Transition Government to secure the arrangements to transition the country from the security and humanitarian crises until the holding of credible, free and fair elections". Insiders reveal that this statement had to be extracted from Henry who resisted being asked to make such a statement on

the basis that "Haiti is a sovereign country".

In any event, while CARICOM leaders say, officially, that Henry has made this statement, he is yet to make such a public statement to the Haitian people. Furthermore, the fact that he and his close group

are alone establishing elections machinery assures civil society and political parties in Haiti that "credible, free and fair elections" are impossible.

Significantly, in an article, published in the New York Times on 13 July, an experienced and knowledgeable expert on Haitian affairs, Jake Johnston, as senior research associate at the Centre for Economic and Policy Research, pointed out that "Henry has close links to a prime suspect in the assassination (of former President Jovenel Moïse)". Johnston reveals the following troubling information: "The former chief prosecutor overseeing the assassination case in Haiti called Mr. Henry to testify. He refused and then called the justice minister and told him to fire the prosecutor. When the minister refused, Mr. Henry fired both. Since then, an audio recording of the judge overseeing the case was leaked to CNN. "Ariel is a prime suspect of Jovenel Moïse's assassination, and he knows it," the judge can be heard saying. "Do you think I can touch Ariel now?"

Meanwhile Haiti continues to descend into chaos, lawlessness and wide scale human suffering. The World Food Programme says half of Haiti's population is experiencing hunger; there is no functioning criminal justice system, there are no trials and 85 per cent of prisoners have never been tried; the only electricity generation in the country comes from a private company owned by an elite Hattian family; between January and March this year, there have been 398 kidnappings and 1,634 violent assaults – including murders and rapes – took place in Port-au-Prince;

many people in Haiti have no birth certificate and no identity papers; officially they do not exist; one hospital in the Canape Vert neighbourhood, south of the Capital, reports that it treats more than 10 patients wounded by gunshots every day.

The Haitian people cannot rely on their government for the basic services that every government is obliged to provide to its people. The state has long since collapsed.

Despite all this, the focus of the international community throughout this worsening crisis has been on whether or not to provide military support to the Haitian Police which is the principal request of the Ariel Henry regime. It is a request deeply feared within Haiti as a ruse to maintain the regime in office, and, consequently, to continue the incapacity to address the dire conditions in which the Haitian people are forced to eke out a miserable life.

Haitian human rights groups and others, who yearn for a better life, do want the restoration of security, but they also want justice and accountability by a government they elect and on which there must be checks and balances, including free and fair elections. Therefore, the start of any international response to the Haitian crisis must be the establishment of a legitimate transitional government, comprising representatives of civil society and political parties.

After three days of a failed meeting from 11 to 13 June in Jamaica – which Henry had to be cajoled to attend – it was obvious that he has no interest in genuine power sharing.

On the gangs in Haiti, it should be recalled that they were created by members of rival political parties and elite oligarch families for their own purposes. Fed by the greed and ambitions of others, they have become forces with lives of their own. Dealing with them requires careful strategies and even negotiations which are best left to a transitional government that enjoys the confidence of a broad cross section of the Haitian people.

To give the country the chance it desperately needs, and which Dr. Henry clearly cannot provide, he should consider stepping aside to facilitate the convocation of willing parties to appoint a transitional government in which neither he nor any member of his present regime should participate, unless agreed and accepted by the broad-based grouping. And that should be the transitional government which should provide the international community with the country's priority needs, giving every safeguard against corruption and political misuse of resources.



### **Shelter Classifications**

Primary shelters can provide refuge during and after a hazard like a storm or earthquake and are equipped with generators as well as facilities for shelterees to cook and bathe.

Secondary shelters can provide refuge during and after a hazard but don't have as many of the facilities as a primary shelter and would house shelterees for a shorter period of time.

Tertiary shelters can provide refuge after a hazard and would only host shelterees temporarily.

These facilities have been inspected by the Department of Disaster Management, the Environmental Health Division, and the Public Works Department in keeping with the BVI Emergency Shelter Manual.



### 'Slavery Reparations are Coming' | UWI in TIME

The University of the West Indies,Regional Headquarters, W.I. WednesdayJuly 19, 2023—TIME Magazine's current front page declaration "Slavery Reparations are coming", has consciously foregrounded the epicentre roles of Barbados, The University of the West Indies and its Vice-Chancellor, Professor Sir Hilary Beckles who is internationally recognised as the global iconic face of the movement.

The recent coverage bears witness that the world is on the cusp of a major structural transition driven by reparatory justice, an inspired development jointly affected by the Caribbean's only indigenous, world-ranked universityand its CARICOM partners.

The UWI, wholly owning its mission as an activist university celebrates theactivism that has placed it at the pinnacle of the

global reparations movement, seeking justice and driving a new development paradigm for the region. Concretising the University'srole at the epicentre of this growing global movement, Vice-Chancellor Professor Sir Hilary Beckles, whose research features in the TIME's article says, "The UWI continues to be at the forefront justice conversations. including the battle for reparations to be made to peoples of the Caribbean. These are owed by colonial powers, as compensation for their historical crimes of native genocide and African enslavement, through which these powers have amassed great wealth, and from which they still profit."

In July 2013 Caribbean leaders at the 34thCARICOM Summit agreed to pursue reparations from Britain,

based on representation by made Professor Hilary Beckles. Two months later, at its first Reparations summit in September 2013, CARICOM identified Sir Hilary to lead its CARICOM Reparations Commission (CRC) as Chairman. Under his leadership, the CRC has taken the reparations discourse across the globe - to the British House of Lords and the US Congress, and to universities in Europe, North America and Africa to name a few.

The UWI, under Vice-Chancellor Beckles, established a Centre for Reparations Research (CRR) based on a mandate of the 34th meeting of the CARICOM Heads of Government. The CRR, with Professor Verene Shepherd at the helm, leads the implementation of CARICOM's Reparatory Justice Programme – promoting

research on the legacies of enslavement. colonialism and native genocide in the Caribbean; working with national and regional reparation commissions and committees to promote education on these legacies and the need for justice and repair; and promoting advocacy for reparatory and social justice by publishing reparatory-justice focused research, building a capacity to provide consultancies to CARICOM and other relevant institutions, raising public awareness through media, and supporting activism around the Reparatory Justice Programme.

As The UWI marks its 75th anniversary year, Vice-Chancellor Beckles notes that it was started as a reparatory justice institution to address the harmful public health legacy of slavery. He distinguishes that The UWI has participated fully in the reparatory justice movement because of its ethical responsibility.

With social justice as part of its core, The UWI, in 2019, ushered in the first-ever Caribbean Reparatory Justice initiative in partnership with University of Glasgow (UoG) in Scotland to create the Glasgow-Caribbean Centre for Development Research, built upon a negotiated 20-year commitment of a £20 million investment as part of an inaugural global reparations development framework.

This September, as an extension of that relationship, The UWI and UoG prepare to launch a jointMA/MSc in Reparatory Justicewith a specific focus on the Caribbean and the slavery reparations movement.

The UWI has also been at the front and centre of two landmark individual family apologies and reparatory initiatives. The first from Bridget Freeman, whose family married into the

Barbados slave-owning class, was a contribution US\$500,000 to the University's development fund-through its 2021 Global Giving campaign, earmarking her gift as part of reparations that should be paid by those who benefitted from the crime against humanity. In February 2023, British-American BBC anchor/correspondent, Laura Trevelyan delivered an apology, signed by 104 members her family and the descendants of the part owners of six slaveowning plantations in Grenada. Laura Trevelyan's personal of £100,000 contribution was pledged to establish an education fund for The UWI Open Campus.

Later this month, from July 24 to 29, The UWI in collaboration with partner agencies - African Union-Economic Social and Cultural (AU-ECOSOCC), Council CARICOM, Africa Judges And Jurist Forum (AJJF), Open Society Foundations and the Government of Barbados - will co-host a high-level study tour which brings together Ambassadors and representatives from selected Member States of the African Union, Pan-African academics, advocates, practitioners and campaigners in Africa, who have worked on or are working on issues related to reparations, healing and Pan-Africanism to draw lessons and learnings from their Caribbean counterparts on how to develop a unified front on reparations for historical crimes. It underscores the strategic relevance for Africa to serve as a leading voice for reparations by coalescing with ally nations in the Caribbean community.

As the global reparatory justice movement gains momentum, The UWI affirms its commitment to greater advocacy and consciousness-raising.
