# TO REPEAL OR NOT TO REPEAL: THAT IS THE **DILEMMA...IS IT?**

Sticking to promises made on the recent campaign trail the Government is moving forward with plans to repeal the controversial Greedy Bill as promised. The move towards keeping this popular promise was made during Cabinet's 15 June meeting when the amendments that would essentially repeal sections of the Retiring Allowances (Legislative Service) (Amendment) Act, 2021 also known as Greedy Bill were considered.


The Bill first sparked public outrage when community Activists Kishma Penn and Cindy Rosan after raising the alarm on social media for weeks before the Bill was passed in the House of Assembly, decided drive throughout the Territory with loud speakers educating the public about the content of the Bill. It was Penn who nicknamed the legislation the "Greedy

Bill" and the name became the correct identifier. The matter was then raised again on the campaign trail as then political candidate and Attorney (now Sixth District Representative) Hon. Myron Walwyn explained in great

detail what was wrong with the legislation.

Overall, the concerns about the legislation focused on what can be described as some problematic parts or sections of the Act that

specifies that legislators who had served in the House of Assembly could receive a gratuity of \$250,000-300,000 immediately upon retirement. Additionally, the same legislators would receive their current salary per month for a fixed number of years as if they were still working.

During the recent meeting Cabinet decided that subsections (2a) through (2f) of Clause three (3) of the Act will be repealed to effectively abolish the provision for salaries to be paid to retiring legislators in excess of their Retiring Allowances as prescribed therein.

The amendments also prescribe that elected members in the Fourth and/or Fifth House of Assembly be given the option of foregoing the salary payment referred to in the Bill that caused public outcry.

It was further stated that the Financial Secretary Jeremiah Frett will be instructing the Attorney General Dawn Smith to draft the necessary legislation to effect the recommended changes to the legislation and that once completed the amended Act will be resubmitted to the Cabinet for approval before forwarding to the House of Assembly.

Cabinet's attention of the matter is essentially a fulfillment of a promise that was made by Premier and Minister of Finance, Dr. Natalio Wheatley after the April reelecting of his government. Following his government's victory, the Premier confirmed that the Retiring

Allowances Legislative Service Amendment Act 2021 will have its offending sections repealed upon his return from a scheduled trip to London. The Premier made this announcement during a press conference and General Update on 2 May discussing various issues in the Territory.

"Soon at the cabinet meeting, perhaps after I return from London, we will have a Cabinet paper which will put forward a decision to have the offending sections of that Act repealed," the Premier stated.

He also highlighted the importance

of going through the legislative process and not skipping steps, as advised by Attorney General Smith. Nevertheless, he promised that a decision would be made as soon as possible to repeal the problematic sections of the legislation, as pledged during the 2023 election campaign trail in the BVI.

Members of the public became skeptical about government's promise to repeal the legislation after it was noted that during the recalled House of Assembly in April 2023, a decision was taken not to repeal the bill on the Attorney General's advice.

As the controversy surrounding the Bill heated up on the campaign trail with persons on the Government's side claiming that Sixth District Representative Hon. Myron Walwyn who raised the alarm about the Bill during the campaign had already benefited from it. Likewise, critics on the Opposition side accused the government of setting the legislation to benefit its first time members.

As the calls for the repealing of the legislation heated up before the Territory went to the polls, the Premier acknowledged that legal advice would be required since there were persons already entitled to benefits, and such individuals cannot be disenfranchised. "That is something that we are going to need legal advice on, persons who have already become entitled to benefits. We certainly don't want to disenfranchise anyone from a legal perspective and taking away rights, which they have already earned," he stated.

Dr. Wheatley further added that an independent body like Pricewaterhouse Coopers is currently reviewing salaries and would recommend salaries for legislators that consider roles and responsibilities, as well as other professions.

"For me, the ideal situation is to come up with salaries from an independent body. Pricewaterhouse Coopers is currently conducting a review of salaries and we would want for them to recommend salaries for legislators, which is commensurate with the roles and responsibilities and also takes into consideration all other professions," he added.

After the elections dust had settled senior Legislator Opposition Member and Third District Representative Hon. Julian Fraser during a JTV interview in May stated that he does not think that the Act needed to be repealed, but rather amended.

The Third District Representative, who had not previously taken a stance on the issue, clarified that he was not currently preoccupied with concerns about how a repeal of the bill would personally affect him.

During the interview Hon. Fraser was asked to comment on the fact that Sixth District Representative Hon. Myron Walwyn who recently returned to the House of Assembly (HOA) after a four-year hiatus, already benefited from the retirement program in place for HOA members.

In response about the impact of Hon. Walwyn's return on his pension, Hon. Fraser explained that there are mechanisms already in place to address such situations. "I believe his pension will be suspended. He will no longer receive pension payments. Instead, he will begin receiving a salary," Hon. Fraser explained. "It's important to remember that he would have received a lump sum based on the pension... when he retires again, whenever that may be, then they'll continue from where he left off."

Hon. Fraser further clarified that repealing a law means eradicating it entirely. He suggested that this may not align with the desires of the public regarding the specific legislation under scrutiny.

"In my opinion, it simply needs to be amended — remove the parts that are problematic and retain the rest of the legislation," Hon. Fraser expressed.

However, he acknowledged that if the public strongly favors repealing the Act, then it should indeed be repealed. Nonetheless, Hon. Fraser emphasized that the relevant sections of the legislation should be integrated into any new law that is drafted.

# REGIONAL COLLABORATION WILL LESSEN IMPACT OF FUTURE PANDEMICS

In consideration of the dramatic economic effect the COVID 19 pandemic had on the Territory's tourism sector the Government is aiming to ensuring that should history repeat itself, the effects on the BVI's economy will not be as devastating. As a result Cabinet has decided that the BVI will participate in the Caribbean Public Health Agency's Regional Tourism and Health/Travelers Health Program (THP).

News of this decision was revealed in the post Cabinet Meeting statement. It was noted that during the meeting on 23 June Cabinet decided that the Ministry of Health and Social Development and the BVI Tourist Board will collaborate with the Caribbean Public Health Agency (CARPHA) to jointly implement the Tourism and Health Program within the Territory.

The program aims to enhance the BVI's ability to effectively prepare for and respond to public health threats associated with the tourism sector, and in the process ensure that the devastating economic impact experienced during the COVID-19 pandemic is not repeated.

The THP, a groundbreaking initiative, addresses critical health, safety, and environmental sanitation concerns that directly impact the tourism industry. By strengthening the BVI's readiness and response mechanisms, the program seeks to minimize risks that transcend national boundaries and can impede access to goods. Moreover, it aims to prioritize the well-being of both tourists and locals, bolster regional health security, and elevate the overall quality, reputation, and sustainability of Caribbean tourism.

The implementation of this comprehensive program will be led by CARPHA, the primary public health institution responsible for disease prevention and health promotion in the Caribbean region. CARPHA will collaborate closely with the Caribbean Hotel and Tourism Association (CHTA), the Caribbean Tourism Organization (CTO), and other participating countries to ensure the successful implementation of the THP.

This regional initiative takes a multifaceted and multisectoral approach, employing a real-time early warning and response system for tourism and health information (THiS). It also establishes Caribbean-wide guidelines to address health issues in various tourism settings such as accommodations and passenger ships. Additionally, the program focuses on capacity building in areas such as food safety, hospitality health safety, and environmental standards, while actively engaging regional and international health and tourism partners.

Through these initiatives, the THP aims to equip countries with the necessary tools and knowledge to effectively respond to public health threats, including those similar to the COVID-19 pandemic.

Additionally, the program encompasses a comprehensive network that consolidates vital health information for travelers. This includes data from THiS, which caters specifically to air travelers, as well as hospitals/health centers, accommodations, cruise ships, laboratories, the environment, media reports, and international health and tourism agencies. These interconnected sources will facilitate rapid and coordinated responses to any potential public health threats, ensuring the safety and well-being of all individuals involved.

### MAJOR OFFENSES CONVICTS TO BE DEPORTED

Within a period of slightly over a month, His Excellency Governor John Rankin, CMG ordered the deportation of four individuals from the Territory who were convicted of various serious crimes. The deportation orders were issued for Lynn Mervin Weekes, Andre Dexter Stedman, Zawdie K. A. H. Daniel, and Kenron Rollinson Fergus.

In accordance with Section 40(1)(b) of the

Immigration and Passport Ordinance (Revised Edition 2013), which outlines the circumstances under which the Governor can issue such orders His Excellency stated that he was made aware that the four persons, who are not considered residents of the Territory, have been convicted of offenses under the Ordinance that carries a minimum prison sentence of three months or more. As such, the Governor ordered

that these individuals leave the Territory within a specified timeframe and remain outside of the BVI thereafter.

Deportee Lynn Mervin Weekes has been convicted of murder, while Andre Dexter Stedman has been found guilty of the offenses of rape and indecent assault. The deportation order for Weekes was issued on 22 May, followed by the deportation order for

Stedman on 21 June.

Zawdie K. A. H. Daniel has been convicted of multiple offenses, including Importation of Controlled Drugs, Overstaying in the Territory, and Possession of Controlled Drugs. His deportation order was issued on 26 June.

The fourth deportee, Kenron Rollinson Fergus also faced more than one criminal charges. He was convicted of Possession of a Controlled Drug with intent to supply. His deportation order was also issued on 26 June.

Governor Rankin ordered that the four deportees leave the Territory on or before the expiration of seven days from the date on which a copy of this Order is served on them by an immigration officer or a police officer, and thereafter stay out of the BVI.

### SAME-SEX MARRIAGE REFERENDUM TO BE ANNOUNCED

The Territory is set to embark on a significant democratic process as the government plans to hold a referendum on the issue of same-sex marriage. The decision comes in light of recent legal challenges questioning the constitutionality of Section 13(1)(c) of the Matrimonial Proceedings and Property Act, No. 6 of 1995, which declares marriages between parties of the same sex as void. As such on 30 June a resolution for the BVI's first referendum was gazetted.

Under the provisions of the Referendum Act, No. 9 of 2002, the Cabinet has the authority to refer matters of Territorial importance to the electorate for determination through a referendum. Recognizing the complex and sensitive nature of the same-sex marriage issue, the Cabinet deemed it necessary to seek public opinion on the matter.

The referendum, which government said will be done shortly aims to gauge the electorate's views and guide the government on the potential legalization of same-sex

marriage or the establishment of civil unions or domestic partnerships for same-sex couples.

The resolution, which has been presented to the House of Assembly, outlines two crucial questions that will be posed to voters during the referendum. The first question will inquire whether individuals are in favor of legalizing same-sex marriage in the British Virgin Islands. The second question focuses on the preference for legislation that would provide for civil unions or domestic partnerships. These unions would grant same-sex couples various rights, privileges, and benefits, encompassing areas such as property rights, employment, healthcare, and social security survivors benefits.

By conducting the referendum, the government seeks to demonstrate its commitment to involving the people of the Virgin Islands in decisions that impact their lives. The referendum will serve as a platform for public engagement, allowing citizens to express their opinions

and shape the government's approach to same-sex marriage. The outcome of the referendum will guide the government's potential legislative intervention and reform, ensuring that the wishes and concerns of the populace are duly considered.

Meanwhile, the case that spurred the decision to hold a referendum was set to commence in the High Court this week. The case involves two Virgin Islands women, who were married in 2019 under UK Law. The couple filed a Constitutional Motion against the British Virgin Islands Government in June 2021; after being denied a marriage license by the Registrar General back in February 2021.

The case which was filed in the High Court is premised on the Virgin Islands Constitution, and the Matrimonial Proceedings and Property Act. According to the filing, the defendant's case is that although they were married in the UK, their marriage is valid in the Territory by law.

Ahead of the referendum, the BVI Christian Council has made representation on the matter, and is an interested party in the monumental case.

Additionally there are several considerations such breach of Human Rights incorporated in our Constitution, the future use of Referenda which could become chaotic or a mere political manipulation, and the more recent lamentations that the BVI is undergoing a

brain-drain that is mirrored in exodus of many talented and "truly" qualified BV Islanders and residents leaving the Territory never to return to go to more progressive countries and nations such as Canada, and most of Western Europe. Furthermore anyone can see the brilliant results obtained with the Brexit referendum.

Update on Small Island Developing States (SIDS) Ministerial Meeting on Non-communicable Diseases and Mental Health

Madam Speaker, I would like to take this opportunity to provide a report to this Honorable House on my recent trip to Barbados from the 11th to the 16th of June to attend the PAHO/WHO SIDS (Small Island Developing States) Ministerial Conference on Chronic Diseases and Mental Health and its significance to the Territory. This meeting follows on from the earlier Technical Meeting also organized by PAHO/WHO also held in Barbados from the 17th to 18th of January which was attended by the Chief Medical

Officer. At the meeting in June, there were representatives from 39 Small Island Developing States (SIDS) countries and 18 Associate Members from all six World Health Organization regions, around the Globe. The resolution agreed to by Ministers of SIDS will be taken forward to the next UN General Assembly in September 2023, the next World Health Assembly in January 2024 and the issues will find themselves on the Agenda of Conference of the Parties COP 28 in December 2023. At COP 28 UN Climate Change Conference,

issues of climate change and health will be on the agenda.

At the UN General Assembly, COP 28, and the World Health Assembly countries will be considering many issues, but the specific concerns of SIDS, Chronic Diseases, and Mental Health will be represented. A strong message from all SIDS from the Bridgetown Initiative which is a clarion call from SIDS for development funding to be allocated on a more equitable basis considering the special vulnerability of SIDS. In consideration of the special

vulnerability of SIDS due to climate change the initiative calls for reforms in how SIDS can access international development funding to invest in health and other emergent issues, because of climate change and highlight concrete actions required on the world stage to deal with the pandemic of chronic diseases and mental health issues. The Bridgetown Agreement is a landmark agreement designed to ensure that the largest polluters and contributors to climate change pay their fair share and the Small Island Developing States such as these Virgin Islands have access to the necessary capital, emergency liquidity, and grants at a fair and equitable price to mitigate these climate change impacts.

As the new Minister of Health, the exposure to best practices and networking with colleagues from SIDS around the world was invaluable. I also took the opportunity to visit the Winston Scott Polyclinic in Bridgetown and observe primary health care in action. I also met with the director of the Chronic Disease Research Center, and took time to visit St. Michael's College, the premier secondary school in Bridgetown and discuss with the principle how she incorporates programs such as Health and Family Life Education across the curriculum and other health promoting interventions. These informal engagements were a welcome addition to what was a very important conference.

The conference highlighted the need to involve all sectors of Government, civil society, and both service users and persons with lived experiences in the process of making policy and developing and evaluating programs. The role of the commercial sector and in particular the impact of

commercial determinants on health was highlighted. Madam Speaker, Government cannot act alone and where commercial activity is having negative impacts on health the sector must be engaged as vigorously as when we engage them on positive matters. The actions that negatively affect health and those required to positively impact health are not only in the Health Sector but also in every sector of Government and society. Hence a whole of Society approach is needed.

Health is often seen as a net consumer of government revenue and questions about revenue collection always arise. While revenue collection is very important it is also equally important to not view health as a cost to society and the public purse, but more so as an investment in our greatest and most important resource. Health is an investment in people and the development of the Territory. Health is a complete state of mental, physical, spiritual, and social wellbeing, not just the absence of disease. Hon Mia Amor Mottley stated at the conference that health is everyone's "first The World Health Organization's Universal Health Care Strategy, underscores the importance of ensuring equitable access to health care. imperative for us to ensure that appropriate, needed, health care is accessible without bias. Without healthy people we do not have productive people. Without productive people we do not have a productive economy. Without these we cannot develop as a Territory. Interestingly enough a healthy people is also a sign of a thriving economy and well developed Territory. The twogo hand in hand.

# Voter Registration Is Ongoing

The Office of the Supervisor of Elections is informing the public that continuous Voter Registration is ongoing, and persons who are eligible to vote are encouraged to register.

Individuals must be a Belonger as per section (2) of the Virgin Islands Order Constitution 2007, 18 years of age or older and domiciled in the Virgin Islands to be qualified to register.

Persons must also present documents including a Virgin Islands Passport with embossed seal or a Belonger's Card or a Belonger's Certificate. A Naturalisation Certificate can also be used, providing the certificate is dated before June 15, 2007.

Further, Section 17(1) of the Elections (Amendment) Act No. 14 of 2011 states that:

"A registered voter who is ordinarily resident in the Territory and who moves his place of residence from within one local electoral district or polling division to another, may have his name transferred to the list of voters for the local electoral district or polling division to which he has moved, if he applies on Form No. 9 and establishes, to the satisfaction of the Supervisor of Elections, proof of residence within the local electoral district or polling division to which he/she has moved".

Persons who have moved their place of residence and wish to be transferred are encouraged to apply for a transfer. Documents to support a transfer can be in the form of Cable, Water, Electricity or Telephone bills, a rent receipt, lease agreement or a notarised document stating the new address.

Registration and Transfer forms are available at the Office of the Supervisor of Elections, Road Town Post Office, the District Offices on Anegada and Virgin Gorda and the Government Office on Jost Van Dyke. Additionally, these forms are accessible online at bvi.gov.vg/departments/office-supervisor-elections under the services tab.

# National Meteorological Service To Begin In The VI

The Government of the Virgin Islands is engaged in discussions for the introduction of a National Meteorological Service in the Territory.

M i n i s t e r - f o r Communication and Works Honourable Kye Rymer said that his team along with the relevant agencies including the Airport Authority and Department of Disaster Management, met with Coordinating Director of the Caribbean Meteorological Organization (CMO) Dr. Arlene Laing and her team earlier this week to initiate discussions about setting up an office in the Territory to provide this service.

In his statement at the Second Sitting of the First Session of the Fifth House of Assembly, Minister for Communication and Works Honourable Kye M. Rymer said his ministry is responsible for meteorology and the efficient and timely movement of meteorological information.

Honourable Rymer said the Virgin Islands' economy relies on tourism, fishing, the marine environment, agriculture, aviation, and other services, which are all affected by the Territory's weather and climate conditions.

The Minister stated, "The region is vulnerable to coastal and marine hazards, and extreme weather events climate variability have historically impacted sustainable development. Recent events like floods and hurricanes demonstrate the need to invest in local weather forecasting capabilities to reduce disaster risks."

Honourable Rymer said developing a National Meteorological Service through a dedicated office is a significant step towards addressing concerns related to severe weather events, climate, and climate change in the Territory.

He added, "With the support of organisations like the Caribbean Meteorological Organization (CMO) and the World Meteorological Organization (WMO), we can work towards building a resilient and sustainable future for the citizens of these Virgin Islands."

### Safety Measures Prioritised Following Incident At Cyril B. Romney Tortola Pier Park

Minister of Communications and Works, with responsibility for Ports, Honourable Kye Rymer, held an emergency meeting today with key stakeholders in response to the recent armed robbery at the Cyril B. To readily assist and facilitate the Royal Virgin Islands Police authorities in their investigations, Tortola Pier Park Ltd and the BVI Ports Authority have promptly provided full access to the park's CCTV cameras. Today's emergency discussion has proven to be successful as plans were outlined to support the implementation of comprehensive mitigation strategies that will ensure the utmost safety of the park and its valued visitors.

To address the concerns arising from this incident, a thorough security audit of the Tortola Pier Park has been commissioned. This audit will precisely evaluate the existing security protocols and systems in place, identify potential vulnerabilities, and propose necessary enhancements. The resulting comprehensive report will be presented to Honourable Kye Rymer, as well as the Boards of both BVIPA and TPPL on July 10, 2023.

## BURT POINT WASTE WATER TREATMENT PLANT NEARING COMPLETION

Wednesday, 45 July – The Ministry of Communication and Works is making moves to recommission and upgrade the previously inoperable waste water treatment plant at Burt Point.

In his statement at the Second Sitting of the First Session of the Fifth House of Assembly, Minister for Communication and Works Honourable Kye M. Rymer said that recommissioning the waste water treatment plant is a priority for his ministry due to the fact that the inoperable facility currently poses a threat to the marine environment.

Honourable Rymer went on to say that pump trucks will soon be able to pump waste water at the Burt Point waste water treatment plant, which will eliminate the need for the trucks to do so at the Road Town station.

He said, "As part of the repairs and commissioning of the plant, we have incorporated a receiving station to allow the sewage pump trucks to dump at the Burt Point plant. This will eliminate the need for the pump trucks to continue to dump sewage in the heart of Road Town at the main pump station at the Roundabout."

Minister Rymer continued, "As we seek to improve our city of Road Town, we have to put measures in place to enhance our aesthetics and the way that we operate, including at our pump station. Having these types of operations relocated to the soon-to-be commissioned plant at Burt Point will allow for monitoring and logging of pump trucks while avoiding the site of sewage being dumped in plain sight of tourists and residents alike."

Honourable Rymer also noted that a total of one million, seven hundred and thirty-four thousand, three hundred and twenty-one dollars and seventy-seven cents (\$1,734,321.77) has been expended on the two million, five hundred ninety-four thousand, three hundred seventeen dollars and eighty-six cent (\$2,594,317.86) agreement between the Government of the Virgin Islands via the Ministry of Communications and Works with BiWater International Limited.

The Minister for Works also stated that his ministry has engaged BiWater International Ltd. to procure the necessary equipment and material to replace the damaged equipment and material at the plant and indicated that the plant is anticipated to be completed and commissioned in August 2023.



VIENNA - The print edition of Austrian newspaper the Wiener Zeitung, which has been published since 1703, will cease to exist after a decision made by Austria's parliament on Thursday.

The Austrian parliament adopted the law that puts an end to the current form of the daily in a majority vote.

The publication has reported on everything from a young Mozart to the effective abdication of the last Habsburg emperor in its 320year history, claiming to be the oldest surviving daily newspaper in the world.

It has been owned by the Austrian government since 1857 and serves an an official gazette, with advertisements for government job openings and other official notices appearing in the newspaper by law.

The new media regulations also alter the Wiener Zeitung's purpose from a daily newspaper to become a "training and further education medium."

In an article published on the day of the vote titled "End by law," the newspaper said this new description is an unclear mandate that will gut its capacity to produce journalism. [Deutsche Welle]

PAKISTAN - Mujahid Hussain, a news hawker in Islamabad, says he is afraid of losing his job amid a downturn in newspaper sales in Pakistan, where people are increasingly getting their information from digital and social media platforms.

"My employer often talks about a slump in newspaper sales and a possible business shutdown. So even if he doesn't close shop, my job is definitely on the line," the 42-year-old father of three told

Hussain pointed out he has already experienced massive pay cuts over the past three years and that his family is struggling to make ends meet.

Many other news vendors in the South Asian country share similar woes.

It was not always like this, however. Even until a decade ago, the newspaper industry thrived in the country. Daily newspapers, weeklies and magazines used to be a must in offices, living rooms and cafes.

But print publications were first eclipsed by the dozens of private TV news channels that were launched during the presidency of General Pervez Musharraf between 2001 and 2008.

affordable Then came smartphones, social media networks and widespread internet connectivity, which further dented newspaper sales as more and more people began to consume news on online platforms. [Deutsche Welle]

ROME - A suspected ancestor of pizza has been found in a still life at Pompeii, the first evidence that the Ancient Romans ate something similar to the iconic pie believed to have been invented in Naples in the 19th century, sources at the ancient city buried by Vesuvius in 79 AD said Tuesday.

While they stressed that it couldn't really be pizza because key ingredients like tomatoes and mozzarella had not been brought to Italy or invented yet, they said its shape was remarkably like present-day pizza. [ANSA]

MOSCOW - The sudden instability that gripped the federal government in Moscow during last week's Wagner mutiny has sown confusion and panic among the leadership of Russia's ethnic republics, according to experts and activists interviewed by The Moscow Times.

Unable to take a side in the unfolding standoff in central Russia and unsure of what message to broadcast at home, most local heads chose to carry on with business as usual, hoping the situation would simply resolve on its own.

"These people already had no agency and they were forced to make important political decisions. It forced them into [the state of] panic and fear," Tatar political expert and journalist Ruslan Aysin told The Moscow Times.

"It was required - as they viewed it — to pledge allegiance to one of the two," said Aysin.

Behind the scenes of ornate Yhyakh celebrations in the republic of Sakha, the local government's apprehension forced all state-linked media into silence for the entire duration of the rebellion taking place far to the west.

"Our government got really scared, especially when the news of Putin's inner circle fleeing Moscow emerged," Kondakova of Free Yakutia told The Moscow Times.

"Some people in the republic believed that our il darkhan [head of the republic Aysen Nikolayev] might also get on the plane and vanish."


Prompted by orders from Moscow on Saturday morning, regional heads and governors issued a stream of statements in support of the Kremlin.

Yet likely unnerved by the uncertainty of the stand-off's outcome, many leaders of the ethnic republics still fell short of declaring unequivocal support for the Kremlin. [Moscow Times]

BERMUDA - The Government claims a report by US lawmakers which branded Bermuda a "wellknown tax haven" where the wealthy can hide money from tax authorities by using "shell banks" was "inaccurate" - but did not say if it had taken steps to have it corrected.

A spokeswoman claimed Bermuda's prominent role in the investigative report by the US Senate Finance Committee which focused on how Texan billionaire Robert Brockman allegedly concealed \$2.7 billion in income from the Internal Revenue Service using a "complex structure involving offshore foreign trusts, foreign and domestic shell companies, nominees and foreign bank accounts" - was based on a misunderstanding.

But she did not respond to a question on what the Government had done to clear up the alleged confusion since the report was

published last August, "The problem is that when somebody beats the IRS or [UK] Inland Revenue, the big countries default to blaming the microoffshore jurisdiction, instead of themselves," he said. "That's why Bermuda is mentioned in a negative context." [Royal Gazette]

GUYANA - Police on Friday night confirmed that a 16-yearold school girl who had accused Guyana's Local Government Minister, Nigel Dharamlall, of rape, has said she no longer wants to pursue the matter.

Head of the Criminal Investigations Department, Assistant Commissioner Wendell Blanhum, in a brief statement said "at this time, I am only able to confirm that the alleged victim has given a 'no further action statement' to investigators in the presence of one of her parents and a representative from the ChildCare Agency.

"The file is currently being prepared to be sent to the DPP (Director of Public Prosecutions) for further legal advice," Blanhum added.

Media reports here said that on Friday, the 16-year-old was taken for a round of forensic interviews with police and other authorities at Blossom Inc, the leading child advocacy body in Guyana. [CNW/CMC]



# Skip the Drive-Thru With Fast, Effortless, Budget-Friendly Dinners "Oops! I totally forgot about dinner!" It

"Oops! I totally forgot about dinner!" It happens. Maybe you didn't actually forget about dinner, but your hectic, nonstop day happened. Suddenly it's 6:00 and the family is looking to you because they're starving. What's for dinner?

There are so many reasons to draw a blank at dinnertime. Sometimes plans go awry. Someone accidentally unplugged the crockpot, the chicken didn't defrost, you didn't make it to the store, or you set out the dinner ingredients and the kids ate half. I feel your pain, because I've been there! Honestly, between work, school, homework, activities

and running a household, it's a wonder our families get fed at all. Before you call for pizza or head to the drive-thru, stop! You have a backup plan because you're reading this column right now. Welcome to the SOS meal. As in "calling out an SOS -- Save Our Supper!" Or sanity, vou decide. An SOS meal is a planned set of economical ingredients that you always keep in your pantry, intended to guarantee a nearly effortless, healthy, inexpensive dinner that practically makes itself. Here's a list of nonperishable pantry staples to keep on hand to make dinner in a flash. Canned beans

(such as black beans, chickpeas or kidney beans), canned tomatoes (diced, crushed or sauce), canned vegetables (corn, peas or green beans), pasta (varieties like spaghetti, penne or macaroni), rice (white, brown or basmati), canned tuna or salmon, chicken or vegetable broth, jarred sauces (marinara, pesto or curry paste).

Here is a recipe for dinner that takes less than 10 minutes to prepare and has your family sitting down to dinner in under 30 minutes. It takes longer than that to go through the drive-thru at McKentucky Junior King.

### LINGUINE WITH GARLIC LEMON TUNA

The most time-consuming variable of this recipe is boiling the water for the pasta. Using better quality tuna

improves this dish, but use what you have on hand. If you happen to have a fresh lemon lying around, use it, but bottled juice is absolutely fine.

Yield: 4 servings
Total time: 25 minutes
8 to 12 ounces linguine or
other pasta
3 tablespoons olive oil
3 garlic cloves, thinly sliced

2 (5 ounce) cans tuna, drained

1 (15 ounce) can cannellini beans, drained and rinsed 2 tablespoons lemon juice, plus zest if using fresh lemon Salt & pepper to taste 2 tablespoons capers

2 tablespoons capers
2 tablespoons parsley,
chopped



Starting with hot tap water, bring a pot of salted water to a boil. Assemble the ingredients, then start opening and draining the cans of tuna and beans. Add the pasta to the boiling water and cook according to package directions.

Meanwhile, in a large skillet, heat the olive oil over low heat. Add the garlic and cook until fragrant, about 1 minute. Add the tuna, beans, lemon juice and zest, salt and pepper. Gently stir and heat through. By now your pasta should be about ready. Reserve 1/2 cup of the pasta cooking water, then drain the pasta and immediately add to sauce in the skillet. Add the capers and 1 tablespoon of the chopped parsley and toss until the spaghetti is well coated. Add the reserved pasta water as needed to thin out the sauce. Serve warm, garnished with remaining parsley, and pass the pepper mill.

The most important takeaway (so you don't pay for takeout) is to have a plan before you need one. By the way, quick pantry recipes also work when you just don't feel like cooking so you can get out of the kitchen and move on with your life!

# DETECTIVES TRACK LEADS IN PIER PARK ROBBERY

Tuesday, July 4 —
Detectives with the RVIPF
Criminal Investigations
Department are tracking
several leads in their
investigations into
Saturday's robbery of House
of Luxury Jewelry Store at
Cyril B. Romney Pier Park.

Acting Commissioner St. Clair Amory says while he is unable to disclose any details at this time, the RVIPF is progressing with investigations.

"No details on our efforts to identify the suspects in this case can be released to the public at this time, however we are making steady progress in our inquiries," Amory noted.

On Saturday at around 2pm, officers were called to the scene of an armed robbery at Pier Park. Employees of the store reported that two armed masked persons entered the store dressed in all white. One assailant proceeded to remove jewelry from the showcases, and both fled the scene toward the parking lot with a quantity of the store's merchandise. The value of the stolen items is undetermined at this time.

One of the perpetrator's discharged a firearm while outside the compound, however no injuries were reported.

Close to the time of

Saturday's robbery, the RVIPF also received reports of gunshots fired near Road Reef and around the Stickett in Long Look. Those reports are also being investigated.

The RVIPF continues its appeal for witnesses to the robbery. Several persons were in or around the Pier Park at the time of the incident. Those who the robbery witnessed are asked to provide any information, no matter how insignificant it may seem, to the RVIPF Intelligence Unit at 368-9339. Alternatively, persons can give this information anonymously contact Crimestoppers at 800-8477.

# Not out of the woods

In Zambia, former president Edgar Lungu's family continues to find themselves in hot water.

This week, authorities arrested the former president's

and daughterin-law. They are accusing Dalitso Lungu and his wife of money laundering possession property of illicit origin worth more than US\$5 Both million. have released been on bail pending a court appearance.

Members of the former ruling party have decried what they see as continued political persecution under the new government. Just last week, authorities seized 20 properties linked to the former president's wife and children. their two Dalitso and Tasila.

While it is not clear

what the allegations against the former president's daughter Tasila are, there is at least one case the authorities could be looking into. In 2019, her alleged involvement

in the illicit trade of mukula wood came to light — a rare African tree protected under the Convention on International Trade of Endangered Species of Wild Fauna and Flora (CITES). Together with our chapter in Zambia, Transparency International called for full-scale investigations at the time, but to no avail.

Fast-forward two years, and revelations of continued looting of Zambia's forestry wealthemerge. Weintensified calls for accountability and demanded that the new

government end the international trade of mukula wood by establishing a zero-export quota under CITES. A week later, we were pleased to see that Zambian authorities ordered the suspension of harvesting and exporting the endangered tree. However, we continued to press for a zero-export quota under CITES and an audit to uncover individuals' roles in the alleged scheme.

And despite recent high-profile arrests over the illegal

precious tree, the anti-corruption authorities have yet to get to the bottom of this case.



If they are serious about achieving accountability for corruption, authorities must ensure that the cases against the former first family are driven by hard evidence, not by who they are. The government should also look to punish abuses of power committed by those within their ranks.

The truth is: corruption continues to be systemic in Zambia. For the third consecutive year, Zambia has stagnated on Transparency International's Corruption Perceptions Index (CPI) with a low score of 33 out of 100. Although there are positive signs that corruption in procurement may have been reduced, there is still limited transparency in how public funds are managed.

Zambia's corruption problem goes beyond any one family, and so does the need for accountability.

### How Certain Diet Styles Work to Lower Heart Disease Risk

DEAR DR. ROACH: Which diet styles in particular are associated with a lower risk of heart disease? Many people get confused about what a healthy diet actually consists of. Is a Mediterranean diet easier than an extreme low-fat diet? — D.H.H.

ANSWER: There are several styles of diet that have been proven to be healthier than a typical North American diet. Two of the best that have been studied are the ones you mentioned — the extreme low-fat diet and the Mediterranean-style diet — but there are many others that show benefit and a few that show harm.

In a landmark study published by Dr. Dean Ornish in 1998, intensive lifestyle changes reduced the amount of heart disease (measured by blockages in the heart arteries) more than those in the control group without medication. This remarkable result required a diet that was mostly vegetarian (egg whites and only 1 cup of milk a day) and no more than 10% fat (the average American diet is 30% to 35% fat).

In addition to dietary changes, participants performed aerobic exercise (3 hours per week), stress management (1 hour per day) and group psychosocial support (4 hours twice a week), and they also had a 100% smoking cessation rate. It is unclear how much of the benefit in reversing heart blockages is due to diet and how much is due to other beneficial behavior changes, or whether they all worked together (which seems likely to me).

The Mediterranean diet, when studied, also reduced risk of heart disease, with a roughly 30% relative-risk reduction in heart attack, stroke or death due to heart disease. This diet is characterized by:

- An abundant use of olive oil

 High consumption of plant foods (fruits, vegetables, legumes, cereals, nuts and seeds)

 Frequent but moderate intake of wine (especially red wine) with meals

 Moderate consumption of fish, seafood, fermented dairy products (yogurt and cheese), poultry and eggs

 Low consumption of red and processed meat as well as sweets

There isn't a doubt that the Mediterranean diet is much easier for most to comply with. The two diets haven't been compared, so I can't say which is better, but I more commonly recommend the Mediterranean diet. However, I do not recommend drinking wine for any kind of health benefit. Exercise, stress management and psychosocial support would be likely to improve outcomes with any kind of favorable dietary change.

The DASH diet — a lower-salt diet with 4 to 5 servings of fruit, 4 to 5 servings of low-fat dairy per day, with less than 25% of daily caloric intake from fat — has been shown to reduce blood pressure. Moreover, in people with high or normal blood pressure, this diet lowers risk of colorectal cancer, cardiovascular disease and premature mortality. It's also easy to maintain.

Many people ask me about ketogenic ("keto") diets, which typically involve large amounts of meat and, consequently, a high proportion of protein and fat. Although these types of diets can cause short-term weight loss, a recent study showed these diets unfortunately increased cholesterol levels and more than doubled the risk of adverse cardiovascular outcomes (heart attack and death).

So, I recommend against following this type of diet and remind readers that weight loss does not necessarily translate into better health. As the above studies have shown, a person of any weight can better their health by having a more plant-based diet, getting regular exercise, managing their stress and receiving psychosocial support. The changes you make do not need to be extreme in order for you to receive better health.

# 45th CARICOM Heads Of Government Meeting Opens Today



(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana -Monday, 3 July 2023) - Caribbean Community (CARICOM) Heads of Government meet Trinidad and Tobago, 3-5 July 2023, for their 45th Regular Meeting and to launch a year of celebrations to mark the 50th Anniversary of the founding of the regional grouping.

The packed agenda for the Meeting tackles several pressing issues for the Community, including food security concerns, climate change and the climate finance agenda; the ongoing difficulties in Haiti; security issues, external relations matters and the CARICOM Single Market and Economy (CSME).

The Heads of Government will engage several international guests, including the President of Rwanda,

Paul H.E. Kagame; UN Secretarythe General, H.E. Antonio President-Guterres: Designate of the United Nations Climate Change Conference (COP 28), H.E. Dr Sultan Ahmed Al Jabe; the Prime Minister of the Republic of Korea H.E. Han Duck-Soo; US Secretary-of-State, Anthony Blinken, Minority Leader in the US House of Representatives, Congressman Hakeem Jeffries.

The Meeting's Opening scheduled Ceremony, for Monday at 4:30 PM (Trinidad Time) at the Hyatt Regency in Port-of-Spain, will be addressed by the Chairman, Prime Minister Hon. Roosevelt Skerrit of Dominica; outgoing Chairman, Prime Minister Hon. Philip Davis of The Bahamas; host Prime Minister Dr. the Hon. Keith Rowley of Trinidad and Tobago, and UN Secretary-General

H.E. Antonio Guterres.

On Tuesday, 4 July, the 50th Anniversary of the signing of the Treaty which created CARICOM, the Heads of Government and delegates will return to Chaguaramas, the venue of the historic signing, for a commemorative ceremony which will feature a Flag Raising event; planting of a Time Capsule and addresses by the CARICOM Chairman and host Prime Minister.

During the day's business session, representatives of foreign governments and heads of international organisations will be invited to pay special tributes to CARICOM in honour of the milestone. Regional cultural artistes will also pay tribute in song, dance, steelband music and other artforms during a CARICOM 50th Anniversary Concert.

### Guyana and Trinidad and Tobago Claim Top Prizes at 16th CARICOM Road Races-10k



(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Monday, 3 July 2023): The 16th CARICOM Road Races concluded yesterday, Sunday, 2 July, in Trinidad and Tobago, with Guyana and the host country taking top honours in a 10K event.

Guyanese Attoya Harvey claimed first prize in the Overall Female category and the CARICOM Secretary-General's Trophy, while Samantha Shikla (Trinidad and Tobago) and Laura Lynn Limery (Saint Lucia) won second and third prizes, respectively.

Trinidad and Tobago dominated the top three positions in the Overall Male category, with popular athlete Nicholas Romany winning the CARICOM Chairman's Trophy and Donnel Francis and Tafari Waldron capturing the second and third prizes, respectively.

Nine (9) CARICOM countries participated in the event, including Antigua and Barbuda, Dominica, Grenada, Guyana, Jamaica, Montserrat, Saint Lucia, Saint Vincent and the Grenadines and Trinidad and Tobago.

In observance of CARICOM's 50th Anniversary, the event returned to the original site of the signing of the Treaty, the Chaguaramas Convention Centre. The Road Races formed part of the pre-event activities of the 45th Regular Meeting of the Conference of Heads of Government of CARICOM scheduled for 3-5 July in Trinidad and Tobago under the chairmanship of Hon. Roosevelt Skerrit, Prime Minister, Dominica.

Attoya Harvey shared that she was elated to win the top prize for Guyana in her first CARICOM 10K. "My coach was my inspiration for participating, he's consistently motivating me to reach for my dreams", stated Attoya.

"There's no secret behind Trinidad winning the top three positions – only consistent training, commitment, a good coach and an amazing team," stated Nicholas Romany, "I got the opportunity to represent my home country, so it was important that I gave my best".

Hon. Roosevelt Skerrit, Prime Minister, Dominica and Chair, CARICOM, delivered remarks and presented the CARICOM Chairman's Trophy and other top prizes. Also present were Dr Carla Barnett, Secretary-General, CARICOM, Dr Armstrong Alexis, Deputy Secretary-General, CARICOM, Ms Alison Drayton, Assistant Secretary-General, CARICOM, Senator The Honourable Dr Amery Browne, Minister of Foreign and CARICOM Affairs, Trinidad and Tobago and Hon. Shamfa Cudjoe, Minister of Sport and Community Development, Trinidad and Tobago.

The 16th CARICOM Road Races also included 5K and 1K races on Saturday, 1 July, at the Queen's Park Savannah in Port of Spain. The event's theme, "Promoting Health Resilience for All," aligns with CARICOM's mandate to promote healthy habits and nutrition to combat the stark increase in persons with non-communicable diseases or NCDs. The Secretariat envisions the event as a beacon to advocate for Caribbean nationals adopting healthier lifestyles for better health outcomes.

# Americans Divided Over Supreme Court Decision on Affirmative Action

### NEW-ORLEANS, LOUISIANA—

Americans are divided by the

Supreme Court overturning decades of precedent supporting affirmative action in college admissions, a policy that advantaged otherwise disadvantaged students from racial or ethnic minority groups. "Unfortunately, race matters in our society affirmative action is essential in guaranteeing that everyone - not just the advantaged benefit from an education that can serve as a pathway to upward mobility," Coalition for a Diverse Harvard board member Michael Williams told VOA.

Harvard University, along with the University of North Carolina Chapel Hill, were sued by Students for Fair Admissions, a nonprofit organization against racial classifications in college admissions. By ruling in their favor, the Supreme Court is disadvantaging all Americans, Williams said.

"Many of our college applicants have been systematically and

purposefully excluded from aspects of our society and discriminated against based on race, and an equitable college admissions process must recognize these disadvantages," Williams said. "But this affects everyone because studies show that diverse institutions are better institutions. Affirmative action helps prepare all our students for the diversity they'll find in the workplace."

Other Americans welcomed the high court's ruling against race-conscious admissions.

"America is supposed to be a meritocracy, and race shouldn't play any part in college or job decisions," said Angelica Garcia, a teacher in Saginaw, Michigan.

"Assuming every Black and brown person has lived this underclass or inferior experience and needs help is racist," she continued. "As a person of color, I worked hard for what I've gotten and I've overcome a lot, and I hate that some people think I've only been accepted into college or my job because of my race."

### Born from civil rights movement

Race-conscious admissions in American universities were born from the civil rights movement of the 1960s and laws supporting affirmative action in the U.S. labor market. Colleges that adopted these policies were challenged in the Supreme Court, where justices ruled that while quota systems unconstitutional were an violation of equal protections, race could still be considered by universities as one factor among others.

"Affirmative action was implemented to address the longstanding exclusion and segregation of Black and brown students in higher education and to recognize the persistent inequalities that students of color face on both individual and systemic levels," Edgar Saldivar, senior staff attorney for the American Civil Liberties Union of Texas, told VOA.

The impact of eliminating that is clear to Connie Chung Joe, chief executive officer of Asian Americans Advancing Justice Southern California.

"Without race-conscious admissions, racial segregation will rise at our nation's and colleges universities," she predicted. "This will disproportionately harm Black, Indigenous, Latinx, Pacific Islander, Native Hawaiian, and Asian communities. Entire generations of talented students of color will be denied the future they deserve."

# Policy has harmed, say opponents

Opponents of race-conscious admissions say it's the policy itself that has done harm by overlooking those excluded from preferential treatments.

"Maybe affirmative action was something necessary many years ago, but in the present day, it was time for it to be revisited," said Jillian Dani, a former teacher from Merritt Island, Florida. "I understand the desire to give minorities more opportunities, but in today's world, minorities have the same opportunities as the rest of us."

"All-women colleges exist, and all-Black colleges exist," Dani told VOA. "But there aren't any all-white male colleges even though poor white people are a real thing. They're missing out on opportunities, too, and affirmative action wasn't helping them."

Twenty-year-old San Diego entrepreneur Willow Hannington believes the decision to strike down affirmative action is a positive one for the country.

"It's a significant stride towards fostering a truly fair and equal society," she told VOA. "This nation has achieved significant progress, and, in my opinion, race should no longer play a decisive role in any aspect of our lives."

### Schools commit to diversity

In a recent poll by ABC News/ Ipsos, a majority of Americans favor this more "race neutral" or "color-blind" approach. Following the ruling, many colleges and universities issued statements reaffirming their commitment to diversity.

"Eliminating the use of standardized test scores in admissions, increasing guaranteed financial support, broadening recruitment efforts to underserved communities, and developing robust middle and high school pipelines that benefit all students are just some of the things that can be done," Saldivar told VOA.

Craig Mindrum from Chicago has a strategy to add. With experience on a graduate school admissions committee, he said students should continue talking about how their lived experiences and race has shaped their character, drive and talents.

"No legislation or court decision is going to stop me from making some recommendations while considering minority or disadvantaged status," he said. "Admissions counselors are people, not legislative robots, and across the country they're going to be making the final decision on who is accepted into their college."

## 2 Bronze medals, Pan Am Games sailing qualifier at CAC Games

Djimon Gumbs and Rikkoi Brathwaite won bronze medals in the Shot Put and 100m at the Central American and Caribbean Games in San Salvador, El Salvador on Monday. Their hardware came after Laser Sailor Thad Lettsome earned a qualifying spot to the Pan Am Games in Santiago, Chile in late October.

Gumbs, in his debut, had a second round heave of 19.00m (62'4") then followed up with 18.83m (61'9'4") another mark that had him in the silver medal position, before being passed by Mexico's Jario Moran's (19.10m (62'8). Eldred Henry, in his return to action after injury slowed his progress since 2020, was sixth with 18.12m (59'5'4"). He won Shot Put bronze in 2018 in Baranquilla, Colombia.

"It means a lot, especially for a senior championships to come home with a bronze medal, it's very good," Gumbs who won the BVI's first Commonwealth Youth Games

Discus Throw medal in 2017 and the 2022 Caribbean Games Shot Put silver medal told Island Sun Sports. "This gave me a lot of motivation (for the Discus Throw on Wednesday) that no matter how things might look, if you work hard and stay determined, you'll get what you want. I just kept my head down, kept pushing and you saw the result and it gave a huge boost for the Discus obviously. I'm just going in there with the same mentality. Stay relaxed, execute, trust the process, trust the coaching and I think it will be a fun one."

Brathwaite then grabbed a 100m bronze medal in 10.26 seconds an hour later, as he ran the same time in a photo finish as the Dominican Republic's Jose Gonzalez, who got the silver medal by .001. Brathwaite ran 10.29 in the prelims and became the second CAC Games 100m male medalist behind Dion Crabbe in 2002.

"It's obviously a good experience and I wanted to come back with more because I've been training so well, but it's a learning experience and things happen. I'm happy that I was able to bring back a medal for the BVI," said Brathwaite who joined Crabbe and Kyron Master as CAC Games track medalists. He said he was a bit 'choppy' but

pulled himself together and started pulling away from the crowd. "But because of my messed up transition, I didn't really get to build throughout the race as I wanted to. Overall, catching myself for what I thought was second but came to be third, it was a good effort but not the best race."

With the accomplishment, Brathwaite who lowered his 100m national record from 10.20 seconds to 10.11 and has a windy all conditions 9.93 (+2.6) to his credit, said that his season has been 'phenomenal.'

"I'm ecstatic about this season and I know that I have more to come," he said. "This race wasn't really a disappointment all the way through because there was a negative 2.4 wind—that's like a 10.0 run—so I'm not disappointed but I like this season so far. I've finally been able to run healthy finally for a long season and I've been happy about this season."

Lettsome, who battled winless race days, got a crucial second place finish in his penultimate race and was sixth overall in the CAC Games. The second place finish clinched an automatic Pan Am Games qualifying spot, from among the 10 countries vying for it

"It was my first time and I got to see what a different game was like and got in tune with competition in the region to see where I am, so it was a good experience," Lettsome told Island Sun Sports. "I'm happy with my overall performance. It's always nice to go to these things, but I'm not satisfied because there's always room for improvement. But my goal was to get the Pan Am Spot so I accomplished my goal and I'm happy with that."

Lettsome added: "I meant a lot to

actually earn the spot and know that I performed better than all the people that I beat out for the spot. Last time (in 2019) I got in on a wild card, so it was good to actually earn it this time and go through the qualification process."

Ritseeniyah Georges made Archery's debut in the Women's Compound and had a score of 539, to rank 27 of the 28 participants. In the round of 16, she lost to Mexico's Andrea Becerra, 148-123.

### Basketball summer league starting date, elections on horizon

In years past, the BVI Basketball Federation men's summer league would be in full swing from Mother's Day. Officials have been besieged by numerous setbacks and elections are yet to be determined.

"We're trying to find a start date for the annual District League," Federation Vice President Jason Edwin told Island Sun Sports. "At the beginning of the year, we were met with the General Elections pushing back the end date for the Volleyball League, which caused a domino effect to have a league start in the normal slot we normally have. We're now trying to work with the Recreation Trust

to find out when we can have a mini tournament of some sort, to at least have something for their calendar year."

Edwin said that they have been told that there were other bookings including HLSCC and ESHS graduations. Summer Sizzle will be held there as well as other activities. He said they're trying to work around those dates to have something for a league.

Regarding the Federation's elections, Edwin said that the BVI Olympic Committee has agreed to facilitate them and they should be able to have elections this month, but no date has been given. He said that a flyer for persons interested in being on the Executive Committee has been sent out. Edwin confirmed on Wednesday morning that 15 persons have

shown interest in becoming Executive Committee members.

Reflecting on the Federation's term coming out of Hurricane Irma and the Covid pandemic, Edwin said that they were able to send a 3x3 Women's team to the Caribbean Games and the Commonwealth Games. A male 3x3 team also went to South America.

"Working through those obstacles, having the facility damaged during the storm, I think those were great accomplishments from the Federation standpoint," he said. "Looking at grassroots programs, we've identified what's needed, those are some of the areas we made great strides on and we plan to work on."

When asked about the challenges getting grassroots basketball in place, Edwin said that since Covid and the reopening of the Multipurpose Sports Complex, they are seeing a lot of players and coaches becoming

interested, rolling up their sleeves and getting their hands dirty in that regard.

"It was all about coming out of Covid and hitting the ground running," he said.

Asked further about cementing these programs after the elections, Edwin said that's for the stakeholders to vote in. "During the elections, the stakeholders will have a vote on the direction they would want basketball to go in terms of leadership," he said. "We'll have to see what happens then."

Edwin agreed that irrespective of who's in the leadership chair, there must be grassroots development.

"In any sport, you want to make sure that you emphasize the grassroots initiatives in terms of your biddy programs, your 3x3s, all those things," he said. "Without those, the sport can't grow. Also the coaches, facilities, statisticians, are all things that foster the growth and development of your sport."

# CARICOM AT 50: THERE IS STILL HOPE

July 4, 2023 marks the 50th anniversary of the signing of the Treaty of Chaguaramas, the foundational document that brought the

Caribbean Community and Common Market (CARICOM) into existence. With high hopes and lofty ambitions, the heads of government of the four largest independent Caribbean countries at the time embarked on a journey towards regional integration. They were later joined, to varying degrees of commitment, by 10 other

countries. Reflection on the past five decades reveals that CARICOM has fallen short of its initial promises and failed to deliver the deep and meaningful integration that was envisioned, leading to the often-repeated phrase, "CARICOM and CARI-GONE."

While CARICOM experienced some initial success, establishing institutions like the Caribbean Development Bank and making progress in trade, its history has been characterized by sporadic bursts of activity followed by prolonged periods of inaction. This inconsistent pattern has eroded confidence and faith in the CARICOM project among various sectors of Caribbean society.

Nevertheless, the fact that CARICOM's framework continues to exist is a testament to the enduring belief in the benefits of regional integration. No government dares to withdraw from it, fearing a popular backlash from within its own population.

Despite the revision of the CARICOM Treaty in 2001, which aimed to establish a Single Market and Economy (CSME), progress towards these goals has been painfully slow. The establishment of a Customs Union, let alone a Common Market, remains unrealized. The lack of a comprehensive regional economic framework has hindered the potential for genuine free trade, cross-border company establishment, and the free movement of labour—a vision that once excited the people of CARICOM.

By 2011, the CSME had effectively stalled, with little progress made in advancing regional integration. In 2022, CARICOM leaders acknowledged that trade barriers, particularly non-tariff barriers, were major obstacles to the development of a regional market for agricultural produce, as well as inter-regional transportation. The inability to overcome even these challenges, especially air transportation, which suffered as a consequence of closed

borders during the 2020 COVID-19 pandemic, highlights the significant capacity that CARICOM states have yet to collectively build.

Comparatively, the countries of the European Union (EU), which embarked on integration efforts around the same time as CARICOM, have made significant strides. The EU expanded its membership, established a single currency, dismantled border barriers, and empowered a central Commission to make decisions collectively for all member countries.

In contrast, CARICOM has limped along, burdened by inadequate implementation of decisions, mistrust among leaders, institutional decline, and a weak and underfunded Secretariat.

Numerous reports and commissions have carefully examined CARICOM's failures and offered recommendations

for improvement. The 1992 West Indian Commission's seminal work, "Time for Action," led by Caribbean luminary, Shridath Ramphal, called for the establishment of a Caribbean Commission similar to the European Commission. Despite the acceptance of some recommendations, crucial proposals regarding governance structures, including the creation of a Caribbean Commission, were largely ignored.

In 2016, the Jamaican government commissioned a review of its relations with CARICOM, headed by Bruce Golding. The commission recommended explicit provisions in the CARICOM Treaty to enforce member states' obligations and ensure timely implementation of decisions. Yet, once again, these recommendations were largely disregarded, further highlighting the challenges of implementing meaningful reform within CARICOM.

In 2021, a CARICOM Commission on the economy revived discussions on regional integration. It suggested that interested member states should proceed with integration, leaving the door open for others to join at their own pace. However, this report, like its predecessors, has not spurred the necessary action.

The dominant characteristic of CARICOM has been the jealous retention of sovereignty by individual governments. In their international bargaining, CARICOM governments have achieved success only when they act together. But there is no established machinery for joint relations with external powers and agencies. Thus, ad hoc collective activities have produced beneficial results, but these have been spectacular exceptions, not the consistent rule. This inclination to maintain decision-making power at the national level has hindered progress. Bureaucrats, too, have perpetuated this culture of nationalism, often

prioritizing their countries' interests over collective regional welfare. Consequently, CARICOM has struggled to implement regional decisions effectively and act in unison, hampering its ability to achieve its objectives.

The Caribbean Court of Justice (CCJ) serves as a notable example of this contradiction. Established in 2001 to replace the British Privy Council as the region's final court of appeal, the CCJ has struggled to gain the full support of member states despite the demonstrated high quality of its jurisprudence. Some countries have been hesitant to embrace the CCJ due to concerns over losing sovereignty and fear of political interference. As a result, the region has been unable to unify under a single legal system, preventing the CCJ from fulfilling its potential as a symbol of Caribbean unity and independence.

The consequences of limited integration have been significant for CARICOM countries. Research conducted by the International Monetary Fund (IMF) indicates that deeper regional integration could bring substantial economic benefits. By reducing non-tariff barriers and trade costs, CARICOM countries could stimulate trade, restructure their economies, and generate net employment gains. Integration would also allow member states to tap into global value chains, attract foreign investment, and enhance their economic potential. The failure to seize these opportunities has come at a cost to the region's development and prosperity.

As CARICOM reaches its 50-year milestone, new challenges face each of its member states that none can manage effectively alone. Among them are the impact of climate change including more frequent and intense disasters; new pandemics for which they are ill-prepared; increasing transnational crime; gang violence and the spread of deadly weapons; and narrowing windows to much needed development funds. All of these developments require more integration, not less.

CARICOM needs a renewed commitment from member states to prioritize collective interests over narrow national concerns. This shift in mindset should be accompanied by concrete actions, such as the removal of remaining trade barriers, harmonization of regulations, and the establishment of effective governance mechanisms that can enforce regional decisions.

CARICOM must also invest in revamping its institutions, providing them with the necessary expertise, authority, and resources to drive the integration agenda forward. Enhanced regional cooperation and coordination, with a focus on effective implementation and enforcement, will be vital to restoring confidence and generating tangible benefits for the people of the Caribbean.

Hopefully, 50 years of lessons will not go unlearned. The vision of a fully integrated Caribbean, where borders are irrelevant, and collective strength prevails, can still be realized.
