MS. PARSONS BEMOANS THE SKIMPINESS OF THE FESTIVAL **ATTIRES**

Once again Virgin Islands cultural icon and former legislator Eileen Parsons has criticized the parade attire of some of the participants in the annual August Monday parade. The comments which Ms. Parsons made during her guest appearance on the 30 July edition of Real Talk with Karia J. Christopher have sparked a conversation in the Territory with some persons agreeing with the icon and others stating that it is a cultural evolution.

During her time on the Show Ms. Parsons decried the current state of dress of troupe members in the annual Emancipation parade. She said: "Let me first say, I know I am of a different generation and what is happening now, I know I honestly can't

relate to and especially knowing what we started out as, and I was a part of what started out and seeing what is happening now."

> While bemoaning

the skimpiness of the carnival attires the former legislator explained that it is a part of the degradation of the traditional Virgin Islands Festival and the uninformed influence of

Rio de Janeiro and Trinidad carnival celebrations, as well as "Mardi Gras in New Orleans."

The Cultural Icon stated, "Years ago, a reporter in Trinidad writing in

a Trinidad newspaper, said Trinidad Carnival had become nothing but feathers and flesh. This was a Trinidad reporter...

Trinidad Carnival has become nothing but feathers and flesh. This is what has happened to us."

"The young ladies they have on practically nothing and this is what we are doing, and this is not what we the old people in 1954 wanted to see. We wanted to see something that speaks of festival, the emancipation that our ancestors came out of when it was proclaimed August 1st, 1834," she pointed out.

The former legislator said that she is not just saddened by embarrassed by the current Parade practice: "I am honestly embarrassed, honest to God. I am embarrassed by what I am seeing on Road Town street... Three weeks ago. I went to my hairdresser on Wednesday and a lady in there said Ms P I was talking about you last night. I say what did I do now? She said nothing Miss P, but I saw some costumes that going to be in the parade this year and I said this year Ms P will faint away...It is nothing more than two little dots for the breast and a triangle for in front, that's it," Ms Parsons said.

MEN ARE TO BE BLAMED

The Great Savant and Cultural Icon noted that the men who are part of the lives of the women who dare to dress skimpily on the parade route should take some of the blame. According to Ms. P.: "I know the kids are mature and it's a different world, but still we are West Indian women and I cannot see how, if you and your boyfriend live together, how could your boyfriend allow you to leave home to go on the Road Town Street with so much of you exposed?"

"How can your husband allow people to see what only he should see? How could your father allow you, his daughter, to go out there exposed?" she added.

Last year Ms. Parsons not only complained about the barely-there costumes but also decried the dance routines along the parade route. She commented: "Honestly, what I am seeing with these women bending over, and the men wukkin up on them, that is not BVI," she noted.

"Honestly, what I'm seeing on Road Town streets now would make my grandmother wonder," Parsons continued "And I know my grandmother would wonder how parents, husbands and boyfriends could allow their ladies to leave home in that kind of condition. What only they should see, the world is seeing August Monday," Parsons added.

The great lady has been complaining about the new norms of August Monday parade since 2013.

KADEEM MAYNARD SEEKS SENTENCE LENIENCY

Kadeem Stephan Maynard, known as Blacka, who has confessed to participating in a drug and money laundering plot leading to the arrest of former Premier Andrew Fahie, proclaimed in court documents seeking sentencing leniency, "I was an honest businessman" and law-abiding citizen before being caught in the Miami scheme.

Kadeem's mother, Oleanvine Pickering Maynard, previously the Managing Director of the BVI Ports Authority (BVIPA), also admitted guilt in connection to the plot. This comes even as Fahie continues to assert his innocence, living under a million-dollar bond at his daughters' residence in Florida.

Following Kadeem's guilty plea, the prosecution suggested a sentence of up to 14 years. However, he has appealed for a reduced sentence of a minimum of five years or even probation, which would allow him to avoid incarceration altogether.

In a legal document submitted last week, Kadeem portrayed himself as having no prior criminal record. He sent an apologetic letter to the presiding Judge, begging for mercy and a chance to make amends. Maynard expressed his sorrow to the court, stating that he lost all that he had diligently worked for over 16 years due to "desperation and temptation."

"I just wanted to be able to save my family home from repossession and to be able to provide for my kids and their future, as well as being a help to others in need. I saw how hard my mom worked to get that home and I just wanted to do all I can to save it," he wrote in the letter.

The court learned about Maynard's hard work in the BVI and the US, including his business ventures in event entertainment, DJ service, Lyft and Uber driving, and local enterprises like the well-known Kravins Night Club & Sports Bar and Triple K Cleaning Services, Car Rental, and Gourmet Catering in Tortola.

He further explained to the Court that he and two of his children face multiple health problems. He expressed his desire to be present in their lives to help them through these issues and guide them correctly. "It hurts sitting incarcerated knowing that they are not proud of their dad. I have also brought embarrassment to my wife, which I have been with for the past 16 years and my mom who has played a huge part in my life," Maynard explained.

In his defense, Kadeem also pointed out: "I wasn't the main player." He admitted to providing information to a confidential informant (CI) but denied falsifying paperwork at BVIPA or having the ability to prepare or negotiate for the transshipment of narcotics at the port.

"Maynard neither negotiated nor calculated the amount of money to be paid for the 3,000-kilo loads. Maynard did not travel to Miami to collect any money from the CI and was not shown any money in Miami," the court documents stated.

They continued to detail that he did not attempt to evade arrest in the US Virgin Islands, had no role in financing the contraband's transportation, and lacked knowledge of the intended recipients.

Maynard informed the court of

his future plans post-incarceration, including completing his GED, obtaining a CDL license, and founding a trucking company in Florida with his wife's support and

sourced startup grants.

Both Maynards are set to be sentenced on August 21, while Fahie's trial has been delayed until January 2024.

"WE'RE DESTROYING THE VERY THING WE'RE HERE TRYING TO BUILD — LOCAL BUSINESSES" HON. SKELTON SAYS

Opposition Leader Hon. Ronnie Skelton has drawn attention to the adverse effects that the financial services sector is having on Virgin Islands' resident-owned businesses.

The Virgin Islands relies heavily on the financial services sector, which stands as one of its two main economic pillars. However, Hon. Skelton has called for a division between the laws governing this sector and those that regulate local businesses. He argues that

local residents suffer under regulations that shouldn't apply to them, as these laws are intended for international companies.The Opposition Leader detailed the burden on local entrepreneurs, stating that they must shoulder costly compliance with regulations designed for the financial services industry. Speaking in the House of Assembly, he said: "It is destroying local businesses. Every time financial services puts something

in place, it applies to local businesses and it is getting very expensive to maintain some of this stuff, and they (locals) are not doing any international business."

He further emphasized: "The people financial services are looking for aren't the local businesses. We really need to get this thing sorted out. We need to separate both types of businesses. If you're selling candies, peppermint and sugar cakes along the road and

you want to protect yourself legally from liabilities, you shouldn't be subject to a lot of international regulations."

Hon. Skelton also voiced his concerns over local businesses losing assets to the government, asserting that many are falling victim to conditions that shouldn't be imposed on them. He lamented: "The people are not keeping their companies active so what happens to the assets in those companies? They go back to the Crown —

the very person you want to get away from. We're destroying the very thing we're here trying to build — local businesses."

Hon Marlon Penn, the Eighth District Representative, has openly conveyed his dissatisfaction with the 2023 Emancipation Festivities in the East End/ Long Look community.

"We've experienced another emancipation celebration, and I must modestly confess my disappointment with what our community has managed to present,"

Hon Penn declared at an EE/LL cultural event on Wednesday, 9 August, at Greenland Field.

"I've been in discussions with the Minister of Culture and the Premier asserting that we must rebuild our subcommittee within our community," he added.

According to Hon Penn, effective community engagement is vital to ensuring that the cultural representation truly mirrors a free people who fought and paved their way to freedom. "I believe it is our duty as leaders to guarantee these aspects are in place," he said.

Describing the events as a tragedy, Hon Penn mentioned that the representative responsible for passing the holiday through the House of Assembly was the late Leslie F. Malone, the great uncle of both himself and the Premier.

"We must correct this situation," asserted Hon Penn. "So Uncle Leslie is rolling in his grave, Premier. We need to reactivate these committees and make sure the standard we deserve and have grown used to is reinstated."

Hon Penn further noted that he is reaching out to members within the community, as well as the Premier, to put the committees back in action. He stressed the need to move beyond party lines to do what's right for the East End/Long Look community.



Athletes return from Trinbago 2023 Commonwealth Youth Games with positive experience

Tortola, British Virgin Islands August 14, 2023 – The Virgin Islands (UK) delegation to the Trinbago 2023 Commonwealth Youth Games returned home late on August 12. The team of 5 athletes aged 14-18 years competed in track and field events in the 7th edition of the Games in Trinidad and Tobago, August 4 – 11, 2023.

Sprinter J'Den Jackson ran on August 7 and successfully qualified for the 100m semifinals with a time of 11.19 in the heats and placed 8th with a non-advancing time of 11.27. The event was ultimately won by English runner Teddy W Wilson (10.37) with fellow national, Ebuka Nwokejie placing 2nd (10.43) and Shaquane G Gordon of Jamaica placing 3rd (10.43).

On Wednesday, August 9, J'Den ran 22.37 placing 4th in heat 4 of the 200m to qualify for the semifinals where he placed 6th with a non-advancing time of 22.24. Samuel Ogazi of Nigeria won the finals in a time of 21.22, Dean Patterson from Scotland placed 2nd in 21.45 and England runner Rusciano Thomas-Riley placed 3rd in 21.59.

Jonathan Lynch ran in the 800m semifinals placing 6th with a non-advancing time of 1:59.64 on August 9. The event concluded on August 10 with Kelvin Koech of Kenya taking the win in 1:50.14, Miles Waterworth of England placing 2nd in 1:52.21 and Caleb McLeod of Scotland placing 3rd in 1:52.83.

Long jumpers A'Sia McMaster and Cristal Daly competed on August 7. A'Sia's longest mark was 5.56m for a 9th place finish while Cristal did not make a mark. Jah'Kyla competed in the high



jump on August 10 but did not make a mark in her event.

The athletes ended their experience of the Commonwealth Youth Games at the Closing Ceremony at Pigeon Point Beach Facility, Tobago on Friday, August 11.

"The athletes were a great team and we can be very proud of their conduct on and off the field of play," said Chef de Mission Ms. Ericca Frederick. "One of the main purposes of these youth-oriented Games is to provide an opportunity for athletes to participate in friendly competition, make friendships and be exposed to the different cultures across the Commonwealth, I can say that our athletes embraced the mission and return home richer for their experience in Trinidad and Tobago."

The team was accompanied by coach Erwin "Redz" Telemaque. Mr. Ephraim Penn, President of the BVICGA, was on the ground to support and encourage the athletes.

"The Commonwealth Youth

Games are a pathway to the senior Commonwealth Games and major Games and the 5 athletes will have been exposed to the competition they can expect to face as they progress in their athletic career," said President Penn. "They were well-guided by their coach and the constructive take-aways from the experience of competing at Trinbago 2023 should serve the athletes well going forward."

More than 1000 athletes from 71 Nations and Territories across the Commonwealth participated in the Games competing in events across 7 sports including athletics and para-athletics, aquatics, beach volleyball, cycling, FAST5 netball, rugby sevens and triathlon.

The Games have traditionally taken place every four years with the first event being hosted in Edinburgh, Scotland in 2000. The VI was first represented at a CYG at Samoa 2015 when athletes competed in track and field and tennis. The date and host for the next Games has not yet been decided.

'Retire Your Ride' Derelict Removal Campaign Underway

Director of the Department of Waste Management Mr. Marcus Solomon is calling on the public to 'retire their rides' as the department launches its derelict removal campaign.

Mr. Solomon said, "Over the next couple weeks we want the

residents of Virgin Gorda as well as Tortola to retire their derelict rides as well as help us to identify derelicts throughout the community."

Mr. Solomon said the aim is to get as many derelicts off the street by September 15 to facilitate export on the September 18.

"Together it is our responsibility to keep our community clean and green but everyone needs to do their part. We are asking you to help us help the community," the director said.

"We have the barge coming in on the 18 and it is our goal to get as many derelicts and scrap metal off of the island," he said.

The community is urged to identify derelicts on private and public property and contact the department at 494-4934 or via the BVIGovReportit app. Persons are advised to record location information and submit to the department or via the app accompanied with photo where applicable. When the report is received, an officer will travel to the location, identify the vehicle(s) and issue a notice appropriate to the location.

"The notice is completed in triplicates, the original is affixed to the derelict or can be handed to owner and two copies remain with the department. Vehicles on public property have a duration of (14) days and private property (21) days before the notice expires," Mr Solomon explained.

The director said when the notice expires and the vehicle remains at the same location the department's wrecker operator or hired operator will remove the derelict from the location and have it transported to the temporary site a Pockwood Pond.

The Department of Waste Management is committed to ensuring that the natural beauty of the Territory is enhanced by utilising state of the ar waste management technology to ensure timely collection disposal and where possible the recycling of waste.



WEST END FERRY TERMINAL PREQUALIFICATIONTO BE RETENDERED. NEW DEADLINE SET FOR AUGUST 31



Thursday, 17 August – Contractors now have until August 31 to submit bids to participate in the prequalification process for the construction of the New West End Ferry Terminal. This project is being financed by the Government of the Virgin Islands through the CDB Rehabilitation and Reconstruction Loan.

The Virgin Islands

(RDA) published the
initial request for prequalification on its

and on the Government of
the Virgin Islands website
at BVI.GOV.VG along
with RDA social media
platforms.

Nine firms inclusive of joint ventures responded to the opportunity by the 9th June, 2023 deadline. The submissions were then evaluated and shared with the

Caribbean Development Bank (CDB) for their 'No Objection'. RDA's Director of Procurement Primo John stated. "Each submission was examined individually to confirm compliance with the requirements of the prequalification document issued." Mr. Primocontinued,"Initial completeness checks were done on the documents of each firm to confirm whether the requested forms and supporting documents have been duly completed submitted. As a result of this evaluation, it was determined that none of the submissions fully met the requirements of the prequalification notice nor submitted fully responsive prequalification documents."

The specific areas that were cited as nonconforming to the West End Ferry Terminal's prequalification requirements included:

- Non submission of balance sheets for ALL the requested years.
- Inclusion of registration documents e.g. Trade Licence
- Incomplete forms with blank or missing information hence, the general and

specific experiences could not be determined.

- Association/joint ventures with firms which are not registered in eligible member countries. Joint Venture members did not possess the requisite qualifications and experience.
- Some firms did not meet the cash flow requirements.
- Insufficient references/ experiences with regards to construction of quay walls,

pile foundation works in marine conditions, revetment construction, reclamation works.

After thorough

assessment, the RDA revised the requirements with CDB's


approval, to ensure a successful procurement process that safeguards the integrity of the technical requirements and to ensure construction works are not compromised.

It is important to note that the experience and qualifications of sub-contractors are not taken into consideration during the prequalification process. The joint venture partners, however, must meet the requirements, combined or separately.

The Virgin Islands Recovery Development Agency in its remit to build BVI Stronger, Smarter, Greener, Better, has been tasked to implement several projects and programmes across the Territory, in key sectors and measured by outcome statements identified by the Recovery to Development Plan.

Remedial Works Ongoing At Public Schools

Minister for Education, Youth Affairs and Sports, Honourable Sharie B. de Castro has said that remedial works have begun for public schools in the Virgin Islands in anticipation of the 2023-2024 school year.

Honourable de Castro said that it was evident that the school infrastructure has suffered maintenance issues for quite some time while on a recent tour of public schools in the Territory.

"We are diligently working on a rigorous schedule of maintenance and rehabilitation works during the summer months to address as many issues as practically possible," the minister said.

Acting Deputy Secretary in the ministry, Mr. Claude Kettle said the focus was on addressing critical maintenance needs such as water tightness, mold remediation, electrical and plumbing works.

Mr. Kettle said the first project was a contract issued to Mr. Cecil Penn Construction Limited to replace the roof of the Claudia Creque Educational Centre on Anegada. The works were completed on July 31.

Additional ongoing works include:

The water tighting of the Alexandrina Maduro Primary School contracted to Garner Abraham Construction through the government's procurement process.

Remedial works, upgrades and painting of the Leonora Delville Primary School by the ministry's maintenance team.

The upgrade of the restroom facilities, replacement of doors, windows and other remedial works at the Joyce Samuel Primary School issued to ABSTR Construction.

Roof repairs, electrical works, upgrade of restrooms and other remedial works are scheduled for the Willard Wheatley Primary School before the re-opening.

The water tighting of the Alexandrina Maduro Primary School contracted to Garner Abraham Construction through the government's procurement process.

Mr. Kettle added that the ministry is awaiting bids for the tender for roof repairs, electrical upgrades, and other remedial works at the Enid Scatliffe Pre-Primary School.

"The bid is out for the replacement of the awning at the Ivan Dawson Primary School, as well as a contract for metal works for the repairs of walkway rails and the repairs to the Ebenezer Thomas Primary School entrance gate," Mr. Kettle explained.

In addition to government spending on school rehabilitation and maintenance, there have been investments by the private sector including Unite BVI who has donated towards the installation of a playground and basketball court at the Francis Lettsome Primary School.

The North Sound Fund will be resurfacing the Robinson O'Neal Memorial Primary School courtyard and other remedial works. There will also be the installation of a playground at the school as well as at the Bregado Flax Education Centre Primary School.

The Ministry of Education, Youth Affairs and Sports remains committed to providing high-quality educational services and promoting access to sports and recreation to enrich the lives of the residents of the Virgin Islands.



VI Community Urged To Be Sensitised About Sargassum Seaweed

The influx of the sargassum seaweed is once again causing concern for members of the Virgin Islands community, namely those working in the tourism industry, fisherfolks and the frequent beach visitors

Acting Deputy Secretary in the Ministry of Environment, Natural Resources and Climate Change, Mr. Mervin Hastings said the Government of the Virgin Islands is constantly on the move to mitigate the issue of sargassum, through clean up initiatives, trainings and workshops with stakeholders, as well as public awareness initiatives.

He said the topic of sargassum is one which is continuously being discussed not only locally or regionally but also in other parts of the world and is costing Governments millions of dollars to address.

Mr. Hastings said, "The purpose of educating the community is, that together we, in the Virgin Islands, along with our regional and international counterparts can find a solution to this costly and concerning issue." He is aslo urging the community to sensitise themselves with the topic of Sargassum in order to understand and adequately navigate the issue.

Meanwhile, Marine Biologist and Environmeal Officer II, Ms. Argel Horton, said the source of sargassum that the Territory is impacted by derives from the Great Atlantic Sargassum Belt.

Ms. Horton said the belt spans across 500 miles and lies between Africa and South America. She said sargassum multiplies fast with warm waters and unfortunately with the ongoing heat that is impacting the region, the blooms will continue to impact the Territory.


The Environmental Officer said that according to satellite tracking, the influx will continue but the volume will be moderate until October 2023. She added that although sargassum is a challenging issue for the local government, she was optimistic that creative ways could be found to tackle this problem.


Ms. Horton said, "Many of our Caribbean counterparts have successfully produced products utilising sargassum such as fertilisers, beauty products and biofuel, just to name a few. I am confident in our people's abilitity to brainstorm and come up with solutions and rise above this issue where we can turn sargassum into a valuable commodity."

Earlier this year, representatives from multiple organisations including the BVI Tourist Board, National Parks Trust of the Virgin Islands, Unite BVI and BVI Ports Authority attended a two-day training of trainer's workshop in sargassum management.

The training was a collaborative effort between the Ministry of Environment, Natural Resources and Climate Change; the Caribbean Natural Resources Institute (CANARI) and the University of the West Indies Centre for Resources Management and Environmental Studies (UWI-CERMES).

The focus was also to increase understanding of the science of sargassum, its origins and ecological value, the principles of adaptive management, selection of tools and approaches for monitoring, and the clean-up and the rehabilitation of affected areas. The Ministry of Environment, Natural Resources and Climate Change envision sound stewardship of our natural resources by implementing a robust legal framework that fosters environmentally friendly best management practices.





GLOBAL NEWS BRIEF STORIES SELECTED BY GIORGIO MIGLIAVACCA

ATLANTA - A grand jury in Atlanta indicted Trump for his role in failed efforts to overturn Georgia's 2020 election results. The 41-count indictment also names 18 others, including former Trump lawyer Rudy Giuliani and former White House chief of staff Mark Meadows. All 19 defendants are accused of violating the state's Racketeer and Influenced Corrupt Organizations Act, or RICO.

Fani Willis is the district attorney charging Trump. She's the first woman elected to her role in Fulton County, where Atlanta is, and she's no stranger to high-stakes cases. She's won 11 convictions in the Atlanta Public Schools cheating scandal and is currently seeking the death penalty and hate crime enhancements against the shooter who allegedly killed eight people in Atlanta-area spas in 2021, including six Asian women. [NPR]

WASHINGTON — Former President Trump has been indicted in Georgia after an investigation by Fulton County Dist. Atty. Fani Willis into efforts to overturn the state's 2020 presidential

election results. Eighteen others were also indicted, including Trump's personal lawyers Rudolph Giuliani and Sidney Powell, and former Chief of Staff Mark Meadows.

Trump was charged in the sweeping 98-page indictment with racketeering and a dozen other felonies, including solicitation of violation of oath by a public officer, conspiracy to commit forgery and false statements and writings.

Willis launched the probe in February 2021 after news broke that the former president was recorded during a Jan. 2, 2021, phone call pressuring Georgia Secretary of State Brad Raffensperger to "find" him 11,780 votes, enough to win in Georgia. Trump has insisted that making the call was appropriate. Willis, a Democrat, had reportedly long focused on charging Trump and his associates under Georgia's Racketeer Influenced and Corrupt Organizations Act, allowing her to prosecute numerous people allegedly involved in a wide-ranging criminal scheme. All 19 defendants are charged under that statute. The act is broader than the federal

RICO law.

The enterprise was working "to accomplish the illegal goal of allowing Donald J. Trump to seize the presidential term of office beginning on Jan. 20, 2021," Willis said at a news conference late Monday night. [LA Times]

HAWAII - It is now the

deadliest wildfire the United States has seen in more than a century. And all signs indicate that the number of victims will continue to rise. Residents of the Hawaiian island of Maui on Monday were trying to come to terms with the scale of the disaster, which has killed nearly a hundred people, left hundreds missing and thousands more homeless in the city of Lahaina, which was consumed by the fire. The search for bodies has been complicated by the smoldering rubble and the possible toxic particles in the water, air and surfaces. This too has posed a challenge for locals seeking to return to collect the few belongings that may have survived the blaze. "We only have 3% of the search done, and they want to be meticulous and do it right. So right now they're going street by street and block by block, they're doing cars, and soon they'll start to enter buildings," Jeff Hickman, a spokesperson Department Hawaii's

of Defense, said on NBC's TODAY on Monday.

In the last hours, new equipment and cadaver dogs have been sent from other parts of the United States. "So the efforts are going to start to move a little faster than they have the past couple days, and hopefully, we bring some closure to those on Maui," said Hickman.


The historic center of Lahaina, the former capital of the Hawaiian Kingdom, was razed to rubble after the fire consumed the city of 12,000 (the island of Maui is home to 170,000 residents) in just four hours last Tuesday, devouring wood and melting metal. [El Pais]

COVID - Up to a year after a bout of COVID-19, some people can develop problems ranging from blood clots to irregular heartbeats to a heart attack. It's not clear why and doctors still are grappling with how to help. He's far from alone. How profound a toll COVID-19 has taken on the nation's heart health is only starting to emerge, years into the pandemic. "We are seeing effects on the heart and the vascular system that really outnumber, unfortunately, effects on other organ systems," said Dr. Susan Cheng, a cardiologist at Cedars-Sinai Medical Center in Los Angeles.

It's not only an issue for long COVID patients like Camilleri. For up to a year after a case of COVID-19, people may be at increased risk of developing a new heart-related problem, anything from blood clots and irregular heartbeats to a heart attack—even if they initially seem to recover just fine. [El Pais]



The stage has already been set for the 70th anniversary of the Territory's Emancipation Festival and those who attended many of the nights of the now-concluded 69th anniversary festivities can say that the precursor is a fitting promo for what is ahead.

This year there were new structures in place, as the Festival and Fairs Committee sought to raise the bar and standard on the traditional event. Although there was some discomfort at the start of the event, many agree that this year turned out to be one of the best there has been in a while.

Although some absences such as the annual calypso competition and the East End and Carrot Bay Village were heavily noted, hopes are high for returns and further elevation next year.

Here are the highlights of the 2023 festivities: **FESTIVAL PERFORMANCES**

The 2 August performance of Byron Messia was the most promoted performance. Weeks prior, there was a social media debate about whether the artiste would be allowed to performafter a popular clergyman complained about his lyrics to the many excitement from persons living in the USVI who stated they were coming over for the show.

The excitement stemmed from the fact that Byron is currently the fastest-rising dancehall artiste. He has already received the nod from a number of international artistes, with a remix that many saw will cross him over to an international fanbase in short order. You can reduce the sugar and make flavor combinations the Quaker dude never thought of.

DIYINSTANT OATMEAL PACKETS

Yield: Approximately 18 packets

Time: 10 minutes

10 cups quick oats, divided

1 teaspoon salt

1 cup brown sugar, or more to taste

1 cup powdered milk, optional

2 tablespoons cinnamon

1 to 2 cups add-ins, optional -- see below for ideas

18 to 20 snack-size zip-top bags

Put 7 cups of the oats in a large bowl. Place the remaining 3 cups of oats in a food processor or blender. Blend until powdery, then pour into the bowl with the whole oats. Add the salt, brown sugar, powdered milk (see tip below) and cinnamon in the large bowl. Mix well until combined.

Measure 1/2 cup of the oatmeal mixture along with 1 to 2 tablespoons of add-ins into each snack-size zip-top baggie and seal. Store the baggies in your pantry, or in the freezer for the longest shelf life.

Tip: If you prefer making oatmeal with milk, you can skip the powdered milk altogether. For cost-saving options, try using a combination of half milk and half water. Personally, I find that making it with milk during cooking enhances the flavor compared to using water and powdered milk.

To use the packets: Pour the contents of a packet in a bowl and add the desired amount of water or milk. Start with 3/4 cup and adjust to the thickness you desire. Microwave on high for 1 minute, stir and serve.

Now here's the fun part. You can put whatever goodies you like into your oatmeal



Some ideas: raisins, pumpkin pie spice, freeze dried strawberries, dried blueberries and slivered almonds, any variety of trail mix, mini chocolate chips and coconut, dried cranberries and pistachios, dried bananas and walnuts, dried apple and crystallized ginger, chopped pecans and maple syrup. 

We will look after you, Chang, Jamaican National Security Minister, assures Haitians

(Jamaican Gleaner)

National Security Minister Dr Horace Chang has said that the 37 Haitians now seeking asylum in Jamaica will be treated fairly during their hearing.

Chang, accompanied representatives from several state agencies and civil society groups, visited Robin's Bay in St Mary, Jamaica on Monday, where they met with the Haitians, who are being housed at a holding facility after illegally entering Jamaica by boat last month.

The minister noted that the facility was not a prison and that the police is maintaining a presence at the Seventh-Day Adventists Church campsite for security reasons.

"It is not a prison or lock-up, but it is secure and the police are here to protect them as well as to prevent [them] from getting off into other activities," he said.

The adults among the migrants were convicted of illegal entry last month and the group was set to be deported before an eleventh-hour filing of an asylum request.

"The court is a part of our law and that has settled, and now, we'll move to the next phase of trying to respond to the request for asylum," said Chang. "We would like to inform you and remind the wider public that Jamaica has always been committed to the rights of you people, Jamaica has always been supportive of the rights of the Haitian people.

"Locally we have a very strong Charter of Rights and we were always at the forefront of the move

But to tell you specifically, we were among the country that brought the situation in Haiti to the United Nations in 1990. Jamaica got the United Nations and CARICOM to assist Haiti both in development as well as an electoral system that was fair," Chang added.

> He further stated that there has always been good and friendly relations between Jamaica and Haiti and that Jamaica is actively seeking to restore stability and peace in Haiti.

> "You are our friends; we welcome Haitians. We will look after you. But we would like to see the time when your country is in a state where Haitians would like to live, raise their families, and work in Haiti and we can be partners," the national security minister said.

The Use of Data

Having taken these decisions, especially considering how critical access to the right skill set is for production purposes, it is of utmost importance that there is a robust means of capturing, analyzing and interpreting how the free movement of skills and temporary service providers regimes in particular, are performing in the CSME.

There are so many questions to be answered. For instance, what are the primary skill sets moving within the CSME? Are they persons who are highly skilled, semi-skilled or low skilled. The 2019 ILO report on labour migration clearly shows that two-thirds of global labour migration comprise of highly skilled labour. Is that global pattern replicated in our regional context? And if not, what is our predominant skill category moving. Is that indicative of skills gaps in our respective economies and should the receiving Member State invest in meeting that need from its own population or should it allow this matter to be addressed from the free movement regime in the Community. How does our free movement regime support the human resource development plans of Member States.

What is the labour migration pattern in the CSME Member States? Are most of our skilled nationals moving to destination countries outside the Region and if so why? Is it administratively easier to move to a country outside the CSME than it is within the CSME? Are the opportunities that are made available to our CSME nationals in the main countries of destination outside the CSME Region more attractive than within our own Region, and if so, can we compete or should we not look to developing a strategic migration policy and strategy for each Member State based on its circumstance and a resulting regional policy and strategy? Are we approaching free movement and migration as part of our national development strategy?

How Has the Free Movement Regime Performed

In November 2021, the CSME Unit conducted a study to estimate the level of usage of the free movement regimes, particularly the skills and right of establishment regimes from inception in 2007 to 2018 using as a basis, the number of indefinite stay stamps issued. There were many challenges with data availability as several countries simply did not submit the data sets to the CARICOM Secretariat (CSME Unit) on an annual basis as agreed. Failure to do so have made it more difficult to report to this workshop on how the free movement of skills regime has performed in the context of the CSME. However, from the data that was submitted, we were able to produce estimates of the utilization of the free movement

and 2018, we estimate that about 15,000 CARICOM nationals moved utilizing either the skills or the right establishment regimes. estimates show that twice as many persons moved in the first five years, that is, between 2007 and 2012 than between the second five years, 2013 and 2018. We now need data to do a similar analysis for the period 2019 to 2023. We were also able to deduce that annually, between 2013 and 2018, approximately 680 CSME nationals from one Member State moved to other Member States in the Community. Importantly, the countries that were net recipients of skilled nationals in that period were Trinidad and Tobago, Barbados, St. Kitts and Nevis and Antiqua and Barbuda in that

From the limited data that we have received from you, the Member States, we have been able to extract that picture. From the start, I posed a short series of questions (just a sample) that I believe we, as a Community, should be able to answer at any time when asked. The real issue is the availability of data. To compound the issue of being in a position to provide answers on our free movement regime for people driven by economic factors, the Conference of Heads of Government have decided that full free movement of CARICOM nationals must be a reality by March 31, 2024. What does this mean in terms of facilitating that mandate in terms of systems that should be operational to ensure that the Community is able to measure whether the CSME, which is the regional economic integration arrangement, is delivering on the intended objectives. This meeting should give creative thought to how we accommodate the Heads mandate with the reality that there must be systems to provide the Heads and indeed the Community with an accurate assessment of how the policy prescription is or is not performing. It is only by so doing, we will be able to make policy adjustments to achieve our stated objectives of building a resilient and competitive regional economic space.

I thank you and thank the IOM for their support in bringing focus on this important matter of data collection on free movement of skilled CSME nationals which is in support of Goal 8 of the Sustainable Development Goals which speaks to promoting decent work for all.

Opening Remarks by Titus Preville Director – CARICOM Single Market At the Workshop on Supporting the CSME on Gathering and Harmonizing Free Movement Data Jointly Organized by IOM and the CARICOM Secretariat (CSME Unit)

(CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana -Tuesday, 15 August 2023):

Mr. Brendan Tarnay, Programme Support Officer for the Caribbean under the Western Hemisphere Programme of the International Organization on Migration (a UN Agency), representatives from Member States of the CSME, staff of the IOM Office, staff from Directorate for CARICOM Single Market and Trade. invited guests, ladies and gentlemen, all. It gives me great pleasure to deliver remarks at the opening of this workshop which is focused on getting a better understanding of the challenges of collecting and using data on the movement of CARICOM nationals directly arising from their exercise of their rights in moving either as skilled nationals, temporary service providers or in exercise of the right to establish economic enterprises. We already have a fairly robust system of data collection on the movement of persons associated with travel for tourism related activities. And that data is heavily utilized by tourism related institutions as part of marketing and other destination-oriented activities. The question is how can we improve data collection and use on movement of CARICOM nationals associated with economic endeavors within the Community and what is the potential value of that data.

Remarks

The CSME was established for many reasons but critical among those reasons was the building of resilience to external economic shocks. The free movement of goods regime is well advanced, and it sought to address two compelling matters. One was the expansion of regional production and trade among Member States thereby building competitiveness of regional enterprises within the Single Market context and secondly, building the capacity and competitiveness to compete in markets external to the CSME region. It was perceived that achieving these two objectives would address the lingering issues of high unemployment, persistent poverty, and sustainable economic growth.

Now central to achieving these

objectives is the free movement of the factors of production, key among which is the movement of labour. The movement of CARICOM nationals for non-economic activity such as vacationing is well facilitated with the absence of visa requirements and automatic six months stay in any receiving Member State. Article 46 of the Revised Treaty of Chaguaramas paves the way for movement of CARICOM nationals to seek employment by first identifying a short list of skilled categories in 46 (1) and makes it possible to enlarge that list through the provisions in 46 (4) (a). As a result of these provisions, we now have 12 approved categories of skilled nationals who have the right to seek employment activity in any sector in any Member State, save for two Member States, Antiqua and Barbuda and St. Kitts and Nevis who have obtained derogations for two categories of skilled nationals in keeping with provisions of the Revised Treaty under Article 27 (4).

We also have provisions in Articles 32, 33, 34, 36 and 37 which pave the way for CARICOM nationals to exercise the right of establishment and temporary provision of services. Both of these activities involve the movement of CARICOM nationals.

Death Toll From Maui Fire Reaches 106

LAHAINA, HAWAII -

A mobile morgue unit arrived Tuesday to help Hawaii officials working painstakingly to identify remains, as Maui County released the first names of people killed in the wildfire that all but incinerated the historic town of Lahaina a week ago and raised the death toll to 106.

The county named two victims, Lahaina residents Robert Dyckman, 74, and Buddy Jantoc, 79, adding in a statement that a further three victims have been identified.

Those names will be released once the county has identified their next of kin.

The U.S. Department of Health and Human Services deployed a team of coroners, pathologists and technicians along with exam tables, X-ray units and other equipment to identify victims and process remains, said Jonathan Greene, the agency's deputy assistant secretary for response.

"It's going to be a very, very difficult mission," Greene said. "And patience will be incredibly important because of the number of victims."

Request for patience A week after a blaze tore through historic Lahaina, many survivors started moving into hundreds of hotel rooms set aside for displaced locals, while donations of food, ice, water and other essentials poured in.

Crews using cadaver dogs have scoured about 32% of the area, the County of Maui said in a statement Tuesday. Hawaii Gov. Josh Green asked for patience as authorities became overwhelmed with requests to visit the burn area.

Maui Police Chief John Pelletier renewed an appeal for families with missing relatives to provide DNA samples. So far 41 samples have been submitted, the county statement said, and 13 DNA profiles have been obtained from remains.

The governor warned that scores more bodies could be found. The wildfires, some of which have not yet been fully contained, are already the deadliest in the U.S. in more than a century. Their cause was under investigation.

When asked by Hawaii News Now if children are among the missing, Green said Tuesday: "Tragically, yes. ... When the bodies are smaller, we know it's a child." He described some of the sites being searched as "too much to share or see from just a human perspective."

Another complicating factor, Green said, is that storms with rain and high winds were forecast for the weekend. Officials are mulling whether to "preemptively power down or not for a short period of time, because right now all of the infrastructure is weaker."

Hardships for survivors

A week after the fires started, some residents remained intermittent power, unreliable cellphone service and uncertainty over where get assistance. Some people walked periodically to a seawall, where phone connections were strongest, to make calls. Flying low off the coast, a single-prop airplane used a loudspeaker to blare information about where to get water and supplies.

Victoria Martocci, who lost her scuba business and a boat, planned to travel to her storage unit in Kahalui from her Kahana home Wednesday to stash documents and keepsakes given to her by a friend whose house burned. "These are things she grabbed, the only things she could grab, and I want to keep them safe for her," Martocci said.

The local power utility has already faced criticism for not shutting off power as strong winds buffeted a parched area under high risk for fire. It's not clear whether the utility's equipment played any role in igniting the flames.

Hawaiian Electric Co. Inc. President and CEO Shelee Kimura said many factors go into a decision to cut power, including the impact on people who rely on specialized medical equipment and concerns that a shutoff in the fire area would have knocked out water pumps. Green has said the flames raced as fast as 1.6 kilometers every minute in one area, fueled by dry grass and propelled by strong winds from a passing hurricane.

Fires still burning

The blaze that swept into centuries-old Lahaina last week destroyed nearly every building in the town of 13,000. That fire has been 85% contained, according to the county. Another blaze known as the Upcountry fire was 60% contained.

The Lahaina fire caused about \$3.2 billion in insured property losses, according to calculations by Karen Clark & Company, a prominent disaster and risk modeling company. That doesn't count damage to uninsured property. The firm said more than 2,200 buildings were damaged or destroyed by flames, with about 3,000 damaged by fire or smoke or both.

Even where the flames have retreated, authorities have warned that toxic byproducts may remain, including in drinking water, after the flames spewed poisonous fumes. That has left many unable to return home.

The Red Cross said 575 evacuees were spread across five shelters as of Monday. Green said thousands of people

will need housing for at least 36 weeks. He said Tuesday that some 450 hotel rooms and 1,000 Airbnb rentals were being made available.

President Joe Biden said Tuesday that he and first lady Jill Biden would visit Hawaii "as soon as we can" but he doesn't want his presence to interrupt recovery and cleanup efforts. During a stop in Milwaukee to highlight his economic agenda, Biden pledged that "every asset they need will be there for them."

Emergency assistance

More than 3,000 people have registered for federal assistance, according to the Federal Emergency Management Agency, and that number was expected to grow.

FEMA was providing \$700 to displaced residents to cover the cost of food, water, first aid and medical supplies, in addition to qualifying coverage for the loss of homes and personal property. The Biden administration was seeking \$12 billion more for the government's disaster relief fund as part of its supplemental funding request to Congress.

Green said "leaders all across the board" have helped by donating over 450,000 kilograms of food as well as ice, water, diapers and baby formula. U.S. Marines, the Hawaii National Guard, the Army Corps of Engineers and the Coast Guard have all joined the aid and recovery efforts.

Lahaina resident Kekoa Lansford helped rescue people as the flames swept through town. Now he is collecting stories from survivors, hoping to create a timeline of what happened. He has 170 emails so far.

The scene was haunting. "Horrible, horrible," Lansford said Tuesday. "You ever seen hell in the movies? That is what it looked like. Fire everywhere. Dead people."

SPORTS 4-135 BVI players helps Great Britain qualify for U23 Worlds

Great Britain opened the tournament with an 8-3 victory over the Czech Republic, then toppled hosts Austria, 10-4, before losing to the Netherlands who they had under a no-hitter through seven, 1-0.

Dawson, in his second U23 stint, told Island Sun Sports that it was a 'cool experience' to go to Vienna and be a part of the team with Mercer and Hodge. "It's always a good time for me and it helps me go back to my roots and to remember I've been playing this game for fun," he said. "With the team itself, we were able to place second and secure the silver medal, which means we qualify for the U23s World Cup next year in China—that is a first in program history, a U23 team has made it that far-so it's special to be a part of history."

Dawson said it was a good tournament overall as they only lost two games to eventual champions Netherlands, the first being a 1-0 game, a game that was won on a walk off homer, after a no-hitter through seven. He said their rematch didn't go as planned with a victory, but they achieved the end result they wanted, which was to qualify for the World Cup and that's something he's proud of.

"Unfortunately, next year, I won't be able to play in the tournament as I will be over the age limit, but Rayondre will be on the roster," he noted. "Hopefully, J'Quaan (Smith) will be on the roster and maybe we could see one or two players from home on the roster, that weren't able to make it this year."


Dawson said that being named one of the team Captains was special, given all his experience he has gained over the last two and a half years including playing in the European senior championships.

"It was special for me to be able to give back to the team and help some of the younger guys through the tournament, because one of the

hardest things is going to Europe for tournament play," he pointed out. "It's a lot quicker, it's more fast paced than regular season baseball. So helping the younger guys adjust to that along with the other two Captains-being with them and helping them to adjust to tournament play was special for

Dawson said the expectation was different to two years ago when they finished fourth, because the expectations were higher, as their focus was on qualifying. With the senior team playing well in the World Baseball Classic, he said that opened the door for people wanting to play with Great Britain's U23 team, as well as all the other teams down the line.

"That opened the team to being more talented and having a better chance to qualify," he said. "We're hoping to keep the trend going and to keep improving the program so that we're bringing in more players than the season before and helping the younger players adjust to that. The better we play, the more publicity we'll get and the more people looking to see if they have any eligibility to play for the Great Britain team. If we keep doing that, we'll have better teams every tournament, so that's always

the goal.

Mercer, who played center, described his U23s debut as 'fun and exciting.' "Coming into it I didn't know what to expect because I never played outside the United States besides back home, but it was a fun experience," he said. "The fans in Austria didn't really like us because of what we did and chirping the other teams and that's not how they play-they were chirping us back and I had fun with it-but, it is something I am definitely looking forward to doing in the future.

Mercer said it was also fun having Hodge and Dawson there. "I proud of them and proud of myself for what we're doing and putting BVI on the map."

Young, wild and free (from corruption)

Young people today are impacted by a world brimming with challenges - from the climate crisis to economic inequalities and multiple forms of discrimination, just to name a few. And all these issues are exacerbated by corruption. Despite the complex landscape today's youth inherit, their energy and passion to challenge the status quo offers hope for the future.

We have just celebrated International Youth Day and it's an opportunity to cast a spotlight on the young advocates boldly leading the fight against corruption.

Young people are more exposed to bribery and are vulnerable to corruption, as they are involved in nearly every aspect of society, as students, workers and consumers. Within this context, the rising generation is increasingly embracing social change, driving political transformation and making a real impact through tech-savvy solutions, active political engagement and peer-to-peer training.

Growing up in an ever-evolving tech anti-corruption landscape, young fighters know how to utilise digital tools in their advocacy. Take Nigeria, for example, where university students use the Timby app to confront sextortion the abuse of power to obtain a sexual benefit. This app provides a safe, anonymous space for survivors of sextortion to submit questions and seek guidance. And in Europe, young people from Germany, France, Italy, Macedonia and Lithuania are building watchdog communities against corruption using digital technologies.

Around the world, young people continuously speak their minds and drive social change, but they require more platforms to amplify their voices. That's why their essential role in policymaking must be recognised. To ensure their demands are heard, youth in



Palestine are taking matters into their own hands by monitoring elections at both local and national levels. With the support of our chapter, they're gaining the skills and knowledge to make an impact in their communities and beyond.

In some places, there is now a formal recognition of their role. For example, the European Union has taken an important step to ensure young people are part of decision-making processes. The EU Youth Action Plan is the firstever policy framework for a strategic partnership with young people around the world to shape action and accelerate progress on issues like sustainable development, peace, gender equality and climate action. As part of this initiative, we've been selected to participate in the Youth Dialogue Platform, providing an opportunity to connect with youth organisations around the world to strengthen the youth agenda within our movement.

But how can young people develop the skills needed to fight corruption? Integrity schools, like the Transparency International School on Integrity in Lithuania, are one way forward. The school is the world's longest-running and best-known programme on transparency, with 1,600 alums from more than 120 countries. Our chapter in Lithuania is not alone in this endeavour; around 25 other chapters-spanning from Jordan to Colombia - are also organising similar programmes. Integrity schools like ours provide an opportunity for young people to develop skills to strengthen their anticorruption efforts by participating in real-life demonstrations of transparent decision-making.

Our chapter in Papua New Guinea is also making strides on that front. Through the Mike Manning Youth Democracy Camps, young people are offered training on a wide range of topics and cross-learning opportunities to strengthen their leadership and advocacy skills. Many students continue to make an impact long after attending the camps by using their experience to improve infrastructure and governance in their schools and communities.

These are just some of the many ways young people are paving the path towards a less corrupt world. And while the responsibility to fix corrupt systems shouldn't fall solely on today's youth, they are driving systemic change. Young people have fresh and innovative perspectives on today's greatest challenges, and they must be given the opportunity to inform policies that directly affect them - and the next generations to come.

KENYAN INTERVENTION IN HAITI? MORE WORK NEEDED

No one should yet be pouring champagne to celebrate the announcement by the U.S. government that Kenya has agreed

to lead a multinational police force to help subdue gangs and improve security in Haiti. This announcement is rightly far from a done deal.

The U.S. exerted a great deal of diplomatic effort in trying to persuade many countries to

lead a multinational force into Haiti - a principal request of Haiti's unelected Prime Minister, Dr. Ariel Henry. Among the countries that declined was Canada, which opted to provide direct support to Haitian forces.

Many nations are cautious about leading or even participating in such a force in Haiti, not least because they recognize that, within Haiti, while the people want an end to the kidnappings. violence, rapes, and other atrocities associated with the rise of gangs, a significant number are concerned about further foreign intervention in their country.

These nations also know that the underlying reasons for Haiti's condition are the economic actions by France which crippled the country's economic prospects for over a century; a U.S. invasion and its economic convenient consequences; the maintaining by foreign governments of avaricious Haitian leaders; and the general impoverishment of the country.

Haitian civil society groups have widely opposed the deployment of any foreign force, referencing bitter experiences with previous intervention and fears that intervening forces would be propping-up the present unelected regime which they regard as partially responsible for the country's crises.

Further, all governments are keenly aware that a multinational force in Haiti's present circumstances would

not be a traditional United Nations (U.N.) peacekeeping force. What Dr. Henry has requested is a force that will help the Haitian police confront and conquer the more than 60 gangs that now dominate the safety and security space in Haiti, leading to potential bloodshed.

For its part, the Kenyan government has said that it is ready to deploy 1,000 police officers to help train and assist Haiti's police to "restore normalcy

in the country and protect strategic installations". The form of assistance was not clarified, and the government also made it clear that its "proposed deployment will crystallize" once it gets a mandate from the U.N. Security Council "and other Kenyan constitutional

processes are undertaken".

The Kenyan need for a U.N. Security mandate explains why the U.S., which is the Chair of the Security Council for the month of August, has announced that it will propose a U.N. Security Council resolution authorizing Kenya to lead a multinational police into Haiti. Getting a Security Council mandate will not be easy. Already the U.S. has been unable to obtain endorsement of the work plan for its Chairmanship because of Russia's objections primarily due to the inclusion of Ukraine.

Interestingly, while U.N. Secretary-General, António Guterres, welcomed Kenya's announcement, he has described it as "a non-U.N. multinational operation in Haiti". Where such a development places Kenva's offer is left to be seen. particularly as the government has publicly stated that it wants "a mandate from the U.N. Security Council".

What is troubling about this development is that it is not awaiting the outcome of several initiatives seeking "a Haitian led solution". Among these initiatives is the CARICOM Eminent Persons Group of three former Caribbean Prime Ministers, working to bridge division among stakeholders in Haiti and to arrive at an agreed plan to take the country forward. Their work is not concluded, nor have they pronounced on whether their mission has any chance of success.

Another initiative was the U.N. Security Council's unanimous Resolution on July 14, 2023, asking the Secretary General to produce options to help combat Haiti's armed gangs.

The time for the submission of the Secretary General's report has not yet elapsed.

The U.S. Ambassador to the U.N., Linda Thomas-Greenfield, disclosed that the U.S. will be seeking Security Council endorsement for Kenya to lead a multinational force into Haiti, saying, "This is not a traditional peacekeeping force, this is not a traditional security situation [...] We have gangs that have overtaken the country, ... that are terrorizing civilians every single day." She admitted that the situation is "unusual".

What is being proposed is not a traditional U.N. peacekeeping force, but a military exercise designed to eliminate heavily armed gangs, which were created by elements of the political and business classes of Haiti, and which are now out of their control.

While no one would disagree with the U.S. that Haiti desperately needs stabilization, not everyone will be convinced that a foreign multinational force, especially one that is not fully endorsed by the U.N. Security Council, is the answer.

Equally concerning is that any intervention in Haiti should be at the expressed wish of the majority of stakeholders in Haiti, including political parties, civil rights groups, the business community, and the influential Haitian diaspora.

Foreign intervention in Haiti is unlikely to secure the desired broad consensus among Haitians, unless the terms are agreed by them, including oversight, agreement on its purpose, and the expiry of its stay.

Moreover, the essential question of who is in charge of the country while it endures these events still remains. Will it continue to be an unelected group, or a transitional government comprised of representatives of political parties, civil society, the business community, and qualified Haitians in the diaspora?

Achieving a Haitian consensus on a multinational force and the terms and objectives of its operations should be the first effort on which energies should be exerted.
