PREMIER RESPONDS TO CRITIC CISMS ABOUT FESTIVAL 2023

During a press conference 24 August Premier and Minister for Finance the Hon. Natalio Dr. Wheatley addressed of the criticisms that have surfaced following the 2023 Emancipation Festival. Hon. Wheatley during the postfestival press conference was very defensive of the

Virgin Islands Festival and Fairs Committee (VIF&FC), and the work that was done to pull off the 69th event.

Each year the cost associated with pulling off the festivities is always a point of conversation, especially in instances of budget overages. This year the Vice Chairman of the VI Festival and Fairs Committee, Birchfield Lettsome informed the media that approximately \$1.8M was spent on the recent Festival activities.

Lettsome noted that although the final financial figures are still being worked out, the VIF&FC can report that its budget included \$1.07M

that was raised and \$1M that was received from the Government.

The Festival Vice Chair explained that the money raised came from sponsorships fundraising activities such as rental spots, and ticket sales. Lettsome further noted that the Committee is proud that it invested heavily in the local economy. In fact, he stated that for every \$1 spent internationally, \$3.50 was spent locally.

ACCOUNTABILITY SOLUTIONS

Premier Wheatley explained that he has heard concerns about accountability but that the current noted Festival Committee does its best. Nonetheless, he said that he understands the need for better transparency. Hon. Wheatley stated: "We are in a new era, we experience a Commission of Inquiry, and the Festival and Fairs handles large amounts of cash, and we have to make

sure that we have a structure that will allow accountability for the use of taxpayer money, especially when you are dealing with those large amounts of cash,"

He further asked: "How well can you hold accountable, volunteers for the spending of huge sums of money? Is it time that we introduce a structure where you have persons working full time on Festival?"

The Premier said that it must be remembered that the volunteers have their personal businesses and obligations and the public must take this into consideration when it is being requested that more time be put into the Festival planning. "All of the people involved have contributed lots of hours to organising the celebrations and the question is if you want to start earlier and if you want to do more planning? Is it sustainable to ask volunteers

to be able to do that," Hon. Wheatley pointed out.

FESTIVAL IS NOT THE SAME

One of the biggest criticisms of this year's Festival is the costume and the regional parade influence. However, the Premier who was firm in his response to those criticisms pointed out that the public needs to remember that things and times change.

The Premier pointed out: "Early on in the 70s,

because of course it was just us, we did our celebrations in a particular way. Now, of course, we have transitioned into something different because our society has changed. What I would like to see us be more of going forward is really to be intentional about who we want to be as a people."

"So we have to have a conversation about our society, we have to grow. And you grow through

having conversations, you go through as a result of those conversations. Taking action is something that we can't be passive about. We have to be active participants in what we want to see and what we want to do," Hon. Wheatley said.

As it relates to the comment made about the parade being about Feather and Flesh the Premier issued a challenge for the critic to do better. Hon. Wheatley said: "The persons who have a challenge with it, did you have an equal number of persons who embrace what it is that they wanted to see? Come for the 70th, are you challenging yourself that you are going to go out there and do a costume in the way that you think it should be done? And if you are not willing to do that and you are only willing to stay on the sidelines and complain about it, well, you know it will be what it will be."

Construction Of Bus Shed To Begin September 4

DEPUTY PREMIER WANTS TO SEE BUSINESS AND COMMERCE THRIVE

Premier Deputy and Minister of Labour, Hon. Lorna Smith has issued a call to action directed at the private sector. Her plea involves fostering stronger collaboration with the to facilitate government increased employment opportunities. A notable focus of this appeal is government's latest employment endeavor, known as the Registration Apprenticeship Training Employment and Development (RATED) program.

Mrs. Smith' rallying cry was delivered during her speech at the rebranding ceremony of the former BVI Chamber of Commerce and Hotel Association,

now called the Chamber of Commerce. Her sentiments echoed those earlier expressed by Premier Wheatley.

The genesis of the RATED program dates back to the previous November, arising as a proactive response to heightened scrutiny of the government's procurement protocols following a comprehensive Commission

of Inquiry (COI). The specific issuance of contracts, particularly those related to bush-cutting, had triggered concerns and debates.

Premier Wheatley, in introducing the program, underlined its purpose transcending a mere channel for allocating bush-cutting contracts and other roadside aesthetic projects. Echoing this perspective, the Premier affirmed: "I am of the strong belief that beyond apprenticeships, your support encompass training and education, particularly attachments. Enthusiastically, I anticipate forging a close partnership in my capacity as the overseer of business development."

While speaking to business owners at the Chamber of Commerce the Labour Minister emphasized the resonance of the Premier's appeal for bolstered Public Private Partnerships (PPP). Hon. Smith explained that such partnerships between governmental bodies and private enterprises can be jointly conceptualized, funded, and administered undertakings.

Hon. Smith also emphasized that she wants to see business and commerce thrive in the Territory. In articulating mission, the Deputy Premier asserted that in her capacity as the accountable Minister, her aim is to amplify and refine business endeavors, and simplify the business landscape. In fact, she said that she is optimistic about achieving this ambitious goal with the invaluable support businesses provide.

AGRICULTURE MINISTER DISCUSSES ILLEGAL ANEGADA LOBSTER HARVESTING

Recent reports have suggested that certain businesses on Anegada are persisting in lobster harvesting activities even after the official closure of the season.

Within the British Virgin

approved Islands. the timeframe for lobster harvesting extends from 1 November to 30 June each year, with a mandated closure period from 1 July to 31 October. Furthermore, seeking individuals engage in lobster harvesting are required to obtain permits.

During a 15 August press conference, Dr. the Hon. Karl Dawson, Junior Minister of Agriculture, was questioned about his awareness of ongoing lobster sales out of season by specific Anegada-based businesses. In response, Dr. Dawson acknowledged being informed of the situation, albeit lacking comprehensive details.

He highlighted a possible scenario where local residents might have previously captured and stored lobsters during the open season, intending to utilize these reserves once the harvesting period had ceased.

In discussing the legislative

governing framework lobster-related activities in the BVI, Dr. Dawson pointed certain ambiguities regarding situations beyond the act of capture. He posed pertinent questions, including the legality of selling lobsters caught in July during the ensuing month of August. Dr. Dawson stressed the importance of careful examination to ensure consistent application of the law, particularly when offering guidance to restaurants and commercial

establishments.

Dr. Dawson disclosed having received an email on that very morning of the press conference, underscoring this specific concern. However, after the conference, it remains unverified-whether indeed businesses are violating-regulations conducting lobster harvesting during the closed season, and whether any official warnings have been issued by relevant authorities.

PREMIER CONFIRMS THAT "WE MUST PAY OUR EDUCATORS MORE"

of the Leader Territory Premier Dr. the Hon. Natalio Wheatley confirmed understanding educators' needs for enhanced salaries and announced that he would like to see the Territory's teachers better compensated.

While speaking the Ministry Education's Professional Development Day the H. Lavity Stoutt Community College (HLSCC) on 28 August Hon. Wheatley declared: "Of course, wages are our concern. The Government did our part in providing the funds and approving the increment payments.

We regret that the process has taken longer than it should have, but we are grateful that 97% would have received their increments by August 31st and the remaining 3% will receive increments by mid-September."

As a former Educator, the Premier explained that he knows the significant contributions of the Virgin Islands' educators. The Premier pointed out that the Territory's teachers deserve heightened acknowledgment, rewards, compensation. However, he noted that the wage upset is not isolated to the British Virgin Islands (BVI), but is a challenge many nations grapple with.

Wheatley Hon. noted that the problem intensified when considering the recruitment competition. "The problem becomes more acute when we factor in that some countries are attracting teachers from other countries to fill their own staff deficits by offering more competitive packages," the Premier mentioned.

He nonetheless assured the educators that efforts are being made to remedy the situation, "we are going to put our best foot forward," he promised.

The Premier also pointed out that the upcoming Public Service Compensation Review that will be presented to the Cabinet is key to addressing the salary concerns educators have. The Premier noted, however: "I do not wish

to pre-empt whatever recommendations the reviewer will be putting forward but certainly, we accept that we must pay our educators more."



Diagnostic Checks Almost Complete On Asphalt Plant

Director of the Public Works Department Mr. Jeremy Hodge has stated that the final diagnostic checks are being conducted before the department's asphalt plant can become operational.

Mr. Hodge said in a recent interview said that the plant's technician and members of his team are in the Territory ensuring that the checks are completed.

The Director thanked the entities including the British Virgin Islands Electricity Corporation and the Department of Information Technology for their assistance in setting up the asphalt plant and for ensuring that it was configured to be connected to the internet thereby ensuring that issues will be identified and rectified in the future.

Mr. Hodge said plans are underway to address the Territory's roads in a holistic manner and reassured the public that his department will be able to respond to issues on the roadways in a more efficient manner. He added that all the Territory's roads will be addressed when the asphalt plant is commissioned.

"I know that there will be a lot of anxiety but we will get around to all those roads, including your community," Mr. Hodge said, adding, "We are also in communication with some technicians overseas to work along with our technicians to share expertise on road paving and other techniques."

The Director also issued an invitation to persons who are about to complete their heavy equipment licence and those with an interest in learning about asphalt or its applications to sign up with the Registration Apprenticeship Training Employment and Development (RATED) Programme where they will receive the necessary training when another team of technicians arrive in the Territory.

GLOBAL NEWS BRIEF STORIES SELECTED BY GIORGIO MIGLIAVACCA

MUGSHOTS - Last week, we saw mug shots of Donald Trump and codefendants after they were booked in Fulton County, Ga. I wrote about mug shots in my essay on Weekend Edition Saturday.

Almost everyone booked gets that close-up. It reminds us that our criminal justice system applies to everyone. I remembered several other famous mug shots:

☐ Bill Gates was booked in New Mexico in 1977 for driving without a license. Didn't he send himself a reminder to renew it?

☐ Frank Sinatra was booked in Hoboken in 1938 and charged with seduction (relations with a married woman, not his rendition of "I've Got You Under My Skin"). Charges were dropped.

☐ Elvis Presley's mug shot is widely misunderstood. He met President Nixon in 1970 and asked to be made "'Federal Agent-at-Large in the Bureau of Narcotics and Dangerous Drugs." Nixon obliged. Elvis would die in 1977 with a 10-drug cocktail — codeine, morphine, and more — in his system. He was just 42.

☐ John Gotti's 1990 mug shot makes you wonder: Why is this man smiling? This booking would lead to his conviction for murder, racketeering, and tax evasion. The crime boss would die in prison.

□ Rosa Parks was 43 when she had a mug shot taken during the Montgomery bus boycott she inspired by refusing to give up her seat. That boycott began a social and political movement that brought down the structure of legal segregation in the United States. You don't get much of a chance to look your best in a mug shot. But Rosa Park's courage and grace shine through. [Courtesy of NPR/Scott]



FULTON COUNTY SHERIFF'S OFFICE

USA - The Republican candidate's election campaign has launched merchandising for sale with the image of the moment he was booked at Fulton County Jail. It took just minutes for Fulton County, Georgia, to release the mugshot taken of Donald Trump as he was booked on Thursday for his role in attempting to interfere in that state in the 2020 presidential election. And after that, it took seconds for the image

of the former U.S. president staring into the camera - with a defiant expression, according to his supporters; frowning, according to his detractors - to go viral. And it took even less time for the current Republican candidate for the White House to start exploiting it economically.

The picture, taken from an elevated angle, shows the former president with his forehead tilted slightly forward and his eyes staring intensely. It is the pose that some movie buffs describe as the "Kubrick stare," after British film director Stanley Kubrick, who used it in films such as A Clockwork Orange and The Shining for Malcolm McDowell and Jack Nicholson to provoke an unsettling sensation in the viewer. According to CNN, there had been an intense debate among Trump's advisors earlier about the expression with which the former president should pose. It has already become meme fodder and an instant classic, one of those that will truly go down in history. It is the first of an American president, active or out of office, as an inmate.

Any other politician with Trump's judicial troubles -he faces 91 charges in four separate indictmentswould be finished. But the leading Republican candidate has chosen to turn the situation around and present himself as a victim of a politicized justice system that wants to take him down by any means necessary, because it fears he will return to the White House and defend ordinary citizens. The photograph of him as a man

under arrest, with the watermark of the Fulton sheriff's office included, thus becomes a badge of honor and a source of pride. Ultimate proof that he is being unjustly persecuted. [El Pais]

HAITI - Protesters led by a pastor marched through a gang-controlled area near the capital. Rights groups reporting on the incident blamed the pastor for leading protesters into such a dangerous situation.

A powerful gang in Haiti opened fire on a pastor-led march through an area controlled by the gang near the capital Portau-Prince, killing several of the marching parishioners.

The gang, which controls the northern Canaan suburb, fired at the protesters with machine guns. Local rights group CARDH said at least seven people were killed, with the group's director Gedeon Jean expecting the death toll to rise. Jean said that several people were wounded, with some churchgoers even kidnapped. [Deutsche Welle]

ETHIOPIA - Women and children in Tigray are still subject to sexual violence despite a peace agreement signed in November 2022, according to a new report. Survivors accuse both Ethiopian and Eritrean soldiers of rape.

"The situation that Tigrayan women are experiencing through sexual violence is deeply distressing," social worker Birhan Gebrekirstos told DW.

Her quiet voice sounded muffled as she talked about her experience of working with survivors of sexual violence in Mekelle, the capital of the northern Ethiopian region of Tigray, over the past three years.

Many women and girls were raped during and also after the two-year civil war in Tigray. [Deutsche Welle]

JAMAICA - An article by NBC News shares the story of Trisha Bailey, a Jamaican entrepreneur whose remarkable brims success story inspiration and impact. Trisha's remarkable journey began in the impoverished settings of St. Elizabeth Parish, Jamaica, This Jamaican-born entrepreneur transformed a small medical supply venture in Orlando into a sprawling empire that spans seven states. NBC News states that Bailey's net worth is estimated at a staggering \$700 million, positioning her as the wealthiest Jamaican-born woman history.Bailey recently unveiled her memoir, "Unbroken: The





Dear Readers: It's coming close to the start of School. Now is the time to get going with your Back-To-School Plans:(3 of 3)

Find a 'go-to-school friend':

If your child walks or takes the bus to school and there are other children in the neighborhood who go to the same school talk to the parents and ask them if the kids can walk or take the bus together. This way the kids will have more fun on their way to school and may share their worries and help each other to feel more comfortable going back to school.

Deal with expectations:

Older children will already have set themselves expectations they want to fulfill at school. Therefore, it is helpful to ask them what they expect about returning to school. It can help to read a story about children who go to school in order to start the conversation and to make it easier for kids to talk about their feelings. It is also important to ask kids if they have any questions or are unsure about anything. Let them know that other kids will be nervous, and that teachers will help them to feel more comfortable.

Show them that you think about them:

When getting lunch or a snack ready for school include a little note in the lunchbox to show your children that you care and that you think about them during the day even if they are away.

Child care after school:

A parent should be at home to help the children to get ready for school in the morning and who supervise them when they return. If this is not possible talk to your children that it is important to follow rules and listen to the adult supervising them.





Cardinal Marengo: Pope's visit to Mongolia is an honor and a grace

The Apostolic Prefect of Ulaanbaatar comments on the importance of the Holy Father's Apostolic Journey in bringing a sense of "belonging to the universal flock of the Catholic Church" to the local community.

"The Church in Mongolia is waiting with great trepidation for the coming of the Holy Father." Cardinal Giorgio Marengo, Apostolic Prefect of Ulaanbaatar, thus remarked on the collective enthusiasm accompanying

the imminent Apostolic Journey in the Asian country that will take place from August 31 (date of departure from Rome) to September 4).

Speaking with Vatican News, Cardinal Marengo presented the activities going on among the local community in preparation for the upcoming visit.

Spiritual preparation

"One aspect worthy to be mentioned," according to the Apostolic Prefect, "is that we are encouraging our Catholic community to intensify the Marian prayer, especially through the prayer of the Holy Rosary."

The "spiritual preparation" goes hand-in-hand with practical experiences, such as a special pilgrimage to a wooden Blessed Virgin Mary statue found "in a dumping area in the northern part of Mongolia."

This preparation path began on March 25, the day the Church celebrates the Annunciation of the Lord, and ended on August 15, the Assumption of the Blessed Virgin Mary.

"In a great embrace between two great solemnities," Cardinal Marengo explained, "we would like to welcome the gift, the grace of the visit of the Holy Father, and to get everyone involved too."

GRATITUDE AND BELONGING

Speaking about the meaning that Pope Francis' visit has for Mongolia, the Apostolic Prefect described it as "a great honor and, at the same time, a very special grace."

"To have the successor of St. Peter with us brings immense gratitude and a sense of belonging to the universal flock of the Catholic Church."

The presence of the Holy Father is a sign of hope and a concrete demonstration that he "cares for this tiny flock of Catholics in Mongolia."

BILATERAL RELATIONS

Cardinal Marengo also examined the Apostolic Journey from a diplomatic point of view. The local government is preparing "with great expectations," recalling "the ancient roots of the bilateral relations" between Mongolia and the Holy See.

Relations that will be further deepened and "will know a new phase of intensification."

"We go back to the 13th century," the Apostolic Prefect recalled, "when Pope Innocent IV sent his special envoy, John of Plano Carpini, Franciscan friar, to visit the Mongolian emperors and to establish a link, a connection with them."

"Mongolia will surely benefit from the point of view of its international interest."

OPEN TO GIFTS AND GRACES



JAMAICA PROJECTING 140,000 ADDITIONAL SEATS FROM THE U.S. THIS FALL

Total Number of Seats Across Carriers Grows 19% Over 2022 and 18% Over 2019 as the Destination Prepares for Record Stopover Arrivals in 2023

KINGSTON, JAMAICA, August 29, 2023 — Continuing to cement its position as one of the world's leading tourism destinations, Jamaica is expecting an increase in scheduled air capacity from the U.S. market this September through December with approximately 140,000 additional inbound seats available across carriers. This figure represents a 19% growth over the same period in 2022 and an 18% growth over 2019.

"This added capacity is a testament to the appeal of the island's tourism product as well as the excellent relationships we enjoy with our U.S. airline partners," said the Hon. Edmund Bartlett, Minister of Tourism, Jamaica. "They clearly have confidence that we can fill these seats as we are now surpassing 2019 stopover arrivals and on track for a full recovery in those annual figures for 2023."

The most significant increases in inbound seats year-over-year for the fall period can be attributed to: American Airlines' extended service from Dallas and Chicago as well as additional frequencies from Charlotte; United Airlines' extended service from Chicago; additional frequency from New Jersey and new service from Denver; and Southwest Airlines' additional frequencies from Baltimore and Orlando plus new service from Kansas City.

"As we return tourism arrivals to growth, new routes, larger planes and more available seats from our valued airline partners are critical to achieving that goal," said Donovan White, Director of Tourism, Jamaica Tourist Board. "We are very grateful to all carriers that have increased service to Jamaica and look forward to continuing to work together throughout the years."

For the summer travel season, the U.S. market accounts for 1.2 million of the 1.4 million airline seats that were secured for the period, representing a 16% increase over the island's previous best year, recorded in 2019. The U.S. remains Jamaica's top source market for visitors, representing approximately 75% of the island's total arrivals.

US COMMERCE SECRETARY WRAPS UP CHINA VISIT WITH COMMITMENTS FOR MORE TALKS

U.S. Commerce Secretary Gina Raimondo wrapped up a four-day visit to China on Wednesday in the latest move by U.S. President Joe Biden's administration to stabilize commercial and trade links between the world's two largest economies.

In public remarks Wednesday, Raimondo said that she is hopeful about holding regular and direct talks with Chinese officials, but that she is "very clear-eyed" and does not expect every issue with Beijing will be resolved "overnight."

Earlier in her visit, she said American companies

told her that China's unlevel playing field and unpredictable regulatory environment with steep penalties have made the country "uninvestible."

Raimondo said the two sides planned to hold meetings with technical experts to talk about disputes over protecting trade secrets as well as sharing information about export controls.

"We are not returning to the days when we had dialogue for dialogue's sake, but shutting down communication and de-coupling services is neither in our economic or national security goals," Raimondo told reporters during a phone briefing.

While the United States and China maintain more than \$700 billion in annual trade, escalating tensions in recent years have made it more challenging for U.S. firms to operate in China.

"I did mention that my own emails had been hacked," she said, "and I mentioned that as an example of an action that erodes trust at a time that we are trying to stabilize the relationship and increase channels of communication."

U.S. officials have said Washington is not seeking a "de-coupling" with the Beijing government, but focusing on "de-risking." Biden signed an executive order earlier this month to restrict U.S. investments in some sensitive and high-tech industries in China, including in semiconductors, microelectronics, quantum computing and certain artificial intelligence capabilities. In Beijing, Chinese officials said the United States was engaging in "de-coupling" under the guise of "de-risking." China's Ministry of Commerce said in a statement on Aug. 10 that the U.S. decision "seriously disrupts the security of global industrial and supply

The two countries have traded other restrictions in recent months.

In May, China's Cyberspace Administration banned corporations from buying memory chips from U.S.-based Micron Technology Inc., as the U.S. works with its allies to ensure that advanced semiconductor manufacturing stays out of the reach of the Chinese industry.

In March, Chinese officials closed the Beijing offices of the U.S. due diligence company Mintz Group and detained five of its employees, accusing the firm of doing "unapproved statistical work." With 18 offices worldwide, Mintz Group specializes in background checking, fact gathering and internal investigations.

Raimondo visited Shanghai Disneyland and a Boeing facility, as well as New York University's campus in Shanghai on Wednesday, after meetings with Chinese Premier Li Qiang and Chinese Vice Premier He Lifeng on Tuesday. She held meetings with Chinese Minister of Commerce Wang Wentao on Monday.

Although Raimondo agreed to

launch an information exchange on export control enforcement and a new working group on commercial issues, Congressional critics are skeptical about Washington's ability to work constructively with

Congressman Michael McCaul, a Republican who chairs the House Committee on Foreign Affairs, accused the Biden administration of being "at best naive" in starting a working group with China.

McCaul said it is a dangerous move because the Chinese Communist Party, or CCP, "steals U.S. intellectual property and hacks the emails of senior government including Secretary officials, Raimondo. The administration must stop treating the CCP as anything other than an adversary who will stop at nothing to harm our national security and spread its malign authoritarianism around the globe."

Raimondo's visit follows recent trips by other senior U.S. officials, including CIA Director Bill Burns in May and U.S. Secretary of State Antony Blinken in June, as well as separate trips by U.S. Secretary of the Treasury Janet Yellen and U.S. Special Envoy on Climate John Kerry in July.

"The Biden administration's decision to join forces with the Chinese Communist Party [CCP] to establish a working group on export controls and commercial Zheng said, "Our hope is that issues with CCP officials is at best naive, but also dangerous," he said. "The CCP steals U.S. intellectual property and hacks the emails of senior government officials

including Secretary Raimondo. "The administration must stop treating the CCP as anything other than an adversary who will stop at nothing to harm our national security and spread its malign authoritarianism around the globe,' McCaul said.

Wang Yiwei, director of the Institute of International Affairs at Renmin University of China in Beijing, said the two countries need an enhanced dialogue on trade "in the lead-up to the U.S. presidential election ... before it's too late."

"The U.S. ban on China-bound high-tech exports and investments has ended up promoting China's [tech] autonomy and innovative capabilities," he told VOA's Mandarin Service. "All these developments do not serve the

interests of [U.S.] high-tech firms."

US, China Agree to New Dialogue on Trade

U.S. and Chinese officials expressed hope for positive economic relations as U.S. Secretary Gina Commerce Raimondo met with Chinese leaders for a second day in Beijing.

Chinese Premier Li Qiang told Raimondo that "sound economic relations and trade cooperation will not only be beneficial to our two countries, but to the whole world."

Raimondo said the United States seeks to maintain its commercial relationship with China and hopes those ties "can provide stability for the overall relationship.' Raimondo also highlighted global concerns such as climate change and fentanyl addiction, saying the United States wants to work with China "as two global powers to do what is right for all of humanity.'

"The world is expecting us to step up together to solve these problems," she said.

Raimondo met earlier Tuesday with Chinese Vice Premier He Lifeng and said the United States is not looking to separate economically from China.

"While we will never of course

compromise in protecting our national security I want to be clear that we do not seek to decouple or to hold China's economy back," Raimondo said.

He Lifeng said China wants to work on "new, positive efforts to keep economic consensus and step up cooperation.'

The United States and China on Monday agreed to create two separate dialogues to reduce misunderstanding of U.S. security issues central to its tight export controls on Chinese technologies, which Beijing sees as an attempt to quash its companies.

After meetings with Chinese Wang Commerce Minister Wentao, Raimondo said the two countries will establish a working group that will include business representatives focus on commercial issues and governmental information exchange to focus on export control issues.

She told Wang Wentao that the Biden administration seeks healthy competition with China and that a "growing Chinese economy that plays by the rules is in both of our

interests."

Wang Wentao said China is ready to work with the United States to "foster a more favorable policy environment for stronger cooperation between businesses to bolster bilateral trade and investment in a stable and predictable manner."

He said U.S.-China economic relations are important not just for the two countries, but also for the rest of the world.

Wendy Cutler, vice president at the Asia Society Policy Institute (ASPI), told VOA Mandarin via email Monday, "Establishing two new U.S.-China working groups is an important step in ensuring that the respective staffs of both commerce ministers will continue to engage beyond this week's China visit by Secretary Raimondo."

"The difficult part will be keeping Chinese expectations in check on the export control enforcement information group, achieving meaningful outcomes in the commercial group to address U.S. business and worker concerns," Cutler said.

Zheng, president of Eric

AmCham Shanghai, told VOA Mandarin in a telephone interview Saturday that he sees the step as a very positive expression.

the two governments will continue to engage in discussions. We are hopeful and at the same time we would like to share our out of the ground perspective, what's going on in China, to provide her with more active, more nuanced understanding of the local market. It's not black and white. There are opportunities for sure and most of our companies are doing well in China and they hope to continue to grow in this strategic market."

"At the same time, there are issues, challenges that we faced with, such as a lack of transparency, IP protections, Iack of a level playing field. So, there are challenges that we would like to share with the secretary as well," he noted. Raimondo is scheduled to visit Shanghai on Tuesday. Her China visit concludes Wednesday, August 30.

Sprinter Adaejah Hodge: 'God really blessed me this year'

Just 17, Adajeah Hodge had a season like no other woman in BVI track and field history at her age. First, she ran an indoor record 22.33 seconds in the 200m. Outdoors, she claimed a pair of Tahesia Harrigan-Scotts' 100m/200m national records that stood since she was a year old, when she scampered 11.11 and 22.60 seconds respectively. Hodge became the territory's youngest World Athletics Championships qualifier ever, and advanced to the 200m semifinals after running 22.82 seconds and then ran 22.96 in the semis.

"I would say it's God's blessings because of all of the things that I achieved, last year I wasn't expecting to achieve all these things," she said. "God really blessed me this year. I hope the plan that he has for me continues to grow and continues to strive."

Hodge said her biggest surprise this year was the 22.33 sees she ran indoors over 200m, as she told her coach that her aim was to run 22.80, but then ran 22.70 in the prelims. "Crossing the line and seeing 22.33 was God's blessing," she told Island Sun Sports. "It was unbelievable."

Hodge said her World Championships experience went very well and she's proud of herself for stepping out on the big stage.

"My favorite part of the experience was definitely the lights and actually being in a lane at the World Championships," she said. "Both of my runs weren't my best runs—I was hoping to produce a little bit more. I wished I executed my

race better but I'm still proud of myself for coming out here and giving it my all."

She has had a very long season leading into Worlds and she said she thought that she handled it well. She noted most athletes now and even in the past, get tired and mentally drained from the sport. "But I really love this sport, so I knew I had a goal," she said. "I knew I wanted to go to Worlds, I just reminded myself, that's what I started this season, even though it was long and even though I didn't perform the way I wanted to, I'm so proud of myself for keeping my mind right to come out here and compete."

Hodge said she's taking away the experience being on the big stage, which is quite different to seeing it on television. She said now that she has been there, knows what the atmosphere is like as well as going through

the rounds, she'll be going back into the lab and will be training to run better rounds.

"I definitely have to mature a little bit more. I'm still 17, I'm still growing," she noted.
"Right now it's to just stay



Most Common Cause Behind Teary Eyes Are Dry Eyes

DEAR DR. ROACH: I am a 74-year-old woman who loves to read the newspaper every morning. I have a problem that's not serious, just annoying. My eyes tear up frequently while I read, causing me to wipe them. After I'm done reading, the problem stops. I see my ophthalmologist every year and have my vision glasses updated as needed. I am not yet a candidate for cataract surgery. Could you enlighten me about a probable cause for this irritating problem? — A.H.G.

ANSWER: By all means, ask your ophthalmologist at your next visit, but the most common cause I see for watery, tearing eyes are ... dry eyes! This apparent paradox is caused by the fact that your eyes have three different fluids.

One of them, called meibum, is a long-lasting, oily material secreted by the meibomian glands, found around the edges of the cyclids near the eyelashes. This covers the eye and prevents fluid from evaporating quickly. Without this fluid, the lacrimal gland (near the temple above each eye) then has to make a lot of its watery secretions, which cause symptoms of tearing.

Most commonly, the meibomian glands get clogged up by secretions becoming dry. Gently cleansing the eyelash area with warm water and baby shampoo belps many people unclog these glands. Artificial tears lubricate the eye and will reduce the symptoms of watery eyes (and maybe some eye irritation, too, which you might not have mentioned).

DEAR DR. ROACH: I am about to undergo gallbladder removal due to recurring pain from gallbladder sludge. Should I be taking replacements for the bile salts that I will no longer be able to produce, and if so, what is the best type of replacement? — S.C.

ANSWER: Your liver makes bile salts, which are necessary for fat absorption. The gallbladder doesn't make them at all; it just stores the bile until you eat a meal, at which point the gallbladder contracts and the bile salts are released into the small intestine to help you digest fat. Most bile salts will be reabsorbed later at the end of the small intestine, recirculating them for reuse.

In people without a gallbladder, the liver itself will continuously release bile salts into the small intestine, rather than on an as-needed basis by the gallbladder. Sometimes, the ability of the terminal ileum (the part of the intestine where bile salts are reabsorbed) gets overwhelmed, and bile acids enter the colon, causing diarrhea.

This is very common in the first few weeks after gallbladder surgery, but the small intestine usually "learns" to absorb more bile salts. The colon also learns to live with bile salts, and the diarrhea mostly goes away. However, some people continue to have diarrhea after surgery, and medication to restrain bile salts (such as cholestyramine) can make a huge difference.

After surgery, avoiding a high-fat diet is prudent for a month or so to minimize the amount of bile needed.



Brick by BRICS

Last weekend, we were keeping a close eye on Zimbabwe's ongoing general election, unfolding in tandem with the 15th annual BRICS Summit in Johannesburg, South Africa. These two events demonstrate the profound shifts underway across the region.

During the two-day BRICS Summit, heads of government from emerging economies - Brazil, Russia, India, China and South Africa - gathered to discuss economic cooperation, peace and sustainable development in the Global South, Despite divisions among members, the summit shared other common themes, including how to increase their membership and global influence on a stage currently dominated by the US and its allies.

Corruption was also a topic of interest. The BRICS anti-corruption

ramp up effectiveness in recovering through public-private partnerships. They also highlighted the importance of analysing the gendered effects of corruption.

This came amidst Zimbabwe's general election, where Zimbabweans select ed councillors, parliamentarians and a president. The frontrunners, President Emmerson Mnangagwa - who's been in power since the fall of the Mugabe regime in 2017 - and opposition leader Nelson Chamisa go head-to-head in the race. Mnangagwa's government has been vocal about its support for BRICS. Members of his party, ZANU-

and condemning US sanctions.

working group discussed the need to corruption and lack of accountability.

Civil society groups and opposition stolen assets and criminal gains leaders have expressed concern about the credibility of elections, highlighting the need for them to be free and fair. Alarming reports of arrests of opposition leaders and intimidation of critics and civil society groups persist. Attempts to block the opposition's electoral campaign have not subsided, and even election observer groups have not been spared, as some have been arrested. The election day was marred by irregularities, including the lack of voting papers and late deployment at polling stations and intimidation of voters by the quasisecurity military organisation, Forever in Zimbabwe - and beyond.

PF, have gone so far as to thank BRICS Associates Zimbabwe. Additionally, members for supporting Zimbabwe last-minute boundary changes caused concern as many voters were unaware

As a result of the lack of media was also impacted. Media observers who wish to cover the elections are unstable local currency as well as required to pay an accreditation

fee, which is a slight of transparency as it hinders free and fair election coverage.

Despite these irregularities, Zimbabwe must guarantee the right to free and transparent elections. And if there is no outright winner, a run-off will be held on 2 October.

Lack of transparency in elections is a shared regional issue. Last year's Corruption Perceptions Index results showed that electoral integrity is a significant concern across Sub-Saharan Africa.

In Equatorial Guinea, President Teodoro Obiang Nguema is the world's longest-serving leader - with six terms under his belt - which international observers have criticised as unfree and unfair. And the previous elections in Kenya highlight the urgent need for public scrutiny of political financing.

At the close of the BRICS Summit, six new members were welcomed to join in January 2024. Spoiler alert: Zimbabwe was not one of them. As you read this, the counting of the votes continues in the country, and we are on the edge of our seats to learn the results. In the meantime, we remain hopeful that change is on the horizon

STOPPING THE SPREAD OF POLITICAL ASSASSINATIONS AND GANG VIOLENCE

The saying, coined by the Latin poet, Horace, that "you too are in danger when your neighbour's house is on

fire" is particularly relevant now in relation to Latin American countries which are the closest neighbours to the member states of the Caribbean Community (CARICOM).

There has been a marked increase in deadly violent incidents in Latin America, linked to organized criminal gangs. This includes the assassination of the leading candidate in Ecuador's presidential elections and the murder of two other politicians over the last month.

Fernando Villavicencio was assassinated on 9 August, eleven days before the 2023 Ecuadorian general election on August 20, at which he was polling in second place to win the presidential contest. He had a fearless and courageous stance against organized crime and corruption which have increased dramatically over the last three years. He was shot in broad daylight.

It is generally accepted in Ecuador that Villavicencio was the victim of organised criminals who feared that he would crack-down upon their activities if he won the presidency. Ecuadorian police reported 3,568 violent deaths between January and July this year. There are some neighbourhoods that police, who are outgunned, unprepared and underpaid, dare not enter.

According to the International Crisis Group (ICG), there have also been upsurges in violence in Argentina, Costa Rica, Panama and Paraguay. The ICG reports that "Even in Chile and Uruguay, long considered bastions of regional calm, crime is skyrocketing. In 2022 alone.

murders in Chile increased by 32%, reaching a record high. Similarly, incidents of rape and the illegal use of firearms rose. In Uruguay, a transit nation for cocaine smuggling, a surge in crime last year saw a 25% increase in murders. Feeding the region's epidemic of violence is the unchecked flow and circulation of illegal weapons.".

In Mexico, the number of criminal

groups doubled between 2010 and 2020. In El Salvador, over the last two years, the government of President Nayib Bukele locked up more than 70,000 persons with what has been described as "little semblance of due

process". The purpose was to eliminate criminal gangs that have tormented the country for years.

Thegovernmentsoftheneighbouring states of Honduras and Guatemala have praised the El Salvador model as one "worth emulating". And, Honduras President, Xiomara Castro, announced her own crackdown on gangs.

Both the governments of El Salvador and Honduras have been criticised for human rights abuses in relation to these responses to violence and crime. But analysts say that the security situation is "pretty dire". Therefore. although the general population acknowledges human rights abuses in El Salvador, "people are so sick of crime that they're willing to sacrifice democracy or personal freedoms if it means that they can sleep easy at night".

These events in Latin America are taking place in the CARICOM neighbourhood; it would be foolhardy to ignore them or to pretend that Latin America is some distant part of the world that matters little. Latin America envelopes the Caribbean, bound by shared waters.

Crime, particularly involving gangs linked to drug and human trafficking, knows no borders. Much like communicable diseases, it can spread unchecked across nations. Scholarly research shows that

enterprises of organized crime are far better funded and organised than the law enforcement agencies of all the CARICOM countries combined. In this connection, it is time that the Caribbean pays serious attention Latin America, not only for occasional forays into trade and tourism opportunities, but to safeguard against the spread of crime which now terrorises people and murders politicians and government officials who stand in their way.

The limited attention given to Latin America is evident in the Caribbean media's lacklustre reportage and commentary. Such events as are reported in the press, radio and television are captured from the Internet or international broadcasters such as CNN and the BBC. Consequently, the Caribbean public receives news of Latin America that CNN and the BBC deem important or relevant.

In any event, CARICOM countries cannot ignore matters in neighbouring states in Latin America, particularly as connections, through modern day technology, are being freely used by criminal elements to organise and strengthen their own networks. This begs the question concerning what structured links are there between law enforcement agencies in Latin America and CARICOM?

The Organization of American States (OAS), through several of its programmes, offers the opportunity for discussion and formulation of actions by law enforcement bodies throughout the hemisphere. However, while the OAS forum is beneficial, it should not be the only means by which the burgeoning problems of crime, gangs and violence are addressed between Latin American and Caribbean authorities.

Much more is needed; the fire is raging in some Latin American states, and it is also blazing in Haiti. The Caribbean must try to stop the spread before it happens. This requires focussed national and regional attention by governments and law enforcement agencies within CARICOM, but it also needs a structured relationship with Latin American states to learn from their experiences and to exchange information.
