Members of the Opposition clearly expressed that the government (from 2019 to present) made an error in deciding not to accept the United Kingdom Government' offer of a loan guarantee. These views were expressed during the 5 September sitting of the House of Assembly by Third District Representative Hon. Julian Fraser and Sixth District Representative Hon. Myron Walwyn.

The Opposition' views on the matter were expressed following Premier and Minister for Finance Dr. the Hon. Natalio Wheatley's disclosure

in the House of Assembly that the United Kingdom's offer of a £300Million loan guarantee is now off the table, but other discussions are ongoing.

### WHY NO LOAN **GUARANTEE**

When the VIP Administration took office in 2019 the acceptance of the UK Loan Guarantee became an extended situation that was exasperated by the fact that the Government commenced discussions on what were deemed unclear matters in the agreement.

discussions moved forward on 27 September 2019 when the Government submitted a proposal regarding the United Kingdom Loan Guarantee in furtherance of the UK/BVI discussions in London.

The views on the loan guarantee seemed only confined to the Government's side, as during the April elections campaign almost all of the opposing parties chided the Virgin Islands Party administration for dragging its feet on accepting the loan guarantee offered by the United Kingdom government the purpose of recovery and development following the two murderous category five

hurricanes in 2017.

The premise that the government should have made use of the loan guarantee was the theme of the questions on the subject that was put to the Premier by Opposition Members during Tuesday's HOA sitting.

Hon. Fraser asked the Premier if the acceptance of the UK loan guarantee was a priority of his administration; and in response the Premier informed that the time for the guarantee has ended. The BVI Leader explained "It must be noted that the loan guarantee presented following the 2017 hurricanes is no longer on the table. We are however planning to approach a financial institution with the hope of obtaining the best possible rates to assist with infrastructure development."

Britain logically wanted control over the guarantee and the manner in which funds were spent; politicians and commentators were not sure about the UK's level of control but in due course they understood that control and vigilance were a firm condition.

Following the Premier's disclosure that the offer was pulled, Hon. Fraser asked whether attempts to keep the offer were made. "Madame Speaker, wonder if the Premier is considering getting that loan guarantee back on the table," the Third District Representative questioned.

In response, to Hon. Fraser's Hon. Wheatley question announced that conversations on the matter are still taking place. The Premier stated, "As it relates to the loan guarantee we are in ongoing discussions with the United Kingdom government as it pertains to borrowing Madame Speaker." Presently the UK is having its own problems and any decision will have to be carefully evaluated by the Mother Country.

#### **GOVERNMENT** THOUGHT LOAN-GUARANTEE ACCEPTANCE WAS A BAD IDEA

Last year December the Premier explained that the Government was reluctant to accept the

UK Loan Guarantee because of conditions that were attached to that funding. Hon. Wheatley said: "The challenge that was had with the loan guarantee had to do with the conditions which [were] attached to the guarantee. I don't think that when you have somebody

who's down, they're devastated, they've been destroyed by hurricanes, you should be attaching some of the conditions that we attach to it."

While indirectly referring to the UK Loan conditions as onerous the BVI Leader alluded that the agreement was akin to selling one's soul. "So yes, we want to borrow, but we don't want to sell our soul, to borrow, and we don't want to sell out the Virgin Islands to borrow. We're going to borrow on terms which are fair," he stated. "Of course, you borrow your money,

you have to pay back, plus interest. We'll look for the best rate possible, and that's really the only conditions which are practical and make sense; not lots of other things that have nothing to do with the loan itself."

### DERELICT VEHICLES CAUSE SUBSTANTIAL FINANCIAL BURDEN ON GOVERNMENT

Government-is considering the introduction of a vehicle disposal fee in response to growing concerns over the mounting costs associated

with the management of derelict vehicles in the Territory. According to statements made by Minister for Health and Social Development, Hon Vincent Wheatley the proposed fee is part of the medium and long-term strategies the government is currently considering.

This revelation came in response to a question posed by Third District Representative and Opposition Member, Hon Julian Fraser, RA, during the Continuation of the Second Sitting of the First Session of the Fifth House of Assembly in Road Town on 5 September.

Hon Fraser sought details regarding the Minister's immediate and long-term plans for managing derelict vehicles within the Territory.

Hon Wheatley emphasized that the Department of Waste Management currently oversees the ongoing task of collecting derelict vehicles. He also noted that each year, funding is allocated to specific subheads to cover the expenses related to the derelict vehicle program.

He elaborated: "However, has become increasingly burdensome cost for the public, as individuals are not required to bear any expenses for disposing of their vehicles, nor do they contribute to the costs once their vehicles have reached the end of their useful life. This situation needs prompt attention, Madam Speaker, to alleviate the government's financial burden in disposing of derelict vehicles."

Hon Wheatley disclosed that the mediumterm plans involve revitalizing a partnership with the Department of Motor Vehicles (DDM) to gather vital information, such as addresses, phone numbers, and owners' names of derelict vehicles within located Territory. This initiative would also encompass enhancements to existing systems, enabling the use of vehicle identification numbers (VINs) to access owner information in cases where stickers or plates are unavailable.

"We will maintain close collaboration with the Royal Virgin Islands Police Force to address vehicles left on the roadside, obstructing traffic, abandoned in public parking areas, damaged due to accidents, or involved in fires," Hon Wheatley added. "When deemed appropriate, vehicles falling into these categories may be subject to impoundment, with owners required to pay retrieval fees."

Concerning longerterm plans, Hon Wheatley stressed the need to reduce the prevalence of derelict vehicles in the Virgin Islands. He suggested that the government should explore options such as imposing a ban on foreignowned vehicles exceeding a specific age or threshold or implementing higher import taxes on such vehicles.

Furthermore, underscored the importance of implementing a disposal fee, which would discourage vehicle owners from abandoning unwanted vehicles on private or public property. Hon Wheatley emphasized the substantial financial burden incurred by the government in the collection, processing, and exportation of derelict vehicles from the islands.

### PROSPECT REEF IS A TOP PRIORITY: PROPOSALS PURSUED

Premier and Minister Finance, Wheatley, Natalio expressed his strong commitment to the revitalization of Prospect Reef, emphasizing its significance as a top priority. He eagerly anticipates the issuance of a Request for Proposal in 2023. During the 5 September sitting of the House of Assembly (HoA), Premier Wheatley

shared the government's vision, stating: "Madam Speaker, the Government's vision is to establish a branded hotel with much-needed conference facilities. As the term of the Board's membership expired, we have initiated the process of appointing a new board, and one of its key mandates will be to issue a request for proposal for the redevelopment of Prospect Reef."

The questions relating to the Prospect Reef Resort were posed by Leader of the Opposition Hon Ronnie Skelton. In his response Premier Wheatley told the House of Assembly: "Madam Speaker, I believe it was just last Thursday that [the] time for persons to apply to the Board expired."

Hon. Wheatley also mentioned that Government entities are currently in the evaluation phase, as it relates to the constitution of the Prospect Reef Board. The Premier also disclosed that once the Board is formed, its primary focus will be to release the Request for Proposal for the revitalization of Prospect Reef.

"So it's a priority for me, and I would like to see a Request for Proposal issued before the end of the year, Madam Speaker," the Premier further added.

Back in May Hon. Wheatley provided an update on the Prospect Reef property and first mentioned that government intended to invite bidders to submit their proposals for the development of the resort.

The Premier at the time stated: "Very soon, I'll be engaging the Prospect Reef board on issuing a Request for Proposal for development. We see Prospect Reef as a hotel that can offer convention centre services to our business community and assist in hosting meetings, conferences and so on. So Prospect Reef is a very big part of what we are intending

to do and the public should see a Request for Proposal very soon."

He further stated that once the bidding process commences, the Prospect Reef Board will be tasked with considering the submitted development proposals in order to consider the right bidder for the development arrangement.

"When the Request for Proposal goes up, anyone who is interested will be able to put forward a proposal and they'll have a fair and transparent process to select a proposal," Hon. Wheatley noted.

### **BVI IMPORTATION OF TEACHERS QUITE SATISFACTORY**

Following multiple rejections from foreign educators, Minister of Education Hon. Sharie de Castro has unveiled strategic roadmap bolster the local to workforce, with the ultimate aim of reducing the Territory's dependence on expat teachers.

Speaking before the House of Assembly (HOA) during the 5 September sitting, Hon. de Castro acknowledged the persistent global shortage of teachers as an ongoing challenge. However, she remained optimistic, citing the forthcoming compensation review catalyst as a for anticipated changes and an opportunity to seek additional funding in the upcoming budget cycle.

While the Ministry explores potential regional collaborations (Jamaica?) graduates attract interested in overseas teaching opportunities, the Education Minister underscored-the government's unwavering commitment to expand the local teaching talent pool and diminish reliance on foreign educators in light of the global teacher shortage.

The Education Minister candidly shared with her fellow lawmakers that the teaching profession had witnessed a significant exodus, citing factors such as meager salaries, heavy workloads, and resource constraints.

In-a-surprising revelation, lawmakers learned that the Education Ministry faced unprecedented number of rejections when extending recent job offers. The primary reason cited by candidates was dissatisfaction with the offered compensation packages.

The Education Minister also disclosed that the commencement of the new school year

required approximately 60 additional teachers to achieve a full staffing complement. She noted that the Ministry had prioritized recruitment efforts in recent months, resulting in the successful filling of most vacant positions.

The-Teaching Service-Commission recommended the hiring of 44 applicants, with 38 already in their roles and the remainder scheduled to join the Ministry by

mid-September.

Consequently, around 15 teaching positions remained-vacant, comprising six at the primary level and an additional eight at the secondary level.



### Statement by Honourable Vincent Wheatley on World Alzheimer's Month

"World Alzheimer's Month" For September, the Virgin Islands' community joins the rest of the world in observing World Alzheimer's Month. The observation of World Alzheimer's Month is being spearheaded by Alzheimer's Disease International to raise awareness of dementia and to help address and eliminate the stigma associated with the disease. Dementia is a degenerative brain condition that robs a person of their memory, competency, comprehension and behavioural awareness, usually slowly, over years and Alzheimer's disease is the most common cause of dementia.

This year, the focus for the World Alzheimer's Month campaign is "Never too early, never too late". This year's campaign hopes to underscore the pivotal role of identifying risk factors and adopting proactive risk reduction measures to delay, and potentially prevent the onset of dementia. This includes ongoing risk reduction strategies for persons who have already received a diagnosis.

Currently, there is a paradigm shift worldwide regarding the perception of Alzheimer's disease and doctors and patients are beginning to understand that Alzheimer's disease and other dementias can start many years before symptoms start to become apparent. Nonetheless, with the global number of people living with dementia expected to triple by 2050, there is a greater need for a more urgent understanding and response to the risk factors associated with this condition.

According to the World Health Organization, more than 55 million people have dementia worldwide with over sixty per cent of them living in low and middle-income countries. Through the National Health Insurance's database, the Virgin Islands Alzheimer's Association found that 188 persons in the Virgin Islands have been officially diagnosed with dementia. Data statistics from Alzheimer's Disease International estimates that worldwide, roughly 75% of dementia cases go undiagnosed. Therefore, it can be reasonably estimated that the number of persons living with dementia in the Territory goes above 300.

There is no current cure for Alzheimer's and given the

as a community must use this year's theme "Never too early, never too late" as a guiding principle for our perception of Alzheimer's disease in the Virgin Islands. We must examine all our personal risk factors and find different strategies to mitigate our risk. New research from The Lancet Commission, a medical journal, indicated that twelve main risk factors over our lifetime can cause dementia and modifying these risks could prevent or delay up to forty per cent of dementia cases. However, it takes advocacy, partnership and the collaboration of public, private and Non-Governmental Agencies to tackle this disease and educate our community, thus slowing prevalence rates within the Virgin Islands so we can keep these numbers from drastically rising

Here are some risk reducing tips:

Consume less alcohol and cease smoking.

Maintain physical activities.

Have your hearing checked regularly and use hearing aids if necessary.

Avoid serious head injuries and take care in sports and motorbike riding from an early age.

Ensure that all children have access to education and the support and knowledge to maintain a healthy weight through nutrition and exercise.

Improve sleep and maintain a healthy lifestyle for both brain health and overall well-being.

Monitor all noncommunicable diseases.

The Ministry of Health and Social Development through its Aged Care Services continue to provide services that can be accessed by people suffering

from Alzheimer's disease. We currently have the East End/ Long Look and Carrot Bay senior programmes which are supervised programmes that promote the socialization of senior citizens with their peers. Studies have shown that feelings of loneliness and social isolation can be common among persons suffering from Alzheimer's disease and other types of dementia. This can further increase symptoms of conditions like depression and anxiety which can lead to a faster cognitive decline.

In addition, the Social Development Department also provides Home care services for elderly persons, which can be accessed by families of persons with Alzheimer's disease. With this service, the Department provides the highest quality services and care in the client's residence. This augments the care and services provided by our local hospitals, communitybased clinics and other health care facilities. Although we continue to do work to help members of our society who suffer from Alzheimer's, there is still a long way to go to properly educate the population on the far-reaching impacts of Alzheimer's.

So, this September is an opportunity for individuals, businesses and charities to hold events and raise awareness in their communities of the effects of dementia. World Alzheimer's Month presents an invaluable opportunity for individuals by affected Alzheimer's, caregivers, professionals, governments, media partners, and communities to collaborate in the fight against dementia. It serves as a platform to raise awareness about the true challenges of dementia, counteract stigma misinformation, and advocate for improved support and care.

I encourage the entire Territory to engage in the events organized by the Virgin Islands Alzheimer's Association, in partnership with the Rotary Family of the BVI and the Lions Clubs of the BVI. These activities are also being carried out in collaboration with the Diabetes Association, Sister Islands District Office, and the Social Development Department throughout World Alzheimer's Month.

Together, we can raise awareness, reduce the risks and eliminate the stigma!

### CARICOM Secretary General urges Innovation, Collaboration in Regional Fisheries Sector

Dr Carla Barnett, Secretary General of the Caribbean Community (CARICOM) has called on fisheries stakeholders to invest more in research and innovation so that countries

in the Region can gain maximum benefits from marine living resources.

In opening remarks to the 20th Anniversary Scientific Conference of the Caribbean Regional Fisheries Mechanism (CRFM) held virtually on Monday 28 August, the Secretary General said that applying knowledge and technology in fisheries and aquaculture will help to create value from unutilized or underutilized marine living resources.

"The health of the coastal and marine ecosystems, and the well-being of our people, are integrally connected," she emphasized. "We need to better understand the complexity of our marine ecosystems and enhance their economic and social contribution to our communities and countries that depend on them."

She called on fisheries stakeholders to work together to make use of the best available scientific data and information to guide decisions about fisheries development and conservation.

Dr Barnett also highlighted the numerous obstacles and setbacks that the Caribbean's fisheries sector continues to experience. "Climate change, ocean acidification; overfishing; pollution; the invasive pacific lionfish; illegal, unreported and unregulated fishing, all place immense pressure on our marine fisheries and ecosystems. They also threaten the jobs and livelihoods of fisherfolk and the food security of our people," the CARICOM CEO outlined.

She noted the valuable efforts of the CRFM, and its predecessor, the CARICOM Fisheries Resource Assessment and Management Programme (CFRAMP), nurture to a sustainable sector empower fisherfolk participate regional in planning and decisionmaking.

"The CRFM's work has advanced CARICOM's agenda for the Region, including our strategic focus on developing our women and young people," she said.



JAMAICA - One persistent of area postindependence Jamaica lies in the area of sports, especially over the past two decades.

In earlier years, Jamaica was accustomed to occasional brilliant individual achievements by few athletes in track and field events at various Olympic meets. However, more and more Jamaican athletes have impressed in recent years. Today, Jamaica is among the strongest countries in sprint events at international track and field meets, including the Olympics. Furthermore, Jamaican sportsmen and women are excelling in other sports like soccer, netball, swimming, and even ice-hockey.

Despite the impressive success of Jamaicans in international sport tournaments, development of sports in Jamaica isn't administered by a dedicated ministry of Rather, the sports sports. ministry is attached to other ministries. Currently, under the administration of Jamaica's government, the sports ministerial portfolio is included in the super-ministry of Sports, Culture, Entertainment, and Gender Affairs. In former administrations the sports portfolio was attached to the Ministry of Education or other ministries. [CNW]

ROME - Democratic Party (PD) leader Elly Schlein said Sunday that her centre-left group will oppose Premier Giorgia Meloni's government with vigor while, at the same time, taking the opportunities that may arise to influence policy. "We are rooting for Italy and we want to have a pragmatic approach to the government but a tough one too," Schlein said at the annual Forum Ambrosetti in Cernobbio. "For example, we'll make sure we look at how we can intervene in the next budget law". She also pledged to press ahead with the bill the PD has presented with other opposition parties to introduce a minimum wage of nine euros an hour in Italy.

Former industry minister Carlo Calenda, the leader of the opposition, centrist Azione party, told the forum that Meloni"s government had followed in the footsteps of her predecessor Mario Draghi's executive when it came to fiscal policy.

"The Meloni government's first budget law was responsible in terms of the final balance," Calenda said. "Meloni put on Mario Draghi's clothes". (ANSA).

with instructions that lawmakers should draw a new congressional map.

A Florida redistricting plan pushed by Republican Gov. Ron DeSantis violates the state constitution and is prohibited from being used for any future U.S. congressional elections since it diminishes the ability of Black voters in north Florida to pick a representative of their choice, a state judge ruled Saturday.

Circuit Judge J. Lee Marsh sent the plan back to the Florida Legislature with instructions that lawmakers should draw a new congressional map that complies with the Florida Constitution.

The voting rights groups that challenged the plan in court "have shown that the enacted plan results in the diminishment of Black voters' ability to elect their candidate of choice in violation of the Florida Constitution," Marsh wrote. [El Pais]

CAYMAN **ISLANDS** Closed-door trials - where the public, media and even the complainant in the case are excluded so government can show secret evidence - could soon be permissible in the Cayman Islands.


Draft legislation, published week, creates framework for civil trials to be held in secret if the evidence is deemed to impact national security.

The Civil Proceedings (Closed Material Procedure) Bill would give Cayman courts the power to review classified material without government having to disclose it to any other party in the proceedings or the public.

Similar legislation has proved highly controversial in the UK, where the balance between open justice, the rights to a fair trial, and the state's need to keep certain evidence under wraps is an ongoing debate. [Cayman Compass]

Addressing concerns and implementing solutions



Despite the decline numbers, 25,000 teachers remain employed within the education system.

Several schools recently advertised vacant teaching positions, to which Williams responded by introducing a job portal. This portal simplifies the advertisement of vacant roles and provides aspiring educators with the necessary information to apply for jobs.

In an effort to aid schools with the recruitment process, the Education ministry dispatched various strategies weeks in advance of the academic year.

Schools received preapproval to make early recruitment decisions, with the green light given for engaging part-time teachers, retired educators, and pre-trained graduates in their final year of study. [CNW]

### Ladyburd Talks...

Dear Readers: Help Stop Bullying- Watch for Bullying Indicators now that school is back in session.

Be sure you are able to recognize the most common types of bullying as well as cyberbullying indicators. Also, be aware that boys and girls often bully differently. For instance, boys may resort to physical bullying and girls are more likely to use relational bullying like ostracizing another student.3

Look for what is called "gateway indicators." These are initial behaviors that students display that are often gateways for more intentional types of bullying. Some possible gateway indicators include rolling eyes, laughing under their breath, making jokes, turning their back on others, and using sarcasm. If you see these behaviors, look a little closer. There may be subtle forms of bullying taking place already.

#### **Empower Student Bystanders**

Strive to empower the bystanders in your class. Encourage them to stand up against bullying behavior or to report it to you or another adult. Remind them that research has shown that bullying ends when one person takes a stand.4 Then provide safe and confidential ways that they can report bullying incidents.

#### Keep Your Ear to the Ground:

Victims of bullying are often afraid or embarrassed to come forward. As a result, you may need to rely on other students to let you know when bullying is occurring. Identify your class leaders early in the school year and check in with them. Let them be your eyes and ears when you cannot be present.

Also, be sure you make it safe for them to alert you of potential issues. No student wants to be called a snitch. So, make sure you implement ways for them to get information to you without the rest of the students knowing who it came from





1/2 cup (one stick) softened butter



## Climate shocks displace close to two million children in Sub-Saharan Africa

Save the Children is working to ehance prevention, preparedness, support and recovery from climate disasters to protect the youngest in emergencies. The NGO is calling on world leaders to address the crisis at the continent's first climate summit running until 8 September in Nairobi, Kenya.

In 2022 the total number of sub-Saharan African children internally displaced within their own countries almost doubled, according to data from the Internal Displacement Monitoring Centre, an NGO that monitors and provides information and analysis on internally displaced people around the world.

The rising numbers require urgent action according to Save the Children, a charitable organisation that has been working alongside young children for over a century now. The NGO says that at the end of 2022, at least 1.85 million children in Sub-Saharan Africa were displaced in their own countries due to climate shocks. The consequences of climate disasters affect health, agriculture, security, housing and work. According to the World Health Organisation, climate change represents the greatest health threat to humanity.

### ALARMING NUMBERS IN NIGERIA AND SOMALIA

Floods in Borno State and other parts of Nigeria caused the number of internally displaced persons (IDPs) due to these disasters to increase threefold over the previous year: from 2.6 million in 2021 to an estimated 4 million in 2022. By the end of 2022, at least 854,000 people remained displaced, including an estimated 427,000 children.

Somalia in contrast has missed five rainy seasons affecting 6.6 million people, 39% of the population now with critical levels of hunger. The country has the second highest number of internally displaced persons (IDPs) at 1.1 million.

These alarming numbers highlight how childrens' livelihoods throughout the region are being undermined by disasters due to the climate crisis and resulting extreme weather events, and as Save the Children states, this despite African countries having contributed least to the root causes with the lowest share of global greenhouse gas emissions.

"CLIMATE REFUGEE" CONCERNS GROWING while working with partners to help communities processing to Save the Children, the emergence of the prepare for and prevent the worst possible impacts.

El Niño weather pattern known to contribute to the generation of extreme meteorological events, the numbers of internally displaced persons are likely to increase 2023. In Borno State in northeast Nigeria, floods forced more than 30,000 people to leave their homes in 2022.

A 13-year-old girl, given the fictitious name of Falmata, recounts her experience: "Life was hard. We got separated from family members and never heard from them again. We found a small room to shelter but the structure was very bad because it had been ruined by rain. The ceilings are leaking and some parts of the room are open. When I see the clouds, I am afraid and I am

reminded of the floods."

### SAVE THE CHILDREN'S APPEAL

At the Africa Climate Summit taking place from 4 to 8 September in Nairobi, Kenya, leaders of African countries are sharing their experiences and voicing their concerns.

"Falmata's experience with last year's floods is all too common," says Vishna Shah, Director of Advocacy, Communications, Campaigns and Media at Save the Children's regional office for West and Central Africa. "In Nigeria and across the region, many children are terrified. They cling to survival as they move from one extreme weather event to the next, unsure if the unseasonal rains are a blessing for failing crops or if they will wipe out their homes. Children have done nothing to cause this crisis," concludes Vishna Shah, "and they need the international community to uphold its climate finance commitments, including resources for adaptation measures to address loss and damage, and to ensure that these take into account the specific needs of children."

For children, losing their homes means losing access to health care, education, food and security. Save the Children's interventions to combat the climate crisis globally include supporting children and their communities in preventing, preparing for and recovering from climate-related disasters. The charitable organisation is also actively monitoring forecasts and potential risks in all regions, while working with partners to help communities predict, prepare for and prevent the worst possible impacts.

### **Shelter Classifications**

**Primary shelters** can provide refuge during and after a hazard like a storm or earthquake and are equipped with generators as well as facilities for shelterees to cook and bathe. **Secondary shelters** can provide refuge during and after a hazard but don't have as many of the facilities as a primary shelter and would house shelterees for a shorter period of time. **Tertiary shelters** can provide refuge after a hazard and would only host shelterees temporarily.

These facilities have been inspected by the Department of Disaster Management, the Environmental Health Division, and the Public Works Department in keeping with the BVI Emergency Shelter Manual.

### Statement by Sir Ronald Sanders, Ambassador of Antigua and Barbuda

At a Meeting of the Permanent Council of the Organization of American States

On Tuesday, 5th September 2023 on "In Remembrance of the 50th anniversary of the coup d'état in Chile"

We, the representatives of our Governments, on this Permanent Council of the Organization of American States, are custodians of democracy, peace, human rights and development in our hemisphere.

It is a grave responsibility, and we must always recall the importance of our task and how much the peoples of our countries expect us to defend and uphold their rights and freedoms.

Today, we collectively remember - and reflect - upon a dark day in the history of the Americas—the coup d'état in Chile on September 11, 1973.

It led to the overthrow of the democratically elected government of President Salvador Allende.

This event shook not only Chile but the very foundations of democracy and the rule of law in our hemisphere.

For a great many people all over the world, President Allende was a beacon for social justice, economic reform, and democratic values.

His life was abruptly and tragically cut short, and so, too, was freedom and justice in Chile.

I recall the words of President Allende spoken in his final radio address to the Chilean people on the day of the Coup.

He said: "I have faith in Chile and its destiny. Other men will overcome this dark and bitter moment when treason seeks to prevail. Keep in mind that, much sooner than later, the great avenues will again be opened, through which will pass free men to construct a better society." But while te coup d'état prevailed, there were widespread human rights abuses, thousands of disappearances, and a regime that stood against the values we cherish today.

To ensure that such an event does not fade into the annals of history, unnoticed and unacknowledged, my delegation fully supports the establishment of a permanent symbol in the OAS headquarters, recognizing President Allende.

We are aware that this will also be a remembrance of all those who lived in fear and suffered under the subsequent autocratic rule in Chile, and a reminder to all our nations of the dire consequences of standing silent when democracy is assaulted.

Our Council should use this occasion to reaffirm our commitment to the enduring values of democracy, human rights, and the rule of law.

Let us honour President Allende and the countless others who have fallen in the struggle for these ideals, let us also resolve never to allow history to repeat itself.

### Blinken in Ukraine for Two-Day Visit Amid Russian Airstrikes

U.S. Secretary of State Antony Blinken is in Kyiv on an unannounced two-day visit, his fourth to Ukraine since Russia invaded the country in February 2022.

Blinken is expected to meet with Ukrainian Foreign Minister Dmytro Kuleba, Prime Minister Denys Shmyhal and President Volodymyr Zelenskyy to hear their assessment of their needs for the ongoing counteroffensive against Russia and the coming winter.

"We've seen good progress on the counteroffensive (inaudible). We want to make sure that Ukraine has what it needs not only to succeed in the counteroffensive but has what it needs for the long term to make sure that it has a strong deterrent, strong defense capacity so that, in the future, aggressions like this don't happen again," Blinken said ahead of his talks Wednesday. Blinken is likely to announce a new package of U.S. assistance worth more than \$1 billion, a senior State Department official told reporters on the trip.

Several hours before his arrival, Russia carried out airstrikes on Kyiv and the southern region of Odesa. No casualties were reported in the capital city, but Ukrainian officials say a civilian was killed and port infrastructure damaged in the south.

The State Department says Blinken intends to demonstrate ironclad U.S. support for Ukraine, and to coordinate with leaders there ahead of the United Nations General Assembly in New York next week, where Washington will lead the push for continued support for Kyiv.

President Zelenskyy tweeted that he has been meeting with his top staff to make plans for winter, and in his words, "anything the terrorist Russian state might do."

Russia has accused the United States of prolonging the war by supporting Ukraine, amid reports that Moscow faces a serious shortage of weapons and ammunition.

A senior State Department official traveling with Blinken was asked by reporters about Russian President Vladimir Putin's reported plans to meet with North Korean leader Kim Jong Un in the coming days in Vladivostok to ask for weapons and ammunition.

The official told reporters: "It

speaks to Russian desperation that they have to go scrounging for stuff in Pyongyang, you know, and that Putin has to fly half all the way across his country to meet another autocrat."

The State Department official compared that with the coalition that supports Ukraine, at some 50 countries around the world.

### Indian Capital Dresses Up for G20 Summit

Bright murals on city walls, freshly paved roads, illuminated monuments and fountains and tall new statues that showcase India's cultural heritage will greet delegates arriving for the Group of 20 summit to the Indian capital New Delhi.

Even as Delhi is dressed up as never before, massive security measures will turn the city into a virtual fortress for the weekend summit with tens of thousands of police, paramilitary and commandos deployed along its streets, borders and at hotels that will house presidents and prime ministers. Anti-drone systems will deter aerial threats.

During its G20 presidency, India has tried to boost its global stature and authorities want the city of over 20 million to showcase a rising power.

Earlier this year, Delhi's Lieutenant Governor, Vinai Kumar Saxena, said the G20 summit was an opportunity to show "the best face of India."

The summit meeting will be held at a revamped convention and exhibition center, named Bharat Mandapam, in the heart of New Delhi. Thousands of potted plants and flowers bedeck sidewalks along roads that VIP motorcades will zip by.

Cutouts of large monkeys called "langurs" have been installed to scare away smaller monkeys, a routine menace in the city. Workers are dowsing mosquito breeding sites with insecticides in a city where dengue cases have been reported in recent months.

The "beautification" drive, that carries a price tag of millions of dollars, is not without controversy.

Several demolition drives in recent months have bulldozed shanties, displacing hundreds of low-income workers. Authorities have denied any link between the demolitions and the G-20 summit, and said they were carried out against "illegal encroachers." The government said they will help those who lost their homes.

But rights activists point out that these tenements had existed for decades.

"It is an attempt to conceal the poverty that is visible — that is why there was a frenzy of demolitions," said Harsh Mander, a prominent rights activist. "That is because these shanties are a reminder of the fact that in the midst of India's economic growth, huge levels of poverty persist. It is a sanitized version of the city that is being projected."

The city's homeless who live under bridges and sleep on footpaths have been shifted to

shelter homes, according to local media.

Many pavement vendors who plied their trade along major roads have been moved to inner lanes. The opposition Congress Party has demanded financial compensation for street vendors, weekly market traders and others whose livelihoods will be affected by the summit restrictions.

"Since the last two days, I was asked to set up my cart in a lane about 150 meters away from the main road. But customers don't come inside," said Devki Nandan Pant, a street vendor who sells "kulfi", an Indian version of ice cream in a South Delhi neighborhood. "It is creating a lot of hardship for people like us."

Delhi's usually crowded streets will be largely silent around the G20 venue with stringent traffic restrictions making it out of bounds for most citizens. Major markets in the vicinity of the convention center, schools and colleges have also been ordered shut from Friday. Offices have been told to work from home.

Many residents are simply leaving the city, choosing to take a break rather than navigate the restrictions.

New Delhi resident Vishaka Talreja took a flight on Wednesday to Kashmir with her family. "Everything will be shut down including food deliveries, so what would we do in the city? We left today itself because I thought it is better to leave before airport security etc. also becomes very stringent or flights get cancelled."

The grand showcasing of the G20 summit is not just meant to underline India's ambitions as a rising power, which wants to emerge as the voice of what it calls the "Global South" or developing countries.

It is also expected to give Prime Minister Narendra Modi a boost domestically ahead of next year's general elections. India's G20 logo features a lotus, the symbol of Mr. Modi's Bharatiya Janata Party —

posters have been plastered along roads, not just in Delhi, but in other cities that hosted a series of G20 events in the past year.

Political analyst Rasheed Kidwai pointed out that G20 summits, whose presidency rotates between members, have been held for many years but have never been scaled up to the level as they have been under India's presidency.

"Among Modi's biggest backers are the great Indian middle class and urban India. For them, this grand showcasing and fanfare projects the image that we have arrived on the international high table. So, taking the G20 summit from a somewhat routine event to a high profile one does yield political dividends domestically also," he

### Softball title repeat for Pirates and 3-peat for Synergy

Pirates Manager Austin "Woody" Maduro, said it was a "sweet victory" for his team and it means a lot. "Our first year we came in, this team (Power Outage) won the championship, we won one game and lost 13," he reflected. "And for the last two years, we've won 13 and lost each year. So, it just shows our team, our workout is improving us. We're not going to stop working out and we're coming for the next one next year again."

#### Synergy 3-peats

Smith said that Synergy is a superior to any of the Women's teams. "The team is like a family," he said. "When I call on them they answer, so I didn't expect anything different."

Smith repeated both women and men's titles he won last year. "They don't want me to retire, but I think I can retire with this," he said.

Sparks Captain Anecha "Spicy" Graham, said her debutant team wanted to end Synergy's streak. "We didn't get them this year, but next year for sure," she said. "We have a plan to work out from October, because Synergy is the

### Spinal Cord Injury Misdiagnosed as Blood Pressure Stroke

DEAR DR. ROACH: Have you ever heard of a "low blood pressure stroke"? That was my husband's (incorrect) diagnosis several years back when he suddenly could not move his arms and legs. He was told that not enough oxygen was getting to his spine. (His blood pressure is historically low, usually around 90/60.)

That lasted about seven months, and he was bedridden the entire time. He then went to a neurosurgeon and was (correctly) diagnosed with a spinal cord injury. He had C1-C2 surgery and had use of his limbs the next day. After months of physical therapy, he regained a lot of function.

We've never heard of that diagnosis before or after his experience. Does it really exist? — E.S.K.

ANSWER: The brain has tremendous ability to regulate its own blood flow under a very wide range of blood pressures, but there are some limits. When a person is used to very high blood pressure levels, such as 200/110 for months or years, a sudden drop to 90/60 (or even 120/80 sometimes) can cause a stroke. That's the main reason we don't lower blood pressure too quickly in people who have had very high blood pressure levels for a long time. It takes weeks or months for the brain to recover its ability to regulate blood flow.

In a person who has a heart attack, prolonged low blood pressure (or no blood pressure) will also cause brain damage. That's why starting CPR as quickly as possible is so critical in order to preserve brain function.

In both of these cases, not enough

blood is getting to the central nervous system (the brain, the spinal cord and the retinas), which can lead to cell death — the hallmark of a stroke. But these are extreme cases.

A healthy person whose normal blood pressure is around 90/60 is at risk for fainting when suddenly standing; however, they are at a lower-than-average risk for heart disease and stroke. The diagnosis of "a low blood pressure stroke" for your husband doesn't make any sense at all to me, and advanced imaging of the brain should have made it abundantly clear that it was not the right diagnosis.

I'm shocked that he wasn't treated correctly for that long. But I'm very happy to hear that his neurosurgeon did not assume the diagnosis of a stroke, instead making the correct diagnosis and performing the procedure to help him recover. Your husband is fortunate that he still had neurological function to recover after such a long time, since spinal cord injuries generally heal better when treated promptly.

DEAR DR. ROACH: My primary care physician and blood specialist claim there is nothing that will increase white blood cell count. Are there any supplements that I can take or foods I can eat to improve the low count? — R.J.L.

ANSWER: The question is, why is your white blood cell count low? Some people have low white blood cell counts for no reason; it runs in families, so there aren't any health concerns there. However, there are a large variety of blood diseases that cause low white cell counts. Some affect the lymphocytes, while others affect the granulocytes (the two main types of white cells).

Nutritional deficiencies are extremely rare in North America (vitamin B12, folic acid and copper are the exceptions that should be looked for), so neither diet nor supplements are usually helpful. If there's an absence of blood disease or symptoms, low white blood cell counts usually do not need treatment.



### **EXPOSURE TO SARGASSUM MAY CAUSE HEALTH PROBLEMS**

Even Christopher Columbus met the encounter people with a range of sargassum weed when he discovered the Caribbean. Sargassum is a genus of brown macroalgae. Numerous species are distributed throughout the temperate and tropical oceans of the world, where they generally inhabit shallow water.

presence of sargassum has become more prominent in the British Virgin Islands and throughout the Caribbean. According to the St. John Source "This summer's influx of sargassum seaweed is threatening to overwhelm the Bovoni landfill and has prompted government agencies to search for another way to manage its disposal.

"A Waste Management Authority spokesperson Friday denied a report that the agency is about to stop accepting sargassum at the St. Thomas landfill, but said it recognizes the continuing volume of seaweed drifting into V.I. waters and that the rotting on its shorelines is a serious problem."

In July the Cayman Compass divulged the welcome news that "Thirteen Caribbean and Latin American nations agreed to concerted control efforts to address the influx of sargassum seaweed that has impacted coastlines and economies across the region. A gathering in Cancun, Mexico, on 27 June resulted in a 26-point agreement, with the goal of establishing an action plan before the next regional sargassum forum this October in the Frenchcontrolled island of Guadeloupe. Signatories to the agreement include Belize, Cuba, Dominican Republic, Guadeloupe, Guatemala, Guyana, Haiti, Honduras, Jamaica, Mexico, Nicaragua, Panama, and Trinidad and Tobago."

In early August, the Jamaica Observer exposed a worrysome aspect of sargassum: "If the rafts of sagassum seaweed continue, as is very likely, there is the expectation doctors will increasingly

symptoms associated with sargassum toxicity. It is also noteworthy that while no specific treatment for the sargassum toxicity exists, supportive medical care for the various symptoms will be necessary. Consequently, it is better for people In recent years the maleodorant to avoid exposure to the seaweed, and for visitors to the island, tour operators and hotels to be cognisant of these effects in order to take active measures to minimise contact of their guests with the seaweed. These could include hiring clean-up crews, installing offshore barriers to limit the amount of seaweed washing ashore, and sending boats into the ocean to remove the seaweed. After returning home, travellers should seek medical care if symptoms occur or are persisting.

"Nevertheless, physical removal from beaches or from bays of the fishing community may provide only temporary respite until the next raft of the seaweed arrives. The matter, therefore, has an international that will need the dimension international scientific community to work with local partners and those who can assist with the logistical handling of the seaweed, to design strategies with positive outcomes that are sustainable." The BVI Health Authority and the BVI Tourist Board are most likely well aware of these dangerous implications and the public would be interested to know what is going to be done.

According to NPR It used to be that the conversation around subtropical marine life centered on declines: the death of coral beds. the diminishing variety of seagrasses, the disappearance of fish.

But for now, it's an overabundance that's hard to miss. From Montego to Miami, an influx of algae called sargassum is leaving stinky brown carpets over what was once prime tourist sand. It's the most sargassum researchers have tracked this early in the year.

Deciding what to do with it is proving more challenging the more we learn about it - and inspiring some entrepreneurs to rethink removing sargassum altogether.

Patches of sargassum have been spotted in the Atlantic Ocean for centuries, but since 2011, a 5,000-mile-long belt of the seaweed has circulated annually between the Gulf of Mexico and the mid-Atlantic.

The density of that belt's clusters keeps increasing, possibly because modern agriculture techniques are sending more and more nutrients downstream and into the ocean.

Just this April, sargassum levels in the Caribbean Sea reached a new record, with the overall belt growing to an estimated 13 million tons, according to a bulletin from the University of South Florida Optical Oceanography lab.

And the top bloom season is still days away, with a peak likely to hit in June or July. If the past is precedent, the size of the belt in July could be double what it is in April, says Brian Barnes, a researcher at USF's College of Marine Science.

It's hard to predict what this could mean for beaches, especially in the eastern Atlantic where persistent clouds are obscuring the satellite views that Barnes and his team rely on.

But already, sargassum beachings are increasing, with the southern regions of Hispaniola, Jamaica and Puerto Rico looking likely to be the most impacted.


