PAC FORMATION SLOWNESS BAFFLES OPPOSITION MEMBERS

Frustrated about Government's seemingly slowmotion about the formation of the Public Accounts Committee, members of the Opposition sought to expedite the process last week but were defeated in their effort.

The Public Accounts Committee (PAC), is a major watchdog body within the House of Assembly. It plays a crucial role in the local House of Assembly as it serves to provide the necessary checks

and balances for the Executive, aiming to uphold principles of accountability, transparency, and good governance in public office.

The Standing Orders of the House of Assembly rule that a Minister of Government cannot sit on the Public Accounts Account. This is why it is being stated that the government is currently in a quandary as it relates to the forming of the Public Accounts Committee. The issue is said to stem from

the fact that the government has a very slim majority with no backbenchers. All of the current members of government have either ministerial or junior ministerial titles and in order to have a government member of the PAC one of the current members would need to give up their title.

During the Special Sitting of the House of Assembly on 13 October Opposition members, namely Opposition Leader and Chair of the Public Accounts Account Hon. Ronnie Skelton and Sixth District Representative Hon. Myron Walwyn made an unexpected move with the aim of amending the Order Paper to address the issue of forming a Public Accounts Committee (PAC) for the House.

The Premier had originally designated this sitting to observe the Heroes and Foreparents holiday and celebrate the men and women who laid the foundation for the Virgin Islands' current thriving and self-sustaining economy.

However, during the course of the sitting, members of the Opposition proceeded with their move, asserting that no prior notice was required for the motion to form the PAC. Premier Dr. the Hon. Natalio Wheatley, on the other hand, disagreed, stating that the House had previously agreed to address a specific issue during this sitting.

Subsequently, after the motion was moved, House Speaker Corine N. George-Massicotte called for a recess to thoroughly consider the motion and its eligibility. Upon her return, the Speaker stated, "While I had the opportunity to consider the motion that was moved, I will call on the

Leader of the Opposition at this time." Opposition Leader Hon. Skelton then proposed a motion to withdraw the original motion, which was seconded by another Opposition member. Prior to the withdrawal, the Premier assured the House that his government had no intention of avoiding the formation of the PAC. He stated: "I want to let the Opposition know that there is no effort to avoid forming the PAC. While they are quite anxious to get it formed, I would kindly ask that today we deal with the matter of the national heroes and leave the PAC issue for the next sitting."

PAC ISSUES PREVIOUSLY RECORDED

Back in 2022 as the previous House of Assembly drew to a close it was noted that even then the Public Accounts Committee

had formation troubles. In an interview at the time with Tola Radio on 11 March, 2022 the then Leader of the Opposition Hon. Marlon Penn explained that the PAC's delayed establishment took away a lot of the time the organization had to attend to its accountability mandate.

In explaining the delayed formulation Hon. Penn stated: "We had to wait for an adjustment from the Standing Orders Committee so that we can then have a different formula where they won't be a lopsided membership in terms of Opposition members versus the one Government member

on the Committee. That process took some time – I don't chair the Standing Orders Committee which is chaired by Hon. Carvin Malone. Once that was done, the resolution was brought to the House to constitute the Committee."

GOVERNOR SUPPORTS PROPOSED POLICE ACT AMENDMENTS

His Excellency Governor John Rankin remains resolute in his defense of proposed amendments to the Police Act 2023. These amendments, which have sparked concerns about potential erosion of citizens' rights and increased police authority, continue to be championed by Governor Rankin, who is once again calling for their approval in the House of Assembly.

The Police Act is a legislation that has made returns to the House of Assembly only to be pulled because of public concerns. This year the Bill made its appearance in the House of Assembly but was pulled after public outcries forced legislators to convene informally on 9 February to consider the situation. Even members of the House of Assembly publicly announced that some of the mentions in the Bill made them uncomfortable. As a result, it was announced that the debate on the Bill has been delayed until further notice.

Last week Governor Rankin voiced his support for the controversial Bill during a press conference convened by

the National Security Council (NSC) on 12 October. The press conference was prompted by recent events, including a disturbance at Elmore Stoutt High School and the shooting of a prison officer in East End. During the press conference, Governor Rankin emphasized the importance of ensuring that the Royal Virgin Islands Police Force (RVIPF) possesses the necessary powers to fulfill their responsibilities. He asserted: "This is why we need the Police Act to return to the House of Assembly for approval."

Furthermore, Governor Rankin reiterated his unwavering commitment to upholding the human rights of individuals within the Territory. He countered the concerns raised, stating: "Contrary to some assertions, this act aligns with international human rights standards. I would not support it otherwise," Mr. Rankin affirmed.

One significant point of contention in the bill centers around Section 27-35, which addresses the collection of fingerprints, foot impressions, and DNA. Critics argue that the Bill effectively grants the police broad authority to collect fingerprints without consent in almost any conceivable circumstance, without the need for a warrant. Governor Rankin, in response to concerns about potential misuse, defended this provision, emphasizing its potential use in apprehending serious offenders, including rapists.

Additionally, Section 36 of the same bill permits the police to conduct warrantless searches of individuals' residences if there are reasonable grounds to believe the person does not live there or lacks permission to be there. Section 38 allows a police officer to search the home of someone arrested for a serious offense without a warrant, even in the individual's absence. These provisions have raised alarms among local activists.

Safe Haven Centre To Host Food Drive Outreach

Monday, October 17, 2023 - The Safe Haven Transitional Centre (SHTC) is hosting a Thanksgiving Food Drive and Free Shower Service outreach programme for vulnerable members of the Virgin Islands community.

The food drive aims at restoring the Family Support Network's (FSN) food pantry for Thanksgiving, while the Free Shower Service to provide free showers for unhoused and vulnerable individuals in the community will be held at the centre on a weekly appointment basis.

The food drive will close on November 9 and members of the public are asked to donate canned goods and non-perishable food items.

Programme Aide at the Safe Haven Transitional Centre Miss Drex-Anne Gaton, noted that this initiative seeks to benefit the less fortunate and also victims of domestic violence.


Miss Gaton said, "It is our hope to also be able to donate some of the items received to Community Mental Health Services. Community Mental Health Services will distribute items received to their clients who are some of the most vulnerable in our community."

EAST END BAKERY OWNER LAMENTS ABOUT ABSENCE OF POLICE

widespread public criticism, Zelma Williams, the proprietor of Mangrove Bakery in East End, has voiced her concerns about the lack of police presence in her community. Her frustration comes in the wake of a break-in at her business on 10 October during which thieves damaged her establishment's door and ran away with an undisclosed of money. Williams promptly reported the incident to the local police station but was met with disappointment. Recalling her ordeal while speaking on Tola Radio, Williams expressed: "I went to the police station, and I yelled

and called out, but there was no response. I noticed some phone numbers on the wall, so I made the calls. However, I received no reply. I even attempted to contact the East End Police Station, and although I could hear the phone ringing while I was there, no one answered."

Despite her concern for her bakery's customers, Williams reluctantly returned to her business. The violation from the robbery and the apparent neglect from the authorities continued to trouble her. Later that day, she made a second visit to the police station, but once again, no one was there to address her.

"I won't be returning there. I've cleaned up my place, and I'm resigned to my circumstances. However, not everyone will react the same way. This kind of behavior is deplorable. It's not the first or second time. When you go to the police station, there's no one!" lamented the exasperated businesswoman.

She added: "Where is our sanctuary? The police are supposed to protect us, but the station is closed? The police talk about increased patrols? They don't seem to have anyone's best interests at heart. We are human beings! We seek help, so help us!"

The burglary in East End occurred in the context of reports of a similar incident at Crandall's, a business in Road Town, earlier in the week. Numerous residents and elected representatives have advocating for enhanced police presence in their communities. However, the Commissioner of Police has contended that law enforcement officers are deployed elsewhere because continuous coverage is not required in some areas. In response to the concerns, Police Commissioner Mark Collins later announced the reopening of the police stations

in the East End and West End communities, effective from Monday, 16 October. He clarified that these stations had temporarily closed to have all response officers stationed in Road Town for collective briefings at the commencement of each shift, facilitating hotspot identification and targeted policing.

Since the onset of 2023, there has been a noticeable uptick in crime and violence. Commissioner Collins confirmed that there were as many as 11 burglaries reported between October 9 and 11.

BVI MOURNS DEATH OF GREAT EDUCATOR AND ENTREPRENEUR JAMES ALFRED CHRISTOPHER

A celebration of life service for the late James Alfred Christopher was held on 13 October at the St. George's Episcopal Anglican Church. Mr. Christopher was born on 1 January, 1929 and departed this life on 26 September 2023.

Mr. Christopher who was known to everyone as Alfred was the sixth child of the late Timothy Christopher and Catherine Christopher. The family resided in Fort Charlotte which overlooks Road Town and Road Harbour.

Alfred's early education was at the Sea Cows Bay infant school followed by the St. George's Anglican Church School. He did exceptionally well and was selected to be one of the pioneer students of the Virgin islands senior school which was opened in May 1943 and later became the Virgin Islands Senior School

 today it is the Elmore Stoutt High School.

During his life the multitalented Alfred accomplished much! He served in the field of education as a Pupil Teacher, Assistant Teacher, and Principal from 1947 - 1954. His teaching career continued at Sea Cow's Bay Primary School as an assistant to the then Principal, Miss Augusta Forbes. On his own he worked his way through Rhodes Preparatory School, New York and then New York University as a fulltime student from 1958 - 1965. In 1963 he obtained a B.S. Degree in Social Studies and History and in 1965 a Master of Arts Degree in Secondary Education Administration.

On completion of these studies, Alfred was granted an 18-month extension of his student visa to work in the

USA. During this period, he worked in several schools in the role of Teacher, Guidance counselor, and Social Worker.

In 1967 Alfred returned to the British Virgin Islands but was unsuccessful in obtaining employment. He then took up employment in neighboring US Virgin Islands and taught at the George Washington, Wayne Aspinall, and Charlotte Amalie High School.

In 1969 Alfred returned to the Territory and served as an Assistant Principal as well as Head of the Social Studies Department at the BVI High School. He taught several subjects such as English Language, English Literature, Music, History, Geography, and Science. As a result of his method of teaching students became highly motivated and garnered outstanding results in the Cambridge GCE O'Level Examinations. During this period he earned the nickname Settle Down as that was what he told students to get them ready for lessons. This nickname stuck with him even when he was no longer teaching.

From 1974 -1984 Mr. Christopher served as Deputy Chief Education Officer. In this position schools in the Territory were visited by him every month. In 1984 he left the Education profession and embraced his entrepreneurial

spirit in hospitality and tourism. After all his parents had founded the Sea View Guest House and Restaurant. He turned what was to be his residential home at the Hotel Castle Maria.

Alfred was a kindhearted as well as a philanthropist and donated to many persons and causes throughout his lifetime. He was also a musician and taught a number of family members to play the piano. He also loved photography.

The late James Alfred Christopher is survived by: His sister Ishma Christopher, brother - Herman Christopher, many nieces and nephews, extended relatives, and The numerous friends. publishers, management and staff of The Island Sun newspaper extend condolences to the relatives and friends of the late James Alfred Christopher. May his soul rest in peace.

KHOUZAM SCHOLARSHIP AWARDED TO AUTHOR OF IMPRESSIVE THESIS

Spazio Filatelia, the area devoted to philately at Milan's central headquarters of Poste Italiane, hosted the final ceremony of the second edition of the "Giovanni Riggi di Numana" Award held on Saturday 14 October 2023.

This award, jointly set up by the Khouzam Foundation (in memory of Giorgio Khouzam, past president of the Federation of the Italian Philatelic Societies) and the Association of Collectors of Definitive Stamps (CIFO), aims at promoting and stimulating studies concerning philately and postal history through a thesis for a Doctorate. On 15 October, the € 3,000.00 scholarship was presented to Dr. Lucia Rusin of Fiumicello

Villa Vicentina (Udine), who had received a Master's Degree in Science for the Conservation and Restoration of Cultural Heritage at the faculty of the Alma Mater Studiorum — University of Bologna with a dissertation on "The Origin of the Kingdom of Italy from the first postage stamps".

Her work deals with the study of the first stamps of the Old Italian States, analysed through X-ray refractometric techniques, UV and Mass Chromatographic, fluorescence, UV spectrophotometry and Visible, as well as chemometric studies of its components such as dyes, binders and paper.

Additionally the wellattended ceremony featured the official presentation of a new book published by Post Horn publishers written by Prof. Angelo Piermattei titled "Letters on the oceans'routes of two 19th century Tuscan entrepreneurs".

This volume includes indepth research on about 300 letters of the two Viti entrepreneurs (Vito and Giuseppe) who used the postal service as a more modern means of communication to reach locations divided by the oceans or by big terrestrial distances.

The Viti letters are well known to collectors since quite a number of them are bejeweled with rarevery elusive and spectacular frankings of rare stamps of the Grand Duchy of Tuscany and Duchy of Modena... Heroes And Foreparents Day

Heroes' and Forefathers Day was celebrated for the first time on 18th October, 2021, replacing St. Ursula's Day and has subsequently been observed every third Monday of October.

This initiative is in alignment of the Government and people of the Virgin Islands' overall objective to advance and promote its history and heritage, while safeguarding the national development of the Territory.

BVI Removed From European Union List Of Non-Cooperative Jurisdictions For Tax Purposes

Following a meeting of the European Union's (EU's) Economic and Financial Affairs Council (ECOFIN) today (17 October 2023), the

British Virgin Islands (BVI) has been removed from the EU list of non-cooperative tax jurisdictions (Annex I).

In a statement, the EU

Council noted that the "British Virgin Islands was removed from the list as it has amended its framework on exchange

of information on request (criterion 1.2) and will be reassessed in accordance with the OECD standard. Pending this reassessment this jurisdiction has been included in Annex II."

recognises This legislative changes (including BVI Business Companies Amendment Act 2022, and BVI Business Amendment Regulations 2022) made in 2022 and which came into force on 1 January 2023, to meet requirements set out by the Organisation for Economic Co-operation and-Development (OECD) Global Forum on Transparency and Exchange of Information for Tax Purposes as part of its Peer Review Process. As such, the BVI has now been reinstated to the state of play document (Annex II) which includes jurisdictions committed to implementing reforms.

Commenting on the announcement, BVI Financial Minister for

Honourable Lorna Smith, OBE said: "We welcome the announcement that the BVI has been removed from Annex I of the EU list, which reflects the current state of play in the BVI. OECS Meetings Discuss Pressing Healthcare Issues

Minister for Health and Social Development Honourable Vincent. O. Wheatley said the just concluded OECS Ministers of Health meeting delved into the pressing healthcare issues facing members of the Organisation of Eastern Caribbean States (OECS).

The Ninth Council of Ministers: Health Meeting was held back-to-back with the 36th OECS/Pooled Procurement Services (PPS) Policy Board Meeting which was dually chaired by Honourable Wheatley.

According to the Health Minister, one of the salient points discussed robustly during the sessions was the migration of health practitioners from OECS countries. Honourable Wheatley acknowledged that the Virgin Islands is one of the beneficiaries of the migration and stated that the Council looked at different ways to share the expertise of healthcare practitioners among **OECS** member states.

Honourable Wheatley said, "The question is now, how do we keep persons in the region so it would not be like St. Vincent and the Grenadines or St. Lucia is losing persons but instead they are sharing their expertise with somebody. That was one of the salient points we took away from the conference."

Minister Wheatley said that there is a need for deeper and wider collaboration among states in terms of what their needs are and that the meetings looked at the different expertise and best practices from each nation.

"I have learnt so much from the other countries about how they tackle problems that exist here, all in the name of getting better healthcare for our people both primary and tertiary," the Minister added.

Meanwhile, Director General of the OECS His Excellency, Dr. Didacus Jules reiterated Honourable Wheatley's point on the



need for collaboration. Dr. Jules noted that most of the discussions at the two meetings centred on how the region can come together to better serve the people and improve healthcare.

The OECS Director General said the PPS Meeting focused heavily on pooling the procurement of medicine and medical supplies in the OECS to pay at a cheaper rate, and added that the OECS is seeking to transition to a position where everything is pooled.

"Whatever governments require that can be delivered more cost-effectively to them via pooling of the requirements across the OECS we can provide. It was a very important meeting because the back-to-back meetings allowed us to look at the needs of the health systems in the OECS and see how that can be aligned to real improvements in the quality of medical services available across the OECS," Dr. Jules said.

Additionally, Minister for Health, Wellness and Elderly Affairs in St. Lucia, Honourable Moses Jn. Baptiste said the meeting was fruitful as countries with lived experiences could share so that others from the sub-region can benefit.

Honourable Jn. Baptiste said, "Our meetings were very frank, very upfront and we looked at the problems in the OECS squarely and we tried our very best to have a plan of action which would cause our various issues to be looked at in the coming months and in the coming years."

The Ministry of Health and Social Development hosted the ministers and other healthcare delegates from across the OECS from October 9 to 12 to discuss the best course of action towards affordable healthcare in the OECS region. The 36th OECS/PPS Policy Board Meeting and the Ninth OECS Council of Ministers: Health was held under the theme: Improving Lives through Preventive Healthcare: An Evidence-Based Approach.

The Ministry of Health and Social Development remains committed to building partnerships and relationships that improve the health and social wellbeing of the people of the Virgin Islands.

Out of the huts of history's pain

Our ancestors bled and died! But with strength and willpower we overcame

To restore Virgin Islands pride!

To preserve our beauty we devised a plan

To obtain ownership of your precious lands!

Educating our people is the

golden key

To maintain the success of this Territory!

The Virgin Islands story cannot be properly told without acknowledging the activism and national service of the likes of:

Theodolph H. Faulkner, Isaac Glanville Fonseca, Hamilton Lavity Stoutt, Dr. Willard Wheatley, Noel Lloyd and the Action Movement, and countless others. Our Virgin Islands heroes include those who fought against the institution of slavery, who marched for our right to govern ourselves, who answered the call for leadership in various capacities when leadership was needed, whose sacrifice are responsible for the freedoms we enjoy today, whose innovativeness and determination laid the path for our political and economic development.

Among those numbers also stand our educators, to whom we owe a tremendous amount of appreciation.

It is our educators over the past decades who have instilled knowledge and skills in our people, enabling us to develop our competencies in all the fields - academic, professional and vocational - to power our economy and our development, and to take charge of our destiny. They have done this often in less than ideal conditions, with less than the best resources, and for compensation that were far insufficient compared to the value and importance of their work. with us, who are able to be with us physically, and through whose hands thousands of Virgin Islands youths, myself included, would have passed and been molded.

I am fortunate to have a perspective from both the viewpoint of the student and the educator.

I am the product of BVI educators, and their devotion to duty is responsible for my successes in academics and in my professional life. As a former educator, I have felt the fulfillment that comes with seeing your students doing well, and how it motivates you to become more invested in your charges.

I have witnessed this cycle in our educators, especially our honorees, who have led, inspired and molded younger educators who came into the system over the years.

The contributions of these men and women to the development of the Virgin Islands and to the success of each of us, are beyond measure. They are responsible for the shaping of our Virgin Islands story and what our people will become and achieve in the future.

It is quite fortuitous that our celebration of 80 years of secondary education in the Virgin Islands coincides with our observance of Heroes and Fore Parents Day.

Heroes and Fore Parents Day is about creating awareness about the contributions of Virgin Islanders to our development and advancement, whose work have often times been under-valued and under-appreciated.

Sometimes, they did not get the recognition because we took them for granted or we did not appreciate the significance of their work and dedication. In some cases, it is also because as Virgin Islands people, we did not own up to our responsibility in documenting and telling the story of our people; and therefore versions of what were purported to be our story were the

ones being told. Heroes and Fore Parents Day and activities such as today's events aim to change that.

Through recognition of our stalwart educators and our heroes and fore parents, we aim to ensure that the historical records and the telling of the Virgin Islands story are made more accurate. We aim also to inspire our present and future generations, and instill them with the confidence to aspire to greatness – as those before them have clearly done.

As we celebrate 80 years of secondary education in the Virgin Islands and Heroes and Fore Parents Day 2023, we thank all who have contributed to the progress of our country and our people, especially our educators. We recognise and remember them, and we pledge to make them proud as we continue on the path they have paved for us.

I thank you.



ISRAEL - The war against Hamas, the deadliest for Israelis in half a century, threatens to become the swansong of a politician who for three decades in power has wielded security as his greatest asset.

Now 73 years old and facing an indictment for corruption, Benjamin Netanyahu returned to the residence of the Prime Minister of Israel on Balfour Street in Jerusalem late last year, the only place where he can seek refuge from serving a prison sentence if convicted. "Everything but the cell" could well have been his motto when he spent a year and a half in the opposition. After being ousted from power in June 2021 with the votes of two of his conservative political protegees in 2023, at the head of the most conservative government in the history of the State of Israel, he has faced a protest movement with precedents against few the judicial reform he has imposed, again in an attempt to avoid prison.

After the fiasco of the Yom Kippur War in 1973, Israelis forced Labor Prime Minister Golda Meir out of power. And four years later, an electoral upset ended the hegemony of the left, as Netanyahu's Likud party came to power for the first time since the birth of the Jewish state three decades earlier."Netanyahu's political exit is inevitable,' predicts Ami Yaalon, former head of the Shabak, the state's internal security service.

Anshel Pfeffer. Netanyahu's biographer, noted this week in his column in the daily Haaretz that if the prime minister does not set clear goals for the war against Hamas, he will have to face the consequences. [El Pais]



ISRAEL - Nothing will stop the destruction of Gaza. Nothing will be able to mitigate the objective of Israel, its government, and its society, shared by the U.S. and the European Union. Not even the ashes of Hamas should remain. The price to be paid will be very high, accepted by the Israelis, in lives — their

own, those of their soldiers, and those of the unfortunate hostages, and others, those of many Gazans international prestige, in their advanced economy, and in relations with their neighbors, perhaps even leading to disastrous geopolitical consequences such as a regional escalation or even to war without intermediaries against Iran. Its allies will also pay the price, the closer they are to it, and this is especially true of Ukraine, in terms of reduced military aid, political neglect, and disregard for the international legislation and institutions that are so convenient for Putin. 
global politics have had a new taste of the risks to democracy represented by so-called deepfake, namely fake multimedia content created using artificial intelligence (AI). During the annual Labour party conference in the UK, accounts on the social media platform X (formerly known as Twitter) released a video containing audio in which party leader Sir Keir Starmer's counterfeit AI voice can be heard swearing at and abusing members of his staff. The episode represented a fake and fullblown attack on the Labour leader from the internet just as he is starting to prepare his political campaign for the general elections that are due to be held between the end of 2024 and early 2025.

Most of all, it seems to have been launched on purpose to discredit him just when the polls are giving his party - which has been in opposition for 15 years a lead of almost 20 points over Prime Minister Rishi Sunak's Conservatives. The deepfake was initially published on an account with only 3,500 followers, in a post that read as follows: I have obtained audio of Keir Starmer verbally abusing his staffers at conference. This disgusting bully is about to become our next PM." At the time of writing, the content had been viewed

Ladyburd Talks...

Dear Readers: Here are some tips to give us some energy throughout the day, that may help us to feel less draggy.

Waking Up: Instead of: Sleeping in..Try: Getting up at the same each day.

This enables your circadian rhythms, which are governed by your body's "master clock" in the hypothalamus gland, to stay in synch with the 24-hour day. In the absence of light, your body's sleepwake cycle wants to delay by an average of 12 minutes every day and work on a 24.2-hour rhythm. (Scientists don't understand why but think it may relate to the sun's seasonal shifts.) "That means your body wants to keep pushing your bedtime to later," says Mariana Figueiro, PhD, program director of Rensselaer Polytechnic Institute's Lighting Research Center. "But if you let that happen and still have to get up at the same time every day, you're going to be tired."

To keep your circadian rhythms in time with the 24-hour day (when they get out of whack, you feel like you're jet-lagged), aim for 30 minutes of light first thing, even on a Saturday when you've decided to sleep in. An easy way to get it is to go for a half-hour stroll outdoors or have your breakfast by a sunny window. If your schedule requires you to rise when it's dark outside, crank up the lights indoors—every little bit may help.

1/2 teaspoon cayenne, optional (adjust to taste)

1 (15-ounce) can black beans

1 (15-ounce) can diced tomatoes with chilies

Assorted chili toppings: tortilla chips, diced onion, crackers, shredded cheese, sour cream

In a Dutch oven or soup pot over medium heat, warm

the olive oil. Saute the onions for a minute or two so they get a head start cooking.

Add the garlic, sweet potatoes, carrots and bell pepper to the pan. Cook until the onions are soft, about 5 minutes.

Reduce the heat to medium-low and add all the spices, stirring well to coat all the veggies. Be careful that you don't burn the spices; keep stirring the pot.

As soon as the spices become beautifully fragrant, add the water or broth, beans and the tomatoes. Deglaze the pan by scraping the bottom of the pan, stirring to incorporate. Bring the pot to a boil then reduce heat to low.



Allow your chili to simmer, partially covered, stirring occasionally, over low heat for about 20 minutes, until the flavors marry, and the sweet potatoes and carrots are soft.

UN ACTION NEEDED URGENTLY TO END ISRAEL-HAMAS VIOLENCE

The attack by Hamas on civilians in Southern Israel on 7 October 2023 was as stupid as it was cruel, brutal and inhuman.

Whatever the purposes - and there were many - behind a slaughter of 1,200 persons, including children - Hamas gave the perfect cover to the Benjamin Netanyahu government in Israel to try to carry out a long-desired objective by many Israelis. And that is to annex Gaza and cleanse it of Palestinians who are either refugees or descendants of refugees who were forced to flee from Palestine in 1948 when Israel announced its independence and a bitter war ensued between the nascent Israeli State and surrounding Arab countries.

THE BACKGROUND TO THE ISSUE

There were two attempts, driven by external powers to partition Palestine into two states, one Arab, one Jewish. The first was offered by Britain, the occupying power in 1937, and the second was proposed by the United Nations in 1947. The Arab countries rejected both plans, and Israel declared itself independent creating its own state. This led to the first Arab-Israeli war and produced more than half a million Arab refugees, and deep hostility that has never waned.

What built even greater resentment was that after the war, Israel destroyed hundreds of Palestinian villages and adopted an "Absentees' Property Law" by which the government confiscated land and houses that Palestinians were forced to abandon.

Over the years, there have been several attempts to negotiate a two-state solution to the problem, but with no success. Meanwhile, with each war, Israel has secured more territory, both occupying and settling it with Jewish people.

ENCAGING PALESTINIANS IN GAZA

Until 7 October, there were approximately 2.3 million Palestinians, hemmed into Gaza, living in crowded and impoverished conditions. Gaza is a narrow piece of land located on the eastern coast of the Mediterranean Sea, bordered by Israel to the east and north, and Egypt to the southwest. It is 41 km (25 mi) long, and from 6 to 12 km (3.7 to 7.5 mi) wide. Its total area is 365 km (141 sq. mi).

Since October 7, more than 2,700 people in Gaza, one third of them children, have been killed and 9,000 wounded by retaliatory Israeli military assaults. Further, 1.1 million people in North Gaza (the area closest to Israel) have been warned to move to South Gaza or risk being killed by military action. Many are trying to seek refuge in Egypt.

However, Egypt, which already hosts millions of migrants, is uneasy about the prospect of hundreds of thousands of Palestinian refugees crossing into its territory. Therefore, it has not opened the border. Consequently, if Israel continues its bombardment of Gaza in an attempt to kill Hamas' leaders, many more thousands of its inhabitants, including those trying to flee, will be killed.

THE RISE AND SUPPORT FOR HAMAS

That carnage, laid at the feet of Israel, would suit Hamas, which has controlled Gaza since 2007 and whose main goal as set out in its revised charter of 2017 is "the destruction of the state of Israel". The resentment and demand for revenge, resulting from the killing of thousands of Palestinians would bring greater support for Hamas.

Hamas was formed in 1987 and, for decades, it has pursued a violent strategy aimed at rolling back Israeli rule — and it has made its presence felt at the cost

of human suffering to both Israelis and Palestinians.

Hamas is known to have a close relationship with Iran. Iran and Israel regard each other as mortal enemies, and Iran is said to be providing weapons and money to Hamas. Additionally, Hamas is now producing its own weapons. This explains how it was able to employ sophisticated means of carrying out its October 7 attack. But it should be noted that Iran is reported to have been surprised at the event, and the US Secretary of State has publicly said that there is no evidence of Iranian

involvement.

Nonetheless, Iran does have an interest in the incident, since it helps to pause, if not to derail, attempts by the US government to promote a deal between Israel and Saudi Arabia, the world's largest oil producer, to normalize relations. Further, Israel's decision to carry out intense military action in Gaza and the likely shedding of Palestinian blood, has caused several Arab states to retreat from closer relations with Tel Aviv. This retreat by Arab states from fashioning closer contact with Israel also suits Iran whose leadership want to keep Israel isolated.

THE IRONY OF ISRAELI SUPPORT FOR HAMAS

In its radical ardour, and access to financing and weaponry, Hamas has usurped the Palestinian Authority in the fight for Palestinian rights.

The irony is that it is the Israeli authorities, which for several years gave favourable treatment to Hamas, that has helped it to rise. In their fear that the Palestinian Authority might succeed in negotiating internationally for a sovereign state that would include the territories occupied by Israel, the Israel authorities sabotaged the Palestinian Authority at the 2006 election which Hamas won in Gaza.

BITTERNESS AND RESENTMENT RUN DEEP

Bitterness and resentment between the Palestinians and Israel run deep. Israeli successes at annexation and expansion, while Palestine withered and Palestinians suffered dislocation and marginalization, have intensified Palestinian anger.

One of the external factors that heightened this acrimony was the recognition of Jerusalem as the Israeli capital by former US President Donald Trump. Palestinians regard Eastern Jerusalem as "occupied territory" where, one day, they wish to establish their own capital.

NOTHING JUSTIFIES BARBARISM

No well thinking person or government can excuse terrorism and barbarism for whatever cause. These events rightly create revulsion and rejection of its perpetrators.

Equally, however, no well thinking person or government should support any effort that uses these circumstances as an opportunity to punish all Palestinians for the actions of a radical group and seize more territory.

This is not the time to take sides. All governments - powerful ones particularly need to look backward and forward at this issue and act to stop the escalating violence and carnage from which nothing good will result.

The fact that the United Nations Security Council (UNSC) has met, in an emergency session, and failed to issue even a joint statement on this matter is simply appalling. There is urgency for diplomatic action at the highest level. The innocent people on both sides of this conflict require responsible action by those entrusted with peace and security in the world. So, too does the global community if this conflict escalates adding to the existing disruption of peace in the world.

INTRODUCTION TO THE STAMPS OF THE B.V.I.

PART 3

STAMPS

The stamps of the Virgin Islands belong to the extremely, and deservedly popular group of West Indian stamps. One of the most famous collectors of all times, said: "among all the fascinating pages of the well-filled stamp album, few are so arresting to the collector and to the profane alike as those devoted to the stamps of the Islands of Virgins". This was the opinion of Frederick John Melville (1882-1940) 150 years ago. He was so impressed as to say: "the charm of the designs, the technical interest in the stamps, and the immunity from really deceptive forgeries, combine to make the stamps of the Virgin Islands of unsurpassed attraction to the specialist".

THE TORTOLA POST OFFICE

The first Post Office was opened in Tortola in 1787, its postmaster was M. McNamara, at this time postage stamps were not invented yet and it was not until 1858 that a small supply of adhesive stamps issued by Great Britain depicting Queen Victoria was utilized by the local Post Office. These stamps were cancelled by an "A 13" postmark

and as such they are extremely rare. Meanwhile the Postmaster had acquired vast portions of land on the hill overlooking Road Harbour in Tortola and the area is still named after him.

In 1860 the control of the Tortola Post Office was transferred from the General Post Office in London to the local administration. On 11 February 1863 the Virgin Islands Postage Ordinance was passed by the local Legislative Council; it set out regulations for the prepayment of postage on letters between colonies.

Three years later Messrs. Nissen & Parker, stationers and printers in London, were commissioned to provide the first postage stamps for the Virgin Islands. They were well established as printers, engravers and stationers for about 100 banks in the United Kingdom. In 1861, Nissen & Parker printed the first stamps of Nevis. This debut on the stamp scene was followed The first stamp of the British Virgin five years later by the first stamps of the Virgin Islands and, in 1869, those of Hyderabad, did not do much to boost the company's business as postage stamp printers.

The 1866 stamps were lithographed and the company actually farmed out most of the work to the firm of Waterlow and Sons. John Rapkin (1813-1899) engraved the master dies for each of the four values prepared by Nissen & Parker. Rapkin had made his reputation as chief engraver for the well-known London-based map printer John Tallis. The son of a shoemaker, he had eight children and a sizable business eventually

named John Rapkin & Sons with four of his sons in business with him. He died aged 85 in 1899 and the Rapkin enterprise survived until the 1970s.

The first two Virgin Islands adhesive postage stamps - a One Penny and a Six Pence - arrived in Tortola in December 1866 and were issued shortly

afterwards.

Most of the early stamps (1866-1883) were cancelled by the earlier mentioned "A13" postmark followed later by an "A91" postmark.

YES, WE ARE DIFFERENT

One remarkable aspect of the early Virgin Islands stamps is that they do not feature Queen Victoria's portrait or Britannia like the stamps of most British colonies did in those days. The Virgin Islands were not the first to do so, but they were the first to adopt a well defined motif that was used for many years and has survived to the 21st century. From their inception local stamps sent a subliminal message back home that the Virgin Islands were different and determined to forge their own future.

Both stamps depict St. Ursula, crowned by a nimbus, holding a lamp in her right hand, and with ten other lamps in the surround. In the One Penny design a central figure occupies an oval frame, and in the Six Pence a rectangle showcases the same female figure (believed by some to be the goddess of Justice as depicted on a local seal).

The same design was used in later years for new stamps but in different colours: a rose-red for the 1 Penny and a dull violet for the Six pence. For many years collectors believed that these early stamps depicted the Blessed Virgin and stamps issued in later years were strongly influenced by this misconception since they depicted what appeared to be a "Madonna".

> An authentic inscription of the early fifth century proves that a consul by the name of Clematius rebuilt a ruined basilica in Cologne, Germany on the tomb of virgin martyrs. This is the nucleus of facts underlying dubious elaborations of legends beginning as far back as the ninth century. Ignorance of Latin epigraphy mistook eleven for 11,000, a mistake which might suggest that the martyrs were possibly only eleven in number.

> Thus took shape the legend of St. Ursula, the daughter of a British king, visiting Rome with her 11,000 virgin companions together with married associates and their children. Their supposed martyrdom on their return journey together with a non-existent Pope Cyriacus and equally non-existent bishops was at the hands of the Huns.

> The 1d. and 6d. stamps of the first issue have a perforation 12. The next printing of the low denomination was perforated 15 (1868) while the 6d. with the same perforation appeared in 1870.

> A major B.V.I. rarity is the 1868 One Penny green perforated 15 x 12; only twelve copies of this rarity are known.

> The plate used for the 1d. Perf. 15 is from a transfer completely different from the first issue. Scholars suggest there were as many as eight transfers of the 1d. perforated 15. However, during my research I have found so many previously unrecorded varieties that do not belong to the better known transfers to

convince me that there may have been more than eight transfers.

The 6d. perf. 15 is a much rarer stamp than catalogues would us believe. In fact, only 1,000 are said to have been printed.



Islands: the One Penny green depicting St. Ursula holding a lamp was issued in 1866 together with its 6 pence rose twin. St. Ursula is the patron saint of the BVI.

An additional 10 lamps surround her, making the number of lamps eleven, each of them symbolizing 1000 virgin companions cruelly slained by the Huns.

THIS WEEK IN TILL DEBT DO US PART

Last week, the International Monetary Fund (IMF) and World Bank annual meetings took place in Marrakech, Morocco. The events brought together global leaders from over 190 countries, and this year is the first time

the gathering takes place outside the United States. This was an opportunity to rebalance global power, scale up international efforts, and move closer to a more stable and prosperous global economy.

Debt restructuring is a hot topic this year following, among other things, the lasting impacts of the COVID-19 pandemic. During the opening address, IMF Managing Director Kristalina Georgieva shared that debt in over half of low-income countries has

increased significantly, especially among low and mediumincome countries, many of which remain at debt distress or high-risk of debt distress.

In practice, this means that such countries spend more on debt service payments than on health, education and the fight against climate change.

As with any distribution of large sums of public money, debt management programmes are not immune to corruption. And although there are some initiatives to enhance transparency in debt, many difficulties remain that hinder transparency and accountability. For example, in many cases, information about lending decision-making, agreements, allocations, and conditions remains undisclosed and unsupervised.

The existing lack of data related to debt management is a reason for concern, with 40 per cent of countries failing to disclose debt information over the past two years. In addition to the already inadequate mechanisms for publishing data, creditors and borrowing governments can introduce confidentiality clauses in lending agreements to keep essential information hidden from public scrutiny.

In today's global economic climate, there is a shift from traditional lenders to bilateral and commercial creditors, which has increased the risk of obscure lending practices - a great cause for concern. The lack of information, transparency and oversight mechanisms in the management of loans also hinders the capacity of Supreme Audit Institutions, parliament, and civil society actors to scrutinise and monitor the loans - and follow how the money is spent. This, coupled with mismanagement, leaves countries at risk of debt distress and economic crises, which increases poverty and unemployment rates, disproportionately affecting groups that experience marginalisation. This is especially seen in countries like Sri Lanka.

CORRUPTION

In 2022, Sri Lanka took out massive international loans

to finance economic growth during its worst financial crisis since independence.

The country soon defaulted on its debts, leading to largescale civic uprisings, with people demanding the resignation of the then-president and systemic change to ensure good governance and tackle corruption.

This ultimately led to a US\$2.9 billion debt-restructuring process by the IMF. This unique program includes anti-corruption and governance as key pillars,

including a governance diagnostic - the first of its kind in Asia.

While we applaud this initiative, development funds are still being mismanaged and more is needed to ensure transparency and accountability in Sri Lanka and beyond. It's imperative to foster civic monitoring and engagement - a sentiment shared by Georgieva herself - and to provide public access and scrutiny of debt-related information.


Systemic change can be achieved by implementing policies and regulatory frameworks to prioritise transparency and accountability in debt negotiations, and (re)structuring and management to ensure corruption can't slip through the cracks.

Inthecomplex global landscape, we're faced with a simple truth: throwing money at a structural problem won't make it disappear. Real change requires strong governance, civic engagement and widespread monitoring to ensure debt sustainability programmes alleviate the burden rather than enhance it. As we pave the way forward, it's essential to recognise that we, as a global community, aren't just handling finances; we're shaping the destinies of nations - and the people within them.

Leveraging debt

Financial capital aka debt is a tool of the rich to get richer still

Now, middle-income consumers – the 30-100K income bracket that most of us fall into in the Virgin Islandsuse debt for a mortgage, or a car. However, for food, drink, clothing, and lower priced items that are essential, such as rent, electricity and water,

middle-income consumers use cash that is available and not borrowed.

OK. There are two main types in the economics tale, producers and consumers, and then there are further sub divisions: savers and spenders, employed and self-employed, high income, middle income, low income, even homeowners and renters.

The rich - the 1-10%, are high-income consumers, savers, and investors with net pay of 250K and above. The rich tend to be frugal: savers. The rich also appear to adopt a culture of savings and investment as modus vivendi. The rich are supply-siders: production oriented. further adopt devices such as using debt in creative ways such as using other people's money in various ventures. A blogger to this writer's column stated that "the rich leverage debt to get richer while debt makes the middle class and poor, poorer."
There is substance to that assertion.

The 90%, that is the middle income and poor, spend on liabilities that are not taxdeductible using debt. The rich on the other hand use debt for investment in assets that are tax deductible and that earn revenue. The rich use debt for assets that put money in their pockets. The rest use debt for liabilities that depreciate and lose money like cars and credit card spending on vacations and the like. Bear in mind that both types need each other. Investors and producers could not exist without consumers, and consumers need the products produced by businesses, corporations, and investment.

OK. Modern governments also spend other peoples' money, and leverage debt. Bear in mind government is a different economic beast from a private individual. It is safe to assert that the majority of middle-income consumers live paycheck to paycheck. In the USA credit-debt is a way of life and nearly half of all residents are \$500 away from broke. Debt keeps millions of consumers in the game, so debt is far from a bad word. Debt keeps capitalism going; debt makes the world go round. The diligent use of debt by individuals, organizations and government, can lead to El Dorado.

On the other hand, debt is a factor in growing inequality as the returns on debt capital make the wealthy, wealthier still.

Dr. Smith said the exercise was conducted after a weeklong training exercise provided invaluable hands-on experience and allowed employees to familiarise themselves with the protocols that are in place to ensure their safety.

"Our team members' ability to remain calm and respond appropriately in an emergency is essential, and this simulation was designed to enhance their preparedness," he said.

Dr. Smith added, "As part of our ongoing commitment to safety and security, we will continue to conduct regular training exercises and drills, ensuring that our team is well-prepared to respond effectively in any emergency situation. Our employees' wellbeing and peace of mind are of the utmost importance to us."

The exercise was conducted in partnership with the Royal Virgin Islands Police Force and planning with the Emergency Response team at the Dr. D. Orlando Smith Hospital. The activity was also observed by the BVI Red Cross through their Disaster Coordinator Ms. Resherma Lyons.

The Management and staff of the BVI Electricity Corporation extend appreciation to the local law enforcement agencies, security consultants, all participants and the community for their support and cooperation during this exercise. The Right Honourable Justin Trudeau, Prime Minister of Canada; Honourable Roosevelt Skerrit, Prime Minister of the Commonwealth of Dominica and Chairman of the Conference of Heads of Government of the Caribbean Community (CARICOM); Other Heads of State and Government of CARICOM Member States; Distinguished delegates;

Ladies and gentlemen.

It is a pleasure to be here today as we convene this Summit between the Caribbean Community (CARICOM) and Canada. On behalf of the Community, I express heartfelt appreciation to the Government of Canada for hosting this high-level engagement and for the warm hospitality extended to our delegations. Canada has remained a vital CARICOM

partner since we established formal diplomatic relations, and the Community attaches great value to the bonds of friendship forged over the years.

Over the next two days, we will discuss a range of issues, including climate change and resilience, access to finance, reform of the international financial architecture, regional security, immigration, trade and investment, and the situation in Haiti.

However, of equal urgency is working together to effectively reduce emissions and make a just transition to a clean energy future across the globe, to limit global warming to within 1.5 degrees Celsius. Israel-Hamas War Could Radically Alter the Middle East

WASHINGTON —

The terror attack by the Hamas militant group that killed approximately 1,400 Israeli civilians, and Israel's determination to destroy the Palestinian militant group in return, may be the start of a new, painful chapter in a region already badly scarred by decades of conflict and violence.

Current and former officials, analysts and aid groups, speaking to VOA directly and at public forums, warn that unlike past conflicts between Israel and Hamas, when each side sought to damage the other before eventually easing off, this time is different.

Despite some considerable differences of opinion, almost all agree that the nature of the Hamas attack has broken the tit-for-tat cycle of violence that has characterized hostilities for most of the past two decades. And they warn that the Israeli effort to eradicate the threat from Hamas could leave Gaza, Israel and the larger Middle East much messier, if not less stable, than ever before.

"Hamas has departed from the script that Israel assigned it for years," according to Jon Alterman, director of the Middle East program at the Center for Strategic and International Studies.

The initial terror attack "was surely only the first act that Hamas had planned," he said. "They knew it was going to be followed by airstrikes and a ground invasion. ... What other surprises do they have planned?"

Former officials and analysts say that is, perhaps, the key question facing Israel's military as it prepares for an expected ground assault against Hamas and its allies in Gaza.

And some, like Middle East Institute senior fellow Nimrod Goren, note that although Israel has a more powerful military and superior technology, past incursions showed that fighting in the streets of Gaza "usually doesn't end very well" for the Israeli military.

Israel's last military incursion in 2014 resulted in the deaths of 67 soldiers when Israeli troops met stiff resistance while never penetrating more than a few kilometers into Gaza.

This time, Israeli military commanders have promised a much more thorough campaign.

"The goal of Israel, as has been announced, is to try and get Hamas out of Gaza in terms of military capabilities and governing capability," Goren said.

"It's not only about taking

control and deterring like last time, but it's now about changing who is ruling Gaza," he said. "It's about reshaping the order in Gaza."

And most officials and analysts expect Israel will face a much stiffer test than it did nine years

Hamas capabilities

U.S. intelligence estimates put the number of Hamas fighters at between 20,000 and 25,000, though some estimates say the number might be 30,000 or higher, bolstered by support from about a dozen other militant groups in Gaza.

Hamas' firepower, due to its own initiative and support from Iran, is also formidable.

Already, Hamas has fired thousands of rockets into Israel, and experts believe it has plenty more at its disposal.

"Their arsenal has grown exponentially over the years, and a lot of that is self-manufactured," said Joe Truzman, a research analyst at the Washington-based Foundation for Defense of Democracies.

"They have rockets that will target areas near the Gaza border, and that's complemented with mortar fire. They have mediumrange rockets that, let's say, can actually reach a little bit further," Truzman told VOA.

"And then you have the longrange rockets," he said. "They're able to attack major cities like Tel Aviv and Jerusalem."

U.S. officials also assess Hamas has plenty of weaponry that would allow it to cause problems for Israeli forces poised to enter Gaza — including small arms, rocket-propelled grenades, man-portable air defense systems (MANPADS) and anti-tank missiles.

Hamas also displayed its ability to use drones during its initial attack on Israel, using the aerial devices to attack Israeli military observation towers. It also is thought to have drones that can attack Israeli naval assets; Israel has accused Hamas of using unmanned underwater drones for an attempted attack in 2018.

Additionally, Hamas has shown an ability to learn and apply those lessons.

"They're operating like an army," said Truzman, adding that for most of the past five years, Hamas has operated its own joint operations room. "It's about 10 to 12 armed groups, terrorist groups, in the Gaza Strip, all affiliated with Hamas that coordinate with one another during times of conflict."

Gaza's tunnels

Hamas also has shown a capacity to use an extensive system of tunnels underneath Gaza to its advantage.

During previous fighting with Israel, Hamas used the tunnels to deploy rocket units to launch attacks and quickly disappear to evade retaliatory strikes. And in 2014, Hamas used the tunnels to ambush Israeli forces that entered Gaza.

Analysts expect the tunnels will at least slow down any ground operation by Israel, if not give Hamas an opportunity to inflict heavy casualties.

"If you really want to root out Hamas and break Hamas as a military organization, you have to go all the way in," said Raphael Cohen, a senior political scientist at the RAND Corporation. "You have to fight underground."

"Hamas knows this and has been working presumably on booby traps and [the] like," Cohen said. "That looks very, very messy."

Fighting Hamas above ground is also expected to be difficult for Israeli forces.

"The way that Hamas is dispersed in everybody's basement and everybody's apartment building and in every part of the city, that's going to be really challenging," warned Thomas Trask, a retired U.S. lieutenant general who previously served as vice commander at U.S. Special Operations Command.

"It's just going to be a block-byblock, very difficult slog," he said. Israel is likely to counter with armored vehicles, tanks and bulldozers.

But Gaza's cramped quarters may make advancing difficult.

The narrow stretch of land bordering Israel and the Mediterranean coast is some 40 kilometers long and about 13 kilometers wide at its widest point and is home to more than 2 million Palestinians. Some observers and analysts have described Gaza as perhaps the most densely populated piece of land in the world.

Additionally, if Israel makes good on its pledge to eliminate Hamas, its forces will have to penetrate deeper into Gaza than they have since Israel left Gaza in 2005

Close quarters

"You've got narrow alleys. You've got concrete buildings of different heights. You've got warrens," said Seth Jones, director of the international security

program at CSIS.

"Hamas, and actually other groups ... they have an intimate knowledge of Gaza's streets and alleys, underground facilities, including tunnels, buildings," Jones said. "So, as IDF [Israel Defense Force] soldiers make their way through Gaza, they've got to have to deal with the improvised devices, explosive suicide bombers, anti-tank missiles, RPGs, drones."

And stuck in between Hamas and the Israeli forces are civilians, not all of whom are willing or able to respond to Israeli demands to use designated evacuation routes to escape the fighting.

"People have nowhere to shelter," said Tahani Mustafa, the Palestine senior analyst for the International Crisis Group.

"They don't have safe rooms. They don't have bomb shelters," Mustafa told VOA from London, adding that she had left Gaza shortly before the fighting began.

"So, Hamas can try and tell people to stay as safe as possible," she said. "But ultimately, how people are doing that is basically congregating in homes of different relatives, friends, in certain facilities like UNRWA [United Nations Relief and Works Agency] schools, hospitals."

As of Tuesday, an estimated 600,000 are thought to have heeded Israeli requests to leave northern Gaza, expected to be the initial front in the offensive. But Jones said the mere presence

of civilians, some of whom may decide to take up arms, will make the likely Israeli offensive more daunting.

"IDF soldiers have ... extraordinary competence in operations in both the West Bank and Gaza, and obviously up north in Lebanon," he said during a call, in response to a question from VOA.

"But when you're facing extraordinary stress — Hamas and other militants and civilians trying to kill you in a densely packed urban environment and have to make very quick decisions with your finger on the trigger with imperfect information — it's going to lead to civilian casualties," Jones said.

Already, Israel's aerial campaign against Hamas in Gaza has inflicted a toll.

According to the Gaza Health Ministry, as of Tuesday, Israeli airstrikes have killed about 3,000 people, about a quarter of them children, and wounded 12,500 more. Most are thought to be civilians, though it is unclear how many of them are Hamas fighters or members of other militant groups.

Further complicating the likely offensive, Israeli and U.S. officials have accused Hamas of purposely putting Palestinian civilians in harm's way.

After Dominica tie, BVI fights back for 2-2 draw with Turks

Substitute Justin Smith scored deep into stoppage time, pulling them from the jaws of defeat, to a 2-2 draw against hosts Turks and Caicos Islands on Monday afternoon, after they had taken the early lead.

With both teams getting a point from the draw, the BVI moved to the top of their CONCACAF League C Group C ahead of Dominica, 5-4, setting up a winner takes all at the A. O. Shirley Grounds on Nov 16, after the BVI and Dominica played to a 1-1 draw in St. Lucia on Thursday.

Midfielder Josh Bertie put the BVI's Nature Boys ahead three minutes into the physical game that saw six yellow cards on both sides, off an assist by Miguel Marshall, as they took their foot off the gas, allowing Turks and Caicos' Billy Forbes to knot the game at 1-1 in the 27th from a penalty.

Forbes would score again in the

76th for a 2-1 lead, before drawing a yellow card a minute later. From then onwards, the BVI who finished with eight shots on goal to Turks' 10, worked with a greater sense of urgency, in a game where they had possession of the ball 49% to Turks' 51%, but committed 19 fouls to their hosts' 10.

Five minutes into stoppage time, Smith got a pass from his One Love teammate Johari Lacey who came in as a sub with him, and fired it past Turks' Goalkeeper Sebastian Turbyfield, for the 2-2 draw, as he raced across the field with three backflips to celebrate.

"We really needed this goal and once I saw the opportunity, I had to take it," Smith said. "We really need to win and come out of our group, because honestly, we were way better than them. We could have won 5-0, but it is what it is."

Bertie said he got a pass from Marshall and was able to put it in the corner, but in the end, it was disappointing as they should have won but he's happy with the draw and not a loss.

"We stepped off the gas when we scored and should have kept going a bit, got sloppy, made silly mistakes that cost us two goals from free kicks," he noted. "We had chances and we have things to work on. The positive outcome is that we didn't lose."

As it was a big game, Coach Chris Kiwomya expected more from his team.

"We got off the hook today, but I'm really disappointed with the performance," he said. "But I think we've come a long way. We're actually drawing games now. Dominica scored in the 83rd minute, disappointed again. Our team hadn't won in 19 years (until a Sept 9 victory over Turks), so I think we're going in the right direction. But I have to try and change the mindset so we can control the game more."

Turks and Caicos Coach Ricky Hill said the goal was definitely to win and get the three points and go to Dominica with a slight chance to get six points and rely on the outcome of the Dominica vs BVI game.

"That's gone now, because we can only get a maximum of four points now," he said. "We spoke about building the foundation and trying to score the first goal, but within two minutes we were one nil down, that's how the script can go wrong. In terms of our management of the game,

knowledge of the game and perhaps our communication, we have lots of work to do."

Luka Chalwell who scored twice against the Turks and Caicos Islands on Sept 9, scored in the 29th for the BVI's 1-0 lead. Both teams had their chances on goal and BVI goalie Daniel Gilford withstood the pressure until Vice captain Briel Thomas scored in the 83rd. With the result, the BVI improved

to 0-2-8 against Dominica.

Kiwomya said his boys really worked hard, went ahead and had chances to go two goals up which would have given them a blanket and a little more confidence. "When it was one nil, we knew it was always going to be difficult," he said. "They put so many balls in the box, but they got guys six foot two, six foot three—about five of them so It's hard to defend against them, but the guys played really well."

Debutant BVI U23 Men show progress in ECVA Championships

Heart Is Deconditioned to Exercise After Airbag Injury

DEAR DR. ROACH: I am a 69-year-old who used to walk up 75 to 90 flights of steps several days a week as exercise. After a steering wheel airbag went off and damaged my heart, I am afraid my ability to do that stopped. After years of medication, I am now on a pacemaker, which definitely helps.

Could the exercise have weakened my heart to such a degree that it could be viewed as overdoing it, therefore exacerbating my condition?—Anon.

ANSWER: In general, exercise does not harm the heart. On the contrary, exercise is almost always good for the heart. However, there are exceptions. In healthy people, there is an optimal amount of exercise, and extreme levels of exercise (on the order of running more than 10 miles a day every day) begin to decrease the benefit that a person gets from exercise. (This remains controversial, but I am convinced from the data.)

In people with severe heart disease (the kind with blockages in the arteries), overdoing exercise can lead to a heart attack, but this is an exception. For every person who gets harmed by overexercising, there must be a hundred who don't get adequate exercise.

The fact that you have improved a lot on the pacemaker suggests that at least part of your problem wasn't with the pump function of your heart, nor with the arteries leading to your heart. The problem lies with the electrical supply.

Once a pacemaker is in, that problem

is immediately alleviated, but the heart may still be deconditioned ("out of shape"). Regular exercise will help the problem.

Your cardiologist can better answer the question for you and also give you advice on how to build up your exercise tolerance over time.

DEAR DR. ROACH: Colds and flus seem to linger in my lungs and nose for a week or more after all other symptoms have passed. If my phlegm and mucus are clear or white, and I feel healthy otherwise, am I still considered infectious?
—S.C.


ANSWER: The color of sputum and mucus is not a reliable indicator of whether an infection is caused by bacteria or viruses, nor of whether you are still infectious. Colds and flus like COVID are caused by viruses. A person is most infectious starting from a day or two before they get symptoms up until a day or two after symptoms start. Most people are no longer infectious after five to seven days of having symptoms, but unfortunately, that's not always 100% certain.

Part of the body's response to infection is to make a great deal of mucus to wash the infection away. This can lead to us feeling very uncomfortable with copious sneezing, runny noses and productive cough. In some people, this tendency is more prolonged. It sounds like you might be one of those people in whom the body's response to infection causes more symptoms than the infection itself.

We can test pretty well for COVID infectiousness with at-home testing, but those home tests don't exist for the flu or other viruses. Following the same advice for COVID — staying home for at least 24 hours after a fever has gone, or remaining in isolation for at least five days without a fever — will minimize your infectiousness to others.

How can stilton be called stilton when trouble finding anything to buy because it is made in Denmark, Wisconsin? It is no joke, check it out! How can Parmesan made in Argentina or somewhere in the United States be called Parmesan? The real Parmigiano Reggiano is made in Parma and Reggio, nowhere else. And how can spaghetti made in Italy be labeled as "Made in USA" when there is no way they are made in USA?

For example, my loafers are from a well-known USA company, but are made in China, why is that? Once upon a time real good shoes were made in Italy and Britain; actually they still are but they look expensive compared to cheap imitations imported from the Far East.

The only way one understands what is the problem is when the shoes fall apart as if they were made of cheap plastics or when orthopedic problems set in and cause \$\$ tens of thousands or more in remedial surgery and therapy.

Presently you have shoe shops with an Italian name well publicized on tv, newspapers and electronic media who sell shoes, flip flops, sandals etc but they are not made in Italy; they may cause serious damage to your feet, your posture, as well as to make the socalled "real leather" that would poison your system with chemicals used to imitate the real thing.

These are some of the mind boggling questions consumers like myself often ask without ever getting a satisfactory answer. What is evident is that the West, and by extension our global village, is being flooded by inferior products manufactured in the Far East, Central America and parts of Africa and imported by giant companies who resell them at 5, 10 up to 50 times their original cost.

A facebook page outlines the reasons why it is called "Ban Made in China" with the following explanation: "My New Year's Resolution is that I plan not to purchase any items that are Made FARAWAY countries. It is my hope that as I shop for everyday items, I can raise awareness of the many products that are nearly all Made In Faraway lands. In packing up all my Christmas ornaments. I discovered that most of them were made in China. I have been hanging on to some Christmas money and have had

everything I pick up has a "Made in Faraway" label. Check your house and all your earthly belongings as you put away your dishes or shop for clothes. If I disposed of everything in my home that was made in Faraway I would not have much left in my house."

An article of The National Post discloses that "acting on a tip, agents of the Food and Drug Administration paid a surprise visit to a cheese factory in rural Pennsylvania on a cold November day in 2012. They found what they were looking for: evidence that Castle Cheese Inc. was doctoring its 100 percent real Parmesan with cut-rate substitutes and such fillers as wood pulp and distributing it to some of the country's biggest grocery chains. The real Parmigiano Reggiano bears that exact name, however lousy imitations are made worldwide using names that sound-alike in order to confuse the buyer and make him/her believe is buying the real thing; these are some of the names used: "Parm; Parmiggiano; Parmagiano; Parmegiano; parmigeano; Parmigiano Reg; Regg; Reggano; reggiano; Regiano; Regianno; Reggiano Parmesan: Reggiano Parmigiano; Parmesan Reggiano.' cases like this, the Consorzio of the real Parmigiano Reggiano has successfully sued companies that encroach on their cheese's identity. Mislabeling of cheese is a big problem worldwide and it is a very serious crime. The Grana Padano is made in Lombardy

"Unfortunately - continues the director of the Consorzio Grana Padano, the most consumed PDO product in the world, starting from the first indications of the study - the alarm cry that we have been raising for some time in the national and European policy is even more serious than we thought. The consumer who goes to a store finds PDO products, such as Grana Padano and Parmigiano Reggiano, mixed with similar products of unknown origin and the lack of adequate regulations do not put him in a position to be able to choose consciously".

A situation that clashes with about 14,000 supervisory and control interventions (for an investment of over 8 million euros) that the Consorzio Grana Padano carries out every year to guarantee the excellence of the more than 4 million and 700 thousand forms produced in 2012 with an increase in exports of 7.5%.

According to Natural News "after being tipped off about possible fraud in the cheese industry, Bloomberg Business tested a variety of Parmesan grated cheeses available for purchase in grocery stores around the U.S., and discovered that a significant number of manufacturers are lying about what exactly is in their products. An independent laboratory hired by Bloomberg learned that a number of grated Parmesan cheeses marketed as containing 100 percent "real" cheese, are in fact laced with exceedingly high levels of cellulose," a common anti-clumping agent made from wood pulp.

"Caveat emptor", buyer beware not all that glitters is gold, cheap products may cause serious health problems including cancer, bone disorders, harm your eyesight, cause intoxication by chemicals... and the list goes on. It is not simply a matter of "you get what you pay for", it is the principle of fair dealing, so when you sell something that is not what it is supposed to be you are committing a crime. A trustworthy, Godfearing person, manufacturer or company would never do that. As the Italians say "To trust is good, not to trust is better!".

Message for International Day for Disaster Risk Reduction

All this means that we have a population that is well on board with the key ways they can incorporate risk reduction concepts into daily living.

But in the spirit of continued improvement, and in keeping with this year's Disaster Risk Reduction Day theme of 'Resilience for All,' I would like to call our collective attention to the fact that when disasters strike, they hit our most vulnerable persons much harder.

Having a disability is a risk multiplier when it comes to facing emergencies. A person whose sole income is a disability grant may have enough funds to meet their basic needs, but would be facing a housing crisis if their home were damaged by a storm. More frequent serious hazard impacts can put such persons in a cycle of moving from crisis to crisis. Let's break the cycle!

You may wonder, what steps have been taken at the national level to support persons with disabilities and fight inequality? I am happy to share that the Government of the Virgin Islands leads in this area. The Public Service has a modern approach to recruitment and hiring of differently-abled persons. The Ministry of Health and Social Development supports resilience of vulnerable persons with their assistance grants programme. It also encourages vulnerable persons to keep in close touch with their case managers and health care providers to maintain continuity of care.

We also have the recently completed SMART Community Centres, which were renovated with accessibility in mind. This helps to ensure that persons using a mobility device such as a walker or wheelchair can have equal access to shelter in the event of an emergency. And, as our recent EMAP reaccreditation showed, national plans and exercises include the most vulnerable of our population.

But how can we as a Territory better support persons with disabilities and other vulnerable groups in our population? In the workplace, we can build awareness about the barriers that persons with disabilities face. Employers can make sure that they hear and understand the challenges of employees and make assistive technology available to our customers and staff. Those of us with means can contribute to the organisations that work to support vulnerable persons. Volunteering your time or donating to the local food pantry enables those organisations to continue their work as part of the social safety net.

Finally, I would encourage us all to do our part to reduce the sense of isolation that may be felt by vulnerable persons. Let us practise a culture of inclusion: hire persons with disabilities and include them in our social activities. Being fully integrated participants in society strengthens the bonds of social support, which helps us achieve resilience for all.


