MISINFORMATION ABOUT VIRGIN GORDA'S MOSQUITO PROGRAMME CREATES CONFUSION

Minister for Health and Social Development, Hon. Vincent O. Wheatley, who is also the Ninth District Representative has lent his voice to the current outcries in the Virgin Gorda community about ongoing Green VI Bug Out programme and its mosquito release initiative.

The Minister's address of the

situation is in response to the fact that a number of Virgin Gorda residents expressed concern about the genetically altered mosquitos that are being released in their community as part of the Green VI Bug Out program. The apprehension of the Virgin Gordians stems from Green VI's disclosure that the released male mosquitos

carry the Wolbachia bacteria. During a meeting held on 17 October at the Old Yard Inn Conference Room Hon. Wheatley attributed the recent discord and confusion to a few individuals who he said may have been misinformed. The Ninth District Representative asserted: "People often fail to attend these crucial meetings

designed to provide the necessary information for understanding."

In an attempt to bring clarity to the situation, Hon. Wheatley pointed out that the origins of the Bug Out program can be traced back to the Chikungunya outbreaks that struck the Territory between 2012 and 2013, causing widespread panic. He noted that the Zika outbreak later in 2016 further underscored the urgency for action.

The Health Minister said that in response, the British Virgin Islands adopted an unconventional approach, and collaborated with Green VI to launch the Bug Out initiative. The primary mission of this initiative, he noted was to reduce the mosquito population, and to combat the spread of diseases like Chikungunya, Zika, dengue, and others.

Hon. Wheatley noted that despite achieving a 50% reduction in the Aedes

(Stegomyia) Aegypti mosquito population through various methods over the years, there has been no further significant progress. As such the Health Minister expressed concerns about waiting for more serious diseases such as malaria or yellow fever to emerge and stressed the need to aim for a mosquito population as close to zero as possible.

He stated that rather than resorting to the conventional method of fogging, officials opted for the Wolbachia approach, which offers a more sustainable solution. Hon. Wheatley detailed, "Extensive discussions and meetings were held to evaluate how this method would function and be received by the community." Entomologist Dr. Amy Lynd, who is part of the Bug Out team explained that since January 2023, Green VI has been releasing male Aedes Aegypti mosquitos

three times a week. Dr. Lynd clarified, "These male mosquitos have a very short lifespan, so consistent releases are necessary to mate with the emerging females from their breeding sites. We initially began

in Handsome Bay and have since expanded our operations into The Valley over the past seven months. We have further expansion plans, including areas like North Road, Fishers Cove, and St. Mary's Church."

The Bug Out program continues to navigate the fine line between public health and community concerns, with ongoing dialogue shaping its future."

PREMIER IS VERY OPTIMISTIC ABOUT THE ECONOMY AND UPCOMING TOURIST SEASON

Premier Dr. Natalio Wheatley has staunchly defended the financial health of the Territory's economy, dispelling worries of an impending downturn. During a recent press conference, political commentator Cindy Rosan questioned the Premier about the economy's apparent sluggishness in the wake of rising crime and burglaries.

Premier Wheatley, however, vehemently refuted the notion economic stagnation, pointing ongoing economic activities and tourism prospects as indicators of resilience.

The exchange began when Rosan minced no words in stating: "The economy is slow. It's not moving."

response, Premier Wheatley fired back with a flurry of examples showcasing pockets economic vibrancy within

the Territory. He highlighted key locales such as Peter Island, Norman Island, and Nanny Cay as thriving hubs commercial activity. Additionally, he offered a glimpse of the "soon-to-bedeveloped" Prospect Reef resort as a potential gamechanger set to inject new life into the local economy.

"We have a multitude of initiatives in the pipeline, many of which will be unveiled in the upcoming budget speech. These initiatives are designed to invigorate the economy, bolster small businesses, and drive growth. I firmly

believe our economy is far underperforming," Premier Wheatley asserted. While acknowledging the impact of new government spending regulations, Premier Wheatley conceded that the slowed procurement process might give the impression of reduced government expenditure in the economy.

However, Hon. Wheatley remained confident in the tourism sector, predicting a record-breaking year ahead. Premier Wheatley disclosed that the forthcoming tourist season is poised to be one of the best in the Territory's history, potentially eclipsing the remarkable 2016, which saw 1.1 million visitors. While specific figures for the current year were not disclosed, he expressed optimism regarding the prospects of a thriving tourist season.

CCTV NETWORK ACROSS THE TERRITORY IS WORKING WELL AND UNDERGOING SIGNIFICANT EXPANSION

In a recent press conference held on 12 October, Commissioner of Police Mr. Mark Collins revealed that the Territory is on the cusp of completing an extensive CCTV camera roll-out. This positive announcement came during a media inquiry into the role of CCTV footage in crime-solving and security within the BVI.

The RVIPF commenced its CCTV camera installation project a few years ago but only some areas were covered. During the press conference, a member of the media asked the Commissioner about malfunctioning CCTV cameras within the network, and in response Collins stated: "I'm not sure about any times when CCTV is not working. I mean, we have a good network of CCTV across the Territory now, and we are in the final stages of that roll-out."

Expanding on the challenges faced during the implementation process, the Commissioner explained: "There have been some delays due to the

installation of fiber optic lines and other infrastructure requirements. So, it has taken longer than anticipated. However, we also have a robust network of privately owned CCTV systems, andbusiness CCTV setups, and our officers are equipped with bodyworn cameras, which further enhance our capabilities when responding to incidents."

Highlighting the importance of video evidence, Commissioner Collins stated: "The prevalence of CCTV footage has

significantly improved our ability to gather and access evidence, thanks to both the CCTV network and body-worn cameras."

While acknowledging the occasional limitations of the system, he noted: "Of course, there will be times when an incident occurs, and the camera may not capture it, or network connectivity issues may arise. However, I must emphasize that I haven't received many reports indicating that the

CCTV system is consistently non-operational."

Earlier this year, the Royal Virgin Islands Police Force (RVIPF) had urged the VI community to embrace **CCTV** camera usage, particularly following a spate of burglaries. Chief Inspector Vernon Larocque stressed the convenience and accessibility of modern CCTV technology, underscoring its affordability and ease of installation.

PREMIER EMPHASIZES READINESS TO POSSIBLE SCHOOL SHOOTINGS

Premier and Minister of Finance, Dr. the Hon. Natalio D. Wheatley, has sounded a call to action for the Territory proactively prepare potential threats, for including the unsettling global trend of school shootings. During a press conference on 12 October, Dr. Wheatley emphasized the necessity of readiness, despite the VI having no history of such incidents.

Drawing upon his prior experience as the Education Minister, Wheatley observed that the British Virgin Islands' preparedness efforts had traditionally focused on natural disasters, a gap in addressing the distinct challenges posed by school shootings.

"As we see around the world, the alarming occurrence of school shootings and related events, even though we have not encountered such incidents here, it is our responsibility to recognize these global trends and equip ourselves accordingly," he stressed.

The Premier pledged to engage with relevant officials, with a particular focus on the Education Minister, to ensure establishment the of robust responses and comprehensive plans to effectively manage such horrendous any incidents.

Meanwhile, Commissioner of the Royal Virgin Islands Police Force Mark Collins reassured the community **RVIPF** that the already well-equipped and prepared to manage situations involving school shootings potential threats. He cited a recent incident at Elmore

Stoutt High School (ESHS) as a testament to their readiness.

During this incident, a report had been received concerning a masked individual with a firearm on the school premises. The=Commissioner commended his officers for their swift response, saying: "Within a few minutes of that incident being reported... I had a firearms commander and Chief Inspector at the school, coordinating resources and addressing the situation head-on."

This cited incident occurred on 9 October and

the Ministry of Education disclosed that the matter originated from an alleged act of retaliation connected to a stolen bicycle. It was stated that law enforcement was called in to assist, resulting in the detainment of individuals who had returned to the school premises, including one individual wearing a mask.

The Ministry clarified that no firearms or other weapons were found in the possession of those involved. An imitation firearm was discovered but was not linked to the school.

the Office of the Deputy Governor, Mrs. Sharleen D a B r e o - L e t t s o m e, MBE commented on the Government's commitment to ensuring that public officers at all levels receive the knowledge and skills necessary to be effective in their roles.

DaBreo-Lettsome Mrs. said, "We have a major responsibility to ensure that public officers at all grades are exposed to the learning and development opportunities that will aid them in the execution of their duties. This particular offering is a reflection of our commitment to ensuring that all Government employees, regardless of their career, can access opportunities for development."

Interim Director of the Virgin Islands Public Service Learning Institute, Dr. Connie E. George said, "VIPSLI is committed to building capacity throughout the service. We are putting strategic focus into ensuring the Public Service is filled with highly knowledgeable and capable officers."

Throughout the two days, the officers received information that allowed them to understand the significance of preventative maintenance, identify critical maintenance tasks, effective developing preventative maintenance plans and improving safety practices. All attendees received official certificates, highlighting the significant milestone.

The completion of this cohort of attendees marks the beginning of a training programme that will be ongoing, ensuring that all Maintenance Officers have the opportunity to advance their skills and knowledge. A second cohort of officers will partake in the training on November 16 and 17.

VI Receives Payout For Tropical Storm Philippe Damage

The Government of the Virgin Islands has received US\$552,297 from the Caribbean Catastrophe Risk Insurance Facility (CCRIF) to assist in recovery efforts

following the passage of Tropical Storm Philippe on October 4.

The storm caused widespread damage to homes, businesses,

infrastructure and agriculture in the Territory. The payout was made under the facility's excess rainfall policy and is the first since the Territory joined CCRIF in 2018.

Premier and Minister of Finance Honourable Dr. Natalio Wheatley said the Government and people of the Virgin Islands are grateful to CCRIF for the timely and much-needed financial support in accordance with the agreement, which will help with the recovery and reconstruction efforts.

Premier Wheatley said, "This payout will enable us to address some of the most urgent needs of our people and restore some normalcy to our islands."

The Premier said he recognises that additional financial and other resources will be needed to assist with the recovery process and a Contingency Warrant would be issued to the Public Work Department in the amount of \$500,000 separate and apart from the insurance proceeds, to aid with the recovery and rebuilding of the Territory from damages caused by Philippe.

Premier Wheatley congratulated the members of his government for their foresight in entering into such an insurance policy for times like these whereby they can mitigate its financial gap in funding its recovery efforts.

Contract Signed For Road Rehabilitation Works At Hodge's Creek

The Government of the Virgin Islands has signed a contract for the rehabilitation of the roadway from Hodges Creek Marina to Paraquita Bay at the Cutlass Tower.

The contract in the amount of Two million, three hundred and eighty six thousand, fifteen dollars and ninetynine cents (\$2,386,015.99) was awarded to Northam Construction Ltd and is expected to be completed in a six (6) month timeline.

Premier and Minister of Finance Honourable Dr. Natalio Wheatley stated that his Government is committed to solving the age old challenges that the Territory has in relation to road infrastructure.

The Premier said the Minister of Communications and Works has a comprehensive plan for routes throughout the Territory and is waiting on the financing to be able to execute those plans.

Premier Wheatley said, "As the budget speech is coming up, you will hear more about our plans to borrow so that we can provide the public with the roads that they deserve. Considering that I not only the Premier and Minister for Finance, but the Representative for the Seventh District, I am doubly pleased that the people of this district who have had to cope with dilapidated roads and potholes will soon see some level of relief, and I have great confidence that Northam Construction Ltd will be able to deliver the type of quality of roads that our people deserve."

Minister for Communication and Works Honourable Kye Rymer gave a synopsis of the works to be completed from Hodge's Creek Marina to Paraquita Bay and noted that going forward, roads will be rehabilitated and maintained to a higher standard than they were done in the past.

Honourable Rymer said, "The road infrastructure of the Territory requires our urgent attention and as a Government, we understand the impact that the road network has, not only in providing a smooth road for the enjoyment of motorists, but more important providing a safe passage in the prevention of accidents and safeguarding motorists and pedestrians alike."

minister The said there is the need for a comprehensive road rehabilitation programme that not only reconstructs our roadways, but includes and incorporates all the utilities such as Water and Sewerage Department, BVI Electricity Corporation the Territory's and telecommunication companies.

Honourable Rymer added, "As a result, any major roadway development to be undertaken will incorporate the plans of the various utility companies to ensure that digging up after the roads are rehabilitated would be minimised."

road rehabilitation works.

GLOBAL NEWS BRIEF

ARGENTINA - Against all odds, Sergio Massa won the first round of the presidential elections in Argentina on Sunday. Winning 36.6% of the vote, the economy minister put a stop to the far-right tsunami. Javier Milei, the political phenomenon who burst into Argentine politics ready to break everything with a chainsaw, won 30%. The two will head to the runoff on November 19.

The results of the first round of the presidential election was a miracle for Massa and a frustration for Milei, who was hoping win the elections outright (by winning 45% or reaching 40% with a difference of 10 points over the runner-up). In the case of Massa, the victory was particularly miraculous given the dire economic state of the country, where inflation is at 140%, 40% of people live in poverty and the Central Bank is in the red.

At the end of the day, the fear of Milei was greater than voters' anger at the government. Coming in third place was Patricia Bullrich, from Juntos por Cambio (Together for Change), the alliance that

brought Mauricio Macri to power in 2015. The former security minister won 23.8% of the votes and was knocked out of the race. It is a historic defeat for Argentina's traditional right, which did not see Milei coming and is struggling to staunch its decline. [EL PAIS]

ISRAEL - Israel has declared war on the Hamas militant group after surprise multifront terror attacks by Hamas from Gaza on October 7. The current conflict has already claimed thousands of Israeli and Palestinian lives.

Israel has said it struck Hamas targets in Gaza on Monday as well as thwarting a Hezbollah strike from Lebanon. Meanwhile, Gaza's Hamas-run Health Ministry says the death toll has passed 5,000.

At least 5,087 Palestinians have been killed since Israel launched retaliatory air strikes in Gaza on October 7, the Hamas-run Health Ministry in Gaza said.

Of those, 2,055 were children, and 1,119 were women. Another 15,273 people were wounded in the strikes, the ministry said.

The numbers of dead and injured from Gaza cannot be independently verified

Israel declared war on Hamas after the militant group broke through border defenses and killed more than 1,400 people in Israel on October 7.

Israel says it only strikes Hamas militants in the densely populated Gaza Strip. Civilians caught in the crossfire, however, have borne the brunt of the war.

Palestinians have been cut off from food and water. EU foreign ministers are meeting Monday to discuss the situation as muchneeded aid slowly trickles into Gaza. [Deutsche Welle]





1/4 cup cold coffee or water

3 fresh unpeeled ripe Bosc pears

1 tablespoon cornstarch

Preheat your oven to 350 F and generously grease a 9-inch springform pan.

Begin by mincing the crystallized ginger with a teaspoon of granulated sugar (this helps prevent

skull shapes.

Wash the pears but do not peel them. Cut them in half lengthwise and use a small spoon or apple corer to remove the core and the vein that runs to the top stem.

Position the halved pear so the flat side is down and the larger end of the pear is on top. Use a small spoon or apple corer to scoop out two holes for the eyes, then cut out the nose with a very small spoon or a straw. Use a paring knife to score the smaller end to look like teeth.

Drain excess moisture by placing them flat side down on paper towels. By now, your brownie should be partially baked. Remove the brownie and reduce the oven

temperature to 300 F.

On a small plate, combine cornstarch with a teaspoon of sugar. Dip the cut side of each pear into the cornstarch mixture before placing them artistically on top of the partially baked brownie. Whip the reserved egg white with a teaspoon of sugar until frothy. Brush this glaze over the skulls.

Return the skull-infested brownie to the oven for 50 minutes.

THE FOUR PENCE AND ONE SHILLING STAMPS

In 1867 Waterlow & Sons, as subcontractors of Nissen & Parker printed a One Shilling stamp depicting the Virgin St. Ursula. The design was to inspire a lower 4 Pence denomination issued the following year.

The printers wanted to impress and produced this One Shilling stamp with a rather innovative bi-coloured process. The background design in rose carmine was printed in lithography, while the central figure of the Virgin in black was typographically printed separately in a second phase.

The frame of the basic 1867 One Shilling underwent two changes, the first and more subtle one merged the two lines into a single one. Copies with double-lined frame were largely utilised to make up a later third type with large crimson frames superimposed and are extremely difficult to locate. As was the case with their 1d and 6d. predecessors the doublelined frame stamps were printed on white and toned paper. THE MISSING VIRGIN

The early stamps are keenly studied by specialists and collectors who appreciate their beauty, exotic background and intrinsic rarity. Their price is still within reach even of collectors with relatively modest means, and the existence of three highly priced rarities is no deterrent for the serious collector.

The most remarkable stamp of the Virgin Islands Victorian era was never put on sale at the Road Town post office. In 1890, twenty-three years after its printing, the Virgin Islands 1 shilling error with the typographically printed figure of the Virgin omitted was discovered in London in a shop in the old Booksellers Row. The stunning error, of which only five examples are said to exist, was estimated between US\$160,000-220,000, but it is believed that when an example of this rarity is auctioned, it may fetch a much higher sum.

Despite its fame and glamour, the "The Missing Virgin" is not the rarest stamp of the Virgin Islands. There are at least two varieties of the One Shilling stamp with large crimson frames superimposed and overprinted "4D" which are much rarer.

Collectors who want to learn more about the stamps of the British Virgin Islands are encouraged to secure a copy of the "Specialised Stamp Catalogue of the British Virgin Islands: 1787-2001" by contacting the BVI Postal Administration.

The issues of the 1880s are guite attractive and hold much interest for the scholar. These stamps were the first local stamps to depict Queen Victoria; they utilised a common design featuring the profile of the monarch's head, turned left. They were introduced to save on stamp production costs; this was made possible by using the same key plate for nine different colonies and by inserting the colony's name using a duty plate.

The BVI was admitted into the Universal Postal Union on 1 July 1870 and, as a result, the first task was to adjust the postage rates. The available stocks would have been sufficient were it not for the lack of a 1/2d. denomination needed for inland mail and for making up the newly introduced 2 1/2d. rate. In the event, the comparitively inexpensive uniform 'Key Plate' type depicting the monarch was adopted and a redbrown 2 1/2d. denomination in this design was issued.

Ultimately, however, the colour of the stamps had to be changed to conform to the UPU 'scheme' (green for printed paper rate; red for postcard rate and blue for letter rate); this was eventually accomplished in two stages but not without some practical and philatelic consequences. In fact, the 'Key Plate' types printed in unorthodox col ours succumbed to a premature demise. As a pertinent postscript it should be noted that, beginning in 1879, the UPU rate for 1/2 oz letters addressed to any member country was 4d. This, however, does not mean that the 4d denomination was the most heavily used since in making up that rate, more often than not, a combination of smaller denominations was used.

THIS WEEK IN CORRUPTION CORRUPTION AS A FUNDAMENTAL THREAT TO PEACE AND SECURITY

The United Nations recognises that democracy is the best way to bring about international peace, and research has proven that democratic countries do not go to war against each other.

But right now, democracy is backsliding around the world - and corruption is one of its greatest antagonists.

The Russian invasion of Ukraine in February 2022 exemplified how corrupt authoritarian regimes threaten international peace, security and economic stability. After his return to power in 2012, Vladimir Putin embarked on a campaign to remove constitutional checks on his authority. Under his leadership, the Russian government has successfully weakened the autonomous

political institutions, organisations and individuals that could constrain Putin's power or hold him accountable, cracked down on political opponents, passed new legislation that limits the space for civil society, banned almost all independent media and chased opponents into exile. At the same time, favouritism in the allocation of public contracts, licenses and concessions, kickbacks and other corrupt schemes helped a small group of oligarchs amass great fortunes that largely depend on their loyalty to the regime. In short, corruption facilitated the consolidation of autocracy in Russia, and once Putin was firmly entrenched in power, he had a free hand to pursue whatever policies he wanted - including war - with little opposition from domestic political and economic elites. Such blurred lines between business and politics in the country explain the lack of public opposition to Putin's decision to invade Ukraine even after several rounds of sanctions that have weakened the Russian economy.

The Russian invasion of Ukraine is perhaps the most extreme example of the dangers that serious corruption and weak checks on power at the domestic level can ultimately pose to international peace and security. Corruption, however, can also be used in much less obvious ways to destabilise a country. There are several historical examples of colonial and postcolonial powers deliberately corrupting the leaders of lands they sought to control. In the past few years, countries like Russia (28), Iran (25) and Qatar (58) have also exploited domestic loopholes in anti-corruption and government integrity systems to: weaken

political actors that threaten their interests; advance foreign policy goals; and undermine the people's trust in the government and institutions of the target country.

This poses a significant threat even for countries with high levels of public integrity and effective anti-corruption controls. While the threats might come from abroad, the vulnerabilities - including loopholes in lobbying, political finance and conflicts of interest regimes - are often home-grown and require action at the national level. Even countries at the top of the Corruption

Perceptions Index (CPI) need to look critically at their anti-corruption frameworks. These countries need to fully implement their international anti-corruption commitments and close the loopholes in their financial systems which help foreign actors - from corrupt politicians to organised crime leaders - hide their illgotten gains and undermine democracy. They also need to prioritise transparency of asset ownership, especially companies, trusts and real estate.



While the examples above show how domestic levels of corruption can become a source of regional or global instability or make a country vulnerable to undue influence from foreign actors, most of the research on the links between conflict and corruption highlights the destabilising effects of corruption within national borders. It is well documented that conflict creates new opportunities for bribery, rent-seeking and theft of public resources. In turn, corruption can also fuel conflict by:

- generating new or stimulating existing grievances in society that fuel violence
- weakening the capacity of the state to protect its citizens from threats like organised crime and terrorism, including by limiting the effectiveness of defence, security and law enforcement institutions
- undermining trust in government and the legitimacy of the state, which limits the state's ability to mediate emerging conflicts and credibly enforce negotiated agreements
- Cross-country studies have also found that anti-corruption is as important as a country's bureaucratic capacity in preventing the outbreak of civil war. Transparent and accountable governments that enact policies to benefit society at large instead of the narrow interests of a few tend to be better at keeping the peace within their national borders.

Capital is multigenerational

Inherited Capital is the greatest source of social inequality. Capital ownership keeps specific families on top the social and wealth pyramid, for multiple generations. Capital and power are synonyms. The system of social class with its various divisions sits on the ownership of capital and wealth above any other consideration.

In the Virgin Islands, land ownership- land is capital- by the native population after slavery and the plantation, propelled certain families up the social ladder who remain at the top even to this day, aided by distinctions such as the ability to read and write, speak the Queen's English, wile, and a fairer skin.

OK. A glance at the list of global corporations and their owners tells a story. Most of these businesses are American, Chinese Pacific, and European. From Walmart to JP Morgan, Facebook to Twitter, Ali

Baba to Tik Tok, Virgin Atlantic and Dyson, Marriott to the Hilton, Apple and Google, Tesla and Exxon Mobil, Cartier, Christian Dior, and Louis Vuitton, then add a host of international businesses, from India to South Korea and Mexico to Nigeria —corporations concentrate wealth and power in a few hands.

Global capital, controlled by a handful of people and their families is the reality: the norm. Global corporations and their owners rule the world. Albeit, fund managers, trusts, offshore accounts, foundations, and complex securities, disguise this ownership. Global Capital uses an army of lawyers, accountants. bankers. financiers, security types, and administrators: the buffer between the 1% and the rest.

Then, the nature of capital is such that it outlasts its owners who are wise enough to ensure the control of these assets stays within their families or a select group of individuals and organizations after they die.

A second reality is that in societies that are strong scientifically, socially, and economically, sustaining wealth from one generation to the next is much easier than in poorer lands. A billionaire in the USA is better able to ensure future generations enjoy his wealth than a billionaire in Nigeria.

Social and economic stability better protects the wealthy. In a crisis-ridden land and war-torn country, a fortune is lost at the drop of a hat if the investor is not cautious.

Now, capital can pre-exist wealthy individuals, who are heirs to capital owned by their forebears, this achieved with wills, trusts, and foundations, the means of ensuring the continuing hegemony of the founders and pioneers after death. Trusts and wills ensure their children are unable to dispose of that capital when they pass on, this achieved complex through elaborate legal and financial device.

One of the features of wealthy families is that they are inheritors of wealth and capital. The idea that all start at the same level, and have access to the same opportunities, for example, the idea of the "American Dream" is fairy tale.

Inheritance drives social inequality in spite of attempts by socialist governments to create a level playing field through wealth tax, inheritance tax, and progressive taxation. Two similar individuals with equal competence, where one inherits millions and the other encumbered by poverty and deprivation. It is easy to know who will prevail in the game of life. Capital will ensure the former rules over the latter.

Then geography is a major part of why social inequality exists globally. A child born in a rich country with an income per capita exceeding \$50K with access to great healthcare and

education has better life chances than a child born in a poor and destitute country where the average income is \$1K per annum and life expectancy is 50. Education and competence may aid the child in the poor country, but usually that means migration to the richer land.

Capital ownership and inheritance are by no means the only factors in the wealth stakes. Education, competence and sheer good fortune all factor into why some are wealthy, middle income, and poor. Inheritance remains invincible as the route to wealth, however. Capital and its ownership is the most brutal divider of men into the different social and income groups. That is the narrative of history.

Robust growth to continue in Guyana - IMF

GEORGETOWN, Guyana, CMC – The International Monetary Fund (IMF) in its new Regional Economic Outlook report for the Western Hemisphere says Guyana will continue to experience robust economic expansion even as other countries in Latin America and the Caribbean face less favourable growth conditions and brace for a slowdown in their productive sectors.

The report noted that Guyana should record a 38.4% real Gross Domestic Product (GDP) growth rate this year and next year, the country's growth should continue with an expansion of 26.6% expected.

The debt taken on by the government is projected to be about 29.9% of GDP while a 7.2% inflation rate is also expected.

This debt refers to all external financial obligations including loans taken while inflation, generally, is the rate of price increases over a period of time.

Guyana is the only country expecting double-digit growth.

St Vincent and the Grenadines (6.2%) and Panama (6.0%) are the countries with the next highest growth rates.

The entire Latin America and Caribbean region expects a 2.3% growth rate this year while growth among the non-tourism-dependent countries in the Caribbean – Haiti, Guyana, Suriname, and Trinidad and Tobago -should be 13.6% this year.

The IMF also projects a 1.6% growth rate for South America and a 3.8% growth rate for the bloc of countries encompassing

Central America, Panama, and the Dominican Republic.

In Guyana's case, massive oil finds offshore are contributing to the high economic growth rates expected.

"... growth in the Caribbean commodity exporters will slow down in 2023 and further in 2024 as these countries face less favourable external conditions, although Guyana will continue to grow at a robust pace following the discovery of sizable oil reserves," the IMF said.

The slowdown in other

countries has been attributed to a weaker external environment, severe weather conditions, and a softening demand for tourism services.

In September, President Dr Irfaan Ali announced that Guyana recorded a 59.5% economic growth rate at the half-year mark with the non-oil economy growing by 12.3%.

Johnson Next Republican to Try to Win House Speaker Role

Another Republican in the U.S. House of Representatives may seek a floor vote Wednesday to try to become the chamber's next speaker, after lawmakers struggled for three weeks to fill one of the top leadership roles in the U.S. government.

Republicans meeting in a closed-door session late Tuesday picked Representative Mike Johnson as their latest House speaker candidate, and the fourth since Representative Kevin McCarthy was ousted from the job.

Johnson is a lawmaker from the state of Louisiana who rallied Republicans around former President Donald Trump's legal effort to overturn the results of the 2020 election.

He received 128 votes Tuesday night to beat other candidates. McCarthy, who was not a declared candidate, came in second place with 43 votes.

It was unclear if Johnson would be able to muster the support of most of the Republicans in the House, something the three previous candidates to replace McCarthy have been unable to do.

Republicans hold a slim 221-212 majority, and with Democrats united behind House Democratic Leader Hakeem Jeffries, any Republican candidate can only lose a few Republican votes and still achieve the simple majority threshold to win the speaker role.

Republicans moved on to Johnson after another candidate, Representative Tom Emmer, withdrew his candidacy earlier Tuesday.

Emmer had outlasted eight other candidates in rounds of secret balloting. The 62-year-old Emmer has served as majority whip, one of the top leadership posts in the House Republican Conference, since earlier this year.

Former President Donald Trump posted on his Truth Social media platform early Tuesday afternoon that he did not know Emmer well and referred to him as a RINO – a term meaning Republican in Name Only.

"The Republican Party cannot take that chance, because that's not where the America First Voters are. Voting for a Globalist RINO like Tom Emmer would be a tragic mistake!" Trump posted.

As many as 20 Republican House lawmakers said they would not vote for Emmer, leading to his withdrawal.

The role of speaker of the House has been vacant since October 3 when eight Republicans joined with all 212 House Democrats to make McCarthy the first-ever

Republicans made their fourth pick in two weeks, underlining the chaos engulfing the fragmented party after previous nominees failed to win the gavel.

speaker to be removed from his position.

A right-wing faction of the Republican Party was displeased with McCarthy for passing a short-term measure funding the government to keep it open past a September 30 deadline with Democratic legislators' help.

Since McCarthy's ouster, House Republicans have been unsuccessful in coalescing around a replacement. They first nominated Representative Steve Scalise of the southern state of Louisiana, who was not able to secure the needed votes.

The Republican caucus next gave its nod to Representative Jim Jordan of the Midwestern state of Ohio. Jordan is a conservative firebrand and staunch supporter of

But Jordan also failed to gain a 217-vote majority in the House, falling well short on a first vote in the full House and then losing ground on two subsequent ballots.

The Republican infighting has left the role of speaker unfilled, leaving the House unable to respond to crucial budget matters. A Nov. 17 deadline looms for budget issues to be resolved or a partial government shutdown will go into effect.

The speaker of the U.S. House of Representatives is second in the line of presidential succession.

Sudan Cease-Fire Talks to Resume Thursday in Saudi Arabia

Talks between Sudan's warring factions will resume Thursday in Jeddah, Saudi Arabia, with a focus on securing access for humanitarian aid to reach beleaguered civilians, according to senior U.S. State Department officials.

The United States and Saudi Arabia have brokered multiple cease-fires between the Sudanese Armed Forces (SAF) and the paramilitary Rapid Support Forces (RSF) at talks in Jeddah since May, but fighting has continued in Khartoum and elsewhere, with each side accusing the other of cease-fire violations.

The U.S. adjourned the talks on June 21.

"The new round will focus on ensuring unhindered humanitarian access, achieving cease-fires, and other confidence-building measures to create conditions for the safe delivery of humanitarian assistance," a senior official said.

The official emphasized that Thursday's talks will not tackle political matters, as both belligerents have been clearly informed that "there is no acceptable military solution to this conflict."

The SAF and RSF have been fighting each other since April 15, triggering a humanitarian crisis in Sudan and in neighboring countries.

Senior U.S. officials have stated that both sides, by choosing to pursue conflicts that involve indiscriminate artillery and drone strikes causing civilian casualties, have demonstrated their unsuitability for governance in post-conflict Sudan.

Sudan's neighbors in the Horn of Africa are playing a role in the latest negotiations as the regional bloc IGAD, or Intergovernmental Authority on Development, will facilitate the resumed talks.

IGAD Executive Secretary Workneh Gebeyehu, a former foreign minister of Ethiopia, will take part in the talks for the African Union.

"We've been in constant communication with our colleagues from IGAD, as well as the African Union. They are in agreement that relaunching Jeddah is essential," another senior State Department official told reporters in a phone briefing.

IGAD is one of the regional economic communities recognized by the African Union. It has eight members: Djibouti, Eritrea, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda.

Sudanese civilians need access to the essentials of life, which include food, shelter, medicine and security, says Alex Rondos, senior adviser for United States Institute of Peace's Africa Center.

"The toughest and boldest decision for Sudan is whether an external force will be needed to protect supply routes, logistics centers and critical infrastructure," Rondos wrote in a recent Peace Institute publication.

Sudan has become the largest internal displacement crisis in the world. An estimated 5.6 million people have been displaced within and outside Sudan after more than six months of fighting, according to the United Nations Office for the Coordination of Humanitarian Affairs.

After returning from the inclement weather affected 'Battle of the Saints' Netball Tournament in St. Maarten with a bronze medal, Technical Director of BVI Netball Mandi Atack, said their aim is to raise the awareness of the sport.

"Literally, we are starting to encourage the government to understand, that we are serious about making netball in the BVI, something that people should be proud of," Atack said. "The girls that went out on this tournament, made the BVI proud. They've come back with a trophy, medals around their necks, social media has pushed us this weekend, which has been amazing and people have acknowledged that and have shared the social media and encouraged all the women that traveled this time, to bring back a trophy. We brought back that trophy, so therefore, give us a few

years and we could be something to reckon with."

The BVI opened the tournament with a 90-18 loss to St. Kitts-Nevis, then rebounded with a 63-10 victory over Guadeloupe. They lost the next two to St. Maarten, 67-45 and 51-41.

"It was an amazing experience it was definite exposure for the BVI team to see what is required to take on an international netball tournament. And it was a huge learning curve in which my girls came out fully learning and positive with it," Atack said. "They are so keen now to take on other countries and to start getting more matches under their belt, to get ranking points, in order to get ranked in the world."

The idea of the tournament Atack noted, was for each country to play each other twice, then playoff for medals and all teams could have had ranking points, but Tropical Storm Tammy interrupted play and they were only able to get the minimal number of matches in,

in order to get the ranking points for the tournament—now World Netball. Atack described St. Kitts as a semi pro team that is already ranked. She said it was an awesome experience for the girls.

"Their eyes were opened to how netball is played outside of the BVI and they had that shock for the first time," she noted. "When they came out against Guadeloupe, they came out firing. Each time they played, they got better and better. It's just a shame that we weren't able to squeeze in a couple more games, in order to show their true colors of what they can actually do."

Against St. Maarten, she said they were able to see them play, analyzed them and knew what they had to do. They went out there, tried their best and when that didn't work, they adapted. She was proud of the team keeping St. Maarten within 10-12 points. Furthermore, she noted, they also need to travel with more than 12 players to make switches, in case there's an injury, it doesn't take the team down, which also keeps fresh legs on the

"The girls have tried with their fitness throughout, but now I think they really appreciate what our fitness trainer has put them through, they now appreciate why he does that," Atack said. "Each time they go to their fitness class, they'll step up even more, in order to prove they can survive 60 minutes, full out."

As they were unable to obtain the ranking points they're seeking, Atack said BVI Netball need to invite international teams in order to play top class netball, and people understand that the sport which was played annually between 1972 and 1992, including playing in the Caribbean Netball Tournament, be brought back to the territory.

"Bringing those teams in and people understanding what netball is again, we can only then grow from there," she said. "Once people understand it's a fascinating sport and enjoyable to watch, we hope the schools will start to bring that into their educational strategies."

A new course will be unveiled on Saturday when the Mourant College Classic Series opens at 7 a.m. on Virgin Gorda.

Even though we were giving medals for the top awardees, we were still able to give something through our sponsors, so it was an added incentive maybe for your efforts in getting up so early. I think people get up early every year as they look forward to the races which I'm happy about."

The race on Virgin Gorda Russ Penn said, is a race for a cause and she has been happy that they have been able to maintain a relationship with the Valley Sound Lions Club, who have been instrumental in the success of races there. This race focus is on breast cancer and people are encouraged to wear pink.

"Persons are encouraged to come out and bring a donation, so that we can all collectively contribute to breast cancer awareness for this first race," Russ Penn said, noting that for the Nov 11 race in Virgin Gorda the focus will be on diabetes awareness and persons are encouraged to wear

The final race on Tortola will be on Nov 4. Tropical Storm Tammy cancelled the Oct 21st race and she said that she's evaluating the format for the final race as the plan was to run it as the Elite Relay Exchange, which has become a nice addition to the series in the last two years.

two, I'm evaluating which is the best format to use," Russ Penn said. "And it's possible that we might run it as an individual race like race one and forego the Relay Exchange for 2023. I'll make that decision by the end of this week, before we start to promote that race but it will be the final race in Tortola."





• I read that Martin Scorsese's new movie is more than three hours long. Will it have an intermission? What is the longest movie ever made anyway? — K.K.

• Widely considered one of America's greatest film directors, Martin Scorsese is known for making films that are anything but short. His latest release, "Killers of the Flower Moon," clocks in at three hours and 26 minutes, and he makes no apologies for not having an intermission. He recently told the Hindustan Times that if viewers at home "can sit in front of the TV and watch something for five hours," people can sit and watch a movie in theaters for more than three hours.


However, he doesn't mention that many Broadway plays and musicals do include intermissions, and those who prefer the couch to their local movie-house have the option to hit pause for a bathroom break. But if "Killers of the Flower Moon" turns out to be as great as the initial reviews are stating, you won't want to take a break, even if your bladder has other ideas.

According to Guinness World Records, the longest film ever made is the aptly titled "The Cure for Insomnia," an 85-hour experimental movie that was released in 1987. Before that film, 1963's "Cleopatra," starring Elizabeth Taylor, premiered at four hours and three minutes, but was then edited down to three hours and four minutes.

When "Titanic" came out in 1997, the debate about intermissions was brought up. Director James Cameron didn't seem concerned, though, and even went beyond that length last year with his film "Avatar: The Way of Water," which audiences flocked to see despite it being three hours and 12 minutes.

Also, despite its definitive-sounding title, the series' creator, Andy Breckman, says that he hopes to follow it up with another movie someday. "A Monk Movie" premieres Dec. 8 on Peacock.

Q. Is it true that Michael Caine is retiring from acting? What was his final movie? — B.N.

A. Yes, the acclaimed two-time Oscar winner Michael Caine is now 90 years old and is done accepting roles. He's starred in more than 100 films and wants to end his career on a high note, having earned great reviews for his current and final film "The Great Escaper." In the movie, he plays a nursing home resident who breaks out to attend the 70th anniversary of the D-Day landings at Normandy.

However, Caine isn't done exploring art. He's written his first work of fiction, a thriller called "Deadly Game," and plans to keep writing. "Deadly Game" will be released on Amazon and in stores on Nov. 23.



Heart Is Deconditioned to Exercise After Airbag Injury

DEAR DR. ROACH: I am a 69-year-old who used to walk up 75 to 90 flights of steps several days a week as exercise. After a steering wheel airbag went off and damaged my heart, I am afraid my ability to do that stopped. After years of medication, I am now on a pacemaker, which definitely helps.

Could the exercise have weakened my heart to such a degree that it could be viewed as overdoing it, therefore exacerbating my condition?—Anon.

ANSWER: In general, exercise does not harm the heart. On the contrary, exercise is almost always good for the heart. However, there are exceptions. In healthy people, there is an optimal amount of exercise, and extreme levels of exercise (on the order of running more than 10 miles a day every day) begin to decrease the benefit that a person gets from exercise, (This remains controversial, but I am convinced from the data.)

In people with severe heart disease (the kind with blockages in the arteries), overdoing exercise can lead to a heart attack, but this is an exception. For every person who gets harmed by overexercising, there must be a hundred who don't get adequate exercise.

The fact that you have improved a lot on the pacemaker suggests that at least part of your problem wasn't with the pump function of your heart, nor with the arteries leading to your heart. The problem lies with the electrical supply.

Once a pacemaker is in, that problem

is immediately alleviated, but the heart may still be deconditioned ("out of shape"). Regular exercise will help the problem.

Your cardiologist can better answer the question for you and also give you advice on how to build up your exercise tolerance over time.

DEAR DR. ROACH: Colds and flus seem to linger in my lungs and nose for a week or more after all other symptoms have passed. If my phiegm and mucus are clear or white, and I feel healthy otherwise, am I still considered infectious? —S.C.

ANSWER: The color of sputum and mucus is not a reliable indicator of whether an infection is caused by bacteria or viruses, nor of whether you are still infectious. Colds and flus like COVID are caused by viruses. A person is most infectious starting from a day or two before they get symptoms up until a day or two after symptoms start. Most people are no longer infectious after five to seven days of having symptoms, but unfortunately, that's not always 100% certain.

Part of the body's response to infection is to make a great deal of mucus to wash the infection away. This can lead to us feeling very uncomfortable with copious sneezing, runny noses and productive cough. In some people, this tendency is more prolonged. It sounds like you might be one of those people in whom the body's response to infection causes more symptoms than the infection itself.

We can test pretty well for COVID infectiousness with at-home testing, but those home tests don't exist for the flu or other viruses. Following the same advice for COVID — staying home for at least 24 hours after a fever has gone, or remaining in isolation for at least five days without a fever — will minimize your infectiousness to others.

HYPERTENSION ONE OF THE MOST NON COMUNICABLE DISEASES IN THE REGION

The Trinidad-based Caribbean Public Health Agency (CARPHA) says hypertension, also known as high blood pressure, is the number one risk factor for illness and premature death from cardiovascular disease, and one of the most common non-communicable diseases (NCDs) in the Caribbean region.

"This disease may undetected, getting thus your blood pressure checked especially frequently is important that timely SO treatment, including lifestyle changes and/or medication. can be started to reduce progression to complications." said CARPHA's Dr Joy John in observance of World

Hypertension Day.

World Hypertension Day is being observed this year under the theme "Measure Your Blood Pressure Accurately, Control It, Live Longer," with health officials saying the objective is to raise awareness, promote hypertension detection and encourage citizens of countries to prevent and control this silent killer. CARPHA said that the non-Latin Caribbean has the greatest mortality rate from cardiovascular disease, estimated at 418 per 100,000 inhabitants.

It said that a study that examined 10-year mortality trends in 20 English and Dutch-speaking Caribbean countries found that cardiovascular disease accounted for most deaths, estimated at between 13-25 per cent, with Montserrat,

Bermuda and Trinidad and Tobago having the highest percentages.

In the adult population aged 30-79, the regional agestandardized prevalence of hypertension was 35.4 per cent in 2019. It was more substantial in men (37.6 per cent) compared to women (33.3 per cent).

The Pan American Health Organization (PAHO) in 2021 noted that the top 20 per cent of countries in the world with the highest prevalence included countries in the Caribbean, with Dominica (47.7 per cent) having the highest prevalence and Belize with the lowest prevalence (38 per cent).

From PLR and other sources this newspaper has learned that hypertension is often called the "silent killer" because it can damage your heart, kidney, and brain, even though you feel no symptoms. Blood pressure is the force exerted by circulating blood on the walls of blood vessels, and constitutes one of the principal vital signs. If your blood pressure is normal, you can work with your health care team to keep it that way. If your blood pressure is too high, you need treatment to prevent damage to your body's organs. High blood pressure is dangerous because it makes the heart work too hard and contributes to atherosclerosis (hardening of the arteries). Blood pressure is a measure of how hard the blood pushes against the walls of your arteries as it moves through your body.

Doctors do not know what causes high blood pressure in

90 to 95 percent of people who have it. In about 10 percent of patients, the disease can be traced to specific causes: heredity, abnormalities. adrenal gland tumors, diabetes, chronic kidney disease, hormone abnormalities, use of birth control pills, pregnancy or a congenital narrowing of the aorta. Other possible causes of higher blood pressure are weight gain and decreased physical activity in winter. The nicotine in cigarettes and other tobacco products causes your blood vessels to constrict and your heart to beat faster, which temporarily raises your blood pressure. In some people, alcohol causes blood pressure to rise quite a lot.

The key for any high blood pressure treatment is to bring the condition under proper control. Treatment depends on how high your blood pressure is, whether you have other health problems such as diabetes, and whether any organs have already been damaged. Treatment begins with changes you can make to your lifestyle to help lower your blood pressure and reduce your risk of heart disease.

You want to achieve your treatment goal, but sometimes it seems your blood pressure just doesn't want to budge. You and your doctor can carefully review your treatment and lifestyle to see what's going on.

For hypertension that isn't controlled by diet and exercise, new treatment guidelines for hypertension recommend that most patients be started on a thiazidetype diuretic, unless there is a compelling need for a different class of medications.

However, the biggest problem with treatment of high blood pressure is not a lack of knowledge, but a lack of the application of our current knowledge.
