Tropical Storm Philippe unleashed a deluge of heavy overnight rains on the British Virgin Islands, wreaking havoc on the night of October 3 and the morning of October 4. The relentless rainfall triggered widespread flooding, rock slides, power outages, and the closure of schools, government offices,

and airports across the Territory.

Reports of flooding poured in from various areas of the Territory, including Road Town, Purcell, Huntums Ghut, Pasea, Sea Cows Bay, and West End. In a startling sight, cars were partially submerged on Flemming Street in Road Town,

highlighting the extent of the inundation.

The British Virgin Islands Electricity-Corporation (BVIEC) issued an official statement-confirming power outages that affected numerous areas throughout the Territory during the hours when a flash flood warning was in effect. The

combination of heavy rains power disruptions compounded the challenges faced by residents and authorities.

In response to the ongoing crisis, His Excellency Governor John Rankin addressed the public with an early morning statement on Wednesday. Governor Rankin assured residents that Tropical Storm Philippe was gradually moving away from the Territory, albeit with lingering rainfall. He stated: "Rainfall continues this morning and is expected to do so throughout the day as Philippe moves away from our area. Rainfall amounts of 3-4 inches were recorded in parts of the Virgin Islands last night."

Governor Rankin emphasized that the Territory remained under a flash flood warning until 4:00 p.m on Wednesday, urging residents to exercise utmost caution. expressed concern about the deteriorating road conditions, acknowledging that several routes had become impassable.

His Excellency implored all residents to remain at home and prioritize safety during these challenging conditions. He stressed that staying indoors was the best way to mitigate risks and allow emergency responders to address the consequences of the storm.

As the British Virgin Islands grapples with the aftermath of Tropical Storm Philippe, residents are encouraged to stay informed through official channels and adhere to safety advisories issued by local authorities. The community's resilience and solidarity will undoubtedly play a crucial role in overcoming the challenges posed by this natural disaster.

YEAR-LONG FOOD FÊTE SCHEDULED TO START IN NOVEMBER

The BVI Food Fete Yearlong celebration has taken off with a bang, igniting the taste buds and setting the stage for an extraordinary culinary journey in the British Virgin Islands. The event which was previously only a month long, is now being extended to ensure that more visitors to the Territory can enjoy the culinary offerings of BVI.

The series of events was unveiled on 2 October by the BVI Tourist Board & Film Commission (BVITBFC) during a media brunch event at Main Street Restaurant BVI Ltd. It was announced that the Food Fête will take place between November 2023 and June 2024 with a major drive to showcase that the BVI is a foodie's dream come true.

During the launch event members of the BVI Tourist Board explained that the Food Fête is aiming to not only showcase the diverse culinary experiences available in the Territory but also attract more tourist to the destination.

While there are several exciting events lined up celebration, one event was noticeably missing. The absentee from this year's lineup is the Jost Pork event that has been part of the Food Fete Calendar over the last few years.

Director of the BVI Board. Tourist Clive McCoy, explained that the decision was made based on feedback from Jost Van Dyke residents. He said that the community was not thrilled about the event and the BVITB listened to the concerns and decided to replace the Jost Pork event. As a result, the Tourist Board has introduced the Jost Lime & Dine promotion, which includes a ferry service to facilitate dining on the sister island.

McCoy shared details about the Jost Lime & Dine promotion, stating, "As the name suggests, it's Jost Lime & Dine, and we know what Jost Van Dyke is all about. It's about liming and having a good time, so we are expecting them to put their best foot forward, showcase their menu, showcase

those nights on Saturdays and Wednesdays in February and all the Saturdays in January."

The TB Director explained that in order to make dining on Jost Van Dyke more accessible, the BVI Tourist Board will provide a complimentary ferry service for individuals returning from the island as part of the promotion. However, he stated that visitors will be responsible for their own transportation to Jost Van Dyke.

Despite the absence of the Jost Pork event, the BVITB has put extensive thought and effort into this year's BVI Food Fête. The yearlong celebration will kick off with the highly anticipated Anegada Lobster Festival from 24 to 26 November. Other events included in the line-up are A Taste of Virgin Gorda on 16 March and A Taste of Tortola on 29 June. With these exciting events and more, the BVI Food Fete Year-long celebration promises to be grander and more spectacular than ever before.

WORKERS MUST REPORT **WORKPLACE GRIEVANCES:** LABOUR MINISTER SAYS

Minister with responsibility for Labour Hon. Lorna Smith has issued a heartfelt plea to workers, urging them to promptly report any workplace grievances to the Labour Department.


During a recent address in the House of Assembly, Hon. Smith disclosed that labor-related issues stood out prominently among the complaints she encountered while visiting Virgin Gorda in her capacity as the Territorial At-Large Representative.

Notably, amidst these complaints, the Minister identified a pervasive sense of fear among employees grappling with uncomfortable workplace situations. She implored members of the public not to let this fear deter them from seeking assistance from the Labour Department, emphasizing that it was essential to either visit the department's offices or make contact via phone.

The Minister of Labour also offered an example of the types of complaints she has received. She explained that some individuals were unknowingly working beyond the 40-hour threshold without understanding their rights, emphasizing the importance of consulting the Labour Department to gain clarity on such matters.

Additionally, Hon. Smith urged fellow At-Large representatives to conduct regular office hours in communities throughout the Territory, recognizing the array of issues residents wish to discuss with their elected leaders. She urged her colleagues, irrespective of their political affiliation, to actively engage with the constituents who entrusted them with their votes, thus countering the perception that Territorial-At-Large representatives may become distanced from the concerns of the people once they assume their roles in the House of Assembly."





GOVERNOR URGES REQUIRED REFORMS TO MEET MAY 2024 DEADLINE

In his Fourth Quarterly of Review the implementation of the Commission of Inquiry (COI) recommendations for the Territory, His Excellency Governor John Rankin emphasized both the progress made by the Government and the challenges that lie ahead as it relates to the required reforms. Most of all, the Governor's report heavily underscored the need for urgent action to meet the May 2024 deadline for the comprehensive COIrecommended legislative

reform.

In his report, the Governor reiterated his concerns about bottlenecks in reform the process, emphasizing the profound scale of legislative changes required. He highlighted critical steps of drafting legislation, consideration, cabinet passage in the House of Assembly, and timely implementation. achieve this ambitious called goal, he for Ministries, Offices, and the Attorney General's Chambers to prioritize

their work and allocate additional resources as needed.

His Excellency said that he did not see an immediate need to seek additional powers at this stage of the reform process, however, he cautioned that if significant progress is not made in the next quarter, additional actions may become necessary. The Governor further expressed the expectation that several more of the forty-eight recommendations would be completed over the

next few months, with all of them finalized by the end of May 2024.

the coming months, Governor-Rankin announced that he anticipates the implementation of strengthened Integrity in Public Life Act and the establishment of the Integrity Commission. Further, he noted "The Whistleblower Act should become law and the necessary amendments to the Register of Interests Act should be made so that it is freely and

easily accessible. These mechanisms will be key to safeguarding against the abuses that the COI highlighted."

Governor Rankin also revealed that he plans to publish his final Quarterly Review in December of this year. He also noted that the report will serve as part of his handover to the new Governor Daniel Pruce, as a means of ensuring a smooth transition in the ongoing reform efforts.

PROSPECT REEF WAILINGS CONTINUE AFTER YEARS OF UNKEPT PROMISES

The government's handling of the Prospect Reef redevelopment project has come under scrutiny, with Sixth District Representative Hon. Myron Walwyn criticizing the slow progress and deteriorating state of the site. This critique in the House of Assembly ignited a debate about the future of the oncepromising tourist attraction, particularly in light of impressive developments in neighboring Caribbean nations. Certainly time has been wasted with unkept promises that will eventually compromise the credibility of a number of politicians.

The Sixth District Representative highlighted the striking contrast between Prospect Reef's current condition and the thriving investments seen in countries like Jamaica, which are witnessing substantial growth, especially in the hotel industry.

"When I asked about new developments, I couldn't get an answer. But when you look around at some of the other countries in the Caribbean, you see them doing marvelous things...I was just reading the other day that Jamaica plans to add another 8,000 hotel rooms by 2024, expanding

over the next two to five years."

Drawing attention to the neglected state of Prospect Reef, which was once home to a thriving hotel development and various tourist attractions, Hon. Walwyn questioned the present government' commitment to revitalizing the greatly positioned site.

"We have nothing. You drive across Prospect Reef, and you can't even see Prospect Reef anymore; it's covered in bush. What are we doing? Because if we are not staying on top of these things — and this is not politics, this is about

people's lives — many are struggling in the BVI, and I'm not sure if we fully grasp the gravity of the situation," the Representative stated.

In response, Premier Wheatley acknowledged the historical challenges faced by the Prospect Reef redevelopment project but firmly pledged to see it through. He further stated, "Our economy is not all doom and gloom. Our main economic pillars are performing well. Regarding new investments mentioned some of them. We will complete some of these projects."

"These were projects that

could have been completed by previous administrations but were not. We had Prospect Reef, and we had the opportunity to make it happen, but it didn't," the Premier further stated.

Wheatley also disclosed that a new board had recently been appointed oversee the project and was currently in the evaluation phase. Once fully constituted, the board's first task will be to issue a request for proposals (RFP) to breathe new life into the Prospect Reef development, signaling the government's determination to revitalize this key location.

FCDO Director General And VI Minister of Communications and Works Hold High-Level Meeting, Highlighting UK Support for VI Infrastructural Projects



Following their productive discussion in Road Town in June, the recent highlevel meeting between the Virgin Islands Minister of Communications and Works the FCDO Director General on 14th September 2023 confirmed the support of the United Kingdom for the Virgin Islands in their pursuit of investment for crucial infrastructural projects. meeting emphasized collaboration, and a shared vision for the development of the Virgin Islands.

During the meeting, the discussions primarily focused on infrastructural development, with a particular emphasis on the urgent need for airport expansion in the Virgin Islands. The UK reiterated its commitment to supporting the Virgin Islands' infrastructural projects and stressed the importance of a collaborative approach. Key points that underscored the UK's support for the Virgin Islands' infrastructural endeavours included:

Airport Expansion:

The Minister of Communications and Works highlighted the urgent need for airport expansion in the Virgin Islands and explored strategies to overcome previous challenges. The success of the project is contingent upon the Virgin Islands' effective handling of debt and recovery plans, as well as the support

from the United Kingdom. The UK encouraged the Virgin Islands to incorporate social into the project, elements drawing inspiration from regional airport successful models. This exemplifies the UK's commitment to maximizing the benefits of the project and ensuring its longterm success.

Furthermore, UK the commended the Minister's actively commitment to engage the public in the airport expansion process, aiming to garner community support. This inclusive approach aligns with the recently held visioning meeting for the airport expansion, which involved a cross-section of stakeholders and industry partners. The Virgin Islands is expected to begin drafting the business case for the expansion by late 2023 or early 2024, demonstrating their strong commitment to advancing the project. The Minister also toured London City Airport and engaged in discussions with UKG infrastructure experts and the Inverness Airport Authority to learn valuable lessons for the future airport development in the Virgin Islands.

The meeting between

Minister Rymer and Director General Rangarajan, along with associated meetings, builds upon previous discussions and emphasizes the United Kingdom's support for sustainable infrastructural project investments in the Virgin Islands. By prioritizing collaboration, progress, and shared goals, this meeting has laid a solid foundation for the future of the Virgin Islands. It also highlights the UK's unwavering commitment to supporting the Virgin Islands in their pursuit of sustainable development and growth.

Protocols for Effective Financial Management (PEFM):

Discussions in London addressed the potential impact of new large infrastructure borrowing on the compliance with borrowing ratios outlined in the Protocols Effective Financial Management (PEFM). All parties acknowledged that the Protocols allow for temporary deviations from fiscal ratios when there is a clear plan for returning to compliance, when the proposed projects adhere to the PEFM procedures. The UK recognized infrastructural these

projects are investments in the territory's sustainability. The PEFM includes best-practice processes such as a thorough business case and appraisal of funding arrangements. The UK reiterated its willingness to consider detailed proposals positively and the Minister also engaged with the UK Local Partnerships agency to follow up on an FCDO offer of technical assistance on infrastructure planning, utilizing Local Partnership's experience in supporting projects of a similar scale across the UK.

The commendable management efforts of the Virgin Islands were acknowledged during the meeting. These proposed investments the territory will demonstrate the UK's confidence in the continuing ability of the Virgin Islands debt management capabilities and commitment to supporting the financial stability of the territory. The UK confirmed its readiness to consider detailed proposals positively, further reinforcing the strong partnership between the United Kingdom and the Virgin Islands.

Public Encouraged To Register To Vote

The Office of the Supervisor of Elections is advising the public that Voter Registration is ongoing, and individuals who are eligible to vote, should register to do so.

As per section (2) of the

Virgin Islands Constitution Order, 2007, an individual must be a Belonger18 years of age or older, and domiciled in the Virgin Islands.

Persons must present a Virgin Islands Passport, with embossed seal, a Belonger's Card or Belonger's Certificate to register. A Naturalisation Certificate can also be used, provided the certificate is dated before June 15, 2007.

Further, section 17(1) of the

Elections (Amendment) Act No. 14 of 2011 states:

"A registered voter who is ordinarily resident in the Territory and who moves his place of residence from within one local electoral district or polling division to another, may have his name transferred to the list of voters for the local electoral district or polling division to which he has moved, if he applies on Form No. 9 and establishes, to the satisfaction of the Supervisor of Elections, proof of residence within the local electoral district or polling division to which he/ she has moved".

Persons who have moved their place of residence and wish to transfer are encouraged to apply for a transfer. Documents to support a transfer can be in the form of cable, water, electricity or telephone bills, a rent receipt, lease agreement or a notarised document stating the new address.

Registration and Transfer forms are available at the Office of the Supervisor of Elections, Road Town Post Office, the District Offices on Anegada and Virgin Gorda and the Government Office on Jost Van Dyke. Additionally, these forms are accessible online at http://www.bvi.gov.vg/departments/office-supervisor-elections under the services tab.

Government Of the VI Takes Steps Toward Public Debt Reform

The Government of the Virgin Islands has undertaken a Debt Management Self-Assessment to evaluate the various processes and institutions currently in place to guide public debt activities.

The Debt Management Self-Assessment twas facilitated by the Commonwealth Secretariat's Debt Management Unit from September 18 to 29 and spanned the full gamut of government debt management functions.

Acting Deputy Financial Secretary in the Ministry of Finance, Dr. Drexel Glasgow said the objective of the assessment was to identify core strengths and areas for improvement for further technical assistance over the next five years.

He said the programme of reforms will help strengthen capacity and institutions to help the Virgin Islands manage its public debt effectively and sustainably.

Dr. Glasgow said, "This assessment will not only be instrumental in evaluating the Territory's debt management practices but also identifies areas for improvement along with other recommendations. The analysis from the report will be a core document guiding any reforms in debt management."

"Following submission of the assessment, the Commonwealth Secretariat will develop a five-year programme to-facilitate-the implementation of the measures identified," Dr. Glasgow added.

The Government of the Virgin Islands commenced an aggressive approach to reform informed by the recommendations in the British Virgin Islands Commission of Inquiry Report since 2022. It is in line with this Reform that the Government requested assistance from the Commonwealth Secretariat to undertake Debt Management Performance Self-Assessment of the Territory.

Adviser and Acting

Head of the Debt Management Unit Commonwealth Secretariat, Mr. Mac Banda said this public debt assessment forms part of a longstanding relationship with Ministry of Finance of the Government of the Virgin Islands.

Mr. Banda said, "In recent past, our DMU offered extensive technical assistance. capacity-building and support, advice debt management systems to the BVI. This includes our flagship tool, Commonwealth Meridian, which BVI has been using for public debt management. I am pleased that the Ministry of Finance has chosen to partner with the-Commonwealth Secretariat on this new which journey. undoubtedly impact not only the economy but the lives of people in the British Virgin Islands."

The assessment was led by Policy jointly Analyst in the Macro-Fiscal Unit, Michele Richmond-Phillips Debt Management Adviser at the Commonwealth Secretariat, assigned to the Caribbean, Delia Cox. Discussions were held with several departments and teams throughout central government, statutory bodies and the private sector, to ensure that the assessment captured the country's unique context and to ensure that the programme of support is tailored and effective.

The team also met with Premier and Minister of Finance, Honourable Dr. Natalio Wheatley to discuss some preliminary of findings the assessment. The Premier expressed his gratitude to the Commonwealth Secretariat for their continued partnership and support, as the assessment comes at a critical time for the Virgin Islands.

The Commonwealth Secretariat's Debt Management Unit (DMU), through its public debt management programme, has been supporting member countries' efforts to effectively manage their debt portfolios for over forty years. Delivery of the programme is through advisory support, capacity building and provision and support of public debt management systems including the new public debt management system, Commonwealth Meridian that incorporates advanced and improved functionalities to address emerging debt management requirements and takes advantage of the latest state-of-the-art technologies.

Norwegian Author Fosse Wins Nobel Prize in Literature

Norwegian author Jon Fosse has been awarded this year's Nobel Prize in Literature.

The Swedish Academy highlighted what it said were Fosse's "innovative plays and prose, which give voice to the unsayable."

His immense oeuvre written in Norwegian Nynorsk and spanning a variety of genres consists of a wealth of plays, novels, poetry collections, essays, children's books and translations," the academy said.

Fosse never achieved popular recognition outside of Norway. But within literary circles, the 64-yearold playwright is considered among the greatest of all time

He has been honored across Europe and was even knighted in France in 2007. Norway's government has long covered his living expenses and financed his work with a lifetime stipend.

The American writer Damion Searls described Fosse as "probably the best craftsman of them all." Others have likened him to Henrik Ibsen, whose 19th century plays popularized modernism in theater.

Fosse had limited success as a playwright until he finally made a name for himself in his 40s, with a 1998 showing of his first-ever play in Paris, called Nokon kjem til å komme, or, in English, Someone Is Going to Come.

Since then, Fosse's plays have been produced in more than 60 countries, his translator said.

While many in theater are

celebrating Fosse's victory, critics have long accused the Committee of unfairly favoring European and white writers, snubbing artists of color from the Global South.

The Nobel announcements began Monday with the prize in Medicine going to Hungary's Kataline Kariko and Drew Weissman of the United States for their joint research that led to the rapid development of the mRNA COVID vaccines.

The academy on Tuesday awarded the Nobel Prize in Physics to Pierre Agostini, Ferenc Krausz and Anne L'Huillier for their individual efforts that led to the creation of "extremely short pulses of light that can be used to measure the rapid processes in which electrons move or change energy."

On Wednesday, Moungi Bawendi, Louis Brus and Alexei Ekimov were awarded the Nobel Prize in Chemistry for their work in advancing the field of nanotechnology.

The Nobel Peace Prize will be announced Friday, followed by the final prize for economic sciences on Monday.

All the categories except economics were established in the will of 19th century Swedish businessman Alfred Nobel, who made a fortune with his invention of dynamite.

The first Nobel Prizes were awarded in 1901, five years after his death.

The economics prize was established in 1968 by Sweden's central bank Sveriges Riksbank in Nobel's memory, with the first laureates, Norway's Ragnar Frisch and Jan Tinbergen of the Netherlands, announced the next year.

Commonwealth supports British Virgin Islands with debt management reform

The Commonwealth Secretariat has partnered with the British Virgin Islands to conduct a full assessment of its debt management practices, as part of a reform process aimed at achieving economic stability.

Upon the request the territory's of Ministry of Finance, the Commonwealth Secretariat organised a workshop from 18 to 29 September 2023 to evaluate all public debt management operations and processes, with a focus on identifying strengths and areas of improvement.

The findings from the assessment report will guide the Commonwealth-supported reform, designed to enhance the ability of the British Virgin Islands to manage its public debt over the next five years.

The way forward

Addressing the workshop, Dr Drexel Glasgow, acting Deputy Financial Secretary at the Ministry of Finance of the British Virgin Islands, said:

"This assessment will not only be instrumental in evaluating the territory's debt management practices but also in identifying areas for improvement. The analysis from the report will be a core document, guiding any reforms in debt management.

"Following [the] submission of the assessment, the C o m m o n w e a l t h Secretariat will develop a five-year programme to facilitate the implementation of the measures identified."

"We are confident that the outcomes of this reform will go beyond improved economic performance. They will help the government to make prudent financial discussions and ensure a fair distribution of resources to uplift everyone in the British Virgin Islands."

Mr Banda further highlighted that the British Virgin Islands has been using the Commonwealth Meridian software for managing its public debt portfolio since 2022.

The assessment was jointly led by Michele Richmond-Phillips, Policy Analyst II at the territory's Macro-Fiscal Unit, and Delia Cox, Adviser at the Commonwealth Secretariat's Debt Management Unit.

In preparation of the assessment report, both experts spoke with officials from various government departments, statutory bodies and the private sector to ensure that the findings were tailored to the local context and reflected the views of stakeholders.

GLOBAL NEWS BRIEF STORIES SELECTED BY GIORGIO MIGLIAVACCA

VENEZUELA- The politician — who currently leads the opposition primary polls in Venezuela — defends privatization policies and the reduction of the size of the state. However, she's tolerant and flexible on issues such as abortion and gay marriage.

María Corina Machado, who is the undisputed poll leader in the opposition primaries, which will take place on October 22. isn't an outsider, nor a newcomer to politics. She isn't part of the group of leaders from the disruptive extremeright, nor does she represent charismatic populism (fascism).

Machado defines herself and her party, Vente Venezuela as "liberal" (or neoliberal, depending on how you look at it), both politically and economically. Her political revolves vision around reducing the size of the state as a provider of public policies, supporting entrepreneurship and promoting the free market, as a means of creating wealth and jobs in a devastated economy. Her vision of government is similar to what Margaret Thatcher or Ronald Reagan had in mind. In Latin America, her proposals seem to align with former Chilean president Sebastián Piñera, of the center-right, who served two terms (2010-2014, 20182022). "Margaret Thatcher had the courage to defend her values all her life against everyone who opposed her," Machado tweeted in 2013, perhaps alluding to herself. She spent a decade after Thatcher's death navigating the Chavista regime — which has been led by Nicolás Maduro following his predecessor's death — and the opposition itself. Only now has she gained a big following. [El Pais]

VATICAN - On 9 October Pope Francis elevated 21 clerics from around the world to the rank of cardinal. These appointments effectively allow the pope to influence the election of his successor.

The new cardinals come from the United States, France, Italy, Argentina, Switzerland, South Africa, Spain, Colombia, South Sudan, Hong Kong, Poland, Malaysia, Tanzania, Venezuela and Portugal. South Sudan got its first cardinal and Malaysia got the second in its history.

As in previous years, Francis has increasingly chosen bishops and archbishops from non-European countries to be named cardinals. "Diversity is necessary; it is indispensable," Francis said. Appointments to the Catholic Church's College of Cardinals, which elects new popes, effectively allow the pontiff to influence the choice of

his successor.

There are now 137 cardinal electors, about 73% of whom were chosen by Francis. This increases the likelihood that the next pope will share his vision of a more progressive, inclusive church. [Deutsche Welle]

ANKARA, Oct 1 (Reuters)
- Two attackers detonated a bomb in front of Turkish government buildings in Ankara on Sunday in an assault that left both of them dead and two police officers wounded, in what authorities called the capital's first terrorist attack in years.

CCTV footage obtained by Reuters showed a vehicle pulling up to the Interior Ministry's main gate and one of its occupants quickly walking toward the building before being engulfed in an explosion, while the other remains on the street.

DIAMOND WAR - G7 experts are set to arrive in India on a fact-finding mission this week ahead of the expected announcement of a new embargo on importing Russian diamonds. An EU ban has also been under discussion for months - but imposing new regulations on the global diamond market is no easy feat. Experts from the G7 and Belgium will discuss potential sanctions on Russian-mined diamonds this week on a visit to the Indian cities of Mumbai and Surat. The trip is the latest step forward in months of negotiations among Western powers over how to impose

sanctions that could transform a sprawling – and often controversial – global industry.


Around one-third of the world's supply of diamonds are mined in the Siberian region of Yakutia by Russian state-owned company Alrosa. The diamond industry overall contributes around billion to the Russian economy annually, making it one of the largest sectors in Russia to avoid the sweeping sanctions imposed by Western powers since the start of the full-scale invasion of Ukraine in 2022. With the role historically cycling through different global regions, the next Secretary-General is anticipated to hail from Latin America or the Caribbean, favoring Mottley's candidacy. As the position has never been held by a woman in its 78-year history, there's significant pressure to appoint a female candidate. Mottley meets this crucial criterion, standing out among potential candidates. [CNW]

HAVANA TIMES - The Russian ambassador to Cuba, Viktor Koronelli, said on Wednesday that Moscow and Havana are "in contact" and "working" to clarify the issue of hiring Cubans in both countries to fight on the Russian side in the war in Ukraine. Koronelli made these statements to the international media outside an act of gratitude by the Cuban Government for a donation of 650 tons of vegetable oil from Russia and the World Food Program (WFP). "The competent bodies are working and are in contact with both the Russian and Cuban sides," said the diplomat, who acknowledged that his embassy is aware of Cubans who had gone to Russia "to prepare militarily," but that he did not know the specific figures.

BAHAMAS-The government of The Bahamas signed a loan agreement with the Saudi Fund for Development (SFD) for \$70 million, that will go toward funding airport infrastructure in the Exumas, a press

Dear Readers: Speak with your children about Bullying (4 of 4)

Use the buddy-system. If you're trying to avoid being bullied, two people are stronger than one. For example, walk with a friend or a group of friends to school, or hang out with them at recess. In other words, make sure to have friends surrounding you wherever and whenever you think you might run in to the bully.

If you have a buddy, remember to be a buddy. Offer to be there for a friend if you know he or she has bully trouble. Act if you see a friend being bullied; after all, you know how hard it is to be bullied. Tell an adult, stand with your friend being bullied, and tell the bully to stop. Support those you see being hurt with words of kindness.

Ignore the bully if they say or do something to you. As much as you can, try to ignore the bully's threats. Pretend you can't hear them and try to leave the situation immediately and go to a safe

Bullies are always looking for a reaction to their teasing. Pretending that you don't notice or care (even if you do care on the inside) may stop a bully's behavior because they are not getting the reaction they expect and want.

Recognize that you have a right not to be bullied. It is not your fault that you are being harassed. You, like everyone else, deserve to feel safe.

Say "no." Tell the bully "No, stop it!" in a loud, assertive voice and then leave if you feel you need to:

You can also say something straight-forward like, "Stop bothering me. Standing up to the bully, simply by saying "no," sends a message that you are not afraid and will not accept his or her behavior. Bullies tend to go after kids who don't stick up for themselves and who they think will take their abuse and do whatever they say.

There's always strength in numbers. Kids can stand up for each other by telling a bully to stop teasing or scaring someone else, and then walk away together.

Preheat your oven to 425 F (220 C).

Core and thinly slice your apples. To peel or not to peel, that is your decision. Melt 4 tablespoons of butter.

Place the sliced apples in a large 10- or 12-inch cast iron skillet, or other oven-safe skillet. Pour the melted butter over the apples and sprinkle 1/4 cup brown sugar and 1/2 teaspoon cinnamon over the top. Bake the apples in the preheated oven for 10 minutes.

While the apples are cooking, make the batter. Melt the



remaining 2 tablespoons of butter. In a blender, combine the flour, eggs, milk, salt, vanilla extract, melted butter, 1 tablespoon brown sugar and 1/2 teaspoon cinnamon. Blend for 1-2 minutes or until smooth.

Carefully remove the very hot skillet from the oven and pour the batter over the apples. Place the skillet immediately back in the oven and bake for 15-20 minutes, or until the Dutch baby is puffed up and golden brown.

Remove from the oven, sprinkle with powdered sugar and a touch more cinnamon, if desired, and serve warm.

Biden to Argue for Continued Funding for Ukraine

WHITE HOUSE -

With U.S. funding for Ukraine at risk because of congressional turmoil, President Joe Biden says he will be delivering a "major speech" to persuade the American people to continue supporting Ukrainians in their defense against Russia's invasion.

"I'm going to make the argument that it's overwhelmingly in the interest of the United States of America that Ukraine succeeds," Biden said Wednesday as he faced questions from reporters.

The remark followed Tuesday's dramatic ousting of Republican Kevin McCarthy from his role as House speaker, just days after Congress omitted provisions for further Ukraine funding from a last-minute deal to prevent a government shutdown.

While a new deal to fund government operations must be negotiated by mid-November, Biden indicated he would seek alternative routes to ensure the flow of aid.

"We can support Ukraine in the next tranche that we need," he said. "And there is another means by which we may be able to find funding for that. But I'm not going to do that now."

Funds remaining

The Pentagon warned that without action from Congress, funding could run out in a matter of months, with only \$5.4 billion remaining under the Presidential Drawdown Authority funds and \$1.6 billion left of the \$25.9 billion provided by Congress to replenish U.S. military stocks that have been flowing to Ukraine.

"It does worry me, but I know there are a majority of members of the House and Senate in both parties who have said that they support funding Ukraine," said

A lapse in funding will

affect not only the situation on Ukraine's battlefields as it grinds through its counteroffensive and heads into the challenging winter months, but it also could embolden Moscow, said Luke Coffey, a senior fellow focusing on foreign policy at the Hudson Institute.

"They see the writing on the wall, and they're very hopeful that this continued chaos stays in the United States and that there's isn't any funding for Ukraine," he told VOA. "Only Russia stands to benefit here."

White House press secretary Karine Jean-Pierre declined to provide further details on the president's speech but acknowledged that a growing share of the American public is questioning whether to continue sending historic sums of money to help the Ukrainian people.

"We have seen the polling," she said in response to VOA's question during Wednesday's briefing. "We also believe that it is fundamentally important to our own national security, as well as supporting the great people of Ukraine, to continue."

Twenty months since Moscow's invasion, public support for U.S. military assistance is waning, according to a poll released Wednesday by the Chicago Council on Global Affairs. Sixty-three percent those surveyed said they supported sending additional arms and supplies to Kyiv, compared with 72% in July 2022. The drop was sharpest Republicans, among

followed by independents, while Democratic support remained largely unchanged.

Amid eroding support, Biden needs to better explain to the American people that their vital interests are at stake, said former Ambassador to Ukraine John Herbst, who is now senior director of the Atlantic Council's Eurasia Center.

The message should be that Putin's aims directly threaten American interests, Herbst told VOA. "Because if he wins in Ukraine, he will be provoking and maybe committing direct aggression against our NATO allies, which will require greater American defense expenditures and the use of American troops."

Since the war began, the Biden administration and Congress have directed more than \$75 billion in assistance to Ukraine, which includes humanitarian, financial and military support, according to the Kiel Institute for the World Economy, a German policy institute.

Ukraine's Foreign
Minister Dmytro Kuleba said
Monday that he remained
confident that U.S. support
had not wavered, calling the
decision by Congress to not
put aside funds for Ukraine
an "individual case."

McCarthy's successor

A new House speaker who opposes funding could quash a proposal before it even comes to a vote, so a deal regarding Ukraine may depend on who succeeds McCarthy. The speaker was ousted Tuesday when a motion to do so from fellow Republican Matt Gaetz was supported by eight Republicans and 208 Democrats.

On Wednesday, Jim Jordan became the first to publicly declare his intention to run for speaker. Other names have been floated, including Steve Scalise, the Number 2 House Republican who has long been favored to take over as speaker after McCarthy, and Kevin Hern, chair of the Republican Study Committee, the largest Republican caucus in the House.

The group Defending Democracy Together ranked lawmakers from A to F on the strength of their past support for Ukraine aid, with A signifying the strongest support. Jordan and Hern were rated as F, while Scalise was rated as B.

House Republicans plan to meet next Tuesday for a first round of internal party voting.

PART 1

GEOGRAPHY

On the map the British Virgin Islands (59.3 square miles) are located between Puerto Rico and the nearest West Indian Island of St. Kitts. They lie 55 miles north of the Lesser Antilles between latitude 18°

25' North and longitude 64° 20 and 64° 52' West, and are among the most beautiful islands in the world. The archipelago consists of forty islands, divided into categories of islands, cays and rocks. The largest and most populated island is Tortola (21.3 square miles), where the capital of the group, Road Town, is situated. Other large islands of the group are: Virgin Gorda (8.3 square miles), Anegada, Jost Van Dyke and Peter Island. West of these lie the United States Virgin Islands (formerly Danish West Indies). The BVI is about 60 sea miles south-east from Puerto Rico and has a population of over 25,000 people. The islands, with the exception of Anegada, are hilly: the highest elevation being Sage Mountain, which stands at 1,780 feet, where traces of a primeval rain forest may still be seen. The people of the BVI are renowned for their warm personality, perhaps a result of the pleasantly warm temperatures which range

from 75 degrees Fahrenheit to 87 degrees Fahrenheit all year round. The tradewinds constantly cool the islands and the short interruptions usually presage occasional rainfall. Tortola is considered a Yachting Mecca, and sailing and other sea sports are plentiful. Many of the islands in the archipelago dot the crystalline waters around an historic seaway: the Sir Francis Drake Channel. Moving along this highway we come upon Norman Island, the famous "Treasure Island" of Robert Louis Stevenson.

HISTORY

More and more archaeological evidence is surfacing suggesting that as early as 1000 BC Amerindians "stone people," (also known as Ciboney) reached the Virgin Islands and were later overthrown by the Taino Arawaks at about 200 AD. Recent finds have confirmed that the Arawaks had settlements

throughout the archipelago that later became known as the Virgin Islands. Sometime before the arrival of Europeans the Caribs, another Amerindian tribe, took over the control of the area and enslaved the indigenous population. On the 16th November 1493, the Italian Admiral, Christopher Columbus, commanding a Spanish fleet of three large galleons and fourteen caravels, was en route to Puerto Rico with an expedition financed by the Spanish Treasury and some Genoese bankers. It was during this voyage that Virgin Gorda and the neighbouring islands were discovered and the entire archipelago was named "Santa Ursula y Las Once Mil Virgenes" (St Ursula and 11,000 Virgins).

On his last voyage to the West Indies in 1595, Francis Drake in the company of Sir John Hawkins, moored his fleet of 27 ships with 2500 men at Gorda Sound. The Dutch were the first Europeans to make a permanent settlement in Tortola, and their presence dates back to 1621

when the islands were used as a base to pillage and harass the Spanish settlements in the bigger islands.

Apart from the strategic interest, early English designs on the islands were not too clear. In 1672 William Stapleton captured Tortola from a small group of Dutch settlers (about twelve families), seriously damaged their fort, seized their guns, and took away about 80 subjects, including Irish, English, and Welsh. They were removed to the more important island of St. Christopher, and the Virgin Islands were annexed to the

Leeward Islands' government by King Charles II of England.

During the 1730s a number of Quaker missionaries visited the islands proselytizing a large number of planters and their African slaves. When the seat of power was transferred from Virgin Gorda, in 1741, John Pickering, a wealthy planter and leader of the Quaker community, became the first Lieutenant Governor of Tortola.

In 1773 the islands were granted a constitutional government with a fully elected House of Assembly and a partly elected, partly nominated Legislative Council in return for an impost of 4½ percent. The first attempt to establish Courts of Justice was unsuccessful. A well orchestrated conspiracy headed by Lieutenant Governor Nugent and a number of affluent planters frustrated any attempts made by the newly appointed Chief of Justice,

George Suckling. It was only a decade later that constitutional rule started to be implemented and ironically enough, the first efforts of the legislators were to establish rigorous punishments for slaves and to settle ongoing land disputes.

The first post office was opened in Tortola in 1787, and concurrently a packet boat service began to call at Tortola once a month to bring in and collect mails. That same year the first ever Royal Visit to the Virgin

Islands took place when William IV (then Prince William Henry) sailed to the islands in the "Pegasus" (a frigate) escorted by Captain Horatio Nelson of the "Boreas" and Captain Holloway of the "Solebay".

Throughout the 1700s the cultivation of sugar cane was expanding, and as a consequence, the demand for slave labour escalated. Samuel and Mary Nottingham had a fairly large estate at Long Look on the island of Tortola and in 1776, after they had left to go to live in New York, the Nottinghams manumitted 25 slaves

and gave them fifty acres of land at Long Look. The Nottinghams sent a written deed declaring that each slave had legally purchased freedom. When the Nottinghams freed their slaves they established a unique precedent by actually emancipating them with the donation of land and tools to cultivate it. By 1787, a Committee for the Abolition of the Slave Trade was established in London. Most members of the Committee were Quakers, whilst other political groups and religious societies started to manifest their disapproval with the slave trade. Then in the spring of 1807 the English Parliament approved a law abolishing the slave trade. This dealt a fatal blow to the Virgin Islands economy, and as the white planters returned to England a number of free blacks then began to buy land, which became a pattern that continued throughout the 19th century.

The struggle to know

Last week, on International Right to Know Day, we took stock of the state of freedom of information in some of the world's leading democracies.

Western governments made targeted sanctions a key part of their response to Russia's brutal invasion of Ukraine. They promised to trace Russian elites' assets stashed within their and, when jurisdictions possible, confiscate them. Considering high public interest, authorities in these countries should be

systematically and proactively sharing information about how in their economies. they're getting on.

Unfortunately, that's not the case. So together with our national chapters and partners, we decided to exercise our right to information, sending freedom of information requests to 19 countries and the European Commission earlier this year.

We asked them - what we believed were - straightforward questions about financial sanctions, asset freezes and related investigations. We assumed governments would be monitoring the outcomes of measures they've imposed. How else can they know if their actions are proving successful?

It's been over eight months and we've yet to hear back from seven countries - including Germany, Canada and the United States.

We've hit a total brick wall with Australia and the United Kingdom, where relevant departments refused to provide us any information – both essentially telling us it would take too much time and effort to compile the data.

Out of the countries we did hear from, most provided only partial information.

Only three countries provided comprehensive responses. This included Cyprus, which has been getting a lot of attention as a playground for Russian kleptocrats. We learned, for example, that the police are investigating nine cases of possible sanctions violations – which is not surprising considering recent investigative reports into a Cypriot service provider's relationships with sanctioned Russian elites. Sadly, most other EU countries weren't as forrthcoming. The response from the European

Commission, who should coordinating their efforts, was especially disappointing.

Why is it important that we have a full picture on the implementation of these sanctions?

Targeted sanctions aren't exactly an accountability tool, but they do provide opening to seek justice for kleptocracy, in which advanced Western economies have long been complicit. That's why we have been encouraging governments to these focus their efforts on targeting assets that could be proceeds of corruption,

and laundered and invested

More than a year and half after Western governments unleashed targeted sanctions against Russian elites, we should be discussing measures to more decisively counter cross-border corruption.

It's only through having access to information on progress so far and the remaining obstacles that we can have a meaningful debate.

Obtaining public information should not be this frustrating. Governments need to do much better when it comes to upholding the public's right to know.

Our experience making freedom of information requests has illustrated continued obstacles that prevent civil society and the wider public to meaningfully scrutinise the effectiveness of targeted sanctions.

Last year, the EU Court of Justice effectively said that building obscure, complex corporate structures is part of privacy and private life. Even so, the court had an obligation to balance the right of personal data protection and the right to privacy with other rights and interests. Curiously, it does not give any recognition to freedom of information at all, writes our legal advisor Adám Földes.

Forthcoming EU anti-money laundering directive will dictate that access to information on companies' real owners will need to be based on "legitimate interest". EU decision-makers must prescribe detailed rules to uphold the right to this information for the stakeholders whose legitimate interest was confirmed by the court.



This remarkable achievement marks another significant 'first' for Antigua and Barbuda since the OAS expanded its membership 61 years ago.

Sir Ronald's third official term commences on October 1st. He has already demonstrated his leadership and commitment by serving as President on various critical occasions, including acting as President over five sessions in the past two weeks alone.

His previous official tenures as President in 2016 and 2021 saw him steering the Council's response to political crises in nations like Haiti, Venezuela, and Nicaragua. As a pivotal figure within the Organization, Sir Ronald has been instrumental in drafting, negotiating, and endorsing resolutions, declarations, and statements that resonate with countries across the hemisphere.

Ambassador Sanders has consistently voiced significant issues pertaining to the Caribbean, taking a strong stance on matters like Climate Change, racism, discrimination, reparations for slavery, women's rights, and the urgent call for social justice and equity.

In recognition of this historic accomplishment, Antigua and Barbuda's Foreign Minister, E. Paul Chet Greene, expressed the Government's profound pleasure. "Ambassador Sanders' record-setting leadership at the OAS amidst a plethora of challenges facing the nations of our Hemisphere unequivocally demonstrates that a country's size is no barrier to its ability to lead effectively, provided it is armed with knowledge and experience," stated Minister Greene.

Looking ahead, Ambassador Sanders disclosed that his third presidency's agenda would prominently feature critical issues like climate change; guns, gangs and violence; and access to concessional financing for development. Work on Funding Foreign, Humanitarian Aid at Standstill Amid US House Turmoil

The U.S. Congress is at a standstill Wednesday, with its lower house paralyzed by the ousting of its speaker and lawmakers facing a deadline six weeks away to approve spending bills and avoid a government shutdown.

The lack of a functioning House of Representatives, and the prospects of losing more days to identifying and electing a speaker candidate who can garner enough support, leaves in limbo several important spending bills, including those providing for foreign military financing, international humanitarian aid and efforts to counter China's influence.

Lawmakers the Republican-majority House are not expected to hold any further votes this week. Instead, Democrats and Republicans discuss who might will lead the narrowly divided chamber through a period that will require agreement not only among themselves, but eventually with the Democratled Senate before the spending bills can be enacted.

Recent history suggests selecting the new speaker may not be a quick process. Former House Speaker Kevin McCarthy, who was ousted Tuesday, needed 15 rounds of voting in January to earn the post. He had to make several concessions to conservative holdouts in his party, including a rule that a single lawmaker could call for a vote to remove him as speaker.

As in the recent negotiations on averting a federal government shutdown, the slim Republican majority in the House meant that Democrats had the numbers to influence the vote on McCarthy.

In a "Dear Colleague" letter to Democrats Tuesday morning, Democratic Leader Hakeem Jeffries urged his caucus to vote to remove McCarthy from the speakership.

"House Democrats remain willing to find common ground on an enlightened path forward. Unfortunately, our extreme Republican colleagues have shown no willingness to do the same. It is now the responsibility of the GOP members to end the House Republican Civil War," Jeffries said in the letter.

I truly believe, though, in the institution of the House at the end of the day. US House Removes McCarthy as Speaker of House

WASHINGTON — For the first time in U.S. history, U.S. lawmakers voted Tuesday to remove the Speaker of the U.S. House of Representatives from power.

Republican Kevin McCarthy was removed from his position as speaker in a 216-210 vote triggered by a rare challenge from his own party. The House cannot hold votes until a new speaker is set to be elected next week.

Republican Representative Matt Gaetz filed a motion late Monday to force a vote on removing McCarthy, expressing frustration in McCarthy's leadership after McCarthy failed to pass a government funding bill last week with conservative spending priorities.

The slim Republican majority in the House meant that Gaetz needed only a handful of Republicans to vote along with Democrats to oust McCarthy. The majority of Republicans voted to keep McCarthy in leadership.

"Think long and hard before you plunge us into chaos because that's where we're headed if we vacate the speakership," Representative Tom Cole warned fellow Republicans on the House floor Tuesday.

Gaetz responded during debate on the House floor, saying, "I don't think voting against Kevin McCarthy is chaos. I think \$33 trillion in debt is chaos. I think that facing a \$2.2 trillion-dollar annual deficit is chaos. I think that not passing single-subject spending bills is chaos."

Some Republicans have also expressed frustration over a deal McCarthy made with President Joe Biden earlier this year to cap spending levels in return for raising the debt ceiling.

"Many of us had begged the speaker, pleaded with the speaker repeatedly to utilize the debt ceiling to leverage spending cuts and reforms. Instead, he negotiated an unlimited increase to the debt ceiling," Republican Representative Bob Good said on the House floor Tuesday, urging members to remove McCarthy.

Before Tuesday, no speaker of the House had ever been removed from the post. McCarthy announced Tuesday night he would not seek reelection to the speakership.

"I can continue to fight, maybe in a different manner, and will not run for speaker again," McCarthy told reporters Tuesday night.

As in the recent negotiations on averting a federal government shutdown, the slim Republican majority in the House meant that Democrats had the numbers to influence the vote on McCarthy.

In a Dear Colleague letter to Democrats Tuesday morning, Democratic Leader Hakeem Jeffries urged his caucus to vote to remove McCarthy from the speakership.

"House Democrats remain willing to find common ground on an enlightened path forward. Unfortunately, our extreme Republican colleagues have shown no willingness to do the same. It is now the responsibility of the GOP members to end the House Republican Civil War," Jeffries said in the letter.

A vote to remove McCarthy required a simple majority in the 435-member House of Representatives. Republicans control the chamber with a 221-212 majority over opposition Democrats.

McCarthy spoke with Jeffries Monday night. McCarthy said he told Jeffries, "You guys do whatever you need to do. I get politics. I understand where people are. I truly believe, though, in the institution of the House at the end of the day — if you throw a speaker out that has 99% of their conference, that kept government open and paid the troops, I think we're in a really bad place for how we're going to run Congress."

The challenge from Gaetz came days after McCarthy relied on votes from a Democratic bloc to pass a short-term funding measure and avoid a shutdown

McCarthy became House speaker in January after repeated rounds of voting that saw Gaetz and other Republicans oppose his candidacy. One concession that led to McCarthy's ultimate election was agreeing to allow any single member to call for a vote to oust the speaker.

BVI hosting Oct 11-15 ECVA Men's U23 Volleyball Championships

Players with backgrounds in different sports including one from Virgin Gorda, has formed the nucleus of the BVI Men's U23 Volleyball team they will field, when they host the Eastern Caribbean Volleyball Championships from October 11-15, at the Multipurpose Sports Complex.

BVI will face their counterparts from Antigua and Barbuda, Dominica, St. Maarten, St. Kitts-Nevis, Saba, St. Lucia, St. Vincent and the Grenadines and Grenada.

"We have a very talented team. They're a bit on the young side and inexperienced in this type of tournament, but I think we have a wealth of trainers and coaches giving their all to get these guys tournament ready," Coach Kwele Williams told Island Sun Sports in an exclusive interview. "I think most of the boys have a natural athletic ability, so we're now trying

to groom that into actual volleyball play to become a team. Volleyball is not an individual thing or just physical alone. It's a lot of mental and physical so we're trying to improve on the mental and the little things that cost you in games and to reduce unforced errors. Sometimes in a game, you can give a team 15 points just by errors. Those are the things we're focusing on, to build skill levels."

Williams said about 80% of the team is new and this year was the first time in the league for many, who have come from other sports including Basketball, Football and Cricket, but they're naturally talented. Past teams, he noted, had a different development pathway as they focused on more developed players. This team however, also includes 14 and 16 year old players.

"We're trying to develop from the youths and even going into the grassroots—going into the Primary Schools—that's the only way we'll get to where the other competitive teams are," he noted. "They may bring an U23 team, but what you may find is that some of their players have been playing for 10, 12 years, whereas, our guys have only been playing volleyball, 2-3 years. That makes a difference when nerves hit you."

Williams said they have been drilling into players that playing at home is 10 times worse than playing in a visitor's arena. "Everybody knows you and when you look into the stands and see 10 eyes looking at you, you shake a little more," he said. "We're trying to get beyond that. With their age level, we're hoping to have this team together for 4-5 years, the 19-20s might move on to the senior team. But we have that core of guys, 14-17, those are the guys we're looking for to become champions down the road."

He said that the guys have the ability but everybody likes to jump, set and hit. He said that anyone can hit and they have attackers from all over the court. "But the challenge is, we want that in game situations," he said. "So that's what we have been focusing on."

Williams said the public is in for a treat in a 'very competitive tournament' with very good teams coming from nine different countries. He said that the BVI is a multinational territory and

he invites people to come out and support their country. "But remember we're living in the BVI, so we're going to try our best to defend the house," he said. "It should be a really, really good tournament, very competitive. High quality."

The BVI hasn't been to an U23 tournament in quite a few years, he noted, but he's surprised with the rankings from the last tournament, with Antigua and Barbuda as the No I team entering the tournament, followed by St. Lucia, St. Maarten and Grenada.

"You have some heavy hitters but our guys are up to the challenge," Williams said. "We haven't been in this type of competition, but I have the confidence in the guys that we're going to come out and put on a good representation of the BVI."

No information could be gleaned into the schedule and the pairings when Island Sun Sports spoke to Williams on Tuesday. All the game details are in the hands of the ECVA authority.

What Prompted the Discontinuation of Fen-Phen?

DEAR DR. ROACH: I'm a 71-year-old healthy female who has struggled with my weight all my life. In the '90s, I thought I had finally found the solution in fen-phen. It was like a miracle! It took all the nagging thoughts of food out of my brain.

My question is, with all the drug ads on TV every day blithely showing the many side effects leading up to — and including — death, why can't we use fen-phen? I worked in a hospital where a very large number of employees were taking it with great results. I never heard a hint about anything that could affect someone's health.

Also, I talked to many of the other patients at the doctor's office where I was receiving it. Everyone was overjoyed with the results. I had no temptations and no constant yammering in my brain to eat something. As I said, it was a miracle. I felt like a normal person. So, why are all of these drug companies allowed to advertise their products, but one drug that truly worked had to get snatched away from us?

ANSWER: Fen-phen was a combination of fenfluramine and phentermine, which was approved for use in 1986. Approximately 18 million prescriptions were written for this medicine until 1987, when an association was made between the use of fen-phen and valve diseases of the heart. These cases were reported with fenfluramine or with the related dexfenfluramine alone, but never with phentermine alone. (Phentermine remains on the market.) Approximately 150 cases were reported.

Subsequent studies estimated that seven out of 10,000 people who took fenfluramine or fen-phen for less than four months developed valve disease, while 35 in 10,000 people who took fenfluramine or fen-phen for more than four months developed valve disease. They were compared to people who either took phentermine alone or did not use a weight-loss medicine.

The U.S. Food and Drug Adminstration determined that the risk of valve disease (some being severe enough to prompt valve replacement surgery) was too high, so the FDA asked manufacturers to remove these drugs from the market.

I fully understand your perspective. Some people are willing to take the risk of a side effect because the benefit of the medicine is so great. In my opinion, people should have the option of making their own decision, but in this case, the FDA felt that the risk was too high.

I have not seen a medicine for weight loss as effective as fen-phen until recently, when semaglutide (Wegovy and Ozempic) and tirzepatide (Mounjaro, not yet approved for weight loss) became available. Just as you say, many of my patients report that they were able to easily control their eating while on these medicines, and as of the time I am writing, there have not been any serious adverse effects of taking these drugs, although there are plenty of milder effects.

However, these medicines only work when you continue to take them, and stopping them generally results in rapid regain of the weight that was lost. It's important to realize that if you take a weight-loss drug, you're making a commitment to a long-term treatment.

GUYANA-VENEZUELA: THE PATH TO PEACEFUL RESOLUTION

Recent intimidatory and aggressive statements issued from Venezuela in the name of President Nicolas Maduro, the Government of Venezuela and the National Assembly concerning Guyana, have raised alarms in the regional, hemispheric and international community.

Commonwealth, The the Organization of American States, and CARICOM have objected to Venezuela's behaviour toward Guyana, particularly as the Venezuelan President Nicolás Maduro alleges, without any substantiation, that the Guyana Government is allowing the United States of America (US) to construct a military base on its territory "against Bolivar's Venezuela".

In a UN statement, the Guyana Government rejected Venezuela's allegation, stating that "this all derives from Venezuela's grotesque claim to two-thirds of Guyana".

HISTORICAL CONTEXT

The background to these events is that in 1899, Venezuela agreed to an international arbitration that established the boundaries between Guyana and Venezuela as a 'full, final, and perfect' settlement. However, in 1962, just as Guyana was on the brink of gaining independence, Venezuela reversed its longstanding acceptance of the 1899 settlement. Without providing any evidence, the government claimed that the settlement was nothing more than a covert political agreement that infringed on its rights.

Based on this unfounded allegation, Venezuela has staked a claim to twothirds of Guyana, specifically the Essequibo region. This claim, together with intermittent acts of belligerence by Venezuela including its naval forces, have cast a shadow over Guyana's economic development for all 57 years of its independence, deterring investors and causing instability in the country.

In February 1966, three months before Guyana's independence from Britain, representatives from Venezuela, Britain, and Guyana convened in Geneva. There, they signed an agreement endorsed by the governments and parliaments of all

three nations, aiming to resolve 'the controversy'. This agreement outlined several steps towards resolution, including a provision for the UN Secretary-General to select a means of resolution as specified in Article 33 of the UN Charter. This process is articulated in Article IV of the 1966 Geneva Agreement which Venezuela fully endorsed.

Therefore, after the failure of initial resolution steps, UN Secretary-General António Guterres decided on 30 January 2018 that the International Court of Justice (ICJ) would be the avenue for resolution.

THE PATH OF PEACEFUL RESOLUTION Accordingly, in March 2018, Guyana applied to the ICJ for

judicial adjudication.

In response, Venezuela refused to recognize the ICJ's jurisdiction, abide by its decisions, or participate in its proceedings. This response was a direct infringement of Article 93 of the UN Charter, which clearly states: "All Members of the United Nations are ipso facto parties to the Statute of the International Court of Justice"

However, the ICJ adjudged that it had jurisdiction to hear the case. Venezuela appeared twice before the Court to object. On both occasions, the Court rejected the Venezuelan objections. Therefore, the case has continued much to the disquiet of Venezuela which has clearly always been fearful of the Court's decision.

THE HOSTILE PATH

In 2020, Guyana started producing and selling oil and gas offshore, boosting its economy. The IMF declared Guyana to be the fastest growing economy in the world with GDP growth of 62.3% in 2022 and 59% in the first half of 2023.

In the wake of these spectacular riches, an immediate response was sparked from the Venezuela government when, on 13 September 2023, the Guyana President, Irfaan Ali, updated the public on bids for 14 new offshore oil blocks, which had been opened for exploration and development. Ali said that immediate bids on 8 of them had been received from oil giants such as ExxonMobil, Hess Corporation, China National Offshore Oil Corporation and Total.

On 19 September 2023, the Venezuela government described the bidding process as "illegal" and issued a "warning" to all the participating companies that it would "apply all necessary measures to prevent the illegitimate exploitation of the natural resources that belong to our nation".

unsubstantiated allegation on 23 September 2023 at the UN General Assembly that the US is seeking "to establish a military base in the contested territory. with the aim of creating a spearhead in its aggression against Venezuela and consolidating the plunder of our energy resources"

ATTEMPT TO DIVIDE CARICOM

In an open message, posted on his X page, Maduro proposed that Guyana should abandon the process at the ICJ for "a meeting promoted by CARICOM to retake the Geneva Agreement of 1966". It is a misleading proposition because it is clear, from even a cursory reading of the Geneva Agreement, that Guyana has followed its terms to the letter.

President Maduro had previously unsuccessfully, to divert CARICOM from supporting the ICJ process. He has not succeeded in this further attempt. Although many CARICOM governments are friendly with the Maduro Government and have urged the US to drop sanctions against it, on 22 September 2023, CARICOM publicly supported Guyana's sovereignty and right to develop its resources. PROMOTING NATIONALIST VENEZUELA SENTIMENT

On 21 September 2023, Venezuela's National Assembly, decided to arouse nationalist sentiment at the urging of the government. It decided to hold a referendum on the claim to Essequibo "so that the people strengthen the defence" and "the inalienable rights of Venezuela". It is a referendum hardly worth holding since, in furtherance of their unsubstantiated claim, for 61 years successive Venezuelan governments have indoctrinated their people from primary school in the belief that Essequibo belongs to Venezuela.

When the Venezuelan political parties met in Mexico in August 2021 in one of the failed attempts to find a way out of the many political, economic and humanitarian challenges that the country faces, the only thing on which they could agree was the claim for the Essequibo

INTERNATIONAL INVOLVEMENT AND RESPONSE

In the wake of all this, the international community has made its position clear: it favours ICJ adjudication as the appropriate and peaceful means to settle the controversy, adhering to the Charter of the UN and international law.

This resolution path not only serves justice but also underpins the stability and development prospects of both Guyana and Venezuela, fostering an environment where mutual respect and cooperation can flourish.

Shelter Classifications

Primary shelters can provide refuge during and after a hazard like a storm or earthquake and are equipped with generators as well as facilities for shelterees to cook and bathe.

Secondary shelters can provide refuge during and after a hazard but don't have as many of the facilities as a primary shelter and would house shelterees for a shorter period of time.

Tertiary shelters can provide refuge after a hazard and would only host shelterees temporarily.

These facilities have been inspected by the Department of Disaster Management, the Environmental Health Division, and the Public Works Department in keeping with the BVI Emergency Shelter Manual.
