OPPOSITION LEADER SAYS CRIME ESCALATION IS LINKED TO WEAK ECONOMY: PREMIER DISAGREES

Premier Dr. the Hon. Natalio Wheatley has fired back at the Leader of the Opposition's assertion that the rise in crime escalation is linked to the economy not being as robust as it should be. In his rebuttal of the comment, the BVI Leader dismissed the Opposition's stance as self-serving and fraught with danger.

Speaking on the matter during a recent interview on The Big Story on JTV on 30 October, Hon. Wheatley refuted Opposition's accusations that the government bears some responsibility for the escalating the crime rate in the British Virgin Islands.

WHAT THE OPPOSITION SAID

While speaking at a press conference convened at the Office of the House

of Assembly Conference Room on 26 October, Leader of the Opposition Hon. Ronnie Skelton expressed his concerns about the rising levels of crime; and emphasized the Opposition's profound apprehension.

The Leader of the Opposition disclosed that the Opposition had engaged in discussions with Police Commissioner Mark Collins to address this matter and quoted statistics on murder rates and the recent surge in burglaries. Hon. Skelton then ventured into discussing the link between unemployment and crime.

Hon. Skelton said that some crime is linked to unemployment in the Territory. "Some of it, not all of it. It is important for us to start finding

ways when our economy is sluggish, the private sector is not moving, for the government... to get people back to work at [getting] the economy moving," the Leader of the Opposition said.

While further making his point Hon. Skelton highlighted the financial strain experienced by the masses. He acknowledged the high cost of living and the challenges faced by individuals in affording necessities such as food and housing.

PREMIER'S DISAGREEMENT

However, Premier Wheatley countered assesments expressing concern about what he described as the dangerous idea that crime was solely a consequence of economic hardship. To make this point Hon.

highlighted Wheatley hardworking members the of community who did not resort to criminal activities even in challenging economic circumstances.

Premier Wheatley further argued that crime ultimately boiled down to personal choices, noting instances of employed individuals who still chose criminal paths in pursuit of quick and easy gains. He cited examples of individuals who had successfully rehabilitated themselves after serving

successfully rehabilitated themselves after serving prison sentences, such as Mr. Ramon George, a talented musician who had become a productive member of society, working as a boat captain.

Addressing the broader

challenges faced by the community, Premier Wheatley acknowledged the compounding issues, including climate disasters, the aftermath of the pandemic, and the impact of the Commission of Inquiry (CoI). He assured the people

of the Virgin Islands that the government was diligently working to tackle these challenges and promised to unveil plans and initiatives in the upcoming Budget Speech to address these pressing concerns."

OPPOSITION PRESENTS 120 QUESTIONS AND STAGE WALKOUT AFTER Q&A POSTPONEMENT

In a dramatic turn of events on 31 October, members of the Opposition staged a walkout from the House of Assembly. Their protest was triggered by the decision of Premier Natalio Wheatley's government to postpone the scheduled question-and-answer segment during the sitting.

The questions and answer

segment is an anticipated information-sharing aspect of the House of Assembly sittings, during which the Opposition members pose questions to the government. While drawing attention to the Opposition's dissatisfaction about the change in the Order Paper, Leader of the Opposition Hon. Ronnie Skelton

expressed his frustration, highlighting that the practice of delaying the questions has become all too common under the Wheatley administration.

The Opposition Leader minced no words, stating, "Obviously, the Premier and the government don't have any respect for the Opposition because this is the second or third time the only matter on the order paper is questions for the Opposition, and it's being shoved to the end of the session. I think this is disrespectful, and it needs to stop today."


Premier Wheatley responded swiftly, asserting that the delay in addressing questions was not indicative of a lack of respect. He reasoned that the sheer volume of questions from the opposition, approximately 120 in total, had placed an undue burden on public officers, forcing them to work overtime to gather the necessary information.

In a fiery sequel, Sixth District Representative Hon. Myron Walwyn raised an intriguing counterpoint. He suggested that it might be government legislators who were overwhelming public officers. Walwyn pointed out that the House had spent a significant portion of the morning listening to the Premier read eight statements, each lasting 15 minutes, along with statements from other government members. He argued that these lengthy statements, drafted by the same civil servants tasked with answering opposition questions, could be better disseminated to the media outside of the House of Assembly.

Hon. Walwyn emphasized that the question-and-answer segment represented the sole opportunity for Opposition members to engage with the government and seek answers on behalf of their constituents.

The matter was put to a vote, resulting in a seven-to-six majority in favor of altering the order paper and pushing the questions to the end of the session. Following this decision, Opposition members left the House in protest, leaving behind some government members who were seen laughing at the spectacle.

The ongoing House session continued with only government legislators present, leaving many questions unanswered and tensions simmering."



DEPUTY PREMIER DEFENDS TEMPORARY SUSPENSION OF TRADE COMMISSION ACT

During the House of Assembly sitting on 31 October, Deputy Premier and Minister for Financial Services, Labour, Trade, Hon. Lorna the Smith has defended Government's decision to temporarily suspend the Virgin Islands Trade Commission Act; despite the expressed disagreement of members of the Opposition. While noting that the suspension decision has caused some concerns, Hon. Smith declared in the House of Assembly that the action was necessary in order to have thoughtful reform and revitalization in the trade sector that aligns with the Territory's needs and aspirations.

During the presentation of the Virgin Islands Trade Commission Act (Suspensory) Bill, 2023 Hon. Smith essentially addressed many of the concerns that have been echoed by the public since it was announced that the Trade Commission was going to be suspended.

The Deputy Premier explained that the decision stemmed from the Government's apprehension about the viability and effectiveness of the Virgin Islands Trade Commission, a statutory body established through the Trade Commission Act, and came into effect on 21 November 2022.

While noting that the Commission was still in its early stages of development it was noted that there are some required enforcement matters that could cause issues. Hon. Smith said that one of the key issues was the timeline given to Trade Department employees.

Employees were granted six months to make this decision, and Minister Smith highlighted that this period coincided with the Commission's inactivity.

Minister noted despite the Act being in place for nearly eight months, key operational elements, such as the establishment of the statutory board, had not been realized. She said that there were some concerning factors and also noted that could bring elevated costs to businesses: "The Ministry received an implementation plan and budget in July, significantly delayed from the Act's enactment, projecting costs of \$1.5 million in government expenditure and an additional \$960,000 from business licensing revenues."

To achieve financial independence, the Commission projected a staggering 154% increase in trade licensing fees in its second year, a prospect that raised concerns about increased costs for businesses," she noted.

In emphasizing another major issue of concern within the Act, the Minister of Trade pointed out that the Business Licensing Act, passed in 2022, imposed even higher annual licensing fees than the proposed trade licensing fees, potentially impacting businesses and consumers.

As she summed up the decision to suspend the Virgin Islands Trade Commission Act, Hon. Smith underscored the commitment to consumer protection. She affirmed that consumer protection measures would remain a priority during the suspension period, with efforts to enhance consumer education, provide avenues for redress, and ensure ethical business practices.

In addition to consumer protection, Hon. Smith acknowledged the importance of investment promotion in

driving economic growth and prosperity. To this end, the Virgin Islands Investment Act of 2021, although falling under the remit of the Government, recognized as opportunity to attract domestic and foreign investments. It was noted through this Act the Ministry would actively promote the jurisdiction as an attractive destination for investment during the suspension period.

The decision to suspend the Trade Commission was brought to the public's attention by member of the Trade Commission Board Bishop John Cline, and Opposition Member Hon Marlon Penn. Both expressed concern that the suspension of the Trade Commission means that trade licenses given out since the Trade Commission Board was set up might become illegal.

PREMIER GIVES UPDATE ON PROGRESS MADE ON IMPLEMENTATION OF COI RECOMMENDATIONS

Premier Dr. the Hon. Natalio Wheatley addressed the House of Assembly on 31 October to provide an update on the government's ongoing efforts to implement the recommendations of the Commission of Inquiry (COI), as outlined in the June 2022 Framework Agreement.

Since the inception of this initiative, Premier Wheatley has emphasized the government's unwavering commitment to implementing these reforms to enhance the transparency, effectiveness,

and accountability of the Virgin Islands' governance. He pointed out that as of the end of September 2023, significant progress has been made, with 24 out of the 50 COI recommendations completed outright, and 26 recommendations having some form of ongoing action.

The BVI Leader provided a breakdown of the progress noting that: 79 out of 131 actions, or 60 percent, have been completed; 17 actions, or 13 percent, are in progress and on track; 24 actions, or 18 percent, are in progress

but experiencing challenges; and 11 scheduled actions, or 8 percent, have not yet begun. He clarified that the varying number of actions associated with each recommendation required a nuanced understanding of the progress achieved.

The-Framework Agreement outlined 12 official reviews, with 10 already completed. The most recent review tabled on 31 October, focused on Recommendation 24 and assessed the governance, financial management, and human resource management of statutory boards. The review was conducted by Mrs. Antoinette Skelton, with assistance from Mr. Nelson Samuel for the portion concerning the BVI Social Security Board.

Premier-Wheatley emphasized-that theinformation-and recommendations-from these reviews are under consideration by the relevant ministries, with input from various government agencies, and action plans will be submitted to Cabinet for further steps.

R e g a r d i n g - t h e implementation-timeline, P r e m i e r - W h e a t l e y acknowledged that some initial deadlines had proven to be overly ambitious. He disclosed that in September 2023, at the request of the Minister for Overseas Territories, the government had updated the deadlines based on the current status of the work.

Opening Statement by Hon. Lorna Smith, OBE, Minister for Financial Services, Labour and Trade on the Virgin Islands Trade Commission Act (Suspensory) Bill, 2023

Madam Speaker, with your permission I would like to present a bill seeking the suspension of the Virgin Islands Trade Commission Act, 2020. This Act, passed on 8 June 2020, aimed to establish the Virgin Islands Trade Commission, and vest it with critical responsibilities related to business, trade, investment, and consumer affairs within our jurisdiction. The Act came into effect on 21 November 2022, through Statutory Instrument S.I. 103 of 2022.

Upon assuming office as the Minister responsible for trade at the end of April 2023, it became evident that the Commission was still in its early stages of development, raising concerns about its viability and effectiveness. Given the circumstances, a careful evaluation of the Act's implementation became imperative.

One significant concern stemmed from the rapidly expiring timeline given to employees of the Trade Department to decide whether to transition to the Commission, which had yet to become fully operational. Employees were granted six months, from November 2022 to May 2023, to choose between remaining with the central government or transitioning to the statutory body, which was still inactive.

In fact, one of my initial official duties was to attend the orientation of the Board on May 15, nearly six months after the Act had become law. It was on that day that I began to question the wisdom of implementing the Virgin Islands Trade Commission under our current circumstances.

Madam Speaker, this sixmonth milestone is significant as it mirrors the timeframe given to Trade Department employees to decide their future, while the Commission remained inactive. Shortly thereafter, I met with the Chairman and key officials to express my concerns and request a clear implementation plan and budget to guide the establishment of administrative arrangements for the Commission.

The period between the legislation's passage and the establishment of a statutory board is typically referred to as an 'incubation' or 'transition' period. During this time, the central government continues to oversee and fund the department's operations while providing technical support to the Board.

Madam Speaker, all of this occurred against the backdrop of discussions with numerous small and medium-sized businesses during my round-table meetings. Business owners highlighted foundational issues requiring immediate government attention to strengthen our business sector and the broader economy. Importantly, none of the hundreds of individuals we spoke to indicated the need for this statutory body as a solution to their challenges.

The Ministry eventually received an implementation plan in July, eight months after the legislation had been enacted, along with a budget that would cost the government \$1.5 million, in addition business licensing revenues of approximately \$960,000. This expenditure was primarily aimed at maintaining the status quo in terms of service delivery while funding core administrative costs such as HR Management, Financial Management, payroll systems, information technology, and legal services separately from central government. Achieving financial independence in the Commission's second year was projected to require a 154% increase in trade licensing fees.

Madam Speaker, while an increase in trade licensing fees is warranted, given that the current fees were set more than three decades ago, I was surprised to inherit a Business Licensing Act, passed in 2022, with even higher annual licensing fees - as much as \$1,000 for Belongers and \$15,000 for Non-Belongers engaged in certain business activities.

We all know that significant increases in the cost of doing business can lead to more business failures and higher prices for consumers. At a time when members of the House are calling

for financial subsidies to support local businesses, their support of this suspensory Bill would demonstrate their commitment to enhancing the business environment in the Territory.

The Business Licensing Act, 2022 is part of a suite of legislation intended to be administered by the Trade Commission, along with the Consumer Protection Act of 2020 and the Virgin Islands Investment Act of 2021. It is crucial to note that neither of these pieces of legislation has been put into effect.

Madam Speaker, I want to underscore that each of these pieces of legislation has merit and will not be abandoned. Appropriate amendments can be made that would allow the Ministry of Financial Services, Labour, and Trade to administer all traderelated legislation.

Madam Speaker, it is crucial to emphasise that as we navigate this period of suspension and reevaluation, the importance of consumer protection will remain at the forefront of our priorities. Our commitment to safeguarding the rights and interests of consumers will not waver. The Consumer Protection Act of 2020 holds great significance in ensuring fair and ethical business practices within our jurisdiction. During this transitional phase, we will work diligently to strengthen and enforce consumer protection existing through measures government channels. We believe that robust consumer protection is not only a fundamental right but also a cornerstone of a healthy and thriving economy. Therefore, our efforts will include enhancing consumer education, providing accessible avenues for redress, and ensuring that businesses adhere to ethical standards in their dealings with customers. In doing so, we aim to build trust between consumers and businesses, fostering a more resilient and prosperous future for the Virgin Islands.

Madam Speaker, in addition to our commitment to consumer protection, we also recognise the pivotal role that investment promotion plays in driving economic growth and prosperity. The Virgin Islands Investment Act of 2021 represents a significant opportunity to attract both domestic and foreign investments that can fuel job creation, infrastructure development, and innovation. Nevertheless, in all honesty, Madam Speaker, it is important

to acknowledge that many of the provisions within the Investment Act fall under matters of policy to be determined by the Government.

While we suspend the Virgin Islands Trade Commission Act, the Ministry can actively promote our jurisdiction as an attractive destination for investment. We will work to streamline investment procedures, create a conducive business environment. engage in targeted marketing efforts to attract investors. By doing so, we aim to foster economic diversification, reduce unemployment, and stimulate sustainable development in the Virgin Islands. Our focus on investment promotion aligns with our broader vision of building a resilient and prosperous future for our Territory.

Madam Speaker, although the Virgin Islands Trade Commission Act of 2020 was enacted with noble intentions, its practical implementation has faced significant challenges and obstacles that warrant reconsideration of its timing. Implementing the Act in its current form faces multiple obstacles, including:

Increased operational costs during a period of budgetary constraints

Increased bureaucracy Staffing limitations

Unresolved employment terms and conditions for transitioning staff; and Resolution of duplicatory functions and clarity of roles of the Commission and the Ministry.

Ignoring these issues would be a failure of our duty, and thus, I propose to suspend the commencement of the Act, rendering its provisions inactive.

In light of this decision, the Ministry of Financial Services, Labour and Trade will assume direct oversight of trade-related policies and operations. We will work diligently to secure the necessary resources to enhance the capabilities of the Department of Trade, Investment Promotion, and Consumer Affairs. Our aim is to streamline and automate business processes, support local entrepreneurs, and promote investment and fair trade practices.

The underlying policy is to strengthen and maintain traderelated public functions within the central government. The Trade Department should be well resourced to carry out a clear mandate and be accountable to the Government and the public. Additionally, the period of suspension will offer an opportunity to assess the best administrative arrangements for governing trade-related policies and services in the future. This evaluation will inform my decision on whether to propose any alterations to the initial scope of operations envisaged for the Trade Commission.

Over the next 12 months, we intend to take the following actions to implement this policy:

Conduct a review of the department's current structure and operations.

Develop a strategic plan for the department with clear priorities for implementation.

Provide the department with the resources it needs to carry out its responsibilities, including technology, staffing, and training.

Develop and document operational policies and procedures to enhance transparency and ensure consistency in its business processes.

Establish clear accountability mechanisms, including setting performance targets for the department and reporting on its progress.

Strengthen the department's relationships with other government agencies and stakeholders to ensure it is well coordinated and aligned with the Government's priorities.

Madam Speaker, I wish to emphasise that the Virgin Islands Trade Commission Act, 2020 is not being repealed; rather, the bill presented today seeks to temporarily suspend its operations. This juncture also provides an opportunity to assess the best administrative arrangements for governing trade-related policies and services going forward.

In conclusion, I urge this honourable House to support the bill to suspend the Virgin Islands Trade Commission Act, 2020, so that we can embark on a path of thoughtful reform and revitalisation in our trade sector, one that better aligns with the needs and aspirations of the Virgin Islands and its people.

Thank you for your attention, and I yield the floor for further deliberation on this matter.



Statement by Premier Wheatley on RATED Programme

Madame Speaker, Registration Apprenticeship Training Employment Development (R.A.T.E.D.) Programme seeks to provide a pathway for persons who are unemployed or who are under-employed to obtain an opportunity through short-term employment, apprenticeship and/or training development. The pathways are: (1) temporary employment for short periods providing services within Government Departments where there is a need for additional resources; (2) apprenticeship, on stipend, with public and private sector organisations that agree to partner with the Government in the programme; and (3) training, education and skills development through courses and programmes offered by the H. Lavity Stoutt Community College (HLSCC) and other training institutions.

Madame Speaker, at the end of 15th October 2023, a total of 721 applications were received representing various areas of interest. Persons who applied are contacted to ascertain their job readiness as it pertains to access to the necessary tools needed to perform the various tasks. Requests for Apprentices were processed using a completed temporary request form. This form allows the requesting Ministries/ Departments to indicate all the necessary details for engaging interested persons.

Madame Speaker, all persons engaged under the programme were issued an assignment letter prior to commencing. The assignment letter highlights the terms and other conditions of the assignment. Once an applicant has received an assignment

letter, that information is entered into an electronic engagement database, capturing all the appointment details and taking note of the completion date. This allows for easy information retrieval on engagements to date. At the end of the assignment, apprentices were issued an end of assignment letter and a Certificate of Completion participating in Apprenticeship Programme.

Madame Speaker, the shortterm assignment allowed for the necessary exposure to employment opportunities with a number of ministries and departments in the Public Service. Interested persons were placed with the Premier's Office, Ministry of Health and Social Development, Virgin Islands Trade Commission, Department of Information and Public Relations, Civil Registry and Passport Office, Virgin Islands Shipping Registry, Immigration Department, the Department of Labour and Workforce Development, Department of Information Technology, Land and Survey Department, Records Management Centre, Ministry of Tourism, Culture and Sustainable Development, Ministry of Communications and Works and the Magistrate's Court. To date there were a total of 53 apprentices in the areas of administration, customer service, data entry and sanitation.

M a d a m e - S p e a k e r, engagement under the Programme is for a period not to exceed six months. Most engaging ministries/departments utilised the maximum period to allow them the opportunity to meaningfully

execute the assigned tasks and to allow a proper timeframe for fairly assessing apprentices' performance. This assisted departments with day-to-day tasks as the departments were challenged, in some cases, by the lack of human resources.

Madame Speaker, the Programme has allowed numerous persons to be engaged, while gaining work experience and exposure to the work force. Each apprentice engaged had the opportunity to be engaged on a full time basis,

should there be the opportunity to do so within the Ministry/ Department; there were a total of six persons who were offered fulltime employment having gone through the R.A.T.E.D. programme. The total funds expended on the programme to date since inception \$1,430,753.61; this amount covers the period December 2022 to September 2023.

Madame Speaker, I would like to take this opportunity to encourage interested persons to apply to the programme. Yes, I recognise that this is not that fulltime employment that you are in search of, but this could be your opportunity to get your feet in the door, as it were, and prove yourself to that prospective employer. I am also encouraging the business community to partner with us on this very important initiative. Overseas recruitment is expensive, so join us as we build the capacity of the local labour pool.

GLOBAL NEWS BRIEF

ISRAEL - Israeli Prime Minister Benjamin Netanyahu has said fighting inside the Gaza Strip will be "long and difficult," with Israeli ground forces now operating in the Palestinian territory for more than 24 hours.

"The war in the [Gaza] Strip will be long and difficult and we are prepared for it," Netanyahu told a news conference after meeting families of hostages held in Gaza.

Netanyahu said the ground operation launched by Israeli troops in Gaza was the second stage in a war against the Islamist group Hamas, and defeating Hamas is an "existential test" for Israel. He also called on the civilian population of Gaza to move to safe areas.

According to the prime minister, contacts to secure the release of hostages are continuing even during the ground offensive, and every effort would be made to rescue the more than 200 hostages held by Hamas.

Netanyahu said the idea of a swap deal of hostages for Palestinian prisoners had been discussed within the Israeli war cabinet. But he declined to elaborate, saying revealing any details would be counterproductive.

He also accused Hamas of using hospitals as command centers and said that "90%" of the Hamas military budget comes from Iran. [Deutsche Welle]

Foreign ISRAEL Minister Eli Cohen has said Israel recalled its diplomatic envoys to Turkey because of "grave statements" made by Ankara. "Given the grave statements coming from Turkey, I have ordered the return of diplomatic representatives there in order to conduct a reevaluation of the relations between Israel and Turkey," Cohen said in a post on the social media site X, previously known as Twitter. On Saturday, Turkish President Recep Tayyip Erdogan told a pro-Palestinian rally in Istanbul that Israel was committing "war crimes." He called on Israel to emerge from what he described as its "state of insanity" and end military actions in Gaza.

Earlier, the Turkish leader had already called Hamas, which rules the Gaza Strip, "freedom fighters," terrorists. Ankara maintains contacts with Hamas and, according to its own statements, is trying to secure the release of the hostages from the Gaza Strip. The militant Islamist Hamas, which launched the October 7 attacks on Israel, has been classified as a terrorist organization by the European Union, Germany, the United States and many other countries. [Deutsche Welle]

ACAPULCO - Mexico's death toll was raised to 39 on Saturday from Category 5 Hurricane Otis' strike on the country's southwestern coast earlier in the week.

Some victims have yet to be identified, according to Mexico Security Secretary Rosa Icela Rodríguez. Ten people are reported missing. The country's secretary defense said an "air bridge" had been set up between Acapulco and Mexico City to bring supplies and medical staff in and take tourists out. More than 100 buses also will be used to evacuate people from the resort city, which sustained heavy damage from Otis.

The limited information,

photos and video coming from the city show severe damage to structures, including many of the hotels and high-rises in tourist areas, and flooding that inundated city streets. Windows were blown out, roofs ripped off and vehicles crushed. Some said no warning was provided about the Category 5 storm, and in some hotels, guests were not moved to safer shelter. "We laid down on the floor, and some between beds," Jakob Sauczuk, who was staying with friends at a beachfront hotel, told the AP. "We prayed a lot." [The Weather Channel]

US VIRGIN ISLANDS - In an announcement made on Friday, the government of the US Virgin Islands raised alarms regarding the safety of the tap water on the island of St. Croix.

Those on the island have been advised against consuming the tap water after the discovery of high levels of lead and copper.


Reports are that a series of tests are underway to discern the source and magnitude of the contamination. Efforts are being consistently made by the US territory's Water and Power Authority, which is actively engaged in flushing the water lines, aiming to mitigate the levels of toxins present. It is reported that the water was first tested in late September as part of a local and federal investigation into its brown and red color. [CNW]





Big Batch Bolognese Sauce for Less-Stress Holidays

The whirlwind of the holiday season is fast approaching. Making delicious, homemade meals ahead and storing them in your freezer is an excellent way to relieve some holiday stress and limit unplanned drivethru meals.

This week, I'm sharing my recipe for Big Batch Bolognese Sauce. It's a slow-cooked, rich, meaty and versatile sauce that's delicious. It's made with ground beef, veggies, tomatoes, wine and milk. Yes, milk. Milk gives Bolognese its distinctive creaminess.

Bolognese freezes beautifully and can be divided and used to make many different dishes. Bolognese goes in pasta, lasagna, deep dish pizzas, baked potatoes and

my favorite -- served over spaghetti squash.

BIG BATCH BOLOGNESE SAUCE

Yield: 18-20 (1 cup) servings Total Time: 4 hours

3 tablespoons olive oil

5 cups chopped onions

2 cups chopped carrots
1 1/2 cups chopped celery

3 tablespoons butter

6 cloves garlic, chopped

Salt and pepper to taste

5 pounds ground beef

2 tablespoons Italian seasoning

1 (15 ounce) can tomato paste

2 cups red or white wine (or beef broth)

2 (28 ounce) cans Italian-style diced

tomatoes

2 cups whole milk

3 bay leaves

1 cup grated Parmesan cheese

In a large Dutch oven or stock pot, over medium heat, saute onions, carrots and celery until they're softened and begin to caramelize. Then add the butter and garlic, and saute until fragrant. Lightly season with salt and pepper. We're adding Parmesan later, so go easy on the salt for now. Remove the veggies and keep them warm.

In the same pot, turn up the heat to medium-high. Brown the beef in three to four batches, breaking it into small pieces and seasoning lightly. After each batch, use a slotted spoon to remove the cooked beef, and drain as much fat as possible. You want the beef to brown and hopefully leave behind some browned bits in the pan.

After the last batch of beef, return the veggies and cooked beef to the pot. Add the Italian seasoning and tomato paste, stirring to coat every morsel with tomato goodness. Let it cook, stirring occasionally, for at least 5 minutes to caramelize the tomato paste. This step adds tremendous depth of flavor.

Now add the wine to deglaze the pot, scraping up all those lovely browned bits from the bottom. When most of the wine has evaporated, about 3 minutes, add the diced tomatoes, milk and bay leaves. Stir and bring



to a boil.

Then reduce the heat to a gentle simmer, cover and cook, stirring occasionally for at least 2 hours, but preferably 4 hours. The longer, the better.

To serve, remove the bay leaves and add the Parmesan cheese, stirring to combine. Meanwhile, cook your pasta according to the package directions. This sauce wonderfully with a wide pasta like tagliatelle or pappardelle, but you can use whatever you have on hand. Don't forget to top it with more Parmesan. And if you have some of that wine left from the recipe, enjoy it with your meal.

Now let's talk about how to make the most of this sauce. To freeze it, the most crucial step is to cool it completely to refrigerator temperature before preparing it for freezing. Portion it into zip-top freezer bags. For the best flavor, use it within three months, but it's safe to eat for a year. Yes, making this recipe takes some time, but most of it is hands-off. Once it's done and waiting in your freezer, you can have a hearty, homemade dinner ready in the time it takes to boil pasta. Enjoy!

INTRODUCTION TO THE STAMPS OF THE B.V.I.

PART 5

THE RICHES OF THE PRESIDENCY OF THE VIRGIN ISLANDS

In 1871 the Virgin Islands and five other Lesser Antilles presidencies formed the newly established Federal Crown Colony of the Leeward Islands, which began issuing its own stamps in October 1890. Leeward Islands stamps were meant to replace local issues but were, in fact, used concurrently with the Virgin Islands stamps.

The Road Town Post Office experienced a substantial loss in revenue

from stamp sales and recommended issuing its own stamps and this caused other presidencies to ask for a similar privilege.

In 1898, the actual post office receipts totalled over £35 and the islands revenue totalled £1,715; a year later with the re-introduction of local stamps the post office receipts amounted to £1,509, boosting the islands' total revenue to a grand total of £2,984.

In fact, in January 1899 the Road Town post office had began to sell a new set of eight Virgin Islands stamps with a uniform design known as the Virgin of the Lilies. The new design was adopted to distinguish the new stamps from the ones previously issued.

The typographical errors (HALFPFNNY and HALΓPENNY) occurring on the 1/2d. denomination of this set are well known; they were promptly discovered by contemporary collectors, some of whom went to the trouble of sending them to the colony to obtain used

specimens. In this respect one may be tempted to label them as cancelled to order but this is hardly a blemish and should be overlooked. Of the 4d. 'FOUR PENCF' error, technically only 298 were printed, how many of them have survived is a different story. Half the specimens surfacing at auction have some gum or perforation problem and used copies are seldom seen.

From 1889 to 1 July 1956, when the Federal Colony of the Leeward Islands was dissolved, both BVI and Leeward Islands stamps were used in the territory with the former enjoying greater favour. Surviving commercial mail with Leeward Islands stamps used in the BVI is rather

small, nevertheless, according to reliable contemporary witnesses Leeward Islands stamps were regularly used by the local post office and its branches throughout the 1940s and early 1950s. The early Leeward Islands issues are particularly difficult to find with BVI postmarks and all subsequent issues, especially on cover, are quite desirable. In the words of R E R Dalwick, Leeward Islands stamps 'used in the Virgin Islands group should not be missed, they greatly increase the interest of the collection and fill up what would otherwise be a big gap in the postal history of the islands.

THE STAMPS OF KING EDWARD VII AND KING GEORGE V

After the death of Queen Victoria, a new set of definitive stamps depicting her son and successor, King Edward VII, was issued by the Virgin Islands post office in 1904. The design features an ornate frame with the head of King Edward VII, turned to left [based on a portrait medallion by Emil Fuchs] based on the design of the Imperium Type of stamps used for other colonies.

His successor, King George V reigned from 1910 to 1936. The first definitive stamps of his reign were issued in 1913 (February) - 1916-17 and 1919. They depict the head of King George V, facing left; Imperium Type [Die 1] used for other colonies. Some are bi-coloured stamps, and some were printed on coloured paper.

THIS WEEK IN CORRUPTION GAS-PING FOR JUSTICE

Is all well that ends well? This

case will make you think twice.

This week, the Nigerian government secured a major legal victory: a UK court overturned a prior award, according to which the Nigerian government was to make an estimated US\$11 billion payout to a shady offshore company involved in a failed gas deal.

The reversal is a massive relief to the government of Nigeria,

who would have struggled to pay such a hefty sum, which currently equates to roughly 40 per cent of the country's 2023 annual budget. It also wraps up a decade-long saga involving corrupt Nigerian officials and truly bizarre legal misconduct.

The Nigerian government's initial deal with Process & Industrial Developments Limited (P&ID), struck back in 2010, raised red flags from the beginning. The small company was registered in the British Virgin Islands, a notorious hub for financial secrecy. It

was run by two business partners, both from Ireland, who had no prior experience in the gas sector.

Even so, they won a contract to develop a processing plant that would turn "wet gas" supplied by Nigeria into more usable "lean gas". Interestingly, they already had a prior relationship with influential Nigerian billionaire and former defence minister General TY Danjuma, who would later be named in the Panama Papers.

The deal turned sour by 2012 when P&ID commenced an arbitration claim, an opaque form of dispute resolution between foreign investors and nation-states, over lost profits. They claimed Nigeria had failed to carry out their side of the deal, setting off years of legal proceedings in the UK. During the drawn-out arbitration process, Nigeria was represented by a legal counsel who, at one point, attempted to summon a witness who was deceased.

This part of the legal saga culminated in 2017, with a UK arbitration tribunal ruling that held Nigeria liable for US\$6.6 billion in damages, plus interest. After an appeal that lasted several years, the damages stood at an eyewatering US\$11 billion at the time of this week's ruling.

As the case was untangled over time, evidence of corruption at the heart of the ill-fated gas deal came to light.

In 2020, Nigeria submitted evidence to the UK courts revealing

that P&ID had bribed two government agency employees responsible for the gas contract. Even more shockingly, another employee of the agency recommended to the Attorney General that the state should settle with P&ID, citing a weak case. This same employee was found to have US\$100,000 in their bank account, deposited seven days later by the counsel representing Nigeria during the arbitration. This raised significant suspicions that the counsel - the one who also wanted to cross-examine a dead witness - was colluding with P&ID.

The disappointing legal drama doesn't end there. This week's ruling also slammed two English lawyers acting for P&ID for retaining legally privileged Nigerian documents and acting without legal integrity. Interestingly, one of the lawyers - a

nephew of P&ID's co-founder - would have received US\$850 million if the case was successful, while another who represented P&ID during the arbitration would have received US\$3 billion.

Auwal Musa Rafsanjani, the executive director of the Civil Society Legislative Advocacy Centre, our chapter in Nigeria, noted to journalists the importance of this week's legal victory in avoiding a potential economic catastrophe. He urged for a thorough

investigation into the government entities involved in the P&ID gas deal.

While this week had a positive outcome for the Nigerian government, there's no denying that the Nigerian people have been let down by public officials who were not serving their best interests and by costly legal proceedings that left everyone involved worse off.

The UK court finally ruled in Nigeria's favour only once irrefutable evidence of corruption was brought to light. There were significant red flags that had surfaced earlier than this, yet they were not considered by the arbitration tribunal. This week's judgement acknowledged a fundamental power imbalance not only in the initial corrupt contract, but in the subsequent legal avenues available to both sides.

Unfortunately, the arbitration processes in cases like these largely take place behind closed doors, leaving no room for civil society advocates in Nigeria, or elsewhere, to investigate and raise red flags.

That is why more transparency in arbitration processes is key. Allowing these disputes to drag on without public scrutiny brings about the sort of risks we have seen in the lengthy P&ID saga. Promoting fairness and accountability would serve the broader interests of justice and the public.

RVIPF REMAINS CONCERNED ABOUT BURGLARY SPIKE

Thursday, November 2

- The RVIPF would like to emphasize its ongoing concern regarding the increase in occurrences of both commercial and residential burglaries. In

these-burglary incidents, the perpetrators frequently make off with a range of electronic devices, including laptop computers, -mobile phones, and gaming consoles.

We urge the public to remain vigilant for individuals selling these items, especially if the prices are significantly lower than the market value. The RVIPF also urges individuals to promptly report any such incidents to the police if there is reason to believe that the items were stolen or acquired unlawfully.

Head of the Criminal Investigation Department, Detective Chief Inspector Kenrick Davis stated: "It is far better to prevent burglaries than to investigate them after they have occurred. A person's home should be their safe space and once it is violated by trespassers, it is not the same place anymore".

The RVIPF is conducting-focused patrols as a preventive measure while

investigations remain ongoing in reported burglary cases. As such, DCI Davis would like to reiterate the following self-help options to individuals, families and businesses:


- 1. Install CCTV cameras in and around your premises to monitor activities and deter potential burglars.
- 2. Utilize alarm systems and ensure that the exterior of your property is well-lit. Adequate lighting can act as a deterrent to would-be intruders. Motion lights are a good option.
- 3. Securely lock your doors and windows, especially when away from your premises. This basic measure can significantly reduce the risk of unauthorized entry.
- 4. Regularly inspect and maintain the locking mechanisms on all windows, ensuring that they are fully operational. Any faulty locks should be promptly repaired or replaced.
- 5. Do not leave a spare key outside. A large percentage of burglaries happen without forced entry.
- 6. Safeguard your valuable possessions by photographing them in their respective locations within your home. Create

a detailed inventory list for each item, and record serial numbers or specific identifying marks to make it easier to identify them in case of theft.

7. Establish a neighbourhood watch group which can be conveniently organised through a WhatsApp platform. In this setup,

residents within a specific neighbourhood can serve as vigilant observers, promptly reporting any suspicious incidents they come across to their fellow community members and the police. The RVIPF stands ready to provide advice and support to any community wishing to start these groups.

Persons who can assist police with information into any burglary can confidentially call the Crime Stoppers line 800-8477 (TIPS) or overseas call 1-284-800-8477 with the relevant information or contact the RVIPF Intelligence Unit at 368-9339.

Jamaicans were left panicking on Monday as a 5.6 magnitude earthquake hit the island prompting people to flee buildings amid heavy shaking that knocked out power in some areas but appeared to cause no serious damage.

Most people reported

feeling the tremor for approximately 30 seconds.

The quake's epicentre was about four kilometres west-northwest of Hope Bay, Portland and occurred at a shallow depth of 10 kilometres.

Jamaica sits atop the Enriquillo-Plantain Garden

fault zone as do Haiti and the Dominican Republic and has been the scene of several earthquakes over many years.

Seismologists say that while small earthquakes are common in and around Jamaica — approximately 200 a year — strong ones are rare.

Departures From Gaza Begin as Rafah Border Crossing Opens for First Time Since Start of Israel-Hamas War

Internet and phone networks are down across the Gaza Strip on Wednesday, the Palestinian telecommunications agency says

U.S. Secretary of State Antony Blinken to return to region Friday

The first group of foreign nationals who have been trapped in Gaza since the start of the war between Israel and the Palestinian militant group Hamas began leaving the besieged enclave for Egypt Wednesday.

The reopening of the Rafah border crossing to allow foreign passport holders to leave was part of a deal between Israel, Egypt and Hamas that was brokered by Qatar. At least 400 foreign nationals will be allowed to cross into Egypt.

In addition to the foreign nationals, about 81 injured Palestinians were also taken by ambulance from Gaza to receive treatment in Egyptian hospitals. The patients are the first known Palestinians allowed out of Gaza since the start of the October 7 war.

The first departures of foreign nationals and

Palestinians comes as Gaza is once again experiencing a total communications blackout.

The-enclave's telecommunications service provider Paltel (Palestine Telecommunication Company) issued a statement late Tuesday on X, the social media website formerly known as Twitter, informing residents of a complete outage of all telephone and Internet services. The company said the outage was "due to international routes that were previously reconnected being cut off again."

Gaza suffered a complete communications blackout for two days beginning last Friday, leaving the besieged territory's 2.3 million people cut off from the world and stalling delivery of critical international relief supplies.

The latest disruption of phone and Internet service occurred hours after an Israeli airstrike on a Palestinian refugee camp in the northern Gaza city of Jabaliya that left at least 50 people dead and 150 others wounded, according to Palestinian health authorities.

An Israeli army spokesman confirmed the airstrike to CNN, saying "a very senior Hamas commander" was in the area. A statement by the Israel Defense Forces later identified the man as Ibrahim Biari and said he was a ringleader of the "murderous terror attack" on October 7 by Hamas militants in southern Israel.

Jabaliya was home to the families of refugees from wars dating back to 1948, according to Reuters. A statement from Hamas said that no commanders were

at the camp and put the casualties at 400 dead or wounded. Agence France Presse said Wednesday that Hamas is claiming that seven hostages, including three foreign passport holders, were among those killed in the airstrike

Those claims have not been independently verified.

Israel accuses Hamas, designated a terrorist group by the U.S. and others, of using civilians as shields and having a sprawling network of tunnels underneath Gaza where it is believed to be stockpiling weapons, food and other supplies.

The airstrike on the Jabaliya refugee camp angered several of Israel's Arab neighbors. The United Arab Emirates's foreign ministry issued a statement saying the attack will lead to "irreparable ramifications in the region." The kingdom once again called for "an immediate ceasefire to prevent further loss of life."

Saudi Arabia condemned

the attack as "inhumane targeting by the Israeli occupation forces," while a spokesman for Iran's foreign ministry said the attack was yet another war crime committed by Israel in a post on the messaging site Telegram.

Tuesday's attack Jabaliya was the latest in a series of ground and air strikes by Israel's military aimed at Hamas and its extensive tunnel network in Gaza. The IDF earlier Tuesday said an airstrike killed another Hamas commander, Nasim Abu Ajina, who orchestrated the October 7 terror attack that left 1,400 people dead. Israeli authorities say as many as 239 people were kidnapped during the raid

and are being held hostage.

Blinken to Return to Region Friday

U.S. Secretary of State Antony Blinken will travel to Israel Friday for meetings with members of the Israel government, with plans to "make other stops in the region," according to a brief statement by spokesman Matthew Miller.

Miller said Blinken spoke by phone Tuesday with Israeli President Isaac Herzog. He said Blinken reaffirmed U.S. support for Israel's right to defend itself against terrorism "consistent with international humanitarian law emphasized the need to take feasible precautions to minimize harm to civilians."

Paget's Disease Causes Arthritis, Pain, Deformities and More

DEAR DR. ROACH: My husband has been diagnosed with Paget's disease. I would like to know more about it; this is the first time I have ever heard of it. I would like to know the treatments and how much damage affects the bones. He is 76, had prostate cancer and underwent radiation treatment. — C. W.

ANSWER: Paget's disease of the bone is a common disease in people of European ancestry, with a lifetime prevalence of approximately 3%, although it remains undiagnosed in many. The cause of the disease appears to be a defect in bone reabsorption by the osteoclast, a specialized cell that normally helps maintain bone health. Paget's disease is not a cancer. It is normally diagnosed over the age of 55.

Most cases of Paget's disease are asymptomatic; however, without treatment, some people will develop arthritis, pain, deformities and fractures. The bone deformities may lead to nerve compression and, in the case of the tiny bones in the ear, hearing loss. X-rays and a high alkaline phosphatase (ALP) blood test are suggestive of the diagnosis. A bone scan is recommended to see the extent of damage from the disease.

Fortunately, highly effective treatments are available. Bisphosphonate drugs, the same drugs that are used to treat many people with osteoporosis, are very effective. A single treatment with zoledronic acid is effective at stopping (not reversing) the progression of the disease, and fewer than 20% of people will need a second dose. Diagnosing and treating early are ideal.

ation treatment has anything to do with his diagnosis of Paget's.

DEAR DR. ROACH: I'm a 76-year-old male who was recently diagnosed with transitional cell carcinoma of the ureter, but I don't have a history of smoking or any occupational exposure to chemicals, plastics, rubber or dyes. My cancer was found through a CT scan with contrast dye after having asymptomatic hematuria. It's isolated to the proximal ureter and a kidney. How rare is that?

I have to have the kidney and ureter removed. Can you talk about living with one kidney and the adjustments that I'll have to make? — R.P.

ANSWER: Urothelial cancers (the new name for transitional cell cancers) come from the lining of the urinary tract and can be present in the kidneys, ureters (the tubes that carry urine from the kidneys to the bladder), bladder and urethra (the tube that carries urine outside of the body). They are not common, about one per 100,000 people per year.

About 17% of people with cancer in the ureter will also have cancer in the bladder at the same time, and almost half will develop cancer in the bladder later in life. Careful screening, such as a look inside the bladder every six months, is essential.

You are correct that smoking and certain industrial exposures are risk factors for developing these cancers, but so is the place of origin; cancer syndromes such as Lynch syndrome; other toxins such as the drug phenacetin; and traditional Chinese herbs containing aristolochic acid. For localized diseases, complete removal is the safest approach, since there may be multiple small areas affected by cancer.

Living with one kidney is not that different from living with two, as the other kidney somewhat compensates for the missing one. Some medications may need to have lower doses, but usually, this is not the case.

VENEZUELA'S DANGEROUS REFERENDUM: THREATENING PEACE AND INTERNATIONAL LAW

For sixty years, from their entry into school, Venezuelans have been trained into believing that the Essequibo region of Guyana belongs to Venezuela. Consequently, regardless of the facts, this belief is ingrained in the Venezuelan psyche.

This is why, the only matter on which the contending political factions in Venezuela can agree is that Essequibo is Venezuelan.

It has long been a political tactic that, when there is domestic discord, a common enemy should be created, in an attempt to gain political support generally.

Hence, the periodic but persistent proclamations from Venezuela, claiming Essequibo.

The latest attempt to validate the acquisition of the Essequibo region is evident in the questions posed to the Venezuelan electorate in a forthcoming referendum with a predetermined outcome.

The contrived referendum, prejudicially titled, "in defence of Guayana Esequiba", will be held on 3rd December 2023. Among its deliberately leading questions, designed to get a desired positive answer, is the following: "Do you agree with the creation of the Guayana Esequiba state and the development of an accelerated plan for the comprehensive care of the current and future population of that territory that includes, among others, the granting of citizenship and Venezuelan identity card in accordance with the Geneva Agreement and international consequently incorporating said state on the map of Venezuelan territory?".

Given that for over 60 years, successive governments of Venezuela have carried out a propaganda policy of brainwashing their people to adopt the claim that Essequibo belongs to Venezuela in defiance of an 1899 International Arbitral Award, the question is framed to secure the electorate's support as validation of the annexation of Essequibo.

Significantly, the questions for the referendum ignore entirely that there is an existing arbitral award since 1899 that establishes the boundaries between Venezuela and Guyana. Similarly, the questions ignore the historical evidence that Venezuela proclaimed the arbitral award and ratified it in their congress.

The referendum also makes no mention of the fact that, since 2018, there is a case before the highest legal court in the world, the International Court of Justice (ICJ), to settle the validity of the 1899

award. The only reference to these proceedings is contained in question 3 of the referendum, which, prejudicially, poses the loaded question: "Do you agree with the historic position of Venezuela not to recognise the jurisdiction of the International Court of Justice to resolve

the controversy over the territory of Guayana Essequiba?".

The Venezuelan authorities neglect to advise their electorate of Articles 92 and 93 of the Charter of the United Nations. Article 92 states, "The International Court of Justice shall be the principal judicial organ of the United Nations" and Article 93 declares, "All Members of the United Nations are ipso facto parties to the Statute of the International Court of Justice." Not to recognise the jurisdiction of the ICJ is tantamount to a repudiation of the UN Charter.

Moreover, the ICJ has already twice decided that it has jurisdiction to determine the validity of the 1899 award and the related land boundary between Venezuela and Guyana. The placing of the question in the referendum, in the manner in which it is framed, is a flagrant disregard for international law, the UN Charter and the ICJ.

It is clear that this contrived referendum is designed to lead the Venezuelan electorate into giving cover for the government decision to ignore the ICJ proceedings and, instead, to take unilateral action to "incorporate" Essequibo into "the territory of

Venezuela".

The Caribbean Community (CARICOM) rightly responded to this situation by noting that "two of the questions approved to be posed in the Referendum, if answered in the affirmative, would authorise the government of the Bolivarian Republic of Venezuela to embark on the annexation of territory, which constitutes part of the Cooperative Republic of Guyana, and to create a state within Venezuela known as Guyana Essequibo". Further, CARICOM reaffirmed that "international law strictly prohibits the government of one State from unilaterally seizing, annexing or incorporating the territory of another state. An affirmative vote as aforesaid opens the door to the possible violation of this fundamental tenet of international law."

Against this background, it seems that the Venezuelan government is convinced that its chances of a favourable decision from the ICJ of its claims are very slim. Therefore, it is moving to annexation, a blatant violation of the Charters of the UN and the

Organization of American States.

Venezuela has reached this point after many efforts to scuttle the ICJ process, by asserting that the controversy with Guyana could be settled by dialogue and negotiation between the two states. In making this assertion, Venezuela ignores the 50 years of joint commissions, direct negotiations, and UN good offices mediation which all failed. It also ignores that the present ICJ process, which flowed directly from the 1966 Geneva Agreement in which both Venezuela and Guyana agreed, under Article IV (1), that the UN Secretary-General shall make the decision concerning "one of the means of settlement provided in Article 33 of the Charter of the United Nations". The Secretary-General decided on the ICJ.

And, Venezuela had every opportunity to participate actively in the proceedings even after it lost its legal arguments objecting to the Court's jurisdiction. Therefore, Venezuela's call for dialogue and negotiation is another gambit to avoid the judicial means of settlement.

International law and the ICJ process are the legitimate and peaceful pathways to a definitive settlement of the land boundary.

Any attempt to unilaterally incorporate Essequibo into Venezuela as is promoted by the planned referendum, or any subsequent military action in furtherance of such a contrived referendum, will rightly be met by international odium, condemnation and action.

New West End Ferry Terminal To Improve Passenger Processing

MinisterforCommunications and Works Honourable Kye Rymer has stated that the completed new West End Ferry Terminal will be designed to process up to 200 passengers per hour, or 200,000 passengers per year.

In his statement at the Fifth Sitting of the First Session of the Fifth House of Assembly, Minister Rymer said the new terminal will more than double the size of the previous facility, and

Virgin Islands Recovery and Development Agency, (RDA) is ably managing its design and construction.

The Minister said that the work is being done in close partnership with key stakeholders including the BVI Ports Authority, the Immigration Department, the Royal Virgin Islands Police Force, His Majesty's Customs, the BVI Tourist Board, ferry operators and taxi drivers.

Honourable Rymer said that there are key milestones in the project thus far and that he is pleased with the local contractors who were successful in the prequalification procurement process.

He said, "I am particularly

pleased to highlight that three local firms (one standalone applicant and two firms within a joint-venture application) were successful in the second-round of the prequalification process."

Honourable Rymer added, "This underscores the ability of our local contractors to succeed in competitive bidding processes. The four successfully prequalified applicants will be invited to bid in the full tender process which will commence in the coming weeks, following approval of the full design set and compilation of required tender documentation."

The Minister said that there are remaining processes that must be completed before the construction phase can

begin, and that the expected completion date of the project is mid-2026.

Honourable Rymer said, "The West End Ferry Terminal will cater to private and charter yachts, private boats and water taxis as well as facilitating reliable access for ferry passengers from the neighbouring USVI and between Jost Van Dyke and Tortola."

He said while the airport and the Ferry Terminal cater to different markets and meet distinct needs, both aim at improving transportation and access to our islands, development of our tourism product, and our overall socioeconomic advancement."

Minister Rymer thanked

the RDA for its continued pursuit of excellence on this major project and for working with his Ministry to advance the works.

Ministry Of Health Advises Public Of Counterfeit Ozempic®

Counterfeit Pen



The Ministry of Health and Social Development is advising the public to be aware of counterfeit Ozempic®.

Chief of Drugs and Pharmaceutical Services, Mrs. Gracia Wheatley-Smith said that the Food and Drug Administration (FDA) and other regulatory bodies around the world have issued warnings about counterfeit/ falsified Ozempic® after cases of hospitalisation where patients reported seizure, hypoglycaemic shock and coma after use of the counterfeit product.

According to the Chief of Drugs the ingredient in the counterfeit pen is insulin and not the correct active pharmaceutical ingredient semaglutide.

Ozempic® is a prescription

only medicine used to treat inadequately controlled type 2 diabetes mellitus, however it is also prescribed for its off label use for weight loss. This high demand of Ozempic® from diabetics and for weight loss patients has made a market for the counterfeit manufacturers as demand is now surpassing the production capacity of the manufacturer of Ozempic®

"The counterfeiters are not using the correct active ingredient and this has resulted in hospitalisation of persons seeking to use the pen for their medical condition," the Chief of Drugs said.

The Ministry of Health is asking the individuals who have been prescribed this medicine and have not purchased it locally to refrain from purchasing it over the internet as Ozempic® is a prescription only medicine and the true product will not be available for purchase on the internet.

Mrs. Wheatley-Smith reiterated that counterfeit or falsified medicines can be very hazardous to your health and life threatening due to the untested quality, potential contaminants and unknown active pharmaceutical ingredient. "Legal order pharmacies are only authorised to sell overthe-counter products and therefore will not sell the original Ozempic®", she explained.

The Chief of Drugs and Pharmaceutical Services is encouraging everyone to purchase their medications from pharmacies and health facilities licenced by the Virgin Islands Government to conduct pharmaceutical service in the BVI. Persons are also advised not to take medicines that are not prescribed for them in order to minimise experiencing side effects or adverse reactions of the medicine.

The Ministry of Health and Social Development is committed to improving the health of the people of the Virgin Islands.
