#### "THE PREMIER' NON-ATTENDANCE AT SFC SESSIONS WAS LESS THAN IDEAL," OPPOSITION LEADER SAYS

Premier Dr. the Hon. Natalio Wheatley has fired back at the Opposition and other critics who suggested that his publicly funded attendance at a recent climate change conference, was unnecessary because a senior public servant could have attended and the Premier should have remained in the Territory to attend to the budget discussions.

Premier Wheatley was in attendance at the 2023 United Nations Climate Change Conference-(COP28) in Dubai, United Arab Emirates, which concluded on 6 December with Arab countries not reducing their export of fossil fuels. During this period, members of the HOA were attending Standing Finance Committee meetings to deliberate on the 2024 budget alongside senior government officials. As a result, the Premier faced accusations of being absent at a critical juncture, with Opposition Leader Hon. Ronnie Skelton expressing

concern that there was no one available to address crucial questions during his

At a recent press conference, Premier Wheatley addressed these criticisms, remarking: "Some individuals may question why I chose to attend COP 28 at this particular moment. but I would assert that these individuals may not fully comprehend the gravity of the situation, which constitutes an existential threat."

He went on to defend his decision to travel, stating: "Of course, I would have preferred to be present during the Standing Finance-Committee sessions. However, when circumstances necessitate my absence, I have capable individuals to represent me. This is precisely why we have an acting Premier in place."

Premier Wheatley assured the public that he has been actively engaged with his finance team, meticulously reviewing requests made during the SFC proceedings. He emphasized, "I am committed to a thorough examination of each request, acquiring a comprehensive understanding discussions, and addressing urgent issues that demand our attention."

Describing climate change as the single greatest threat to survival and development, Dr. Wheatley stressed that the efforts and mobilization required to combat this crisis should not underestimated or dismissed However lightly. Arab countries attitude rendered the whole COP28 exercise "futile theatrics" (according to Financial Post), or better yet "a farce rigged to fail" (according to The Guardian). "Humanity is in a battle for its very existence, and the most vulnerable are the Small Island Developing States (SIDS). Among these, Overseas Territories

are even more vulnerable, as our existence often goes unacknowledged," the Premier concluded.

#### WHAT LEADER OF THE OPPOSITION SAID

During the time of the Premier's absence, Leader of the Opposition Hon. Ronnie Skelton questioned the BVI Leader's decision to leave the Territory to attend a climate change summit while the House of Assembly's Standing Finance Committee' budget process was ongoing.

In his criticism of the matter, Hon. Skelton questioned the effectiveness of the SFC budget process in the Premier's absence, given that the presence of the Premier, who also held the position of Finance Minister, was crucial for addressing key spending inquiries related to the Territory.

The Opposition Leader stated, "Presenting a budget to the parliament without being here to address the challenging questions that members may have renders

process essentially pointless. There are critical within various needs government departments, ministries, and statutory bodies that are necessary for the betterment of the country, and these could not be addressed adequately Premier's without the presence."

Hon. Skelton had further emphasized that critical issues such as crime, policing, infrastructure development, roads, water supply, and other essential matters required funding allocation by the Minister of Finance, and the Premier's absence could have hindered progress in these areas.

While acknowledging Acting Premier Kye Rymer's efforts in facilitating the budget process in Premier Wheatley's absence, the Leader of the Opposition indicated that the Premier's nonattendance was less than ideal.

Hon. Skelton declared, "We currently have the Premier, Minister of Finance, and the Deputy Premier all away from the country, and I understand that the Minister of Health will also be departing soon. Consequently, it will be

necessary to appoint another junior minister to assume responsibilities within the country. This was not the optimal course of action."

"We should not underestimate the importance of these procedures in facilitating the growth and organization of our society. With the Minister of Finance absent from this critical process, we were heading in the wrong direction," he added.

Furthermore,-Skelton pointed out that it was the members of the Opposition who were ensuring that the SFC met its quorum, a crucial requirement for the validity of the meeting's proceedings at that time.

# HON. LUCE HODGE-SMITH IS CONCERNED ABOUT GUN VIOLENCE

Junior Minister for Tourism and Culture, Hon. Luce Hodge-Smith has expressed her ongoing concern about the issue of gun violence in the Territory, especially when it affects young men the most.

During a recent interview with 284 Media Hon Hodge-Smith shared her deep sadness about the prevalence of gun violence in the community. She stated: "I am truly saddened by the gun violence in our community. Yes, I'm a mother, and I have two boys, and it seems to be the young men who are suffering the most. We are losing our young men, and it's truly heartbreaking. Just when you think it might be over, it starts up again."

In the year 2023, there have been six recorded shooting deaths in the Territory. The most recent tragic incident occurred on 6 November, when 25-year-old Julio Rivera, a resident of Purcell Estate, was fatally shot in a parking lot along De Castro Street.

Expressing her frustration,

the Junior Minister remarked: "You wonder what can be done? Where can you find these individuals and just shake them, and ask them, 'What are you doing with your life? Why are you choosing this path?' Then I remind myself that they are caught up in it and need to understand that there are consequences."

Hon. Hodge-Smith also conveyed her bewilderment at the callousness of those who resort to gun violence, saying, "I cannot comprehend how someone can callously take a gun and another person's life. So, the issue of gun violence in our community deeply troubles me."

The Junior Minister further

pointed out her efforts to engage with seniors and women in a church setting to address violence against men, women, and children. She stressed that these discussions have led to a shared agreement on the importance of speaking out against violence.

She urged the community, particularly its seniors, to actively voice their concerns guidance, provide stating: "As a community, we need to speak out. I have also spoken to seniors on two occasions and told them that they are the ones we are learning from. You have experienced what we are going through now, you have lived your life, and now you're retired, but you still have a role to play in our community."

Hon Hodge-Smith also called upon VI's seniors to offer their wisdom and guidance whenever they notice troubling-developments, saying, "We need to listen to you; don't just take a back seat."



#### POCKWOOD POND FIRE INCIDENT ACCENTUATES NEED FOR SOLUTIONS

Following another fire incident at the Pockwood Pond dumpsite over the weekend, Hon. Vincent Wheatley, who serves as the NinthDistrictRepresentative and Minister for Health and Social Development with-responsibility-for waste management is advocating for recycling.

The Minister proposed that the challenges plaguing the local incinerator can be effectively resolved through a reduction in the volume of waste being processed at the facility.

This suggestion comes after residents expressed outrage over what they described as yet another fire incident at the facility. The fire which started around 4:00 am on Saturday, 9 December specifically affected the tipping area of the Pockwood Pond garbage facility. The resulting smoke plumes wafted across the western end of Tortola much to the discomfort of

residents, particularly those residing in Pockwood and West End.

During an appearance on the Monday, 11 December broadcast of the Da Morning Braff radio show, Minister Wheatley expressed his commitment to introducing a new Environmental Bill, stating: "If we do not curtail the amount of waste being sent to the incinerator, we will inevitably find ourselves facing similar challenges in the future."

Acknowledging the persistent issues with the incinerator, Hon Wheatley disclosed plans to issue a Request for Proposal for a

new incinerator, alongside a concurrent effort to restore the current facility to functionality. He also highlighted the existence of modern facilities capable of more efficient waste management.

The Minister of Health and Social Development encouraged-recycling practices, stating: "I urge everyone to maximize their recycling efforts. The less waste collectively sent to the landfill, the greater the reduction in the waste burden on our incinerator."

Furthermore, he noted that residents from the First and Second Districts, and even as far as St. John in the US Virgin Islands (USVI), have had to contend with the consequences of landfill fires at Pockwood Pond over the years.

Regarding the repair of the current system, Hon Wheatley indicated that the Department of Waste Management is currently awaiting a shipment of parts, which is expected to enable the facility to resume operations in approximately four months. The Pockwood Pond Incinerator has been non-operational since February 2022 due to a previous fire.

#### PETITION DEMANDS REMOVAL OF COP

Approximately-30 individuals,-including members of the Royal Virgin Islands Police Force (RVIPF), have united in a demand for the removal of-Commissioner-of Police Mark Collins from his current position. The grounds for this demand stem from the presentation of 55 serious allegations against Commissioner Collins.

Contained within an extensive 11-page petition addressed to His Excellency Governor John Rankin, the signatories not only stress the urgency of Commissioner Collins' removal but also call for

impartial investigations into allegations of misconduct in Public Office and the abuse of authority.

The petition firmly states: "It is imperative to acknowledge the recent circulation of an email dated 5 October 2021, allegedly from Commissioner of Police Mark Collins, within the public domain of the British Virgin Islands. We firmly believe that the intent and directives outlined in this email were crafted to obstruct the smooth functioning of the justice system, characterized by deceit, dishonesty, and unlawful behavior, thereby raising significant doubts

about the Commissioner of Police's credibility."

The leaked email that has captured collective attention reportedly concerns the arrest and charging of an Inspector, with Commissioner Collins providing updates to St. Clair Amory regarding the case. The Commissioner's email acknowledged 'issues with the arrest and process' and suggested the existence of 'potentially incriminating video footage of the incident that should not be used as evidence and should be destroyed.' The public's outrage over that leaked email stems from the fact that destroying evidence constitutes criminal a offense.


The petition also delves into the definition of misconduct in Public Office as outlined by the Crown Prosecution Service, underlining the Constitution's provision of fundamental rights and freedoms to the citizens and residents of the Territory

The document meticulously

outlines numerous grave allegations,-including, but not limited to, the destruction of evidence, obstruction of justice, defamation,-interference with administrative justice, and manipulation of the promotion process within the RVIPF.

Furthermore, copies of the

petition have been sent to Hon James S. Cleverly of Homeland Security, Hon David H. Rutley – Parliamentary Undersecretary of State (Americas and Caribbean), Premier Dr. the Hon Natalio D. Wheatley (R7), and Rosalia Gardener, Chairman of the Police Service Commission."





#### Remarks By Premier Wheatley With Updates On Recent Duty Travel

Climate change is the single greatest threat to our survival and development. As small islands, we contribute less than a drop in the bucket to the problem, yet, stand on the frontlines of the climate crisis, experiencing the worst and most severe impacts soonest.

Gone are the days when there is a debate about whether climate change is real. We are now living the reality of climate change. Without drastic action, the world is on a path to exceeding global warming of 1.5°C within the next 10 years. In such a world, the unbearable heat of this summer will become the norm year round. Fragile, temperaturesensitive ecosystems like coral reefs are at high risk disappearing. Mass sargassum landings persist.

The risk of dengue and other vector-borne diseases will increase and new diseases will emerge. We could experience 'runaway' sea level rise and lose our beaches, low-lying coastal communities and coastal infrastructure. Even with a warming of 1.5°C, flash floods like the one we experienced on August Monday 2017 will become

more common. On the other extreme, we can also expect more frequent and extreme droughts. Hurricanes like Irma and Maria will not be freak events but the hurricanes of our future. How many times can we afford to lose 200% of our GDP and take out hundreds of millions of dollars in debt to recover?

So, you see, climate change directly impacts every person, business and economic sector in The Climate Virgin Islands. change is the common denominator that has the power to cut down and set back any development strides we make. If we are to survive and thrive then, we must invest in adaptation - that is, actions to ensure our critical ecosystems, infrastructure, facilities, communities and economic sectors are more resilient to the various impacts of climate change.

But adaptation is very costly, more than we can afford. If we are to adapt then, we must be able to access the scale of financing that we will require over time, on the order of billions of dollars, from the developed countries that have created the climate crisis.

The COP28 is the shorthand for the 28th Conference of the Parties of the United Nations Framework Convention on Climate Change. Attending the annual conference is a priority for small islands development states. Some may assume that small

islands matter least in the global negotiations on climate change, but let me tell you, we matter most! Not just because we are on the very frontlines, but because history reflects that all the major victories in the climate change fight, including the recent creation of the Loss and Damage Fund, have been championed by small islands who have an equal vote.

The UK Overseas Territories, like all independent small island developing states in the Caribbean, were represented at COP28. The difference is that while our independent neighbours have access to the billions of dollars available through the various financing mechanisms under the Convention, such as the Green Climate Fund, and will now have access to the trillions of dollars expected under the Loss and Damage Fund, the Overseas Territories, including The Virgin Islands do not have access to any of those funds. Nor does the United Kingdom provide direct climate finance to the Territories. While the world is warming up, we are being left in the cold.

As the clock runs out on our window to adapt, this Government saw it as a priority to start the important work of advocating for access to international climate funds under the Convention and to also advocate for a dedicated UK Climate Change Fund for Overseas Territories.

Without this win, The Virgin Islands will certainly fail on its development journey. Advocating requires firstly being at the table and this was the absolute imperative or necessity of attending COP28.

Towards this end, at COP28, Overseas Territory leaders, including Hon. Vincent Wheatley and I had a meeting with the UK Delegation on Wednesday December 6 and just this morning Hon. Wheatley represented The Virgin Islands in a meeting with Rt Hon Graham Stuart, UK Minister for Energy Security and Net Zero.

I'm pleased to report that as a result of the collective representation of the OTs at those key meetings at COP28, we now have agreement from the UK that the Territories will be engaged at the start of the cycle for the UK to prepare its negotiating strategy for COP29 and COPs going forward. This provides the critical window that we needed to ensure that our concerns and issues are considered in the process and have a chance to make it into the global negotiations.

Additionally, I'm

very pleased to report that Minister Stuart was open and receptive to the ask for a dedicated UK Climate Change Fund for its Territories and we have agreed that the next step in materializing this be a formal request from the Territories, outlining the details of what is required, through the Minister responsible for the Overseas Territories as well as the Department Environment, Food & Rural Affairs which is responsible for climate change adaptation in the UK. Hon Wheatley also raised the concern for support on building resilience in the health sector which was also well received.

Our collective objective now should be how to build on the great work already done to establish a Climate Change Committee, develop a Climate Change Policy and legally establish The Virgin Islands Climate Change Trust Fund and the foundation laid at COP28 to access climate finance to ensure that we are not left behind as victims on the frontlines. The media can partner with Government on this to help highlight the special case of the Territories.





### Government Evaluated For Financial Services Compliance

In March of this year, the Virgin Islands underwent mutual evaluation assessment by the Caribbean Financial Action Task Force (CFATF), the regional body

of the Financial Action Task Force (FATF), to measure the Virgin Islands' compliance with FATF's recommendations and the effectiveness of its anti-money laundering terrorist financing framework.

Minister for Financial Services, Labour and Trade Honourable Lorna Smith

said, "Although I was not in office during the assessment period, as the Minister of Financial Services, Labour and Trade, I bear the responsibility of ensuring our financial services industry's regulation aligns global standards and that it recognises its obligations in this critical area."

In line with those responsibilities, Minister Smith recently attended the CFATF plenary held in Aruba, where the draft mutual evaluation report was tabled.

Honourable Smith stated, "A government presence such international forums is vital. It underscores a country's commitment at the highest level to ensure that standards are met and that the FATF recommendations are adhered to. It also clearly demonstrates our readiness to address any identified issues with the necessary resources promptly effectively. All those I met reinforced that political leadership in these matters is highly regarded."

During her time in Aruba Honourable Smith met the CFATF Executive Director Ms. Dawne Spicer and Honourable Samuel Bulgin K.C., J.P., the outgoing CFATF Chair of the Plenary, and Attorney General of the Cayman Islands, as well as other key figures.

Thedraftmutualevaluation

report remains confidential while it undergoes the usual CFATF/FATF quality and control checks. However, publication is anticipated in January 2024.

The Virgin Islands delegation included the Attorney General Honourable Dawn Smith, and comprised key personnel from the Attorney General's Chambers and other relevant authorities including the BVI Financial Services Commission, the Financial Investigation Agency, the Royal Virgin Islands Police Force, and the Director of Public Prosecution.

In partnership with all its competent authorities and industry stakeholders, the Government of the Virgin Islands is committed addressing recommendations identified in the final report and ensuring the availability of necessary resources for this purpose.

The FATF establishes international standards towards combatting money laundering, terrorist financing, and the financing of the proliferation of weapons of mass destruction.

The Virgin Islands is a founding member of the CFATF and the Government remains steadfast towards international upholding best practice standards on money laundering, terrorist financing, and proliferation financing.

### **Construction Of National Emergency Operations Centre Progressing**

The construction of the new National Emergency Operations Centre (NEOC) in McNamara, Tortola is progressing, with the concrete roof pour now complete.

The centre is designed to house the Government of the Virgin Islands operations in the event of a major emergency or hazard impact and is being constructed to standards that will allow it to withstand all natural disasters, including hurricanes, earthquakes and landslides.

Financial Secretary, Mr. Jeremiah Frett said following its destruction during the passage of Hurricane Irma in 2017, the Government of the Virgin Islands set out to rebuild the NEOC as a regional model for disaster preparedness and response.

Mr. Frett reiterated the Government's commitment

to ensuring projects that are vital to the Territory's National Disaster Management Plan are funded and managed well, including the ability to respond to hazard impacts.

Mr. Frett said, "Now more than ever, there is an undeniable need to ensure we fund these projects that will help to safeguard our Territory, and better prepare us for disasters. The construction of a state-of-the-art NEOC is a major priority, and the Government of the Virgin Islands remains fully committed to this."

Permanent Secretary in the Office of the Deputy Governor, Mrs. Sharleen DaBreo-Lettsome, MBE, who is a former Director of the Department of Disaster Management (DDM) said during the events of 2017, we fully understood and experienced some of the

natural hazards the Territory is exposed to.

Mrs. DaBreo-Lettsome said," Our previous NEOC was destroyed during Hurricane Irma, displacing the Government's emergency operations centre. We want to ensure that does not happen again. The construction of a NEOC that is resilient and sustainable is a major priority as we plan for the Territory's future."

The new National Emergency Operations Centre features a foundation that was designed with ground anchors to ensure minimal movement during extreme weather, windows and doors rated far beyond Category 5 hurricanes, extra steelwork in size and quantity for increased rigidity, and an increased pound per square inch for concrete, to ensure a



stronger structure.

There has also been an increase in connectivity between structural elements to ensure minimal separation during earthquakes and other extreme weather events.

During hazard impacts, public officers who are a part of the NEOC may be required to remain in the centre for a duration of time, to ensure the operations of Government, including the immediate response to impacts are coordinated.

The new NEOC is therefore being constructed to ensure persons can comfortably remain in the building, including the installation of water storage and solar technology.

The building is expected to be completed within the fourth quarter of 2024.

Tandem Development and D&B Construction are the contractors on the project that is being managed by Virella Crespo and Associates. The contract for the construction of the centre is valued at Nine Million, Eight Hundred and Three Thousand, Two Hundred and Fifteen Dollars, and Fifty-Three Cents (\$9,803,215.53)

The Government of the Virgin Islands remains committed to ensuring the Territory is prepared for hazard impacts, including the ability to prepare effectively, and swiftly respond.

#### EARLY WARNING SYSTEM TRIGGERS QUICK RESPONSE TO FIRE

New protocols implemented by the Department of Waste Management continues to result in early notifications, which led to swift action to extinguish an early morning blaze at the Pockwood Pond Dumpsite.

At around 4:00 a.m. on Saturday, December 9, the Department of Waste Management was notified of a fire at the Pockwood Pond Dumpsite on Tortola. The Fire and Rescue Service were immediately notified and

worked to extinguish the blaze started.

Director of Waste Management Mr. Marcus Solomon reported that the dumpsite tipping area caught fire, and the fire quickly extended to the BVI Electricity Plant, which is located in close proximity to the fire.

"The fire was likely caused by older garbage heat which came into contact with combustibles. The combustion of the materials could be heard on the site and spread to the entire garbage load, which fueled the quick acceleration of the fire," Mr. Solomon stated.

The Director further explained that because the incinerator is currently inoperable, we are having issues with processing the waste in a timely manner, which is contributing to garbage staying in the tipping area longer than desirable. We are working on waste management strategies to improve the way



we process our waste, but we still need assistance from the community to help avert future occurences".

According to the Director, while his Department is working on much needed equipment, improvement to the current infrasturcture at the dumpiste, as well as the training and monitoring of contractors, he also needs the public to play their part.

"We are pleading with the community to reduce, repurpose, and reuse to assist with decreasing waste generation. We also want them to stop putting hazardous and flamable materials into the waste stream," Mr. Solomon said.

As officials continue to work on extingusihing the flames, the




public is advised to take the necessary health precautions and avoid the smoke where possible.

The public should also be aware that until further notice the Pockwood Pond dumpsite will not be accepting any garbage. Only persons with the ability to reach to the top of the hill will be allowed to access the site.

The Department continues to work on best practice strategies to manage waste throughout the Territory. Subsequent updates will be provided where necessary.

The Ministry of Health and Social Development is committed to improving the health and well-being of the people of the Virgin Islands.

H. Lavity Stoutt Community College- who will deliver media production development workshops to empower BVI youth.

Governor John Rankin CMG met with the successful applicants on 7th December to offer his congratulations. The Governor said "I am delighted to announce today funding for three youth empowerment projects. I know these projects will benefit the lives of young people in the BVI. I am grateful for the very high calibre of applications we received and thank everyone involved."

#### Additional detail on the projects

Mentoring Anointed Leaders Everywhere (MALE) who will run a series of intensive mental health workshops for young men. The workshops will aim to deliver outcomes on the following areas:

Better awareness and relationship with self; positive approach to mental health – which will result in a better relationship with oneself, also better relationship with others.

Resolution conflict skills better processing skills to navigate through difficult situations

Decision making and goal setting skills - positive approach to mental health result in higher aspirations for careers and fulfilling of dreams.

Mindfulness and Meditation – to help manage stress, anxiety, and emotions.

Expressive therapy – getting in touch with oneself and answering self-awareness questions through, art, music, and drama.

Outdoor activities, games, sports, arts and crafts: Positive approach to mental health result in better assessment and ability to make healthy decisions and choices by getting in touch with nature, hiking with nature and culture walks.

Group support and team building – Learning to respect and support others and create a non-judgemental, supportive environment and learning the value of community. The effects of this can trickle and ripple throughout homes, communities, and territories.

Coping Skills – Introducing practical skills such as time management, journaling, creative writing, and resolution conflict that are vital to releasing daily stress.

Self-care – How to detox, reflection and relaxation techniques, breathing exercises. Assist them in creating healthy boundaries and the importance of taking care of oneself.

H. Lavity Stoutt Community College will deliver development workshops. project will introduce a workshop series in media production to empower BVI youth. The workshop series will focus on developing skills in characterization, media production, and musical expression through practical exercises and research. Workshop participants will learn to identify and utilize platforms for creativity, experiment with diverse performance art forms, foster self-awareness, and promote collaborative teamwork. This initiative aims to cultivate practical skills, fostering participation in global and regional creative industries by opening doors to

platforms like Netflix, Instagram, TikTok and YouTube; as well as opportunities to participate in film festivals.

Road Town Boys and Girls Brigade will receive funds to revitalise their programs, including replacement parade flags and drilling equipment; replacement marching drums; official parade uniforms; non-official uniforms for weekly company meetings and community service activities; special programs uniforms; badges and awards to award members for completing badge work; revitalization of RTGB (RTBB) websites and online store;

procurement of materials; and tools to carry out programming such camping, traveling, transportation, first-aid certification and IT. The Brigades are international, interdenominational, uniformed, afterschool, outreach organisations that empower youth and make a difference.



# GLOBAL NEWS BRIEF STORIES SELECTED BY GIORGIO MIGLIAVACCA

DARK CHOCOLATE UNDER SCRUTINY - A long time ago, many people switched from consuming milk chocolate to dark chocolate (much higher in cocoa), in search of healthier food. Today, however, some news suggests that chocolate may be contaminated with cadmium and lead.... and that the concentration of these heavy metals may be higher in dark chocolate.

Does this mean that we're going to have to stop eating it? Well, if we actually analyze the information and put it into context, we can see that the risk isn't exactly as high as most headlines indicate.

In just a few years, cocoa has gone from being frowned upon — due to its association with unhealthy foods, such as sweetened milk chocolate — to essentially being a superfood. Nowadays, many people include pure cocoa — or chocolate with high cocoa content — in their diet, in search of a beneficial effect on health. But recent news is warning of the supposed

danger that its consumption entails, due to its content of heavy metals, specifically cadmium and lead. [El Pais]

FIGHT DIABETES - As fresh seafood, sardines can be a savoury, protein-rich addition to Caesar salads, pasta dishes, or enjoyable on their own. While fresh sardines are seasonal, reaching peak abundance between the months of July and November, they can typically be found in stores all year round.

According to a report by 20minutos, the fresh ones have a higher healthy fat content than their canned counterparts and are sometimes tastier, but experts urge the consumption of sardines of all varieties, including the canned ones.

In the study, the Barcelona researchers introduced the two cans of sardines to a group of people over the age of 65 with prediabetes, meaning they have high blood glucose levels and run the risk of developing diabetes in the future. Another, statistically

identical group was not given the sardines, and based on the results, researchers were able to confirm that the sardinerich diet was instrumental in preventing the former group from developing diabetes. [El Pais]

R U S S I A - W i t h challenges to his rule all but removed, Putin's next six years in office promise to keep Russia on its current trajectory. But the risk of an economic crisis looms.

In a choreographed and widely predicted move, President Vladimir Putin announced Friday that he will run for a fifth term in the 2024 presidential election next March.

The 71-year-old, who has been in power since 2000, is expected to run virtually unopposed apart from a few handpicked challengers following the adoption of wartime censorship and the crushing of the liberal opposition.

His next six years in office promise to keep Russia on its path of socially conservative policies and pivot away from the West, while his readiness to wage war on Ukraine for as long as it takes to win stands to

put mounting strain on the unity of Kyiv's allies, experts told The Moscow Times.

The Kremlin's confidence is boosted by the economy's better-than-expected growth under its second year of wartime sanctions, but experts warn that risks of economic overheating will persist. [The Moscow Times

ITALY - The Intangible Heritage Committee of the United Nations Educational, Scientific and Cultural Organization (UNESCO) on Wednesday proclaimed the art of Italian opera singing to be part of the intangible heritage of humanity.


The decision came at a meeting of the Committee's member countries in Botswana.

In March 2022 Italy's UNESCO commission chaired by Franco Bernabe' approved a bid by Italian opera to go forward as candidate to present to the UNESCO intergovernmental committee for the 2023 cycle.

Then culture minister Dario Franceschini said that with the opera bid "Italy is aiming for the recognition of one of its most authentic and original cultural expressions". (ANSA).

D O M I N I C A N REPUBLIC - Spanish authorities, including the Civil Guard and Customs Surveillance of the Spanish Tax Agency, have confiscated a staggering 530 kilograms of cocaine at the Adolfo Suárez Madrid-Barajas airport. The illicit drugs were concealed within a shipment of avocados originating from the Dominican Republic.

The operation took place last Saturday during routine inspections of goods arriving at the international airport in Madrid. Suspicion arose due to potential tampering in a consignment labeled as fresh fruit, leading to a thorough examination by authorities.



Traffickers employ this method, known as the "lost hook" or "rip-off," in an attempt to smuggle significant quantities of narcotics through airports without detection by import and export companies or customs officials. Criminals target shipments legal merchandise from reputable import companies with consistent traffic, aiming to avoid suspicion during customs checks. [Dominican Today]

# "COP28 Is A Step In The Right Direction" - Premier Wheatley

Premier and Minister responsible for Climate Change, Honourable Dr. Natalio Wheatley is satisfied that his recent participation in the Conference of Parties (COP28) in Dubai will aid the Virgin Islands in navigating the impact of climate change.

Premier Wheatley who led a three member delegation to the conference said that as a result of the collective representation of the OTs at those key meetings, there is now an agreement from the UK that the Territories will be engaged at the start of the cycle to prepare negotiating strategies for COP29 and COPs going forward.

The Premier said, "This provides the critical window that we needed to ensure that our concerns and issues are considered in the process and have a chance to make it into the global negotiations."

Premier Wheatley highlighted that the Virgin Islands, along with the rest of the Caribbean region, stand on the frontlines of the climate crisis as they experience the worst and most severe impacts.

The Premier said, "Additionally, I am very pleased to report that the UK Minister of Energy Security and Net Zero, the Rt Honourable Graham Stuart, was open and receptive to the suggestion for a dedicated UK Climate Change Fund for its Territories."

Premier Wheatley added, "We have agreed that the next step in materialising





this be a formal request from the Territories, outlining the details of what is required, through the Minister responsible for the Overseas Territories as well as the Department for Environment, Food & Rural Affairs which is responsible for climate change adaptation in the UK".

Honourable Wheatley also raised the concern for support on building resilience in the health sector which was also well received.

The Premier's delegation included Minister for Health and Social Development, Honourable-Vincent

Wheatley; Climate Change Officer in the Ministry of Environment, Natural Resources, and Climate Change, Ms. Angela Burnett Penn and the Acting United Kingdom/European Union Representative, Ms. Tracy Bradshaw.

The COP is an annual event where countries that are party to the United Nations Framework Convention of Climate Change, review and agree joint efforts to limit the extent of climate change and to support the most impacted and vulnerable countries, like small island developing states, adapt to impacts.

#### THE NEVER ISSUED STAMPS INSCRIBED "BRITISH"

In a previous chapter mention was made of the stamps celebrating the Restoration of the Legislative Council and Constitutional Rule. Among the innovations was also a set of stamps depicting King George VI and the map of the Virgin Islands. The unexpected surprise that may not have made a big impression was the name of the colony at top left of each of the four stamps: "BRITISH VIRGIN ISLANDS" never used before on local stamps. For the first time the word "BRITISH" was used on a Virgin Islands postage stamp.

Although essays of the 1952 definitive series with the new legend "BRITISH VIRGIN ISLANDS" were submitted to the monarch for his

consideration the issue with the new inscription never materialised owing to the King's death on 6 February 1952; as a result the new definitive series was issued on 15 April 1952 and reverted to the traditional inscription "VIRGIN ISLANDS".

Later on, as a result of the Foreign and Commonwealth Office memorandum, beginning in 1968 and with only two exceptions (1968, Martin Luther King stamps, and 1976 United States Virgin Islands and BVI Friendship Day) the local postage stamps are routinely inscribed "BRITISH VIRGIN ISLANDS".

The above-mentioned essays of the 1952 definitive series are part of the Royal Philatelic Collection and are shown by gracious permission of H.M. the Late Queen Elizabeth II in the Specialised Catalogue of BVI Stamps (page 164). The only essays in private hands are pictured here for the very first time.

# THIS WEEK IN CORRUPTION ON THE COSP OF CHANGE

With International Anti-Corruption Day and the biggest international anti-corruption meeting just around the corner, 'tis the season to fight corruption. And there's no better time than the present to get even more serious about holding power to account.

Tomorrow is International Anti-Corruption Day, an opportunity for the global community to reflect on the progress and challenges and consider the necessary steps to stop corruption in its tracks.

This year, it falls ahead of the 10th Conference of the States Parties (CoSP) to the United Nations Convention against Corruption (UNCAC) taking place in Atlanta, Georgia on 11-15 December, where delegates from 190 countries gather to make decisions and pave the way forward. And since it's the 20th anniversary of UNCAC, this is a particularly unique

moment to reflect on the advances promoted by the convention and to reconsider measures to strengthen its implementation and follow-up mechanisms - which are urgently needed.

With the conclusion of the informal negotiations in Vienna, there are already noticeable divisions. Similar to previous years, some states appear motivated to restrict civil society participation during CoSP and are set on blocking any resolutions that could bring about substantial change in the anti-corruption landscape. This concerning development is a stark reminder that even in these spaces, self-interest can take precedence. In order to win the fight against

corruption, we need a united global movement - not one riddled with fragmentation.

Together with our many chapters and allies, we will be attending this year's UNCAC CoSP to push states parties to improve transparency in political financing, enhance beneficial ownership transparency and protect civic space, just to name a few of our priorities. The international community must take immediate action to bolster the fight against corruption and help prevent democratic decline - an ailment that no country is immune to.

The persisting lack of transparency in political finance in many countries is one area of concern. The opacity surrounding how much and whose money political parties and candidates receive and spend allows shady funds to enter politics, posing a direct threat to the foundations of democracy.

After two decades of UNCAC implementation, little progress has been made to advance transparency in political financing on the international level. Despite submitting over 60 resolutions throughout the last 20 years, states parties have yet to adopt one to strengthen Article 7.3 of the Convention on political financing - which is a very troubling reality. This is why we joined forces with over 100 civil society and international organisations to call on UNCAC States Parties to take action on

political finance transparency at the upcoming CoSP.

As shown in our recent submission to UNCAC CoSP and exemplified by the worrisome political finance challenges in regions like the Western Balkans and Turkey, world leaders must work together to close existing legal loopholes, ensure the proper disclosure of expenditures, donations and donors and address the inadequate oversight and accountability mechanisms. If you follow our work, you know how crucial beneficial ownership transparency is to the fight against corruption. Together with our allies and partners, we were successful in achieving a global consensus that government-held central registers are the only effective way to ensure transparency in company ownership. This CoSP is an opportunity to build on recent progress.

Transparency International is calling on UNCAC signatories to agree on new commitments to ensure that ongoing and future beneficial ownership transparency reforms are impactful. Key

among them is promoting access to and use of beneficial ownership data by all actors who have a role to play in the fight against corruption. Better yet would be to adopt public registers.

Without beneficial ownership transparency, investigations into cross-border corruption and efforts to recover stolen assets are likely to hit a dead-end. This matters in all parts of the world, but especially in Africa, which loses billions of dollars each year due to illicit funds being siphoned abroad. Our new report, Loophole Masters, shows that foreign-registered anonymous companies are essential to corruption schemes originating from the African

continent. This is why our African chapters are urging CoSP delegates to make new pledges to help African nations curb illicit financial flows more effectively.

Last but certainly not least, it's crucial to emphasise the importance of protecting civic space to enable civil society's participation in anti-corruption efforts. While reviews on the implementation of UNCAC do not appear to point to significant challenges, other UN bodies - including the Human Rights Council and the Special Rapporteur on the situation of human rights defenders - and civil society organisations express serious concerns. Journalists, whistleblowers and civil society groups reporting suspected corruption cases and promoting reforms continue to face retaliation in the form of intimidation, threats, digital attacks and state-sanctioned violence.

The convention recognises that civil society is key in preventing and combatting corruption. However, this can only be fulfilled if they have the freedom to organise, form groups and associations, and operate safely, independently and without undue restrictions. States parties must take immediate action to effectively implement Article 13 of the Convention in order to protect those fighting corruption daily while strengthening civic participation during UNCAC meetings and beyond.

# Land is Capital

Land is part of the capital mix. Land as capital is the mold for shaping and situating human society, productivity and activity.

Now, the Caribbean cliché 'land don't spoil' is an appropriate assertion. We are born, exist, and die, on land. Nothing happens without the land. Civilization evolved on land.

Then all the various types of capital from enterprise, -labor, management-and technology to machinery, buildings, finance, and natural resources, require land to transform into the form that producers and consumers require.

One sage person stated that the person who owns the land owns the country. That was an accurate observation.

From ancient times, the people who owned and controlled the land possessed power to rule and decide on scarce resource allocation.

Today, international borders determine social, economic, and political boundaries. That so even when it may appear that the world is becoming increasingly borderless with Avantgarde technologies such as Artificial intelligence, robotics, internet banking, digitization, and wireless trading.

Land is a crucial asset socially, politically, and economically. Social capital such as schools, hospitals, care homes, ports, police stations, government offices all require land to exist. Economic capital, like shops, hotels, banks, farms,-warehouses, restaurants,-factories, and workshops- the list is endless- all require land.

Virgin Islanders guard their land zealously and rightly so. The Wickham's Cay Matter with the Great Noel Lloyd's Positive Action Movement where a threat to control key lands on the archipelago by Bates Hill and Co was a demonstration of this native understanding of the importance of land ownership for the country's posterity.

That local land ownership was unlike the history of Caribbean where Islands land remained in the hands of the European planters, then a wealthy and European bourgeoisie, even after the plantation era. That inability to own the land by former slaves and their families created a permanent underclass of landless Caribbean indigenes.

However, in the British Virgin Islands, providence and history saw a significant portion of the land transferred to the native population. A landless population is a disenfranchised population.

Land ownership by the native population post slavery allowed for the building of humble homes, subsistence farming that fed the population, basic docking for fishing boats, the first schools and clinics, and more, leading to the establishment of a self-governing and selfsufficient community. Native land ownership has been integral to Virgin Islands culture.

Land ownership by natives started a new community led by lightskin creoles who were the product of white planters and their enslaved mistresses. These creoles owned a greater proportion of the land than their darker skinned brothers and sisters post slavery, allowing these families to become entrepreneurs and landowners whose progeny became the new elite after the wealthy white planters returned to the United Kingdom. Social class in the Virgin Islands has land ownership as the key factor to this day.

Land ownership has driven the social structure of the Virgin Islands and enabled a thriving business community. The supermarket owner, drinking water supplier, quarry business, building building contractor, supplies, private hospital, hotel. local seaside restaurant. car rental. and so on and so forth,

would not exist without the efforts of forbears who owned land passed on. Businesses that rent premises also benefit from land as part of their capital mix.

Control and ownership of land has allowed native Virgin Islanders and citizens to own businesses, communal property such as churches and community centers, and the homes where they dwell. Land, with the added forms of capital such as enterprise and technology, drives Virgin Islands prosperity. Native Virgin Islanders, citizens of the Virgin Islands of all hues and ethnicities, must never take land ownership for granted, or they will wake up one morning to the life of regret of the dispossessed. "Land don't spoil" and land lasts many generations.

# COP28: Report recommends young people get a fair share of climate finance



Young people, who are among those most at risk to the impacts of climate change, are not accessing the funds they need to tackle the challenges posed by global warming, according to a report published yesterday.

The joint report by the Commonwealth Secretariat and YOUNGO, the children and youth constituency of the United Nations Framework Convention on Climate Change (UNFCCC), analysed 100 climate finance initiatives targeted at young people.

While it shows an increase in youth-focused climate finance, funds are mainly disbursed in small amounts, hindering large-scale youth-led climate action.

In addition, the audit information provided by funders lacked full transparency, especially about beneficiaries and what projects were funded.

In response, the report calls for a fit-for-purpose approach to deploying climate finance for youth-led actions to remove existing barriers and ensure young people receive a fair share of support.

The proposed solutions include targeted reporting, a streamlined process for accessing funds with a focus on clear eligibility criteria, increased private sector support and new innovative financing sources.

Climate finance, a core part of the Paris Agreement, is provided to help developing countries cut greenhouse gas emissions and adapt to the impacts of climate change

The report was launched at a side event, 'Empowering Youth

Leadership: Experiences from the Commonwealth in Access to Climate Finance, Capacity Building and Technology' – hosted by the Commonwealth Secretariat in partnership with the governments of Fiji and Zambia on 9 December 2023 during the United Nations Climate Change Conference (COP28).

Speaking at the event, the Commonwealth Secretary-General, the Rt Hon Patricia Scotland KC, said:

"Young people, who make up 60 per cent of Commonwealth citizens, are on the frontline of the climate crisis, living mostly in areas prone to extreme weather events.

"As a result, many are facing job losses, displacement, health issues and educational setbacks. In the face of adversity, the resilience of young people shines through as they harness their drive and talent to lead on powerful climate solutions."

She added: "This report reveals the dire need to scale up financial support for young people and prevent them from being stuck in the vicious cycle of chasing funds. We must work together with young people to address the barriers they face in accessing climate finance and support them in scaling contributions to meeting climate targets. This is essential to our belief that youth-led action is integral to our pursuit for a sustainable future for all."

During the event, participants shared their experiences on accessing climate finance, upskilling and leveraging technology to empower youth-led

efforts in tackling the challenges posed by climate change, while examining ways to maximise existing opportunities.

Collins Nzovu, Zambia's Minister of Green Economy and Environment, said: "The future belongs to the children, and we should do everything possible to ensure we leave a liveable climate for them. We realise we need to pass the baton of leadership to the youth. We are increasing our support to the youth to take leadership which demonstrates our unwavering support for the Commonwealth Year of the Youth."

The minister urged youth to use their energy, presence, connections and innovation to drive the change needed to save the planet.

In his remarks, Naipote Tako Katonitabua, Fiji's Ambassador to the United Arab Emirates, said: "The world is facing unprecedented impacts of climate change the global stocktake has shown us how far behind we are in our climate ambitions."

"We need dramatic actions to benefit our climate and we need them now," he added. "Youth inclusion at all levels in climate action including at political level is necessary to ensure the sustainability of our efforts."

Sheen Tyagi, Research Director at YOUNGO's Finance and Markets Working Group, said: "The seeds of environmental resilience are sown in the passion and innovation of youth. Investing in youth-led climate projects is not just an investment in the future; it's a commitment to safeguarding our planet."

She continued: "Climate finance directed towards our projects is the imperative bridge between aspirations and actionable change. The currency of change lies in climate finance for the youth, and to ensure a sustainable tomorrow, we need the unwavering support of governments, institutions, the private sector, communities, and every individual."

During the event, Dr Ruth Kattumuri, Senior Director at the Commonwealth Secretariat's Economic Youth and Sustainable Development, announced this year's winners of the Commonwealth Sustainable Energy Transition Award.

Bangladesh's Areebah Armin Ahsan and Pakistan's Sarah Shahbaz Khan received awards for their outstanding short stories: 'Tragedy to Triumph: Biogas in Daria Nagar' and 'Mudcoated Walls and Sandy Dunes', respectively.

In the category of the best technical solution, Uganda's Michael Okao, Darius Ogwang and Joshua Elem were recognised for their solar concentrator that harnesses renewable energy for clean cooking. Nigeria's Michael Chiangi Gbagir won the best educators award for his initiative 'EcoPower Adventure', which engages different communities through interactive learning activities, such as energy scavenger hunts.

The 'Availability of Climate Finance for Youth' report will inform the Commonwealth Secretariat's ongoing work, especially its Commonwealth Climate Finance Access Hub, which has supported small and vulnerable countries to access about \$322 million of climate finance for projects to mitigate and adapt to the impacts of climate change.

#### CARICOM Statement on Venezuela-Guyana Border Controversy



CARICOM Heads of Government met in caucus on Friday December 8 to discuss the situation with regard to the Venezuela Guyana border controversy and agreed to issue the following statement:

CARICOM firmly supports Guyana in pursuance of the resolution of its border controversy with Venezuela through the process of the ICJ.

Further, CARICOM urges Venezuela to respect the conservatory measures determined by the ICJ in its recent ruling until a final resolution.

CARICOM reiterates its commitment to the Caribbean as a Zone of Peace and the maintenance of international law.

Accordingly, CARICOM calls for a de-escalation of the conflict and for appropriate dialogue between the leaders of Venezuela and Guyana to ensure peaceful coexistence, the application and respect for international law and the avoidance of the use or threats of force.

# 10 Israeli Troops Killed in Northern Gaza as UN Calls for Cease-Fire

Israel's military Wednesday announced the deaths of 10 of its soldiers in fighting in the northern Gaza Strip, as it carried out attacks in its campaign to eliminate the Hamas militant group.

The Israeli military said it had attacked more than 250 targets during the past day.

Israeli airstrikes included hitting what the military said was a team preparing to launch rockets at Israel.

During an operation in Gaza, Israeli troops recovered the bodies of two people taken hostage during the Hamas attack in October that prompted the Israeli military response. An Israel Defense Forces spokesman said Hamas was holding hostages underground in crowded parts of Gaza, making rescue efforts complex but he said Israel would not be deterred in its mission to free every hostage.

The continued fighting came amid renewed warnings about the war's effect on Palestinian civilians in Gaza.

"Tragically, however, we foresee more civilian deaths and suffering and also further displacement that threatens the region," U.N. refugee chief Filippo Grandi said Wednesday. Pope Francis renewed his call for an immediate cease-fire, while calling for humanitarian aid deliveries to Gaza and the release of hostages held by Hamas.

In a sign that the United States is getting increasingly concerned over the scale of civilian casualties from Israel's military campaign in Gaza, President Joe Biden delivered a public rebuke to Prime Minister Benjamin Netanyahu on Tuesday, even as he maintains staunch support for Israel.

"We have made it clear to the Israelis, and they are aware that ... the safety of innocent Palestinians is still a great concern. And so, the actions they're taking must be consistent with attempting to do everything possible to prevent innocent Palestinian civilians from being hurt, murdered, killed, lost, etc.," Biden said at a press conference.

Biden has grown more vocal with his public criticism of Israel's military campaign which is now in its third month. Speaking off-camera to Democratic donors for his 2024 reelection bid earlier Tuesday, Biden said Israel is starting to

lose support around the world because of its "indiscriminate bombings," according to a White House transcript of the event.

Biden's comment stands in contrast to those of White House officials who say Israel has taken measures to make their strikes more targeted to avoid civilian deaths.

"He's [Netanyahu] a good friend, but I think he has to change. ... This government in Israel is making it very difficult for him to move," Biden said.

The president singled out Itamar Ben-Gvir, Israel's farright national security minister.

"Ben-Gvir and company and the new folks, they don't want anything remotely approaching a two-state solution," he said. "They not only want to have retribution, which they should for what the Palestinians — Hamas — did, but against all Palestinians."

He suggested Netanyahu will need to empower the Palestinian Authority to become a partner in the peace process toward the two-state solution, which Israeli hard-liners oppose.

"You cannot say there's no Palestinian state at all in the future. And that's going to be the hard part," Biden said, even as he underscored that the U.S. will not do "a damn thing other than protect Israel in the process."

Biden said national security adviser Jake Sullivan will travel to the region this week and meet with the Israeli war Cabinet to emphasize U.S. commitment to Israel, as well as the need to protect civilian life and ensure more humanitarian assistance into Gaza.

Defense Secretary Lloyd Austin will also travel to the region to step up international efforts to protect the free flow of commerce through the Red Sea that has been disrupted by Iran-backed Houthi militants attacking vessels heading into Israel.

#### House Set for Key Vote on Biden Impeachment Inquiry as Republicans Unite

WASHINGTON — The U.S. House of Representatives is pushing toward a vote Wednesday to formally authorize the impeachment inquiry into President Joe Biden as Republicans rally behind the charged process despite lingering concerns among some in the party that the investigation has yet to produce evidence of misconduct by the president.

The vote comes as House Speaker Mike Johnson and his leadership team face growing pressure to show progress in what has become a nearly yearlong probe centered around the business dealings of Biden's family members. While their investigation has raised ethical questions, no evidence has emerged that Biden acted corruptly or accepted bribes in his current role or previous office as vice president.

Ahead of the vote, Johnson called it "the next necessary step." He acknowledged there are "a lot of people who are frustrated this hasn't moved faster."

But Johnson said on Fox News he believes the resolution will pass the House and "we'll be in the best position to do our constitutional responsibility."

By holding a vote on the floor, the speaker, who has been on the job less than two months, will be putting his conference on record in support of an impeachment process that can lead to the ultimate penalty for a president: punishment for what the Constitution describes as "high crimes and misdemeanors," which can lead to removal from office if convicted in a Senate trial.

A successful vote would also ensure that the impeachment investigation extends well into 2024 when Biden will be running for reelection and seems likely to be squaring off against former President Donald Trump — who was twice impeached during his time in the White House. Trump has pushed Republicans to move swiftly on impeaching Biden, part of his broader calls for vengeance and retribution against his political enemies.

In a recent statement, the White House called the whole process a "baseless fishing expedition" that Republicans are pushing ahead with "despite the fact that members of their own party have admitted there is no evidence to support impeaching President Biden."

Some House Republicans, particularly those hailing from politically divided districts, have been hesitant to take any vote on Biden's impeachment, fearing a significant political cost. But GOP leaders have made the case in recent weeks that the resolution is only a step in the process, not a decision to impeach Biden. That message seems to have won over skeptics.

"As we have said numerous times before, voting in favor of an impeachment inquiry does not equal impeachment," Representative Tom Emmer, a member of the Republican leadership team, said at a news conference Tuesday.

Emmer said Republicans "will continue to follow the facts wherever they lead, and if they uncover evidence of treason, bribery or other high crimes and misdemeanors, then and only then will the next steps towards impeachment proceedings be considered."

Most of the Republicans hesitant to back the impeachment push have also been swayed by leadership's recent argument that authorizing the inquiry will give them better legal standing as the White House rebuffs their requests for information.

A letter last month from a top White House attorney to Republican committee leaders portrayed the GOP investigation as overzealous and illegitimate as the chamber had not yet authorized a formal impeachment inquiry by a vote of the full House. Richard Sauber, special counsel to the president, also wrote that when Trump faced the prospect of impeachment by a Democratic-led House in 2019, Johnson had said at the time that any inquiry without a House vote would be a "sham."

Representative Dusty Johnson, a Republican from South Dakota, said Monday that while there was no evidence to impeach the president, "that's also not what the vote this week would be about."

"We have had enough political impeachments in this country," he said. "I don't like the stonewalling the administration has done, but listen, if we don't have the receipts, that should constrain what the House does long term."


• "Supernatural," starring Jared

#### Ampullary Cancer Treatment Can Include Chemo Prior to Surgery

DEAR DR. ROACH: My husband was diagnosed with ampullary cancer. He has a tumor the size of a marble. We are told this is an aggressive cancer. My concern is that they are giving him chemotherapy before the Whipple surgery. Is this standard practice? — P.T.

ANSWER: The ampulla of Vater is an opening in the duodenum (the first segment of the small intestine), where the common bile duct releases bile and pancreatic enzymes to aid digestion. A cancer of the ampulla can originate from the pancreas, bile duct or duodenum, and these can all be aggressive cancers.

The standard approach in people with the possibility to be cured is called a pancreaticoduodenectomy, otherwise known as the Whipple procedure. Although this is a complex surgery that used to have a high mortality rate, the risk of death from the procedure in specialized centers is now about 1%.

Most people are familiar with getting chemotherapy after surgery to help remove any cancer cells that remain, a technique called "adjuvant therapy." However, giving chemotherapy before surgery ("neoadjuvant chemotherapy") has increasingly been used in people with ampullary cancer. The idea is to shrink the tumor to make it easier for the surgeon to remove completely. Chemotherapy may also kill any cancer cells that have already spread.

The decision of when to use chemotherapy depends on the individual's situation, so I can't tell you which would be better in your husband's case, as I lack both the details of his tumor and the expertise. I can confirm that giving chemotherapy prior to surgery is being used in regards to ampullary cancer.

DEAR DR. ROACH: I am 22. I had an electrocardiogram (EKG) last year, which indicated an incomplete right bundle branch block and early repolarization of the ventricles.

Are these two related to each other? Are they serious to any extent, since I don't have any symptoms? How can my heart rate be normal if the ventricles repolarize early?

— B.A.N.

ANSWER: Both early repolarization and an incomplete right bundle branch block are common findings in young people who are getting EKGs, usually as part of a school physical and often as an evaluation for athletes. Depolarization of the heart muscle is seen on the surface electrocardiogram and corresponds to the contraction of the ventricle (called the QRS waves). The muscle cells must then "repolarize" — that is, restore their electrical potential to get ready for the next contraction.

Early repolarization is a normal variant where the ventricle gets electrically ready for the next beat faster than average. In fact, one way to be sure that the EKG finding really does signify early repolarization is to put the person on a treadmill to raise their heart rate. The early repolarization will then go away, since faster repolarization is appropriate for a quicker heartbeat.

About 15% of young athletes with early repolarization will also have an incomplete right bundle branch block, which represents slowing of the electrical impulses within the ventricles and a widening of the QRS complex.

Fortunately, these findings almost never represent serious disease in people without any symptoms.

### FOREIGN INVESTMENT IS HIGH RISK AFFAIR

Foreign investment is often regarded as a positive aspect as well as a sign of confidence in the stability and future of the recipient country. However, investments have often proven risky even within the boundaries of a given country, imagine beyond boundaries. such Here, let us briefly explore a few, but significant, and often catastrophic, examples from the past.

The early phases of the 100 Years War (1337-1453) between England and France impacted not only the economy of the respective countries, but also that of Italy. King Edward III had received enormous loans from the Italian banking firms of Bardi and Peruzzi to finance his war and honour earlier loans he had made with other parties. his chronic Unfortunately, defaulting on repayments precipitated a dramatic financial crisis in the commercial cities of northern and central Italy. From 1342 to 1345, the managers and executive officers of both the Bardi and Peruzzi banks were arrested for bankruptcy and released on condition of renouncing all claims to interest, while the English crown canceled massive debts to the Peruzzi.

mighty Florentine Medici Bank in London had made huge loans to King Edward IV and to the British nobility. Eventually, the War of the Roses was unfavourable to most of the major Medici borrowers, and the succeeding Tudors never paid off the debt left by their predecessors. When the Medici's

London branch completed its liquidation, in 1478, it had to swallow a loss of over 51,000 gold florins (equivalent to 392 pounds of pure gold) - a truly astronomical sum for the time.

Throughout the 1880s and until 1913, foreign investment played a leading role in the industrialization of Russia. Significant capital influx from France, England and, to a lesser extent, Belgium and Germany accounted for 40 percent of Russian industrial investment. Such a massive input of foreign investment was looked upon as a sign of confidence in the Russian economy, but it was also a vehicle of foreign interference in the decisionmaking process of a vast empire. By the end of the 1800s, most Russian industries were dependent on foreign capital, foreign technology, entrepreneurship, and as a new century was born, Russia had accumulated the largest foreign debt in the world. Deja vu?!

Nevertheless, the stock markets of London and Paris continued to channel the money of the wealthy to St. Petersburg. By the outbreak of World War I, Great Britain had invested some 3 billion francs in Russia, representing 2.6 percent of her During the late 1460s, the foreign investments. However, France outperformed everyone with 12 billions of francs invested in Russian securities, representing over 26 percent of her foreign investments. Then came the Great War and then the 1917 revolution, and with it the repudiation by the new regime of any foreign debt.

denouement in the summer of 1986. when the Russian Foreign Minister Eduard Shevardnadze met Prime Minister Margaret Thatcher in London and agreed to settle a large portion of the Czar's debt to Britain, amounting to about 1 billion dollars. The French, ce la va sans dire, are still waiting for their billions.

While Europe was at war, foreign investment brought death and repression to Haiti. In 1915 the United States President, Woodrow Wilson, responded to complaints from American banks to which Haiti was deeply in debt, by occupying the country. The American occupation of Haiti lasted until 1934 and has been described as "selfinterested, sometimes brutal, and causing problems that lasted past its lifetime."

Interestingly enough, until the early 1900s, the US, now a champion for the rights of foreign investors, was adamant in regulating foreign investment rather heavily. Furthermore, when Great Britain, France, and Germany became net capitalimporters after the Second World War, they introduced a lot of formal and informal regulations on foreign investment.

Hopefully, history has thought us not to repeat the same mistakes. Foreign investment has its good sides, but it produces other less agreeable side effects. It is like salt, in moderation it makes our food rather tasty; nonetheless, too much of it makes the whole experience less than palatable. How would you feel if China invested \$20Billions in the BVI?

### **UK Government And The British Overseas Territories Agree To Closer Collaboration**

New Joint Declaration agreed by UK Government and elected leaders of British Overseas Territories (OTs)

Declaration commits to a new, more collaborative and 'modern partnership' between the UK and the OTs.

Includes plan to deepen bilateral partnerships enhance transparency and support the OTs to take on more responsibilities, alongside accountability should they wish to do so.

The UK Government and elected leaders of the British Overseas Territories, including the British Virgin Islands, have agreed a new Joint Declaration. The Declaration defines a new, more collaborative and 'modern partnership' between the UK and the OTs. The Declaration includes a commitment to practise the highest standards of governance, including in the

law, integrity in public life and financial management.

As part of the declaration, the UK and OTs committed to; improve transparency and deepen bilateral partnerships; consult OTs on UK primary legislation that impacts them; and support OTs to take on more responsibilities where they wish to do so.

UK Minister for the Overseas Territories, David Rutley, said:

"The Overseas Territories are an important part of the British Family, and our shared values such as support for democracy and the rule of law underpin this close relationship.

"Our new Joint Declaration sets out more clearly than ever how the UK and Overseas Territories will work closer together on the opportunities and challenges of the modern world."

The Joint Declaration was

British Overseas Territories annual Joint Ministerial Council meeting in London on 14 – 15 November and has now been formally approved within the OTs.

Other commitments in the agreement include investigating improvements to how the UK provides financial support to OTs and agreeing to speak with one voice on the international stage, such as at the United Nations. It also creates more opportunities for the OTs to take on responsibilities where they want to, such as around transparency measures, and through the development of 'Compacts.'

These 'Compacts' will set out roles and responsibilities on specific issues bespoke to each community. The UK will seek to agree these detailed bilateral agreements with each of the OTs.

14... Antigua and Barbuda Ambassador, Sir Ronald Sanders, has been invited to participate in the transition of government in Guatemala by the country's President, Dr. Alejandro Giammettei. Guatemala held Presidential general elections in June 2023, with run-off Presidential elections on August 20. The presidential elections were won by Bernardo Arévalo of the Semilla party. However, while President Giammettei pledged himself committed to a hand-over of the Presidency and the


government on January 14, there have been several attempts by the Attorney General and the Public Ministry to suspend Arévalo, and so disqualify him from taking office.

This issue has attracted the concern of the international community and has occupied the deliberations of the Permanent Council of the Organization of American States, under the presidency of Ambassador Sanders.

In accepting President Giammettei's invitation to Guatemala, alongside OAS Secretary-General,

Luis Almagro, Sir Ronald "I have accepted the President's invitation because everything possible must be done to ensure that the will of electorate of Guatemala is respected and upheld, consistent with democratic principles and the rule of law".

Sir Ronald will visit Guatemala on 15 and 16 December 2023, meeting the President and other key players in the country in an effort to contribute to the successful and peaceful transfer of government on January 14.



#### Family Support Network accepts \$10K Seasonal donation from Drakes Traders

Mrs. Prudence Charles-Phillip, Interim Executive Director, FSN and Mrs. Judith Charles, long-time volunteer at the FSN, were presented with the cheque by the Drakes Traders team at the hardware store in Fish Bay, Tortola on Wednesday, December 6.

The gift matches the annual seasonal donation made by the community hardware store to the charitable organization last year. The funds were received with the same depth of appreciation by Mrs. Charles-Phillip and Mrs. Charles as in 2022.

"This generous amount of money that we receive from you always allows us to breathe a sigh of relief," said Mrs. Charles-Phillip addressing Mr. Christian Esser, Managing Director of Drakes Traders. "The cash outlays needed to meet the needs of our clients along with our monthly overheads, are hard to manage as the demands are always fluctuating based on the areas of support needed in any one month."

Mrs. Charles-Phillip explained that, besides the community pantry stocked by donations, the FSN's supporting role extends from providing emergency shelter and food for individuals and families to counselling services and job placement support services.

"The needs for each client coming to us seeking support in escaping a domestic abuse situation varies," said Mrs. Charles-Phillip. "We have arrangements in place to accommodate those that need shelter, but the cost, which includes 3 basic meals per day per person, is not a constant or something we can adequately budget for based on our assured annual income. The same goes for professional

counselling that is essential to help people break away from the cycle of abuse and rebuild their self-confidence to start building a sustainable new life away from their abuser.

"Our aim is to provide a mediumto-long term solution for people in abusive situations, where staying with the abuser seems like the only option based on their income, status or threats levelled at them or their children should they leave the home.
