IMPLEMENTATION OF COLREFORMS IS "FAR BEHIND SCHEDULE": GOVERNOR ANNOUNCES FINAL DEADLINE

The additional power request by Governor John Rankin that has caused both the House of Assembly and members of the public to express concern was offered

by the United Kingdom Overseas Minister since last year.

recommendations on 5 January Governor Rankin announced that while he was not going to trigger the Order in Council that would establish an interim administration led

that very day. These powers the Governor stated were required to "help ensure that the BVI Government delivers its commitments." Since then, Premier and Minister of Finance Dr. the Hon. Natalio Wheatley has announced that he intends to also write the UK Minister of Overseas Territories asking him not to grant the additional powers to the Governor. However, it has been stated that the idea for the Governor being given additional power was placed on the table since April last year by the same Ministry the Premier intends to write. This disclosure was made in the same review the

"In his letter in April 2023, Lord Goldsmith asked me to consider if "resources, additional powers technical expertise" were necessary to accelerate the Government's reform programme."

At this point, the Governor declared that he is going to accept that offer to fulfill the COI recommendations implementation. He said, "In addition to exercising the powers which I have under the Virgin Islands Constitution, I have reached the conclusion that I must request additional powers to help ensure the Framework Agreement proposed by the BVI Government is delivered. Experience has shown that providing more time alone will not be sufficient to deliver reform and that there may be a need for the Governor to step in further."

While making the case further for his intervention the Governor stated: "Key recommendations are far behind schedule and the capability and determination of the BVI Government to drive forward and complete reforms is in question. It has remained an option to consider an interim administration whereby the Governor takes over the responsibilities of Ministers in line with the Order in Council. However, this is not my recommendation at this stage."

Over the months of the implementation efforts persons in the community have accused the Governor of being insensitive to the gravity of work the implementation requires; and even chided the Governor for originally lagging behind. In an obvious response to this criticism the Governor stated in the review: "I do not underestimate the scale of the task to deliver recommendations which I am responsible. I increased resources have

and developed contingency plans to ensure that the Law Enforcement Review (B38 & 41) and Vetting Project (B39) meet deadlines. I am confident that we will. I expect Ministers to take a similar approach and dedicate resource to make the COI reforms a priority."

He also stated that he is not taking any pleasure from the fact that he had to contemplate requesting additional powers. "I am disappointed to be in the position of requesting additional powers and an extension at this stage. I nonetheless continue to hold the best interests of the BVI in mind and I believe that these measures are necessary in ensuring that the BVI prospers in the future, with the strong foundations of a modern democracy."

The Governor noted that he has been very cooperative and understanding throughout the process, and is disappointed that this is where things have gotten: "At the beginning of April 2023, the then UK

Minister for the Overseas Territories, Lord Goldsmith, set the expectation that reforms must have taken root no later than May 2024. In my previous Quarterly Review, I offered my understanding of what that could look like."

"By May 2024, I would expect to see that reforms are making a tangible difference. This could include legislation which is in force, policies which are being consistently applied, and adequate resources assigned to maintain systems and processes to ensure that reforms are achieved effectively."

While further belaboring the snail's pace of the reform the Governor pointed out: "... Some of these mechanisms have been in development for the last twenty years and remain on the shelf." He also touted that as far as he could see the additional powers were the best way to ensure implementation: "Much more must be done to fully implement the COI recommendations. I previously

reported that I was concerned that without additional action, the reforms needed were at risk. I highlighted that the pace of work needed to increase with appropriate levels of prioritization.

In further shedding light on his concern about the implementation His Excellency noted that the progress has been disappointing. "Only one additional recommendation is reported as completed since my June 2023 Quarterly Review, or indeed since the General Election in April 2023. The total reported is 25 of 48 with only a few months left until May 2024. The reforms are more than a box ticking exercise, however the fact that there has only been one additional recommendation completed in the past few months is unacceptable. It shows that the required milestones have continued to be missed. In some areas, it is evident that work is progressing, but in other areas meaningful change seems unlikely to be achieved by the end of May 2024 at the

current rate.

While the Governor noted that the 48 recommendations are not weighted equally, and some require much more work than others; he did note that being in-progress is not the same as complete. "For legislative change, a recommendation would usually be marked as complete if the legislation has been brought into force. In relation to reviews, the COI Implementation Unit considers these recommendations to be complete when policy changes or legislative amendment is made."

Governor Rankin further lamented that deadlines proposed by the BVI Government and agreed by the UK had to be revised on at least two occasions. "The Premier wrote to me in September with the most recent proposed deadlines; this letter was shared with the UK Government. Based on this, a number of recommendations should have been completed by now," he added.

GOVERNOR ANNOUNCES REVIEW INTO COMPLAINTS AGAINST POLICE COMMISSIONER

Territory in the Region to

conduct an independent

His Excellency the Governor, John Rankin has announced the initiation of a comprehensive review into numerous complaints lodged against the Territory's Commissioner of the Royal Virgin Islands Police Force (RVIPF), Mark Collins.

Several of these complaints against Mr. Collins emanate from a leaked email wherein he had allegedly instructed senior officials to dispose of specific evidence linked to a case involving a now-retired officer. However, the majority of other complaints were formally presented

to Governor Rankin in the form of a petition in late 2023, encompassing a total of 55 allegations against Commissioner Collins.

The decision to formally look into the matter was mentioned by the Governor on 5 January during his Fifth Quarterly Report on the Implementation of the Commission of Inquiry COI). In noting the decision His Excellency pointed out: "I have, in fact, in line with UK and international best practice, enlisted the services of a senior police officer from another Overseas

review of the complaints that have been made..."As it relates to the way forward on the matter, the Governor said: "Once the review is concluded and the findings and recommendations are available, I will share the information with the public. However, I must await the outcome of this review. I take all complaints seriously and have acted accordingly in this matter, as in others." Governor Rankin did not disclose details regarding the identity or qualifications of the investigating officer from the Overseas Territory, but he emphatically asserted that there was no bias on his part. He stated: "I have demonstrated that I hold no bias in this matter and have initiated a review of the complaints... I categorically reject any accusations of bias."Additionally, the Governor clarified that he is not aware of any evidence suggesting that the majority of RVIPF officers are opposed to the Commissioner, as suggested one reporter. remarked: "I have reviewed the petition, which has been endorsed by several officers. While some complaints in the petition vary in nature, they will all be thoroughly examined. I do not believe there grounds are lack confidence in the Commissioner of Police, but I will await the outcome of the review with impartiality and fairness."

Premier Natalio Wheatley was also asked to weigh in on the plans to investigate the Commissioner. The Premier was asked to comment on why the Commissioner was still on active duty even though he is under investigation.

In response the Premier said that he would look into the matter and ensure that the response is fair and in accordance with established protocols. Dr. Wheatley stated: "Obviously, I would lobby for what is fair and what is right. If it's fair and it's right under the existing protocols for when someone is being investigated for them to go on administrative leave, I certainly would advocate for that."



OPPOSITION CRITICIZES GOVERNOR'S PLANS TO SEEK ADDITIONAL POWERS

While emphasizing that they stand united with the Government members of the Opposition have criticized the Governor's plan to seek additional powers. Even more, Sixth District Representative Hon. Myron Walwyn announced that the Governor already wields the authority.

His Excellency Governor John Rankin on 5 January announced that he was writing to the United Kingdom government to give him additional powers to be able to fast-track the implementation of the COI recommendations. This disclosure has been criticized across the

Territory; nevertheless it is a fact that the COI reforms are too slow in materializing.

In his announcement of his disapproval of the matter, Hon. Walwyn on 9 January during a press conference organized by the Opposition to show solidarity and support to the Government announced that additional power is unnecessary.

his response, In Walwyn carefully Hon. scrutinized the governor's for justification these enhanced powers and contended that many of them were already the Governor's disposal. Mr. Walwyn stated: "He mentioned the ability to

introduce legislation directly to the House of Assembly, exercising control over departments and ministries to accomplish specific tasks, and overseeing contract matters brought before the Public Accounts Committee. I argue that, within the existing framework of the Virgin Islands Constitution Order 2007 and the standard government operations, the Governor can achieve each of these three objectives he mentioned."

He further asserted that, within his reserved powers, the governor can delegate or request the Premier or any other Minister to present legislation to the House of Assembly on his behalf.

While emphasizing his disagreement with the request, the Sixth District Representative declared that he sees no good reason why the Governor would pursue such additional

powers. Hon. Walwyn said:
"I am not entirely convinced
that having the authority to
introduce legislation directly
in the House would expedite
its progress beyond the
current pace."

While further poking holes with the Governor's announced reason accessing additional powers Hon. Walwyn also pointed out that Governor Rankin in is role as Chairman of Cabinet has the authority to summon any department, including the COI Implementation Unit, to investigate the causes of delays if he is dissatisfied with the responses provided by the minister responsible for implementation.

DEPUTY PREMIER EXPRESSES CONCERNS ABOUT COI

INVESTIGATIONS

His Excellency Governor John Rankin has refuted comments that the Commission of Inquiry (COI) investigations and the allegations involving misconduct or the misuse of public funds should be dismissed as "frivolous".

During a 5 January press conference a member of the media asked His Excellency the Governor about the possibility of the UK providing compensation to individuals facing COI charges if they were later proven innocent. While asking the question the media member suggested that some persons view the allegations or even charges in some instances as "frivolous."

In response, Governor Rankin stated: "I'm not aware of any frivolous charges that have been brought, though there may

be differing opinions on the matter. Charges are only laid after a thorough investigation by the RVIPF and are subsequently subject to the independent decision of the DPP. Thus, I would not categorize these charges as frivolous in that regard." As it relates to whether United Kingdom Government was going consider providing compensation to individuals found innocent who choose to sue the British Government for the public embarrassment they endured due to the COI.

In response, the Governor said: "The short answer is that it depends on the nature of the civil lawsuit, the outcomes of the civil lawsuit, and determining the party specifically responsible for any wrongdoing. We would

need to scrutinize all these aspects before offering a definitive response to that question."

Concerns about COI investigations and the allegations associated were mentioned by Deputy Premier and Minister for Labour Hon, Lorna Smith during a recent House of sitting. Assembly Minister stated that she noticed that a number of cases linked to the COI are still under investigation and appear to be the priority for the police and Governor Rankin.

Hon. Smith said, "It is my understanding that there is a significant number of prosecutions still pending and the fact that these appear to be the priority for the police and the Governor, reminds me of Nero fiddling while Rome burned."

"Don't get me wrong, I

am all for good governance and best practice and the implementing the recommendations of the COI but I must ask the question: are we putting sufficient human and other resources into solving these crimes, including the unsolved murders? Or are we investigating and making arrests on charges like breach of trust simply to tick the boxes? We must ensure this country does not descend into the abyss of complete chaos and lawlessness," she added.



PRESS STATEMENT FROM GOVERNOR OF THE BRITISH VIRGIN ISLANDS MR JOHN RANKIN CMG

Today I have published my Fifth Quarterly Review of the implementation of the Commission of Inquiry recommendations.

The COI report published in April 2022, twenty-one months ago. The COI found poor governance, a lack of accountability and the misuse of public funds. Members of the House of Assembly weren't declaring their interests, two thirds of all contracts over \$100k weren't being openly tendered. There were serious concerns over the system of assistance grants, which were further clearly shown in the audits that have been carried out by the Auditor General.

The COI made recommendations help to resolve these issues and place the BVI on a better path to good governance. In June 2022, the Government of National Unity accepted 48 of those 49 recommendations and committed themselves to delivering them. Politicians from across political parties agreed that delivering these reforms was vital.

I am disappointed however to report that in recent months progress on these commitments has significantly stalled. My previous Quarterly Review was relatively positive, but it called for a concerted effort and prioritisation from Ministers to make further progress. This has not happened.

Last September, 24 of the 48 recommendations had been delivered by the Government's own count. As of today, only one more recommendation has been delivered. Namely, the receipt of the Constitutional Review Commission Report, which of course was not carried out by Government but by an independent review body.

In April 2023, I published a letter from the then UK Minister for the Overseas Territories. Lord Goldsmith said if the necessary reforms have taken root no later than May 2024, this should allow the Order in Council to be lifted. I do not

now foresee that reforms will have taken root at that point, and it is clear that more time will be required. I have accordingly suggested in my Quarterly Review that an extension to the end of November 2024 would be appropriate.

While I believe an extension is necessary, additional time alone will not be enough. The initial deadlines were agreed by BVI Government. Some (not all) of the deadlines were tight and the Government asked for extensions on two occasions, last January and again in September. Those extensions were accepted by the UK. But even these are still being consistently missed.

So in addition to a deadline extension to the end of November, there is clearly a need for some further step or steps to drive forward implementation of the COI recommendations. I am not recommending triggering of the Order in Council in order to establish an interim administration led by the Governor. But I have come to the conclusion that additional powers for the Governor are required to help ensure that the BVI Government delivers its commitments. I will be writing to the UK Minister today with a recommendation to that effect.

I know that implementation of some of the recommendations isn't easy. Indeed I have faced challenges in delivering a couple of the recommendations for which I am responsible. For example, the Vetting Project, to conduct checks to ensure that all law enforcement officers are suitable for their roles. When we realised matters weren't moving quickly enough, my team and I stepped in to provide greater oversight, with additional time and resources devoted to the project. In particular we successfully pushed for and got a full time project manager, who has helped to bring this work back on track.

Similarly, we've ensured that the Law Enforcement Review is now fully underway, with an expert team now in place who have made two intensive visits to the Territory, supported by \$1m funding from the UK Government. I expect to receive their report by the end of March

There is a need for similar interventions when other recommendations are lagging behind.

So which specific areas are lagging behind? The Premier wrote to me in September with the most recent proposed deadlines. For example, by now we should have:

An amended Register of Interests Act

A new education grants policy

A policy setting out the principles of how Statutory Boards should operate

A new Public Service Management Act Revised Criminal Procedure Rules Improvements to the way the discretionary powers of Ministers are exercised

A strengthened Integrity in Public Life Act

A functioning Whistleblower Act

None of these have yet been achieved.

Without such reforms, the better governance which the people of the BVI need and deserve will not be achieved and the issues which the COI identified could more easily return.

I want the BVI to succeed. It is precisely for that reason that I believe that simply proposing another extension in deadlines is insufficient and that additional steps are required. The potential of these beautiful Virgin Islands is there for all to see and I want to see that potential wholly fulfilled.

I am scheduled to leave the Territory soon and a new Governor, Mr Daniel Pruce, will be in place by the end of January. I will continue to work hard during my remaining time in the BVI. I am grateful to the Premier for his continued commitment and the hard work demonstrated by the public servants who are committed to this work. With determination and resolve together, the reforms which the people of the Virgin Islands want and deserve can be achieved.



STATEMENT BY THE PREMIER HONOURABLE DR. NATALIO D. WHEATLEY AT A PRESS CONFERENCE

Update on the Implementation of the COI Recommendations

A pleasant good afternoon to the Press Corps, persons listening online and via radio, and Virgin Islanders here at home and abroad. Firstly, allow me to wish the people of the Virgin Islands a blessed and prosperous 2024. May we as a people ask Our Most High God for wisdom, knowledge, and understanding as we navigate the tumultuous waters on this journey of nation building.

I am pleased to be joined by my Government colleagues with whom it is an honour to serve the people of the Virgin Islands as we work together to build a model democracy in which we thrive as a community.

As I indicated in my address last Friday in response to the Governor's quarterly update on governance reform, I am holding this press conference to provide the public with greater detail on the progress of implementation. Unfortunately, the Governor's press conference did not present the full picture of where things stand. It is extremely important that you are aware of the full extent of the work your Government has been undertaking and the context. First, however, I would like to reiterate some of the key points I made in my previous address.

My colleagues and I alarmed and deeply offended by the Governor's request for additional powers to implement the recommendations of the Commission of Inquiry (COI). Only as recently as last month we agreed a joint declaration with the United Kingdom (UK) Government which spoke to the deep, historic and enduring partnership between the UK and the Overseas Territories (OTs). Further, it affirmed the principle of equal rights and selfdetermination of the people of the Overseas Territories as enshrined in the United Nations Charter and pledged greater consultation between the UK Government and the Governments of the Overseas Territories. The hallmark of a modern partnership is democratic engagement between partners.

Now, for the Governor to seek the power to overrule our Constitution and have the authority to act in areas of constitutional responsibility devolved to the elected arm of Government, especially after a General Election only just over eight months ago, is a shock to the system. The fact that this request has been made without any consultation with the Government of the Virgin Islands harkens back to the heyday of colonial Governors ruling over these Virgin Islands.

This Government has said from the start that we see the reforms recommended by the COI in April 2022, as an essential route to improving the delivery of transparent, effective and accountable government in the Virgin Islands.

To this end, we have worked with our officials to effect what is a major transformation and reform of government for the Territory. We have stated on a number of occasions that given the capacity and staffing resources of the Government of the Virgin Islands, the original timelines for implementation of the COI Recommendations and Other Reforms were always extremely tight. This, together with the dayto-day responsibility of governing a country still recovering from two category five hurricanes, and with two economic pillars in tourism and financial services, which need constant care and attention, made for a significant challenge. But we have put our shoulder to the wheel to get implementation across the line and there has been significant progress which I want to outline to you today.

I also want to give more details on some of the areas the Governor has mentioned, but which unfortunately were not adequately addressed in his report.

As of 30th November 2023, 50% of the recommendations agreed in the implementation framework between the Government of the Virgin Islands and the UK Government had been fully implemented.

Within the 50 Recommendations, there are 131 Actions. Of these 80 (61%) have been completed, while there are 34 actions (26%) that are in the red zone, meaning that they are not yet completed and the deadline agreed for their completion has passed. The December report is currently being finalised, so I will be able to update you on additional progress within the next two weeks. However, today, I want to give you some perspective specifically on these red zone actions and where we stand on them. I would not ordinarily give this level of detail in a speech but given the Governor's recent statement, I think that it is essential that I give a full measure of clarity, so you, the People of the Virgin Islands can understand where the COI Implementation stands.

Firstly, we have four actions that will need constitutional amendment in order for them to be marked as completed. Two of these actions relate to Declaring House of Assembly Interests and another two relate to the Jury Act.

Secondly, we have four actions that are waiting on the Governor himself. As he admits in his report, he has faced challenges balancing the need to implement the recommended reforms with the capacity to bring those reforms into effect. The reforms within his area of responsibility, including those in law and order and prisons are urgent and I find it questionable that the Governor can turn a blind eye to his own failure to make adequate progress on these reforms, but wishes to penalise the Government of the Virgin Islands for its capacity challenges.

We have two further actions that have actually advanced almost to completion but are now dependent on external action outside of our control. These relate to our Criminal Procedure Rules reform. We have completed the draft for Cabinet's approval but the Chief Justice has asked us to allow the OECS review to be completed before we advance our own so they can be in synergy. We have been advised that this will be completed by the end of March.

We have two Reviews that our Audit Department is working assiduously to complete: The Audit of COVID Assistance Grants covers two actions and the other has to do with Audit of Contracts over \$100,000.

We, of course, also have our critical law enforcement reviews which span three actions that were initially delayed because the reviewers first selected could not in fact conduct the reviews. I should point out that the delay in this area has worked out to the benefit of the Virgin Islands as the reviewers now engaged wish to maintain a long-term relationship with our law enforcement bodies, and will help us to build capacity and standards moving forwards.

Outside of the red zone, we have eight actions that are ongoing throughout the COI Implementation process which cannot be marked as completed until the full process is finished. These are connected to how the process works and is monitored.

Finally, we had completed much of our election reform but in consideration of the 2023 election, we agreed not to make significant changes to our electoral process right before a general election. Following the election, the Elections Supervisor and external observers have submitted their reports and their recommendations will be considered for incorporation into the reforms that we already intend to implement.

I remind everyone that reform is not a tick box exercise to check off deadlines. We must live and breathe these reforms and thus consider all the factors involved, some of which were not raised during the COI hearings but that are certainly significant. The process must also be democratic and involve our people and the relevant stakeholders. This is the only way we can make positive and lasting change for our territory. I share the Governor's urgency in advancing to completion the reforms and seeing us come safely through the task that the COI has set before us, but true reform is about building capacity and resilience and ensuring that all of us in the Virgin Islands understand what we must do to move forwards. Time is needed above all else- time to consider, time to consult and time to draught new

Indeed, because we have taken that time, we have at least one action for which a different solution has been envisioned from what was originally agreed in the Framework and which may need now to be considered closed. This relates to addressing the Border Security System.

legislation and amend existing

laws.

In addition, there are a number of recommendations which have significant implications for our Territory, how we live and our future. We are a country of 30,000 and our people have opinions on these matters which as a Government, we cannot and will not simply ignore. Indeed, that is the whole of point of democracy.

Given this, the Government decided to extend its public and internal consultation periods, to ensure that we have taken all considerations into account before we map the way forward in these matters: There are 12 remaining Actions in these areas and they are related to Public Assistance Grants, Educational Assistance Grants, Crown Land Disposal, Belonger and Residency Status and the Public Service Management Act.

The quick path is not always the best path. This process is about understanding what is right and doing that requires transparency and thorough consultation so that reform would be driven by the democratic will of the people of the Virgin Islands.

And we should not be punished or our democratic and human rights threatened with an Order in Council in reserve to suspend our constitution. Nor should the Governor be granted additional powers just because he wants to see certain things done before he departs the Territory. He does not have the democratic accountability to make certain decisions for the people of these islands.

It is incredulous that the Governor, who has also sought extra time for unfinished tasks under his purview is pursuing a power grab to assume control over strategic areas within the elected government's responsibility. This is an uneven approach that raises concerns about fairness and collaboration in addressing the challenges at hand.

This necessitates an partial suspension of the constitution – an alarming and retrograde step that should not be considered. Preserving democratic principles is paramount, and alternative solutions must be explored to expedite reforms without compromising our constitutional framework.

I will write to UK Overseas Territories Minister Hon. David Rutley immediately to urge him to decline the Governor's request for additional powers and remain on the path of partnership that he has led with the agreement of a Political Declaration between the UK, Virgin Islands and

other Overseas Territories. It is not worth damaging the UK's relationship with the Government and people of the Virgin Islands and sullying the UK's international reputation as it grapples with its colonial past and the legacy of slavery. The perception of the UK matters in the Caribbean region, Commonwealth and the World.

A supportive approach by the UK would assist the Virgin Islands in progressing the remaining reforms and demonstrate the re-establishing of the modern partnership we have just agreed. That is the spirit of partnership Lord Goldsmith had in mind when he set the target date of May 2024 to lift the Order in Council in reserve that is not justified you genuinely believe in democracy. I am asking Minister Rutley to stay true to

partnership and democracy.

I restate today that my Administration remains firmly committed to full transparency and good governance and intends to fulfil our Framework Agreement. While realistic and appropriate timeframes will assist with this, our focus is on completion at the highest possible level.

Where we stand on each Recommendation can be seen in the recently launched and publicly accessible COI tracking tool (Commission of Inquiry Implementation Tracker). The site will be populated with more details over the next few weeks but for now, you can see Recommendation by Recommendation, which have been implemented, which are in progress and which are yet to start. Importantly, you can also see where responsibility for implementation lies for each

Before I finish, I want to pay tribute to our public officers. While politicians are used to developing thick skins in the rough and tumble of political debate, it is essential to recognise that this should not be expected of our dedicated public officers.

The deflating and frankly anti-democratic words of the Governor are an insult to our voters. They also damage the morale of the very public officers who are working so tirelessly to ensure that the Virgin Islands fully implements the COI's recommendations and through this enables us

to develop truly modernised government structures.

Within the next six weeks, Cabinet will consider the new Educational Grants Policy, the new Crown Land Disposal Policy, the new Belongership and Residency Policy, the drafting instructions for the Public Service Management Act and the new Statutory Boards Management Policy. We have done much consultation on these and involved you, the citizens and residents of the Virgin Islands, as we considered how to best move forward.

This has only been possible through the hard work of our

officers. I can assure all of them that this Government stands with them and together we will ensure that decision making in the Virgin Islands continues to be underpinned by democratic governance, continues to maintain our selfdetermination and continues to protect the interests of all Virgin Islanders.

Thank you very much for your attention and I would very much welcome questions from the press on the implementation of the reforms I mentioned earlier. It is important that the people of the Virgin Islands are clear on where things stand.



GLOBAL NEWS BRIEF

USA - EUROPE: In the years following the historic 2008 financial crisis, the IMF, the OECD and other major international organizations became overly optimistic. Year after year, reality tested growth forecasts that repeatedly proved to be too bullish. This trend has seen a reversal recently. The energy crisis triggered by Russia's invasion of Ukraine dampened European growth, starting with Germany, but it didn't cripple the bloc as feared. But caution is always warranted in the forecasting business, as the economy is an ever-evolving story — the last few years have proven that anything is possible. Macroeconomic indicators show remarkable resilience despite the steepest interest rate hikes in four decades.

Pessimistic economists dismissed the prospect of a soft landing last year, the coveted scenario in which an economy can digest inflation and rising interest rates without sinking into a deep recession. Now, what was once a niche theory is close to becoming a tangible reality. Growth is slowing on both sides of the Atlantic, but it hasn't stopped altogether. This is mainly due to a strong labor market and steady household consumption in the face of significant credit tightening.

If one had to choose a single word to describe the economy in 2023, it would undoubtedly resilience. Inflation is approaching reasonable levels again, and with the prospect of interest rate cuts by the Federal Reserve and the European Central Bank (ECB), a much more favorable economic outlook is not unthinkable. The future is not all rosy, but it is far from the "blood, sweat and tears" that many feared.

"Everything is pointing towards a soft landing, as proven by the recent stock market surge," said Xosé Carlos Arias, an economics professor at the University of Vigo (Spain). "The feeling is that we are converging towards the 2% inflation target, so fears of price spikes are dissipating." However, everything is still in the treacherous realm of "it seems as if..." Still, Arias said, "One thing is clear: tight monetary policy has not led to a severe recession, and any comparison to the [oil] crisis of the 1970s is hyperbole." [El Paisl

ITALY - The disposable income, purchasing power and savings of Italian families all grew in the third quarter of last year, ISTAT said on Friday. Household gross disposable income and final consumption expenditure of

consumer households grew respectively by 1.8% and 1.2% over the second quarter of 2023 according to the national statistics institute's Quarterly non-financial General Government (GG) account.

Purchasing power of consumer households in real terms rose by 1.3% over the previous quarter against a 0.5% increase in prices The saving rate of consumer households stood at 6.9%, 0.6 percentage points higher than in the second quarter of 2023. [ANSA]

FRANCE - "We no longer sell this brand due to unacceptable price increases," say tags on shelves in Carrefour's French stores where the Pepsico products once stood.

The source said the move also affected stores in Belgium, Italy and Spain.

It means consumers will no longer be able to find the iconic products alongside PepsiCo names such as Lay's potato chips, Lipton tea, Quaker Cereals and 7Up.

French retailers are locked in annual negotiations with big food industry firms on prices and other conditions regarding their sale in supermarkets.

"We've been in discussion with Carrefour for many months and we will continue to engage in good faith in order to try to ensure that our products are available," a PepsiCo spokeswoman said, declining to comment further on the talks.

Retailers say they are under pressure from food industry firms to raise prices.

Pepsi's main rival, Coca-Cola, said in November is was seeking to raise its prices an average of 7 percent.


PepsiCo reported in October its sales so far in 2023 had risen by 9 percent on slightly lower food sales and steady beverage sales, an indication it has also raised prices. [France 24]

RUSSIA - Moscow said its military accidentally bombed a village in the southern Voronezh region on January 2 during a massive Russian attack on Ukraine. The Russian Defense Ministry said six buildings had been damaged but there were no casualties in Petropavlovka, some 150 kilometers east of the border with Ukraine. It came on the same day that Russia's military launched a barrage of missiles and drones at Ukraine, with four killed and nearly 100 injured in Kyiv and Kharkiv, the two cities targeted in the Russian attacks. (RadioFreeEurope)

LIAT - After nearly half a century of operating under Caribbean government ownership, the 67-year-old regional carrier LIAT is set to conclude its current phase as LIAT (1974) Ltd on January 24, according to Barbados Today. This decision will unfortunately result in over 90 employees being laid off without receiving their due payments, although assurances have been made regarding company's meeting the obligations. Barbados TODAY obtained a letter signed by the administrator, Cleveland Seaforth, dated Thursday, which conveyed this news.

Although the closure leads to staff layoffs, a handful of employees are expected to stay behind to oversee the final tasks aimed at wrapping up the company's affairs. This step is part of the transition toward establishing its replacement, the proposed LIAT (2020) Limited, according to one of the few remaining employees.

"After careful consideration and evaluation of the present operations, a decision has been taken by the court-appointed Administrator to permanently cease all commercial flying operations as of close of business on January 24, 2024," said the letter by Seaforth who had been retained to run a scaled-down LIAT which collapsed in





"As a result of the foregoing, you are hereby notified that your employment with LIAT (1974) Limited (in administration) will be made redundant effective February 4, 2024." Seaforth told the staff the company was not in a position to make any severance payments at this stage, but declared that it would not be shying away from its obligations to them on severance, vacation pay, retroactive pay, and any outstanding salaries.

LIAT was owned by the governments of Antigua and Barbuda, Barbados, St Vincent and the Grenadines, and Dominica. Browne said that LIAT was needed for greater connectivity "and to ensure that Caribbean people could move and move readily." He had also hoped that the airline could complement the efforts of the Trinidad-based Caribbean Airlines. But he also said he believed that there are "regional competing forces that would like to see the demise of LIAT." The governments of Antigua and Barbuda, Barbados, Dominica, and St Vincent and the Grenadines and regional trade unions say their members are owed millions of dollars in severance payments and other benefits.[CNW]

Another layer of misery: Women in Gaza struggle to find menstrual pads, running water

Heba Usrof, a young woman in Gaza, is running out of options to deal with her menstrual cycle. Pads have disappeared from pharmacies and stores. It's been this way since the war that began in October, and it's a situation that mirrors how nearly every basic requirement — from food to medical aid — has become harder to find in Gaza over the past three months.

"We go around and around, searching in all the pharmacies for pads, but we can't find any," Usrof says.

Ruba Akkila, whose work in Gaza before the war focused on the protection of women and children, says pads do sporadically appear on shelves, but they are five and six times their normal price when and if they are sold, putting them out of reach for most of Gaza's impoverished and now unemployed households. The lack of pads is a result of Israel's near-total siege of Gaza, which began following a deadly rampage in Israel by Hamas militants on October 7. "We're suffering from being hungry, from being thirsty, from being bombed. We're suffering from being displaced," says Bisan Owda, a young woman in Gaza who's been vividly documenting her life throughout the war to her 3.7 million followers on Instagram.

"Now, we're suffering also because there's no pads. It's just a new suffering," she says in a video post about this issue.

A LACK OF HYGIENE PRODUCTS — AND BASIC HYGIENE

The U.N. estimates that some 700,000 women and girls in Gaza experience menstrual cycles but don't have adequate access now to basic hygiene products like pads, toilet paper or even running water and toilets because of the war. These conditions put women and girls in Gaza at risk of reproductive and urinary tract infections, according to the U.N.

A spokesperson for UNICEF told NPR: "This situation is particularly challenging for women and adolescent girls, who lack safe, private and dignified places to manage menstrual hygiene. There are reports this is exacerbating mental health issues."

Jumana Shahin, a women's rights activist in Gaza, says women's needs are being neglected because of the scale of the humanitarian crisis gripping Gaza.

"This situation is not simple. We are talking about a woman's needs," she said. "This situation does not have a solution. You ask if there are alternatives. There are no alternatives."

"The situation is harder than you can imagine," she adds. HOW WOMEN ARE COPING

Nevertheless, women are trying to find ways to deal with their menstrual cycles.

Usrof says her friends are now taking pills that prevent their periods. She's going to start doing the same, she says. It's either that or "drown,", she says. "This issue is we're moving around a lot. We don't have the luxury of sitting around and relaxing, so it's really hard,' she says, describing how most people have fled from their homes and shelters multiple times in past weeks as Israel expands its offensive.

Meanwhile, not all women can find pills to block their periods or, for underlying health reasons, can take these pills. With no other choice, Akkila, the gender protection expert, says some women are turning to old clothes, towels or even the corners of their tents to use as pads.

"The only way to do it is just to do with scissors," she says. "It's messy. It's terrible. And nobody speaks about it," Akkila says, explaining openly talking about menstrual struggles remains taboo, even in wartime. That's partly a reflection of Gaza's traditional society — and because menstruation is a sensitive and private subject everywhere in the world.

THE SEARCH FOR RUNNING WATER AND TOILETS

Israel's bombardment and evacuation orders have displaced around 2 million people, more than 85% of Gaza's population. As a result of this mass displacement, women also have to contend with a lack of privacy and little to no access to bathrooms. Much of Gaza has no access to running water, making showers a rare luxury.

The water crisis is so severe that those in apartments, where extended families are sheltering together, can only flush the toilet when necessary because every drop of water has to be carried up the stairs and rationed.

Most Gazans, however, are living in overcrowded U.N.-run schools, where 400 people or more share a single bathroom.

Others are living in tents and on the streets as Israeli evacuation orders push people further and further south as the Israeli military tries to dismantle Hamas tunnels and expands deeper into Gaza.

Women are waking up early and lining up at hospitals to shower before water runs out for the day, Akkila says.

Others are lining up at hospitals just to use the bathroom.

Researchers find a massive number of plastic particles in bottled water

Microscopic pieces of plastic are everywhere. Now, they've been found in bottled water in concentrations 10 to 100 times more than previously estimated.

Researchers from Columbia University and Rutgers University found roughly 240,000 detectable plastic fragments in a typical liter of bottled water. The study was published Monday in the Proceedings of the National Academy of Sciences.

About 10% of the detected plastic particles were microplastics, and the other 90% were nanoplastics. Microplastics are between 5 millimeters to 1 micrometer; nanoplastics are particles less than 1 micrometer in size. For context, a human hair is about 70 micrometers thick.

Water

Microplastics have already been found in people's lungs, their excrement, their blood and in placentas, among other places. A 2018 study found an average of 325 pieces of microplastics in a liter of bottled water.

Nanoplastics could be even more dangerous than microplastics because when inside the human body, "the smaller it goes, the easier for it to be misidentified as the natural component of the cell," says Wei Min, a professor of chemistry at Columbia University and one of the study's co-authors.

The researchers used a technology involving two lasers called stimulated Raman scattering (SRS) microscopy to detect the particles and used machine learning to identify them. They searched for seven common types of plastic using this system: polyamide 66, polypropylene, polyethylene, polymethyl methacrylate, polyvinyl chloride, polystyrene and polyethylene terephthalate.

They tested three brands of bottled water; they did not identify the brands.

The particles they could identify accounted for only 10%

of total particles they found — the rest could be minerals, or other types of plastics, or something else, says Beizhan Yan, a research professor at the Lamont-Doherty Earth Observatory of Columbia University and a co-author on the study.

The International Bottled Water Association, an industry group that represents U.S. and international water bottlers and distributors, said in a statement that it has had "very limited notice and time" to review the study.

But the group said the new detection method "needs to be fully reviewed by the scientific community and more research needs to be done to develop standardized methods for measuring and quantifying nanoplastics in our environment."

The association said there is "no scientific consensus on the potential health impacts of nano- and microplastic particles." It added: "media reports about these particles in drinking water do nothing more than unnecessarily scare consumers."

The researchers hypothesize that some of the plastics in the bottled water could be shedding from, ironically enough, the plastic used in types of water filters.

Phoebe Stapleton, another study co-author who is a professor of pharmacology and toxicology at Rutgers University, says researchers have known that nanoplastics were in water. "But if you can't quantify them or can't make a visual of them, it's hard to believe that they're actually there," she says.

The significance of their group's research is that it now "brings that to light, and not only provides what is a computer generated image, but it also allows for the quantification and even more importantly, the chemistry of that quantification," Stapleton says.

They hope the research will lead to having a better understanding of how much plastic humans are regularly putting into their bodies and its effects.

Yan says they plan future research employing the same technology to look at plastic particles in tap water, in the air, in food and in human tissues. "This is basically just to open a new window for us to see [what was] this invisible world before." Humans produce more than 440 million tons of plastic each year, according to the United Nations. About 80% of plastic ends up in landfills or the environment, researchers say.



Bewitching Charcuterie Board on a Budget

It's a continuing hot trend in easy holiday entertaining -- charcuterie boards overflowing with wonderful nibbly-noshy goodies. A charcuterie (shahr-KU-tuh-ree) board is essentially a lavish meat, cheese and cracker board. While it's easy to drop a bucket of cash going "overboard" with this entertaining trend, you can create an Instagram-worthy board and still have money for rent. Here are some rules for success.

Rule 1 -- There are no rules. Put whatever you like on your board.

Rule 2 -- Don't go crazy! As tempting as it is; you don't need 25 different items on your board. It's better to



have a generous quantity of affordable items than tiny portions of high-priced offerings.

Rule 3 -- Spend wisely. Be conservative with costly items like meats and cheeses and liberal with low-cost items like bread and fruit. For a hearty appetizer, plan on 2 ounces of meat and 3 ounces of cheese per person.

Rule 4 -- Shop your pantry first and use up all the little bits of dried fruits and nuts left from baking projects. Look for jars of pickles, peppers, mustards and jams in the back of the fridge.

Here are three secret weapons for frightfully frugal and fabulous entertaining.

MUSHROOM skulls

Here's a ghoulishly great addition to your Halloween board.

8 ounces button mushroom for skulls, see directions below

2 tablespoons butter

1 tablespoon olive oil

1/4 cup shallots or red onion, thinly sliced

2 cloves garlic, sliced thin

Salt and pepper

To make mushroom skulls: Clean your mushrooms. To create two skull faces on opposite sides of each mushroom, use a straw to form the eye holes. Use a paring knife to cut nose holes and to slice down the stem to create teeth. Cut mushroom in half, creating two skull halves.

To saute the mushrooms: In a saute pan, heat butter and oil. Add shallot and garlic, and cook until fragrant.

Add the mushrooms, gently tossing to coat with the oil. Sautž the mushrooms until warmed through and softened. Season to taste with salt and pepper. Serve with any accumulated juices: warm, room temperature or cold.

BEER CHEESE BALL

Yield: 16 servings Prep: 15 minutes Rest: 8 hours or overnight

This makes one ratherlarge cheeseball, so I suggest dividing it into two.

16 ounces sharp cheddar cheese, cut into 1/2-inch cubes

4 ounces cream cheese services cheese services tablespoon Worcestershire sauce

1 small garlic clove, finely



minced

1/4 teaspoon kosher salt

2/3 cup lager beer, nonalcoholic beer, cider or white wine

- 1. Place cheese in a food processor; pulse until crumbled, about 1 minute. This creates a better texture than shredding.
- 2. Add cream cheese, Worcestershire, garlic and salt. While continuing to process, gradually add beer until mixture is smooth and spreadable.
- 3. To make a pumpkin shape; double wrap the cheeseball in plastic wrap and form into a round. Take four rubber bands and space them evenly around the ball to make impressions like a pumpkin. Refrigerate until firm. For a stem, press a bell pepper stem into the top.

ONION JAM

1 large onion -- any variety

1 tablespoon butter

1/4 cup balsamic vinegar

2 tablespoons brown sugar

- 1. Thinly slice the onion. In a large skillet on low heat, warm the butter and add onions. Cook, stirring occasionally for 20 to 25 minutes or until very soft and translucent.
- 2. Add the balsamic vinegar and brown sugar, stirring to combine. Reduce heat to very low and simmer for 15 minutes or until most of the liquid has evaporated.

TOURISM RUINED MY CITY. TOURISM IS SAVING MY CITY

SEVILLE, Spain — There was an old house in a very narrow street in central Seville, Spain that I used to stop and look at when I was a teenager in the early '90s. I dreamt of owning it one day, or at least one similar in the neighborhood that back then had a decent number of locals.

I say "back then" because today that area, Barrio de Santa Cruz, has lost its soul. It's not me saying this — it's what you hear from nearly anyone who lives or works in the neighborhood. Many longtime residents have left, saying they were pushed by a wave of tourism that, after the pandemic, has come back in full force. It's good news for the city and its economy. But it's mixed news for nearly anyone whose memories are attached to those narrow streets, now filled with souvenir shops, boutique hotels and restaurants that locals don't quite feel welcome in anymore.

This is the story of how a city tries to honor its past while ensuring its future.

STUDENTS REPLACED BY SELFIES

In the heart of Barrio de Santa Cruz you can still find a public school. It almost seems like a relic of a different time, when this neighborhood had not turned into a museum of sorts.

Ana Palacio is the principal of the San Isidoro school. She joined seven years ago, when admission for students was competitive. "When we'd start receiving applications for admission, people would camp out at the door and spend the night to grab a spot for their kids," she tells me.

Now, she has open spots in her classrooms, and the reason is simple. Palacio looks up and points at the beautiful old houses in front of the school, on Mateos Gago street. "All those houses, where families used to live and send their kids to our school - all those houses are now apartments for tourists," she says.

For Palacio, this is not just a small inconvenience.

"I have real issues here. When kids enter and exit the school, I have a crowd of tourists at the door," she says. "Since the school building is a beautiful old convent, tourists want to take pictures and shoot videos."

The tourism boom is causing an exodus of sorts. Locals have been leaving the historic center for other neighborhoods, which has then driven up rents across the city. Palacio gets emotional when talking about how Seville is changing.

"We have the largest historic city center in Europe. Let's not ruin it," she says. "If there are no neighbors that care for it personally - neighbors who hurt when they see that tree not being respected, when they see a glass bottle thrown on the ground - we need those neighbors, and we're losing them."

This change isn't confined to the city center. Palacio lives in Triana, a neighborhood overlooking the Guadalquivir river, which has also become a tourist attraction in recent years.

She says it's affecting the way locals enjoy the city, and that in areas where tourists flock, locals sometimes don't even feel welcome at tapas bars and restaurants. "In Seville, you order the first beer at the bar. Then you sit down and chat with your friends. Then maybe you order a tapa. And after a while,

you order another one. And before you realize it, it's 5 or 6 in the evening," she says. That would be the Sevillian way. But many restaurants are no longer locally owned, or simply prefer to cater to tourists, who sit for an hour, order fast and copiously, and then move on. These days it's not unusual to see restaurants that don't serve tapas anymore and won't let you sit at a table if you're not ready to order a meal.

THERE ARE THOSE WHO BENEFIT

There are some restaurants, however, that are still locally owned, and try to maintain a balance between benefitting from the tourism boom and serving local customers.

On Mateos Gago street, just a short walk from the San Isidoro school, I stand in front of a small restaurant called La Azotea. I know this place well; it used to be called Campanario more than two decades ago. I worked here when I was in my early twenties. I meet Juan Antonio Gómez, the chef and owner of La Azotea, outside of his restaurant, where the view from the tables is simply astonishing. The tower of the cathedral of Seville, La Giralda, is the most iconic monument of the city. If you come to Seville, chances are you will walk down this street and visit it. When Gómez opened his first location, his clients were mostly locals.

"But soon — as in, like, three months — we start to receive our first tourist. And a year later, we have, every day, lines at the door at the opening time for 30 people, mostly tourists," Gómez says. His story reinforces a truth now widely known in Seville: if a restaurant is good, tourists will find it.

Gómez says he wishes he could see more locals around Mateos Gago street — an area he has known since he was a child attending the same San Isidoro School that is now struggling to find students. Tourism is an engine of the Spanish economy. In 2022, it represented more than 11% of the national GDP. It's even more acute in Seville, where tourism provides an estimated 20% of the city's economy. This southern region of Spain where Seville is located has long been mired by unemployment as well, which currently sits at just over 18% — about 5 points above the national average. So you can appreciate how jobs in the service sector provide a lifeline for the city that welcomed nearly 2 million visitors in just the first eight months of 2023 — up 14% from the previous year.

Gómez benefits from this tourism boom, obviously, but he has mixed feelings: "What I'm seeing right now in Seville I've never seen before. It's massive. And I think, in one way or another, we have to stop a little bit."

THE YEAR EVERYTHING CHANGED

Sevillians point to 1992 as transformative for the city. It was the year Seville hosted the International Expo, which became a presentation party of sorts, celebrating the 500th anniversary of Christopher Columbus' arrival in the Americas. Seville was pitching itself to the world as a place of beauty and historic landmarks. Hundreds of acres of unutilized land was transformed into a type of international theme park, with more than 100 nations represented in pavilions. Tens of millions of people visited Seville that year. Billions of dollars were invested in the city: bridges were built over the Guadalquivir River; dozens of new hotels were opened; a high-speed train connecting Madrid and Seville was inaugurated; and the city looked at the historic center as its crown jewel. A jewel that needed urgent care.

Miguel López was 10 years old then, and lived in the neighborhood of Alameda - a huge open space now filled with restaurants. Like the city center back then, his neighborhood was falling apart, he tells me, with many houses needing drastic rehabilitation. Crime was common in central areas, and it wasn't unusual to turn to a street and find yourself alone and vulnerable to theft or worse. Before the wave of expo investment, the region of Andalucía had a staggering 30% unemployment rate, which skyrocketed to more than 50% for young people. López was enamored with the expo as a child, with all its promise of change and progress, and visited the site many times that year. On his way home, he would have to cross the Alameda, an area that was known for drugs, crime and sex workers back then.

Meeting of CARICOM Heads discusses situation in Haiti



The Seventh Meeting of the Caribbean Community Lead Heads of Government on Haiti was held today under the chairmanship of His Excellency Dr Mohamed Irfaan Ali, President of the Co-operative Republic of Guyana and Chairman of CARICOM, to consider the situation in Haiti and determine further action in support of a Haitian-led solution to the crisis in that sister CARICOM country.

Heads received a briefing from the CARICOM Eminent Persons Group and acknowledged the important efforts being made to facilitate a political consensus among stakeholders in Haiti. They also took account of the status of preparations for the Multinational Security Support (MSS) Mission. Heads acknowledged the role of Jamaica in coordinating the efforts of the Community in this regard, as well as the critical contributions of Ministers of Foreign Affairs.

Heads remained gravely concerned over the deteriorating security and humanitarian situation in Haiti as the political and security crises persist with the horrendous impacts of this situation on the most vulnerable in Haiti.

They noted that increasing violence had resulted in the loss of thousands of lives and forced hundreds of thousands to flee from their homes.

Heads called on all stakeholders in Haiti to exert every effort to urgently arrive at a political resolution and the implementation of a transitional roadmap towards stability, facilitation of humanitarian support, the holding credible elections, the restoration of political and institutional legitimacy, and long-term development for the Haitian people.

The Community remains committed to working with the people and all in stakeholders Haiti towards durable peace and sustainable development. CARICOM looks forward to strengthened collaboration and coordination of efforts with the friends of Haiti and the wider international community in support of Haiti.

JAMAICA INSTALLING NEW KIOSKS AT TWO OF ITS AIRPORTS

Passport Control Systems to Streamline Passenger Flow

MONTEGO BAY, JAMAICA, January 10, 2024 – As part of upgrades being made to the island's airports, Jamaica's Passport, Immigration & Citizenship Agency (PICA) is installing and testing new kiosks at Montego Bay's Sangster International Airport and Kingston's Norman Manley International Airport. These kiosks are automated passport control systems to streamline passenger flow.

"We are very pleased that PICA is installing kiosks at our premier airports in Montego Bay and Kingston, as they will provide additional convenience for stopover visitors by speeding up processing times through the immigration halls," said the Hon. Edmund Bartlett, Minister of Tourism, Jamaica. "This will provide a more seamless airport experience as we progress through our peak winter season, during which we expect to welcome record-breaking arrivals."

The kiosks, which are a feature at many airports worldwide, use biometric technology to authenticate the identity of passengers. They scan the passenger's passport and take a photo of the passenger's face, which is then compared to the digital image stored in the passport's microchip. These kiosks will serve as an alternative to using desks staffed by immigration officers, thereby allowing passengers to move through passport control more quickly. In addition, they free up immigration officers to concentrate on more critical border security duties.

"The installation of automated kiosks for passport control at our airports is an excellent use of modern technology to improve the overall passenger experience at Jamaica's airports, which is important as we continue to grow arrivals to the destination," said Donovan White, Director of Tourism, Jamaica Tourist Board. "Visitors' first impressions of Jamaica's overall tourism product take place upon landing, so we are glad to soon be able to enhance them."

It is anticipated that airline passengers will have access to as many as 100 immigration kiosks before the end of the year.

China, Finland Held 'Constructive' Talks on Damaged Gas Pipeline

vessel, Helsinki said.

They said findings suggested it belonged to the Chinese cargo ship Newnew Polar Bear.

"The presidents noted the-constructive dialogue between the countries regarding the Balticconnector pipeline incident," a statement from the Finnish presidency said. A Chinese statement about the presidents' video-link meeting made no mention of talks on the damaged pipeline.

Finnish officials said in late October that China was cooperating in its investigation.

The incident came just over a year after underwater explosions struck three of four Nord Stream gas pipelines in the Baltic Sea, cutting off a major supply route to Europe from Russia at a time of heightened tensions between Moscow and the West over the war in

Ukraine.


The cause of that sabotage remains unknown.

The Finnish operator of Balticconnector said in October it would take at least five months to repair the pipeline, leaving Finland dependent on liquefied natural gas imports for the winter.

Natural gas accounts for around five percent of Finland's energy consumption, being mainly used in industry and combined heat and power production.

In the Finnish statement, Niinisto, whose country joined NATO last year, said he had also raised the issue of the war in Ukraine in his talks with Xi and "stressed the role of China in achieving a just and lasting peace."

In a summary of the meeting on Chinese state television CCTV, Xi said the Asian nation was "firmly pursuing an independent foreign policy of peace." US, China Conclude Military Talks in Washington

WASHINGTON — The United States and China wrapped up two days of military talks in Washington Tuesday, the Pentagon said, the latest engagement since the two countries agreed to resume military-to-military ties.

Washington and Beijing are at loggerheads over everything from the future of democratically ruled Taiwan to territorial claims in the South China Sea. Ties are still recovering after the U.S. downed an alleged Chinese spy balloon in February.

U.S. President Joe Biden and Chinese President Xi Jinping agreed late last year to resume military ties, severed by Beijing after a visit in August 2022 by then-House of Representatives Speaker Nancy Pelosi to Taiwan.

The 17th round of the talks saw Michael Chase, the deputy assistant secretary of defense for China, Taiwan, and Mongolia, meet China's Major General Song Yanchao, deputy director of the central military commission office for international military co-operation, the Pentagon said.

"The two sides discussed U.S.-PRC defense relations, and Chase highlighted the importance of maintaining open lines of military-to-military communication in order to prevent competition from veering into conflict," the statement added, using an acronym for the People's Republic of China. Pentagon officials say communication between the two militaries is key to preventing a miscalculation from spiraling into conflict.

The top U.S. military officer, General Charles Q. Brown, the chairman of the Joint Chiefs of Staff held a virtual meeting last month with his Chinese counterpart, General Liu Zhenli.

China is willing to develop healthy and stable military-to-military relations with the U.S. "on the basis of equality and respect," its defense ministry said in a statement Wednesday, citing the meeting.

It urged the U.S. to cut military deployment and "provocative actions" in the South China Sea, as well halt support for such actions by "certain countries," but did not identify them.

It asked the U.S. to abide by the one-China principle and stop arming Taiwan, which China claims as its own territory, despite Taiwan's strong objections, and vowed never to compromise on the issue.

"The United States should fully understand the root causes of the maritime and air security issues, strictly restrain its front-line forces, and stop hyping up (the issues)," it added.

Taiwan is holding presidential and parliamentary polls this weekend amid a ramped-up war of words between Taiwan and China.

U.S. officials have cautioned that even with some restoration of military communications, forging truly functional dialog between the two sides could take time.

Lynch said it was a good day and he felt good about it and can work on improving the time. "I'm looking forward to staying healthy, staying focused as I always tell people to do, listening to your coach and being true to the game," he told Island Sun Sports. "My 800m goal is to shoot for a World Jr. Championship qualifying time (1:51.00). My preparations have been going well. I'm feeling my body getting stronger and stronger and with the work I'm putting in, I should be able to get there."

He added: "Last year taught me that as much as you want it, there's always somebody that wants it more."

U17 Girls Shot Putters Makeda

Christopher and Romeena Davis are finding their footing in the technical event, they're fairly new to. Christopher switched her style of throwing.

"I used to do the glide, now that I'm doing the spin I'm seeing a little improvement," she said. "But more needs to go into the work. I need more practices, more training so that I can get my form right."

On her final throw after a 10.26m heave, Christopher, who had a faulty release because her right hand was in a throwing motion, explained that her hand needed to be going slightly down and to the side. She said the progress she made last year wasn't bad but expects more this year.

"Today I was hoping for an 11 or 12m throw," she said. "I have to correct my form. My leg form my technique, my arms and my legs."

Davis, who threw 10.11m, said it wasn't a good competition for her and felt she could have done better. "Last year, I did better and I know that I can throw further," she said. "Today I had problems with my form—in the front part (of the circle) and my hand. Last year, It wasn't like that. Last year, I was slower in the front and now I'm too quick in the front and I need to slow down some more."

In the off season, she said that she had been working on her technique

which has improved quite a lot since last year. "I wasn't satisfied with my throws today," she said. "I will be looking for something about 11-12m."

Davis, who is now in the third year of her event, said that her aim is to qualify for the Carifta Games in Grenada, over the Easter Weekend. Their Coach and former national Shot Put record holder, Raphael "Booker" Jack, told Island Sun Sports that he has been working with Davis and Christopher for the last two years. He said that they have improved. Christopher has slimmed down and is now looking like a Shot Putter.

"These girls are going to be alright. They're working hard, but it's getting the technique right now as they've just started. They've only been out for two years. If they were in it for 3-4 years, they would have been more technical,' Jack explained. "We've been doing a lot of exercises for release, where you're pounding the ball into the ground, you're throwing other things. But these girls are young coming up in the sport so they're going to be making mistakes from time to time. But as they progress, I know that they will be good because you can see their technique is coming, from the things I have been putting in in training.

Jack said he was expecting throws over 12m from both girls, but things didn't work out as planned, so they'll have to return to the drawing board.

"I've been seeing some high 13s from them but I don't really have them throwing the lighter competition implement (3kg), they throw the heavier ball (4kg) in practice," he noted. "When you see they're throwing high 10s and 11s with the heavier ball, it's equivalent to a 14m throw (with the lighter ball). There were just mistakes with the put and we'll have to correct all of that. These girls were on Christmas holidays vacation, so it's just to come back in now and get their groove in. I guarantee that by the next two meets, we'll be at 12, 13m."

L.A. Lakers waive D'Moi Hodge after playing seven NBA games


Draft, and played collegiately at Florida, was also waived.

RALPH GONSALVES EXPLAINS HIMSELF ON GUYANA VENEZUELA MAP

The New Year broke over Guyana with

Guyanese everywhere deeply worried about the intentions of the Nicolas Maduro government in Venezuela which, through various communiques and public statements and action, appeared to be gearing up to seize the Essequibo region of Guyana.

A meeting, on December 14, 2023,

in which Maduro and Guyana's President, Irfaan Ali, participated in St Vincent, under the auspices of the Prime Minister of that country, Dr. Ralph Gonsalves, eased fears of an imminent Venezuelan invasion, but it did not quell the sense of deep disquiet among the Guyanese people.

Into this scenario of anxiety and uncertainty, on Wednesday, January 3, a Venezuelan group posted a photograph on Facebook which was rapidly shared on social media networks. The photograph prompted swift condemnation of Prime Minister Gonsalves from many Guyanese. The picture showed the Prime Minister and his Foreign Minister, Keisal Peters, standing at the two ends of a line with two Venezuelans, who were holding, for the camera in front of them, a papier-mâché map of Venezuela which depicted Essequibo as Venezuelan territory. Behind Gonsalves was a statue of Simon Bolivar.

The photograph was described by the Venezuelans, who posted it, as "Very emblematic image of the PM of Saint Vincent and the Grenadines, paying homage to the liberator Simon Bolivar with a map of Venezuela that includes our Essequibo". As happens when emotions are high and anxiety pervasive, none of those who commented on the Facebook post, checked either the age of the photograph or the circumstances in which it was taken.

There appeared to be a general assumption that the photograph was taken after the St Vincent meeting of December 14, which issued "The Joint Declaration of Argyle for Dialogue and Peace between Guyana and Venezuela". In this connection, the comments on Facebook and on social media accused Gonsalves of acting in support of the Venezuelans by appearing in the company of Venezuelans with a map, showing Essequibo

as part of Venezuela.

I was never persuaded that the Facebook post and the image it offered of Gonsalves, seeming to endorse Essequibo as a part of Venezuela, represented the truth of the situation. I immediately posted on the Facebook page, the following observation: "I

have known and highly regarded Dr Ralph Gonsalves for over 40 years. I cannot be convinced that, when he stood behind the artwork map, showing the Essequibo incorporated into Venezuela, he was made aware of the image being displayed. The Ralph Gonsalves, I know and respect, would not consciously do such a one-

sided thing while the world awaits a decision on the Guyana-Venezuela controversy from the International Court of Justice, and while he, himself, is playing the role of CELAC's honest broker".

In order to write this commentary, I called Dr Gonsalves to learn his side of this story. He told me what he subsequently included in a letter to Presidents Ali and Maduro, concerning this incident. He explained that he was not aware of the photograph but confirmed that it was taken at a ceremony commemorating Bolivar in St Vincent on the grounds of the Venezuelan Embassy in December 2022.

He went on to say in his letter, as he had told me: "While the photographs were being taken, I am advised that someone attached to the Venezuelan Embassy placed the "papier-mâché" depiction of the said map in front of us. I did not look at what the depiction was. I assumed that it was about Simon Bolivar."

As all leaders know - politicians and otherwise - persons take photographs in which they appear but have little knowledge of anything or anyone that is not within their vision. Gonsalves was behind the map, and photographs are taken within seconds. That situation could have happened to anyone, and indeed, they frequently do.

He described the incident as "an innocent inadvertence on his part" and he regarded it as "unfortunate" that it "has been used by some to drum up, unnecessarily, antipathy of one kind or another". He also understood "all the emotions attendant on this controversial issue"; and recognized that, as happened on this occasion, "from time to time there will be flare-ups".

Gonsalves then said to both Ali and Maduro, "we as leaders must maintain a patience and a calm knowing that sun brightens stone, Island Sun

even as the river burns". For those who do not recognize those words, they are taken from one of the iconic poems of Guyana's Poet Laureate, the late Martin Carter, "Death of a Slave". Dr. Gonsalves went on to urge that "about this matter of the papier-mâché depiction, hopefully it has been laid to rest, where it ought properly to reside among the assorted ghosts from the past, which ought never to rule us from the grave". None should forget that in the long months of 2020 as Guyana's democracy was being sorely tested and the free will of the people, as expressed at the ballot box, was being jeopardised, Ralph Gonsalves stood in solidarity with all the people of Guyana, seeking peace, stability and democratic rights. Like every man, Ralph Gonsalves, is not infallible but one thing is for certain, he is a Caribbean man and, he cares deeply about our one Caribbean region. Undoubtedly, he has a friendship with Maduro, and he is seeking, as best he can, to promote acceptance of a lasting solution to the Guyana-Venezuela controversy. That is Ralph Gonsalves' nature. But he is no enemy of Guyana's, and none should wrongly try to make him so.

He has explained himself fully and satisfactorily. As he has asked, the matter should be laid to rest.

Of the greatest importance now is that Guyana and its CARICOM partners must move forward, focusing on the legal and diplomatic efforts necessary to end the Venezuela controversy.




