#### PUBLIC SERVICE PENSION COMMITMENT IS BALLOONING

public pension dilemma-recently lamented by Opposition Leader Hon. Ronnie Skelton during the budget debate is about to become more dire based on information contained in the Standing

Finance Committee report distributed to the media last week.

Over the years various calls have been made to find an alternative to the current pension expense that is borne by the public purse. In fact, the situation which has been lamented in the House of Assembly for almost two decades has been referred to as an albatross around central government's neck.

In the Standing Finance Committee report, which captured the deliberations for the 2024 budget estimates it was revealed that the time is nearing for the format of the pension to be changed from non-contributory to contributory.

Such points were made by Sharleen Dabreo-Lettsome-Permanent Secretary, - Deputy Governor's-Office (PSDGO) during her appearance before the SFC. According to the report, Dabreo-Lettsome informed-legislators that in 2024 the pension disboursement-rose further.-She-stated, "Currently, the amount for pensions and gratuity is \$4.7 million of noncontributory-pension. There is a need for a contributory pension scheme. Over 100 officers are slated for retirement this year, which will add another \$1.8 million to the pension cost."

#### **OPPOSITION CONCERN**

Opposition Leader Hon. Skelton cautioned the Government about the current public service pension commitment which he noted ballooning and becoming unsustainable.

While raising the matter during the budget debate Hon. Skelton told the House of Assembly that firm action is needed to remedy the situation. The Leader of the Opposition "Madam announced: Speaker the pension liability of the government needs attention."

While further lamenting the current situation Hon. Skelton said: "It cannot continue to the way it's going. We can't sustain it, and those of us who have gone before and benefited from it are at risk, because eventually...! Although the law says that pension has the first call on the Consolidated Fund - that doesn't mean that you

must be absent-minded and not do what needs to be done to correct that situation."

#### OLD OPTIONS ON THE TABLE

In 2022 it was announced that the Government is finally taking action to minimize the cost associated with the current full funded public pension. Ministry of Finance was said to be working on a Comprehensive Pension Plan to reform the pension system. In fact, it was stated that on 14 February, 2022 an initial meeting was held to discuss a way forward with this initiative.

At that time it was explained that the migrating to a contributory scheme was the preferred solution and would ease the current burden. The public was told that the goal was to make a contributory pension scheme, thereby removing the contingent liability from the Government and allowing for a system that would have greater flexibility for public officers on their retirement options.

### CARVIN MALONE HAS PASSED AWAY

Former Minister for Health and Social Development and former President of the ruling Virgin Islands Party (VIP), Carvin Malone, has passed away at 64 years of age. Around 2:00 AM on 14 January, it was reported that Mr. Malone found unresponsive was immediately rushed to the Dr. D. Olando Smith Hospital where it is believed he suffered a brain aneurysm. Sadly, the former legislator succumbed while in the hospital's Intensive Care Unit.Mr. Malone held the position of Minister for Health and Social Development from 2019 to 2022, a challenging period during the global Covid-19 pandemic. He was not only a VIP member but also served as its long-standing President before entering elective office. Although he was defeated in the 2023 General Elections in his bid for a second term, Mr. Malone remained actively engaged in educating the public on various topical issues through his 'One Virgin Islands Agenda' platform.

Premier and Minister of Finance Dr. the Hon. Natalio Wheatley expressed his condolences to the former legislator's family, stating: "On behalf of the Government and people of the Virgin Islands, myself and family, I express my profound sadness on the passing of our dear and

beloved brother, Carvin Malone, who passed on Sunday morning, 14 January, and I extend condolences to his wife Pernis; his siblings, Jane, Meade, Guy, and Keith; his daughter, Kirsten, and his extended family." Hon. - Wheatley acknowledged that Mr. Malone's passing had left an indelible mark on the Virgin Islands. "Carvin Malone was a champion for the Virgin Islands, and his sudden passing was shocking and heart-wrenching. While we mourn his loss, we remember him for the sterling traits he possessed. Carvin Malone lived a life of dedicated service to his community. He was a proud and dedicated member of the Lion's Club of Tortola, having served as its President on several occasions. He was also a former president of the BVI Chamber of Commerce and Hotel Association and served as Vice President of the BVI Amateur Basketball Association. Wherever he had the opportunity to serve, he took it," noted the

Premier.

Speaker of The House Of Assembly, Hon. Corine George-Massicote, also offered her condolences to Mr. Malone's family, saying, "It is with profound sorrow and a heavy heart that I extend my deepest condolences, on behalf of Members and Staff of the House of Assembly, on the recent passing of Former Legislator Carvin Malone." Hon. George-Massicote emphasized that Mr. Malone's contributions Territory were to the immeasurable, leaving an indelible mark on both the legislative landscape and the hearts of those he served. "As the Minister for Health and Social Development, he demonstrated unwavering commitment, particularly during the height of the Covid-19 pandemic. His leadership and resilience in the face of this unprecedented crisis were instrumental in steering our community through challenging times," the Speaker said.

"In addition to his role as Minister, Mr. Malone served briefly in the opposition, showcasing his commitment to the democratic ideals that underpin our parliamentary system and our journey to self-determination. His willingness to bridge divides and work collaboratively for the greater good exemplified his statesmanship," she added.

#### GOVERNOR RANKIN HAS NO DOUBLE STANDARDS: COP TO BE INVESTIGATED

"His Excellency Governor Rankin is facing allegations of double standards in the wake of the announcement that Commissioner of the Royal Virgin Islands Police Force (RVIPF), Mark Collins, will not be placed on administrative leave. Amid growing public regarding concern decision, Governor Rankin revealed that Kurt Walton, the Police Commissioner of the Royal Cayman Islands Police Service, has been appointed to investigate the numerous complaints against Commissioner Collins."

The Governor made this disclosure during a JTV interview on 16 January. While discussing Walton's appointment, he mentioned that the former Cayman Islands Chief of Police (COP) had been provided with Terms of Reference to investigate any aspect of the petition.

This petition, signed by approximately 30 RVIPF officers, demanded the removal of Commissioner Collins, citing 55 damning allegations against him. In their 11-page petition addressed to the Governor, these officers not only called for his removal but also urged independent investigations into allegations of misconduct in Public Office and abuse of office.

Premier Hon. Natalio Wheatley publicly stated his belief that Commissioner Collins should be placed on administrative leave, similar to other public servants under investigation, without any special treatment.

Nevertheless, Commissioner Collins continues to hold his position and Governor Rankin sought to reassure the public that there is no double standard. During his JTV appearance, he stated: 'When an allegation is made, you don't simply suspend a public officer based on an allegation. Instead, an investigation is conducted, and if the evidence supports the belief that a disciplinary offense may have occurred, necessitating a disciplinary investigation, the officer is placed on administrative leave. Therefore, it differs from the situation with the Police Commissioner.'

Regarding Walton's appointment, the Governor explained that the former Cayman Islands COP will 'examine the evidence as he deems appropriate, pursue the evidence as he sees fit, and then produce findings. If these findings suggest that an offense may have been committed or that disciplinary action may be necessary, the Governor will then decide whether to place the COP Collins on administrative leave. This is a fair approach, and I intend to treat the Police Commissioner just as I have treated other public officers.'

Governor Rankin also clarified that he has not set a timeframe for Mr. Walton to complete his review and has given him 'full autonomy' in the matter. He expressed his hope that the process would be efficient and swift, with a commitment to fairness for all parties involved."

# HON. DAME J. M. PEREIRA TO RETIRE FROM EASTERN CARIBBEAN SUPREME COURT

"Chief Justice Hon Dame Janice M. Pereira delivered her final address in her capacity as Chief Justice during a Special Sitting marking the commencement of the Law Year for the Eastern Caribbean Supreme Court. This significant event, held under the theme 'Innovation & Justice Reform, looking to the future,' was broadcast live from the Radisson Grenada Beach Resort on 12 January.

With heartfelt words, she expressed: "It is with no less humility, pleasure, or honor than I had on each of those occasions that I address you now for the ceremonial opening of the Law Year 2024, my final address to you as your Chief Justice."

Born in the BVI, Hon Dame Janice M. Pereira, DBE, made history by becoming the first female Chief Justice of the Eastern Caribbean Supreme Court on 24 October, 2012. Her journey within the Court began in 2003 as a High Court Judge, and in 2009, she ascended to the position of Justice of Appeal. In May 2013, she received the Dame Commander of the Order of the British Empire from Her Majesty, Queen Elizabeth II.

She extended warm New Year wishes, stating: "I am heartened to have yet another opportunity to welcome each and every one of you to our customary special sitting and to wish you all a happy New Year filled with promise and hope that God will bestow His richest blessings, wisdom, and guidance upon us all, and upon all the Member States and territories." Chief Justice Pereira also acknowledged the impact of the COVID-19 pandemic, which

necessitated previous virtual openings of the Law Year and the continued reliance on technology for broadcasting. She highlighted the Court's commitment to innovation, saying: "These innovative tools and platforms enable us to reach as many people as possible from various locations. Since its inception, the Eastern Caribbean Supreme Court has remained on a steady path of improving its role in the administration of justice. Collectively, we have persevered through numerous challenges, adapting where necessary and reimagining where possible."



#### Triple Jack To Compete In Caribbean 600 After Hurricane Irma Destruction



Onboard-Triple-Jack

Tortola, British Virgin Islands, January 17, 2023 - Triple Jack, the 44-year old Derek Kelsall designed one-off trimaran, will be making her ocean racing return in the Caribbean 600 on February 19 after a 39-year hiatus since the Ostar in 1984.

Triple Jack was a fixture on the Caribbean racing circuit ever since she was sailed to the Caribbean by Richard Wooldridge and Steve Davis in 1997. However, since September 6, 2017, she has been undergoing a major rebuild and remodel after Hurricane Irma left her upside down on a bridge, rigging lost, coach roof crushed, hatches ripped off, and sponsons hanging on by a thread.

"The aftermath of Hurricane Irma was not a pretty sight" said Richard. "Triple Jack's 'lucky break' was to be somehow somersaulted out of the water and up on to a concrete bridge that connects Nanny Cay to the outer peninsula. Earlier her storm lines tore through her front beams allowing her to cartwheel across the new marina breaking the mast in four places as she went."

In a five-year labour of love at Nanny Cay Marina, thousands of manhours have been spent chopping, grinding, filling, fibreglassing, epoxying, fairing, and painting.

The crew will be the first corinthian team from the Virgin Islands to enter this race in its 15-year history and they aim to make their mark. Triple Jack will also be competing in the Caribbean Multihull Challenge starting February 1.

Triple Jack reappeared at last year's BVI Spring Regatta for her first shakedown event and the windy conditions proved the repairs are sound. The Caribbean 600 is a RORC race with World Sailing Category 2/3

requirements that include an engine, liferaft, AIS and a kitchen sink - all have been added to ensure Triple Jack's compliance.

For Steve and Richard it is now payback time. No stone has been left unturned and the final touches are now being made to get her ready for ocean racing once more. "She was built for offshore racing and it's time to get back out there," Richard concluded.

# GLOBAL NEWS BRIEF

USA - The National Book Award-winning novel was born in a box full of books. Justin Torres, the author of Blackouts, was working at Modern Times, a defunct San Francisco bookstore, when he had to unpack a donation. "It seemed like they were the books of someone who had recently died. Almost all of them were novels, and then this random sexology book, this medical text that simply blew my mind," says Torres, who will read a fragment of his work this Thursday at a free event at the Hammer Museum in Los Angeles. That document was Sex Variants, a study published in 1941 in which researchers George Henry and Jan Gay published one of the first treatises on queer identity in the United States and several years before the famous reports by Alfred Kinsey saw the light

The discovery made Torres, a 44-year-old queer writer born in New York, wonder about the mysterious reader, whose collection included this research done on 40 men and 40 women that began in 1935 and that must have been very sought after, as it was barely available even to members of the medical community. "It was fascinating to come across this and meet people who willingly exposed

everything about themselves, their sex lives, their bodies. Their desire was to change the narrative that existed around queerness, although some of them wanted to be cured," says Torres. Sex Variants was an empirical test of the clinical history and criminalization to which part of the LGBTQ+community has been subjected.

This is how Juan, one of the characters in Blackouts, was born. He is an old man withering away inside a nursing home in an unnamed desert city. His life takes place between memories, which are brought to the present by an anonymous narrator who has shown up at the scene to try to question Juan about the two mysterious volumes that rest on an old radiator. They are two volumes of Sex Variants that have been censored with many parts blacked out, which gives the book one of the meanings of its title. Torres' prose is charged with erotic energy and permanent sexual tension. This is a stance on the peaceful times that exist, where sexual joy is a repressed pleasure. "I want to see more depictions of sex. And especially sex that isn't safe or sanctioned, or doesn't have that stamp of approval by the would be censors, whether they're coming from the right or the left. I hope the next generation realizes how strange these times have been and brings back free love," the author, who is not afraid of controversy, says laughing.

The book won the 2023 National Book Award at a particularly conservative time in the United States. Although Torres has always moved through the liberal poles of the country, the American media is full of news about censorship of literary works and authorities trying to legislate the bodies of women and trans people. Torres received his award in a ceremony in which a great political moment took place. The winners read a joint message about the war between Israel and Hamas, which has left thousands of innocent victims inside the Gaza Strip. "I think it was very balanced. And if I had said something on my own, I think I would have focused much more on the disparity of violence. I would have focused much more on the long history of Israeli occupation. And I think I would have said something perhaps more controversial," he says. The National Book Award jury has highlighted the "aesthetic complexity, multiplicity, and beauty" of the images created by Torres. [El Pais]

BARBADOS - For the ninth straight year, Barbados again holds the title of the most powerful passport in the Caribbean region, according to a recent report. According to the 2024 Henley Passport Index ranking, released by London-

based global citizenship and residence advisory firm Henley & Partners, Barbados is number one in the Caribbean and is positioned globally at number 22 with visa-free access to 165 countries.

Rounding out the top 5 most powerful Caribbean passports are The Bahamas, St Kitts and Nevis/St Vincent and the Grenadines (tied at No. 3), Antigua and Barbuda, and Trinidad and Tobago. [CNW]


EUROPE - France, Germany, Italy, Japan, Spain, and Singapore have all secured the prestigious position of possessing the most powerful passport globally in 2024. These nations grant their passport holders visa-free access to an impressive 194 destinations.

On the flip side, Afghanistan holds the distinction of having the least powerful passport in the world. Ranked at number 104, it provides visa-free access to a modest 28 destinations. [CNW]

LEPROSY - Health officials in Barbados have reassured the public not to panic following the confirmation of a leprosy case on the island. Deputy Chief Medical Officer Dr. Arthur Phillips, in an update with Barbados Today, informed that the affected individual currently undergoing treatment, with just a month or two left in their regimen. Dr. Phillips highlighted that this is an isolated case, and the situation is under control. [CNW]

SANTO DOMINGO - The Dominican Republic is the top tourist destination in the Caribbean, according to TripAdvisor's list of "Best of the Best 2024 in the Caribbean" winners. In the same order, the Dominican Republic is followed by Cuba, Aruba, Puerto Rico, Jamaica, St. Martin, Grand Cayman, Providenciales, St. Lucia, and Curacao. The publication points out that the Dominican Republic is located in the same waters that bathe Cuba and Puerto Rico, occupying the eastern twothirds of the island it shares with Haiti.

**BERMUDA** - The population of Bermuda has dropped to a 20-year low, according to 2022 estimates. The decline in numbers has been attributed to another drop in the birthrate, which fell to a record low in 2022. According to the Department of Statistics, the population at the end of 2022 stood at 63,542, down by 106 from 2021. The population has now declined for five consecutive years and is at its lowest since 2003, when it stood at 63,525. The number of deaths has exceeded births for the fifth consecutive year. There were 479 births in 2022 - another record low - compared with 585 deaths. Birthrates have been in fairly constant decline in the past ten years, while the number of deaths has steadily increased each year. In 2013, there were 648 births against 471 deaths. Of the 479 births on the island in 2022, only seven were to mothers under the age of 20.

The vast majority — 412, or 86 per cent — were to mothers between the ages of 20 and 39, while a further 60 babies were born to mothers aged 40 or older. [Royal Gazette]

# Enjoying Holidays Leftovers Is Easy as Pie

What's the best thing about Christmas and New Year Holidays? I know we're supposed to say it's all the friends and loved ones gathered around the table groaning with traditional food and all the blessings and thankfulness. Yes, yadda, yadda, whatever. Just admit it: It's the leftovers.

It's knowing for the rest of the long weekend you can stand in front of your open fridge with nothing but a plate and a fork and come away with the makings of a gastronomic masterpiece.

So, what if we could buy an extra ingredient while doing our last-minute shopping that will transform these anticipated leftovers and make them even better? Something beyond

the usual soup and sandwich (no offense to any sandwiches or soups reading this). Something like pie dough or puff pastry.

You know that perfect Thanksgiving bite where you load up your fork with turkey, potatoes, stuffing and cranberry? Well, I think it's even better when it's wrapped in a buttery, flaky crust. See how I am?

#### **HOLIDAYS FAREWELL & HAND PIES**

Yield: 12 mini-pies Time: 45 minutes

One package (two 9-inch) pie crust, or homemade equivalent

1/2 cup diced turkey

1/2 cup mashed potatoes

1/2 cup stuffing

1/4 cup sweet potatoes or carrots

1/4 cup cranberry sauce

1 egg

#### Gravy for dipping

- 1. Preheat oven to 375 F. Cover a baking sheet with parchment paper.
- 2. Thinly roll out the pie dough and cut into desired size circles. (I used a 4-inch cookie cutter.)
- 3. Using a teaspoon measure, place a small amount of each ingredient on one half of the round, being sure to leave about 1/4 inch clear on the outer edges. Fold each dough circle over to cover the filling, pressing around the edges with your finger, letting out as much air as possible. Use the tines of a fork to seal the edges. Place on baking sheet.
- 4. Whisk the egg in a small bowl with a teaspoon of water and brush the tops of the pies with the egg wash.

5. Poke the tops with a fork to vent steam. Bake for 30 minutes or until crust is golden and irresistible. Serve with gravy for dipping. \*optional, but why wouldn't you?

# NEW YEAR

Yield: 6 pies Time: 50 minutes

- 1 tablespoon butter
- 1 teaspoon poultry seasoning

1 medium onion, diced

- 1/4 cup all-purpose flour
- 2 cups whole milk
- 2 cups cooked turkey, diced
- 3 cups assorted leftover Thanksgiving veggies



1 sheet frozen puff pastry (from a 17.3-ounce package), thawed

1 egg

- 1. Preheat oven to 375 F. Grease six (12-ounce) ramekins or bowls, place on a rimmed baking sheet.
- 2. Heat butter in a large skillet over medium heat. Add onion and cook, stirring occasionally, until tender, 5 to 7 minutes. Add poultry seasoning and stir. Sprinkle flour over onion and cook, stirring, 1 minute. Slowly stir in milk.
- 3. Bring to a simmer; cook, stirring constantly, until thick and bubbly, 2 to 3 minutes. Stir in turkey and your choice of leftover veggies. Season with salt and pepper. Ladle into prepared ramekins, let cool.
- 4. Roll out thawed puff pastry on a floured surface to a 1/4-inch thickness. Cut out six circles, or squares, that are 1-inch larger than ramekins or bowls being used. Top each ramekin with puff pastry, crimping edges over sides to seal.
- 5. Beat the egg with a teaspoon of water or milk. Brush the pastry with egg. Bake until puffed and golden brown, 20 to 25 minutes.
- So, to reprise, if you pick up a package of pie crusts or puff pastry, you can make perfectly portioned pot pies or palate-pleasing portable hand pies. Happy Holidays leftovers from Divas On a Dime!

#### SAFEGUARD CHILDREN FROM UNDERAGE DRINKING

Tuesday, January 16 – Child safeguarding is the action that is taken to promote the welfare of children and to protect them from deliberate or unintentional acts that lead to the risk of or actual harm.

The Family and Juvenile Unit of the Royal Virgin Island Police Force is urging the public, especially business owners of bars, restaurants, supermarkets, and hotel; and family members who might be organizers of events and within the household, to be mindful not to serve alcoholic beverages to underage children or to allow them access to places where alcohol is being served.


Unfortunately, 2023 ended

with several Juveniles partaking in underage drinking: some resulting in the need for medical attention. The Liquor Licence Ordinance Chapter 106, section 34 of the Virgin Islands prohibits businesses from selling alcoholic beverages to persons under the

age of 16.
Likewise, section 204 (2) (c),
Cruelty to Children, of the
Criminal Code of the Laws of
the Virgin Islands as amended
in 2013 states " a person,
having attained the age of 18
years, who gives, or causes to
be given, or sells or causes to be
sold to a child under the age of
16 years any intoxicating liquor,

qualified medical practitioner, or in case of sickness, apprehended sickness, or other urgent cause, shall be deemed to have ill-treated that child in a manner likely to cause injury to the child's health."

As 2024 progresses, the Royal Virgin Island Police Force calls upon the community to actively engage in promoting a safe and secure environment for our children. Vigilance in enforcing age restrictions on the sale of alcoholic beverages is not just a legal requirement but a moral duty. By adhering to these regulations, we collectively contribute to the well-being of our youth and the overall safety of our community.



#### Commonwealth Secretary-General to attend Non-Aligned Movement Summit in Uganda

12 January 2024



The-Commonwealth Secretary Patricians Cottand KC Ceneral General, the Rt Hon Patricia Scotland KC, will attend the Non-Aligned Movement Heads of State Summit from 19 to 20 January 2024 in Kampala, Uganda, as a Special Guest.

Established in 1961, the Non-Aligned Movement - which shares 44 of its 120 members with the Commonwealth - is a grouping of mostly developing countries working together to advance shared interests.

During her visit, the Secretary-General will consult with leaders from Commonwealth countries, seeking their perspectives on economic and environmental challenges and collaborating on strategies to deliver more tailored assistance.

She will also brief leaders on the preparations for the Commonwealth Heads Government Meeting, scheduled for October this year in Samoa.

In a statement ahead of her

Scotland thanked President Yoweri Museveni of Uganda for the invitation and commended his leadership as the Chair of the Non-Aligned Movement

Reflecting on the summit's theme of 'deepening cooperation for shared global affluence', the Secretary-General said:

"Many developing countries have made considerable progress to improve the well-being of their people. But they are now bearing the brunt of a myriad of crises, with the lingering effects of COVID-19, soaring debt, inflation pressures and intensifying climate extremes and disasters.

"The absence of adequate international support forces them to commit more of their limited resources into protecting their people from these crises, which further compounds their

challenges, eroding hard-earned progress on poverty, inequality and development, and is pushing many countries to the edge.

She added: "To tackle these overlapping challenges, we need more cooperation and solidarity than ever before. The voice of the Non-Aligned Movement is essential, and the Commonwealth stands as a trusted partner in achieving our shared vision for a peaceful, just and sustainable future for all."

In her engagements, Secretary-General Patricia Scotland will draw attention to the urgent reform of the global financial system to meet the needs of developing countries.

She will share how the Commonwealth's Vulnerability Index Universal can help better target international finance, including overseas aid and debt relief, for countries in need of

The Secretary-General also discuss the progress made at last year's United Nations Climate Change Conference (COP28) and the Commonwealth's assistance targeted member countries translate those commitments into action.

In particular, Secretary-General Scotland will inform leaders about the Commonwealth Climate Finance Access Hub, which has mobilised US \$322 million in climate finance for 17 vulnerable countries, with an additional US \$500 million in the pipeline.

She will also highlight the Commonwealth's coordinated response to ocean challenges through the Commonwealth Blue Charter, land degradation issues the Commonwealth through Living Lands Charter and a just energy transition through the Commonwealth Sustainable Energy Transition Agenda.

While in Kampala, Secretary-General is expected to meet with government ministers, senior officials, and other public figures to discuss ways to deepen ongoing cooperation.

#### Medicine for Hostages, Palestinian Civilians Due to Reach Gaza After Agreement

Medicine for hostages held by Hamas militants in Gaza is to be delivered Wednesday under a deal brokered by France and Qatar.

France said the medication was destined for 45 hostages who have chronic illnesses, and that the delivery would be made with the help of the International Red Cross.

Qatar said the agreement also included medicine and other humanitarian aid for Palestinian civilians in the Gaza Strip.

Hamas militants abducted about 240 people during the Oct. 7 attack on Israel during which they also killed about 1,200 people, according to Israeli tallies. Israel began its military campaign to wipe out Hamas after that attack.

More than 100 hostages were released during a temporary truce in November, but about 130 are believed to still be held by Hamas in Gaza.

The United States said Tuesday it is hopeful that talks brokered through Qatar could lead to a new deal to release the hostages in exchange for a cease-fire in the fighting between Hamas and Israel.

"I don't want to say too much publicly here as we have these talks, but we're hopeful that it can bear fruit, and bear fruit soon," National Security Council spokesman John Kirby told reporters at a White House briefing.

The war continued Wednesday with Israel's military saying it killed six Palestinian fighters, including a Hamas officer it said was in charge of interrogating suspected spies in southern Gaza.

Gaza health authorities said that in the last day, Israeli forces had killed 163 people in the Palestinian enclave, raising their toll for the war to 24,448, a figure that includes both Hamas fighters and civilians.

Since the war began in October, Israeli forces have also killed more than 350 Palestinians in the occupied West Bank, according to the Palestinian Health Ministry. The deaths have mostly come during protests and Israeli military raids.

The Israeli military said Wednesday it carried out an airstrike that killed a senior Palestinian militant in the West Bank city of Nablus. It accused Ahmed Abdullah Abu Shalal of being responsible for planning multiple attacks against Israelis in Jerusalem.

Four others were killed in the attack in the Balata refugee camp, the Israeli military said.

The Palestinian Red Crescent said Israeli forces prevented medical personnel from reaching the airstrike site to evacuate the wounded, including directing gunfire at its teams.

The organization also said Israeli troops blocked ambulance teams from entering the Tulkarm refugee camp in the West Bank after Israeli shelling there injured multiple people.

There has been no comment from Israel on the Palestinian allegations.

#### China Sees One of Worst Years of Growth Since 1990

China's economy last year grew at one of its slowest rates in more than three decades, official figures showed Wednesday, as it was battered by a crippling property crisis, sluggish consumption and global turmoil.

The figures were in line with expectations and even beat Beijing's target but will likely pile fresh pressure on officials to unveil more stimulus measures to kickstart business activity and get the country's army of consumers spending again.

China's National Bureau of Statistics revealed that gross domestic product expanded 5.2% to hit \$17.6 trillion last year. The reading is better than the 3% recorded in 2022, when strict zero-COVID curbs destroyed activity, but marks the weakest performance since 1990, excluding the pandemic years.

While 5.2% would be looked on enviously by other governments such as the United States and eurozone, which each expanded around 2% in 2022, it is well down from the levels around 6% or 7% constantly enjoyed in the 2010s.

After lifting its draconian COVID measures at the end of 2022, Beijing set itself a growth target of "around 5%" for last year.

The economy enjoyed an initial post-pandemic rebound but ran out of steam within months as a lack of confidence among households and businesses hit consumption.

The country's exports — historically a key growth driver — fell last year for the first time since 2016, according to figures published by the customs agency on Friday.

Geopolitical tensions with the United States and efforts by some Western nations to reduce dependence on China or diversify their supply chains have also hit growth.

Hodge ran 7.31 seconds in the 60m prelims on Friday night in the VA Showcase in Virginia, then followed up by running 36.97 seconds in the 300m, becoming the No 4 All Time U.S. High Schooler in the event, missing No 3 by .01.

On Saturday, Hodge ran 7.24 seconds in the 60m final to equal her personal best in finishing 2nd. She then capped her day by helping the Montverde Girls 4x4, which included St. Croix's Michelle Smith—her roommate and future Georgia teammate—break Long Beach Poly's 20-year old National

High School Girls record of 3:38.91 secs. Hodge led off the squad to 3:37.63, with a 54.10 split.

"I would say, this is one of the best season openings I've had in a long time," Hodge told Island Sun Sports. "We opened with a season's best, US No 1 and a national record, I can't complain."

Her 60m prelim was a benchmark to see where she was in her training she said, while noting she doesn't remember much of 300m race, but knew she felt good going in.

"I felt prepared with all the work I did over Christmas break and all the training I did in general," she said. "So I knew it was going to be fast, but seeing 36.97 put me in the history books as the fourth person to run 36 seconds, was like, wow, hard work really pays off. I've run 36s in practice and seeing that I can execute it on race day is always different and an eye opener for me."

Her personal best equalling 60m she said was another race she couldn't remember. She had been practicing starts and was super confident going into the race. "The last 10m was the most difficult part

because we hadn't been focusing on top end speed, so when I felt the competition, I started tightening up," she said. "And got second after that."

Her opening performance is a confidence boost for the season she said and since it's her senior year, she not pressing for anything expect the Olympic Games and enjoying her final year as a highschooler. She said that she wants to leave a legacy at Montverde and show the underclassmen how to be fearless, work hard and execute the way coach wants them to do and also be proud of themselves no matter what.

"That's what we're trying to build at Montverde," she said.

# ACTION ON CRIMINAL GANGS AND GUNS IS URGENT

The Ecuador, once celebrated for its tranquillity, now finds itself at the epicentre of a distressing surge in gang violence, its streets marred

by the ominous shadow of armed groups fuelled by the trafficking of illicit drugs.

On January 7, President Daniel Noboa deployed the nation's armed forces to clean up prisons from which gang leaders were directing their criminal activities. This

desperate response came after days of unrest, during which two formidable gang leaders escaped from jail, prison guards were held hostage, and explosive devices wreaked havoc in cities across the country.

These events starkly illustrate a broader crisis, one that extends its menacing grip across Latin America and the Caribbean.

Ecuador, nestled between the world's two largest cocaine producers, Colombia and Peru, faces the dire consequences of its geographic vulnerability. The United Nations Global Report on Cocaine 2023 reveals a record surge in cocaine production, with Ecuador serving as a tragic victim of its easily accessible coastal routes.

However, Ecuador's plight is not a solitary narrative; it is a haunting prelude to a region-wide symphony of chaos.

The issue of gangs, guns, and violence cannot be confined within borders. Governments are now awakening to the problem, but it has already spiralled out of control in some nations, while others are teetering on the brink.

The Caribbean, in particular, stands as a sobering example, with four of the five most murderous countries and territories in the region in 2022 being the Turks and Caicos Islands, Jamaica, Venezuela, St. Lucia, and St. Vincent and the Grenadines. Disturbingly, there were no reliable figures for Haiti, leaving a void in understanding the full extent of the crisis which, in any event, is known to be completely unmanageable.

Statistics for the region reveal

a grim reality; eight out of ten countries with the highest homicide rates in the world are located in Latin America and the Caribbean. The average homicide rates, according to 2021 data, stood at 9.3 per 100,000 for South America, 16.9 per 100,000 for Central America, and 12.7 per 100,000 for the Caribbean.

The Caribbean also grapples with a dual challenge: an influx of illicit firearms, primarily sourced from the United States, and a decrease in funding for crucial security initiatives.

The United States, despite being a major source of the region's illicit firearm woes,

paradoxically reduced its budget for the Caribbean Basin Security Initiative by 11.8% in fiscal year 2022. This initiative provides vital aid for border and port security, a lifeline desperately needed to combat the influx of weapons.

prevalence alarming The American-made guns in the hands of Caribbean gangs has spurred heads of government to call for stronger U.S. efforts in curbing arms trafficking. In June 2023, Bahamas' Prime Minister, Philip Davis, emphasised to U.S. Vice-President Kamala Harris, the urgency of reducing the flow of illegal guns entering his nation from the United States. However, the U.S. account of the meeting made no mention of this serious concern, not because the Biden government is not troubled by gun crimes, but because it is a domestic political issue in the U.S. Hence, not enough is being done to stop the flow of illegal weapons into the Caribbean.

Even as these nations grapple with the inflow of illegal firearms, their capacity to intercept and prevent such activities remains a significant challenge. Ports of entry often lack the necessary interdiction capacity, and limited enforcement resources hinder their ability to curb the tide of arms. The traffickers exploit the short distances between Caribbean islands, utilizing go-fast boats and yachts to move weapons seamlessly across the extensive coastlines.

Efforts to control and combat this phenomenon have been ongoing since the late 1990s. Despite these efforts, gangs continue to proliferate, fuelled by drug traffickers who arm their criminal enterprises.

Recognizing the urgency and gravity of the situation, during my term as President of the Organization of American States (OAS), I placed the topic of "Guns, gangs, and violence" on the agenda of the Permanent Council.

An expert panel, convened to address the growing crisis, proposed approaches to tackle the root causes and consequences of criminal gang violence, particularly gun-related violence. The resulting Resolution, adopted on December 12, emphasized the necessity for greater collaboration between governmental agencies. It acknowledged that no single state possesses the capacity to match the formidable resources available to organized criminals operating across borders.

The resolution underscored the links between transnational organized crime, criminal gangs, and the vital importance of a cross-border, collaborative approach.

We strongly proposed that the matter be addressed at the upcoming OAS general assembly in June, with the objective of establishing practical systems of collaboration between Latin American nations and Caribbean states. The criminals are organized; if governments and their law enforcement agencies fail to follow suit, the consequences will be more disastrous than they already are. But this alone, while a start, is not enough. Much more needs to be done. At the regional level, collaboration is paramount, as no single state can confront the vast resources of transnational organized crime independently.

At the national level, robust legislation, effective implementation machinery to punish drug traffickers, and prison reforms to prevent them from becoming recruitment centres are imperative. Equally important is raising awareness among communities about the dangers, consequences, and sanctions associated with membership in criminal gangs and the possession and illegal use of firearms.

As the Caribbean confronts this multifaceted crisis, the imperative is clear: collective, resolute action is not just an option but an absolute necessity. The path forward demands a commitment to national, regional and hemispheric action. Gangs, guns and lawlessness now threaten every personthe examples are too many to ignore.





### Vi Government Launches Employment Registration Drive

The Premier said, "I am pleased to see this new initiative, "Coming to a District near You". This is yet further proof that we are on our way to achieving our goals through the RATED programme which is to change lives, enhance skills and develop future entrepreneurs, one person at a time."

Premier Wheatley spoke about the future of the RATED programme and outlined plans to further develop the programme, thus extending more benefits for the people of the Virgin Islands.

Meanwhile, Permanent Secretary in the Ministry of Environment, Natural Resources and Climate Change, Mr. Ronald Smith-Berkeley is inviting interested persons to make a special effort to attend and be registered, during the drive.

Mr. Smith-Berkeley said, "So far the RATED programme has made its mark in the lives of many Virgin Islanders and Belongers who have had an opportunity to participate in the programme and some of whom have been able to secure permanent employment."

He added, "We have taken notice of the positive impact, and that is why we have launched "Coming to a District Near You", to ensure that everyone hears about RATED and those interested and eligible can sign up to be a part of this Programme".

Interested persons are asked to present documents including a BVI Passport or Belonger Card, National Health Insurance (NHI) Card, Social Security Card, Resumé (For persons interested in office employment)

The RATED Programme is promoting areas of interest Landscaping/ including Cutting, Painting, Bush Construction, Carpentry, Marine, Administration, Data Communications/ Public Relations, Agriculture/ Fisheries, Janitorial Services, Legal/Professional Services, Real Estate, and Hospitality.

#### Health Ministry To Expand Cervical Cancer Advocacy To The Oecs





Minister for Health and Social Development Honourable Vincent O. Wheatley is expected to partner with local cancer advocate Dr. Arliene T. Penn to spread awareness on cervical cancer across the Organization of Eastern Caribbean States (OECS) region.

In his message on Cervical Cancer Awareness Month, observed in January, Honourable Wheatley said he will partner with Dr. Penn as an ambassador to assist the OECS in executing its strategy to eradicate cervical cancer as a pandemic in the region.

The Health Minister who is also the Chairman of the 36th OECS/PPS Policy Board Meeting and the 9th OECS Council of Ministers: Health, said he is taking a proactive approach to health issues, hence Dr. Penn is expected to travel throughout the region to enlighten, encourage, inspire and support women as the OECS seeks to lower and eradicate cervical cancer in the region.



According to the Pan American Health Organisation, Cervical Cancer claims lives and is the leading cause of death in more than 35,000 women in the Americas. The majority, 80 per cent or 28,000, of these cases are in Latin America and the Caribbean.

As such, Honourable Wheatley is urging women to schedule annual checkups for cervical cancer as early detection can drastically reduce the number of deaths associated with the disease.

The Ministry of Health and Social Development remains committed to improving the health and well-being of the people of the Virgin Islands.

Mr. Ephraim Penn stated that Lord Coe's courtesy call is a testament to VI achievements. He said the Olympic Committee has been playing a key role in working with all the Territory's national federations, in particular track and field.

Mr. Penn added, "We are very pleased with the progress being made in

track and field under Steve's leadership it has really made a positive change that we embrace. The significance of having Lord Coe here speaks volumes not just locally or regionally, but internationally."

Meanwhile, Lord Sebastian Coe thanked the Territory for its hospitality and expressed his gratitude for the opportunity to visit the Virgin Islands. 
