POPULATION CENSUS ENCOUNTERS ROADBLOCKS

In what was anticipated to be a meticulous and comprehensive gathering operation to inform future planning and research, the Population Census of 2023 in the British Virgin Islands has encountered a series of roadblocks, which affected

its ability to meet the December 31st deadline.

During a presentation to the Standing Finance Committee (SFC), Raymond Phillips, the Director of the Central Statistics Office (DCSO), underscored the vital role the Census plays in collecting extensive housing,

social, and economic data that surveys typically do not capture. This data, essential for both public and private sector planning, sheds light on the living conditions economic standing of households and serves as a primary source for poverty and living condition

analysis. The Census,

conducted every ten years worldwide, boasts an extensive database encompassing numerous variables. This wealth information allows for precise targeting of vulnerable populations and the allocation of limited resources to areas where they are most needed. It also informs decisions about the redrawing of electoral district boundaries based on population growth in specific regions. Furthermore, by comparing consecutive censuses, governments can gauge their social and economic progress or regression over time, making it an invaluable resource for research and long-term planning.

However, despite its critical importance, the Census has faced a slew of setbacks. Initially scheduled commence on 15 June, the fieldwork was delayed until mid-July due to technical

challenges. Over enumerators were assigned to various enumeration districts throughout the British Virgin Islands. Yet, Phillips expressed growing concern that not all enumerators are actively conducting interviews, and some have yet to initiate fieldwork despite receiving repeated reminders.

Enumerators have encountered a host of difficulties in their efforts to collect crucial data. These challenges range from unresponsive residents and encounters with unfriendly dogs to outright refusals, skepticism about legitimacy of the exercise, intimidations, and even threats. Some enumerators have felt compelled to request police escorts when visiting certain households due to safety concerns. These numerous and often disheartening challenges have taken a toll

on the morale of many enumerators. Some have reduced the frequency of interviews, while others have promised to quit or

have already returned their census equipment.

The Director emphasized that despite the Census's signifi cant government investment and extensive awareness campaigns, there appears to be a notable lack of appreciation for the exercise among segments of the population. He firmly asserted that noncooperation without valid reasons should not be tolerated, as it ieopardizes the successful completion of the Census-a substantial government undertaking. Eighth-Distri ctRepresentative-H on.-Marlon-Penn,-w hile-acknowledge i

nconcerns-about th e Census questionnaire being intrusive, called for innovative solutions to address cooperation issues. He suggested enlisting persuasive family members for households with large families and harnessing the influence of various associations to reach diff erent segments of the community eff ectively. He stressed the importance of finding individuals who can establish a genuine rapport with the community, particularly young men, to gather essential data, such as unemployment rates.

The process to commencethe census started in early 2020 with a call for enumerators. However, the call for an updated census began in 2015. It became even more urgent following the 2017 hurricanes. At that time it was explained

that the Territory's population which stood at 36,000 before September 2017 was reduced to 32,000. It is unclear what the current population number is. In late 2017 the household surveys were delayed because of the state of most homes as a result of damages sustained. It was reported that people were uncomfortable with the state of their homes and would not welcome enumerators; so it was decided that the survey would be conducted in the last quarter of 2018

The 2010 census report was not laid on the table of the House of Assembly until 2014. The report stated that there were a total of 10,830 households and 28,054 persons residing in the British Virgin Islands at that time.

USVI LEAGUE OF B.V.ISLANDERS TO HONOUR THE LATE CARVIN MALONE

While Mr. Malone had initially been among the five individuals selected for recognition, his untimely departure has made this tribute even more poignant. The President of the League of British Virgin Islanders, Mr. Moleto A. Smith Jr., shared that the Board of Directors, in collaboration with the Malone

family, has decided to bestow this honor posthumously, acknowledging Mr. Malone's lasting contributions. Mr. Smith Jr. conveyed the league's condolences, saying: "Our sympathies and prayers are with his family and the entire BVI community during this diffi cult time of bereavement." During his tenure as the Minister for Health and Social Development from 2019 to 2022, Mr. Malone faced the formidable challenges posed by the global Covid-19 pandemic. He was not only a VIP Member but also held the position of the party's President for an extended period before venturing into elective offi ce. Despite an unsuccessful bid for a second term in the 2023 General Elections, Mr. Malone remained dedicated to serving the public through his One Virgin Islands Agenda platform, where he continued

to educate the community on pressing issues. Beyond his political role, Mr.

Malone was an active fi gure in various community leadership roles. He served as a Former President of the BVI Chamber Commerce and Hotels Association, Vice President of the BVI Amateur Basketball Association, and President of the Lions Club of Tortola. Reflecting on Mr. Malone's remarkable contributions. Premier and Minister of Finance, Dr. the Hon Natalio Wheatley, paid tribute, stating: "Mr. Malone was a true champion for the Virgin Islands, and his sudden passing has left us all shocked and heartbroken."

The community looks forward to commemorating his legacy the forthcoming during ScholarshipLuncheon.

GOVERNORRANKINLEAVES BVI-HISTENURE HAS MADE HISTORY

Governor John Rankin has departed the Territory thus ending his tenure as Governor of the Territory amid a backand-forth between his office and the Government. The backand-forth stemmed from the Governor's announcement that he was going to be requesting additional powers from the UK to advance the implementation of the COI recommendations. Both the Government and the Opposition took offense to the Governor's suggestion and implied that the Governor was tampering with the Territory's democracy.

In defense of his decision the Governor announced that he had no choice but to push for the powers. Mr. Rankin defended his stance, emphasizing that it is in response to the need to implement good governance recommendations outlined in the Commission of Inquiry report.

Governor Rankin argued

that his appeal for enhanced authority was driven by the lack of progress and determination exhibited by various ministries and departments to meet the COI's stipulated deadlines for reforms and improvements in governance.

However, the government has countered these claims, alleging that the governor is overstepping his bounds and encroaching upon the traditional powers held by elected officials in the Territory. Some lawmakers have even expressed concerns that these additional powers could potentially be used to introduce same-sex marriage legislation. In response to these criticisms, Governor Rankin clarified his intentions during an interview with ZBVI, stating: "I'm aware that the additional powers proposal is a strong proposal to make, but I think there's been some, perhaps incorrect representation of precisely

what it is I have suggested."
Governor Rankin dismissed claims that the proposed powers would enable a takeover of the democratic system, including the introduction of same-sex marriage laws, by emphasizing that the additional powers were specifically intended for the implementation of

the Commission of Inquiry's recommendations.

He further elaborated, saying, "And whatever your views on same-sex marriage may be, that's not one of the Commission of Inquiry recommendations. So those people that have suggested that are way off beat in terms of what's being proposed."

Most likely they are victims of bigoted scaremongers that manipulate people and then speak of others doing what themselves are doing: breaking human rights.

The Governor stressed that his proposal sought to achieve nothing beyond what the government had already pledged but had struggled to deliver. He explained that the additional powers for introducing legislation were not meant to undermine the House of Assembly's role in passing

laws but rather to facilitate the process by addressing any obstacles that may arise in bringing legislation to the House for debate and consideration by lawmakers.

Governor Rankin reminded the public of the damning findings of the COI, which revealed instances of poor governance, misuse of public funds, misallocation of assistance grants, lawmakers failing to register their interests, and over two-thirds of major contracts not being subjected to open tendering processes.

The debate over the Governor's request for expanded powers continues, with both sides holding firm in their positions, highlighting the ongoing tensions surrounding the implementation of the COI's recommendations and the broader issue of governance in the British Virgin Islands.

29 JANUARY IS THE NEW DATE OF FAHIE'S TRIAL

The eagerly awaited trial of former BVI Premier Andrew Fahie, who is facing charges of drug smuggling, money laundering, racketeering, has once again been postponed. Fahie's trial was initially scheduled to commence on 8 January but was delayed by two weeks, with a new expected start date. However, a recent announcement by Justice Williams Kathleen pushed the trial back by an additional week, setting the new trial date for next Monday, 29 January.

The trial, taking place in a Miami court, has garnered significant attention, both locally and internationally, as it revolves around allegations of drug-related activities and conspiracy on an international scale. Fahie, along with his co-defendant, former BVI Ports Director Oleanvine Maynard, was arrested in Miami in April 2022, following accusations that they conspired to allow huge quantities of cocaine to pass through the British Virgin Islands' ports.

The alleged illicit scheme was said to be part of a multi-million dollar deal Fahie entered into with an undercover informant from

the United States Drug Enforcement Administration (DEA), who was posing as a drug trafficker at the time. Kadeem Maynard, Oleanvine Maynard's son and another co-defendant, recently received a 57-month prison sentence after accepting a plea deal related to his involvement in the case.

Fahie's defense attorney, Theresa Van Vliet, raised objections to what she deemed the prosecution's "eleventh-hour" motions, which were filed just three weeks before the trial's originally scheduled start date. Van Vliet argued that these last-minute motions introduced several critical issues that had not been previously addressed.

Among the key issues to be considered during the trial are the potential introduction of foreign law jury instructions and expert witnesses, questions surrounding hearsay testimony, and the possibility of an entrapment defense.

Furthermore, it is expected that Oleanvine Maynard, who has also accepted a plea deal, will serve as the prosecution's main witness once the trial begins. The former BVI Leader faces severe consequences if convicted on the charges brought against him by the United States government, including the possibility of life imprisonment. Currently, as part of his \$1 million bond conditions, Fahie is confined to his daughters' residence in Miami, Florida, awaiting the commencement of his trial. The trial's delays and complexities underscore the significance of this legal battle, which continues to captivate public attention and raise questions about the former Premier's legal fate.

The Director encouraged residents to make use of free templates for emergency plans for schools, businesses and families available on the Department of Disaster Management's (DDM) website, www.bviddm.com.

"In the event of an emergency, having an agreed upon plan allows you to bypass panic and take speedy and effective action. Investing the time to sit with your team or your family to agree on an emergency plan can save lives," Mr. Penn said.

The Director stated that effective family emergency plans include considerations for shelterin-place, safeguarding the home, evacuation locations and routes, critical contact information and details for how the family will reconnect if separated. Plans for businesses should also include procedures for shutting down the business and re-opening after an emergency.

Once the plan is in place, persons should test their procedures to ensure they are a good fit, Mr. Penn added. Persons can exercise on their own or join a national-level exercise such as the Caribe Wave tsunami exercise on March 21.

The Department of Disaster Management works to foster comprehensive disaster management and climate change adaptation as a way of life in the Virgin Islands.

Eu-Funded Project Bolsters Vi's Climate Resilience



The Virgin Islands continues making strides to strengthen schools against the unpredictable impacts of disasters and climate change under the BVI SMART Schools initiative.

The collaboration between the Ministry of Education, Youth Affairs and Sports (MEYAS) and the Department of Disaster Management (DDM) is being expanded with the support of the Resilience, Sustainable Energy, and Marine Biodiversity (RESEMBID) Programme funded by the European Union and implemented by Expertise France.

The latest iteration of the BVI SMART Schools project, steered by DDM, builds on the established partnership with MEYAS by adding the expertise of Green VI, H. Lavity Stoutt Community College and the BVI Red Cross to reshape the Territory's education infrastructure with resilience at its core.

Director at the Department of Disaster Management Jasen Penn said the BVI SMART Schools initiative fortifies schools against the challenges posed by climate change. He said, "RESEMBID's financial support has facilitated a partnership to enhance our efforts at improving student safety and fostering a culture of resilience."

The initiative is funded by the European Union at a cost of €1.3M over two years and seeks to make 14 schools across the Territory safer, healthier, and greener. The project has conducted comprehensive school assessments, provided essential guidance to individual schools, and initiated campus community emergency response training, strengthening preparedness within these educational institutions.

"What our students and teachers are learning prepares our wider community for greater resilience, which ultimately means a more prepared Virgin Islands," Mr. Penn said.

RESEMBID Senior Programme Manager - Resilience, Edward Turvill applauded the focus on schools and students, saying, "Education stands as the bedrock of change. What we are seeing with projects in the BVI is a great effort to shift the community's idea of what it means to be resilient and responsive to climate change."

Mr. Turvill commended DDM and its partners for what he considers a comprehensive approach to the idea of SMART Schools. He said it is refreshing to see a coming together of partner organisations in the VI to address the core objectives of this programme.

The Senior Programme Manager said, "It shows that through this type of publicprivate partnership, BVI has the persons and tools to address some of the most challenging issues surrounding resilience and climate change. RESEMBID is truly proud to have the chance to facilitate such partnerships that are to the benefit of society and future generations."

Programme partners are enhancing the legacy SMART Schools initiative to support target schools in key areas. For example, efforts to establish vibrant school gardens, conduct water and energy audits, and develop a culture of conservation within school campuses, are led by Green VI. BVI Red Cross has put its efforts towards empowering educators and enhancing the overall resiliency of communities by facilitating First Aid training for teachers. Its community assessments continue to bolster safety measures beyond school premises.

USA - 2023 was slowest year for US home sales in nearly 30 years as high mortgage rates frustrated buyers. Mortgage rates have been mostly easing November, echoing since a pullback in the 10-year Treasury yield, which lenders use as a guide to pricing loans. Sales of previously occupied U.S. homes sank in 2023 to a nearly 30-year low as mortgage rates climbed to the highest level in more than two decades and prices hit record highs, pushing homeownership out of reach for many Americans.

The National Association of Realtors said Friday that existing U.S. home sales totaled 4.09 million last year, an 18.7% decline from 2022. That is the weakest year for home sales since 1995 and the biggest annual decline since 2007, the start of the housing slump of the late 2000s. The median national home price for all of last year edged up just under 1% to record high of \$389,800, the NAR said.

Mortgage rates surged in 2023, climbing to a two-decade high of 7.08% by late October as the Federal Reserve continued to boost its key lending rate in a quest to cool the economy and tame inflation.

The sharply higher home loan borrowing costs limited home hunters' buying power on

top of years of soaring prices. A stubbornly low level of homes for sale also kept many wouldbe homebuyers and sellers on the sidelines.

Mortgage rates have been mostly easing since November, echoing a pullback in the 10year Treasury yield, which lenders use as a guide to pricing loans. The yield has largely come down on hopes that inflation has cooled enough for the Federal Reserve to shift to cutting interest rates this year.

The average rate on a 30-year home loan was 6.6% this week, according to mortgage buyer Freddie Mac. If rates continue to ease, as many economists expect, that should help boost demand heading into the spring homebuying season, which traditionally begins in late February. [El Pais]

ITALY - Police clashed with protesting demonstrators against Israeli participants at the VicenzaOro jewellerysector trade fair in Vicenza on Saturday.

The clashes took place after the march, which started shortly before 11.20 a.m. with about 500 participants, deviated from the established route, with protesters trying to the area of the trade-fair centre.

At this point police in riot gear baton-charged the protesters.

The demonstrators threw

smoke bombs and firecrackers and the police responded by firing water cannons.

Nine police officers were injured in the clashes, sources said.

"The right to demonstrate is sacred and it is protected by the Constitution.

"But those who take to the streets carrying clubs with their faces covered go against the legacy of the founding fathers (of the republic), who wrote that article (of the Constitution) after the darkest years in the history of our country". [ANSA]

GERMANY - Huge crowds of protesters have descended on cities in Germany, as demonstrations calling for a ban on the far-right Alternative for Germany (AfD) gain momentum.

Tens of thousands have already braved sub-zero temperatures this week to protest against the party, after it emerged senior AfD members discussed a plan to deport migrants en masse in revelations that have been compared to the Nazi era.

Crowds of up to 35,000 gathered in Frankfurt on Saturday under the banner "Defend democracy Frankfurt against the AfD," while a similar number of people turned out in the northern city of Hanover, German newspaper Der Spiegel reported.

Significant crowds were also seen in Stuttgard, Dortmund and Nuremberg.

In a video message issued Friday night, German Olaf Chancellor Scholz welcomed this weekend's protests as "good and right."

He added that he tries to imagine "how the more than 20 million citizens who have a history of migration feel" about the deportation plans.

Protests of up to 30,000 people have already taken place in cities including Berlin, Leipzig, Rostock, Essen and Cologne. Demonstrators gathered outside the capital's redbrick town hall on Wednesday reading holding placards "Nazis out" and chanting slogans against far-right AfD politician Björn Höcke.

People are enraged by reports that senior members of the AfD discussed a "master plan" for the mass deportation of German asylum-seekers and German citizens of foreign origin during a meeting late last year. [CNN]

BAHAMS - The world's largest cruise ship, Icon of the Seas, which is owned and operated by Royal Caribbean International (RCI), was docked at the Nassau Cruise Port last weekend.

President and Chief Executive Officer of RCI Michael Bayley said during a ceremony onboard Icon of the Seas, to mark its first sailing to Nassau, that RCI is expected to bring more than four million cruise visitors to The Bahamas



ST. VINCENT - The Ministry of Health in St. Vincent and the Grenadines has issued an advisory, urging both residents and visitors to take proactive measures in safeguarding themselves against an array of infectious diseases.

This alert encompasses the ongoing COVID-19 pandemic, dengue fever, leptospirosis, and a resurgence of Influenza A -H1N1, known as the swine flu.

Between December 25th of last year and January 6th of this year, a palpable surge in Influenza A - H1N1 cases has set off alarm bells within the healthcare system.

As of January 6, the tally of confirmed SARS-COV2 cases in St. Vincent and the Grenadines has reached a total of 9,804 cases since the initial outbreak in 2021.

The Ministry of Health's advisory also highlighted the prevalence of other infectious diseases in the region.

In 2023, St. Vincent and the Grenadines recorded 17 cases of dengue fever, emphasizing the continued importance of vigilance in combating this mosquito-borne illness. [CNW]

Easy Pork Carnitas a Cinco de Mayo Classic

Melt-in-your-mouth, flavorful and juicy with irresistible caramelized crunchy bits, carnitas means "little meats" in Spanish. If you like carnitas brimming with classic flavors like Mexican oregano, cumin, chili powder and a surprising bright note of citrus, you're going to love this divine recipe, just in time for Cinco de Mayo.

This recipe yields restaurant-quality pork carnitas at a fraction of restaurant costs. It uses historically inexpensive cuts of heavily marbled pork that are slow cooked for hours until the meat is completely tender. After cooking, it falls apart and practically shreds itself. Before serving, the meat is broiled to make those signature delicious crispy bits.

Carnitas can be the star of your Cinco de Mayo festivities, but don't wait for a party, they make any day a celebration. Carnitas are equally at home in your nacho platter, a build-your-own taco or burrito bar, or served simply with a fork, corn tortillas, salsa and lots of napkins.



Serve up restaurant-quality pork carnitas at a fraction of the cost.

Choosing the right cut of pork is essential for the tender, juicy quality we're looking for. This recipe doesn't work with lean meats, so no lean pork loin, and please don't try this with chicken breast!

You'll want pork shoulder or pork butt, with or without bone. Incidentally, they're the exact same cut of meat from the shoulder of the pig. The name "butt" comes from Colonial America, when butchers in the Boston area would pack the pork shoulder in barrels they called "butts."

Lastly, this recipe calls for Mexican oregano, which is entirely different from regular Mediterranean oregano. Mexican oregano is earthy and grassy with citrus notes and is related to lemon verbena. Mediterranean oregano is subtle and related to the mint family. You can find Mexican oregano in the ethnic spice section of the grocery store, usually for under a dollar.

SLOW COOKER PORK CARNITAS

Yield: 6 to 8 servings Prep: 10 minutes Cook: 4 hours

What You'll Need:

- 4 pounds pork shoulder (also known as "pork butt")
- · 1 lime -- juice and zest
- · 1/2 orange -D juice and zest
- 1 tablespoon ground cumin
- · 1 tablespoon dried Mexican oregano
- · 2 teaspoons kosher salt
- · 1 teaspoon chili powder
- · 1 teaspoon garlic powder
- 1 teaspoon onion powder
- 1/2 teaspoon ground black pepper
- Cut the pork shoulder into big chunks, about 4-inches cubed, and place in the slow cooker. Add the zest and juice of the lime and half an orange, and stir to coat the meat in the liquid.
- In a small bowl, mix the cumin, oregano, salt, chili powder, garlic powder, onion powder and black pepper. Sprinkle the seasoning evenly over the meat, stirring until the meat is well-coated.
- Cover and cook on HIGH for 4 hours or LOW for 7-8 hours. Just wait until
 you can smell this slice of heaven! When it's cooked, using a slotted spoon,
 remove the pork to a rimmed baking sheet that's been covered in foil or
 with cooking spray.
- Pour the liquid from the slow cooker into a small saucepan and boil to reduce until thickened. Pour this lovely liquid over the pork and shred with two forks, coating the meat with the sauce.
- Turn on the broiler and place the pan o'goodness under the broiler until some of the edges are brown and crispy, about 5 minutes. But keep your eye on it, because burning a pan filled with this amazing stuff would be a crime.

This recipe is so easy, but please don't skip the last step. Caramelizing the meat under the broiler to concentrate the flavors is what takes this dish over the top. Buen Provecho!

ONE PERSON ARRESTED AS MURDER INVESTIGATION CONTINUES

STOP AND SEARCHED ENDED WITH TWO ARRESTS





STATE-BACKED RUSSIAN HACKERS ACCESSED SENIOR MICROSOFT LEADERS' EMAILS, COMPANY SAYS

BOSTON — State-backed Russian hackers broke into Microsoft's corporate email system and accessed the accounts of members of the company's leadership team, as well as those of employees on its cybersecurity and legal teams, the company said Friday.

In a blog post, Microsoft said the intrusion began in late November and was discovered on Jan. 12. It said the same highly skilled Russian hacking team behind the SolarWinds breach was responsible.

"A very small percentage" of Microsoft corporate accounts were accessed, the company said, and some emails and attached documents were stolen.

The White House is warning companies that Russia could be planning to launch cyberattacks against critical U.S. infrastructure.

The U.S. has previously warned about the Russian government's capabilities to digitally attack U.S. companies, but President Biden reiterated the message on Monday, saying in a statement that "evolving intelligence" showed Russia is "exploring options for potential cyberattacks."

The potential attacks would be in response to U.S. sanctions against Russia over its invasion of Ukraine, the White House said.

Deputy National Security Adviser for Cyber and Emerging Technology Anne Neuberger called for companies to secure their systems, including implementing multifactor authentication, patching systems against known vulnerabilities, backing up data, running drills and engaging with federal authorities before a cyberattack happens.

telecommunications providers.

The main focus of the SVR is intelligence-gathering. It primarily targets governments, diplomats, think tanks and IT service providers in the U.S. and Europe.

In another hackers criminal activity, in Iran-linked hacking group is "actively targeting and compromising" multiple U.S. facilities for using an Israeli-made computer system, U.S. cybersecurity officials say.

The Cybersecurity and Infrastructure Security Agency (CISA) said on Friday that the hackers, known as "CyberAv3ngers," have been infiltrating video screens with the message "You have been hacked, down with Israel. Every equipment 'made in Israel' is CyberAv3ngers legal target."

The cyberattacks have spanned multiple states, CISA said. While the equipment in question, "Unitronics Vision Series programmable logic controllers," is predominately used in water and wastewater systems, companies in energy, food and beverage manufacturing, and health care are also under threat.

"These compromised devices were publicly exposed to the internet with default passwords," CISA said.

The agency did not specify how many organizations have been hacked, but on Friday CNN reported that "less than 10" water facilities around the U.S. had been affected.

Capital and Governance

The quality of country's capital: the various combinations both private and public capital, decides quality of life, standard of living, and wellbeing. Capital Mix: wealth generating assets and resources, from land and technology, to enterprise human resources. decides the level of national prosperity.

Good governance is synonymous with a capital mix that drives up prosperity and wellbeing: the public or national good.

If we look at countries that underperform, overwhelmingly, it is down to their poor governance. Governance is an octopus with tentacles that affect every area of national life. Poor governance results in a capital mix that fails to deliver.

Now, leadership is top down, and even though the values and cultures held by a population are factors in deciding the quality of leadership, poor governance will destroy a country's culture. Countries get the governments they deserve, yes. However, like a fish, where the rot starts at the head, poor leadership delivers mass misery.

In Africa, a continent blessed with vast and abundant natural resources, poor governance is a synonym for unethical cultures. Poor governance has been a top down affair corrupting everything inflicting and war, underdevelopment, and poverty, on hundreds of millions of people.

Countries may have abundant natural and human resources, like Nigeria, Venezuela, and much of Africa. However, no matter the abundance of natural wealth, poor and dishonest governance has placed these lands at a disadvantage, keeping them in poverty, under-development, and conflict.

Countries with far less natural wealth possess a higher quality of life and standard of living owing to the fact of honest, progressive, and thoughtful governance. The governing culture of a country appears to have a more lasting effect on prosperity and welfare than the gold, silver, copper, aluminum, and uranium, sitting under the earth.

The modern Caribbean is a tourism haven, but limited in natural resources unlike many an African nation with oil, gas, minerals, and arable land. The Caribbean owes any positive economic growth and social development to the fact that most islands possess a reasonable degree of honest governance.

That is, honest governance, relative to countries in Africa and Latin America. Honest and good governance, results in a capital mix in the Caribbean of a relatively sustainable-social and economic-infrastructure. Much of the Caribbean would have resembled Haiti or Venezuela had it not been for governance that has adopted a degree of honesty.

Consequently, the islands

— including overseas
territories of the USA, UK,
France, and the Netherlandsare safe for tourism and
offshore administrative
and financial services: key
revenue earners.

Then, much of the Caribbean-possesses adequate power and water supply, and a connecting road network that borders coastlines, and links

with hubs and towns, inland. Again, this is the consequence of sustainable public investment; public cash that has not ended up in Swiss Accounts, as is the case with too many naturally wealthy but corrupt and undeveloped economies.


There remains much to be improved, but Caribbean roads beat regions of the world where potholes become craters, collapsed bridges left in disrepair for many months, even, years. A drive through a land where corruption is rife will be a shock to anyone living in a safe, sustainable, and stable country with good governance.

A Caribbean Island nation such as Haiti, can blame poor governance for driving a capital mix that has resulted in poverty crime, and underdevelopment, especially in recent decades.

Today, the Virgin Islands is going through the trauma of a Commission of Inquiry and its aftermath. That exercise aims at strengthening its governance. Getting governance right will be more of an influence on long-term prosperity than the natural beauty and majestic geography of the islands.

A country can be beautiful and endowed with natural wealth but remain poor, and-under-developed, if governance is poor. Conversely, a country with limited natural wealth will prosper if it possesses good governance.

US Congressional Delegation Travels to Taiwan After Island's Election

TAIPEI, TAIWAN -

The co-chairs of the U.S. Congressional Taiwan Caucus on Wednesday opened the first trip by U.S. lawmakers to the island where the independenceleaning Democratic Progressive Party a third straight term in presidential elections this month.

U.S. Reps. Ami Bera, a Democrat from California, and Florida Republican Mario Díaz-Balart plan to "engage with senior officials and business leaders," Bera's office said in a statement, without naming those with whom they would meet.

"The aim of the trip is to reaffirm U.S. support for Taiwan following their successful democratic elections, express solidarity in their shared commitment to democratic values, and explore opportunities to further strengthen the robust economic and defense relationship between the United States and Taiwan,"

the statement said.

China, America's chief competitor for global influence, claims Taiwan as its own territory and threatens to use force to bring it under its control. Beijing strongly condemned the election of current Vice President Lai Ching-te as Taiwan's leader and appears set to continue its policy of refusing to engage with the island's government first set down following the election of the DPP's Tsai Ing-wen in 2016.

Beijing objects to any form of official contact between the U.S. and Taiwan and responded to a 2022 visit by then-House Speaker Nancy Pelosi with some of its largest military maneuvers in years, including missile launches and a simulated blockade of the island. It views visits by foreign government officials as them recognizing the island's sovereignty.

President Joe Biden has sought to calm that complaint, insisting there's

no change in America's longstanding "one-China policy," which recognizes Beijing but allows informal relations and defense ties with Taipei.

Washington cut formal diplomatic relations with Taiwan in 1979 in order to recognize China, but U.S. law requires it to ensure the island has the means to defend itself and to treat all outside threats as a matter of grave concern.

While China regularly sends warplanes and navy ships to intimidate and harass Taiwan, there was no discernible spike in activity on Tuesday and Wednesday. Defense Ministry The reported seven Chinese warplanes and five naval vessels had been detected near the island over the previous 24 hours. It also said two Chinese balloons flew over the island's northern and southern regions. The nature of the balloons remains unclear.

UN Calls on Hong Kong to Drop Case Against Publisher Jimmy Lai



As Hong Kong's official legal year began Monday, the city's chief justice, Andrew Cheung, used the opportunity to stress how the judiciary takes its duty seriously.


The courts will not "blindly convict" anyone and will respect fundamental rights in national security cases, Cheung said at the official ceremony, adding that the justice system will also not bow to pressure.

"Threats of sanction or reprisal against judges for simply discharging their judicial duties are, therefore, repugnant to the rule of law and fundamentally objectionable," said Cheung.

Jah'Kyla Morton clears highest height ever on BVI soil

National High Jump record holder Jah'Kyla Morton, scaled the bar at 1.68m (5'61/4") for the highest clearance ever on BVI soil, during Saturday morning's session of the 2nd Dag Samuels Development Series.

During the afternoon session, Tiondre Frett became the territory's first qualifier for the 51st Carifta Games in St. George's Grenada, March 30-April 1.

Morton, who won NACAC U18 Championships silver last year with a meet and national record leap of 1.74m (5'8½") after winning Carifta Games U17 silver and a bronze in 2022, narrowly missed the bar at 1.71m (5'7¼") on her final attempt.

"I was a bit disappointed. I had one aim today and that was to qualify (for Carifta Games)," Morton told Island Sun Sports of the 1.70m (5'7") qualifying mark. "Last year, I also qualified on this date. My first two attempts at 1.71 were

the best ones but on the last one, I came down on the bar. But it's motivating. I'm still young. I'm developing, so I have to train hard to jump higher."

Her Coach Carl Barrett said Morton had a much improved performance, based on the work she's put in. During the first meet two weeks ago, she cleared 1.60m (5'3"). While it's January, last year she cleared 1.50m+.

"Based on projections and Carifta being at the end of March, we're at 1.68 now. Last year, a couple weeks before Carifta, we jumped 1.67," Barrett recalled. "Knowing this is the best jump on local soil, it shows that the work is going well." Of the 1.71 effort, he said that she didn't arch her back and the bar came down. "Her glutes touched the bar," Barrett said, noting he thought she had cleared the height. "I guess she hit it a little too hard, so on the way down after she fell, the bar came off."

Barrett said his young charge is focused in training and knows what the goals are.

Competing in the afternoon session, Morton ran 15.73 seconds to win the 100m Hurdles.

"During practice this week, I wasn't clearing the first two (hurdles) at least. I would throw down the second hurdle because I was overthinking," she said. "When I ran through all 10, I felt good even though the time was very horrible, I feel for the first meet, it's progress."

A further reflection on the High Jump after the hurdles, Morton said that she was feeling great and can't wait until the next meet where she'll seek to clear the 1.70m qualifying mark. "My coach told me that we have to work on that specific part of the run up and try to have more consistency on my run up," she noted about helping her to arch better while clearing the bar. "I have to watch YouTube videos on arching."

With the exception of two coaches, two other athletes and officials, there were no fans witnessing her performance during the morning session—the only event on the schedule. "If I get to jump in the afternoon," Morton said. "I feel it would be motivating because people would be cheering me on."

When asked, what would clearing 1.81m and qualifying for the World Jr. Championships in Lima, Peru this summer mean, Morton who never heard of Lima before, said if she qualifies, wouldn't have expected to get there as it wasn't in her consciousness last year.

"It would be a great experience like the Commonwealth Youth Games," she said. "I feel that it would be on the same competitive level."

When she opened her season on Jan 6, she high jumped in the morning and two hours later, ran the 400m Hurdles. "The last 100m, I don't know what happened, but my legs locked up," she said.

Meanwhile, in becoming the first Carifta Games qualifier, Frett ran his 100m in 11.14 seconds into a -1.6 meters per second wind. Jahshani Farrington and Jonathan Lynch, Carifta Games 800m finalists in 2023, opened their respective campaigns with a 2:00.40 and 2:01.92 seconds, respectively.

BVI National Surfing Association formed as newest sports body

Surfing became the latest organization to elect an executive body, when a British Virgin Islands National Surf Association was formed on January 12. Alec "Woo" Dick-Read who was elected as the first chairman, told Island Sun Sports that the association was formed because there's a small window of opportunity to send surfers to Puerto Rico, in an attempt to qualify for the Paris Olympic Games, this summer.

"The BVI up to now, hasn't had an association that could join into that Olympic pipeline," he noted. "We have some candidates on island who would do really well and we tried to set it up that way so we might squeeze into that window. That's the short-term goal. But the

most important part is setting it up so that youths of the BVI can know that this is a channel that they can use their athletic abilities, go to the Olympic Games and win golds for the BVI."

Dick-Read, who's also association chairman, said he's hoping that by setting up the association, future BVI surfers can win medals in the international sphere.

"The people that win at the moment, the top, top athletes in surfing, they come from places where the waves aren't as good as what we have in the BVI," he said. "So we have potential here to send people. Hopefully with this, this can be a channel where we can enable them."

Dick-Read said that the association not only covers surfing but other board sports including long board surfers, stand up paddle board surfers. "There are variations on surfing that we want them to be represented and to be able to use this structure for those different variations of the sport that exists," he stated.

He said one of the top priorities is to encourage BVI children to learn to swim. That's the baseline for what they do in surfing and the baseline for so many other activities as well as safety and enjoyment of the BVI. He said that's the underlying philosophy they're built on. The association will be seeking sponsorship and every member who pays the \$10 membership fee, they will get a Red Cross lifesaving certification from courses offered.

"We hope that all our surfers in the BVI will be a network of lifesavers who are there if necessary, if anybody gets in trouble," he said.

"It's almost like that right now, but if you join the association, hopefully we can find a sponsor to give that small basic instruction."

Studies have shown that traditional diversifiers (such as bonds and alternative assets) often fail during times of market stress or instability. Even a small allocation of gold has been proven to significantly improve the consistency of portfolio performance during both stable and unstable financial periods.

Gold improves the stability and predictability of returns. It is not correlated with other assets because the gold price is not driven by the same factors that drive the performance of other assets. Gold is also significantly less volatile than practically all equity indices.

The value of gold, in terms of real goods and services that it can buy has remained remarkably stable. In contrast, the purchasing power of many currencies has generally declined.

Traditionally, access to the gold market has been through: investment in physical gold, usually as gold coins or small bars, or, for larger quantities, by way of the over the counter market; gold futures and options; gold mining equities, often packaged in gold-oriented mutual funds.

WHY YOU SHOULD CARE AT ALL ABOUT CHOOSING A BANK




- 1. Location: While choosing a bank, you must consider the location. If you wish to access your bank account regularly then you should choose a bank located near to your business place or home.







ACTION ON CRIMINAL GANGS AND GUNS IS URGENT

The Ecuador, once celebrated for its tranquillity, now finds itself at the epicentre of a distressing surge in gang violence, its streets marred

by the ominous shadow of armed groups fuelled by the trafficking of illicit drugs.

On January 7, President Daniel Noboa deployed the nation's armed forces to clean up prisons from which gang leaders were directing their criminal activities. This

desperate response came after days of unrest, during which two formidable gang leaders escaped from jail, prison guards were held hostage, and explosive devices wreaked havoc in cities across the country.

These events starkly illustrate a broader crisis, one that extends its menacing grip across Latin America and the Caribbean.

Ecuador, nestled between the world's two largest cocaine Colombia and Peru, producers, faces the dire consequences of its geographic vulnerability. The United Nations Global Report on Cocaine 2023 reveals a record surge in cocaine production, with Ecuador serving as a tragic victim of its easily accessible coastal routes.

However, Ecuador's plight is not a solitary narrative; it is a haunting prelude to a region-wide symphony of chaos.

The issue of gangs, guns, and violence cannot be confined within borders. Governments are now awakening to the problem, but it has already spiralled out of control in some nations, while others are

teetering on the brink.

The Caribbean, in particular, stands as a sobering example, with four of the five most murderous countries and territories in the region in 2022 being the Turks and Caicos Islands, Jamaica, Venezuela, St. Lucia, and St. Vincent and the Grenadines. Disturbingly, there were no reliable figures for Haiti, leaving a void in understanding the full extent of the crisis which, in any event, is known to be completely unmanageable.

Statistics for the region reveal

a grim reality; eight out of ten countries with the highest homicide rates in the world are located in Latin America and the Caribbean. The average homicide rates, according to 2021 data, stood at 9.3 per 100,000 for South America, 16.9 per 100,000 for Central America, and 12.7 per 100,000 for the Caribbean.

The Caribbean also grapples with a dual challenge: an influx of illicit firearms, primarily sourced from the United States, and a decrease in funding for crucial security initiatives.

> The United States, despite being a major source of the region's illicit firearm woes,

paradoxically reduced its budget for the Caribbean Basin Security Initiative by 11.8% in fiscal year 2022. This initiative provides vital aid for border and port security, a lifeline desperately needed to combat the influx of weapons.

prevalence The alarming American-made guns in the hands of Caribbean gangs has spurred heads of government to call for stronger U.S. efforts in curbing arms trafficking. In June 2023, Bahamas' Prime Minister, Philip Davis, emphasised to U.S. Vice-President Kamala Harris, the urgency of reducing the flow of illegal guns entering his nation from the United States. However, the U.S. account of the meeting made no mention of this serious concern, not because the Biden government is not troubled by gun crimes, but because it is a domestic political issue in the U.S. Hence, not enough is being done to stop the flow of illegal weapons into the Caribbean.

Even as these nations grapple with the inflow of illegal firearms, their capacity to intercept and prevent such activities remains a significant challenge. Ports of entry often lack the necessary interdiction capacity, and limited enforcement resources hinder their ability to curb the tide of arms. The traffickers exploit the short distances between Caribbean islands, utilizing go-fast boats and yachts to move weapons seamlessly across the extensive coastlines.

Efforts to control and combat this phenomenon have been ongoing since the late 1990s. Despite these efforts, gangs continue to proliferate, fuelled by drug traffickers who arm their criminal enterprises.

Recognizing the urgency and gravity of the situation, during my term as President of the Organization of American States (OAS), I placed the topic of "Guns, gangs, and violence" on the agenda of the Permanent Council.

An expert panel, convened to address the growing crisis, proposed approaches to tackle the root causes and consequences of criminal gang violence, particularly gun-related violence. The resulting Resolution, adopted on December 12, emphasized the necessity for greater collaboration between governmental agencies. It acknowledged that no single state possesses the capacity to match the formidable resources available to organized criminals operating across borders.

The resolution underscored the links between transnational organized crime, criminal gangs, and the vital importance of a cross-border,

collaborative approach.

We strongly proposed that the matter be addressed at the upcoming OAS general assembly in June, with the objective of establishing practical systems of collaboration between Latin American nations and Caribbean states. The criminals are organized; if governments and their law enforcement agencies fail to follow suit, the consequences will be more disastrous than they already are. But this alone, while a start, is not enough. Much more needs to be done. At the regional level, collaboration is paramount, as no single state can confront the vast resources of transnational organized crime independently.

At the national level, robust legislation, effective implementation machinery to punish drug traffickers, and prison reforms to prevent them from becoming recruitment centres are imperative. Equally important is raising awareness among communities about the dangers, consequences, and sanctions associated with membership in criminal gangs and the possession and illegal use of firearms.

As the Caribbean confronts this multifaceted crisis, the imperative is clear: collective, resolute action is not just an option but an absolute necessity. The path forward demands a commitment to national, regional and hemispheric action. Gangs, guns and lawlessness now threaten every person the examples are too many to ignore.
