#### OPPOSITION LEADER DRAWS ATTENTION TO CIVIL SERVANTS PENSIONS BURDEN

Leader of the Opposition Ronnie Skelton Hon. cautioned the Government the about current public service pension commitment which he noted is ballooning and becoming unsustainable.

Over the years various calls have been made to find an alternative to the current pension expense that is borne by the public purse. In fact, the situation which has been lamented in the House of Assembly

for almost two decades has been referred to as an albatross around central government's neck.

While raising the matter during the budget debate Hon. Skelton told the House of Assembly that firm action is needed to remedy the situation. The Leader of the Opposition announced,-"Madam the pension Speaker liability of the government needs attention."

While further lamenting the current situation Hon. Skelton said: "It cannot continue to the way it is going. We can't sustain it, and those of us who have gone before and benefited from it are at risk, because eventually...! Although the law says that pension has the first call on the Consolidated Fund - that doesn't mean that you must be absent-minded

and not do what needs to be done to correct that situation."

#### **SOLUTION TO** PENSION DILEMMA MULLED

In 2022 it was announced that the Government is finally taking action to minimize the cost associated with the current full funded public pension. It was announced that the Ministry of Finance is working on a Comprehensive Pension Plan to reform the pension system. In fact, it was stated that on 14 February, 2022 "an initial meeting was held to discuss a way forward with this initiative."

At that time it was explained that migrating to a contributory scheme was the preferred solution and will ease the current burden. The public was told that the goal is to contributory make pension scheme, thereby removing the contingent liability from the Government and allowing for a system that will have greater flexibility for public officers on their retirement options.

One of the main voices in the call for an alternative solution was pension Auditor General, Sonia Webster. In her 2015 report (Audit Issue 10) Auditor General sounded an alarm on the matter stating that the present funding method mammoth-size unsustainable undertaking by government. Webster

government supports a fully funded pension system for qualifying public servants and legislators. However, she noted that the concerning factor at that time was the realization that over a ten-year period pension and gratuities payments doubled from \$7.6M in 2005 to \$16.5 million in 2015.

She stated: "Currently

the government's pension obligation far exceeds the balance held in its Pension Fund of \$1.05 million."

Nonetheless, the Auditor General explained that an actuarial assessment required to facilitate the introduction of adequate provisions to support this liability. "This requirement especially relevant pending the implementation of IPSAS standards, which require pension obligation

to be disclosed as liabilities in public sector financial reporting."

The situation of the exorbitant pension contribution was brought up in the 2018 Standing Finance Committee deliberations as Director, Human Resources, Michelle Donovan-Stevens noted that there continues to be an increase in the cost of pensions and that the number of retirees had gone up as well.

#### HON. MATHER URGES A COMPREHENSIVE REVIEW OF THE EDUCATION SYSTEM

Speaker Deputy Territorial-At-Large Representative Hon. Stacy Mather is pleading for a thorough examination of the education system within the Territory, coupled with an appeal to the government to steer clear of political maneuvering in the process. The first-time legislator made this entreaty following what was described as a series of unsatisfactory responses during the Standing Finance Committee's-budget deliberations, particularly in response to crucial questions concerning-educational matters.

During his budget debate contribution, Hon. Mather disclosed that his efforts to determine the scale and value of donations received by non-profit organizations, especially those directed toward education the sector, proved to be in vain. Drawing upon his more two decades-long experience in the non-profit sector, he acknowledged

the substantial contributions made by these organizations to the nation, whether through tangible goods or financial support. While he respected the donors' desire anonymity, emphasized that he was not seeking the disclosure of their identities.

" M y - q u e r y - w a s straightforward: what is the worth? However, I am still without a satisfactory answer. I was attempting to convey that the cost of education surpasses the allocated \$65 million in the budget. Yet, I have been unable to obtain a precise figure," he argued.

Moreover, he suggested

that the government should be capable of providing a tangible account of donations to the education sector, whether through the construction of buildings or the provision of school necessities such as chairs and desks.

"As an elected member of this legislative body, I wish to emphasize that when I pose a question, regardless of my junior status, I expect a meaningful response," Mather conveyed to his fellow lawmakers.

Simultaneously, Mather addressed the government's-STEAM-(Science,-Technology, Engineering, Arts, Mathematics) initiative, as well as previous educational policies such as 'No Child Left Behind' and 'From Good to Great' that have been implemented within the sector. He expressed his view that these often served as mere buzzwords that he did not endorse.

the expenditures incurred to date on the STEAM initiative, he was informed that it amounted to \$57,000 in resources.

"If I ask a question, it is because I genuinely seek answers. People out there inquire because they are aware that the government invests in my education, and I am here to give back to my country. Therefore, I beseech us to refrain from politicizing our queries," he urged.

Mather pointed out that the

STEAM initiative failed to address issues such as school altercations - an ongoing concern that has challenged successive administrations. He advocated for a more comprehensive approach to address such challenges within the education system. "I advocate for a comprehensive review of our education system,encompassing resources,personnel, curriculum, policies, and all aspects," he argued."

#### PREMIER DEFENDS TOURISM EFFORTS

Premier and Minister of Finance Dr. the Hon. Natalio Wheatley has clapped back at claims by the Opposition that the Government does not have a plan for the Tourism pillar of the BVI economy.

The criticism was leveled during the recent budget deliberations in the Standing Finance Committee (SFC) by Opposition Member and Sixth District Representative Hon. Myron Walwyn who stated that he came to this conclusion after he posed pressing questions to technocrats but received no satisfactory answers on this subject.

"It appears as though the [tourism] department may be inactive or embroiled in legal disputes... The room fell into a tense silence when I raised this issue, leaving everyone uncertain," the Sixth District Representative disclosed.

He further asserted: "Premier, you were not present; you were engaged in international affairs. However, while you were away, our competitors relentlessly improved their tourism sectors. Meanwhile, we seem to be dragging our feet and misallocating funds on less essential endeavors, neglecting the economic backbone."

Hon. Walwyn further probed the government's investment in the Territory's tourism sector, inquired about efforts to enhance the status quo, and criticized the glaring deficiencies in the Territory's tourism facilities.

"People frequent our beaches with no assurance of finding restroom facilities. Tourists are often left with no choice but to venture into the wild for basic amenities in what should be a premier tourist destination," he underscored.

The Opposition Member questioned the government's optimism in expecting a whopping \$401 million injection into the economy in 2024 without a well-defined tourism plan. He also expressed dismay at the allocation of a \$10 million grant to the Tourist

Board.

Walwyn recounted his exchange with Tourist Board officials, where he learned that the estimated operational expenses to achieve the ambitious \$400 million target amounted to approximately \$8 million.

Highlighting the stark disparity, Mr. Walwyn pointed out that a mere \$1.5 million had been earmarked for marketing efforts to reach the government's tourism goals, and he posed a rhetorical question: "How can a meager \$1.5 million investment generate a massive \$401 million boost to the economy? Such financial arithmetic defies logic in the world of numbers and business."

While firing back at the criticism the BVI Leader said that there was movement in the tourism space. "We talk about having a plan – and we will develop one. But I want to make it clear that this isn't rocket science," the Premier stated. "It's not rocket science. The British Virgin Islands is a

naturally attractive destination that draws people in."

He continued, saying, "We don't need to make a strenuous effort to convince people to visit here. Everyone who comes here speaks about the natural beauty of our islands; they are enchanted by the Virgin Islands. There are just a few straightforward things we need to do, such as ensuring access. It's not a complex issue. We need to provide access to the Virgin Islands."

Premier Wheatley argued that his government is making progress in this direction and commended Communications and Works Minister Kye Rymer for his contributions to the sector, particularly in introducing flights between the BVI and Miami.

According to Hon. Wheatley, the Territory faced airlift challenges after American Airlines terminated operations in Puerto Rico. However, he pointed out that the introduction of direct flights to Miami was a significant milestone

in the Territory, although political considerations might lead some to overlook such accomplishments.

"We' are not stopping here. We are delighted to announce that we have increased our daily flights from one to three," Premier Wheatley noted: "That's truly remarkable."

He concluded by stating, "One issue I have with my government is that we often accomplish things and downplay them. We tend to be modest about our achievements and allow others to criticize our performance."

## USA PROSECUTORS ASSERT THAT FORMER PREMIER VIOLATED US AND BVI LAWS

Miami prosecutors have asserted that former British Islands Premier Virgin Andrew Fahie not only violated U.S. law in an alleged cocaine smuggling money laundering scheme but should also be held accountable for his violations of BVI laws. In court filings published on 27 December, prosecutors argued that Fahie, who has entered a plea of not guilty, transgressed BVI laws related to the importation and distribution of controlled substances. Furthermore, they contended that he ran afoul of laws specifically designed to prevent bribery and embezzlement schemes


involving both the United States and the British Virgin Islands.

Fahie's legal team objected, citing a lack of adequate prior notice regarding the inclusion of foreign laws, particularly with the trial set to commence on 10 January. Nonetheless, prosecutors informed the court that a thorough examination of charging documents dating back to at least May 2022 unmistakably demonstrate an intention to hold Fahie accountable for violating BVI laws as well.

On 28 April, Fahie and former Ports Authority Director-Oleanvine Pickering Maynard were

arrested after disembarking from a private plane where they allegedly inspected a \$700,000 down payment related to their involvement in a significant cocaine smuggling conspiracy.

An individual identified only as R.S., who remains uncharged,-was-also apprehended-alongside Pickering Maynard. In recent court filings, Fahie's attorney used female pronouns when referring to R.S. While Pickering Maynard and her son Kadeem Maynard pleaded guilty in June to single counts of conspiracy to import cocaine, Fahie has steadfastly maintained his innocence.



## Government Launches Website To Track COI Recommendations Implementation

The Government of the Virgin Islands is forging ahead with efforts to enhance the delivery of services to the people of the Virgin Islands, with the launch of a dedicated website to track the implementation of the Commission of Inquiry (COI) recommendations.

This is in line with the Virgin Islands Modern Governance Approach, "Government Business at its Best", launched at the end of July last year, to further the implementation of the recommendations of the COI Report.

On January 19, 2021, the United Kingdom appointed a Commissioner to inquire into possible corruption, abuse of office or other serious dishonesty by public officials in recent years. The inquiry considered the conditions which may have

allowed such conduct to take place and whether they still existed. Commissioner, The Rt. Hon. Sir Gary Hickinbottom, made 50 recommendations to improve the standards of governance and the operations of law enforcement agencies in the Territory.

In presenting his latest report to the House of Assembly in September 2023, Premier of the Virgin Islands, Honourable Dr. Natatio D. Wheatley, announced that work had begun on all the recommendations. He reported that several reviews audits have been completed, covering Social Assistance Grants, Education Grants, the Disposal of Crown Lands, the Policy for Granting Residence and Belonger Status, and the reappointment of Statutory Boards.

Regarding the Modern Governance Approach, the Premier said, "The purpose of this initiative is to inform and educate the public and stakeholders on Government's continued reform initiatives going beyond the Framework recommendations. aimed at correcting inaccurate, misinformed, or misleading perceptions about the work that the public Government and officers do. This is also in line with the Government's commitment to transparency and accountability."

Another-significant initiative, -as-efforts continue to show how the reform work will effect change, is the launch of the COI Recommendations Implementation Tracker Wednesday website last January 3, 2024. website was introduced the Government during programme 'Table Talk', to be aired live at 11:00 a.m. on the Government's Facebook Page, ZBVI Radio 780AM and CBN Radio.

Permanent Secretary in the Premier's Office, Mrs. Carolyn Stoutt-Igwe, said, "It is very important for the public to be informed about the new policies being implemented to transform the way we do business. This website will be a one stop shop for all COI related information and for the public to follow along as public officers' work towards greater accountability and transparency."

The-website provides-information on the Framework Implementation the Recommendations of the Commission of Inquiry Report and other Reforms; an overview of the recommendations; and will include all press releases. statements and other information about process relating to this Modern Governance Approach.

Mrs. Stoutt-Igwe thanked all public officers for their dedication and commitment to providing 'Government Business at its Best'. She encouraged the public to log on to the website once launched to browse the features. become more informed on the work of Government, and contact the COI Implementation Unit with any questions or comments.

#### Kyron McMaster To Receive OBE for His Services to Sports in the British Virgin Islands

Mr. Kyron McMaster is the Territory's newest recipient of an OBE from His Majesty The King for his contributions to sport in the British Virgin Islands.

Kyron McMaster, at 21

years old, won the British Virgin Islands' first ever Commonwealth Games medal after placing 1st in the 400m hurdles at the Gold Coast 2018 Games in Australia. This was in the aftermath of the 2017 devastating hurricane, which destroyed homes, livelihoods and all training facilities. The hurricane also sadly claimed the life of McMaster's coach and

mentor, Coach Xavier "Dag" Samuels.

McMaster has since gone on to win the Diamond League achieve twice. another Commonwealth gold at the Birmingham 2022 Games, and win a silver at the World Track and Field Championships in Budapest 2023 - the first ever medal for the British Virgin Islands at this championship event. He also finished 4th place finalist at the Tokyo 2020 Olympic Games, where despite the COVID-19 restrictions that had hampered training, he achieved a National Record time of 47.08.

On visits home, McMaster dedicates his time to supporting young people, using his own experiences growing up on Tortola to share lessons learned. He also champions grass roots sports, working with the Ministry of Education, Culture, Youth Affairs and Sports to ensure it gets the investment needed.

His Excellency Governor John Rankin CMG said:

"I am delighted that this award has been made in recognition of Kyron's



outstanding achievements and unparalleled service to the Virgin Islands.

With his two Commonwealth Golds Medals and World Champion Silver medal, Kyron has placed BVI on the sporting map across the world and given cause for national celebration even in some of the most challenging times in the aftermath of the 2017 hurricane.

Off the track, Kyron continues to inspire, using his own experience to motivate young students and athletes.

I offer my warmest congratulations to Kyron".

#### **Derelict Vehicles Cleared From Throughout The Territory**

The Department of Waste Management has stepped up its effort to rid the Virgin Islands of derelict vehicles as the year draws to a close.

Director of the Department of Waste Management Mr. Marcus Solomon said the department managed to tag and successfully move over seven hundred derelict vehicles from the Virgin Islands. The derelicts were taken from both Tortola and Virgin Gorda.

Mr. Solomon said, "We have also removed scrap metals as well as bulk waste such as refrigerators, stoves, washing machines and BVI Electricity Corporation scrap metals. So, those are the materials we are currently processing to export out of the country. We just want to thank members of the public for helping us identify the scrap metals and derelict vehicles that needed to be removed so that we can keep the Territory clean."

The clearance project is being undertaken by local company KNJ General Maintenance. Operations began on December 11 in Virgin Gorda before moving to Tortola on December 13.

Earlier this year, KNJ General Maintenance processed and removed over two thousand tons of derelict vehicles and other scrap metals from the Virgin Islands. The scrap metal was exported to Colombia where it was used for recycling purposes.

Mr. Solomon said he hopes the project will be completed in the coming days.

"We want to finish the operation and bring back the storage area to a pristine state again. So, all the derelict vehicles will be on the barge and those items that are not for the barge will be moved to our Pockwood Pond site," the Director of the Department of Waste Management said.

The Ministry of Health and Social Development through the Department of Waste Management is committed to transforming and implementing innovative ideas and strategies to manage waste in the Virgin Islands.

#### The UWI Mourns the Loss of a Titan of Leadership in Basdeo Panday

Regional Headquarters, Jamaica W.I. Wednesday, January 3, 2024-The University of the West Indies (The UWI) expresses its heartfelt condolences on the passing of the Honourable Basdeo Panday. An indomitable spirit, whose legacy as a former Prime Minister of Trinidad and Tobago echoes with grandeur and reverence, Mr. Panday's tenure as Prime Minister and as the visionary founder and leader of the United National Congress (UNC) was marked by an unyielding commitment to the upliftment of his nation and its people.

In response to the news, and speaking on behalf of the regional institution, the Vice-Chancellor of The UWI, Professor Sir Hilary Beckles extends condolences to Mr. Panday's family and noted, "We remember Mr. Panday's support to our regional university during his term

as Prime Minister, and his notable initiatives such as the School-Building and Dollarfor-Dollar Programmes, aimed at enhancing education in Trinidad and Tobago."

His own eclectic career path, which spanned diverse roles including that of a primary school teacher and a civil servant among others, set the stage for his pursuit of higher education in Law, Economics and Drama. His zeal for transformative change deeply rooted, stemming from a lifetime dedicated to battling against the odds - from the courtrooms to the heart of the labour movement, all the way to the halls of Parliament.

In reflecting on the monumental

loss of such a venerable figure, Professor Indar Ramnarine Acting Principal of the St. Augustine Campus expressed that "Mr. Panday was a titan in the political arena, and his multifaceted life was a testament to his profound devotion to his country and family. He was not just a politician, but a man of many talents who inspired many. His legacy is outlined in his own words when he stated, 'If you see me and a lion fighting, don't feel sorry for me, feel sorry for the lion,' encapsulating the formidable tenacity and relentless courage that defined his remarkable journey."

In a powerful statement during the 2012 "Conversations with Prime Ministers" event, Mr. Panday addressed the concept of legacy by declaring that shaping one's legacy isn't a personal choice, as "history writes your legacy." 

USA - Among the dozens of greetings with which celebrities, sports entities, governments, or institutions sent us Christmas best wishes from their social networks, the one that stood out for me was that of Barack Obama. Perhaps you will be disappointed, because you will not find anything particularly striking in it. The former U.S. president appears standing in an austere room decorated with a pair of poinsettias. Wearing a gray sweater and a Santa Claus hat, Obama reminds us, in a 45-second video, of the importance of participating in the lives of those around us and collaborating with those communities closest to us, the strongest support networks in difficult times. A simple piano melody accompanies Obama's words, which end when he holds up a pink banner bearing two words: "Merry Christmas." From a staging point of view, the video is rudimentary, with no editing, an innocuous backdrop and a sequence shot of a man speaking into the camera lens. However, it gives off a powerful message of vindication of the simple, of communication with a human dimension, of a return to the essential.

This year has tested us in many ways, but Christmas is a reminder of the power of community to keep us together even in difficult times. Wishing you all a peaceful holiday. [El Paisl

PARIS - Turkish President Tayyip Recep Erdogan and Israeli Prime Minister Benjamin Netanyahu became entangled in yet another Hitler quarrel on Wednesday after the former said that the Israeli leader was no different from

"They used to speak ill of [German Nazi leader Adolf] Hitler. What difference do you have from Hitler? They are going to make us miss Hitler. Is what this Netanyahu is doing any less than what Hitler did?

It is not," Erdogan said.

"He is richer than Hitler, he gets the support from the West. All sorts of support comes from the United States. And what did they do with all this support? They killed more than 20,000 Gazans," Erdogan continued.

The comments drew sharp rebuke not just from Netanyahu but also other Israeli leaders.

In exchange, Netanyahu accused Erdogan of carrying out "genocide against the Kurds."

Erdogan "holds [the] world record of imprisoning journalists who object [to] his regime" and "is the last one to give us a lesson in morals," he wrote on social media platform X, formerly known as Twitter.

Netanyahu added that the Israeli army is fighting "against the most despicable and cruel terrorist organization in the world, Hamas-Daesh, which perpetrated crimes against humanity, an organization Erdogan is praising and is hosting its senior officials." [Al Monitor

UK-SPAIN - On January 31, obligatory sanitary and phytosanitary controls agricultural and livestock products crossing the English Channel will finally come into force. The EU immediately applied them to all products coming from the island. The United Kingdom has already delayed applying these controls as many as five times. The government is aware of the chaos that could be caused

to its importers, and above all is fearful that prices of grocery items that are already more expensive this year due to runaway inflation will skyrocket.

Sources from the Spanish Economic and Commercial Office in London say that what happens in just over a month will be very important when it comes to verifying, once again, whether or not the obstacles created by Brexit can be overcome.

At the end of August, the British government presented its new Border Target Operating Model. The apparently more simplified method for carrying out security and health controls on imports and exports includes smart seals and GPS locators on many of the products.

The new controls will be rolled out in phases over the next year. From January 31, health certificates for mediumrisk animal and plant products from the EU will be introduced. It will not be until April 30 if the announced deadlines are finally met - that British customs officials will carry out physical and identity checks on many of these products and demand the mandatory documents from the importer.



The police force states the victims of this horrific incident include an 18-year-old man and a 74-year-old man, whose lives were tragically cut short.

"In response to this incident, our law enforcement agencies have launched an active investigation to bring those responsible to justice. We are committed to ensuring the safety and security of our community, and we need your assistance in this matter."

The Royal Anguilla Police Force is appealing to anyone who may have witnessed the incident or has any related information to come forward.

SANTO DOMINGO .-Tourism entrepreneur Frank Rainieri, the founder of the Puntacana Group, expressed approval of the Supreme Court of Justice's decision to uphold the suspension of the Bávaro International Airport (AIB) construction. Speaking at a ceremony celebrating the arrival of the 10 millionth tourist at the Punta Cana terminal, Rainieri emphasized the need for such infrastructure projects to be part of a national planning strategy and adhere to local regulations.

The Supreme Court's ruling rejected an appeal from the Bávaro International Airport, which sought to overturn a decision by the Civil Aviation Institute (IDAC) that deemed the airport project detrimental to the national interest. Consequently, the original concept and approval of the AIB project were dismissed.

Rainieri applauded independence demonstrated by the Supreme Court and its judges, who faced significant pressure but ultimately delivered a unanimous decision. He raised concerns about the rapid authorization process for the AIB, [Dominican Today]



## Spice Up Your Winter With Easy Pumpkin Chili

Every year, the week before Halloween, we host a little pumpkin carving party. Since I'm an enthusiast of inexpensive, nearly effortless entertaining, I'll be making pumpkin chili for our pumpkin party. I just get it in the pot in the morning to have a super simple supper ready in the afternoon. This scrumptious recipe feeds a crowd, smells divine and always gets raves.

It's the perfect chili to serve on Halloween because it's family-friendly comfort food with lots of protein to counter all the trick-or-treat goodies. And just look at all these veggies! There are tomatoes, peppers, onion, beans, chilies and, of course, pumpkin, It's practically

virtuous!

One thing you'll love about this pumpkin chili is that it's exceptionally thick, more like a stew really. If you want to serve the chili as soup rather than stew, just add a can of beef, chicken or vegetable broth.

Ordinarily you'd serve cornbread or corn muffins with chili, but to give this a little va-va-voom, let's serve it over cornbread waffles. Doesn't that sound ridiculously good? Yes, indeed!

#### EASY PUMPKIN CHILI

Yield: 8 servings Prep: 20 minutes Cook: 4 to 8 hours

This chili can be made in a crock pot or on the stovetop. It comes together really

quickly; other than browning the sausage and onion, most of your time will be spent opening cans.

1 tablespoon olive oil

16 ounces sweet Italian sausage

1 sweet onion, chopped

1 (6 ounce) can tomato paste

2 bell peppers, any color, chopped

1 (14.5 ounce) can tomato sauce

1 (14.5 ounce) can diced tomatoes

1 (28 ounce) can pure pumpkin puree

2 (14 ounce) cans beans of your choice, rinsed and drained

1 (4 ounce) can of green chilies

2 tablespoons chili powder

1 tablespoon cumin

1. In a stockpot, or a medium skillet if using slow cooker, heat the

medium skillet if using slow cooker, heat the olive oil and brown the sausage with the chopped onions until sausage is nearly cooked through. Add the tomato paste, mix it all together and continue to cook until the tomato paste is lightly browned and caramelized in spots.

2. If you're using a slow cooker, place in the meat, onions and tomato. Add remaining ingredients to the slow cooker and give it a good stir. Set on HIGH for 4-5 hours or LOW for 8 hours.

If you're cooking on the stovetop, add the rest of the ingredients and simmer on lowest heat, stirring often, for 4 hours.



 Serve chili spooned over cornbread waffles garnished with sour cream and shredded cheese.

Substitutions: If you'd like, you can substitute turkey Italian sausage or make this vegetarian by using an Italian seasoned meat alternative. This recipe calls for fresh bell peppers, but feel free to substitute one (14 ounce) bag frozen bell peppers, or use frozen pepper and onion blend, and omit the sweet onion.

#### **CORNBREAD WAFFLES**

Yield: 6 waffles Time: 15 minutes

There is a time and place for baking from scratch. This isn't one of them.

1 (8.5 ounce) package corn muffin mix

1 egg

3/4 cup milk


2 tablespoons butter, melted

Preheat your waffle iron. Blend all ingredients together (batter might be lumpy, but that's OK). Proceed to make waffles according to your waffle iron's directions. It's incredibly easy, but take credit for being a culinary genius anyway.

- 1. Take proactive measures by recording dinghy serial numbers to aid in case of theft.
- 2. Remove the kill cord when

the dinghy is not in use.

- 3. Hoist the dinghy when it is not in use, particularly during nighttime.
- 4. Secure the outboard motor to the dinghy with a lock.
- distinctive Engrave markings on the dinghy for easy identification.
- 6. Regularly check on the dinghy to ensure it remains in its place.
- 7. Install a tracker on your dinghy, if possible.

8. In the event of theft, promptly notify the RVIPF's Marine Unit at 368-9642 or 311.

Sergeant Padmore of the Marine Unit emphasizes, "Frequently when a dinghy is reported stolen, we find that these incidents could have been prevented with proper preventative measures and Hence, we are issuing these specific reminders to boaters to reduce such occurrences."







# THIS WEEK IN CORRUPTION WHISTLEBLOWER PROTECTION ACROSS THE EU

Whistleblowers like Antoine Deltour, Zuzana Hlávková and Andrea Franzoso have all faced great personal and professional ramifications by exposing corruption and wrong doing in the public interest.

Whistleblower protection legislation remains the exception rather than the rule in the EU. Most Member States do not have dedicated legislation in place, and even in the few countries where such laws do exist, they usually leave significant loopholes and fall short of good practice.

As a result, European citizens remain largely unprotected in case they take the decision to speak up, facing the risk of retaliation, judicial proceedings and dismissal. This, in turn, leaves suspected cases of fraud, corruption and other malpractice unattended - a huge potential to fight such practices is lost.

Now is the time for the EU to bring forward comprehensive legal protection for whistleblowers that which to expose the truth.

Over the last three years we have worked with a board coalitions of EU national chapters, civil society organisations, trade unions and journalist associations. In October 2017, the European Parliament adopted a strong own-initiative report in favour of a horizontal Directive on whistleblower protection, in line with international principles, including those of TI. Following the Commission's legislative proposal in April 2018, the Parliament adopted a series of committee

opinions and ultimately a Legal Affairs committee report, in November 2018, which incorporated numerous key TI policy recommendations. There was also progress made with the Austrian and Romanian Council Presidencies, especially when negotiations began with the Parliament in early 2019.

In April 2019 the European Parliament and EU Council came to a preliminary agreement on the EU Directive that incorporates many of our key recommendations. When it is formally adopted by the Parliament and Council, scheduled for early October, Member States will have two years year to transpose the Directive. We will continue to work to ensure that national governments carry out a rigorous transposition process that strengthens the existing minimum standards set out in the directive to ensure EU citizens are finally afforded protections to speak up.

#### About Whistleblowing

A key challenge in preventing and fighting corruption is to detect and expose bribery, fraud, theft of public funds and other acts of wrongdoing. One of the most direct methods of shining the light on corruption is whistleblowing. Unfortunately, whistleblowers commonly face retaliation in the form of harassment, firing, blacklisting, threats and even physical violence, and their disclosures are routinely ignored.

We work to ensure that the EU institutions are fulfilling their legal obligations to provide comprehensive and robust protections for EU staff whistleblowers. We are also currently advocating for the Commission to come forward for a proposal for an EU directive on whistleblower protection.

#### Social Capital

If capital drives wealth, power, and inequality, any attempt to create greater equality will involve capital too, and its management and ownership.

That capitalism rules the 21st century is not in dispute. In fact, the history of the world post the Industrial Revolution of the 1700s is the story of capitalism and its ascendance as the undisputed ideology of the modern world.

Capitalism, the thinking behind capital and its ownership has triumphed over socialism and communism, two ideas at the other end of the social and economic spectrum.

Capital governs politics, society, and power in all cultures. The failure to recognize the fact of capital is a limitation for any aspiring politician, thinker, or entrepreneur. The relationship between power and capital is symbiotic: the

two chained together.

A number of economists argue that the triumph of capital and the resulting social inequality it creates is not a good thing. Wealth concentrated in the hands of the tiniest number of people will concentrate power to such a degree that it will eventually affect humanity in ways that may well be unsustainable.

Today, 100 families control the world economy. Populism and a right wing backlash in the west is the result of that concentration of wealth and resulting inequality. Then social anger was the catalyst for fascism, volatility, and war for decades.

However, there is no evidence capitaliststhe owners of capitalare threatened. The concentration of wealth and power in their hands continues unrelentingly. The capitalist culture grows without limit, even in former communist states such as China, Russia, and Vietnam.

The struggle between capital and those who demand greater equality has been an ongoing tale. Civil wars in Europe, the two world wars, the Cold war, and conflicts in Asia, Africa and the Middle East are a continuation of the story of

the thrust of capital to the top of the world's power pyramid.

Behind every war is capital. The struggle between capital and communism resulted in civil war in Spain in the 1930s and offered European fascists a rallying point: Hitler, Mussolini and Franco.

The prevailing power of capital is a reality of history where nations with the optimum capital mix tend to prevail in war and peace. That was the story of the USA in the Pacific between 1941- and 1945, against the Empire of Japan. The influences of capital and the control of capital starts and ends wars.

In World War 2, Germany lost when it overstretched its own capital mix enterprise, machinery, raw materials, technology, laborattempting to fight wars on multiple fronts in the north, south, east, and west. Japan too, simply did not possess the vast capital mix its US enemy brought to bear in the Pacific War after the attack on Pearl Harbor in 1941. US capital won the Second World War. Russia relied on American capital to march into Berlin in 1945 just as US capital drove the allies to victory.

History has revealed

that greater equality will not come about through violence, the barrel of the gun, as the owners of capital have the upper hand in the game of power. Greater equality can come about only through the democratic process and a recognition by the powerful capitalist that it is in his interest that there be a fairer distribution of wealth and power.

One way in which greater equality is established is through the idea of social capital.

Social capital is another term for public investment. Social capital is capital that drives the highest quality of life for the poor and the most vulnerable: public healthcare, free education, public transportation, social welfare, agricultural cooperatives, public housing, community police, and so on and so forth.


The quality of a country's social capital depends primarily on the tax regime: taxing the rich to invest in the underprivileged. Nevertheless, social capital

benefits the high-income earner and the rich too, by ensuring a safer community with essential public services available to all, rich and poor.

Social capital decides the standard of living of a country, arguably as much as a country's private capital: private industry and business. Private capital adopts GDP as a measure of economic output. Social capital also adopts GDP as measure, but quality of life is crucial to outcomes in the social capital mix.

The quality and management of a country's social capital has reaching effects on the standard of living, quite apart from GDP. Countries, such as those in Northern Europe, with the highest standards of living in the world possess a mix of social capital that has ensured very high levels of wellbeing for their populations. Those countries also tax at a very high rate, which is anathema to Jack the Capitalist.

## **Huge Number of Migrants Highlights Border Crisis**

U.S. officials processed an estimated 300,000 people at the U.S. border with Mexico in December, which would be the highest number ever recorded, according to multiple news organizations.

While the Department of Homeland Security will release the December numbers later this month, Reuters and other news organizations estimate that 300,000 people attempted to cross the border in the final month of 2023, with about 50,000 of them coming through designated points of entry.

Those estimates suggest that the first three months of fiscal 2024, which began in October, will set a record. Experts said multiple factors are causing migrants — many from as far away as Asia, Africa and the Middle East — to come to the U.S. border, either legally, as asylum-seekers, or illegally.

The record-level border encounters come as the U.S. enters a presidential election year in which the topic of immigration is expected to play a major role.

President Joe Biden, expected to receive the Democratic nomination, has repeatedly said that immigrants are one of the country's strengths, even as he has taken steps to curb the current influx. Former President Donald Trump, the prohibitive favorite to win the Republican nomination, has long advocated for tighter control on immigration and has frequently used incendiary

language to describe immigrants to the U.S.

#### 'Push' and 'pull' factors

Michelle Mittelstadt, director of communications and public affairs for the Migration Policy Institute, told VOA that multiple factors have contributed to the elevated number of migrants at the southern border.

Mittelstadt said that many migrants arriving at the border have been "pushed" out of their own countries by economic and political upheaval, natural disasters, and other crises. For example, the collapse of the Venezuelan economy over the past decade has driven about 8 million people from that country. While many have found refuge in other South American countries, such as Colombia, hundreds of thousands have made the long and dangerous trek to the U.S.

Other factors contribute to "pull" migrants to the U.S., including the strength of the country's economy, which currently has two open jobs for every American seeking work. Mittelstadt said that what she called the growing professionalization of human smuggling organizations has also made the gamble of migration seem more appealing, and that the possibility that Trump might be reelected in 2024 has encouraged many migrants to attempt to cross the border before stricter immigration measures can be put in place.

Hovering above all these factors is the glaring evidence that the American system for processing asylum-seekers is deeply broken: Individuals admitted to the country while their claims are assessed frequently wait several years before they receive a hearing in an immigration court. More than 3 million cases are pending, more than 1 million of which were added in the past 12 months.

"It's hard to see that any of these factors are going to lessen anytime soon, even were there to be very sharp policy changes by the U.S. government," Mittelstadt said.

Spreading crisis

States along the southern border have long complained about the increased number of migrants crossing into the U.S. On multiple occasions, small border towns have faced sudden influxes of thousands of migrants in the space of a few days.

Leaders of border states, such as Texas Governor Greg Abbott, have complained that the federal government's response to the crisis has been insufficient, both in terms of policy responses that would reduce the flow of migrants and in terms of providing assistance in managing the care of the vast numbers who do cross the border.

In the past year Abbott, in particular, has accelerated a program under which Texas transports large groups of migrants, by bus or by plane, to major U.S. cities, typically run by Democratic mayors, such as New York and Chicago.

In recent months, the leaders of cities that have received tens of thousands of immigrants in this fashion have begun trying to stem the flow. In New York, Mayor Eric Adams issued an executive order restricting the entry of migrant buses to certain times and drop-off points. In response, many of the buses have simply stopped near mass transit stations in neighboring New Jersey and directing passengers to use public transportation into New York.

#### Dialogue with Mexico

The Biden administration has taken steps to address the crisis, including disrupting human smuggling organizations, accelerating certain kinds of deportations, deploying military assets to support Border Patrol and immigration officers, and expanding facilities to hold and process asylum-seekers and other migrants.

Last week, Secretary of State

Antony Blinken led a U.S. delegation to Mexico for talks with the administration of President Andrés Manuel López Obrador on reducing the flow of migrants.

In a statement, López Obrador said the discussions had led to "important agreements," though no details were released.

#### Biden criticized

Biden, as a presidential candidate, signaled an openness to asylumseekers and immigrants.

During a presidential debate in 2020, then-candidate Biden defended the practice of allowing individuals seeking asylum to remain in the U.S. indefinitely while their cases were processed, saying, "You come to the United States and you make your case that, 'I seek asylum based on the following premise, why I deserve it under American law."

Conservative organizations in favor of stricter immigration enforcement say the results of the president's policies have been clear and predictable.

"Before even taking office, Biden sent a clear message to wouldbe illegal immigrants worldwide that they had a high chance of being released into the U.S."

said Simon Hankinson, a senior research fellow with the Heritage Foundation's Center for Border Security and Immigration.

In recent weeks, Republicans in Congress have refused to consider major foreign aid packages to Ukraine and Israel unless they are tied to significant immigration reforms.

In an appearance on CBS on Sunday, Senator Lindsey Graham put his position on the matter succinctly: "When you come to our border, we say, 'I'm sorry, we're full.""

On the same program, Denver Mayor Mike Johnston pushed back against the idea that the country is full, saying cities like his are only asking for orderly arrivals of migrants.

"What we don't want is people arriving at two in the morning at a city and county building with women and children outside in 10-degree weather and no support," he said. "And so, we want buses here to do what every other bus does, which is land at a bus station and a bus stop at hours when we can have staff there to receive them and to direct them toward services."

#### Sugar Boys, VG United players penalized, points deducted after mass confrontation

FOOTBALL

Sugar Boys and VG United lost their respective appeals, in a judgement handed down by the BVIFA Disciplinary Committee today, as several players will receive sanctions of up to seven games and three points deducted from both Sugar Boys and VG United respectively, following a December 3 mass confrontation that prematurely ended the game played on Virgin Gorda.

In its statement, the Disciplinary Committee stated that according to the referee's report, the incident involved 30 to 40 people and involved a number of individuals fighting and was in fact "a mass confrontation."

"The Sugar Boys disputed the referee's report. They stated that Keron Daniel was not an instigator contrary to the report and that the punishments were too harsh," the Disciplinary Committee noted. "The Disciplinary Committee has no power to interfere with the factual findings of the Referee's

Report, except where there is a bad faith, malicious intent, fraud or a grave error, in accordance with the Doctrine of the Field of Play."

Furthermore, it said, the only grave error that the Disciplinary Committee found in the Referee's Report was that it was noted that Romaine Henry entered the field of play, when in fact Romaine Henry was always on the field of play.

"The Disciplinary Committee states in the strongest possible terms that participation in a mass confrontation is one of the gravest offenses in football. It not only brings the BVIFA into disrepute, but puts members of the public, match officials and team members in danger of being injured, as evidenced by the example of Keron Daniel leaving the field of play to search for "something" in order to return to the field of play to "defend" himself in the mass confrontation," the statement said. "That something happened to be a rock and had he hit someone with that rock, he could have caused severe injury and would have caused the authorities in the Virgin Islands to be wary of events held by the BVIFA and may very well have exposed the BVIFA to civil

Furthermore, the Disciplinary Committee, finds that it is immaterial as to whether it was Keron Daniel that instigated the mass confrontation or whether it was someone else, participation in a mass confrontation is unacceptable.

"As a consequence, the Disciplinary Committee orders the deduction of 3 points from Sugar Boys and 3 points from VG United," the statement said. "The individual punishments pursuant Rule 6.5.1 of are broken down as follows:"

 a. Keron Daniels shall be banned for 7 matches for participating in a mass confrontation and picking up a weapon.

 Joshua Ramprashad shall be banned 7 matches for participating in a mass confrontation and charging onto a field of play.

c. T'Khoy Morton shall be banned from 6 matches. He may still perform national duties and attend practices unless the Executive Committee decides otherwise.

d. Quelahni Nickie shall be banned for 6 matches and shall be banned from attending BVIFA sponsored matches/games for the duration of his suspension, due to the fact that he ran on to field of play despite serving

a suspension from a previous match.

 e. Oral Perry shall be banned for 6 matches for participating in a mass confrontation.

f. Andres Bailey shall be banned for 7 matches for participating in a mass confrontation and entering the field of play.

g.Bernard-Cumberbatch shall be banned or 6 matches for participating in a mass confrontation.

2. Romaine Henry's ban is overturned by virtue of the fact that he prevented

Keron Daniel's from re-entering the field of play with a rock pursuant to Rule 6.5.2.

#### 400m Hurdler Kyron McMaster honored with OBE



400m Hurdler Kyron McMaster, is the territory's newest recipient of an Order of the British Empire (OBE) from His Majesty The King for his contributions to sport in the territory and will become the first athlete to receive the honor which are traditionally announced during King Charles III New Year's honors.

"I am delighted that this award has been made in recognition of Kyron's outstanding achievements and unparalleled service to the Virgin Islands," Gov John Rankin said in a statement. "With his two Commonwealth gold Medals and World Champion Silver medal, Kyron has placed the BVI on the sporting map across the world and given cause for national celebration even in some

of the most challenging times in the aftermath of the 2017 hurricane. Off the track, Kyron continues to inspire, using his own experience to motivate young students and athletes. I offer my warmest congratulations to Kyron."

During the World Athletics Championships in Budapest, Hungary in August, he won the BVI's first senior outdoor championships medal in the 400m Hurdles. In 2016, he won 400m Hurdles bronze in the World Jr. Championships, the first and only athlete to do so, so far.

At 21, Kyron won the BVI's first ever Commonwealth Games medal when he won the 400m hurdles at the Gold Coast 2018 Games in Australia. This was in the aftermath of the 2017 devastating hurricane, which destroyed homes, livelihoods and all training facilities. The hurricane also sadly claimed the life of his coach and mentor, Coach Xavier "Dag" Samuels.

He has since gone on to win the Diamond League trophy twice, achieve another Commonwealth gold at the Birmingham 2022 Games, before winning silver at the World Track and Field Championships in Budapest 2023. He was fourth in the Tokyo 2020 Olympic Games, where despite the COVID-19 restrictions that had hampered training, he established a National Record time of 47.08 seconds.

Kyron has also won the NACAC Championships twice and the CAC Games 400m Hurdles. An injury kept him out of the 2019 Pan Am Games and he skipped the 2023 version which was held in November.

On visits home, McMaster dedicates his time to supporting young people, using his own experiences growing up on Tortola to share lessons learned. He also champions grassroots sports, working with the Ministry of Education, Culture, Youth Affairs and Sports to ensure it gets the investment needed.


Thus far, he's the only BVI athlete to have qualified for the Paris Olympic Games this summer, which will be his second Olympic Games.



"Gunsmoke" made its TV debut in 1955. It was set in Dodge City, Kansas, in the 1890s and centered on U.S. Marshal Matt Dillon, played by James Arness. Miss Kitty (Amanda Blake) was the red-haired proprietress of the Long Branch Saloon, while Doc Adams (Milburn Stone) was the town doctor. There was indeed a Chester: Deputy Marshal Chester Goode, played by Dennis Weaver, who left the series in 1964.

Blake started out on the stage before MGM studios discovered her, viewing her as "the next Greer Garson." After 19 seasons on "Gunsmoke," she left to devote time to breeding cheetahs in cap-tivity. She passed away in 1989 at age 60.

Milburn Stone grew up in a tiny Kansas town much like Dodge City. He was briefly replaced by actor Pat Hingle while he underwent heart surgery, but returned for the final four seasons.

Dennis Weaver chose to leave "Gunsmoke" because, as he told The Toronto Star, he didn't want to be the "second banana" anymore. He eventually played the titular role in "McCloud," a TV series that ran seven years. Weaver was replaced on "Gunsmoke" by Ken Curtis as Festus Haggen. Curtis, a singer and the son-in-law of director John Ford, has

appeared in numerous films, including "Mister Roberts" and "The Searchers." "Gunsmoke" ran until 1975 on CBS

and was the longest running scripted series in history before "The Simp-sons" broke that record in 2018.



# POPE'S JANUARY PRAYER INTENTION: FOR GIFT OF DIVERSITY IN THE CHURCH



Pope Francis releases his prayer intention for the month of January, and invites Christians to embrace the diversity of charisms in the Church as a richness.

"Let us pray that the Spirit help us recognize the gift of different charisms within the Christian communities, and to discover the richness of different ritual traditions within the Catholic Church."

As the new year got underway, Pope Francis released a video to accompany his prayer intention for the month of January 2024, during which Christians celebrate the Week of Prayer for Christian Unity, on 18-25 January.

In the video, the Pope urged Christians to unite our prayers to his "for the gift of diversity in the Church," since diversity is an opportunity to "rejoice".

He noted that diversity and unity were already present in the early Christian communities, adding that the tension brought about by diversity "had to be resolved on a higher level."

## Gift of God for the Church

However, said the Pope, diversity in the Church includes our brothers and sisters of different Christian confessions.

"To move forward on the journey of faith, we also need ecumenical dialogue with our brothers and sisters of other confessions and Christian communities," he said. "This is not something confusing or disturbing, but is a gift God gives to the Christian community so it might grow as one body, the Body of Christ."

Pope Francis offered the example of the diversity of rites within the Eastern Churches that are in communion with Rome.

In conclusion, the Holy Father recalled that all Christian unity comes to us as a gift

of the Holy Spirit.

"If we are guided by the Holy Spirit, abundance, variety, and diversity never cause conflict," he said. "The Holy Spirit reminds us first and foremost that we are children loved by God - everyone equal in God's love, and everyone different."

"Let us pray that the Spirit help us recognize the gift of different charisms within the Christian communities, and to discover the richness of different ritual traditions within the Catholic Church."

## Cross as symbol of Christian unity in diversity

The Pope's Worldwide Prayer Network, which produces each month's The Pope Video, released a press statement to accompany the Holy Father's intention.

It noted that the Cross represents the common thread of this month's video, describing it as a symbol of unity and diversity.

"It is much more than an object of devotion," read the communique. "In short, it is the mystery of love under which all Christians stand, regardless of their confession, tradition, and rite."




