## HON. MATHER FOCUSES ON UNEMPLOYMENT INSURANCE

The-discussion-of unemployment insurance has been broached once again, this time by Deputy Speaker and Territorial At-Large Representative Hon.-Stacy-Mather. speaking in the House of Assembly recently voiced a pressing need for the implementation of an unemployment insurance plan, designed to support individuals grappling with

job loss stemming from unforeseen events like the COVID pandemic and the 2017 hurricanes.

Unemployment insurance, similar to the National Insurance-Scheme, operates by deducting funds from salaries to assist individuals facing financial hardship.

During the last sitting of the House of Assembly, the At Large Representative directed queries Minister for Health and Social-Development, Hon.-Vincent Wheatley, regarding the government's stance on establishing this vital social safety net.

In response, Hon. Wheatley acknowledged the-long-standing consideration-ofunemployment insurance successive BVI administrations.-He highlighted the ongoing collaboration between the ministry and the Social Security Board (SSB) to explore the practicality of introducing such a system. "Various administrations have explored the potential implementation of an

unemployment insurance system, with documented efforts dating back as far as 2005," noted Minister Wheatley, referencing information provided by the SSB, including the recent completion of an unemployment benefit system commissioned by Mr. Derrick Osbourne in May 2020.

"In the weeks ahead, the Ministry will maintain dialogue with the SSB to assess existing information on the proposed system and devise the most viable strategy for its realization," Hon. Wheatley added.

The-need-for unemployment Insurance in the Territory became apparent during COVID 19 pandemic; especially during Government-instituted lockdowns. At that

time both businesses and individuals-struggled to make ends meet and Government had to foot a stimulus payment via the Social Security Board to help curb the situation. As a result, discussions commenced about ensuring that there is a dedicated system in place to help persons in periods of

work loss.

In keeping with the process to move forward with such an idea, last year Premier and Minister of Finance Dr. the Hon. Natalio Wheatley announced in his 2023 Budget Address that efforts to explore this initiative will commence. He stated: "the Government will...engage stakeholders introduce plans to unemployment benefits, as well as explore measures to extend Social Security coverage to more workers in the informal economy."

Back in 2020 Government members announced that the Unemployment Insurance extension of the Social Security system was going to be in place by summer 2021. However, this was not the case.

The announcement that the Territory would have had Unemployment Insurance by 2021 was made by Hon. Vincent Wheatley who was at the time the Minister for Natural Resources Labour and Immigration.

At that time Hon. Wheatley stated that the unemployment insurance legislation would pave the road for the Territory to soon have unemployment benefits for residents who for one reason or another are unable to work.

Unemployment benefit or unemployment insurance is a benefit that is offered in many countries and in response to calls for this service the former Minister announced that the Government was aiming to have the insurance at no additional cost to residents.

## PREMIER PROMISES REFERENDUM ON SAME-SEX MARRIAGES

Premier Dr. Natalio Wheatley's promised referendum on the handling of same-sex marriages in the Territory faces yet more delays, adding to the tension surrounding this divisive issue. Same-sex marriage remains a hot-button topic in the BVI, with Premier Wheatley committing back in 2022 to let the public decide through a referendum, especially with a looming court trial that could shape the outcome.

The ongoing court case revolves around the marriage of Kinisha Forbes and Kirsten Lettsome, two Virgin Islands women, who were married abroad and are suing the BVI government to have their union legally recognized in the Territory.

The Premier had previously stated that the BVI government would vigorously defend its local laws that clearly define marriage as being between a man and a woman. The proposed referendum, which will be a first for the BVI will also consider whether the Territory should introduce new legislation to provide person in a domestic partnership or civil union with certain legal rights, such as the ability to pass on one's estate to their partner regardless of sex. The same-sex married couple sued the BVI government in June 2022 after being denied a marriage license from the Registrar General. If the couple is successful, Section 13(1)(c) of the Matrimonial Proceedings and Property Act, which defines marriage as between a man and a woman, would be declared unconstitutional and null and void, leading to samesex marriage becoming legal in the BVI.

Many progressive countries including UK, USA, Israel, and European Union have been at the forefront of legislation regarding same sex marriages and civil unions. Same-sex marriage is legally performed and recognized in 35 countries: Andorra, Argentina, Australia, Austria, Belgium, Brazil, Canada, Chile, Colombia, Costa Rica, Cuba, Denmark, Ecuador, Estonia, Finland, France, Germany, Iceland, Ireland, Luxembourg, Malta, Mexico, the Netherlands, New Zealand, Norway, Portugal.

Recently Pope Francis confirmed that he will give blessings to same sex married couples; he repeated the same approach this week Wednesday.

+ In mid December Pope Francis had formally approved allowing priests to bless same-sex couples, with a new document explaining a radical change in Vatican policy by insisting that people seeking God's love and mercy shouldn't

be subject to "an exhaustive moral analysis" to receive it.

The BVI referendum will be an opportunity for the people to have their say on the issue of same-sex marriage. The Premier hopes that it will be held soon.

Dr. Wheatley estimated that holding a referendum outside of a general election would incur costs of \$250,000 to \$300,000. In terms of legalities:

Under Section 8 of the BVI's Referendum Act, 2002, a

referendum addressing a specific subject requires only affirmative or negative votes. If over fifty percent of the total votes counted are affirmative, it's considered accepted. Conversely, if fifty percent or fewer votes are negative, the referendum is rejected.

However, for a referendum to be valid, at least fifty percent of registered voters must cast valid votes.

Once the results are declared, they're final and binding.



## CONSTITUTIONAL REVIEW COMMISSION REPORT PUBLISHED

The Constitutional Review Commission's (CRC) report has been officially made This extensive public. document, spanning nearly 300 pages, was unveiled on February 5, outlining numerous recommendations aimed at overhauling the constitution of the Territory. Among the report's notable suggestions is the proposal that both the Premier and Deputy Premier should be drawn from the pool of At Large elected officials, with added term limits

— a departure from the traditional norms observed in-Westminster-style Governments.

While the CRC hinted at the possibility of subjecting the issue of Term Limits to a referendum, they firmly recommended that should the decision be made to directly elect these positions, term limits should be introduced. Furthermore, the report advocates for the introduction of a recall mechanism for elected officials, a move that raises eyebrows given

its potential conflict with democratic principles. The CRC proposes legislative action to enact such a mechanism, suggesting an amendment to section 67(3) of the Constitution to include recall as a valid reason for vacating a seat in the House of Assembly (HoA).

According to the report, the recall legislation should outline specific grounds for triggering the mechanism, including serious breaches of the Code of Conduct outlined in the Integrity in Public Life Act 2021.

M o r e o v e r , - t h e Commissioners recommend setting a high threshold for initiating the recall process to ensure it remains a last resort, alongside establishing a 'safe harbor period' post-assumption of office before the recall mechanism can be activated. This buffer period aims to provide elected representatives with adequate time to fulfill their electoral promises.

However, skepticism looms

as a majority of political commentators scrutinizing the matter caution that recall provisions could sow seeds of political instability. They argue that such mechanisms might undermine democratic will of the people by allowing defeated opponents to perpetually challenge elected Members' positions, potentially creating a constant state of political turmoil.

# FORMER BVI PREMIER FACES TRIAL IN MIAMI

Jurors in the Miami, Florida, drug and money laundering trial of former premier Andrew Alturo Fahie were informed that Fahie allegedly intended to divert the proceeds from an alleged drug scheme towards a house he was constructing at the time of his arrest in April 2022.

Fahie was apprehended in Miami in April 2022 after purportedly-conspiring with others to allow significant quantities of cocaine to transit through the BVI's ports as part of a multimillion-dollar deal with an undercover US Drug Enforcement Administration (DEA) informant posing as a drug trafficker.

Testifying in court, undercover-detective Jossue-Dominguez,

instrumental in Fahie's and co-accused former BVI Ports Authority Director Oleanvine-Maynard's-apprehension, revealed that the two was promised nearly \$700,000 for their roles in the alleged drug and money laundering plot.

Secretly-recorded conversations allegedly captured Fahie discussing methods-to-obscure the funds he received from these transactions as construction-related invoices for his home in Tortola's western end.


In these recordings, Fahie purportedly inquired about a 'cartel' construction company issuing invoices, with an initial transaction totaling \$40,000.

An undercover informant, using the alias Roberto,

informed Fahie that his fictitious cartel operated three-construction companies serving as 'fronts' and offered various materials to aid the former Premier.

They discussed the possibility of Fahie establishing a line of credit with the fictitious cartel-construction firms to create a veneer legitimacy. Fahie allegedly stated that windows, doors, and tiles for his home would cost nearly \$300,000.

Fahie's defense attorney argued that Fahie had no genuine intention of facilitating drug shipments through the Territory and suggested that the UK authorities were framing him to oust him as Premier.



# **Constitutional Review Commission Report Now Available**

The-Constitutional Review Commission Report was laid on the table during the Eighth Sitting of the First Session of the Fifth House

of Assembly on Wednesday,

31st January, 2024.

The-comprehensive report, which is 288 pages, is divided into six chapters and eight appendices. The Commission in its Terms

of Reference was required to consider, among other things:

1.the aspirations of the people of the Virgin Islands; the executive

ministerial government can be held to account in the HOA (e.g. by some different structure, number and/or configuration of seats) and/ or in other ways;

- 3. whether the current constitutional pillars of governance are sufficient, and in any event how those independent institutions can be effective:
- 4. the powers that need to be reserved to the Governor, and how issues as to the exercise of devolved reserved powers respectively, when they arise, are to be resolved;
- 5. a mechanism for the transfer of reserved powers to the devolved Virgin Islands' Government in the future, without a further change to the Constitution being required;
- 6. whether there should be a regime in relation to election expenses in the form of a requirement on election candidates to submit a breakdown of expenses including donations above a specific sum and/or a cap on such expenses;
- whether statutory boards should be embedded in the Constitution and, if so, whether there should be a Statutory Boards Commission;
- 8. whether the term "Government of the Virgin Islands" is intended to encompass statutory bodies;


9. whether the Speaker should continue to be a political-appointment, or whether he or she, even if elected, should be independent of the political

parties; and

10. without prejudice legislative earlier to action, clarification of the circumstances in which persons seeking election to the House of Assembly who contract with the Government of the Virgin Islands (either personally or through a dba, a partnership or a company with which he or she is associated), need to declare an interest, how such a declaration should be made, and the consequences of him or her not doing so.

"The Overseas Territories are a core part of the UK family and the UK Government is committed to the security. prosperity and wellbeing of the people of the British Virgin Islands. We want to see a successful, thriving, well-governed BVI, and will continue to do our upmost to support the Governor and the people of the BVI to achieve that goal.

"The Commission of Inquiry has identified serious governance and reputational issues, but progress on implementing its recommendations has been too slow, with agreed deadlines missed. That is why I am here: to listen and understand from those working directly on the reforms how they can be delivered quicker so that the people of BVI get the good governance they deserve.

"The UK will provide further technical assistance if required. However, if there continues to be a lack of progress, we will not hesitate to take further action to help deliver the much-needed reforms."

Of the Minister's visit, Governor Daniel Pruce said:

"The Minister's visit comes at a crucial time for the BVI, and signals the UK's interest and commitment to ensuring that the BVI succeeds. Delivering the recommendations of the Commission of Inquiry will help us achieve the positive changes we all want to see, including better access to services, a fairer society with opportunities for all, and a more accountable and transparent government."

Findings from the independent Commission of Inquiry (COI) showed that the people of BVI have long lacked good governace and set out a list of recommendations to be implemented to address the historic failures around honesty, transparency and the rule of law.

SPAIN Supermarkets increasingly offer vegetables that, within just a few minutes of microwaving them in the same plastic bag in which they were purchased, are ready to eat. Potatoes, cabbages, or mixtures of various vegetables come already pre-cooked and - according to the producers' instructions - it's not necessary to put them in another container to microwave them. But new research shows that perhaps it would be better to take your veggies out of the bag before heating them up.

Researchers from University of Almería (Spain) led by Dr. Francisco José Díaz Galiano - have discovered that this microwave cooking process actually causes a "very pronounced" transfer of plastic components from the bag to the vegetable. The research - published in the journal Food Chemistry - has also identified that the action of the microwave in these cases creates a new compound in the potato, which they call HMPPmaltose. According to Díaz Galiano, this is a "potentially toxic" compound, although new studies are still required to confirm this. Regardless, the transfer of plastic to potatoes remains an issue.

The researchers had the feeling that "in a very energetic situation - like that of the microwave - it was more than possible for certain plastic components to migrate into the food." They began to do all kinds of tests with potatoes from different brands, dispensed in bags and ready to be cooked or heated up. They were made with all possible variants: "In the microwave in a plastic bag or in a microwave in a glass container... in both cases using the recommended time for the bag, or cooked in water over fire. In this case, we gave [the potatoes| more time, between 10 and 15 minutes," Díaz Galiano explains. He remembers that the potatoes were also analyzed before cooking them. They did 27 replicates of the experiment and "the same differences always appeared." [El Pais]

Around 150,000 people have attended a protest rally in the German capital, Berlin, against the far right and its ideology, the latest in a series of such demonstrations across Germany in recent weeks.

The wave of protests follows a recent report by the investigative network Correctiv on a secret meeting, attended by neo-Nazis, business people and members of the political parties AfD and CDU, others, where among participants discussed a secret plan for the mass deportation of millions of immigrants.

In the year's first Bundestag general debate, German Chancellor Olaf Scholz spared with the conservative opposition, but both sides of the political spectrum agreed on denouncing the far-right

In an unusually fiery Germany's speech in lower house of parliament, the Bundestag, German Chancellor Olaf Scholz democratic called on parties from across the political spectrum to stand together against threats to democracy.


Wearing a black suit and black tie following a special parliamentary session to mark Holocaust Remembrance Day, Scholz evoked Germany's Nazi past as he urged voters to reject the far-right Alternative for Germany (AfD) party and argued for a stronger European Union. [Deutsche Welle

ITALY - ustice Minister Carlo Nordio told La Stampa newspaper Sunday that he had felt "deep sorrow and surprise" when he saw Italian antifascist militant Ilaria Salis being led into court on a chain with her hands and ankles cuffed in Budapest last Monday.

Nordio stressed that "as long as the trial lasts, the Hungarian jurisdiction is sovereign, but there is work to be done on the prison treatment front, so that European standards are respected." "And to achieve results one must act with prudence," Nordio underscored to the Turinbased daily. Prudence was also called for by Foreign Minister Antonio Tajani, who in the Corriere dela Sera newspaper noted a "willingness to listen on the Hungarian side", assured support to Salis' family and lawyers and stressed that "when negotiating, silence is golden". Salis faces up to 24 years in jail for allegedly attacking the two neoNazis, who were reportedly only slightly injured and did not complain to the Hungarian police. [ANSA]

CALABRIA (Italy) Their arrival had aroused amazement and perplexity. Today, the Cuban doctors who arrived in Calabria to make up for the shortage of doctors represent a healthcare asset that allows many hospitals scattered throughout the region to still be kept open. Another 98 arrived on Thursday, adding to the 172 already in service for more than a year. As happened with their colleagues before being placed on the ward, they will follow an Italian course. «It is not a structural solution - says Roberto Occhiuto, president of the region - but we could not do otherwise, given the shortage of doctors. # A Fusion of Love and Tradition: The Chinese New Year and Valentine's Day Hot Pot Feast

As winter With Chinese New Year coming up on Feb. 10 and Valentine's Day Feb. 14, let's embark on an affordable culinary love story as we blend the rich traditions of Chinese New Year with the romance of Valentine's Day through a delightful hot pot experience at home.

A hot pot meal is a communal dining experience where diners cook a variety of raw ingredients, such as thinly sliced meat, seafood and vegetables, in a simmering pot of flavored broth at the center of the table.

While my take on hot pot doesn't offer a strictly authentic experience, it's a simple and enjoyable introduction. For a more authentic encounter, additional research, or a visit to a hot pot restaurant or a Chinese market is recommended.

For those with access to an Asian market, a single trip will yield all the essentials. If an Asian market isn't handy, a little online planning can bring the

necessary ingredients and equipment to your doorstep.

When shopping for your hot pot feast, simplicity is key. Equip yourself with an electric or butane burner for tabletop cooking, use an electric skillet or plan your meal around the stovetop. Consider a divided pot to enjoy two broths at once. A wire skimmer and chopsticks keep your ingredients in check while cooking. (You can use a fork; I won't tell anyone.)

When planning your menu, it's easy to over shop. Plan for 8 to 12 ounces of meat, seafood and/or tofu per person, and aim for 2 to 3 ingredients from each food group: vegetables, mushrooms, starch and fun accompaniments. Leftovers? Repurpose them into delicious soups and noodles in the days following the festivities.

The menu that's pictured includes thin slices of beef sirloin and pork belly. The veggies are napa cabbage, baby bok choy, spinach, sweet potato, red pepper and white, cremini and enoki mushrooms. For starch you'll see fresh noodles, bean threads and rice vermicelli -- as well as dipping sauces, zesty soy sauce, peanut sauce and chili oil, with fresh garnish of cilantro, green onion, chopped peanuts and sesame seeds.

Since this meal centers on broth, this recipe makes a delicious broth using chicken, beef, pork or vegetable broth. Or you can also use a few flavor packets from instant ramen and cook the noodles during your meal.

## HOT POT BROTH

Yield: 6 to 8 cups Time: 20 minutes

6 to 8 cups broth, depending on pot size

2 cloves garlic, smashed

1 (1-inch) piece ginger, peeled and sliced

2 green onions, chopped into large pieces

1 tablespoon soy sauce

2 teaspoons sesame oil

1/2 teaspoon chili oil, or to taste for spicy broth only!

Heat broth in a saucepan on the stovetop or in your hot pot. Add the remaining ingredients and simmer until ready to use.

## ZESTY SOY DIPPING SAUCE

Yield: 1/2 cup Time: 5 minutes

1/2 cup low sodium soy sauce

1 (heaping) tablespoon green onion, sliced

1 clove garlic, grated

1/2 teaspoon ginger, grated

1 teaspoon brown sugar

Mix ingredients together and refrigerate until serving.



#### EASY PEANUT SAUCE

Yield: 1/2 cup

Time: 5 minutes

1/3 cup peanut butter

1 tablespoon vegetable oil 1 tablespoon teriyaki sauce

1 teaspoon sesame oil

1/2 teaspoon garlic, grated

1/2 teaspoon ginger, grated

Place peanut butter, oil and teriyaki sauce in a microwave-safe bowl, and microwave for 15 seconds. Stir until the ingredients are smooth. Add remaining ingredients and stir to incorporate. Refrigerate until serving. Feel free to customize these ideas to fit your style and preferences. Enjoy creating a memorable and culturally rich Valentine's Day and Chinese New Year celebration!

# Biden wins South Carolina's Democratic presidential primary

President Biden won the South Carolina Democratic primary on Saturday, according to The Associated Press. It is the first official nominating contest for the party, and one that Democrats hope sends a message to Black voters.

As the incumbent president, Biden had been widely expected to carry the primary. Rep. Dean Phillips, D-Minn., and author Marianne Williamson were also on the ballot.

Biden backed the push to change the party's calendar this

year to put South Carolina's primary at the front of the pack, ahead of lowa and New Hampshire. It's not a state that Democrats expect to win in the general election, but by elevating its primary, the Democratic Party is signaling the importance of Black voters — a crucial part of its base.

"When I was elected President, I said the days of the backbone of the Democratic Party being at the back of the line were over," Biden said in a statement

Saturday night. "That was a promise made and a promise kept. Now, you are First In The Nation."

Despite skipping the unsanctioned New Hampshire primary, Biden won that race after voters wrote in his name — though the results won't count toward his official nomination at the party's convention in August.

In 2020, Biden turned around his struggling campaign in the state, where Black voters account for about 60% of the party's electorate.

He referenced that win in his statement Saturday.

"In 2020, it was the voters of South Carolina who proved the pundits wrong, breathed new life into our campaign, and set us on the path to winning the Presidency," Biden said. "Now in 2024, the people of South Carolina have spoken again and I have no doubt that you have set us on the path to winning the Presidency again — and making Donald Trump a loser — again."

The Biden campaign sees South Carolina as a springboard for his reelection bid and has poured resources into the state over the past month. Biden campaigned at a barbershop and spoke at a luncheon at a Black church. Vice President Harris campaigned in the state on Martin Luther King Jr. Day — and returned on Friday to speak at a historically Black college. First lady Jill Biden attended a gala for Alpha Kappa Alpha, a historically Black sorority.

"We know that to be the Democratic nominee and to win

the general, you need to be getting a lot of support from voters of color," said Josh Marcus-Blank, the Biden campaign's communications director for state operations. "And that's what South Carolina is all about."

Polls have shown Biden has been lagging in approval ratings with younger voters and nonwhite voters, so analysts will be paying close attention to turnout as a signal of whether Biden's message is resonating.

But Terrance Woodbury of HIT Strategies, a group that researches Black voter attitudes, cautioned against overanalyzing the results of this primary — a contest that likely will mainly attract party faithful, rather than the

# RUSSIA-UKRAINE AND ISRAEL-PALESTINE CONFLICTS SHOULD NOT BE CHESS PIECES

If governments, around the world have become confused about support for Ukraine in defence of its sovereignty and territorial integrity against Russian aggression, the US Congress is responsible.

Over recent weeks, a contentious negotiation has unfolded between Republicans and Democrats, overshadowing the urgent matter of authorizing continued funding for Ukraine. Republicans

seek to tie increased aid to Ukraine with the closure of the US southern border, citing concerns about escalating migrant numbers. Despite Democrats acquiescing to this demand, Republicans, influenced by Donald Trump's campaign strategies, have hesitated to act on border closure, potentially using the migrant issue as a political tool against Joe Biden.

The theatrics exhibited by representatives of both the Republican and Democratic parties in the US Congress have been broadcasted globally, prompting onlookers to question whether Ukraine should consider alternative avenues to resolve the conflict

However, Ukraine faces a dire predicament with limited favorable options. Without adequate military support, it is left with the grim choice of either engaging in a potentially more devastating conflict with Russia or acquiescing to significant territorial concessions and ceding control over crucial aspects of its affairs to Russia.

Ukraine bears no responsibility for igniting this conflict; rather, it was instigated by Russia, blatantly violating international law and the principles outlined in the Charter of the United Nations.

Russian President Vladimir Putin has frequently cited the expansion of the North Atlantic Treaty Organization (NATO) into Eastern Europe as justification for his country's invasion of Ukraine, despite NATO never formally agreeing to Ukraine's membership, both then and now. It's plausible that NATO refrained from extending membership to Ukraine precisely due to concerns about provoking Russia, given that its 31 members, predominantly European states along with Canada and the US, aimed to avoid escalating tensions.

Hence, the more plausible motive behind Russia's aggression towards Ukraine, which commenced with the invasion and annexation of Crimea in 2014, long predating the current military escalation, is Vladimir Putin's persistent aspiration to absorb Ukraine into Russia.

Any act of aggression against a sovereign state warrants universal condemnation to preserve peace and stop war. This principle holds particular significance for smaller nations, whose defence against aggression by more powerful entities relies heavily on worldwide adherence to international law. The toxic behaviour exhibited in the US undermines the credibility of the Congress in upholding international principles.

It is the behaviour of the US Congress that is causing other nations to ponder other choices for Ukraine.

Mixed-up with the global attitude to the Russian-Ukraine conflict is the Israeli war against Hamas in Gaza, which is now in its fourth month since October 7, 2023, when Hamas militants killed some

1,200 Israelis and took more than 200 hostages. Whatever Hamas thought it would achieve by its actions, it succeeded in giving a license to Israeli leader, Benjamin Netanyahu, to rain down a war of hell in Gaza. Israeli military forces are now responsible for the deaths of more than 27,000 people. The war's death, destruction and displacement are without precedent in the decades of conflict between Israel and Palestine. Netanyahu's confrontational stance has sparked international outrage, prompting South Africa to file a case with the International Court of Justice. The case accuses Israel of genocide in its campaign against Hamas, alleging a

deliberate intent to annihilate Palestinians in Gaza as part

of the broader Palestinian community.

Netanyahu's persistent and aggressive stance against Palestinians, exemplified by his rejection of a Hamas ceasefire proposal as "delusional," has stirred international frustration. Of greater concern is Netanyahu's decision to intensify military operations in Gaza, despite the support of influential Arab states like Egypt, Saudi Arabia, and Qatar

for a peace plan that includes the establishment of a Palestinian state in the West Bank and Gaza Strip. Netanyahu's insistence on pursuing "absolute victory" and opposing a Palestinian state further complicates the situation.

Meanwhile, US Secretary of State Antony Blinken is actively pursuing what has been termed as "a practical, timebound, irreversible path to a Palestinian state," as part of negotiations involving the US, Israel, the Palestinian Authority, and Saudi

While there are no assurances that such a deal could be reached or effectively implemented, Blinken's efforts are set against a backdrop where the reputation of the US government has, in the eyes of many governments, been tarnished by its previous staunch support for Israel.

However, conflating the plight of Ukraine, a victim of Russian aggression, with the Israeli-Hamas conflict is a misstep. Refusing to address the Ukrainian crisis unless Gaza receives comparable focus is counterproductive. What is necessary is equal global attention to both crises and a steadfast commitment to actively pursue their resolution.

As UN Secretary-General António Guterres emphasized to the UN General Assembly when outlining priorities for 2024: "Peace is the missing piece across the globe and across a spectrum of issues. People yearn for peace and security, peace and dignity, and quite frankly, peace and quiet".

Representatives in the US Congress should reconsider their posture of bargaining for domestic political advantage over global issues that is costing lives and disrupting the world. All other nations should refrain from treating the Russia-Ukraine and Israel-Palestine conflicts as bargaining chips. These crises demand urgent humanitarian attention and the application of international justice.

If the US Congress and governments around the world continue the present approach to these two conflicts, much more destruction and many more lives will be lost. This will exacerbate the current global instability, and potentially expand into other countries, pushing the prospect of global peace further out of reach.

# RULE OF LAW AND POLITICAL INTEGRITY THREATS UNDERMINE ACTION AGAINST CORRUPTION

The Corruption Perceptions Index (CPI) average score of 65 out of 100 has dropped for the first time in almost a decade in Western Europe and the European Union (EU). Despite remaining the top-scoring region in the CPI, robust anti-corruption measures continue to be undermined by the weakening of checks and balances. The erosion of political integrity contributes to diminishing public trust in countries' ability to tackle the region's ongoing challenges.

The 2023 CPI reveals that anti-corruption efforts have stagnated or declined in more than three-quarters of the countries in the region. Among the 31 countries assessed, only six have improved their score, while eight have declined since 2012.

Several high-ranking democracies, including Sweden (CPI score: 82), Netherlands (79), Iceland (72) and the United Kingdom (71), have recorded their lowest-ever scores. Notably, the UK has experienced a six-point decrease over the past five years. Denmark (90), Finland (87) and Norway (84) top the CPI ranking, while the lowest-performing countries, reflecting substantial weaknesses in the rule of law, include Hungary (42), Romania (46) and Bulgaria (45).

Over a decade of systemic breach of the rule of law in Hungary (42) has created a system where high-level corruption thrives unsanctioned. The of rule of law reforms, coupled with a recent legislative initiative to silence remaining critics, reveal the government's commitment to protect the status quo.

Despite the adoption of long-overdue legislation on whistleblowing, Bulgaria's (45) significant problems with the rule of law and oligarchic influence remain, despite the legislative reform agendas of consecutive governments. The long overdue legislation on whistleblowing was adopted, but challenges with its implementation are evident.

The UK (71) continues to backslide with a two-point decline, marked by persistent lobbying scandals and instances of abuse of public office for private gain. The absence of an appointed Anti-Corruption Champion for the prime minister over the past eighteen months and the emerging details about the handling of COVID contracts have done little to restore confidence. Weaknesses in Norway's (84) trust-based system were brought to light following a string of conflict of interest scandals leading to the resignation of high-profile ministers.

Italy's (56) proposed amendments to the constitution, if passed, would concentrate power in the executive, weakening parliamentary oversight.

Reporting on corruption is also becoming increasingly challenging for journalists, weakening a vital check on government, due to heightened use of strategic lawsuits against public participation (SLAPPs) or legal intimidation by powerful businesses and politicians in countries such as Cyprus (53), Malta (51), Ireland (77), Hungary (42), Croatia (50), Bulgaria (45), the Netherlands (79) and Poland (54).

# Judicial independence falling short across Europe Weaknesses in judicial systems are creating barriers to accessing

Weaknesses in judicial systems are creating barriers to accessing justice and preventing courts from effectively limiting government powers. In the worst cases, politicisation of judicial and law enforcement appointments has left abuses of power unchecked.

The EU has highlighted issues in the appointment judges and the overall quality of the justice system in countries across the region, including Sweden (82), Spain (60), Poland (54), Croatia (50), Malta (51), Greece (49), Lithuania (61) and Ireland (77).


In Slovakia (54), previous progress in the prosecution of corruption is tainted by the government's controversial dismissals in the justice sector. This was swiftly followed by legislative measures aimed at closing the special prosecutor's office responsible for combating corruption and reducing criminal sanctions for corruption. If adopted, these changes would significantly undermine the rule of law and democratic stability, fostering an environment of impunity for corruption.

Long-standing rule of law issues persist in Spain (60), with judicial independence perceived as falling short. At the centre is the urgent need for reform of the party quota system of judicial appointments, which has led to a five-year standoff of appointments to the General Council of the Judiciary.

In France (71), Minister of Justice Éric Dupond-Moretti has been indicted on suspicion of using his ministerial role to settle disputes with magistrates with whom he had clashed during his time as a lawyer. The special court made up of members of parliament found him not guilty. Dupond-Moretti remained in office throughout the trial.

# Trump Not Immune From Prosecution in Election Subversion Case, US Appeals Court Rules

Former U.S. President Donald Trump is not immune from being prosecuted on charges that he illegally plotted to overturn his 2020 reelection loss to stay in power, a U.S. appellate court panel in Washington unanimously ruled Tuesday.

The 3-0 decision rejected Trump's claim that special counsel Jack Smith cannot prosecute him for the actions Trump took in the waning days of his presidency to upend his loss to Democrat Joe Biden because they were related to his official duties as president.

"Former President Trump has become citizen Trump, with all of the defenses of any other criminal defendant," the court ruled. "But any executive immunity that may have protected him while he served as President no longer protects him against this prosecution."

In a four-count indictment, Smith accused Trump of using false claims of voter fraud to pressure state election officials, the Justice Department and his vice president, Mike Pence, to thwart congressional certification of the election results showing he had lost.

Trump, the first president accused in a criminal case, has denied wrongdoing in the election subversion case and three other indictments he is facing that encompass a total of 91 charges. Some of the trials in the cases could occur this year as Trump, the leading 2024 Republican presidential candidate, seeks to reclaim the White House in the November election, again facing Biden.

Trump campaign spokesman Steven Cheung said the appellate court ruling "threatens the bedrock of our Republic. Without complete immunity, a President of the United States would not be able to properly function!"

Tuesday's ruling, which Trump said he is appealing, either to the full appellate court or the U.S. Supreme Court, came nearly a month after the three appellate judges heard arguments in the case, with Trump in the courtroom.

With the length of the time for a decision on Trump's immunity claim and other legal issues in the case yet to be decided, U.S. District Judge Tanya Chutkan last week indefinitely postponed the scheduled March 4 trial date.

Chutkan had rejected Trump's immunity claim, which he then appealed to the appellate court. She said the office of the president "does not confer a lifelong 'get-out-of-jail-free' pass."

The appellate court ruling was handed down by Judges Florence Pan and Michelle Childs, both Biden appointees, and Karen LeCraft Henderson, who was named to the bench by President George H.W. Bush, a Republican.

While awaiting the appellate court ruling, Trump has claimed numerous times at campaign rallies and on social media that all U.S. presidents need full immunity from prosecution, lest their political rivals charge them with crimes once their four-year presidential terms have ended.

Trump's lawyers argued that former presidents were entitled to sweeping legal protections. They claimed that unless the House of Representatives had first impeached them for wrongdoing, and they then were convicted by the Senate and removed from office, they could not be criminally prosecuted for official actions.

Trump was twice impeached by the House, including for inciting an insurrection at the U.S. Capitol two weeks before he left office by urging supporters to "fight like hell" to block congressional certification of Biden's election victory. In both impeachment cases, enough Senate Republicans voted to acquit him to keep him from being convicted.

Even if Trump's immunity is eventually rejected by the Supreme Court, he will have delayed his prosecution and possibly pushed any trial past the November 5 election. If he wins, he could direct the Justice Department to drop the case.

But any trial, whether the Washington election subversion case or any of other three Trump is facing, holds unprecedented implications for the U.S. presidential contest.

Rather than campaigning, Trump would be required to sit in court day after day and listen to testimony against him. News stories about the cases would fill the front pages of newspapers and dominate the airwaves and social media accounts just as the election approaches.

In addition to the Washington case, Trump faces federal charges in Florida that he illegally retained classified documents at his Mar-a-Lago estate after he left office in January 2021. He is also charged in the southeastern state of Georgia with scheming to subvert Biden's 2020 victory there and in New York in connection with hush money payments made to porn actress Stormy Daniels ahead of his successful 2016 election.

The New York trial is scheduled to start in late March.

## Media Reports: Ukrainian Intelligence Official Fired Over Surveillance of Journalists

A top official at Ukraine's SBU intelligence agency was fired following revelations that investigative journalists in the country had been surveilled, according to media reports.

Ukrainian President Volodymyr Zelenskyy approved the firing, a source said.

The press freedom group Reporters Without Borders, or RSF, which identified three relevant cases, called for investigations.

In one case, the investigative outlet Bihus.info reported on Monday it had been under surveillance by the SBU, the Security Service of Ukraine. The intelligence agency later confirmed the monitoring but said it had acted as part of an investigation into drug trafficking.

In another case, Odesa-based journalist Iryna Hryb reported in January that she found a device in her car that could be used to listen to her phone calls or discussions with passengers and track her movement.

In the third case, masked individuals tried to force their way into the Kyiv apartment of investigative reporter Yuriy Nikolov on January 14. He was threatened with forcible enlistment to fight in the Ukrainian army, according to RSF.

Speaking about the surveillance of Bihus.info, SBU chief Vasyl Maliuk condemned these actions and announced internal measures against the "people involved."

A source with the SBU told Agence France-Presse this week that "the head of the SBU state protection department, Roman Semenchenko, was fired as a result of the surveillance of Bihus Info staff."

Jeanne Cavelier, head of RSF's Eastern Europe and Central Asia desk, said these cases are connected because all three involved journalists covering corruption linked to the Ukrainian elite.

"Journalists must be able to work in Ukraine without being spied on, followed or threatened," Cavelier said in a statement. "The Ukrainian media landscape draws its strength from these journalists, who continue their investigative reporting despite the war." Russia invaded Ukraine in February 2022.

# Palesa Caesar opens with Carifta Games Discus Throw qualifier



Discus Thrower Palesa Caesar, opened her season with three throws over 39m, to qualify for the 51st Carifta Games in St. George's Grenada, over the Easter weekend. She settled for a best mark of 39.62m (129'113/4") which came on her opening effort.

"The first throw was the best out of all I did. I threw two 38s and three 39s and I had one foul. It was not my best meet," she told Island Sun Sports in an exclusive interview following the event. "It was my first meet of the season but not my best meet I've ever had. It's not really okay-ish for a season opener, but I'm not complaining, because I know that I can do way better than

For an opening effort, Caesar said she wanted at least a throw over 40m (132'23/4"). In order to do that, she said that she must fix her lining and her speed in the circle to get the desired mark. She also has to fix

the middle of her throws and stay stable. On the throw she fouled, Caesar explained that her release was a bit too early, causing her to hit the supporting pole on the cage.

"That's why that happened," she said on reflection, noting that she has to correct that by "fixing" the line. "If you fix your line, you fix your foot timing," she said. "This year, I'm looking for a 45m (147'73/4") throw. I'm looking for more of course, but the least is a 45m throw." Caesar entered the 2024 season with a personal best of 43.68m (143'334").

Notable performances on the track came from Shaniah Johnson, who won an U20 Girls sprint double in 12.39 and 25.22 seconds respectively, dropping her time from 25.83 in the latter, during her debut. M'Kenzii Crabbe-who will be 14 later this year-was second in both events in 12.68 (0.1) and 25.76 (0.2) seconds respectively. She opened her season with 26.04 and 60.91 in the 400m.

Vadley Sylvester ran 49.40 and 22.05 seconds respectively, in the 400m and 200m. Jahshani Farrington, who was second in 49.68, pulled Jonathan Lynch to an 800m personal best of 1 minute, 58.61 seconds, after he stopped the clock at 1:57.98. Lynch opened his

season with 2:01.92.


Already qualified for Carifta in the U17 Boys 100m, Tiondre Frett made his 400m debut in 51.71





#### Celebrate the Chinese New Year With Firecracker Shrimp

When it comes to demystifying Chinese cooking, my friend Katie Chin, daughter of restaurateur Leeann Chin, knows what it takes to bring tasty recipes into American homes. As a chef, cookbook author and television personality, Katie believes in spreading the word about how truly delicious Chinese cuisine can be, starting with sharing culinary traditions with her 8-year-old twins.

"Chinese New Year is coming up on Feb. 10," she reminds me. "Firecracker shrimp is a tasty and whimsical appetizer to kick off the celebration in our home in Southern California. My sous-chef kids mix the dipping sauce and roll up the 'firecrackers,' revealing shrimp tails and carrot strips for 'fuses.' As we prep, I'll tell them about their grandmother's memories of growing up in China and how firecrackers (believed to ward off evil spirits) lit up the sky on New Year's Day."

Roll up her firecracker shrimp for an appetizer that explodes with flavor in every bite. The recipe was adapted from her cookbook "Katie Chin's Everyday Chinese Cookbook: 101 Delicious Recipes From My Mother's Kitchen."

#### FIRECRACKER SHRIMP

Serves 6 as an appetizer

- 1 large carrot, cut into 3-inch-by-1/4-inch matchsticks
- 1/2 teaspoon garlic salt, divided
- 12 shelled and deveined large, raw shrimp (tails left intact)

- 4 spring roll wrappers
- 1 egg, beaten
- Vegetable oil for deep-frying

Place carrot slices in a small bowl. Sprinkle with 1/4 teaspoon garlic salt. Sprinkle shrimp with remaining garlic salt. Set aside.

Cut each spring roll wrapper into thirds to make 12 long strips. Brush the top third of each strip with the egg. Lay 1 shrimp at the bottom of the strip. Set a carrot slice on top of the shrimp.

Tightly roll, letting the egg seal it together at the end. (The tail of the shrimp and the carrot should protrude from one end to resemble a firecracker.) Repeat with remaining wrappers.

In a large wok or deep skillet, heat 2-3 inches of oil to 350 F. Fry the shrimp rolls 5 or 6 at a time until golden brown (about 2 minutes), turning 2 to 3 times. Transfer to a cooling rack lined with paper towels.



Serve hot with dipping sauce.

#### DIPPING SAUCE

- 4 tablespoons mayonnaise
- 2 tablespoons sriracha chili sauce In a small bowl, mix the mayonnaise and sriracha together.

Cook's Note: Find spring roll wrappers in the freezer section of Asian markets. You can also substitute them with egg roll wrappers from the produce section of grocery stores.



How to Take Precautions When a Family Member Has Mono

DEAR DR. ROACH: My daughter was exposed to infectious mononucleosis ("mono") at college, and she is coming to spend a week at home. What precautions do we need to take to make sure that the rest of the family remains safe? How long does the virus stay active on surfaces?

Also, can she get her flu and COVID shots? — D.G.

ANSWER: Mono is classically caused by the Epstein-Barr virus (EBV), but very similar symptoms can be caused by other agents, viruses and even a parasite as well. The virus is transmitted through saliva.

The latency period (the time from exposure until the time of symptoms) is longer than you might expect; four to six weeks is typical. Not everybody develops symptoms. Younger children seldom develop symptoms at all when infected, yet they still receive immunity. Unfortunately, they may shed infectious virus particles for months, years or even decades.

It is likely that the adults in your family are immune, since 90% of adults have had an EBV infection before. EBV is not a particularly infectious disease, so transmission to family members is uncommon. Still, you should avoid sharing anything that saliva touches, like food, cups or toothbrushes. You don't need to take special precautions with surfaces.

Does tart cherry juice reduce or increase inflammation? What is the difference between sucrose and fructose in terms of health?—P.G.

ANSWER: There is some evidence that tart cherry juice does have anti-in-flammatory properties, and studies on athletes have shown through blood tests that the benefits of tart cherry juice include faster recovery, improved performance, enhanced muscle oxygenation and decreased inflammation. A glass of tart cherry juice (without added sugar) has 25 grams of sugar, about the same as a glass of orange juice.


The studies that show improvement included the effect of sugar, but I understand you want to reduce sugar, which means that you will need to be careful elsewhere in your diet if you do start drinking cherry juice.


As far as fructose (most fruit sugar) versus sucrose (table sugar), there is almost no difference in its effect on your health. Sucrose is rapidly broken down into fructose and glucose, and both fructose and glucose are used for energy. Too much of either sucrose or fructose isn't healthy, and there isn't a special benefit to "natural" sugar.

Keeping your simple sugar intake to less than 10% of your total calorie intake (roughly 36 grams for most men) is the healthiest option, so a glass of tart cherry juice would be a significant part of your sugar intake for the day.

# 6 BOOKS TO HELP YOUNG READERS LEARN ABOUT BLACK HISTORY

Each February, the U.S. honors the contributions and sacrifices of African Americans who have shaped the nation. If

you're struggling with the best way to educate children about Black history, this month or year-round, experts often suggest turning to literature to assist.

Books can help children engage with all kinds of history, but can be particularly helpful for the nuanced aspects of Black history, said Meg Medina, an award-

winning children's author and the 2023-2024 National Ambassador of Young People's Literature.

"I think when we give kids really rich texts, and trust them with the information, trust them to be curious, allow them to follow their curiosity, we do them an enormous service," she said.

And 2024 is a wonderful time to find the best texts to do this, Medina said.

"I tell people we are in a golden age of children's books. So many incredible people are producing really meaningful work that respects kids intelligence, respects their curiosity," she said.

Here are six picks for Black History Month reading, recommended by authors, librarians and book shop employees, appropriate for a range of ages from toddlers to teens.

As the Librarian of Congress, Carla Hayden oversees the national library of the United States, which contains a collection of approximately 164 million items. For Black History Month, she has two recommendations for children — firstly, A Library by Nikki Giovanni, with colorful illustrations by Erin K. Robinson.

"It's a book that I would recommend for anyone, and particularly though, in Black History Month because it features a young African American girl and she takes so many adventures through books. And to have a young African American child having those adventures in a library at this time is very significant when so many things are being challenged," Hayden said.

"Books can do so much. And during Black History Month, I think we owe it to the young people in our lives to introduce them to that free resource: The library," Hayden said. "I'm a little prejudiced."

She said A Library also reminded her of her second pick, a lifelong favorite book of hers, Bright April by Marguerite de Angeli.

The book, published in 1946, is about a

young African American girl named April who experiences racial prejudice for the first time. The main character has pigtails and is a Brownie — a Girl Scout in the second or third grade of elementary school — which blew the mind of a young Hayden, who also was a Brownie with pigtails.

Bright April "even now makes me smile, because it was the first time I saw myself in a book," she said. "I thought that I was April."

She now owns a well-worn copy of the book, which serves as an important reminder: "It's important during African American History Month, too, that

we present materials, especially for children, where they can have windows on the world, of course, but also mirrors and they see themselves."

"I didn't know what being the first really meant until the day I arrived," Ruby Bridges writes in I Am Ruby Bridges, channeling the voice of her 6-year-old self.

Brittni Robertson Powell, program director for the New Orleans bookstore Baldwin & Co., said she picked the picture book to highlight her hometown's not-so-distant history.

"Ruby is younger than my mom," Robertson Powell said. "How is that possible?"

Robertson Powell said she and her 10-yearold son regularly drive past the New Orleans elementary school Bridges integrated in 1960 in the wake of Brown v. Board of Education.

"I told him, 'This is where it happened.'
He cannot fathom that," she said.

They recently read Bridge's book together, and since then, he's been applying the story to his own life, she said. When someone didn't want to play with him recently, "He was like, 'I wonder if that's how Ruby felt?," she said. Robertson Powell likes the lessons the book teaches — among them, to be confident, be kind and accept people who are different from you.

"I'm glad she's penned it because it's being told by her, as opposed to other individuals who want to tell her story," she said.

The importance of telling your own story, she said, is an important lesson for kids. too.

Picture books aren't just for little kids, said Meg Medina.

That's partially why she chose Carole Boston Weatherford's book Schomburg: The Man Who Built A Library.

"Even though it is a picture book, I think we should think about picture books as everybody books, especially a book like this," she said.

The book tells the story of Arturo

Schomburg, a historian, writer, book collector and activist who lived during the Harlem Renaissance.

As a child, he asked a teacher why the class wasn't learning about the contributions of Black men and women to their country. The teacher told him that Black culture had nothing worthy to preserve.

"And that horrible statement stayed with him and fueled his lifelong passion for discovering, documenting and collecting proof and evidence of Black greatness across the globe," Medina said.

Schomburg's initial collection of around 5,000 items eventually led to the creation of the Schomburg Center for Research in Black Culture, a research library within the New York Public Library which now holds about 11 million items.

The book highlights some of the many people that Schomburg collected books and other items about, including Frederick Douglass and Phillis Wheatley, who is considered the first African-American author of a published book of poetry. He was also from Puerto Rico, born of African and German descent, so the book highlights Afro-Latino history and identity as well.

"I love the idea of intersecting identities, which sometimes get cast aside when when we're forcing people to sort of think of their identity as one thing or another," Medina said.

Medina said the book is a springboard for learning about a man who wanted to discover the truth about his culture and its contributions. From there, the reader can learn about the many other people Schomburg highlights in his collection.

The depth of contributions of Black Americans to the country's history and greatness are vast, Medina said. "I think kids deserve to know those things and deserve to learn about it and at least have the information so that they themselves can become little Arturo Schomburgs."

The Black Kids by Christina Hammonds Reed follows a Black teenager named Ashley, who attends a predominantly white high school in Los Angeles and has lived a fairly cushioned life.

Then, her world is upended by the Rodney King riots, which broke out in 1992 after four L.A. policemen, three of whom were white, were acquitted for the brutal beating of King, a Black man. Afterwards, Ashley is left questioning her life, identity and her position in society.

"I feel like it's kind of an untold story because it talks about the intersection of race and class," said Juno Kling, a teen librarian at the Blair-Caldwell African American Research Library in Denver.





### **ANGUILLA ENJOYS A SURGE** IN TOURISM ARRIVALS FOR 2023

## Minister outlines strategic plans to ensure sustained future growth

The Valley, Anguilla, February 5, 2024: Anguilla's Minister of Infrastructure, Communications, Utilities, Housing and Tourism and the Honorable Haydn Hughes proudly announced a remarkable surge in visitor arrivals to the island for 2023. Emphasizing the island's steady growth in arrivals and sustained.

Hughes highlighted the unprecedented success in his statement: "The total number of stopover arrivals has reached an extraordinary high of 95,944, surpassing the previous record set in 2019." This commitment is exemplified in the development of the terminal at Blowing Point, which aligns with the goal of delivering a top-notch travel experience for Anguillians and, consequently, positively influencing the overall visitor experience".

Minister Hughes further stated, "Ongoing improvements at the Clayton J. Lloyd International Airport have yielded a product that has garnered favorable feedback from the international carrier American Airlines. These enhancements address their customers' specific needs and preferences and underscore the government's unwavering commitment to cultivating a positive and enjoyable travel environment for both Anguillians and visitors".

"We are expanding our air services to sustain this upward growth trajectory. Intra-regional connectivity has expanded with the introduction of new routes linking Anguilla, Antigua, and St. Barths. Anguilla Air Services now offers scheduled flights between Anguilla and Antigua thrice a week from Tuesday, Friday, and Saturday until April 2024. Tradewind Aviation unveiled a codeshare partnership with British Airways, facilitating interline bookings. Flights connecting Antigua and Anguilla are scheduled to operate on Saturdays and Sundays from mid-January 2024 to early April," he continued.

Looking ahead, the Minister spoke of the development at Altamer Resort, a 118-berth marina designed to cater to yachts of up to 250 feet in size. Accompanying this is a luxurious 62-room 5-star hotel featuring 58 branded residences, including 20 beachfront villas and 48 resort condominiums. The comprehensive amenities include a state-of-the-art fitness center, a spa, and duty-free shopping. Notably, the resort will have its port of entry equipped with customs and immigration clearance facilities. Phase 1 will concentrate on completing the marina infrastructure by Q4 2025, followed by the Yacht Club Boutique Hotel component scheduled for completion in Q4 2026, he concluded.
