# FAHIE UNANIMOUSLY FOUND GUILTY: TWO JURORS REPORTEDLY CHANGED MINDS

The aftermath of the trial of Andrew A. Fahie, former Premier of the British Virgin Islands, has been marked by unexpected twists as two jurors reportedly changed their minds minutes after the guilty verdict was delivered. According to reports, they even reached out to presiding US District Judge Kathleen Williams, though she had already polled each of the 12 jurors on their unanimous verdicts and discharged them.

The Miami federal jury found Fahie guilty of conspiring to import cocaine into the United States and three

related charges money laundering and

racketeering on 8 February. - His sentencing is scheduled for 29 April.

However, on 12 February, the 'Miami Herald' revealed that the two jurors contacted the judge to express their differing views from the rest of the panelists and reversed their stance on the defendant's guilt. However, their change of heart came too late. Williams, -federal prosecutors, - and Fahie's-defenseattorneys now find themselves grappling with an unprecedented question: Can the judge reconvene the discharged jurors to reassess their trial verdicts?

The Miami Herald suggests-that historically, such an action would not be permissible-unless external pressure was exerted on the jurors or there was evidence of racial bias against Fahie, who is Black, neither of which appears to be the case.

Furthermore, there are strict constitutional restrictions on how much inquiry judges attorneys and can make into a jury's deliberations.

# "EXTREMELY LIMITED AVENUES" During an unusual post-verdict

hearing on 12 February, Judge Williams acknowledged the unique scenario,

stating: "I have extremely-limited avenues to explore." Federal prosecutors argue that the judge must uphold the unanimous guilty verdicts unless a mistake was made on the verdict form. Assistant U.S. Attorney Kevin Gerarde-emphasized that the discharge of the jurors nullified any

disagreements among them once they were polled in court.

Fahie's defense lawyer, Theresa Van Vliet, urged the judge to poll the two jurors in question, if not all 12, acknowledging the nature unprecedented of the situation. She highlighted-Fahie's potential-severe sentencing consequences and emphasized

importance of a fair assessment of the jurors' convictions.

Adding to the complexity, Van Vliet disclosed that one of the jurors had left a voice message on her law firm's phone, which neither she nor Fahie's second attorney, Joyce

Delgado, had listened to. Judge Williams proposed that both sides listen to the voice-mail recording privately and report back to her. She ordered motions to be filed by Thursday addressing the dilemma suggesting-potential solutions.

Ultimately, the judge could choose to uphold the verdicts or declare a mistrial, potentially leading to Fahie facing another trial with a different jury.

Meanwhile, in an official statement, Premier and Minister for Finance, Dr. the Hon. Natalio Wheatley issued a statement on behalf of the Government acknowledging the verdict reached on 8 February in the case before the Miami Federal Court.

The statement affirmed that both the Government and the people of the Territory hold deep respect for the court's role in administering justice. It was noted that as a jurisdiction, BVI the

remains steadfast in its commitment to good governance and upholding the highest standards of integrity in public life.

" We are dedicated to the ongoing process of enhancing the relevant systems and

institutions of government to safeguard the integrity of the Territory and maintain our international reputation, & quot; -the statement stated.

# RACETRACK LEASE: FORMER LEGISLATOR CALLS FOR DECISIVE ACTION

As horseracing, which is one of the most popular Territorial sporting events, continues in limbo after being halted by a land dispute, former Legislator Eileen Parsons has reiterated her call for decisive action, stressing the necessity of courageous leadership to resolve the impasse.

"I've been saying that if I were in power, I would have taken the damn land by eminent domain - get two appraisals for the land and pay the higher appraisal. If they don't want to take the money, put it in the bank. They'd be taking the money for the public good, it would have been settled," Parsons lamented.

Advocating for the government to assert eminent domain and acquire the venue forcefully, Parsons emphasized the urgency of bold decision-making.

The Former Legislator said during an interview on Tola Radio, "you need to have the courage - bad Andrew, good Andrew, he would have done settled this long time. It is a

shame that Easter is coming up and there will be no race."

Expressing disappointment in the current Minister of Sports, Sharie de Castro, Parsons urged her to take a more proactive role in addressing the issue within her ministerial capacity.

"There's a Minister of Sports

whose grandfather was a big horse owner. That young lady is totally silent. I hope she's listening. Don't tell me she can't come out and say something, this is her subject," Parsons asserted.

Meanwhile,-former President of the BVI Horse Owners' Association, Violet "Letty"

Hodge, stressed the need for collective action from the community to pressure legislators into restoring horseracing.

"I don't know if there needs to be a march, demonstration or something to let those higher heads know that we mean business and we want this thing back," Hodge emphasized.

# LAWMAKERS INTERESTS TO GAIN TRANSPARENCY AFTER COI RECOMMENDATIONS ARE IMPLEMENTED

Amidst two years of staunch resistance, the Cabinet has finally relented to implement significant changes in transparency regarding the interests held by lawmakers and senior public officials, aligning with the Commission of Inquiry's (COI) recommendation to overhaul the Register of Interests Act.

The Register of Interests serves as a repository for the financial interests of legislators, providing a platform for them to publicly disclose any private interests that may present conflicts with their public duties.

According to the COI findings, many lawmakers were egregiously late in declaring their interests, with some failing to do altogether. Previous attempts to reform the legislation faced fierce opposition from lawmakers, resulting in the passage of a diluted and severely restrictive version of the COI's recommendations.

Moreover, the government missed the December deadline set by the COI for implementing a framework that would extend the revised law to include senior public servants.

In a recent Cabinet decision, it was agreed that the Deputy Governor's Office would spearhead the amendments to the Register of Interests Act and relevant legislation. Among the proposed changes is the full accessibility of the Register of Interests for members of the House of Assembly to the public at no charge.

Furthermore, -the amendments aim to broaden

the scope of interest declaration to encompass senior public officers, particularly those at the level of Heads of Departments, Deputy Secretaries, officers in Grades 19 to 21. Given the past resistance, it is likely that the register for these officers will remain private, accessible only to the Governor and Deputy Governor.

Additionally, the proposed revisions advocate for granting the Registrar of Interests the authority to directly refer matters

concerning integrity to the Integrity Commission for advice.

Former Governor John Rankin, in his final quarterly review, reiterated his call for the government to take proactive measures in-enacting-good governance-legislation that has been pending for over two years. This most effective legislation a strengthened includes Integrity in Public Life Act, Whistleblower Act, and amended Register of Interests Act.

# SOME PUBLIC SERVANTS MAY FACE DELAYS UP TO 5 YEARS BEFORE RECEIVING INCREMENTS

In a significant update on the status of salary increments for public servants, Premier Dr. Natalio Wheatley has offered clarification on why some may face an extended wait of up to four years before receiving their promised increments earned several years ago.

Initially, public servants assured that were outstanding increments would be disbursed by the end of the second quarter of the preceding year. However, in a surprising turn of events revealed by Cabinet in December, it was disclosed that certain public servants might experience a delay of up to four additional years before receiving their increments.

As of 15 January, Dr. Wheatley reported that over 2,000 public officers

had already received their increments for the 2018 -2019 work years, a figure encompassing both active separated and public officers. He commended the Department of Human Resources for their dedicated efforts in facilitating this process while simultaneously gearing up for the implementation of a new salary structure.

The Cabinet's decision stipulates that all outstanding increment arrears for the public service must be settled by 2027, contingent upon funding availability and unforeseen circumstances.

Explaining the rationale behind extending the timeline to 2027, the Premier clarified that this adjustment aims to distribute the outstanding amounts

across several budget years. However, he emphasized that this doesn't preclude the possibility of earlier payments.

Moreover, Dr. Wheatley disclosed that ongoing in crement -salary adjustments from 2020 to 2022, originally slated for completion by December 2023, will now also incorporate the adjustment of a step for the 2023 incremental work year.

Addressing lawmakers, the Premier underscored the fluctuating total staff complement of the public service from 2018 to the present. He noted an increase from the initially reported 2,261 public officers to approximately 2,496 by the conclusion of 2023.

# The Ministry of Health and Social Development will be hosting a virtual workshop to improve the prescription of medication for the elderly.

The "Safe Prescribing for the Elderly" workshop will be held on Thursday, February 29 from 7:00 p.m. to 9:00 p.m. via a virtual platform. The session is geared towards doctors, nurses, pharmacists, pharmacy technicians and caregivers who wish to empower themselves with lifesaving information and improve care for the elder population. Chief of Drugs and Pharmaceutical Services, Mrs. Gracia Wheatley-Smith said, "The elderly are diagnosed with maybe two or three chronic conditions that decreases the functionality of the organs which makes them more prone to experiencing side effects and adverse drug events."

Mrs. Wheatley-Smith explained that prescribing for the elderly takes into account the side effects of medications, adverse events, drug to drug interactions, drug-disease interactions and medications that should not be prescribed for certain conditions.

The Chief of Drugs further stated that the workshop, aims to improve physicians prescribing techniques for the elderly.

"We also want to empower pharmacists to flag prescriptions and dosing information that may adversely affect the elderly," Mrs. Wheatley-Smith said. She added, "We want caretakers to be able to spot red flags early and alert family members, who would then liase with the doctor or pharmacist so appropriate actions can be taken. This is a part of efforts to improve the quality of care given to our elders."

The workshop will also feature the Beers criteria, which are five categories of potentially inappropriate medicines for persons over the age of 65. This include medications to avoid among persons with certain health conditions, medications that may cause drug to drug interactions, medications to avoid where the risk outweighs the benefit ratio, and medications to use at limited dosage or avoid due to effects on the kidney function.

Participants will gain knowledge on pharmacokinetic and pharmacodynamics changes in the elderly and the factors that influence doctors' prescriptions. A medicine utilisation review of a small random sample of prescriptions written for the elderly in the Virgin Islands will also be looked at among other objectives.

The workshop will be facilitated by Consultant and former Organization of Eastern Caribbean States, Pharmaceutical Procurement Service, OECS/PPS head, Mr. Francis Burnett. There is a \$10 registration fee and Continuing Education credits will be available upon completion.

# **Update on Implementation of COI Recommendations**

Statement Premier of the Virgin Islands Hon. Natalio D. Wheatley

9 February, 2024 Press Conference

A pleasant good day to all the people of the Virgin Islands.

The Government of the Virgin Islands has noted the verdict which was reached today in the case before the Miami Federal Court involving former Premier, Andrew Fahie.

The Government and people of the Virgin Islands respect

the role of the court in the administration of justice.

As a jurisdiction, the Virgin Islands is committed to good governance and upholding the highest standards of integrity in public life.

We will continue the ongoing process of strengthening the relevant systems and institutions of government to ensure that the integrity of the Territory is maintained and international reputation upheld.

We acknowledge the impact of the verdict on the family. Let us keep them in our prayers.

Today I will provide a further update on governance reform and my meetings earlier this week with UK Minister for the Overseas Territories, Honourable David Rutley MP. Those meetings, of course, took place on 4th and 5th February, 2024.

While on island, Minister Rutley also met with Cabinet and Junior Ministers, Members of the Opposition, Permanent Secretaries, and other officials.

These discussions were primarily about implementation of the remaining governance reforms.

In my specific meetings with Minister Rutley, we discussed each of these reforms in detail and my Administration's plans to implement them.

Minister Rutley gave very helpful input based on the UK experience with such exercises.

My colleagues and I reiterated our commitment to good governance and delivering all of the remaining governance reforms under the remit of the elected arm of government.

We also reiterated our desire for a modern partnership with the UK based on the new joint declaration that was agreed between the UK and the Overseas Territories Governments at the Joint Ministerial Council meeting just about three months ago.

I wish to again thank Minister Rutley for his visit and also Governor Pruce for the important role they played and with whom I will be working on governance reform matters.

As Premier of these Virgin Islands, I greatly appreciated the collaborative spirit in which our engagements took place.

In my statement on 6th February, 2024, I promised to provide some further details on what we have achieved in the reform programme and the work that lies ahead for us to

complete

Let me say that we are still working with May 2024 as our substantive deadline for full implementation. We have to keep the pace up and do our best to meet as many targets as possible. If there are still any outstanding deliverables by then, these must be very few.

As I mentioned on prior occasions, the framework for-implementation included proposals that were included in the COL recommendations but which the Government felt would be beneficial to the broader goals that we are trying to achieve and which would enhance the results to be achieved from the recommendations. The 50 recommendations and other initiatives have been broken down into 131 Actions. Some recommendations have more tasks than others. All Actions are not weighted equally, as some Actions require more work or are more complicated than others. This is a shared responsibility between the Elected Government, Governor's Group, and the House of Assembly. I will focus mainly on the areas under the Elected Government and the House of Assembly.

Following the visit of Minister Rutley, there are seven Actions that we are able to close off either because they are covered in other deliverables within the Framework, or because they are not in the Framework, although in the latter case, these Actions will be completed. These include, for example, the Amendment to the Jury Act (Action B43.02) which is dependent on an amendment to the Constitution. Declarations of Interests for Members of the House of Assembly and the policy for HOA Members contracting with the Government (Actions B05.04 and B05.05) are covered by Recommendation B4 as well as the Constitutional Review. Action B26.01, legislative amendments based on the Statutory Board Policy, has been closed pending approval of B25.02, Policy and Action Plan, which is on the Amber priority list.





# Update on Implementation of COI Recommendations...from page 6

Before I go further, may I remind everyone that the Government, under our Business at its Best initiative, and in the interest of being transparent and keeping the public informed, recently launched a website where persons can track the progress the implementation programme. The website is www.vicoiimplementation. vg, and there persons will find in-depth information on the status of the work on the Recommendations 131 Actions. I urge persons to visit the website regularly so that you can get first-hand information on the status of the very important matter of the reform implementation.

The majority of the remaining work is well on the way to a timely completion. For instance, in the Green line:

Recommendation B4 -Public Register of Interests; the legislation to extend the Register of Interests to a wider category of persons in public life is already with the House of Assembly, having undergone its First Reading. One of the Actions under this Recommendation is that of the establishment of the Integrity Commission. With the Integrity in Public Life Act having come into force on 7th February, 2024, the process of appointing the chairperson and members establish the Integrity Commission will commence.

Recommendations B10 – Assistance Grants Policy and B11 – Educational Assistance Grants – Both Policies have been submitted for Cabinet's Agenda and will be addressed soon.

Recommendation B30 – Crown Land Disposal Policy – The Policy has been submitted for Cabinet's consideration and will be addressed soon.

Recommendation B33

- Belonger and Residency
Process—The Draft Immigration
Policy was presented to me and
will be uploaded for Cabinet's
consideration in the next
few days. Once the policy is

finalised and approved, the process for translating it into legislation and having that legislation enacted into law will take place.

Recommendation B36 -Review of the Public Service Management Act - the Draft Bill is being reviewed by the Deputy Governor's Office and the Attorney General's Chambers. Once the Bill is finalised it will be taken to Cabinet for consideration and approval, and then to the House of Assembly for consideration and approval. Again, there is optimism that this can be completed in a fairly short time since a lot of work has already been covered.

Other Reforms 01 - The reforms to our elections process and legislation is another area where a significant amount of work has already been done and it is at the stage of finalizing the instructions for the relevant legislation to be drafted by the Attorney General's Chambers. The Supervisor of Elections report of the 2023 General Elections was recently tabled in the House of Assembly. The next step is for an informal meeting of the House of to review Assembly recommendations and decide on which recommendations would be advanced submitted for amendments to the Elections Act.

May I say that these seven Recommendations represent a significant portion of the Actions that have not yet been completed — many of which are underway. Completion of these Actions will take us into the region of at least 75 percent completion.

And again, I want to emphasise that the reforms are not a box-ticking exercise. The Government is serious in our commitment that the reforms must be done properly and implemented properly so that they will be effective, and so that they will truly benefit the Virgin Islands people.

The Amber line represents Actions that are not overdue, but which require critical attention to ensure that they remain on track. On the Amber line, we have:

Recommendation B01 – Revision of the COI Act – The DGO is working on drafting instructions. Once this stage is finalised, instructions can be issued for the legislation to be drafted.

Recommendation B25 – Statutory Board Reform – The Statutory Board Policy and Action Plan have been drafted, so the Cabinet Paper is being prepared.

There are a few items that are on the Red line. Red does not mean that the items are necessarily past due or failed. But it is a flag to pay particular attention to those Actions so that they can be brought in within time. In terms of Recommendations and Actions that are on the Red line:

Recommendation A03 - HOA Discretionary Powers Policy – Two Actions have been completed and we are moving into the stage of getting the policy drafted. A drafter has to be appointed which will take place within the next few weeks.

Recommendation A04 – Audits and Investigations – Most of the audits and investigations are completed. The Action related to Financial Recovery is the only remaining Action. This Action is being led by the Governor and the Attorney General's Chambers. Cabinet has to be formally

informed of what measures have been put in place for financial recovery.

Recommendation B07

- Public Assistance Grants

- This includes four policy documents, three of which have been completed. The Policy and Action Plan for the other is being finalised, following which instructions will have to be issued for the drafting of legislation and Regulations.

Recommendation B30 - Crown Land Disposal Policy - There are a couple of Actions that are critical to meeting the target of having the amended legislation in place.

Recommendation B42

- Reforms to the Criminal Procedure Rules - Drafting instructions have been issued and drafting complete. The revised draft is awaiting review by the Chief Justice/ECSS.

The Government, together with the Implementation Unit has updated our implementation strategy with the targeted completion date of May 2024. We are very confident that most, if not all the Actions, can be closed out on time.

Of course, again, I reiterate, this is not a box-checking exercise. We want the reforms to be done properly and for them to be effective.

One of the objectives of the reform programme, which was also one of the stated objectives of the COI, was good governance. Consistency and proper constitutional conduct requires that the principles of democracy and Good Governance must be followed in everything that we are doing in this reform exercise.

Hence, where it is

required that the citizenry is involved, for example through consultations, then we, as the Government, must ensure that consultations are held and that the consultative process is genuine. In developing legislation, we have to ensure that the legislative process is followed. We also have to respect the independence of the independent offices and bodies that are involved in some of the Action items. Most importantly, persons deserve to be given reasonable and ample space to do their work, so that we do not find ourselves down the road pointing fingers at persons if something was not done properly because someone was rushed. In this regard, the Government will continue to provide the resources and support so that persons can effectively perform.

I want to once again urge persons to regularly visit the website, www. vicoimplementation.vg, and get first-hand, updated information on the status of the reform implementation.

My Government and I remain confident and optimistic that the outcomes from our meetings with Minister Rutley, and the updated project plan we have charted, will have a positive bearing on the Virgin Islands People achieving their national goals, among which is that of more robust Governance systems and enhanced transparency, accountability and value for money in the operations of Government and to do this in the context of the COI recommendations within the timeframes we have set for ourselves.

The Superintendent added, "We look forward to building our rehabilitation programmes and combine what we do in terms of vocational skills and qualifications for prisoners but also expanding that into offending behaviour



and change modification programmes."

In addition, Gender Mainstream Lead in the Foreign Commonwealth Development Office Ms. Maria Stanley said the meeting was a great way to see stakeholders come together to look for ways to progress on all matters

relating to gender equality and equity.

# GLOBAL NEWS BRIEF STORIES SELECTED BY GIORGIO MIGLIAVACCA

WASHINGTON The Diplomatic Room — a charming room on the ground floor of the White House, decorated in pastel tones — is typically used for the formal photographs that the president takes with his guests at Christmas parties and various other celebrations. Due to its smaller dimensions than the large rooms on the main floor, it was chosen on Thursday, February 8, for Joe Biden to appear before the press after the devastating report released by Special Counsel Robert Hur.

The document exonerated Biden of having appropriated classified material, but it questioned his memory and mental sharpness. The idea was that - in a more secluded setting, where the president usually performs better than in front of crowds - he would demonstrate excellent mental abilities in front of the cameras. The result was the opposite: the various gaffes he made during the session fueled the controversy over whether he's fit to run for a second term.

The White House and Democratic insiders have come out en masse to defend the president, who — during his heated interaction with the press — confused Egypt with Mexico and stopped short while describing the rosary of

his deceased son, Beau. "No one who works here [agrees with Hur's report]. We all see a person who works very, very hard, who perfectly understands how Americans feel and how to respond to the issues that matter to them," said Biden's press secretary, Karine Jean-Pierre, at her daily press conference on Friday. [El Pais]

USA - Former US President Donald Trump said on Saturday that he would "encourage" Russia to attack members of NATO who had not met their financial obligations, in remarks that the White House rejected as "appalling and unhinged." Speaking at a campaign rally in South Carolina Saturday, the Republican presidential nomination frontrunner appeared to recount a conversation with a fellow head of state at an unspecified NATO meeting. "One of the presidents of a big country stood up and said, 'Well, sir, if we don't pay, and we're attacked by Russia, will you protect us?' I said, 'You didn't pay, you're delinquent?"

"No, I would not protect you. In fact, I would encourage them to do whatever the hell they want. You got to pay. You got to pay your bills." The NATO treaty contains a provision that assures mutual defense of member states if one is

attacked, but it also stipulates that members should spend 2% of their GDP on defense, a target that the majority of states regularly fail to meet.

Trump has long expressed skepticism about the 31-nation military alliance.

On being asked about Trump's statement White House spokesperson Andrew Bates, said: "Encouraging invasions of our closest allies by murderous regimes is appalling and unhinged — and it endangers American national security, global stability and our economy at home."

European Council President Charles Michel also denounced Trump's comments as "reckless." "The Transatlantic Alliance has underpinned the security and the prosperity of Americans, Canadians and Europeans for 75 years," said Michel on X, formerly Twitter." Reckless statements on #NATO's security and Art 5 (Article 5) solidarity serve only Putin's interest." [Deutsche Wellel

Sonia Guzman said that according to Central Bank figures, in 2023, the country received US\$10,157.2 million in remittances. Of this, some US\$8,532 million, 84% of the total received, came from the community established in the United States.

Guzman also highlighted that the United States continues to be the Dominican Republic's leading trading partner, claiming that in 2023, bilateral trade between the Dominican Republic and the United States totaled US\$18,072 million, where we exported a total of US\$6,489 million in Dominican products and goods to the United States, representing 54.38% of the total exported by the country.


"Exports from the DR to the US has not been reduced; what decreased were mining exports due to a drop in their production and prices," informed the diplomat.

She also noted that the United States is the number one country issuing non-resident foreign tourists to the Dominican Republic, representing 46.8% of the total number of tourists received.

During her speech at the Capitol, Sonia Guzman said, "The Dominican community in the United States is a moving force that continues to grow, not only in quantity, averaging about 2.3 million, but also in quality, as more and more Dominicans living in the United States have been educated and overcome, and currently occupy positions of relevance at the political, commercial, cultural, academic, economic, health and other levels, which fills us with pride."

Guzman added, "Dominicans are the fourth largest Latino community in the US, after Mexicans, Salvadorans, and Cubans, and we know how they have been efficiently integrating into US society and have reached levels of employment and education like never before." The Dominican ambassador to the US, Sonia Guzman, indicated that the Dominican Republic and the United States will celebrate 140 years of diplomatic relations established in 1884 next March.

She said that the relationship between the two countries continues to be one of friendship and close collaboration, as was highlighted during the visit of President Luis Abinader to the White House last November, where he held a successful bilateral meeting in the Oval

**DOMINICA** The Caribbean Public Health Agency (CARPHA) is urging persons to protect themselves against adverse health effects of a Saharan dust plume, which has covered many parts of the Caribbean. The Caribbean Institute for Meteorology and Hydrology (CIMH) in a Dust Bulletin dated February 9th. 2024 stated, "it is highly likely that particulate matter levels will be above the 24-hour outdoor air quality guidelines" as established by the World Health Organization (WHO).

Dr Joy St John, Executive Director, CARPHA, explained "Saharan dust worsens air quality and increases the levels of particulate matter in the air. This can be hazardous, especially to small children, older adults and people with underlying lung conditions and chronic cardiopulmonary diseases". Dr St John added, "Saharan dust can also worsen the health symptoms of those who suffer from asthma, allergies and chronic obstructive pulmonary disease (COPD)". [Dominica News]



# Optimism about the U.S. economy sends stocks to a new record

Stocks are on a record-setting run.

For the first time in history, the S&P 500, the broad-based U.S. index of the largest and best-known companies in the world, is above 5,000.

The S&P 500 opened over the milestone mark at the opening bell on Friday. This comes a day after it touched

the level for a brief moment before settling lower.

"Investors are feeling optimistic that we have sidestepped a recession," says Sam Stovall, the chief investment strategist at the financial research firm CFRA.

The latest economic data seem to indicate the Federal Reserve is getting close to executing a so-called "soft landing" for the U.S. economy. That's

despite widespread fears of a recession last year, when the Fed raised interest rates aggressively to fight high inflation.

The S&P 500 is up more than 5% so far this year, on the heels of a strong year when the index gained 24%.

# Lower interest rates will juice the economy further

Even then, some professional investors downplay the significance of milestones.

"I think it's a psychological threshold," says Stovall, noting that Wall Street has a fondness for round numbers, and investors see these "millennial levels" as key milestones.

Investors believe policymakers are comfortable enough with the progress they've made and will soon start cutting interest rates.

That would juice the economy because it would make it less expensive for everyone — companies included — to borrow money, and investors would also feel more comfortable making riskier bets.

Beyond that, hundreds of companies have updated Wall Street in recent days on their financial performance, and many of them performed better in the final three months of 2023 than analysts expected.

According to Stephen Suttmeier, the chief equity technical

strategist at Bank of America, the stock market rally has been strong, but narrow. The strength of a handful of companies have powered the major indices — the S&P 500 among them — higher.



Last year, a group of stocks nicknamed "The Magnificent Seven" accounted for most

of the broader market's gains, and most of those well-known companies — Alphabet, Amazon, Apple, Meta, Microsoft, Nvidia and Tesla — have continued to outperform.

Year to date, shares of Nvidia, which designs high-end microchips for most of the computers that power artificial intelligence, are up about 45%.

"It's a couple growth sectors, and that's it," says Suttmeier. "What's leading the market is still more growth-y, tech-y stocks."

And if you dig deeper, most of these companies are in the communication services and information technology sectors, which are beating the broader market.

So, where does the market go from here? It took 34 months — or slightly less than three years — for the S&P 500 to go from 4,000 to 5,000.

"If you look at the history, my guess is we spend some time above 5,000, probably spend some time below 5,000," Suttmeier says. "And I think we can actually move well beyond 5,000."

But he's of the belief, like many Wall strategists, that this rally needs to broaden to continue moving higher.



# POLITICSS: THE CORRUPTION CURVE

"Power tends to corrupt, and absolute power corrupts absolutely. Great men are almost always bad men." (Lord Acton)

We all like to think of ourselves as kind, honest, and benevolent. In our hearts, we are convinced that should we ever attain personal power, whether through building our own business, rising to the corporate executive office, becoming extraordinarily influential in our area of expertise, or in winning public office, we will continue to be honest and ethical, incorruptible to the end.

The action of wielding power varies greatly with the individual involved and the extent of power obtained. We are all familiar with the petty tyrant at work who rules a tiny business empire with greed and self-indulgence, bullying underlings without any sense of fairness or mercy. We have seen the research scientists who have forged a reputation over a lifetime fall into disgrace through subverting results to support their theories and their sponsors.

As the extent of power increases, we see the Enron and Lincoln Savings brand of tableaux unfold. Not only does that same greed and self-indulgence hold sway, but the concept of being above the law arises and accountability and trust are jettisoned from the boardroom. The more esoteric the lifestyle becomes, the greater the disconnect between the powerful and the rest of the world. Those who lack power are to be cheated, manipulated, and drained of their possessions surely only just desserts for their failure to rise to the top.

In a world where hereditary monarchies are an anachronism, the most absolute power lies in the political sphere whether wielded by a military-backed dictator or by those who have been so repeatedly elected to office that they no longer see themselves as public representatives but as entitled oligarchs of a system they control.

The presumptuous ambition of one man, Julius Caesar, led to the destruction of a republic that had guided Rome to the heights of civilization. The empire he created held the seeds of its own destruction in its descent into the unrestrained autocracies of a string of less than illustrious rulers who wielded their absolute power with caprice and personal whim.

The framers of the Constitution had a vision of a government where no such unconstrained power could arise because of the checks and balances inherent in the system they devised. No one could be above the law because the rule of law was paramount. The advise and consent required from different branches of government ensured that a multitude of voices and philosophical ideas were involved in any major decision.

But those who drove the development of our constitutional

law were giants in their own right. Washingtons refusal to accept the title of king, advocated by several of his supporters, signaled his rejection of too much power concentrated in one individual. His peers Jefferson, Adams, Franklin, Madison, and many more followed the same course: divide power to ensure that the needs of the many can be met through a myriad of representative voices.

Over the centuries, the checks and balances they built have kept the ship of state afloat. Occasionally listing to port or starboard, the sheer multiplicity of participants in the political process have been repetitively able to pull it back to an upright middle course. Certainly, there have been many dark periods of corruption and incompetence. We face such a darkness now: individuals in office for too long, with too much power within their grasping fingers; too many officials who have forgotten that they are public servants, developing a mindset of entitlement and the conviction that they know, better than anyone else, what is good for the public who, after all, elected them.

Only the rule of law, so carefully crafted more than 200 years ago, can keep them in check. The lawful prosecution of a congressman accepting millions of dollars in bribes, of a congressional leader who used election money as he saw fit rather than as the law required, and administration officials who destroyed a womans career and jeopardized the lives of covert operatives all over the world, restores balance in a world rife with corruption, greed, and overweening pride.

Ongoing investigations into the honesty of leaders in evoking the need for military intervention and the rising voice of dissent against financial favors for the rich and powerful at the cost of cutting services to the powerless poor, offer a glimmer of hope that the corruption will be curbed and the hubris of our leaders punctured and exposed.

The embattled defendants cry foul, claiming that the only transgression is the political ambition of their critics. They have moved so far beyond the pale of the common citizen that their own corruption and misdeeds seem entirely ordinary and acceptable to them.

Happily, unlike the impotent rubber-stamp Roman senators, we can face our would-be Caesars without threat of bodily harm and we can cast them out of their cozy nest with the most powerful weapon ever devised: the BALLOT BOX.

Claudette gave back to her adopted home as an active volunteer at several organizations. She spent hours sorting through donations and organizing the shelves of the BVI Red Cross thrift shop. She was also a volunteer docent at the Old Government House Museum where she shared her knowledge of the island with visitors. She served as an office assistant for St. Williams Parish, supporting Father Peter and Father Nihal in serving the community. She also loved animals. She and Ronald adopted three dogs over the years and actively supported the BVI Humane Society.

After Hurricane Irma damaged their home on Fahie Hill, Claudette and Ron decided to move back to the United States, where they took up residence in Baltimore, Maryland but the British Virgin Islands were never far from Claudette's thoughts as she kept up by phone and email with friends in the territory and spent time organizing her photographs and scrapbooks of memories of her years there. Claudette will always be remembered as an energetic and caring person and will be sorely missed by those who knew her. Funeral services took place in Sayville, New York, at St. Lawrence the Martyr Church on February 3, 2024. In lieu of flowers or other remembrances, donations may be made in Claudette's name to the BVI Red Cross or St. Williams Parish.

# Austin to Lead Talks on Defense Support for Ukraine

U.S. Defense Secretary Lloyd Austin is hosting a virtual meeting with allies Wednesday to discuss support for Ukraine as the two-year anniversary of Russia's full-scale invasion nears.

The Ukraine Defense

Contact Group brings together officials from more than 50 nations to coordinate their Ukraine efforts, but there is uncertainty about when the United States, the biggest provider of military aid to Ukraine, might resume its support.

"I think some of the messages that you'll hear is that the U.S. is going to stand with Ukraine for as long as it takes but we do need that congressional authority to continue to provide those packages," Pentagon deputy press secretary Sabrina Singh told reporters when asked about what message Austin would bring to the talks.

The United States has not sent any military aid to Ukraine since late December, when funding ran out.

The Senate late Monday passed a \$95 billion aid package that includes more than \$60 billion for Ukraine, but the legislation faces opposition in the Republican-led House of Representatives.

# US Senate Approves Aid Package for Ukraine, Israel and Taiwan

U.S. President Joe Biden called on U.S. lawmakers Tuesday to swiftly pass a \$95 billion foreign aid package for Ukraine, Israel and Taiwan, despite opposition in the Republican-led House of Representatives.

"I call on the speaker to let the full House speak its mind and not allow a minority of most extreme voices in the house to block this bill even from being voted on," Biden told reporters. Earlier Tuesday, the U.S. Senate passed the aid package by a 70-29 vote, with more than a dozen Republicans joining the

majority Democrats in support. Ukrainian President Volodymyr Zelenskyy quickly expressed gratitude, saying U.S. aid "helps to save human lives from Russian terror."

"American assistance brings just peace in Ukraine closer and restores global stability, resulting in increased security and prosperity for all Americans and all the free world," Zelenskyy said on X.

Senate Majority Leader Chuck Schumer said the measure is "one of the most historic and consequential bills passed [in] the Senate. A bill that so greatly impacts not just our national security, just the security of our allies, but also the security of democracy as we know it."

# Black History Month Recognizes Achievements, Contributions of African Americans

Black History Month, which began Feb. 1, has been recognized in the United States for 48 years as a time when governments, organizations and individuals celebrate the struggles, achievements and central role of Black Americans in U.S. history.

# How was Black History Month designated?

The month was officially recognized in 1976 by former President Gerald Ford, who said that the month was to "honor the too-often neglected accomplishments of Black Americans in every area of endeavor throughout our history."

Its origin stems from Negro History Week, a celebration created by Carter G. Woodson in 1926. Woodson was a historian, journalist and author who sought to expand the study and celebration of Black history in the U.S.

The second week of February was chosen to align with the birthdays of Abraham Lincoln and Frederick Douglass, according to the NAACP.

The establishment of celebrations across the nation led to calls to expand the week into a month, to which Ford later obliged.

#### What is the government's role in Black History Month?

Sine the month was officially recognized, every U.S. president has issued a statement to honor it. Many municipalities and state governments also issue statements each Black History Month to commemorate the struggles and achievements of Black Americans.

New York City Mayor Eric Adams issued a statement Feb. 1, recognizing the month and highlighting the steps he says still need to be taken to achieve racial equity, particularly concerning health care disparities affecting women of color.

Other local leaders have organized events to commemorate the month, with Washington Mayor Muriel Bowser hosting her inaugural "Welcome Black" event at the beginning of the month, showcasing local Black artists and performers

This year, President Joe Biden issued a proclamation highlighting the importance of the celebration and noting the actions his administration has taken to advance racial equity throughout the United States. Some examples include providing more than \$7 billion in funding for historically Black colleges and universities and implementing elements of the 2021 George Floyd Justice in Policing Act, aiming to mitigate police brutality.

However, according to a Pew Research poll in August 2023, 52% of adults say efforts to ensure equal rights for all people within the past 60 years haven't gone far enough. Additionally, about a third of Black Americans (32%) believe America hasn't made much or any progress on racial equality in the past 60 years.

# How is the month celebrated today?

Civil rights organizations often take the lead in celebrations.

The NAACP, founded in 1909 to ensure equality for minorities and eliminate racial prejudice in the U.S., its website says, operates in seven regions through state conferences, local branches, youth councils and college branches

Many of these branches and chapters organize Black History Month events throughout February.

For example, the Boulder County, Colorado, NAACP branch is organizing a Freedom Fund Celebration event on Feb. 18, where R&B artist Danielle Ponder will perform and author and activist Anthony Ray Hinton will be sharing his story and discussing criminal justice reform.

The Fairfax County, Virginia, NAACP branch is holding a speaker's event on Feb. 24, with guest speaker Marvin Powell discussing the theme of "Black Privilege."

Other organizations have chosen to rebrand the month to focus on Black history and emphasize the present and future.

Black Lives Matter has reframed the month to Black Futures Month, a "forward-looking initiative inspired by Black movement leaders," according to its website.

To celebrate the occasion, Black Lives Matter will be holding Music Mondays, Tech and Innovation Tuesdays, Wellness Wednesdays, Throwback Thursdays and Film Fridays. Each of these days will spotlight aspects of Black history and contemporary Black achievements for each theme.

# BVI U20 Football team set for CONCACAF tournament in Nicaragua

A BVI U20 Men's squad departs the territory on Saturday to participate in the CONCACAF U20 tournament in Nicaragua, and will hold a pre competition camp before the tournament kicks off Feb 23-March 2. The BVI is in Group A with Cuba, Nicaragua, Belize and Anguilla.

Since two tune up games in St. Kitts-Nevis in December, Coach Clinton "Tinnie" Percival told Island Sun Sports that they have been trying to put the team together in different ways. He said players have been coming to the training sessions and doing what's being asked.

"Now, we're expecting them to go out and execute what they've been training to do. What we have, we're making use of it and I'm happy with what I've seen so far," he said after Tuesday's training. "We had five or six overseas players, but based on that game in St. Kitts, we've been building around that and trying to possess the ball a lot more and more importantly, when we don't have the ball, we have the players working hard to regain it.

To me, I've seen a lot of progress in that so I'm really looking forward to the players really going out there and doing their best."

Despite facing formidable and experienced opponents, Percival said he has asked his squad to play simple football, try to do the things they've been asked and try to remember, it's a field that has 11 vs 11

"On the day, the team that's concentrating the most on the things they have been training to do, they'll most likely come out as the successful team, so I'm asking them to just do their best," he said. "I'm looking forward to good results. Whatever the results may be, I'm hoping that the players go out and do their best and for me their best is good enough so I'm asking them to do their best."

Percival said that in the group, Cuba, Nicaragua and Belize are higher ranked than the BVI, but have told his players while the rankings mean a lot, but at the end of the day, the teams that goes on the field and plays the best football on the day will most likely come out with the victory.

"It's a tough zone and I might be looking at it as the group of death," he said. "But it's better to be there because if we're at the bottom of the zone, it's only one way we can go is up, so I'm asking the payers to just stay positive and give it their best shot and at the end of the day, whatever we do, I'm going to be happy with what we've done."

He said that even though they've been working hard, there's good camaraderie and they have been trying to build the team spirit, because that will be more important than anything else. He added that if they play as one unit, they'll be as strong as everyone else.

"The mood has been good. Some players are going to be disappointed that they didn't make the final squad, but at the end of the day, that is what we want," he said of the team that started with over 40 players on the roster but had no more than 28 turning out on any given day, but doesn't include overseas players. "I heard that in the past, we didn't have an opportunity to choose who we wanted to play, we just had to play with what we got. Now we have a lot of players to choose from, a lot of competitiveness within the training and that is what we want. It makes it really tough for me and all the other coaches to make a final squad, so that is the kind of headache I want-being able to choose between more than one player-and I think I'm having that problem, but it's a good problem."

Heat oven to 325 F. Line two baking sheets with parchment paper.

In a large mixing bowl, combine maple syrup, orange zest and salt. Add nuts and toss until well-coated. Spread half of the nuts in a single layer on a baking sheet and bake for 8 minutes. Remove from oven and stir with a spatula. Return to oven and bake an additional 5-7 minutes, or until medium brown.



Place on wire rack to cool. Lightly sprinkle with fleur de sel, if you wish. Repeat with remaining nuts. When completely cool and dry, combine all nuts with chocolate chips and dried cranberries.

HOLLYWOOD — The children of four-time "Superman" Christopher Reeve bare their souls in a documentary commemorating the 20th anniversary of their father's passing at the age of 52. The documentary follows his rise to fame through 1995, when he was thrown from a horse, breaking two vertebrae in his neck and leaving him paralyzed from the shoulders down.

I met Christopher in 1976 when he played **Katharine Hepburn's** grandson on Broadway in "A Matter of Gravity." He also starred in the soap "Love of Life" and asked me to write a story on why he was leaving the soap. The photos and story ran in Soap Opera Digest, and I invited him to stay in my guest room in Hollywood if he ever needed to.

To my surprise, he called six months later after completing a role in "Gray Lady Down" with Charlton Heston and Rosemary Forsyth, and he became my house guest. I shot new photos of him, and two of them were sent to the producers of the upcoming "Superman" movie, who saw the jawline of the future "Man of Steel" in my photographs.

He was then flown to London for testing and serious bodybuilding to become "Superman" for four films from 1978-1987. In addition, he made other classic films such as "Somewhere in Time" (1980). In 2006, despite having partial paralysis and being in a wheel chair, he directed and executively produced the computer-animated sports comedy "Everyone's Hero," with the voices of Rob Reiner, William H. Macy. Raven-Symone and Whoopi Goldberg. Christopher truly was a super man!

Glen Powell has become the first breakout star of 2024. His rom-com "Anyone but You" passed the \$100 million mark, possibly saving the genre. In addition to his Netflix film "Hit Man" (due June 7) and the disaster film "Twisters" with Daisy Edgar-Jones and Anthony Ramos (due July 19), Powell is currently prepping for "Huntington," which was inspired by the 1949 British comedy "Kind Hearts

# O . How is Wendy Williams doing . since her talk show was canceled? Is she in good health? - K.J.



ness remains uncertain.


Is Catherine O'Hara going to be in a new show or mov-anytime soon? I loved her in "Schitt's Creek" and still watch the reruns. - B.B.



# A MAN DIED FROM ALASKAPOX LAST MONTH. HERE'S WHAT WE KNOW ABOUT THE VIRUS

Alaska health officials reported last week that a man died in January after contracting a virus known as Alaskapox.

The disease was first discovered in a person living near Fairbanks, Alaska, in 2015, and there have been several known infections since then.

But officials believe that last month's case is the first fatality from the newly discovered virus — as well as the first known case outside the state's interior — and authorities are now urging doctors across the state to be on the lookout for signs of the disease.

Still, authorities note that immunocompromised people may be at a higher risk for severe illness from the virus, and so far the only known cases of Alaskapox have been detected within the state. WHAT IS ALASKAPOX?

Alaskapox is of a type orthopoxvirus that infects including mammals, humans, and causes skin lesions. Other orthopoxviruses include the noweradicated smallpox virus as well as mpox, which was previously known as monkeypox and experienced an outbreak of thousands of cases worldwide in 2022.

"Orthopoxviruses are zoonotic viruses, meaning that they circulate primarily within animal populations with spill over into humans occasionally," said Centers for Disease Control and Prevention epidemiologist Julia Rogers, as reported by Alaska Public Media.

Alaska's Division of Public Health says the virus has been found primarily in small animals in the Fairbanks area, such as shrews and red-backed voles.

Patients typically have one or more skin lesions and can also develop swollen lymph nodes and joint or muscle pain.



# WHAT DO WE KNOW ABOUT THE REPORTED ALASKAPOX CASES?

There have been seven known infections in Alaska since 2015, including last month's fatality. Six of the infections were detected in the Fairbanks area, while the man who died last month was from a forested area of the Kenai Peninsula.

The patient who was hospitalized and later died was an "elderly man" who lived alone and was immunocompromised from cancer treatment, which "likely contributed" to the severity of his illness, officials say.

The man also told health officials that he gardened in his backyard and took care of a stray cat, which hunted small animals nearby and would frequently scratch him. The cat tested negative for orthopoxvirus.

Officials believe there have been more cases of Alaskapox in humans that weren't caught.

Rogers, the epidemiologist, said she expects Alaskapox infections to remain rare.

Most patients who had documented cases of Alaskapox

suffered mild illnesses that cleared up on their own after a few weeks.

Can I get Alaskapox from another person? It's unclear.

To date, no human-to-human transmission has been documented, Alaska's Department of Health says.

It also notes that some orthopoxviruses can be passed on via contact with skin lesions.

Pet cats and dogs may also spread the virus.

"We are not sure exactly how the virus spreads from animals to people but contact with small mammals and potentially domestic pets who come into contact [with] small wild mammals could play a role," the Division of Public Health says on its website.

Health officials encourage people with lesions potentially caused by Alaskapox to keep them covered with a bandage.

The Centers for Disease Control and Prevention recommends that people keep a safe distance from wildlife and wash their hands after being outside.

# WHAT'S BEING DONE TO RESPOND TO THE ALASKAPOX CASES?

The first six cases of Alaskapox were discovered in the Fairbanks area, but the more recent case occurred in the Kenai Peninsula, indicating that the virus is more geographically widespread in the state than previously known.

The Alaska Section of Epidemiology, along with the CDC and the University of Alaska Museum, are working outside the state's interior region to test small mammals for the virus.

State health officials are also urging Alaska doctors to familiarize themselves with the symptoms of Alaska pox and reportany suspected cases to the Section of Epidemiology.




