Premier and Minister for Finance Dr. the Hon. Natalio Wheatley has issued a comprehensive statement in response to the recent publication of the Mutual Evaluation Report (Report) of the BVI by the Caribbean Financial Action Task Force (CFATF). The Report, a culmination of extensive evaluations and-assessments, provides insights into the

jurisdiction's adherence to-international standards-and protocols-concerning financial integrity and transparency.

In his address, Premier Wheatley emphasized the-government's unwavering commitment-to upholdinghighstandards of financial integrity and-transparency, which are paramount

fostering for trust and credibility within the global financial community.-The Premier underscored the importance of embracing the Report's findings and recommendations, viewing-them-as opportunities-for enhancing regulatory frameworks-and strengthening mechanisms aimed at combating financial crimes such as money laundering and terrorist financing.

The-Government's response to the Report includes the unveiling of a comprehensive National-Action Plan, meticulously crafted to address the recommendations

outlined therein. Premier Wheatley reaffirmed government's the dedication to rigorously implementing Action Plan, allocating resources, and fostering collaboration between the public and private sectors to ensure its successful execution. This implementation process will be closely monitored by the through CFATF its follow-up mechanism, underscoringthe-jurisdiction's commitment-to accountability and transparency its in financial practices.

Deputy Premier and Minister for Financial Services, Labour, and Trade. Hon. Lorna

Smith provided further insights into the concrete steps already underway to align with the Report's recommendations. These measures include revision of the National Anti-Money Laundering/ Countering the Financing Terrorism (AML/ of CFT) Policy, the enhancement of risk assessment frameworks and inspection processes, and the implementation of a regulatory framework for virtual assets service providers (VASPs) by the Financial Services Commission (FSC).

Attorney General, Hon. Dawn Smith, confirmed the commencement of implementation of the National the Action Plan, emphasizing the government's active engagement with CFATF and its commitment to

fulfilling its obligations as part of the Financial Action Task Force Global Network.-Minister Smith-highlighted the robust legislative framework already in place, which, coupled with the collaborative efforts between the public private sectors, positions the Virgin Islands effectively to

implement the CFATF Recommendations and safeguard the integrity of its business and financial services sector.

Minister Smith further stressed the collective responsibility of all stakeholders, both in the public and private sectors, in mitigating the risks associated with financial crimes. She emphasized the importance of fostering a culture of compliance and vigilance, urging for enhanced c o o r d i n a t i o n - a n d cooperation among law enforcement-agencies, competent-authorities, and industry professionals to effectively identify and address potential threats.

PREMIER COMMITTED TO RESOLVING THE ISSUES PLAGUING CUSTOMS PROCESSING

Premier Dr. the Hon. Natalio Wheatley made a firm commitment to address the ongoing delays in processing goods at the Territory's ports. This assurance came in response to mounting concerns from both businesses and Leader of the Opposition, Hon. Ronnie Skelton regarding the sluggish pace of customs clearance procedures.

During the House of Assembly, Skelton expressed frustration over the extended wait times, citing that it now takes up to five days for goods to clear customs - a delay that he emphasized is severely impacting businesses. Leader of the Opposition's remarks underscored the urgent need for corrective measures to alleviate the strain on enterprises grappling with increased costs and operational inefficiencies. In response, Premier Wheatley echoed these concerns, acknowledging the detrimental

effects of delays on businesses, particularly the escalating fees incurred by containers lingering at the ports for extended durations. In light of these challenges, Hon. Wheatley pledged to initiate discussions with port authorities and customs officials to explore viable solutions aimed at expediting processing times.

During a recent House of Assembly sitting, Hon. Wheatley provided insights into the steps being taken to address the deficiencies in the Customs Automated Processing System (CAPS), which plays a pivotal role in revenue collection and importation data management. CAPS modernization The initiative seeks to enhance computing compatibility, data storage capacity, system security, and user experience to streamline operations and bolster efficiency.

Funding allocated in 2023 facilitated the procurement process, culminating in an

agreement with IBM for the acquisition of essential hardware, including the IBM Cisco HyperFlex node server, along with requisite licenses and accessories. Substantial investments have been made in server infrastructure, power supplies, backup systems, and software licensing, with construction underway facilitate the system's upgrade. Premier Wheatley assured stakeholders-of-the government's-unwavering to resolving commitment the issues plaguing customs processing, emphasizing the pivotal role of an efficient system in sustaining the Territory's economic prosperity. The proposed upgrades to CAPS underscore a proactive approach by the government modernize critical infrastructure, thereby fostering conducive environment business growth and development.

VI Government to Address Illegal Developments on Crown Lands

The Government of the Virgin Islands will be addressing illegal development on the Territory's Crown lands as well as removal of derelict vehicles, boats and heavy equipment machinery on these lands.

Permanent Secretary in the Ministry of Environment Natural Resources and Climate Change Mr. Ronald Smith-Berkeley stated that as per the newly instituted Crown Land's Policy under the subject of Monitoring and Control, the policy authorises the Ministry of Environment to remove or demolish any illegal structure.

Mr. Smith-Berkeley said the Territory's Crown lands are to be strategically utilised to facilitate the administration and operations of Government and to achieve agreed development objectives, including ensuring delivery of critical public infrastructure, community facilities and social services.

He said other objectives also include development of agriculture and fisheries; environmental protection; adaptation to climate change; reduction of disaster risk; and supporting affordable land and housing programmes for Virgin Islanders, and belongers.

Mr. Smith-Berkeley is cautioning persons who are infringing on this section of the law/policy that their developments will be removed at their expense if they fail to comply with enforcement notices issued under the Physical Planning Act. The Permanent Secretary said, "The Ministry, in collaboration with the Royal Virgin Islands Police Force will remove, at the owner's expense, any vehicle, building material and other personal property left unattended or abandoned on Crown

Mr. Smith-Berkeley added that the ministry is charged with the conservation of the environment of the Virgin Islands, as well as the preservation and development of its natural resources and that the necessary legislation is put into place to support it.

Land, including public roads and sidewalks, for more than five

The Virgin Islands Crown Land Policy governs the administration management, development and use of all Crown land for all purposes, and focuses on strengthening the transparent administration and management of Crown land, including disposal of the same.

TRANSFER OF MANAGEMENT OF FESTIVALS CRITICIZED BY OPPOSITION MEMBER

Opposition Member Hon. Marlon Penn has accused Premier Natalio Wheatley of unlawfully transferring the management of festivals and events in the Territory. Penn's allegations center around the purported illegal shift of responsibilities from the Virgin Islands Festival & Fairs Committee (VIF&FC) to the British Virgin Islands Tourist Board (BVITB).

During a recent interview on Tola Radio, Hon. Penn raised concerns over what he perceives as a of sidestepping pattern legal procedures in favor personal agendas. He emphasized that the established law designates the VIF&FC as the rightful overseer of festivals and fairs within the Territory. Penn criticized the government's decision to bypass this legal

mandate, viewing it as a threat to the rule of law and accountability.

According to Penn, the Islands Festivals Virgin and Fairs Committee explicitly outlines Act committee's role in managing national festivals and fairs, underscoring the for adherence necessity to legal frameworks. He argued that any changes to these protocols should be enacted through proper legislative channels rather than executive fiat.

Penn cautioned against the dangerous precedent set by disregarding established

laws and expressed about apprehensions potential future arbitrary decisions impacting other institutional frameworks. He urged for transparency, accountability, adherence to due process to safeguard governance principles.

In response, the Cabinet of the Virgin Islands defended its-decision,-framing the transfer of festival management functions to the BVITB as a strategic move to enrich the tourism sector with elements of local culture and heritage. Premier Wheatley, who oversees the Ministry of Tourism and Culture, highlighted the decision as part of broader efforts to enhance tourism opportunities by integrating Virgin Islands culture into the tourism product.

The dispute surrounding the transfer of festival management responsibilities underscores broader tensions concerning governance, compliance, legal and cultural preservation in the British Virgin Islands. As controversy unfolds, stakeholders await further clarification on the legality and implications of the government's actions.

SENTENCING OF FORMER MANAGING DIRECTOR OF BVI PORTS AUTHORITY POSTPONED

The sentencing of Oleanvine Pickering-Maynard, the former Managing Director of the BVI Ports Authority who struck a plea deal with the US Drug Enforcement Administration-(DEA), has been postponed once more. Initially scheduled for various dates, most recently

22 February, the new sentencing date has been set for 28 March by a Miami federal court.

Pickering-Maynard's case has been closely watched, particularly after her testimony against Mr. Fahie in his recent trial, where he was found guilty of drug and money laundering conspiracy charges. Her cooperation in Fahie's trial, coupled with her plea deal, has drawn significant attention to her own sentencing process.

This delay follows a pattern of postponements, with previous dates set for 21 August and 22 January. The latest extension further prolongs the resolution of-Pickering-Maynard's legal-proceedings, leaving stakeholders and observers awaiting further developments.

In a related case, Pickering-Maynard's son, Kadeem Maynard, was sentenced on 20 November to serve 57 months in prison after pleading guilty to a single count of conspiracy to import cocaine. The interconnected nature of these legal proceedings underscores the complexity and scope of the investigations surrounding drug-related offenses in the region.

Meanwhile, Mr. Fahie's sentencing, initially scheduled for 29 April, faces uncertainty following revelations that two jurors have changed their minds about their guilty verdict.

US District Judge Kathleen

Williams has called for federal prosecutors and defense attorneys to reconvene on 7 March to address this development and potentially find a legal solution.

The unfolding events surrounding Pickering-Maynard's sentencing and Fahie's trial highlight the intricacies of navigating the legal system in cases involving drug trafficking and conspiracy charges. As the legal saga continues, stakeholders anticipate further clarity on the outcomes and implications of these proceedings.

STATEMENT ON PUBLICATION OF MUTUAL EVALUATION REPORT OF THE VIRGIN ISLANDS

Premier Honourable Dr Natalio Wheatley has reacted to today's publication of the Mutual Evaluation Report (Report) of the Virgin Islands by the Caribbean Financial Action Task Force

(CFATF).

The Government has welcomed the Report and confirmed that it is committed to rigorously implementing its recommendations, as laid out in the National Action Plan, also published today. This implementation process will be observed by the CFATF through its follow-up process.

Premier Wheatley said: "We know high standards of financial integrity and transparency that meet global standards are essential. The Government has prioritised resources to support the work outlined in the Action Plan and I am confident that our public and private sectors will work together to ensure that we progress successfully."

Deputy Premier and Minister for Financial Services, Labour and Trade, Honourable Lorna Smith, OBE said: "The Report made a number of Recommendations and I can verify that a number of these actions are already underway.

These include:

Commencement of a revision of the National Anti-Money Laundering/Countering the Financing of Terrorism (AML/ CFT) Policy

Updating-and implementingrisk assessment frameworks and inspection processes of the FIA and Financial Services Commission (FSC)

Implementation-of the virtual assets service provider (VASP) regulatory framework by the FSC

Drafting of legislation to address minor technical gaps identified in the Report

Ensuring that maintenance of beneficial ownership information is directly with a public authority

Commencement of the terrorist financing risk assessment of Non-Profit Organisations by the Financial Investigations Agency (FIA)

The establishment of a specific Sanctions Unit within the Attorney General's Chambers to ensure greater efficiency in dealing with all sanctions related matters

Specific training for law enforcement agencies and other relevant authorities on money laundering investigative techniques and sanctions compliance

Measures to enhance coordination and cooperation amongst law enforcement agencies

and other competent authorities

Plans to update our terrorist financing risk assessment and assess the specific risk posed to the jurisdiction by legal persons and legal arrangements.

The introduction of a Compliance and Governance Master Course to provide industry professionals with essential knowledge and skills."

Attorney General, Honourable Dawn J. Smith confirmed that implementation of the National Action Plan has started.

The Attorney General said: "The Minister's presence at the CFATF Plenary in November 2023 demonstrated the high level of commitment of the Virgin Islands Government, its respect for the CFATF and its responsibilities as a part of the Financial Action Task Force (FATF) Global Network. We have a strong legislative framework in place and I believe this, together with the robust partnership between the public and private sectors, means that we will be able to safeguard the integrity of our business and financial services sector and implement the CFATF Recommendations in good time and to its satisfaction."

Minister Smith added "All of those engaged in business and financial services in the Virgin Islands - whether in the public or private sector - must recognise that there are those who would misuse our services. Our goal is to ensure that the Virgin Islands is always a hostile environment for illegitimate financial activity. The partnership between ourselves, our competent authorities, law enforcement agencies and the private sector, to identify and address the risks we face is vital. We must work together even more closely to mitigate them and successfully pursue the prosecution of financial crime.'

The Public is hereby informed that continuous Voter Registration is ongoing, and all persons who are eligible are encouraged to register to vote.

To be qualified to register, a person must be a Belonger as per section (2) of the Virgin Islands Order Constitution 2007, 18 years of age or older, and domiciled in the Virgin Islands.

Documents to be presented when registering are either a Virgin Islands Passport with embossed seal, Belonger's Card or a Belonger's Certificate.

A Naturalization Certificate can also be used, provided the certificate is dated before June 15, 2007.

Further, section 17(1) of the Elections (Amendment) Act No. 14 of 2011 states that:

"A registered voter who is ordinarily resident in the Territory and who moves his place of residence from within one local electoral district or polling division to another, may have his name transferred to the list of voters for the local electoral district or polling division to which he has moved, if he applies on Form No. 9 and establishes, to the satisfaction of the Supervisor of Elections, proof of residence within the local electoral district or polling division to which he/she has moved".

Persons who have moved their place of residence and wish to transfer are encouraged to apply for a transfer.

Documents to support a transfer can be in the form of Cable, Water, Electricity or Telephone bills, a rent receipt, lease agreement or a notarized document stating the new address.

Registration and Transfer forms are available at the Office of the Supervisor of Elections, Road Town Post Office, the District Offices on Anegada and Virgin Gorda and the Government Office on Jost Van Dyke. \

SPAIN -A 14-story residential complex in Valencia, Spain's third-largest city, was devoured by a fire on Thursday last week, killing at least five people and injuring 15, by the latest count on Friday afternoon. The flames swept through the two contiguous buildings in just half an hour, raising questions about the way the complex was constructed.

Housing units inside the residential complex began to be marketed in 2006, and construction was completed in 2008, right in the middle of the property bubble in Spain. The complex is located in the northwest of Valencia, in the Nou Campanar neighborhood.

Like the entire real estate sector, the developer behind the building - a firm called Fbex — went into crisis. In 2010 it filed for bankruptcy after racking up €640 million (\$693 million) in debt. The development, financed by Banesto - a bank that was later absorbed by Santander in 2012 — passed into the hands of the lender. [El Pais]

RUSSIA - The Russian Olympic Committee has lost an appeal against its suspension by the International Olympic Committee. The Court of Arbitration for Sport said Friday that it had dismissed the ROC's appeal against the

suspension imposed in October. The IOC objected to the ROC incorporating four sports bodies representing regions of eastern Ukraine, which it calls "a breach of the Olympic Charter".

Russia was already barred by the IOC from entering athletes for the Paris Olympics under its own flag, and the suspension doesn't stop the IOC's efforts for Russians to compete as neutral athletes without national symbols. CAS said it found the suspension issued by the IOC executive board "did not breach the principles of legality, equality, predictability or proportionality."

The ROC said the CAS ruling, which has not yet been published in full, "practically copied out the IOC's arguments" and ignored the Russian case. [El Pais]

ITALY Centre-left opposition Democratic Party (PD) leader Elly Schlein told supporters Saturday to fight for the legalisation of gay marriage and cannabis in Italy.

"Let us fight together for egalitarian marriage and for the legalisation of cannabis, also approved in Germany, these are important battles", she said at the event 'For the United States of Europe', organised in Rome by the Più Europa (More Europe) party. [ANSA]

RUSSIA - The body of late Russian opposition leader Alexei Navalny has been handed to his mother more than a week after he died in an Arctic prison colony, his spokesperson said on Saturday.

Navalny, President Vladimir Putin's most vocal critic, died on Feb. 16 in one of Russia's toughest prisons in northern Siberia, where he was serving a 19-year sentence on charges widely seen as political retribution for his opposition.

"Alexei's body was handed over to his mother. Many thanks to all those who demanded this with us." Navalny spokesperson Kira Yarmysh said on X, formerly known as Twitter. For the past week, Russian authorities had refused to give Lyudmila Navalnaya custody of her son's body, after she traveled to the town of Salekhard in the Yamalo-Nenets region, the nearest settlement to the prison colony where Navalny died. [The Moscow Times]

FRANCE - Actress Judith Godreche, a leading figure in France's #MeToo movement, received a standing ovation at the Cesar Awards after calling for the French film industry to "face the truth" about sexual violence. At the Cesar Awards in Paris on Friday, French Judith actress Godreche denounced the French film industry's "level of impunity, denial and privilege" in dealing with allegations of rampant sexual abuse. A leading figure in France's #MeToo movement, Godreche had been invited to speak at France's version of the Oscars, after actresses alleged they were teenage victims of sexual abuse by directors. Godreche has accused directors Benoit Jacquot and Jacques Doillon of sexually assaulting her while she was a teenager.

"Why accept that this art that we love so much, this art that binds us together, is used as a cover for illicit trafficking of young girls?" she said. "We can decide that men accused of rape no longer rule the [French] cinema." "Is it possible that we are able to face the truth?" the actress questioned. [Deutsche Welle

GERMANY - A German bank is making negative headlines for its investments in US commercial property. While many European banks have avoided these assets on a grand scale, Deutsche Pfandbriefbank has embraced them. What comes next? Worries about US commercial property are making a German bank nervous. What had previously promised high profits is becoming a massive problem for Deutsche Pfandbriefbank (pbb). The mid-sized bank based near Munich specializes in commercial real estate loans in Europe, but is also heavily invested in America.

The vacancy rates for offices and business premises there are higher than they have been for years. It is partly a knockon effect of the COVID-19 pandemic and the new norm of working from home. More broadly, tighter lending, higher interest rates and inflation are making construction and real estate less attractive.

Overall, pbb is sitting on customer loans of just over €49 billion (\$52.9 billion). Of that, around 44% of its real estate financing is connected to commercial real estate in Germany. Yet around €5.4 billion, or 15%, is tied to commercial real estate in the US. A market "where uncertainty surrounding commercial real estate valuations is particularly high," according to a recent report by S&P, a credit rating agency. [Deutsche Welle]

LUCIA authorities in St. Lucia are intensifying their investigations following a series of violent episodes that have rocked communities across the island.

In the southern town of Vieux Fort, two individuals were killed, while numerous others sustained injuries during a recent outbreak of gun violence.

Meanwhile, a separate fatal incident occurred in Dennery, a serene fishing village nestled along St. Lucia's eastern coast.

Affordable, Sustainable, and Simply Delicious: Canned Salmon for Budget-Conscious Cooks

Here's a stellar pantry staple I don't write about often enough, so let's dive into some canned salmon.

There's no doubt that salmon is among the healthiest of foods. Yet fresh salmon is expensive, seasonal and sometimes hard to find, particularly salmon that's wild caught rather than farmed. So, while we wait for fresh salmon to go on sale, canned salmon is an affordable choice for the frugal and fabulous pantry.

It's crucial to scrutinize salmon labels for quality. Farmed salmon, raised in crowded pens with antibiotics and toxins, poses health risks. Avoid Atlantic salmon, which is farmed due to overfishing. Opt instead for wild-caught Alaskan pink salmon, sustainably harvested in well-managed fisheries. Not only is it ethically sound, but also budget-friendly.

If you've never tried canned salmon, here's what you should know. Canned salmon comes in two varieties: with the skin and bones (less expensive) and without (more expensive).

If you buy salmon with the skin and bones, there's a tiny little drawback. Namely, skin and bones. You're getting a section of the whole fish (scales and organs removed) then pressure cooked right in the can. The bones are soft and completely edible, in fact, they're highly nutritious. You can choose to eat everything in the can, or you can pick out the skin and bones, leaving only the fillets.

If you or your family feel squeamish about the bones, I suggest you remove the obvious bits and add a handful of slivered almonds to any recipe using canned salmon to completely camouflage any remaining bones.

Canned salmon is so versatile; you can make sandwiches, salads, chowders, pasta and more. But a family favorite is salmon patties -- crisp on the outside, tender on the inside and bursting with flavor. This adaptable recipe also makes awesome burgers or little appetizer cakes.

SALMON PATTIES

Yield: 4 to 6 servings Total Time: 1 hour 1 cup mayonnaise

1/2 cup green onion, minced, divided

1 teaspoon lemon zest

1 tablespoon fresh lemon juice

3/4 teaspoon Old Bay seafood seasoning

1/2 teaspoon low sodium soy sauce

1/2 cup celery, finely minced

2 eggs

1 (14.75 ounce) can pink salmon

1 tablespoon slivered almonds, optional

1 3/4 cups panko breadcrumbs, divided

1 tablespoon everything bagel seasoning

2 tablespoons vegetable or olive oil, for frying

In a mixing bowl, combine mayonnaise, half (1/4 cup) of the green onions, lemon zest and juice, Old Bay and soy sauce. Reserve about 1/2 cup of this mixture to use as a dipping sauce or spread later. Into the remaining mayo mixture add celery, remaining green onion, beaten eggs and salmon. For this purpose, I remove the skin and bones, but it's your choice. Add the almonds, if

desired. Stir to combine. Thoroughly fold 1 cup of panko breadcrumbs into this mix. Refrigerate for at least 20 minutes. Meanwhile, in a shallow bowl, combine the remaining panko and everything bagel seasoning.

When you're ready to cook your patties, place a skillet on medium-low heat and add 1 tablespoon of oil.

Divide the mixture and form 4 or 6 patties. Press each patty into the panko mix, covering all sides. The patties are sticky until they're coated, then they're much easier to work with. Place into the heated skillet in batches. Cook on the first side for 4 minutes before carefully flipping over until fully cooked. Repeat with remaining patties, adding oil as needed. Serve with the reserved dipping sauce or as a burger with the usual accompaniments.

So, next time you're stocking your pantry, I hope a few cans of salmon find their way back upstream to your shelf.

Haiti, as a sister nation of the Community was a key focus of the 46th Regular Meeting of the Conference of Heads of Government of the Caribbean Community in Georgetown, Guyana, on 26 February. "

CARICOM Heads of Government,-including Haitian Prime Minister Ariel Henry, met with International Partners of Haiti including, Canada, France, the United States, the United Kingdom and the United Nations in a coordination meeting on the situation in Haiti in the context of the Security Council Resolution 2699. Haiti, as a sister nation of the Community was a key focus of the Forty-Sixth Regular Meeting of the Conference of Heads of Government of the Caribbean Community in Georgetown, Guyana, on 26 February.

The Heads of Government

and the Partners received an update on the situation by the Coordinator of the Eminent Persons Group, former Prime Minister Kenny Anthony. In the course of a frank and in-depth discussion on the situation in Haiti, the CARICOM Heads Government expressed their deep concern over the continued deterioration of the security, humanitarian and political situation, and the continued delay in overcoming the political stalemate, which have blocked the possibility of free and fair elections. CARICOM Heads underlined the critical and immediate need for a clear political path forward which should be participatory and inclusive.

The CARICOM Heads took note of the commitment made by Prime Minister Ariel Henry to major steps to move the political process forward, including the holding of general elections to restore constitutional government and authority no later than 31 August 2025. To this end an

electoral needs gap assessment team will be put together led by CARICOM and the United Nations with the support of Canada, United States of America and the Organisation of American States by 31 March 2024, to support planning and efforts of the relevant Haitian institutions to be established.

The CARICOM Heads and the key Partners recognised the depth of the suffering of the Haitian people. This has been exacerbated by the lack of consensus among the political stakeholders, civil society, the private and religious sectors and the Government of Haiti. In this regard, the CARICOM Heads of Government called on all concerned to make the necessary concessions to arrive at a resolution of the political impasse. They urged that each Stakeholder must recognize that they will not obtain all that they want, but Haiti must obtain what it needs.

Against this background CARICOM will extend an invitation to the Stakeholders to participate in a meeting urgently to address and settle the critical political path that is participatory and inclusive.

In reaffirming the right to freedom of expression and to public speech CARICOM Heads of Government strongly condemned the development, presence, tolerance, or acceptance of violent, anti-social music and social media content that denigrate women and encourage or promote or support the use of violence, guns, and other anti-social behaviour, particularly targeted to our Youth.

CARICOM Heads of Government affirmed their support for engaging with young people in the creative economy, including the entertainment and music industry, and the sporting industry to develop, support and spread across the Region positive content to offset the negative impact of antisocial, violent, and criminal behaviour, which some elements in that sector promote and support.

Given the serious, significant and chronic negative developmental impact that crime and violence is having on Member States, CARICOM Heads of Government committed to working with all sectors and institutions, including civil society, academia, labour, churches, our creatives, law enforcement, the judiciary, political parties, employers and businesses, and our external partners to implement all of the measures set out in the Declaration on Crime and Violence as a Public Health Safety Issue. CARICOM Heads of Government remain committed to maintaining this Region as a zone of domestic peace and safety to ensure the preservation of our Caribbean civilisation.

Cabinet Approves New Immigration Policy

The Belonger Status and Permanent Residence Policy for the Virgin Islands has been approved by Cabinet.

The policy addresses issues including the length of time required for being eligible for Residence and Belonger Status, the establishment of guidelines and criteria governing the award of status by Cabinet, and the process for determining quotas. Moreover, other issues addressed include children's path to Residence Status and Children Born in the BVI to Non-Belonger Parents.

Premier and Minister responsible for Immigration Honourable Dr. Natalio Wheatley said that the policy's foundation is focused on creating a balance between economic growth, cultural integration and social stability. He said the policy will not only recognise the invaluable contributions of immigrants to the Virgin Islands community, but will also safeguard the interests and heritage of Virgin Islanders.

Premier Wheatley said, "The new Immigration Policy proposes planning and decision-making processes that will inform the sustainable management of statuses granted. The policy was approved after a careful analysis of labour market needs, population density, the importance of fostering investment and availability of resources which will ensure balanced growth."

This approach the Premier said will allow for a more controlled and beneficial immigration process, contributing to the overall wellbeing and prosperity of the Virgin Islands.

The work that has been undertaken in this area of reform not only address the longstanding issues outlined in Recommendation B33 of the Commission of Inquiry, but also speak to an immigration policy that transcends the original scope.

Acting Permanent Secretary in the Ministry of Tourism, Culture and Sustainable Development Mr. Joseph Smith Abbott said the process of extensive public consultations was in direct alignment with the Public Service Transformation plan that prescribes that public consultation forms part of the public policy mechanism for all considerations.

Mr. Joseph Smith Abbott said this strategic approach to incorporating the feedback from public consultation into the formulation of public policies will contribute to enhanced administrative policies and procedures for legal, financial and regulatory compliance, digital access, business continuity, document management and disaster resilience.

Mr. Smith Abbott said, "This policy aligns with the Public Service Transformation Plan, marking a significant step forward in our journey towards sustainable development and prosperity for all in the Virgin Islands."


The Virgin Islands possesses a rich culture of freedom that is a broad

Biden Issues Executive Order to Better Shield Americans' Sensitive Data From Foreign Foes

WASHINGTON -

President Joe Biden on Wednesday is signing an executive order aimed at better protecting Americans' personal data on everything from biometrics and health records to finances and geolocation from foreign adversaries like China and Russia.

The attorney general and other federal agencies are to prevent the large-scale transfer of Americans' personal data to what the White House calls "countries of concern," while erecting safeguards around other activities that can give those countries access to people's sensitive data.

The goal is to do so without limiting legitimate commerce around data, senior Biden administration officials said on a call with reporters.

Biden's move targets commercial data brokers, the sometimes shadowy companies that traffic in personal data and that officials say may sell information to foreign adversaries or U.S. entities controlled by those countries.

Most eventual enforcement mechanisms still have to clear complicated and often monthslong rulemaking Still, processes. the administration hopes eventually to limit foreign entities, as well as foreign-controlled companies operating in the U.S., that might otherwise improperly collect sensitive data, the senior officials said.

Data brokers are legal in the U.S. and collect and categorize personal information, usually to build profiles on millions of Americans that the brokers then rent or sell.

The officials said activities like computer hacking are already prohibited in the U.S., but that buying potentially sensitive data through brokers is legal. That can represent a key gap in the nation's national security protections when data is sold to a broker knowing it could end up in the hands of an adversary — one the administration now aims to close with the president's executive action.

"Bad actors can use this data to track Americans, including military service members, pry into their personal lives, and pass that data on to other data brokers and foreign intelligence services," the White House wrote in a fact sheet announcing the move. "This data can enable intrusive surveillance, scams, blackmail, and other violations of privacy."

The order directs the Department of Justice to issue regulations that establish protections for Americans' sensitive personal data, as well as sensitive government-related data — including geolocation information on sensitive government sites and members of the military.

The Justice Department also plans to work with Homeland Security officials to build safety standards to prevent foreign adversaries from collecting data. It will further attempt better checks to ensure that federal grants going to various other agencies, including the departments of Defense and Veterans Affairs, aren't used to facilitate Americans' sensitive data flowing to foreign adversaries or U.S. companies aligned with them.

The senior administration officials listed potential countries of concern as China, Russia, North Korea, Iran, Cuba and Venezuela. But it is China

— and TikTok, which has over 150 million American users and is a wholly owned subsidiary of Chinese technology firm ByteDance Ltd. — that U.S. leaders have been most vocal about.

Rep. Mike Gallagher, a Wisconsin Republican who chairs the House Select Committee on the Chinese Communist Party, recently noted, "There's no such thing as a private business in China."

The senior administration officials stressed that the executive action was designed to work in conjunction with legislative action. So far, however, numerous bills seeking to establish federal privacy protections have failed to advance in Congress.

Biden's executive order on artificial intelligence last fall that seeks to balance the needs of cutting-edge technology companies with national security and consumer rights.

That sought to steer how AI is developed so that companies

can profit without putting public safety in jeopardy, creating early guardrails meant to ensure that AI is trustworthy and helpful, rather than deceptive and destructive.

US Justice Department Says It Disrupted Russian Intelligence Hacking Network

The U.S. Justice Department said on Thursday it disrupted a Russian intelligence hacking network.

"For the second time in two months, we've disrupted state-sponsored hackers from launching cyber-attacks behind the cover of compromised U.S. routers," U.S. Deputy Attorney General Lisa Monaco said in a statement.

The Justice Department said that a January 2024 court-authorized operation

neutralized the network of hundreds of small office/ home office (SOHO) routers controlled by Russian intelligence and used "to conceal and otherwise enable a variety of crimes."

"In this case, Russian intelligence services turned to criminal groups to help them target home and office routers, but

the Justice Department disabled their scheme," Attorney General Merrick Garland added.

Garland said the Justice Department was accelerating efforts to disrupt the Russian government's cyber campaigns against the United States and its partners, including Ukraine.

Croal wins BVI's 7th conference double as Gumbs lands 40th overall

South Florida sprinter Jaleel Croal ran personal bests to win an American Athletics Conference 60 and 200m sprint double on Sunday in Birmingham, Alabama, becoming the 7th BVI athlete to pull off the feat since Northern Arizona's Tracy Bradshaw started the streak in 1993. On Monday, Northwestern State strongman Djimon Gumbs, used a Shot Put personal best to bag the territory's 40th overall conference crown since Dean Greenaway won the first in 1979.

Croal, who ran the 60 in 6.65 seconds and the 200m in 20.96—the 1st BVI athlete under 21:00 indoors—joined Northern Arizona's Bradshaw, who won the Big Sky 55 and 200m in 1993; Minnesota's Keita Cline, Big 10 Long and Triple Jump, 1995; Portland State's Karene King,

Big Sky 100 and 200m in 2011; St. Thomas University's Dekoya Hodge, Summit League Shot Put and Javelin Throw, 2019 and Findlay's Eldred Henry, GMAC Shot Put and Discus Throw, 2019 and Northwestern State's Djimon Gumbs, Southland Shot Put and Discus Throw, 2022.

"To me, it means a lot. I don't think the feeling has sunk in, I've been saying that all weekend," Croal, who ran 6.68 and 21.08 seconds to advance, told Island Sun Sports. "People say that the sprint double is the hardest and I agree because of the circumstances this weekend, which was after the 60m, I had about a 25-minute break before the 200m. After running the 60, you put all that power in your legs-your legs feel weird-I was going through that and had to talk to myself to get it done, so it really means a lot.'

He added: "It shows all the work I've been putting in, so it's a very proud moment for me, my family, and also the people who support me."

Entering the indoor season, Croal's 200m best was 21.75, after finishing 11th last year, said he lowered his time in every race. His only goal was to get a personal best. "After accomplishing that, I did it again and again and again," he said 21.51, 21.45, 21.32, 21.08 before the 20.96. "It worked for me. Instead of setting big goals, I set small goals to make myself feel good and it really worked out."

He said that he has improved his start and has been more consistent with it and also improving his transition, which has helped him drop his times as well as working in the gym. His performances set him up well for outdoors he said.

"I have high expectations for myself because if I can do that indoors, outdoors should be even better because that's my normal," he said. "It's going to be scary. I was mainly trying to get a hang of indoors. Each race, I was trying to figure out how to run the 200m so it's going to drop more and more to make it harder for the next person." Gumbs, the reigning outdoor Shot Put champion, unleashed a 5th round 19.35m (63'6") heave, to win his first Southland Conference indoor title and fourth overall, for the No 2 mark in conference history behind the 19.85 (65'11/2") mark. In the process, he tied Minnesota's Cline, who won Long and Triple

Jump titles between 1994 and 1995 and Portland State's King, 100 and 200m crowns in 2011 and 2012, for the most Collegiate conference crowns by BVI athletes. Gumbs' title brings the BVI's total to 40 by 20 athletes in 16 different conferences since 1979.

Twin brother Diamante was 5th with a best effort of 16.49m ((54'11/4"), after uncorking a season's best 19.38m (63'7"), the second best mark of his career in the 35 lbs Weight Throw, to place second.

After two losses BVI beats Belize 4-3 in CONCACAF U20 Championships



Azarni Callwood scored twice on Tuesday night in leading the BVI to a thrilling 4-3 victory over Belize in their first encounter in the CONCACAF U20 Championships, following losses to hosts Nicaragua and Cuba on Friday and Sunday.

Callwood scored from a penalty in the 37th minute to tie the game at 1-1. Two minutes later, Curtis Lane made it 2-1 off a header from a right corner. Then in traffic inside the 18-yard box, Callwood placed a laser to the right corner past the Belizean goalie in the 45+2, giving the BVI a 3-1 advantage at the half. It was his third goal

of the tournament.

In the second half, Belize scored from two penalties four minutes apart—first in the 54th then in the 58th—to level the game at 3-3. Striker Johari Lacey converted a penalty in the 70th and BVI's defense kept Belize out the nets and rode off with a 4-3 victory.

The BVI was coming off a 2-1 loss to Cuba on Sunday in a game Callwood scored, after Friday's 8-0 loss to hosts Nicaragua.

"After we played the first two games, the fellows recognized that we had enough that we can compete, so we asked them to complete what we finish building against Cuba, and we asked them to work as a unit, stay focused as much as possible," Coach Clinton "Tinnie" Percival told Island Sun Sports. "We asked them to continue doing the things we asked them to do because

we knew if we continue to do well, eventually we'll get some success. I think they did that tonight and I'm really proud of them because they stuck to the plan, and we got the result." Percival said they'd asked the

Percival said they'd asked the team not to give up an early goal, but they gave up one in the first 15 minutes. He said that he was proud that they continued to play and they eventually scored and kept the momentum to finish the first half up 3-1. During the break, he asked them not to get complacent because anybody with their backs against the wall will keep coming back at you.

"Unfortunately, when the second half started, we conceded two soft penalties and we brought them right back into the game, but again, the guys showed some resilience and continued to play hard and we finally got the goal we wanted

THIS WEEK IN CORRUPTION

SHADES OF GREY

It's the eve of the second anniversary of Russia's full-scale invasion of Ukraine. The suffering from the war has been immense, with millions displaced and tens of thousands of lives lost.

Despite international condemnation, Putin seems undeterred.

Last week, as Western leaders gathered in Munich to discuss myriad threats to global security, news broke that Russian opposition leader Alexey Navalny had died in prison.

Almost reflexively, the West is responding with more sanctions. For instance, the EU agreed a new sanctions package targeting an additional 200 individuals and companies, bringing the total to 2,000.

Two years later, we maintain that sanctions are simply not enough. Never mind that sanctions aren't an accountability tool, but they're also destined to

become toothless. Tracking down and seizing assets isn't a stroll in the park; it's a tremendously challenging task due to financial secrecy and complicit enablers, not to mention challenges related to legally confiscating assets.

By overly focusing on sanctions, there's a risk that attention will be diverted from the systemic reforms that are essential to really counter kleptocracy. It's no secret that Russian elites have boosted their wealth, power and influence through corruption that extends across borders.

While Western economies have unleashed sanctions over the past two years, Russian elites have reportedly turned to other secrecy jurisdictions, including the United Arab Emirates (UAE). And they're not the only ones who have found safe haven in the Emirates. The UAE has been a money laundering hotspot for a long time. It has appeared time and time again in major cross-border corruption scandals, and has a knack for attracting individuals and businesses who like to conceal information about their wealth and activities. This appears to be an evergrowing and profitable business model for the country known for its opulent cities.

This hadn't gone unnoticed, and in 2022 the Financial Action

Tast Force (FATF) put the UAE on its so-called grey list. This move was prompted by the FATF finding several flaws in the UAE's anti-money laundering framework. For example, evaluators criticised law enforcement agencies that weren't up to scratch identifying significant money laundering cases considering the country's risk profile. They also highlighted low prosecution numbers and the country's poor record on international cooperation.

While the UAE has undertaken reforms in response to its

grey-listing, it's still too early to assess their impact. Meaningful implementation and political will to fight financial crime have been historically lacking in the country, raising the risk that their recent efforts will ultimately be futile.

Crucially, UAE authorities have shown no signs of investigating cases of potential money laundering through real estate. This is even though ownership of these properties is not hidden through complex ownership structures. In fact, properties held through corporate vehicles remain shielded, demanding a more

substantial commitment and investment by authorities.

Yet, today, FATF announced the country's exit from the grey list after just two years.

We'll have to wait for FATF to release more information to understand how some of the outstanding concerns may have been addressed. However, in the months and weeks leading up to this week's decision there have been reports that geopolitical considerations could play a role in their removal from the list. It's certainly troubling that allegations have arisen of direct lobbying and doubts about the credibility of information that UAE officials have provided the FATF.

Overall, recent media coverage suggests that the UAE's apparent cooperation on Russia-Ukraine sanctions earned the country some support within FATF. It's obvious to us that even if the UAE is finally cooperating on sanctions, it's still falling short. They have much more to prove when it comes to taking financial crime seriously, as their anti-money laundering failures have very real consequences that extend beyond its borders.

It's time for the international community to address the underlying problems that feed impunity.



'Bob Marley: One Love' Stirs U \$27.7 Million Weekend at Box

NEW YORK — Paramount Pictures' Bob Marley biopic "Bob Marley: One Love" outperformed expectations to debut at No. 1 at the box office with a \$27.7 million opening weekend, while Sony's "Madame Web" flopped with one of the lowest debuts for a movie centered on a Marvel character.

Both films launched in theaters on Tuesday to rope in Valentine's Day

moviegoers. But on a weekend that was once expected to go to "Madame Web," "One Love" emerged as the muchpreferred option in theaters, despite largely poor reviews.

"One Love," Instead, starring Kingsley Ben-Adir and produced with the involvement of the Marley estate, performed roughly on par with previous hit musical biopics like "Rocketman" and "Elvis." Paramount is forecasting that "One Love" will gross \$51 million over its first six days, including estimates for President's Day on Monday. It added \$29 territories.

Chris Aronson, distribution chief for Paramount, noted

that pre-release projections forecast a six-day total closer to \$30 million for "One Love." But moviegoers from a wide range turned out for the first big-screen biopic of the Rastafarian legend. "

It was across all generations. It wasn't just a movie for an older audience that grew up with Bob Marley's music," said Aronson. "Our highest quadrant was (age) 18 to 24. A third of the audience was under 25. That, to me, speaks volumes."

Produced for about \$70 million, "One Love," directed by Reinaldo Marcus Green, chronicles Marley during the making of the 1977 album "Exodus" while leading up to a pivotal concert for his native Jamaica. Among the movie's producers are Marley's children, Ziggy and Cedella, and his wife, Rita.

Ziggy Marley, in a statement Sunday, said: "We thank the people for embracing this film and in so doing helping to highlight the message of one love."

Though critics dinged the film (43% "fresh" on Rotten Tomatoes) for relying on biopic conventions, audiences gave it a much higher grade, with an "A" CinemaScore. That kind of audience response plus the strong opening should bode well for the film's run.

"Madame Web," however, was dead on arrival. Over six days, Sony is estimating a \$15.2 million weekend and a six-day \$25.8 million haul. Audiences (a "C+" CinemaScore) agreed with critics (13% "fresh").

Such launches were once unfathomable for stand-alone superhero films. But the film, an extension of Sony's universe of Spider-Man films, struggled to shed the bad buzz surrounding the \$80 million project. In it, Dakota Johnson stars as a New York paramedic with clairvoyant powers.

"The entire superhero genre has had a really rough go of it over the past year," said Paul Dergarabedian, senior media analyst for data firm Comscore. "Certain things are no longer a sure bet. Except maybe now, the musical biopic has become the go-to genre. It just shows how tastes can change."

Sony's Spider-Man spinoffs have been mostly hit and miss. Its two "Venom" films have together surpassed \$1.3 billion worldwide. But 2022's poorly received "Morbius" collected just \$167.4 million

globally. "Madame Web" still couldn't come close to the \$39 million domestic opening weekend for "Morbius." In 61 overseas markets, "Madame Web" added \$25.7 million.

The better news for Sony's Spider-verse came Saturday night at the 51st Annie "Spider-Awards. where Man: Across the Spider-Verse" won best feature and collected seven prizes in total. "Across the Spider-Verse" is nominated for best animated feature at the Academy Awards — and the Annie Awards can often be a good

Moviegoing has slowed to a crawl in recent weeks, while 2023's strikes have impacted this year's release schedules. Even with the strong "One Love" opening, ticket sales were down 15% on the weekend compared to 2023, according to ComScore.

Expectations are high for "Dune: Part Two," opening March 1. Until then, "Bob Marley: One Love" will be jammin'.

HOLLYWOOD -- It's not a good sign when multiple cast members of a movie appear on every talk show to promote their film. "Argylle" stars Henry Cavill, Bryce Dallas Howard, Bryan Cranston and Ariana DeBose hit them all -- morning and night. One reason may be because the \$200 million film has received mixed reviews from 33% of the top critics on Rotten Tomatoes, and its success or failure may determine the fate of the next two films in the spy trilogy.

In 2015, Cavill starred in a film version of the hit spy TV series "The Man From U.N.C.L.E.," with Armie Hammer and Alicia Vikander (who won an Oscar the following year for "The Danish Girl"). The film cost \$75 million and only grossed \$110 million. Many have hoped Cavill would be the next James Bond, but he probably won't be considered anymore now that he's done "Argylle" and Guy Ritchie's next two films -- an untitled action film that has already been completed and "The Ministry of Ungentlemanly Warfare," with Alex Pettyfer, Henry Golding, Cary Elwes and "Reacher's" Alan Ritchson.

In 2022, Ariana DeBose won an Oscar as Anita in Steven Spielberg's "West Side Story," a role that also won Rita Moreno her Oscar. It was originally created on Broadway by the late, great

Chita Rivera, who passed away on Jan. 30. DeBose, proving to be multitalented, has completed two more films: the superhero epic "Kraven the Hunter" due Aug. 30, opposite Aaron Taylor-Johnson and Russell Crowe, and her first top-billed film -- the supernatural-horror film "House of Spoils," in which she plays a chef.

High Troponin Levels Follow After Bout of Food Poisoning

DEAR DR. ROACH: I am a 77-year-old male who apparently suffered a case of food poisoning. I say apparently because no cause was ever discovered for the uncontrollable vomiting and diarrhea that lasted for a whole day and recurred briefly the following morning.

A trip to the emergency room involved many tests, but nothing turned up except a troponin level well over 0.04 ng/mL, which prompted an angiogram that didn't reveal any problems with my heart. What else might have caused my high troponin level? — Anon.

ANSWER: A troponin level is a standard blood test usually used to evaluate patients for heart attacks. However, newer, highly sensitive assays have proven that tiny levels of troponin may be detected in nearly everybody.

A level above 0.04 ng/mL is often used as the cutoff for the "normal" range, but depending on the assay and population studied, a few healthy people may have levels above this. People with heart attacks may have troponin levels in the hundreds or thousands. The higher the troponin level, the more muscle damage there is.

The fact that your coronary arteries don't show any blockages is very good news. Other types of heart damage may also cause a high troponin level, including inflammation of the heart (myocarditis) and heart failure. Also, critical illnesses can cause high troponin levels (at much higher levels than you may

have had) in people who don't have heart blockages. (A median of 0.57 ng/mL was found in people with septic shock.)

I found a long list of reported causes behind elevated troponin levels, but gastroenteritis was not on the list. I suspect your body was working so hard to fight off the infection without enough fluid that your heart needed more oxygen-carrying blood than it got, leading to tiny amounts of injury to the heart muscle despite normal heart arteries. You can lose a lot of fluid with vomiting and diarrhea, and people at age 77 don't have as much reserve as they did when they were younger.

DEAR DR. ROACH: I'm a 56-year-old male who never had the chicken pox. When the first of my children was born, I had blood tests done to see if I'd ever been exposed. I had not, so I received the chicken pox vaccine in case my children were to expose me.


Twenty-five years later, many friends and colleagues have either received the shingles vaccine or have had a shingles outbreak. My question to you is: Since I've never had chicken pox, do I still need the shingles vaccine? — D.S.S.

ANSWER: Yes, the shingles vaccine is still recommended. Shingles is a recurrence of the chicken pox virus. The vaccine you got was a live but weakened form of chicken pox. It has a lower risk of causing shingles than getting the actual chicken pox, but there is still a risk.

Shingles is so bad that the vaccine is absolutely worth it, in my opinion. Even people who have had the old one-shot vaccine (Zostrix), as well as those who don't recall having had chicken pox, should get the new two-dose vaccine (Shingrix), which is not a live virus. It's better to just get the vaccine than doing blood testing in people who don't recall getting chicken pox as a child.



FRANCE AND THE US BROKE HAM; THEY SHOULD BE THE FIRST TO MEND IT

When the Foreign Ministers of the world's wealthiest nations gathered in Brazil from February 21, 2024, Haiti's dire situation found a brief

moment of attention—not in the main agenda but on the sidelines of the G20 Foreign Ministers' Meeting in Rio de Janeiro. This sidelining is emblematic of the low priority assigned to Haiti by these global powerhouses.

U.S. Secretary of State Antony Blinken took the initiative to put Haiti on the agenda, highlighting U.S. concerns over the country's instability and the continuous arrival of Haitian refugees to U.S. shores, which has been a contentious issue. Yet, as of February 23, 2024, major G20 nations have not shown an enthusiastic response.

This lack of enthusiasm reflects the acute rivalry of other major G20 countries, particularly Russia and China, with the U.S., as they have differing interests concerning Haiti. In the case of China, it has argued for a multifaceted approach that includes political stability and security support to create a sustainable path forward for Haiti. For its part, Russia has expressed scepticism towards international military interventions without a clear national consensus and detailed operational plans. Russia abstained from voting on the UN Security Council Resolution, which authorized the deployment of a Multinational Security Support (MSS) mission to Haiti by like-minded countries, led by Kenya.

Nonetheless, Secretary Blinken has continued to encourage G20 and other nations, from both developed and developing regions, to join the MSS mission. To date, the U.S has not managed to secure troop commitments except from Kenya and a few countries of the Caribbean Community (CARICOM). The particularly notable absence of troop commitments from European nations, especially France—a former imperial power in Haiti and a major

beneficiary of its slave-produced wealth—underscores this point.

The U.S. itself has committed no troops. Instead, it has concentrated on trying to get African and Caribbean nations to send their military personnel. The Biden administration's reluctance to commit troops to Haiti may be influenced by the stance of Donald Trump, Biden's presidential

rival, known for his reluctance to deploy U.S. troops abroad. Nonetheless, it irks some nations that the U.S. is calling on them to provide troops who would be endangered in Haiti, while choosing to keep its soldiers at home.

Further, while the U.S. government is touting its willingness to pay \$200 million to finance an intervention in Haiti, it says half will come from the Department of Defence, but the other half must come from the U.S. Congress. To date, the Congress has not voted to allocate any money. Therefore, the full amount of the U.S. government pledge is not available and is \$100 million short of the Kenyan demand.

Jake Johnson, in his insightful book "Aid State: Elite Panic, Disaster Capitalism, and the battle to control Haiti," suggests that Western perceptions of Haiti are marred by a history of colonialism and racism. While I share Johnson's view and commend his work for its depth, I argue that the issue is primarily one of passive racism—a disregard for Haiti that likely wouldn't exist if its population were white.

That passive, almost unthinking, reflexive racial attitude is also mixed with the view that Haiti is a corrupt country where billions of dollars of aid has either been mismanaged or stolen. The two elements have been a toxic brew for western policy makers to swallow.

A further unofficial consideration in the minds of many governments, and one that is whispered in the margins of international gatherings, is that tens of billions of dollars have been spent on peacekeeping efforts in Haiti in the past by the United Nations and participating governments. Yet, as soon as peacekeeping forces leave, Haiti returns to instability resulting from conflicts between rival political forces in the country.

It is noteworthy that while Caribbean Community (CARICOM) has generally agreed to support a humanitarian intervention in Haiti, less than five of its 15 members have actually offered troops. In the event, CARICOM lacks the capacity to make any significant military contribution to any intervention in Haiti. The grouping has done so because Haiti is a member state, and, more importantly, because the Haitians were the first nation to rise up against slavery and create a black independent nation in 1804.

But, in any analysis of the Haitian situation, France and the U.S. have a particular responsibility, having significantly profited from and subsequently destabilized the country. Neither country, whatever internal political issues they face, can be excused from their responsibility for impoverishing Haiti. The heavy debt imposed by France following Haiti's independence and the U.S.'s prolonged financial and political interference have left deep scars on Haiti's ability to self-govern and prosper.

In light of this, the primary onus for aiding Haiti lies with France and the U.S. They should be at the forefront of efforts to restore order and rebuild the nation, contributing not just through police presence now but also by investing in Haiti's infrastructure and social systems, rectifying the historical injustices that continue to impede its progress. Haiti's relegation to the sidelines of international discourse is a stark reminder of the need for a renewed, committed global effort to address its crises. It is time for those nations most implicated in its historical exploitation, to fulfil their moral and ethical obligations to Haiti.

There is need for an intervention in Haiti to end the current lawlessness, but the support for such an intervention should come from the broadest representation of the Haitian people. It should also include a timetable and a comprehensive plan, with resources, to build Haiti's much needed physical, social, political and governance infrastructure at the intervention's conclusion.

Only then can we hope to see Haiti as a stable, sovereign, and thriving nation, rather than perpetually labelled as a "failed" state or an "aid" state."

This was announced by H.E. Dr. Mohamed Irfaan Ali, CARICOM Chair on the final day of the 46th Regular Meeting in Georgetown, Guyana."

Revered Guyanese Cricketer and Caribbean hero Sir Clive Hubert Lloyd CBE, AO, CM will be conferred with the Order of the Caribbean Community (OCC) at the next Regular Meeting of the Conference of Heads of Government of CARICOM, which will be held in Grenada in July. This was announced by H.E. Dr. Mohamed Irfaan Ali, CARICOM Chair on the final day of the 46th Regular Meeting in Georgetown, Guyana.

Sir Clive was a Special Guest during a plenary session and accompanied by young Guyanese Cricketer, Shamar Joseph, who was also recognised for having bowled the West Indies Team to victory during the recent Test Match against Australia. This marked the first victory for the West Indies Team against Australia in twenty-four years.

Heads of Government and delegates paid tribute to Sir Clive Lloyd following the announcement and remarked on his illustrious tenure.

Emerging from humble beginnings in Guyana, Sir

Clive is widely regarded as one of the greatest cricket captains of all time. He made his Test debut on 13 December 1966 against India and captained the West Indies in three World Cups, winning in 1975 (with Lloyd scoring a century), 1979 and the 1983 final.

In 1971, Sir Clive was named a Wisden Cricketer of the Year and captained the West Indies team between 1974 and 1985. He was also instrumental in its rise to become the greatest Test and One Day International team of the 20th Century; only Australia achieved comparable success. Sir Clive is considered one of the most successful Test captains in the history of West Indies Cricket. During his captaincy, his side had a run of 27 matches without defeat, which included 11 wins in succession. He was the first West Indian player to earn 100 international caps.

In 2009, Sir Clive was inducted into the ICC Cricket Hall of Fame and was knighted in 2022.

The Order of the Caribbean Community will be another crowning moment in Sir Clive's decorated career and legacy.

The United Republic of Tanzania is all set to welcome ministers and attorneys-general to the Commonwealth Law Ministers Meeting, which will open in Zanzibar on 4 March 2024.

Held every two years, the meeting of law ministers is a leading platform for collaboration among the 56 Commonwealth countries, which share a common legal tradition.

The theme of this year's meeting is 'Technology and Innovation: How digitalisation paves the way for the development of people-centred access to justice.'

Under this theme, law

will ministers examine ethical ways to technology to make legal services and information more accessible to people, while exploring responses to threats, such as cybercrime. Speaking about the meeting, the-Commonwealth Secretary-General, the Rt Hon Patricia Scotland KC. commended the Government the United Republic

of Tanzania for making

exceptional arrangements for the meeting.

Secretary-General Scotland drew attention to the pressing need to close the access to justice gap, which currently affects two-thirds of the world's population.

She highlighted the detrimental consequences of the lack of people's access to justice on development, inclusive growth, and conflict prevention.

The-Secretary-General continued: "At a time when increasing conflicts are undermining respect for international law, ensuring equal access to justice remains a fundamental precondition for building peace and security for all."

She said: "Our priority is to help all our member states deliver equal access to justice for all. That requires legal systems which can meet the needs of all.

"The-upcoming Commonwealth-Law Ministers Meeting offers us a vital platform to discuss the growing threats to the rule of law and find innovative ways to deliver the changes which will guarantee justice for every one of the 2.5 billion people living in our Commonwealth."

Hon Ambassador Dr Pindi H. Chana, the United Republic of Tanzania's Minister of Constitutional and Legal Affairs and Chair of the 2024 Commonwealth Law Ministers Meeting, announced the meeting's details at a press conference in Zanzibar on 26 February 2024.

Addressing journalists, she said: "We expect to get a lot of benefits following this meeting as the topics that will be discussed will help to find the right ways to strengthen and enforce the law and access to human rights."

The meeting's four-day agenda will cover a range of topical legal issues, including digital assets, electronic resources for efficient

legal systems, access to justice for people with disabilities and developments in climate legislation.

The outcomes from the meeting will shape the agenda for the upcoming Commonwealth Heads of Government Meeting (CHOGM) in Samoa later this year.

The meeting will be held at the Mora Hotel in Zanzibar from 4 to 8 March 2024.




