## "THE PUBLIC'S VOICE MATTERS IN SHAPING A BETTER MINIMUM WAGE," SAYS DEPUTY PREMIER

Deputy Premier and Minister for Financial Services, Labour, and Trade, Hon Lorna Smith, OBE, has reaffirmed the importance of a thorough and inclusive process in the ongoing review of the minimum wage in the British Virgin Islands. Responding to inquiries during a recent press conference, Hon Smith emphasized the need for

careful consideration before announcing any adjustments to the minimum wage.

"At the press conference, I stated that I didn't know and reiterated that the review is ongoing, which aligns with my commitment to a thorough and inclusive decisionmaking process," Hon Smith stated in a press release issued on April 5.

Highlighting the formation of the Minimum Wage Advisory Committee in November, Hon Smith underscored the committee's role in evaluating the current wage structure and soliciting input from stakeholders. emphasized She the significance of conducting a comprehensive analysis and seeking feedback from all relevant parties. "While an increase is

likely, at this stage of the review, prematurely announcing an increase could-undermine stakeholder consultation, data integrity, and policy confidence," Hon Smith asserted.

Expressing empathy for those facing financial challenges, Hon Smith acknowledged the desire for a wage increase

among many individuals. However, she stressed the importance of basing decisions on evidencebased findings and broad participation.

"I am very much aware that many persons are struggling and are desirous of an increase in wages. I also believe in a process that is participative and supported by evidencebased findings in making decisions," she affirmed.

To facilitate public engagement, Hon Smith announced the availability of survey questionnaires the government's website and encouraged stakeholders to participate in discussions at the Ministry's conference room over the next two weeks.

"We will also make time available at my ministry's conference-room location to accommodate engagements on minimum wage discussion from 4 pm - 5 pm over the next two weeks (8 –19 April)," she stated.

The Deputy Premier emphasized that potential increase in the minimum wage would be contingent upon feedback from the public and the comprehensive analysis conducted by the advisory committee, led by a capable economist within the ministry.

"We have to get all of the information. We have to get everybody to respond to the survey, all persons. There is also a survey for employers, and based that information, the economists, and the

advisory committee will devise or put together the necessary data," she explained.

As anticipation mounts for-the-advisory committee's report, Hon Smith reiterated that the final decision would rest with the Cabinet.

"Cabinet will make the decision," she affirmed.

Hon Smith concluded by urging active participation from all stakeholders in shaping a fair and effective minimum wage policy for the British Virgin Islands.

"The public's voice matters in shaping a better minimum wage policy. I anticipate the report by the end of this month," she stated.

## FORMER PREMIER SENTENCING RESCHEDULED

A request for a delay in the sentencing of former Premier Andrew Fahie, who was convicted on charges related to drug trafficking racketeering, has been granted by a Miami court. The motion, submitted Fahie's attorney, Theresa Van Vliet, cited conflicting commitments and the need additional time to address potential objections to the pre-sentencing report.

Originally scheduled for 29 April, Fahie's sentencing has now been rescheduled for 25 June, following the approval of Van Vliet's motion by Judge Kathleen Williams. This decision allows Fahie's legal team the necessary time to adequately prepare for

the sentencing process and ensure a thorough review of relevant documentation.

Fahie's conviction stemmed from involvement in a conspiracy to import cocaine through British Virgin Islands (BVI) ports, alongside Oleanvine Maynard, the former Managing Director of the BVI Ports Authority, and Maynard's son, Kadeem Maynard. The trio's collaboration with an informant of the US Drug Enforcement Administration (DEA) resulted their apprehension subsequent legal and proceedings.

Despite Fahie's unanimous guilty verdict on 8 February, the aftermath of the trial has been marked by unexpected developments. Recent revelations regarding jurors expressing second about thoughts their decision have raised questions about the integrity of the verdict and generated debates surrounding the sanctity of jury deliberations.

In contrast to Fahie's situation, Oleanvine's case has taken a different course. Maynard, who admitted guilt in connection to the conspiracy, entered into a plea agreement with prosecutors and agreed to testify against Fahie in exchange for potentially lenient sentencing terms. Consequently, Maynard's had sentencing been postponed for separate reasons.

Meanwhile, her son Kadeem, who pleaded guilty to a single count of conspiracy to import cocaine, received a 57-month prison sentence on 20 November, 2023, concluding his involvement in the illicit activities.

In this deeply personal account, Mrs. Flax-Shaw, reminisces on her childhood and teenaged experiences, while depicting traditional Virgin Islands culture and values.

She encourages readers to, "Come with me on a nostalgic journey to Virgin Gorda, the land of my birth...a different land...a different time...one without automobiles, electricity, and any form of [modern] technology."

"Everyone lived in complete harmony with each other. Stroll with me through the moonlit nights of that place that once was so perfect, it could be remembered as our utopia. You will not want to miss this adventure," Mrs. Flax-Shaw recounts.

According to the author, the text also pays tribute to her parents, teachers, ancestors, and culture bearers. Chapters include "Mother-isms", "Declining Customs", and "Protected Areas of Interest", which portray and preserves a range of themes that embrace the traditional customs of Virgin Gorda, and by extension, the Virgin Islands to the benefit of future generations.

Meanwhile, Director of Culture, Dr. Katherine Smith said the value of this genre of writing is that readers are provided with a first-hand account of the author's experiences.

"This is often the rich socio-cultural description that is often missing from historical records," she said.

Dr. Smith added, "Of course, the more we are able to hear from our Sister Islands, the more accurate and balanced our understanding of our history. Increasingly, a common traditional cultural experience is being unveiled across the Virgin Islands."

Persons are encouraged to attend the launch on Saturday April 13, at the Flax Administration Building conference room in Virgin Gorda at 10:00 a.m.

## EXPENDITURE FOR MUSIC FESTIVAL ENCOUNTERS NEW CRITICISM

More criticism has arisen the over government's decision to allocate \$670,000 to an upcoming festival. music with concerns voiced that the funding prioritizes frivolous activities over pressing needs, such as support for small businesses. Sixth District Representative Hon. Myron Walwyn expressed discontent during a recent sitting of the House of Assembly, arguing that the government's approach lacks practicality.

Since the announcement of the government-sponsored music festival, many in the community have expressed outrage at the notion that the

government was funding a music fest while a private entity was also advertising a similar event within weeks. While analysing the public view on the matter, Hon. Walwyn explained that he is not opposed to the concept of a music festival. However, he questioned the planning process and the viability of attracting attendees with such short notice. "How can you plan a music fest, advertise it, or announce it just a month and a half before it's scheduled?" he challenged. He further questioned the government's ability to ensure a substantial return on investment within such a brief timeframe.

Some observers are asking whether the music festival is more suitable to the August BVI Festival.

"When people who are struggling to receive assistance from the government witness expenditures like this, it understandably frustrates them," the Sixth District Representative remarked,

emphasizing the disconnect between public needs and government priorities.

Hon. Walwyn warned of escalating discontent as the government prepares to finance another elaborate event during the 70th anniversary of the Emancipation Festival.

defense of the government's expenditure, Premier Natalio Wheatley emphasized the economic benefits of funding such events, arguing that they provide opportunities for generation income and exchange. cultural Dr. Wheatley-highlighted the participation of local residents in regional music festivals, underscoring their significance in promoting cultural tourism and community engagement.

"We have successful music festivals in the region where our own people spend their money and participate," the Premier noted. "This demonstrates their recognition of the value and importance of these events and their willingness to support them."

While aspiring to elevate the British Virgin Islands' music festival to regional prominence, Hon. Wheatley acknowledged the need for significant efforts to achieve such an objective.

## "IT'S UNFAIR TO SAY THAT WE NEGLECT THE TRADE DEPT": DEPUTY PREMIER SAYS

Deputy-Premier Lorna Hon. Smith responded has criticisms regarding the perceived neglect of the Trade Department within her extensive portfolio, countering evidence with a-comprehensive leadership-strategy. Amidst-concerns that her focus on the financial services sector overshadowing was other areas, the Deputy emphasized Premier a holistic approach to governance.

Acknowledging public sentiments,

Hon. Smith defended her administration's commitment to trade development, stating: "It takes some time to get everything in place, but I don't think it's fair to say that we are ignoring Trade." She reiterated her dedication fostering growth across all sectors under her purview. Those who know the Deputy Premier well know that she has always been vocal about greater support to Trade and Private Sector.

As the Minister for Financial Services.

Labour, and Trade, Hon. Smith also addressed concerns about the apparent disparity in attention given to different sectors. She emphasized recent advancements within the Trade Department, including imminent staff additions and upcoming initiatives.

Hon. Smith highlighted the - imminent of a Business Development Manager for the Trade-Department, underscoring-the government's efforts to enhance trade-

related services. She also referenced plans for a business expo and initiatives aimed at reviving the National Business Bureau as evidence of ongoing commitment to trade development.

Supporting-Smith's stance, Policy Analyst and Strategic Advisor at the Ministry, Lizette George,-concurred that criticisms were unfounded.-George detailed-internal restructuring efforts, including a recent staff audit to recruit

specialized personnel and streamline processes.

George-revealed ongoing recruitment efforts for a Deputy Director-position, emphasizing-the department's proactive approach to addressing emerging needs. She assured that recent improvements-had led to expedited trade licensing processes, demonstrating tangible progress in enhancing trade-related services.

## Playground Facility Marks A Milestone In Community

Six months since its official handover, the Anegada Children's-Playground continues to benefit children of all ages on the island.

The completed playground is the combined power of a shared vision, and publicpartnerships, as private funding was provided by Unite BVI and the Government of the Virgin Islands. Designed promote physical activity and foster social interaction, the facility represents a hub for families and children to gather, play, and thrive.

Key features of the playground include the installation of artificial turf and playground equipment and the construction of a white picket fence, which provides a safe and inclusive space for children of diverse abilities to explore and enjoy.

The completion of the Anegada Children's Playground is one of four activities to rehabilitate the Anegada Recreational Facility. Other completed activities are the Rubberised Resurfacing of the Basketball Court with demarcations, the Exterior Perimeter Fencing with a chain link fence and pedestrian gates, and the installation of Exterior Lighting.

The Recovery Development Agency is now conducting a Value for Money (VfM) Assessment on the Recreational Facility to evaluate the economy, efficiency, effectiveness and equity of this project The intervention. **RDA** conducts VfM assessments for all completed projects towards-continuous improvement in delivery of projects.

This is the third recreational facility that the RDA has rehabilitated.-Directly following the passage of Hurricanes Irma and Maria, the RDA partnered with the BVI Olympic Committee and the BVI



Athletics Association to install the rubberised track and thereafter, stands and bathroom facilities at the A. O. Shirley Recreational Ground and in May 2022, the RDA completed the rehabilitation of the Anthonie Jeffrey Caines Sports Arena in Virgin Gorda.

Director of Programme Strategy at the RDA, Kinisha Forbes said, "The successful completion of these projects underscores the RDA's dedication to community development, sustainability, and quality of life enhancement".

Ms. Forbes added, "Through planning, design, and execution, we have transformed a vision into reality, leaving a lasting legacy for generations to come."



## 23 Named Storms In Forecast For 2024 Hurricane Season

Forecasters at the Colorado State University Tropical Meteorology Project are warning that the region will likely see above average levels of storm activity during the 2024 Atlantic Hurricane Season, which begins June 1.

Senior Research Scientist Dr. Phil Klotzbach during a presentation at the Topical Weather Conference said that the Atlantic basin is forecast to see 23 named storms over the course of the season. Eleven hurricanes are expected to form, and of those, five are expected to develop into major hurricanes of Category 3 or stronger.

Dr. Klotzbach said higher than average sea temperatures will provide heat energy conducive to storm development, while a return to La Nina conditions later this year will mean very little vertical wind shear to disrupt the organisation and strengthening of storm systems.

Director of Disaster Management Jasen Penn said that while conditions and expectations can change as the season develops, this forecast should prompt residents to prepare early for the possibility of seasonal storms.

"The reality is that regardless of the forecast, it remains important for persons to take steps to prepare, because just one storm coming to our area can be devastating," Mr. Penn said.

The director noted that forecasters predict a 66% probability of a major hurricane tracking through the Caribbean Sea, compared to 47% probability in an average year.

Mr. Penn said, "Probabilities are not certainties, but I would encourage all of us to

take all steps possible to be ready for seasonal storms. As we often say, it is better to prepare and prevent than to repair and repent."


As the hurricane season approaches, residents are urged to monitor local

weather reports, which are shared daily via the DDM website and social media channels. Updates are more frequent when a system poses a potential threat.

Other steps that can help prepare before a storm include:

Downloading the DDM App; Making or updating an emergency plan; Inspecting roofs, gutters, shutters and drainage paths;. Assembling essential supplies such as food, water, and medication Purchasing or updating insurance policies

Residents can view other tools to help them get prepared like a hurricane tracking map, an emergency kit checklist, and the latest list of emergency shelters at www.bviddm.com.



If travel is on the horizon, it is also recommended that your new device is VoLTE (Voice over LTE) capable. Most mobile roaming partners abroad have also phased out their 2G networks and require VoLTE for roaming connectivity while travelling abroad.

bins throughout the Territory.

Residents are asked to place their used or waste oil around the public bins to be collected and transported to the facility. Persons can also take small quantities directly to the site Monday to Friday between the hours of 8:00 a.m. and 4:00 p.m. beginning Monday April 8.

Mr. Myers said, "We will be accepting small quantities of waste oil from households, small commercial businesses, hotels, restaurants and

government organisations."
He added that oil products in large quantities or from large commercial businesses such

as charter or fuel companies is strictly prohibited.

The Department of Waste Management is committed to ensuring that the natural beauty of the Territory is enhanced by utilising state of the art waste management technology to ensure timely collection disposal and where possible the recycling of waste.



GOLD It may be premature to talk about gold fever, but it is striking that, during the opening minutes of the first session in the second trimester, its price by the ounce had nearly a 2% revaluation.

My prognosis for this year was for a dramatic revaluation of the gold ounce, which has already come to pass with this year's rise of nearly 10%. I think that at the height of 2024, that rise will hit 30%.

But even more striking is the fact that this rise in the price of the ounce of gold has been compatible with the appreciation of the dollar against the euro, which, since the beginning of 2022, has been 5%, meaning that those who had invested in gold at the time (and who had the euro as their financing currency) have accumulated a 28% revaluation of their investment. of which 23% corresponds to a rise in the price of gold and 5% to the appreciation of the dollar against the euro.

For the most part, it is normal for dollar and gold prices to move in opposite directions (i.e., when the price of gold rises, the price of the dollar falls), but there are always exceptional periods during which both appreciate or depreciate. And it seems that we are in one of those moments in which both

appreciate or, at least, the rise in the price of gold is much higher than the depreciation of the dollar. Such has been the case for the last month and a half. While the price of an ounce of gold has risen by 13%, the dollar has depreciated by only 0.6% [El Pais]

FALSE OR TRUE? -Stock market high

Claim: "This is the Trump stock market because my polls against Biden are so good that investors are projecting that I will win, and that will drive the market up." Trump made this claim on his network Truth Social on January 29, 2024, in response to a US stock market high.

DW FACT CHECK: FALSE In fact, over the past year, between April 2023 and April 2024, the S&P 500 stock index rose by 27 percent.

Along with the Dow Jones and Nasdaq, the S&P 500 is the third major US stock market indicator. It includes the 500 largest stock-exchange-listed companies in the United States.

The boom in the US stock market has less to do with Trump's poll ratings and more with the interest rate policy of the Federal Reserve (FED). The US stock market recovery began in late 2023, when the FED chairman, Jerome Powell, hinted that the

historic tightening of monetary policy was probably over, as inflation was falling faster than expected. On April 3, 2024, Powell stated that, given the good development of the US economy, and "if the economy evolves broadly as we expect," a rate cut could be forthcoming at some point this year.

According to analysts, other factors have also contributed to the stock market high, such as "optimism with regard artificial intelligence." [Deutsche Welle]

HUNGARY - A contender to Hungarian Prime Minister Viktor Orban brought tens of thousands of people onto the streets of downtown Budapest on Saturday.

Peter Magyar, who until recently had close links to the government, launched a political movement in February that seeks to dethrone the populist leader after 14 years in power.

Magyar, a lawyer who used to be married to Orban's justice minister. former recently alleged entrenched corruption and cronyism among Hungary's leaders.

Protesters marched to the parliament building, some of them shouting: "We are not scared" and "Orban resign!"

Many wore the red-whitegreen national colors or waved the Hungarian flag.

Magyar addressed crowd, describing how his political movement would bring together those frustrated by Orbán's rule and the fragmented, ineffectual political opposition.


"Step by step, brick by brick, we are taking back our homeland and building a new country, a sovereign, modern, European Hungary," Magyar told supporters.

"Our elected leaders have incited the Hungarian people against each other for the past 20 years. Whether the fate of our country went well or we were close to bankruptcy, we were pitted against each other instead of allowing us to band together," Magyar added. "We will put an end to this now." [Deutsche Welle]

BERMUDA - Over the past few months, Jason Hayward has been in the news with respect to an amendment to the Employment Act 2000. When first announced, the Minister of Economy and Labour praised Bermuda Industrial Union Helena "Molly" executive Burgess for lobbying him to address the abuse identified. This amendment concerned the reported practice of unscrupulous employers in the hospitality sector retaining a percentage of gratuities intended for designated employees. In other words, some employers were found to be using their control of the gratuity system in a way that was not intended and denying employees their full share of the identified gratuities in question.

Think of the potential revenue losses that workers have endured during that period by Mr Hayward's inaction. So while he neglected unforgivably to address that issue for five vears, he would facilitate the undermining of another key facet of the gratuities scheme. He accomplished this when — in conjunction with Cordell Riley, the chairman of the Wage Commission, and Chris Furbert, the president of the BIU — he allowed the industry to use gratuities in the calculation of basic pay, which employers in the global hospitality industry love for obvious reasons.

All this despite the caveat in the approved report. However, we now see even in the Cayman Islands, as was reported recently, that its "Minimum Wage Advisory Committee" has belatedly decided to a phase out a similarly inequitable scheme implemented there only a few years ago. That

1 teaspoon kosher salt

1/2 teaspoon black pepper

2 teaspoons granulated garlic

1 (8 ounce) can tomato sauce

1 tablespoon yellow mustard

1 tablespoon brown sugar

1 tablespoon apple cider vinegar

1 teaspoon chili powder

Optional: 1/8 teaspoon cayenne pepper, or more to taste

For serving:

4 hamburger buns

1/2 cup shredded cheese

Optional: bread and butter pickles and/or pickled jalapeno slices

Add the olive oil to a skillet over medium-high heat. Add the onion and pepper blend. Cook for 5-7 minutes until they release most of their moisture and are cooked through. Push the peppers to the side and add the turkey. Cook for 5-7 minutes until browned and no longer pink. Add the salt, pepper and garlic, and stir it all together. Cook for 1 minute until fragrant.

Meanwhile, in a small bowl stir together the tomato sauce, mustard, brown sugar, vinegar, chili powder and cayenne, if using.

However,-persistent efforts by officers resulted in his apprehension and subsequent charges.


Jamal Freeman, 29, of Long Look, has been charged with two counts of Theft,

Tick-tock, the sound of a scandal known as Rolexgate, is echoing through Peru. President Dina Boluarte [pictured below is at the centre of a corruption investigation. The reason? She's been spotted wearing luxury watches and jewellery.

The controversy ignited when the Peruvian news podcast, La Encerrona, delved into 10,000 images from the presidential Flickr account. They uncovered a trend: Boluarte has worn jewellery, including Rolex watches, since assuming the role of vice president in 2021, during the tenure of the incarcerated former president, Pedro Castillo. The estimated value of this jewellery collection is staggering, reaching up to USD\$500,000. This figure is striking compared to her monthly salary, which fluctuates between 30,000 to 16,000 soles (USD\$8,000 to \$4,300). The president didn't disclose these items in her asset declaration forms, raising eyebrows and prompting further

scrutiny. Boluarte once vowed to fight corruption and stand up for the rural people. But the stark contrastbetweenhersalary and flashy accessories led to an investigation for breaking the country's unlawful enrichment and asset disclosure laws. In Peru, elected officials must report any assets to the government worth more than 10,300 soles (about \$USD2,774) and disclose any gifts from third parties.

In an unprecedented move, the police conducted a raid on Boluarte's residence in search of the

watches. This was the first time in Peru's history that the police forcibly entered the home of a sitting president. The raid was prompted by Boluarte's failure to attend a scheduled hearing where she was expected to present the Rolex watches she had been seen wearing and explain how she obtained them. Despite inquiries, she didn't explain where the watches came from and refused to allow the police to execute a search warrant at her residence.

In a televised address, Boluarte denied she was "corrupt or a thief". However, the foggy details surrounding her luxurious

collection raise serious questions about the integrity and ethics of her exercise of power. This lack of clarity is once again undermining Peruvians' trust in their institutions and reinforcing the perception that power is being abused by the political class.

Peru's battle with corruption is long and winding, affecting all layers of governance and public life. The 2023 Corruption Perceptions Index paints a grim picture, showing Peru recorded its worst drop since 2012. This decline is linked to a series of moves by Congress, wherein piling up reforms creates setbacks in anti-corruption measures. This hinders effective collaboration and even shields ethically questionable congress members.

The scandal has substantial political ramifications. Six cabinet ministers resigned, and lawmakers petitioned the congress to remove her from office citing "permanent

> moral incapacity," a constitutional provision previously used to force the resignation and removal of three former presidents within the last six years. Peru's congress, however, reject the attempt to impeach her.

Peru finds itself trapped in an enduring political turmoil. The request was made by representatives from diverse political including factions, Peru Libre, a party Boluarte was once affiliated with.

Last week, Friday, the National Prosecutor's Office scheduled an interrogation

It has put Boluarte's presidency under the microscope and raised questions about corruption and transparency in Peru's political landscape. While worrisome, the scandal can be a turning point and wake-up call for Peru to strengthen its protocols, align with international standards regarding the receipt of gifts and courtesies, and reinforce the integrity of its

In 1887, they sold the gun business and founded Smith Premier Typewriter Co. in Syracuse, New York. It became L.C. Smith & Bros. Typewriter Co. in 1903. The company merged with Corona Typewriter Co. in 1925 to become L.C. Smith & Corona Typewriter Co. Personal computers replaced typewriters in most homes, schools and offices

beginning in the 1980s. Smith-Corona no longer makes typewriters; it now makes thermal labels. The serial number on your typewriter indicates it was made in 1937. Some old typewriters are collectible and sell for a few hundred dollars. A few rare typewriters sell for more than \$1,000. Many common old typewriters sell for \$20 to \$50.

#### "OUR TOURISM STRATEGY MUST STRENGTHEN LINKAGES AND PREVENT LEAKAGES" – BARTLETT

Kingston, Jamaica; Friday, April 5, 2024: Minister of Hon. Tourism, Edmund Bartlett has expressed that, in developing Jamaica's new Tourism Strategy and Action Plan (TSAP), greater focus will have to be placed on strengthening linkages with other sectors and preventing economic leakages. was speaking yesterday at the Spanish Court Hotel as the Ministry of Tourism, in collaboration with the Inter-American Development Bank (IDB), successfully concluded its islandwide series of tourism strategy consultation workshops, with the final session being held with stakeholders from the Kingston and St. Andrew destination area.

The tourism minister highlighted that the strategy must have an emphasis on reinforcing linkages between tourism and other productive sectors, such as agriculture and manufacturing, to prevent economic leakages, as the sector prepares to meet the sustained and increased demand of visitors over the

next few years. In this regard, Minister Bartlett noted: "Our strategy in tourism must drive the linkages in the various areas, to stop the leakages from other areas."

The workshops, which have garnered valuable insights from several stakeholders across Jamaica's seven destination areas, form a part of the Ministry's thrust to develop a comprehensive new strategy and action plan for the country's vital tourism industry.

"The whole idea of these strategy development workshops is to respond to innovation and the changing realities of one of the most dynamic industries on planet Earth. The discussion today is critical if we are going to be able to create the capacity to respond to the new architecture that tourism will demand," the tourism minister added.

The United States pushed Hamas Tuesday to accept a cease-fire deal with Israel to halt fighting in Gaza for six weeks, while also releasing some of the 100 or so hostages held by the U.S.-designated terror group in exchange for Israel freeing hundreds of Palestinians it has

U.S. Secretary of State Antony Blinken told reporters in Washington that it was a "very serious" proposal presented to Hamas in Cairo last weekend and "should be accepted."

"The ball is in Hamas's court," Blinken said. "The world is watching to see what it does."

He added that the fact that Hamas has not already agreed to the terms "says what it thinks of the people of Gaza, which is not much.'

Israel declared war on Hamas after its shock October 7 terror attack on Israel that killed 1,200 people and led to the capture of about 250 hostages. Israel's subsequent

counter-offensive in Gaza has killed more than 33,000 people, about two-thirds of them women and children, according to Gaza health officials, while the Israeli military says several thousand Hamas fighters are among those

As of mid-February, 112 hostages had been freed, most during a weeklong cease-fire in November, while 36 more are believed to have died or been killed in Gaza during the six months of fighting.

Blinken said the war could have ended months ago if Hamas "had put down its guns, stopped hiding behind civilians and surrendered.'

Israeli Prime Minister Benjamin Netanyahu said Monday an undisclosed date has been set for its military to invade Rafah on the Gaza-Egyptian border, a region where more than a million Palestinians are sheltering to try to remain safe.

The U.S. opposes the planned Rafah attack, with Blinken saying the Israelis have not shared any attack date with Washington. But he said U.S. officials plan to meet with Israeli officials again next week to share their thoughts and offer alternative plans for attacking the last remaining Hamas battalions in the region.

The top U.S. diplomat said President Joe Biden has "been very clear about our concerns, our deep concerns about Israel's ability to move civilians out of out of harm's way to care for them" in the event of an Israeli attack.

Blinken said he does not see anything imminent happening in Rafah and that he does not believe anything will occur before U.S. and Israeli officials meet.

Meanwhile, U.S. Defense Secretary Lloyd Austin told a Senate hearing that a deadly mass famine in Gaza would likely

accelerate violence and ensure a long-term conflict. The U.S. has continually pressed Israel to allow more humanitarian aid into Gaza to feed famished Palestinians.

"If Israel wants to create lasting effects then it must address the humanitarian needs of the Palestinian people...And not in a marginal way," he told U.S. lawmakers Tuesday.

#### Biden hosts Kishida in official visit as US-Japan bolsters defense ties

From cherry trees to collective deterrence, the United States and Japan celebrate their decades-long alliance Wednesday as President Joe Biden hosts Prime Minister Kishida at the White House for an official visit and state dinner.

Eager to showcase the robustness of U.S.-Japan ties, the leaders will unveil new initiatives on technology and defense, including an upgrade of allied command-and-control arrangements of American and Japanese forces, civic space exploration to the moon, and research partnerships on AI, quantum, semiconductors, and clean energy.

The two leaders will highlight how Tokyo has ramped up defense spending and intensified joint military exercises with the U.S. and other regional allies, turning it into a key player in what the Biden administration calls its "lattice-like strategic architecture" to bolster deterrence against adversaries.

The leaders will take part in a trilateral summit on Thursday with President Ferdinand Marcos, Jr., of the Philippines, another key regional ally. The U.S.-Japan-Philippines trilateral meeting will focus on freedom of navigation in the South China Sea.

"The idea of switching to a multilateral lattice-like strategic architecture is then to flip the script and isolate China," a senior administration official said during a briefing to reporters Tuesday.

"When you have, like we did this week, the United States, Japan, Australia, and the Philippines doing an exercise together, when you have the trilat on Thursday, the country that's isolated is China, not the Philippines."

Last year, Biden hosted a similar trilateral meeting with Japan and South Korea to deal with the threat from North Korea.

Wednesday's meeting is the twelfth in-person engagement Biden has had with Kishida since taking office and a major milestone for the two countries, once bitter enemies during World War II. It marks a historical shift in defense ties from "alliance protection to alliance projection," the official said.

"When it's either the Quad or either one of the trilats, or whether it's a military exercise with the Philippines, the constant in all this by our side is Japan. That did not exist five years ago, 10 years ago, 15 years ago, 20 years ago," the official said. "This is the new norm." However, Biden and Kishida must navigate a key irritant - Nippon's Steel plans to acquire Pittsburghbased U.S. Steel. Biden has indicated his opposition to the deal, a thorny issue ahead of the U.S. presidential election in November. Officials said the issue is unlikely to come up in discussions as the leaders are already clear on the other's position.

Deterrence against China

Biden and Kishida will also discuss Japan's potential involvement in AUKUS, a trilateral security partnership formed in 2021 among the U.S., Australia and the United Kingdom to strengthen deterrence against China.

"We're prepared to work with additional partners beyond the three of us, where they can bring capabilities," national security adviser Jake Sullivan said in response to VOA's question during a White House briefing Tuesday. "Japan is one of the countries that could very well bring capabilities to that, so we will explore a partnership with Japan under Pillar II of AUKUS as well as other partners."

"Pillar II" of AUKUS is focused on delivering advanced capabilities and sharing technologies across a range of areas including quantum computing, undersea, hypersonic, artificial intelligence and cyber technology. The step takes the group's effort to push back against China beyond its first pillar - delivery of nuclear-powered attack submarines to Australia.

Sullivan also confirmed an announcement later this week of trilateral joint naval patrols between

U.S., Japan and the Philippines in the South China sea, another move likely to trigger a strong reaction from Beijing.

China said it opposes "cobbling together exclusive groupings and stoking bloc confrontation in the region" and "escalating the arms race in the Asia-Pacific to the detriment of peace and stability in the region."

"Japan needs to earnestly draw lessons from history and stay prudent on military and security issues," Chinese Foreign Ministry Spokesperson Mao Ning said during her briefing Tuesday.

Kishida's visit caps state visits by

leaders of the "Quad," the quadrilateral strategic security dialogue between the United States and Australia, India and Japan, hosted by Biden since taking office. The only other state visit he has hosted was for President Emanuel Macron of France - underscoring his focus on Indo-Pacific security partner-

Kishida will also participate in a cherry tree-planting ceremony at the Tidal Basin, where thousands of cherry trees gifted by the Japanese government in 1912 delight tourists with their blossoms each spring. Tokyo has offered to replace the hundreds of trees that had to be removed due to repairs.

When Pitchers Raymond "Mahasa" Mercer and Kathleen Fahie got the call that they would be the 2024 Virgin Islands Baseball-Softball Association Fast Pitch League honorees, they had different reactions.

They were honored on Saturday at the E. Walwyn Brewley Softball Park, during the opening of the league.

"It was really exciting," Mercer told Island Sun Sports. "I said, at least the moment reached, and I said it's a long time I've been waiting because it looks like I would have had to be out of here before...so that was a home run."

Fahie expressed being

surprised when the call came.

"I was in disbelief," she said.
"I even asked Molly (Sharoma Penn-Maduro) a couple times if she was talking to the right person. But I'm pleased and honored to be chosen at this young age."

When asked what the feeling was like going through the opening ceremony, Mercer said he felt like he wanted to 'play again.' "But I had enough of it," he said. "I just like watching it. But there are things the guys must learn a little bit more—hitting, pitching, and practicing—that's the main part of it. The fielding, the defense is fine but that hitting and pitching it's needed."

Mercer said the Pirates' pitchers had asked him for assistance with pitching. "I came here a couple of times, but they never showed up," he reflected. "It discouraged me."

Fahle, a retired teacher, wove the team names into a poem to give her vision of what's expected to a thunderous applause, and said that she was nervous.

"I'm not good at being in front of a crowd of adults. I prefer to be in a crowd of children," she noted. "But I was excited. I didn't expect this at such a young age and getting your flowers while you're living was powerful."

Fahie, who pitched to her daughter and Mercer, threw out the traditional first pitches to start the league. "I wish I could have thrown to the other daughter too that was there, but it was great," she said. "My first pitch wasn't a strike, so I had to do it again."

Mercer said his pitch wasn't a strike, maybe he was trying to throw too hard. He said he'd like to see players having the love of the game, practicing more, and

putting in the work. "They only want to come when they have to," he noted. "It's not going to work that way."

Fahie stated that she'd like to see players being more in tune with plays, thinking about what's happening, following the play, and knowing what to do before the play occurs.

During his illustrious career, Mercer said he has never thrown a no-hitter or hit for the+cycle. "In all the things I did, I've never done those two," he said. "I came as close as a one-hitter."

#### Constant Aleve and Ibuprofen Consumption Can Cause Damage

DEAR DR. ROACH: My husband, age 70, had been diagnosed with osteoarthritis in his neck, for which he would take Aleve to relieve his discomfort when needed. Just before Christmas last year, his back began hurting so much that he went to his doctor, who said to get up and move more. (We have always exercised and remained active in life, but he did slow down due to his pain.)

My husband then added ibuprofen to the Aleve he was already using. His doctor said that the pain is due to osteoarthritis in his mid-back area. Apparently, there is nothing to do for it but take Extra Strength Tylenol at the recommended dose. Ibuprofen or Aleve isn't recommended because it causes liver and kidney damage. So, we bought Tylenol, and he used this medication instead of his usual. But his pain only got worse.

So, this morning, he switched back to Aleve and ibuprofen. It is what helped before and is helping again now. In addition, he is using a drugfree Aleve Direct Therapy pad that uses waveform technology. He also uses Icy Hot pain relief cream and a heating pad. These reduce his pain, but his back continues to hurt since before the holidays.

Our question is, should he use Aleve and ibuprofen instead of the Tylenol that doesn't seem to help? He has actually used Aleve for a very long time. He just had his blood tested, and the doctor said his liver and kidneys are good. Is there anything more we can do to relieve his osteoarthritic pain? It is hard to see my husband in so much discomfort when he was previously a very active, pain-free man. — S.F.A.

ANSWER: Osteoarthritis in the neck is a common and painful condition, and there are not always good treatment options. In terms of medicine, anti-inflammatory medicines, like Aleve or ibuprofen (Advil and many other brands), can be very helpful for some people.

However, taking both doesn't improve pain relief. It does increase the risk of toxicity, so he should never take two anti-inflammatory medicines — choose just one. Tylenol helps some people, but in my experience, most people do better with anti-inflammatories instead of Tylenol. Tylenol does have a smaller risk of side effects.


In addition to liver and kidney problems, Aleve and similar medicines can cause stomach problems, ranging from mild upset to life-threatening ulcers; though, this is uncommon with over-thecounter doses. I often recommend a trial of Tylenol to see if it is as good as the anti-inflammatories. Since it's not for your husband, he should tell his doctor this, and it seems reasonable for him to go back to taking Aleve alone. However, I can't tell you to disregard his physician's advice. Some people benefit from Tylenol on top of Aleve.

Beyond pain medicines, the Aleve Direct Therapy pad uses electricity to relieve pain without medicine. It's fine to combine this therapy with medicines. Creams — whether they are anti-inflammatory, menthol and camphor, or topical anesthetics — provide some relief, but they tend to be better on the hands, wrists and knees than the neck. Though, they still may be worth trying in combination with medicines.

In more severe cases, injections can be used before considering surgery.

## Moments in time

- On April 22, 2000, 6-year-old Elián Gonzalez, who was the sole survivor of an abortive attempt by 13 other Cuban citizens to enter America as illegal immigrants, was taken by a S.W.A.T. team from his Miami relatives. Following a number of court battles, the child was returned to his father, Juan Miguel Gonzalez.
- On April 23, 1898, Spain declared war on the U.S. after rejecting its ultimatum to withdraw from Cuba. Following the declaration, the American Asiatic Squadron, under Commodore George Dewey, engaged the Spanish Pacific squadron under Admiral Patricio Montojo y Pasarón in the Philippines' Manila Bay, and decimated the Spanish squadron.
- On April 24, 1942, singer/actress/film producer Barbra Joan Streisand was born in Brooklyn, N.Y. Considered "the girl on the block with the good voice" in her youth, and determined to be a star, her breakthrough came with the lead role in the 1964 Broadway musical "Funny Girl." ## SOCIAL MEDIA: REWARDS, RISKS, AND UGLY ASPECTS

National Public Radio (NPR, stylized as npr) is an American non-profit media organization headquartered in Washington, D.C., with its NPR West headquarters in Culver City, California.

NPR journalists are active on social media and those rewards and risks aren't new or unfamiliar any more. In fact, one unpleasant aspect has become all too familiar: While NPR journalists generally enjoy their interactions with the public on social media, they have also been the targets of abuse on Twitter and other platforms. We've added new guidance on how to handle such situations.

But even as new social media tools and challenges pop up, and as old ones evolve, our core principles still drive the way we should conduct ourselves in the digital world.

That's why we continue to say:

"Conduct yourself online just as you would in any other public circumstances as an NPR journalist. Treat those you encounter online with fairness, honesty and respect, just as you would offline. Verify information before passing it along. Be honest about your intent when reporting. Avoid actions that might discredit your impartiality."

Though the core principles haven't changed, we've gone through the entries about social media and updated them where we felt it was necessary.

SOCIAL MEDIA PLATFORMS ARE GREAT TOOLS WHEN HANDLED CORRECTLY.

Social networking sites, such as Facebook, Twitter and Slack have become an integral part of everyday life for people around the world. As NPR grows to serve an audience that extends well beyond radio listeners, social media are an increasingly important way of connecting with our audiences. Properly used, social networking sites can be valuable parts of our newsgathering and

reporting kits because they can speed research and quickly extend a reporter's contacts. They are also useful transparency tools — allowing us to open up our reporting and editing processes when appropriate. We encourage our journalists to take advantage of them.

But reporting in social media spaces requires the same diligence we exercise when reporting in other environments. When NPR bloggers post about breaking news, they do not cite anonymous posts on social media sites — though they may use information they find there to guide their reporting. They carefully attribute the information they cite and are clear about what NPR has and has not been able to confirm.

When NPR correspondents go on the air they may mention discussions they've seen on social media sites as reflecting in part the tone or mood or general reaction to an event. But they realize that is not the same as a scientific survey of public opinion or a substitute for the kind of indepth reporting that leads to a deep understanding of a subject.

WORDS MATTER. TRY TO STRIKE THE RIGHT TONE.

NPR has always tried to be engaging, entertaining and informative – while being civil. We've never shouted at our guests. We seek answers, not confrontations, when we conduct interviews. We are firm when we need to be, but never mean.

We take the same attitude to social media. We shouldn't SHOUT IN ALL CAPS when we're angry. We shouldn't take the bait from trolls and sink to their level. We don't use foul language. We pause to re-read our responses before hitting "reply."

HOW WE TREAT EACH OTHER

We sometimes want to write about NPR on social media. Sharing our colleagues' work is encouraged. Pointing to NPR's coverage of news events is of course perfectly fine. But

when it comes to criticism of the work done by NPR's journalists, we treat our colleagues as we hope they would treat us. If we have something critical to say, we say it to their face – not on social media.

We also treat each other with respect when using social media platforms such as Slack to communicate internally. When in doubt, it's always wise to ask a few questions: Would I say that to this person's face? Would I say that in front of my coworkers? How would I feel if that was said – in public — to me?

Side note: When posting about NPR's work, do respect its copyrights. For example, it is OK to link from your blog or Facebook profile to a story of yours on the NPR site, but you should not copy the full text or audio onto a personal site or Web page. Assume the terms of use that apply to the public also apply to your usage in these situations.

HOW WE DEAL WITH ABUSIVE BEHAVIOR BY OTHERS.

Journalists are just like those in other professions. We enjoy being praised when we do good work. But unlike those in occupations that aren't in the public eye, journalists have to accept that being criticized is part of the job. We know that the words we write and say, the photos and videos we post, the charts we produce and – yes – the things we say in social media may anger others. If we're willing to report facts that may cast public officials in an unfavorable light and are willing to dig into controversial topics, we have to be willing to put up with some pushback from the public.

We do not, however, have to put up with threatening or abusive communications from those who don't like our reporting. We do not have to put up being personally attacked because of our gender, race, religion or any other identifying factor.

The guiding principles when such abuse comes in are "don't feed the trolls" and "don't respond in kind." This is a classic example of "easier said than done," of course. We're human. We want to fire back.



## Rebranding from Open to Global: Remaining Faithful to our Regional Countries, Towns, Villages and Hamlets

Office of the Pro Vice-Chancellor and Principal. Monday, April 8, 2024 - The UWI Open Campus as an Online Campus has been rebranded into The UWI Global Campus. "Strewn across the Region and dispersed globally to increase our impact, it was this agile Campus which demonstrated that learning could continue when other institutions and other organisations were shutting down. The Global Campus looks forward to fulfilling the vision of the Vice-Chancellor to be the major pillar in the Revenue Revolution phase of The UWI Triple A strategy through aggressive, entrepreneurial activities that take our excellent programme offerings online to wider regional and global markets," said Honourable Ambassador Dr June Soomer, Chair, The UWI Global Campus Council, in her opening remarks to the Global Campus Council Meeting on Friday, March 22, 2024.

She spoke about the rebranding

process and asked for continued patience as the Campus navigates the changes. She further indicated that the Campus was grateful for the understanding and patience during these challenging times. "We are committed to ensuring that citizens in non-independent countries will know that we will help them to build capacity in special entrepreneurship and employability skills training programmes which target beneficiaries of social protection programmes, especially women. Our citizens in Belize who tackled mental health in the workplace will know that we want better working conditions. Our citizens in Saint Lucia and Dominica, who would be happy to include continuing and professional educational process, will know that we understand that the development of countries will depend on the type of education they receive. These are also our aspirations for students that we will attract globally. The UWI will consolidate its reputation for excellence. We will be at the heart of shaping global citizens. As we move into the last 25 years of the first century of The UWI, the Global Campus is well-placed to assist the University in achieving the goals of one graduate for each household so that we can spur the development of the generational wealth that has been in the Region. We look forward to sustained advancement," Ambassador Soomer stated.

Vice-Chancellor Sir Hilary

Beckles in his remarks stated, "The 75th year gave us a tremendous opportunity not only for reflection upon the achievements of our University but also an opportunity to make projections as we look toward the centenary 25 years from now. It has been a rich engagement and many lessons have been learnt, and we are now actively making preparation for the future. I can reliably state that after 75 years, the reputation of this University has never been greater. I can also state that the global visibility of our University has never been greater."

The Vice-Chancellor indicated that despite encountering internal challenges, the University's achievements have commendable. "We are in a very good competitive position relating to the system of higher education. The 75th year has found us right where we wanted to be. Our goal has always been to rank among the top 5% of the best universities in the world, and from year to year we might also be in the top 1.5, or top 2 or 3, but that is where we will always be, that is our plan. This is where we are, the #1 University in the Caribbean in a field of over 150. The top 1% in Latin America and the Caribbean, among 2,000 universities, and in the world in a field of 32,000 universities, we are in the top 3%," explained Vice-Chancellor Beckles.

He indicated that this brings a tremendous sense of greater responsibility for the future and that it was imperative to begin charting a course towards the centenary of the University. He mentioned that in the past two years, there were significant challenges due to the COVID-19 Pandemic and that in some respects, the Pandemic posed an existential threat to the University. He stated that "Several institutions in our hemisphere and beyond found it necessary to close their doors. They could not see how they could deliver on their culture of teaching and learning and research within that context... We did not make those very adverse decisions. We decided to stay focused. We embraced our students and took them through this process. We did the best possible and we were commended for it. However, we could not have achieved that circumstance without the specific and focused mobilisation of the Global Campus."

He spoke about the International School for Development Justice (ISDJ) which will be located within the Global Campus and

indicated that it will be a business school focused on teaching and learning at the graduate level, specifically around the Sustainable Development Goals. He explained that this is a unique opportunity that will see the Global Campus in a very positive position in the years ahead. "As we prepare to become actively involved globally in the world of higher education, we must remind ourselves that it is a multibillion dollar market and we at The UWI will be a part of it, securing our share of the revenue associated with the rapidly expanding global economic systems. We are now about to complete the rebranding exercise from Open to Global so that the concept of the Global Campus rolls off our lips in a way that the Open Campus did in past decades. This is what we are hoping for so that we can all embrace the concept and the vision. We are now in the business of revenue-generating in light of the financial and physical context of the Region and we will make progress," stated Sir Hilary.

Vice-Chancellor Principal, Dr Francis O Severin in presenting his Annual Report to the University Council for the 2022/2023 Academic Year, spoke of the new Global brand. "We are a hybrid and blended Campus since we are virtual with 42 physical site locations serving 17 Englishspeaking Caribbean countries and authentically a Pan-Caribbean Campus. We make a fundamental and unequivocal claim to this". He explained that the sub-theme for his presentation, which speaks to Remaining Faithful to our Regional Countries, Towns, Villages, and Hamlets is befitting of the Campus' commitment to community outreach.

"At the Global Campus, we believe in the power of education to transform lives and communities. As we embark on this exciting journey, it is important for us to remain devoted and committed to our Regional countries, towns, villages, and hamlets as we want our community outreach to remain robust, consistent, and strong. assess the unique needs and characteristics of each subregion within the Caribbean community. "We appreciate and understand that education should be accessible to everyone regardless of their geographical location. Our goal has therefore been to sustain and bolster our ties with our Regional countries. We have done this while having as our focus the provision of quality education and support to all."

The Principal reported that the Reaccreditation Midcycle Review was held on

November 13 and 14, 2023. He noted that it was an opportunity for the Campus to reflect on its development and achievements since the granting of full accreditation for 7 years in 2019. "The process included looking at any matters identified in the reaccreditation report that required action and to look ahead at the development plan for the remainder of the accreditation period. It was also an opportunity for the Barbados Accreditation Council (BAC) to keep abreast of developments in the Campus and to check on continued compliance with the accreditation standards,"

explained Dr Severin.

Concerning the Rightsizing Human Resource Consultancy, Principal Severin explained that the process was launched on January 29, 2024, and is on track for completion on May 31, 2024. He paid tribute to the Caribbean Development Bank and thanked them for funding 83% of the cost of the Consultancy and indicated that 17% represents a contribution-in-kind from the Campus.

In closing his presentation, Dr Severin informed the meeting that the Campus has proposed a project titled Circular Community for Health, Wellness and Sports in Grenada. "This is a fundamental Global Campus Revenue Revolution initiative that will benefit not only Grenada but the Eastern Caribbean as well. This project dovetails with our emphasis on sustainable development, justice, climate justice, and the circular economy," stated Dr Severin.

Principal Severin wrapped up the Annual Report by thanking our contributing and supporting governments,-the-Vice-Chancellor and the University's Executive-Management Committee, and all our stakeholders, friends and wellwishers. He expressed gratitude to the Campus Council Chair, Honourable Ambassador Dr June Soomer for her continued support and keeping in very close touch with him and his team. He advocated that, as a resilient team and Campus, that "...we shall continue to renew our strength; we shall mount up with wings like eagles; we shall run and not be weary; we shall walk and not faint."

The meeting also received several departmental reports from members of the Global Campus Senior Management Team as well as the Audited Financial Statements, the Audit Committee Report, the Guild of Students Statement, and the Open Campus Alumni Report.
