MUSIC FEST DISPLEASES DEPUTY PREMIER, OPPOSITION, AND VAST SEGMENTS OF CITIZENRY

The Territory is in the throes of a heated debate over the need for two music festivals this year, and whether the government should have invested in the event. With literally days before the government-sponsored music fest is held Deputy Premier Hon. Lorna Smith has noted her reservations about the matter. Her hesitance came on the heels of one of many protests held by clergyman John Cline on the site of the event.

The end of May music fest is a delivery of a promise made by the incumbent government during its bid for office. It was expected to be the resurrection of the music fest held in May for many years.

However, persons in the community have been calling for the event to be boycotted because it was

noted that a privately hosted music festival was organized and will be held weeks after the Government-sponsored music festival.

It was noted that a focal point of the contention is the hefty price tag and perceived misallocation of taxpayer funds associated with the event.

During an interview with ZBVI Radio, Hon. Smith expressed-reservations about the decision to host the Music Fest amidst widespread criticism and economic-uncertainty. While voicing her support for the government's overall agenda, Smith said: "I support the government's agenda, but I don't think that the Premier expects me to agree with everything he does."

While the Deputy Premier has been cautious about

expressing her concern, Clergyman Cline has been loudly vocal about his opposition to the festival. He staged a one-man protest which went viral on social media and garnered significant attention. Cline, urging the public to boycott the event, has been a staunch critic of what he views as fiscal irresponsibility on the part of the government.

During a recent radio interview, Cline expressed dismay at the Premier's refusal to disclose financial details of government spending, particularly in relation to past festivals and associated contractors. Is there something rotten in the BVI?

Cline's concerns were further exacerbated by the Premier's invocation of parliamentary rules to withhold information

deemed "not in the public's best interest." "This guy has gone rogue," remarked Cline, highlighting what he sees as a troubling lack of transparency and accountability in governance. He called on both members of the Opposition and Government to assertively hold the Premier-accountable, emphasizing the importance of democratic checks and

balances.

- The controversy surrounding-government spending on the Music Fest has ignited a broader conversation about the role of entertainment events in the Territory's development. For instance, Premier Wheatley on numerous occasions has described the events as necessary for the growth

of the Territory's tourism sector. Hon. Wheatley has mentioned as well that many in the BVI travel across the region to attend various music festivals.

However, persons against the financial injections government has made

towards the event state that there were other pressing matters to fund such as roads, 15 year-old sewage stink, and other infrastructure. They also argue for greater fiscal responsibility and transparency.

The disagreement over the

staging of the event has also included logistical matters with Opposition member Hon. Myron Walwyn questioning the planning process and the viability of attracting attendees with such short notice.

"How can you plan a

music fest, advertise it, or announce it just a month and a half before it's scheduled?" he challenged and further questioned the government's ability to ensure a substantial return on investment within such a brief timeframe.

"When people who are

struggling to receive assistance from the government-witness expenditures like these, it understandably frustrates them," the Sixth District Representative remarked, emphasizing the disconnect between public needs and government priorities.

DEPUTY SPEAKER AND EDUCATION MINISTER COMMITTED TO ENGAGE IN DISCUSSIONS

Tensions flared in the House of Assembly recently as Minister for Education, Youth Affairs, and Sports, Hon Sharie De Castro, took to the floor to counter assertions made by Deputy Speaker and Opposition Member, Hon Stacy Mather.

The controversy gained

momentum-following Hon Mather's appearance on the popular talk show "Cut Deep" hosted by Cindy Rosan, on Tuesday 30 April. During the broadcast, Hon Mather aired grievances regarding what he perceived as Minister De Castro's reluctance to engage with him on matters concerning education and youth development.

In a candid admission, Hon Mather revealed that while a scheduled meeting between the two regarding-educational

issues was pending, he harbored-reservations due to what he described as a lack of rapport and-communication breakdown.

However, Minister De Castro wasted no time in rebutting these claims during the Tenth Sitting of the First Session of the Fifth House of Assembly on Thursday, 2 May. Responding to queries, she vehemently denied any allegations of non-cooperation.

"Contrary to unfounded allegations, -I-have

consistently-extended invitations to the Member and made sincere efforts to foster constructive dialogue," asserted the Education Minister as she dispelled any notions of discord.

Providing context to the situation, Minister De Castro shed light on a previously scheduled meeting on 23 February, which was canceled by Hon Mather. Despite proactive attempts by her Ministry to reschedule and accommodate his availability, no response was forthcoming.

Emphasizing-the-importance-of transparency and accuracy, Minister De Castro called for an end to the spread of misinformation and urged Hon Mather to communicate his availability for fruitful discussions aimed at advancing educational and youth development initiatives.

"Let me take this opportunity to respectfully

urge the Member to refrain from spreading misinformation and instead collaborate with the Ministry to facilitate meaningful dialogue that will benefit our youth and education sector," implored the Education Minister.

In a conciliatory gesture, Hon Mather acknowledged the Minister's remarks and expressed his willingness to engage in dialogue.

"In this Honourable House, I affirm my commitment to engaging in discussions with the Minister," Hon Mather declared, signaling a willingness to move past the impasse and work together for the betterment of the Virgin Islands.

REHABILITATION OF GOVERNMENT ADMIN BUILDING REQUIRES SWIFT ACTION

Calls for urgent action to rehabilitate the deteriorating old Government Administration Building in Road Town, Tortola, echoed through the chambers of the House of Assembly as Opposition Member Hon Marlon Penn voiced concerns over its current state during the Tenth Sitting of the First

Session of the Fifth House of Assembly on 2 May.

Hon Penn highlighted the pressing need for repairs to the building, emphasizing that it currently houses individuals, including a mentally ill man. "I saw a young man living in that building, there's people living in the building right now. I shudder to understand the condition of that building, a young man who is out in the open causing some disturbance, obviously has some mental challenges, is living in that building," expressed Hon Penn. In response, Premier Dr the Hon Natalio Wheatley acknowledged the significance of the building to the Territory, revealing plans for its revitalization. Dr Wheatley

outlined the government's cautious approach in determining the best course of action to restore the building to its former glory.

"The Deputy Governor requested funding in the 2024 budget to repair the external facade of the building which is now creating a hazard for pedestrians and vehicles," stated Premier Wheatley. He further detailed plans for restoration works, including repairs to the roof and the restoration of the annex for use by the Archives Unit.

Addressing concerns about the welfare of the individuals occupying the building, particularly the mentally ill man, Premier Wheatley assured that the government is

committed to assisting those in need. "We're very sensitive to that and I do think that it would be appropriate for the Minister of Health to get together with his team and to see what support can be provided to the individual," Dr Wheatley affirmed.

The Premier's pledge to address both the structural concerns of the building and the well-being of its occupants underscores

the government's dedication to preserving historical landmarks while prioritizing the welfare of its citizens.

As discussions continue regarding the rehabilitation of the old Government Administration Building, stakeholders remain hopeful that swift action will be taken to ensure its preservation for future generations to appreciate and enjoy.



FIRST NATIVE COMMISSIONER OF POLICE DIES AT AGE 76

News of the passing of former legislator and first local Commissioner of Police, Vernon Malone reverberated across the Territory. Mr. Malone peacefully departed on Saturday, 4 May at the age of 76, leaving behind

a legacy of service and genuine dedication to his community.

Born on 5 June, 1947, in Long Look, Mr. Malone spent his formative years in the heart of the BVI. His contributions spanned various sectors, from education to law enforcement, politics, and beyond.

A testament to his commitment to public service, Mr. Malone's journey began as a school teacher before he embarked on a distinguished career with the Royal Virgin Islands Police Force (RVIPF). Rising swiftly through the ranks, he made history by

becoming the Territory's first local Commissioner of Police, a role he served with distinction from 1992 to 2002.

During his tenure, Mr. Malone was a fervent advocate for education within the police force, championing initiatives aimed at uplifting and empowering officers. He played a pivotal role in establishing educational programs at the H. L. Stoutt Community-College tailored specifically for law enforcement personnel. Additionally, Mr. Malone's unwavering support extended beyond words, often reaching into his own pocket to finance

his officers' educational pursuits. Today, many of them stand as testaments to his mentorship, holding Bachelor's and Law Degrees earned under his guidance.

Driven by his passion for learning and advocacy, Mr. Malone pursued higher education himself, earning a law degree and subsequently founding his own esteemed law firm, Vernon E. Malone & Co, located in Brewers Bay. In 2007, Mr. Malone ventured into politics, securing a seat with the Virgin Islands Party (VIP) and earning commendation for his dedicated service to

the people. Though his political career saw its ups and downs, his commitment to his constituents and the betterment of the Territory remained unwavering.

Throughout his lifetime of service, Mr. Malone garnered numerous accolades, including the prestigious Queen's Police Medal (QPM) in 1996, in recognition of his outstanding contributions to law enforcement and community development.

Draft Report On Minimum Wage Submitted

The Ministry of Financial Services, Labour and Trade has received the draft report of the ad hoc Minimum Wage Advisory Committee.

The Committee was established in November 2023 to conduct a comprehensive review of the Territory's Minimum Wage.

The last increase in minimum wage was made on 1 October 2016. Since then, a review of Social Assistance by the Social Policy Research Institute (SPRI

Global) discovered that the current minimum wage is well below what is now necessary to reasonably meet one's basic needs. However, the researchers cautioned that the speed by which the minimum wage is adjusted must take into account economic constraints.

During the Committee's review process, they examined relevant policy documents, economic data, and labour force statistics. Members of the Committee

also engaged in community outreach activities, which included surveys, interviews on radio and television, and focus group discussions.

The Minister for Financial Services, Labour and Trade expressed confidence in the community's participation and the wide range of data captured. She stated, "The Committee's efforts aimed to capture a wide range of perspectives to inform our minimum wage policy. I am pleased to say that we had a

significant response from both employees and employers."

The Minister expressed gratitude to the community for their participation in the discussions. She also thanked the Committee, which was coordinated by Dr. Dawn Alexander-Joseph of the Ministry, for their hard work in ensuring that the report was delivered.

Regarding the next steps, the Ministry of Financial Services, Labour and Trade

will review the Report, and its recommendations will be submitted to Cabinet for review. The public will be informed once Cabinet has made its decision.

Virgin Islands Responds To Flash Flooding Event

Damage assessments began yesterday as the Virgin Islands carries out its emergency response to the passage of a trough May 7 and 8.

The event dumped more than 5 inches of rain on Road Town and approximately 9 inches on Virgin Gorda.

His Excellency the Governor Daniel Pruce chaired a meeting on May 8 with leaders from key responding agencies including the Royal Virgin Islands Police Force, Ministry of Health and Social Development, BVI Ports Authority, BVI Electricity Corporation, and the Public Works Department to discuss preliminary impacts and next steps.

Governor Pruce said, "Thankfully, no lives were lost and there were no reports of injuries during the flash flood event. I am grateful to everyone involved in response to the flooding and disruption caused by the heavy rains in the past few days."

"I hope that as a Territory and a community, we can come together to support those persons who now face the difficult process of recovering belongings and rebuilding businesses," the Governor added.

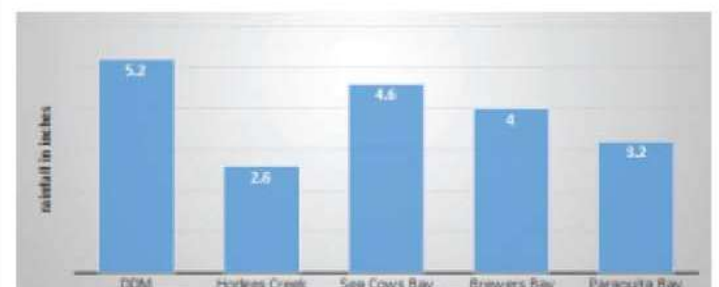
Director of Disaster Management Mr. Jasen Penn said that the event illustrated how sudden flash flooding can be and underscored the importance of preparedness and mitigation for the entire Territory.

"Part of what makes flash flooding so dangerous is that it can occur with very little warning, and unfortunately that is what the Territory experienced May 7 and 8," Mr. Penn said. He added, "The presence of a trough had been forecasted by our partners at the Antigua Met Office, however, the level of rainfall was not understood until it was already underway."

Mr. Penn expressed his gratitude for the public's overall safety during the event.

"We know that measures like school closures, office hour adjustments and requesting persons not to drive during the event disrupt persons' routines, but these measures also help to ensure that the population can stay safe," he said.

Virgin Islands residents are reminded that the hurricane season begins on June 1 and that it is important to be ready for storms, floods and other emergencies. Kickin It University Launched to Preserve Virgin Islands Culture

Tortola, Virgin Islands – May 8, 2024 – Kickin It' launches a community program called Kickin It University (KIU), with an

aim to preserve Virgin Islands culture. KIU jumpstarts with a crowdfunding campaign to support the development and delivery of engaging classes,

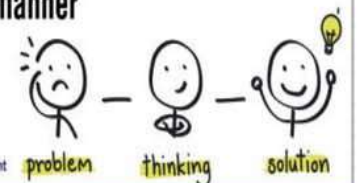

BVI laser sailor Thad Lettsome secures spot at Paris 2024 Olympic Games – becomes first BVI sailor at Olympics since 1996!

Tortola, British Virgin Islands, May 7, 2024 – The BVI Olympic Committee today received and accepted an official invitation from the Tripartite Commission in collaboration with World Sailing, for the allocation of a Universality Place at the Paris 2024 Summer Olympic Games to BVI's ILCA7 (Laser) sailor, Thad Lettsome. At 22 years old, Lettsome becomes the first BVI sailor to compete at an Olympic Games since 1996 when 2x Olympian Robby Hirst competed in the Laser event at the Atlanta Games.

The BVI OC and Chef de Mission for Paris 2024, Tahesia Harrigan-Scott received the official invitation via email. Lettsome was one of 3 sailors eligible for the two available spots for the Universality Place. Competing at The Last Chance Regatta in Hyères, France (April 21-27), Lettsome placed 31 out of 61 sailors to edge up his rankings.

“This is an historic occasion for the Virgin Islands, the Royal BVI Yacht Club and for the BVI Olympic Committee,” said BVI OC President Ephraim

Penn. “One of our mandates is to increase the number of sports represented at major Games. Through Olympic Solidarity and Panam Sports funding, the BVI OC has supported the development of sailing and Thad’s progression for several years and today we have reached an incredible milestone with the offer of a Universality Place at the Paris 2024 Olympic Games for a BVI sailor.

Lettsome and McMaster are members of the BVI OC’s current roster of elite athletes benefiting from the Tahesia Harrigan-Scott Elite Athlete Scholarship programme.

GLOBAL NEWS BRIEF

PANAMA - Jose Raul Mulino, the stand-in candidate for disqualified former President Ricardo Martinelli, was declared Panama's president-elect after elections Sunday.

Panama's electoral authority announced Mulino's win, after he garnered 34.4% of the votes, with over 85% of the votes counted.

"I promise to the country at this time to put together, to establish, a government of unity as soon as possible," Mulino said after electoral officials called him to confirm he had won the presidency.

Eight candidates were competing to replace the center-left President Laurentino Cortizo, who by law is limited to one consecutive term.

Mulino only officially joined the race on Friday after his former running mate was forced to drop out over a money laundering conviction.

Mulino took over the candidacy of the Realizing Goals (RM) party from ex-President Ricardo Martinelli after the latter lost an appeal

against his conviction.

Mulino then faced his own problems after his candidacy was challenged on the basis of not having won a primary vote and not having picked a running mate, which is a requirement by law.

But the Supreme Court threw out the complaint on Friday, leaving Mulino free to run. Most Panamanians assume that Martinelli will still run the show from behind the scenes. [Deutsche Welle]

ISRAEL - A global trend of increasing antisemitism has skyrocketed since Hamas' deadly October 7 attack, a new report has said. The Tel Aviv University report says many Jews across the world may soon be unable to live in safety.

Antisemitic incidents are rising across the world at a rate unseen since World War II, with the Israel-Hamas war in Gaza spreading "a fire that was already out of control," an annual report released on Sunday said.

The report, issued by the Center for the Study of Contemporary European Jewry at Tel Aviv University

and the Anti-Defamation League (ADL) in the US, said that although antisemitism had increased since the atrocities carried out by the Islamist militant group Hamas in southern Israel on October 7 last year, the first nine months of 2023 also saw a rise in antisemitic incidents compared to 2022.

The report stressed that the increased hatred of Jews could not simply be put down to emotions raised by Israel's retaliatory offensive against Hamas in Gaza, saying that many "outrageous" expressions of antisemitism occurred before that campaign began. [Deutsche Welle]

RUSSIA - Nearly four decades ago today, the Soviet Union witnessed the worst nuclear disaster in history when the fourth reactor at the Chernobyl nuclear power plant in Ukraine exploded.

In the present-day Russian capital, another potential radioactive threat lies dormant beneath Muscovites' feet.

In Moscow's northwestern Shchukino district, city authorities are planning new developments atop underground pipes carrying liquid radioactive waste, with plans to erect business and residential buildings, a

school and a kindergarten.

Locals and experts say these extensive construction works could damage the pipes, potentially spilling this radioactive waste into the environment.

"Inside the old pipes, there are centimeter-thick deposits of radioactive salts. There's a huge cocktail there, with many different radionuclides present," said Andrei Ozharovsky, a nuclear physicist and antinuclear campaigner.

"In the event of damage to a functioning pipe ... it could lead to the simple spillage of its contents, resulting in local contamination," Ozharovsky told the Moscow Times. [Moscow Times]

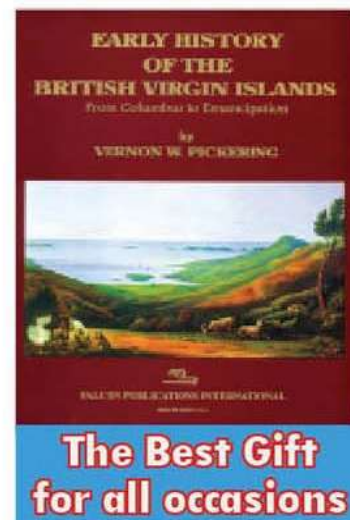
ITALY - Italy has dropped five slots to 46th in the latest world press freedom report by Reporters Sans Frontieres with the case of press agency AGI, set to be sold to League MP and rightwing newspaper proprietor Antonio Angelucci, cited as one of the reasons.

Rome is midway in the rankings topped by Norway and with Eritrea in last place, with RSF voicing concern over businessmen allied to governments taking over media.

It cites the case of AGI, Italy's second biggest news agency after ANSA and owned for the last 40 years by state controlled oil giant Eni, which is set to be sold to Angelucci, owner of conservative dailies Il Giornale, Libero and Il Tempo, effectively by a top member of his own party, League bigwig and Economy Minister Giancarlo Giorgetti.

The RSF report says "an example of some political groups orchestrating the acquisition of the media ecosystem is Giorgia Meloni's Italy, where a member of her coalition is trying to buy the AGI press agency". [ANSA]

JAMAICA - Jamaica has surged in press freedom, climbing eight places in the latest World Press Freedom

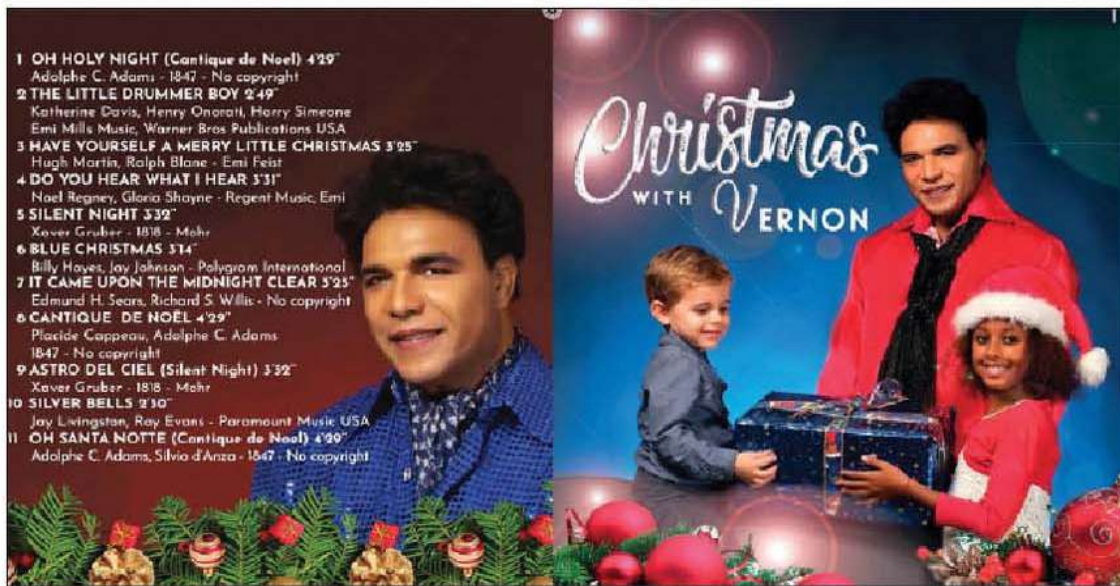
Now standing at the forefront of the Caribbean, the nation has claimed the 24th spot among 180 countries assessed.

ETON MESS: A DELIGHTFUL BRITISH

TREAT FOR MOTHER'S DAY

As Mother's Day approaches, it's time to treat the special mother figures in our lives with something unique, fun and utterly delicious. Why not surprise Mom with a taste of British charm by serving up a delightful dessert known as Eton Mess? Eton Mess originated from the prestigious boarding school, Eton College, in Windsor, England.

Don't let the name fool you; this is one mess Mom will absolutely adore!

Eton Mess is not only delicious, its playful combination of textures and flavors make this a joy to eat. With simple, affordable ingredients like fresh strawberries, meringue and cream, you can create a dessert fit for a queen without breaking the bank.

ETON MESS

The amount of meringue can vary depending on personal preference and the size of the servings. If you don't want to make meringue, use 8 to 16 store-bought cookies, depending on size.

Yield: 6 servings

Total Time: 10 minutes

1 pound of fresh strawberries

1/2 medium lemon, juice and zest

2 tablespoons of granulated sugar, divided

1 recipe baked meringue slab (below)

2 cups of cold heavy cream

Begin by making a meringue slab, if using.

Slice the fresh strawberries into a bowl. Save a few for garnish. Zest half of a lemon; reserve zest for later use. Squeeze the lemon until you have 1 tablespoon of juice. Add the lemon juice and 1 tablespoon of granulated sugar to the strawberries, giving them a gentle toss to

combine.

Now, let's add some crunch! Take the meringue slab (or cookies) and coarsely crush them with your fingers or a knife.

In the bowl of a stand mixer with the whisk attachment (or mixing bowl with a hand mixer), pour in 2 cups of cold heavy cream and the remaining tablespoon of granulated sugar. Beat on medium speed until soft peaks form.

Once your cream is whipped to perfection, gently fold in the crushed meringues and about two-thirds of the prepared strawberries using a spatula. This will create a luscious, creamy mixture with delightful pockets of crunch and bursts of fruity flavor.

To serve, evenly divide the Eton Mess mixture between 6 coupes, short glasses or small bowls. Top each serving with the remaining strawberries and a sprinkle of lemon zest for extra zing.

BAKED MERINGUE SLAB

Yield: approximately 6 cups

Prep Time: 2 hours, 10 minutes

3 large egg whites, at room temperature

3/4 cup granulated sugar

1/2 teaspoon vanilla extract

Pinch of salt

Preheat your oven to 225 F (110 C). Line a baking sheet with parchment paper.

In a clean mixing bowl, with stand mixer or hand mixer, beat egg whites on medium speed until soft peaks form, 1-2 minutes. Gradually add the sugar while continuing to beat the egg whites. Once all the sugar has been added, increase the speed to high and beat until stiff, glossy peaks form. Fold in the vanilla extract and a pinch of salt until well incorporated.

Transfer the meringue mixture onto the prepared baking sheet; spread it about 1/2-inch thick.

Place the baking sheet in the oven and bake for 1 hour, or until the meringue is dry to the touch. Once baked, turn off the oven and leave the meringue slab inside to cool completely. This slow cooling helps prevent cracking.

Once completely cooled, remove the slab from the baking sheet and break it into bite-size pieces.

Eton Mess is the perfect way to show Mom just how much she means to you. After all, every mom appreciates a little messiness in her life, especially when it's this delicious!

RVIPF RESPONDS TO BOMB THREAT AT AIRPORT

Monday, May 6 — The Royal Virgin Islands Police Force was alerted to a potential bomb threat at Terrence B. International Airport on May 5, after 4pm.

The threat was communicated via email to Advance Marketing & Professional

Services, claiming the presence of a bomb on an aircraft and at the Terminal Building. In response, RVIPF and Airport Security promptly evacuated the premises, and conducted a thorough search of all areas. After two and a half hours, the all-clear was issued, and normal operations resumed.

Similar threats targeting the International Airports of Turks and Caicos and Bermuda have also been reported. RVIPF is collaborating with these jurisdictions to identify the offenders behind these threats.

Despite an extensive search, no devices were discovered, indicating the messages were likely intended to create chaos and disrupt airport operations, inconveniencing passengers, and staff.

RVIPF reaffirms its dedication to resolving all criminal matters and will provide updates as the investigation progresses.

THIS WEEK IN CORRUPTION

ON THE BRINK OF A BALLOT

On Sunday 5 May, Panamanians headed to the polls to elect a new president amid controversy and uncertainty. The country grapples with institutional fragility, tight margins in the polls and the lack of a runoff election. This intensifies the ongoing political crisis, fueled by social inequality and corruption protests in recent years.

Former President Ricardo Martinelli, once the front-runner, was disqualified following a ten-year sentence on money laundering charges. He was convicted in July 2023 for his involvement in the “New Business” case, where companies that won bids during his presidency sent over US\$40 million to a ghost company owned by him.

In 2021, former president Martinelli pleaded guilty to money laundering and his son confessed to the acceptance of bribes before a New York court linked to the large-scale money laundering and bribery scheme of the Brazilian construction company Odebrecht.

Following Martinelli’s recent conviction in Panama, José Raúl Mulino, his running mate and former public security minister, stepped in. Despite bypassing party selection processes, the Supreme Court rejected the constitutional challenge to his candidacy.

Mulino has also faced scrutiny for corruption allegations on embezzlement. He spent six months in jail and despite lengthy journalistic investigations on the matter, charges against him were dropped. The rest of the candidates have denounced they don’t have equal opportunities or resources. The ruling party, for example, has been accused of using state resources to influence the elections, creating an uneven

playing field for all candidates.

The slogan for the leading campaign asserts, “Martinelli is Mulino and Mulino is Martinelli.”. While disconcerting, Mulino’s lead on the polls can be attributed to the economic growth during Martinelli’s administration, driven by the construction of the first metro line and the expansion of the Panama Canal.

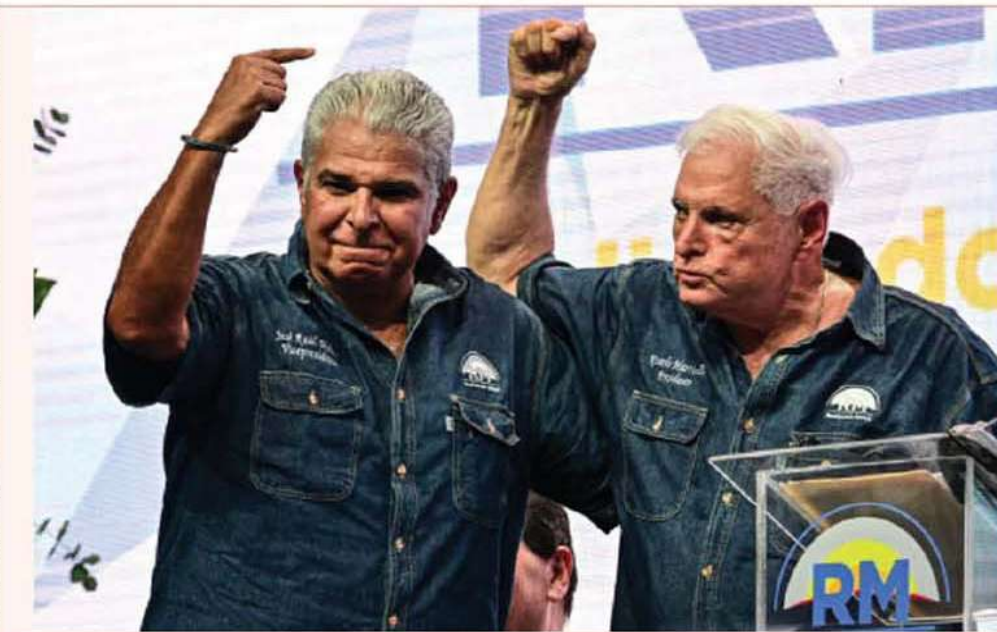
Regardless of the election, Panamanians recognise corruption as a big problem. With a score of 35 points on the Corruption Perceptions Index (CPI), the country’s

lowest since 2012, it’s clear there hasn’t been enough progress in ensuring transparency and accountability. The fight against corruption has seen both progress and challenges. Even though authorities are launching more investigations, cases often stagnate or don’t reach the courts.

As the election approaches, tensions escalate, creating a dangerous situation that could cause social unrest and violence. We call on authorities to ensure a fair and peaceful electoral process, safeguarding the

rights of all citizens.

Despite the election outcome, hope remains. The incoming president has the power to create real change and effectively address corruption. Civil organizations advise the new government to strengthen legal frameworks, reinforce laws against public administration crimes, implement anti-bribery laws, and protect whistleblowers, journalists and activists from judicial harassment. Legal reforms are also needed to ensure transparency in officials’ financial disclosures and conflicts of interest, as well as to improve public access to information.

KOVELS ANTIQUES AND COLLECTING

Toothpick Holders

Collectibles don't need to be utilitarian. In fact, many of today's collectibles have a purpose that has been lost to time. Toothpick holders, especially from the 19th century, are miniature examples of the beauty of art glass, pottery, porcelain or silver. They often resemble tiny vases or figurines and may sell for lower prices than larger pieces by the same makers.

This porcelain toothpick holder sold at Woody Auction for \$84. The auction describes it as "bag-shaped," but it is an unusual example. Bag-shaped vessels tend to be shaped like upright bags with the opening as the neck. This one is shaped like a bag lying on its side, tied closed, with a gilt-edged "hole" as the top opening. It is decorated with painted sprays of flowers and marked with the initials "J.P.L.," the mark of Jean Pouyat, one of the many porcelain makers in Limoges, France. There is also a complex signature of intertwined letters; likely the mark of the painter. Some porcelain factories in Limoges sold blanks, or undecorated pieces, to be painted by artists or hobbyists.

Q: I follow your column regularly in the Sunday Republican and enjoy it very much. I own four bronze sculptures by Frederic Remington. They are all about 12 inches tall. They are in very good condition. Can you give me an idea of their value?

A: Frederic Remington (1861-1909) made 22 different sculptures

beginning in 1895. The first four were cast in bronze at the Henry-Bonnard Bronze Co. in New York. Beginning in 1900, his sculptures were cast at the Roman Bronze Works in New York. All his original bronzes are marked with one of those two foundry names. His bronze sculptures are the most reproduced bronzes. Most of the original sculptures are about 24 inches tall or larger. Original Remington bronzes sell at auctions for \$75,000 or more. The 32-inch bronze sculpture titled "The Broncho Buster" sold for over \$600,000 a few years ago. Reproductions sell for under \$500. The website of the Frederic Remington Museum in Ogdensburg, New York (FredericRemington.org), has information and a form you can fill out if you think you have an original Remington sculpture.

These were the sentiments of Dr. Carla Barnett, CARICOM Secretary-General, expressed at the launch of the CARICOM Climate Change and Health Orientation and Training for CARICOM Youth Ambassadors and Youth Leaders, held Tuesday 23 April at the CARICOM Secretariat in Georgetown, Guyana.

A crucial step in empowering youth leaders, the workshop aims to heighten their understanding of the health implications of climate change and foster their involvement in devising and executing effective measures to counter these effects.

Hon. Dr. Frank Anthony, Guyana's Minister of Health; Ms. Alison Drayton, Assistant-Secretary-General, Human and Social-Development; and representatives of Development Partners joined over 60 CARICOM Youth Ambassadors (CYAs), Youth Leaders and Advocates for the Opening

Ceremony of this four-day programme.

Dr. Barnett emphasized that climate change is not a distant threat. It is an immediate and pressing reality with significant consequences for human health, livelihoods and well-being. "From escalating temperatures and extreme weather events to shifting disease patterns and food insecurity, the impacts of climate change are extensive, disproportionately affecting vulnerable populations, including young people, Indigenous communities and marginalised groups."

The Secretary-General underscored that young people will have to grapple with the consequences of climate change well into the future if the Region fails to take effective action. She highlighted that the CARICOM Secretariat plays an important role in providing leadership and guidance in addressing the complex challenges posed by climate change. Development Partners, including the Pan American Health Organization (PAHO) and the European Union (EU), were recognized by the Secretariat for the financing under the 11th European Development Fund (EDF) project and their ongoing partnership with CARICOM to address some of these critical issues.

According to the Secretary-General, the Region, has been making significant strides in advancing climate change adaptation and mitigation efforts, including the establishment of regional frameworks and policies

and the implementation of community-based initiatives and awareness campaigns.

"However, there is much more work to be done, and active participation of young people is essential to drive progress and foster positive change. I am pleased to see that young people have already begun to lead the charge."

She commended Youth Leaders Dwane Hendrickson from St. Kitts and Nevis and Renee Atwell from Trinidad and Tobago for "their exemplary initiatives addressing climate change and health challenges within their respective communities." As a result of these initiatives, over 40 young people in both countries were actively engaged in efforts to mitigate the adverse effects of climate change. This has inspired more CYAs to develop their

own national projects.

She noted the Secretariat's commitment to fostering meaningful-Youth engagement and empowering the next generation of leaders to act on climate change, health, and a range of issues with which the Community is challenged. "We will continue to strengthen our own capacity to meaningfully work with young people. We will continue to create opportunities to bring young people together, not only to impart information but also to listen to you," stated the Secretary-General.

Hon. Dr. Frank Anthony, Minister of Health, Guyana, echoed Dr. Barnett's call for creating an enabling environment for meaningful participation by young people in climate change mitigation. "Empowering Youth in climate change

involves educating them about the relationship between climate change and health," stated Dr. Anthony, "We should enable them to advocate for evidence-based policies and practices, participate in decision-making processes and invest in education and capacity-building initiatives that enable them to lead sustainable initiatives."

Addressing the Youth Leaders directly, the Minister underscored the importance of their contributions to mitigating the effects of climate change. "To the Youth, your energy, creativity, and passion are invaluable assets in our quest for a healthier and more resilient Caribbean. Seize this opportunity to make your mark, to inspire change, and to shape the future of our Region."

TOURISM WORKERS PENSION SCHEME GENERATES \$1.6 BILLION IN CONTRIBUTIONS IN 2 YEARS

Kingston, Jamaica; Thursday, May 2, 2024: Minister of Tourism, Hon. Edmund Bartlett has announced a significant milestone in the Ministry's mission to "weave a safety net" for Jamaica's invaluable tourism workers, as the ground-breaking Tourism Workers Pension Scheme (TWPS), launched in January 2022, has surpassed 7,000 contributing members, recording \$1.63 billion in contributions as of April 2024.

"This is a commendable accomplishment in two years, especially when viewed against the backdrop that in 2022 several tourism operators were still recovering from the adverse impact of the pandemic," declared the tourism minister, during his 2024/2025 Sectoral Debate

opening presentation in Parliament earlier this week. The TWPS, a first-of-its-kind initiative in the world, offers a vital safety net for tourism workers. "This pioneering scheme continues to serve as a support system, ensuring our hardworking personnel can retire with dignity and security," Minister Bartlett emphasised.

These impressive figures, exceeding J\$80 million in monthly contributions, position the scheme to reach a total of over J\$2 billion by summer 2024, the tourism minister noted.

Minister Bartlett further highlighted that, "the endowment fund that was seeded with J\$1 billion by the Government now stands at J\$1.25 billion as of March 31, 2024. Therefore,

when added to the total contribution to date, Total Funds Under Management stand at J\$2.88 billion. So, based on the run rate, Total Funds Under Management will reach J\$3 billion by June of this year."

The tourism minister also stressed the importance of good governance. "I am also quite pleased to indicate that the Board of Trustees, which governs the scheme is now fully and properly constituted in keeping with the Act, as we recently appointed five member-nominated trustees to the Board," he added. Additionally, he noted that audits for the scheme are up-to-date, with 2022 financials completed and 2023 audits currently underway.

In the meantime, the tourism minister outlined the Ministry's ambitious plans for the TWPS. "The Chairman of the Scheme expects a significant increase in membership, given a number of strategies that will be pursued over the next 12 months," Minister Bartlett revealed. These strategies include targeted advertising campaigns, outreach to tourism operators and self-employed - individuals, collaboration - with industry associations, and diversification of investment management approaches.

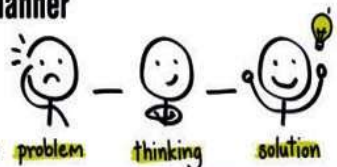

Biden calls out 'ferocious surge' of antisemitism

WHITE HOUSE — President Joe Biden on Tuesday called out what he described as a "ferocious surge" of antisemitism, using a somber speech to tie together two grim anniversaries: his nation's annual commemoration of the Holocaust, and the beginning of the seventh month of hostilities in Gaza.

"This hatred continues to lie deep in the hearts of too many people in the world," Biden said as he delivered the keynote address at the U.S. Holocaust Memorial Museum's Annual Days of Remembrance ceremony. He spoke at the U.S. Capitol before a group of legislators and a few elderly survivors of Nazi Germany's move to systematically exterminate 6 million Jews during World War II.

In his remarks, Biden sought

to tie that event to militant Palestinian group Hamas' stunning attack that killed about 1,200 Israeli civilians on October 7. The attack provoked a conflict that is ongoing to this day and has killed more than 34,000 Palestinians.

"We've seen a ferocious surge of antisemitism in America and around the world," since the October attack, said Biden. "Now here we are, not 75 years later, but just seven and a half months later, and people are already forgetting, already forgetting, that Hamas unleashed this terror."

'You belong'

Biden assured the Jewish community: "You belong. You always have, and you always will. ... My commitment to the safety of the Jewish people, security of Israel, and its right

to exist as an independent Jewish state is ironclad, even when we disagree."

Amy Spitalnick, CEO of the Jewish Council for Public Affairs, applauded Biden's speech and said in a statement that antisemitism is everybody's problem, not just one for Jews.

"Rising antisemitic conspiracy theories and hate are a threat that undermines each and every American's safety and our core democratic norms and values," Spitalnick said. "We're grateful for President Biden's clear moral leadership confronting this threat, including through the historic U.S. National Strategy to Counter Antisemitism."

"We urge Congress to quickly move the Countering Antisemitism Act forward

for a vote, support robust implementation of the National Strategy, and significantly increase funding for the U.S. Department of Education's Office of Civil Rights to investigate fully and address acts of antisemitism — and all civil rights violations — on campus. It's time to make clear that just, inclusive societies are ones in which Jews and all communities are safe and free."

Mounting pro-Palestinian protests on U.S. college campuses have raised questions about whether criticizing the world's only Jewish state as it continues to besiege Gaza should be seen as antisemitic speech.

"It is perfectly OK to object to the policies of a state," said Mirette Mabrouk, a senior fellow at the Middle East

Institute. "It is never OK to be a bigot. So, when the state of Israel conflates the two — conflates being Jewish with the policies of the state of Israel — it makes it significantly more difficult for people to object to the policies of Israel, because you don't want to come across as being antisemitic. That is absolute nonsense."

VOA asked White House press secretary Karine Jean-Pierre where the Biden administration draws that line.

"I shouldn't have to talk about a line," she replied. "It's very clear. It presents itself in the most hateful, abhorrent way. And antisemitism is hate speech. It is just hate speech. I'm not going to stand here and give examples. That's not something I'm going to do — it is obvious."

Storms batter Midwest, including reported tornadoes that shredded FedEx facility

DETROIT — Severe storms barreled through the Midwest early Wednesday, a day after two reported tornadoes struck one Michigan city and destroyed homes and commercial buildings, including a FedEx facility.

Tornadoes were first reported after dark Tuesday in parts of Michigan, Indiana and Ohio, while portions of Illinois, Kentucky and Missouri were also under a tornado watch, according to the National Weather Service. The storms came a day after a deadly twister ripped through an Oklahoma town.

As the storms raged on in the pre-dawn hours Wednesday, the National Weather Service in Pittsburgh warned that a tornado in northeastern Ohio could cross into Pennsylvania. Parts of West Virginia were also under a tornado warning. Hancock County Schools in West Virginia closed schools Wednesday because of "extensive overnight weather issues" in the county. News outlets reported damaged buildings and power outages.

Hours earlier in southwestern Michigan, two reported tornadoes

blitzed the city of Portage near Kalamazoo on Tuesday night, destroying homes and commercial buildings, including a FedEx facility that was ripped apart.

No serious injuries were immediately reported, but city officials said in a news release that the twisters knocked out power to more than 20,000 people. Most of them would be without power until late Wednesday, city officials said.

At one point, about 50 people were trapped inside the FedEx facility because of downed power lines. But company spokesperson Shannon Davis said late Tuesday that "all team members are safe and accounted for." More than 30,000 customers were without power in Michigan early Wednesday, and an additional 10,000 in Ohio, according to PowerOutage.us.

Michigan Gov. Gretchen Whitmer declared a state of emergency for four counties.

"My heart goes out to all those impacted by tonight's severe weather in southwest Michigan," Whitmer said in a message on social media. "State and local emergency teams are on the ground and working together to assist Michiganders."

National Weather Service crews were working Wednesday to survey storm damage in several counties in Michigan's southwest Lower Peninsula to determine whether tornadoes touched down in those areas, including the two reported Tuesday night in the city of Portage, said meteorologist Mike Sutton with the weather service's Grand Rapids office.

He said the Grand Rapids office had received a total of 11 reports of tornadoes from storm spotters, emergency managers and the public from late Tuesday afternoon into Tuesday night, but as of 8 a.m. Wednesday, it had not confirmed any tornado touchdowns.

Sutton said it could be a couple days before the storm surveys are completed and he stressed that some of the tornado reports could be duplicate reports passed along by people who saw the same storm.

It's quite possible those are multiple reports from the same tornado. The actual number of tornadoes may be lower depending on what they find when they're out surveying," he said.

Tuesday's storms came a day after parts of the central United

States were battered by heavy rain, strong winds, hail and twisters. Both the Plains and Midwest have been hammered by tornadoes this spring.

Across the U.S., the entire week is looking stormy. The Midwest and the South are expected to get the brunt of the bad weather through the rest of the week, including in Indianapolis, Memphis, Nashville, St. Louis and Cincinnati — cities where more than 21 million people live. It should be clear over the weekend.

Oklahoma's recent twisters

On Monday night, a deadly twister in Oklahoma tore through the 1,000-person town of Barnsdall. At least one person was killed, and another was missing. Dozens of homes were destroyed.

Aerial videos showed homes reduced to piles of rubble and others with roofs torn off. The twister tossed vehicles, downed power lines and stripped limbs and bark from trees across the town. A 160-acre (65-hectare) wax manufacturing facility in the community also sustained heavy damage.

It was the second tornado to hit Barnsdall in five weeks — a

twister on April 1 with maximum wind speeds of 90 to 100 mph (145 to 161 kph) damaged homes and blew down trees and power poles.

At the Hampton Inn in nearby Bartlesville, several splintered two-by-fours were driven into the building. Chunks of insulation, twisted metal and other debris were scattered over the lawn, and vehicles in the parking lot were heavily damaged, with blown-out windows.

Hotel guest Matthew Macedo said he was ushered into a laundry room to wait out the storm.

"When the impact occurred, it was incredibly sudden," he said.

Oklahoma Gov. Kevin Stitt, who toured the twister's damage Tuesday, said it was rated by weather researchers as a violent tornado with winds reaching up to 200 mph (322 kph). Stitt said he and legislative leaders have agreed to set aside \$45 million in this year's budget to help storm-damaged communities.

Areas in Oklahoma, including Sulphur and Holdenville, are still recovering from a tornado that killed four and left thousands without power late last month.

Lesmore Smith's Ghostinyou wins St Thomas Carnival Governor's Cup

Lesmore Smith's Ghostinyou, won Friday's St. Thomas Carnival Governor's Cup, overhauling early leader Protector down the stretch, to win the Mile and 70 yards race in one minute 43.2., in the return of horse racing in St. Thomas at the Clinton E. Phipps Racetrack, after a seven-year absence. The race had a record \$43,000 purse.

It was Smith's fourth Governor's Cup victory, after wins in 2011 and 2012 with Good Prospecting and in 2016 with Giant Valley.

"It's a good feeling and to know you're blessed to be in that position of winning," Smith told Island Sun Sports. "It was a challenge. It was tough knowing that you literally had to incur all the costs because there was no way out, no help, there was no other way to do it. It was rough but the victory was rewarding."

When his horse lined up for the race, Smith said he had no fear because his horse isn't a quitter. He could be four, five lengths off the pace but at the finish line, he'll be there.

"He's not afraid of a challenge or to be in any awkward position, because the horse can finish," Smith said. "I knew Ghostinyou had run against tougher horses than those on the card and we were confident with the training he had been giving us and we knew he would do well."

Smith's Risk vs Reward finished second to Purple Speight in the Albert "Boysie" Benjamin Cup, over 1-1/16 miles, with Anegada's Kenny Francis Alabama Jamma, finishing sixth in the race that offered a \$25,000 purse. He said that the horse could have performed better.

"He got a bad break and the jockey said he was literally racing the other horses in front of him, because he didn't realize that the other white horse was that good at what he was doing, otherwise, he would have gone earlier at him," Smith noted. "However, it's one of those things that in any preparation, you find that you miss one and the one you

miss, will cost you—that's what it is. But we're going at the June 30 races and we're taking Risk right back at that horse and we'll be running for the Lt. Governor's Cup."

Smith said he's hoping that Purple Speight would stay in that race but his handlers are trying to throw the challenge at his Ghostinyou.

"To me, I need a replay to see whether or not you can beat me fairly and squarely," he said of Purple Speight. "You beat me but, if we had a better chance at it—evenly drawn—I think it would have been a different race as well." Smith attributes his Governor's Cups success in winning four of them to 'blessings.'

"When I go among others abroad, I feel that with my competitive spirit, I feel that I'm more blessed, receive and I'm more fortunate than when I'm at home—not saying that at home I haven't had some success—but I find when I'm going into the races in St. Thomas, especially the Governor's Cup," he said. "I feel to have some favor and blessings that overpowers and overshadows and I'm grateful to God in every capacity of it, for his blessings."

Smith has won more Governor's Cups than any BVI horse owner but is still chasing lifting that elusive Premier's Cup and said that he doesn't know when that's going to happen. "I think that I'm in a better position for striking and obtaining, with the caliber of horses that I have, but the issue is, when will that come on stream? I don't know when that would be," he said, after being honored for his victory on Saturday following his return from

St. Thomas. "I'm hoping that they will get things in place very soon. We need to get ourselves up and running because they (St. Thomas horsemen) are asking us when we would be able to do something in Tortola. I'm telling them that we can't do anything because we don't have the facility. So, I'm hoping that things could shift a bit—things could change a bit—and we could get things put together."

Rising Stars easily flog VI Combined Renegades by 10 wickets

Hushman was Man of the Match for his 100, which included 17 fours and four sixes.

Diabetics Receive Great Results From a Plant-Based Diet

DEAR DR. ROACH: Your recent column about treating diabetes left me wondering. Diabetes, as I understand it, is usually a result of too much sugar being consumed. But consuming carbohydrates is not that different because they are quickly converted to sugar through the human chemical processes. So, why are you promoting a plant-based diet that is high in carbohydrates?

Consuming protein, which is easily obtained by eating meat, seems to be the answer to reducing the consumption of simple and complex carbohydrates that are quickly converted to sugar in our body. I've switched to a high-protein diet (both plant and animal protein), and my blood sugar has been very well-controlled for a couple of years. — *F.B.*

ANSWER: Diabetes is not a result of consuming too much sugar. Type 1 diabetes is an autoimmune disorder where the cells that make insulin are destroyed by the body. Type 2 diabetes is a disease of insulin resistance and a relative inability to secrete insulin in response to a sugar load.

In a person with Type 2 diabetes, consuming too much sugar in a short time overloads the body's ability to respond, so their blood sugar goes up. It is persistent high blood sugar that is responsible for most of the damage to the kidneys, eyes, blood vessels and nerves.

I am careful about what I mean by a plant-based diet. While it's true that a diet consisting entirely of maple syrup and orange juice would be extremely bad for a person with diabetes because of the concerns about blood sugar that you raised, a plant-based diet that is most-

fatty fish and nuts/seeds with moderate amounts of whole fruits does not raise blood sugar more than a standard Western diet.

The high fiber content of the legumes, whole grains and vegetables prevents rapid absorption, and the protein and healthy fat in nuts and fatty fish likewise slow stomach-emptying. Finally, there is good evidence that people with diabetes have excellent results with this kind of diet.

You are right that protein is important for a person with diabetes, but many high-protein diets based on meat also have high amounts of saturated fat, which increase the risk for heart blockages. In addition, saturated fat is a major cause of disease and death in people with diabetes. However, it is possible to have a healthy, high-protein diet with care.

DEAR DR. ROACH: The supplemental facts on the One A Day Men's 50+ vitamins and Women's 50+ vitamins are similar — only the men's had vitamin K, and the women's didn't. Other than this, the sole differences were variations in some of the daily values.

Is there any potential downside to a man taking a Women's 50+ vitamin or vice versa? — *J.M.*

ANSWER: I don't recommend daily multivitamins for healthy people, besides a few exceptions: Women of reproductive age who are considering pregnancy should be on a folate-containing regimen. People with known deficiencies (such as vitamin D) should be getting replacement supplements. Finally, vitamin E may increase prostate cancer risk and should be avoided in those with a prostate.

Women who are menstruating need more iron than men do, and sex-specific vitamin formulations keep these issues in mind. (Iron generally isn't dangerous for people who aren't menstruating, unless they have hemochromatosis.) So, while I don't recommend them, and although they are very similar, there are subtle reasons to choose a sex-appropriate vitamin.

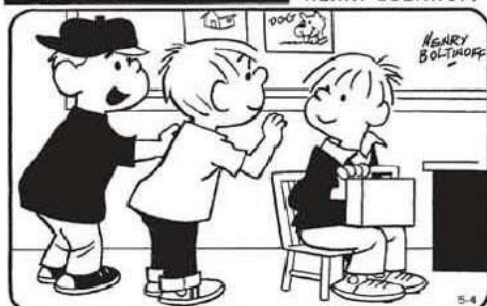

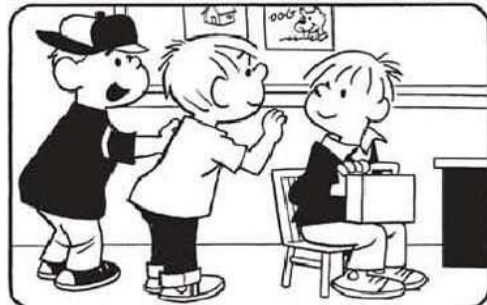

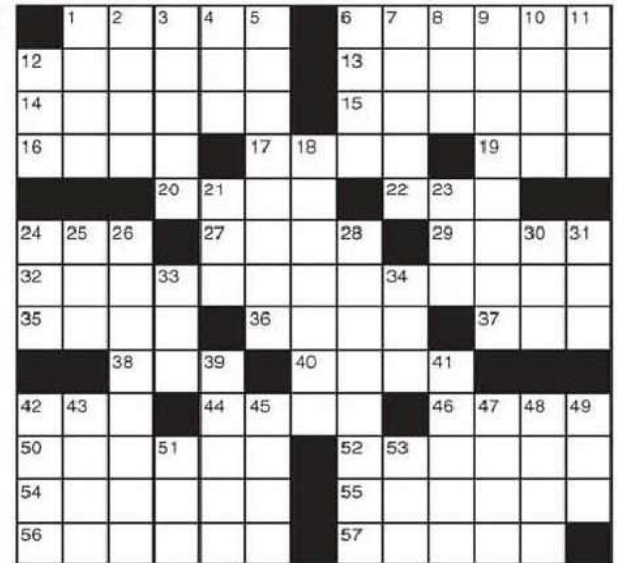

Q: What is the name of the show that preceded "NCIS"? It had a very handsome leading man, but I'm blanking on the show and the star. -- K.L.

A: "JAG," which is a United States military acronym that stands for Judge Advocate General, debuted on NBC in 1995, but the show moved to CBS a year later and lasted another nine seasons. The handsome leading man was played by David James Elliott, who was previously known as one of Elaine's boyfriends on the "Seinfeld" episode titled "The Couch."

"JAG" also starred Catherine Bell, Patrick Labyorteaux and John M. Jackson, all of whom have guest-starred on its very successful spin-off "NCIS." Mark Harmon, Cote de Pablo and Michael Weatherly launched the original "NCIS" series, which was currently just renewed for its 22nd season.

Elliott and Bell have both moved on from the show, working steadily since. Elliott starred alongside Jennifer Finnigan in another legal drama "Close to Home," from 2005 to 2007, and Bell starred in "Army Wives" for seven seasons. She's since acted in several TV movies for Lifetime and Hallmark. Elliott can be seen in the upcoming film "Harvest Moon," written by and starring Paul Bettany ("WandaVision").

"JAG" ultimately led to five "NCIS" series in total, each set in a different city. Unfortunately, "NCIS: Hawai'i" -- the first one with a female headliner (Vanessa Lachey) -- was recently canceled after three seasons. It was axed days before the network was planning to announce its fall schedule. Its series finale will air on May 6.

Q: I recently read how much money Mark Cuban had to pay in taxes. Is he the richest of the "Shark Tank" investors? -- E.E.

A: According to an article on TVInsider, the main panel members of ABC's "Shark Tank" have collectively invested \$200 million into products and investment opportunities featured on the show. Barbara Corcoran has the least net worth at an estimated (gulp) \$100 million. 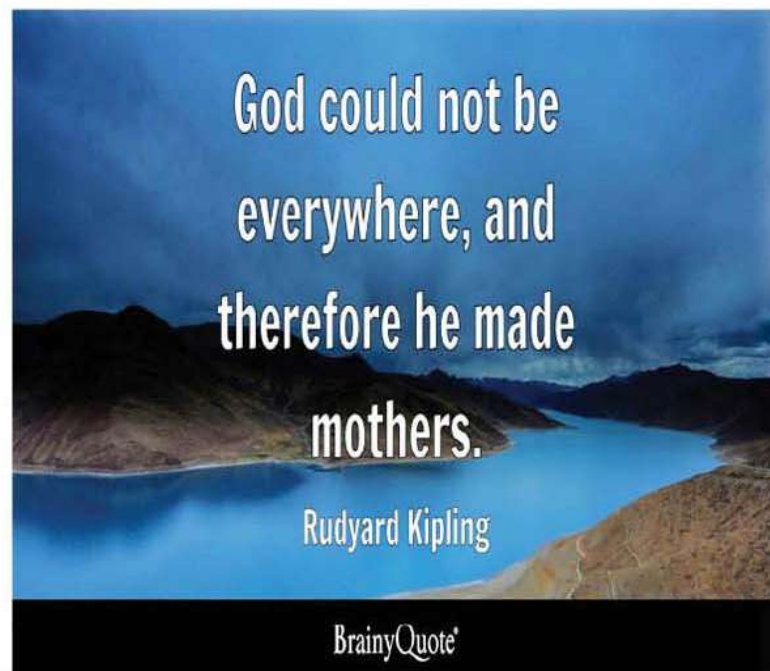

EXAMINING NEWSWEEK REPORTING ON CHINA'S PRESENCE IN ANTIGUA AND BARBUDA

Is it ever justifiable for journalism to fan the flames of geopolitical tension? This question arises after reading Didi Kirsten Tatlow's recent Newsweek article, which paints a distorted picture of Chinese involvement in Antigua and Barbuda.

The article, published on April 19, 2024, bore the headline: "China Building New Outpost on U.S. Doorstep, Leaked Documents Reveal". The headline alone is enough to raise eyebrows. It suggests a looming geopolitical confrontation, framing China's activities in the Caribbean in starkly ominous tones.

But what does the article actually reveal? The so-called "new outpost on the U.S. doorstep" refers to the Chinese Embassy in Antigua and a Free Trade Zone that is owned not by the Chinese government, but by private Chinese individuals. This latter point alone raises questions about the underlying narrative of the article.

A brief look at Ms. Tatlow's background shows that she spent thirty-nine years in Hong Kong, Beijing, and Taiwan, and she now resides in Germany. Her writings predominantly critique China's politics and international influence.

The sensational nature of her headline is clear. It screams "Leaked Documents Reveal," yet the content refers to "Chinese-run special economic zone" that turns out to be a private enterprise, not a state-run operation. This is akin to labelling any business operated by a US national overseas as a "US-run" operation—a misleading comparison at best.

By emphasizing the strategic significance of the location of the Free Trade Zone as near an Antigua and Barbuda military base (which it is not) and linking it to the Government of China (which it isn't), the article wrongly attributes actions to China and frames them as potentially militaristic.

Furthermore, it fails to mention that the Free Trade Zone's establishment and operational scope, debated and approved by Antigua and Barbuda's

article is not just evocative but also shapes a narrative which casts China's diplomatic presence in a suspicious, almost nefarious light.

The choice of phrases like "black-clad" to describe a Chinese security guard at the Embassy and referring to the Embassy as a "fortress" connotes isolation, impregnability, and a military-like presence, which can enhance perceptions of a secretive or defensive operation rather than a normal diplomatic facility. In fact, the Chinese Embassy in Antigua is no more large, guarded or enclosed than the US Embassy in Barbados.

Beyond just emotive language, the article employs selective fact presentation that further skews perception. The mention of the US "shuttering" its Embassy in 1994 and "relocating" to Barbados implies a strategic shift prompted by recent events. However, the US has maintained an Embassy in Barbados since 1966, well before Antigua and Barbuda established diplomatic relations with China in 1983.

The terms used to describe geopolitical spaces, such as turning Antigua from America's "backyard" into China's "front yard", imply a possessive and competitive dynamic between the US and China, while, in reality, Antigua and Barbuda fiercely safeguards its nationhood and identity.

The article uncritically accepts a claim by an Antiguan opposition politician that Antigua and Barbuda has 'traded its sovereignty,' suggesting a loss of autonomy due to its engagement with China. This portrayal frames the relationship as a surrender rather than a partnership. However, it's important to note that Antigua and Barbuda's loan agreements with China are purely financial and do not impose any political conditions. Additionally, and in fairness, it is noteworthy that the same politician was part of a previous government that entered into agreements with China.

The use of this term, "Listening

Post" in describing the activities suspected to be conducted at the Chinese Embassy conjures images of espionage and surveillance, increasing the sense of threat. This choice of language is an attempt to influence the reader's emotional response to the information, steering perceptions towards seeing China's involvement in Antigua and Barbuda as ominous or threatening.

Yet, the Article itself discloses that the US Department of Defence agency, SOUTHCOM, which is based in Florida and has responsibility for providing US contingency planning, operations, and security cooperation for Central and South America and the Caribbean, said it had not identified technologies such as satellite "reference stations" at the Chinese Embassy that would equip it as a "listening post".

Of course, Antigua and Barbuda is not the only country in the Caribbean in which the Government of China and Chinese businessmen have partnered, nor is it the biggest beneficiary of Chinese loans. Further, the largest private sector investors in Antigua and Barbuda are US companies and nationals; not Chinese. US nationals also represent the largest number of tourists and residents who are welcome to the country. These are facts not considered in the Newsweek article.

Antigua and Barbuda, has no greater obligation by treaty or agreements to China than to the US, the EU, the UK or anywhere else. And, while its development partnership with China is greatly valued, it also happily enjoys a high level of cooperation with the US on a range of issues that are vital to human rights, the fight against trafficking in persons and drugs, freedom, security and curbing the impact of Climate Change.

The Newsweek article itself admits that the US State Department says, "the US and Antigua and Barbuda maintain strong and historic ties, with ongoing robust cooperation in regional security initiatives aimed at countering firearms trafficking and crime, as well as other efforts in climate and development". The two countries also enjoy a high level of collaboration on issues of human rights and political freedom at the United Nations and the Organization of American States, and, at the people-to-people level, a very long, and highly-valued intertwined relationship.

Thus, while journalistic inquiry remains a cornerstone of a free society, it must strive to present a balanced context and respect the sovereignty of the nations involved, thereby fostering a well-informed and discerning public.

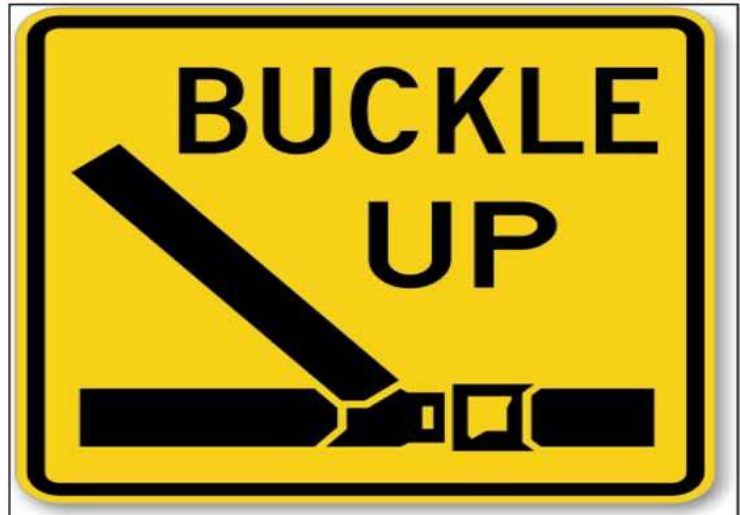
